Tachyon dark energy models: dynamics and constraints

We explore the dynam ics of dark energy models based on a Dirac(Bom(Infeld (DBI) tachyonic action, studying a range of potentials. We numerically investigate the existence of tracking behaviour and determ ine the present-day value of the equation of state parameter and its running, which are compared with observational bounds. We not that tachyon models have quite similar phenomenology to canonical quintessence models. While some potentials can be selected amongst many possibilities and netuned to give viable scenarios, there is no apparent advantage in choosing a DBI scalar eld instead of a Klein(Gordon one.

I. INTRODUCTION

Most dark energy modelling using scalar elds has followed the quintessence paradigm of a slowly-rolling canonical scalar eld. However, there has been increasing interest in loosening the assumption of a canonical kinetic term. In its most general form, this idea is known as k-essence [1]. A more specic choice is the 'tachyon' [2], which can be viewed as a special case of k-essence models with Dirac(Born(Infeld (DBI) action [3]. This kind of scalar eld is motivated by string theory as the negative-m assm ode of the open string perturbative spectrum, though its use in the dark energy sector is prim arily phenom enological. One goal of such studies is to investigate whether there are any distinctive signatures of non-canonical actions available to be probed by observations. For a recent comprehensive review of dark energy dynamics see Ref. [4].

Tachyon dark energy has been explored by many authors, for example Refs. [5, 6, 7, 8, 9, 10]. Two papers are particularly closely related to the present work. Bagla et al. [7] focussed on two special choices oftachyon potential, and carried out numerical analysis of the cosmological evolution in order to constrain them against supernova data and the growth rate of large-scale structure. Copeland et al. [9] studied a wider range of potentials, concentrating mainly on analytical inspection of attractor behaviour and the critical point structure without making comparison to special observations. In this paper, we aim to merge some of the positive features of each analysis, by studying a wide range of potentials and testing them directly against current observational constraints as given in Ref. [13].

The mechanism of slow rolling is the key ingredient in order to get an accelerating evolution driven by a scalar eld. Since the DBI action can be expanded to match the Klein{Gordon one in this regime, one does not expect to nd radically dierent features from the tradi-

tional quintessence models. However, we point out that, as compared to canonical quintessence, tachyon models require more ne-tuning to agree with observations. This is consistent with the properties of the slow-roll correspondence between the tachyon and an ordinary scalar [14, 15].

II. TACHYON DARK ENERGY MODELS

A. Equations of motion

We assume a four-dimensional, spatially—at Friedmann {Robertson {Walker (FRW) Universe lled by dust matter (subscript h '), radiation (Y') and a minimally—coupled hom ogeneous DBI tachyon T with potential V (T) and dimension E 1 . For a perfect uid n with energy density $_{n}$ and pressure p_{n} , the barotropic index is w $_{n}$ p_{n} = $_{n}$. Each uid component satis es a continuity equation

with $w_m=0$ and $w_r=1=3$. Here, a dot is derivation with respect to synchronous time and H $\underline{a}=a$ is the Hubble parameter defined in terms of the scale factor a(t). In the following a subscript 0 will denote quantities evaluated today (at t_0), when $a(t_0)=a_0=1$. Defining the critical density today as $_{c0}=3H_0^2=(8\ G)$ and assuming that gravity obeys an Einstein (Hilbert action, the Friedmann equation reads

where $%_n$ $_n = _{c0}$, U $V = _{c0}$, and the time coordinate has been rescaled as t! $t = H_0$ so that H = 1 today. The tachyon is dimensionless in these units. Note that the $%_n$ are the densities normalized to the present value of the critical density, and are not the density parameters. The

present density param eters have values $_{\rm m}$;0 0:24 [16] and $_{\rm r;0}$ 8 10 5 .

The tachyon equation of motion is

where $U_{,T}$ dU=dT. Since $p_{T}=V$ $\frac{p}{1}$ T^{2} , the barotropic index for the tachyon is

which can vary only between $\,$ 1 and 0 in order for the action to be well de ned. When the scalar eld slowly rolls down its potential, JLj $\,$ 1, it behaves like an elective cosmological constant, w $_{\rm T}$ $\,$ 1. From now on we drop the subscript T' on w $_{\rm T}$.

Since the cosm ological evolution spans m any orders of m agnitude in synchronous time, for numerical work it is convenient to switch to the number of e-foldings N $\ln a=a_0=\ln a$ as the evolution parameter, so that

D errivatives w ith respect to N w ill be denoted by prim es, so that Q= H Q 0 and Q = H 2 (Q 0 0) for any quantity Q, where H=H 2 = (H 2) 0 =(2H 2). W ith the compact notation x H 2 , % * + % $_{\rm r}$, the Friedmann equation becomes

M apping between the number of e-foldings and the redshift z $a_0=a$ 1, we note that at nucleosynthesis N $_{\rm BBN}$ 20 (z 10), at matter{radiation equality N $_{\rm eq}$ 8 (z 3200), and at recombination N $_{\rm ec}$ 7 (z 1100).

As regards the initial conditions at early times for the dynamical equations, we can consider two qualitative cases. In the rst one, the scalar eld starts rolling down very slow ly, xT^{\otimes} 1. The Friedmann equation becomes linear in x and, during radiation domination, % U and x %. In such a picture of the events, the initial condition is a radiation-dominated Universe in which a dynamical cosm ological constant is negligible. Later on, %_T increases relative to %_r, eventually dominating at low redshift, while w stays negative and varies, perhaps non-monotonically, from around 1 to $w_0 < 0$. The parameters of the model and the shape of the potential can be adjusted so that the actual value of w_0 is compatible with supernov data.

In the second case $xT^{0} < 1$, that is, T^{0} is large enough to compensate, but not override, x = 1. The tachyon starts from a dust regime and ends up again with a suitable negative w_{0} . This is precisely the situation studied numerically in Ref. [9] for U / T^{-1} .

Below, we shall focus mainly on the rst case, which encodes all the relevant features of the models.

B. Tracking and creeping regim es

Quintessence behaviour typically falls into one of two classes, named as tracking and creeping in Refs. [17] and [18] (see also Ref. [19] which refers to the late-time behaviour in these scenarios as freezing and thawing respectively). The same kind of evolution occurs in the tachyon case too.

Tracking behaviour occurs when the potential has an attractor as a response to a cosm ological uid, which renders the nal outcome (at xed uid density) independent of the initial conditions. M any potentials support tracking behaviour, which takes place provided the initial dark energy density is not too low (otherwise the scalar eld cannot dominate by the present). A tracking eld slows down near the present as it starts to feel the friction induced by its own dominance of the energy density, and hence has equation of state reducing with time (w $^0 < 0$). Note that an asymptotic solution, in which radiation and matter are negligible and dark energy is the only component, may be an attractor but is not a tracker according to the above de nition; tracking behaviour is induced by another uid component.

A creeping eld is one which sits static at low energy density until the density of other materials drops low enough for it to become dynamical and start to move at the present epoch. Creeping dark energy typically does not make predictions independent of initial conditions, but can be characterized by the equation of state increasing away from 1 at the present epoch as the eld starts to move ($w^0 > 0$).

Potentials with tracking regimes also feature creeping behaviour for low enough initial density, which can lead to dierent predictions from the same potential. C reeping behaviour can also be found for many potentials which do not support tracking.

In order to regard the tachyon as a model of dynamical dark energy, it is useful to parametrize the barotropic

index as a function of the scale factor:

so that $w = w_0$ today. Its value can be found by solving the Friedmann equation today for $T_0^0 = T^0(0)$, getting from Eq. (9)

Then one has w 0 < 0 when either T 0 < 0 and 3xT 0 + U $_{,T}$ =U < 0 (for inverse power-law potentials, U T , the latter condition is 3xTT 0 < 0, true when T > 0), or T 0 > 0 and 3xT 0 + U $_{,T}$ =U > 0.

The transition between a tracker and a creeper can be de ned by imposing an initial condition for T and T 0 so that $w_0^0=0$. Genuinely non-tracking models are problem atic as they do not make de nite predictions, in the sense that there is strong dependence on initial conditions. This makes them rather unattractive, although by no means ruling them out. Indeed, it makes some of them more viable than trackers in relation to experimental bounds, as we shall see.

C. Choice for the tachyon potential

As for the tachyon self-interaction, there are a number of models which one can consider, some being motivated by nonperturbative string theory and others purely by phenomenology. We review the classication of Ref. [9], to which we refer for further details and references. For each case, past results are summarized. In the following, $U_{\rm c}$ is a normalization constant.

- 1. $U = U_c T$, < 0, / $T^2 ! 1 as T ! 0$. This model is a ected by instabilities [20].
- 2. U = U_cT , 0 < < 2, / T 2 ! 0 as T ! + 1 [asym ptotically de Sitter (dS)]. In order to get viable cosm ologies, U_c does not need to be ne-tuned since it is not a ected by the super-P lanckian problem of the inverse quadratic potential. In general there is a stable late-time attractor [21]. In Ref. [9] the case = 1 was considered as a numerical example.
- 3. U = U_cT ², = constant. This is the potential associated to the exact power-law solution a = t^p [7, 21, 22]. One has to ne-tune U_c in order to get su cient acceleration today. A phase-space analysis in Refs. [9, 23] con ms that it is dicult for this model to explain dark energy, since the only late-time attractor in the presence of matter or radiation has %_T =x ! 0.

- 4. U = $\rm U_c T$, > 2, / T 2 ! 1 as T ! +1. This potential has not been studied numerically previously, but Ref. [21] showed that it has a dust attractor. The authors of Ref. [9] also argued that it behaves as in model 7 below .
- 5. $U = U_c \exp(1 = T)$, > 0, / $\exp(1 = T) = T^2$!
 0 as T! + 1. This gives an asymptotic dS solution with elective cosmological constant given by U_c . This potential has been considered also for K lein (G ordon quintessence [17, 24], and it should have properties similar to model 2 [9].
- 6.U = $U_c \exp(^2T^2)$, > 0, $/T^2 \exp(^2T^2)$! 0 as T! 0. This potential arises in KKLT setups for m assive scalar m odes on the D-brane [8]. The eld oscillates around T = 0 w ith elective cosmological constant given by U_c , and can give viable scenarios [9].
- 7. U = U_c exp(T), > 0, / exp(T)! 1 as T! +1. This potential arises in D {D systems of coincident branes with a real tachyonic mode, and was studied in Ref. [7]. The authors of Ref. [9] found it to have a stable dust attractor after a period of acceleration. They suggested the possibility that we are living during this transient regime. Note that this potential is a large-eld approximation of U = U_c=cosh(T) [25].
- 8.U = $U_c \exp(^2T^2)$, > 0, / $T^2 \exp(^2T^2)$! 1 as T! +1. In Ref. [9] it was argued that its predictions are similar to model 7.

These potentials o er a rather comprehensive range of generic behaviours: one reaches a cosm ological constant regime at in nite time [U / exp(T 1)], one at nite time (U / exp T 2), while in other situations the potential asymptotically vanishes.

The structure of analytic asymptotic solutions of the equations of motion for inverse power-law and exponential potentials is presented in the Appendix.

III. NUMERICAL ANALYSIS

The equations of motion are integrated forward in time from before matter{radiation equality $(N_i 10)^3$. Having xed the initial values T_i and T_i^0 , our numerical

 $^{^3}$ A lthough the problem is de ned by boundary conditions at the present time, we do not attempt to integrate backwards from them (for instance by choosing T_0 freely while $T_0^{\,\,0}$ is constrained by the Friedmann equation at N=0). This is because in many cases we are dealing with situations having strong attractors, which become repellors in backwards integration leading to rapid growth of numerical instabilities. Instead, we integrate forwards using a shooting method to adjust the initial conditions to obtain the right present properties.




FIG. 1: P resent value of the barotropic index w for tachyon tracking solutions (squares) and for creeping solutions for $T_{\rm i}=1$ (circles) with inverse power-law potentials U / T . For comparison the result for tracking canonical quintessence is also shown (triangles).

code adjusts the normalization of the potential to yield the solutions which satisfy the boundary conditions today ($\mathbf{x}_0 = 1$, matter and radiation energy densities equal to $_{\mathrm{m};0}$ and $_{\mathrm{r};0}$, respectively). In cases where a tracker behaviour is present, one would expect the present values of these to be independent from the initial conditions to a good approximation.

We choose $T_i^0=0$ as initial condition; an arbitrary non-vanishing value could typically only have arisen if at very early times the tachyon had an unacceptably high velocity. The initial phase of approach to a tracker is articial, as the real cosm ological initial conditions were presumably laid down at an earlier epoch than those of our code. Anyway, it will be su cient to capture the main features of these models, although one might devise some physical situations which do predict U $\,$ % and 0 < T 0 $\,$ 1 as initial conditions.

In the following we inspect case by case the models listed in Sec. IIC . Since case 1 is unstable, we start with inverse power-law potentials.

$$A \cdot U = U_c T$$

These potentials lead asym ptotically to dS for < 2 and to a dust attractor for 2. The rst case is the most viable for obvious reasons, and we have verilled that for $T_i < 0.1$ and $T_i^0 = 0$ the numerical solutions with < 2 lie on the asym ptotically dS attractor, while for 2 and the same initial conditions it is not possible to achieve a cosmology compatible with observations (i.e., $\kappa_0 = 1$). For $T_i > 0.1$, one goes further and further away from the attractor and enters a creeping regime, in the sense that the evolution depends on the choice for T_i . In Fig. 1 the value of w_0 is shown for the tracker solution and for a particular creeping solution with $T_i = 1$. In gen-




FIG. 2: Evolution of the density parameters and equation of state as a function of N for the inverse power-law tachyon model with = 1=3. Solid line: $%_m = x$; dashed line: $%_r = x$; dotted line: $%_T = x$. The dot-dashed line is the barotropic index w.

eral, creepers m imic a cosm ological constant m ore closely than trackers, and in particular only a creeping solution is available for 2. For comparison we also show the equation of state from tracking canonical quintessence models, which for the same is always more negative than that of the tracking tachyons.

These results can be understood by recalling that in the slow-roll approximation there is a mapping between the DBI scalar and the K lein (G ordon one [14, 15]. The tachyon energy density is $%_T = U$ (T) = $\frac{1}{1} = \frac{U}{Rp} = \frac{U}{U}$ (T)+U (T)T^2=2, and after a eld rede nition one obtains a canonical action for a scalar with potential W () U[T()]. For U(T) T, one has

Hence the tachyon tracker for 0 < 2 is dual to the tracking quintessence solution ~ 0 . From Fig. 1, one can see that any dual pair $(;\sim)$ corresponds to almost the same index w_0 | see in particular the pairs (2=3;1) and (1;2).

The attractor evolution of the uid components is shown in Fig. 2 together with w (N), for the particular case = 1=3. The behaviours of these quantities for other values of are all similar. Note that the barotropic index is w 1 until matter domination, increases up to w 0.8 at redshift z 1 2 0, and then decreases towards 1. This is consistent with the Yireezing' behaviour and its limit of applicability as classified by Ref. [19].




FIG. 3: Numerical points in the w_0 - w_0^0 plane for tracking solutions (squares) and creeping solutions for $T_i=1$ (circles) with inverse power-law potentials U / T . The value of is shown at each point, while the dotted lines are the 1 and 2 likelihood bounds [13]. The unlabelled points on the left and right of = 1 in the tracking curve are = 0.95 and = 1.05, respectively.

For the creeping solutions (not shown here) the index w is very close to 1 up to very late times, when it starts deviating to a softer equation of state.

In this and all other exam ples, the onset of dark energy lies in the interval 1 < N < 0, that is, for redshift z < 1.7. Such late dom ination by dark energy is essential to prevent an excessive suppression of structure form ation growth, see e.g. Ref. [7].

In Fig. 3 the points predicted by the same models in the $w_0\{w_0^0$ plane are shown together with the 1 and 2 likelihood contour bounds of Ref. [13]. These are based on the rst-year SN LS data set [26] and SD SS [27], W M A P 3 [16], and 2dF [28, 29] experiments. Note that there is a minimum value for w_0^0 around 0:99; we have checked that its closeness to 1 is an accident of the particular m_{j0} used.

The conclusion is that there is tracking behaviour for < 2, and if T_1 is not too large this operates and gives a well-de ned prediction for w_0 , which is however in disagreem ent with observations unless—is quite small. The predicted w_0 m oves closer to—1 as the potential attens, but only once it gets down to about—< 0.8 do we start to see compatibility with the 2—level bounds. This is even—atter than the equivalent constraint on quintessence, < 4=3. Hence these models are not very pleasant from—either a theoretical or experimental point of view. One has to impose—< 1 or ne-tune the initial conditions. Relaxing either assumption results in incom—

patibility with observations. The creeping solution with $T_i=1$ (upper curve) gives an example of observationally viable model for 3, but at the cost of ne-tuned initial conditions.

One can also make $T_i^{\ 0}$ big enough that the initial w is close to zero rather than 1. Then it dips to 1 and increases to join the tracker, eventually giving exactly the same evolution as if one had chosen $T_i^{\ 0}=0$ at the start. This is exactly the same sequence of epochs that are seen in quintessence models [30]; if the initial velocity is set high, then the trajectory bvershoots' the tracker, comes to rest at lower potential energy for a while, and eventually rejoins the tracker from below.

W e can compare the numerical output for T_0 with the asymptotic solutions derived in the Appendix, specically Eq. (A16). W ith C = 0:045, the ratio $\mathfrak{T}_{0}^{\text{num}}$ Appendix, the asymptotic analytic solution relies on a polynom ial rather than monom ial potential, and in generalthey will predict a dierent variation of w. Moreover, the values of p from Eq. (A15) are rather small, corresponding to 2:5 N < 0:5, where N is the big bang event; i.e. the asymptotic solution which matches the present evolution has a big bang in the very recent past, and hence can only have become a reasonable approxim ation very recently. The solution properly approaches the attractor only for large positive N , when the contributions of radiation and dust matter are negligible. Nevertheless it appears to give a good estimate of w_0 , though not \mathbf{w}_0^0 .

$$B \cdot U = U_c \exp(1 = T)$$

This model has a non-zero vacuum energy $U_{\rm c}$ as T ! 1 , which will be achieved asymptotically. It exhibits some features similar to the inverse power-law potential with < 2, but does not appear to exhibit tracking behaviour. We have xed = 1 and checked that this does not result in a loss of generality. For $T_{\rm i}$ $^>$ 2 the solution is very close to de Sitter, w $_0$ 1 and 0 < w $_0^0$ < 10 3 , essentially amounting to a creeping solution (T_0 $T_{\rm i}$) sitting on the asymptotic at part of the potential.

For smaller $T_i \le 1$ the cosm ological values today depend on the initial conditions of the model. For $T_i = 1$ we now $w_0 = 0.95$, $w_0^0 = 0.04$ and for $T_i = 0.5$, $w_0 = 0.77$, $w_0^0 = 0.05$. The solution exits the 2-contour at about $T_i = 0.4$ ($w_0 = 0.70$, $w_0^0 = 0.14$). One might argue that the initial condition $T_i^0 = 0$ is inappropriate for this model, since the potential is very steep at small eld values. However, we have verified that the slow-roll velocity is small enough to be negligible anyway at least for $T_i = 0.2$ (which is beyond the observable region). There is no evidence of tracker-type behaviour for $T_i = 0.2$.

Thism odel does not need ne-tuning of the initial conditions, as the eld can lie anywhere on the at part of the potential. However one has to $\,x$ the value of U $_{\text{C}}$

by hand in order to reproduce the observed dark energy density, which of course does not resolve the $\cos m$ ological constant problem .

As in the inverse-power case, we can compare the numerical output of w_0 with the asymptotic solution Eq. (A 35), where $_0=1=T_0^{\rm num}$. When $_0=1$ and the approximation giving Eq. (A 35) breaks down, $\dot{y}_0^{\rm num}$ where $\dot{y}_0^{\rm num}$ j 0.1, while at large T_0 one has $\dot{y}_0^{\rm num}$ where $\dot{y}_0^{\rm num}$ j < 10 3 or better. We note that Eq. (A 36) is negative de nite while $w_0^{\rm num}$ $^0>0$, and there is disagreement between the two.

$$C \cdot U = U_c \exp(^2T^2)$$

This modelalso has a non-zero vacuum energy U_c , this time at T=0. Fixing =1, for $T_i<0$:1 one has a de Sitter behaviour (w_0 1, $0< w_0^2<10^3$), while for increasing T_i the barotropic index goes away from 1 (for instance, $T_i=1$ gives w_0 $0:81, w_0^2$ 0:13).

Checking the num erical output of \mathbf{w}_0 w ith Eq. (A 37), where $_0 = (\mathbf{T}_0^{\text{num}})^2$ 1, one can see that $\mathbf{j}\mathbf{w}_0^{\text{num}}$ $\mathbf{w}_0^{\text{theor}}\mathbf{j}\mathbf{j}\mathbf{w}_0^{\text{num}}\mathbf{j} < 10^4$. A gain, Eq. (A 38) is negative de nite while $\mathbf{w}_0^{\text{num}}{}^0 > 0$.

Note that lower values of lead even more closely to a cosmological constant behaviour, well inside the 1 bound. This may be relevant when trying to construct a model which tsalso for in ation, as one needs 2 10 8 to get the correct level of an isotropies [8].

 and $U = U_c = \cosh(T)$




FIG. 4: Evolution as a function of N of the model U = $U_c = \cosh(T)$, in this case extending beyond the present. Solid line: $%_T = x$; dashed line: $%_T = x$. The dot-dashed and dot-dot-dashed lines are w and w⁰, respectively. In this example, the initial condition is $T_i = 0.5$, for which w₀ 0.98 and w₀ 0.003.

W hen considering the pure exponential potential U = T), choosing a dierent starting value of T has no impact on the evolution because a rescaling T! T+ const. simply renormalizes Uc, which the program then adjusts to give the sam e present status (corresponding to 0:93, w 0:10). Therefore we consider directly w_0 the hyperbolic cosine potential of Ref. [25], for which this degeneracy is rem oved. For $0 \le T_i \le 0.3$, the solution has $w_0 < 0.99$ and $0 < w_0^0 < 10^2$, while for larger values of Ti the present-day barotropic index becom es larger. We note that the accelerating phase of these solutions is only a transitory epoch before reaching the dust attractor in the future, as shown in Fig. 4 where the equations have been integrated up to positive values of N.

Since one must tune, although not too severely, the initial condition (or, equivalently, $U_{\rm c}$) so as to get viable acceleration today, this and other models leading to a dust regime are not very predictive. They are however capable of explaining the observed dark energy properties.

This model has a dust attractor whose qualitative features match the previous case. It is not dicult to nd suitable initial conditions mimicking a cosmological constant today.

IV. DISCUSSION

None of the models we have discussed are very satisfactory. Those which carry reasonable theoretical motivation allend up with a high degree of ne-tuning. Either the potential normalization $\rm U_c$ has to be set to match the observed dark energy density, or the initial conditions tuned to the creeping regime, meaning that the present density was already set in place during the early Universe. In either case, this tuning amounts to a restatement of the cosmological constant problem, rather than a resolution. The models which avoid ne-tuning of initial conditions (while still subject to tuning of the normalization), such as the inverse power-law, are constrained by observations into parameter regimes with no theoretical motivation.

The string tachyon with DBI action seems only weakly competitive as a dark energy candidate, and another formulation of the elective theory might have more successful applications. The tachyonic elective action as the lowest-order level truncation of cubic string eld theory has been studied only very recently and its cosmological impact has yet to be fully assessed [31, 32, 33, 34]. An alternative would be to abandon the pure four-dimensional picture (ideally corresponding to a low-energy single or coincident brane con guration in a higher-dimensional spacetime) and consider more general brane{anti-brane}

setups where open string modes naturally live. However, any modication to Einstein gravity would be severely constrained after nucleosynthesis.

Still, the era of high-precision cosm ology opened up by m icrow ave background and large-scale structure observations is allowing us to constrain in ationary and dark energy models in a more and more stringent way, selecting some of them from a plethora of possibilities. Here we have given an example of the rst stage of such a procedure. The second one will be to develop and re ne those m odels that seem particularly promising, by embedding them in a comprehensive and consistent picture of the cosm ological history and its particle theory content.

APPENDIX A: ASYMPTOTIC SOLUTIONS

In this Appendix we derive some analytical asymptotic solutions describing the evolution once the tachyon has becom e com pletely dom inant.

1. A sym ptotic solutions for power-law potentials

Inverse power-law potentials, introduced in the context of dark energy in Ref. [35], have no general support from string theory. However, they can be viewed as large-eld approximations (jīj! +1) of the exact solution [36]

p. In the rst case, the big bang event is at N and N < N < +1; in the second case, 1 <N < N. The solutions with the potential Eq. (A5) are wellbehaved when N > 0 and either 2 < < 3 (n < 0)or > 3 (n > 2).

The case given by Eq. (A7) is the most interesting since it corresponds to the tracking regime. Using the de nition Eq. (A4) and neglecting matter and radiation contributions, one has the exact solution

The classical stability of these solutions was studied in Refs. [9, 21]. At late times (i.e., large T and N), one has a de Sitter regime for 0 < < 2, ! 0, or an asymptotically dust solution (> 2). These solutions are actually attractors. As regards the latter, we note that

where we have taken the Carroll lim it [37] (the DBI action then becomes singular) corresponding to tachyon

condensation into dust. This expression prescribes a regularization for all the above formul, and suggests the following possibility, considered also in Ref. [9]. The only way to balance the increasingly small denominator is to im pose that $w_0 + 1$ 0; this m ight mean that if > 2, the Universe tends to become dust dominated but only after passing through an accelerating phase. Since the origin of time is arbitrary, such a phase is not positioned unequivocally and it will be determined also by the norm alization constant Uc of the potential.

2. A sym ptotic solutions for exponential potentials

In general, a solution for the Friedmann equation in term sofT can be found by noting that, when w the T dependence of the Hubble parameter must be the same as of the tachyon potential, the square root in the denominator of Eq. (9) (with % = 0) being dimensionless: x(T)/U(T). All the exponential potentials we consider can be suitably param etrized so that

3. Com parison with num erical solutions

Having built the asymptotic analytic solutions, one would like to check whether the numerical behaviour really approaches such solutions at late times. In particular, we want to compare the numerical points in the $w_0 \{ w_0^0 \text{ plane in param eter space, found via }$

The m atter content today still am ounts to 25% of the total energy density and contributes to the cosm ological evolution, so we expect a deviation of the num erical results relative to the asym ptotic, pure tachyonic solution.

There is another source of discrepancy one should take into account, namely the approximations implicit in the solutions presented in this Appendix. In the inverse power-law example, while Eqs. (A9) { (A13) are valid for a polynom ialpotential as in Eq. (A2), the numerical model is actually Eq. (A3), and in general the two will give a dierent running of the barotropic index w^0 , Eq. (A40).

In Sec. IIIA we not that w_0^{num} and w_0^{0} theor do disagree, but still there is remarkable agreement between w_0^{num} and w_0^{theor} [the latter comparison is in fact done between T_0^{num} and T_0^{theor} (w_0^{num})].

In the case of exponential potentials, the asymptotic models have w const: by construction [x (N) / U (N)] and the equations of motion are much simplied. A gain, w $_0^{\rm num}$ w $_0^{\rm theor}$ to good approximation (see Secs. IIIB and IIIC), while a comparison of the running would require a more rened treatment.
