## Observation of Modulated Quadrupolar Structures in PrPb3

Neutron di raction measurements have been performed on the cubic compound PrPb3 in a [001] magnetic ell to exam ine the quadrupolar ordering. A ntiferromagnetic components with q=  $(\frac{1}{2}$   $\frac{1}{2}$  0),  $(\frac{1}{2}$   $\frac{1}{2}$  0) (  $\frac{1}{8}$ ) are observed below the transition temperature To (0.4 K at H = 0) whose amplitudes vary linear with H and vanish at zero eld, providing the rst evidence for a modulated quadrupolar phase. For H < 1 T, a non-square modulated state persists even below 100 mK suggesting quadrupole moments associated with a 3 doublet ground state to be partially quenched by hybridization with conduction electrons.

In recent years, there has been a growing interest towards the role of orbital degrees of freedom in daswell as f electron system s. A num ber of unusual properties in transition metal compounds have been discussed on the basis of underlying orbital orders. In the case of 4f electron systems, the strong intra-atom ic spin-orbit coupling forces the magnetic and orbital degrees of freedom to be described in term softhe total angularm om entum J. For instance, an orbitally degenerate level carries quadrupole m om ents (rank-2 irreducible tensor operators in J). In a cubic (Oh) system, up to ve independent quadrupole m om ents are de ned (two  $_3$  type and three  $_5$  type operators) [1,2]. The orbital ordering in felectron systems, i.e., a spontaneous lifting of the orbital degeneracy by interactions, therefore is a phase transition of quadrupole m om ents. In reality, active quadrupole m om ents depend on the low-lying crystalline eld levels of the 4f ions.

Following magnetic orderings, one refers to uniform alignm ent of the quadrupolem om ent as a ferroquadrupolar state, whereas an ordering having a staggered quadrupolar com ponent is called an antiferroquadrupolar (AFQ) state. To date, however, the number of AFQ system swhose ordering structures and the order param eter (OP) are identied is still limited. They include  $CeB_6$  [3, 4], TmTe [5],  $DyB_2C_2$  [6, 7],  $UPd_3$  [8] and PrFe<sub>4</sub>P<sub>12</sub> [9]. Because of a lack of internal magnetic eld (tim e reversal sym m etry is conserved) and sm allness of the associated lattice distortion, there are only a few experim entalm ethods to explore the AFQ structure microscopically. Am ong them, neutron di raction in magnetic eld is a powerful method to investigate the AFQ OPs as well as the ordering wave vectors. In an AFQ phase, a uniform magnetic eld applied along a suitable direction generates a staggered magnetic moment which has the same periodicity with the underlying AFQ structure. Note that the direction of the induced staggered component is closely related to the sym m etry of the OP [2]. This technique has been applied successfully to m any of the AFQ compounds mentioned before to identify their OPs.

So far, all the AFQ structures known have simple q vectors (simple alternations of the quadrupole moments) [3, 4, 5, 6, 7, 8, 9]. One of the reasons for this could be the short range nature of quadrupolar interactions. Nevertheless, it has been argued theoretically that an indirect quadrupolar interaction of RKKY type m ight exist in some intermetallic systems [1, 10] and as a matter of fact, as pointed out recently, these indirect multipole interactions are responsible for the unusual properties of  $CeB_6$  [2, 11, 12]. In metallic systems, the existence of long range quadrupolar interactions would not rule out the possibility of modulated or incommensurate AFQ structures.

In the present study, we focus our attention on the interm etallic compound  $PrPb_3$  with the AuCu<sub>3</sub>-type cubic structure. The crystalline eld ground state of  $PrPb_3$  is a 3 non-Kramers doublet [13, 14], with a magnetic 4 triplet lying 15 19 K above the ground state [14,15,16]. Since the 3 doublet carries quadrupole moments  $O_2^0 = (3J_z^2 \quad J^2) = 2$  and  $O_2^2 = \frac{9}{3}(J_x^2 \quad J_y^2)/2$ ,  $PrPb_3$  is a good candidate for a quadrupolar transition. The compound exhibits a second-order transition at 0.4 K with a lambda-type anomaly in the specic heat [13,17]. Absence of a magnetic superlattice reection and a lattice distortion in the neutron direction measurement performed in zero magnetic eld [14] suggests the phase transition to be of AFQ type [18].

The idea of an AFQ ordering has further been strengthened by the H  $\,$  T diagram study [16], in which reentrant behavior with a signi cantenhancement of the transition temperature  $T_Q$  is observed for H k [100], as is often the case for AFQ ordering systems. A mean-eld analysis based on a simple two-sublattice model succeeded in reproducing the overall features of the reentrant phase diagram s of PrPb3 with an alternating alignment of the 3-type quadrupole moments as the possible OP. Shortly af-




FIG. 1: Evolution of the magnetic scattering in a eld of H = 4 T applied along the [001] direction, obtained in a temperature interval of 0.125 K < T < 0.81 K. The Q -scans were performed along the line  $(h^{\frac{1}{2}}0)$ , as indicated by a red arrow in the (hk0) reciprocal plane (inset) where open and closed circles represent the nuclear and the magnetic rejections observed at T = 0.125 K, respectively.

ter, angle-resolved m agnetization m easurem ents revealed characteristic eld-angular oscillations of  $T_{\rm Q}$  (H ), which can be interpreted by assuming O  $_2^0$ -type AFQ m oment and its equivalents to be the OPs at low H  $\,$  (< 7 T ) [19].

So far, no microscopic veri cation for an AFQ ordering has been obtained in this system. Our preliminary neutron di raction measurement in a [110] magnetic eld ((110) scattering plane) could not detect any eld-induced antiferrom agnetic rejection in the AFQ phase below 3 T [20]. In the present work, we have continued the experiment in a magnetic eld applied parallel to the [100] direction using a larger crystal of higher quality, and succeeded in observing eld-induced superlattice rejections which, as we will discuss below, to our surprise are associated with modulated quadrupole structures.

Single crystalline P rP b<sub>3</sub> was grown by the B ridgem an method. In the present study, a specimen with 10 mm diameter by 24 mm long was used. Neutron diraction measurements were performed using the ISSP triple-axis spectrometer GPTAS (4G) installed at the JRR-3M research reactor in Japan Atomic Energy Research Institute. More details of the experimental procedure will be published elsewhere.

Figure 1 shows the results of Q -scans along the  $(h\frac{1}{2}0)$  line carried out in a eld of H = 4 T at various temperatures ranging from 0.125 K to 0.8 K .O n cooling below the transition temperature  $T_Q=0.65$  K where quadrupolar ordering has been reported [16], strong superlattice reections appear at  $q_1=(\frac{1}{2}-\frac{1}{2}0)$  with 1=8.0 n further cooling below  $T_t=0.45$  K, i.e., the rst-order transition




FIG. 2: Field dependence of the square root of the  $(\frac{3}{8}\frac{1}{2}0)$  re ection intensity (circles) at T =  $0.32\,\mathrm{K}$ . The background was subtracted from the data. The intensity of the  $(\frac{1}{8}\frac{1}{2}0)$  peak (triangles) is also shown as a function of H . Small arrows indicate the direction of the eld scan.

tem perature found in magnetization [21] and specicheat m easurem ents[22], the third-order harm onic  $q_1^0 = (\frac{1}{2} \quad 3)$  $\frac{1}{2}$  0) with much weaker intensity is found to develop. Sim – ilar re ections were also observed at  $q_2 = (\frac{1}{2} \frac{1}{2})$  $q_2^0 = (\frac{1}{2} \frac{1}{2} 3 0)$  as well. The inset of Fig. 1 shows the (hk0) reciprocal plane (? H) investigated, where open and closed circles represent the nuclear and the magnetic re ections, respectively, observed in a eld of H = 4 T at T = 0.125 K . W e observed that the integrated intensity of the superlattice rejections has no signicant dependence on the angular direction of the scattering vector. We also carried out a sim ilar Q -scan experim ent at several elds, but could not observe any noticeable change in the relative intensity between the rejections at  $q_1$  and  $q_2$ . Hence a change in a domain population, if any, is con med to be very small.

K now ing that the dom ain population change is negligible, we may estimate the eld variation of the staggered component from the intensity of the  $(\frac{3}{8},\frac{1}{2},0)$  re ection. In Figure 2, we plot the square root of the scattering intensity (background subtracted) at T = 0.32 K as a function ofH. Keeping in m ind that the peak width is virtually independent of H, the square root intensity is proportional to the staggered component. The intensity vanishes at H = 0, consistent with the previous work reporting the absence of antiferrom agnetic scattering in zero eld[14]. The important point is that the staggered component develops proportional to H up to 2 T. This fact strongly indicates that the observed superlattice re ections arise from an induced antiferrom agnetic m om ent in the presence of an underlying AFQ ordering [23]. The present experiment thus con mms the AFQ ordering in PrPb3, and to the best of our know ledge, provides the rst evidence of a modulated ( & 0) quadrupolar ordering.

At around 2.1 T, we observed a jum p in the scattering intensity with an apparent hysteretic behavior, indicat-

ing an occurrence of a rst-order transition at this eld. A speciated with this transition is the 3rd-order harm onic  $\mathbf{q}_1^0$  as shown in Fig. 2. We found that this transition eld remains nite (  $1\,\mathrm{T}$ ) on cooling down to below  $100\,\mathrm{m}\,\mathrm{K}$ . It is important to note that no harm onic component is observed in the low eld phase.




FIG. 3: H T phase diagram of PrPb3 in a [001] magnetic eld. Open and closed triangles denote the transition points determ ined from the T- and H-scan measurements, respectively. For both cases, the upward and downward triangles represent the increasing and decreasing T (H) scans, respectively. A FQ I denotes the possible incommensurate structure with the wave vectors  $\mathbf{q}=(\frac{1}{2}-\frac{1}{2}~0)$  and/or  $(\frac{1}{2}~\frac{1}{2}-0)$ , ( $-\frac{1}{8}$ ). A FQ II denotes the antiphase structure as discussed in the text. The inset shows the temperature dependence of the center position of the magnetic rejection at around  $\mathbf{q}=(\frac{1}{2}-\frac{1}{2}~0)$  in a eld of H = 4 T, obtained on cooling below 0.75 K as shown by the arrow .

Figure 3 shows the H T phase diagram of PrPb3 for H parallel to [001] obtained by the present experiment. The quadrupolar transition line is de ned by the onset of the  $q_1$  and  $q_2$  superlattice re ections. The obtained phase boundary  $T_0$  (H ) agrees well with the phase line reported in the speci cheat and magnetization measurements [16, 21, 22]. Within the AFQ phase, we observed a rst-order phase transition characterized by the appearance of the  $q_1^0$  and  $q_2^0$  harm onic rejections. This transition line Tt (H) again agrees with the results of previous therm odynamical measurements [21, 22]. The inset of Fig. 3 shows the temperature dependence of the position  $\frac{1}{2}$  0) superlattice re ections in a eld of 4 T. In the tem perature range  $T_t < T < T_Q$  , takes a value slightly below 1/8. Upon the rst-order transition at  $T_t$ , exhibits a jum p to a value very close to 1/8. A Ithough m ore careful study would be needed, we expect that the phase below  $T_0$  is an incommensurate state and  $T_t$  is a lock-in tem perature into the comm ensurate state with = 1/8. Noteworthy, the  $T_t$  (H) line does not intersect with the abscissa for low T and the modulated phase continues to exist to T! 0 at low elds below 1 T.




FIG. 4: Field induced antiferrom agnetic m oments and the possible quadrupole structures along the [100] axis(y=0) in a [001] eld. (a) sinusoidal structure with  $q=(\frac{1}{2} \quad \frac{1}{2} \ 0)$ , and (b) antiphase structure with  $q=(\frac{1}{2} \quad \frac{1}{2} \ 0)$  and  $(\frac{1}{2} \quad 3 \quad \frac{1}{2} \ 0)$ . We assume that  $=\frac{1}{8}$  for simplicity. Uniform components are not included. The solid lines denote the amplitude of the staggered components, whose phase factor is arbitrarily chosen.

We now discuss possible magnetic and quadrupole structures of  $PrPb_3$  in a [001] eld. While the eldindependence of the relative intensity of the  $q_1$  and  $q_2$  reections favors a double-q structure, we cannot rule out the possibility of a single-q structure with two equally populated Q domains. The direction-independent scattering intensity within the (hk0) plane leaves two possibilities regarding the polarization of the eld-induced antiferrom agnetic com ponent AF; AF is either parallel to [001] or rotating in the (001) plane. A lthough the latter structure cannot be excluded from the present neutron scattering data alone, it is incompatible with the quadrupole OPs in the 3 doublet state and therefore we will not discuss this possibility here [2]. In the former case, the alignment of  $_{
m AF}$  along the [100] axis is given in Figure 4 by the thick arrows, where we assum e = 1/8for simplicity. The observed superlattice rejections below  $T_0$  (AFQ I) is best described by a sinusoidally modulated antiferrom agnetic structure as shown in Fig. 4(a). The amplitude of the staggered moment is determined ing a single-q structure. Below Tt (H), this state undergoes a rst-order transition into an antiphase structure (AFQ II) as shown in Fig. 4 (b) which is accompanied by third harm onic rejections at  $q_1^0$  and  $q_2^0$ . The polarization of AF k [001] (angular m om entum operator  $J_z$ ) is compatible with the quadrupole moment  $0^0_2$  [2], being consistent with the analysis of the recent angle-resolved  $T_{\rm O}$  (H ) m easurement[19]. Since the eld-induced  $_{\rm A\,F}$  is proportional to the AFQ OP [23], it is concluded that

the O $_2^0$  m om ent should show a sim ilar sinusoidal oscillation in this phase as schem atically illustrated in Fig. 4(a) where the solid line represents the amplitude of the O $_2^0$  m om ent. Below  $T_t$ , the O $_2^0$  m om ent would also take the antiphase structure as shown in Fig. 4(b).

Recalling that  $PrPb_3$  is a  $_3$  non-K ram ers doublet ground state system, it is reasonable that the system undergoes a phase transition from the sinusoidal to the antiphase structures at low T. In general, the sinusoidal structure is stable only at a high tem perature region below  $T_0$  where therm al uctuations are dominant, and gives way to the antiphase (square) structure in the ground state to reduce the entropy, as is often seen in m agnetic ordering system s. Calling back the phase diagram in Fig. 3, however, we nd that the non-square m odulated phase persists down to the experim ental accessible temperature of 100 mK in low elds below 1 T, without any indication of further transition. This observation is hardly understood within the framework of a localized f electron model in which the (pseudo) degeneracy with respect to the 3 doublet would remain in a part of Pr sites. Sim ilar phenom ena of non-antiphase m odulated structures persisting toward T ! 0 have also been reported in  ${\tt m}$  agnetic K ram ers com pounds, in  ${\tt w}$  hich a Kondo screening e ect is considered to be relevant for stabilizing such states at T = 0 [24, 25]. The analogy to those magnetic systems strongly suggests that

the local quadrupole m om ent in  $P ext{ rP } b_3$  should be partly quenched in the modulated phase at very low T due to

the quadrupole K ondo e ect.[26] Possibility of the K ondo e ect associated with the orbital degeneracy has been discussed in several U- and P r-based systems [27, 28, 29], but is still not well established experimentally. Very recently, it has been recognized that the strong hybridization e ect between Pr 4f and conduction electrons does exist in some of the P r-based skutterudites, leading to heavy fermion behavior and unconventional superconductivity [30, 31]. The present results on  $PrPb_3$  would provide another piece of evidence for the K ondo e ect in Pr (4f²) systems [32]. It would be interesting to examine the low energy excitation of this system at very low temperatures.

In sum m ary, neutron di raction experim ent in a m agnetic eld has revealed a m odulated quadrupole strucuture in  $PrPb_3$  which persists as T!0 at low eld. The results suggest a K ondo screening of the quadrupole moments of  $Pr^{3+}$  in the ground state.
