Clarens Client and Server Applications

This paper describes Python, ROOT, Iguana and browser-based clients for the Clarens web services fram ework. Back-end services provided include le access, proxy escrow, virtual organization management, Storage Resource Broker access, job execution, and a relational database analysis interface.

1. Introduction

The Clarens web services platform, described in a companion article, [15] acts as a go-between for distributed clients on the wide area network to access services using the widely XML-RPC and SOAP data serialization standards on top of the lower-levelHTTP protocol. Its usefulness must ultimately be measured by the usefulness of the services and clients them-selves.

This paper is divided into two parts describing the currently im plem ented services as well as clients taking advantage of these services.

2. Services

A rather terse overview of the current C larens services are given below. The reader is referred to the C larens web page [2] for full docum entation of all methods and modules.

2.1. File access

A coessing les on a rem ote machine remains the most useful service any middlew are product can provide. This is evident from the more than 40 million web servers that are deployed worldwide [6]. Although the percentage of static les served is hard to gauge, the SPEC web99 [13] benchmark puts this number at 70% of requests.

Clarens serves les in two di erent ways: in response to standard HTTP GET requests, as well as via a file.read() service method. A virtual server root directory can be de ned for each of the above via the server con guration le which may be any directory on the server system.

The file.read() method takes a lename, an oset and the number of bytes to return to the client. Error message are returned as serialized RPC responses. Network I/O is handed o to the web server, which uses the zero-copy sendfile() system call where available to minimize CPU usage and increase throughput.

directory information, and file.md5() to obtain a hash value for checking le integrity.

2.2. Proxy escrow

Despite the use of asymmetric key cryptography, keym anagement remains a problem, with private keys and certicates (credentials) having to be present on the client system. In the case where the same credentials must be used from dierent places, e.g. a person's desktop, laptop and other computer systems, this is inconvenient, as well as degrading the security of the credentials.

In analogy to the M yP roxy [5] project, C larens offers the ability to store and retrieve short-lived, self-signed certicates (called proxy certicates in Grid-oriented literature).

RPC The ΑPΙ provides the m ethods proxy.store(), proxy.retrieve(), proxy.delete() for managing stored proxy certi cates. Combinations of private key/certi cate pairs or proxy/certi cate pairs may be stored in this way, with the certicate distinguished name (DN) acting as a unique identi er. The credential information is stored in encrypted form using a symmetric cipher using a password provided when invoking the store method. The password itself is not stored, for obvious reasons.

From the above it should be obvious that this approach presents a chicken-and-egg problem of having to present credentials in order to obtain credentials. This may be solved in two similar ways. As demonstrated during the oral presentation, a web portal m ay be constructed that takes input from the user and acts as an interm ediary to log into the C larens server in question and retrieve the credentials. This can be done with the portal residing on an arbitrary machine. Secondly, the ability of Clarens to respond to HTTP GET requests (i.e. act as as sim ple web server) m ay be used to construct such a portal on the C larens server itself, which has access to the server methods as an unprivileged user. These web portals may also be accessed program matically from within programs or scripts.

m ay be perceived as less secure than keeping the credentials on possibly multiple systems' as les or in web browsers.

2.3. Virtual organization management

The C larens authentication architecture [15] is built around the concept of a hierarchical virtual organization (VO) of groups and subgroups of individuals identied by unique distinguished names (DNs). These individuals may be both people or servers.

To ease adm inistration of the VO, a set ofm ethods is provided in the group module to create, delete, and list groups and their mem bers and adm inistrators.

The most important of these methods are described in Table I.

In addition to managing the VO structure, the group module also provide methods to store, retrieve and search for certicates. Certicate Authority certicates may similarly be searched and retrieved, but not stored, since these certicates are used to ensure the uniqueness of client distinguished names. Instead, CA certicates are managed by the system administrator in the form of less tored in a designated directory.

2.4. Access control management

The Clarens authorization architecture is built around the concept of hierarchical access control lists for RPC m ethods [15]. To adm inister these ACLs, m ethods are provided to create and modify lists

2.5. Storage Resource Broker access

The SD SC Storage Resource Broker (SRB) provides a uniform interface to external applications to access various storage media, including local and remote le systems, and tape storage. It is also a client-server system, with Clarens acting as an SRB client on behalf of its own clients. The Clarens SRB API provides methods to initialize a connection to the SRB server and browse, store, and retrieve les.

This interface is not currently deployed, however, since it exposed a critical in pedance m ism atch between these two client-server systems: Clarens uses an entirely stateless connection protocol, while SRB uses a stateful protocol. This means that in the current in plan entation a new SRB connection must be initiated upon each method invocation by the Clarens client, which results in very poor perform ance.

W ork is underway to remedy this m ism atch by utilizing C larens agents that can hold persistent connections to SRB on behalf of clients. A nother approach being considered is to implement a stateful protocol interface to C larens itself.

2.6. Job execution

Next to le access, the ability to execute jobs on a rem otem achine rem ains one of the cornerstones of distributed computing. U sing the C larens distinguished name to system user mapping [15], system commands can be executed by rem ote users.

Clarens makes use of a small compiled program, called suexec to change the perm issions of the resulting process. This program can be more easily audited for security. Upon receipt of a shell command, a directory owned by the remote user is created where the command's output and errorm essages are stored. The working directory of the resultant process is also changed to this directory, and any newly created les may be accessed remotely using a job ID which is managed by Clarens.

It should be pointed out that this interface is not designed to schedule jobs on Clarens servers, but is mostusefulforhanding jobs to the schedulers (e.g. [3], [8]) them selves, and retrieving the resultant output les.

This interface is currently used to develop interactive rem ote analysis using the CMSORCA analysis package, where analysis jobs them selves become Clarens servers (albeit less featureful ones) that can act as personal rem ote application servers to allow in-

2.7. Relational database analysis interface

An interface to the Stlbased Object Caching And Transport System (SOCATS) being developed by Caltech, allows remote users to query large Physics datasets using standard relational database (SQL) queries.

SOCATS results are returned in the form of a object le form atted as a ROOT [10] tree, which can be retrieved by the above-mentioned le access methods. A ROOT interface to Clarens is also described below, which was successfully demonstrated at the 2002 Supercomputing conference.

3. Clients

One of the express aim s of the Clarens architecture is to use widely deployed interfaces to lower the implementation barrier for new client applications. The availability of HTTP and SSL and SOAP/XML-RPC implementations on most platforms and program mings languages helps us achieve this goal fairly easily.

3.1. Python

Python [9] is a weakly typed, object oriented scripting language. Its programs are compiled to a platform-independent byte-code, similar in many ways to Java. It's built-in support for both HTTP, SSL, and XML-RPC, combined with the rapid prototyping abilities inherent in a scripting language made it natural to be used as the default client-side development language.

The P ython C larens client is in plemented as a pure P ython class, called clarens_client that takes an argument for the server URL, and optionally the certicate and private key les to be used in the connection to its constructor method. The constructor method initiates a connection with the server an authenticated the user using the credentials stored in the standard places by the G lobus toolkit, including proxy credentials if they exist, or those provided to the constructor method.

The clarens_client object maps all non-local method calls to remote procedure calls, handling serializing/descrializing of the method arguments and return values transparently. The following example of the echo.echo() method demonstrates this:

I.e. the echo.echo() rem ote method is invoked directly from the command line, and the result is returned as a native Python string to the caller. The result is always returned as a list, indicated by the square brackets.

3.2. **ROOT**

The object-oriented modular architecture of the ROOT [10] analysis package, combined with its rich set of built-in objects and wide adoption in the high energy physics community makes it a very useful client for remote analysis functionality.

In analogy to the Python client ,C larens ROOT client handles authentication transparently, and provides the user with a C larens object to communicate with the remote server. This client does not do automatic serialization/deserialization of arguments and return values to native ROOT objects, a lower level interfacem ust be used instead for general remote procedure calls.

It does, however, provide a convenient interface to read remote les using the Clarens server, via a TCWebFile object derived from the native TFile object. This object provides all the functionality of the local version, allowing transparent analysis of remote les from the ROOT command line, scripts or compiled code by changing only the object type. Using the interactive ROOT object browser it is possible to browse the structure and content of remote ROOT les quickly and easily, with the ability to display histograms and other types of plots contained in the re-

The TFile base class supports a dynamic local caching mechanism that is used to optimize letransfers, so that the extremes of transferring the whole remote leto the local client, as well as making a remote procedure call for small parts of the lecan be avoided, striking a balance between bandwidth and latency constraints.

m ote les interactively or program m atically.

Another convenience class is the TCSystemDirectory, derived from the TSystemDirectory base class. This class provides an interface to the directory browsing functionality in the Clarens file module, allowing the client to interactively traverse the remote directory structure using the ROOT object browser. Any remote ROOT

les m ay be opened by clicking on their icons in the browser. The TCSystemDirectory class may also be used program matically from ROOT scripts or compiled C++ programs.

3.3. IGUANA

IGUANA is an interactive visualization toolkit,

Physics DataGrid project [7]. Clarens development is hosted by SourceForgenet [11].

3.4. Browser interface

The web browser is currently the most widely used distributed computing tool, bar none. Modern browsers have native support for SSL-encrypted connections and client-side certicate authentication, making it an ideal platform for a C larens interface.

A firer initial experiments with using client-side Java applets for communicating with the server, it was decided to use the Javascript language embedded in most browsers to handle this task. Since Clarens is able to serve web pages in response to HTTP GET requests, the browser interface is implemented as a series of static web pages that embed Javascript scripts to handle communication and interface display using dynamic HTML. This implementation eliminates the need for clients to installany additional software apart from a web browser, which most people already have.

The browser interface uses XML-RPC for data serialization since it is by far simpler than the more complex SOAP protocol. As with the Python interface, argument and return value serialization/deserialization is handled transparently by the provided Javascript libraries, made easy by the object oriented, loosely typed nature of the language.

Functionality currently provided include browsing a rem ote le repository, with the ability to download les, and virtual organization management.

4. Conclusion

Clarens provides a growing functionality for doing distributed computing in a Grid-based environment. Couple with a set of useful client implementations, it is hoped that it will become a exible solution to a wide range of distributed computing problems.
