# D iam onds's Tem perature:

Unruh e ect for bounded trajectories and therm altime hypothesis

#### A bstract

We study the Unruh e ect for an observer with a nite lifetime, using the thermal time hypothesis. The thermal time hypothesis maintains that: (i) time is the physical quantity determined by the ow dened by a state over an observable algebra, and (ii) when this ow is proportional to a geometric ow in spacetime, temperature is the ratio between ow parameter and proper time. An eternal accelerated Unruh observer has access to the local algebra associated to a Rindler wedge. The ow dened by the Minkowski vacuum of a eld theory over this algebra is proportional to a ow in spacetime and the associated temperature is the Unruh temperature. An observer with a nite lifetime has access to the local observable algebra associated to a nite spacetime region called a \diamond". The ow dened by the Minkowski vacuum of a (four dimensional, conformally invariant) quantum eld theory over this algebra is also proportional to a ow in spacetime. The associated temperature generalizes the Unruh temperature to nite lifetime observers.

Furtherm ore, this tem perature does not vanish even in the lim it in which the acceleration is zero. The tem perature associated to an inertial observer with lifetim e T , which we denote as \diam ond's tem perature", is  $T_D = 2 \sim k_B T$ . This tem perature is related to the fact that a nite lifetim e observer does not have access to all the degrees of freedom of the quantum eld theory.

## 1 Introduction

This work has two motivations. First, to study the Unruh e ect<sup>1</sup> for an observer with a nite lifetime. Second, to probe the thermal time hypothesis<sup>2</sup>. The Unruh e ect is the theoretical observation that the vacuum state of a quantum eld theory on M inkowski spacetime looks like a thermal equilibrium state for an uniformly accelerated observer with acceleration a. The observed temperature is the D avis-Unruh temperature  $T_U = \text{-a=2} \text{ k}_D c$ , and is closely related to H aw king's black hole temperature (c is the speed of light, -and kb are the P lanck and B oltzm ann constants.)

There exist many derivations of the Unruh e ect. 3,4 One generally assumes that the observer moves over along an in nite worldine of constant acceleration. A model detector moving on this world line and interacting with the vacuum state of the eld becomes excited and reaches a thermal state. For a free eld, this can be computed integrating the two-point functions along the in nite trajectory. A Itematively, one can consider the region causally connected to the world line. This region is the R indler wedge W . A quantization scheme for the eld restricted to W leads to the

de nition of particle states. The conventional vacuum is a thermal distribution state of these particle. A nother approach is based on B isognano-W ichm an theorem  $^{5;6}:$  W orld lines of uniform ly accelerated observers in W , param etrized by proper time, are orbits of the action of a one-param eter group, which can be interpreted as the time ow of the accelerated observers. The vacuum state is a KMS state with temperature  $T_{\rm U}$ , with respect to this time ow, over the algebra of the local observables in W . Intuitively, the reason the accelerated observer does not see a pure state can be viewed as related to the fact that he has no access to part of . Each observer instantaneity surface is cut into two parts by the edge of the wedge. The degrees of freedom of the eld on the other side of the edge are inaccessible to the observer. Since has vacuum correlations across the edge, the two sets of degrees of freedom on the two sides of the edge are entangled. The restriction of to the edge interior, therefore, fails to be pure a state.

Doubts have been raised on the universality of the Unruh elect, for instance in Ref.[7]. One of the sources of the doubts is that most derivations of the elect consider in nite trajectories, while the trajectories of realistic detectors have a beginning and an end. In our opinion, the theoretical support for the Unruh elect is rather robust, and these doubts do not have much consistency. Nonetheless, the issue of observers with nite lifetime is interesting. The region causally connected to a nite trajectory is far smaller than W. Typically, it is the intersection of the future of the beginning point of the trajectory with the past of its end point. Such a region is called a \diam ond". In suitable Lorentz coordinates  $x = (x^0; x)$ , any diam ond can be represented as the region D<sub>L</sub>, with L > 0, defined by

T=2L is the lifetime of the observer if he m oves inertially. In a sense, only the nite region D  $_L$  can take part in the thermalization process. M ore precisely, the observer has access only to the degrees of freedom of the eld that lie within  $j \times j < L$  on the  $x^0=0$  simultaneity surface. Does this observer see a thermal state? Is there a sense in which there is an associated temperature? These questions can be addressed in a variety of ways. Here we consider the possibility of adapting the B isognano-W ichm an approach to this case.

Let us now come to the thermal time hypothesis. Consider a system with a large number of degrees of freedom. We describe our experimental know ledge of its state as a statistical state. A generic state determines a ow: In quantum theory, a state over an observable algebra determines a ow called the modular ow, or the Tomita ow. In the classical case, the relation between a state and a its modular ow reduces to the relation between the distribution on phase space representing the state and the Hamiltonian ow of ln. The thermal time hypothesis demands that the ow determined by the statistical state coincides with what we perceive as the physical ow of time. A second part of the hypothesis refers to the special cases in which a geometrical background provides an independent notion of temporal ow: if the geometric ow and the modular are related, the ratio of the rates of the two ows is identiced as the temperature. The hypothesis was initially motivated by the problem of time in quantum gravity.

The Unruh e ect can be interpreted as an example in which the thermal time hypothesis is realized. The relation between the Unruh e ect and the thermal time hypothesis is the following. The vacuum state , restricted to the algebra of the observables in the wedge W generates a modular ow. This modular ow is precisely proportional to the proper time ow of uniformly accelerated observers. For each observer, the ratio of the two ows is  $T_{\rm U}$ . A coording to the thermal time hypothesis, this means that the natural physical time generated by on the algebra of the observables in the wedge is the proper time of an accelerated observer, and the corresponding temperature is the D avis-Unruh temperature.

A natural question, then, is whether there are other cases in which the thermal time associated to a spacetime region has a physical meaning. Local algebras associated to diamonds are very

natural objects in algebraic quantum eld theory. As mentioned, a diam ond is the region causally connected to an observer with nite lifetime. It is natural to wonder whether the modular ow generated by the vacuum restricted to the local algebra associated to a diam ond {the \diam onds' ow ", or the \diam onds' time" { may have any signicance at all.

In general, there is no reason to expect that a modular ow should have a geometric interpretation and lead to a notion of temperature. Remarkably, however, the modular ow of a diamond is associated to a geometric action in the case of a conformally invariant quantumed he directly proportional to the proper time along the geometric ow, because the modular parameter runs all along R while the proper time of an observer in  $D_L$  is bounded. However, we can nevertheless de neal local temperature as the local ratio of the two ows. This allows us to de neatemperature which is a natural generalization of the Unruh-Davies temperature to observers with a nite lifetime. In this paper we explicitly compute this temperature. For xed acceleration, this temperature reduces to the Unruh temperature when L is large.

Furtherm ore, this tem perature does not vanish even for non-accelerating observers. The (m in-im all) tem perature associated an inertial observer with lifetim e T is the tem perature

This tem perature is related to the fact that a nite lifetime observer does not have access to all the degrees of freedom of the eld. But we leave the precise physical interpretation of this tem perature for future investigations. In particular, it would be interesting to study whether it is related to the response of model detectors.

Section 2 brie y presents our main tools (de nition of local observable algebra, modular autom orphism and KMS condition) and the thermal time hypothesis. In Section 3, we recall the discussion of the Unruh e ect in the Bisognano-Wichman approach. Section 4 presents our new results, namely the discussion of the generalization of the Unruh e ect to diamonds D L and its physical interpretation. Section 5 brie y discusses the case of the future cone. Minkowski metric has signature (+; ; ; ). From now on, we take  $c = - k_b = 1$ .

#### 2 Tools

### 2.1 Local observable algebra

Consider a quantum eld theory on four dimensional Minkowski space. We restrict our attention to conform ally invariant quantum eld theories. The conform algroup is the group of transform ations  $x \ 7 \ x^0$  that preserve the causal structure:  $(x^0 \ y^0)(x^0 \ y^0) = 0$  i  $(x \ y)(x \ y) = 0$ . In four dimensions, this is the freen-parameters group generated by Poincare transform ations, dilatations and proper conform altransform ations. An in nitesimal transformation is given by

where (! = ! ;a; ;k) are in nitesim alparam eters. We assume that both the dynamics and the vacuum of our quantum eld are invariant under these conformal transformations. Since mass terms break conformal invariance, this means that we are dealing with a massless eld. Equivalently, we are considering a regime in which masses can be neglected.

We recall a few elements on local observable algebras. 6;15 We have a Hilbert space H carrying a unitary representation U of the Poincare group. If the theory is conformally invariant, U extends to

a representation of the entire conform algroup. There is a ray in H , called the physical vacuum , invariant under the action of the Poincare group (or the conform algroup). A eld is an operator valued distribution over M inkow ski space M . There is no operator corresponding to the value (x) of the eld at a given point x; there is an operator (f) corresponding to the quantity obtained sm earing out the eld with a sm ooth function f

Consider a nitely extended open subset 0 of M . The algebra generated by all operators (f), where f has support in O, is interpreted as representing physical operations that can be performed within O. By completing this algebra in the norm topology, we obtain a C-algebra R (O). This is called the local observable algebra associated to O. We have an algebra R (O) associated to each open subset O. The Reeh-Schlieder theorem states that the vacuum is a cyclic and separating vector for R (O) as soon as the causal complement of O (the set of all points which lie space-like to all points of O) contains a non-void open set.  $^{1}$ 

## 2.2 M odular autom orphism s

The Tom ita-Takesaki theorem associates a preferred ow  $_{\rm S}$  to any C -algebra A acting on a H ilbert space with a preferred cyclic and separating vector . The ow is built as follows. Let S be the conjugate linear operator from A to A

for any a 2 A . S is closeable with respect to the strong topology and its closure – still denoted by S – has a unique polar decomposition

where is a selfad joint positive operator (unbounded in general) called modular operator and J is antiunitary. This allows us to de ne a one-parameter group of automorphisms of A: the modular group  $_{\rm S}$  of A associated to

(see [14] for details on the de nition of  $^{is}$ ) with s 2 R . If A is the algebra of local observables on an open set O of M inkow ski space, with non-void causal complement, we call modular group of O the modular group of R (O) associated to the vacuum . We denote it as  $_{s}$  (O). We write (O) for the corresponding modular operator.

#### 2.3 KMS condition

Let us now recall the relation between modular ow and thermodynamics. Consider a physical system with a nite number of degrees of freedom, say N particles in a nite box with volume V. In statistical physics, an equilibrium state is a state of maximal entropy. If H is the ham iltonian describing S, the mean value of any observable a when S is in an equilibrium state at inverse temperature is

is cyclic but not separating for the algebra associated to the entire M inkow skispace M. Intuitively, a separating state can be thought as a density matrix with nonvanishing components on all basis states.

Consider now the therm odynam ical lim it of this system: send the volume of the box V and the number of particles N to in nity, keeping the density N=V xed. In this lim it the total energy E goes to in nity and therefore the partition function (9) is no longer de ned. One therefore needs a way to characterize the equilibrium states alternative to equations (8) and (9). This can be obtained as follows. An equilibrium state! of inverse temperature can be directly characterized as a state over the algebra satisfying the KMS condition. This requires that for any two observables a and b

A state! satisfying these conditions is called KMS with respect to the time translation  $_{\rm t}$ . One can shows that both conditions (10) and (12) reduce to (8) in the case of a nite dimensional system. These conditions represent the correct extension of the de nition of an equilibrium state to in nite-dimensional systems.

Now, the remarkable fact is that, given a C-algebra A acting on a Hilbert space H with a cyclic and separating vector, the faithful state! over A de ned by

we obtain condition (10) (as far as (12) is concerned, see ref. [6]). In other words: an equilibrium state at inverse tem perature—can be characterized as a faithful state over the observable algebra whose modular automorphism—group— $_{\rm S}$  is the time translation group. The modular parameter s is proportional to the time t. The proportionality factor is minus the inverse temperature. (The minus sign is there only for historical reasons: the mathematicians have dened the modular ow with opposite sign than the physicists).

#### 2.4 Therm altime hypothesis

The modular group equips a system in a generic state with a dynamics. The existence of such an intrinsic dynamics suggests a solution to a longstanding open puzzle in the physics of general covariant systems. The dynamical laws of a generally covariant system determine correlations between observables, but they do not single out any of these observables as time. This \timeless" structure is su cient to provide all dynamical predictions. However, this timeless structure leaves us without any understanding of the physical basis for the low of time, a low that has evident

observable e ects particularly in them odynam ical contexts. The them altime hypothesis is the idea that there is no dynam ical basis for the ow of time, but there is a therm odynam ical basis for it. M ore precisely, a generic state determines a modular ow, and it is this ow that represents the physical basis of the ow of time. This ow is state dependent. Thus:

The physical time depends on the state. When the system is in a state!, the physical time ow is given by the modular ow of!.

The second part of the hypothesis dem ands then that if the modular ow is proportional to a ow in spacetime, parametrized with the proper time, then the ratio of the two ows is the temperature

In other words, when t is independently de ned, (17) becomes a denition of the temperature. In previous applications of this idea, only cases in which  $\frac{1}{s}$  is exactly constant along the low were considered. In this paper, we extend the framework slightly, by considering a case in which the modular low is proportional to a low in spacetime, but the constant of proportionality between  $\frac{d}{ds}$  and  $\frac{d}{d}$  varies along the low. In such a situation, it is natural to consider a local notion of temperature, defined at each point by

The therm altime hypothesis is based on the idea that the origin of time is therm odynam ical, and that the time ow is state-dependent. In a sense, the therm altime hypothesis is an inversion and a generalization of KMS theory. Given a time ow , KMS theory identies the therm alstates as the KMS states of the time ow. But given the KMS state, the time ow is precisely its modular ow. Since any generic state de nes a modular ow, the idea here is that, generically, this modular ow is in fact the physical time that governs macroscopic therm odynam ics.

As far as conventional systems are concerned, notice the following remarkable fact: if we measure the statistical distribution of an equilibrium state, we can infer the ham iltonian from the result. We can then denetime as the parameter of the own generated by the ham iltonian. This provide an operational characterization of time. On the other hand, it is well known that it is dicult to provide a purely dynamical (as opposed to statistical/them odynamical) characterization of what is time. In a generally covariant context, where denitely no physical time is determined by the dynamics, the them altime hypothesis identies the physical time as the modular own for generic states.

The thermal time hypothesis has been checked in several examples. The most striking one concerns the cosm ic microwave background (CMB). The statistical state distribution describing the CMB determines a ow that coincides with the time coordinate of usual Friedman-Robertson-Walkermetric. The associated temperature is the CMB temperature. The Rindlerwedge provides another example in which the hypothesis is realized.

For a detailed discussion of this issue and the motivations of the thermal time hypothesis, see refs. [2,8]. On the large literature on problem of time in general relativity see for instance ref. [9] and references therein.

# 3 Time in the Rindler Wedge

Consider a uniform ly accelerated observer. For simplicity, let us assume that the motion is in a plane with constant  $x^2$  and constant  $x^3$ , and that the acceleration four-vector writes (0;a;0;0) in

where C and  $C^0$  are constants. W ith a Poincare transform ation, we can take C and  $C^0$  to zero

That is, (a) generates a proper-time translation of proper time along the accelerated world line.

Consider a quantum eld theory de ned on M and let K denote the representation of the generator of this boost, so that

can be viewed as an operator that generates the evolution in proper-time seen by the accelerated observer.

The region causally connected to the accelerated observer, namely the set of the points that can exchange signals with a uniform by accelerated observer is the R indler wedge  $\mathbb{W}$ , de ned by

The wedge W has a non void causal complement thus the modular group  $_s$  (W) is dened. The modular operator (W) is known  $^5$ . It corresponds precisely to a Lorentz boost

therefore the modular ow  $_{\rm s}$  (W ) (de ned in (7)) is given by the boost

This ow is precisely proportional to the geometric ow (27). The relation between the modular parameters and the propertime is obtained comparing the two operators: a translation by s generates a shift in propertime

The result is therefore that the state , restricted to the R indler wedge generates a time ow which is the one of an accelerated observer, with an associated temperature which is the Unruh-D avis temperature.

## 4 The time of the diam onds

# 4.1 Diam ond's modular group

Consider now an observer that lives for a nite time. Let  $x_i$  be the event of his birth and  $x_f$  the event of his death, which is in the past of  $x_i$ . To begin with, assume that the life of the observer is the straight segment from  $x_i$  to  $x_f$ . Let

be the observer lifetime, namely the propertime between  $x_i$  and  $x_f$ . Let D be the region which is in the past of  $x_f$  and in the future of  $x_i$ . This region is called a D iam ond. It is the region with which the observer can exchange signals during his lifetime: he can send a signal, and receive a response, to each point of D. Imagine that the observer sends out measuring apparata on spacecrafts to make local measurements on the quantumeld, and receives back the signals from his apparata. Then he will be capable of observing, at most, the local observables in D. The local algebra to which he has access is therefore R (D). Assuming that the quantumeld theory is in its vacuum state, we can ask what kind of state will this observer observe. The answer is the restriction of to R (D). Let us therefore study the properties of this restriction.

W ith a Poincare transform ation, we can always choose M inkowski coordinates such that

U sing this map, it is im mediate to and out the modular ow  $_{\rm S}$  (D) of the diamond local algebra R (D): this is simply obtained by mapping the modular ow of the wedge to the diamond. More precisely, we consider the one parameter group of transform ations  $_{\rm D}$  () of the diamond into itself given by

This generalizes easily to a diam ond D  $_{\rm L}$  of arbitrary dim ension L > 0. The m odular operator (D  $_{\rm L}$ ) is the representation of the conform all transform ation  $_{\rm D_L}$  ( ) = L  $_{\rm D}$  ( )L  $^{\rm 1}$  where L is the dilatation by a factor L . Explicitly

# 4.2 Temperature

The orbits of the modular group of the diamond are uniformly accelerated trajectories. Indeed, consider a uniformly accelerated observer moving from  $x_i$  to  $x_f$  with acceleration a. For simplicity, assume that the motion is in the plane  $x^2 = x^3 = 0$ . Its worldline is given by (20) with  $C^0 = 0$  and

The line of universe (43) is precisely an orbit of the diam ond's modular group  $_s(D_L)$ . Let us x the origin of the modular parameter s so that s=0 when s=0. This gives s=0 with s=0 with simple algebra,

We have therefore two parameterizations of the same worldline. One (43) given by the proper time  $2 \ 0$ ; 0; 0; the other (45) given by the modular parameter =  $2 \ s2 \ 1$ ; +1 [. To not the relation between these two parameterizations, we can compare x () with x (). This gives

$$x^0 = a^1 sha = \frac{La^1 sh}{a^1 ch};$$
 (47)

$$x^1 = a^1 cha + C = \frac{L^2}{C a^1 ch}$$

It is convenient to write arcshaL, so that aC = ch . U sing this, we have

This gives

$$\frac{d}{d} = \frac{L}{dh + dh}$$

Recalling that = 2 s, and the de nition of we conclude

$$\frac{d(s)}{ds} = 2 \frac{d(s)}{ds} = \frac{2 L}{ds + ds} = \frac{2 L}{1 + a^2 L^2 + ds};$$
 (52)

The therm altime hypothesis (19) de nes the tem perature

(s) = 
$$\frac{d}{ds} = \frac{2 L}{1 + a^2 L^2 + ch (2 s)}$$
: (53)

Noticing from (45) that  $=\frac{2}{La}x^{1}$ , we can use (43) to rewrite this inverse temperature as

( ) = 
$$\frac{2}{La^2}$$
 (  $\frac{p}{1 + a^2L^2}$  cha ) (54)

In particular, at  $x^0 = 0$ , that is s = 0, we have

$$_{0} \qquad (0) = \frac{2 \text{ L}}{\text{a}^{2}\text{L}^{2} + 1 + 1} : \tag{55}$$

We analyze the meaning of this result in the following two sections.

## 4.3 Unruh e ect for the observer with a nite lifetim e

First, consider the case in which a is large. This corresponds to orbits that stay near the boundary of the diam ond. In particular, at  $x^0 = 0$  the observer is near the edge jxj = L of the diam ond. In the lim it of large a, we have

$$_{0}=\frac{2}{a}; \tag{56}$$

which is the D avis-U nruh tem perature. Therefore, the therm altime hypothesis associates precisely the D avis-U nruh tem perature to a uniformly accelerated observer with a nite lifetime that passes near the edge. For xed acceleration a, an observer with nite lifetime, in the middle of his life, observes the D avis-U nruh temperature if his lifetime 2L is large enough. The rst order correction in 1=L gives

$$_{0} = \frac{2}{a} \quad \frac{2}{a^{2}L};$$
 (57)

while the exact formula for every L is given by (55). This result provides a complete generalization of the Unruh e ect to observers with nite lifetime. In order to better appreciate this result, consider the dependence of the temperature from the proper time. In the limit of large L, this is given by

$$() = \frac{2}{a} \quad 1 \quad \frac{\text{ch (a)}}{aL} \quad :$$
 (58)




Figure 1: The inverse tem perature as a function of the proper time seen by the accelerated observer with nite, but long, lifetime L (acceleration is a = 1).

In Figure 1 we have plotted this function in the  $\,$  nite region of the observer proper time. Notice that the function goes rapidly to zero at the boundaries of the interval of the life of the observer, but it is nearly  $\,$  at over most of the region. That is, for the observer measuring his proper time,  $\,$  ( ) is constant and  $\,$  0 for most of his lifetime.

## 4.4 Diam ond's temperature

Next consider the case in which, for a given lifetime T, the acceleration is small. In particular, consider the case in which a=0. This is the observer moving along a straight line from  $x_i$  to  $x_f$ . Interestingly, the tem perature associated to this observer does not vanish. The inverse tem perature reaches a maximum value at  $x^0=0$ , which is

$$_{D} = L:$$
 (59)

Therefore the thermal time hypothesis associates the nite temperature

$$T_D = \frac{1}{D} = \frac{2}{T} \tag{60}$$

to an observer with a nite lifetime T. Inserting back the dimensional constants  $s_i^*$  and  $k_b$ , we get equation (2). What is the meaning of this temperature?

It is tempting to conjecture that this temperature is due to the fact that the observer cannot observe all the degrees of freedom of the quantum eld. In particular, he can only observe the degrees of freedom that at time zero are inside the sphere  $j \times j < L$ . Because of the quantum eld theoretical correlations between the inside and the outside of this sphere, the vacuum state restricted to this sphere is not a pure state. If this is correct, there should be a physical temperature naturally associated to observers with a nite lifetime, whether they are accelerating or not. We leave the study of this idea for future investigations.

# 5 Future cone

For completeness, we describe here also an observer that is born at  $x_i$  and lives forever. The region causally connected to this observer is the future cone  $V^+$  of  $x_i$ . Since this has a non void causal complement, the vacuum restricted to  $V^+$  is a separating state and we can search the action of its modular group  $_s(V^+)$ . In fact this action is also geometrical. Taking  $x_i$  in the origin, it corresponds to the dilatation  $^6$ 

$$x \ 7 \ x \ (s) \ e^{2 \ s} \ x :$$
 (61)

As for the wedge and the diam ond, we can interpret the orbits of this action as motions of a physical observer. An inertial observer with constant speed  $v = (v^1; v^2; v^3)$  with respect to the origin, which leaves the origin at v = 0 follows the world line

$$x () = K$$
 (62)

where K  $^0$  c , K  $^i$  =  $v^i$  with  $(1 \frac{v^2}{c^2})^{-\frac{1}{2}}$ . The (closure of the) line of universe (61) for s 2 R coincides with the line of universe (62) where runs from 0 to +1. The relation between the modular parameter s and the proper time is easily obtained as

$$(s) = e^{2 s}$$
: (63)

Therefore the temperature is

$$(s) = 2 e^{2 s}$$
: (64)

The temperature is nite and non zero at the birth of the observer and then it goes exponentially to zero, as it should for a long living observer moving with constant speed.

#### 6 Conclusion

Starting from the thermal time hypothesis, we have obtained the result that the Unruh e ect exists also for observers with a nite lifetime. Restauring dimensional constants, the thermal time hypothesis associates the temperature (54)

$$T ( ) = \frac{ \sim L a^2}{2 k_b c^3} \frac{1 + \frac{a^2 L^2}{c^4}}{1 + \frac{a^2 L^2}{c^4}} ch \frac{a}{c}$$
 (65)

to an observer living for a nite time and moving with constant nite acceleration a between two spacetime points at proper temporal distance T=2L=c from each other. The temperature depends on the observer proper time lapsed from the middle of his lifetime. In the limit of large L, we recover the D avis-U nruh temperature. For large L, an observer with a large acceleration sees the D avis-U nruh temperature for most of his lifetime.

Furtherm ore, it follows from the therm altime hypothesis that also an inertial observer with nite lifetime has an associated temperature. The minimum value of this temperature is the diam onds temperature  $T_D$  (2)

$$T_{D} = \frac{2^{\sim}}{k_{D}T} : \tag{66}$$

We have speculated that this tem perature rejects the fact that the observer has no access to distant degrees of freedom. It would be interesting to understand whether this temperature is related to the response of model thermometers with nite lifetime.

A ltogether, the therm al time hypothesis seems to play an interesting role in these physical situations. Much more work is needed to study the validity of this hypothesis, and its relation with therm odynamical and statistical temporal phenomena.
