On the relevance of center vortices to QCD

In a num erical experim ent, we rem ove center vortices from an ensemble of lattice SU (2) gauge con gurations. This removal adds short-range disorder. Nevertheless, we observe long-range order in the modied ensemble: con nement is lost and chiral symmetry is restored (together with trivial topology), proving that center vortices are responsible for both phenomena. As for the Abelian monopoles, they survive but their percolation properties are lost. These statements hold regardless of the Gribov copy chosen for center projection.

The essential non-perturbative properties of QCD are con nement and chiral symmetry breaking. It has been observed through numerical lattice simulations that these two properties persist in the quenched theory (where the feedback of quarks on gluons is ignored) until the temperature is raised to a critical value $T_{\rm C}=220 {\rm M}$ eV, where con nement is lost; chiral symmetry appears to be simultaneously restored [1]. The disorder which leads to the area law for the Wilson loop thus seems to be somehow tied to the existence of a chiral condensate. Elective mechanisms have been proposed to explain con nement or chiral symmetry breaking. But a successfule ective model should provide a common explanation for both.

Two e ective descriptions of QCD have been receiving a lot of attention: one considers instantons as the e ective degrees of freedom, the other chrom o-m agnetic m onopoles. Instantons are natural candidates to explain chiral sym metry breaking, because each instanton is associated with a zero mode of the Dirac operator [2], and there must be an accumulation of zero eigenvalues to obtain a quark condensate at low temperature [3]. Above Tc, the vanishing of the quark condensate is accompanied by a qualitative change in the instanton ensemble (see, e.g., [4]). On the other hand, it is unlikely that instantons play a signi cant role in con nem ent (see [5] for a recent discussion). An attractive mechanism for con nement is dual superconductivity of the QCD vacuum [6]. Considerable evidence for this dual Meissner e ect has been accumulated on the lattice, including a disorder parameter dem onstrating the condensation of chrom o-m agnetic m onopoles below T_c [7]. This condensation has been observed directly after gauge-xing to \M axim al Abelian Gauge" [8], and the idea of \Abelian dominance" has em erged, according to which the Abelian degrees of freedom of the Yang-Mills eld encode all its long-distance

properties. Indeed, chiral symmetry breaking and its restoration have been observed in the Abelian sector [9]. The Abelian dom inance scenario has some awshowever: it does not explain the breaking of the adjoint string; and the Abelian string tension diers slightly from the Yang-Mills one [10]. Moreover, degrees of freedom more elementary than the Abelian monopoles, embedded in them and solely responsible for the physics assigned to them, cannot be ruled out.

The idea of center vortices, which initially failed due to their m isidenti cation [11], has been successfully revived, rst as an embedded model inside the Abelian sector [12], then without reference to Abelian projection [13]. Center vortices are exposed by gauge-xing: after a gauge transform ation which brings each lattice link as close as possible to a center element of the gauge group, vortices consist of defects in the projected gauge eld form ed from those center elements alone. The idea of center dom inance is again that the center degrees of freedom (d.o.f.) encode all the long-distance physics. This is aesthetically attractive because the do.f. are decimated even m ore than in the Abelian projection. Furtherm ore, the density of center vortices seems to be a well-de ned continuum quantity; the center string tension appears to m ore or less m atch the original one; and an explanation for the behaviour of the adjoint potential has been proposed [14]. However, chiral sym metry has not yet been studied in this context.

An additional problem with Abelian and center dom inance is that the relevant do.f. are identied only after gauge- xing. Gauge- xing non-Abelian elds is notoriously am biquous, and di erent G ribov copies produce different A belian m onopoles or center vortices, whose properties like the string tension di er slightly. For this reason, we are a priori suspicious of e ective models which involve gauge-xing, and so we designed a simple num erical experim ent to disprove the center-dom in ance scenario. For sim plicity, we consider the gauge group SU (2), with center Z2. Our starting point is an ensemble of lattice gauge elds representative of the continuum. We identify center vortices in this ensemble, and construct from it a modi ed ensemble where all center vortices have been removed by ipping the sign of a subset of SU (2) gauge links. As expected, this operation introduces a lot of disorder in the gauge eld. Nonetheless, these disordered gauge elds now have a trivial, vortex-free center projection, and so according to the credo of center dom inance they should not con ne. In other words, our introduction of short-range disorder should at the same time bring long-range order. To our surprise, this is indeed what happens. On this vortex-free ensemble, con nement is lost. Emboldened by this inding, one may ask if the spectral properties of the Dirac operator are not also dominated by the center components of the gauge eld. In that case, our modied ensemble should show no sign of chiral symmetry breaking, since its center projection is the trivial (perturbative) vacuum. Indeed, this is what we observe: removal of center vortices causes both loss of connement and restoration of chiral symmetry.

The next intriguing question regards the fate of Abelian monopoles as center vortices are removed. They do not disappear; on the contrary, the introduction of short-range disorder increases their number. However, we observe the complete disappearance of monopole current loops winding around the periodic lattice: we can thus identify these as the fundamental objects associated with connement in the Abelian sector, apparently in uenced by the underlying center degrees of freedom.

Finally, we investigated the e ect of G ribov copies which caused our initial skepticism. We repeated our experiment on the same SU(2) ensemble, but introduced a systematic tolerance in the gauge condition to be satised before identifying the center vortices to be removed. Although the location and number of center vortices we removed varied appreciably, the modied SU(2) ensemble was always non-conning and chirally symmetric.

The num erical experiment { We start from an ensemble of SU(2) lattice gauge elds obtained by Monte Carlo using the standard Wilson plaquette action. We want to generate a modied ensemble, free of center vortices, and compare the static potential and the chiral condensate on the original and modied ensembles.

To identify center vortices, we gauge—x the original con gurations in order to bring each SU (2) gauge link U (x) as close as possible to an element of the center $Z_2 = f + 1$; 1q. We therefore try to iteratively maxim ize

as in [13], where this gauge is called the \direct m axim alcenter gauge." The gauge- xed SU (2) links, denoted U $^{\rm GF}$ (x), are then projected to Z $_2$ elements Z (x) using

P laquettes in the $\rm Z_2$ -projected theory with value 1 represent defects of the $\rm Z_2$ gauge eld called P-vortices [12]. Numerical evidence has been presented [12,13] showing that plaquette-like P-vortices signal the presence of macroscopic, physical excitations, called center vortices, in the unprojected original SU (2) con quration.

Consider then the modi ed SU (2) con guration made of gauge links U $^{\rm 0}$ (x) constructed as

The gauge transform ation which maxim izes Q (fU g) in (1) also gives the same maximum to Q (fU 0 g), so that the modi ed gauge—xed links U 0GF (x) are simply Z (x) U GF (x). Therefore, we instantly know the center projection Z 0 (x) of U 0 (x):

Every con guration in our modiled ensemble thus projects onto the trivial \mathbf{Z}_2 vacuum: all center vortices have been removed.

Our ensemble consists of about 1000 SU (2) con gurations, on a 16^4 lattice at = 2.4. To maxim ize Q (fU g) (Eq.1) we use standard overrelaxation, stopping when

from one gauge-xing sweep to the next.




FIG. 1. Normalized plaquette distribution on the original and modi ed ensembles (SU (2), = 2.40). Center-vortex removal increases short-range disorder.

In Fig.1 we show the distribution of SU (2) plaquette values on the original and modi ed ensembles. It is apparent that under the sign ip Eq.(3), many SU (2) plaquettes acquire a negative value. Removal of the center vortices increases the action: the modi ed ensemble has more short-range disorder.




FIG. 2. C reutz ratios on the original and modi ed ensembles. The dashed band is the string tension result of [15].

Results { In Fig 2 we present our results for the C reutz ratios (R;R) In [NW (R;R) ilW (R 1;R 1)i=NW (R;R 1)i²] constructed from the averages NW (R;T)i of R by T W ilson loops on the original and m odi ed ensembles. For large R, (R;R) tends to the string tension . It is clear that on the m odi ed ensemble the C reutz ratios decrease and tend to zero. In spite of the increased short-range disorder, long-range order has been created and con nement has been lost.




FIG.3. W ilson loop values hW (R;T)i on the original and modi ed ensembles. Note the parallel lines for successive R in the latter: upon center-vortex removal, con nement is lost.

This is even clearer if one looks directly at the W ilson loop values. In Fig.3 we show lntW (R;T)i as a function of T. For a xed R, points at successively larger T form a line whose asymptotic slope is the value of the static potential V (R). The lines corresponding to the modi ed ensemble are parallel, indicating that V (R) does not grow with R: the string tension has vanished.




FIG.4. Quark condensate h i(m $_{\rm q}$) on the original and m odi ed ensembles. The dashed line corresponds to \poor" center-vortex identication (see text). In all cases, center-vortex removal restores chiral symmetry.

Fig.4 illustrates our study of chiral sym m etry on the original and m odi ed ensem bles. As is well-known, chiral sym m etry breaking cannot occur on a nite lattice. Therefore, we measure h i (m q) = hTr (\Rightarrow + m q) ¹ i for a range of quark masses m q where nite-size e ects are small, and extrapolate to m q! 0. In the original ensemble, h i clearly extrapolates to a non-zero value which signals chiral sym metry breaking. In the modied ensemble, the extrapolated value is zero within errors: the removal of center vortices restores chiral sym metry. We expect then the instanton content of the Yang-Mills eld to be modied also. To check this, we use in proved cooling [16] to measure the topological charge of the modied eld: the striking result is that the removal of center vortices always leads to the trivial topological sector.

We therefore have clear num erical evidence for \center dom inance": if the center-projected eld is the trivial vacuum with all links equal to 1, as in the modi ed ensemble, then the Yang-Mills eld shows the long-distance

properties of the trivial vacuum, i.e., no con nem ent, no quark condensate and no topology. The long-distance properties of the Yang-Mills eld appear to be determined by its center projection.

On the other hand, a large number of studies now support the alternative scenario of \Abelian dominance."
We use our approach of center-vortex removal to directly assess the relationship between these two scenarios.

In a rst experiment, we construct the Abelian projection of our original SU (2) ensemble by gauge—xing to Maximal Abelian Gauge in the usual way [8], then identify and remove center vortices from the Abelian sector. While the original Abelian-projected ensemble shows con nement, with a string tension similar to the non-Abelian one, the modied Abelian-projected con gurations do not con ne. Therefore, we nd no contradiction between \Abelian dominance" and \center dominance." The latter simply appears more fundamental because of the greater reduction of the number of dof.




FIG. 5. Size distribution of monopole clusters on the original and modi ed ensembles.

In a second experiment, we look at clusters of Abelian m onopole currents, whose percolation has been identi ed as the signal for con nem ent [17], obtained from the original and modied ensembles. We not that the removal of center vortices changes the distribution of m onopole cluster sizes in a crucial way (see Fig. 5): whereas in the original ensemble, each con guration contains typically one very large, percolating monopole cluster and many very sm all ones, the modied ensemble gives a more homogeneous size distribution, with a handful of large clusters per con guration. These large clusters are the rem nants of the very large one, broken into pieces by the vortex rem oval. Som e of them still percolate, even though con nem ent has disappeared. Therefore, we are led to associate con nem ent with a more specic feature of the monopole clusters: m onopole current loops which wind around the periodic lattice. Such loops can be found frequently on the original, con ning ensemble, but never on the modi ed, non-con ning one. W e conclude that: (i) con nem ent m anifests itself in the Abelian sector by the presence of monopole current bops with non-trivial topology; (ii) center-vortex removal, which destroys con nement, always nds the \weak links" of these non-trivial bops and breaks them into trivial pieces.

Now let us consider the issue of gauge-xing ambiguities, which was the reason for our initial skepticism about the center-vortex idea. These ambiguities com e from the structure of Q (Eq.1), which has many local maxima, any of which can be selected by a local iterative maxim ization algorithm. Each local maximum, or G ribov copy, will have its own set of P-vortices, di ering in number and location. The proposal of [12] is that, no m atterwhich G ribov copy one chooses, P-vortices are the traces of physical center vortices and are roughly located at their center. This argum ent may account for P-vortices di ering in location but not in number. To study this question in more detail, we magnied the effect of gauge-xing am biguities, by stopping our iterative algorithm early, as soon as $(Eq.5) < 10^{\circ}$. Thus we not only explore a di erent basin of attraction of Q, but we do not even stop at a localm axim um . One e ect of this partial gauge-xing is expected: the density of P-vortices increases from 7:414%, i.e. shows 5:504% to 1:91%. The string tension we meaan increase sure in the Z₂-projected ensemble increases accordingly: whereas the Z₂ string tension after \com plete" gauge $xing (a^2)$ 0:075) is a little larger than but compatible with the non-Abelian string tension (0:0708 0:011 from [15], see Fig.2), it jumps to 0:12 after partial gauge-xing. W hat is remarkable is that this increase 0:045 is sim ilar to that obtained by placing the surof P-vortices at random, uncorrelated locations: plus 2). This does not prove, but makes it plausible, that the center projection always captures the core degrees of freedom relevant for long-distance properties, plus a varying am ount of unrelated noise. Indeed, it has been argued that gauge-xing is not even necessary for center projection [18]. In our description, centergauge-xing acts as an UV noise-litering device, with di erent Gribov copies letting through di erent noise components. Further evidence for this is obtained by

removing from the original SU(2) ensemble the center

vortices identi ed after partial gauge— xing only. Just as for \com plete" gauge— xing, we observe that con nem ent is lost, chiral sym m etry restored, and the topology trivial. The only di erence is that the modi ed ensemble now has much more short-range disorder.

In conclusion, we have shown that rem oval of center-vortices from an SU (2) Y ang-M ills ensemble causes the loss of connement and the restoration of chiral symmetry. C entervortices appear as elective degrees of freedom in terms of which both phenomena can be successfully described. It would be desirable, of course, to formulate an elective action for the center-projected theory. Ref. [19] considers an extension of the Nambu-G oto action, where the fundamental dof. are 2-dimensional random surfaces dual to the P-vortices. Ref. [20] instead proposes to consider center monopoles and their world-lines. We suggest identifying a \minimum spanning tree" of negative \mathbb{Z}_2 links responsible for the P-vortices: perhaps only a subset of them form the essential dof. governing the long-distance properties.

Finally, our vortex-rem oval procedure can be used to study properties of non-con ning non-A belian elds and e ects of center-symmetry breaking. For instance, removing time-like center disorder only would be similar to raising the temperature above $T_{\rm c}\,.$
