The lightest H iggs B oson of m SUGRA, m G M SB and m A M SB at P resent and Future C olliders:

Observability and Precision Analyses

A bstract

We investigate the physics of the lightest CP -even M SSM H iggs boson at the Tevatron, the LHC, a linear e⁺ e collider, a collider and a ⁺ collider. The analysis is performed in the three most prominent soft SUSY-breaking scenarios, m SUGRA, m GMSB and mAMSB. For all colliders the observability and parameter regions with suppressed production cross sections (compared to a SM H iggs boson with the same mass) are investigated. For the lepton and photon colliders the potential is analyzed of precision measurements of the branching ratios of the light CP -even H iggs boson for obtaining indirect bounds on the mass of the CP -odd H iggs boson and the highenergy parameters of the soft SUSY-breaking scenarios. In regions of the parameter space where the LHC can detect the heavy H iggs bosons, precision measurements of the properties of the light H iggs boson at the linear collider can provide valuable information for distinguishing between the mSUGRA, mGMSB and mAMSB scenarios.

1 Introduction

The search for the light neutral Higgs boson is a crucial test of Supersym metry (SUSY) that can be performed with the present and the next generation of high-energy colliders. The prediction of a relatively light Higgs boson is common to all supersymmetric models whose couplings remain in the perturbative regime up to a very high energy scale [1]. Finding the Higgs boson and subsequently studying its couplings to fermions and bosons is thus one of them ain goals of high-energy physics. The data taken during the nalyear of LEP running at $\frac{P}{S} > 206$ GeV have established a 95% C.L. exclusion limit for the Standard Model (SM) Higgs boson of M_{HSM} > 114:4 GeV. They showed a slight excess at about the 2 level of signal-like events over the background expectation, which would be compatible with the expectation for the production of a Higgs boson with SM-like ZZH coupling with a mass M_{HSM} 116 1 GeV 2]. In the Minimal Supersymmetric Standard Model (MSSM) the mass of the lightest CP-even Higgs boson, m_h, is bounded from above by m_h < 135 GeV [3,4] (taking into account radiative corrections up to two-loop order [3,4,6,7,8,9,10,5,11,12,13,14]).

In the M SSM no speci c assumptions are made about the underlying Supersymmetry-(SUSY)-breaking mechanism, and a parameterization of all possible SUSY-breaking terms is used. This gives rise to the huge number of more than 100 new parameters in addition to the SM, which in principle can be chosen independently of each other. A phenomenological analysis of this model in full generality would clearly be very involved, and one usually restricts to certain benchmark scenarios, see e.g. Refs. [15,16,17]. On the other hand, models in which all the low-energy parameters are determined in terms of a few parameters at the Grand Unication scale (or another high-energy scale), employing a specic soft SUSY-breaking scenario, are much more predictive. The most prominent scenarios in the literature are minimal Supergravity (m SUGRA) [18,19], m in im algauge Mediated SUSY Breaking (m GMSB) [20] and minimal Anomaly Mediated SUSY Breaking (mAMSB) [21,22,23]. Analyses of the Higgs sector in these scenarios, mostly focusing only on the maximum value of mh, have been performed in Refs. [24,25,26,27,28,29,30,31]. A detailed comparison of the three soft SUSY-breaking scenarios in terms of exclusion regions in the M $_{
m A}$ tan -plane (where A is the CP -odd Higgs boson and tan the ratio of the vacuum expectation values of the two Higgs doublets), their compatibility with the slight excess observed at LEP, and their corresponding SUSY particle spectra can be found in Ref. [32].

In the present paper the work of Ref. [32] is extended to an analysis of the lightest CP even H iggs boson phenom enology at present and future colliders. We relate the input from the three soft SU SY -breaking scenarios in a uniform way to the predictions for the low -energy phenom enology in the H iggs sector, allowing thus a direct comparison of the predictions arising from the dierent scenarios. The high-energy parameters given in the three scenarios are related to the low-energy SU SY parameters via renormalization group (RG) running, taking into account contributions up to two-loop order [33] (for a recent comparison of dierent codes and current accuracies, see Ref. [34]). After transforming the parameters obtained in this way into the corresponding on-shell parameters [35,36,37], they are used as input for the program FeynH iggs [38,39,40]. As a result the H iggs boson mass spectrum and the H iggs decay rates and branching ratios [41,42] have been obtained. Further restrictions such as from precision observables and the non-observation of SUSY particles at LEP and the Tevatron are also taken into account. For an analysis within the m SUGRA scenario where also the cold dark matter (CDM) constraints are included, see Ref. [43]. Based on

these predictions for the H iggs sector phenom enology, we analyze the observability of the lightest M SSM H iggs boson at the Tevatron, the LHC, a future e^+e^- linear collider (LC), a collider (C), and a collider (C). Regions of the high-energy param eter space with strongly suppressed H iggs production cross sections are identied. As the next step the branching ratios of the lightest H iggs boson into SM ferm ions (h! bb;h! cc;h!) and into W bosons (h! W W) are compared for the m SUGRA, mGMSB and mAMSB case. We show that the precise measurement of the various H iggs decay branching ratios can be used to impose bounds on the value of M_A and also the high-energy input parameters. Combined with the information on M_A that could be obtained from the LHC H iggs searches, we further discuss the possibility of distinguishing the three scenarios via the H iggs branching ratio measurements at the LC.

The rest of the paper is organized as follows. In Sect. 2 we brie y review the three soft SUSY-breaking scenarios and the evaluation of the low-energy data. The observability of the lightest MSSM Higgs boson is investigated in Sect. 3. In Sect. 4 the potential is analyzed of precision measurements of the Higgs boson branching ratios for obtaining indirect constraints on M $_{\rm A}$ and the high-energy parameters of the soft SUSY-breaking scenarios. The possibility of a distinction of the mSUGRA, mGMSB and mAMSB scenarios is discussed. The conclusions can be found in Sect. 5.

2 The low-energy sector and phenom enological constraints

In deriving the low-energy param eters in the three soft SUSY-breaking scenarios (m SUGRA, m GM SB and m AM SB) from the high-energy input param eters we follow Ref. [32]. Thus, in this section only the m ost relevant facts are brie y sum m arized.

2.1 The soft SUSY -breaking scenarios

The fact that no SUSY partners of the SM particles have so far been observed means that low-energy SUSY cannot be realized as an unbroken symmetry in nature, and SUSY models thus have to incorporate additional Supersymmetry breaking interactions. This is achieved by adding to the Lagrangian (dened by the SU(3)_C SU(2)_L U(1)_Y gauge symmetry and the superpotential W) some further interaction terms that respect the gauge symmetry but break Supersymmetry (softly, i.e. no quadratic divergences appear), so called \soft SUSY-breaking" (SSB) terms. Assuming that the R-parity symmetry [44] is conserved, which we do in this paper for all SUSY breaking scenarios, reduces the amount of new soft terms allowed in the Lagrangian. Choosing a particular soft SUSY-breaking pattern allows further reduction of the number of free parameters and the construction of predictive models. The three most prominent scenarios for such models are

m SUGRA (minimal Super Gravity scenario) 1[8,19]:

A part from the SM param eters (for the experim ental values of the SM input param eters we use Ref. [45]), 4 param eters and a sign are required to de ne them SUGRA scenario:

While m₀, m₁₌₂ and A₀ de ne the scalar and ferm ionic masses and the trilinear couplings at the GUT scale (10^6 GeV), tan (the ratio of the two vacuum expectation values) and the sign() (is the supersymmetric Higgs mass parameter) are dened at the low-energy scale. For our numerical analysis, see Sects. 3, 4, we have scanned over the following parameter space¹:

The low-energy spectrum has been evaluated with the program s SU IT Y / FeynSSG [48, 49].

m G M SB (minimalGauge Mediated SUSY-Breaking) 20]:

A very promising alternative to mSUGRA is based on the hypothesis that the soft SUSY-breaking occurs at relatively low energy scales and is mediated mainly by gauge interactions through the so-called \messenger sector" [51,50,20]. Also in this scenario, the low-energy parameters depend on 4 parameters and a sign,

where M $_{\text{m ess}}$ is the overall m essenger m ass scale; N $_{\text{m ess}}$ is a number called the m essenger index, parameterizing the structure of the m essenger sector; is the universal soft SU SY -breaking m ass scale felt by the low-energy sector. The phenomenology of m GM SB is characterized by the presence of a very light gravitino G with m ass given by m $_{3=2}$ = m $_{\text{G}}$ = $\frac{F}{3M_{\text{p}}^{0}}$ ' $\frac{p_{\overline{F}}}{100 \text{ TeV}}$ 2:37 eV [52], where \overline{F} is the fundamental scale of SSB and M $_{\text{p}}^{0}$ = 2:44 10^{18} G eV is the reduced P lanck m ass. Since \overline{F} is typically of order 100 TeV, the G is always the LSP in these theories. The numerical analysis in Sects. 3, 4 is based on the following scatter ranges:

The low-energy parameter sets for this scenario have been calculated by using the program SUSYFIRE [53] and adopting the phenomenological approach of Refs. [54,55,56,29].

m A M SB (m in im al A nom aly M ediated SUSY B reaking) 2[1,22,23]: In this model, SUSY breaking happens on a separate brane and is communicated to

the visible world via the super-Weylanomaly. The particle spectrum is determined by 3 parameters and a sign:

The overall scale of SUSY particle masses is set by m $_{\rm aux}$, which is the VEV of the auxiliary eld in the supergravity multiplet. m $_0$ is introduced as a phenomenological parameter to avoid negative slepton mass squares, for other approaches to this problem see Refs. [21,57,58,59,60]. The scatter parameter space for the numerical analysis in Sects. 3, 4 is chosen to be

The low-energy spectrum has been derived with the code described in Ref. [26].

2.2 Evaluation of predictions in the Higgs boson sector of the M SSM

The most relevant parameters for Higgs boson phenomenology in the MSSM are the mass of the CP-odd Higgs boson, M_A, the ratio of the two vacuum expectation values, tan , the scalar top masses and mixing angle, m_{t_1}; m_{t_2}; t_t, for large tan also the scalar bottom masses and mixing angle, m_{t_1}; m_{t_2}; t_t, for large tan also the scalar bottom masses and mixing angle, m_{t_1}; m_{t_2}; t_t, the supersymmetric Higgs mass parameter, the U (1) and SU (2) gaugino masses, M₁ and M₂, and the gluino mass, m_t. These low-energy parameters are derived from the high-energy parameters of the three soft SUSY-breaking scenarios via RG running, see Ref. [32]. Since the RG running employed in the three scenarios is based on the \overline{DR} scheme, the corresponding low-energy parameters are \overline{DR} parameters. In order to derive predictions for observables, i.e. particle masses and mixing angles, these parameters in general have to be converted into on-shell parameters.

For the predictions in the M SSM H iggs sector we use results obtained in the Feynm andiagram m atic (FD) approach within the on-shell renormalization scheme as incorporated in the Fortran code FeynH iggs [38,39,40] based on Refs. [5,4,3].

Our analysis is concerned with the main Higgs production and decay channels at dierent colliders. To this end the predictions for the Higgs boson masses and elective couplings (especially the elective mixing angle, e, in the neutral CP-even Higgs boson sector that includes higher-order corrections) as well as for the branching ratios of the lightest MSSM Higgs boson (and for a SM Higgs boson with the same mass) have been evaluated. While the predictions for the decays of h! bb;cc; are based on Ref. [41], including the higher-order corrections described in Ref. [61,62], the other decay channels have been derived with the code H decay [42], which has been implemented as a subroutine in the latest version of FeynHiggs [40]. The proper transition from on-shell parameters in FeynHiggs to \overline{DR} parameters in H decay has been taken into account [35,36,37].

In order to derive the relative di erence between a M SSM production or decay rate and the corresponding SM rate (for the same H iggs boson mass), the following ratios have been

calculated (below the notation tt! tth refers to the processes qq;qg! tth, and VV! h refers to the vector boson fusion processes at the LHC and the LC, qq! q^tq^th , $e^te!$ h, respectively):

For some of the cross sections in Eqs. (7) { (12) more complete results for the MSSM exist in the literature than those used in our analysis, see e.g. Refs. [63,64,65,66]. For the qualitative analysis below, however, the approximations used here should be su cient, see e.g. the comparison in [63].

For the num erical analysis the above production and decay modes have been combined to the most relevant channels for each collider, i.e. we have calculated the product

Due to our approximations for the production processes the relative results of $BR^{SUSY} = BR^{SM}$ for the same nal states in the two chains numerically agree.

2.3 Phenom enological constraints

While our main focus in this paper is on the physics in the Higgs sector, we also take into account some further (relatively mild) constraints when determining the allowed parameter space. These constraints are brie y summarized here. (A more detailed discussion can be found in Ref. [32].)

LEP Higgs bounds:

The results from the Higgs search at LEP have excluded a considerable part of the M SSM parameter space [67]. The results of the search for the M SSM Higgs bosons are usually interpreted in three dierent benchm ark scenarios [15]. The 95% C L. exclusion limit for the SM Higgs boson of M $_{\rm H_{SM}}$ > 114:4 G eV [2] applies also for the lightest CP -even Higgs boson of the M SSM except for the parameter region with small M $_{\rm A}$ and large tan . In the unconstrained M SSM this bound is reduced to m $_{\rm h}$ > 91:0 G eV [67] for M $_{\rm A}$ < 150 G eV and tan $^{>}$ 8 as a consequence of a reduced coupling of the Higgs to the Z boson. For the CP -odd Higgs boson a lower bound of M $_{\rm A}$ > 91:9 G eV has been obtained [67]. In order to correctly interpolate between the parameter regions where the SM lower bound 2 of M $_{\rm H_{SM}}$ > 113 G eV and the bound m $_{\rm h}$ > 91 G eV apply, we use the result for the Higgsm ass exclusion given with respect to the reduced Z Z h coupling squared (i.e. \sin^2 ($_{\rm e}$)) [68]. We have compared the excluded region with the theoretical prediction obtained at the two-loop level for m $_{\rm h}$ and \sin^2 ($_{\rm e}$) for each parameter set (using m $_{\rm t}$ = 175 G eV).

P recision observables:

The electroweak precision observables are a ected by the whole spectrum of SUSY particles. The main SUSY contributions enter via the -parameter [69]. In our analysis we take into account the corrections arising from $\mathfrak{t}=\mathfrak{d}$ loops up to two-loop order [70]. A value of outside the experimentally preferred region of $^{SUSY} < 3 \quad 10^3$ [45] indicates experimentally disfavored \mathfrak{t} and \mathfrak{d} m asses. The evaluation of SUSY is implemented in FeynHiggs.

Experim ental bounds on SUSY particle masses

In order to restrict the allowed parameter space in the three soft SUSY-breaking scenarios we employed the current experimental constraints on their low-energy mass spectrum [45]. The precise values of the bounds that we have applied can be found in Ref. [32].

O ther restrictions

We just brie y list here the further restrictions that we have taken into account. For a detailed discussion see Ref. [32].

- { The top quark mass is $xed to m_t = 175 GeV$.
- { The GUT or high-energy scale parameters are taken to be real, no SUSY CP violating phases are assumed.
- { In all models under consideration the R-parity symmetry [44] is taken to be conserved.

 $^{^2}$ Instead of the actual experim ental lower bound, M $_{\rm H_{\,SM}}$ > 114.4 GeV [2], we use the value of 113 GeV in order to allow for some uncertainty in the theoretical evaluation of m $_{\rm h}$ from unknown higher-order corrections, which is currently estimated to be 3 GeV [4].

- { Param eter sets that do not full the condition of radiative electroweak symmetry breaking (REWSB) are discarded (already at the level of model generation).
- { Param eter sets that do not full the constraints that there should be no charge or color breaking minima are discarded (already at the level of model generation).
- { Contrary to Ref. [32] we did not apply a \naturalness bound" on the sferm ion and gluino mass, but just restricted the scanned parameter space as indicated in Sect. 2.1. This is in fact not an important restriction for the BR calculation, since very heavy SUSY particles tend to decouple from the observables we are considering here, i.e. the quantity in Eq. (15) approaches 1.
- { We dem and that the lightest SUSY particle (LSP) is uncolored and uncharged. In the mGMSB scenario the LSP is always the gravitino, so this condition is automatically fulled. Within the mSUGRA and mAMSB scenario, the LSP is required to be the lightest neutralino. Parameter sets that result in a dierent LSP are excluded.
- { We do not apply any further cosm ological constraints, i.e. we do not dem and a relic density in the region favored by dark matter constraints [72].
- { Although we do not apply constraints from BR (b! s) [47] or g 2 of the muon [46], we restrict ourselves to the case where the Higgsino mixing parameter is positive, > 0. This choice is favored by the current data. The results with negative can dier signicantly from the case we consider here and would require an additional analysis.

2.4 Bounds on m h and tan

Scanning over the parameter space of m SUGRA, mGMSB and mAMSB as described in Sect. 2.1 and applying the constraints as described in Sect. 2.3 results in upper maximal values of m_h and lower bounds on tan (for the general MSSM case, see Refs. [67,73]). This analysis has been performed in Ref. [32]. However, due to the progress in the m_h evaluation, see Ref. [4] for a review, these bounds have changed as compared to our earlier analysis. Tab. 1 gives an update of the obtained m_h and tan bounds.

 $^{^3}$ W e use here the one-loop m in imization conditions. A nalytical two-loop expressions of O ($_{t-s}+_{t}^2$) for the m in imization conditions have been recently given in Ref. [71]. The full two-loop corrections can be derived numerically from the work of Ref. [14].

3 Observability of the lightest M SSM Higgs boson

In this section the observability of the lightest M SSM Higgs boson at the dierent colliders is analyzed. Especially at the hadron colliders a reduced BR for certain channels compared to the SM value could make it more dicult to establish a Higgs signal over the background.

Tevatron:

In all three soft SUSY-breaking scenarios the Tevatron search channels are not significantly suppressed compared to the SM rates. The channel V ! Vh! Vbb is suppressed by not more than 10% as compared to the SM value. Therefore the prospects at the Tevatron for the discovery of the lightest M SSM Higgs boson are as good as for the SM Higgs boson. A similar observation has already been made in Ref. [43] for the m SUGRA scenario, where also other phenomenological constraints have been taken into account.

LHC:

We start our discussion with the channelgg! h! that is of particular importance for a light SM-like Higgs boson with m $_{\rm h}$ < 130 GeV [74]. As has been shown in Ref. [75,76,16], for certain values of the SUSY parameters this production channel can be heavily suppressed for a wide region of the M $_{\rm A}$ tan -parameter space of the unconstrained MSSM (see also Ref. [77] for an analysis in the mSUGRA scenario). Since the event rate for this channel is relatively low (h! being a rare decay), a suppression of 50% or more would certainly pose a challenge to the experiment.




Figure 1: The rate for the LHC channelgg! h!, normalized to the SM case with the same Higgs boson mass, (BR) $^{SUSY} = (BR)^{SM}$, is shown in the MA {tan plane for the mSUGRA, mGMSB and mAMSB scenarios (from top to bottom). The unconnected dots appearing in this and the following gures reject the fact that only a few points with very low density appear in this area. However, increasing the density of the scatter data would cover the whole area in which the dots are located.

The situation within the three soft SUSY-breaking scenarios can be read of from Fig. 1 4 . Within the mSUGRA scenario a suppression of up to $10\{20\%$ is found for M $_A$ < 700 GeV for all tan values. For very large tan , tan > 50, a reduction even larger than 20% can be found. This is in agreement with the result obtained in Ref. [43], where no substantial reduction has been found, after other phenomenological constraints like BR (b! s), g 2 and especially the CDM restrictions had been applied. Concerning the parameter space of the GUT scale parameters m $_0$ and m $_{1=2}$ (which is not shown here explicitly), the reduction is found for all m $_0$ and m $_{1=2}$ < 350 GeV.

The suppression can be stronger in the other two scenarios. Nearly all model points with M $_{\rm A}$ < 400 G eV for m G M SB and m A M SB , which correspond to tan values of tan $^>$ 20, show a suppression of 20-50% (or even m ore). For M $_{\rm A}$ < 200 G eV (300 G eV) and tan $^>$ 50 (30 < tan $^<$ 40) the reduction is even larger than 50% in m G M SB (m A M SB). For larger M $_{\rm A}$ values, M $_{\rm A}$ > 600 G eV , the SM value of $_{\rm B}$ BR is approached. Concerning the high-energy parameters, the largest reduction in them G M SB scenario is found allower the parameter space for M $_{\rm mess}$ and N $_{\rm mess}$ (with tan $^>$ 50 and $^>$ 30 TeV), whereas a reduction by 10-20% is mostly found for the lowest values for all M $_{\rm mess}$ values. Within m A M SB the largest reduction is found form $_0$ < 700 G eV and m $_{\rm aux}$ < 4 10 G eV . Sm all values of the high-energy parameters correspond to relatively sm all values of the low-energy SU SY parameters, which are required for a sizable suppression of the gg! h! channel [75,76,16].

We now consider the associated production channel at the LHC, qq; qg! tt! tth! tttb. In all three scenarios the rate is not suppressed compared to the SM rate by more than 10% or even an enhancement by up to 10-20% occurs. Therefore this channel, which is most relevant in the region 100 GeV $^{<}$ m $_{\rm h}$ $^{<}$ 120 GeV [74] does not suler from suppression due to SUSY corrections in the three soft SUSY-breaking scenarios.

M ore recently also the H iggs boson production via W boson fusion, W $^{+}$ W $^{+}$ H, w ith a subsequent decay to $^{+}$ pairs, W bosons or photons has been discussed, see Refs. [79,80] for a SM analyses and Refs. [81,82] for the mode h ! $^{+}$ in the M SSM case. These channels can be relevant for the whole allowed m $_{\rm h}$ range in the M SSM . The m SU G R A scenario o ers very good prospects for the decay into $^{+}$, which is characterized by the coupling \sin $_{\rm e}$ = cos . O ver alm ost the whole parameter space the rate for BR di ers by less than 10% from the SM rate. Only for very small M $_{\rm A}$ and very high tan a suppression is possible. This corresponds to the parameter space where the heavy H iggs boson can have SM like couplings, see F ig. 1 in Ref. [32]. The other channels (h ! W W ;) show the following pattern: due to the increased decay rates to ferm ions, at relatively small M $_{\rm A}$, 250 G eV $^{<}$ M $_{\rm A}$ $^{<}$ 500 G eV , a suppression of the decays into W bosons or photons is possible, while the value of the SM rate is approached for larger M $_{\rm A}$.




Figure 2: The rate for the LHC channel W W ! h! W W , normalized to the SM case with the same Higgs boson mass, is shown in the M $_{\rm A}$ {tan plane for the m G M SB (upper plot) and the m A M SB scenario (lower plot).

The situation is similar in the mGM SB and mAM SB scenarios, besides that the suppression of the $^+$ channel for very small M $_{\rm A}$ and very large tan is not found. For the smallest possible values of M $_{\rm A}$ and the largest possible values of tan a strong enhancement of these channels can be observed. This agrees with the results of Ref. [32], where only in the mSUGRA scenario but not in the mGMSB and mAMSB scenario a region of the parameter space has been found where the heavy Higgs boson is SM like. Thus the h! $^+$ channel is enhanced everywhere in mGMSB and mAMSB. Correspondingly the two other channels, h! WW and h! are suppressed everywhere. As an example, in Fig. 2 we show the channel WW! h! WW in the mGMSB and the mAMSB scenario. For not too large M $_{\rm A}$, M $_{\rm A}$ $^<$ 550 GeV (700 GeV), in mGMSB (mAMSB) a reduction larger than 10% can be observed. For larger M $_{\rm A}$ the results in the mGMSB and mAMSB scenarios approach the one in the SM.

LC:

Due to its clean experimental environment, Higgs boson production should be easily observable at the LC, i.e. in various channels even a signicant suppression compared to the SM rate would not be harm ful [84,85,86]. Therefore the production channels Z! Zh and WW! h (which yield the same numerical result in our analysis, see Sect. 2.2) and all decay channels, h! bb, cc, + , WW, gg, are observable in the three soft SUSY-breaking scenarios. This applies also in the region of small MA, MA < 200 GeV, where a suppression of more than 50% can occur in all three scenarios. We will therefore present a detailed analysis of the LC production and decay channels only in the context of precision measurements, see Sect. 4.

⁵A lso some other channels for a SM Higgs boson have been studied, e.g. tt! tth! ttW W [83]. They could be easily included in our analysis as outlined in Sect. 2. Since including these channels does not change our qualitative results, we do not discuss them here explicitly.

C:

Also the C, due to the Higgs boson production in the s-channel, o ers very good prospects for the Higgs boson observation [87,88]. Only the decay h! could become problem atic if it is strongly suppressed compared to the SM value (e.g. due to an enhanced hbb coupling).

In the m SUGRA scenario the h! channel and the h! W W channel are very sim - ilar. They can be suppressed by m ore than 20% only for very large tan , tan $\,^>$ 50, or for tan $\,^-$ 10 w ith the sm allest allowed M $_{\rm A}$ values. On the other hand, the h! bb and h! $\,^+$ m odes are unproblem atic w ith in m SUGRA and show either only a very sm all suppression or even some enhancement, with the only exception of a possible suppression at very large tan .

In the m G M SB scenario the h! bb and h! $^+$ channels are always enhanced. The h! and h! W W channels show a suppression of m ore than 50% for




Figure 3: The rate for the C channel ! h! , normalized to the SM case with the same Higgs boson mass, is shown in the M $_{\rm A}$ {tan plane for the mGMSB (upper plot) and the mAMSB scenario (lower plot).

M $_{\rm A}$ < 100 GeV, while for M $_{\rm A}$ < 600 GeV still a suppression of m one than 10% occurs, see Fig. 3 for the h! channel. The situation is quite similar in the mAMSB scenario, with an exception in the intermediate M $_{\rm A}$ region, 600 1300 GeV, where there is an enhancement of the h! mode compared to the one obtained in the mGMSB scenario, see Fig. 3.

C:

Finally, to complete our analysis, we also brie y look at the C. This collider o ers good prospects since the Higgs boson can be produced in the s-channel without a loop suppression like at the C, however with the relatively small $^+$ h Yukawa coupling [89]. However, in the unconstrained MSSM it is possible that the $^+$ h coupling, being $\sin_e = \cos$, can become very small if $_e$! O because of loop corrections [89,90]. In this parameter region, on the other hand, H, A production at the C happens with an enhanced rate and o ers good prospects for resolving H

and A as separate resonances [89,90].

The feature of a suppressed $^+\,$ h coupling can also be realized in the m SUGRA scenario when the heavy (and not the light) CP-even H iggs boson is SM like. This is possible for very high tan and small M $_{\rm A}$, M $_{\rm A}$ $^<$ 300 GeV (note that here no CDM constraints are taken into account, in contrast to the analysis of Ref. [89]). In this parameter region a strong suppression is possible for all C channels of the light CP-even H iggs boson (while H , A production happens at enhanced rates). In the rest of the parameter space the h! bb and h! $^+$ channel are strongly enhanced for M $_{\rm A}$ $^<$ 700 GeV . For very large M $_{\rm A}$ an enhancement of up to 10% occurs. Correspondingly, the h! W W channel is not enhanced, but still within 10% of the SM value.

W ithin m G M SB and m A M SB the suppression of the $^+\,$ h coupling is not present. Because of the coupling factor $\sin_e=\cos$ the h! bb and h! $^+\,$ channels are strongly enhanced for sm all M $_A$, while the SM value is approached for large values of M $_A$. The h! W W channel, being enhanced with the sin $_e=\cos$ factor only at the production vertex, is less enhanced, but should be unproblem atic for the whole param eter space.

4 Precision analyses of the Higgs masses and branchingratios

We now investigate the potential of H iggs branching ratio measurements at future colliders for testing the underlying SUSY model. We concentrate our analysis on the LC and the C, since the anticipated precisions of at the LHC will in general be much worse, while on the other hand branching ratio measurements of the light H iggs boson at the C are not expected to yield substantially better results than at the LC.

O verm ost of the parameter space of the scenarios discussed here one would of course also expect to observe direct production of SUSY particles at the next generation of colliders.

However, we concentrate our analysis on information obtainable from the Higgs sector without assuming further knowledge of the SUSY spectrum. In a realistic situation one would of course confront the model under study with all available experimental information.

Tab. 3 lists the anticipated accuracies in di erent channels at the LC [84,93] and the C [87,88]. The values given in Tab.3 correspond to a SM -like Higgs boson with a mass com patible with the allowed mass range of the lightest CP -even Higgs boson in the three soft SUSY -breaking scenarios according to the upper bounds given in Tab. 1. There is of course som e variation in the accuracy with which the branching ratios can be measured over the allowed range of m_h . For simplicity, we assume a constant precision over the allowed m ass range for each channel with a value referring to the middle of the allowed range. In param eter regions where the M SSM rate diers drastically from the SM rate the prospective precision will of course be dierent than in the SM. While in extreme cases like this it will be easy to infer properties of the SUSY model from Higgs sector measurements, we will focus in our analysis below on moderate deviations between the MSSM and the SM, for which the values given in Tab. 3 can be applied in good approximation. We will indicate the deviation between the M SSM and the SM in terms of the accuracies given in Tab. 3, i.e. a \ n " deviation m eans that the calculated M SSM value of BR deviates from the corresponding SM value (with M $_{\rm H_{SM}}$ = m $_{\rm h}$) by (n precision).

4.1 Sensitivity to M_A and tan

W hile within the M SSM the prospects for the detection of the lightest CP -even H iggs boson at the next generation of colliders are very good, the situation is quite di erent for direct observation of the CP -odd A boson. At the LHC the detection of this particle can be very

di cult over sizable fractions of the M SSM param eter space (see e.g. Ref. [74,94]), while it m ay be outside the kinematical reach of the LC (see Refs. [64,95] for a recent account of this subject). Thus, it is of interest to study the potential for obtaining indirect bounds on M $_{\rm A}$ from precision measurements. Exploiting the sensitivity to M $_{\rm A}$ can be done in a similar fashion as nowadays for the SM H iggs, where indirect bounds are derived from electroweak precision tests. Since in the decoupling limit, M $_{\rm A}$ M $_{\rm Z}$, the H iggs sector of the M SSM becomes SM—like, deviations in the production and decay of the lightest CP—even H iggs boson of the M SSM can in principle be translated into an upper bound on M $_{\rm A}$. If direct information on M $_{\rm A}$ is available, the indirect sensitivity to M $_{\rm A}$ allows a stringent test of the model.

Several analyses of the sensitivity to M A at the LC or the C have been carried out in the literature [43,88,96,97,98] (for an analysis focusing on them easurements with a G igaZ option of the LC see Ref. [99]). While in many of these analyses particular \benchmark" values of the SUSY parameters have been chosen, we perform a detailed scan over the parameter space of the three soft SUSY-breaking scenarios. Our study diers considerably especially from previous studies of the Higgs branching ratios in Ref. [88,96,97]. In these previous analyses, allparameters except for the one under investigation have been kept xed and the elect of an assumed deviation between the MSSM and the SM has solely been attributed to this single free parameter. This would correspond to a situation with a complete knowledge of all SUSY parameters without any experimental or theoretical uncertainty, which obviously leads to an unrealistic enhancement of the sensitivity to the investigated parameter. Allowing the other SUSY (and SM) parameters to vary within reasonable ranges would result in reduced sensitivities as compared to the ones reported in these studies.

Since assum ptions about which part of the SUSY spectrum might be accessible at the next generation of colliders are necessarily very speculative, we do not assume any further information beyond the Higgs sector at all and perform a full scan over the parameter space of the three soft SUSY-breaking scenarios. The resulting sensitivity to M $_{\rm A}$ (which electively covers also possible theoretical uncertainties of) can thus be interpreted as a \worst case" scenario within m SUGRA, mGMSB and mAMSB, which could be improved by incorporating further information from other sectors of the model.




Figure 4: Indirect sensitivity to M $_{\rm A}$ in the m SUGRA scenario: for the channels h ! bb, h ! cc, h ! $^+$ and h ! W W (from top to bottom) the regions in the M $_{\rm A}$ {tan plane are shown where the result in the m SUGRA scenario di ers from the SM prediction by 1 , 2 or 3 , assuming the prospective accuracy at the LC according to Tab. 3.

In Fig. 4 the indirect sensitivity to M $_{\rm A}$ within the m SUGRA scenario is investigated for the channelsh! bb;cc; $^+$;W W at the LC. The gure shows the regions in the M $_{\rm A}$ {tan plane where the result in the m SUGRA scenario diers from the SM prediction by 1 , 2 or 3 , according to the prospective accuracy at the LC as given in Tab. 3. The corresponding sensitivities at the C (which are not shown here) turn out to be usually worse than at the LC for the m SUGRA scenario.

If a 2 or 3 deviation of the Higgs branching ratios from the corresponding SM values is found at the LC, an upper bound on M $_{\rm A}$ can be inferred within the m SUGRA scenario according to Fig. 4. In particular, the h! W W channel yields an upper bound on M $_{\rm A}$ of 500 $\,$ 600 G eV (depending on tan) for a more than 3 deviation, 600 $\,$ 700 G eV for a deviation in excess of 2 , while deviations of more than 1 occur for M $_{\rm A}$ up to 800 $\,$ 1000 G eV within the m SUGRA scenario. On the other hand, measuring a suppression in the h! bb and/or h! $^+$ channel (left column of Fig. 4) or an enhancement in the h! $\,$

and/or h! W W channel (right column of Fig. 4) would determ ine tan to lie within 35 < tan < 55 in the m SUGRA scenario. The m SUGRA scenario is the only of the three soft SUSY-breaking scenarios that could accommodate a suppression of the h! bb and/or h! channel. Thus these measurements can help to distinguish the soft SUSY-breaking scenarios, see Sect. 4.3.




Figure 5: Indirect sensitivity to M $_{\rm A}$ in the mGM SB scenario: for the channels h! bb (top left), h! cc (top right), h! $^+$ (bottom left) and h! W W (bottom right) the regions in the M $_{\rm A}$ (tan plane are shown where the result in the mGM SB scenario di ers from the SM prediction by 1 , 2 or 3 , assum ing the prospective accuracy at the LC according to Tab. 3.




Figure 6: Indirect sensitivity to M $_{\rm A}$ in the m G M SB scenario: for the channels h! bb (left) and h! W W (right) the regions in the M $_{\rm A}$ {tan plane are shown where the result in the m G M SB scenario di ers from the SM prediction by 1 , 2 or 3 , assum ing the prospective accuracy at the C according to Tab. 3.

In Fig. 5 we show the sensitivity to M $_{\rm A}$ within the mGMSB scenario for the channels h ! bb;cc; $^+$;WW at the LC. The corresponding results for h ! bb;WW at the C are displayed in Fig. 6 (which yields comparable sensitivities in this scenario). As for mSUGRA, the observation of a 2 or 3 deviation compared to the SM prediction will allow to establish an upper bound on M $_{\rm A}$ within the mGMSB scenario. Also in this case the h!WW channel shows signicant deviations from the SM prediction over a wider range of the M $_{\rm A}$ (tan plane than the other channels. For a more than 2 deviation in this channel an upper bound on M $_{\rm A}$ of about 700 GeV (depending somewhat on tan) can be inferred.




Figure 7: Indirect sensitivity to M $_{\rm A}$ in the mAM SB scenario: for the channels h! bb (top left), h! cc (top right), h! $^+$ (bottom left) and h! W W (bottom right) the regions in the M $_{\rm A}$ (tan plane are shown where the result in the mAM SB scenario di ers from the SM prediction by 1 , 2 or 3 , assum ing the prospective accuracy at the LC according to Tab.3.

B igger deviations result in correspondingly lower upper bounds on M $_{\mbox{\scriptsize A}}$.

In Fig. 7 the sensitivity to M $_{\rm A}$ within the m AM SB scenario is displayed for the channels h! bb;cc; $^+$;W W at the LC. The sensitivities at the C are usually worse in this scenario. As for the other two scenarios, in general an upper bound on M $_{\rm A}$ can be established if a 2 or 3 deviation from the SM result is observed. Again in particular the h! W W channel o ers good prospects for observing sizable deviations. It allows to set an upper bound on M $_{\rm A}$ of 800 900 GeV (depending on tan) if a deviation of m ore than 2 is observed. Higher deviations result in correspondingly lower upper bounds on M $_{\rm A}$. Comparing the results for the h! W W channel in the m AM SB scenario with the other scenarios, in the m AM SB scenario sizable deviations from the SM prediction occur over a wider parameter space in the M $_{\rm A}$ {tan plane than in the other scenarios. Thus, the prospects for experimentally establishing a deviation from the SM prediction and in this way inferring an upper bound on M $_{\rm A}$ appear to be particularly good in the m AM SB scenario.

4.2 Sensitivity to high-energy param eters




Figure 8: Indirect sensitivity to m $_0$, m $_{1=2}$ in them SUGRA scenario: for the channelsh! bb, h! cc, h! and h! W W (from top to bottom) the regions in the m $_{1=2}$ {m $_0$ plane are shown where the result in the m SUGRA scenario di ers from the SM prediction by 1, 2 or 3, assuming the prospective accuracy at the LC according to Tab. 3.

Besides providing sensitivity to M $_{\rm A}$, precise measurements of H iggs branching rations at the LC can also yield indirect information on the high-energy parameters of the dierent soft SUSY-breaking scenarios. In Fig. 8 the results for the channels h! bb;cc; $^+$;W W are shown in the m $_{1=2}$ {m $_0$ plane for the m SUGRA scenario. W hile the indirect constraints that can be obtained with a 2 or 3 deviation on m $_0$ are rather m ild, stronger bounds can be obtained for m $_{1=2}$. This rejects the fact that M $_{\rm A}$ and the squark masses are strongly correlated with the m $_{1=2}$ value. Combining the channels, an upper bound of 350 GeV on m $_{1=2}$ can be set if a deviation of more than 3 from the SM prediction is observed, a 2 deviation constrains m $_{1=2}$ to be smaller than 450 GeV, while deviations of more than 1 occur for m $_{1=2}$ < 650 GeV.

Concerning the mGMSB scenario (which is not displayed here) the indirect constraints are weaker. Results deviating from the SM prediction for the h! WW channel by 3, for instance, are distributed over nearly the whole M $_{\rm mess}$ { plane. Thus, establishing a non SM-like behavior in the H iggs sector alone is not su cient to derive indirect bounds on M $_{\rm mess}$ and , i.e. further experimental information is necessary to constrain these parameters. On the other hand, weak lower limits on M $_{\rm mess}$, could be set, which can cut out the lower edge of the mGMSB allowed M $_{\rm mess}$ { area, if the deviation from the SM value is found to be small.




Figure 9: Indirect sensitivity to m $_0$, m $_{\rm aux}$ in the mAMSB scenario: for the channels h! bb (left) and h! cc (right) the regions in the m $_0$ {m $_{\rm aux}$ plane are shown where the result in the mAMSB scenario diers from the SM prediction by 1,2 or 3, assuming the prospective accuracy at the LC according to Tab.3.

In Fig. 9 the results for the channels h! bb;cc are shown in the m $_0$ {m $_{\rm aux}$ plane for the mAMSB scenario. Like in the mGMSB scenario, deviations of 3 or 2 with respect to the SM prediction occur over a rather wide range of m $_0$ and m $_{\rm aux}$ values. An observed deviation of 3 would constrain m $_0$ to be smaller than 1100 GeV, while m $_{\rm aux}$ would have to be smaller than 6 10GeV. Observation of a 2 deviation would allow to set an upper bound on m $_0$ of m $_0$ < 1400 GeV, while restricting the parameter space to the one compatible with a 2 deviation does not significantly reduce the range of possible values of m $_{\rm aux}$ in Fig. 9.

4.3 Discrim ination between soft SUSY-breaking scenarios

We now investigate the potential of precise measurements of Higgs branching ratios at a LC for distinguishing between the three soft SUSY-breaking scenarios. The main experimental test of dierent SUSY-breaking scenarios will of course be to confront their predictions for the SUSY spectrum with the results obtained from the direct observation of SUSY particles. The analysis of the Higgs sector, however, may contribute further valuable information. Since the dierent soft SUSY-breaking scenarios predict dierent mass patterns for the SUSY particles, variations in the results for the Higgs sector observables for the same value of M $_{\rm A}$ can be expected.

As above, we do not assume experimental input from other sectors of the MSSM, but concentrate on the Higgs sector. Clearly, resolving dierences between the predictions of the three scenarios via measurements in the Higgs sector will require some experimental information on the tree-level parameters of the Higgs sector, M_A and tan. Therefore we will focus on a scenario where the LHC can detect the heavy MSSM Higgs bosons via their decays H=A! (with the main production channel bb! bb H=A), which can be realized for large tan and not too large M_A [74,100]. As a specic example we assume that the LHC provides a measurement of M_A as well as a lower bound on tan,

$$500 \,\mathrm{G\,eV} < \mathrm{M}_{\mathrm{A}} < 600 \,\mathrm{G\,eV}$$
; tan > 30 : (24)

The results of the analysis below would improve for smaller values of M $_{\rm A}$, while for a larger M $_{\rm A}$ and smaller tan observation of the heavy H iggs bosons at the LHC would become increasingly dicult.

Restricting the data set of our scan, see Sect. 2.1, to those parameter points ful lling Eq. (24) we compare the predictions for the dierent branching ratios arising from the three scenarios. As above, we indicate the deviations from the SM prediction in terms of the prospective accuracy at the LC according to Tab. 3.




Figure 10: Comparison of BR (h $!\,$ bb) (top) and BR (h $!\,$ gg) (bottom) in the three soft SUSY-breaking scenarios via LC m easurements.

In Fig. 10 we show the results for the channels h! bb and h! gg. The results for these channels, as for the others that are not shown (h! $^+$, h! cc and h! W W), are similar: for the M $_{\rm A}$ values corresponding to Eq. (24) the m AM SB scenario gives rise to larger

deviations in the branching ratios from the SM values than the mGMSB scenario. Thus, if in the situation of Eq. (24) a 3 deviation from the SM value were found in BR (h! bb) and a 4 deviation in BR (h! gg), this would be better compatible with an AMSB scenario than with a mGMSB scenario. If, on the other hand, the branching ratios were found to agree well with the SM prediction, this would be best compatible with a SUSY-breaking scenario of mSUGRA type.

As a consequence, precision measurements at the LC of the branching ratios of the light CP-even Higgs boson of the MSSM may indicate a preference among the three soft SUSY-breaking scenarios at the 1-2 level. This information will be complementary to the information from the direct observation of SUSY particles.

5 Conclusions

We have investigated the relevant production and decay channels of the lightest CP-even M SSM Higgs boson at the Tevatron, the LHC, an e^+e^- LC, a C and a C within the m SUGRA, mGM SB and mAM SB scenarios. The values of BR have been compared with the corresponding SM values with the same Higgs boson mass, M $_{\rm H_{SM}}=m_{\rm h}$. In this context we have also updated earlier results on the upper bound on $m_{\rm h}$ within the three scenarios and on the lower bounds on tan that can be inferred by confionting the theoretical predictions with the LEP exclusion lim it.

We have stanalyzed the observability of the lightest M SSM Higgs boson at the dierent colliders. The modes gg! h! , tt! tth and W W! h! W W; $^+$; allow the detection of the lightest M SSM Higgs boson in all three scenarios over the whole corresponding parameter space. Possible exceptions occur for the very small M $_{\rm A}$ region in the m G M SB and m A M SB scenarios, where a strong suppression ofm ore than 50% could happen for gg! h! . Within the clean experimental environment of the LC the observation of the light Higgs will be ensured for all three scenarios. For a C, the very small M $_{\rm A}$ region in m G M SB and m A M SB can be problem atic for the h! bb and h! mode. At the C, M $_{\rm A}$ < 150 GeV and tan $^>$ 50 for m SU G R A exhibits a strong suppression for the h! bb and h! mode, while on the other hand in this parameter region the production of the heavy M SSM Higgs bosons H , A happens with an enhanced rate. Besides these dicult regions, the main search modes at a C and a C do not suler from severe suppressions with respect to the SM case in all three scenarios. The results of this analysis are sum marized in Tab. 2. Thus, all possible future colliders of er very good prospects for detecting the lightest CP -even Higgs boson of the M SSM in an m SU G R A , m G M SB or m A M SB scenario.

be the case, this could be independently con $\,$ m ed by H iggs m ediated B-physics observables like B $^{\,0}$! $\,$ or B $^{\,0}$ B $^{\,0}$ m ixing.

Sim ilarly, precise m easurements of BR at the LC can also provide indirect information on the high-energy parameters of the three soft SUSY-breaking scenarios. While within the mGMSB scenario the experimental determination of the Higgs branching ratios will allow to set only very weak bounds on the high-energy parameters, within mSUGRA relatively strong bounds on m $_{1=2}$ and in mAMSB moderate bounds on m $_{0}$ could be set.
