The role of strange sea quarks in chiral extrapolations on the lattice

A bstract

Since the strange quark has a light mass of order 0 ($_{OCD}$), uctuations of sea as pairs may play a special role in the low-energy dynamics of QCD by inducing signi cantly di erent patterns of chiral symmetry breaking in the chiral lim its N $_{\rm f}$ = 2 (m $_{\rm u}$ = m $_{\rm d}$ = 0, m $_{\rm s}$ physical) and N $_{\rm f}$ = 3 $(m_u = m_d = m_s = 0)$. This e ect of vacuum uctuations of ss pairs is related to the violation of the Zweig rule in the scalar sector, described through the two 0 (p^4) low-energy constants L₄ and L₆ of the three- avour strong chiral lagrangian. In the case of signi cant vacuum uctuations, three-avour chiral expansions might exhibit a numerical competition between leadingand next-to-leading-order term's according to the chiral counting, and chiral extrapolations should be handled with a special care. We investigate the impact of the uctuations of ss pairs on chiral extrapolations in the case of lattice simulations with three dynamical avours in the isospin limit. In form ation on the size of the vacuum uctuations can be obtained from the dependence of the masses and decay constants of pions and kaons on the light quark masses. Even in the case of large uctuations, corrections due to the nite size of spatial dimensions can be kept under control for large enough boxes (L 2:5 fm).

In order to achieve a better understanding of nonperturbative features of the strong interaction, it is interesting to recall the particular mass hierarchy followed by the light quarks:

where $_{QCD}$ is the characteristic scale describing the running of the QCD e ective coupling and $_{\rm H}$ 1 GeV the mass scale of the bound states not protected by chiral symmetry. Therefore, the strange quark may play a special role in the low-energy dynamics of QCD:

i) it is light enough to allow for a combined expansion of observables in powers of m $_{\rm u}$; m $_{\rm d}$; m $_{\rm s}$ around the N $_{\rm f}$ = 3 chiral lim it (m eaning 3 m assless avours):

ii) it is su ciently heavy to induce signi cant changes in order parameters from the N $_{\rm f}$ = 3 chiral lim it to the N $_{\rm f}$ = 2 chiral lim it (m eaning 2 m assless avours):

iii) it is too light to suppress e ciently loop e ects of m assive ss pairs (contrary to c;b;t quarks).

These three arguments suggest that ss sea-pairs may play a signicant role in chiral dynamics leading to dierent behaviours of QCD in N $_{\rm f}=2$ and N $_{\rm f}=3$ chiral limits. Then, chiral order parameters such as the quark condensate and the pseudoscalar decay constant:

would have signi cantly dierent values in the two chiral lim its (lim $_{\rm N_{\,f}}$ denoting the chiral lim it with N $_{\rm f}$ massless avours).

The role of ss-pairs in the structure of QCD vacuum is a typical loop e ect. Therefore, it should be suppressed in the large-N $_{\rm C}$ lim it, and it can be signi cant only if the Zweig rule is badly violated in the vacuum (scalar) channel $J^{\rm PC}=0^{++}$. On general theoretical grounds [1], one expects ss seapairs to have a param agnetic e ect on chiral order param eters. The latter should decrease when the strange quark m ass is sent to zero: for instance, $(2;m_s)$ $(2;m_s=0)$, and similarly for F². This corresponds to

However, the size of this param agnetic suppression is not predicted.

This e ect can also be discussed in terms of the Euclidean QCD D irac operator, more precisely of its eigenvalue spectrum (with an appropriate weight over the gluonic con gurations) [2, 3]. Chiral order parameters are related to the accumulation of the lowest eigenvalues in the thermodynamic limit. For instance, the quark condensate can be interpreted as the average density of eigenvalues around 0. In this language, the Zweig-rule violating e ect due to ss pairs corresponds to multi-point correlations in the density of eigenvalues around 0 [1]. The size of the paramagnetic suppression eq. (5) depends on the importance of such correlations which can be interpreted as uctuations ².

Thus, it is highly desirable to extract the size of the chiral order parameters in $N_f=2$ and $N_f=3$ limits from experiment. Recent data on scattering [4] together with older data and numerical solutions of the Roy equations [5] allowed us to determ ine the two-avour order parameters expressed in suitable physical units [6]:

A di erent analysis of the data in ref. [4], with the additional input of dispersive estim ates for the scalar radius of the pion, led to an even larger value of X (2) [7]. In any case, X (2) and Z (2) are close to 1, so that corrections related to m $_{\rm u}$; m $_{\rm d}$ 6 0 (while m $_{\rm s}$ rem ains at its physical value) have no signi – cant in pact on the low-energy behaviour of Q C D . In turn, two—avour C hiral Perturbation Theory (PT) [8], which consists in an expansion in powers of m $_{\rm u}$ and m $_{\rm d}$ around the N $_{\rm f}$ = 2 chiral lim it, should su er from no particular problems of convergence. Indeed, its two O (p²) low-energy constants F² (2) and (2) are dominant in the expansions of the decay constant and m ass of the pion.

Unfortunately, two-avour PT [8] deals only with dynam ical pions in a very limited range of energy. In order to include K-and -m esons dynam-ically and extend the energy range of interest, one must use three-avour PT [9] where the expansion in the three light quark masses starts around the N $_{\rm f}$ = 3 vacuum m $_{\rm u}$ = m $_{\rm d}$ = m $_{\rm s}$ = 0. From the above discussion, large vacuum uctuations of ss pairs should have a dramatic e ect on N $_{\rm f}$ = 3 chiral expansions. The leading-order (LO) term, which depends on the O (p²) low-energy constants F² (3) and (3), would be damped. On the other hand,

Observables unrelated to chiral symmetry (string tension, vector sector) would hardly be a ected by this e ect and could be described accurately through large-N $_{\mathrm{C}}$ techniques.

next-to-leading-order (NLO) corrections could be enhanced, in particular those related to Zweig-rule violation in the scalar sector. For instance, the Gell-M ann {O akes{Renner relation would not be saturated by its LO term and would receive sizeable numerical contributions from terms counted as NLO in the chiral counting.

We called unstability of the expansion such a numerical competition between terms of dierent chiral counting. A nave argument based on resonance saturation suggests that higher orders in the chiral expansion should be suppressed by powers of $(M = _H)^2$. However, such an argument does not apply to a leading-order contribution proportional to (3): there is no resonance that could saturate the quark condensate. We expect therefore to encounter three-avour chiral expansions with a good overall convergence:

but the numerical balance between the leading order A_{LO} and the next-to-leading order A_{NLO} depends on the importance of vacuum uctuations.

At the level of O (p⁴) N $_{\rm f}$ = 3 chiral perturbation theory, the size of the vacuum uctuations is encoded in the low-energy constants (LECs) L $_4$ and L $_6$ whose values remain largely unknown. For a long time, one set them to 0 at an arbitrary hadronic scale (typically the -mass) assuming that the Zweig rule held in the scalar sector. More recent but indirect analyses based on dispersive methods [10, 11, 12] suggest values of L $_4$ and L $_6$ which look quite modest but are enough to drive the three-avour order parameters (3) and F 2 (3) down to half of their two-avour counterparts (2) and F 2 (2). Obviously, these indirect hints of sizeable vacuum uctuations call for a more direct con rm ation.

Unstable N $_{\rm f}$ = 3 chiral expansions (A $_{\rm LO}$ — A $_{\rm N~LO}$) require a m ore careful treatm ent than in two- avour PT where such unstabilities do not occur. For instance, it would be wrong to believe that the chiral expansion of 1=A converges nicely 3 . This m ight induce the observed problems of convergence in current two-loop computations [13]: the latter treat the uctuations encoded in L $_4$ and L $_6$ as small uctuations and are not designed to cope with a large violation of the Zweig rule in the scalar sector, leading to unstabilities of the chiral series.

In a previous work [14], we proposed a framework to deal with chiral expansions in the case of large uctuations, by picking up a subset of observables with (hopefully) good convergence properties and resumming the uctuation terms containing the Zweig-rule violating LECs L_4 and L_6 . This

fram ework includes consistently the alternatives of large and small vacuum uctuations.

Obviously, there is a price to pay for this extension: some usual O (p⁴) relations cannot be exploited anymore, because of our ignorance about their convergence. Let us comment on a few novelties in our framework:

 F_p^2 and F_p^2 M $_p^2$ (P = ;K;) are expected to converge correctly: LO and NLO m ay compete, but there should be only a tiny contribution form NNLO and higher. On the contrary, the chiral expansion of M $_p^2$ (ratio of the form er quantities) m ay exhibit a bad convergence.

The three-avour quark condensate and pseudoscalar decay constant expressed in physical units:

are free param eters. Constraints come from the vacuum stability and the param agnetic inequalities (5):

where the values of X (2) and Z (2) have been determined from experiment, see eq. (6).

The quark mass ratio $r=m_s=m$ (m = m $_u=m_d$) cannot be xed from M $_K^2=M^2$ since we do not control the convergence of its three-avour chiral expansion. r becomes a free parameter which can vary in the range:

The chiral expansions of F 2 M 2 and F $^2_{\rm K}$ M $^2_{\rm K}$ lead to a correlation between r and X (2) [1]. Experimentally, the analysis of scattering phase shifts [4] shows that r > 14 (95% CL), slightly favouring values between 20 and 25 [14].

The agreement of the pseudoscalar spectrum with the Gell-Mann $\{$ 0 kubo formula requires a neutuning of L_7 . Let us remark though that this neutuning exists even in the case of a dom inant three-avour quark condensate and small vacuum uctuations [14].

One cannot determ ine LECs or combinations of LECs through ratios of observables. For instance, one should not use $F_K = F$ to determ ine L_5 because we do not know if the chiral expansion of $F_K = F$ converges at all.

There are some prospects of probing experimentally the three-avour sector and in particular the size of vacuum uctuations through K scattering [12]. Unfortunately, the current data are not precise enough to draw any de nite conclusion. On the other hand, recent progress achieved by lattice unquenched simulations [15] makes them an interesting eld to investigate the size of vacuum uctuations. For instance, lattice practitionners can vary very easily the value of the quark masses.

A comment is in order at this point. From large-N $_{\rm c}$ considerations, it is often assumed that quark-loop e ects are not significant, so that simulations with only two dynamical avours, or even none (quenched case), could be good approximations to real QCD. We are precisely questionning this assumption in the case of observables related to chiral symmetry breaking. Thus, it is mandatory to perform unquenched simulations with three dynamical avours in order to probe strange sea-quark e ects on the pattern of chiral symmetry breaking,

One could think of investigating directly the correlations of D irac eigenvalues, or the m_s-dependence of the quark condensate and pseudoscalar decay constant. However, this m ight prove rather challenging tasks since they require simulations with three dynamical very light quarks. In this paper, we investigate another way of probing the size of vacuum uctuations through the spectrum of the theory. Indeed, this less im mediate approach is easier to follow with current lattice simulations. We believe that this exercise might also be useful to illustrate some subtleties arising in three-avour chiral extrapolations when vacuum uctuations of ss pairs are not negligible.

We are not going to address the issue of discretisation, which depends on the speci c implementation of the lattice action. We focus on chiral extrapolations with potentially large vacuum—uctuations and on the impact of nite-volume corrections. For de niteness, we work in the isospin limit $m_{\rm u}=m_{\rm d}=m$ and we consider a lattice simulation with (2+1)—avours: two avours are set to a common mass m, whereas the third one is kept at the same mass as the physical strange quark m $_{\rm S}$. Each quantity X—observed in the physical situation (m; m; m $_{\rm S}$) has a lattice counterpart X for (m; m; m $_{\rm S}$).

We introduce the notation:

where (3) and F (3) are (the absolute value of) the quark condensate and the pion decay constant in the N $_{\rm f}$ = 3 chiral lim it, and B $_{\rm 0}$ = (3)=F (3) 2 . We take the following values for the m asses and decay constants: F = 92:4 M eV , F $_{\rm K}$ =F = 1:22, M = 139:6 M eV , M $_{\rm K}$ = 493:7 M eV , M = 547 M eV .

1 Vacuum uctuations at in nite volum e

1.1 Bare expansions of masses and decay constants

We start by considering the impact of vacuum uctuations on the spectrum in the limit $L \,! \, 1$. Since large vacuum uctuations are allowed, the problems highlighted in the introduction might arise. Therefore, we have to de ne the appropriate observables to consider and the treatment of their chiral expansion. We follow the procedure advocated in [14]:

- 1. Consider a subset of observables that are assumed to have a good overall convergence { we call them \good observables". They must form a linear space, which we choose to be that of connected QCD correlators (of vector/axial currents and their divergences) away from any kinematic singularities. This rule selects in particular F_p^2 and $F_p^2M_p^2$.
- 2. Take each observable and write its NLO chiral expansion.
- 3. In theses formulae, reexpand the physical observables (masses, decay constants...) in powers of quark masses wherever the resulting dependence on the latter is polynomial. Keep the physical quantities only in the nonanalytic terms (unitarity cuts, logarithmic divergences...). The result is called \bare expansion".
- 4. In the polynom ials in quark m asses, reexpress $0 (p^2)$ and $0 (p^4)$ LECs in terms of X (3), Z (3) and r using exact W and identities for pseudoscalar m asses and decay constants.

The rst step is straightforward : one has to compute the NLO chiral expansion of the m asses and decay constants of G oldstone bosons in an in - nite volume with the quark m asses m $_{\rm u}$ = m $_{\rm d}$ = m and m $_{\rm s}$. The expressions can be obtained directly from ref. [9]. Then, we must reexpand the physical quantities occurring in these formulae in terms of the quark m asses wherever

the dependence is analytic. In the case of F_P^2 and $F_P^2M_P^2$, the only issue lies in tadpole contributions such as:

To obtain the bare expansions associated with F_p^2 and $F_p^2 M_p^2$, we keep the physical masses only in the (nonanalytic) logarithm but we expand the front factor in powers of quark masses. Hence, at the chiral order we are working, the contribution from the pion tadpole has the following bare expansion:

In the bare expansion, the polynom ial structure in the quark masses is explictly displayed, so that we can keep track of the relative contribution of the LO, NLO, NNLO...term s.

The resulting bare expansions for the decay constants (third step of our procedure) can be expressed in the following way:

where e_p are NNLO remainders of 0 (m $_q^2$) (m $_q$ denotes either m $_s$ or m). We have divided by the physical value of F 2 in order to deal with dimensionless quantities.

In a sim ilar way, we obtain the bare expansions of the masses:

where \hat{G}_P are NNLO rem ainders of 0 (m $_q^2$). We have divided by the physical value of F 2 M 2 in order to deal with dimensionless quantities.

1.2 Expression of O (p⁴) LECs

We must know perform the fourth step of our procedure. As shown in refs. [1, 10, 11, 14], one can reexpress the O (p^4) LECs L_4 ; L_5 ; L_6 ; L_8 in terms of [r; X (3); Z (3)] (and NNLO remainders) using the four chiral expansions of F_P^2 and F_P^2 M $_P^2$ (P=; K) in the physical case. These quantities, related to two-point functions of axial/vector currents and of their divergences at vanishing momentum transfer, are expected to have smallNNLO remainders. One obtains [14]:

L $_{i}$ = L $_{i}^{r}$ () combine the (renormalized and quark-m ass independent) constants L $_{4;5;6;8}$ and chiral logarithm s so that they are independent of the renormalisation scale :

whereas d; d⁰ and e; e⁰ are combinations of NNLO remainders associated with the chiral expansions of ; K m asses and decay constants respectively. These remainders should be small, and we are going to neglect them for all numerical estimates in the following.

We stress that eqs. (21)-(24) are nothing more than a convenient reexpression of the N $_{\rm f}=3$ chiral expansions of F 2 ; F $_{\rm K}^2$; F 2 M 2 ; F $_{\rm K}^2$ M $_{\rm K}^2$. The latter can be easily recovered through linear combinations of eqs. (21)-(24). For instance, the chiral expansion of F 2 [F 2 M 2] is obtained when one combines eqs. (21)-(22) [eqs. (23)-(24)] to eliminate (r) [(r)].

1.3 Numerical results

To exploit the previous form ulae, we have to x the values of r; X (3); Z (3). Since these parameters are only weakly constrained by experimental data, we will vary them in the ranges r=20;30, Z (3) = 0.4;0.8 and X (3) = 0.2;0.4;0.8. In each \physical" situation, we study how the masses and decay constants of the simulated and X vary with Y, neglecting all NNLO remainders for the moment.

A slight computational diculty arises: in eqs. (15)-(20), the logarithm ic NLO corrections involve the values of the simulated masses $M_{\rm p}^{\,2}$. We could solve iteratively the system of equations to determ in these masses. However, two iterations turn out to achieve a su cient numerical accuracy. This corresponds to an easier procedure: i) compute $M_{\rm p}^{\,2}$ dened from eqs. (15)-(20) with $M_{\rm p}^{\,2}$ replaced by $M_{\rm p}^{\,2}$ on their right-hand side, ii) consider eqs. (15)-(20) again, with $M_{\rm p}^{\,2}$ replaced by $M_{\rm p}^{\,2}$ on their right-hand side, iii) the resulting values for the pseudoscalar masses are equal to $M_{\rm p}^{\,2}$ up to a tiny error.

In gs. 1 and 2 we have plotted F_P^2 , $F_P^2M_P^2$ and M_P^2 (P = ;K) as functions of $q = m + m_s$ in an in nite volume, neglecting all NNLO remainders. For each observable, the rst column corresponds to Z (3) = 0.8, the second one to Z (3) = 0.4. On each plot, the curves correspond to dierent values of X (3) [full: 0.8, long-dashed: 0.4, dashed: 0.2] and of r [thick: r = 30, thin: r = 20].

A few comments are in order:

Our choice of normalisation in poses that all the curves intersect at the




Figure 1: F^2 , F^2M^2 and M^2 (respectively upper, middle and lower plots) normalized to their physical values as functions of $q=m=m_s$. The rst (second) column corresponds to Z (3) = 0.8 (0.4). On each plot, full, long-dashed and dashed curves correspond respectively to X (3) = 0.8;0.4;0.2. Thick (thin) lines are drawn for r=30 (20). All NNLO remainders are neglected.




Figure 2: F_K^2 , F_K^2 M_K^2 and M_K^2 (respectively upper, middle and lower plots) normalised to their physical values as functions of $q=m=m_s$. The rst (second) column corresponds to Z (3) = 0.8 (0.4). On each plot, full, long-dashed and dashed curves correspond respectively to X (3) = 0.8;0.4;0.2. Thick (thin) lines are drawn for r=30 (20). All NNLO remainders are neglected.

If Y (3) > 1, vacuum instability may occur: the pion mass becomes negative for \large" masses $[q = 0 \ (1)]$. This situation would occur if vacuum uctuations had a more signicant impact on the decay constant than on the condensate: the rst would decrease more quickly than the latter from the physical case to the three-avour chiral limit.

A ctually, this situation seem sunlikely. A nonvanishing F^2 is equivalent to the spontaneous breakdown of chiral sym m etry. O ther chiral order parameters (like) may or may not vanish depending on the breaking pattern. We expect therefore F^2 to be the last chiral order parameter to vanish, after or together with all the other parameters (e.g.,), and thus Y (3) 1. The analysis of some properties of the small D irac eigenvalues suggests the same conclusion [2, 3].

Even though this theoretical expectation has not been checked experimentally yet, we dism iss the case Y (3) 1 (unphysical in our opinion) in the remainder of this article.

On the plots, very small values of X (3) do not necessarily correspond to alm ost vanishing pion masses. Indeed, we take into account at least two dierent sources of chiral sym metry breaking: quark condensation (3) and vacuum uctuations L $_4$, L $_6$. For X (3) = 0, chiral sym metry breaking may still be triggered by the uctuations encoded in L $_6$, and the simulated pion mass may remain rather massive for meters

The pseudoscalar masses M_p^2 are not the best candidates to observe a curvature due to chiral logarithms. The m-dependence is hardly dierent from a polynomial one. In addition, X (3) must be much smaller than 1 to observe a variation in the curvature.

2 Finite-volume e ects

2.1 NLO chiral expansions

The lattice simulations are performed in a nite spatial box, whereas time is sent to in nity to single out the ground state. For su ciently large boxes

1 = H), the Goldstone modes remain the only relevant degrees of freedom, whose interactions can be described through a low-energy e ective theory [16]. In the case of periodic boundary conditions, this e ective theory is identical to PT, with the same values of the LECs as in an in nite volume. In addition, if the box size is large enough compared to the inverse Compton length of the pion [16, 17, 18], the so-called p-expansion is valid and the only di erence from the in nite-volume case shows up in the propagators of the Goldstone modes. This a ects only the tadpole logarithms in the formulae of the previous section:

2.2 Bare expansions at nite volum e

The above NLO chiral expansions are not bare expansions yet. We must reexpand the physical masses in powers of quark masses wherever the dependence on the latter is polynomial. Therefore, we have to identify the nonanalytic pieces in the tadpole term ~, which are a logarithm due to ultraviolet divergences and a pole due to infrared divergences.

Since the (nite-volume) tadpole sum and the (in nite-volume) integral share the same ultraviolet divergences, it is convenient to introduce their dierence [19]:

In App.A, we check that all the nonanalytic dependence on M_P^2 in \sim_P com es from the 1rst two terms in eq. (41), whereas the last (bracketed) is analytic in LO (M_P^2) . We could take eq. (41) as the bare expansion of \sim_P . However, a further simplication can be performed: the (last) logarithm in

term in Eq. (41) is smallwhatever the size of the uctuations and contributes to \sim_P only at NLO .W e choose to absorb these terms in the NNLO remainders of the masses and decay constants and to de ne the bare expansion of \sim_P through:

where the ellipsis denotes $0 (p^4)$ terms that are absorbed in the NNLO remainders.

First, let us notice that we recover the results of the previous section in the large-volume limit: only the 11st term in eq. (44) survives, which is exactly the bare expansion of the in nite-volume tadpoles discussed in Sec. 1.1. In addition, this choice for the bare expansion settles related issues concerning the convergence of the expansion at nite volume. PT in a nite box can be consistently formulated in three dierent regimes, called p-, -and -expansions, depending on the relative sizes of the box sides and the pion mass [16]. In particular, the p-expansion used here holds if:

If the second condition is violated, the pion is too large to be contained in the box: the breakdown of the p-expansion is agged by infrared divergences. In the case of small uctuations, quark condensation is responsible for N $_{\rm f}=3$ chiral sym metry breaking. The second condition in eq. (45) is translated into 2m B $_0{\rm L}^2={\rm LO}$ (M $^2)$ ${\rm I}^2$ 1. If either mor B $_0$ are too small compared to the size of the box, the condition is violated and infrared divergences occur in $\sim_{\rm p}$.

In the case of large uctuations, the second condition in eq. (45) has a di erent interpretation. We do not assume any special convention for N $_{\rm f}=3$ chiral symmetry breaking. For non vanishing quark masses, B $_{\rm 0}$ may be small without leading to a small pion mass: for instance, in the limit case B $_{\rm 0}$! 0, a signicant pion mass can be generated by the vacuum uctuations encoded in L $_{\rm 6}$ and L $_{\rm 4}$. Therefore, a small pion mass is obtained only if the quarks are light enough, and the p-expansion must break down form too small but not for B $_{\rm 0}$ too small. One can check that the proposed bare expansion of $_{\rm P}$ exhibits an infrared divergence when m ! 0, but not B $_{\rm 0}$! 0. In other words, even a very small three—avour quark condensate does not lead to the breakdown of the p-expansion if vacuum uctuations are signicant enough.

We could now take the NLO nite-volume expressions for the masses and decay constants, perform the replacement in eq. (44) and study the

resulting expressions. However, we are mainly interested in the nite-volume corrections to the in nite-volume estimates:

2.3 Size of the nite-volume corrections

We begin with a sample plot of the nite-volume corrections. In g. 3, (F 2) and (F 2 M 2) are plotted as functions of q for the special choice of parameters r=25 and Z (3) = 0.8. The left (right) column corresponds to L=1.5 fm (2.5 fm). The thick full, full, long-dashed and dashed curves correspond to X (3) = 0;0.2;0.4;0.8 respectively. For X (3) = 0, the nite-volume correction to F 2 M 2 vanishes at this order, see eq. (49).

We see that the corrections are very signi cant for L = 1.5 fm, but much smaller for L = 2.5 fm. In addition the corrections are smaller for F 2 M 2 than for the decay constant. Indeed, the nite-volume chiral expansion of F 2 M 2 contain an additional factor LO (M 2) multiplying the tadpole term s \sim_P . This tames the infrared divergences occurring when the pion mass is too small compared to size of the box. This damping factor is absent in the expansion of the decay constants.

We want the nite-volume corrections to remain small over a reasonable range of variation for q. Noticing that the size of the corrections is weakly dependent on Z (3), we introduce the quantity:




Figure 3: The relative nite-volume correction to F^2 (upperplots) and F^2M^2 (lower plots). The left (right) column corresponds to $L=1.5~{\rm fm}$ (2.5 fm). We set $r=25;{\rm Z}$ (3) = 0.8. The thick full, full, long-dashed and dashed curves correspond to X (3) = 0;0.2;0.4;0.8 respectively.

whose size we investigate as a function of r and Y (3) for L=2 and 2.5 fm . In gs. 4 and 5, black regions correspond to D sm aller than 5%, increasingly lighter regions to D sm aller than 10,20 and 40% respectively.

We observe the expected decrease of the <code>nite-volum</code> e e ects when the size of the box increases. Once again, we notice that the corrections to $F_P^2M_P^2$ are much smaller than those to the decay constants, due to a better behaviour at the approach of the infrared region. $F_P^2M_P^2$ (P = ;K) in large volum es (L = 2:5 fm) is a quantity for which we manage a good control of nite-volum e e ects.

3 Constraining three-avour order parameters on the lattice

For de niteness, we take a volume of size L=2.5 fm and set r=25. However, we must keep in m ind that the latter is a parameter which may vary between 15 and approximately 35. The qualitative conclusions that we are about to draw do not depend on the exact values of r, but one observes small shifts in the following plots when r is varied in its range.

We take into account the remainders associated with the simulated masses and decay constants e_p and $\tilde{\alpha}_p$ (but not the indirect remainders $d;d^0;e;e^0$). As a rule of thumb [14], we estimate the size of NNLO remainders in the physical case by attributing a 30% (10%) elect to an m $_s$ (m) factor, which leads to 0 (m $_s^2$) 10%, 0 (m m $_s$) 3% and 0 (m²) 1%.

For lattice simulations where m varies, we take the following estimate:

in order to recover the physical case, i.e. 0 $(m m_s)$ ' 0:10 for $m = m_s$ (q = 1) and 0 $(m m_s)$ ' 0:03 for m = m (q = 1 = r).

Figs. 6 and 7 show the pseudoscalar decay constants and m asses as functions of the quark mass ratio $q=m\to \infty$. The left column corresponds to Z (3) = 0.8, the right one to Z (3) = 0.4. On each plot, the various bands show the impact of NNLO uncertainties for dierent values of X (3) [full: 0.8, long-dashed: 0.4, dashed: 0.2]. We plot the results only when the nite-volume e ects are smaller than 10%, but we do not include these corrections in the quantities plotted.

At small q, the pion mass becomes too light, the nite-volume e ects become larger than 10%, and we cannot trust the corresponding results because of potentially large higher-order corrections (in such a case, we set the result to 0 on the plots). In particular the upper left plot in g.6 \mathbb{F}^2 = \mathbb{F}^2 for




Figure 4: The maximal nite-volume corrections D (F^2) (upper plots) and D (F^2M^2) (lower plots) as functions of r and Y (3). The left (right) column corresponds to L = 2 fm (2.5 fm). Black domains correspond to D smaller than 5%, increasingly lighter domains to D smaller than 10,20 and 40% respectively.




Figure 5: The maximal nite-volume corrections D (F_K^2) (upper plots) and D (F_K^2 M $_K^2$) (lower plots) as functions of r and Y (3). The left (right) column corresponds to L = 2 fm (2.5 fm). Black domains correspond to D smaller than 5%, increasingly lighter domains to D smaller than 10,20 and 40% respectively.




Figure 6: F^2 and F^2M^2 (normalised to their physical value) as functions of q. The rst (second) column corresponds to Z (3) = 0.8 (0.4). On each plot, full, long-dashed and dashed bands correspond respectively to X (3) = 0.8;0.4;0.2. Cases where Y (3) > 1 are not shown.




Figure 7: F_K^2 and $F_K^2 M_K^2$ (normalised to their physical value) as functions of q. The rst (second) column corresponds to Z (3) = 0.8 (0.4). On each plot, full, long-dashed and dashed bands correspond respectively to X (3) = 0.8;0.4;0.2. Cases where Y (3) > 1 are not shown.

Z (3) = 0.8], where q m ust be rather large to tame nite-volume e ects, conms that the chiral expansions of the decay constants m ay su er from sizeable uncertainties at small simulated m asses because of large nite-volume corrections.

From the previous analysis, the sensitivity to the three-avour order parameters through the curvature seems more important in the case of the masses (which have smaller nite-volume corrections as well). We can isolate this elect by considering the dimensionless ratios:




Figure 8: The ratio R as a function of q. The rst (second) column corresponds to r = 20 (30). The rst (second) row deals with Z (3) = 0.8 (0.4). On each plot, full, long-dashed and dashed bands correspond respectively to X (3) = 0.8;0.4;0.2. Cases where Y (3) > 1 are not shown.




Figure 9: The ratio R_K as a function of q. The rst (second) column corresponds to r=20 (30). The rst (second) row deals with Z (3) = 0.8 (0.4). On each plot, full, long-dashed and dashed bands correspond respectively to X (3) = 0.8;0.4;0.2. Cases where Y (3) > 1 are not shown.

Figs. 8 and 9 indicate that these two ratios can provide a way of constraining the size of vacuum uctuations by varying q from 1=r to 1. The larger r, the easier the distinction between small and large uctuations, even though the uncertainties due to NNLO remainders increase at the same time.

4 Conclusion

The presence of massive ss-pairs in QCD vacuum may induce signi cant di erences in the pattern of chiral symmetry breaking between N $_{\rm f}$ = 2 and N $_{\rm f}$ = 3 chiral limits, i.e., when m $_{\rm s}$ remains at its physical mass and when m $_{\rm s}$ is set to 0. This e ect, related to the violation of the Zweig rule in the scalar sector, may destabilise three-avour chiral expansions numerically, by damping leading-order (LO) terms proportional to (3) and F 2 (3), and by enhancing next-to-leading-order (NNLO) terms containing the O (p 4) Zweig-rule violating low-energy constants L $_4$ and L $_6$. In such case, a more careful treatement of chiral expansions is required to avoid uncontrolled corrections from higher chiral orders.

In a previous work [14], we proposed a consistent fram ework to take into account the possibility of large vacuum—uctuations. Indirect hints from dispersive estim ates [10, 11, 12] suggest that this e ect m ight be signi cant, but an experim ental determ ination has not been achieved yet. In this paper, we proposed to probe the size of ss-pairs—uctuations through lattice simulations with three dynamical—avours, with a strange quark at its physical mass m s and two lighter—avours of mass m . We focused on the masses and decay constants of the pions and kaons, and worked out chiral expansions which should exhibit small NNLO remainders even when LO and NLO terms compete numerically. The dependence of these observables on m can provide useful constraints on the structure of the N $_{\rm f}=3$ chiral vacuum, and in particular on the size of vacuum—uctuations. Conversely, this dependence

on vacuum uctuations should stand as a warning about three—avour chiral extrapolations on the lattice, which might prove more delicate to handle than usually assumed if vacuum uctuations of ss pairs are signicant.

We have also estimated the corrections due to the nite spatial dimensions used in the lattice simulation. As expected, large volumes (L 2:5 fm) are required to prevent these corrections from spoiling the predictivity of the chiral expansions in the p-regime. These corrections do not seem enhanced in the case of large vacuum uctuations for the observables considered here.

Finally, we isolated two dimensionless ratios based on F 2 M 2 and F 2 M 2 showing interesting features. They are not a ected very strongly by nite-volume corrections, and their dependence on modula provide interesting insights at the size of vacuum uctuations. Therefore, it would be rather interesting to perform a lattice study of these ratios with three dynamical avours, a reasonably large spatialbox, and an action with good chiral properties. The results might shed some light on the pattern of N $_{\rm f}=3$ chiral symmetry breaking and the low-energy dynamics of QCD.

A Bare expansion of nite-volume tadpoles

The nite-volume tadpole $\sim_{\mathbb{P}}$ is related to its in nite-volume counterpart through $_{1=2}$ which can be reexpressed as:

where $g_r^{(d)}$ has been introduced in App.A of ref. [19], and the zero-tem perature limit is given in eq. (B.1) of the same reference 4 .

From App.B of ref. [19], it is straightforward to determ ine the expansion of $g_{1=2}^{(3)}$ in powers of M:

with $_{n+1=2}$ are known numerical coecients (the rst few are displayed in table 1 of ref. [19]).

This leads to the following expansion of $_{1=2}$ (L;M):

Thus, the nonanalytic dependence of \sim_P on LO (M_P^2) comes only from the pole and the logarithm singled out in eq. (41). A coording to our prescription, the bare expansion is obtained once the polynomial terms are reexpanded in powers of quark masses. At our order of accuracy, this amounts to replacing M_P^2 by LO (M_P^2) in the polynomial pieces, i.e.:

The bracketed term has only a polynomial dependence on LO (M_P^2) . This expression yields eq. (44) and the bare expansion of \sim_P .
