# Neutrino Masses in E<sub>6</sub> Unication

#### A bstract

We show that the neutrino masses with large mixing between and are naturally reproduced in a supersymmetric  $E_6$  grand unication model with an anomalous  $U(1)_X$  symmetry. We propose a simple scenario which incorporates a novelmechanism called E-twisting by which all the characteristic features of the fermion mass matrices, not only the quark/lepton's Dirac masses but also the neutrino's Majorana masses, can be well reproduced despite all the members in 27 of each generation are assigned a common  $U(1)_X$  charge.

#### x1. Introduction

Recent report from Superkam iokande strongly indicates two important facts, 1) which have driven us to the unication groups including left-right symmetry. The rst fact is the extremely smallmasses of the neutrinos, which is most naturally explained by the existence of right-handed neutrinos with their Majorana masses of order of  $10^{13}~{\rm G~eV}$ . The existence of the right-handed neutrinos im plies that Nature prefers left-right symmetry and we are led to the left-right symmetric unication group like SO (10). The second fact is the large neutrinom ixing angle which is needed to explain the zenith angle dependence of the observed atm ospheric muon neutrino spectrum. If one wishes to understand the mass matrices in the unied theories larger than SU (5), this large neutrino mixing angle apparently seems unnatural compared with the ordinary quark lepton mass matrices. In SO (10) GUT, for instance, quarks and leptons appear on the same footing and the Dirac-type masses for the neutrinos and charged leptons should be parallel to those for the up-and down-type quarks, respectively. So the most natural prediction would be that the neutrino mixing would also be very small with hierarchical mass structure among generations. This naive prediction of parallelism between quark and lepton sectors, however, was found to be maximally violated in the neutrino sector. Thus the neutrino masses and mixings seem to require something beyond even SO (10). z

Here we would like to rem ark also that the up and down quark mass matrices are already violating the parallelism: the hierarchical structure of the up quark sector is far stronger than that of down quark sector. Also it has long been one of the most important problems to answer the question \why is the top quark far heavier than the bottom quark?"

If one w ishes to explain the inter-generation hierarchical m ass structure, one natural possibility w illbe the Frogatt-N ielsen m echanism  $^{4)}$  using an anom alous U (1)<sub>X</sub> charge. However, if the uni ed gauge group is SO (10) or larger, all the ferm ion members in each generation has a common U (1)<sub>X</sub> charge quantum number, so that the naive application of the Frogatt-N ielsen mechanism will predict a completely parallel hierarchical mass matrix for all the quarks and leptons, contradicting the observations. The naive prediction of this complete parallelism between quark and lepton mass matrices is, however, a result of our prejudice that the three generations of ferm ions are a mere repetition of the same structure, namely, a parallel family structure. If the parallelism between families is broken, then the paral-

lelism between mass matrices of quarks and leptons can also be avoided. The importance of breaking parallel family structure was rst emphasized by Yanagida. 5) Then the question is how the unication model, and what unication group, can avoid this parallel fam ily structure. Am ong the simple groups larger than SO (10), E 6 is essentially the unique group that adm its complex representations in a consistent manner with the chiral structure of our low-energy ferm ions. The exceptional group E 6 has been investigated by many authors  $^{6);7);8);9);10);11);12);13)$  as an attractive uni cation group so far, because of its good features; 1) autom atically anomaly-free, 2) all the basic ferm ions of one generation belong to a single irreducible representation 27 and lastly 3) all the Higgs elds necessary for symm etry breaking are supplied by the ferm ion bilinears. On the other hand, 10 dim ensional E<sub>8</sub> heterotic string theory has been thought to be very attractive as a uni ed theory including gravity from which the low energy N = 1 supersymm etric standard modelm ay be derived.  $^{14)}$  The Calabi-Yau compactication into 4 dimensions may naturally produce E  $_{6}$ gauge sym m etry. In this kind of string models there exists an anomalous U (1) which is to be cancelled by the so-called G reen-Schwarz mechanism. 15) In supersymmetric model this anomalous U (1) was found to play an essential role for explaining the hierarchy of ferm ion m asses via Frogatt-Nielsen mechanism. 16)

The purpose of this paper is to show that there is a novel and natural mechanism in a supersymmetric  $E_6$  grand unication model with an anomalous  $U(1)_X$  symmetry, with which the parallel family structure can be avoided and all the characteristic features of the fermion mass matrices, not only the quark/lepton's Dirac masses but also the neutrino's Majorana masses, can be reproduced. We propose and examine a very simple scenario which incorporates this novel mechanism called E-twisting'.

In x2 we present the basic framework of our E  $_6$  model and point out that there is a freedom of SU (2) $_E$  inner automorphism in E  $_6$  in embedding SO (10) such that SU  $_{GG}$  (5) SO (10) E  $_6$ . As a rejection of this SU (2) $_E$  symmetry, the fundamental representation 27 contains two SU (5) 5 and two 1 components, both giving spinor representations of SU (2) $_E$ . This SU (2) $_E$  transformation plays an important role in explaining the largemixing angle of neutrinos while keeping very small family mixings in the quark sector. In x3 we determine the U (1) $_X$  charges assigned to the three generation matter super elds  $_i$  (27) belonging to 27 of E  $_6$ . In x4 we discuss 5 family structure, namely, which three 5 's become the usual down-quarks and charged leptons among six 5 's in the three 27's. Describing three typical options, parallel family structure, nonparallel family structure and E-twisted structure, we argue that the E-twisted structure gives the simplest option which can reproduce the down quark spectrum and Cabibbo-Kobayashi-Maskawa (CKM) mixings, and, at the same time, the large lepton mixing angle. In x5 we examine the right-handed neutrino Majorana masses

which naturally come from higher dimensional operators in the present scenario. Section 6 is devoted to the sum mary and discussions.

## x2. E<sub>6</sub> Unication Model and E-sym metry

We consider here the simplest example of supersymmetric  $E_6$  unication model which reproduces the large neutrino mixing angle as well as the quark and lepton masses and mixings.

A side from E  $_6$  gauge vector multiplet, we introduce several chiral multiplets which belong to the fundamental representation 27 or 27, or singlet 1 and carry a quantum number, denoted by X, of anomalous U  $(1)_{\rm X}$ .

- 1. The quarks and the leptons of three generations are included in three chiralmultiplets  $_{i}$ 's (i = 1;2;3) of 27 representation, to which we assign odd R-parity and U (1) $_{X}$  charges  $X = f_{i}$ . (The values  $f_{i}$  will be determined later.)
- 2. We introduce two pairs of Higgs elds, (H h; H h), and (x, x), of 27 and 27 chiral multiplets, which are R-parity even and carry the U (1)x charges X = h and X = x, respectively. Their neutral components develop vacuum expectation values (VEV's) and provide superheavy masses for the fermions other than the usual low-energy quarks and leptons and the light masses for the ordinary fermions.
- 3. In addition to these, we introduce an  $E_6$  singlet eld with X=1 and R-parity even, which supplements the Yukawa couplings so as to match the U  $(1)_X$  charge.

Then R-parity, U  $(1)_X$  and E  $_6$  invariant superpotentials giving Yukawa interactions are,

The coupling constants y and y<sup>0</sup> m ay generally depend on (i; j), but we assume they are all of order 1 and so we can suppress the (i; j) dependence in the present discussion of order of m agnitude. The hierarchical m ass structure of ferm ions are explained via Frogatt-N ielsen mechanism; that is, the powers of E<sub>6</sub> singlet eld in this higher dimensional Yukawa coupling (2·1) are required by the U (1)<sub>X</sub> quantum number matching and thee ective Yukawa couplings are suppressed by corresponding powers of  $= h i=M_P$ . We assume  $= h i=M_P$  0·22 henceforth.

Note that the representations 5 and 1 of SU (5) appear twice here, while 10 and 5 appear only once. This suggests that we can do no a parity-like transformation, which we call E-parity',

and the other SU (5) components (16;10) and (10;5) remain intact. A ctually, this E-parity turns out to be a rotation of a certain SU (2)  $E_6$ : indeed, even if we x the SU (5) subgroup in  $E_6$  as the usual SU (5)<sub>GG</sub> of Georgi-G lashow, the embedding of SO (10) into  $E_6$  such that SU (5)<sub>GG</sub> SO (10)  $E_6$ , is not unique, but possesses a freedom of rotations of an SU (2).\*

To see this fact would be easiest if we consider another maximal subgroup SU (6) SU (2)<sub>E</sub>  $E_6$  where the form er SU (6) contains SU (5)<sub>GG</sub> U (1)<sub>E</sub> such that the rst 5 entries of the fundamental representation 6 gives the fundamental representation 5 of SU (5)<sub>GG</sub> U Under this SU (5)<sub>GG</sub> U (1)<sub>E</sub> U (1)<sub>E</sub>

This decomposition of 27 clearly shows that the two 5 as well as 1 belong to a doublet of SU (2)<sub>E</sub>, and so are rotated into each other as a spinor by this SU (2)<sub>E</sub>. In view of the U (1)<sub>V</sub>  $_{\odot}$

There, the embedding of SU (5) into SO (10) such that SU (3)<sub>c</sub> SU (2)<sub>L</sub> SU (5) SO (10) holds, is not unique but possesses a freedom of rotations of an SU (2). This SU (2) is in fact the usual SU (2)<sub>R</sub> of SU (4)<sub>Pati-Salam</sub> SU (2)<sub>L</sub> SU (2)<sub>R</sub> SO (10). But this identication of SO (10) must be possible even after performing an arbitrary SU (2)<sub>E</sub> rotation exp (i  ${}^{j}E_{j}$ ). Then the SO (10) generators  $T_{M,N}$  () for the case of angle—are given by exp (i E)  $T_{N}$  exp (i E) in terms of the original SO (10) generators  $T_{N}$ . This exp (i E) de ness an inner automorphism of E  $_{6}$  which gives a three parameter family of embeddings of SO (10) into E  $_{6}$  such that SU (5) $_{GG}$ —SO (10)—E  $_{6}$  holds. We may call this exp (i E) E-symmetry and the E-parity transformation introduced above is merely a special case of  $T_{N}$  exp (i E  $T_{N}$ ) (or exp (i E  $T_{N}$ )). Indeed, with this exp (i E  $T_{N}$ ) rotation, the E  $T_{N}$  generator is rotated into E  $T_{N}$  = E  $T_{N}$  and hence the E  $T_{N}$  = 1=2 eigenstates of spinor representation are interchanged, in plying that the two 5 states in 16 and 10, as well as the two 1 states in 16 and 1, in Eq. (2.9) are interchanged.

In Eq. (2.1) the Yukawa couplings for individual components are determined by the E $_6$  group relation: the E $_6$  invariant trilinear in 27 is given by a totally symmetric tensor  $^{\rm ABC}$  in the form

It may worth noting that this E-symmetry group SU (2)<sub>E</sub> is identical with an SU (2) subgroup of SU (3)<sub>R</sub> which appears in the famous maximal subgroup SU (3)<sub>C</sub> SU (3)<sub>L</sub> SU (3)<sub>R</sub> of E<sub>6</sub>. But SU (2)<sub>E</sub> is the SU (2) subgroup of SU (3)<sub>R</sub> acting on the second and third entries of 3 of SU (3)<sub>R</sub>, while the usual SU (2)<sub>R</sub> of left-right symmetric theory is another SU (2) subgroup of SU (3)<sub>R</sub> acting on the rst and second entries of 3. # x3. Determination of U(1)x Charges

In 27, SU (5) 10 and 5 components appear once, so the mass matrix of the up quark sector uniquely comes from the term (16;10) (16;10)H (10;5) in Eq. (2·15), which always yields a symmetric matrix. Let H (10;5) develops a VEV, hH (10;5)i =  $v_u$ , giving the up sector masses. We can take the U (1)<sub>X</sub> charge of the Higgs elds H to be h=0 without loss of generality. With this convention, we now determine the U (1)<sub>X</sub> charges  $f_i$  for the three families of  $f_i$  (27).

Experim entally the up sector mass matrix is known to take the following form:

where 0.22 is the order of Cabibbo angle and the bracket () means the corresponding matrix element may be less than the order indicated, since the CKM angles are the dierence

between the up and down sectors. We take  $f_3 = h=2$ , which is zero by our convention for h. Then, in view of the diagonal 33, 22 and 11 elements of this mass matrix, we see that we must take  $f_2 = 2$  and  $f_1$  should be either 3 or 4.

In order to x the U (1) $_{x}$  charge to either 3 or 4, we use the inform ation of the Cabibbo angle. But to discuss the Cabibbo angle, we need the inform ation of the down sector mass matrix. The mass matrix of the down sector has, however, a complication owing to the mixing of the two 5 representations in 27 both for the right-handed down quark d<sup>c</sup> and Higgs H, and comes from the the Yukawa couplings of two types, Eqs. (2.14) and (2.13). We shall discuss this problem in detail in the next section. The Cabibbo angle is given by M  $_{u\,12}$ =M  $_{u\,22}$  M  $_{d\,12}$ =M  $_{d\,22}$  with M  $_{u}$  and M  $_{d}$  are mass matrices of the up and down quark sectors. We will see that, in the scenario to be discussed there, M  $_{d\,12}$ =M  $_{d\,22}$  as well as M  $_{u\,12}$ =M  $_{u\,22}$  is of the order  $_{1}^{f_{1}}$  f, determined by the U (1) $_{x}$  charge assignment to the rst and second families. Thus the Cabibbo angle of order requires  $_{1}^{f_{1}}$  f = 1, from which we must uniquely choose  $_{1}^{f_{1}}$  = 3.

with  $m_t$   $yv_t$ . The u quark mass of order  $^6$  is a bit large so that a small cancellation should occur in the computation of the correct eigenvalue for u.

# x4. 5 Family Structure

Now that we have determ ined the U  $(1)_X$  charges of three families  $_i(27)$ , our next task is to look for a possible 5 family structure which can reproduce the down quark spectrum and CKM mixings, and, at the same time, the large lepton mixing angle.

As already mentioned above, there are two 5 's in each 27. The Higgs doublet, which survives down to the low energy region, can in general be an arbitrary mixed state of the two 5 's in H (27):

which is just an H (10;5) of the E-rotated SO (10) by angle 2, corresponding to generators  $T_{\text{M N}}$  (2) = exp (2i  $E_2$ ) $T_{\text{M N}}$  exp (2i  $E_2$ ). Of course, it should be noted that this angle itself has no physical meaning, but becomes meaning ful once the other down quarks or H iggs specify the direction of the SO (10). In the conventional treatment, the low energy H iggs doublet is identified with H (10;5) corresponding to the choice  $\cos = 1$ , which implies that the SO (10) direction is specified by the H iggs eld. Here, in our scheme, SO (10) direction will be determined by the down quark sector.

So let us proceed to the three families of (right-handed) down quarks, they can in general be any three linear combinations of the six 5 's in the three  $_{\rm i}$  (27). We here consider three typical scenarios:

#### 1. Parallel fam ily structure:

Each family of low energy ferm ions 5 and 10 are contained in a 16 representation of (a xed) SO (10).

### 2. Nonparallel family structure:

Inter-generation m ixings are so large that the three 5 's do not come from  $_1$ ,  $_2$  and  $_3$ , one from each. Such an example is

The structure similar to this was rst proposed by Yanaqida. 5);12);17)

#### 3. E-twisted structure:

Some of the  $_{i}(16;5)$ 's are replaced by  $_{i}(10;5)$  in the parallel family structure (4.2). For example E-twisted version of the third family is given by

This structure implies that the third family falls into 16 of an E-twisted SO (10) compared to the other two families.<sup>k</sup>

Am ong these three possibilities, it is obvious that the rst option (the parallel fam ily structure) predicts completely parallel mass matrices for all the fermions, the up and down quarks, leptons and neutrinos. Thus it can reproduce neither the down quark masses nor the large neutrino mixing angle.

A bit similar twisting in down quark and lepton sectors was ever considered by Haba et. al.<sup>13)</sup> in the SU (6)<sup>0</sup> SU (2)<sub>R</sub> uni ed theory, in which they took essentially (0 (1) $d_1^c + 0$  (1) $d_2^c; D_3^c; D_3^c$ ) and  $(e_1; E_1; O(1)E_2 + O(1)E_3)$ .




Fig. 1. Nonparallel family structure in which the 5 's enclosed by circles are the dominant components which remain light. The solid and dotted lines denote heavy mass terms given by  $h^{x=3}(1)i$  and  $h^{x=2}(16;1)i$ , respectively. The U  $(1)_X$  -suppressed terms with higher powers of  $h^{x=1}$  are indicated by thinner lines. The bracketed line connecting 5 to 5 in the 2nd generation 10 should be absent for this scenario to work, which can be realized if x=3 is 351 coupling to  $(27-27)_A$  anti-symmetrically.

As for the second option (nonparallel family structure), it turns out that we need a higher representation Higgs eld in order to make the other ferm ion components superheavy, as is seen as follows: we need to make  $_1$  (10;5),  $_3$  (16;5) and  $_3$  (10;5), as well as all the 5 components,  $_1$  (10;5), superheavy. This could be most economically achieved as shown in Fig. 1; namely, we rst introduce a Higgs eld  $^{x=3}$  with the U (1)<sub>x</sub> charge 3 such that its VEV h  $^{x=3}$  (1)i = M = $y^0$  in the SO (10) singlet component can yield mass terms M  $_3$  (10;5) and M  $_1$  (10;5) and M  $_1$  (10;5) via the yukawa coupling in Eqs. (2·1) and (2·11). This VEV also yields other mass terms by the Yukawa interactions (2·1) which are generally allowed by supplementing powers of (=M  $_P$ ) to match the U (1)<sub>x</sub> quantum number:

The 22 m atrix element is bracketed here by the reason which becomes clear shortly. Next we add another Higgs eld x=2 with the U (1)<sub>x</sub> charge 2 such that its VEV h x=2 (16;1)i = M  $^{0}$ =y $^{0}$  in the SO (10) 16 SU (5) singlet component can give a mass term M  $^{0}$   $_{3}$  (16;5)  $_{2}$  (10;5) via the coupling (2·12). Of course, this coupling simultaneously yields an (unwanted) mass term M  $^{0}$   $_{2}$  (16;5)  $_{3}$  (10;5) with the same strength M  $^{0}$ . Including also the subdominant

term s suppressed by powers of  $=M_P$ , this VEV gives a mass matrix

Then 1st the pairs  $_3$  (10;5), and  $_1$  (10;5), and 1(10;5) and 3(10;5) acquire a superheavy mass M and decouple from the others. Next we expect that the pair of 3 (16;5) and 2 (10;5) becomes superheavy by the VEV h  $^{x=2}$  (16;1)i = M  $^{0}$ =y $^{0}$ . However, for the component  $_{2}$  (10;5), there is also another m ass term M  $_2$  (10;5)  $_2$  (10;5) with strength M coming from the coupling to the VEV  $h^{x=3}$  (1)  $i = M = y^0$ . In order to keep  $_2$  (10;5) light while to make the pair  $_3$  (16;5) and  $_2$  (10;5) really heavy, the condition M  $^0$  M should hold, but this is incompatible with the rst assumption M  $M^{0}$ . (Note that, without the condition M the presence of the mass term M $^{0}$  2 (16;5) would have caused a large mixing between  $_{2}$  (16;5) and  $_{1}$  (10;5), contrary to our desire to keep essentially the component 2 (16;5) light.) The only way to avoid this situation is therefore to forbid the problem atic m ass term M  $_2$  (10;5)  $_2$  (10;5), which would be realized if the rst H iggs eld  $^{x=3}$  with  $h^{x=3}$  (1)  $i = M = y^0$  were not a 27 but 351 representation of E  $_6$  whose Yukawa couplings to  $_{i}(27)$   $_{i}(27)$  are only antisymmetric in (i;j).

The sim plest and most attractive option is thus the third one, E-tw isted structure, which we shall investigate in the following sections.

#### x5. Down Sector Masses in E-Twisted Structure

Let us investigate the case of E-tw isted structure. In this case, we need only one H iggs  $^{\text{x}=4}$  other than the usual H iggs H and suppose that they develop the following V E V's:




Fig. 2. E-tw isted structure in which the 5 's enclosed by circles are the dominant components which remain light. The solid and dotted lines denote heavy mass terms given by h  $^{x=-4}$  (1) i and hH (16;1)i, respectively. The U (1)<sub>X</sub> -suppressed terms with higher powers of h i=M  $_{\rm P}$  are indicated by thinner lines, as in Fig. 1.

Let us again assume that M  $^{0}$ , namely the breaking scale of E  $_{6}$  down to SO (10) is higher than the breaking scale of SO (10) down to SU (5). This option has very simple structure in which h  $^{x=4}$  (1) i = M =  $y^{0}$  gives superheavy masses to  $_{i}$  (10;5) and  $_{i}$  (10;5) with i = 1 and 2, while hH (16;1) i = M  $^{0}$ =y gives a bit smaller superheavy mass to  $_{3}$  (16;5) and  $_{3}$  (10;5). This now leaves us with the following three light (massless at this stage) eigenstates:

up to unimportant minor mixings with heavier components. These three states are essentially  $_1$  (16;5);  $_2$  (16;5);  $_3$  (10;5) as desired. Then, taking the Higgs mixing (4·1) into account, the Yukawa couplings Eqs. (2·13) and (2·14) lead to the following form of down sector mass matrix:

where  $v_d = hH$  (5 )i and is the Higgs m ixing angle. Our convention for the Dirac mass matrix M  $_{ij}$  is that the ferm ion mass term is given by  $L_m = \overline{(R_iM_{ij} L_j + h.c.)}$ . Note

that the m ixing terms retained in Eq. (5.3), although being small, are also contributing to the j1 and j2 (j = 1;2;3) m atrix elements with the same order amounts as indicated. So they should be taken into account properly if we wish to calculate not only the orders of magnitude but also the coe cients of the matrix elements correctly. If we take  $\sin^2$ , then

So we have  $^2yv_d = m_b$ . This factor  $^2$  came from the Higgs mixing sin in the present E-twisted structure, and provides a natural explanation for the reason why the bottom mass is very small compared with the top quark mass, in the small tan 1 scenario.

This mass matrix M  $_{\rm d}$  is common to the down quark and lepton sectors at the GUT scale in the present approximation, and keeps almost the same form (aside from the over all normalization) down to our low energy regime even after the renormalization group evolution; so we have M  $_{\rm l}$  (m =m  $_{\rm b}$ )M  $_{\rm d}^{\rm T}$ . (The reason why the transposition T appears relatively is because the left-handed and right-handed components are contained in the SU (5) 5 and 10 oppositely for the lepton and down-quark cases.) It is important that the 32 and 33 elements have become of the same order. This gives a large mixing angle in the charged lepton sector:

The M is the Majorana mass matrix of the light (almost) left-handed neutrinos, which we discuss in the next section.

The remarkable fact is that the mass matrix in the down sector is not symmetric even in such a large unication group as  $E_6$  and that it has led to the quite dierent lepton and down quark mixing angles. This was achieved by the E-twisted structure of the third generation.

We have shown that the mass matrix form (5.5) surely reproduces the usual small down quark mixings on the one hand and very large lepton 2-3 mixing on the other. However, to show that the MNS matrix really gives the large 2-3 mixing, we have to examine the the neutrino mass matrix M and turn to this task now.

### x6. Neutrino Masses in E-Twisted Structure

The Majorana mass matrix for the light neutrino is given by

If the param eter  $= M_1=M_2$  is larger than  $^2$ , this left-handed neutrino m ass m atrix M shows hierarchical structure, implying small mixing angles in the neutrino sector. Therefore the large 2-3 m ixing angle in the MNS matrix suggested in the recent atmospheric neutrino experiment can be explained for a wide range of param eters.

Finally, we add some numerology for the absolute values of light neutrino masses. Suppose that

One problem in this scenario which seems unnatural is, however, that SO (10) (16;1) VEV of  $^{x=5}$  must be larger than the SO (10) singlet VEV of H  $^{x=0}$ , quite oppositely to the VEV's of their partner Higgs elds H  $^{x=0}$  and  $^{x=5}$ .

### x7. Discussion and Further Problems

We have presented a supersymmetric  $E_6$  GUT model with anomalous  $U(1)_X$ , which incorporates a novelmechanism for yielding nonparallelmass structures between up-quark and down-quark/charged-lepton sectors.

The hierarchical mass structure is basically explained by the Frogatt-N ielsen mechanism using the U  $(1)_X$  quantum numbers. However, in large unication models with gauge group larger than SO (10), the whole members of each generation fall into a single multiplet and hence must carry a common value of the U  $(1)_X$  charge. Therefore a straightforward application of the Frogatt-N ielsen mechanism would yield a common hierarchical mass matrix to all the up-, down- and lepton sectors, in contradiction to the observation. It seems due to this disculty' that many authors who try to explain the mass hierarchy by the Frogatt-N ielsen

m echanism adopt smaller unication gauge groups, or even discard the grand unication framework.

However we have proposed a novel mechanism which can overcome this diculty in an E  $_6$  GUT framework. We pointed out that there is a freedom of SU  $(2)_E$  inner automorphism in E  $_6$  in embedding SO (10) in such a way that SU  $_{\rm GG}$  (5) SO (10) E. As a rejection of this, the fundamental representation 27 contains two SU (5) 5 (and 1) components, giving a spinor representation of SU  $(2)_E$ , and an arbitrary linear combination of those two together with 10 and a 1 can form a 16 multiplet of an SU  $(2)_E$  rotated SO (10). Our low energy fermions plus a right-handed neutrino just give an SO (10) 16 at each generation. However, the SO (10)'s chosen by three generations need not be the same but may be SU  $(2)_E$  rotated from one another. Moreover yet another SU  $(2)_E$  rotation can occur also in the Higgs 27. Based on this observation, we examined the simplest and typical version in which the SO (10)'s chosen by the rest and second families coincide but the SO (10) of the third family is rotated by angle from it.

It is remarkable that this simplest E-tw isted scenario can reproduce all the characteristic features of the ferm ion masses, not only the D irac masses but also the Majorana masses, by introducing only two Higgs elds H (27) and  $^{x=-4}$  (27), paired with H  $\overline{(27)}$  and  $^{x=-4}$   $\overline{(27)}$ . The small SU (2)<sub>E</sub> rotation with sin  $^2$  in the Higgs H sector explains why the bottom quark is  $^2$  times lighter than the top quark, and why the mixing between the second and third generation neutrinos is very large. The high mass scale M and M  $^0$  for the superheavy ferm ions are supplied by the two Higgs elds H and  $^{x=-4}$ , and their partners H and  $^{x=-4}$  at the same time give the right handed neutrino masses.

We here did not use any higher representations for Higgs elds. Note, however, that 27 of E $_6$  contains no SU (5) nonsinglet component which is standard gauge group singlet. So, to break SU (5) symmetry, we need at least one Higgs eld of higher representations, as far as we stick to the conventional GUT framework. A nother possibility is to use the symmetry breaking mechanism by Wilson lines, as suggested by string theory. We also did not discussed the detailed dierences between the down-quark and charged-lepton mass matrices. If one wishes to utilize Georgi-Jarlskog type mass matrix, one needs 45 representation of SU (5) which is not included in 27.

It is clear from Eq. (A·13) that the SU (2)<sub>E</sub> is an SU (2) subgroup of SU (3)<sub>R</sub> which acts on the second and third entries of the fundam ental representation 3 of SU (3)<sub>R</sub>. Note also that SU (5)<sub>GG</sub> and SU (3)<sub>L</sub> are regular subgroups of this SU (6) such that the rst ve entries and the last three entries of the 6 of SU (6) are the fundam ental representations 5 and 3 of SU (5)<sub>GG</sub> and SU (3)<sub>L</sub>, respectively.

The eld contents in Eq. (A·15) is actually obtained from Eq. (A·13) with this replacement for the component elds together with relabeling the last three indices of SU (6), (4;5;6)! (6;4;5). By this inner automorphism, it is clear that the E<sub>6</sub> invariant trilinear in 27 is given by the same formula Eq. (A·14) also in this case. (If one wishes to have SU (4)<sub>Pati-Salam</sub> which has  $(u_i; )$  and  $(d_i; e^c)$  as its 4 and 4, instead of  $(u_i; )$  and  $(d_i; e^c)$  in the Eq. (A·15), one can easily achieve it using another suitable inner automorphism by an element of SU (2) SU (3), since SU (2) spinors change signs under 2 rotation.)

Finally, as is now clear, yet another SU (6) SU (2) subgroup, SU (6) SU (2), can be obtained from the SU (6) SU (2), by an inner automorphism by rotation exp ( i  $J_{\mathbb{R}}^{\mathbb{R}}$ ) of SU (2), Doing this transform ation exp ( i  $J_{\mathbb{R}}^{\mathbb{R}}$ ) to Eq. (A·13), we note that the A (27) is decomposed under this subgroup SU (6) SU (2), into
