H igher order corrections to parton showering from resum mation calculations

A bstract

The connection between analytic and M onte C arbo calculations of soft gluon em ission is reanalyzed in light of recent, theoretical developments in resum mation. An alternative M onte C arbo algorithm is suggested which incorporates (1) corrections beyond leading order to the show ering and (2) smoothly merges with the higher order calculation of single, hard parton em ission. In particular, it is possible to study jet properties in heavy boson production for all values of the boson transverse momentum with a total cross section of NLO accuracy. The speci c cases of W, Z and Higgs boson production at the Tevatron in Run II are addressed using a modiled version of the PYTHIA M onte C arbo.

I. IN TRODUCTION

In the near future, experiments at two, high (energy hadron colliders will search for evidence of physics that supersedes the standard model. Important among the tools that will be used in these searches are showering event generators or showering M onte Carlos (SM C's). Am ong the most versatile and popular of these are the Monte Carlo's HERWIG [1], ISAJET [2], and PYTHIA [3]. SM C's are useful because they accurately describe the emission of multiple soft gluons, which is, in e ect, an all orders problem in QCD. However, they only predict total cross sections to a leading order accuracy, and, thus, can demonstrate a sizeable dependence on the choice of scale used for the parton distribution functions (PDF's) or coupling constants (particularly s). Also, in general, they do not translate smoothly into kinem atic con gurations where only one, hard parton is emitted. In distinction to SM C's are certain analytic calculations which account formultiple soft gluon emission and higher order corrections to the hard scattering. These resumm ation calculations, however, integrate out the kinem atics of the soft gluons, and, thus, are limited in their predictive power. They can, for example, describe the kinematics of a heavy gauge boson produced in hadron collision, but cannot predict the number or distribution of jets that accompany it. However, searches for new physics, either directly or indirectly through carefulm easurem ents of standard model predictions, often dem and detailed know ledge of kinem atic distributions and jet activity. Furtherm ore, W + jets (and Z + jets) processes are often backgrounds to SUSY or technicolor signatures, and we dem and a reliable prediction of their properties. The aim of this present study is to show how the positive features of the analytic resumm ation calculations can be used to improve the showering algorithms.

The outline of the remainder of this paper is as follows. First, we review the parton shower (Sec. II) and the analytic resummation formalisms (Sec. III). We then show how to modify the showing algorithm to incorporate higher (order corrections to the total cross section (Sec. IV). Furthermore, we show how to correct the soft gluon approximation made in the showering, so that there is a smooth transition between the showering and hard

em ission limits (Sec. V), and we compare this approach to other work. Finally, we present numerical results (Sec. VI) for W, Z and Higgs boson production at the Tevatron in Run II using a modied version of PYTHIA, and our conclusions (Sec. VII).

In the ensuing discussion, we focus on the specic example of W boson production at a hadron collider, when the W decays leptonically. The results apply equally well to ;Z and Higgs bosons (or any heavy, color{singlet particle) produced in hadron collisions.

II. PARTON SHOW ERS

SM C's are based on the factorization theorem [4], which, roughly, states that physical observables in any sensible gauge theory are the product of short{distance functions and long{distance functions. The short{distance functions are calculable in perturbation theory. The long{distance functions are t at a scale, but their evolution to any other scale is also calculable in perturbation theory.

A standard application of the factorization theorem is to describe W boson production at a pp collider at a xed order in $_{\rm S}$. The production cross section is obtained by convoluting the partonic subprocesses evaluated at the scale Q with the PDF's evaluated at Q. The partons involved in the hard collision must be su ciently virtual to be resolved inside the proton, and a natural choice for the scale Q is Q = M $_{\rm W}$ [5]. Prior to the hard collision, however, the partons are not resolvable in the proton (i.e. the proton is intact) and have virtualities at a much lower scale Q $_{\rm O}$ of the order of 1 G eV. The connection between the partons at the low scale Q $_{\rm O}$ and those at the high scale Q is described by the D G LAP evolution equations [6]. The D G LAP equations include the most in portant kinematic con gurations of the splittings a! bc, where a; b and c represent di erent types of partons in the hadron (q; q, etc.). Starting from a measurement of the PD F's at a low scale Q $_{\rm O}$, a solution of the D G LAP equations yields the PD F's at the hard scale Q. Equivalently, starting with a parton c involved in a hard collision, it is also possible to determ ine probabilistically which splittings generated c. In the process of de{evolving parton c back to the valence quarks

in the proton, a number of spectator partons (e.g. parton b in the branching a! bc) are resolved. These partons constitute a shower of soft jets that accompany the W {boson, and in uence its kinematics.

The shower described above occurs with unit probability and does not change the total cross section for W (boson production calculated at the scale Q [7]. The showering can be attached to the hard (scattering process based on a probability distribution after the hard scattering has been selected. Once kinematic cuts are applied, the transverse momentum and rapidity of the W (boson populate regions never accessed by the dierential partonic cross section calculated at a xed order. This is consistent, since the xed (order calculation was inclusive (i.e., pp! W + X) and was never intended to describe the detailed kinematics of the W (boson. The parton shower, in elect, resolves the structure of the inclusive state of partons denoted as X. In practice, the xed order partonic cross section (without showering) can still be used to describe properties of the decay leptons as long as the measurable is well defined (e.g., the number of leptons with central rapidity and high transverse momentum, but not the distribution of rapidity or transverse momentum of the W).

Here, we review parton showering schem atically. More details can be found in Ref. [8]. First, for simplicity, consider the case of nal state or forward showering, where the parton virtuality Q evolves forward to the low scale Q_0 . The basis for developing a probabilistic picture of nal state showering is the DGLAP equation for the fragmentation functions:

where $\hat{P}_{a!\ bc}$ is an unregularized splitting function, $_{abc}$ is the coupling times color factor, and is a cuto . The equation can be rewritten as

gives the probability of evolving from the scale $Q^{0} = e^{t^0}$ to $Q_0^2 = e^{t_0}$ with no resolvable branchings, and is called the Sudakov form factor. t_0 is a cuto—scale for the showering. (t^0) contains all the information necessary to reconstruct a shower, since it encodes the change in virtuality of a parton until a resolvable showering occurs. Showering is reduced to iterative solutions of the equation $r = (t^0) = (t^0)$, where r is a random number uniformly distributed in the interval [0;1], until a solution for Q^0 is found which is below a cuto. For consistency, the cuto—should represent the lowest scale of resolvable emission Q_0 .

For the case of initial state radiation, several modi cations are necessary. The fragmentation function is replaced by a parton distribution function, and the evolution proceeds backwards from a large, negative scale \mathfrak{P}^2 j to a small, negative cuto scale \mathfrak{P}^2 j. There are two equivalent formulations of backwards showering based on the probabilities

A fler choosing the change in virtuality, a particular backwards branching is selected from the probability function based on their relative weights (a sum mation over all possible branchings a! bc is implied these expressions), and the splitting variable is chosen by solving the equation

where r is a random number. The details of how a full shower is reconstructed in the PYTHIAM onte Carb, for example, can be found in Ref. [3]. The structure of the shower can be complex: the transverse momentum of the W {boson is built up from the whole series of splittings and boosts, and is known only at the end of the shower, after the nalboost.

The SMC formulation outlined above is fairly independent of the hard scattering process considered. Only the initial choice of partons and possibly the high scale diers. Therefore, this formalism can be applied universally to many dierent scattering problems. In e ect, soft gluons are not sensitive to the species of the hard scattering, only the color charge of the incoming partons.

III. ANALYTIC RESUMMATION

At hadron colliders, the partonic cross sections can receive substantial corrections at higher orders in $_s$. This a ects not only the total production rate, but also the kinematics of the W boson. At leading order ($_s^0$), the W {boson has a (Q_T^2) distribution in Q_T^2 . At next{to{leading order, the real em ission of a single gluon generates a contribution to $d = dQ_T^2$ that behaves as Q_T^2 $_s(Q_T^2)$ and Q_T^2 $_s(Q_T^2)$ ln $(Q^2 = Q_T^2)$ while the leading order, soft, and virtual corrections are proportional to (Q_T^2) . At higher orders, the most singular terms follow the pattern of $(Q_T^2)^n$ $(Q_T^2)^n$ (Q

The rst studies of soft gluon em ission resum m ed the leading logarithm s [11,12], leading to a suppression of the cross section at small Q_T . The suppression underlies the importance of including sub{leading logarithms [13]. The most rigorous approach to the problem of multiple gluon em ission is the Collins{Soper{Sterm an (CSS) formalism for transverse momentum resum mation [14], which resum sall of the important logarithms. This is achieved after a Fourier transformation with respect to Q_T in the variable b, so that the series involving the delta function and term s V^T simplies to the form of an exponential. Hence, the soft gluon em ission is resum med or exponentiated in this b{space formalism. To be more correct,

the Fourier transform ation is the result of expressing the transverse (m om entum conserving delta functions $^{(2)}(Q_T)^P(K_{T_i})$ in their Fourier representation. Also, the exponentiation is accomplished through the application of the renormalization group equation, not by reorganizing an in nite sum of terms. Despite the successes of the b(space formalism, there are several drawbacks. Most notable for the present study is that it integrates out the soft gluon dynamics and does not have a simple physical interpretation.

The CSS form alism was used by its authors to predict both the total cross section to NLO and the kinematic distributions of the W {boson to all orders [15] at hadron colliders. A similar treatment was presented using the AEGM formalism [16], that does not involve a Fourier transform, but is evaluated directly in transverse momentum Q_T space. When evaluated at NLO, the two formalisms are equivalent to NNNL order in $_{\rm S}$, and agree with the xed order calculation of the total cross section [17]. A more detailed numerical comparison of the two predictions can be found in Ref. [18].

Recently, the AEGM form alism has been reinvestigated, and an approximation to the b{space formalism has been developed in Q_T {space which retains its predictive features [19] (see also the recent eprint [20]). This formulation does have a simple, physical interpretation, and can be used to develop an alternate algorithm for parton showering which includes higher{order corrections to the hard scattering.

In the $b{space form a lism, the dierential cross section of the W {boson produced in association with soft gluons is:$

In this expression, Q, Q_T and Y describe the kinematics of the boson Y, the function Y is regular as Q_T ! 0 and corrects for the soft gluon approximation, and the function W has the form:

In these expressions, C_1 , C_2 and C_3 are constants, H is a function that describes the hard scattering, and A, B, and C are calculated perturbatively in powers of s:

(the rst non{zero terms in the expansion of A and B are for n=1). The functions $C^{(n)}$ are the W ilson coecients, and are responsible for the change in the total production cross section at higher orders. In fact, (C f) is simply a rede nition of the parton distribution function obtained by convoluting the standard ones with an ultraviolet{safe function.

We remove the constants C_1 ; C_2 and C_3 from these expressions by choosing their canonical values [14], which also removes large logarithms. At leading order, the expression for the production of an on $\{\text{shell W } \{\text{boson sim plies considerably to:} \}$

where contains physical constants and we ignore the function Y for now. The expression contains two factors, the total cross section at leading order $_0$, and a cumulative probability function in Q_T^2 that describes the transverse momentum of the W {boson (the total integral over Q_T^2 transforms $e^{i\delta Q_T}$ to $^{(2)}$ (5)). Except for the complication of the Fourier transform, the term $e^{S=2}f(x;b)=f(x;Q)$ is analogous to $(Q)f(x;Q^0)=(Q^0)f(x;Q)$ of the SMC.

Equation (3.1) in b{space has a surprisingly similar structure in Q_T {space. This is surprising, since the b{space result depends critically on the conservation of total transverse momentum. To NLLL accuracy, however, the Q_T space expression agrees exactly with the b{space expression, and has the form [19]:

The factor $_1$ is the total cross section to a $\,$ xed order, while the rest of the function yields the probability that the W {boson has a transverse m om entum $\,$ Q $_{\rm T}$ $\,$.

IV.A MODIFIED SHOW ERING ALGORITHM

The SMC algorithm is based on the evolution equations for fragmentation or parton distribution functions. In fact, the function $\overline{\mathbb{W}}$ in Eq. (3.2) also obeys an evolution equation in b{space. G iven the success of the Q_T {space approach in reproducing the b{space results, we are tempted to rewrite the evolution equation in Q_T {space:

Based on the form of Eq. (3.7) and the above evolution equation, we are led to generalize the function (t)=f(x;t) f(x;t)0= (t0) of backwards showering to $\sqrt[q]{}$ (the square root appears because we are considering the evolution of each parton line individually).

For implementation in a numerical program, like PYTHIA, this requires only that we provide the new, modied PDF (mPDF) based on the W ilson coecients. At leading order, the only W ilson coecient is C $_{ij}^{(0)} = _{ij}$ (1 z), and we reproduce exactly the standard showering formulation. For W {boson production at NLO, the W ilson coecients C are:

and $f_g(x;)$ is unchanged. The rst term gives the contribution of an unevolved parton to the hard scattering, while the other two contain contributions from quarks and gluons with higher momentum fractions that split q! qq and q! qq, respectively.

One should take care that the Sudakov form factor used in the analytic expressions and in the SMC's are equivalent. In fact, we not that:

where $z_m = \frac{Q_T}{(Q+Q_T)}$ is an infrared cuto , and we drop terms of order z_m and higher [21]. When the integration over the running coupling is included to calculate the full Sudakov form factor, there is a mism atch in the argument, but this is formally of higher order. Note that the coecients $A^{(1)}$ and $B^{(1)}$ are universal to qq annihilation into a color singlet object, just as the showering Sudakov form factor only knows about the partons and not the details of the hard scattering. For qq fusion, only the coecient $A^{(1)}$ is universal. In general, at higher orders, the analytic Sudakov is sensitive to the exact hard scattering process.

However, the sim ilarity is not complete. No cuto like z_m appears in the analytic calculations, nor is this the same cuto that appears in the SMC. The expression to the left is positive (provided that $z_m < \frac{1}{2}$), while the analytic expression can become negative. This is disturbing, since it means subleading logarithms (proportional to B) are dominating leading ones. Also, the Q_T (space Sudakov form factor is expressed directly in terms of the Q_T of the heavy boson. In the SMC's, the nal Q_T is built up from a series of branchings, and the analogous expression in terms of the Q_T of the heavy boson would be complicated. We are still in the process of quantifying our comparison between the dierent Sudakov form

factors. Nonetheless, we feel that the agreem ent apparent in Eq. (4.5) is compelling enough to proceed assuming the two Sudakov form factors are equivalent. This becomes important later in our numerical results, because we continue to use the standard SMC Sudakov form factor in the modiled showering, but the analytic expression when correcting the hard emission. To avoid the regions when the B $^{(1)}$ term dominates the A $^{(1)}$ term, we retain only A $^{(1)}$ in our analytic expression.

V.HARD EM ISSION CORRECTIONS

The SMC and resum mation formalisms are tuned to deal with kinematic congurations that have logarithmic enhancements L. For large Q_T , there are no such enhancements, and a xed order calculation yields the most accurate predictions. The region of medium Q_T , however, is not suited to either particular expansion, in ${}_s^n L^m$ or ${}_s^n$.

The problem becomes acute for SMC's. In the standard implementation of SMC's, the highest Q_T is set by the maximum virtuality allowed, $Q = M_W$ in our example, so that the region Q_T Q is never accessed. However, at Q_T Q, the xed order calculation is preferred and yields a non {zero result, so there is a discontinuity between the two predictions. Clearly, the SMC underestimates the gluon radiation wellbefore Q_T ' Q, but the xed order calculation make equally overestimate the radiation if extended to the region Q_T Q.

In the b{space calculation, the same sort of behavior would occur, except that contributions to the cross section that are not logarithm ically enhanced as Q_T ! 0 can be added back order{by{order in $_S$. This procedure corrects for the approximations made in deriving the exponentiation of soft gluon emission. This correction is denoted Y, or Y_f in contrast to the resummed term Y_r . If the coecients A and B are calculated to high{enough accuracy, one sees a relatively smooth transition between Eq. (3.1) and the NLO prediction at $Q_T = Q$. The situation is even better in the Q_T {space calculation, since the matching at $Q_T = Q$ is guaranteed at any order.

Therefore, it is desirable to de ne a function similar to Y in the analytic calculations for

use in the SM C's. At LO, Y vanishes, thereby exhibiting the correct limiting behavior. At NLO, Y is the difference between the order $_{\rm S}$ calculation of W + parton and the resum med distribution expanded to order $_{\rm S}$. The latter is also called the asymptotic piece. In application, Y is a positive function, but this is misleading, since the asymptotic piece can be negative. In a SM C, the event weights are positive denite, and its truncation at a certain order will also be positive. However, the fact that the asymptotic piece becomes negative is only a technical point related to the behavior of the Sudakov form factor in the analytic calculations. Y is meant to correct for the soft gluon approximation made in constructing the Sudakov form factor. Therefore, our denition of the Y piece for the SM C is simply the order $_{\rm S}$ calculation minus the single emission contribution from the showering.

The appropriate correction is derived by reviewing Y in the resum m ed calculation, w hich has the form

The terms proportional to Q_T^2 are the asymptotic pieces. To guarantee that only one em ission has occurred, the asymptotic piece derived from the showering should be additionally corrected to the probability that this is the hardest scattering in the shower. This is accomplished by weighting by the Sudakov form factor exp($S(Q;Q_T)=2$) for the appropriate transverse momentum Q_T . The necessity of weighting by the em ission probability has been stressed elsewhere [23].

The e ects of Y are calculated by generating the explicit N LO subprocess and correcting on an event{by{event basis. We illustrate this explicitly for the qq^0 ! Wg subprocess. Each event receives an additional weight f_Y before it is accepted or rejected (this is accomplished in the subroutine PYEVWT already provided in the PYTHIA code for the user to reweight any process), where f_Y is defined as:

and J $(r^2) = \$(1 - r^2 = Q^2) = (r^2 - \frac{1}{2}r^2 = Q^2)$ is a Jacobian factor. A $_{\rm exact}$ is proportional to the exact squared am plitude, and A $_{\rm show\,er}$ is the show ering contribution in the collinear lim it. The presence of factor P $_{\rm show\,er}$, which accounts for the probability that the parton em ission occurs at Q $_{\rm T}$, guarantees that the correction vanishes at Q $_{\rm T}=Q$ and cancels the collinear singularity in the exact squared am plitude when Q $_{\rm T}$! 0. A similar correction is applied to the qg! W q^0 subprocess, which can be extracted from Eq. (5.2).

At this point, it is useful to compare the scheme outlined above to other approaches at improving the showering algorithm. One class of corrections is based on phase space splitting, where part of a NLO matrix element is treated with LO kinematics and part

with exclusive NLO kinematics [24]. The idea is to allow parton showering for one of these con gurations, and not the other. Particular care must be taken not to consider showering con gurations already included in the complimentary phase space region. U sually, there is an adjustable parameter that splits the phase space, and physical observables are sensitive to the exact choice (see the discussion in Ref. [22] regarding Q_T^{sep}). This scheme is guaranteed to give the NLO cross section before cuts, but does not necessarily generate the correct kinematics.

The other class of corrections modi es the showering to reproduce the hard emission limit [25]. While this can be accomplished, it does so at the expense of transferring events from low Q_T to high Q_T . There is no attempt to predict the absolute event rate, but only to generate the correct event shapes. In some implementations, the high scale of the showering is increased to the maximum virtuality allowed by the collider energy. This is contrary to the analytic calculations, where the scale $Q = M_W$, for example, appears naturally (in the choice of constants C_1 ; C_2 and C_3 which eliminate potentially large logarithms). This scheme will generate the correct hard limit, but will not generate the correct cross section in the soft limit.

The present formulation contains the positive features of both schemes. Phase space is split (but without any adjustable parameters { which is also true for the corrections outlined in Ref. [23]), but higher { order corrections are also applied to the showering algorithm. This is contained in the modiled PDF and the Sudakov form factor. Instead of applying corrections to the showering to reproduce the hard limit, corrections are applied to the hard emission cross section to avoid double counting with the showering. The corrections allow a smooth transition between the explicit hard emission and the showering.

So far, the discussion has been theoretical. In the next section, we demonstrate the phenom enological implementation of these ideas.

VI.NUM ERICAL RESULTS

We have applied the showering modi cations outlined above to three cases of relevance to the Tevatron in Run II: (a) We boson production, (b) Ze boson production, and (c) standard model Higgs boson production with a Higgs boson mass $m_H = 100~\text{GeV} \cdot \text{We}$ have accomplished this by modifying the PYTHIA Monte Carlo [3]. Most of the previous discussion applies almost exactly to the case of Ze boson production. In particular, the modied PDF used for the showering and the corrections f_Y are exactly the same. For Higgs boson production, we use the expressions for A; Be and Ce presented in Ref. [27]. One technical point should be noted: we have not yet attempted to modify the Sudakov form factor in plemented in PYTHIA. For reweighting events by f_Y , we use only the A $^{(1)}$ term in the Sudakov form factor with a running coupling. For Higgs boson production, A $^{(1)} = 3$.

First, we present the Q_T distribution of the heavy boson produced at the Tevatron. These distributions are in good agreement with analytic calculations, but cannot be predicted accurately by the standard showering algorithm. Secondly, we present jet properties for the same processes, which are not signicantly altered from the predictions of the standard showering algorithm. These cannot be predicted by analytic calculations.

A. Heavy Boson Properties

Here, we present our results on the $Q_{\rm T}$ distributions for the bosons of W , Z , and H iggs bosons (m $_{\rm H}$ = 100 GeV) produced at the Tevatron in Run II. Even though we have only considered leptonic decays of the W and Z bosons and the decay of the H iggs boson, our nal results represent the total production cross section.

Figure 1 displays the Q_T distribution of the W boson generated using the modi ed version of PYTHIA. The solid line is the full distribution, where the dashes and dots show the individual contributions from the corrected showering and the corrected hard emission (Y) piece. The modi ed PDF (mPDF) is calculated using CTEQ4M PDF's. For reference, we

show the Q $_{\rm T}$ distribution using the default version of PYTHIA and CTEQ4L PDF's. Because the maximum virtuality of the showering is set to the scale M $_{\rm W}$, the SMC contributions are suppressed beyond Q $_{\rm T}$ ' M $_{\rm W}$. Note how the Y piece lls in the intermediate Q $_{\rm T}$ region down to small Q $_{\rm T}$, where showering gives the preferred result. The total cross section predicted by PYTHIA is (182, 20.5, 23.60) nb using CTEQ4L, CTEQ4M, and mPDF+Y. The total increase in rate from LO to NLO is in good agreement with Ref. [22] at $^{\rm P}$ $^{\rm C}$ = 2 TeV. Our numbers for $^{\rm P}$ $^{\rm C}$ = 1.8 TeV also agree with the CDF and D data [26].

We do not present a direct comparison with the Q_T distribution presented in Ref. [22], since the peak in the region Q_T 10 GeV, where the bulk of the data lies, is determined by non{perturbative functions [28], which generate a primordial k_T for the partons. It is interesting that the mPDF calculation, without Y, yields nearly the same rate as using just the CTEQ 4M PDF (21.6 nb vs. 20.5 nb). This is anticipated by the smallness of the virtual correction in the W ilson coe cients / 2 8. However, this need not be the case for different processes or different colliders.

In Fig. 2, we display the sim ilar results for Z boson production at the Tevatron in Run II. This shows only the true Z contribution without any . The results are quite similar to the W boson case, and we present them without further comment.

The results for the production of a Higgs boson with mass $m_H = 100$ GeV is shown in Fig. 3. Here, the correction to the lowest order process is quite large. The total cross section predicted by PYTHIA is (0.50, 0.48, 1.05) pb using CTEQ 4L, CTEQ 4M, and the mPDF+Y. The nal number are in good agreement with Ref. [29]. There is a noticeable bump in the nal distribution from the merging of the mPDF and Y contributions. We feel this is the result of a mism atch between the analytic Sudakov form factor and the Monte Carlo one. In particular, we have not yet successfully included any contributions beyond A $^{(1)}$, since we not values of Q_T where subleading excets appear to be more important than leading ones. A lso, we have used the default PYTHIA value for the primordial k_T , which determines the location of the peak in the showering distribution and the existence of the bump. If we believe that the non (perturbative function should have the same form as the perturbative Sudakov form

factor, then the prim ordial k_T should scale like $C_A = C_F$ relative to the qq case [30]. This m ight wash out the apparent bum p. Finally, while we have not done so in the present study, we could allow additional parton showering in Y, provided that no em issions from showering are harder than the explicit hard em ission. This too would reduce any m ism atch between the showering distribution and Y.

It is interesting to know if the kinematic distributions for the heavy bosons can be reproduced using the standard showering algorithms with a multiplicative K (factor that yields the total NLO rate. Figure 4 shows the ratio of the Higgs boson transverse momentum distributions calculated from mPDF+Y to CTEQ4L times K (K $^{>}$ 2). There are variations as large as 10% in the important regions of small and medium $Q_{\rm T}$. Of course, the elect is much larger for the large $Q_{\rm T}$ region where there is almost no rate from the standard parton showering.

B. Jet properties

In Figs. 5 and 6, we present jet properties for the W and Higgs boson production processes. The results for Z boson production are qualitatively the same as for the W boson, so we do not present them here.

Jets are de ned using the cone clustering algorithm of the PYTHIA subroutine PYCELL with a cone of size R = 0.5, E_T > 15 GeV, and j j < 2.5. For W boson production in Fig. 5, we present the jet multiplicity distributions for all Q_T , Q_T < 10 GeV, $10 < Q_T < 20$ GeV, and Q_T < 30 GeV. We compare the showering predictions using mPDF (solid line), CTEQ 4M (dashed line), and CTEQ 4L (dotted line). To study the elects of the modiled showering algorithm, we do not include Y, which would increase the N jet = 1 bin of the mPDF prediction. All distributions are normalized to unity. From Fig. 5, we see that the predictions have only minor dilerences, which is expected since the Wilson coel cients for W production are nearly unity.

For the case of H iggs boson production in Fig. 6, we study the regions Q $_{
m T}$ $\,<\,$ 25 G eV ,

 $25 < Q_T < 50 \ GeV$, and $Q_T < 75 \ GeV$. There are more noticeable dierences, and much more radiation in general than for the W boson case. The higher order PDF's generate slightly more jet activity and yield similar distributions. In general, though, there are no dram atic changes in the distributions. This is not too surprising, since the showering depends on the ratio of the modiled PDF's evaluated at two dierent scales, which is not as sensitive to the overall normalization of the PDF.

From these examples, we learn that the use of the modi ed showering algorithm does not change the jet properties in a majorway. On the other hand, we have not yet modi ed the splitting kernels in the Sudakov form factor to account for the coe cients $A^{(2)}$ or $B^{(2)}$, but these higher order terms should not have a substantial e ect.

VII.CONCLUSIONS

We have presented a modi ed, parton showering algorithm that produces the total cross section and the event shapes beyond the leading order. These modi cations are based on the Q_T (space resummation. The parton showering itself is modi ed by using a new PDF (called mPDF) which encodes some information about the hard scattering process. Simultaneously, the explicit, hard emission is included, but only after subtracting out the contribution already generated by the showering: this correction is called Y. The presence of Y yields a smooth transition from the parton showering to single, hard emission. We modied the PYTHIAM onte Carlo to account for these corrections, and presented results for W, Z, and Higgs boson production at the Tevatron in Run II.

The scheme works very well at NLO for the cases considered in this study, and the correct cross sections, transverse momentum distributions, and jet properties are generated. We have compared our kinematic distributions to the case when the results of the standard showering are multiplied by a constant K (factor to reproduce the NLO cross section. We not variations on the order of 10% for small and medium transverse momentum. For Higgs boson production, a slight mismatch is present in the transition between showering with

mPDF and the hard correction Y, which probably comes from the approximate form of the Sudakov form factor used in our studies.

There are several e ects which still need study. We have not included the exact distributions for the decay of the leptons [31] for W and Z production, which are resum med di erently. It is straightforward to include such e ects. In the theoretical discussion and num erical results, we have focussed on initial state radiation, but our results should apply equally well for nal state radiation. The situation is certainly simpler, since nal state radiation does not require detailed know ledge of the fragm entation functions. A lso, the case when color ows from the initial state to the nal state requires study. A resum med calculation already exists for the case of deep inelastic scattering [33], and much theoretical progress has been made for heavy quark production [34]. We believe that the modi ed showering scheme outlined in this study generalizes beyond NLO, just as the analytic calculations can be calculated to any given order. For example, we could include hard W + 2 jet corrections [32] to Y. For consistency, however, higher order terms (A and B) will also need to be included in the Sudakov form factor.




FIG.1. W boson transverse momentum distribution.




FIG. 2. Z boson transverse m om entum distribution.




FIG .3. Higgs boson transverse m om entum distribution (m $_{\rm H}$ = 100 GeV).




FIG.4. The ratio of Higgs boson transverse momentum distributions (m $_{\rm H}$ = 100 GeV) from the modi ed showering algorithm and from the standard showering algorithm using the CTEQ4L PDF. The CTEQ4L result has been multiplied by a constant K {factor to reproduce the NLO rate.




FIG.5. Jet multiplicity in W boson events for dierent Q $_{\rm T}$ binnings.




FIG .6. Jet multiplicity in Higgs boson events for dierent Q $_{\rm T}$ binnings.
