M agnetic M om ents of H eavy B aryons

A bstract

First non-trivial chiral corrections to the magnetic moments of triplet (T) and sextet (S $^{(\)}$) heavy baryons are calculated using Heavy Hadron Chiral Perturbation Theory. Since magnetic moments of the T-hadrons vanish in the limit of in nite heavy quark mass (m $_{\rm Q}$! 1), these corrections occur at order O (1= (m $_{\rm Q}$ 2)) for T-baryons while for S $^{(\)}$ -baryons they are of order O (1= 2). The renormalization of the chiral loops is discussed and relations among the magnetic moments of dierent hadrons are provided. Previous results for T-baryons are revised.

1 Introduction

Chiral Perturbation Theory (ChPT) and Heavy Quark E ective Theory (HQET) can be combined together to construct an e ective lagrangian which describes soft interactions of hadrons containing a single heavy quark [1]-[4]. Electrom agnetic interactions can be included in the form alism by gauging a U (1) $_{\rm EM}$ subgroup of the global SU (3) $_{\rm L}$ SU (3) $_{\rm R}$ symmetry group.

In the lim it m $_{\rm u}$, m $_{\rm d}$, m $_{\rm s}$! 0, the QCD Lagrangian for light quarks has a SU (3) $_{\rm L}$ SU (3) $_{\rm R}$ U (1) $_{\rm V}$ sym m etry, which is spontaneously broken to SU (3) $_{\rm V}$ U (1) $_{\rm V}$. The lightest particles of the hadronic spectrum, the pseudoscalar octet (, K , K ,), can be identifed with the corresponding Goldstone bosons. Their low-energy interactions can be analysed making use of Chiral Perturbation Theory (ChPT) [5], which is an expansion in terms of momenta and meson masses. Goldstone bosons are parametrised as

and appear in the Lagrangian via the exponential representation = $\exp(2i = f)$ being f 93 M eV the pion decay constant. Under chiral transform ations,

where L (R) are global elements of SU (3)_{L (R)}, and h is a local SU (3)_{L+R} transform ation, which depends both on and on the chiral transform ation (L; R). To construct the elective theory, one must write the most general Lagrangian consistent with chiral sym metry involving and its derivatives. Chiral sym metry is explicitly broken in QCD by the quark mass term. This can be incorporated in the elective Lagrangian through the light mass matrix, which gives rise to a quadratic pseudoscalar mass term. The Lagrangian is then organized as an expansion in powers of (p=) and (mq=), where p is the low pseudoscalar momenta, mq denotes the light quark masses and 1 GeV is the chiral sym metry breaking scale which suppresses higher{order terms in the elective theory.

On the other side, in the opposite lim it, m $_{\mathbb{Q}}$! 1 , which is useful for c and b-quarks, di erent simplications occur in the dynam ics of heavy-light hadrons. Q wark interactions do not change the velocity of the heavy quark inside the hadron, because the momentum exchange is of order P $_{\mathbb{Q}\,\mathbb{C}\,\mathbb{D}}$ << m $_{\mathbb{Q}}$. In the hadron rest frame, the heavy quark acts as a static colour source which interacts with the light degrees of freedom. This interaction is independent of the mass and spin of the heavy quark, and thus the hadron dynamics shows SU (2) spin symmetry and SU (N $_{\mathrm{f}}$) avour symmetry (for N $_{\mathrm{f}}$ heavy avours). HQET [6] is an elective eld theory for QCD which makes this symmetry manifest in the m $_{\mathbb{Q}}$! 1 limit, and describes the dynamics of hadrons containing a heavy quark, at momentam uch lower than m $_{\mathbb{Q}}$. The elective baryon elds are labeled by their velocities and their mass is removed from the baryon momentum, P. Derivatives on the baryon elds produce powers of residual momentum (k=m $_{\mathbb{Q}}$) << (P=m $_{\mathbb{Q}}$).

In some kinematical regions, which are not far from the chiral and heavy quark limits, both approaches can be simultaneously used. Baryons containing a heavy quark, in the m_Q! 1 limit, can emit and absorb light pseudoscalar mesons without changing its velocity, v. In Heavy Hadron Chiral Perturbation Theory (HHCPT) one constructs an elective Lagrangian whose basic elds are heavy hadrons and light mesons. In ref. [7], the formalism is extended to include also electromagnetism. We use this hybrid elective Lagrangian to calculate the magnetic moments (MM) of some baryons containing a clore a big quark.

In section 2 we review the needed HHCPT form alism, introduced in ref. [7]: the elective elds representing S and T-baryons, the lowest order chiral lagrangian and its O (1=m $_{\rm Q}$), O (1=) corrections. These terms generate divergent chiral loops which contribute to the MM. Their renormalization requires the introduction of higher order operators. In the case of S we not that all divergences and scale dependence to O (1= 2) can be absorbed in a rede nition of only one O (1=) coupling. Our computations and results are presented in section 3. The magnetic moments of the T-baryons are analyzed in ref. [15]. However this analysis does not include all meson loops and the needed counterterms are not taken into account. In section 4 we provide a consistent calculation of the T magnetic moments to order O (1=(m $_{\rm O}$)). Finally section 5 summarizes our conclusions.

2 HHCPT form alism for magnetic moments

The light degrees of freedom in the ground state of a baryon with one heavy quark can be either in a s_1 = 0 or in a s_1 = 1 con guration. The rst one corresponds to $J^P = \frac{1}{2}^+$ baryons, which are annihilated by $T_i(v)$ elds which transform as a 3 under the chiral SU (3)_{L+R} and as a doublet under the HQET SU (2)_v. In the second case, s_1 = 1, the spin of the heavy quark and the light degrees of freedom combine together to form $J^P = 3=2^+$ and $J = 1=2^+$ baryons which are degenerate in m ass in the m_Q! 1 limit. The spin- $\frac{3}{2}$ ones are annihilated by the Rarita-Schwinger eld S ^{ij} (v) while the spin- $\frac{1}{2}$ baryons are destroyed by the D irac eld S ^{ij} (v). It is very useful to combine both operators into the so-called super eld [8]

which transforms as a 6 under SU $(3)_{L+R}$ and as a doublet under SU $(2)_v$ and is symmetric in the i, j indices.

The J=3=2 partners of the baryons of Eq. 5 and Eq. 7 have the same SU (3)_V assignement in S ij .

The lowest order chiral lagrangian describing the soft hadronic and electrom agnetic interactions of these baryons in the in nite heavy quark mass limit is given by [7]

Because of the dierent spin con guration of the light degrees of freedom there is an intrinsic mass dierence, $_{\text{ST}}$ M $_{\text{S}}$ M $_{\text{T}}$, among the S $^{()}$ and the T baryons.

Notice that a direct coupling of the pseudo-Goldstone bosons to the 3 baryons is forbidden at the lowest order in 1= .

As can be seen, there are no M M terms in the lowest order lagrangian in Eq. 8. Therefore, the contributions to the M M $\,$ com e from :

1) the next order in the baryon chiral lagrangian [7]

where the constants c_i are all unknown. We will take = 4 f ' 12 GeV which xes the normalization of the unknown couplings c_i ;

3 Results for S-baryons ($s_1 = 1$)

We de nethem agneticm om ent operator for a spin 1/2 baryon B and a spin 3/2 baryon B respectively as

The leading contributions from the light-and heavy-quark magnetic interactions are of order 0 (1=) and 0 (1=m $_{\rm Q}$) respectively. We compute the next-to-leading chiral corrections of order 0 (1= 2) which originate from the loop diagram s shown in g1.

The resulting M M can be decomposed as:




Figure 1: Meson loops contributing to S-baryons MM.

We want to stress that due to avour symmetry, the constants $c_{\rm s}$, $g_{\rm 2}$ and $g_{\rm 3}$, and hence the values of , $g_{\rm 2}$ and $g_{\rm 3}$, are the same for c and b{baryons. The only dierence is the contribution proportional to $_{\rm HQE}$ due to the dierent electric charge of the c, $Q_{\rm c}$ = +2=3, and b, $Q_{\rm b}$ = 1=3, quarks (see Eq.15).

In Eq. 15 we have not considered contributions of order 0 (1=(m $_{\rm Q}$)). For the b{ baryons, these corrections can be safely neglected. For the c{baryons, however, a simple estimate shows that their contribution cannot be larger than, say, 15%. Besides, the self{energy and loop diagrams with an insertion of the operator in Eq. 12 yield contributions of order 0 (1= 3) which again can be neglected because they are NNLO chiral corrections.

The results proportional to g_2^2 are obtained performing a one-loop integral (g.1 with an S {baryon running in the loop) that has to be renormalized. The divergent part of the integral does not depend on the pion or kaon mass and is instead proportional to the mass of the baryon running in the loop. If one considers both pion and kaon loops the divergent part respects the SU (3) structure of the chiral multiplet and can be canceled with an operator of the form

This is the most general dimension {6 chiral and Lorentz invariant operator constructed out of S ij and Q F , preserving parity and time-reversal invariance which contributes to M M . When the equation of motion ((v D)S = $_{\rm ST}$ S) is applied, its contribution is of the same form as the term proportional to $c_{\rm s}$ in Eq. 12. Thus, the local contribution from the operator in Eq. 18 can be taken into account, together with the lowest order term in Eq. 12, through an elective coupling $c_{\rm S}$ (). The scale dependence of the loop integrals is exactly canceled by the corresponding dependence of the coelient $c_{\rm S}$ ().

The contribution proportional to g_3^2 involves a loop integral in which a baryon of the T-multiplet is running in the loop. However, as we are in the limit of m_T ! 1 no mass term for these T-baryons is present in the Lagrangian of Eq. 8. This means that the only massive particles running in the loop are the light mesons and the result of the integral is convergent and proportional to their mass.

U sing Table 2 one can derive the following linearly independent relations for the magnetic moments of spin 1/2 baryons containing a c-quark:

Including the spin 3/2 baryons one can derive six m ore independent relations,

The last three equations connect observables corresponding to spin 1/2 and spin 3/2 baryons.

From Table 2, we see that the order O (1=~) and O $(1=~^2)$ contributions cancel in the sum of all baryon M M within the sextet. Therefore, the average over the baryon m om ents measures the M M of the heavy quark,

If one has got a num erical estimate of the couplings g_2 and g_3 , it is possible to derive a scale independent relation between any couple of baryons. The combination

is independent of the unknown coupling $c_{\scriptscriptstyle S}$ () an can then be predicted. For instance

The couplings g_2 and g_3 have been calculated theoretically. In Table 3 we report the results of these computations.

There exists an experimental measurement of g_3 from CLEO coming from the decay g_3 ! $g_3 = \frac{1}{3}(0.57 - 0.10)$. The direct measurement of g_2 is not possible at present. However, the quark model relates its value to g_3 [12], yielding $g_2 = 1.40 - 0.25$.

In order to get a num erical estim ate of the left-hand side of Eq. 26 we set $g_2 = 1.5$ 0.3 and $g_3 = 0.99$ 0.17 and the rest of the constants as in Table 1. We not for our best estim ate of Eq. 26

4 Results for T-baryons ($s_1 = 0$)

As the light quarks of the T-baryons are in a $s_1=0$ con guration, the contributions to the magnetic moments of these hadrons are $1=m_Q$ suppressed [4]. The leading term is of the form $m_{Q,E}=m_Q$ and the rst chiral corrections are of order $O(1=(m_Q))$) and come from [15]

The contributions of order 0 (1= (m $_{\rm Q}$ $^{\rm 2}$)) have di erent origin:

1. there is a divergent contribution [15] com ing from Eq.8 through the chiral loops shown in g.2, which is proportional to the explicit mass splitting,

for the spin 1/2 and spin 3/2 parts of S-baryons [16];

2. besides, one can consider a spin { sym m etry breaking operator of 0 ($1=m_0$);

which gives rise to divergent loop diagram s, as the one in g. 2, where one of the vertices is proportional to g^0 .

3. further, there are nite contributions of the same order coming from the SU(3)-breaking operators

As in the case of the S-baryons, when all G oldstone boson loops are included, the scale dependence of the result of g. 2 is canceled by the corresponding dependence of an elective c_T (). Neither the interaction term of Eq. 30 nor the nite terms of Eq. 31 were taken into account in ref. [15].




Figure 2: Meson loops contributing to T-baryons MM.

Sim ilarly to what we have done in the previous paragraph we write the magnetic moment of T-baryons as

Corrections to our results for T {baryons are of order O (1=m $_0^2$) and hence negligible.

By elim inating the unknown coupling constants, one can deduce two independent relations among the magnetic moments of both T-m ultiplets

In the absence of the SU (3)-breaking operators in Eq. 31, the average baryon MM over the T multiplet would be equal to the heavy quark MM [15]. The result is however corrected by contributions proportional to the unknown couplings $!_1$ and $!_2$ ¹:

5 Conclusions

The magnetic moments of triplet and sextet heavy baryons have been computed in the HHCPT. The calculation of the S $^{()}$ -baryons MM at the order O $(1=\ ^2)$ involves only one new arbitrary constant, $c_{\rm S}$. Thus it is possible to derive relations among the MM of the hadrons in the same sextet where all masses and elective couplings are eliminated. Due to heavy quark symmetry the MM of the S and S sextets are also related. Moreover, as c and b baryons are described by the same arbitrary constants, we can connect the MM of the two kinds of hadrons. The average over one sextet equals the corresponding heavy quark MM.

In the case of T-baryons the $\,$ rst corrections appear at order O (1= (m $_{\rm Q}$ 2)) and four arbitrary constants are required. Then we are left with only two independent relations which combine c and b triplets and contain m $_{\rm C}$ and m $_{\rm b}$. The average over one triplet equals the heavy quark M M $\,$ only in the absence of SU (3)-breaking operators.
