Radiative corrections to the Chern-Sim ons term at nite temperature in the noncommutative Chern-Sim ons-Higgsmodel

Abstract

The one-loop radiative correction to the Chem-Sim ons coe cient is computed in noncommutative Chem-Sim ons-Higgsmodelat zero and at nite temperature. At high temperature, we show that the static limit of this correction is proportional to TlogT, in contrast with the commutative case, where it goes like T.Our results are analytic functions of the noncommutative parameter.

I. INTRODUCTION

The analysis of the radiative corrections to the Chem-Sim ons coe cient has stimulated considerable interest in the recent years [1]. These studies pointed out that the well known nonrenorm alization theorem [2] may become invalid outside perturbation or even perturbatively whenever infrared singularities occur. Typical of the last possibility are situations which potentially modify the long distance behavior of the relevant models. Examples in this direction are the breakdown of some continuous symmetry, therm ale ects and the possible noncommutativity of the underlying space. In this work we are going to focus on the changes in the Chem-Simons coe cient due to thermale ects and the noncommutativity of the space.

The appearance of noncom mutative coordinates has an old history [3] but gained in petus more recently, mainly due to its connection with string theory [4]. One peculiar aspect of these theories is the infrared/ultraviolet (IR/UV) mixing [5], i. e., the presence of infrared singularities even in theories without massless elds. Such behavior may be ameliorated in some supersymmetric models [6]. The absence of IR/UV mixing has also been veried for the pure U (n) Chem-Simons model which actually seems to be a free theory [7].

At nite tem perature, many features of noncommutativity have been examined and applied to dierent eld theoretical models [8]. One of the motivations for the studies in noncommutative Quantum Field Theory (QFT) is to understand how the thermal properties of physical systems are a ected by the noncommutativity. At nite tem perature, it is known that for small momenta the amplitudes are, in general, not well behaved and this feature is understood in terms of the new structure introduced by the tem perature, the velocity of the heat bath [9]. On the other hand, in a noncommutative manifold, the new structure is the tensor, which measures the noncommutativity of the space, and it also leads to an infrared nonanalytic behavior, at least at zero temperature QFT there are many disculties to evaluate amplitudes in a closed form. Thus, to simplify matters, those authors in particular have considered a generalization of the hard thermal loop limit, which involves the noncommutative parameter.

In a noncom mutative manifold, it will appear trigonometric factors and, because of them, the amplitudes are separated in two parts, the planar and nonplanar ones. The rst of them

is proportional to the corresponding am plitude in the commutative case. The elects coming from the noncommutativity of the space can be extracted from the nonplanar contribution. In this paper we will study the corrections to the Chem Simons coel cient at nite temperature arising from the one-loop contributions to the gauge eld two point function. To x the notation, we ist consider a commutative manifold. In [11], it was shown that, in the Chem-Simons-Higgs model in the spontaneously broken phase, the coel cient increases like T in the static limit (in that work this result was extracted as a particular limit of the Maxwell-Chem-Simons-Higgs model). Here, we are going to extend this study to the noncommutative case and prove that it increases like T logT in this limit. As expected, although we are considering the Abelian model, because of the noncommutativity, there will be strong resemblances with the nonabelian theory.

The paper is organized as follows: In Section II the noncommutative version of the Chem-Sim ons-Higgs model in the broken phase is presented. Section III contains the one loop corrections to the Chem-Sim ons coe cient in both commutative as well as noncommutative case and at nite temperature in the imaginary time formalism. The zero temperature results are obtained as consequence of this evaluation. Finally, in Section IV the conclusions are presented.

II. NONCOM MUTATIVE CHERN-SIMONS-HIGGS MODEL

Noncom mutative quantum eld theories are de ned in a manifold where the coordinates do not com mute among them selves. Rather, the com mutator between two position operators is postulated to be

where is an antisymmetric matrix, which commutes with the %'s. The algebra of operators in such a kind of manifold has extensively been studied [12], and many properties are known (see [13] for a review). For example, due to the W igner-M oyal correspondence, instead of working with functions of the above noncommutative coordinates, one may use ordinary functions of commutative variables embodied with the so called M oyal product, de ned as

U sing this de nition, one can study quantum eld theories in a noncom mutative space, by replacing the standard pointwise product of elds by the M oyal one. For simplicity, in this paper we shall keep $^{0i} = 0$.

Let us consider the Chem-Sim ons-Higgs model in a noncommutative space de ned by the Lagrangian density

where we have chosen the R gauge, specied by the gauge xing Lagrangian

Furtherm ore, the notations [;] and f;g stand, respectively, for the commutator and anticommutator using the M oyal product.

To complete the Lagrangian of the model, one has to add to Eq. (5) the contribution of the Faddeev-Popov ghost eld given by

where c and c are the ghost elds.

The propagator for the gauge eld is

where $M=\frac{m^2}{}$. The propagators for the other elds are the standard ones (D (p) = $i=(p^2-m^2)$, D = $i=(p^2-m^2)$ and D $_c=\frac{i}{p^2}$). These propagators are not a ected by the noncommutativity.

At nite tem perature and using the imaginary time formalism, the gauge propagator is (! i in the Euclidean space)

III. ONE-LOOP RESULTS

In this section we will compute the one-loop radiative correction to the Chem-Sim ons coe cient of the above model in both commutative and noncommutative cases at nite temperature in the imaginary time formalism.

A. Com mutative case




FIG. 1: One loop graphs contributing to the parity violating part of the A two point function.

Let us start by evaluating the parity violating part of the polarization tensor in the commutative case. There is only one diagram, Fig. 1a, to evaluate. At one loop, the ghost eld does not contribute to the parity violating part, as can be seen from $L_{\rm FP}$. Thus, we have

Note that, in the static lim it, $_{ij}$ vanishes due to the antisymmetry of the integrand in Eq. (11). We have also introduced the notation $w_M^2 = \tilde{k}^2 + M^2$ and w^2 (p) = (p \tilde{k}) $^2 + m^2$. Using that

The nite temperature part of Eq. (16) is more complicated but can be expressed in terms of polylogarithm functions as

The results (17) and (21) agree with the corresponding ones in the Chern-Sim ons-Higgs limit of the Maxwell-Chern-Sim ons-Higgs model calculated in [11], as commented in the introduction.

B. Noncom mutative case

Next, let us determ ine the parity violating part of the polarization tensor in the noncom—mutative Chem—Sim ons Higgs model. In this case, both diagrams in Fig. 1 contribute. As in the commutative case, at one—loop the ghost eld does not give a parity violating part correction to the polarization tensor. The diagram in Fig. 1a gives

To compute this integral, let us note that, while the denom inator has only sum s of \tilde{k} and p and so can be expanded for small values of p, as we have done in the commutative case, the numerator has the product ${}^{ij}k^ip^j$ which is not necessarily small for small p. To avoid possible problems, we will proceed as follows. We do not necessarily small for small p such that p = 0. A fterwards, we evaluate the sum, by expanding the denominator for small p as in Eq. (13) and then use Eq. (15), yielding

where A_{0i} and B_{0i} are respectively the planar and non-planar contributions to a_{i0i} ($p_0 = 0$); the $p_0 = 0$ jp j! 0 lim it will be taken shortly.

The planar part is exactly one half of Eq. (16). Thus, going to the non-planar contribution, from Eq. (24) we have

These integrals are evaluated in the appendix A. Here, we will only write the nal results. So, we have:

where = pT. Note the apparent singularity in Eq. (28) at p = 0; this kind of structure is the well known infrared singularity, characteristic of noncommutative eld theories [5]. Here, however, as we will shortly see, this singularity cancels in the nal result. Next, let us check if these results are consistent with the = 0 limit, namely, if in this limit we obtain the other half of Eqs. (17) and (21), so that the commutative result is recovered. For the zero temperature part, expanding Eq. (28) for small values of p, we get

When ! 0, we obtain one half of Eq. (17), completing the expected result for the commutative case.

Now, looking at the temperature dependent part, Eq. (29), when = 0, we found that the result is again proportional to function de ned in Eq. (19):

From the asymptotic behavior of the polylogarithm functions [14], we found that in the high temperature limit, Eq. (31) behaves as

Once we have obtained the commutative \lim it, we consider next the rst correction, which in this case is proportional to 2 . The computations for this term are \sin illar to the ones that we have done so far, and nally, we can write the result, up to 4 , as

Before proceeding to the computation of the remaining diagram, it is worth noting that both the temperature independent as well as temperature dependent parts of B_{0i} , Eqs. (30) and (33), are analytic functions of p: no infrared singularities shows up.

Evaluating the graph in Fig. 1b, we have

It is worth noting here the gauge dependence of b. Naively, we could expect that there would be no gauge dependence at this point of the calculation, as it happens in the commutative case. But, this graph gives a purely noncommutative contribution to , which will disappear when goes to zero. Therefore, there is no relation between it and what is found in the commutative case. We recall that a dependence on the gauge parameter was also obtained in the commutative studies of the nonabelian gauge models [16].

IV. CONCLUSIONS

The graphs computed in section III su ce to obtain the one-loop contribution to the parity violating part of the polarization tensor and so, to the Chem-Sim ons coe cient. Collecting the results coming from $_{\rm a}$ and $_{\rm b}$, we obtain the zero and nite temperature contributions to $^{\rm N\,C}$. So,

From Eqs. (39) and (40) we can see that the commutativity can be recovered straightforwardly, by considering the lim it p! 0. In other words, there are no Seiberg poles appearing in this lim it.

Furtherm ore, looking at the nite temperature result, Eq. (40), in the static limit we can extract the leading behavior in the high temperature regime and rst order correction in the noncommutative parameter as being proportional to T logT. So, our calculation provides a logarithm correction to the result obtained in [11] for the commutative version of the same model.

Concerning gauge invariance it should be pointed out that previous studies of noncommutative gauge theories have shown that, as it happens in the commutative non-Abelian CS model, invariance under large gauge transformation requires that the CS coe cient be quantized [17]. At nite temperature, the veri cation of this property for the elective action is a highly non trivial task which probably involves all orders of perturbation and also other (nonlocal) interactions. Even in the commutative setting, invariance under large non-Abelian gauge transformation was veried only in simplied situations [18]. In our calculations large gauge transformation is certainly partially broken. In spite of that, our result should still be a good approximation for small couplings.

Possible extensions of this work are the analysis of the parity even part of the gauge eld two point function and the investigation of the properties of its elective action under small gauge transformation. This last study requires the calculation of the gauge eld three and four point functions. Such work is in progress.

A fter the completion of this work, we became aware of reference [19], where similar studies were made for Maxwell gauge eld coupled with Majorana fermions.

Note that here we have computed both zero temperature and nite temperature parts together, although in sections II and III they occur separately.
