Therm odynamics of Abelian Gauge Fields in Real Hyperbolic Spaces

We work with N dimensional compact real hyperbolic space X with universal covering M and fundamental group. Therefore, M is the symmetric space G=K, where $G=SO_1(N;1)$ and K=SO(N) is a maximal compact subgroup of G. We regard as a discrete subgroup of G acting isometrically on M, and we take X to be the quotient space by that action: X=nM=nG=K. The natural Riemannian structure on M (therefore on X) induced by the Killing form of G gives rise to a connection p form Laplacian L_p on the quotient vector bundle (associated with an irreducible representation of K). We study gauge theories based on abelian p form son the real compact hyperbolic manifold X. The spectral zeta function related to the operator L_p , considering only the co-exact part of the p forms and corresponding to the physical degrees of freedom, can be represented by the inverse Mellin transform of the heat kernel. The explicit thermodynamic functions related to skew-symmetric tensor elds are obtained by using the zeta-function regularization and the trace tensor kernel formula (which includes the identity and hyperbolic orbital integrals). Thermodynamic quantities in the high and low temperature expansions are calculated and new entropy/energy ratios established.

I. INTRODUCTION

It is believed that the real universe is a form of Friedm an-Robertson-Walkermodels. However, the timedependent m etrics of these m odels brings about at least two inconvenient problems: (i) the de nition of vacuum state in a time-dependent background; the background starts producing particles in a continuous way, and therefore, vacuum states in the M inkow skian sense do not exist; (ii) the all-important therm odynamic investigation of the early universe becomes senseless due to the lack of a proper de nition of equilibrium state [1]. Einstein static universes can meet the inconveniences stated before. For these type of manifold, a vacuum state can be unambiguously de ned both locally and globally. It can be shown that a closed universe has the same vacuum energy and pressure as a static Einstein universe [2]. The radius of this universe is the instantaneous radius of the Friedm an-Robertson-Walker universe. Finitetem perature eld theory in curved backgrounds makes sense again. The therm odynamics of quantum elds in an E instein universe for som e radius is equivalent to that of an instantaneously static closed universe. The thermodynamics of positive curvature Einstein spaces was discussed by several authors before. In particular the socalled entropy bounds or entropy to therm alenergy ratios were calculated and compared with known bounds such

as the Bekenstein bound or the Cardy-Verlinde bound. For example, for a massless scalar eld in S³ space this was done in [3] and for a massive scalar eld in [4]. Here wewish to extend the evaluation of those type of bounds to the case of skew-symmetric tensor elds in real compact hyperbolic spaces, a m ore delicate and involved task when compared with previous calculations in S3 space, as we shall see. This paper is divided as follows: In Section II we set the relevant m athem atical tools of the quantum dynamics of exterior forms of real hyperbolic spaces; in Section III we apply Fried trace formula to the tensor kernel and derive the identity and the hyperbolic contributions; in Section IV the spectral functions associated with exterior form sare obtained; in Sections V and V I we establish the pertinent high and low temperature expansions and calculate the entropy bounds for the problem at hand. Comparison with results obtained for a massive scalar eld in S³ and nal remarks are left for the last Section. Throughout this paper we employ natural units, \sim = c = 1; Boltzm ann constant k_B is also set equal to the unity.

II. QUANTUM DYNAM ICS OF EXTERIOR FORM S OF REAL HYPERBOLIC SPACES

Let X be a N dim ensional real compact hyperbolic space with universal covering M and fundam ental group

. Then we can represent M as the symmetric space G=K, where $G=SO_1(N;1)$ and K=SO(N) is a maximal compact subgroup of G. We regard as a discrete subgroup of G acting isometrically on M, and we take X to be the quotient space by that action: X = nM = nG = K. be the space of eigensections of L corresponding to . Here we note that since X is compact we can order the spectrum of L by taking $0={}_0<{}_1<{}_2<\lim_{j!\ 1}{}_{j!\ 1}=1$. We shall focus on the case when N = 2k is even, and we shall specialize to be the representation p of K = SO (2k) on ${}^pC^{2k}$, say p & k. The case when N is odd will be dealt with later. It will be convenient moreover to work with the normalized Laplacian L = c(N)L where c(N) = 2(N 1) = 2(2k 1). Let $!_p$; $'_p$ be exterior di erential p form s; then, the invariant inner product is de ned by $(!_p;'_p) \stackrel{\text{def } R}{=} !_p$ $'_{p}$. The following properties for operators and form s hold: dd = = 0, = $(1^{N})^{p+N+1}$ d , **! = $(1)^{p(N-p)}!_{p}$. The operators d and are adjoint to each other with respect to this inner product for p form s: ($!_p;'_p$) = ($!_p;d'_p$). In quantum eld theory the Lagrangian associated with !p takes the form: d!p ^ d!p (gauge eld), and $!_p$ $\hat{}_p$ (co{gauge eld). The Euler{Lagrange equations, supplied with the gauge, give: $L_p!_p = 0$; $!_p = 0$ (Lorentz gauge); $L_p!_p = 0$; $d!_p = 0$ (co{Lorentz gauge). These Lagrangians provide a possible representation of tensor elds or generalized abelian gauge elds. The two representations of tensor elds are not completely independent, because of the well{ known duality property of exterior calculus which gives a connection between star{conjugated gauge and co{gauge tensor elds. The gauge p forms are mapped into the ∞{gauge (N p) form s under the action of the Hodge

where we need to factorize the divergent gauge group volume and integrate over the classes of gauge transformations (! ! ! + d).

III. THE TRACE FORM ULA APPLIED TO THE TENSOR KERNEL

The space of sm ooth sections 1 E of E is just the space of sm ooth p form s on X . We can therefore apply the version of the trace form ula developed by Fried in [7]. First we set up some additional notation. For p the natural representation of SO (2k 1) on $^pC^{2k-1}$, we have the corresponding Harish {Chandra {Plancherel density given { for a suitable normalization of the Haar measure dx on G { by

For p 1 there is a measure (r) corresponding to a general irreducible representation . Let $_{\text{p}}$ be the standard representation of SO (N $\,$ 1) on $\,$ PC $\,$ (N $\,$ 1). If N = 2k is even then p (0 p N 1) is always irreducible; if N = 2k + 1 then every p is irreducible except for p = (N 1)=2 = k, in which case k is the direct sum of two spin { (1=2) representations : k = 0.05For p = k the representation $_k$ of K = SO (2k) on k C 2k is not irreducible: $k = \frac{1}{k}$ is the direct sum of two spin { (1=2) representations. In the case of the trivial representation (p = 0, i.e. for sm ooth functions or sm ooth vector bundle sections) the measure (r) sponds to the trivial representation. Therefore, we take $I^{(1)}(K_t) = H^{(1)}(K_t) = 0$. Since $_0$ is the trivial representation, we have $_{_{0}}$ (m) = 1. In this case, formula (8) reduces exactly to the trace formula for p = 0[5, 9, 10, 11],

IV. THE SPECTRAL FUNCTIONS OF EXTERIOR FORMS

The spectral zeta function related to the Laplace operator L_j can be represented by the inverse M ellin transform of the heat kernel $K_t = Tr \exp (tL_j)$. Using the Fried formula, we can write the zeta function as a sum of contributions:

V. THE HIGH TEMPERATURE EXPANSIONS

U sing the M ellin representation for the zeta function, we can obtain useful form ulas for the tem perature dependent part of the identity and hyperbolic orbital components of the free energy (see for detail Refs. [10, 11, 12])

VII. CONCLUSIONS

We have considered gauge theories based on abelian p forms in real compact hyperbolic manifolds. The explicit thermodynamic functions associated with skew-symmetric tensor elds are obtained by using zeta function regularization and the trace tensor kernel formula. Thermodynamic quantities in the low and high temperature limits were calculated. We also have obtained the entropy/energy ratios (in both temperature limits). The dependence on the Miatello coe cients related to the structure of the Harish {Chandra {Plancherel measure stems from the second term of the expansion. In the case of scalar elds (p = 0) we have Eq. (36) with

where $_0^2 = _0^2 + m^2$ ($_0^2 = _0^2$ for the m assless case). For three-dim ensional hyperbolic m anifolds the M iatello coe cients read [17]: $a_0^{(0)} = a_2^{(0)} = 1$ and therefore

$$\frac{S^{(3)}()}{E^{(3)}()} = \frac{4}{3} + \frac{10}{3^2}(2 - \frac{2}{0})^{3} + O(^{5}).$$
 (54)

This formula is in agreement with the result obtained in [4] where entropy bounds were calculated for spherical geometry and where the dependence on geometry of the backgrounds also stems from the second term of the expansion.
