The inverse problem for perturbed harmonic oscillator on the half-line

Abstract

We consider the perturbed harmonic oscillator $T_D \psi = -\psi'' + x^2 \psi + q(x)\psi$, $\psi(0) = 0$ in $L^2(\mathbb{R}_+)$, where $q \in \mathbf{H}_+ = \{q', xq \in L^2(\mathbb{R}_+)\}$ is a real-valued potential. We prove that the mapping $q \mapsto$ spectral data = {eigenvalues of T_D } \oplus {norming constants} is one-to-one and onto. The complete characterization of the set of spectral data which corresponds to $q \in \mathbf{H}_+$ is given. Moreover, we solve the similar inverse problem for the family of boundary conditions $\psi'(0) = b\psi(0), b \in \mathbb{R}$.

1 Introduction

Consider the Schrödinger operator

$$\mathbf{H} = -\frac{\partial^2}{\partial \mathbf{x}^2} + \mathbf{x}^2 + q(|\mathbf{x}|), \quad \mathbf{x} \in \mathbb{R}^3,$$

acting in the space $L^2(\mathbb{R}^3)$. We set $x = |\mathbf{x}| \ge 0$ and assume q is a real-valued bounded function. The operator H has pure point spectrum. Using the standard transformation $u(\mathbf{x}) \to xu(\mathbf{x})$ and expansion in spherical harmonics, we obtain that H is unitary equivalent to a direct sum of the Schrödinger operators acting on $L^2(\mathbb{R}_+)$. The first operator from this sum is given by

$$T_D \psi = -\psi'' + x^2 \psi + q(x)\psi, \qquad \psi(0) = 0, \qquad x \ge 0.$$

The second is $-\frac{d^2}{dx^2} + x^2 + \frac{2}{x^2} + q(x)$ etc. Below we consider the simplest case, i.e., the operator T_D . In our paper we assume that

$$q \in \mathbf{H}_{+} = \left\{ q \in L^{2}(\mathbb{R}_{+}) : q', xq \in L^{2}(\mathbb{R}_{+}) \right\}.$$

This class of potentials is convenient to solve the inverse problem as it was shown in [CKK2], which is devoted to the analogous problem on the whole real line. Recall that the complete characterization of the set of spectral data that corresponds to potentials $q \in L^2$ is unknown.

Define the unperturbed operator $T_D^0 \psi = -\psi'' + x^2 \psi$, $\psi(0) = 0$. The spectrum $\sigma(T_D)$ of T_D is the increasing sequence of simple eigenvalues $\lambda_{2n+1} = \lambda_{2n+1}^0 + o(1)$, $n \ge 0$, where $\lambda_{2n+1}^0 = 4n+3$, $n \ge 0$, are the eigenvalues of T_D^0 . The spectrum $\sigma(T_D)$ does not determine q(x) uniquely, see Theorems 2.2 and 2.3. Then what does the isospectral set

$$\operatorname{Iso}_D(q) = \{ p \in \mathbf{H}_+ : \lambda_{2n+1}(p) = \lambda_{2n+1}(q) \text{ for all } n \ge 0 \}$$

of all potentials p with the same Dirichlet spectrum as q look like?

We come to the inverse problem. It has two parts: i) to describe the set $Iso_D(q)$; ii) to characterize all sequences of real numbers which arise as the Dirichlet spectra of $q \in \mathbf{H}_+$. In order to describe $Iso_D(q)$, we need "additional" spectral data. Below we consider two choices of such data:

1) The Neumann spectrum $\sigma(T_N)$ of q(x), where $T_N\psi = -\psi'' + x^2\psi + q(x)\psi$, $\psi'(0) = 0$. The spectrum $\sigma(T_N)$ is the increasing sequence of simple eigenvalues $\lambda_{2n} = \lambda_{2n}^0 + o(1)$, where $\lambda_{2n}^0 = 4n+1$, $n \ge 0$. The corresponding inverse spectral problem $q \mapsto \{\lambda_{2n}\}_{n=0}^{\infty} \cup \{\lambda_{2n+1}\}_{n=0}^{\infty}$ is equivalent to the inverse spectral problem on the whole real line with even potentials q(x) = q(-x), $x \in \mathbb{R}$ (see Theorem 2.2 and Sect. 3).

2) The sequence of the so-called norming constants for eigenfunctions of T_D . The corresponding inverse problem is the main point of our paper (see Theorem 2.3 and Sect. 4).

We also consider the inverse problem for the family of operators $\{T_b\}_{b\in\mathbb{R}}$ given by

$$T_b\psi = -\psi'' + x^2\psi + q(x)\psi, \qquad \psi'(0) = b\psi(0), \qquad x \ge 0,$$

see Theorem 2.4 and Sect. 5. Note that the analysis of the whole family $\{T_b\}_{b\in\mathbb{R}}$ is simpler than the case of the fixed constant $b \in \mathbb{R}$. It is similar to the Sturm-Liouville problem on the unit interval ([IT], [IMT], [RT]). We give the explicit expression of b in terms of spectral data in Theorem 2.5.

Our approach is a generalization of the method applied in [CKK2] and [PT] (devoted to the inverse Dirichlet problem on [0, 1]). There is a big difference (see e.g. [GS]) between the case of the whole real line and the case of the half-line. The main point in the inverse problem for the perturbed harmonic oscillator T_D on \mathbb{R}_+ is the characterization of "additional" spectral data, i.e. the characterization of the set $\text{Iso}_D(q)$ (see [GS] about the connectedness of this set in various classes of potentials). We introduce the standard norming constants $s_{2n+1}(q)$ by (2.5), the same way as in [CKK2], [PT]. Unfortunately, we have two problems: i) the sequence $\{s_{2n+1}(q)\}_{n=0}^{\infty}$ doesn't belong to a "proper" Hilbert space; ii) the eigenvalues and the norming constants are not "independent coordinates" in the space of potentials.

Roughly speaking, the set of all sequences $\{s_{2n+1}(p)\}_{n=0}^{\infty}$, $p \in \operatorname{Iso}_D(q)$, essentially depends on the spectrum $\{\lambda_{2n+1}(q)\}_{n=0}^{\infty}$. Recall that in the case of the Sturm-Liouville operators -y''+q(x)y on [0,1] with the mixed boundary conditions $y(0) = y'(1) = 0^1$ (see [K2]) the eigenvalues and the norming constants are not independent since in this case we have the identity

similar to (2.10). Note that the dependence between $\{\lambda_{2n+1}(q)\}_{n=0}^{\infty}$ and $\{s_{2n+1}(p)\}_{n=0}^{\infty}$ is more complicated. Therefore, we need an essential modification of the norming constants. We define the new coordinates $\{r_{2n+1}\}_{n=0}^{\infty}$ by (2.6). The new parameters $\{r_{2n+1}\}_{n=0}^{\infty}$ are "independent coordinates" and $\{r_{2n+1}\}_{n=0}^{\infty} \in \ell_{3/4}^2$ (see Theorem 2.3). Moreover, the spectral mapping $q \mapsto (\{\mu_{2n+1}(q)\}_{n=0}^{\infty}, q(0), \{r_{2n+1}(q)\}_{n=0}^{\infty})$ is a real-analytic isomorphism between \mathbf{H}_+ and $\mathcal{S}_D \times \mathbb{R} \times \ell_{3/4}^2$, where

$$\lambda_n = \lambda_n^0 + \mu_n, \quad n \ge 0, \quad \text{and} \quad \mathcal{S}_D = \Big\{ \{h_n\}_{n=0}^\infty \in \mathcal{H} : \lambda_1^0 + h_0 < \lambda_3^0 + h_1 < \lambda_5^0 + h_2 < \dots \Big\}.$$

In other words, after this modification we have the spectral mapping with similar properties as in the case of the real line [CKK2] and the new parameters $\{r_{2n+1}\}_{n=0}^{\infty} \in \ell_{3/4}^2$ give the correct parameterization of the isospectral manifolds.

The inverse problem for the family of operators $\{T_b\}_{b\in\mathbb{R}}$ is similar to the case of T_D but we need to control the dependence of our spectral data from the boundary constant $b\in\mathbb{R}$. Here Theorem 2.5 plays a crucial role. It is similar to the case of the Sturm-Liouville operators -y'' + q(x)y on [0, 1] with the mixed boundary conditions y(0) = y'(1) = 0, see [K2]. The ingredients of the proof of main theorem are:

i) Uniqueness Theorem. We adopt the proof from [PT] and [CKK1]. This proof requires only some estimates of the fundamental solutions.

ii) Analysis of the Fréchet derivative of the nonlinear spectral mapping {potentials} \mapsto {spectral data} at the point q = 0. We emphasize that this linear operator is complicated (in particular, it is not the Fourier transform, as it was in [PT]). Here we essentially use the technique of generating functions (from [CKK2]), which are analytic in the unit disc.

iii) Asymptotic analysis of the difference between spectral data and its Fréchet derivatives at q=0. Here the calculations and asymptotics from [CKK2] play an important role.

iv) The proof that the spectral mapping is a surjection, i.e. the fact that each element of an appropriate Hilbert (or Banach) space can be obtained as spectral data of some potential $q \in \mathbf{H}_+$. Here we use the standard Darboux transform of second-order differential equations.

The present paper continues the series of papers [CKK1], [CKK2] devoted to the inverse spectral problem for the perturbed harmonic oscillator on the real line. Note that the set of spectra which correspond to potentials from \mathbf{H}_+ (see Sect. 3 for details) is similar to the space of spectral data in [CKK2]. In particular, the range of the linear operator $f(z) \mapsto (1-z)^{-1/2} f(z)$ acting in some Hardy-Sobolev space in the unit disc plays an important role. As a byproduct of our analysis, we give the simple proof of the equivalence between two definitions of the space of spectral data which was established in [CKK2] using a more involved technique.

2 Main results

We recall some basic results from [CKK2]. Consider the operator

$$T\psi = -\psi'' + x^2\psi + q(x)\psi, \qquad q \in \mathbf{H}_{even} = \left\{q \in L^2(\mathbb{R}) : q', xq \in L^2(\mathbb{R}); \ q(x) = q(-x), \ x \in \mathbb{R}\right\},$$

acting in the space $L^2(\mathbb{R})$. The spectrum $\sigma(T)$ is an increasing sequence of simple eigenvalues given by

 $\lambda_n(q) = \lambda_n^0 + \mu_n(q) \,, \quad \text{where} \quad \lambda_n^0 = \lambda_n(0) = 2n+1, \ n \geqslant 0 \,, \quad \text{and} \quad \mu_n(q) \to 0 \text{ as } n \to \infty \,.$

Define the real weighted ℓ^2 -space

$$\ell_r^2 = \left\{ c = \{c_n\}_{n=0}^{\infty} : c_n \in \mathbb{R}, \ \|c\|_{\ell_r^2}^2 = \sum_{n \ge 0} (1+n)^{2r} |c_n|^2 < +\infty \right\}, \ r \ge 0,$$

and the Hardy-Sobolev space of functions, which are analytic in the unit disc $\mathbb{D} = \{z : |z| < 1\}$:

$$H_r^2 = H_r^2(\mathbb{D}) = \left\{ f(z) \equiv \sum_{n \ge 0} f_n z^n, \ z \in \mathbb{D} : \ f_n \in \mathbb{R} , \ \|f\|_{H_r^2} = \|\{f_n\}_{n=0}^\infty\|_{\ell_r^2} < +\infty \right\}, \ r \ge 0.$$

Introduce the space of spectral data

$$\mathcal{H} = \left\{ h = \{h_n\}_{n=0}^{\infty} : \sum_{n \ge 0} h_n z^n \equiv \frac{f(z)}{\sqrt{1-z}}, \ f \in H_{\frac{3}{4}}^2 \right\}, \quad \|h\|_{\mathcal{H}} = \|f\|_{H_{3/4}^2}.$$
(2.1)

Theorem 2.1 ([CKK2]). The mapping $q \mapsto \{\mu_n(q)\}_{n=0}^{\infty}$ is a real-analytic isomorphism² between the space of even potentials \mathbf{H}_{even} and the following open convex subset of \mathcal{H} :

$$S = \left\{ \{h_n\}_{n=0}^{\infty} \in \mathcal{H} : \lambda_0^0 + h_0 < \lambda_1^0 + h_1 < \lambda_2^0 + h_2 < \dots \right\}.$$

Remark. The inequalities in the definition of S correspond to the condition of monotonicity of eigenvalues of T: $\lambda_0(q) < \lambda_1(q) < \lambda_2(q) < \dots$

Recall the following more precise representation from [CKK2]:

$$\lambda_n(q) = \lambda_n^0 + \mu_n(q), \quad \mu_n(q) = \frac{\int_{\mathbb{R}} q(t) dt}{\pi \sqrt{\lambda_n^0}} + \widetilde{\mu}_n(q), \quad \{\widetilde{\mu}_n(q)\}_{n=0}^\infty \in \mathcal{H}_0, \quad (2.2)$$

where the subspace $\mathcal{H}_0 \subset \mathcal{H}$ of codimension 1 is given by

$$\mathcal{H}_{0} = \left\{ h \in \mathcal{H} : \sqrt{1 - z} \sum_{n \ge 0} h_{n} z^{n} |_{z=1} = f(1) = 0 \right\}.$$
(2.3)

Remark that Lemma 3.4 yields $\widetilde{\mu}_n(q) = O(n^{-\frac{3}{4}} \log^{\frac{1}{2}} n)$ as $n \to \infty$.

Next we consider the inverse problem for the operator T_D on \mathbb{R}_+ . For each $q \in \mathbf{H}_+$ we put q(-x) = q(x), $x \ge 0$. This gives a natural isomorphism between \mathbf{H}_+ and \mathbf{H}_{even} . We have

$$\sigma(T) = \sigma(T_D) \cup \sigma(T_N), \quad \sigma(T_N) = \{\lambda_{2n}(q)\}_{n=0}^{\infty}, \quad \sigma(T_D) = \{\lambda_{2n+1}(q)\}_{n=0}^{\infty}.$$

²By definition, the mapping of Hilbert spaces $F : H_1 \to H_2$ is a local real-analytic isomorphism iff for any $y \in H_1$ it has an analytic continuation \widetilde{F} into some complex neighborhood $y \in U \subset H_{1\mathbb{C}}$ of y such that \widetilde{F} is a bijection between U and some complex neighborhood $F(y) \in \widetilde{F}(U) \subset H_{2\mathbb{C}}$ of F(y) and both $\widetilde{F}, \widetilde{F}^{-1}$ are analytic. The local isomorphism F is a (global) isomorphism iff it is a bijection.

Using Theorem 2.1 and Lemma 3.5, we obtain the following description of the perturbations of $\sigma(T_D)$ and $\sigma(T_N)$ which correspond to potentials $q \in \mathbf{H}_+$:

$$S_{D} = \left\{ \{\mu_{2n+1}(q)\}_{n=0}^{\infty}, q \in \mathbf{H}_{+} \right\} = \left\{ \{h_{n}\}_{n=0}^{\infty} \in \mathcal{H} : \lambda_{1}^{0} + h_{0} < \lambda_{3}^{0} + h_{1} < \lambda_{5}^{0} + h_{2} < \dots \right\},$$
$$S_{N} = \left\{ \{\mu_{2n}(q)\}_{n=0}^{\infty}, q \in \mathbf{H}_{+} \right\} = \left\{ \{h_{n}\}_{n=0}^{\infty} \in \mathcal{H} : \lambda_{0}^{0} + h_{0} < \lambda_{2}^{0} + h_{1} < \lambda_{4}^{0} + h_{2} < \dots \right\} = S_{D}$$

(recall that $\lambda_{2n+1}^0 = \lambda_{2n}^0 + 2$, $n \ge 0$). It is important that two spectra $\sigma(T_D)$ and $\sigma(T_N)$ are not independent. The following Theorem describes this relationship between $\{\mu_{2n+1}\}_{n=0}^{\infty}$ and $\{\mu_{2n}\}_{n=0}^{\infty}$. Let

$$\tau_n = \mu_{2n} - \mu_{2n+1} = \lambda_{2n} - \lambda_{2n+1} + 2, \quad n \ge 0.$$

Theorem 2.2. (i) The mapping $q \mapsto \left(\{\mu_{2n+1}(q)\}_{n=0}^{\infty}, \{\tau_n(q)\}_{n=0}^{\infty} \right)$ is a real-analytic isomorphism between \mathbf{H}_+ and the following open and convex subset of $\mathcal{H} \times \ell_{3/4}^2$:

$$\left\{ \left(\{h_n\}_{n=0}^{\infty}, \{\tau_n\}_{n=0}^{\infty} \right) \in \mathcal{H} \times \ell_{\frac{3}{4}}^2 : \lambda_0^0 + h_0 + \tau_0 < \lambda_1^0 + h_0 < \lambda_2^0 + h_1 + \tau_1 < \lambda_3^0 + h_1 < \dots \right\}.$$

(ii) The mapping $q \mapsto \left(\{\mu_{2n+1}(q)\}_{n=0}^{\infty}, \{\tau_n(q)\}_{n=0}^{\infty} \right)$ is a real-analytic isomorphism between \mathbf{H}_+ and the following open and convex subset of $\mathcal{H} \times \ell_{3/4}^2$:

$$\left\{ \left(\{h_n\}_{n=0}^{\infty}, \{\tau_n\}_{n=0}^{\infty} \right) \in \mathcal{H} \times \ell_{\frac{3}{4}}^2 : \lambda_0^0 + h_0 < \lambda_1^0 + h_0 - \tau_0 < \lambda_2^0 + h_1 < \lambda_3^0 + h_1 - \tau_1 < \dots \right\}.$$

(iii) For each $q \in \mathbf{H}_+$ the identity $q(0) = 2 \sum_{n \ge 0} \tau_n(q)$ holds true.

Remark. As in Theorem 2.1, these subsets are open and convex. Inequalities in its definitions correspond to the monotonicity of the sequence $\{\lambda_m(q)\}_{m=0}^{\infty}$.

We now come to the main results of our paper. Namely, we consider the spectrum of T_D and a convenient choice of additional spectral data (coordinates of an isospectral set). As a first step, we introduce the norming constants $s_{2n+1}(q)$. In order to keep the connection with the problem on \mathbb{R} we use odd indices. We consider the unperturbed equation

$$-\psi'' + x^2\psi = \lambda\psi, \quad \lambda \in \mathbb{C}\,,$$

and its solutions $\psi^0_+(x,\lambda) = D_{\frac{\lambda-1}{2}}(\sqrt{2}x)$, where $D_\mu(x)$ is a Weber function (see [B]). The perturbed equation

$$-\psi'' + x^2\psi + q(x)\psi = \lambda\psi, \quad \lambda \in \mathbb{C}, \quad q \in \mathbf{H}_+,$$
(2.4)

has a solution $\psi_+(x, \lambda, q)$ such that $\psi_+(x, \lambda, q) = \psi^0_+(x, \lambda)(1+o(1))$, $x \to +\infty$ (see (A.13)). The norming constant (see also [MT], [IT], [PT]) is defined by

$$s_{2n+1}(q) = -\log|\psi'_{+}(0,\lambda_{2n+1}(q),q)| = \log\left[(-1)^{n} \frac{\varphi(\cdot,\lambda_{2n+1}(q),q)}{\psi_{+}(\cdot,\lambda_{2n+1}(q),q)}\right], \quad n \ge 0, \qquad (2.5)$$

where φ is the solution of (2.4) such that $\varphi(0, \lambda, q) = 0$ and $\varphi'(0, \lambda, q) = 1$.

The standard identities $\psi_{+}^{2} = \{\dot{\psi}_{+}, \psi_{+}\}', \varphi^{2} = \{\dot{\varphi}, \varphi\}'$ imply³

$$\begin{aligned} \|\psi_{+}(\cdot,\lambda_{2n+1}(q),q)\|_{+}^{2} &= (-1)^{n} \dot{w}_{D}(\lambda_{2n+1}(q),q) e^{-s_{2n+1}(q)} ,\\ \|\varphi(\cdot,\lambda_{2n+1}(q),q)\|_{+}^{2} &= (-1)^{n} \dot{w}_{D}(\lambda_{2n+1}(q),q) e^{s_{2n+1}(q)} ,\end{aligned}$$

where

$$w_D(\lambda, q) = \{\varphi, \psi_+\}(\lambda, q) = -\psi_+(0, \lambda, q) = -\psi_+^0(0, \lambda) \cdot \prod_{n \ge 0} \frac{\lambda - \lambda_{2n+1}(q)}{\lambda - \lambda_{2n+1}^0}$$

and the entire function $\psi^0_+(0,\lambda) = D_{\frac{\lambda-1}{2}}(0)$ is given by (A.3).

If q=0, then the norming constants have the form⁴

$$s_{2n+1}^{0} = -\log|(\psi_{+}^{0})'(0,\lambda_{2n+1}^{0})| = -\log\pi^{-\frac{1}{2}}2^{n+\frac{3}{2}}\Gamma(n+\frac{3}{2}) \sim -n\log n, \quad n \to \infty.$$

In many cases⁵, the sequence of eigenvalues and the sequence of norming constants are "independent coordinates" in the space of potentials. But, different from most known cases, $\{\mu_{2n+1}\}_{n=0}^{\infty}$ and $\{s_{2n+1}\}_{n=0}^{\infty}$ are not independent parameters (establishing a real analytic isomorphism between \mathbf{H}_{+} and some Hilbert space). To find such an isomorphism, we use some modification $\{r_{2n+1}\}_{n=0}^{\infty}$ of the norming constants $\{s_{2n+1}\}_{n=0}^{\infty}$. This modification is not trivial and it uses the discrete Hilbert transform. Namely, we define $r_{2n+1}(q)$ by

$$s_{2n+1}(q) = s_{2n+1}^0 + \alpha_{2n+1} \cdot \mu_{2n+1}(q) + \frac{q(0)}{4(2n+1)} + \frac{1}{2} \sum_{m \ge 0} \frac{\mu_{2m+1}(q)}{2(n-m)+1} + r_{2n+1}(q), \quad n \ge 0, \quad (2.6)$$

where

$$\alpha_{2n+1} = -\frac{(\dot{\psi}_{+}^{0})'}{(\psi_{+}^{0})'} (0, \lambda_{2n+1}^{0}) \sim -\log n \,, \quad n \to \infty \,.$$

Theorem 2.3. (i) Let $q \in \mathbf{H}_+$. Then $\{r_{2n+1}(q)\}_{n=0}^{\infty} \in \ell_{3/4}^2$, where r_{2n+1} is given by (2.6) (ii) The mapping $q \mapsto (\{\mu_{2n+1}(q)\}_{n=0}^{\infty}, q(0), \{r_{2n+1}(q)\}_{n=0}^{\infty})$ is a real-analytic isomorphism between \mathbf{H}_+ and $\mathcal{S}_D \times \mathbb{R} \times \ell^2_{3/4}$.

Remark. $(q(0), \{r_{2n+1}(q)\}_{n=0}^{\infty})$ are "independent coordinates" in the isospectral sets.

We consider the inverse problem for the family of operators $T_b y = -y'' + x^2 y + q(x)y$ with the boundary conditions y'(0) = by(0), $b \in \mathbb{R}$. Denote its spectrum by

$$\sigma(T_b) = \{\lambda_{2n}(q, b)\}_{n=0}^{\infty} = \{\lambda_{2n}^0 + \mu_{2n}(q, b)\}_{n=0}^{\infty}$$

(note that $\lambda_{2n}(q,0) = \lambda_{2n}(q)$). Then (see (5.2))

$$\lambda_{2n}(q,b) = \lambda_{2n}^0 + \frac{2\int_{\mathbb{R}_+} q(t)dt + 2b}{\pi\sqrt{\lambda_{2n}^0}} + \widetilde{\mu}_{2n}(q,b), \quad \{\widetilde{\mu}_{2n}(q,b)\}_0^\infty \in \mathcal{H}_0,$$
(2.7)

for $(q,b) \in \mathbf{H}_+ \times \mathbb{R}$ and, in particular, $\widetilde{\mu}_{2n}(q,b) = O(n^{-\frac{3}{4}} \log^{\frac{1}{2}} n)$, $n \to \infty$.

boundary conditions; perturbed harmonic oscillator $-\frac{d^2}{dx^2} + x^2 + q(x)$ on \mathbb{R} ([MT], [CKK2]).

By analogy with (2.5), (2.6) we introduce the norming constants $s_{2n}(q, b)$ and the new parameters $r_{2n}(q, b)$ by

$$s_{2n}(q,b) = -\log|\psi_{+}(0,\lambda_{2n}(q),q)| = \log\left[(-1)^{n}\frac{(\vartheta+b\varphi)(\cdot,\lambda_{2n}(q),q)}{\psi_{+}(\cdot,\lambda_{2n}(q),q)}\right]$$
(2.8)

$$= s_{2n}^{0} + \alpha_{2n} \cdot \mu_{2n}(q,b) - \frac{q(0) - 2b^2}{4(2n-1)} + \frac{1}{2} \sum_{m \ge 0} \frac{\mu_{2m}(q,b)}{2(n-m)-1} + r_{2n}(q,b), \quad n \ge 0, \qquad (2.9)$$

where ϑ is the solution of (2.4) such that $\vartheta(0, \lambda, q) = 1$, $\vartheta'(0, \lambda, q) = 0$ and

$$s_{2n}^{0} = -\log|\psi_{+}^{0}(0,\lambda_{2n}^{0})| \sim -n\log n, \quad \alpha_{2n} = -\frac{\psi_{+}^{0}}{\psi_{+}^{0}}(0,\lambda_{2n}^{0}) \sim -\log n, \quad n \to \infty.$$

Theorem 2.4. (i) Let $(q, b) \in \mathbf{H}_+ \times \mathbb{R}$. Then $\{r_{2n}(q, b)\}_{n=0}^{\infty} \in \ell_{3/4}^2$, where r_{2n} is given by (2.9). (ii) The mapping $(q, b) \mapsto (\{\mu_{2n}(q, b)\}_{n=0}^{\infty}, q(0) - 2b^2, \{r_{2n}(q, b)\}_{n=0}^{\infty})$ is a real-analytic isomorphism between $\mathbf{H}_+ \times \mathbb{R}$ and $\mathcal{S}_N \times \mathbb{R} \times \ell_{3/4}^2$.

Finally, we give the explicit expression of the "boundary" constant b in terms of spectral data. Introduce the Wronskian

$$w_N(\lambda, q, b) = \psi'_+(0, \lambda, q) - b\psi_+(0, \lambda, q), \quad \lambda \in \mathbb{C}.$$

Note that the entire function $w_N(\lambda, q, b)$ can be reconstructed by its zeros $\{\lambda_{2n}(q, b)\}_{n=0}^{\infty}$ as

$$w_N(\lambda, q, b) = (\psi^0_+)'(0, \lambda) \cdot \prod_{n \ge 0} \frac{\lambda - \lambda_{2n}(q, b)}{\lambda - \lambda_{2n}^0}, \quad \lambda \in \mathbb{C}$$

where the entire function $(\psi^0_+)'(0,\lambda) = \sqrt{2}D'_{\frac{\lambda-1}{2}}(0)$ is given by (A.3).

Theorem 2.5. For each $(b,q) \in \mathbb{R} \times \mathbf{H}_+$ the following identity is fulfilled:

$$-b = \sum_{n \ge 0} \left(\frac{(-1)^n e^{-s_{2n}(q,b)}}{w_N(\lambda_{2n}(q,b),q,b)} - 2\pi^{-1/2} E_n \right), \quad E_n = \frac{(2n)!}{2^{2n}(n!)^2}.$$
 (2.10)

Remark. In the proof we use ideas from [K2].

The plan of the paper is as follows. In Section 3 we recall some results of [CKK2], describe basic properties of \mathcal{H} and prove Theorem 2.2. Section 4 is devoted to the Dirichlet boundary condition at x=0 (here we prove Theorem 2.3). In Section 5 we solve the inverse problem for the family of the operators $\{T_b\}_{b\in\mathbb{R}}$ (Theorems 2.4, 2.5). All needed properties of fundamental solutions, gradients of spectral data and asymptotics are collected in Appendix.

3 Preliminaries and proof of Theorem 2.2

We recall some crucial points of [CKK2]. Let ψ_n^0 be the normalized eigenfunctions of the unperturbed harmonic oscillator on \mathbb{R} . It is well-known that

$$\psi_n^0(x) = (n!\sqrt{\pi})^{-\frac{1}{2}} D_n(\sqrt{2}x) = (2^n n!\sqrt{\pi})^{-\frac{1}{2}} H_n(x) e^{-\frac{x^2}{2}}, \quad n \ge 0,$$

where $H_n(x)$ are the Hermite polynomials. For each $n \ge 0$ we consider the second solution

$$\chi_n^0(x) = \left(\frac{n!\sqrt{\pi}}{2}\right)^{1/2} \begin{cases} (-1)^{\frac{n}{2}} \operatorname{Im} D_{-n-1}(i\sqrt{2}x), & n \text{ is even} \\ (-1)^{\frac{n-1}{2}} \operatorname{Re} D_{-n-1}(i\sqrt{2}x), & n \text{ is odd}, \end{cases}$$

of the equation $-y'' + x^2 y = \lambda_n^0 y$, which is uniquely defined by the conditions

$$\{\chi_n^0, \psi_n^0\} = 1, \qquad (\psi_n^0 \chi_n^0)(-x) = -(\psi_n^0 \chi_n^0)(x), \quad x \in \mathbb{R}.$$

Note that $(\psi_n^0\chi_n^0)(x) \sim (-1)^{n+1}x$ as $x \to 0$, and $(\psi_n^0\chi_n^0)(x) \sim -x^{-1}$ as $x \to \infty$.

Let $s_{2m}(q) = s_{2m}(q, 0)$, $m \ge 0$. Define the modified norming constants $\tilde{s}_n(q)$ by

$$s_n(q) = s_n^0 + \alpha_n \mu_n(q) + \widetilde{s}_n(q), \quad n \ge 0$$
(3.1)

(recall that $s_n^0 = s_n(0)$, $\alpha_{2m+1} = -(\dot{\psi}_+^0)'/(\psi_+^0)'(0, \lambda_{2m+1}^0)$ and $\alpha_{2m} = -\dot{\psi}_+^0/\psi_+^0(0, \lambda_{2m}^0)$, $m \ge 0$).

Theorem 3.1. For each potential $q \in \mathbf{H}_+$ the following asymptotics are fulfilled⁶:

$$\mu_n(q) = 2\dot{q}_n^+ + \ell_{\frac{3}{4}+\delta}^2(n), \qquad \tilde{s}_n(q) = \dot{q}_n^+ + \ell_{\frac{3}{4}+\delta}^2(n), \qquad (3.2)$$

for some absolute constant $\delta > 0$, uniformly on bounded subsets of \mathbf{H}_+ , where

$$\hat{q}_n^+ = (q, (\psi_n^0)^2)_+, \qquad \check{q}_n^+ = (q, \psi_n^0 \chi_n^0)_+$$

Remark. i) This result does not cover the general boundary condition y'(0) = by(0), $b \neq 0$. ii) Using Proposition 3.2 and Corollary 4.2, it is easy to see that $\{\hat{q}_n^+\}_{n=0}^{\infty} \in \mathcal{H}$, $\{\check{q}_n^+\}_{n=0}^{\infty} \in \mathcal{H}_0$ for each $q \in \mathbf{H}_+$. Then, Lemma 3.4 and Proposition 3.3 (i) yield

$$\hat{q}_n^+ = \pi^{-1} \int_{\mathbb{R}_+} q(t) dt \cdot (\lambda_n^0)^{-\frac{1}{2}} + O(n^{-\frac{3}{4}} \log^{\frac{1}{2}} n) , \qquad \check{q}_n^+ = O(n^{-\frac{3}{4}} \log^{\frac{1}{2}} n) , \quad n \to \infty .$$

Proof. Let $\mu_n = \mu_n(q)$. We suppose that n is odd, the other case is similar. Repeating arguments of [CKK1] Lemma 4.2 and using Rouché's Theorem, we obtain $\mu_n(q) = O(n^{-1/2})$. Note that the value μ_n is the solution of the equation $\psi_+(0, \lambda_n^0 + \mu_n, q) = 0$. Due to estimates from Corollary A.3 and asymptotics (A.15), we have

$$0 = \frac{\psi_+(0,\lambda_n^0 + \mu_n, q)}{\dot{\kappa}_n} = \frac{\psi_+^{(1)}(0,\lambda_n^0, q) + \dot{\kappa}_n \cdot \mu_n}{\dot{\kappa}_n} + O(n^{-1}\log^2 n).$$

⁶Here and below $a_n = b_n + \ell_r^2(n)$ means that $\{a_n - b_n\}_{n=0}^{\infty} \in \ell_r^2$. We say that $a_n(q) = b_n(q) + \ell_r^2(n)$ holds true uniformly on some set iff norms $\|\{a_n(q) - b_n(q)\}_{n=0}^{\infty}\|_{\ell_r^2}$ are uniformly bounded on this set.

Hence, Lemma A.6 (ii) gives $\mu_n = 2\hat{q}_n^+ + O(n^{-1}\log^2 n)$. Let $\mu_n^{(1)} = 2\hat{q}_n^+$. Using the similar arguments, we obtain

$$0 = \frac{1}{\dot{\kappa}_n} \left(\psi_+^{(1)} + \psi_+^{(2)} + \dot{\psi}_+^0 \cdot \mu_n + \dot{\psi}_+^{(1)} \cdot \mu_n^{(1)} + \frac{\ddot{\psi}_+^0}{2} (\mu_n^{(1)})^2 \right) (0, \lambda_n^0, q) + O(n^{-\frac{3}{2}} \log^3 n).$$

Together with Lemma A.6 (ii), it follows

$$\frac{\mu_n}{2} = \hat{q}_n^+ - \check{q}_n^+ \hat{q}_n^+ + \left(\frac{\dot{\kappa}_n'}{\kappa_n'} \, \hat{q}_n^+ + \frac{1}{2} \, \check{q}_n^+\right) \cdot 2\hat{q}_n^+ - \frac{\ddot{\kappa}_n}{\kappa_n} \, (\hat{q}_n^+)^2 + \ell_{\frac{3}{4}+\delta}^2(n) \\ = \hat{q}_n^+ + \left(\frac{2\dot{\kappa}_n'}{\kappa_n'} - \frac{\ddot{\kappa}_n}{\kappa_n}\right) \cdot (\hat{q}_n^+)^2 + \ell_{\frac{3}{4}+\delta}^2(n) = \hat{q}_n^+ + \ell_{\frac{3}{4}+\delta}^2(n),$$

where we have used (A.16).

Furthermore, we have

$$e^{s_n^0 - s_n(q)} = \frac{\psi'_+(0, \lambda_n(q), q)}{\kappa'_n} = 1 - \check{q}_n^+ + \frac{\dot{\kappa}'_n}{\kappa'_n} \cdot \mu_n + \frac{1}{2} (\check{q}_n^+)^2 - \frac{\pi^2}{8} (\hat{q}_n^+)^2 + \left(-\frac{\dot{\kappa}'_n}{\kappa'_n} \check{q}_n^+ + \frac{\pi^2}{8} \hat{q}_n^+\right) \cdot \mu_n^{(1)} + \frac{\ddot{\kappa}'_n}{2\kappa'_n} (\mu_n^{(1)})^2 + \ell_{\frac{3}{4} + \delta}^2(n).$$

Hence,

$$s_n^0 - s_n(q) = -\check{q}_n^{+} + \frac{\dot{\kappa}_n'}{\kappa_n'} \cdot \mu_n + \left(\frac{\ddot{\kappa}_n'}{\kappa_n'} - \frac{(\dot{\kappa}_n')^2}{(\kappa_n')^2} + \frac{\pi^2}{16}\right) \cdot \frac{(\mu_n^{(1)})^2}{2} + \ell_{\frac{3}{4}+\delta}^2(n)$$
$$= -\check{q}_n^{+} + \frac{\dot{\kappa}_n'}{\kappa_n'} \cdot \mu_n + \ell_{\frac{3}{4}+\delta}^2(n),$$

where we have used (A.16). This yields the second part of (3.2) in view of (3.1).

Below we need some special representation of the sequences $\{\hat{q}_n^+\}_{n=0}^{\infty}$ and $\{\check{q}_n^+\}_{n=0}^{\infty}$. Define the functions

$$\tilde{\psi}_n^0(x) = 2^{1/4} \psi_n^0(\sqrt{2}x), \quad n \ge 0.$$

Note that the system of functions $\{\widetilde{\psi}_{2m}^0\}_{m=0}^{\infty}$ is the orthogonal basis of \mathbf{H}_{even} , i.e. the orthogonal basis of the space \mathbf{H}_+ , while the system $\{\widetilde{\psi}_{2m+1}^0\}_{m=0}^{\infty}$ is the orthogonal basis of its subspace $\mathbf{H}_+^0 = \{q \in \mathbf{H}_+ : q(0) = 0\} \subsetneq \mathbf{H}_+$.

Following [CKK2], for each $q \in \mathbf{H}_+$ we define two (analytic in the unit disc \mathbb{D}) functions

$$(F^{+}q)(z) \equiv \frac{1}{(2\pi)^{1/4}} \sum_{k \ge 0} \sqrt{E_k} (q, \tilde{\psi}_{2k}^0)_+ \cdot z^k , \quad z \in \mathbb{D} ,$$

$$(G^{+}q)(z) \equiv -\frac{(2\pi)^{1/4}}{2} \sum_{k \ge 0} \frac{(q, \tilde{\psi}_{2k+1}^0)_+}{\sqrt{(2k+1)E_k}} z^k , \quad z \in \mathbb{D} ,$$
(3.3)

where

$$E_k = \frac{(2k)!}{2^{2k}(k!)^2} \sim \pi^{-\frac{1}{2}} k^{-\frac{1}{2}} \text{ as } k \to \infty.$$

Note that F^+q , $G^+q \in H^2_{3/4}$ for each $q \in \mathbf{H}_+$. Moreover, the mapping $q \mapsto F^+q$ is a linear isomorphism between \mathbf{H}_+ and $H^2_{3/4}$, while the mapping $q \mapsto G^+q$ is a linear isomorphism between \mathbf{H}^0_+ and $H^2_{3/4}$. Recall that $\hat{q}_n^+ = (q, (\psi_n^0)^2)_+$ and $\check{q}_n^+ = (q, \psi_n^0\chi_n^0)_+$, $n \ge 0$.

Proposition 3.2. For each $q \in \mathbf{H}_+$ the following identities⁷ are fulfilled:

$$\sum_{n \ge 0} \hat{q}_n^+ z^n \equiv \frac{(F^+q)(z)}{\sqrt{1-z}}, \qquad \sum_{n \ge 0} \check{q}_n^+ z^n \equiv P_+ \left[\frac{(G^+q)(\zeta)}{\sqrt{1-\overline{\zeta}}}\right], \qquad z \in \mathbb{D},$$
(3.4)

$$(F^+q)(1) = (2\pi)^{-\frac{1}{2}} \int_{\mathbb{R}_+} q(t)dt, \qquad (F^+q)(-1) = 2^{-\frac{3}{2}}q(0).$$
(3.5)

Remark. Here and below we put $(P_+f)(z) \equiv \frac{1}{2\pi i} \int_{|\zeta|=1} \frac{f(\zeta)d\zeta}{\zeta-z}$ for any $f \in L^1(\mathbb{T})$ and $z \in \mathbb{D}$. In particular, the identity $(P_+ \sum_{n=-k}^k c_n \zeta^n)(z) \equiv \sum_{n=0}^k c_n z^n$ holds true for any $c_n \in \mathbb{C}$.

Proof. Identities (3.4) were proved in [CKK2] (Propositions 1.2 and 2.9). Also, in [CKK2] it was shown that

$$1 = \sum_{k \ge 0} \widetilde{\psi}_{2k}^0(x) \int_{\mathbb{R}} \widetilde{\psi}_{2k}^0(t) dt = (2\pi)^{\frac{1}{4}} \sum_{k \ge 0} \sqrt{E_k} \, \widetilde{\psi}_{2k}^0(x) \,, \quad x \in \mathbb{R}$$

in the sense of distributions, which gives $(F^+q)(1) = (2\pi)^{-\frac{1}{2}} \int_{\mathbb{R}_+} q(t) dt$. Furthermore,

$$\delta(x) = \sum_{k \ge 0} \widetilde{\psi}_{2k}^0(x) \cdot \widetilde{\psi}_{2k}^0(0) = \sum_{k \ge 0} \widetilde{\psi}_{2k}^0(x) \cdot \frac{2^{1/4} H_{2k}(0)}{(\sqrt{\pi} \, 2^{2k} (2k)!)^{1/2}} = \left(\frac{2}{\pi}\right)^{1/4} \sum_{k \ge 0} (-1)^k \sqrt{E_k} \, \widetilde{\psi}_{2k}^0(x)$$

in the sense of distributions. Together with (3.3), this implies $(F^+q)(-1) = 2^{-\frac{1}{2}} \cdot \frac{q(0)}{2}$.

Emphasize that definition (2.1) of the space \mathcal{H} is directly motivated by Eq. (3.4). The following Proposition gives the basic properties of \mathcal{H} , \mathcal{H}_0 (see [CKK2] Lemmas 2.10, 2.11).

Proposition 3.3. (i) For each $\{h_n\}_{n=0}^{\infty} \in \mathcal{H}$ there is a unique decomposition $h_n = \frac{v}{\sqrt{\lambda_n^0}} + h_n^{(0)}$, where $v = (\pi/2)^{-\frac{1}{2}} \sqrt{1-z} \sum_{n=0}^{+\infty} h_n z^n|_{z=1}$ and $\{h_n^{(0)}\}_{n=0}^{\infty} \in \mathcal{H}_0$. The mapping $h \mapsto (v, h^{(0)})$ is a linear isomorphism between \mathcal{H} and $\mathbb{R} \times \mathcal{H}_0$. If $h = \{\hat{q}_n^+\}_{n=0}^{\infty}$, then $v = \pi^{-1} \int_{\mathbb{R}_+} q(t) dt$. (ii) The set of finite sequences $\{(h_0, \ldots, h_k, 0, 0, \ldots), k \ge 0, h_j \in \mathbb{R}\}$ is dense in \mathcal{H}_0 . (iii) The embeddings $\ell_{3/4}^2 \subset \mathcal{H}_0 \subset \ell_{1/4}^2$ are fulfilled.

Remark. Since $\mathcal{H}_0 \subset \ell_{1/4}^2$, the sequence of leading terms $\{v/\sqrt{\lambda_n^0}\}_{n=0}^\infty$ doesn't belong to \mathcal{H}_0 . The next Lemma gives the *O*-type estimate for elements of \mathcal{H}_0 .

Lemma 3.4. Let $h = \{h_n\}_{n=0}^{\infty} \in \mathcal{H}_0$. Then $h_n = O(n^{-\frac{3}{4}} \log^{\frac{1}{2}} n)$ as $n \to \infty$.

⁷We write $f(z) \equiv g(z)$ iff the identity f(z) = g(z) holds true for all $z \in \mathbb{D}$.

Proof. The proof is similar to the proof of Lemma 2.1 in [Ch]. Definition (2.3) of \mathcal{H}_0 yields

$$\sum_{n \ge 0} h_n z^n \equiv \frac{\sum_{k \ge 0} f_k z^k}{\sqrt{1-z}}, \quad \{f_k\}_{k=0}^\infty \in \ell_{3/4}^2, \quad \sum_{k \ge 0} f_k = f(1) = 0.$$

Recall that $(1-z)^{-\frac{1}{2}} \equiv \sum_{m \ge 0} E_m z^m$. Hence,

$$h_n = \sum_{k=0}^n E_{n-k} f_k = \sum_{k=1}^n (E_{n-k} - E_n) f_k - E_n \sum_{k=n+1}^\infty f_k.$$

It is easy to see that $E_n = O(n^{-\frac{1}{2}})$ and $E_{n-k} - E_n = O(kn^{-1}(n-k+1)^{-\frac{1}{2}})$. Therefore,

$$\left| E_n \sum_{k=n+1}^{\infty} f_k \right| \leqslant E_n \left(\sum_{k=n+1}^{+\infty} k^{-\frac{3}{2}} \right)^{1/2} \left(\sum_{k=n+1}^{+\infty} k^{\frac{3}{2}} |f_k|^2 \right)^{1/2} = O(n^{-\frac{3}{4}}),$$

$$\left| \sum_{k=1}^n (E_{n-k} - E_n) f_k \right| \leqslant \left(\sum_{k=1}^n O\left(\frac{k^{\frac{1}{2}}}{n^2(n-k+1)} \right) \right)^{1/2} \left(\sum_{k=1}^n k^{\frac{3}{2}} |f_k|^2 \right)^{1/2} = O(n^{-\frac{3}{4}} \log^{\frac{1}{2}} n),$$

where the inequality $\sum_{k=1}^{+\infty} k^{\frac{3}{2}} |f_k|^2 < +\infty$ has been used.

In order to prove Theorem 2.2 we need

Lemma 3.5. (i) Let $h = \{h_n\}_{n=0}^{\infty} \in \mathcal{H}$. Then $h_N = \{h_{2n}\}_{n=0}^{\infty}$, $h_D = \{h_{2n+1}\}_{n=0}^{\infty} \in \mathcal{H}$ and $\triangle h = \{h_{2n} - h_{2n+1}\}_{n=0}^{\infty} \in \ell_{3/4}^2$. (ii) Both mappings $h \mapsto (h_N, \triangle h)$, $h \mapsto (h_D, \triangle h)$ are isomorphisms between \mathcal{H} and $\mathcal{H} \times \ell_{3/4}^2$. Proof. (i) For $z \in \mathbb{D}$ denote $h(z) \equiv \sum_{n \ge 0} h_n z^n$, $h_N(z) \equiv \sum_{n \ge 0} h_{2n} z^n$ and so on. By definition of \mathcal{H} , we have

$$h_N(z^2) + zh_D(z^2) \equiv h(z) \equiv \frac{f(z)}{\sqrt{1-z}}, \quad f \in H^2_{3/4}.$$

Then,

$$h_N(z^2) \equiv \frac{f_N(z^2)}{\sqrt{1-z^2}}, \quad \text{where} \quad f_N(z^2) \equiv \frac{f(z)\sqrt{1+z}+f(-z)\sqrt{1-z}}{2},$$

$$h_D(z^2) \equiv \frac{f_D(z^2)}{\sqrt{1-z^2}}, \quad \text{where} \quad f_D(z^2) \equiv \frac{f(z)\sqrt{1+z}-f(-z)\sqrt{1-z}}{2z}, \quad (3.6)$$

$$(\triangle h)(z^2) \equiv h_N(z^2) - h_D(z^2) \equiv \frac{-f(z)\sqrt{1-z}+f(-z)\sqrt{1+z}}{2z}.$$

Due to $\sqrt{1\pm z} \in H_{3/4}^2$, we obtain $f_N, f_D, \triangle h \in H_{3/4}^2$, and hence $h_N, h_D \in \mathcal{H}$. (ii) By definition of \mathcal{H} , the mappings $h \mapsto f$, $h_N \mapsto f_N$ and $h_D \mapsto f_D$ are isomorphisms between \mathcal{H} and $H_{3/4}^2$. We show that both mappings $f \mapsto (f_N, \triangle h), f \mapsto (f_D, \triangle h)$ are isomorphisms between $H_{3/4}^2$ and $H_{3/4}^2 \times H_{3/4}^2$. Indeed, due to (3.6), the direct mappings are bounded. On the other hand, identities

$$f(z) \equiv f_D(z^2)\sqrt{1+z} + \triangle h(z^2)\sqrt{1-z} \equiv f_N(z^2)\sqrt{1+z} - \triangle h(z^2)z\sqrt{1-z}$$

follow that the inverse mappings are bounded too.

Proof of Theorem 2.2. Theorem 2.1 and the second part of Lemma 3.5 give that both mappings $q \mapsto (\{\mu_{2n+1}(q)\}_{n=0}^{\infty}, \{\tau_n(q)\}_{n=0}^{\infty})$ and $q \mapsto (\{\mu_{2n}(q)\}_{n=0}^{\infty}, \{\tau_n(q)\}_{n=0}^{\infty})$ are real-analytic isomorphisms. We show that $q(0) = 2 \sum_{n \ge 0} \tau_n(q)$. Proposition 3.2 yields

$$\sum_{n \ge 0} (\hat{q}_{2n}^+ - \hat{q}_{2n+1}^+) = \frac{(F^+q)(z)}{\sqrt{1-z}} \Big|_{z=-1} = \frac{q(0)}{4} \,. \tag{3.7}$$

Hence, it is sufficient to check that

$$\sum_{n \ge 0} (\mu_{2n}(q) - 2\hat{q}_{2n}^+) = 0, \qquad \sum_{n \ge 0} (\mu_{2n+1}(q) - 2\hat{q}_{2n+1}^+) = 0$$
(3.8)

(note that these series converge due to Theorem 3.1). Below we prove the first identity, the proof of the second is similar.

Put q(-x) = q(x), $x \ge 0$, and consider the harmonic oscillator on \mathbb{R} perturbed by the potential q(x). The perturbation theory (see e.g. [Ka]) yields⁸

$$\frac{\partial \lambda_{2n}(q)}{\partial q(x)} = \psi_{2n}^2(x,q), \qquad \frac{\partial \psi_{2n}(x,q)}{\partial q(y)} = \psi_{2n}(y,q) \sum_{m:m \neq 2n} \frac{\psi_m(y,q)\psi_m(x,q)}{\lambda_{2n}(q) - \lambda_m(q)},$$

where $\psi_m(t,q)$, $m \ge 0$, are the normalized eigenfunctions of the operator T.

Therefore,

$$\mu_{2n}(q) - 2\hat{q}_{2n}^{+} = \int_{0}^{1} \left(q, \psi_{2n}^{2}(sq) \right)_{L^{2}(\mathbb{R})} ds - \hat{q}_{2n} = \int_{0}^{1} \left(q, \psi_{2n}^{2}(sq) - (\psi_{2n}^{0})^{2} \right)_{L^{2}(\mathbb{R})} ds$$

and

$$\left(q(x), \psi_{2n}^2(x, sq) - (\psi_{2n}^0)^2(x)\right)_{L^2(\mathbb{R}, dx)} = \int_0^s \left(q(x), \frac{d}{dt}\psi_{2n}^2(x, tq)\right)_{L^2(\mathbb{R}, dx)} dt$$

$$= \int_0^s \left(q(x), 2\psi_{2n}(x, tq) \cdot \left(q(y), \psi_{2n}(y, tq)\sum_{m \neq 2n} \frac{\psi_m(y, tq)\psi_m(x, tq)}{\lambda_{2n}(tq) - \lambda_m(tq)}\right)_{L^2(\mathbb{R}, dy)}\right)_{L^2(\mathbb{R}, dx)} dt$$

Since $(q, (\psi_{2n}\psi_{2m+1})(\cdot, tq))_{L^2(\mathbb{R})} = 0$ for any $n, m \ge 0$, we have

$$\sum_{n \ge 0} (\mu_{2n}(q) - 2\hat{q}_{2n}^+) = 2 \int_0^1 ds \int_0^s \sum_{n \ge 0} \sum_{m:m \ne n} \frac{(q, (\psi_{2n}\psi_{2m})(tq))_{L^2(\mathbb{R})}^2}{\lambda_{2n}(tq) - \lambda_{2m}(tq)} dt.$$

Let

$$S_{k} = \sum_{n=0}^{k} \sum_{m:m \neq n} \frac{(q, (\psi_{2n}\psi_{2m})(tq))_{L^{2}(\mathbb{R})}^{2}}{\lambda_{2n}(tq) - \lambda_{2m}(tq)} = \sum_{n=0}^{k} \sum_{m=k+1}^{+\infty} \frac{(q, (\psi_{2n}\psi_{2m})(tq))_{L^{2}(\mathbb{R})}^{2}}{\lambda_{2n}(tq) - \lambda_{2m}(tq)}$$

Using Lemma A.7 and the estimate $|\lambda_{2n}(tq) - \lambda_{2m}(tq)| \ge c(m-n)$ for some c > 0 and $m > n \ge 0$, we obtain $S_k \to 0$ as $k \to \infty$, which yields $\sum_{n \ge 0} (\mu_{2n}(q) - 2\hat{q}_{2n}^+) = 0$.

⁸Here and below $\partial \xi(q) / \partial q = \zeta(q)$ means that for any $v \in L^2$ the equation $(d_q \xi)(v) = (v, \overline{\zeta})_{L^2}$ holds true.

4 Inverse problem for the operator T_D

We begin with the connection between two functions F^+q and G^+q (given by (3.3)) for fixed $q \in \mathbf{H}_+$. Recall that the system of functions $\{\widetilde{\psi}_{2k}^0\}_{k=0}^{\infty}$ is a basis of \mathbf{H}_+ . Therefore, it is possible to rewrite G^+q in terms of F^+q . For $\zeta \in \mathbb{T}$, $\zeta \neq -1$, we put $\sqrt{\zeta} = \sqrt{e^{i\phi}} = e^{\frac{i\phi}{2}}$, where $\zeta = e^{i\phi}$, $\phi \in (-\pi, \pi)$. We have the following identity in $L^2(\mathbb{T})$:

$$\frac{1}{\sqrt{\zeta}} = \frac{2}{\pi} \sum_{l=-\infty}^{+\infty} \frac{(-1)^l}{2l+1} \zeta^l , \quad \zeta \in \mathbb{T} .$$

$$(4.1)$$

Lemma 4.1. For each $q \in \mathbf{H}_+$ the following identity is fulfilled:

$$(G^+q)(z) \equiv -\frac{\pi}{2} P_+\left(\frac{(F^+q)(\zeta)}{\sqrt{\zeta}}\right), \quad z \in \mathbb{D}.$$

$$(4.2)$$

Proof. We determine the coefficients of the function ψ_{2m+1}^0 with respect to the basis $\{\psi_{2k}^0\}_{k=0}^\infty$. The standard identity $\{\psi_{2k}^0, \psi_{2m+1}^0\}' = (\lambda_{2k}^0 - \lambda_{2m+1}^0)\psi_{2k}^0\psi_{2m+1}^0$, yields

$$(\psi_{2m+1}^0, \psi_{2k}^0)_+ = \int_{\mathbb{R}_+} \psi_{2m+1}^0(x)\psi_{2k}^0(x)dx = \frac{\{\psi_{2k}^0, \psi_{2m+1}^0\}(0)}{\lambda_{2m+1}^0 - \lambda_{2k}^0} = \frac{\psi_{2k}^0(0)(\psi_{2m+1}^0)'(0)}{2(2(m-k)+1)}$$

Note that

$$\psi_{2k}^{0}(0) = \frac{H_{2k}(0)}{(\sqrt{\pi} \, 2^{2k}(2k)!)^{1/2}} = \frac{(-1)^{k} 2^{k}(2k-1)!!}{(\sqrt{\pi} \, 2^{2k}(2k)!)^{1/2}} = \frac{(-1)^{k}}{\pi^{1/4}} \sqrt{E_{k}},$$

$$(\psi_{2m+1}^{0})'(0) = \frac{H'_{2m+1}(0)}{(\sqrt{\pi} \, 2^{2m+1}(2m+1)!)^{1/2}} = \frac{(-1)^{m} 2^{m+1}(2m+1)!!}{(\sqrt{\pi} \, 2^{2m+1}(2m+1)!)^{1/2}} = \frac{(-1)^{m} \sqrt{2}}{\pi^{1/4}} \sqrt{(2m+1)E_{m}}.$$
Therefore

Therefore,

$$(\widetilde{\psi}_{2m+1}^0, \widetilde{\psi}_{2k}^0)_+ = (\psi_{2m+1}^0, \psi_{2k}^0)_+ = \frac{1}{\sqrt{2\pi}} \cdot \frac{(-1)^{m-k}}{2(m-k)+1} \sqrt{(2m+1)E_mE_k}.$$

Since $\|\widetilde{\psi}_{2k}^0\|_+^2 = \frac{1}{2}$, we obtain

$$\frac{\widetilde{\psi}_{2m+1}^0}{\sqrt{(2m+1)E_m}} = \sqrt{\frac{2}{\pi}} \sum_{k=0}^{+\infty} \frac{(-1)^{m-k}}{2(m-k)+1} \cdot \sqrt{E_k} \, \widetilde{\psi}_{2k}^0 \, .$$

It gives

$$P_{+}\left(\frac{(F^{+}q)(\zeta)}{\sqrt{\zeta}}\right) \equiv \frac{2^{3/4}}{\pi^{5/4}} P_{+}\left(\sum_{l=-\infty}^{+\infty} \frac{(-1)^{l}}{2l+1} \zeta^{l} \cdot \sum_{k=0}^{+\infty} \sqrt{E_{k}}(q, \tilde{\psi}_{2k}^{0})_{+} \zeta^{k}\right)$$
$$\equiv \frac{2^{1/4}}{\pi^{3/4}} \sum_{m=0}^{+\infty} \frac{(q, \tilde{\psi}_{2m+1}^{0})_{+}}{\sqrt{(2m+1)E_{m}}} z^{m} \equiv -\frac{2}{\pi} \left(G^{+}q\right)(z), \quad z \in \mathbb{D},$$

where definition (3.3) of the functions F^+q and G^+q has been used.

We should mention that Lemma 4.1 gives the simple proof of [CKK2] Theorem 4.2 about the equivalent definition of \mathcal{H}_0 . Following [CKK2], we introduce the linear operator

$$(\mathcal{A}f)(z) \equiv P_{+}\left[\frac{f(\zeta)}{\sqrt{-\zeta}}\right] \equiv P_{+}\left[\sqrt{1-\overline{\zeta}} \cdot \frac{f(\zeta)}{\sqrt{1-\zeta}}\right], \qquad f \in L^{1}(\mathbb{T}).$$

$$(4.3)$$

Let

$$\overset{\circ}{H}_{3/4}^2 = \{ f \in H_{3/4}^2 : f(1) = 0 \} \subset H_{3/4}^2 .$$

Corollary 4.2. (i) The operator $\mathcal{A} : \overset{\circ}{H}^{2}_{3/4} \to H^{2}_{3/4}$ and its inverse are bounded. (ii) The following equality is fulfilled:

$$\mathcal{H}_{0} = \left\{ \{h_{n}\}_{n=0}^{\infty} : \sum_{n \ge 0} h_{n} z^{n} \equiv P_{+} \left[\frac{g(\zeta)}{\sqrt{1-\overline{\zeta}}} \right], \ g \in H_{3/4}^{2} \right\}.$$
(4.4)

The norms $\|h\|_{\mathcal{H}}$ and $\|g\|_{H^2_{3/4}}$ are equivalent, i.e. $C_1\|g\|_{H^2_{3/4}} \leq \|h\|_{\mathcal{H}} \leq C_2\|g\|_{H^2_{3/4}}$ for any $g \in H^2_{3/4}$ and some absolute constants $C_1, C_2 > 0$.

Remark. This equivalence was proved in [CKK2] using different and complicated arguments.

Proof. (i) Recall that the mapping $q \mapsto (G^+q)(-z)$ is a linear isomorphism between \mathbf{H}^0_+ and $H^2_{3/4}$. Also, due to the identity $(F^+q)(-1) = 2^{-3/2}q(0)$ (see Proposition 3.2), the mapping $q \mapsto (F^+q)(-z)$ is a linear isomorphism between \mathbf{H}^0_+ and $\mathring{H}^2_{3/4}$. Therefore, the mapping

$$f(z) \equiv (F^+q)(-z) \mapsto q \mapsto (G^+q)(-z) \equiv -\frac{\pi}{2} P_+ \left[\frac{(F^+q)(-\zeta)}{\sqrt{\zeta}}\right] \equiv \mathcal{A}f(z)$$

is a linear isomorphism between $\overset{\circ}{H}^2_{3/4}$, \mathbf{H}^0_+ and $H^2_{3/4}$ respectively.

(ii) If $g \in H^2_{3/4}$, then $g_0(z) \equiv g(z) - g(1) \in \overset{\circ}{H}^2_{3/4}$ and so $|g_0(\zeta)| \leq C|\zeta - 1|^{1/4}$, $|\zeta| = 1$, for some constant C > 0. Hence, the following equivalence is valid:

$$\begin{split} \sum_{n \ge 0} h_n z^n &\equiv P_+ \left(\frac{g(\zeta)}{\sqrt{1 - \overline{\zeta}}} \right) \quad \Leftrightarrow \quad \sum_{n \ge 0} h_n z^n \equiv g(1) + \frac{g_0(z)}{\sqrt{1 - \overline{z}}} - P_- \left(\frac{g_0(\zeta)}{\sqrt{1 - \overline{\zeta}}} \right) \\ &\Leftrightarrow \quad P_+ \left(\sqrt{1 - \overline{\zeta}} \sum_{n \ge 0} h_n \zeta^n \right) \equiv g(1) + g_0(z) \equiv g(z) \,, \end{split}$$

where $P_-f \equiv f - P_+f$ is the projector to the subspace of antianalytic functions in \mathbb{D} . Therefore, the equation

$$\frac{f(z)}{\sqrt{1-z}} \equiv \sum_{n \ge 0} h_n z^n \equiv P_+ \left[\frac{g(\zeta)}{\sqrt{1-\overline{\zeta}}} \right], \quad \text{where} \quad f \in \overset{\circ}{H}^2_{3/4}, \quad g \in H^2_{3/4},$$

is equivalent to $g(z) \equiv (\mathcal{A}f)(z)$. Then (i) follows (4.4).

Consider the linear terms in asymptotics (3.2). Due to Lemma 3.5, the identities

$$\sum_{n \ge 0} \hat{q}_{2n}^+ z^n \equiv \frac{(F_N q)(z)}{\sqrt{1-z}}, \quad \text{where} \quad (F_N q)(z^2) \equiv \frac{(F^+ q)(z)\sqrt{1+z} + (F^+ q)(-z)\sqrt{1-z}}{2},$$
$$\sum_{n \ge 0} \hat{q}_{2n+1}^+ z^n \equiv \frac{(F_D q)(z)}{\sqrt{1-z}}, \quad \text{where} \quad (F_D q)(z^2) \equiv \frac{(F^+ q)(z)\sqrt{1+z} - (F^+ q)(-z)\sqrt{1-z}}{2z}$$

hold true. Note that

$$(F^+q)(z) \equiv \frac{(F_Nq)(z^2) + z(F_Dq)(z^2)}{\sqrt{1+z}}, \quad z \in \mathbb{D}.$$
(4.5)

Lemma 4.3. For each $q \in \mathbf{H}_+$ there exists functions $G_N q$, $G_D q \in H^2_{3/4}$ such that the following identities are fulfilled:

$$\sum_{n \ge 0} \check{q}_{2n}^+ z^n \equiv P_+ \left[\frac{(G_N q)(\zeta)}{\sqrt{1 - \overline{\zeta}}} \right], \qquad \sum_{n \ge 0} \check{q}_{2n+1}^+ z^n \equiv P_+ \left[\frac{(G_D q)(\zeta)}{\sqrt{1 - \overline{\zeta}}} \right].$$

Moreover,

$$(G_N q)(z) \equiv -\frac{\pi}{2} (F_D q)(z), \quad (G_D q)(z) \equiv -\frac{\pi}{2} (S_* F_N q)(z), \quad z \in \mathbb{D},$$

where $(S_*F)(z) \equiv P_+[\overline{\zeta} \cdot F(\zeta)]$ is the "left-shift" operator.

Proof. Define the function

$$(G_N q)(z) \equiv P_+ \left[\sqrt{1 - \overline{\zeta}} \sum_{n \ge 0} \check{q}_{2n}^+ \zeta^n \right] \quad z \in \mathbb{D}.$$

It gives

$$P_{+}\left[\frac{(G_{N}q)(\zeta)}{\sqrt{1-\overline{\zeta}}}\right] \equiv P_{+}\left[\sum_{n\geqslant 0} \check{q}_{2n}^{+} \zeta^{n} - \frac{P_{-}\left[\sqrt{1-\overline{\zeta}}\sum_{n\geqslant 0} \check{q}_{2n}^{+} \zeta^{n}\right]}{\sqrt{1-\overline{\zeta}}}\right] \equiv \sum_{n\geqslant 0} \check{q}_{2n}^{+} z^{n}.$$

On the other hand, we have

$$\sum_{n \ge 0} \check{q}_{2n}^+ z^{2n} \equiv \frac{1}{2} \left(P_+ \left[\frac{(G^+ q)(\zeta)}{\sqrt{1 - \overline{\zeta}}} \right] + P_+ \left[\frac{(G^+ q)(-\zeta)}{\sqrt{1 + \overline{\zeta}}} \right] \right).$$

Therefore,

$$(G_N q)(z^2) \equiv \frac{1}{2} P_+ \left[\sqrt{1 + \overline{\zeta}} \cdot (G^+ q)(\zeta) + \sqrt{1 - \overline{\zeta}} \cdot (G^+ q)(-\zeta) \right].$$

Lemma 4.1 yields

$$(G_N q)(z^2) \equiv -\frac{\pi}{4} P_+ \left[\frac{\sqrt{1+\overline{\zeta}}}{\sqrt{\zeta}} \cdot (F^+ q)(\zeta) + \frac{\sqrt{1-\overline{\zeta}}}{\sqrt{-\zeta}} \cdot (F^+ q)(-\zeta) \right].$$

Due to (4.5), we obtain

$$(G_N q)(z^2) \equiv -\frac{\pi}{4} P_+ \left[\left(\frac{\sqrt{1+\overline{\zeta}}}{\sqrt{\zeta}\sqrt{1+\zeta}} + \frac{\sqrt{1-\overline{\zeta}}}{\sqrt{-\zeta}\sqrt{1-\zeta}} \right) (F_N q)(\zeta^2) + \left(\frac{\zeta\sqrt{1+\overline{\zeta}}}{\sqrt{\zeta}\sqrt{1+\zeta}} - \frac{\zeta\sqrt{1-\overline{\zeta}}}{\sqrt{-\zeta}\sqrt{1-\zeta}} \right) (F_D q)(\zeta^2) \right] \equiv -\frac{\pi}{2} (F_D q)(z^2) ,$$

where we have used the identities

$$\frac{\sqrt{1+\overline{\zeta}}}{\sqrt{\zeta}\sqrt{1+\zeta}} = \frac{1}{\zeta}, \quad \zeta \neq -1, \quad \text{and} \quad \frac{\sqrt{1-\overline{\zeta}}}{\sqrt{-\zeta}\sqrt{1-\zeta}} = -\frac{1}{\zeta}, \quad \zeta \neq 1.$$

The proof of the identity $(G_D q)(z) \equiv -\frac{\pi}{2} P_+ \left[\overline{\zeta} \cdot (F_N q)(\zeta)\right]$ is similar.

Proof of Theorem 2.3 (i). Recall that Theorem 3.1 gives $\tilde{s}_{2n+1}(q) = \check{q}_{2n+1}^+ + \ell_{\frac{3}{4}+\delta}^2(n)$, which yields

$$\sum_{n \ge 0} \widetilde{s}_{2n+1}(q) z^n \equiv \sum_{n \ge 0} \check{q}_{2n+1}^+ z^n + \omega(z) , \quad \omega \in H^2_{\frac{3}{4} + \delta} , \quad \delta > 0 .$$

Lemma 4.3 implies

$$\sum_{n \ge 0} \widetilde{s}_{2n+1}(q) z^n \equiv P_+ \Big[\frac{(G_D q)(\zeta)}{\sqrt{1-\overline{\zeta}}} \Big] + \omega(z) \equiv -\frac{\pi}{2} P_+ \Big[\frac{(F_N q)(\zeta)}{\zeta \sqrt{1-\overline{\zeta}}} \Big] + \omega(z) \,.$$

Since $(F_N q)(z) \equiv \sqrt{1-z} \sum_{m \ge 0} \hat{q}_{2m}^+ z^m$ and $\sqrt{1-\zeta}/\zeta \sqrt{1-\zeta} = -1/\sqrt{-\zeta}, \, \zeta \ne 1$, we obtain

$$\sum_{n \ge 0} \widetilde{s}_{2n+1}(q) z^n \equiv \frac{\pi}{2} P_+ \left[\frac{1}{\sqrt{-\zeta}} \sum_{m \ge 0} \hat{q}_{2m}^+ \zeta^m \right] + \omega(z) \,. \tag{4.6}$$

Let

$$(\triangle Hq)(z) \equiv \sum_{m \geqslant 0} (\hat{q}_{2m}^+ - \hat{q}_{2m+1}^+) z^m \,, \quad z \in \mathbb{D} \,.$$

Note that Lemma 3.5 yields $riangle Hq \in H^2_{3/4}$ and Theorem 3.1 gives

$$\sum_{m \ge 0} \hat{q}_{2m}^+ z^m \equiv (\triangle Hq)(z) + \sum_{m \ge 0} \hat{q}_{2m+1}^+ z^m \equiv (\triangle Hq)(z) + \frac{1}{2} \sum_{m \ge 0} \mu_{2m+1}(q) z^m + \omega_1(z) , \quad \omega_1 \in H^2_{\frac{3}{4} + \delta}.$$

Moreover, (3.8) yields $\omega_1 \in \mathring{H}^2_{\frac{3}{4}+\delta}$. Substituting the last identity into (4.6), we have

$$\sum_{n \ge 0} \widetilde{s}_{2n+1}(q) z^n \equiv \frac{\pi}{4} P_+ \left[\frac{1}{\sqrt{-\zeta}} \sum_{m \ge 0} \mu_{2m+1}(q) \zeta^m \right] + \frac{\pi}{2} P_+ \left[\frac{(\triangle Hq)(\zeta)}{\sqrt{-\zeta}} \right] + \omega_2(z) \,,$$

where $\omega_2(z) = \omega(z) + \frac{\pi}{2} P_+ \left[\omega_1(\zeta) / \sqrt{-\zeta} \right] \in H^2_{\frac{3}{4} + \delta}$ since the operator $\mathcal{A} : \overset{\circ}{H}^2_{\frac{3}{4} + \delta} \to H^2_{\frac{3}{4} + \delta}$ given by (4.3) is bounded⁹. ⁹The proof repeats the proof of [CKK2] Theorem 4.2 or Corollary 4.2 in the present paper.

Furthermore, denote values \tilde{q}_n^+ by

$$\sum_{n \ge 0} \widetilde{q}_n^+ z^n \equiv \frac{\pi}{2} P_+ \left[\frac{(\triangle Hq)(\zeta) - (\triangle Hq)(1)}{\sqrt{-\zeta}} \right] \equiv \frac{\pi}{2} P_+ \left[\frac{(\triangle Hq)(\zeta)}{\sqrt{-\zeta}} \right] - \frac{\pi q(0)}{8} P_+ \left[\frac{1}{\sqrt{-\zeta}} \right], \quad (4.7)$$

where we have used (3.7). Note that $\{\tilde{q}_n^+\}_{n=0}^{\infty} \in \ell_{3/4}^2$, since the operator $\mathcal{A} : \overset{\circ}{H}_{3/4}^2 \to H_{3/4}^2$ is bounded (see Corollary 4.2). Summarizing, we obtain

$$\sum_{n \ge 0} \widetilde{s}_{2n+1}(q) z^n \equiv \frac{\pi}{4} P_+ \left[\frac{1}{\sqrt{-\zeta}} \sum_{m \ge 0} \mu_{2m+1}(q) \zeta^m \right] + \frac{\pi q(0)}{8} P_+ \left[\frac{1}{\sqrt{-\zeta}} \right] + \sum_{n \ge 0} \widetilde{q}_n^+ z^n + \omega_2(z) .$$

Since $1/\sqrt{-\zeta} = \frac{2}{\pi} \sum_{l=-\infty}^{+\infty} \zeta^l / (2l+1)$, it implies

$$\widetilde{s}_{2n+1}(q) = \frac{1}{2} \sum_{m \ge 0} \frac{\mu_{2m+1}(q)}{2(n-m)+1} + \frac{q(0)}{4(2n+1)} + r_{2n+1}(q), \qquad r_{2n+1}(q) = \widetilde{q}_n^+ + \ell_{\frac{3}{4}+\delta}^2(n). \quad (4.8)$$

In particular, $\{r_{2n+1}(q)\}_{n=0}^{\infty} \in \ell^2_{3/4}$.

Remark. Due to definition of F^+q and Lemma 3.5, the mappings $q \mapsto F^+q \mapsto (F_Dq, \triangle Hq)$ are linear isomorphisms between \mathbf{H}_+ , $H^2_{3/4}$ and $H^2_{3/4} \times H^2_{3/4}$ respectively. Since the operator $\mathcal{A} : \overset{\circ}{H}^2_{3/4} \to H^2_{3/4}$ and its inverse are bounded (see Corollary 4.2) and due to definition (4.7) of \tilde{q}^+_n , the mappings

$$\Delta Hq \mapsto \left((\Delta Hq)(0); \Delta Hq - (\Delta Hq)(0) \right) \mapsto \left((\Delta Hq)(0); \sum_{n \ge 0} \widetilde{q}_n^+ z^n \right) ,$$

are linear isomorphisms between $H^2_{3/4}$, $\mathbb{R} \times \overset{\circ}{H}^2_{3/4}$ and $\mathbb{R} \times H^2_{3/4}$. Therefore, using the identity $(\triangle Hq)(0) = \frac{1}{4}q(0)$, we obtain that the mappings

$$q \mapsto (F_D q; \triangle H q) \mapsto \left(\{ \hat{q}_{2n+1}^+ \}_{n=0}^\infty; q(0); \{ \tilde{q}_n^+ \}_{n=0}^\infty \right) ,$$

$$\mathbf{H}_+ \leftrightarrow H_{3/4}^2 \times H_{3/4}^2 \leftrightarrow \mathcal{H} \times \mathbb{R} \times \ell_{3/4}^2 ,$$
(4.9)

are linear isomorphisms.

Proof of Theorem 2.3 (ii). Consider the mapping $\Psi : \mathbf{H}_+ \to \mathcal{S}_D \times \mathbb{R} \times \ell^2_{3/4}$, given by

$$\Psi: q \mapsto \left(\{\mu_{2n+1}(q)\}_{n=0}^{\infty}, q(0), \{r_{2n+1}(q)\}_{n=0}^{\infty} \right),$$

which maps potential to spectral data. The proof given below consists of four steps: 1) Ψ is injective; 2) Ψ is analytic; 3) Ψ is a local isomorphism; 4) Ψ is surjective. 1. Uniqueness Theorem. The proof repeats the case of the whole real line [CKK1]. Let

 $(\{\mu_{2n+1}(p)\}_{n=0}^{\infty}, p(0), \{r_{2n+1}(p)\}_{n=0}^{\infty}) = (\{\mu_{2n+1}(q)\}_{n=0}^{\infty}, q(0), \{r_{2n+1}(q)\}_{n=0}^{\infty}),$

for some potentials $p, q \in \mathbf{H}_+$. Note that it gives

 $\lambda_{2n+1} = \lambda_{2n+1}(p) = \lambda_{2n+1}(q), \quad s_{2n+1} = s_{2n+1}(p) = s_{2n+1}(q), \quad n \ge 0.$

Recall that $\varphi(x, \lambda, q)$ is the solution of Eq. (2.4) such that $\varphi(0, \lambda, q) = 0$, $\varphi'(0, \lambda, q) = 1$. Define functions

$$f_1(\lambda; x, q, p) = \frac{F_1(\lambda; x, q, p)}{w_D(\lambda, q)}, \quad F_1(\lambda; x, q, p) = \varphi(x, \lambda, p)\psi'_+(x, \lambda, q) - \psi_+(x, \lambda, p)\varphi'(x, \lambda, q),$$

$$f_2(\lambda; x, q, p) = \frac{F_2(\lambda; x, q, p)}{w_D(\lambda, q)}, \quad F_2(\lambda; x, q, p) = \varphi(x, \lambda, p)\psi_+(x, \lambda, q) - \psi_+(x, \lambda, p)\varphi(x, \lambda, q),$$

where

$$w_D(\lambda, q) = \{\varphi(\cdot, \lambda, q), \psi_+(\cdot, \lambda, q)\} = -\psi_+(0, \lambda, q).$$

Both functions f_1 , f_2 are entire with respect to λ . Indeed, all roots $\lambda_{2n+1}(p) = \lambda_{2n+1}(q)$ of the denominator $w_D(\cdot, q)$ are simple and all these values are roots of the numerators F_1 , F_2 , since the definition of norming constants yields

$$\varphi(x,\lambda_{2n+1},q) = e^{s_{2n+1}} \cdot \psi_+(x,\lambda_{2n+1},q), \quad \varphi(x,\lambda_{2n+1},p) = e^{s_{2n+1}} \cdot \psi_+(x,\lambda_{2n+1},p).$$

Standard estimates (see Lemma A.2 and asymptotics (A.7)) of φ and ψ_+ give

$$f_1(\lambda; x, p, q) = O(1), \quad f_2(\lambda; x, p, q) = O(|\lambda|^{-1/2}), \quad |\lambda| = \lambda_{2n'}^0, \ n' \to \infty$$

Furthermore, the maximum principle and asymptotics of f_1 as $\lambda \to -\infty$ implies

$$f_1(\lambda; x, p, q) = 1$$
, $f_2(\lambda; x, p, q) = 0$, $\lambda \in \mathbb{C}$.

This follows $\varphi(x, \lambda, p) = \varphi(x, \lambda, q)$ and $\psi_+(x, \lambda, p) = \psi_+(x, \lambda, q)$, i.e. p = q.

2. Analyticity of Ψ . Recall that for some $\delta > 0$ the following asymptotics are fulfilled (see (3.2) and (4.8)):

$$\mu_{2n+1}(q) = 2\hat{q}_{2n+1}^+ + \ell_{\frac{3}{4}+\delta}^2(n), \qquad r_{2n+1}(q) = \tilde{q}_n^+ + \ell_{\frac{3}{4}+\delta}^2(n).$$
(4.10)

Let $\mathbf{H}_{+\mathbb{C}}$ be the complexification of the space \mathbf{H}_{+} . Due to Lemma A.4, for each real potential $q \in \mathbf{H}_{+}$ all spectral data $\mu_{2n+1}(q)$, $s_{2n+1}(q)$, $n \ge 0$, extend analytically to some complex neighborhood $Q \subset \mathbf{H}_{+\mathbb{C}}$ of q. Repeating the proof of (4.10) we obtain that these asymptotics hold true uniformly on bounded subsets of Q. Note that Lemma A.4 gives

$$\frac{\partial \mu_{2n+1}(q)}{\partial q(t)} = \psi_{2n+1}^2(t,q), \qquad \frac{\partial s_{2n+1}(q)}{\partial q(t)} = (\psi_{2n+1}\chi_{2n+1})(t,q), \qquad (4.11)$$

where $\psi_{2n+1}(\cdot, q)$ is the *n*-th normalized eigenfunction of T_D and $\chi_{2n+1}(\cdot, q)$ is some special solution of Eq. (2.4) for $\lambda = \lambda_{2n+1}(q)$ such that $\{\chi_{2n+1}, \psi_{2n+1}\} = 1$. In particular,

$$(\psi_{2n+1}\chi_{2n+1})(t,q) \sim t, \quad t \to 0, \qquad (\psi_{2n+1}\chi_{2n+1})(t,q) \sim -t^{-1}, \quad t \to +\infty$$

Let

$$\Psi = \Psi_0 + \Psi_1, \quad \Psi_0 : q \mapsto \left(\{ 2\hat{q}_{2n+1}^+ \}_{n=0}^\infty ; q(0) ; \{ \tilde{q}_n^+ \}_{n=0}^\infty \right), \quad \Psi_1 : q \mapsto \Psi q - \Psi_0 q$$

As it was shown above (see (4.9)), the linear operator Ψ_0 is an isomorphism between \mathbf{H}_+ and $\mathcal{H} \times \mathbb{R} \times \ell^2_{3/4}$. In particular, Ψ_0 is a real-analytic mapping. Consider the second term

$$\Psi_1: q \mapsto \left(\{ \mu_{2n+1}(q) - 2\hat{q}_{2n+1}^+ \}_{n=0}^\infty; 0; \{ r_{2n+1}(q) - \tilde{q}_n^+ \}_{n=0}^\infty \right)$$
$$\Psi_1: \mathbf{H}_+ \to \ell_{\frac{3}{4}+\delta}^2 \times \mathbb{R} \times \ell_{\frac{3}{4}+\delta}^2 \subset \mathcal{H} \times \mathbb{R} \times \ell_{\frac{3}{4}}^2.$$

Each "coordinate function" $\mu_{2n+1}(q) - 2\hat{q}_{2n+1}^+$, $r_{2n+1}(q) - \tilde{q}_n^+$ is analytic and the mapping Ψ_1 is correctly defined and bounded in some complex neighborhood of each real potential (since (4.10) holds true uniformly on bounded subsets). Then, Ψ_1 is a real-analytic mapping from \mathbf{H}_+ to $\ell_{\frac{3}{4}+\delta}^2 \times \mathbb{R} \times \ell_{\frac{3}{4}+\delta}^2$. Hence, $\Psi = \Psi_0 + \Psi_1$ is a real-analytic mapping.

3. Local Isomorphism. Since Ψ is analytic, the Fréchet derivative $d_q \Psi : \mathbf{H}_+ \to \mathcal{H} \times \mathbb{R} \times \ell^2_{3/4}$ is bounded for each $q \in \mathbf{H}_+$. We need to show that $(d_q \Psi)^{-1}$ is bounded too. Note that the operator

$$d_q \Psi_1 : \mathbf{H}_+ \to \mathcal{H} \times \mathbb{R} \times \ell_{\frac{3}{4}}^2$$

is compact since it maps \mathbf{H}_+ into $\ell_{\frac{3}{4}+\delta}^2 \times \mathbb{R} \times \ell_{\frac{3}{4}+\delta}^2$ and the embedding $\ell_{\frac{3}{4}+\delta}^2 \subset \ell_{\frac{3}{4}}^2$ is compact. Therefore,

$$d_q \Psi = d_q \Psi_0 + d_q \Psi_1 = \Psi_0 + d_q \Psi_1 : \mathbf{H}_+ \to \mathcal{H} \times \mathbb{R} \times \ell_{\frac{3}{4}}^2$$

is a Fredholm operator (due to (4.9), the inverse operator Ψ_0^{-1} is bounded). By Fredholm's Theory, in order to prove that $(d_q \Psi)^{-1}$ is bounded, it is sufficient to check that the range Ran $d_q \Psi$ is dense:

$$\mathcal{H} \times \mathbb{R} \times \ell_{3/4}^2 = \overline{\operatorname{Ran} d_q \Psi} \,. \tag{4.12}$$

,

Due to Lemma A.5 (i), for each $q \in \mathbf{H}_+$ the following standard identities are fulfilled:

$$\left((\psi_{2n+1}^2)'(q), \psi_{2m+1}^2(q) \right)_+ = 0, \quad \left((\psi_{2n+1}^2)'(q), (\psi_{2m+1}\chi_{2m+1})(q) \right)_+ = \frac{1}{2} \,\delta_{mn}, \\ ((\psi_{2n+1}\chi_{2n+1})'(q), (\psi_{2m+1}\chi_{2m+1})(q))_+ = 0, \quad n, m \ge 0.$$

$$(4.13)$$

Using (4.11) and (4.13), we obtain

$$\left(2(\psi_{2n+1}^2)'(q), \frac{\partial\mu_{2m+1}(q)}{\partial q}\right)_{+} = 0, \quad \left(2(\psi_{2n+1}^2)'(q), \frac{\partial\tilde{s}_{2m+1}(q)}{\partial q}\right)_{+} = \delta_{nm}.$$

Note that $(\psi_{2n+1}^2)'(\cdot,q) \in \mathbf{H}_+$ and $(\psi_{2n+1}^2)'(0,q) = 0$. By definition (2.6) of $r_{2m+1}(q)$, we have

$$\left(2(\psi_{2n+1}^2)'(q), \frac{\partial r_{2m+1}(q)}{\partial q}\right)_+ = \delta_{nm}$$

Hence,

$$(d_q\Psi)\left(2(\psi_{2n+1}^2)'(\cdot,q)\right) = (\mathbf{0}\,;0\,;\mathbf{e}_n)$$

where $\mathbf{0} = (0, 0, 0, \ldots)$, $\mathbf{e}_0 = (1, 0, 0, \ldots)$, $\mathbf{e}_1 = (0, 1, 0, \ldots)$ and so on. Therefore,

$$\{(\mathbf{0};0)\} \times \ell_{3/4}^2 = \{(\mathbf{0};0;\mathbf{c}): \mathbf{c} \in \ell_{3/4}^2\} \subset \overline{\operatorname{Ran} d_q \Psi}.$$
(4.14)

We come to the second component of $(d_q \Psi) \xi$, i.e. to the value $\xi(0)$. We consider the lowest eigenvalue $\lambda_0(q)$ of the operator T_N (with the same potential q) and the function

 $\xi(t) = (\varphi \vartheta)'(t, \lambda_0(q), q), \quad t \in \mathbb{R}.$

Note that $\xi(0) = 1$ and asymptotics (A.13), (A.14) give $\xi \in \mathbf{H}_+$ since $\vartheta(\cdot, \lambda_0(q), q)$ is proportional to $\psi_+(\cdot, \lambda_0(q), q)$. Moreover, since $\varphi(0, \lambda_0(q), q) = \psi_{2m+1}(0, q) = 0$, we have

$$\left(\xi, \frac{\partial\mu_{2m+1}(q)}{\partial q}\right)_{+} = \left(\xi, \psi_{2m+1}^{2}(q)\right)_{+} = \frac{-\{\psi_{2m+1}, \varphi\}\{\psi_{2m+1}, \vartheta\}(0, \lambda_{0}(q), q)}{2(\lambda_{2m+1}(q) - \lambda_{0}(q))} = 0.$$

Hence,

$$(d_q\Psi)\xi = (\mathbf{0}; 1; (d_q r)\xi)$$
, where $(d_q r)\xi = \left\{ \left(\xi, \frac{\partial r_{2n+1}(q)}{\partial q}\right)_+ \right\}_{n=0}^{\infty} \in \ell_{3/4}^2$.

Together with (4.14) this gives

$$\{\mathbf{0}\} \times \mathbb{R} \times \ell^2_{3/4} \subset \overline{\operatorname{Ran} d_q \Psi}$$

Furthermore, we consider the functions $-2(\psi_{2m+1}\chi_{2m+1})'(q) \in \mathbf{H}_+$ (see asymptotics (A.13), (A.14)). Identities (4.11), (4.13) and $(\psi_{2m+1}\chi_{2m+1})'(0,q) = 1$ give

$$(d_q \Psi) \left(-2(\psi_{2m+1}\chi_{2m+1})'(q) \right) = \left(\mathbf{e}_m ; -2 ; (d_q r) \left(-2(\psi_{2m+1}\chi_{2m+1})'(q) \right) \right) .$$

Due to Proposition 3.3 (ii), the set of finite sequences is dense in \mathcal{H}_0 . Therefore,

$$\mathcal{H}_0 \times \mathbb{R} \times \ell^2_{3/4} \subset \overline{\operatorname{Ran} d_q \Psi} \,. \tag{4.15}$$

In conclusion, we consider an arbitrary function $\zeta \in \mathbf{H}_+$ such that $\int_{\mathbb{R}_+} \zeta(t) dt \neq 0$. Proposition 3.3 (i) follows

$$(d_q \Psi) \zeta \notin \mathcal{H}_0 \times \mathbb{R} \times \ell^2_{3/4}$$

Together with (4.15) it yields (4.12), since the codimension of \mathcal{H}_0 in \mathcal{H} is equal to 1.

4. Ψ is surjective. We need

Lemma 4.4. Let $q \in \mathbf{H}_+$, $n \ge 0$ and $t \in \mathbb{R}$. Denote

$$q_{2n+1}^t(x) = q(x) - 2\frac{d^2}{dx^2}\log\eta_{2n+1}^t(x,q), \quad \eta_{2n+1}^t(x,q) = 1 + (e^t - 1)\int_x^{+\infty}\psi_{2n+1}^2(s,q)ds$$

Then $q_{2n+1}^t \in \mathbf{H}_+$ and

$$\lambda_{2m+1}(q_{2n+1}^t) = \lambda_{2m+1}(q), \qquad s_{2m+1}(q_{2n+1}^t) = s_{2m+1}(q) + t\delta_{mn}$$

for all $m \ge 0$. Moreover, $q_{2n+1}^t(0) = q(0)$. Remark. By definition (2.6), we have $r_{2m+1}(q_n^t) = r_{2m+1}(q) + t\delta_{nm}$ for all $m \ge 0$. *Proof.* This Lemma is similar to [CKK2] Theorem 3.5 and can be proved by direct calculations using the so-called Darboux transform of second-order differential equation (see also [MT], [PT]). Note that

$$\eta^t_{2n+1}(x,q) = e^t - (e^t - 1) \int_0^x \psi^2_{2n+1}(s,q) ds = e^t + O(x^3) \,, \quad x \downarrow 0 \,.$$

This implies $q_{2n+1}^t(0) = q(0)$.

We consider an arbitrary spectral data $(h^*; u^*; c^*) \in S_D \times \mathbb{R} \times \ell^2_{3/4}$. Due to Theorem 2.2, there exists a potential $q^* \in \mathbf{H}_+$ such that

$$\mu_{2n+1}(q^*) = h_n^*, \quad n \ge 0, \text{ and } q^*(0) = 2\sum_{n \ge 0} \tau_n(q^*) = u^*.$$

It gives

$$(h^*; u^*; r(q^*)) \in \Psi(\mathbf{H}_+), \text{ where } r(q^*) = (r_1(q^*), r_3(q^*), \ldots).$$

Due to Proposition 3.3 (ii), for each $\varepsilon > 0$ there exist a finite sequence $t_{\varepsilon} = (t_1, \dots, t_{2k-1}, 0, \dots)$ such that

$$\|(c^* - r(q^*)) - t_{\varepsilon}\| = \|(c^* - t_{\varepsilon}) - r(q^*)\| < \varepsilon$$

Since Ψ is a local isomorphism, for some $\varepsilon > 0$ we have

$$(h^*; u^*; c^* - t_{\varepsilon}) = (h^*; u^*; (c_1^* - t_1, \dots, c_{2k-1}^* - t_{2k-1}, c_{2k+1}^*, c_{2k+3}^*, \dots)) \in \Psi(\mathbf{H}_+).$$

It means that $(h^*; u^*; c^* - t_{\varepsilon}) = \Psi(q_k)$ for some $q_k \in \mathbf{H}_+$. Using Lemma 4.4 step by step, we construct the sequence of potentials $q_j \in \mathbf{H}_+$ such that

$$q_{j-1} = (q_j)_{2j-1}^{t_{2j-1}}, \quad j = k, k-1, \dots, 1,$$

$$\Psi(q_j) = \left(h^*; u^*; (c_1^* - t_1, \dots, c_{2j-1}^* - t_{2j-1}, c_{2j+1}^*, c_{2j+3}^*, \dots)\right).$$

$$h^*: u^*: c^*$$

Then, $\Psi(q_0) = (h^*; u^*; c^*)$.

5 Perturbed oscillator on \mathbb{R}_+ , general case

In this Section we consider the family of self-adjoint operators $\{T_b\}_{b\in\mathbb{R}}$ given by

$$T_b y = -y'' + x^2 y + q(x)y, \quad y'(0) = by(0), \quad q \in \mathbf{H}_+.$$

We begin with asymptotics of spectral data. Recall that

$$w_N(\lambda, q, b) = \psi'_+(0, \lambda, q) - b\psi_+(0, \lambda, q), \quad \lambda \in \mathbb{C}.$$

Due to standard estimates of ψ_+ , ψ'_+ (see Lemma A.2 and asymptotics (A.7)), we have

$$w_N(\lambda, q, b) = (\psi^0_+)'(0, \lambda) \cdot (1 + O(|\lambda|^{-1/2})), \quad |\lambda| = \lambda^0_{2k+1}, \quad k \to \infty.$$

Repeating arguments of Lemma 4.2 [CKK1] and using Rouché's Theorem, we obtain

$$\lambda_{2n}(q,b) = \lambda_{2n}^0 + \mu_{2n}(q,b), \quad \mu_{2n}(q,b) = O(n^{-1/2}), \quad n \to \infty$$

uniformly on bounded subsets of $(q, b) \in \mathbf{H}_+ \times \mathbb{R}$.

We define the modified norming constant $\tilde{s}_{2n}(q, b)$ by

$$s_{2n}(q,b) = s_{2n}^0 + \alpha_{2n}\mu_{2n}(q,b) + \tilde{s}_{2n}(q,b), \quad n \ge 0,$$
(5.1)

where $s_{2n}^0 = s_{2n}(0,0)$ and $\alpha_{2n} = -\dot{\psi}_+^0/\psi_+^0(0,\lambda_{2n}^0)$.

Theorem 5.1. For each $(q; b) \in \mathbf{H}_+ \times \mathbb{R}$ and some absolute constant $\delta > 0$ the following asymptotics are fulfilled:

$$\mu_{2n}(q,b) = 2\hat{q}_{2n}^{+} + \frac{2E_n}{\sqrt{\pi}}b + \ell_{\frac{3}{4}+\delta}^2(n), \qquad \tilde{s}_{2n}(q) = \check{q}_{2n}^{+} + \frac{\pi E_n^2}{8}b^2 + \ell_{\frac{3}{4}+\delta}^2(n), \qquad (5.2)$$

uniformly on bounded subsets of $\mathbf{H}_+ \times \mathbb{R}$.

Remark. Recall that $E_n = 2^{-2n} (2n)! / (n!)^2 = \pi^{-\frac{1}{2}} n^{-\frac{1}{2}} (1 + O(n^{-1})), n \to \infty$.

Proof. Let $\lambda_{2n} = \lambda_{2n}(q, b)$ and $\mu_{2n} = \mu_{2n}(q, b)$. We use arguments similar to the proof of Theorem 3.1. Due to Corollary A.3, Lemma A.6 (i) and asymptotics (A.15), we have

$$\frac{\psi'_{+}(0,\lambda_{2n}^{0}+\mu_{2n},q)}{\dot{\kappa}'_{2n}} = -2\hat{q}_{2n}^{+}+\mu_{2n}+O(n^{-1}\log^{2}n), \quad \frac{\psi_{+}(0,\lambda_{2n}^{0}+\mu_{2n},q)}{\kappa_{2n}} = 1+O(n^{-\frac{1}{2}}\log n).$$

Since $(\psi'_{+}-b\psi_{+})(0,\lambda_{2n}^{0}+\mu_{2n},q)=0$ and $\kappa_{2n}=O((\lambda_{2n}^{0})^{-\frac{1}{2}}\dot{\kappa}'_{2n})$ (see (A.15)), we obtain

$$\mu_{2n} = 2\hat{q}_{2n}^{+} + \frac{\kappa_{2n}}{\kappa'_{2n}}b + O(n^{-1}\log^2 n) = 2\hat{q}_{2n}^{+} + \frac{2E_n}{\sqrt{\pi}}b + O(n^{-1}\log^2 n).$$
(5.3)

Let $\mu_{2n}^{(1)} = 2\hat{q}_{2n}^{+} + 2\pi^{-\frac{1}{2}}E_nb$. Using Lemma A.6 (i) again, we see that $\frac{\psi'_+(0,\lambda_{2n}^0 + \mu_{2n},q)}{\dot{\kappa}'_{2n}} = -2\hat{q}_{2n}^{+} + \mu_{2n} + 2\check{q}_{2n}^{+}\hat{q}_{2n}^{+} - \left(\frac{2\dot{\kappa}_{2n}}{\kappa_{2n}}\hat{q}_{2n}^{+} + \check{q}_{2n}^{+}\right)\cdot\mu_{2n}^{(1)} + \frac{\ddot{\kappa}'_{2n}}{2\dot{\kappa}'_{2n}}(\mu_{2n}^{(1)})^2 + \ell_{\frac{3}{4}+\delta}^2(n)$

and

$$\frac{\psi_+(0,\lambda_{2n}^0+\mu_{2n},q)}{\kappa_{2n}} = 1 - \check{q}_{2n}^+ + \frac{\dot{\kappa}_{2n}}{\kappa_{2n}} \mu_{2n}^{(1)} + O(n^{-1}\log^2 n) \,.$$

Substituting these asymptotics into the equation $(\psi'_+ - b\psi_+)(0, \lambda^0_{2n} + \mu_{2n}, q) = 0$, we obtain

$$\mu_{2n} = \mu_{2n}^{(1)} + \left(\frac{\dot{\kappa}_{2n}}{\kappa_{2n}} - \frac{\ddot{\kappa}_{2n}'}{2\dot{\kappa}_{2n}'}\right) \cdot (\mu_{2n}^{(1)})^2 + \ell_{\frac{3}{4}+\delta}^2(n) = \mu_{2n}^{(1)} + \ell_{\frac{3}{4}+\delta}^2(n) \,.$$

We come to the second part of (5.2). Due to Lemma A.6 (i), we have

$$e^{s_{2n}^0 - s_{2n}(q,b)} = \frac{\psi_+(0,\lambda_{2n},q)}{\kappa_{2n}} = 1 - \check{q}_{2n}^+ + \frac{\dot{\kappa}_{2n}}{\kappa_{2n}}\mu_{2n} + \frac{(\check{q}_{2n}^+)^2}{2} - \frac{\pi^2(\hat{q}_{2n}^+)^2}{8} + \left(-\frac{\dot{\kappa}_{2n}}{\kappa_{2n}}\check{q}_{2n}^+ + \frac{\pi^2}{8}\hat{q}_{2n}^+\right)\mu_{2n}^{(1)} + \frac{\ddot{\kappa}_{2n}}{2\kappa_{2n}}(\mu_{2n}^{(1)})^2 + \ell_{\frac{3}{4}+\delta}^2(n).$$

Therefore,

$$s_{2n}^{0} - s_{2n}(q,b) = -\check{q}_{2n}^{+} + \frac{\dot{\kappa}_{2n}}{\kappa_{2n}}\mu_{2n} - \frac{\pi^{2}}{8}\left(\hat{q}_{2n}^{+} - \frac{\mu_{2n}^{(1)}}{2}\right)^{2} + \left(\frac{\ddot{\kappa}_{2n}}{\kappa_{2n}} - \frac{\dot{\kappa}_{2n}^{2}}{\kappa_{2n}^{2}} + \frac{\pi^{2}}{16}\right)\frac{(\mu_{2n}^{(1)})^{2}}{2} + \ell_{\frac{3}{4}+\delta}^{2}(n) + \ell_{2n}^{2}(n) + \ell_{$$

This asymptotic is equivalent to (5.2) due to definition (5.1) of $\tilde{s}_{2n}(q, b)$.

Lemma 5.2. Let $(q, b) \in \mathbf{H}_+ \times \mathbb{R}$. Then the following identity is fulfilled:

$$\sum_{n \ge 0} (\mu_{2n}(q, b) - 2\hat{q}_{2n}^+ - 2\pi^{-1/2}E_n b) = -\frac{b^2}{2}.$$

Remark. This formula generalizes the first identity in (3.8).

Proof. We put q(-x) = q(x), $x \ge 0$, and consider the following symmetric potential on \mathbb{R} :

$$q_{\delta}(x) = q(x) + 2b \cdot \delta(x) \,.$$

Then (formally) we have $\lambda_{2n}(q_{\delta}) = \lambda_{2n}(q, b)$. Note that

$$(q_{\delta})_{2n}^{\wedge} = 2\hat{q}_{2n}^{+} + (\psi_{2n}^{0})^{2}(0) \cdot 2b = 2\hat{q}_{2n}^{+} + 2\pi^{-1/2}E_{n} \cdot b.$$

The right-hand side coincides with the main (linear with respect to q, b) term in the first asymptotics (5.2). Repeating the proof of (3.8) (and Lemma A.7), we obtain

$$\begin{split} \sum_{n \geqslant 0} (\mu_{2n}(q, b) - 2\hat{q}_{2n}^+ - 2\pi^{-1/2}E_n b) &= 2\int_0^1 ds \int_0^s \sum_{n \geqslant 0} \sum_{m:m \neq n} \frac{(q_\delta, (\psi_{2n}\psi_{2m})(\cdot, tq_\delta))_{L^2(\mathbb{R})}^2}{\lambda_{2n}(tq_\delta) - \lambda_{2m}(tq_\delta)} \, dt \\ &= 8b^2 \int_0^1 ds \int_0^s \sum_{n \geqslant 0} \sum_{m:m \neq n} \frac{(\psi_{2n}\psi_{2m})^2(0, tq_\delta)}{\lambda_{2n}(tq_\delta) - \lambda_{2m}(tq_\delta)} \, dt \, . \end{split}$$

Since $(\psi_{2n}^0)^2(0) = \pi^{-1/2} E_n = \pi^{-1}(n+1)^{-1/2} + O(n^{-3/2})$, we have

$$\frac{(\psi_{2n}\psi_{2m})^2(0,tq_{\delta})}{\lambda_{2n}(tq_{\delta}) - \lambda_{2m}(tq_{\delta})} = \frac{(n+1)^{-\frac{1}{2}}(m+1)^{-\frac{1}{2}} + O(n^{-\frac{1}{2}}m^{-1} + n^{-1}m^{-\frac{1}{2}})}{4\pi^2(n-m)}$$

uniformly with respect to $t \in [0,1]$. Note that the double sum $\sum_{n \ge 0} \sum_{m:m \ne n} \frac{O(...)}{4(n-m)}$ is absolutely convergent and so is equal to 0. Hence,

$$\sum_{n \ge 0} (\mu_{2n}(q,b) - 2\hat{q}_{2n}^+ - 2\pi^{-1/2}E_nb) = \frac{b^2}{\pi^2} \lim_{k \to \infty} \sum_{n=0}^k \sum_{m=0, m \ne n}^{+\infty} \frac{(n+1)^{-\frac{1}{2}}(m+1)^{-\frac{1}{2}}}{n-m}$$

$$= \frac{b^2}{\pi^2} \lim_{k \to \infty} \frac{1}{k^2} \sum_{n=0}^k \sum_{m=k+1}^{+\infty} \frac{1}{\sqrt{\frac{n+1}{k} \cdot \frac{m+1}{k}} \left(\frac{n+1}{k} - \frac{m+1}{k}\right)} = \frac{b^2}{\pi^2} \int_0^1 dx \int_1^{+\infty} \frac{dy}{\sqrt{xy} \left(x - y\right)} \\ = \frac{4b^2}{\pi^2} \int_0^1 dx \int_1^{+\infty} \frac{dy}{x^2 - y^2} = -\frac{2b^2}{\pi^2} \int_0^1 \log \frac{1+x}{1-x} \frac{dx}{x} = -\frac{4b^2}{\pi^2} \sum_{s=0}^{+\infty} \frac{1}{(2s+1)^2} = -\frac{b^2}{2},$$

since $\log \frac{1+x}{1-x} = 2 \sum_{s=0}^{+\infty} \frac{x^{2s+1}}{2s+1}$, $x \in (0,1]$ and $\sum_{s=0}^{+\infty} (2s+1)^{-2} = \frac{3}{4} \sum_{s=0}^{+\infty} s^{-2} = \frac{3}{4} \cdot \frac{\pi^2}{6} = \frac{\pi^2}{8}$.

Proof of Theorem 2.5. Define the meromorphic function

$$f(\lambda) = \frac{\psi_+(0,\lambda,q)}{w_N(\lambda,q,b)} = \frac{\psi_+(0,\lambda,q,b)}{\psi'_+(0,\lambda,q) - b\psi_+(0,\lambda,q)}, \qquad \lambda \in \mathbb{C}.$$

By definition (2.8) of $s_{2n}(q, b)$, we have

$$\operatorname{res}_{\lambda=\lambda_{2n}(q,b)} f(\lambda) = \frac{\psi_+(0,\lambda_{2n}(q,b),q)}{\dot{w}_N(\lambda_{2n}(q,b),q,b)} = \frac{(-1)^n e^{-s_{2n}(q,b)}}{\dot{w}_N(\lambda_{2n}(q,b),q,b)}$$

Note that

$$f_0(\lambda) = \frac{\psi_+^0(0,\lambda)}{(\psi_+^0)'(0,\lambda)} = \frac{1}{2} \cot \frac{(\lambda-1)\pi}{4} \cdot \frac{\Gamma(\frac{1}{4}(\lambda+1))}{\Gamma(\frac{1}{4}(\lambda+3))}, \qquad \underset{\lambda=\lambda_{2n}^0}{\operatorname{res}} f_0(\lambda) = 2\pi^{-1/2}E_n$$

Put $|\lambda| = 2k \to \infty$. Then, due to (A.7), we have $C_1 k^{-\frac{1}{2}} \leq |f_0(\lambda)| \leq C_2 k^{-\frac{1}{2}}$ for some absolute constants $C_1, C_2 > 0$. Lemma A.2 gives

$$\frac{\psi_+(0,\lambda,q)}{\psi_+^0(0,\lambda)} = 1 + \frac{\psi_+^{(1)}(0,\lambda,q)}{\psi_+^0(0,\lambda)} + O(k^{-1})\,, \quad \frac{\psi_+'(0,\lambda,q)}{(\psi_+^0)'(0,\lambda)} = 1 + \frac{(\psi_+^{(1)})'(0,\lambda,q)}{(\psi_+^0)'(0,\lambda)} + O(k^{-1})$$

Note that (A.4) implies $\psi_+^{(1)}(0) = \int_0^{+\infty} (\psi_+^0 \varphi^0)(t)q(t)dt$ and $(\psi_+^{(1)})'(0) = -\int_0^{+\infty} (\psi_+^0 \vartheta^0)(t)q(t)dt$, where we omit λ and q for short. Since $\psi_+^0(t) = \psi_+^0(0)\vartheta^0(t) + (\psi_+^0)'(0)\varphi^0(t)$, we have

$$\frac{f(\lambda)}{f_0(\lambda)} = \frac{1 + \frac{\psi_+^{(1)}}{\psi_+^0}(0) + O(k^{-1})}{1 + \frac{(\psi_+^{(1)})'}{(\psi_+^0)'}(0) - bf_0(\lambda) + O(k^{-1})} = 1 + bf_0(\lambda) + \frac{\int_0^{+\infty} (\psi_+^0)^2(t,\lambda)q(t)dt}{\psi_+^0(0)(\psi_+^0)'(0)} + O(k^{-1}).$$

Therefore,

$$f(\lambda) = f_0(\lambda) + b \cdot (f_0(\lambda))^2 + h(\lambda, q) + O(k^{-\frac{3}{2}}), \quad \text{where} \quad h(\lambda, q) = \frac{\int_0^{+\infty} (\psi_+^0)^2(t, \lambda)q(t)dt}{((\psi_+^0)')^2(0, \lambda)}.$$

Applying the Cauchy Theorem in the disc $|\lambda| \leq 2k$ to this function and passing to the limit as $k \to \infty$, we obtain

$$\sum_{n \ge 0} \left(\frac{(-1)^n e^{-s_{2n}(q,b)}}{\dot{w}_N(\lambda_{2n}(q,b),q,b)} - 2\pi^{-1/2} E_n \right) = b \cdot \sum_{n \ge 0} \operatorname{res}_{\lambda = \lambda_{2n}^0} (f_0(\lambda))^2 + \sum_{n \ge 0} \operatorname{res}_{\lambda = \lambda_{2n}^0} h(\lambda) \,. \tag{5.4}$$

Note that

$$\operatorname{res}_{\lambda=\lambda_{2n}^0}(f_0(\lambda))^2 = -\frac{\ddot{g}_0(\lambda_{2n}^0)}{(\dot{g}_0(\lambda_{2n}^0))^3}, \quad \text{where} \quad g_0(\lambda) = \frac{1}{f_0(\lambda)} = \frac{(\psi_+^0)'}{\psi_+^0}(\lambda), \quad \lambda \in \mathbb{C}.$$

On the other hand, the identity $g_0(\lambda_{2n}^0 + \mu_{2n}(0,\beta)) = \beta$ gives

$$\frac{d\mu_{2n}(0,\beta)}{d\beta}\Big|_{\beta=0} = \frac{1}{\dot{g}_0(\lambda_{2n}^0)}, \qquad \frac{d^2\mu_{2n}(0,\beta)}{d\beta^2}\Big|_{\beta=0} = -\frac{\ddot{g}_0(\lambda_{2n}^0)}{(\dot{g}_0(\lambda_{2n}^0))^3} = \operatorname{res}_{\lambda=\lambda_{2n}^0}(f_0(\lambda))^2.$$

Due to Lemma 5.2, we have

$$\sum_{n \ge 0} \operatorname{res}_{\lambda = \lambda_{2n}^0} (f_0(\lambda))^2 = \sum_{n \ge 0} \frac{d^2 \mu_{2n}(0,\beta)}{d\beta^2} \Big|_{\beta = 0} = -1.$$
(5.5)

Furthermore,

$$\sum_{n \ge 0} \operatorname{res}_{\lambda = \lambda_{2n}^0} h(\lambda) = \frac{1}{2\pi i} \lim_{k \to \infty} \oint_{|\lambda| = 2k} h(\lambda) d\lambda = \frac{1}{2\pi i} \lim_{k \to \infty} \oint_{|\lambda| = 2k} \frac{\int_0^{+\infty} (\psi_+^0)^2(t, \lambda) q(t) dt}{((\psi_+^0)')^2(0, \lambda)} d\lambda.$$

Using Lemma A.2, asymptotics (A.7) and the estimate $\rho(t, \lambda) \ge \rho(t, |\lambda|)$, we obtain

$$\left|\oint_{|\lambda|=2k} h(\lambda)d\lambda\right| \leqslant \int_{0}^{+\infty} |q(t)|R_{k}(t)dt, \qquad R_{k}(t) = \frac{C}{k^{\frac{1}{2}}\rho^{2}(t,2k)} \cdot \oint_{|\lambda|=2k} e^{-2\sigma(t,\lambda)} |d\lambda|,$$

where C > 0 is some absolute constant. Since $\sigma(t, \lambda) \ge 0$, we have $R_k(t) = O(k^{\frac{1}{2}}/\rho^2(t, 2k))$ uniformly with respect to t and k. Therefore, (A.11) yields the following estimate, which is uniform with respect to k:

$$\int_0^{+\infty} |q(t)| R_k(t) dt = O(k^{1/2}) \cdot \int_0^{+\infty} \frac{|q(t)| dt}{\rho^2(t, 2k)} = O(k^{1/2}) \cdot \beta(q, 2k) = O(||q||_{\mathbf{H}_+}).$$

On the other hand, due to definitions (A.5), for any fixed t > 0 we have

$$R_k(t) = O(1) \cdot \int_0^{2\pi} e^{-2\sigma(t,2ke^{i\phi})} d\phi \to 0, \qquad k \to \infty,$$

since $e^{-2\sigma(t,2ke^{i\phi})} \leq 1$ and $\sigma(t,2ke^{i\phi}) \rightarrow +\infty$ as $k \rightarrow \infty$ for any $\phi \in (0,2\pi)$. Hence,

$$\int_0^{+\infty} |q(t)| R_k(t) dt \to 0, \qquad k \to +\infty$$

This follows

$$\sum_{n \ge 0} \operatorname{res}_{\lambda = \lambda_{2n}^0} h(\lambda) = 0.$$
(5.6)

Substituting (5.5) and (5.6) into (5.4), we obtain (2.10).

Proof of Theorem 2.4 (i). Note that Theorem 5.1 gives $\tilde{s}_{2n}(q) = \check{q}_{2n}^+ + \frac{1}{8}\pi E_n^2 b^2 + \ell_{\frac{3}{4}+\delta}^2(n)$. Arguing in the same way as in the proof of Theorem 2.3 (i), we obtain

$$\sum_{n \ge 0} \check{q}_{2n}^+ z^n \equiv P_+ \left[\frac{(G_N q)(\zeta)}{\sqrt{1 - \overline{\zeta}}} \right] \equiv -\frac{\pi}{2} P_+ \left[\frac{(F_D q)(\zeta)}{\sqrt{1 - \overline{\zeta}}} \right] \equiv -\frac{\pi}{2} P_+ \left[\sqrt{-\zeta} \sum_{m \ge 0} \hat{q}_{2m+1}^+ \zeta^m \right].$$

Recall that $({\scriptscriptstyle \bigtriangleup} Hq)(z)\!\equiv\!\sum_{m\geqslant 0}(\hat{q}_{2m}^+\!-\!\hat{q}_{2m+1}^+)z^m$. Then,

$$\sum_{n\geqslant 0} \check{q}_{2n}^+ z^n \equiv -\frac{\pi}{2} P_+ \left[\sqrt{-\zeta} \sum_{m\geqslant 0} \hat{q}_{2m}^+ \zeta^m \right] + \frac{\pi}{2} P_+ \left[\sqrt{-\zeta} \cdot (\triangle Hq)(\zeta) \right], \tag{5.7}$$

Due to Theorem 5.1, we have

$$\sum_{m \ge 0} \hat{q}_{2m}^+ z^m \equiv \frac{1}{2} \sum_{m \ge 0} \mu_{2m}(q, b) z^m + \frac{b}{\pi^{1/2}} \sum_{m \ge 0} E_m z^m + \omega(z) \,, \quad \omega \in H^2_{\frac{3}{4} + \delta} \,.$$

Note that Lemma 5.2 yields $\omega(1) = \frac{1}{4}b^2$. Since $\sum_{m \ge 0} E_m z^m \equiv (1-z)^{-1/2}$, we have

$$\sum_{m \ge 0} \hat{q}_{2m}^+ z^m \equiv \frac{1}{2} \sum_{m \ge 0} \mu_{2m}(q, b) z^m + \frac{\pi^{-1/2} b}{\sqrt{1-z}} + \frac{b^2}{4} + \omega_1(z) \,, \quad \omega_1 \in \mathring{H}_{\frac{3}{4} + \delta}^2 \,.$$

Due to the identity $P_+[\sqrt{-\zeta}/\sqrt{1-\zeta}] \equiv P_+[1/\sqrt{1-\zeta}] \equiv 1$, we obtain

$$-\frac{\pi}{2}P_{+}\left[\sqrt{-\zeta}\sum_{m\geq 0}\hat{q}_{2m}^{+}\zeta^{m}\right] \equiv -\frac{\pi}{4}P_{+}\left[\sqrt{-\zeta}\sum_{m\geq 0}\mu_{2m}(q,b)\zeta^{m}\right] + \frac{\pi^{1/2}b}{2} - \frac{\pi b^{2}}{8}P_{+}\left[\sqrt{-\zeta}\right] + \omega_{2}(z),$$
(5.8)

where $\omega_2(z) \equiv -\frac{\pi}{2} P_+[\sqrt{-\zeta}\omega_1(\zeta)] \in H^2_{\frac{3}{4}+\delta}$.

We consider the second term in (5.7). Recall that $(\triangle Hq)(1) = \frac{1}{4}q(0)$ and

$$\frac{\pi}{2} P_+ \left[\frac{(\triangle Hq)(\zeta) - (\triangle Hq)(1)}{\sqrt{-\zeta}} \right] \equiv (\widetilde{H}q)(z) \equiv \sum_{n \ge 0} \widetilde{q}_n^+ z^n \in H^2_{3/4}$$

Since $1/\sqrt{-\zeta} = \sqrt{1-\overline{\zeta}}/\sqrt{1-\zeta}$, $\zeta \neq 1$, we have

$$(\triangle Hq)(z) - (\triangle Hq)(1) \equiv \frac{2}{\pi}\sqrt{1-z} P_+ \left[\frac{(Hq)(\zeta)}{\sqrt{1-\overline{\zeta}}}\right]$$

Using the identity $zP_+[f(\zeta)](z) \equiv P_+[\zeta f(\zeta)](z) - P_+[\zeta f(\zeta)](0)$, we obtain

$$\frac{\pi}{2}P_{+}\left[\sqrt{-\zeta}\cdot\left((\triangle Hq)(\zeta)-(\triangle Hq)(1)\right)\right] \equiv P_{+}\left[\frac{1-\zeta}{\sqrt{1-\overline{\zeta}}}P_{+}\left[\frac{(\widetilde{H}q)(\zeta)}{\sqrt{1-\overline{\zeta}}}\right]\right]$$
$$\equiv P_{+}\left[\frac{1}{\sqrt{1-\overline{\zeta}}}\left(P_{+}\left[\frac{(1-\zeta)(\widetilde{H}q)(\zeta)}{\sqrt{1-\overline{\zeta}}}\right]+P_{+}\left[\frac{\zeta(\widetilde{H}q)(\zeta)}{\sqrt{1-\overline{\zeta}}}\right](0)\right)\right]$$
$$\equiv P_{+}\left[\frac{(1-\zeta)(\widetilde{H}q)(\zeta)}{1-\overline{\zeta}}\right]+\sum_{k\geqslant 0}E_{k+1}\widetilde{q}_{k}^{+}\equiv -\sum_{n\geqslant 1}\widetilde{q}_{n-1}^{+}z^{n}+\sum_{k\geqslant 0}E_{k+1}\widetilde{q}_{k}^{+}.$$
(5.9)

Substituting (5.8) and (5.9) into (5.7), we get

$$\sum_{n \ge 0} \check{q}_{2n}^+ z^n \equiv -\frac{\pi}{4} P_+ \left[\sqrt{-\zeta} \sum_{n \ge 0} \mu_{2n}(q, b) \zeta^n \right] + \frac{\pi(q(0) - b^2)}{8} P_+ \left[\sqrt{-\zeta} \right] - \sum_{n \ge 0} \check{q}_{n-1}^+ z^n + \omega_2(z) \,,$$

where

$$\tilde{q}_{-1}^{+} = -\sum_{k \ge 0} E_{k+1} \tilde{q}_{k}^{+} - \frac{\pi^{1/2} b}{2}.$$
(5.10)

Using Theorem 5.1 and the identity $\sqrt{-\zeta} = -\frac{2}{\pi} \sum_{l=-\infty}^{+\infty} \zeta^l / (2l-1)$, we obtain

$$\widetilde{s}_{2n}(q) = \breve{q}_{2n}^{+} + \frac{\pi E_n^2}{8} b^2 + \ell_{\frac{3}{4}+\delta}^2(n) = \frac{1}{2} \sum_{m \ge 0} \frac{\mu_{2m}(q,b)}{2(n-m)-1} - \frac{q(0)-2b^2}{4(2n-1)} + r_{2n}(q,b),$$

$$r_{2n}(q,b) = -\widetilde{q}_{n-1}^{+} + \ell_{\frac{3}{2}+\delta}^2(n).$$
(5.11)

$$r_{2n}(q,b) = -q_{n-1} + \ell_{\frac{3}{4}+\delta}(n).$$
(5.1)

In particular, $\{r_{2n}(q,b)\}_{n=0}^{\infty} \in \ell_{3/4}^2$, since $\{\widetilde{q}_{n-1}^+\}_{n=0}^{\infty} \in \ell_{3/4}^2$.

Proof of Theorem 2.4 (ii). As in the proof of Theorem 2.3, we prove that the mapping Φ is 1) injective; 2) analytic; 3) local isomorphism and 4) surjective, where

$$\Phi: (q;b) \mapsto \left(\{\mu_{2n}(q,b)\}_{n=0}^{\infty}; q(0) - 2b^2; \{r_{2n}(q,b)\}_{n=0}^{\infty} \right), \qquad \mathbf{H}_+ \times \mathbb{R} \to \mathcal{S}_N \times \mathbb{R} \times \ell_{3/4}^2.$$

1. Uniqueness Theorem. Suppose that

$$\left(\{\mu_{2n}(p,a)\}_{n=0}^{\infty}, p(0)-2a^2, \{r_{2n}(p,a)\}_{n=0}^{\infty}\right) = \left(\{\mu_{2n}(q,b)\}_{n=0}^{\infty}, q(0)-2b^2, \{r_{2n}(q,b)\}_{n=0}^{\infty}\right)$$

for some potentials $p, q \in \mathbf{H}_+$ and some real constants $a, b \in \mathbb{R}$. It follows

$$\lambda_{2n}(p) = \lambda_{2n}(q), \quad s_{2n}(p) = s_{2n}(q), \quad n \ge 0.$$

Theorem 2.5 yields a = b. The rest of the proof repeats the proof of Theorem 2.3 with the function $\vartheta(x, \lambda, q) - b\varphi(x, \lambda, q)$ instead of $\varphi(x, \lambda, q)$.

2. Analyticity of Φ . Arguments, similar to the proof of (4.9), follow that the mappings

$$q \mapsto (F_N q; \triangle H q) \mapsto \left(\{ \hat{q}_{2n}^+ \}_{n=0}^\infty; q(0); \{ \widetilde{q}_n^+ \}_{n=0}^\infty \right) ,$$

$$\mathbf{H}_+ \leftrightarrow H^2_{3/4} \times H^2_{3/4} \leftrightarrow \mathcal{H} \times \mathbb{R} \times \ell^2_{3/4} ,$$

are linear isomorphisms. Also, it is clear that the mapping

$$\left(\{\hat{q}_{2n}^+\}_{n=0}^{\infty}; b\right) \mapsto \left(\{2\hat{q}_{2n}^+ + 2\pi^{-\frac{1}{2}}E_nb\}_{n=0}^{\infty}; b\right)$$

is a linear isomorphism between $\mathcal{H} \times \mathbb{R}$ and $\mathcal{H} \times \mathbb{R}$. Furthermore, since \tilde{q}_{-1}^+ is a linear combination of \tilde{q}_n^+ , $n \ge 0$, and b (see (5.10)), the mapping

$$\left(b; \{\widetilde{q}_n^+\}_{n=0}^\infty\right) \mapsto \{\widetilde{q}_{n-1}^+\}_{n=0}^{+\infty}$$

is a linear isomorphism between $\mathbb{R} \times \ell_{3/4}^2$ and $\ell_{3/4}^2$. Combining these isomorphisms, we obtain that the linear operator

$$\Phi_0: (q;b) \mapsto \left(\{ 2\hat{q}_{2n}^+ + 2\pi^{-\frac{1}{2}} E_n b \}_{n=0}^\infty; q(0); \{ \tilde{q}_{n-1}^+ \}_{n=0}^\infty \right), \quad \Phi_0: \mathbf{H}_+ \times \mathbb{R} \leftrightarrow \mathcal{H} \times \mathbb{R} \times \ell_{3/4}^2$$

and its inverse are bounded. Recall that Theorem 5.1 gives

$$\mu_{2n}(q,b) = 2\hat{q}_{2n}^+ + 2\pi^{-1/2}E_nb + \ell_{\frac{3}{4}+\delta}^2(n), \qquad r_{2n}(q) = -\tilde{q}_{n-1}^+ + \ell_{\frac{3}{4}+\delta}^2(n).$$

In other words, if we put $\Phi = \Phi_0 + \Phi_1$, then Φ_1 maps $\mathbf{H}_+ \times \mathbb{R}$ into the space $\ell_{\frac{3}{4}+\delta}^2 \times \mathbb{R} \times \ell_{\frac{3}{4}+\delta}^2$. Moreover, Φ_1 is locally bounded. Using Lemma A.4 by the same way as in Sect. 4, we obtain that Φ_1 is analytic and hence Φ is analytic too.

3. Local Isomorphism. The proof is similar to the case of Dirichlet boundary condition in Sect. 4. Due to Lemma A.4, the following identities are fulfilled:

$$\frac{\partial \mu_{2n}(q,b)}{\partial q(t)} = \psi_{2n}^2(t,q,b), \qquad \frac{\partial s_{2n}(q)}{\partial q(t)} = (\psi_{2n}\chi_{2n})(t,q,b), \qquad (5.12)$$

where $\psi_{2n}(\cdot, q, b)$ is *n*-th normalized eigenfunction of T_b and $\chi_{2n}(\cdot, q, b)$ is some special solution of Eq. (2.4) for $\lambda = \lambda_{2n}(q, b)$ such that $\{\chi_{2n+1}, \psi_{2n+1}\} = 1$. In particular, $(\psi_{2n}\chi_{2n})' \in \mathbf{H}_+$. Also,

$$\frac{\partial \mu_{2n}(q,b)}{\partial b} = \psi_{2n}^2(0,q,b), \qquad \frac{\partial s_{2n}(q)}{\partial b} = (\psi_{2n}\chi_{2n})(0,q,b).$$
(5.13)

Note that for each $q \in \mathbf{H}_+$, $b \in \mathbb{R}$, the Fréchet derivative

$$d_{(q;b)}\Phi = \Phi_0 + d_{(q;b)}\Phi_1 : \mathbf{H}_+ \times \mathbb{R} \to \mathcal{H} \times \mathbb{R} \times \ell^2_{3/4}$$

is a Fredholm operator since Φ_0^{-1} is bounded and $d_{(q;b)}\Phi_1$ maps $\mathbf{H}_+ \times \mathbb{R}$ into $\ell_{\frac{3}{4}+\delta}^2 \times \mathbb{R} \times \ell_{\frac{3}{4}+\delta}^2$ and so is compact as an operator from \mathbf{H}_+ to $\ell_{\frac{3}{4}}^2 \times \mathbb{R} \times \ell_{\frac{3}{4}}^2$. Hence, it is sufficient to show that

$$\mathcal{H} \times \mathbb{R} \times \ell_{3/4}^2 = \overline{\operatorname{Ran} d_{(q;b)} \Psi} \,. \tag{5.14}$$

Using (5.12), (5.13) and Lemma A.5 (ii), we get

$$\left(2(\psi_{2n}^2)'(q,b), \frac{\partial \mu_{2n}(q,b)}{\partial q} \right)_+ + \psi_{2n}^2(0,q,b) \frac{\partial \mu_{2n}(q,b)}{\partial b} = 0,$$
$$\left(2(\psi_{2n}^2)'(q,b), \frac{\partial s_{2n}(q,b)}{\partial q} \right)_+ + \psi_{2n}^2(0,q,b) \frac{\partial s_{2n}(q,b)}{\partial b} = \delta_{nm},$$

Moreover, note that

$$(d_{(q;b)}(q(0)-2b^2))(2(\psi_{2n}^2)'(q,b);\psi_{2n}^2(0,q,b)) = 2(\psi_{2n}^2)'(0,q,b) - 4b\psi_{2n}^2(0,q,b) = 0,$$

since $\psi_{2n}'(0,q,b))\!=\!b\psi_{2n}(0,q,b)$. Hence, definition (2.9) gives

$$(d_{(q;b)}\Phi)\left(2(\psi_{2n}^2)'(\cdot,q,b);\psi_{2n}^2(0,q,b)\right) = (\mathbf{0};0;\mathbf{e}_n) \ .$$

Therefore,

$$\{(\mathbf{0}; 0)\} \times \ell_{3/4}^2 \subset \overline{\operatorname{Ran} d_{(q;b)}\Phi}.$$

We consider the lowest eigenvalue $\lambda_1(q)$ of the operator T_D (with the same potential q) and the function

$$\xi(t) = ((\vartheta - b\varphi)\varphi)'(t, \lambda_1(q), q) \,.$$

Note that $\xi(0)\!=\!1\,,\,\xi\!\in\!\mathbf{H}_+$ and $(\xi,\psi_{2m}^2(q))_+\!=\!0\,.$ Hence,

$$(d_{(q;b)}\Phi)(\xi;0) = (\mathbf{0};1;(d_{(q;b)}r)(\xi;0))$$
.

This implies

$$\{\mathbf{0}\} \times \mathbb{R} \times \ell^2_{3/4} \subset \overline{\operatorname{Ran} d_{(q;b)}\Phi}.$$

Furthermore, using Lemma A.5 (ii) again, we obtain

$$(d_{(q;b)}\Phi)\left(-2(\psi_{2m}\chi_{2m})';-(\psi_{2m}\chi_{2m})(0)\right) = \left(\mathbf{e}_m;2;(d_{(q;b)}r)(-2(\psi_{2m}\chi_{2m})';-(\psi_{2m}\chi_{2m})(0))\right)$$

Since the set of finite sequences is dense in \mathcal{H}_0 , it yields

$$\mathcal{H}_0 \times \mathbb{R} \times \ell^2_{3/4} \subset \overline{\operatorname{Ran} d_{(q,b)} \Phi}.$$

In conclusion, we consider an arbitrary function $\zeta \in \mathbf{H}_+$ such that $\int_{\mathbb{R}_+} \zeta(t) dt \neq 0$. Due to asymptotics (2.7), we have

$$(d_{(q,b)}\Phi)(\zeta;0) \notin \mathcal{H}_0 \times \mathbb{R} \times \ell^2_{3/4}$$

Hence, (5.14) holds true since the codimension of \mathcal{H}_0 in \mathcal{H} is equal to 1.

4. Φ is surjective. The following Lemma is an analogue of Lemma 4.4: Lemma 5.3. Let $q \in \mathbf{H}_+$, $b \in \mathbb{R}$, $n \ge 0$ and $t \in \mathbb{R}$. Denote

$$q_{2n}^t(x) = q(x) - 2\frac{d^2}{dx^2}\log\eta_{2n}^t(x,q,b)\,, \qquad b_{2n}^t = b + (1-e^{-t})\,\psi_{2n}^2(0,q,b)\,,$$

where

$$\eta_{2n}^t(x,q,b) = 1 + (e^t - 1) \int_x^{+\infty} \psi_{2n}^2(s,q,b) ds$$

Then $q_{2n}^t \in \mathbf{H}$ and

$$\lambda_{2m}(q_{2n}^t, b_{2n}^t) = \lambda_{2m}(q, b), \qquad s_{2m}(q_{2n}^t, b_{2n}^t) = s_{2m}(q, b) + t\delta_{nm}$$

for all $m \ge 0$. Moreover, $q_{2n}^t(0) - 2(b_{2n}^t)^2 = q(0) - 2b^2$. Remark. In this case definition (2.9) yields $r_{2m}(q_{2n}^t, b_{2n}^t) = r_{2m}(q, b) + t\delta_{nm}$. *Proof.* The crucial point is the changing of b, i.e. the changing of the boundary condition. It is known (see [PT], [MT], [CKK2]) that for each $m \ge 0$ the function

$$\widetilde{\psi}_{2m}(x) = \psi_{2n}(x,q,b) - (e^t - 1) \frac{\psi_{2n}(x,q,b)}{\eta_{2n}^t(x,q,b)} \int_x^{+\infty} \psi_{2n}(s,q,b) \psi_{2m}(s,q,b) ds$$

is a solution of the equation $-\psi'' + x^2\psi + q_{2n}^t(x)\psi = \lambda_{2m}(q,b)\psi$. Direct calculations show that the identities $\tilde{\psi}'_{2m}(0) = b_{2n}^t \tilde{\psi}_{2m}(x)$ holds true for all $m \ge 0$. Hence, $\lambda_{2m}(q_{2n}^t, b_{2n}^t) = \lambda_{2m}(q,b)$. The other equalities are similar to Lemma 4.4.

The rest of the proof is the same as in Sect. 4. We consider an arbitrary spectral data $(h^*; u^*; c^*) \in \mathcal{S}_D \times \mathbb{R} \times \ell^2_{3/4}$. Due to Theorem 2.2, there exists potential $q^* \in \mathbf{H}_+$ such that

$$\mu_{2n}(q^*) = \mu_{2n}(q^*, 0) = h_n^*, \quad n \ge 0, \qquad q^*(0) = u^*.$$

Since Φ is a local isomorphism and the set of finite sequences is dense in \mathcal{H}_0 , there exists a finite number of values t_0, t_2, \ldots, t_{2k} such that

$$\left(h^*; u^*; (c_0^* - t_0, \dots, c_{2k}^* - t_{2k}, c_{2k+2}^*, c_{2k+4}^*, \dots)\right) = \Phi(q_{k+1}; b_{k+1}) \in \Phi(\mathbf{H}_+ \times \mathbb{R}).$$

Using Lemma 5.3 k+1 times step by step, we obtain potential $q_0 \in \mathbf{H}_+$ and constant $b_0 \in \mathbb{R}$, such that $\Psi(q_0; b_0) = (h^*; u^*; c^*)$. The proof is finished.

A Appendix

Here we collect some technical results from [CKK2], [CKK1] which are essentially used above. A.1 The unperturbed equation. It is well-known that for each $\lambda \in \mathbb{C}$ the equation

$$-\psi'' + x^2\psi = \lambda\psi. \tag{A.1}$$

has the solution $\psi^0_+(x,\lambda) = D_{\frac{\lambda-1}{2}}(\sqrt{2}x)$, where $D_\mu(x)$ is the Weber function (or the parabolic cylinder function, see [B]). Moreover, for each x the functions $\psi^0_+(x,\cdot)$ and $(\psi^0_+)'(x,\cdot)$ are entire and the following asymptotics are fulfilled:

$$\psi_{+}^{0}(x,\lambda) = (\sqrt{2}x)^{\frac{\lambda-1}{2}} e^{-\frac{x^{2}}{2}} \left(1 + O(x^{-2})\right), \quad x \to +\infty,$$

$$(\psi_{+}^{0})'(x,\lambda) = -\frac{1}{\sqrt{2}} (\sqrt{2}x)^{\frac{\lambda+1}{2}} e^{-\frac{x^{2}}{2}} \left(1 + O(x^{-2})\right), \quad x \to +\infty,$$

(A.2)

uniformly with respect to λ on bounded domains. Note that (see [B])

$$\psi_{+}^{0}(0,\lambda) = D_{\frac{\lambda-1}{2}}(0) = 2^{\frac{\lambda-1}{4}} \Gamma(\frac{1}{2}) \Gamma(\frac{3-\lambda}{4}) = \cos\frac{(\lambda-1)\pi}{4} \cdot \frac{2^{\frac{\lambda-1}{4}}}{\sqrt{\pi}} \Gamma(\frac{\lambda+1}{4}),$$

$$(\psi_{+}^{0})'(0,\lambda) = \sqrt{2} D'_{\frac{\lambda-1}{2}}(0) = 2^{\frac{\lambda-1}{4}} \Gamma(-\frac{1}{2}) \Gamma(\frac{1-\lambda}{4}) = \sin\frac{(\lambda-1)\pi}{4} \cdot \frac{2^{\frac{\lambda+3}{4}}}{\sqrt{\pi}} \Gamma(\frac{\lambda+3}{4}).$$
(A.3)

Let $J^0(x,t;\lambda)$ be the solution of (A.1) such that $J^0(t,t;\lambda) = 0$, $(J^0)'_x(t,t;\lambda) = 1$. Note that

$$J^{0}(0,t;\lambda) = -\varphi^{0}(t,\lambda), \qquad (J^{0})'_{x}(0,t;\lambda) = \vartheta^{0}(t,\lambda).$$
(A.4)

In order to estimate ψ^0_+ and J^0 , we introduce real-valued functions

$$\rho(x,\lambda) = 1 + |\lambda|^{1/12} + |x^2 - \lambda|^{1/4},$$

$$a(\lambda) = \left|\frac{\lambda}{2e}\right|^{\frac{\operatorname{Re}\lambda}{4}} e^{\frac{\pi - \phi}{4} \operatorname{Im}\lambda}, \qquad \lambda = |\lambda|e^{i\phi}, \quad \phi \in [0, 2\pi),$$

$$\sigma(x,\lambda) = \operatorname{Re} \int_0^x \sqrt{y^2 - \lambda} \, dy, \quad x \ge 0,$$
(A.5)

where $\sqrt{y^2 - \lambda} = y + o(1)$ as $y \to +\infty$ (note that it follows $\operatorname{Re} \sqrt{y^2 - \lambda} \ge 0$, if $y \ge 0$).

Lemma A.1. For all $(x, t, \lambda) \in \mathbb{R}_+ \times \mathbb{R}_+ \times \mathbb{C}$ the following estimates are fulfilled:

$$|\psi^0_+(x,\lambda)| \leqslant C_0 a(\lambda) \cdot \frac{e^{-\sigma(x,\lambda)}}{\rho(x,\lambda)}, \qquad |(\psi^0_+)'(x,\lambda)| \leqslant C_0 a(\lambda) \cdot \rho(x,\lambda) e^{-\sigma(x,\lambda)}, \quad (A.6)$$

$$|J^{0}(x,t;\lambda)| \leq \frac{C_{1}}{\rho(x,\lambda)\rho(t,\lambda)} e^{|\sigma(x,\lambda)-\sigma(t,\lambda)|}, \quad |(J^{0})'_{x}(x,t;\lambda)| \leq C_{1} \frac{\rho(x,\lambda)}{\rho(t,\lambda)} e^{|\sigma(x,\lambda)-\sigma(t,\lambda)|},$$

where C_0 , C_1 are some absolute constants.

Proof. See Lemmas 2.1 and 2.3 [CKK1]. Note that the proof is based on the result of [O]. \Box

Remark. If x = 0 and $|\lambda| \ge 1$, then¹⁰ $\sigma(0, \lambda) = 0$ and $\rho(0, \lambda) \asymp |\lambda|^{1/4}$. Identities (A.3) and routine calculations follow

$$\begin{aligned} |\psi^0_+(0,\lambda)| &\asymp |\lambda|^{-1/4} a(\lambda) \,, \quad \text{if} \quad |\lambda| = k \neq 4n+3 \,, \\ |(\psi^0_+)'(0,\lambda)| &\asymp |\lambda|^{1/4} a(\lambda) \,, \quad \text{if} \quad |\lambda| = k \neq 4n+1 \,, \end{aligned}$$
(A.7)

In other words, the estimates (A.6) of $|\psi_+(0,\lambda)|$ and $|\psi'_+(0,\lambda)|$ are exact on these contours. A.2 The perturbed equation. The solutions ψ_+ , ϑ , φ of the perturbed equation

$$-\psi'' + x^2\psi + q(x)\psi = \lambda\psi, \quad \lambda \in \mathbb{C}, \qquad (A.8)$$

can be constructed by iterations:

$$\psi_{+}(x,\lambda,q) = \sum_{n \ge 0} \psi_{+}^{(n)}(x,\lambda,q) , \quad \psi_{+}^{(n+1)}(x,\lambda,q) = -\int_{x}^{+\infty} J^{0}(x,t;\lambda)\psi_{+}^{(n)}(t,\lambda,q)q(t)dt , \quad (A.9)$$

$$\vartheta_{1,2}(x,\lambda,q) = \sum_{n \ge 0} \vartheta_{1,2}^{(n)}(x,\lambda,q), \qquad \vartheta_{1,2}^{(n+1)}(x,\lambda,q) = \int_0^x J^0(x,t;\lambda)\vartheta_{1,2}^{(n)}(t,\lambda,q)q(t)dt \,, \quad (A.10)$$

where we use the notations $\vartheta_1 = \vartheta$ and $\vartheta_2 = \varphi$ for short.

¹⁰Here and below $f \simeq g$ means that $C_1|f| \leq |g| \leq C_2|f|$ for some absolute constants $C_1, C_2 > 0$.

Introduce functions

$$\beta_+(x,\lambda,q) = C_1 \int_x^{+\infty} \frac{|q(t)|dt}{\rho^2(t,\lambda)}, \qquad \beta_0(x,\lambda,q) = C_1 \int_0^x \frac{|q(t)|dt}{\rho^2(t,\lambda)} dt$$

It is easy to see ([CKK2] Lemma 5.5) that

$$\beta(\lambda, q) = \beta_{+}(x, \lambda, q) + \beta_{0}(x, \lambda, q) = C_{1} \int_{0}^{+\infty} \frac{|q(t)|dt}{\rho^{2}(t, \lambda)} = O(|\lambda|^{-1/2} ||q||_{\mathbf{H}_{+}}).$$
(A.11)

Lemma A.2. For all $(x, \lambda, q) \in \mathbb{R}_+ \times \mathbb{C} \times \mathbf{H}_{+\mathbb{C}}$ the following estimates are fulfilled:

$$|\psi_{+}^{(n)}(x,\lambda,q)| \leqslant C_0 a(\lambda) \frac{e^{-\sigma(x,\lambda)}}{\rho(x,\lambda)} \cdot \frac{\beta_{+}^n(x,\lambda,q)}{n!},$$
$$|\vartheta_j^{(n)}(x,\lambda,q)| \leqslant \frac{2C_1}{(1+|\lambda|^{1/4})^{2j-3}} \cdot \frac{e^{\sigma(x,\lambda)}}{\rho(x,\lambda)} \cdot \frac{\beta_0^n(x,\lambda,q)}{n!}, \quad j=1,2.$$

In particular, series (A.9), (A.10) converge uniformly on bounded subsets of $\mathbb{R}_+ \times \mathbb{C} \times \mathbf{H}_{+\mathbb{C}}$. Moreover, the similar estimates with $\rho(x, \lambda)$ instead of $\frac{1}{\rho(x, \lambda)}$ in right-hand sides hold true for the values $|(\psi_{\pm}^{(n)})'(x, \lambda, q)|$ and $|(\vartheta_j^{(n)})'(x, \lambda, q)|$.

Proof. See [CKK1] Lemma 3.1 and [CKK2] Lemmas 5.2, 5.3.

Corollary A.3. For all $(\lambda, q) \in \mathbb{C} \times \mathbf{H}_{+\mathbb{C}}$, $n, m \ge 0$ and some absolute constant C > 0 the following estimates are fulfilled:

$$\left|\frac{\partial^{m}\psi_{+}^{(n)}(0,\lambda,q)}{\partial\lambda^{m}}\right| \leqslant \frac{m!C^{n+m+1}\|q\|_{\mathbf{H}_{+}}^{n}}{n!} \cdot \frac{\log^{m}(|\lambda|+2) \cdot a(\lambda)}{(|\lambda|+1)^{\frac{n}{2}+\frac{1}{4}}},$$

$$\left|\frac{\partial^{m}(\psi_{+}^{(n)})'(0,\lambda,q)}{\partial\lambda^{m}}\right| \leqslant \frac{m!C^{n+m+1}\|q\|_{\mathbf{H}_{+}}^{n}}{n!} \cdot \frac{\log^{m}(|\lambda|+2) \cdot a(\lambda)}{(|\lambda|+1)^{\frac{n}{2}-\frac{1}{4}}}.$$
(A.12)

Proof. Note that $\sigma(0, \lambda) = 0$ and $\rho(0, \lambda) \approx 1 + |\lambda|^{1/4}$. Hence, Lemma A.2 and (A.11) give (A.12) for m = 0. Recall that $\psi_+^{(n)}(0, \lambda, q)$, $(\psi_+^{(n)})'(0, \lambda, q)$ are entire functions. Therefore, the integration over the contour $\lambda(\phi) = \lambda + e^{i\phi} \log^{-1}(|\lambda| + 2)$, $\phi \in [0, 2\pi]$, together with the simple estimate $a(\lambda(\phi)) = O(a(\lambda))$ follows (A.12) in the general case m > 0.

Let

$$\widetilde{\beta}_{+}(x,q) = \frac{1}{x^{2}+1} + \int_{x}^{+\infty} \left| \frac{q(t)}{t} \right| dt.$$

The following asymptotics as $x \to +\infty$ are fulfilled uniformly on bounded subsets of $\mathbb{C} \times \mathbf{H}_{+\mathbb{C}}$ (see [CKK2] p.139 and p.169):

$$\psi_{+}(x,\lambda,q) = (\sqrt{2}x)^{\frac{\lambda-1}{2}} e^{-\frac{x^{2}}{2}} (1+O(\widetilde{\beta}_{+}(x,q))),$$

$$\psi_{+}'(x,\lambda,q) = -\frac{1}{\sqrt{2}} (\sqrt{2}x)^{\frac{\lambda+1}{2}} e^{-\frac{x^{2}}{2}} (1+O(\widetilde{\beta}_{+}(x,q))).$$
(A.13)

Moreover, if $\chi_+(x,\lambda,q)$ is an arbitrary solution of (A.8) such that $k = \{\chi_+,\psi_+\} \neq 0$, then

$$\chi_{+}(x,\lambda,q) = -\frac{k}{\sqrt{2}} (\sqrt{2}x)^{\frac{-\lambda-1}{2}} e^{\frac{x^{2}}{2}} (1+O(\widetilde{\beta}_{+}(x,q))),$$

$$\chi_{+}'(x,\lambda,q) = -\frac{k}{2} (\sqrt{2}x)^{\frac{-\lambda+1}{2}} e^{\frac{x^{2}}{2}} (1+O(\widetilde{\beta}_{+}(x,q))).$$
(A.14)

Remark. If $q \in \mathbf{H}_{+\mathbb{C}}$, then (A.13), (A.14) give $(\psi_+\chi_+)' \in \mathbf{H}_{+\mathbb{C}}$ (see [CKK2] p. 172).

A.3 Analyticity of spectral data and its gradients.

Lemma A.4. For each $(q; b) \in \mathbf{H}_+ \times \mathbb{R}$ all spectral data $\lambda_{2n+1}(q)$, $s_{2n+1}(q)$, $\lambda_{2n}(q, b)$, $s_{2n}(q, b)$ extend analytically to some complex ball $\{(p; a) \in \mathbf{H}_{+\mathbb{C}} \times \mathbb{C} : ||p-q||^2_{\mathbf{H}_{+\mathbb{C}}} + |a-b|^2 < R^2(q, b)\}$. Moreover, its gradients are given by

$$\frac{\partial \lambda_{2n+1}(q)}{\partial q(t)} = \psi_{2n+1}^2(t,q), \qquad \frac{\partial \lambda_{2n}(q,b)}{\partial q(t)} = \psi_{2n}^2(t,q,b),$$
$$\frac{\partial s_{2n+1}(q)}{\partial q(t)} = (\psi_{2n+1}\chi_{2n+1})(t,q), \qquad \frac{\partial s_{2n}(q,b)}{\partial q(t)} = (\psi_{2n}\chi_{2n})(t,q,b),$$

where ψ_{2n+1} is the n-th normalized eigenfunction of T_D , ψ_{2n} is the n-th normalized eigenfunction of T_b , and

$$\chi_{2n+1}(t,q) = \frac{\vartheta(t,\lambda_{2n+1}(q),q)}{\psi'_{2n+1}(0,q)} - \frac{\dot{\psi}'_{+}}{\psi'_{+}} (0,\lambda_{2n+1}(q),q) \cdot \psi_{2n+1}(t,q),$$
$$\chi_{2n}(t,q,b) = -\frac{\varphi(t,\lambda_{2n}(q,b),q)}{\psi_{2n}(0,q,b)} - \frac{\dot{\psi}_{+}}{\psi_{+}} (0,\lambda_{2n}(q,b),q) \cdot \psi_{2n}(t,q,b).$$

Furthermore,

$$\frac{\partial \lambda_{2n}(q,b)}{\partial b} = \psi_{2n}^2(0,q,b), \qquad \frac{\partial s_{2n}(q,b)}{\partial b} = (\psi_{2n}\chi_{2n})(0,q,b),$$

Proof. The proof of the analyticity repeats the proof of [CKK2] Lemma 2.3 (p. 172). In order to calculate gradients note that standard arguments (see [CKK2] Lemma 5.6) give

$$\frac{\partial \psi_+(0,\lambda,q)}{\partial q(t)} = (\varphi \psi_+)(t,\lambda,q), \qquad \frac{\partial \psi'_+(0,\lambda,q)}{\partial q(t)} = -(\vartheta \psi_+)(t,\lambda,q), \quad t \ge 0.$$

Applying the implicit function Theorem to the equation $\psi_+(0, \lambda_{2n+1}(q), q) = 0$ and using the identity $\int_{\mathbb{R}_+} \psi_+^2(t, \lambda, q) dt = \{\psi_+, \dot{\psi}_+\}(0, \lambda, q)$, we obtain

$$\frac{\partial\lambda_{2n+1}(q)}{\partial q(t)} = -\frac{\partial\psi_+(0)/\partial q(t)}{\partial\psi_+(0)/\partial\lambda} = -\frac{(\varphi\psi_+)(t)}{\dot{\psi}_+(0)} = -\frac{\psi_+^2(t)}{\psi_+'(0)\dot{\psi}_+(0)} = \frac{\psi_+^2(t)}{\{\psi_+,\dot{\psi}_+\}(0)} = \psi_{2n+1}^2(t)$$

(here and below we omit $\lambda = \lambda_{2n+1}(q)$ and q for short). Moreover,

$$\frac{\partial s_{2n+1}(q)}{\partial q(t)} = -\frac{\partial \log |\psi'_+(0,\lambda_{2n+1}(q),q)|}{\partial q(t)} = \frac{(\vartheta\psi_+)(t) - \dot{\psi}'_+(0) \cdot \psi^2_{2n+1}(t)}{\psi'_+(0)} = (\psi_{2n+1}\chi_{2n+1})(t).$$

By the same way, the identity $(\psi'_+ - b\psi_+)(0, \lambda_{2n}(q, b), q)$ follows

$$\frac{\partial\lambda_{2n}(q)}{\partial q(t)} = -\frac{\partial(\psi'_{+} - b\psi_{+})(0)/\partial q(t)}{\partial(\psi'_{+} - b\psi_{+})(0)/\partial \lambda} = \frac{(\vartheta + b\varphi)(t)\psi_{+}(t)}{\dot{\psi}'_{+}(0) - b\dot{\psi}_{+}(0)} = \frac{\psi^{2}_{+}(t)}{\psi_{+}(0)(\dot{\psi}'_{+}(0) - b\dot{\psi}_{+}(0))} = \psi^{2}_{2n}(t),$$
$$\frac{\partial\lambda_{2n}(q)}{\partial b} = \frac{\psi_{+}(0)}{\dot{\psi}'_{+}(0) - b\dot{\psi}_{+}(0)} = \frac{\psi^{2}_{+}(0)}{(\psi'_{+}(0) - b\dot{\psi}_{+}(0))} = \psi^{2}_{2n}(0),$$

$$\frac{\partial (\psi_{2h}(t))}{\partial b} = \frac{\psi_{+}(t)}{\dot{\psi}_{+}(0) - b\dot{\psi}_{+}(0)} = \frac{\psi_{+}(t)}{\{\psi_{+}, \dot{\psi}_{+}\}(0)} =$$

Furthermore,

$$\frac{\partial s_{2n}(q)}{\partial q(t)} = -\frac{\partial \log |\psi_+(0,\lambda_{2n}(q),q)|}{\partial q(t)} = -\frac{(\varphi\psi_+)(t) + \dot{\psi}_+(0) \cdot \psi_{2n}^2(t)}{\psi_+(0)} = (\psi_{2n}\chi_{2n})(t),$$
$$\frac{\partial s_{2n}(q)}{\partial b} = -\frac{\partial \log |\psi_+(0,\lambda_{2n}(q),q)|}{\partial b} = -\frac{\dot{\psi}_+(0) \cdot \psi_{2n}^2(0)}{\psi_+(0)} = (\psi_{2n}\chi_{2n})(0),$$

where we omit $\lambda = \lambda_{2n}(q, b)$ and q for short.

Lemma A.5. (i) For each $q \in \mathbf{H}_+$ and $n, m \ge 0$ the following identities are fulfilled:

$$\left((\psi_{2n+1}^2)', \psi_{2m+1}^2 \right)_+ = 0, \qquad \left((\psi_{2n+1}\chi_{2n+1})', \psi_{2m+1}^2 \right)_+ = -\frac{1}{2} \,\delta_{mn}, \\ \left((\psi_{2n+1}^2)', \psi_{2m+1}\chi_{2m+1} \right)_+ = \frac{1}{2} \,\delta_{mn}, \quad \left((\psi_{2n+1}\chi_{2n+1})', \psi_{2m+1}\chi_{2m+1} \right)_+ = 0.$$

(ii) For each $q \in \mathbf{H}_+$, $b \in \mathbb{R}$ and $n, m \ge 0$ the following identities are fulfilled:

$$\left((\psi_{2n}^2)', \psi_{2m}^2 \right)_+ = -\frac{1}{2} \left(\psi_{2n}^2 \psi_{2m}^2 \right)(0), \qquad \left((\psi_{2n} \chi_{2n})', \psi_{2m}^2 \right)_+ = \frac{1}{2} \left(-\delta_{nm} - (\psi_{2n}^2 \psi_{2m} \chi_{2m})(0) \right), \\ \left((\psi_{2n}^2)', \psi_{2m} \chi_{2m} \right)_+ = \frac{1}{2} \left(\delta_{nm} - (\psi_{2n}^2 \psi_{2m} \chi_{2m})(0) \right), \quad \left((\psi_{2n} \chi_{2n})', \psi_{2m} \chi_{2m} \right)_+ = -\frac{1}{2} \left(\psi_{2n} \chi_{2n} \psi_{2m} \chi_{2m} \right)(0).$$

Remark. This Lemma is similar to [CKK2] Lemma 2.6 (see also [PT] p. 44-45).

Proof. (i) For instance, we prove the third identity. Integration by parts gives

$$I_{nm} = \int_{\mathbb{R}_{+}} (\psi_{2n+1}^{2})'(t,q)(\psi_{2m+1}\chi_{2m+1})(t,q)dt = \frac{1}{2} \int_{\mathbb{R}_{+}} \{\psi_{2m+1}\chi_{2m+1}, (\psi_{2n+1}^{2})\}(t,q)dt$$
$$= \frac{1}{2} \int_{\mathbb{R}_{+}} (\chi_{2m+1}\psi_{2n+1}\{\psi_{2m+1}, \psi_{2n+1}\} + \psi_{2m+1}\psi_{2n+1}\{\chi_{2m+1}, \psi_{2n+1}\})(t,q)dt.$$

For $n \neq m$ it follows

$$I_{nm} = \int_{\mathbb{R}_+} \frac{(\{\psi_{2m+1}, \psi_{2n+1}\}\{\chi_{2m+1}, \psi_{2n+1}\})'(q, t)}{2(\lambda_{2m+1}(q) - \lambda_{2n+1}(q))} dt = 0.$$

If n = m, then we have $\{\psi_{2m+1}, \psi_{2n+1}\} = 0$ and $\{\chi_{2m+1}, \psi_{2n+1}\} = 1$. Therefore,

$$I_{nn} = \frac{1}{2} \int_{\mathbb{R}_+} \psi_{2n+1}^2(t,q) dt = \frac{1}{2}.$$

The proof of others identities and the proof of (ii) is similar.

A.4 The leading terms of asymptotics of $\psi_+(0,\lambda)$ and $\psi'_+(0,\lambda)$. Let

$$\kappa_n = \psi^0_+(0,\lambda^0_n), \qquad \kappa'_n = (\psi^0_+)'(0,\lambda^0_n), \qquad \dot{\kappa}_n = \dot{\psi}^0_+(0,\lambda^0_n) \text{ and so on.}$$

Note that (A.3) yields

$$\kappa_{2n} \asymp |\lambda_{2n}^0|^{-1/4} \cdot a(\lambda_{2n}^0), \qquad \kappa'_{2n} = 0, \qquad \dot{\kappa}'_{2n} \asymp |\lambda_{2n}^0|^{1/4} \cdot a(\lambda_{2n}^0), \kappa_{2n+1} = 0, \qquad \kappa'_{2n+1} \asymp |\lambda_{2n+1}^0|^{1/4} \cdot a(\lambda_{2n+1}^0), \qquad \dot{\kappa}_{2n+1} \asymp |\lambda_{2n+1}^0|^{-1/4} \cdot a(\lambda_{2n+1}^0),$$
(A.15)

and

$$\frac{\dot{\kappa}_{2n}}{\kappa_{2n}} - \frac{\ddot{\kappa}_{2n}'}{2\dot{\kappa}_{2n}'} = O(n^{-1}), \qquad \frac{\ddot{\kappa}_{2n}}{\kappa_{2n}} - \frac{\dot{\kappa}_{2n}^2}{\kappa_{2n}^2} + \frac{\pi^2}{16} = O(n^{-1}),
\frac{\dot{\kappa}_{2n+1}'}{\kappa_{2n+1}'} - \frac{\ddot{\kappa}_{2n+1}}{2\dot{\kappa}_{2n+1}} = O(n^{-1}), \qquad \frac{\ddot{\kappa}_{2n+1}'}{\kappa_{2n+1}'} - \frac{(\dot{\kappa}_{2n+1}')^2}{(\kappa_{2n+1}')^2} + \frac{\pi^2}{16} = O(n^{-1}), \qquad (A.16)$$

Lemma A.6. (i) Let $\psi_{+}^{(1)} = \psi_{+}^{(1)}(0, \lambda_{2n}^{0}, q)$, $\dot{\psi}_{+}^{(1)} = \dot{\psi}_{+}^{(1)}(0, \lambda_{2n}^{0}, q)$ and so on. The following identities and asymptotics are fulfilled for some absolute constant $\delta > 0$:

$$\begin{split} \psi_{+}^{(1)} &= -\kappa_{2n} \cdot \check{q}_{2n}^{+}, & \dot{\psi}_{+}^{(1)} &= \kappa_{2n} \left(-\frac{\dot{\kappa}_{2n}}{\kappa_{2n}} \check{q}_{2n}^{+} + \frac{\pi^{2}}{8} \hat{q}_{2n}^{+} + \ell_{\frac{1}{4}+\delta}^{2}(n) \right), \\ (\psi_{+}^{(1)})' &= -2\dot{\kappa}_{2n}' \cdot \hat{q}_{2n}^{+}, & (\dot{\psi}_{+}^{(1)})' &= -2\dot{\kappa}_{2n}' \left(\frac{\kappa_{2n}}{\kappa_{2n}} \hat{q}_{2n}^{+} + \frac{1}{2} \check{q}_{2n}^{+} + \ell_{\frac{1}{4}+\delta}^{2}(n) \right), \\ (\psi_{+}^{(2)})' &= -2\dot{\kappa}_{2n}' \left(-\check{q}_{2n}^{+} \hat{q}_{2n}^{+} + \ell_{\frac{3}{4}+\delta}^{2}(n) \right), & \psi_{+}^{(2)} &= \kappa_{2n} \left(\frac{1}{2} \left(\check{q}_{2n}^{+} \right)^{2} - \frac{\pi^{2}}{8} \left(\hat{q}_{2n}^{+} \right)^{2} + \ell_{\frac{3}{4}+\delta}^{2}(n) \right). \end{split}$$

(ii) Let $\psi_+^{(1)} = \psi_+^{(1)}(0, \lambda_{2n+1}^0, q)$, $\dot{\psi}_+^{(1)} = \dot{\psi}_+^{(1)}(0, \lambda_{2n+1}^0, q)$ and so on. The following identities and asymptotics are fulfilled for some absolute constant $\delta > 0$:

$$\begin{split} \psi_{+}^{(1)} &= -2\dot{\kappa}_{2n+1}\dot{q}_{2n+1}^{+}, & \dot{\psi}_{+}^{(1)} &= -2\dot{\kappa}_{2n+1}(\frac{\dot{\kappa}_{2n+1}'}{\kappa_{2n+1}'}\dot{q}_{2n+1}^{+} + \frac{1}{2}\,\dot{q}_{2n+1}^{+} + \ell_{\frac{1}{4}+\delta}^{2}(n)), \\ (\psi_{+}^{(1)})' &= -\kappa_{2n+1}'\cdot\dot{q}_{2n+1}^{+}, & (\dot{\psi}_{+}^{(1)})' &= \kappa_{2n+1}'(-\frac{\dot{\kappa}_{2n+1}'}{\kappa_{2n+1}'}\dot{q}_{2n+1}^{+} + \frac{\pi^{2}}{8}\dot{q}_{2n+1}^{+} + \ell_{\frac{1}{4}+\delta}^{2}(n)), \\ \psi_{+}^{(2)} &= -2\dot{\kappa}_{2n+1}(-\dot{q}_{2n+1}'\dot{q}_{2n+1}^{+} + \ell_{\frac{3}{4}+\delta}^{2}(n)), & (\psi_{+}^{(2)})' &= \kappa_{2n+1}'(\frac{1}{2}(\ddot{q}_{2n+1}')^{2} - \frac{\pi^{2}}{8}(\dot{q}_{2n+1}^{+})^{2} + \ell_{\frac{3}{4}+\delta}^{2}(n)). \end{split}$$

Proof. See [CKK2] Lemmas 5.11, 5.12 and [CKK2] Theorem 6.4.

A.5 The convergence of one double sum. Here we prove technical Lemma A.7. Let $q, p \in \mathbf{H}$. Then

$$S_k = \sum_{n=0}^k \sum_{m=k+1}^{+\infty} \frac{(q, (\psi_n \psi_m)(p))_{L^2(\mathbb{R})}^2}{m-n} \to 0 \quad as \quad k \to \infty .$$

Proof. Using Lemma A.2, Corollary A.3 and asymptotics (A.7), we obtain

$$\psi_n^0 = O(\rho^{-1}(x,\lambda_n^0)), \qquad \psi_n(x,p) = \psi_n^0(x) + O(n^{-\frac{1}{2}}\log n \cdot \rho^{-1}(x,\lambda_n^0)).$$

Note that

$$\left(\int_{\mathbb{R}} \frac{|q(t)|dt}{\rho(t,\lambda_n^0)\rho(t,\lambda_m^0)}\right)^2 \leqslant \int_{\mathbb{R}} (t^2+1)|q(t)|^2 dt \cdot \int_{\mathbb{R}} \frac{dt}{(t^2+1)\rho^2(t,\lambda_n^0)\rho^2(t,\lambda_m^0)} = O(n^{-\frac{1}{2}}m^{-\frac{1}{2}}).$$

Let
$$S_k = \sum^k \sum^{k+k^{3/4}} + \sum^k \sum^{-+\infty} = S_k^{(1)} + S_k^{(2)}.$$

$$S_k = \sum_{n=0}^{\infty} \sum_{m=k+1}^{\infty} + \sum_{n=0}^{\infty} \sum_{m=k+k^{3/4}}^{\infty} = S_k^{(1)} + S_k^{(1)}$$

We have

$$S_k^{(1)} = O(k^{-\frac{1}{2}}) \sum_{n=0}^k O(n^{-\frac{1}{2}}) \sum_{m=k+1}^{k+k^{3/4}} \frac{1}{m-n} = O(k^{\frac{1}{4}}) \sum_{n=0}^k O(n^{-\frac{1}{2}}(k-n)^{-1}) = O(k^{-\frac{1}{4}}\log k) ,$$

i.e. $S_k^{(1)} = o(1)$ as $k \to \infty$. We estimate $S_k^{(2)}$. Let $\varepsilon > 0$ be sufficiently small. If $m \ge n$, then $(q, (\psi_n \psi_m)(p))_{L^2(\mathbb{R})}^2 = (q, (\psi_n^0 \psi_m^0))_{L^2(\mathbb{R})}^2 + O(\log n \cdot n^{-1}m^{-\frac{1}{2}})$

$$(q, (\psi_n \psi_m)(p))_{L^2(\mathbb{R})}^2 = (q, (\psi_n^0 \psi_m^0))_{L^2(\mathbb{R})}^2 + O(\log n \cdot n^{-1}m^{-1$$

since

$$\left(\int_{|t| \ge n^{\varepsilon}} \frac{|q(t)|dt}{\rho(t,\lambda_n^0)\rho(t,\lambda_m^0)}\right)^2 \leqslant \int_{|t| \ge n^{\varepsilon}} (|t|^{3/2} + 1)|q(t)|^2 dt \cdot O(n^{-\frac{1}{2}}m^{-\frac{1}{2}}) = O(n^{-\frac{1}{2}-\frac{\varepsilon}{2}}m^{-\frac{1}{2}}) \,.$$

It is easy to see (see e.g. [CKK2] Lemma 6.7) that

$$\psi_n^0(t) = \sqrt{2/\pi} \cdot (\lambda_n^0)^{-\frac{1}{4}} \cos(\sqrt{\lambda_n^0} \cdot t - \frac{\pi n}{2}) + O(n^{-\frac{3}{4}+3\varepsilon}), \qquad |t| \le n^{\varepsilon} \cdot dt$$

If $m \ge n + n^{3/4}$, then $\sqrt{\lambda_m^0} - \sqrt{\lambda_n^0} \ge n^{\frac{1}{4}}$. Integration by parts and $q' \in L^2(\mathbb{R})$ follow

$$\int_{-n^{\varepsilon}}^{n^{\varepsilon}} q(t)\psi_{n}^{0}(t)\psi_{m}^{0}(t)dt = O(n^{-\frac{1}{2}}m^{-\frac{1}{4}}) \cdot \int_{-n^{\varepsilon}}^{n^{\varepsilon}} |q'(t)|dt + O(n^{-\frac{3}{4}+3\varepsilon}m^{-\frac{1}{4}}) = O(n^{-\frac{1}{2}+\frac{\varepsilon}{2}}m^{-\frac{1}{4}})$$

Summarizing, we obtain $(q, (\psi_n \psi_m)(p))_{L^2(\mathbb{R})}^2 = O(n^{-\frac{1}{2}-\frac{\varepsilon}{2}}m^{-\frac{1}{2}})$, if $m \ge n+n^{3/4}$. Therefore,

$$S_k^{(2)} = \sum_{n=0}^k \sum_{m=k+k^{3/4}}^{+\infty} \frac{O(n^{-\frac{1}{2}-\frac{\varepsilon}{2}}m^{-\frac{1}{2}})}{m-n} \leqslant \sum_{n=0}^k O(n^{-\frac{1}{2}-\frac{\varepsilon}{2}}) \sum_{m=k+1}^{+\infty} \frac{O(m^{-\frac{1}{2}})}{m-n}$$

Note that $\sum_{n=0}^{k} O(n^{-\frac{1}{2}-\frac{\varepsilon}{2}}) = O(k^{\frac{1}{2}-\frac{\varepsilon}{2}})$ and $\sum_{m=k+1}^{+\infty} \frac{O(m^{-\frac{1}{2}})}{m-n} = O(\log k \cdot k^{-\frac{1}{2}})$. Hence, $S_k^{(2)} = o(1)$ as $k \to \infty$. We are done.
