

Theta Series of Unimodular Lattices, Combinatorial Identities and Weighted Symmetric Polynomials

Abstract

We find two combinatorial identities on the theta series of the root lattices of the finite-dimensional simple Lie algebras of type D_{4n} and the cosets in their integral duals, in terms of the well-known Eisenstein series $E_4(z)$ and Ramanujan series $\Delta_{24}(z)$. Using these two identities, we determine the theta series of certain infinite families of positive definite even unimodular lattices obtained by gluing finite copies of the root lattices of the finite-dimensional simple Lie algebras of type D_{2n} . It turns out that these theta series are weighted symmetric polynomials of two fixed families of polynomials of $E_4(z)$ and $\Delta_{24}(z)$.

1 Introduction

Denote by \mathbb{Z} the ring of integers. A unimodular (linear) lattice is a finite-rank free abelian group with a symmetric integer-valued \mathbb{Z} -bilinear form whose associated symmetric matrix is of determinant ± 1 . Unimodular lattices are important objects in geometry of numbers. In sphere packings, many packings provided by unimodular lattices are of higher covering density (cf. [CS3]). The second cohomology group of a 4-manifold over \mathbb{Z} modulo the torsion subgroup forms a unimodular lattice with respect to its intersection matrix (cf. [F]). The vertex operator superalgebra associated with a positive definite unimodular lattice enjoys the property of having a unique locally-finite irreducible module, that is, itself. The well-known example of Leech lattice is directly related to important simple finite groups, the Conway groups (cf. [C]). The moonshine representation of the Monster group was constructed by orbifold construction through the vertex operator algebra associated with the Leech lattice and some of their twisted modules (cf. [B2], [FLM]).

Classification of positive definite unimodular lattices has been done up to rank twenty-six (cf. [B1], [CS2]). In [X1] (also cf. [X2], [X3]), the author gave some explicit constructions of infinite families of positive definite unimodular lattices.

The arithmetic content of a positive definite unimodular lattice is given by its theta series, the generating function of the numbers of lattice points on spheres of integral square radius. A classical Hecke's theorem says that the theta series of a positive definite even unimodular lattice is a polynomial of the well-known Eisenstein series $E_4(z)$ and Ramanujan series $\Delta_{24}(z)$ (cf. [H]). However, there is still a little known on how to write the theta series of a positive definite even unimodular lattice as the polynomials of $E_4(z)$ and $\Delta_{24}(z)$. In particular, there are no results on the theta series of infinite families of positive definite unimodular lattices. A natural question is what kind polynomials of $E_4(z)$ and $\Delta_{24}(z)$ could be the theta series of positive definite even unimodular lattices. In this paper, we find two combinatorial identities on the theta series of the root lattices of the finite-dimensional simple Lie algebras of type D_{4n} and the cosets in their integral duals, in terms of the Eisenstein series $E_4(z)$ and Ramanujan series $\Delta_{24}(z)$. Using these two identities, we determine the theta series of certain infinite families of positive definite even unimodular lattices with a sublattice of the same rank that is isomorphic to the direct sum of finite copies of the root lattices of the finite-dimensional simple Lie algebras of type D_{2n} . It turns out that these theta series are weighted symmetric polynomials in $\Delta_{24}(z)$ and two fixed families of polynomials of $E_4(z)$ and $\Delta_{24}(z)$. Below, we shall give a more detailed technical introduction.

The fundamental arithmetic functions used in counting lattice points are the following theta functions:

$$\vartheta_2(z) = \sum_{m \in \mathbb{Z}} q^{(m+1/2)^2}, \quad \vartheta_3(z) = \sum_{m \in \mathbb{Z}} q^{m^2}, \quad \vartheta_4(z) = \sum_{m \in \mathbb{Z}} (-q)^{m^2}, \quad (1.1)$$

where

$$q = e^{\pi\sqrt{-1}z} \text{ with } \text{Im}(z) > 0. \quad (1.2)$$

An important identity among them is

$$\vartheta_2^4(z) + \vartheta_4^4(z) = \vartheta_3^4(z). \quad (1.3)$$

The Eisenstein $E_4(z)$ series is defined by

$$E_4(z) = \frac{1}{2}(\vartheta_2^8(z) + \vartheta_3^8(z) + \vartheta_4^8(z)) \quad (1.4)$$

and the Ramanujan series is defined by

$$\Delta_{24}(z) = \left(\frac{\vartheta_2(z)\vartheta_3(z)\vartheta_4(z)}{2} \right)^8. \quad (1.5)$$

As q -powers,

$$E_4(z) = 1 + 240 \sum_{m=1}^{\infty} \left(\sum_{d|m} d^3 \right) q^{2m} \quad (1.6)$$

and

$$\Delta_{24}(z) = \sum_{m=1}^{\infty} \tau(m) q^{2m} \quad (1.7)$$

whose coefficients $\tau(m)$ are called *Ramanujan numbers*. We refer to Table 4.9 in [CS3] for the first one hundred of coefficients of the q -powers in $E_4(z)$ and the reference [L] for first three hundred of the Ramanujan numbers.

Denote by \mathbb{R} the field of real numbers. For a positive integer n , we denote by \mathbb{R}^n the n -dimensional Euclidean space with the inner product

$$\langle \vec{\alpha}, \vec{\beta} \rangle = \sum_{i=1}^n \alpha_i \beta_i \quad \text{for } \vec{\alpha} = (\alpha_1, \dots, \alpha_n), \vec{\beta} = (\beta_1, \dots, \beta_n) \in \mathbb{R}^n. \quad (1.8)$$

A *positive definite integral lattice* L of rank n is an additive subgroup L of \mathbb{R}^n generated by a basis of \mathbb{R}^n such that

$$\langle \vec{\alpha}, \vec{\beta} \rangle \in \mathbb{Z} \quad \text{for } \vec{\alpha}, \vec{\beta} \in L. \quad (1.9)$$

The lattice L is called *even* if

$$\langle \vec{\alpha}, \vec{\alpha} \rangle \in 2\mathbb{Z} \quad \text{for } \vec{\alpha} \in L, \quad (1.10)$$

and is unimodular if and only if

$$L = \{ \vec{\alpha} \in \mathbb{R}^n \mid \langle \vec{\alpha}, \vec{\beta} \rangle \in \mathbb{Z} \text{ for } \vec{\beta} \in L \}. \quad (1.11)$$

For any coset L' of L in \mathbb{R}^n , we define the *theta series of L'* by

$$\Theta_{L'}(z) = \sum_{\vec{\alpha} \in L'} q^{\langle \vec{\alpha}, \vec{\alpha} \rangle}. \quad (1.12)$$

Hecke [H] proved that $\Theta_L(z)$ is a polynomial of $E_4(z)$ and $\Delta_{24}(z)$ for any positive definite even unimodular lattice L . Thus a fundamental question in positive definite even unimodular lattices is to determine the coefficients of the theta series of the lattices as polynomials of $E_4(z)$ and $\Delta_{24}(z)$. One may ask the question in another way that what kind polynomials of $E_4(z)$ and $\Delta_{24}(z)$ could be the theta series of positive definite even unimodular lattices. To this author's best knowledge, only a few of theta series of positive definite even unimodular lattices are known.

For a nonnegative integer n , we let

$$h_n(z) = \vartheta_2^{8n}(z) + \vartheta_3^{8n}(z) + \vartheta_4^{8n}(z), \quad (1.13)$$

$$\rho_n(z) = \frac{\vartheta_3^{8(n+1)+4}(z) - \vartheta_2^{8(n+1)+4}(z) - \vartheta_4^{8(n+1)+4}(z)}{(\vartheta_2(z)\vartheta_3(z)\vartheta_4(z))^4}. \quad (1.14)$$

By (1.3), the coefficients of the q -powers in $\rho_n(z)$ are positive integers. Denote by \mathbb{Z}_+ the set of positive integers and by \mathbb{N} the set of nonnegative integers. In this paper, we shall prove that for any $n \in \mathbb{Z}_+$, the following combinatorial identities hold:

$$h_n(z) = 2E_4^n(z) + \sum_{i=1}^{\lfloor n/3 \rfloor} \frac{n}{i} \binom{n-i-1}{2i-1} 2^{8i} \Delta_{24}^i(z) E_4^{n-3i}(z), \quad (1.15)$$

$$\rho_n(z) = \sum_{i=0}^{\lfloor n/3 \rfloor} \frac{2n+3}{2i+1} \binom{n-i}{2i} 2^{8i} \Delta_{24}^i(z) E_4^{n-3i}(z). \quad (1.16)$$

The above two identities can be viewed as higher-order analogues of the identity (1.3).

For a positive integer n , the type-D root lattice R_{D_n} is defined by

$$R_{D_n} = \left\{ \alpha = (\alpha_1, \alpha_2, \dots, \alpha_n) \in \mathbb{Z}^n \mid \sum_{i=1}^n \alpha_i \in 2\mathbb{Z} \right\} \subset \mathbb{R}^n \quad (1.17)$$

with the symmetric form (1.8). We define *weights* by

$$\text{wt } \Delta_{24}(z) = 3, \quad \text{wt } h_n(z) = \text{wt } \rho_n(z) = n \quad \text{for } n \in \mathbb{Z}_+. \quad (1.18)$$

In this paper, we shall determine the theta series of certain infinite families of even unimodular lattices that have a sublattice of the same rank and isomorphic to the direct sum of finite copies of the lattices R_{D_n} with various n . They are the following functions

$$\begin{aligned} & 2^{-2\ell-1} \left[\sum_{1 \leq j_1 \leq j_2; j_1+j_2 \leq \ell} \text{sym}\{h_{m_1+\dots+m_{2j_1}}(z) h_{m_{2j_1+1}+\dots+m_{2(j_1+j_2)}}(z) h_{m_{2(j_1+j_2)+1}+\dots+m_{2\ell+1}}(z)\} \right. \\ & - \sum_{0 \leq j_1 \leq j_2 \leq \ell-j_1-j_2-1} \text{sym}\{h_{m_1+\dots+m_{2j_1+1}}(z) h_{m_{2j_1+2}+\dots+m_{2(j_1+j_2+1)}}(z) \\ & \times h_{m_{2(j_1+j_2)+3}+\dots+m_{2\ell+1}}(z)\} + \sum_{j=1}^{\ell} (3 - 4^{\ell-j}) \text{sym}\{h_{m_1+\dots+m_{2j}}(z) h_{m_{2j+1}+\dots+m_{2\ell+1}}(z)\} \\ & \left. + \left(4 - 3 \cdot 4^{\ell} + \frac{2}{3} \sum_{j_1+j_2 \leq \ell-1} \binom{2\ell+1}{2j_1+1, 2j_2+1} \right) h_{m_1+\dots+m_{2\ell+1}}(z) \right] \quad (1.19) \end{aligned}$$

for $\ell \in \mathbb{N}$ and $m_1, \dots, m_{2\ell+1} \in \mathbb{Z}_+$;

$$\begin{aligned} & 2^{-2\ell} \left[\sum_{1 \leq j_1 \leq j_2 \leq \ell-j_1-j_2} \text{sym}\{h_{m_1+\dots+m_{2j_1+j_1}}(z) h_{m_{2j_1+1}+\dots+m_{2(j_1+j_2)+j_2}}(z) \right. \\ & \times h_{m_{2(j_1+j_2)+1}+\dots+m_{2\ell+\ell-j_1-j_2}}(z)\} - 2^8 \Delta_{24}(z) \sum_{1 \leq j_1, j_2; j_1+j_2 \leq \ell-2} \text{sym}\{\rho_{m_1+\dots+m_{2j_1+1}+j_1-1}(z) \\ & \times \rho_{m_{2j_1+2}+\dots+m_{2(j_1+j_2)+j_2-1}}(z) h_{m_{2(j_1+j_2)+3}+\dots+m_{2\ell+\ell-j_1-j_2-1}}(z)\} \end{aligned}$$

$$\begin{aligned}
& +3 \sum_{j=1}^{[\ell/2]} \text{sym}\{h_{m_1+\dots+m_{2j}+j}(z)h_{m_{2j+1}+\dots+m_{2\ell}+\ell-j}(z)\} + 2^8 \Delta_{24}(z) \\
& \times \sum_{j=0}^{[(\ell-1)/2]} (2^{2j} + 2^{2(\ell-j-1)} - 3) \text{sym}\{\rho_{m_1+\dots+m_{2j+1}+j-1}(z)\rho_{m_{2j+2}+\dots+m_{2\ell}+\ell-j-2}(z)\} \\
& + \left(4 - \frac{2}{3} \sum_{j_1+j_2 \leq \ell} \binom{2\ell}{2j_1, 2j_2}\right) h_{m_1+\dots+m_{2\ell}+\ell}(z) \tag{1.20}
\end{aligned}$$

for $\ell \in \mathbb{Z}_+$ and $m_1, \dots, m_{2\ell} \in \mathbb{N}$;

$$\begin{aligned}
& \frac{1}{2} h_{m_1+m_2+m_3+m_4+2\epsilon+1}(z) - 32 \Delta_{24}(z) [\rho_{m_1+m_2+\epsilon-1}(z)\rho_{m_3+m_4+\epsilon-1}(z) \\
& + \rho_{m_1+m_3+\epsilon-1}(z)\rho_{m_2+m_4+\epsilon-1}(z) + \rho_{m_1+m_4+\epsilon-1}(z)\rho_{m_2+m_3+\epsilon-1}(z)] \tag{1.21}
\end{aligned}$$

for $m_1, m_2, m_3, m_4 \in \mathbb{N}$ and $\epsilon = 0, 1$. Here we have treated $\rho_{-1}(z) = 0$ in (1.20), and (1.21), and “sym{·}” means the symmetric polynomial with respect to the integrable variables m_i and the expression in the braces is a representative term. For instance,

$$\begin{aligned}
& \text{sym}\{h_{m_1+m_2+1}(z)h_{m_3+m_4+1}(z)\} \\
& = h_{m_1+m_2+1}(z)h_{m_3+m_4+1}(z) + h_{m_1+m_3+1}(z)h_{m_2+m_4+1}(z) \\
& + h_{m_1+m_4+1}(z)h_{m_2+m_3+1}(z), \tag{1.22}
\end{aligned}$$

$$\begin{aligned}
& \text{sym}\{h_{m_1+m_2+1}(z)\rho_{m_3-1}(z)\rho_{m_4-1}(z)\} \\
& = h_{m_1+m_2+1}(z)\rho_{m_3-1}(z)\rho_{m_4-1}(z) + h_{m_1+m_3+1}(z)\rho_{m_2-1}(z)\rho_{m_4-1}(z) \\
& + h_{m_1+m_4+1}(z)\rho_{m_2-1}(z)\rho_{m_3-1}(z) + h_{m_3+m_4+1}(z)\rho_{m_1-1}(z)\rho_{m_2-1}(z) \\
& + h_{m_2+m_4+1}(z)\rho_{m_1-1}(z)\rho_{m_3-1}(z) + h_{m_2+m_3+1}(z)\rho_{m_1-1}(z)\rho_{m_4-1}(z). \tag{1.23}
\end{aligned}$$

These theta series are weighted symmetric polynomials of the series $\{\Delta_{24}(z), h_n(z), \rho_n(z) \mid n \in \mathbb{Z}_+\}$. Thus we essentially determine the theta series of these lattices as polynomials of the well-known Eisenstein series $E_4(z)$ and Ramanujan series $\Delta_{24}(z)$. We speculate that the theta series of the other infinite families of positive definite even unimodular lattices may relate to the invariants of the other finite groups.

The results in this paper could be useful in study of modular forms and partition functions of the conformal field theories related to positive definite even unimodular lattices. The covering densities of the sphere packings of these lattices can be calculated by our formulae.

In Section 2, we shall prove (1.15) and (1.16). In Section 3, the theta series of our concerned lattice will be determined.

2 Proofs of the Combinatorial Identities

In this section, we shall present the proofs of the combinatorial identities (1.15) and (1.16).

Set

$$a = \vartheta_2^4(z), \quad b = \vartheta_4^4(z). \quad (2.1)$$

By (1.3), we have

$$\vartheta_3^4(z) = a + b. \quad (2.2)$$

Moreover, (1.13) and (1.14) become

$$h_n = a^{2n} + b^{2n} + (a + b)^{2n}, \quad \rho_n = \frac{(a + b)^{2n+3} - a^{2n+3} - b^{2n+3}}{ab(a + b)}. \quad (2.3)$$

We allow $n = 0$ in the above equations.

For convenience, we let

$$E = E_4(z) = \frac{1}{2}(a^2 + b^2 + (a + b)^2) = a^2 + b^2 + ab, \quad (2.4)$$

$$\Delta = 2^8 \Delta_{24}(z) = (\vartheta_2(z)\vartheta_3(z)\vartheta_4(z))^8 = a^2 b^2 (a + b)^2. \quad (2.5)$$

Note that

$$h_0 = 3, \quad h_1 = 2E. \quad (2.6)$$

Moreover,

$$\begin{aligned} E^2 &= (a^2 + b^2 + ab)^2 \\ &= a^4 + b^4 + (ab)^2 + 2a^2 b^2 + 2a^2 \cdot ab + 2ab \cdot b^2 \\ &= a^4 + b^4 + 3a^2 b^2 + 2ab(a^2 + b^2). \end{aligned} \quad (2.7)$$

Hence,

$$\begin{aligned} h_2 &= a^4 + b^4 + (a + b)^4 \\ &= a^4 + b^4 + a^4 + b^4 + 4ab(a^2 + b^2) + 6a^2 b^2 \\ &= 2[a^4 + b^4 + 3a^2 b^2 + 2ab(a^2 + b^2)] \\ &= 2E^2. \end{aligned} \quad (2.8)$$

Lemma 2.1. *For $3 \leq n \in \mathbb{Z}$, we have:*

$$h_n = 2Eh_{n-1} - E^2 h_{n-2} + \Delta h_{n-3}. \quad (2.9)$$

Proof. Note that

$$2Eh_{n-1} = (a^2 + b^2 + (a + b)^2)(a^{2(n-1)} + b^{2(n-1)} + (a + b)^{2(n-1)})$$

$$\begin{aligned}
&= a^{2n} + b^{2n} + a^2b^2(a^{2(n-2)} + b^{2(n-2)}) + (a^2 + b^2)(a + b)^{2(n-1)} \\
&\quad + (a + b)^2(a^{2(n-1)} + b^{2(n-1)}) + (a + b)^{2n} \\
&= h_n + a^2b^2(a^{2(n-2)} + b^{2(n-2)}) + (a^2 + b^2)(a + b)^{2(n-1)} \\
&\quad + (a + b)^2(a^{2(n-1)} + b^{2(n-1)}). \tag{2.10}
\end{aligned}$$

Moreover,

$$\begin{aligned}
&(a + b)^2(a^2 + b^2) + a^2b^2 \\
&= (a^2 + b^2 + 2ab)(a^2 + b^2) + a^2b^2 \\
&= (a^2 + b^2)^2 + 2ab(a^2 + b^2) + a^2b^2 \\
&= a^4 + b^4 + 2a^2b^2 + 2ab(a^2 + b^2) + a^2b^2 \\
&= E^2. \tag{2.11}
\end{aligned}$$

Hence, we obtain

$$\begin{aligned}
&E^2h_{n-2} \\
&= ((a + b)^2(a^2 + b^2) + a^2b^2)(a^{2(n-2)} + b^{2(n-2)} + (a + b)^{2(n-2)}) \\
&= (a + b)^2[a^{2(n-1)} + b^{2(n-1)} + a^2b^2(a^{2(n-3)} + b^{2(n-3)})] + a^2b^2(a^{2(n-2)} + b^{2(n-2)}) \\
&\quad + (a^2 + b^2)(a + b)^{2(n-1)} + a^2b^2(a + b)^{2(n-2)} \\
&= (a + b)^2(a^{2(n-1)} + b^{2(n-1)}) + \Delta(a^{2(n-3)} + b^{2(n-3)}) + a^2b^2(a^{2(n-2)} + b^{2(n-2)}) \\
&\quad + (a^2 + b^2)(a + b)^{2(n-1)} + \Delta(a + b)^{2(n-3)} \\
&= (a + b)^2(a^{2(n-1)} + b^{2(n-1)}) + a^2b^2(a^{2(n-2)} + b^{2(n-2)}) \\
&\quad + (a^2 + b^2)(a + b)^{2(n-1)} + \Delta h_{n-3}. \tag{2.12}
\end{aligned}$$

Thus we have

$$2Eh_{n-1} - E^2h_{n-2} = h_n - \Delta h_{n-3}, \tag{2.13}$$

which is equivalent to (2.9). \square

By Lemma 2.1, we calculate

$$h_3 = 2E^3 + 3\Delta, \quad h_4 = 2E^4 + 8\Delta E, \quad h_5 = 2E^5 + 15\Delta E^2, \tag{2.14}$$

$$h_6 = 2E^6 + 24\Delta E^3 + 3\Delta^2, \quad h_7 = 2E^7 + 35\Delta E^4 + 14\Delta^2 E, \tag{2.15}$$

$$h_8 = 2E^8 + 48\Delta E^5 + 40\Delta^2 E^2, \quad h_9 = 2E^9 + 63\Delta E^6 + 90\Delta^2 E^3 + 3\Delta^3, \tag{2.16}$$

$$h_{10} = 2E^{10} + 80\Delta E^7 + 175\Delta^2 E^4 + 20\Delta^3 E. \tag{2.17}$$

In fact, we had directly calculated (2.14)-(2.17), and then observed (2.9) from them. Analyzing the coefficients in (2.14)-(2.17), we speculated the following theorem.

Theorem 2.2. *For $n \in \mathbb{Z}_+$, we have*

$$h_n = 2E^n + \sum_{i=1}^{\lfloor n/3 \rfloor} \frac{n}{i} \binom{n-i-1}{2i-1} \Delta^i E^{n-3i}, \quad (2.18)$$

which is equivalent to (1.15) by (2.4) and (2.5).

Proof. We shall prove (2.18) by (2.9) and induction on n . First for $m, k \in \mathbb{Z}_+$ such that $k \leq m-1$, we have

$$\begin{aligned} & \frac{2m}{k} \binom{m-k-1}{2k-1} - \frac{m-1}{k} \binom{m-k-2}{2k-1} + \frac{m-2}{k-1} \binom{m-k-2}{2k-3} \\ &= \frac{1}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} [2m(m-k-1)(m+1-3k) \\ & \quad - (m-1)(m+1-3k)(m-3k) + 2k(m-2)(2k-1)] \\ &= \frac{1}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} [2m(m+1)(m-k-1) - 6mk(m-k-1) \\ & \quad - (m-1)(m+1)(m-3k) + 3(m-1)k(m-3k) + 2k(m-2)(2k-1)] \\ &= \frac{1}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} [(m+1)(2m(m-k-1) - (m-1)(m-3k)) \\ & \quad + k(-6m(m-k-1) + 3(m-1)(m-3k) + 2(2k-1)(m-2))] \\ &= \frac{1}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} [(m+1)(m^2 + km - m - 3k) \\ & \quad + k(-3m^2 + km + m + k + 4)] \\ &= \frac{1}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} [(m+1)(m^2 + km - m - 3k) \\ & \quad + k(m+1)(k+4-3m)] \\ &= \frac{1}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} (m+1)(m^2 + km - m - 3k + k^2 + 4k - 3km) \\ &= \frac{1}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} (m+1)(m^2 + k^2 - 2km - m + k) \\ &= \frac{(m+1)(m-k)(m-k-1)}{2k(k-1)(2k-1)} \binom{m-k-2}{2k-3} \\ &= \frac{m+1}{k} \binom{m-k}{2k-1}. \end{aligned} \quad (2.19)$$

When $n = 1$, (2.18) holds by (2.6). Let $m \in \mathbb{Z}_+$. Suppose that (2.18) holds for $n \leq m$. By (2.9),

$$\begin{aligned} h_{m+1} &= 2Eh_m - E^2h_{m-1} + \Delta h_{m-2} \\ &= 2E^{m+1} + [2m(m-2) - (m-1)(m-3) + 2]\Delta E^{m-2} + 2 \sum_{i=2}^{\lfloor m/3 \rfloor} \frac{m}{i} \binom{m-i-1}{2i-1} \end{aligned}$$

$$\begin{aligned}
& \times \Delta^i E^{m+1-3i} - \sum_{i=2}^{\lfloor (m-1)/3 \rfloor} \frac{m-1}{i} \binom{m-i-2}{2i-1} \Delta^i E^{m+1-3i} \\
& + \Delta \sum_{i=1}^{\lfloor (m-2)/3 \rfloor} \frac{m-2}{i} \binom{m-i-3}{2i-1} \Delta^i E^{m-2-3i} \\
= & 2E^{m+1} + (m+1)(m-1)\Delta E^{m-2} + 2 \sum_{i=2}^{\lfloor m/3 \rfloor} \frac{m}{i} \binom{m-i-1}{2i-1} \Delta^i E^{m+1-3i} \\
& - \sum_{i=2}^{\lfloor (m-1)/3 \rfloor} \frac{m-1}{i} \binom{m-i-2}{2i-1} \Delta^i E^{m+1-3i} \\
& + \Delta \sum_{i=2}^{\lfloor (m-2)/3 \rfloor + 1} \frac{m-2}{i-1} \binom{m-i-2}{2i-3} \Delta^i E^{m+1-3i}. \tag{2.20}
\end{aligned}$$

Case 1. $m = 3l$ with $l \in \mathbb{Z}_+$.

$$\begin{aligned}
h_{m+1} &= 2E^{m+1} + (m+1)(m-1)\Delta E^{m-2} + 2 \sum_{i=2}^l \frac{m}{i} \binom{m-i-1}{2i-1} \Delta^i E^{m+1-3i} \\
& - \sum_{i=2}^{l-1} \frac{m-1}{i} \binom{m-i-2}{2i-1} \Delta^i E^{m+1-3i} + \Delta \sum_{i=2}^l \frac{m-2}{i-1} \binom{m-i-2}{2i-3} \Delta^i E^{m+1-3i} \\
= & 2E^{m+1} + (m+1)(m-1)\Delta E^{m-2} + \sum_{i=2}^{l-1} \left[\frac{2m}{i} \binom{m-i-1}{2i-1} - \frac{m-1}{i} \binom{m-i-2}{2i-3} \right] \\
& + \frac{m-2}{i-1} \binom{m-i-2}{2i-3} \Delta^i E^{m+1-3i} + \left[\frac{2m}{l} \binom{2l-1}{2l-1} + \frac{m-2}{l-2} \binom{2l-2}{2l-3} \right] \Delta^l E \\
= & 2E^{m+1} + (m+1)(m-1)\Delta E^{m-2} + \sum_{i=2}^{l-1} \frac{m+1}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i} \\
& + 2(m+1)\Delta^l E \\
= & 2E^{m+1} + \sum_{i=1}^{l-1} \frac{m+1}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i} + \frac{m+1}{l} \binom{m-l}{2l-1} \Delta^l E \\
= & 2E^{m+1} + \sum_{i=1}^l \frac{m+1}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i} \\
= & 2E^{m+1} + \sum_{i=1}^{\lfloor (m+1)/3 \rfloor} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i}. \tag{2.21}
\end{aligned}$$

Case 2. $m = 3l + 1$ with $l \in \mathbb{N}$.

$$\begin{aligned}
h_{m+1} &= 2E^{m+1} + (m+1)(m-1)\Delta E^{m-2} + \sum_{i=2}^l \left[\frac{2m}{i} \binom{m-i-1}{2i-1} \right. \\
& \left. - \frac{m-1}{i} \binom{m-i-2}{2i-1} + \frac{m-2}{i-1} \binom{m-i-2}{2i-3} \right] \Delta^i E^{m+1-3i}
\end{aligned}$$

$$= 2E^{m+1} + \sum_{i=1}^{\lfloor (m+1)/3 \rfloor} \frac{m+1}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i}. \quad (2.22)$$

Case 3. $m = 3l + 2$ with $l \in \mathbb{N}$.

$$\begin{aligned} h_{m+1} &= 2E^{m+1} + (m+1)(m-1)\Delta E^{m-2} + \sum_{i=2}^l \left[\frac{2m}{i} \binom{m-i-1}{2i-1} - \frac{m-1}{i} \binom{m-i-2}{2i-1} \right. \\ &\quad \left. + \frac{m-2}{(i-1)} \binom{m-i-2}{2i-3} \right] \Delta^i E^{m+1-3i} + \frac{m-2}{l} \binom{2l-1}{2l-1} \Delta^{l+1} \\ &= 2E^{m+1} + \sum_{i=1}^l \frac{(m+1)}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i} + 3\Delta^{l+1} \\ &= 2E^{m+1} + \sum_{i=1}^l \frac{(m+1)}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i} + \frac{m+1}{l+1} \binom{m-(l+1)}{2(l+1)-1} \Delta^{l+1} \\ &= 2E^{m+1} + \sum_{i=1}^{l+1} \frac{(m+1)}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i} \\ &= 2E^{m+1} + \sum_{i=1}^{\lfloor (m+1)/3 \rfloor} \frac{(m+1)}{i} \binom{m-i}{2i-1} \Delta^i E^{m+1-3i}. \end{aligned} \quad (2.23)$$

Thus (2.18) holds for $n = m + 1$. Therefore, (2.18) holds for any $n \in \mathbb{Z}_+$ by induction on n . \square

Next we consider ρ_n (cf. (2.3)). Note that

$$\rho_0 = \frac{(a+b)^3 - a^3 - b^3}{ab(a+b)} = \frac{3a^2b + 3ab^2}{ab(a+b)} = 3, \quad (2.24)$$

$$\begin{aligned} \rho_1 &= \frac{(a+b)^5 - a^5 - b^5}{ab(a+b)} \\ &= (ab)^{-1} [(a+b)^4 - a^4 - b^4 + ab(a^2 + b^2) - a^2b^2] \\ &= (ab)^{-1} [4ab(a^2 + b^2) + 6a^2b^2 + ab(a^2 + b^2) - a^2b^2] \\ &= 5(a^2 + b^2 + ab) \\ &= 5E, \end{aligned} \quad (2.25)$$

$$\begin{aligned} \rho_2 &= \frac{(a+b)^7 - a^7 - b^7}{ab(a+b)} \\ &= (ab)^{-1} [(a+b)^6 - a^6 - b^6 + ab(a^4 + b^4) - a^2b^2(a+b) + a^3b^3] \\ &= (ab)^{-1} [6ab(a^4 + b^4) + 15a^2b^2(a+b) + 20a^3b^3 + ab(a^4 + b^4) - a^2b^2(a+b) + a^3b^3] \\ &= 7(a^4 + b^4 + 2ab(a+b) + 3a^2b^2) \\ &= 7E^2 \end{aligned} \quad (2.26)$$

by (2.4) and (2.7).

Lemma 2.3. *For $3 \leq n \in \mathbb{Z}$, we have:*

$$\rho_n = 2E\rho_{n-1} - E^2\rho_{n-2} + \Delta\rho_{n-3}. \quad (2.27)$$

Proof. Note that

$$\begin{aligned} 2E\rho_{n-1} &= (ab(a+b))^{-1}(a^2+b^2+(a+b)^2)[(a+b)^{2n+1} - a^{2n+1} - b^{2n+1}] \\ &= (ab(a+b))^{-1}[(a^2+b^2)(a+b)^{2n+1} - a^{2n+3} - b^{2n+3} \\ &\quad - a^2b^2(a^{2n-1} + b^{2n-1}) + (a+b)^{2n+3} - (a+b)^2(a^{2n+1} + b^{2n+1})] \\ &= \rho_n + (ab(a+b))^{-1}[(a^2+b^2)(a+b)^{2n+1} - a^2b^2(a^{2n-1} + b^{2n-1}) \\ &\quad - (a+b)^2(a^{2n+1} + b^{2n+1})], \end{aligned} \quad (2.28)$$

$$\begin{aligned} &E^2\rho_{n-2} \\ &= (ab(a+b))^{-1}((a+b)^2(a^2+b^2) + a^2b^2)((a+b)^{2n-1} - a^{2n-1} - b^{2n-1}) \\ &= (ab(a+b))^{-1}[(a+b)^{2n+1}(a^2+b^2) - (a+b)^2(a^{2n+1} + b^{2n+1} + a^2b^2(a^{2n-3} + b^{2n-3})) \\ &\quad + a^2b^2(a+b)^{2n-1} - a^2b^2(a^{2n-1} + b^{2n-1})] \\ &= (ab(a+b))^{-1}[(a+b)^{2n+1}(a^2+b^2) - (a+b)^2(a^{2n+1} + b^{2n+1}) - \Delta(a^{2n-3} + b^{2n-3}) \\ &\quad + \Delta(a+b)^{2n-3} - a^2b^2(a^{2n-1} + b^{2n-1})] \\ &= (ab(a+b))^{-1}[(a+b)^{2n+1}(a^2+b^2) - (a+b)^2(a^{2n+1} + b^{2n+1}) \\ &\quad - a^2b^2(a^{2n-1} + b^{2n-1})] + \Delta\rho_{n-3} \end{aligned} \quad (2.29)$$

by (2.11). Thus we have

$$2E\rho_{n-1} - E^2\rho_{n-2} = \rho_n - \Delta\rho_{n-3}, \quad (2.30)$$

which is equivalent to (2.27). \square

By Lemma 2.3, we calculate

$$\rho_3 = 9E^3 + 3\Delta, \quad \rho_4 = 11E^4 + 11\Delta E, \quad \rho_5 = 13E^5 + 26\Delta E^2, \quad (2.31)$$

$$\rho_6 = 15E^6 + 50\Delta E^3 + 3\Delta^2, \quad \rho_7 = 17E^7 + 85\Delta E^4 + 17\Delta^2 E, \quad (2.32)$$

$$\rho_8 = 19E^8 + 133\Delta E^5 + 57\Delta^2 E^2, \quad \rho_9 = 21E^9 + 196\Delta E^6 + 147\Delta^2 E^3 + 3\Delta^3, \quad (2.33)$$

$$\rho_{10} = 23E^{10} + 276\Delta E^7 + 322\Delta^2 E^4 + 23\Delta^3 E. \quad (2.34)$$

Analyzing the coefficients in (2.31)-(2.34), we speculated the following theorem.

Theorem 2.4. For $n \in \mathbb{Z}_+$, we have

$$\rho_n = \sum_{i=0}^{\lfloor n/3 \rfloor} \frac{2n+3}{2i+1} \binom{n-i}{2i} \Delta^i E^{n-3i}, \quad (2.35)$$

which is equivalent to (1.16) by (2.4) and (2.5).

Proof. We shall prove (2.35) by (2.27) and induction on n . First for $m, k \in \mathbb{Z}_+$ such that $k \leq m-1$, we have

$$\begin{aligned} & \frac{2(2m+3)}{2k+1} \binom{m-k}{2k} - \frac{2m+1}{2k+1} \binom{m-k-1}{2k} + \frac{2m-1}{2k-1} \binom{m-k-1}{2k-2} \\ = & \frac{1}{2k(2k+1)(2k-1)} \binom{m-k-1}{2k-2} [2(2m+3)(m-k)(m-3k+1) \\ & - (2m+1)(m-3k+1)(m-3k) + 2k(2k+1)(2m-1)] \\ = & \frac{1}{2k(2k+1)(2k-1)} \binom{m-k-1}{2k-2} [2(2m+3)(m-k)(m-3k+1) \\ & - (2m+1)(m-3k+1)(m-k) + 2k(2m+1)(m-3k+1) + 2k(2k+1)(2m-1)] \\ = & \frac{1}{2k(2k+1)(2k-1)} \binom{m-k-1}{2k-2} [(2(2m+3) - (2m+1))(m-3k+1)(m-k) \\ & + 2k((2m+1)(m-3k+1) + (2k+1)(2m-1))] \\ = & \frac{1}{2k(2k+1)(2k-1)} \binom{m-k-1}{2k-2} [(2m+5)(m-3k+1)(m-k) \\ & + 2k(2m^2 - 6km + 2m + m - 3k + 1 + 4km - 2k + 2m - 1)] \\ = & \frac{1}{2k(2k+1)(2k-1)} \binom{m-k-1}{2k-2} [(2m+5)(m-3k+1)(m-k) \\ & + 2k(2m^2 - 2km + 5m - 5k)] \\ = & \frac{1}{2k(2k+1)(2k-1)} \binom{m-k-1}{2k-2} [(2m+5)(m-3k+1)(m-k) \\ & + 2k(2m+5)(m-k)] \\ = & \frac{(2m+5)(m-k+1)(m-k)}{2k(2k+1)(2k-1)} \binom{m-k-1}{2k-2} \\ = & \frac{2m+5}{2k+1} \binom{m+1-k}{2k}. \end{aligned} \quad (2.36)$$

Note that when $k=0$, $\binom{m-k-1}{2k-2} = 0$ and

$$\frac{2(2m+3)}{2k+1} \binom{m-k}{2k} - \frac{2m+1}{2k+1} \binom{m-k-1}{2k} = 2(2m+3) - (2m+1) = 2m+5. \quad (2.37)$$

When $n=1$, (2.35) holds by (2.25). Let $m \in \mathbb{Z}_+$. Suppose that (2.35) holds for $n \leq m$. By (2.35), we have the following cases.

Case 1. $m = 3l$ with $l \in \mathbb{Z}_+$.

$$\begin{aligned}
\rho_{m+1} &= 2 \sum_{i=0}^l \frac{2m+3}{2i+1} \binom{m-i}{2i} \Delta^i E^{m+1-3i} - \sum_{i=0}^{l-1} \frac{2m+1}{2i+1} \binom{m-i-1}{2i} \Delta^i E^{m+1-3i} \\
&\quad + \sum_{i=0}^{l-1} \frac{2m-1}{2i+1} \binom{m-i-2}{2i} \Delta^{i+1} E^{m-3i-2} \\
&= 2 \sum_{i=0}^l \frac{2m+3}{2i+1} \binom{m-i}{2i} \Delta^i E^{m+1-3i} - \sum_{i=0}^{l-1} \frac{2m+1}{2i+1} \binom{m-i-1}{2i} \Delta^i E^{m+1-3i} \\
&\quad + \sum_{i=0}^l \frac{2m-1}{2i-1} \binom{m-i-1}{2i-2} \Delta^i E^{m+1-3i} \\
&= \sum_{i=0}^{l-1} \left[\frac{2(2m+3)}{2i+1} \binom{m-i}{2i} - \frac{2m+1}{2i+1} \binom{m-i-1}{2i} + \frac{2m-1}{2i-1} \binom{m-i-2}{2i-2} \right] \\
&\quad \times \Delta^i E^{m+1-3i} + \left[\frac{2(6l+3)}{2l+1} \binom{2l}{2l} + \frac{6l-1}{2l-1} \binom{3l-l-1}{2l-2} \right] \Delta^l E^{m+1-3l} \\
&= \sum_{i=0}^{l-1} \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} + (6l+5) \Delta^l E^{m+1-3l} \\
&= \sum_{i=0}^{l-1} \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} + \frac{2m+5}{2l+1} \binom{m+1-l}{2l} \Delta^l E^{m+1-3l} \\
&= \sum_{i=0}^l \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} \\
&= \sum_{i=0}^{\lfloor (m+1)/3 \rfloor} \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} \tag{2.38}
\end{aligned}$$

Case 2. $m = 3l + 1$ with $l \in \mathbb{N}$.

$$\begin{aligned}
\rho_{m+1} &= 2 \sum_{i=0}^l \frac{2m+3}{2i+1} \binom{m-i}{2i} \Delta^i E^{m+1-3i} - \sum_{i=0}^l \frac{2m+1}{2i+1} \binom{m-i-1}{2i} \Delta^i E^{m+1-3i} \\
&\quad + \sum_{i=0}^{l-1} \frac{2m-1}{2i+1} \binom{m-i-2}{2i} \Delta^{i+1} E^{m-3i-2} \\
&= \sum_{i=0}^l \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} \\
&= \sum_{i=0}^{\lfloor (m+1)/3 \rfloor} \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} \tag{2.39}
\end{aligned}$$

Case 3. $m = 3l + 2$ with $l \in \mathbb{N}$.

$$\rho_{m+1} = 2 \sum_{i=0}^l \frac{2m+3}{2i+1} \binom{m-i}{2i} \Delta^i E^{m+1-3i} - \sum_{i=0}^l \frac{2m+1}{2i+1} \binom{m-i-1}{2i} \Delta^i E^{m+1-3i}$$

$$\begin{aligned}
& + \sum_{i=0}^l \frac{2m-1}{2i+1} \binom{m-i-2}{2i} \Delta^{i+1} E^{m-3i-2} \\
= & 2 \sum_{i=0}^l \frac{2m+3}{2i+1} \binom{m-i}{2i} \Delta^i E^{m+1-3i} - \sum_{i=0}^l \frac{2m+1}{2i+1} \binom{m-i-1}{2i} \Delta^i E^{m+1-3i} \\
& + \sum_{i=0}^{l+1} \frac{2m-1}{2i-1} \binom{m-i-1}{2i-2} \Delta^i E^{m+1-3i} \\
= & \sum_{i=0}^l \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} + \frac{6l+3}{2l+1} \binom{2l}{2l} \Delta^{l+1} E^{m-3l-2} \\
= & \sum_{i=0}^l \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} + 3\Delta^{l+1} E^{m-3l-2} \\
= & \sum_{i=0}^l \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} \\
& + \frac{2m+5}{2(l+1)+1} \binom{m+1-(l+1)}{2(l+1)} \Delta^{l+1} E^{m+1-3(l+1)} \\
= & \sum_{i=0}^{l+1} \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i} \\
= & \sum_{i=0}^{\lfloor (m+1)/3 \rfloor} \frac{2m+5}{2i+1} \binom{m+1-i}{2i} \Delta^i E^{m+1-3i}. \tag{2.40}
\end{aligned}$$

Thus (2.35) holds for $n = m + 1$. Therefore, (2.34) holds for any $n \in \mathbb{Z}_+$ by induction on n . \square

3 Theta Series and Weighted Symmetric Polynomials

In this section, we shall determine the theta series of certain infinite families of positive definite even unimodular lattices containing a sublattice of the same rank and isomorphic to the direct sum of finite copies of the lattices $R_{D_{2n}}$ with various n . The theta series of these lattices are weighted symmetric polynomials of the functions of $\{\Delta_{24}(z), h_n(z), \rho_n(z) \mid n \in \mathbb{Z}_+\}$. By (1.15) and (1.16), we essentially determine the theta series of these lattices as polynomials of the well-known Eisenstein series $E_4(z)$ and Ramanujan series $\Delta_{24}(z)$.

Let k be a positive integer. Suppose that $\{n_1, \dots, n_k\} \subset \mathbb{Z}_+$ is a subset. Set

$$\bar{n}_0 = 0, \quad \bar{n}_i = \sum_{j=1}^i n_j, \quad n = \bar{n}_k. \tag{3.1}$$

Recall the Euclidean space \mathbb{R}^n with inner product (1.8). All the lattices in this section have the symmetric bilinear form inherited from this inner product. Set

$$Q = \{\vec{\alpha} = (\alpha_1, \dots, \alpha_n) \in \mathbb{Z}^n \mid \sum_{j=1}^{n_i} \alpha_{\bar{n}_{i-1}+j} \in 2\mathbb{Z} \text{ for } i \in \overline{1, k}\} \subset \mathbb{R}^n. \quad (3.2)$$

Then Q is a lattice that isomorphic to $R_{D_{n_1}} \oplus \dots \oplus R_{D_{n_k}}$. For $j \in \mathbb{N}$, we denote

$$\mathbf{0}_j = (0, \dots, 0), \quad \mathbf{1}_j = (1, \dots, 1) \in \mathbb{R}^j. \quad (3.3)$$

Set

$$x_1^i = \frac{1}{2}(\mathbf{0}_{\bar{n}_{i-1}}, \mathbf{1}_{n_i}, \mathbf{0}_{n-\bar{n}_i}), \quad x_2^i = (\mathbf{0}_{\bar{n}_{i-1}}, 1, \mathbf{0}_{n-\bar{n}_{i-1}-1}), \quad x_3^i = x_1^i + x_2^i \in \mathbb{R}^n \quad (3.4)$$

for $i = 1, \dots, k$. When $k = 1$, we have

$$\Theta_Q(z) = \Theta_{R_{D_{n_1}}} = \frac{1}{2}(\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1}), \quad \Theta_{x_1^1+Q}(z) = \Theta_{x_3^1+Q}(z) = \frac{1}{2}\vartheta_2(z)^{n_1}, \quad (3.5)$$

$$\Theta_{x_2^1+Q}(z) = \frac{1}{2}(\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1}) \quad (3.6)$$

(cf. (1.12) and Chapter 4 of [CS3]). Moreover,

$$2x_1^1, 2x_2^1 \in Q \quad (3.7)$$

when n_1 is even. In fact, we have

$$\{\vec{\alpha} \in \mathbb{R}^n \mid \langle \vec{\alpha}, \vec{\beta} \rangle \in \mathbb{Z} \text{ for } \vec{\beta} \in Q\} = \sum_{i=1}^k (\mathbb{Z}x_1^i + \mathbb{Z}x_2^i) + Q \quad (3.8)$$

(eg., cf. [CS3] or [X3]).

Set

$$L = \sum_{i=1}^k \mathbb{Z}(x_1^i + x_2^1 + \dots + x_2^{i-1} + x_2^{i+1} + \dots + x_2^k) + Q. \quad (3.9)$$

When $k = 1$,

$$L = \mathbb{Z}x_1^1 + Q. \quad (3.10)$$

Theorem 3.1. *If $k = 2\ell + 1$ is an odd positive integer and $n_i = 8m_i$ with $\ell \in \mathbb{N}$ and $m_i \in \mathbb{Z}_+$, then L is a positive definite even unimodular lattice with the theta series*

$$\begin{aligned} & 2^{2\ell+1} \Theta_L(z) \\ = & \sum_{1 \leq j_1 \leq j_2; j_1+j_2 \leq \ell} \text{sym}\{h_{m_1+\dots+m_{2j_1}}(z) h_{m_{2j_1+1}+\dots+m_{2(j_1+j_2)}}(z) h_{m_{2(j_1+j_2)+1}+\dots+m_{2\ell+1}}(z)\} \end{aligned}$$

$$\begin{aligned}
& - \sum_{0 \leq j_1 \leq j_2 \leq \ell - j_1 - j_2 - 1} \text{sym}\{h_{m_1 + \dots + m_{2j_1+1}}(z) h_{m_{2j_1+2} + \dots + m_{2(j_1+j_2+1)}}(z) \\

&= \sum_{1 \leq j_1 \leq j_2 \leq \ell - j_1 - j_2} \text{sym}\{(\vartheta_2(z)^{n_1 + \dots + n_{2j_1}} + \vartheta_3(z)^{n_1 + \dots + n_{2j_1}} + \vartheta_4(z)^{n_1 + \dots + n_{2j_1}}) \\
&\quad \times (\vartheta_2(z)^{n_{2j_1+1} + \dots + n_{2(j_1+j_2)}} + \vartheta_3(z)^{n_{2j_1+1} + \dots + n_{2(j_1+j_2)}} + \vartheta_4(z)^{n_{2j_1+1} + \dots + n_{2(j_1+j_2)}}) \\
&\quad \times (\vartheta_2(z)^{n_{2(j_1+j_2)+1} + \dots + n_{2\ell}} + \vartheta_3(z)^{n_{2(j_1+j_2)+1} + \dots + n_{2\ell}} + \vartheta_4(z)^{n_{2(j_1+j_2)+1} + \dots + n_{2\ell}})\} \\

&= \sum_{1 \leq j_1 \leq j_2 \leq \ell - j_1 - j_2} \text{sym}\{h_{m_1 + \dots + m_{2j_1} + j_1}(z)h_{m_{2j_1+1} + \dots + m_{2(j_1+j_2)} + j_2}(z) \\
&\quad \times h_{m_{2(j_1+j_2)+1} + \dots + m_{2\ell} + \ell - j_1 - j_2}(z)\} - 2^8 \Delta_{24}(z) \sum_{1 \leq j_1, j_2; j_1 + j_2 \leq \ell - 2} \text{sym}\{\rho_{m_1 + \dots + m_{2j_1+1} + j_1 - 1}(z) \\
&\quad \times \rho_{m_{2j_1+2} + \dots + m_{2(j_1+j_2+1)} + j_2 - 1}(z)h_{m_{2(j_1+j_2)+3} + \dots + m_{2\ell} + \ell - j_1 - j_2 - 1}(z)\} \\
&\quad + 3 \sum_{j=1}^{\lfloor \ell/2 \rfloor} \text{sym}\{h_{m_1 + \dots + m_{2j} + j}(z)h_{m_{2j+1} + \dots + m_{2\ell} + \ell - j}(z)\} + 2^8 \Delta_{24}(z) \\
&\quad \times \sum_{j=0}^{\lfloor (\ell-1)/2 \rfloor} (2^{2j} + 2^{2(\ell-j-1)} - 3) \text{sym}\{\rho_{m_1 + \dots + m_{2j+1} + j - 1}(z)\rho_{m_{2j+2} + \dots + m_{2\ell} + \ell - j - 2}(z)\} \\
&\quad + \left(4 - \frac{2}{3} \sum_{j_1 + j_2 \leq \ell} \binom{2\ell}{2j_1, 2j_2}\right) h_{m_1 + \dots + m_{2\ell} + \ell}(z). \quad \square \tag{3.33}
\end{aligned}$$

According to the above theorem, we have the following theta series of the lattice (3.9) with the assumption on n_i as in the theorem:

$$\Theta_L(z) = \frac{1}{2} h_{m_1}(z) \tag{3.34}$$

when $k = 1$;

$$\Theta_L(z) = \frac{1}{2}h_{m_1+m_2+1}(z) - 64\Delta_{24}(z)\rho_{m_1-1}(z)\rho_{m_2-1}(z) \quad (3.35)$$

when $k = 2$;

$$\begin{aligned} \Theta_L(z) = & -\frac{1}{2}h_{m_1+m_2+m_3}(z) + \frac{1}{4}(h_{m_1}(z)h_{m_2+m_3}(z) + h_{m_2}(z)h_{m_1+m_3}(z) \\ & + h_{m_3}(z)h_{m_1+m_2}(z)) - \frac{1}{8}h_{m_1}(z)h_{m_2}(z)h_{m_3}(z) \end{aligned} \quad (3.36)$$

when $k = 3$;

$$\begin{aligned} & \Theta_L(z) \\ = & 16\Delta_{24}(z)[2 \operatorname{sym}\{\rho_{m_1-1}(z)\rho_{m_2+m_3+m_4}(z)\} - \operatorname{sym}\{h_{m_1+m_2+1}(z)\rho_{m_3-1}(z)\rho_{m_4-1}(z)\}] \\ & + \frac{1}{16}[3 \operatorname{sym}\{h_{m_1+m_2+1}(z)h_{m_3+m_4+1}(z)\} - 10h_{m_1+m_2+m_3+m_4+2}(z)] \end{aligned} \quad (3.37)$$

when $k = 4$;

$$\begin{aligned} \Theta_L(z) = & \frac{1}{32}[\operatorname{sym}\{h_{m_1}(z)h_{m_2+m_3}(z)h_{m_4+m_5}(z)\} - \operatorname{sym}\{h_{m_1}(z)h_{m_2}(z)h_{m_3+m_4+m_5}(z)\} \\ & 2 \operatorname{sym}\{h_{m_1}(z)h_{m_2+m_3+m_4+m_5}(z)\} - \operatorname{sym}\{h_{m_1+m_2}(z)h_{m_3+m_4+m_5}(z)\} \\ & - 4h_{m_1+m_2+m_4+m_5}(z)] \end{aligned} \quad (3.38)$$

when $k = 5$;

$$\begin{aligned} & \Theta_L(z) \\ = & \frac{1}{64}[-118h_{m_1+m_2+m_3+m_4+m_5+m_6+3}(z) + 3 \operatorname{sym}\{h_{m_1+m_2+1}(z)h_{m_3+m_4+m_5+m_6+2}(z)\} \\ & + \operatorname{sym}\{h_{m_1+m_2+1}(z)h_{m_3+m_4+1}(z)h_{m_5+m_6+1}(z)\}] - 4\Delta_{24}(z)[\operatorname{sym}\{h_{m_1+m_2+1}(z) \\ & \times \rho_{m_3-1}(z)\rho_{m_4+m_5+m_6}(z)\} + \operatorname{sym}\{h_{m_1+m_2+m_3+m_4+2}(z)\rho_{m_5-1}(z)\rho_{m_6-1}(z)\} \\ & - 14 \operatorname{sym}\{\rho_{m_1-1}(z)\rho_{m_2+m_3+m_4+m_5+m_6+1}(z)\} \\ & - 5 \operatorname{sym}\{\rho_{m_1+m_2+m_3}(z)\rho_{m_4+m_5+m_6}(z)\}] \end{aligned} \quad (3.39)$$

when $k = 6$. In particular, we have

$$\text{the theta series of Niemeier lattice of type } D_{24} = E_4^3(z) + 384\Delta_{24}(z) \quad (3.40)$$

by (3.34);

$$\text{the theta series of Niemeier lattice of type } D_{12}^2 = E_4^3(z) - 192\Delta_{24}(z) \quad (3.41)$$

by (3.35);

$$\text{the theta series of Niemeier lattice of type } D_8^3 = E_4^3(z) - 384\Delta_{24}(z) \quad (3.42)$$

by (3.36). We refer to [N] for the Niemeier lattices.

Remark 3.2. In the case $k = 2\ell$ and $n_1 = n_2 = \cdots = n_{2\ell} = 4$, the lattice L in Theorem 3.1 contains a sublattice isomorphic to $R_{D_{8\ell}}$, and $\Theta_L(z) = h_\ell(z)/2$. The theta series $\Theta_L(z)$ in (3.12) is different from that in (3.11) if not all m_i are zero.

We go back to the settings in (3.1)-(3.8). Assume that $k = 4$ and $n_i = 8m_i + 4\epsilon + 2$ with $m_i \in \mathbb{N}$ and $\epsilon = 0, 1$. Set

$$L = \mathbb{Z}(x_2^1 + x_3^3 + x_3^4) + \mathbb{Z}(x_2^2 + x_3^4 + x_3^1) + \mathbb{Z}(x_2^3 + x_3^1 + x_3^2) + \mathbb{Z}(x_2^4 + x_3^2 + x_3^3) + Q \quad (3.43)$$

(cf. (3.4)).

Theorem 3.3. *The lattice L in (3.43) is a positive definite even unimodular lattice with the theta series*

$$\begin{aligned} \Theta_L(z) &= \frac{1}{2}h_{m_1+m_2+m_3+m_4+2\epsilon+1}(z) - 32\Delta_{24}(z)(\rho_{m_1+m_2+\epsilon-1}(z)\rho_{m_3+m_4+\epsilon-1}(z) \\ &\quad + \rho_{m_1+m_3+\epsilon-1}(z)\rho_{m_2+m_4+\epsilon-1}(z) + \rho_{m_1+m_4+\epsilon-1}(z)\rho_{m_2+m_3+\epsilon-1}(z)). \end{aligned} \quad (3.44)$$

Proof. L is unimodular by (1.11) and (3.7)-(3.9). By (3.5)-(3.7) and calculating the theta series of the cosets in L/Q , we obtain

$$\begin{aligned} &2^4\Theta_L(z) \\ &= \vartheta_2(z)^{n_3+n_4}(\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1})(\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_2}) + \vartheta_2(z)^{n_1+n_4}(\vartheta_3(z)^{n_2} - \vartheta_4(z)^{n_2}) \\ &\quad \times (\vartheta_3(z)^{n_3} + \vartheta_4(z)^{n_3}) + \vartheta_2(z)^{n_1+n_2}(\vartheta_3(z)^{n_3} - \vartheta_4(z)^{n_3})(\vartheta_3(z)^{n_4} + \vartheta_4(z)^{n_4}) \\ &\quad + \vartheta_2(z)^{n_2+n_3}(\vartheta_3(z)^{n_4} - \vartheta_4(z)^{n_4})(\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1}) + \vartheta_2(z)^{n_1+n_3}(\vartheta_3(z)^{n_2} - \vartheta_4(z)^{n_2}) \\ &\quad \times (\vartheta_3(z)^{n_4} + \vartheta_4(z)^{n_4}) + \vartheta_2(z)^{n_1+n_2+n_3+n_4} + \vartheta_2(z)^{n_2+n_4}(\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1}) \\ &\quad \times (\vartheta_3(z)^{n_3} + \vartheta_4(z)^{n_3}) + \vartheta_2(z)^{n_2+n_4}(\vartheta_3(z)^{n_3} - \vartheta_4(z)^{n_3})(\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1}) \\ &\quad + \vartheta_2(z)^{n_1+n_2+n_3+n_4} + \vartheta_2(z)^{n_1+n_3}(\vartheta_3(z)^{n_4} - \vartheta_4(z)^{n_4})(\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_2}) + \vartheta_2(z)^{n_2+n_3} \\ &\quad \times (\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1})(\vartheta_3(z)^{n_4} + \vartheta_4(z)^{n_4}) + \vartheta_2(z)^{n_1+n_2}(\vartheta_3(z)^{n_4} - \vartheta_4(z)^{n_4}) \\ &\quad \times (\vartheta_3(z)^{n_3} + \vartheta_4(z)^{n_3}) + \vartheta_2(z)^{n_1+n_4}(\vartheta_3(z)^{n_3} - \vartheta_4(z)^{n_3})(\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_2}) \\ &\quad + \vartheta_2(z)^{n_3+n_4}(\vartheta_3(z)^{n_2} - \vartheta_4(z)^{n_2})(\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1}) + (\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1})(\vartheta_3(z)^{n_2} \\ &\quad - \vartheta_4(z)^{n_2})(\vartheta_3(z)^{n_3} - \vartheta_4(z)^{n_3})(\vartheta_4(z)^{n_1} - \vartheta_4(z)^{n_4}) + (\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1}) \\ &\quad \times (\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_2})(\vartheta_3(z)^{n_3} + \vartheta_4(z)^{n_3})(\vartheta_4(z)^{n_1} + \vartheta_4(z)^{n_4}) \\ &= \vartheta_2(z)^{n_3+n_4}[(\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1})(\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_2}) + (\vartheta_3(z)^{n_2} - \vartheta_4(z)^{n_2}) \\ &\quad \times (\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1})] + \vartheta_2(z)^{n_1+n_4}[(\vartheta_3(z)^{n_2} - \vartheta_4(z)^{n_2})(\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_3}) \\ &\quad + (\vartheta_3(z)^{n_3} - \vartheta_4(z)^{n_3})(\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_2})] + \vartheta_2(z)^{n_1+n_2}[(\vartheta_3(z)^{n_3} - \vartheta_4(z)^{n_3}) \end{aligned}$$

$$\begin{aligned}
& \times (\vartheta_3(z)^{n_4} + \vartheta_4(z)^{n_4}) + (\vartheta_3(z)^{n_4} - \vartheta_4(z)^{n_4})(\vartheta_3(z)^{n_3} + \vartheta_4(z)^{n_3}) \\
& + \vartheta_2(z)^{n_2+n_3} [(\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1})(\vartheta_3(z)^{n_4} + \vartheta_4(z)^{n_4}) + (\vartheta_3(z)^{n_4} - \vartheta_4(z)^{n_4}) \\
& \times (\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1})] + \vartheta_2(z)^{n_1+n_3} [(\vartheta_3(z)^{n_2} - \vartheta_4(z)^{n_2})(\vartheta_3(z)^{n_4} + \vartheta_4(z)^{n_4}) \\

& + 2\vartheta_2(z)^{n_1+n_2+n_3+n_4} + (\vartheta_3(z)^{n_1} - \vartheta_4(z)^{n_1})(\vartheta_3(z)^{n_2} - \vartheta_4(z)^{n_2})(\vartheta_3(z)^{n_3} - \vartheta_4(z)^{n_3}) \\
& \times (\vartheta_4(z)^{n_1} - \vartheta_4(z)^{n_4}) + (\vartheta_3(z)^{n_1} + \vartheta_4(z)^{n_1})(\vartheta_3(z)^{n_2} + \vartheta_4(z)^{n_2}) \\
& \times (\vartheta_3(z)^{n_3} + \vartheta_4(z)^{n_3})(\vartheta_4(z)^{n_1} + \vartheta_4(z)^{n_4}) \\
= & 2[-(\vartheta_3(z)^{n_1+n_2} - \vartheta_2(z)^{n_1+n_2} - \vartheta_4(z)^{n_1+n_2})(\vartheta_3(z)^{n_3+n_4} - \vartheta_2(z)^{n_3+n_4} - \vartheta_4(z)^{n_3+n_4}) \\
& - (\vartheta_3(z)^{n_1+n_3} - \vartheta_2(z)^{n_1+n_3} - \vartheta_4(z)^{n_1+n_3})(\vartheta_3(z)^{n_2+n_4} - \vartheta_2(z)^{n_2+n_4} - \vartheta_4(z)^{n_2+n_4}) \\
& - (\vartheta_3(z)^{n_1+n_4} - \vartheta_2(z)^{n_1+n_4} - \vartheta_4(z)^{n_1+n_4})(\vartheta_3(z)^{n_2+n_3} - \vartheta_2(z)^{n_2+n_3} - \vartheta_4(z)^{n_2+n_3}) \\
& + 4(\vartheta_2(z)^{n_1+n_2+n_3+n_4} + \vartheta_3(z)^{n_1+n_2+n_3+n_4} + \vartheta_4(z)^{n_1+n_2+n_3+n_4})] \\
= & 2[4h_{m_1+m_2+m_3+m_4+2\epsilon+1} - 2^8\Delta_{24}(z)\text{sym}\{\rho_{m_1+m_2+\epsilon-1}\rho_{m_3+m_4+\epsilon-1}\}], \tag{3.45}
\end{aligned}$$

which implies (3.44). \square

By (3.44) with $m_1 = m_2 = m_3 = m_4 = 0$ and $\epsilon = 1$, we have

$$\text{the theta series of Niemeier lattice of type } D_6^4 = E_4(z)^3 - 480\Delta_{24}(z) \tag{3.46}$$

(cf. [N]).

Remark 3.4. (a) The theta series in (3.44) is different from those in (3.11) and (3.12) if $(m_1, m_2, m_3, m_4, \epsilon) \neq (0, 0, 0, 0, 0)$.

(b) The above families of lattices are the infinite families of positive definite even unimodular lattices whose theta series are weighted symmetric polynomials of the functions of $\{\Delta_{24}(z), h_n(z), \rho_n(z) \mid n \in \mathbb{Z}_+\}$ that we can find so far. We speculate that the theta series of the other infinite families of positive definite even-unimodular lattices may be related to the invariants of the other finite groups.
