# Geophysicalm odeling and microbcal properties of Colombeau functions

#### A bstract

In global seism ology Earth's properties of fractal nature occur. Zygm und classes appear as the most appropriate and system atic way to measure this local fractality. For the purpose of seism is wave propagation, we model the Earth's properties as Colom beau generalized functions. In one spatial dimension, we have a precise characterization of Zygm und regularity in Colom beau algebras. This is made possible via a relation between molli ers and wavelets.

#### 1 Introduction

W ave propagation in highly irregular media. In global seism ology, (hyperbolic) partial di erential equations the coe cients of which have to be considered generalized functions; in addition, the source mechanisms in such application are highly singular in nature. The coe cients model the (elastic) properties of the Earth, and their singularity structure arises from geological and physical processes. These processes are believed to reject them selves in a multi-fractal behavior of the Earth's properties. Zygm und classes appear as the most appropriate and system atic way to measure this local fractality (cf. [2, Chap 4]).

The modeling process and Colom beau algebras. In the seism ic transm ission problem, the diagonalization of the rst order system of partial dierential equations and the transformation to the second order wave equation requires dierentiation of the coe cients. Therefore, highly discontinuous coe cients will appear naturally although the original model medium varies continuously. However, embedding the fractal coe cient rst into the Colombeau algebra ensures the equivalence after transformation and yields unique solvability if the regularization scaling is chosen appropriately (cf. [7, 9, 4]). We use the framework

and notation (in particular, G for the algebra and  $A_{\rm N}$  for the molli er sets) of Colombeau algebras as presented in [10].

An interesting aspect of the use of Colom beau theory in wave propagation is that it leads to a natural control over and understanding of 'scale'. In this paper, we focus on this modeling process.

#### 2 Basic de nitions and constructions

#### 2.1 Review of Zygm und spaces

We brie y review hom ogeneous and inhom ogeneous Zygm und spaces,  $C^s(\mathbb{R}^m)$  and  $C^s(\mathbb{R}^m)$ , via a characterization in pseudodi erential operator style which follows essentially the presentation in [3], Sect. 8.6. A lternatively, for practical and implementation issues one may prefer the characterization via growth properties of the discrete wavelet transform using orthonormal wavelets (cf. [8]).

C lassically, the Zygm und spaces were de ned as extension of Holder spaces by boundedness properties of di erence quotients. Within the system atic and uni ed approach of Triebel (cf. [12, 14]) we can simply identify the Zygm und spaces in a scale of inhom ogeneous and hom ogeneous (quasi) B anach spaces, B  $_{\rm pq}^{\rm S}$  and B  $_{\rm pq}^{\rm S}$  (s 2 R, 0 < p;q 1), by C  $^{\rm S}$  (R  $^{\rm m}$ ) = B  $_{1}^{\rm S}$  (R  $^{\rm m}$ ) and G  $^{\rm S}$  (R  $^{\rm m}$ ) are B anach spaces.

To emphasize the close relation with molliers we describe a characterization of Zygm und spaces in pseudodierential operator style in more detail.

and note that if a < j j < b then ( ) =  $\binom{0}{0}$  (j j) j j > 0. We denote by M ( $\mathbb{R}^n$ ) the set of all pairs ('; ) 2 D ( $\mathbb{R}^m$ )<sup>2</sup> that are constructed as above (we usually suppress the dependence of M on a and b in the notation).

We are now in aposition to state the characterization theorem for the inhomogeneous Zygm und spaces as subspaces of S  $^0$  (R  $^m$  ). It follows from [13], Sec. 2.3, Thm. 3 or, alternatively, from [3], Sec. 8.6. Note that all appearing pseudodierential operators in the following have x-independent symbols and are thus given simply by convolutions.

- Remark 2. (i) juj $_{S}$  de nes an equivalent norm on  $C^{S}$ . In fact that all norms de ned as above by some ('; ) 2 M ( $R^{m}$ ) are equivalent can be seen as in [3], Lem m a 8.6.5.
  - (ii) If s 2 R<sub>+</sub> n N then C<sup>s</sup> ( $R^m$ ) is the classical Holder space of regularity s. Denoting by bsc the greatest integer less than s it consists of all bsc times continuously dierentiable functions f such that 0 f is bounded when j j bsc and globally Holder continuous with exponent s bsc if j j= bsc.

#### 2.2 The continuous wavelet transform

Following [2] we call a function  $g 2 L^1(\mathbb{R}^m) \setminus L^1(\mathbb{R}^m)$  with g = 0 a wavelet. We shall say that it is a wavelet of order m  $(m 2 N_0)$  if the moments up to order m vanish, i.e., x g(x) dx = 0 for j j m.

The (continuous) wavelet transform is de ned for f 2  $L^p(\mathbb{R}^m)$  (1 p 1 ) by ("> 0)

R em ark 3. If f is a polynom ial and g 2  $S_0$  it is easy to see that  $W_g f = 0$ . In fact, f, g, and  $W_g f$  are in  $S^0$  and  $(W_g f (:;")) = fg(":)$ . Since g is in  $S_0$  the Fourier transform g(":) is smooth and vanishes of in nite order at 0. But f has to be a linear combination of derivatives of f0 in plying f0 f0 f0. Therefore the wavelet transform f1 is blind to polynom ial parts of the analyzed function (or distribution) f. In term sofgeophysicalm odeling this means that a polynom ially varying background medium is litered out automatically.

#### 2.3 W avelets from molli ers

The Zygm und class characterization in Theorem 1 (and remark 2,(v)) used asymptotic estimates of scaled smoothings of the distribution which resembles typical molli erconstructions in Colombeau theory. In this subsection we relate this in turn directly to the wavelet transform obtaining the well-known wavelet characterization of Zygm und spaces.

- Remark 5. (i) Observe that the condition on bimplies that and hence can never have compact support. Since we will rely on such characterizations in a theory of Zygm und regularity detection within Colombeau theory we have to allow for molliers of this kind in the corresponding embedding procedures. This is the issue of the following subsection. Nevertheless we note here that according to remarks in [5], (22) and (3.1), the restrictions on the wavelet itself in a characterization of type (7) may be considerably relaxed | depending on the generality one wishes to allow for the analyzed distribution u. However, (for arbitrary space dimension m) these statements do neither include precise properties required of the wavelet nor on the aprioriknowledge about the analyzed distribution. In case m = 1 and u is a function precise formulations of such characterizations (mainly due to Holschneider and Toham itchian) can be found in [1], Sect. 2.9, or [2], Sect. 4.2.
  - (ii) There are more rened results in the spirit of the above theorem describing local Holder (Zygmund) regularity by growth properties of the wavelet transform (cf. in particular [2], Sect. 42, [6], and [5]).
  - (iii) The counterpart of (7) for  $L^1_{loc}$ -functions in terms of multiresolution approximations is [8], Sect. 6.4, Thm. 5.

#### 3 Colom beau modeling and wavelet transform

### 3.1 Embedding of temperate distributions

We consider a variant of the Colombeau embedding  $: D^0(\mathbb{R}^m) : G(\mathbb{R}^m)$  that was discussed in [4], subsect. 32. As indicated in remark 5, (i) we need to allow for molli ers with noncompact support in order to gain the exhibility of using wavelet-type arguments for the extraction of regularity properties from asymptotic estimates. On the side of the embedded distributions this forces us to restrict to  $S^0$ , a space still large enough for the geophysically motivated one cients in model PDEs.

Recall ([4], Def. 11) that an adm issible scaling is defined to be a continuous function  $: (0;1) ! R_+$  such that (r) = 0 (1=r), (r) ! 1, and (sr) = 0 ((r)) if 0 < s < 1 (xed) as <math>r ! 0.

The following statements describe properties of such a modeling procedure resembling the original properties used by M . O berguggenberger in [9], Prop.1.5, to ensure unique solvability of sym metric hyperbolic systems of PDEs (cf. [9,7]). The denition of Colombeau functions of logarithmic and bounded type is given in [10], Def. 192, the variation used below is an obvious extension.

In particular, we can model a fairly large class of distributions as Colombeau functions of logarithm ic growth (or log-type) thereby ensuring unique solvability of hyperbolic PDEs incorporating such as coe cients.

#### 3.2 W ave front sets under the embedding

One of the most important properties of the embedding procedure introduced in [4] was its faithfulness with respect to the microlocal properties if appropriately measured in terms of the set of regular Colombeau functions  $G^1$  ( $\mathbb{R}^m$ ) ([4], Def. 11). But there the proof of this microlocal invariance property heavily used the compact support property of the standard mollier which is no longer true in the current situation. In this subsection we show how to extend the invariance result to the new embedding procedure de ned above.

Referring to the proof (and the notation) of [4], Thm. 15, we may now nish the proof of the theorem simply by carrying out the following slight changes in the two steps of that proof.

#### 3.3 The modeling procedure and wavelet transform s

Sim ple wavelet-molli er correspondences as in subsection 2.3 allow us to rewrite the Colom beau modeling procedure and hence prepare for the detection of original Zygm und regularity in terms of growth properties in the scaling parameters.

Both lem m as 11 and 12 m ay be used to translate (global) Zygm und regularity of the modeled (embedded) distribution f via Thm. 7 into asymptotic growth properties with respect to the regularization parameter. To what extent this can be utilized to develop a faithful and completely intrinsic Zygm und regularity theory of Colom beau functions may be subject of future research.

## 4 Zygm und regularity of Colom beau functions: the one-dim ensional case

If we combine the basic ideas of the Zygm und class characterization in 2.3 with the simple observations in 3.3 we are naturally lead to de ne a corresponding regularity notion intrinsically in Colombeau algebras as follows.

De nition 13. Let be an adm issible scaling function and s be a real number. A Colombeau function U 2 G ( $R^m$ ) is said to be globally of -Zygm und regularity s if for all 2  $N_0^m$  there is M 2  $N_0$  such that for all 2  $A_M$  ( $R^m$ ) we can not positive constants C and such that

The set of all (globally) — Zygm und regular C olom beau functions of orders will be denoted by  $G^s$  .

We brie y study the case m=1 and s>0 in some detail. Concerning applications to PDEs this would mean that we are allowing for media of typical fractal nature varying continuously in one space dimension. For example one may think of a coe cient function f in C  $^s$  (R) to appear in the following ways.

- Example 14. (i) Let f be constant outside some interval (K;K) and equal to a typical trajectory of Brownian motion in [K;K]; it is well-known that with probability 1 those trajectories are in  $C^S(R)$  whenever s < 1=2. This is proved, e.g., in [2], Sect. 4.4, elegantly by wavelet transform methods.
  - (ii) We refer to [15], Sect. V.3, for notions and notation in this example. Then similarly to the above one can set f = 0 in (1;0], f = 1 in [2;1) and

in [0;2] let f be Lebesgue's singular function associated with a Cantor-type set of order d 2 N with (constant) dissection ratio 0 < 1=2. Then f belongs to C  $^s$  (R) with  $s = \log(d+1)=j\log()$  j. (The classical triadic Cantor set corresponds to the case d=2 and d=1=3.)

We have already seen that the Colombeau embedding does not change the microlocal structure (ie., the —wave front set) of the original distribution. We will show now that also the rened Zygm und regularity information is accurately preserved. If n 2 N<sub>0</sub> we denote by  $C_b^n(R)$  the set of all n times continuously dierentiable functions with the derivatives up to order n bounded. Note that  $C_b^n(R)$  is a strict superset of  $C^{n+1}(R)$ .

In other words, in case 0 < s < 1 we can precisely identify those Colombeau functions that arise from the Zygm und class of order s within all embedded bounded continuous functions.
