The Plancherel decom position for a reductive sym metric space I. The spherical part

A bstract

We prove the Plancherel formula for spherical Schwartz functions on a reductive sym metric space. Our starting point is an inversion formula for sphericals mooth compactly supported functions. The latter formula was earlier obtained from the most continuous part of the Plancherel formula by means of a residue calculus. In the course of the present paper we also obtain new proofs of the uniform tempered estimates for normalized Eisenstein integrals and of the Maass-Selberg relations satis ed by the associated C-functions.

1 Introduction

In this paper and its sequel [14] we determ ine the P lancherel decomposition for a reductive symmetric space X = G = H : H ere G is a real reductive Lie group of H arish-C handra's class and H is an open subgroup of the group G of xed points for an involution of G : In the present paper we establish the P lancherel form ula for K - n ite (spherical) Schwartz functions on X : W ith K = - n invariant maximal compact subgroup of G : In [14] we shall derive the P lancherel decomposition, in the sense of representation theory, from it.

The space X carries a G-invariant measure dx; accordingly the regular representation L of G in L^2 (X) is unitary. The P lancherel decomposition amounts to an explicit decomposition of L as a direct integral of irreducible unitary representations. The reductive group G is a symmetric space of its own right, for the left times right action of G G: In this base of the group', the explicit P lancherel decomposition was obtained in the sixties and early seventies in the work of H arish-C handra, see [25], [26], [27]. H is ideas, in particular those on the role of E isenstein integrals and the M aass-Selberg relations satisfied by them, have been a major in when work of nour work. On the other hand, our approach to the P lancherel formula is via a residue calculus, and thus in a sense closer in spirit to the work of R P. Langlands on the spectral decomposition in the theory of autom orphic forms, see [30].

The results of this paper and [14] were found and announced in the fall of 1995 when both authors were visitors of the M ittag-Le er Institute in D jursholm, Sweden. At the same time P.Delome announced his proof of the Plancherel theorem. His results have appeared in a series of papers, partly

in collaboration with J.Carm ona, culm inating in [21]. It should be said that at the time of the announcement we relied on Delome's theorem on the Maass-Selberg relations in [20]. In the meantime we have been able to derive the relations from those associated with the most continuous part of the decomposition; these had been obtained earlier in [5], [6]. The resulting proof of the Plancherel theorem in the present paper and [14] is independent of the one in [21]; moreover, it follows a completely dierent approach. Finally, we mention that T.O shim a has announced a Plancherel formula in [32], p. 604, but the details have not appeared. For reductive symmetric spaces of type $G_c = G_R$; the Plancherel formula is due to P.Harinck, [23].

We rst give a rough outline of the contents of this paper and its sequel [14]. The following global picture should be kept in mind. We rst concentrate on the Plancherel formula for K - nite functions, with K G a m axim alcom pact subgroup that is chosen to be -stable. The latter condition is equivalent to the condition that the Cartan involution determined by K commutes with: The building blocks of the formula will be discrete series representations of X and generalized principal series of the form Indp (1); with $P = M_P A_P N_P a$ -stable parabolic subgroup of G with the indicated Langlands decomposition, a discrete series representation of $X_P := M_P = M_P \setminus H$ and contained in the space $ia_{p,q}$ of unitary characters of $A_P = A_P \setminus H$: For purposes of exposition this introduction is written under the simplifying assumption that the number of open H -orbits on P nG is one. In general the open orbits are param etrized by a nite set PW of representatives, and then one should take for the discrete series representations of all the spaces $X_{P,v} := M_P = M_P \setminus vH v^{-1}; v \cdot 2^P W$:

In [10] we obtained the most continuous part of the P lancherel decomposition; this is the part built up from representations obtained by induction from a minimal stable parabolic subgroup P $_0$ = M $_0$ A $_0$ N $_0$ Here M $_0$ =M $_0$ \ H is compact, so the theory of the discrete series did not enter at this stage. On the level of K - nite functions the most continuous part of the formula is described via a Fourier transform F $_0$; which in turn is dened in terms of E is enstein integrals E (P $_0$:): The latter are essentially matrix coecients of the principal series induced from P $_0$ and behave nitely under the action of the algebra D (X) of invariant dierential operators on X:

From them ost continuous part of the P lancherel decom position we derived in [12] a Fourier inversion formula for functions in C_c^1 (X:); the space of sm ooth compactly supported -spherical functions on X; with a nite dimensional unitary representation of K: This formula expresses a function f in terms of F_0f :

The strategy of the present paper is to put the inversion form ula in a form that makes it valid for functions in the Schwartz space C (X:): This requires the introduction of E isenstein integrals E (P:) via residues of the E isenstein integrals E (Po:): To show that these residual E isenstein integrals de ne Fourier transforms on the Schwartz space we need the Maass-Selberg relations. It is here that the theory of the discrete series, initiated by M. Flensted-Jensen in [22] and further developed by T.O shim a and T.M atsuki in [33], enters. In our proofs we do not need the full classic cation of the discrete series. However, for

the theory of the constant term developed in [15] to apply, both the necessity of the rank condition and the fact that the in nitesimalD (X)-characters of discrete series representations are real and regular (see Theorem 16.1, due to [33]), play a crucial role.

The resulting inversion formula for Schwartz functions is called the spherical P lancherel formula, see Theorem s 21.2 and 23.1. It naturally leads to the spherical P lancherel formula for L^2 -functions, Theorem 23.4. The present paper nishes at this point, where it is not yet clear that the residual E isenstein integrals are related to induced representations. This fact will be established in the second paper [14] by using the vanishing theorem of [13]. The contributions of all K-types can then be collected and lead to the representation theoretic P lancherel formula. At the end of the second paper it will also be shown that the residual E isenstein integrals E (P:) equal the normalized E isenstein integrals introduced in D elorme's paper [19]. The idea is to use the automatic continuity theorem of W. Casselm an and N.R. Wallach ([18], [35]) to show that the residual E isenstein integrals are matrix coecients. An asymptotic analysis then completes the identication.

We shall now give a more detailed outline of the present paper. The rst few sections concern prelim inaries. In particular, in Section 5 we specify the normalizations of the residual operators and the measures used in the rest of the paper. In Section 6 we give a formulation of the vanishing theorem of [13], in a form suitable for this paper. In Section 8 we recall the inversion form ula of [12]. Let $\,$ be the root system of a_q in g and let W $\,$ be the associated W eyl group. Let $\,$ be the system of simple roots associated with the m inimal element P_0 from P: For each F; let P_F = M_F A_F N_F denote the associated standard parabolic subgroup in P: Then the inversion form ula is of the form

To make the above formula valid for Schwartz functions it is necessary to establish it with " $_{\rm F}=0$; for every F: This can be achieved by using C auchy's formula, once we have establised the regularity at ${\rm ia_{F\ q}}$ of the kernel functions K $_{\rm F}^{\rm t}$ (;x;y) in the variable : In addition to this we need estimates that are tempered in the variables x;y with uniform ity in 2 ${\rm ia_{Q\ q}}$: A llthis is taken care ofby a long inductive argument, that ranges over the Sections 12 { 21. We shall describe the structure of the argument, which goes by induction on the -split rank of X; at a later stage in this introduction.

In Section 9 we recall the de nition of the generalized E isenstein integral E $_{\rm F}$ (); for 2 a $_{\rm F~qc}$; from [13]. O riginally, this E isenstein integral was de ned by m eans of a linear com bination of residual operators (a so called Laurent functional) applied to the E isenstein integral E $\,$ (P $_{\rm O}$:) with respect to the variable : As a fam ily in the parameter ; the generalized E isenstein integral belongs to E $_{\rm P~F}^{\rm hyp}$ (X :): Hence, in view of the vanishing theorem , it can be characterized uniquely in terms of its asymptotic behavior along P $_{\rm F}$; see Theorem 9.3.

In Corollary 10.6 we show that the generalized Eisenstein integral is tem – pered for regular imaginary values of : This fact can be derived from a limitation on the asymptotic exponents, see Theorem 10.5, caused by the support of the residual operators. In the next section, in Proposition 11.6, we establish uniformly moderate estimates for the generalized Eisenstein integrals. These estimates come from similar estimates for E (P $_{0}$:); which survive the application of the residual operators.

In Section 12 we start with the preparation of the long inductive argument mentioned above. The space X is said to be of residue type if it has compact center modulo H and if, in addition, the operator $T^{\,\rm t}$ is projection onto the discrete part $L^2_{\rm d}$ (X :) of L^2 (X :) (which may be trivial). In particular, this means that the mentioned operator, and hence the associated discrete' kernel K $^{\rm t}$; is independent of the particular choice of residue weight t: M oreover, it follows from the assumption that $L^2_{\rm d}$ (X :) is nite dimensional.

W e proceed with the induction in Section 13.A parabolic subgroup P 2 P is said to be of residue type if the space $X_P := M_P = M_P \setminus H$ is. A subset F is said to be of residue type, if the associated standard parabolic subgroup P_F is. At the end of the inductive argument, which goes by induction on the -split rank of X; it will be shown that every element from P is of residue type.

The kernel K $_{\rm F}^{\rm t}$ (: :) is determined by its asymptotic expansion along P $_{\rm F}$ P $_{\rm F}$; in view of the vanishing theorem . The coe cient of e $_{\rm F}$ e $_{\rm F}$ in this expansion is essentially the discrete kernel of M $_{\rm F}$ =M $_{\rm F}$ \ H : If F is of residue type, then the discrete kernel, and hence K $_{\rm F}^{\rm t}$; is independent of the particular choice of t: Therefore, so is the generalized E is enstein integral. From then on we call this E is enstein integral the normalized one and denote it by E (P $_{\rm F}$:): It

is a m erom orphic function of $2 \, a_{F \, qc}$; with values in C^1 (X) Hom (A $_{2;F}$; V); where A $_{2;F}$ = L_d^2 (X $_F$: $_F$): (W ithout the simplifying assumption mentioned above, the latter space is replaced by a suitable direct sum over F W:) The unique characterization of the normalized E isenstein integral by means of the vanishing theorem then allows us to dene it for P $_F$ replaced by any parabolic subgroup P 2 P of residue type. This in turn allows us to dene a kernel function K $_P$ for arbitrary P 2 P of residue type, generalizing the kernels for standard parabolic subgroups of residue type. In terms of the normalized E isenstein integrals, the kernel is given by the formula

Here W $_{\rm P}$ is the subgroup of W that corresponds to the W eylgroup of X $_{\rm P}$; and E (P::) is the dualized Eisenstein integral. The latter is the function in C 1 (X) Hom (V; A $_{2,\rm P}$) dened by

Two parabolic subgroups P;Q 2 P are said to be associated, notation P Q; if their -split components $a_{P\,q}$ and $a_{Q\,q}$ are conjugate under W: If P;Q 2 P are associated, and if one of them is of residue type, then so is the other. M oreover, the set

is non-empty. The main result of the section is Theorem 1320, which asserts that the kernel function is unchanged if P; are replaced by Q;s; with Q P and s 2 W (aQq jaPq): For P minimal, this result is a consequence of the M aass-Selberg relations for the E isenstein integral E (P:); in view of (12). For arbitrary P of residue type the result follows from the minimal case by W -equivariance properties of the residue calculus.

In Section 14 we describe the action of D (X) on the normalized Eisenstein integral E (P:); for P of residue type. The diagonalization of D (X $_{\rm P}$) on L $_{\rm d}^2$ (X $_{\rm P}$: $_{\rm P}$); where $_{\rm P}:=$ $_{\rm jk}$ $_{\rm NP}$; induces a simultaneous diagonalization of the action of D (X) on the Eisenstein integral, in view of the vanishing theorem, see C orollary 14.4. In the next section this result is used to show that the uniform moderate estimates of the Eisenstein integral can be improved to uniform tempered estimates, exploiting a technique that goes back to [5].

In Section 16 we recall the mentioned result of [33] on the D (X)-characters of the discrete series in Theorem 16.1. This result is of crucial importance for Section 17, where we determ ine the constant term of the normalized Eisenstein integral. In addition we use the theory of the constant term as developed in [15], see also [25].

The constant term of E (P:) along a Q 2 P with Q P describes e $^\circ$ times the top order asymptotic behavior along Q; it is given by

In Section 18 we derive the M aass-Selberg relations from the invariance property of the kernel (1.2) m entioned above. They assert the following identity of m erom orphic functions in the variable $2 \, a_{P,q}$;

Because of the uniform tempered estimates formulated in Corollary 18.12, it becomes possible to de ne a spherical Fourier transform F_P in the next section by the formula

In Section 21 the long inductive argument is completed as follows. In the proof of Theorem 21.2, it is shown that every P 2 P is of residue type, by induction on the split rank of X: The hypothesis of the induction step implies that one may assume that G has compact center modulo H and that every F (is of residue type. In view of the regularity of the normalized E isenstein integrals, hence of the kernels K $_{\rm F}$ (: :); for F (and 2 ia_q; the formula (1.1) becomes valid with " $_{\rm F}$ = 0 for every subset F (recall that " = 0). with W $_{\rm F}$ the normalizer of $a_{\rm F\,q}$ in W: In other words, the residue weight describes the weight by which an element in the class of F contributes to the above inversion formula.

In Section 22 we give a precise description of the kernels and im ages of the Fourier transforms and their adjoints. This leads to the spherical Plancherel theorem for Schwartz functions, Theorem 23.1 and the similar theorem for L²-functions, Theorem 23.4. In particular, the summands in (1.7) extend to orthogonal projections of L² (X:) onto mutually orthogonal subspaces.

2 Notation and prelim inaries

Throughout this paper, G will be a real reductive group of Harish-Chandra's class, an involution of G and H an open subgroup of G; the set of xed points for : The associated reductive sym m etric space is denoted by

In particular, g denotes the Lie algebra of G:T he in nitesimal involutions of g associated with and are denoted by the same symbols.

We equip gwith a G-invariant non-degenerate bilinear form B that restricts to the Killing form on [g;g]; that is positive denite on p; negative denite on k; and for which is symmetric. Then hX; Yi:= B(X; Y) denes a positive denite inner product on g for which the involutions and are symmetric. A coordingly, the decompositions g = k p = h q into the +1 and 1 eigenspaces of these involutions, respectively, are orthogonal. If v g is a linear subspace, we agree to identify v with a linear subspace of g via the inner product h; i: Finally, we equip the linear dual g of g with the dual inner product, and the complexied dual g with its complex bilinear extension.

We x a maximal abelian subspace a_q of $p \setminus q$ and denote the associated system of restricted roots by = $(g; a_q)$: This is a, possibly non-reduced, root

system; the associated W eyl group is denoted by W = W (): W e recall that W ' N $_K$ (a $_q$)=Z $_K$ (a $_q$); naturally. A coordingly, the natural im age of N $_K$ \ $_H$ (a $_q$) in W is denoted by W $_K$ \ $_H$:

If P is a parabolic subgroup of G; we denote its Langlands decom position by $P = M_P A_P N_P$ and put $M_{1P} := M_P A_P : A$ parabolic subgroup that is invariant under the composed involution is called a -parabolic subgroup. The set of -parabolic subgroups containing $A_q := \exp a_q$ is nite and denoted by P:

We shall brie y recall the structure of the parabolic subgroups from P , m eanwhile xing notation. For details we refer to [13], x2.
