A NORMAL FORM ALGORITHM FOR DIFFERENTIAL DEFORMATIONS

Abstract. We introduce the notion of a formal dierential deformation of a local Artinian algebra and describe a normal formalgorithm to compute presentations of dierential deformations. We show that the microlocal structure of the Brieskom lattice of an isolated hypersurface singularity can be considered as a dierential deformation.

1. Introduction

A ssociated to an isolated hypersurface singularity there are m any interesting and deep invariants like the m onodrom y and H odge-theoretic invariants like the spectral numbers and spectral pairs.

E.Brieskom [Bri70] was the rst who gave an algorithm to compute the monodrom y. A lgorithm s to compute the above Hodge-theoretic invariants were found only one year ago [SS01, Sch01a]. The basis for all of the above algorithm s is E.Brieskom's formula

for the action of the Gauss-Manin connection on the Brieskom lattice

$$H^{0} = n+1 = df \wedge d^{n-1}$$

in terms of germs of holomorphic dierential forms. The Brieskom lattice is a free module over the ring of convergent power series \mathbb{C} ftg but also over the ring of microdierential operators \mathbb{C} ff0 1 gg.

W hile the original B rieskom algorithm uses the \mathbb{C} ftg-structure, the new algorithm s are based on the microlocal structure of the B rieskom

lattice which is related more closely to the de nition in terms of differential forms and has many advantages. Therefore it is essential to have an algorithm to compute basis representations in terms of the microlocal structure of the Brieskom lattice.

We will introduce the notion of a formal dierential deformation of a local Artinian algebra and describe a normal form algorithm to compute presentations of dierential deformations. We will show that the Brieskom lattice with its microlocal structure can be consideres as a dierential deformation. In particular, the normal formal gorithm computes basis representations in terms of the microlocal structure of the Brieskom lattice.

We will denote row vectors by a lower bar and column vectors by an upper bar. Upper indices are row indices and lower indices are column indices. We apply the degree operator deg componentwise to vectors and matrices and the operators min and max to the set of components of vectors and matrices.

2. Differential Deformations

Let K be a eld and $0 := K \underline{k}_{\underline{k}}$ a localized polynom ialring over K. Let $\underline{h}\underline{f}i$ 0 be an ideal such that $0 = \underline{h}\underline{f}i$ is a local Artinian K -algebra, i.e.

Let D be the ring of dierential operators on O. Then we can consider the right D-m odule D=hfiD and a form aldeform ation

of $D = h\underline{f}$ iD where D is a matrix with coe cients in D [s]. Tensoring with the left D-m odule O = D=D hQi, we obtain a \mathbb{C} [s]-m odule

with the coe cients of D operating on O [s].

De nition 2.1. Let \underline{h} i 0 be an ideal with \dim_K (0 = \underline{h} i) < 1 and D a matrix with ∞ cients in D. Then we call the \mathbb{C} [s] module

a form aldi erential deform ation of 0 = hfi.

3. Degree Bound Lemma

We will freely use the de nitions and results in [GP96]. Let

be a form aldi erential deform ation. We may assume \underline{f} to be polynomial. Let weights $\deg \underline{x} < 0$ of the variables \underline{x} be given and denne weights

of the corresponding dierential operators $\underline{0}$. Note that this de nition is compatible with the commutator $\underline{0}$; \underline{x} = 1 and the degree of a monomial in D is well de ned.

Let $>_{\underline{x}}$ be a local degree ordering w.r.t. $\deg \underline{x}$, \underline{g} a reduced standard basis w.r.t. $>_{\underline{x}}$ of hfi, and A a matrix such that

U sing standard basis m ethods, one can compute polynomial \underline{g} and A . We de neweights degs < 0 of the variables by

Let $>_{\underline{s}}$ be a local degree ordering w rt. degs and let > = $(>_{\underline{s}};>_{\underline{x}})$ be the product ordering of $>_{\underline{s}}$ and $>_{\underline{x}}$. We denote the leading term w rt. > which is the maximal monomial of the argument by lead and use a lower index s (resp. \underline{x}) to denote the leading term w rt. $>_{\underline{s}}$ (resp. $>_{\underline{x}}$) which is the sum of maximal monomials of the argument.

We say that \underline{g} is succient if \underline{g} is a standard basis of $\underline{h}\underline{f} + \underline{s}\underline{D}$ if $\underline{[\underline{x}]}_{(\underline{x})}$ [s], that is

The following lemma is the basis for the normal form algorithm for dierential deformations.

4. Normal Form Algorithm

The proof of lem m = 3.2 m otivates the following normal form algorithm for formaldi erential deformations.

- 1. The algorithm can be form aulated without recursion.
- 2. The choice of j in ddnf is xed for each monomial.

Hence, lead p decreases strictly in each step. For xed_s , there are only nitely many monomials $\underline{s}\underline{x}$ with deg_s \underline{x} N (K) and hence



Hence, $_{\rm K}$ is additive. By de nition of ddnf, $_{\rm K}$ is compatible with K [s]-multiplication.

5. Presentations

Lem m a 4.4 im m ediately implies our main result saying that ddnf computes representations in the generators of a formaldierential deformation up to arbitrary degree in \underline{s} .

Remark 52. Up to this point, K $[\underline{k}]_{(\underline{k})}$ can be replaced by K $[\underline{k}]$. Then $>_{\underline{x}}$ can be any global ordering and $>_{\underline{s}}$ any local ordering. The degree bound deglead p N (K) in algorithm 4.1 and the niteness assum p—tion dim $_{K}$ (0 =hfi) < 1 in de nition 2.1 can be dropped.

The following proposition gives a critierion for a formal dierential deformation to be a free K s-m odule.

De nition 5.5. A formaldi erential deformation $0_s=hf_s$ sD iO_s is called at if any relation of f lifts to a relation of f _sD .

Proposition 5.6. A at formaldi erential deformation is a free K [s] module.

Proof: Let O[s]=hf sD iO[s] be a at formal differential deform ation. Since O=hf is a at K -m odule and s a regular sequence in K[s], it su ces to prove that s_1 is a non-zero divisor in O[s]=hf sD iO[s] by the local criterion of atness E is 96, C or S S S Let S be a relation

The B rieskorn lattice H 00 of f is the image of the canonical map $^{n+1} \longrightarrow ^{n+1} G$.

Note that Cff0 1 gg is a discrete valuation ring and Cftg is a free Cff0 1 gg-m odule of rank 1.

Theorem 6.3 ([Pha79, SS85]). The Gauss-Manin system G is a dimensional Cff0 1 cg [0]-vector space and the Brieskorn lattice H 0 is a free Cff0 1 cg-m odule of rank .

We abbreviate $s = 0^{-1}$. Let b be the hxi-adic completion of and b resp. H⁰ be the hsi-adic completion of G resp. H⁰. We abbreviate

For computational purposes, we may identify the Brieskom lattice H $^{\rm 00}$ with the formaldi erential deformation

$$\mathbb{F}^{0} = \mathbb{C} \times \mathbb{E}_{s} = \mathbb{G}(f) \quad \text{seiC } \times \mathbb{E}_{s}.$$

By theorem 6.3, \mathbb{F}^{0} is a free \mathbb{C} [s]-m odule of rank and hence a standard basis \underline{g} of $\underline{h}\underline{f}$ is su cient. By proposition 5.1, the normal form algorithm 4.1 computes basis representations in \mathbb{F}^{0} up to arbitrary degree in s.

The norm alform algorithm for \$\mathbb{F}^{(0)}\$ is the core of the library gaussman.lib [Sch01b] in the computer algebra system Singular [GPS01]. This library provides procedures to compute invariants of isolated hypersurface singularities like the monodromy and Hodge-theoretic invariants like the spectral numbers and spectral pairs. These procedures are based on the ideas described in [SS01, Sch01a].
