UNITARY TRIDIAGONALISATION IN M (4;C)

VISHWAMBHAR PATI

Abstract. A question of interest in linear algebra is whether all n-n complex matrices can be unitarily tridiagonalised. The answer for all n-6-4 (a mm ative or negative) has been known for a while, whereas the case n-4 seems to have remained open. In this paper we settle the n-4 case in the a mm ative. Some machinery from complex algebraic geometry needs to be used.

1. Main Theorem

Let $V = C^n$, and h; i be the usual euclidean herm itian inner product on V. U (V) = U (n) denotes the group of unitary automorphism s of V with respect to h; i. $fe_ig_{i=1}^n$ will denote the standard orthonormal basis of V. A 2 End_C = M (n; C) will always denote a C-linear transformation of V.

A matrix $A = [a_{ij}]$ is said to be tridiagonal if $a_{ij} = 0$ for all 1 i; j n such that ji jj 2. Then we have:

Theorem 1.1. For n 4, and A 2 M (n;C), there exists a unitary U 2 U (n) such that UAU is tridiagonal.

R em ark 1.2. The case n = 3, and counterexam ples for n = 6, are due to Longsta , [4]. In the paper [2], Fong and W u construct counterexam ples for n = 5, and provide a proof in certain special cases for n = 4. The article x4 of [2] poses the n = 4 case in general as an open question. Our main theorem above answers this question in the arm ative. In passing, we also provide another elementary proof for the n = 3 case.

2. Some Lemmas

We need some preliminary lemmas, which we collect in this section. In the sequel, we will also use the letter A to denote the unique linear transformation determined by A.

Lem m a 2.1. Let A 2 M (n;C). For all n, the following are equivalent:

- (i): There exists a unitary U 2 U (n) such that UAU is tridiagonal.
- (ii): There exists a ag (= ascending sequence of C subspaces) of V = C^n :

$$0 = W_0 \quad W_1 \quad W_2 \quad \dots \quad W_n = V$$

such that dim $W_i = i$; $AW_i \quad W_{i+1}$ and $AW_i \quad W_{i+1}$ for all $0 \quad i \quad n \quad 1$.

(iii): There exists a ag in V:

 :::: $W_n = V$

such that dim $W_i = i$; $AW_i W_{i+1}$ and $A(W_{i+1}^?) W_i^?$ for all 0 i n 1.

Proof:

(i)) (ii)

Set $W_i = C$ —span $(f_1; f_2; ::: f_i)$, where $f_i = U$ e_i and e_i is the standard basis of $V = C^n$. Since the matrix $[b_{ij}] := U A U$ is tridiagonal, we have:

(where b_{ij} is understood to be = 0 for i 0 or j n+1). Thus AW $_i$ W $_{i+1}$. Since $ff_ig^n_{i=1}$ is an orthonormal basis for V = C^n , we also have:

which shows A (W_i) W_{i+1} for all i as well, and (ii) follows.

(ii)) (iii)

A W $_{i}$ W $_{i+1}$ implies (A W $_{i}$)? W $_{i+1}$ for 1 i n 1. But since (A W $_{i}$)? = A 1 (W $_{i}$?), we have A (W $_{i+1}$) W $_{i}$? for 1 i n 1 and (iii) follows.

(iii)) (i)

Inductively choose an orthonorm albasis f_i of $V = C^n$ so that W_i is the span of ff_1 ; ::; f_i g. Since A (W_i) W_{i+1} , we have:

Since $f_i = 2 (W_{i-1})^2$, and by hypothesis A $(W_{i-1}) = W_{i-2}^2$, and $W_{i-2}^2 = C$ —span $(f_{i-1}; f_i; ::; f_n)$, we also have

and by comparing the two equations (1), (2) above, it follows that

$$A f_i = a_{i 1;i} f_{i 1} + a_{ii} f_i + a_{i+1;i} f_{i+1}$$

for all i, and de ning the unitary U by U $e_i = f_i$ makes UAU tridiagonal, so that (i) follows.

Lem m a 2.2. Let n 4. If there exists a 2-dim ensional C-subspace W of $V = C^n$ such that AW W and AW W, then A is unitarily tridiagonalisable.

Proof: If n 2, there is nothing to prove. For n=3 or 4, the hypothesis implies that A maps W? into itself. Then, in an orthonormalbasis $ff_ig_{i=1}^n$ of V which satis es W = C-span($f_1; f_2$) and W? = C-span($f_3; ::; f_n$) the matrix of A is in (1;2) (resp. (2;2)) block-diagonal form for n=3 (resp. n=4), which is clearly tridiagonal.

Lem m a 2.3. Every matrix A 2 M (3;C) is unitarily tridiagonalisable.

Proof:

For A 2 M (3;C), consider the hom ogeneous cubic polynom ial in $v = (v_1; v_2; v_3)$ given by:

$$F(v_1;v_2;v_3) := det(v;Av;Av)$$

Note $v^A v^A = F(v_1; v_2; v_3)e_1^e_2^e_3$. By a standard result in dimension theory (see [1], p. 74, Theorem 5) each irreducible component of V(F) P_C^2 is of dimension 1, and V(F) is non-empty. Choose some $[v_1:v_2:v_3] = V(F)$, and let V(F) we have the two cases:

Case 1: v is a comm on eigenvector for A and A . Then the 2-dim ensional subspace $W = (Cv)^2$ is an invariant subspace for both A and A , and applying the lemma 2.2 to W yields the result.

Case 2: v is not a common eigenvector for A and A. Say it is not an eigenvector for A (otherwise interchange the roles of A and A). Set $W_1 = Cv$; $W_2 = C$ —span (v; Av); $W_3 = V = C^3$. Then dim $W_i = i$, for i = 1; 2; 3, and the fact that $v \wedge Av \wedge Av = 0$ shows that A $W_1 = W_2$. Thus, by (ii) of lemma 21, we are done. 2 Let $V = C^4$ from now on, and A 2 M (4; C).

Lem m a 2.4. If A and A have a common eigenvector, then A is unitarily tridiagonalisable.

Proof: If $v \in 0$ is a comm on eigenvector for A and A , the 3-dimensional subspace $W = (C v)^2$ is invariant under both A and A , and unitary tridiagonalisation of A $_{W}$ exists from the n=3 case of the lemma 2.3 by a $U_1 \ 2 \ U \ W$) = U (3). The unitary U=1 U_1 is the desired unitary in U (4) tridiagonalising A .

Lem m a 2.5. If the main theorem holds for all A 2 S, where S is any dense (in the classical topology) subset of M (4;C), then it holds for all A 2 M (4;C).

Proof:

This is a consequence of the compactness of the unitary group U (4). Indeed, let T denote the closed subset of tridiagonal (with respect to the standard basis) matrices.

Let A 2 M (4;C) be any general element. By the density of S, there exist A_n 2 S such that A_n ! A. By hypothesis, there are unitaries U_n 2 U (4) such that $U_nA_nU_n=T_n$, where T_n are tridiagonal. By the compactness of U (4), and by passing to a subsequence if necessary, we may assume that U_n ! U 2 U (4). Then $U_nA_nU_n$! UAU . That is T_n ! UAU . Since T is closed, and T_n 2 T, we have UAU is in T, viz., is tridiagonal.

We shall now construct a suitable dense open subset S M (4;C), and prove tridiagonalisability for a general A 2 S in the remainder of this paper. More precisely:

Lem m a 2.6. There is a dense open subset S M (4;C) such that:

- (i): A is nonsingular for all A 2 S.
- (ii): A has distinct eigenvalues for all A 2 S.
- (iii): For each A 2 S, the element $(t_0 I + t_1 A + t_2 A) 2 M$ (4;C) has rank 3 for all $(t_0; t_1; t_2) \in (0;0;0)$.

Proof: The subset of singular matrices in M (4;C) is the complex algebraic subvariety of complex codimension one dened by $Z_1 = fA$: det A = 0g. Let S_1 , (which is just GL(4;C)) be its complement. Clearly S_1 is open and dense in the classical topology (in fact, also in the Zariski topology).

A matrix A has distinct eigenvalues i its characteristic polynom ial $_A$ has distinct roots. This happens i the discrim inant polynom ial of $_A$, which is a 4-th degree hom ogeneous polynom ial (A) in the entries of A, is not zero. The zero set $Z_2 = V$ () is again a codim ension-1 subvariety in M (4;C), so its complement $S_2 = (V$ ()) of is open and dense in both the classical and Zariski topologies.

To enforce (iii), we claim that the set de ned by

is a proper real algebraic subset of M (4;C). The proof hinges on the fact that three general cubic curves in P_C^2 having a point in common imposes an algebraic condition on their coe cients.

Indeed, saying that rank $(t_0I + t_1A + t_2A)$ 2 for some $(t_0;t_1;t_2) \in (0;0;0)$ is equivalent to saying that the third exterior power $(t_0I + t_1A + t_2A)$ is the zero map, for some $(t_0;t_1;t_2) \in (0.7)$ 1. This is equivalent to demanding that there exist a $(t_0;t_1;t_2) \in (0.7)$ 2 such that the determinants of all the 3 3-m inors of $(t_0I + t_1A + t_2A)$ are zero.

Note that the (determ inants of) the (3 3)-m inors of $(t_0I + t_1A + t_2A)$, denoted as M $_{ij}$ (A;t) (where the i-th row and j-th column are deleted) are complex valued, complex algebraic and C-hom ogeneous of degree 3 in t= $(t_0;t_1;t_2)$, real algebraic and R-hom ogeneous of degree 3 in the variables $(A_{ij};A_{ij})$ (or, equivalently, in ReA $_{ij}$; Im A $_{ij}$), where A = $[A_{ij}]$.

We know that the space of all hom ogeneous polynom ials of degree 3 with complex coe cients in $(t_0; t_1; t_2)$ (upto scaling) is parametrised by the projective space P_C^9 (the Veronese variety, see [1], p.52). We rst consider the complex algebraic variety:

$$X = f(P;Q;R;[t]) 2 P_C^9 P_C^9 P_C^9 P_C^2 : P(t) = Q(t) = R(t) = 0g$$

where $[t] = [t_0 : t_1 : t_2]$, and (P;Q;R) denotes a triple of hom ogeneous polynomials. This is just the subset of those (P;Q;R;[t]) in the product $P_C^9 - P_C^9 - P$

algebraic subvariety of the quadruple product. Its im age under the rst projection $Y := _1(X) P_C^9 P_C^9 P_C^9$ is therefore an algebraic subvariety inside this triple product (see [1], p. 58, Theorem 3). Y is a proper subvariety because, for example, the cubic polynomials $P = t_0^3$; $Q = t_0^3$; $R = t_0^3$ have no common non-zero root.

Denote pairs (i;j) with 1 i;j 4 by capital letters like I;J;K etc. From the minorial determinants $M_{I}(A;t)$, we can de ne various real algebraic maps:

for I; J; K distinct. Clearly, V_3 (t₀I + t₁A + t₂A) = 0 for some t = (t₀; t₁; t₂) \in (0;0;0) i $_{IJK}$ (A) lies in in the complex algebraic subvariety Y of P_C^9 P_C^9 , for all I; J; K distinct. Hence the subset Z_3 M (4;C) de ned above is the intersection:

$$Z_3 = \bigcup_{\substack{1 \text{JJ:K}}} 1 \text{(Y)}$$

where I; J; K runs over all distinct triples of pairs (i; j); 1 i; j 4.

We claim that Z_3 is a proper real algebraic subset of M (4;C). Clearly, since each M $_{\rm I}$ (A;t) is real algebraic in the variables ReA $_{\rm ij}$; Im A $_{\rm ij}$ the map $_{\rm IJK}$ is real algebraic. Since Y is complex and hence real algebraic, its inverse in age $_{\rm IJK}^1$ (Y), de ned by the real algebraic equations obtained upon substitution of the components M $_{\rm I}$ (A;t); M $_{\rm I}$ (A;t); M $_{\rm I}$ (A;t) in the equations that dene Y, is also real algebraic. Hence the set Z_3 is a real algebraic subset of M (4;C).

To see that Z_3 is a proper subset of M (4;C), we simply consider the matrix (de ned with respect to the standard orthonorm albasis $fe_ig_{i=1}^4$ of C^4):

$$A = \begin{cases} 2 & & & 3 \\ 0 & 1 & 0 & 0 \\ 6 & 0 & 0 & 1 & 0 \\ 4 & 0 & 0 & 0 & 1 \\ 0 & 0 & 0 & 0 \end{cases}$$

For $t = (t_0; t_1; t_2) \in 0$, we see that:

$$t_0I + t_1A + t_2A = \begin{cases} 2 & & & & 3 \\ t_0 & t_1 & 0 & 0 \\ 6 & t_2 & t_0 & t_1 & 0 & 7 \\ 0 & t_2 & t_0 & t_1 & 5 \\ 0 & 0 & t_2 & t_0 \end{cases}$$

For this m atrix above, the m inorial determ inant M $_{41}$ (A;t) = t_1^3 , whereas M $_{14}$ (A;t) = t_2^3 . The only com m on zeros to these two m inorial determ inants are points [t_0 :0:0]. Setting t_1 = t_2 = 0 in the matrix above gives M $_{1i}$ (A;t) = t_0^3 for 1 i 4. Thus t_0 m ust also be 0 for all the minorial determ inants to vanish. Hence the matrix A above lies outside the real algebraic set Z_3 .

It is well known that a proper real algebraic subset in euclidean space cannot have a non-empty interior. Thus the complement Z_3^c is dense and open in the classical and real-Zariski topologies. Take $S_3 = Z_3^c$.

Finally, set

$$S = S_1 \setminus S_2 \setminus S_3 = \begin{bmatrix} 3 & ! & c \\ & & Z_i \end{bmatrix}$$

which is also open and dense in the classical topology in M (4;C). Hence the lem m a. 2

R em ark 2.7. One should note here that for each matrix A 2 M (4;C), there will be at least a curve of points $[t] = [t_0:t_1:t_2] 2 P_C^2$ (de ned by the vanishing of det $(t_0I+t_1A+t_2A)$, on which $(t_0I+t_1A+t_2A)$ is singular. Similarly for each A there is at least a curve of points on which the trace tr V_3 ($t_0I+t_1A+t_2A$) vanishes, and so a non-empty (and generally a nite) set on which both these polynomials vanish, by dimension theory ([1], Theorem 5, p. 74). Thus for each A 2 M (4;C), there is a at least a non-empty nite set of points [t] such that $(t_0I+t_1A+t_2A)$ has 0 as a repeated eigenvalue. For example, for the matrix A constructed at the end of the previous lemma, we see that the matrix $(t_0I+t_1A+t_2A)$ is strictly upper-triangular and thus has 0 as an eigenvalue of multiplicity 4 for all $(0;t_1;0) \in 0$, but nevertheless has rank 3 for all $(t_0;t_1;t_2) \in (0;0;0)$.

Indeed, as (iii) of the lem m a above show s, for A in the open dense subset S, the kernelker $(t_0I + t_1A + t_2A)$ is at m ost 1-dim ensional for all $[t_1] = [t_0:t_1:t_2] 2 P_C^2$.

3. The varieties C;; and D

N otation 3.1. In the light of the lem m as 2.5 and 2.6 above, we shall henceforth assum e A 2 S. As is easily veri ed, this implies A 2 S as well. We will also henceforth assum e, in view of lem m a 2.4 above, that A and A have no common eigenvectors. (For example, this rules out A being normal, in which case we know that the main result for A is true by the spectral theorem). A lso, in view of lem m a 2.2, we shall assume that A and A do not have a common 2-dimensional invariant subspace.

In P_C^3 , the complex projective space of $V = C^4$, we denote the equivalence class of $v \ge V$ n 0 by [v]. For a $[v] \ge P_C^3$, we de ne W ([v]) (or simply W (v) when no confusion is likely) by:

$$W ([v]) := C - spanfv; Av; Avg$$

Since we are assuming that A and A have no common eigenvectors, we have dim W ([v]) 2 for all [v] 2 P_c^3 .

Denote the four distinct points in P_C^3 representing the four distinct eigenvectors of A (resp. A) by E (resp. E). By our assumption above, E \ E = .

Lem m a 3.2. Let A 2 M (4;C) be as in 3.1 above. Then the closed subset:

$$C = f[v] 2 P_C^3 : v^A v^A v = 0g$$

is a closed projective variety. This variety C is precisely the subset of [v] 2 P_C^3 for which the dimension dim W ([v]) = dim (C-span fv;Av;A vg) is exactly 2.

Proof: That C is a closed projective variety is clear from the fact that it is dened as the set of common zeros of all the four (3 3)-m inors of the (3 4)-m atrix

(which are all degree-3 hom ogeneous polynomials in the components of v with respect to some basis). Also C is nonempty since it contains E [E .

Also, since A and A are nonsingular by the assumptions in 3.1, the wedge product $v^A v^A v$ of the three non-zero vectors $v_i A v_i A v$ vanishes precisely when the space W([v]) = C-spanf $v_i A v_i A v$ is of dimension 2. Since by 3.1, A, A have no common eigenvectors, the dimension dim W([v]) = C for all $[v] 2 P_C^3$, so C is precisely the locus of $[v] 2 P_C^3$ for which the space W([v]) is 2-dimensional.

Now we shall show that for A as in 3.1, the variety C de ned above is of pure dimension one. For this, we need to de ne somem ore associated algebraic varieties and regular maps.

De nition 3.3. Let us de ne the bilinear map:

Note that the image $\operatorname{Im} B$ (v;) is the span of fv ; A vg, which was denied to be W (v). For a xed t, denote the kernel

$$K (t) := ker(B (;t) : C4 ! C4)$$

Denoting $[t_0:t_1:t_2]$ by [t] and $[v_1:v_2:v_3:v_4]$ by [v] for brevity, we de ne:

Finally, de ne the variety D by:

Lem m a 3.4. We have the following facts:

(i):

(ii): $_1$: ! C is 1-1, and the m ap g de ned by

is a regular map so that is the graph of g and isom orphic as a variety to C.

- (iii): D P_{C}^{2} is a plane curve, of pure dimension one. The map $_{2}$: ! D is 1-1, and the map $_{1}$ $_{2}^{1}$: D ! C is the regular inverse of the regular map g de ned above in (ii). A gain is also the graph of this regular inverse g 1 , and D and are isomorphic as varieties. In particular, C and D are isomorphic as varieties, and thus C is a curve in P_{C}^{3} of pure dimension one.
- (iv): Inside P_{C}^{3} P_{C}^{2} , each irreducible component of the intersection of the four divisors D_{i} : (B_i(v;t) = 0) for i = 1;2;3;4 (where B_i(v;t) is the i-th component of B (v;t) with respect to a xed basis of C⁴) occurs with multiplicity 1. (Note that is set-theoretically the intersection of these four divisors, by denition).

Proof:

It is clear that $_1$ () = C, because B (v;t) = $t_0v + t_1Av + t_2Av = 0$ for some $[t_0:t_1:t_2] 2 P_C^2$ idim W (v) 2, and since A and A have no common eigenvectors, this means dim W (v) = 2. That is, [v] 2 C.

C learly [t] 2 $_2$ () i there exists a [v] 2 P $_{\rm C}^3$ such that B (v;t) = 0. That is, i dim ker B (;t) 1, that is, i

$$G(t_0;t_1;t_2) := det B(;t) = 0$$

Thus $D = {}_{2}$ () and is defined by a single degree 4 hom ogeneous polynomial G inside P_{C}^{2} . It is a curve of pure dimension 1 in P_{C}^{2} by standard dimension theory (see [1], p. 74, Theorem 5) because, for example [1:0:0] 8 D so $D \notin P_{C}^{2}$. So $_{2}$ () = D, and this proves (i).

To see (ii), for a given [v] 2 C, we claim there is exactly one [t] such that ([v]; [t]) 2 i the linearm ap:

has a non-trivial kernel containing the line Ct. That is, dim Im B (v;) 2. But the image Im B (v;) = W (v), which is of dimension 2 for all v 2 C by our assumptions. Thus its kernel must be exactly one dimensional, dened by ker B (v;) = Ct. Thus ([v]; [t]) is the unique point in Lying in $_1^{-1}$ [v], viz. for each [v] 2 C, the vertical line [v] P_{C}^{2} intersects in a single point, call it ([v]; g[v]). So $_1$: ! C is 1-1, and is the graph of a map g: C! D. Since $g([v]) = _{2} _{1}^{-1}$ ([v]) for [v] 2 C, and is algebraic, g is a regular map. This proves (ii).

To see (iii), note that for [t] 2 D, by de nition, the dimension dim kerB (;t) 1. By the fact that A 2 S, and (iii) of the lemma 2.6, we know that dim kerB (;t) 1 for all [t] 2 P_C^2 . Thus, denoting K (t) = kerB (;t) for [t] 2 D, we have:

Hence we see that the unique projective line [v] corresponding to Cv = K (t) yields the unique element of C, such that ([v]; [t]) 2. Thus $_2$: ! D is 1-1, and the regular map $_1$ $_2$! D! C is the regular inverse to the map g of (ii) above. is thus also the graph of g 1 and, in particular, is isomorphic to D. Since g is an isomorphism of curves, and D is of pure dimension 1, it follows that C is of pure dimension one. This proves (iii).

To see (iv), we need some more notation.

Note that D P_C^2 nf[1;0;0]g, (because there exists no [v] 2 P_C^3 such that I v = 0!). Thus there is a regular map:

Let $(t_1;t_2)$ be the discrim inant polynom ial of the characteristic polynom ial t_1A+t_2A of t_1A+t_2A . C learly $(t_1;t_2)$ is a hom ogeneous polynom ial of degree 4 in $(t_1;t_2)$, and it is not the zero polynom ial because, for example, $(1;0) \in 0$, for (1;0) is the discrim inant of t_1A , which has distinct roots (= the distinct eigenvalues of A) by the assumptions 3.1 on A. We will now prove that for each irreducible component of , and each point x=([a];[b]) in nF_1 , the four equations $fB_i(v;t)=0$ $g_{i=1}^4$ are the generators of the ideal of the variety in an anneneighbourhood of x, where $B_i(v;t)$ are the components of $B_i(v;t)$ with respect to a xed basis of C^4 . Since F_1 is a nite set, this will prove (iv), because the multiplicity of in the intersection cycle of the four divisors $D_i=(B_i(v;t)=0)$ in P_C^3 P_C^2 is determined by generic points on , for example all points of nF_1 . We will prove this by showing that for x=([a];[b]) 2 nF_1 , the four divisors $(B_i(v;t)=0)$ intersect transversely at x.

So let be some irreducible component of , with x = ([a]; [b]) 2 nF_1 .

Fix an a 2 C 4 representing [a] 2 C = $_1$ (), and also x b 2 C 3 representing [b] = g([a]) 2 g(C). A lso x a 3-dim ensional linear complement $V_1 = T_{[a]}(P_C^3)$ C 4 to a and similarly, x a 2-dim ensional linear complement $V_2 = T_{[b]}(P_C^2)$ C 3 to b. (The notation comes from the fact that $T_{[v]}(P_C^n)$ ' $C^{n+1}=Cv$, which we are identifying non-canonically with these respective complements V_1). These complements also provide local coordinates in the respective projective spaces as follows. Set coordinate charts on around [a] 2 P_C^3 by [v] = (u) = [a+u], and around [b] 2 P_C^2 by [t] = (s) = [b+s], where $u \ge V_1$ ' C^3 , and $s \ge V_2$ ' C^2 . The images (V_1) and (V_2) are a neneighbourhoods of [a] and [b] respectively. These charts are like Stereographic

projection' onto the tangent space and depend on the initial choice of a (resp. b) representing [a] (resp. [b]), and are not the standard coordinate systems on projective space, but more convenient for our purposes.

Then the local a ne representation of B (v;t) on the a ne open V $_1$ $V_2 = C^3$ C^2 , which we denote by , is given by:

Now one can easily calculate the derivative D (0;0) of at (u;s) = (0;0). Let $(X;Y) 2 V_1 V_2$. Then, by bilinearity of B, we have:

By the equations (5) and (6) above, we see that the image of D (0;0) is precisely Im B (;b) + W ([a]).

Claim: For ([a]; [b]) 2 nF_1 , the space Im B (;b) + W ([a]) is all of C^4 .

Proof of C laim: Denote T := B (;b) for brevity. C learly a 2 W ([a]) by de nition of W ([a]). A lso, a 2 kerT = K (b). Then it is enough to show that $0 \in A$ is not in the image of T. For, if a 2 Im T, we would have A = A Tw for some w A K (b) = kerT and w A 0. In fact w is not a multiple of a since A w = a A 0 whereas a 2 kerT. Thus we would have A = 0, and completing A = a = Tw; A = w to a basis A for A the matrix of T with respect to such a basis would be of the form:

Thus T = B (;b) would have 0 as a repeated eigenvalue. But we have stipulated that ([a]; [b]) $E F_1$, so that [b] $E F_1$, and hence B (;b) does not have 0 as a repeated eigenvalue. Hence the non-zero vector a 2 W ([a]) is not in Im T. Since Im T is 3-dimensional, we have $C^4 = Im T + W$ ([a]), and this proves the claim.

In conclusion, all the points of nF_1 are in fact smooth points of , and the local equations for in a small neighbourhood of such a point are precisely the four equations i(u;s) = 0, 1 i 4. This proves (iv), and the lem ma.

4. Some algebraic bundles

We construct an algebraic line bundle with a (regular) global section over C. By showing that this line bundle has positive degree, we will conclude that the section has zeroes in C. Any zero of this section will yield a ag of the kind required by lemma 2.1. One of the technical complications is that none of the bundles we de ne below are allowed to use the herm itian metric on V, orthogonal complements, orthonormal bases etc., because we wish to remain in the \mathbb{C} -algebraic category. As a general reference for this section and the next, the reader may consult [3].

De nition 4.1. For $0 \le v \ge V = C^4$, we will denote the point $[v] \ge P_C^3$ by v, whenever no confusion is likely, to simplify notation. We have already denoted the vector subspace C—spanfv; Av; Avg C^4 as W(v). Further denew 3(v) = W(v) + AW(v), and \overline{W}_3 (v) = W(v) + AW(v). Clearly both W3(v) and \overline{W}_3 (v) contain W(v).

Since A and A have no common eigenvectors, we have dim W (v) 2 for all v 2 P $_{\rm C}^3$, and dim W (v) = 2 for all v 2 C, because of the dening equation v ^ A v ^ A v = 0 of C. Also, since dim W (v) = 2 = dim AW (v) for v 2 C, and since 0 \oplus A v 2 W (v) \ AW (v), we have dim W $_3$ (v) 3 for all v 2 C. Similarly dim $\stackrel{.}{W}$ $_3$ (v) 3 for all v 2 C.

If there exists a v 2 C such that dim W $_3$ (v) = 2, then we are done. For, in this case W $_3$ (v) must equal W (v) since it contains W (v). Then the dimension dim \vec{W}_3 (v) = 2 or = 3. If it is 2, W (v) will be a 2-dimensional invariant space for both A and A , and the main theorem will follow by lem m a 22. If dim \vec{W}_3 (v) = 3, then the ag:

R em ark 4.2. We are reduced to the situation where the following condition holds:

For each v 2 C, dim W (v) = 2; dim W₃ (v) = dim \overline{W}_3 (v) = 3.

Now our main task is to prove that there exists a v 2 C such that the two 3-dimensional subspaces W $_3$ (v) and \vec{W}_3 (v) are the same. In that event, the ag

will meet the requirements of (ii) of the lemma 2.1. The remainder of this discussion is aimed at proving this.

De nition 4.3. Denote the trivial rank 4 algebraic bundle on P_C^3 by $O_{P_C^3}^4$, with bre $V=C^4$ at each point (following standard algebraic geometry notation). Similarly, O_C^4 is the trivial bundle on C. In $O_{P_C^3}^4$, there is the tautological line-subbundle $O_{P_C^3}$ (1), whose breat V is CV. Its restriction to the curve C is denoted as V 1 = O_C (1).

There are also the line subbundles $AO_{P_c^3}$ (1) (respectively $AO_{P_c^3}$ (1)) of $O_{P_c^3}$, whose breat v is Av (respectively Av). Both are isomorphic to $O_{P_c^3}$ (1) (via the global linear automorphisms AV) of V). Similarly, their restrictions AO_c (1), AO_c (1), both isomorphic to O_c (1). Note that throughout what follows, bundle isomorphism over any variety X will mean algebraic isomorphism, i.e. isomorphism of the corresponding sheaves of algebraic sections as O_X -modules.

Denote the rank 2 algebraic bundle with bre W (v) V at v 2 C as W $_2$. It is an algebraic subbundle of O $_{\rm C}^4$, for its sheaf of sections is the restriction of the subsheaf

Denote the rank 3 algebraic subbundle of O $_{\rm C}^4$ with bre W (v) + AW (v) (respectively W (v) + A W (v)) by \mathbb{W}_3 (respectively \mathbb{W}_3). Both \mathbb{W}_3 and \mathbb{W}_3 are of rank 3 on \mathbb{C}_2 because of (4.2) above, and both contain \mathbb{W}_2 as a subbundle. \mathbb{W}_3 denote the line bundles \mathbb{W}_3 by \mathbb{L}_2 , and \mathbb{W}_3 (resp. \mathbb{W}_3) by \mathbb{L}_3 (resp. \mathbb{S}_3). Then \mathbb{L}_2 is a line subbundle of $^{\vee}{}^{2}O_{c}^{4}$, and L_{3} ; \mathfrak{G}_{3} are line subbundles of $^{\vee}{}^{3}O_{c}^{4}$.

 $\textit{F inally, for } X \textit{ any variety, w ith a bundle } E \textit{ on } X \textit{ which is a subbundle } of a \textit{trivial bundle } O^m_X \textit{ , the annihilator } \\$ of E is de ned as:

Thus the rst and third exact sequences of (i) follow. The proofs of the second and fourth are similar. From the rst exact sequence in (i), it follows that 3W_3 , 2W_2 . This implies the rst identity of (ii). Similarly the second exact sequence of (i) in plies the other identity of (ii).

Since for every line bundle , is trivial, we get from the rst identity of (ii) that L_2 ' L_3 . From third exact sequence in (i) it follows that 2 A nnW $_2$ ' L_3 , and this in plies (iii).

To see (iv), note that

The autom orphism A 1 of V m akes the last bundle on the right isom orphic to the line bundle W $_2$ = (W $_2$ \A 1 W $_2$) (note all these operations are happening inside the rank 4 trivial bundle O $_{\rm C}^4$). Similarly, $^{\sim}$ is isom orphic (via the global isom orphism A 1 of V) to the line bundle W $_2$ = (W $_2$ \A 1 W $_2$). But for each v 2 C, W (v)\A 1 W (v) = Cv = W (v)\A 1 W (v), from which it follows that the line subbundles W $_2$ \A 1 W $_2$ and W $_2$ \A 1 W $_2$ of W $_2$ are the same (= W $_1$ ' O $_2$ (1)). Thus ' $^{\rm e}$, proving (iv).

To see (v), we need another exact sequence. For each v 2 C, we noted in the proof of (iv) above that O_{C} (1) = $W_{2} \setminus A^{-1} W_{2}$. Thus the sequence of bundles:

5. Degree computations

In this section, we cam pute the degrees of the various line bundles introduced in the previous section.

Denition 5.1. Note that an irreducible complex projective curve C, as a topological space, is a canonically oriented pseudom anifold of real dimension 2, and has a canonical generator $_{\mathbb{C}}$ 2 H $_{\mathbb{C}}$ (C; Z) = Z. Indeed, it is the image $_{\mathbb{C}}$, where : \mathbb{C} ! C is the normalisation map, and $_{\mathbb{C}}$ 2 H $_{\mathbb{C}}$ (\mathbb{C} ; Z) = Z is the canonical orientation class for the smooth connected compact complex manifold \mathbb{C} , where : $\mathbb{H}_{\mathbb{C}}$ (\mathbb{C} ; Z)! H $_{\mathbb{C}}$ (\mathbb{C} ; Z) is an isomorphism for elementary topological reasons.

If F is a complex line bundle on C, it has a rst Chern class c_1 (F) 2 H 2 (X;Z), and the degree of F is de ned by:

$$degF = hc_1(F); ci2Z$$

It is known that a complex line bundle on a pseudom anifold is topologically trivial its rst Chem class is zero. In particular, if an algebraic line bundle on a projective variety has non-zero degree, then it is topologically (and hence algebraically) non-trivial.

Finally, if i:C ,! $P_{\mathbb{C}}^n$ is an (algebraic) embedding of a curve in some projective space, we dene the degree of the bundle $O_{\mathbb{C}}$ (1) = i $O_{P_{\mathbb{C}}^n}$ as the degree of the curve C (in $P_{\mathbb{C}}^n$). We note that $[C] := i (_C) 2 H_2(P_{\mathbb{C}}^n; Z)$ is called the fundamental class of C in $P_{\mathbb{C}}^n$, and by denition deg $C = hc_1(O_{\mathbb{C}}(1))$; $C := c_1(O_{P_{\mathbb{C}}^n}(1))$; C :

M ore generally, a complex projective variety $X = P_C^n$ of complex dimension m has a unique orientation class $_X = 2 H_{2m} (X;Z)$. Its image in $H_{2m} (P_C^n;Z)$ is denoted [X], and the degree deg X of X is denoted as $(c_1 (O_{P_C^n}(1)))^m$; [X]. It is known that if X = V(F) for a homogeneous polynomial F of degree d, then deg X = d.

W e need the following remark later on:

Remark 5.2. If f:C! D is a regular isomorphism of projective curves C and D, both of pure dimension 1, and if F is a complex line bundle on D, then deg f F = deg F. This is because f ($_{\rm C}$) = $_{\rm D}$, so that

Now we can compute the degrees of all the line bundles introduced.

Proof:

We denote the image of orientation class of the curve (see de nition 3.3 for the de nition of) in $H_2(P_C^3 - P_C^2; Z)$ by []. By the part (iv) of the Lem m a 3.4, we have that the hom ology class [] is the same as the hom ology class of the intersection cycle de ned by the four divisors $D_i := (B_i(v;t) = 0)$ inside $H_2(P_C^3 - P_C^2; Z)$. By the generalised B ezout theorem in $P_C^3 - P_C^2$, the hom ology class of the last-m entioned intersection cycle is the hom ology class P oincare-dual to the cup product

where d_i is the rst Chern class of the the line bundle L_i corresponding to D_i , for i = 1;2;3;4. (See [1], p. 237, $E \times 2$).

Since each $B_i(v;t)$ is separately linear in v, t, the line bundle de ned by the divisor D_i is the bundle ${}_1O_{P_C^3}(1) = {}_2O_{P_C^2}(1)$, where ${}_1;_2$ are the projections to P_C^3 and P_C^2 respectively. If we denote the hyperplane classes which are the generators of the cohom ologies $H^2(P_C^3;Z)$ and $H^2(P_C^2;Z)$ by x and y respectively, we have:

The proof of (ii) is sim ilar, we just replace C by D, and $_1$ by $_2$, and $_1$ (x) by $_2$ (y) in the equalities of (9) above, and get 4 (as one should expect, since D is de ned by a degree 4 hom ogeneous polynom ial in $P_{\rm C}^2$). This proves (ii).

For (iii), we use the identity of lem m a 4.5 that $L_2 = g O_D$ (1) O_C (2), and the rem ark 5.2 applied to the isom orphism of curves g:C! D (part (iii) of the lem m a 3.4) to conclude that $\deg L_2 = \deg D$ 2deg C = 4 12 = 8, by (i) and (ii) above, so that $\deg L_2 = 8$.

For (iv), we have by (vi) of the lem m a 4.4 that hom $_{\mathbb{C}}$ (L₃; $^{\mathbb{C}}$) ' L₂ 3 O $_{\mathbb{C}}$ (2), so that its degree is $3 \deg L_{2}$ 2deg \mathbb{C} = 24 12 = 12 by (i) and (iii) above.

This proves the lemma.

From (iv) of the lem m a above, we have the:

C orollary 5.4. The line bundle hom $_{\mathbb{C}}$ (L3; $^{\mathbf{e}}$) is a non-trivial line bundle.

6. Proof of the Main Theorem

Proof of Theorem 1.1: By the third exact sequence in (i) of the lemma 4.4, we have a bundle morphism s of line bundles on C de ned as the composite:

satis es the requirem ents of (ii) of ${\rm lem}\, m$ a 2.1, and the main theorem 1.1 follows.

R em ark 6.1. Note that since dim C = 1, then the set of points $v \ge C$ such s(v) = 0, where s is the section above, will be a nite set. Then the set of ags that satisfy (ii) of lem m a 2.1 which tridiagonalise A of the kind considered above (viz. A satisfying the assumptions of 3.1), will only be nitely many (at most 12 in number!).
