## HAM ILTONIAN 2-FORMS IN KAHLER GEOMETRY, I

### V.APOSTOLOV, D.M.J.CALDERBANK AND P.GAUDUCHON

Abstract. We introduce the notion of a ham iltonian 2—form on a Kahlermanifold and obtain a complete local classication. This notion appears to play a
pivotal role in several aspects of Kahler geometry. In particular, on any Kahler
manifold with co-closed Bochner tensor, the (suitably normalized) Ricci form is
ham iltonian, and this leads to an explicit description of these Kahler metrics,
which we call weakly Bochner—at.

H am iltonian 2-forms draw attention to a general construction of K ahler m etrics which interpolates between toric geometry and C alabi-like constructions of m etrics on (projective) line bundles. They also arise on conformally-E instein K ahler m anifolds. We explore these connections and ram i cations.

In a previous paper  $\beta$ ], while investigating K ahler 4-m anifolds whose antiselfdual W eyltensor is  $\infty$ -closed, we happened upon a remarkable linear dierential equation for (1;1)-form so on a K ahler manifold. This equation states that

for all vector elds X, where (g;J;!) is the Kahler structure with Levi-Civita connection r. A ham iltonian 2-form is a (nontrivial) solution of (1).

Ham iltonian 2-forms underpin many explicit constructions in Kahler geometry. In particular they arise on Bochner- at Kahler manifolds and on Kahler manifolds (of dimension greater than four) which are conformally-Einstein, both of which have been classified recently, respectively by Bryant [5], and Derdzinski and Maschler [9]. In this paper we obtain an explicit local classication of all Kahler metrics with a ham iltonian 2-form, which provides a unifying framework for these works, and at the same time extends Bryant's local classication to the much larger class of Kahler manifolds with co-closed Bochner tensor, called weakly Bochner- at.

The key feature of ham iltonian 2-form s| and the reason for the nam e| is that if is ham iltonian, and  $_1;:::$   $_m$  are the elementary sym metric functions of the eigenvalues of  $_{1}$  with respect to the Kahler form  $_{2}$ , then the ham iltonian vector elds K  $_{2}$  =  $_{2}$  grad  $_{3}$   $_{4}$  are all K illing. Furtherm ore, the Poisson brackets f  $_{1}$ ;  $_{2}$  are all zero, so that the K illing vector elds K  $_{1}$ ;  $_{2}$ ::K  $_{3}$  com mute.

If K  $_1$ ;:::K  $_m$  are linearly independent, then the K ahler m etric is toric. However, not every toric K ahler m etric arises in this way: the ham iltonian property also implies that the eigenvalues of have orthogonal gradients. We say that a toric m anifold is orthotoric if there is a momentum map ( $_1$ ;::: $_m$ ) for the torus action  $_m$  with respect to some basis of the Lie algebra) such that the roots of the polynomial  $_m$  of  $_m$  have orthogonal gradients. (Here  $_0$  = 1.)

Of course  $K_1$ ;::: $K_m$  need not be linearly independent; then on an open set where the span is '-dim ensional, we have a local ham iltonian action of an '-torus

with '< m, so that the Kahler metric may be described locally by the Pedersen {
Poon Ansatz [18], as a bration over a 2 (m ')-dimensional complex manifold S
with 2'-dimensional toric bres. Again, not all Kahler metrics with a hamiltonian
'-torus action arise in this way: in particular, the hamiltonian property of implies
that the bres are totally geodesic, or (equivalently) that the nonlinear connection
on the bration is associated to a principal connection on an '-torus bundle over
S. We refer to this special case of the Pedersen {Poon Ansatz as the generalized
Calabi construction, since when '= 1, it has its origins in work of Calabi on Kahler
metrics on (projective) line bundles [6, 7].

Our main result shows that any Kahler manifold with a ham iltonian 2-form may locally be described explicitly, as a generalized Calabi construction with orthotoric bres, and that conversely, any such explicit Kahler metric admits a ham iltonian 2-form. From this result we are able to deduce a local classication of weakly Bochner-at Kahler metrics, rederiving in particular Bryant's classication of Bochner-at Kahler metrics. We also obtain a new proof of the Derdzinski Maschler classication of conformally-Einstein Kahler metrics in higher dimensions.

Our classication of ham iltonian 2-forms draws attention to the generalized Calabi construction and orthotoric Kahler metrics as useful tools in Kahler geometry. This yields in particular, an Ansatz for extremal Kahler metrics including constant scalar curvature and Kahler Einstein metrics which unies and extends many constructions in the literature. In a second paper on this subject, we shall use this to obtain new compact examples.

The structure of the paper is as follows. In section 1, after reviewing some background material, we explain how equation (1) arises on weakly Bochner-at Kahler manifolds and on conformally-Einstein Kahler manifolds. This motivates the denition of ham iltonian 2-forms given in section 2, where we also derive the existence of the ham iltonian Killing vector elds and show that the equation for ham iltonian 2-forms is an overdetermined equation of nite type which is completely integrable on manifolds of constant holomorphic sectional curvature.

In section 3 we study ham iltonian torus actions in general. This section is almost entirely independent of the rst two, and may be read separately, although our analysis is motivated by the special properties of ham iltonian 2-forms. We rst show that the Pedersen (Poon Ansatz [18] has a natural and essentially coordinate-free description in terms of a potential G, which is a brewise Legendre transform of a Kahler potential, and is required to satisfy only open conditions such dual potentials appeared rst in the toric case, in work of Guillem in [11] and Abreu [1]. We also characterize the pluriharm onic functions and compute the Ricci form.

In section 3.3 we introduce the generalized C alabi construction, a special case of the Pedersen {Poon A nsatz in which the toric geometry of the bresalmost entirely decouples from the geometry of the bration over the base. A particularly important consequence is that the Ricci form is linear in the matrix of inner products of the Killing vector elds, which makes this Ansatz well-suited to the construction of Kahler{E instein and extremal Kahler metrics. Such constructions are well known when the bresare one dimensional [6,7,12,21,22]: we extend them to the general case, and give several characterizations.

In the nalpart, 3.4, of section 3, we turn to orthotoric Kahler metrics. In four dimensions, orthotoric metrics were introduced in [3] and explicitly classified. Here we extend this denition and classification to all dimensions. The decisive feature of orthotoric 2m-m anifolds is that they depend excitively on me functions of 1 variable, rather than the 1 function of metrics (the dual potential G) that

governs toric Kahler metrics in general. This means that conditions on the curvature are (functional) ordinary dierential equations, rather than partial dierential equations, which is again expedient in the study of explicit examples.

The central results of this paper can be found in section 4, where we bring the work of sections 2 and 3 together to provide our explicit local classication of K ahler manifolds with a ham iltonian 2-form. We est prove that on a connected K ahler 2m manifold with a ham iltonian 2-form and associated K illing vector elds K  $_1; ::: K_m$ , there is an integer ', with 0 ' m such that the span of K  $_1; ::: K_m$  is everywhere at most 'dimensional, but that on a dense open set K  $_1; ::: K_m$  is everywhere at most 'dimensional, but that on a dense open set K  $_1; ::: K_m$  are linearly independent. the bres are orthotoric;

the bration is a generalized Calabi construction;

the constants arising in the generalized Calabi construction are related to the orthotoric geometry of the bres in a speci cway.

In section 5 we study the curvature of our explicit metrics and hence obtain classications of extremal Kahler metrics with a hamiltonian 2-form, of weakly Bochner-at Kahler metrics, and of Bochner-at Kahler metrics [5].

To sum marize, we have the following result.

Theorem . Let (M ;g;J;!) be a connected K ahler 2m -m anifold with a ham iltonian 2-form of order '. Then there are functions  $F_1$ ;:::F, of one variable such that on a dense open subset of M , the K ahler structure m ay be written

The scalar curvature is then constant if and only if  $a_0=0$  and is zero if and only if also  $a_1=0$ . Any extremal Kahler metric with a ham iltonian 2-form arises in this way provided the gradient of the scalar curvature is tangent to the bration dened by the ham iltonian 2-form.

(g;J;!) has constant holomorphic sectional curvature if and only if  $c_2 = 0$  and is at if and only if also  $c_1 = 0$ . Any Bochner- at Kahler metric arises in this way.

The proof of this theorem can be found in Theorem s 1 and 2, and Propositions 14, 15 and 16. We end the paper by discussing ham iltonian 2-form s of order 1, and the classication of conform ally-Einstein Kahler metrics [9]. There are also two appendices. In Appendix A, we relate ham iltonian 2-form s to conform alk illing form s, which have been recently studied by Semmelmann [20]. In Appendix B, we collect some Vandermonde identities, which we have used freely in the paper.

## 1. The curvature of a Kahler manifold

In this section we review some background material in order to x notation, and to present the notions of Bochner- at, weakly Bochner- at, and conformally-E instein Kahler metrics. Our conventions mainly follow [4].

1.1. R iem annian curvature. The curvature R of a n-dimensional R iem annian manifold (M ;g) is de ned by

$$R_{X;Y}Z = r_{[X;Y]}Z$$

for all vector elds X;Y;Z, where r denotes the Levi-C ivita connection. It is a 2-form with values in the adjoint bundle AM (the bundle of skew endom orphisms of the tangent bundle TM) and satisfies the algebraic Bianchi identity:  $R_{X;Y}Z + R_{Y;Z}X + R_{Z;X}Y = 0$ . Via the metric g, AM can be identified with the bundle  $^2M$  of 2-form s and R can be viewed as a section of  $^2M$   $^2M$ . Then, the algebraic Bianchi identity is equivalent to the following two conditions:

- (i) R belongs the the sym m etric part,  $^{2}$ M  $^{2}$ M , of  $^{2}$ M  $^{2}$ M  $^{2}$ M
- (ii) R belongs to the kernel of the linear map, , from  $^2{\rm M}$   $^2{\rm M}$  to  $^4{\rm M}$  determ ined by the wedge product.

The subbundle R M  $\rightleftharpoons$  ker of  $^2$ M is called the bundle of (abstract) curvature tensors.

The Ricci contraction associates to R the bilinear form Ricci de ned by: Ric $_{X;Y}$  = tr(Z! R $_{X;Z}$ Y). It can be considered as a linear map c from RM to the bundle SM of sym metric bilinear form s of M. We thus obtain the following orthogonal

decomposition of vector bundles:

$$RM = c (SM) WM;$$

where W M , called the bundle of (abstract) W eyl tensors of (M ;g), denotes the kernel of c in R M . A coordingly, the curvature R splits as R = c (h) + W , where W , the component of R in W M , is the W eyl tensor of (M ;g), whereas h satis es c (h) = Ric. For n 3, c is surjective; its adjoint c is then injective and h is determined by

$$h = \frac{Scal}{2n (n - 1)} g + \frac{Ric_0}{n - 2};$$

where Scal is the scalar curvature of g, i.e., the trace of R ic with respect to g, and R ic\_0 denotes the traceless part of R ic (so that R ic =  $\frac{1}{n}$ Scalg + R ic\_0), which is a section of S\_0M, the bundle of sym metric traceless bilinear form s. For n = 2, c has kernel S\_0M so that R ic\_0 = 0 and the tracefree part of h is undetermined.

Finally, the curvature R, viewed as a sym m etric endom orphism of  $^2$ M using g, splits into three orthogonal pieces as follows:

where  $fRic_0$ ; g acts on  $2^{-2}M$  to give the anticom mutator  $fRic_0$ ;  $g = Ric_0 + Rig ofRic_0$  and , which are viewed, via g, as endom orphism s, respectively sym metric and skew, of TM . When n = 2, the second term is zero.

Each piece of (2) is an element of RM. The corresponding subbundle of RM is associated to an irreducible representation of the orthogonal group 0 (n), respectively the trivial representation, the Cartan product  $R^n$   $R^n$ , the Cartan product o(n) o(n), where o(n) =  ${}^2R^n$  denotes the Lie algebra of 0 (n). (The Cartan product of two irreducible representations with dominant weights  ${}_1$  and  ${}_2$  is the irreducible sub-representation of the tensor product with dominant weight  ${}_1+{}_2$ .)

W e denote by

$$^{2}M = ^{J;+}M$$

the (orthogonal) decomposition of  $^2M$  into its J-invariant part,  $^{J;+}M$ , and its J-anti-invariant part,  $^{J;}M$ . The Riemannian curvature R has values in  $^{J;+}M$  and therefore acts trivially on  $^{J;}M$ . More generally, we call an element of RM kahlerian if it acts trivially on  $^{J;}M$ . The set of abstract kahlerian curvature tensors is a vector subbundle of RM, denoted by KM; thus KM is the kernel of the linear map from  $^{J;+}M$  to  $^{4}M$  determined by the wedge product.

The curvature tensor R of a Kahler manifold (M;g;J) is a section of KM, but in general none of its components in (2) is. Indeed, the rst component of R in (2) is only an element of KM if it is zero or n=2, while the second component is only an element of KM if it is zero or n=4. We do not the Bochner tensor W KD be the orthogonal projection of the third component, the Weyl tensor W, onto KM; it follows that W KD belongs to the intersection W M \ KM . By projecting the

other components of (2) orthogonally onto KM to obtain a new decomposition of the curvature R inside KM .

Here j  $_{J_{i+}M}$  has to be interpreted as the orthogonal projection  $7^{-J_{i+}}$  of  $^{2}M$  onto its J-invariant part  $^{J_{i+}}M$ , and  $_{0}$ ! acts on  $^{2}M$  to give  $h_{0}$ ; i!, where the inner product on 2-form s is normalized so that h!;!  $i=m=\frac{n}{2}$ .

The three pieces of R appearing in (3) are sections of subbundles of KM associated to irreducible representations of the unitary group U (m), viewed as a subgroup of O (n), namely: the trivial representation, the Cartan product  $C^m$   $C^m$ , the Cartan product su (m) su (m) respectively, su (m) being the Lie algebra of SU (m).

If Scal is a positive constant, then the rst component of R in (3) agrees with the curvature of the complex projective space CP  $^m$  with the Fubini{Study metric of holom orphic sectional curvature equal to  $\frac{Scal}{m \ (m+1)}$ .

The second component in (3) agrees with the second component in (2) when n=4, since then  $fRic_0$ ;  $^{J}$ ;  $g=[J^{J}]$ ;  $_0]=0$ , whereas  $fRic_0$ ;  $^{J}$ ; g=h;  $_0i!+h$ ;  $!i_0$ . The four dimensional case is also special because the Weyl tensor Weyl tens

Bringing together W  $^+$  and the scalar part of R in (2), we deduce that W  $^K=W$ . In higher dimensions, the W eyl tensor W of a Kahler manifolds splits into three pieces: one is the Bochner tensor W  $^K$ , while the other two are identified with Rico and Scal. In other words, on a Kahler manifold of dimension n=2m=6 the information given by the Riemannian curvature is already contained in the Weyl tensor; in particular, for n=6, a locally conformally—at Kahler metric is at.

(We specialize (4) by  $X=e_j$ ,  $Y=Je_j$ , where  $fe_jg$  is a local, J-adapted, orthonormal frame and we observe that  $=\frac{1}{2}\prod_{j=1}^nR_{e_j}$ ; here we do not  $(R)_{JX}:=\prod_{j=1}^nr_{e_i}R_{e_i}$ ; JX.) The M atsushim a identity immediately implies that the Ricci tensor of a K ahlermanifold is parallel if and only if the curvature is co-closed, as a 2-form with values in M.

The Ricci form may also be expressed as  $(X;Y) = \frac{1}{2} \sum_{j=1}^{n} hR_{X,Y} e_j; Je_j i$ , and so it follows from (4) that it is closed. Hence from (3) and (5), we infer the following

expression for the codi erential of the Bochner tensor:

De nition 1. A Kahler manifold (M;g;J) is called Bochner- at (or Bochner{Kahler) if the Bochner tensor vanishes, W $^{\rm K}=0$ , and weakly Bochner- at if the Bochner tensor is co-closed, W $^{\rm K}=0$ .

By (7), a Kahler manifold is weakly Bochner- at if and only if it satis es the following weak Einstein condition:

1.4. Conform ally-E instein K ahler m etrics. A Kahler m anifold (M;g;J;!) of dimension n=2m-4 is said to be conformally-E instein if there is a nonvanishing function such that  $g := {}^2g$  is an E instein m etric, i.e.,  $R ic_0^g = 0$ . A straightforward and standard computation of the conformal change of the Ricci tensor shows that g is conformally-E instein with conformal factor—if and only if

We recall that a ham iltonian vector eld  $K = J \operatorname{grad}_g f$  is K illing if and only if it preserves J, if and only if the hessian r df is J-invariant, if and only if r J df =  $\frac{1}{2} \operatorname{dd}^c f$ , in which case f is said to be a K illing potential.

C learly equation (9) in plies that  $2 \, \text{(m)} 1$  or  $Jd = \, \text{(m)} 1$  ddf, so that by dierentiating (9), we obtain  $d \, ^2 = 0$  and hence  $d \, ^2 = 0$ . We shall say that g is strongly conform ally-E instein if  $d \, ^2 = 0$ ; this is automatic if  $d \, ^2 = 0$  since the wedge product with! is then injective on 2-form s.

The fact that conform ally-E instein K ahler metrics are strongly conform ally-E instein in 6 or more dimensions was rst observed by D erdzinski and M aschler [9], who used this fact to obtain an explicit local description of such metrics. A key step in their description is essentially equivalent to the following.

Lem m a 1. [9] Suppose that g is strongly conformally-E instein, with conformal factor. Then on the open set where d is nonzero,

## 2. Hamiltonian 2-forms

In this section we introduce the notion of a ham iltonian 2-form and develop the most basic general properties and the simplest examples.

2.1. Ham iltonian 2-form s and K illing vector elds. The de nition of ham iltonian 2-form s is motivated both by weakly Bochner at Kahler manifolds and by strongly conform ally-E instein Kahler manifolds. The reason for the term inology will shortly become apparent.

De nition 2. Let be any (real) J-invariant 2-form on the Kahler manifold (M;g;J;!). We say is ham iltonian if there is a function on M such that

for any vector eld X . W hen M is a Riemann surface, we require in addition that is a K illing potential.

It follows im mediately from the denition that d=dtr, where tr=h;! i is the trace of with respect to!, so without loss of generality, we may take = tr. The dening equation for ham iltonian 2-form s is therefore linear. Note that, for a general ham iltonian 2-form , A=+! is closed, dA=0.

Example 1.0 n any Kahler manifold, any J-invariant parallel 2-form is ham iltonian. In particular, a constant multiple of the Kahler form! is ham iltonian. It follows that if is ham iltonian, then so is t = t! for any constant t.

Example 2. We shall be particularly interested in the ham iltonian 2-forms arising from the following immediate consequence of equation (8).

Proposition 1. A Kahler manifold of dimension n=2m 4 is weakly Bochnerat if and only if the normalized Ricci form  $\sim = 0 + \frac{1}{m} s! = s!$  is ham iltonian.

Example 3. In view of equation (11), we also have the following result.

Proposition 2.0n any strongly conformally-Einstein Kahler manifold of dimension 2m 4, with conformal factor, there are constants a; b not both zero, such that = (a + b)d  $^Jd = jd$   $^J$  jis ham iltonian on the open set where d is nonzero.

The equation for ham iltonian 2-form s is overdeterm ined. By di erentiating and skew-sym m etrizing (12), we get

Proposition 3. If is a ham iltonian 2-form, then the functions p(t) on M (for each t 2 R) are Poisson-commuting ham iltonians for K illing vector elds K (t) =  $J \operatorname{grad}_{\alpha} p(t)$  which preserve. In particular, the vector elds K (t) all commute.

Proof. We rest prove that  $K := J \operatorname{grad}_g$  is K illing, i.e., r d is J-invariant. Since  $R_{X,Y}$  is J-invariant in X and Y, equation (13) in plies that

2.2. The connection on 2-jets of ham iltonian 2-form s. We have noted already that the equation for ham iltonian 2-form s is overdeterm ined. In fact it has nite type, i.e., the space of local solutions is nited in ensional, being given by the parallel sections for a connection on the 2-jets of ham iltonian 2-form s. In this section, we not this connection and compute its curvature.

The de ning equation (12) for ham iltonian 2-forms shows that the 1-jet of is determined by (; K), where  $K = J \operatorname{grad}_{\alpha}$ :

2.3. The di erential system in the weakly Bochner- at case. On a weakly Bochner- at Kahler manifold, the normalized Ricci form  $\sim$  is ham iltonian. These cases can be considered together by supposing that (g;J;!) is a weakly Bochner- at Kahler metric with a ham iltonian 2-form such that  $\sim$  is a constant linear combination of and !. Follow ing B ryant, we refer to  $F_C$  as the characteristic polynom ial of (q;J;!;).

2.4. Ham iltonian 2-forms on complex projective and hyperbolic space. A Kahler manifold has constant holomorphic sectional curvature if and only if it is Bochner- at and Kahler(Einstein. Ham iltonian 2-forms on such a manifold therefore correspond to solutions of (25) with W  $^{\rm K}$  = 0,  $_0$  = 0 and  $_1$  = 2s=m (recall s = h~;!i). In this case, it follows from (23) and (24) that the connection dening the linear system is at a one can easily check directly.

Let us consider the case that s is nonzero, i.e., up to scale, the Kahler metric is the Fubini{Study metric of complex projective space, or the Bergm an metric of complex hyperbolic space. If we put  $_2 = 2s = m$ , the system (25) becomes

The (m $^2$  + 2m + 1)-dim ensional space of ham iltonian 2-forms (parallel sections (;K;)) corresponds precisely to the (m + 1) $^2$ -dim ensional space of Killing potentials, and the latter may be identified with the unitary Lie algebra u (m + 1) or u (m;1), using the Poisson bracket. We can thus classify ham iltonian 2-forms on complex projective and hyperbolic space by classifying elements of this Lie algebra, which essentially amounts to adding the characteristic polynomial (we ignore the more rened information needed to classify the non-sem is impleelements of u (m;1)).

Specializing Proposition 4 to the case in hand gives a degree m + 1 polynom ial

with constant coe cients. We shall obtain an explicit description of the ham iltonian 2-form swith a given characteristic polynom ial  $F_c$  (t) in section 5.4 below.

We end the section by remarking that in the positive curvature case, the Killing potentials, hence also the ham iltonian 2-forms, are all globally dened on CP  $^{\rm m}$  | indeed the Killing potentials are nothing but the eigenfunctions corresponding to the rst non-zero eigenvalue  $2\frac{m+1}{m}s$  of the Laplacian, plus constants.

#### 3. Hamiltonian torus actions

We have seen that on a Kahler 2m-m anifold with a ham iltonian 2-form, there is a fam ily of Poisson-commuting ham iltonian Killing vector elds K (t) =  $J \operatorname{grad}_g p(t)$ . Since p(t) is a monic polynomial of degree m, the span of the K (t) is at most mdimensional. If they are not all zero, then on an open set where the span has rank ', 1 'm, the K (t) generate a local action of an '-dimensional torus.

In this section we study the geom etry of ham iltonian 'torus actions in general. Our discussion is independent of the theory of ham iltonian 2-form s, but is strongly motivated by it, as we shall see later. Roughly speaking, there are two aspects to the description of ham iltonian 'torus actions on M . First, if '< m , there is the geom etry of the bration de ned by the complexied action. Second, if '> 1, there is the toric geom etry of the bres. In full generality, these structures are quite dicult to study. However, there is a class of brations, called generalized Calabi constructions, and a class of toric manifolds, called orthotoric, which are more amenable to computation. It will turn out that ham iltonian 'torus actions induced by ham iltonian 2-form s are always given by generalized Calabi constructions with orthotoric bres.

## 31. Ham iltonian actions and the Pedersen (Poon Ansatz.

De nition 3. A ham iltonian 'torus action on a Kahler manifold (M;g;J;!) of dimension n=2m is a torus action generated by an 'torus ensional fam ily of holomorphic Killing vector elds K 2 C  $^1$  (M;TM) R' which are linearly independent on a dense open set and isotropic in the sense that ! (K;K) = 0.

The last condition means that every component of JK is orthogonal to every component of K. It follows that '  $m \mid \text{if equality holds, we say that } (M; g; J; !)$  is a toric Kahler manifold.

For clarity, we write  $K_r = K$  ( $e_r$ ) (r = 1; :::`) for the components of K with respect to a basis  $e_r$  of R' | this choice is by no means necessary and could be interpreted as an abstract index notation. In this subsection and the next (only) we adopt the sum mation convention and contract repeated indices.

Since  $L_{K_r}!=0$  for all r, and ! is closed, we have  $[K_r;K_s]=0$  (!  $(K_r;K_s))=0$  so that the holomorphic K illing vector elds  $K_r$  commute. Furthermore, since  $L_{K_r}J=0$  and J is integrable,  $L_{JK_r}J=0$  for all r, so that  $[K_r;JK_s]=0=[JK_r;JK_s]$ . Hence K generates a local isometric action of an 'torus, and K , JK span an integrable rank 2' distribution tangent to a foliation F of M .

We can make an analogous de nition for any almost Hermitian manifold, although if the Kahler form is not closed, we assume a priori that  $[K_r; K_s] = 0$  for all r;s, while if J is not integrable, we assume a priori that  $[JK_r; JK_s]$  is in the span of JK for all r;s.

In order to obtain a local description of these m etrics, valid near any point in the dense open set where the K  $_{\rm r}$  are linearly independent, we m ay assume that M is a principal 'torus bundle over a (2m ')-dimensionalm anifold B, and that the foliation F dense a bration over a 2 (m ')-dimensionalm anifold S.

Let ;J = J 2  $^{\circ}$  (M;  $^{1}$ M) R be the connection 1-forms dual to K; JK, i.e.,  $_{r}$  (K $_{s}$ ) =  $_{rs}$  and  $_{r}$  vanishes on the distribution orthogonal to F. (W e m ay locally write  $_{r}$  =  $dt_{r}$  +  $_{r}$  where t:M! R and  $_{r}$  (K $_{s}$ ) = 0 =  $_{r}$  (JK $_{s}$ ).)

The two families of 1-forms J  $\,$  and  $\,_{\rm K}$  ! span the same '-dimensional space. Hence we may write

where  $G_{rs}$  and  $H_{rs}$  are mutually inverse matrices of functions preserved by K . Since  $g(K_r;K_s) = !(K_r;JK_s) = H_{rs}$ , we deduce that  $G_{rs}$  and  $H_{rs}$  are symmetric and positive de nite.

Now ! is closed and K -invariant, so  $_{\rm K_r}$ ! is closed. If we locally write  $_{\rm K_r}$ ! = d  $_{\rm r}$ , then  $_{\rm r}$  is a K illing potential for K  $_{\rm r}$ , and  $_{\rm r}$ ! R  $^{\rm h}$  is a momentum map for the 'torus action. The integrability of J in plies that the JK  $_{\rm r}$  are commuting holomorphic vector elds, so that S is a complex manifold, the Kahler quotient: since it may be locally idential ed with any level surface of , S has a family of Kahler structures parameterized by points in the image of the momentum map .

It is useful to decom pose the exterior derivative on B into horizontal and vertical parts as

Pedersen and Poon [18] do not develop the potential form ulation in terms of G, which is instead inspired by work of G uillem in on the toric case [11] (see below, and also [1]). We shall refer to G as a dual potential.

Rem ark 1. It is crucial in P roposition 5 that the torus action is ham iltonian in the strong sense that the momentum maps Poisson-commute, i.e.,  $d_r(K_s) = 0$ . This condition is often missed in the literature, since if  $K_r$  and  $K_s$  commute,  $d_r(K_s)$  is constant, and on a compact manifold r must have a critical point, so the constant is zero. However, we are not assuming compactness: indeed, the above local description is only valid on an open set where r has no critical points!

The Pedersen (Poon Ansatz for Kahlermanifolds with a ham iltonian 'torus action is too complicated, in its fullest generality, for constructing interesting Kahlermetrics. Indeed most applications, including those in [18], use only Kahlermetrics in the following subclass.

(ii) and (iii) are equivalent by (29) and (31).

When '= 1 it is essentially equivalent to constructions due to Calabi [6, 7] of Kahler metrics on complex line bundles, and their natural extensions [12, 21, 22]: many known examples of extremal Kahler metrics, including constant scalar curvature metrics and Kahler (Einstein metrics, tinto this framework. However, for larger ', the general toric Kahler metric on the bres is still rather di cult to handle.

## 3.4. O rthotoric K ahler m etrics.

De nition 5. A Kahler manifold (M; g; J; !) of real dimension n = 2m is called orthotoric if it is equipped with m real functions i such that:

- (i) the vector elds  $L_j := Jgrad_{q-j}$  are linearly independent and orthogonal;
- (ii) the vector  $elds\ K_r := Jgrad_{q-r}$  are K illing and Poisson-commuting, where  $_1$ ;:::  $_m$  are the elementary symmetric functions of the  $_1$ 's.

Note that an orthotoric K ahlerm anifold is certainly toric, and any toric R iem ann surface is orthotoric. For a higher dimensional toric manifold it is hard to detect whether it is orthotoric: in the orthotoric case there is choice of momentum map (  $_1;:::_m$ ), with respect to some basis for the m-dimensional family of K illing vector elds, such that the roots  $_j$  of the polynomial  $_{r=0}^m$  (  $_1)^r$   $_r$ t have orthogonal gradients, but it may not be easy to not such a momentum map.

## 4. Classification of hamiltonian 2-forms

4.1. Rough classication of ham iltonian 2-forms. On any Kahler manifold, any J-invariant parallel 2-form is ham iltonian. However, in this case the Killing vector elds K (t) are all identically zero. For a general ham iltonian 2-form , it is important to know how many of the K (t) are linearly independent.

In order to do this, we (tem porarily) write  $p(t) = \sum_{r=0}^{m} (1)^r r^{t^m}$  and  $K_r = J$  grad<sub>g</sub> r for the coe cients of the momentum polynom ial and the corresponding K illing vector elds. Hence K (t) =  $\sum_{r=1}^{m} (1)^r K_r t^{t^m}$  is a linear combination of  $K_1$ ;::: $K_m$  for any t.

Proof. By the maximality of ', wherever  $_1$ ;::: $_m$  can be smoothly dened, at most 'of the d $_i$  are independent. At the other extreme, when '= m, M is toric and Lemma 5 shows in fact that it is orthotoric, so has the explicit form of Proposition 10, determined by m functions of one variable.

42. Explicit description of the metric. We now present the general description of Kahlermanifolds with a hamiltonian 2-form. To do this, it will be convenient to adopt dierent notation from the previous subsection.

4.3. The ham iltonian 2-form . The theorem of the previous subsection shows that if M is a K ahler manifold with a ham iltonian 2-form , then the K ahler structure is given explicitly by the generalized C alabi construction over the K ahler manifold S , with orthotoric bres, and with constants  $c_r = (1)^r$ .

However, we have not yet shown that for any such explicit Kahler structure, equation (64) actually does do not a ham iltonian 2-form. 5.2. Extrem al K ahler m etrics. Recall that a K ahler m etric is called extrem al if the scalar curvature is a K illing potential [6, 7]. W eakly B ochner- at K ahler m etrics of dimension n=2m-4 are extrem al, since the scalar curvature is then the trace of a ham iltonian 2-form. In this section we classify the extrem al K ahler m etrics w ith a ham iltonian 2-form such that  $d_h Scal=0$ , i.e., the scalar curvature is a ham iltonian for a K illing vector eld tangent to the bres of M over S.

Our proof above is very much inspired by [5, Section 4.5], where Bryant indicates how to obtain an explicit formula for the general Bochner- at metric, although he stops short of providing the nal formula. Our approach has proceeded in reverse, by rst nding the general formula, then showing that it is Bochner-at. This has permitted us to give a proof using standard methods in Kahler geometry, substituting a linear system for the nonlinear system which Bryant integrates using Cartan's generalization of Lie's Third Theorem.

Bryant's remarkable paper also addresses global questions: the compact Bochnerat Kahler manifolds necessarily have constant holomorphic sectional curvature, but Bryant nds compact orbifold examples, and classies the complete examples (cf. also [2] for the case of K ahler surfaces). In a subsequent paper we shall show that there are m any m ore compact weakly Bochner- at Kahler m anifolds than just the manifolds of constant holomorphic sectional curvature (see also [3]).

We end the present section by discussing the characteristic polynomial. We write F for  $F_i$  (the latter being independent of j), and de ne  $F^{red}$  (t) = F (t) =  $P_c$  (t) =

In section 2.4 we showed that ham iltonian 2-forms are given by parallel sections with respect to a at connection on a bundle of rank  $(m+1)^2$ . In the simply-connected case, or more generally, when the Kahler manifold is an open subset of  $C^m$ ,  $CP^m$  or  $CH^m$ , the connection trivializes this bundle and the solutions extend globally to  $C^m$ ,  $CP^m$  or  $CH^m$ . In the nonzero scalar curvature case, we identifed the solution space with u(m+1) or u(m;1), the Lie algebra of Killing potentials under Poisson bracket. The scalar curvature is nonzero when  $F^{red}$  has exactly degree '+ 1.

5.5. The Calabi-type case. To illustrate the conditions of the previous subsections, and for use in the next subsection, we specialize to the simple, but important case of ham iltonian 2-forms of order one, with the constant roots all zero. The

Propositions 14, 15 and 16 specialize as follows:

5.6. Strongly conform ally-E instein K ahler m etrics. We return brie y to the strongly conform ally-E instein m anifolds of D erdzinski (M aschler [9] and explain how their classication can be derived in a natural way in our fram ework.

We recall that if (M; g; J; !) strongly conform ally-E instein with conform al factor, then =  $(a + b)d ^3 = jd ^2j$  is a ham iltonian 2-form with trace = a + b. If a = 0 then is parallel, and M is a Kahler product of a R iem ann surface and a Kahler manifold of dimension 2m + 2. We shall concentrate on the more interesting case  $a \in 0$ . We set a = 1 = q and b = p = q so that = q + p. This allows us to take the  $\lim it q ! = 0$ , when is constant and (M; g; J; !) is Kahler (E instein. Since is ham iltonian of order one, with all constant roots zero, the Kahler structure has the explicit form (80) given in the previous subsection. We also recall from the previous subsection that g is conform all to a K ahler metric  $\overline{g}$  with the opposite orientation. This new K ahler metric is conform ally-E instein with conform all factor  $\overline{\phantom{g}} = q + \overline{p}$ . Just as q=0 corresponds to the case that g is K ahler (E instein, so p=0 corresponds to the case that  $\overline{g}$  is K ahler (E instein.

Appendix A. Conformal Killing forms and hamiltonian 2-forms

We have noted already that for any ham iltonian 2-form  $\ A = + ! = 0$  is closed. One also easily observes that  $\ m : is co-closed$  (divergence-free). In this appendix we relate ham iltonian 2-form s to conform al K illing 2-form s, which have been investigated recently by Semmelmann [20].

De nition 7. A conformal Killing or twistor 2-form on a Riemannian manifold of dimension n 3 is a 2-form satisfying the equation

for all vector elds X, where is a 1-form and is a 3-form.

It follows im m ediately from this equation that = =  $_{i}^{P}$   $_{i}$   $_{e_{i}}$  r  $_{e_{i}}$  and that = d . Hence is a conform alK illing 2-form if and only if r , which is a section of  $^{1}$ M  $^{2}$ M , is the kernel of the natural projections to  $^{1}$ M and  $^{3}$ M .

The notion of conform alK illing form can be extended to p-form s and is conformally invariant for p-form s of weight 1, i.e., for sections of  $L^{p+1}$   $^pM$ , where L is the density line bundle.

The following observation is due in part to Sekizawa [19] and Semmelmann [20].

Proposition 18. Let (M;g;J;!) be a Kahler manifold of dimension n=2m 4

- (i) If is a ham iltonian 2-form, then the J-invariant 2-form =  $\frac{1}{2}$  (tr )! is a conform al K illing 2-form, with tr =  $1 \frac{m}{2}$  tr.
- (ii) Conversely, if is a J-invariant conformal Killing 2-form, then

In particular, for m > 2 the map 7  $\frac{1}{2}$  (tr )! is a bijection from ham iltonian 2-forms to J-invariant conformal K illing 2-forms, with inverse 7  $\frac{1}{m-2}$  (tr )!.

The equation for conform alk illing form s im plies

We end this appendix by remarking that there is also a connection between ham iltonian 2-forms and K illing tensors (cf. [13]), i.e., symmetric 2-tensors S satisfying sym r S = 0. Indeed is ham iltonian if and only if A = + ! is closed and S = J ( !) is a K illing tensor. For the reverse implication, observe that dA = 0 determines  $r_X$  (Y;Z) +  $r_Y$  (X;Z) +  $r_Z$  (X;Y) in terms of the 1-form d , while sym r S = 0 determines  $r_X$  (JY;Z) +  $r_Y$  (JZ;X) +  $r_Z$  (JX;Y). Replacing JY by Y in the second expression and adding to the rst yields a formula for  $2r_X$  (Y;Z) +  $r_Y$  (Z;X)  $r_{JY}$  (JZ;X) and the J-invariant part (in Y;Z) is (12).

# Appendix B. Vandermonde matrices

B.1. The inverse of a Vanderm onde matrix. A Vanderm onde matrix is a (m - m)-matrix of the form

B 2. The determ inant of a Vanderm onde m atrix. In order to compute the determ inant detV of V, we use the fact that W  $_{11}=\frac{1}{_{1}}$  is equal to the determ inant of the m inor of  $V_{11}$  in V divided by detV. Now the m inor of  $V_{11}$  is clearly V (2;:::; m); we thus get the following induction formula:

In fact we shall only make serious use of the identities (96) and (97) for 0 s 2. In particular (96) implies
