On the index of a vector field tangent to a hypersurface with non-isolated zero in the embedding space

Abstract

We give a generalization of an algebraic formula of Gomez-Mont for the index of a vector field with isolated zero in $(\mathbb{C}^n, 0)$ and tangent to an isolated hypersurface singularity. We only assume that the vector field has an isolated zero on the singularity here.

1 Introduction

Let $(V,0) = (\{f = 0\}, 0) \subseteq (\mathbb{C}^n, 0)$ be an isolated singularity of a hypersurface and

$$X = X_1 \frac{\partial}{\partial z_1} + \dots + X_n \frac{\partial}{\partial z_n}$$

the germ of a holomorphic vector field on $(\mathbb{C}^n, 0)$ tangent to (V, 0), say Xf = cf, with an isolated zero on (V, 0). In [3] is defined a notion of an index $\operatorname{ind}_{V,0}X$ of this vector field, called GSV index and generalizing the Poincaré-Hopf index. By contracting germs of Kähler forms on (V, 0) with X one obtains two complexes

$$(\Omega_{V,0}^*, X) \colon 0 \to \Omega_{V,0}^n \xrightarrow{X} \cdots \xrightarrow{X} \Omega_{V,0}^1 \xrightarrow{X} \mathscr{O}_{V,0} \to 0$$
$$(\Omega_{V,0}, X) \colon 0 \to \Omega_{V,0}^{n-1} \xrightarrow{X} \cdots \xrightarrow{X} \Omega_{V,0}^1 \xrightarrow{X} \mathscr{O}_{V,0} \to 0$$

which have both finite dimensional homology spaces, see [2]. We set

$$h_i^* := \dim_{\mathbb{C}} H_i(\Omega_{V,0}^*, X) \qquad h_i := \dim_{\mathbb{C}} H_i(\Omega_{V,0}, X).$$

It has been proved in [2] that the topologically defined GSV index is given as

$$\operatorname{ind}_{V,0} X = \chi(\Omega_{V,0}, X) = \sum_{i=0}^{n-1} (-1)^i h_i.$$

Further the numbers h_i and h_i^* are computed under the condition that X has an isolated zero on $(\mathbb{C}^n, 0)$. We want to extend these computations to the case that X has an isolated zero only on (V, 0) using the same methods as in [2]. Note that one can assume after a linear change of coordinates in $(\mathbb{C}^n, 0)$ that $(X_1, \ldots, X_{n-1}, f)$ is a regular \mathscr{O} -sequence. Throughout this paper we always assume the coordinates to be chosen in this way. We denote by

$$\mathscr{A} := \frac{\mathscr{O}}{(\partial f / \partial z_1, \dots, \partial f / \partial z_n)}$$

the Milnor algebra of f at 0 and we set

$$\mathscr{B} := \frac{\mathscr{O}}{(X_1, \dots, X_n)} \qquad \mathscr{B}' := \frac{\mathscr{O}}{(X_1, \dots, X_{n-1})}.$$

We simply write \mathscr{O} resp. Ω^i instead of $\mathscr{O}_{\mathbb{C}^n,0}$ resp. $\Omega^i_{\mathbb{C}^n,0}$. \mathscr{B}' is infinite dimensional and \mathscr{B} not necessarily finite dimensional. Our main result is the following:

Theorem 1. The \mathbb{C} -dimensions of the homology spaces of $(\Omega_{V,0}, X)$ are given by

$$h_0^* = \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)},$$

$$h_1^* = \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{(c)} + \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{\operatorname{ann}_{\mathscr{B}'}(X_n) \cap \mathscr{B}'(f, \partial f/\partial z_n)},$$

$$h_2^* = \dots = h_n^* = \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{A}}(f)}{(c)} = \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{A}}(c)}{(f)} =: \lambda.$$

2 The homological index

The first steps are easy generalizations of the computations in [2]. Consider the complex

$$(\Omega^*, X) \colon 0 \to \Omega^n \xrightarrow{X} \cdots \xrightarrow{X} \Omega^1 \xrightarrow{X} \mathscr{O} \to 0.$$

Lemma 1. $H_j(\Omega^*, X) = 0$ for $j \ge 2$ $H_1(\Omega^*, X) \cong \operatorname{ann}_{\mathscr{B}'}(X_n), (h_1 dz_1 + \dots + h_n dz_n \to h_n)$ $H_0(\Omega^*, X) \cong \mathscr{B}.$

Proof. It follows immediately from the dual version of Corollary 17.12 of [1]. \Box

Multiplication with c gives us a map of complexes

$$\cdot c \colon (\Omega^*, X) \to (\Omega^*, X).$$

We denote by \mathcal{B} the mapping cone associated to this map, see [1]. We have

$$\mathcal{B} \colon 0 \leftarrow \mathscr{O} \oplus 0 \stackrel{\beta}{\leftarrow} \Omega^1 \oplus \mathscr{O} \stackrel{\beta}{\leftarrow} \cdots \stackrel{\beta}{\leftarrow} \Omega^n \oplus \Omega^{n-1} \stackrel{\beta}{\leftarrow} 0 \oplus \Omega^n \stackrel{\beta}{\leftarrow} 0$$

where

$$\beta(\omega,\eta) := \begin{pmatrix} X & (-1)^j c \\ 0 & X \end{pmatrix} \begin{pmatrix} \omega \\ \eta \end{pmatrix} := \begin{pmatrix} X(\omega) + (-1)^j c \eta \\ X(\eta) \end{pmatrix},$$

and j is the degree of $(\omega, \eta) \in \Omega^j \oplus \Omega^{j-1}$.

Lemma 2. $H_k(\mathcal{B}) = 0 \text{ for } k \ge 3$ $H_2(\mathcal{B}) \cong \operatorname{ann}_{\mathscr{B}'}(X_n) \cap \operatorname{ann}_{\mathscr{B}'}(c)$ $H_1(\mathcal{B}) \cong \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{c \cdot \operatorname{ann}_{\mathscr{B}'}(X_n)} \oplus \operatorname{ann}_{\mathscr{B}}(c)$ $H_0(\mathcal{B}) \cong \frac{\mathscr{B}}{(c)}.$

Proof. $H_0(\mathcal{B}) \cong \frac{\mathscr{B}}{(c)}$ is obvious. We have an exact sequence of complexes



From the long exact sequence of homology we get $H_k(\mathcal{B}) = 0$ for $k \ge 3$ and the non-trivial part of the sequence is

$$0 \to H_2(\mathcal{B}) \xrightarrow{p_2} H_1(\Omega^*, X) \xrightarrow{\cdot c} H_1(\Omega^*, X) \xrightarrow{i_1} H_1(\mathcal{B}) \xrightarrow{p_2} \mathscr{B} \xrightarrow{\cdot c} \mathscr{B} \to \frac{\mathscr{B}}{(c)} \to 0,$$

where i_1 is the inclusion to the first factor and p_2 the projection onto the second factor. Now one has

$$H_2(\mathcal{B}) \cong \operatorname{im} p_2 = \ker c \cong \operatorname{ann}_{\mathscr{B}'}(X_n) \cap \operatorname{ann}_{\mathscr{B}'}(c)$$

by Lemma 1 and the isomorphism given there. Further we get

$$H_1(\mathcal{B}) \cong \ker p_2 \oplus \operatorname{im} p_2.$$

We have $\operatorname{im} p_2 = \ker c = \operatorname{ann}_{\mathscr{B}}(c)$ and

$$\ker p_2 = \operatorname{im} i_1 \cong \frac{H_1(\Omega^*, X)}{\ker i_1} = \frac{H_1(\Omega^*, X)}{\operatorname{im} c} \cong \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{c \cdot \operatorname{ann}_{\mathscr{B}'}(X_n)}.$$

Lemma 3.

$$H_1(\Omega^*_{V,0}, X) \cong \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)} \oplus \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{\operatorname{ann}_{\mathscr{B}'}(X_n) \cap \mathscr{B}'(f, \partial f/\partial z_n)}$$

Proof. We have an exact sequence of complexes



where $\mathscr{R}^k := f\Omega^k + df \wedge \Omega^{k-1}$. From Lemma 1 one gets the last part of the long exact sequence in homology

$$0 \to H_2(\Omega^*_{V,0}, X) \xrightarrow{\delta_2} H_1(\mathscr{R}, X) \xrightarrow{i_1} H_1(\Omega^*, X) \xrightarrow{p_1} H_1(\Omega^*_{V,0}, X) \xrightarrow{\delta_1} \\ \xrightarrow{\delta_1} H_0(\mathscr{R}, X) \xrightarrow{i_0} \mathscr{B} \xrightarrow{p_0} \frac{\mathscr{B}}{(f)} \to 0,$$

where δ_1 and δ_2 are the connecting homomorphisms. This gives us

$$H_1(\Omega^*_{V,0}, X) \cong \ker \delta_1 \oplus \operatorname{im} \delta_1.$$

One has $\operatorname{im} \delta_1 = \ker i_0$, $\mathscr{R}^0 = f \mathscr{O}$ and $\mathscr{R}^1 = f \Omega^1 + df \mathscr{O}$. For

$$\omega = f(h_1 dz_1 + \dots + h_n dz_n) + h df$$

we get

$$X(\omega) = f(X_1h_1 + \dots + X_nh_n) + hcf$$

and therefore

$$\ker i_0 = \frac{\{gf \in \mathcal{O} : gf \in I_n\}}{fI_n + \mathcal{O}(cf)}.$$

We have set $I_n := \mathcal{O}(X_1, \ldots, X_n)$ here. On the other hand multiplication gives an isomorphism

$$f: \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)} \to \frac{\{gf \in \mathscr{O} : gf \in I_n\}}{fI_n + \mathscr{O}(cf)}$$

and this proves

$$\operatorname{im}\delta_1 \cong \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)}.$$

Consider ker δ_1 now. Then we have

$$\ker \delta_1 = \operatorname{im} p_1 \cong \frac{H_1(\Omega^*, X)}{\ker p_1} = \frac{H_1(\Omega^*, X)}{\operatorname{im} i_1}.$$

We have an isomorphism

$$\phi \colon H_1(\Omega^*, X) \to \operatorname{ann}_{\mathscr{B}'}(X_n)$$

given as $\phi(h_1 dz_1 + \dots + h_n dz_n) = h_n$ with $X_1 h_1 + \dots + X_n h_n = 0$. To prove

$$\ker \delta_1 \cong \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{\operatorname{ann}_{\mathscr{B}'}(X_n) \cap \mathscr{B}'(f, \partial f/\partial z_n)}$$

we have to show

$$\phi \circ i_1(H_1(\mathscr{R}, X)) = \operatorname{ann}_{\mathscr{B}'}(X_n) \cap \mathscr{B}'(f, \partial f / \partial z_n)$$

" \subseteq ": Let $\omega \in H_1(\mathscr{R}, X)$, say $\omega = f(h_1 dz_1 + \dots + h_n dz_n) + hdf$ with $X(\omega) = 0$ and so we have $f(X_1h_1 + \dots + X_nh_n) + hcf = 0$. ω is mapped to $fh_n + h\partial f/\partial z_n$. Modulo I_{n-1} we have

$$(fh_n + h\partial f/\partial z_n)X_n = fh_nX_n + hcf = 0$$

and this shows the inclusion. Here we have set $I_{n-1} := \mathscr{O}(X_1, \ldots, X_{n-1})$. " \supseteq ": Let $h \in \operatorname{ann}_{\mathscr{B}'}(X_n) \cap \mathscr{B}'(f, \partial f/\partial z_n)$ be a representative, say

$$hX_n = g_1 X_1 + \dots + g_{n-1} X_{n-1}$$

and $h = s_1 f + s_2 \partial f / \partial z_n$ with $s_1, s_2 \in \mathcal{O}$. It follows that

$$s_1 f X_n + s_2 \partial f / \partial z_n X_n = f(s_1 X_n + s_2 c) - s_2 (\partial f / \partial z_1 X_1 + \dots + \partial f / \partial z_{n-1} X_{n-1})$$

= $g_1 X_1 + \dots + g_{n-1} X_{n-1}$

and therefore $f(s_1X_n + s_2c)$ is contained in I_{n-1} . This means that $s_1X_n + s_2c$ is contained in I_{n-1} , because f is not a zero divisor in \mathscr{B}' . Let

$$s_1 X_n + s_2 c = l_1 X_1 + \dots + l_{n-1} X_{n-1}.$$

Then one has

$$g_1 X_1 + \dots + g_{n-1} X_{n-1} = f l_1 X_1 + \dots + f l_{n-1} X_{n-1} - s_2 (\partial f / \partial z_1 X_1 + \dots + \partial f / \partial z_{n-1} X_{n-1})$$

Set

$$\omega := -(fl_1 - s_2\partial f/\partial z_1)dz_1 - \dots - (fl_{n-1} - s_2\partial f/\partial z_{n-1})dz_{n-1} + hdz_n.$$

It follows

$$\omega = f(-l_1dz_1 - \dots - l_{n-1}dz_{n-1} + s_1dz_n) + s_2 \cdot df \in \mathscr{R}^1$$

and

$$X(\omega) = f(-X_1l_1 - \dots - X_{n-1}l_{n-1} + s_1X_n) + s_2cf$$

= $f(-s_1X_n - s_2c + s_1X_n) + s_2cf$
= 0

Therefore $w \in H_1(\mathscr{R}, X)$ with $\phi \circ i_1(\omega) = h$.

2.1 Proof of Theorem 1

The double complex \mathcal{G} We use the construction as in [2]. Consider the double complex \mathcal{G} :



Numeration: $\mathcal{G}_{i,0} = \Omega^i$, $\mathcal{G}_{i,1} = \Omega^i \oplus \Omega^{i-1} = \mathcal{G}_{i+k,1+k}$ for $k \ge 1$ and $\mathcal{G}_{i,j} = 0$ for i < 0 or j < 0. The mappings are $\bar{\alpha}(\omega, \eta) := \pm f\omega + df \wedge \eta$,

$$\alpha(\omega,\eta) := \begin{pmatrix} df & 0\\ \pm f & df \end{pmatrix} \begin{pmatrix} \omega\\ \eta \end{pmatrix} := \begin{pmatrix} df \wedge \omega\\ \pm f\omega + df \wedge \eta \end{pmatrix}$$

and

$$\beta(\omega,\eta) := \begin{pmatrix} X & \pm c \\ 0 & X \end{pmatrix} \begin{pmatrix} \omega \\ \eta \end{pmatrix} := \begin{pmatrix} X(\omega) \pm c\eta \\ X(\eta) \end{pmatrix}.$$

In [2] it is shown that

$$H_i(\operatorname{tot}\mathcal{G}) \cong H_i(\Omega^*_{V,0}, X) \text{ for } 0 \le i \le n$$

and

$$\dim_{\mathbb{C}} H_i(\operatorname{tot}\mathcal{G}) = \lambda \text{ for } i > n,$$

where $\operatorname{tot}\mathcal{G}$ denotes the total complex of \mathcal{G} and λ is defined as in Theorem 1. The argument there does not use at this stage that (X_1, \ldots, X_n) is a regular sequence. The homology spaces of the total complex are also obtained by analizing the spectral sequence (E, d) of \mathcal{G} obtained by taking first the α -homology and then the β -homology. The spectral sequence (E, d) Let us analyze (E, d). We get the following ²*E*-terms by Lemma 1 and Lemma 2:

$${}^{2}E_{0,0} \cong \operatorname{coker}\left(\frac{\mathscr{B}}{(c)} \xrightarrow{\cdot f} \mathscr{B}\right) \cong \frac{\mathscr{B}}{(f)}$$
$${}^{2}E_{0,1} \cong \operatorname{ker}\left(\frac{\mathscr{B}}{(c)} \xrightarrow{\cdot f} \mathscr{B}\right) \cong \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)}$$
$${}^{2}E_{1,0} \cong \operatorname{coker}\left(H_{1}(\mathcal{B}) \xrightarrow{\bar{\alpha}} H_{1}(\Omega^{*}, X)\right)$$
$${}^{2}E_{1,1} \cong \operatorname{homology}\left(\frac{\mathscr{B}}{(c)} \xrightarrow{\alpha} H_{1}(\mathcal{B}) \xrightarrow{\bar{\alpha}} H_{1}(\Omega^{*}, X)\right)$$
$${}^{2}E_{l+1,l} \cong \operatorname{coker}\left(H_{1}(\mathcal{B}) \xrightarrow{\alpha} H_{2}(\mathcal{B})\right)$$
$${}^{2}E_{l,l+1} \cong \operatorname{ker}\left(\frac{\mathscr{B}}{(c)} \xrightarrow{\alpha} H_{1}(\mathcal{B})\right)$$
$${}^{2}E_{l+1,l+1} \cong \operatorname{homology}\left(\frac{\mathscr{B}}{(c)} \xrightarrow{\alpha} H_{1}(\mathcal{B}) \xrightarrow{\alpha} H_{2}(\mathcal{B})\right)$$

where $l \geq 1$ and all other $^2E\text{-terms}$ are trivial. The differential on 2E is now given as

$$d_2 \colon {}^2E_{q-1,p+2} \to {}^2E_{q,p}.$$

Therefore the spectral sequence degenerates at the second level and we are able to compute the total homology of the double complex. First note that

$$\ker\left(H_1(\mathcal{B}) \xrightarrow{\bar{\alpha}} H_1(\Omega^*, X)\right) = \ker\left(H_1(\mathcal{B}) \xrightarrow{\alpha} H_2(\mathcal{B})\right)$$

by the isomorphisms given in Lemma 1 and Lemma 2. Therefore we get

$$\dim_{\mathbb{C}} H_2(\operatorname{tot}\mathcal{G}) = \dim_{\mathbb{C}} H_i(\operatorname{tot}\mathcal{G}) = \lambda$$

for $i \geq 2$ even. Similarly we get

$$\dim_{\mathbb{C}} H_i(\mathrm{tot}\mathcal{G}) = \lambda$$

for $i \geq 3$ odd. Comparing this with the result on $H_i(\text{tot}\mathcal{G})$ in [2] as stated above and using Lemma 3 for h_1^* Theorem 1 follows.

Corollary 1. The following algebras are finite dimensional and for n even

$$\operatorname{ind}_{V,0}(X) = \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} - \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)} - \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{\operatorname{ann}_{\mathscr{B}'}(X_n) \cap \mathscr{B}'(f, \partial f/\partial z_n)} + \dim_{\mathbb{C}} \frac{\mathscr{A}}{(c)} - \dim_{\mathbb{C}} \mathscr{A}$$

and for n odd

$$\operatorname{ind}_{V,0}(X) = \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} - \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)} - \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}'}(X_n)}{\operatorname{ann}_{\mathscr{B}'}(X_n) \cap \mathscr{B}'(f, \partial f/\partial z_n)} + \dim_{\mathbb{C}} \frac{\mathscr{A}}{(f)}$$

Proof. First note that $\Omega_{V,0}^n\cong \frac{\mathscr{A}}{(f)}$ and so we get

$$h_{n-1} = h_{n-1}^* + \dim_{\mathbb{C}} X(\Omega_{V,0}^n)$$
$$= h_{n-1}^* + \dim_{\mathbb{C}} \frac{\mathscr{A}}{(f)} - h_n^*.$$

Now it follows

$$\sum_{\nu=0}^{n-1} (-1)^{\nu} h_i = \sum_{\nu=0}^n (-1)^{\nu} h_i^* + (-1)^{n-1} \dim_{\mathbb{C}} \frac{\mathscr{A}}{(f)}$$

and we get the claim for n odd and for n even

$$\operatorname{ind}_{V,0}(X) = h_0^* - h_1^* - \dim_{\mathbb{C}} \frac{\mathscr{A}}{(f)} + \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{A}}(f)}{(c)}.$$

Since we have an exact sequence

$$0 \to \operatorname{ann}_{\mathscr{A}}(f) \to \mathscr{A} \xrightarrow{\cdot f} \mathscr{A} \to \frac{\mathscr{A}}{(f)} \to 0$$

we get

$$\dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{A}}(f)}{(c)} - \dim_{\mathbb{C}} \frac{\mathscr{A}}{(f)} = \dim_{\mathbb{C}} \frac{\mathscr{A}}{(c)} - \dim_{\mathbb{C}} \mathscr{A}$$

and the corollary follows.

Now if (X_1, \ldots, X_n) is a regular sequence our formula reduces to the formula of Gomez-Mont in the following way. We find that

$$\lambda = \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)} = \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}}(c)}{(f)}$$

and we get for even n

$$\operatorname{ind}_{V,0}(X) = \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} - \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{A}}(f)}{(c)} + \dim_{\mathbb{C}} \frac{\mathscr{A}}{(c)} - \dim_{\mathbb{C}} \mathscr{A}(c)$$
$$= \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} - \dim_{\mathbb{C}} \operatorname{ann}_{\mathscr{B}}(f)$$
$$= \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} - \dim_{\mathbb{C}} \frac{\mathscr{A}}{(f)}.$$

For n odd we get

$$\operatorname{ind}_{V,0}(X) = \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} - \dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{A}}(f)}{(c)} + \dim_{\mathbb{C}} \frac{\mathscr{A}}{(f)}$$
$$= \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} + \dim_{\mathbb{C}} \mathscr{A}(c)$$
$$= \dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} - \dim_{\mathbb{C}} \frac{\mathscr{A}}{(c)} + \dim_{\mathbb{C}} \mathscr{A}.$$

Note that the formula of Gomez-Mont can also be written in this form.

3 Relations to residues and examples

The index of the vector field X can also be computed as a residue, see [5]: Let $\delta_1, \ldots, \delta_{n-1} \in \mathbb{R}_{>0}$ be chosen small enough and the real hypersurfaces $\{|X_i| = \delta_i\}, i = 1, \ldots, n-1$, in general position. Further let the real (n-1)-cycle

$$\Sigma := \{ f = 0, |X_i| = \delta_i, i = 1, \dots, n-1 \}$$

oriented so that $d(\arg X_1) \wedge \cdots \wedge d(\arg X_{n-1}) > 0$. One defines the holomorphic function \hat{c} to be the coefficient of t^{n-1} in the formal power series expansion of

$$\frac{\det(\mathbb{1} - \frac{ti}{2\pi}DX)}{\det(1 - \frac{ti}{2\pi}c)}.$$

Then one has

$$\operatorname{ind}_{V,0}(X) = \int_{\Sigma} \frac{\hat{c}dz_1 \wedge \dots \wedge dz_{n-1}}{X_1 \dots X_{n-1}}.$$

DX is the Jacobi matrix of X here. Let us compute \hat{c} explicitly. Denote by $\sigma_i(DX)$ the coefficients of the characteristical polynomial of DX, i.e.

$$\det(DX - tE) = \sum_{i=0}^{n} (-1)^i \sigma_{n-i}(DX) t^i.$$

Set $g(t) := \det(E - \frac{ti}{2\pi}DX)$ and $h(t) := 1/(1 - \frac{ti}{2\pi}c)$. We have

$$g^{(k)}(0) = \left(\frac{-i}{2\pi}\right)^k k! \sigma_k(DX)$$

and

$$h^{(l)}(0) = l! \left(\frac{ic}{2\pi}\right)^l.$$

Then we get

$$\hat{c} = \frac{(gh)^{n-1}(0)}{(n-1)!}$$

$$= \frac{1}{(n-1)!} \sum_{k=0}^{n-1} {\binom{n-1}{k}} g^{(k)}(0)h^{(n-k-1)}(0)$$

$$= \left(\frac{1}{2\pi i}\right)^{n-1} \sum_{k=0}^{n-1} (-1)^{n-k-1} c^{n-k-1} \sigma_k(DX)$$

$$= \left(\frac{1}{2\pi i}\right)^{n-1} \sum_{k=0}^{n-1} (-1)^k c^k \sigma_{n-k-1}(DX).$$

Using the formula in [4] expressing integrals over cycles in V as Grothendieck residues in \mathbb{C}^n we obtain

$$\operatorname{ind}_{V,0}(X) = \operatorname{res}_{\mathbb{C}^n,0} \left[\frac{\frac{\partial f}{\partial z_n} \sum_{k=0}^{n-1} (-1)^k c^k \sigma_{n-k-1}(DX)}{X_1 \dots X_{n-1} f} \right].$$

If moreover (X_1, \ldots, X_n) is a regular \mathcal{O} -sequence we find that there is a $k \in \mathbb{N}$ with $f^k \in I_n$. This means that there is a $\beta \in \mathcal{O}$ with $f^k = \beta X_n \mod(I_{n-1})$ and therefore we have for any $h \in \mathcal{O}$

$$\operatorname{res}_{\mathbb{C}^{n},0} \begin{bmatrix} hc \\ X_{1} \dots X_{n} \end{bmatrix} = \operatorname{res}_{\mathbb{C}^{n},0} \begin{bmatrix} hc\beta \\ X_{1} \dots X_{n-1}f^{k} \end{bmatrix}$$
$$\operatorname{res}_{\mathbb{C}^{n},0} \begin{bmatrix} h\frac{\partial f}{\partial z_{n}} \\ X_{1} \dots X_{n-1}f \end{bmatrix} = \operatorname{res}_{\mathbb{C}^{n},0} \begin{bmatrix} h\frac{\partial f}{\partial z_{n}}f^{k} \\ X_{1} \dots X_{n-1}f^{k+1} \end{bmatrix}$$
$$= \operatorname{res}_{\mathbb{C}^{n},0} \begin{bmatrix} h\beta cf \\ X_{1} \dots X_{n-1}f^{k+1} \end{bmatrix}$$

which means that

$$\operatorname{res}_{\mathbb{C}^n,0} \begin{bmatrix} hc \\ X_1 \dots X_n \end{bmatrix} = \operatorname{res}_{\mathbb{C}^n,0} \begin{bmatrix} h \frac{\partial f}{\partial z_n} \\ X_1 \dots X_{n-1} f \end{bmatrix}$$

We have obtained

Proposition 1. (i) $\operatorname{ind}_{V,0}(X) = \operatorname{res}_{\mathbb{C}^n,0} \begin{bmatrix} \frac{\partial f}{\partial z_n} \sum_{k=0}^{n-1} (-1)^k c^k \sigma_{n-k-1}(DX) \\ X_1 \dots X_{n-1} f \end{bmatrix}$. (ii) If (X_1, \dots, X_n) is a regular sequence

$$\operatorname{ind}_{V,0}(X) = \operatorname{ind}_{\mathbb{C}^n,0}(X) - \operatorname{res}_{\mathbb{C}^n,0} \begin{bmatrix} \det(DX - c\mathbb{1}) \\ X_1 \dots X_n \end{bmatrix}$$

We remark that the residues are very easy to compute: If g_1, \ldots, g_n is a regular sequence and $h \in \mathcal{O}$ we can find integers k_1, \ldots, k_n with $(x_1^{k_1}, \ldots, x_n^{k_n}) \subset (g_1, \ldots, g_n)$ and therefore a matrix A with

$$\begin{pmatrix} x_1^{k_1} \\ \vdots \\ x_n^{k_n} \end{pmatrix} = A \begin{pmatrix} g_1 \\ \vdots \\ g_n \end{pmatrix}.$$

If d is the coefficient of $x_1^{k_1-1} \dots x_n^{k_n-1}$ in the power series expansion of $h \det A$ then $\operatorname{res}_{\mathbb{C}^n,0} \begin{bmatrix} h \\ g_1 \dots g_n \end{bmatrix} = d.$

Let us consider an example. $D_k: f = x^2y + y^{k-1}, k \ge 4.$

$$X := \frac{k-2}{2(k-1)} x^{m+1} \frac{\partial}{\partial x} + \frac{1}{k-1} x^m y \frac{\partial}{\partial y}, \ m \ge 2.$$

We have $c := x^m$ here. The index can be computed easily with Proposition 1 and we obtain $\operatorname{ind}_{V,0}(X) = (m-1)(k-1)$. We want to verify that Corollary 1 gives the same value. Using residues again we compute

$$\dim_{\mathbb{C}} \frac{\mathscr{O}}{(X_1, f)} = (k-1)(m+1).$$

Consider the monomial $x^m y$ in $\frac{\mathscr{O}}{(x^{m+1}, x^2 y + y^{k-1})}$. We find that the monomials $x^m y, \ldots, x^m y^{k-2}$ are linearly independent in this algebra and therefore

$$\dim_{\mathbb{C}} \frac{\mathscr{B}}{(f)} = \dim_{\mathbb{C}} \frac{\mathscr{O}}{(X_1, f)} - k + 2 = m(k - 1) + 1.$$

Now we claim

$$\{g \in \mathscr{O} : gf \in (X_1, X_2)\} = \mathscr{O}(x^m).$$

Let

$$gf = c_1 x^{m+1} + c_2 x^m y.$$

Then

$$g(x^2y + y^{k-1}) - c_2 x^m y \in \mathscr{O}(x^{m+1})$$

and therefore

$$g(x^2 + y^{k-2}) \in \mathscr{O}(x^m)$$

since y is not a zero divisor in $\frac{\mathscr{O}}{(x^{m+1})}$. This means $g \in \mathscr{O}(x^m)$ since $x^2 + y^{k-2}$ is not a zero divisor in $\frac{\mathscr{O}}{(x^m)}$. It follows that

$$\dim_{\mathbb{C}} \frac{\operatorname{ann}_{\mathscr{B}}(f)}{(c)} = 0.$$

We also find immediately $\dim_{\mathbb{C}} \mathscr{A} = k$ and $\dim_{\mathbb{C}} \frac{\mathscr{A}}{(c)} = k$. Since $\operatorname{ann}_{\mathscr{B}'}(X_2) = \mathscr{B}'(x)$ we find

$$\frac{\operatorname{ann}_{\mathscr{B}'}(X_2)}{\operatorname{ann}_{\mathscr{B}'}(X_2) \cap \mathscr{B}'(f, \partial f/\partial y)} = \frac{\mathscr{B}'(x)}{\mathscr{B}'(x) \cap \mathscr{B}'(f, \partial f/\partial y)} \cong \mathscr{A}'(x)$$

with $\mathscr{A}' = \frac{\mathscr{O}}{(f,\partial f/\partial y)}$. A basis of \mathscr{A}' is given by $1, x, xy, \ldots, xy^{k-2}, y, \ldots, y^{k-2}$ and therefore $\dim_{\mathbb{C}} \mathscr{A}'(x) = k$ since $y^{k-2} \sim x^2$ in \mathscr{A}' . Now Corollary 1 gives in fact

$$\operatorname{ind}_{V,0}(X) = (m-1)(k-1).$$
