Criteria for Balance in Abelian Gain Graphs, with Applications to Piecewise-Linear Geometry

Abstract

Consider a gain graph with abelian gain group having no odd torsion. If there is a basis of the graph's binary cycle space each of whose members can be lifted to a closed walk whose gain is the identity, then the gain graph is balanced, provided that the graph is nite or the group has no nontrivial in nitely 2-divisible elements. We apply this theorem to deduce a result on the projective geometry of piecewise-linear realizations of cell-decom positions of manifolds.

1 Introduction

A gain graph (;g;G) consists of a graph = (V;E), a group G, and a hom on orphism g from the free group F_E on the edges of to G. We call g the gain map and G

the gain group.¹ (O ne thinks of the edges of G as oriented in an arbitrary but xed way). Gain graphs have appeared in pure mathematics, physics, operations research, psychology, and discrete geometry, among many other areas (see Zaslavsky's annotated bibliography (1998) for a survey).

The simplest gain graphs are those in which every simple closed walk on lies in the kernel of g; such gain graphs are called balanced. If is connected, (;g;G) is balanced if and only if () Kerg. Since for general gain graphs one can treat each component separately, we shall assume throughout that G is connected. A basic problem is how to tell whether or not a gain graph is balanced. We investigate this problem when G is abelian; then we call (;g;G) an abelian gain graph. We propose here a criterion for balance in abelian gain graphs that is broader than previous ones, but which has the drawback that it is not valid for all groups. Our topics are, rst, the problem of describing the abelian gain groups for which it is valid and, second, an application of the criterion to a problem of polyhedral geom etry.

To state the criterion we must rst de ne a \circle" and a \cycle" in a graph. A circle is the edge set of a nontrivial simple closed walk (a walk in which no vertex or edge is repeated, except that the initial and nalvertices are the same). There are two kinds of cycles of concern to us.² they are integral cycles, i.e., elements of $Z_1() = K \text{ ere}$ where 0 is the standard 1-dimensional boundary operator of cellular hom ology of , and binary cycles, i.e., elements of $Z_1(; Z_2)$. There are natural epim orphism s

that consist, respectively, of abelianization and reduction of coe cients modulo 2. Suppose that b is a binary cycle: a cyclic orientation of b is any closed walk \mathfrak{B} for which $\mathfrak{B}^a] = b$. If B is a set of binary cycles, a cyclic orientation of B is any set $\mathfrak{B} = \mathfrak{f}\mathfrak{B}: b 2$ Bg of cyclic orientations of the members of B. This de nition is very broad: a binary cycle has many cyclic orientations; also, edges may appear in \mathfrak{B} that are not in the support of b, provided that each such edge appears an even number of times in \mathfrak{B} . Thus, a binary cycle with disconnected support can have a cyclic orientation, which is always connected. In general, there is no cyclic orientation of a cycle that can reasonably be regarded as canonical, except in the case of a binary cycle whose support is a circle.

Now, our test for balance:

Denition. Let (;g;G) be a gain graph and B be a basis of Z₁(;Z₂). We say that B passes the B inary Cycle Test if it has a cyclic orientation \mathbb{P} such that all elements of \mathbb{P} have gain 1. We say the B inary Cycle Test is valid for (;g;G) if the existence of a basis B that passes the B inary Cycle Test im plies that (;g;G) is balanced. We say the B inary Cycle Test is valid for a fam ily of graphs G and a fam ily of groups H if it is valid for every gain graph (;g;G) with 2 G and G 2 H.

Our main results are that the Binary Cycle Test is valid for any abelian gain group that has no odd torsion if the graph is nite (Theorem 3.3) or if the gain group has no nontrivial in nitely 2-divisible elements (Theorem 3.5). We also show an in nite graph

that fails the B inary C ycle Test for all gain groups that have an in nitely 2-divisible element other than the identity. (In Rybnikov & Zaslavsky (20xx) we prove that for any gain group with non-trivial elements of odd order there is a graph for which the B inary C ycle Test does not work. Focussing on properties of the gain graph that are due to the gain group rather than the graph is how the present paper di ers from that one.)

In m ost applications to physics, psychology, or operations research, the gain graphs are nite and have Z_2 or R as the gain group. Groups R or R^d tend to appear in discrete-geometry applications such as Voronoi's generatrix construction and the M axwell{C rem ona correspondence. The B inary C ycle Test applies to such situations, since all these groups are abelian and do not have odd torsion. However, if the gain graph is in nite, our results do not apply when G = R or R^d , since these groups are 2-divisible. We know that for certain particular binary cycle bases their passing the B inary C ycle Test does in ply balance even then, but they have to be carefully selected, as E xam ple 4.1 show s.

The reason we need the B inary Cycle Test rather than a simpler test for balance of (;g;G), such as the existence of a set of balanced circles that form a fundam ental system of circles (i.e., the set of circles obtained from a xed spanning tree by adjoining each nontree edge), is that, in applications, offen a basis of the binary cycle space is given to us or is in some way naturally associated with the problem, so we are not free to choose the basis, or the geom etry may yield inform ation about the gains only of certain cycles that are not a fundam ental system or otherwise tractable.

In Euclidean space, the sphere, or hyperbolic space, gain graphs are a natural setting for problem s of existence and classi cation of tilings with prescribed restrictions on the group or the tiles, and of d + 1-dim ensional piecew ise-linear realization of d-m anifolds with given projection. Among important examples are Coxeter's theorem reducing the classi cation of re ection groups to that of C oxeter sim plices (1934), A lexandrov's space-lling theorem (1954), Voronoi's (1908) construction of a generatrix (generative in the French original), the Maxwell{C rem ona correspondence (see C rapo & W hiteley, 1993; Rybnikov, 1999), colorings of graphs and polyhedra (Ryshkov & Rybnikov, 1997), etc. In Section 6 we demonstrate the appropriateness of gain graphs by applying the B inary C ycle Test to generalize a theorem of Voronoi (1908), that any sim ple tiling of R^d is the projection of a (convex) PL-surface which, given the tiling, is uniquely determ ined by d + 2 free real parameters. (A spline theorist would say that the dimension of the space of C_1^0 -splines over the tiling is d + 2.) Such a surface is called a (convex) lifting of the tiling to R^{d+1}. It is known that the notion of lifting and the space of liftings can be de ned for any PL-realization of a hom ology d-m anifold in R^d. Our generalization consists in showing that the dimension of the space of liftings of any non-degenerate PLrealization in \mathbb{R}^d of a homology d-manifold M with $H_1(M; \mathbb{Z}_2) = 0$ is d + 2, provided that each $(d \quad 3)$ -cell of M is incident to exactly four d-cells. This application was chosen because in the course of the proofs gain graphs appear in a number of di erent geom etric guises and we employ the Binary Cycle Test several times.

A nother application of the B inary C ycle Test is to Voronoi's conjecture on parallelohedra, which states that any parallelohedron is an a ne copy of the D irichlet dom ain of a lattice. D eza and G rishukhin (2003) recently gave a number of combinatorial reform ulations of Voronoi's conjecture that are essentially gain-graphical. The proof of the Voronoi conjecture can be reduced to a number of questions about a certain type of nite gain graph with gain group R , called the Venkov graph. (See O rdine (2002), Rybnikov (2002a,b), and D eza & G rishukhin (2003) for de nitions and examples.) W e have noticed that the B inary C ycle Test sim pli es attacking these questions, because in the case of Venkov graphs it is much easier to look for a basis of the binary cycle space rather than of the integral cycle space. Very recently O rdine (2004) m ade a m a jor advance in Voronoi's conjecture by proving an important special case, where the dual gures for the stars of (d 3)-cells of the tiling are restricted to tetrahedra, octahedra, and pyram ids. The B inary C ycle Test can be applied to greatly sim plify his proof; we hope to explain this elsewhere.

2 Preliminaries

Our graphsm ay be in nite. Loops (edges with two equalendpoints) and multiple edges are allowed. We assume that is connected and that it has a xed (but arbitrary) orientation.

A circle C can be written as the edge set of a simple closed walk in a way that is unique up to choice of initial vertex and direction. Then it depends only on C, not on the choice of walk, whether the walk is in K erg. If it is, we say C is balanced.

If we is a closed walk on , denote by w the corresponding element we^a of Z_1 (). If w 2 Z_1 (), denote by [w] the corresponding element of Z_1 (; Z_2).

We denote by () the fundam ental group of . The essential gain group of a gain graph is g(()). It is well de ned up to conjugation in G. Evidently, (;g;G) is balanced if and only if the essential gain group is trivial.

N aturally, g induces a hom om orphism from () to G and from ZE, the free abelian group on E, to $G = G^0$, where, as usual, G^0 denotes the commutator subgroup. Hence, g induces a hom om orphism from Z_1 (), the abelianization of (), to $G = G^0$.

A cyclic orientation, or lifting to the fundam entalgroup, of an element b of Z_1 (; Z_2) is any element \mathfrak{B} of () whose abelianization modulo 2 is b. A circle has natural cyclic orientations obtained by taking an element of () corresponding to a simple walk around the circle in either direction from any starting point. A lifting of b to the cycle space is the image b in Z_1 () of a cyclic orientation of b. If B is a basis of Z_1 (; Z_2); then denote by \mathfrak{B} a cyclic orientation of B. As one can see from our notation, if b denotes an element of the binary cycle space, then b denotes one of the possible liftings of b to the cycle space, and \mathfrak{B} is one of the liftings of b to the fundam ental group. If w 2 Z_1 (), denote by [w] the corresponding element of Z_1 (; Z_2).

If H (), then H^a denotes $H = (()^0 \setminus H)$, the abelianization of H with respect to (); that is, H^a is the image of H in $Z_1()$. If L; M A, we denote by L=M the image of L in A=M; in particular, L=2A is L reduced modulo 2.

3 The Test for A belian G roups

Lem m a 3.1 Let A be a free abelian group, and let h be a hom om orphism from A to G, an abelian group without odd torsion. Let L be a subgroup of A such that h(L) = 0 and L=2A = A=2A. Suppose K is a subgroup of A such that $K = (L \setminus K)$ does not have elem ents of in nite order. Then h(K) = 0.

Proof. Suppose there is $y \ge K$ such that $h(y) \notin 0$. Since h(L) = 0, $y \ge L$. There is a minimall> 1 such that $ly \ge L$. Let $l = 2^e a$, where a is odd. Denote ay by x. Notice e > 0, since otherwise h(x) would have odd order in G.

Now, h (ay) \notin 0, since otherwise h (y) would have odd order in G. Then 2^e is the order of x in K = (L \ K) and e = minfk $j 2^k x 2$ Lg. Let fb_ig be a basis of L, so that $2^e x = p$ l_ib_i. Since L=2A = A=2A, f[b_i]g_i generates A=2A. Thus [x] = i[b_i], ic., x = ib_i + 2z for some z 2 A. We have $2^e x = i2^e b_i + 2^{e+1}z$. Thus $(l_i i2^e)b_i 2$ 2A and all l_i are divisible by 2, ie., $l_i = 2m_i$, $m_i 2$ Z. Since e > 0 we have $2^e i x = m_i b_i 2$ L. This contradicts the choice of e as minfk $j2^k x 2$ Lg. Therefore h (K) = 0:

Lem m a 3.2 Let (;g;G) be a gain graph, where G is an abelian group without odd torsion, and let K be a subgroup of Z_1 (). If a basis B of Z_1 (; Z_2) has some cyclic orientation B that lies in the kernel of g, and if $K = (hB)i^a \setminus K$) does not have elements of in nite order, then any lifting of K to () lies in Kerg.

Proof. Denote $h\mathfrak{B}^{\mathfrak{s}}$ ia by L. The hom on orphism g induces, in a natural way, a hom omorphism h from $Z_1()$ to G. Obviously, h(L) = 0 and $L=2Z_1() = Z_1()=2Z_1() = Z_1()=Z$

Theorem 3.3 Suppose is a nite graph and G is an abelian group without odd torsion. If all elements of a basis B of Z_1 (; Z_2) have cyclic orientations that lie in Kerg, then (;g;G) is balanced.

Proof. Since is nite, rankh \mathbb{B}^{i^a} = rank \mathbb{Z}_1 (), so all elements of \mathbb{Z}_1 ()=h \mathbb{B}^{i^a} have nite order. Now apply Lemma 32 with K = \mathbb{Z}_1 ().

Lem m a 3.4 Let G be an abelian group without odd torsion. If some basis B of Z_1 (; Z_2) has a cyclic orientation B that lies in Kerg, then g(()) is 2-divisible.

Proof. The elements of $Z_1()$ that have nite order in $Z_1()$ =hB²i^a form a subgroup in $Z_1()$, which we denote by F. Since F=hB²i^a does not have elements of in nite order, Lemma 3.2 with K = F implies that g(F) = 0. Thus if y = xinF, g(y = x) = 0: Therefore, g induces an epim orphism h from $Z_1()$ =F onto g(()).

Let $y \ge Z_1()$: Since $h \mathbb{F}^{i^a} = F$ and $[h \mathbb{F}^{i^a}] = Z_1(; Z_2)$, there is $x \ge F$ such that y = 2z for some $z \ge Z_1()$. Thus $y \ge 2z + F$; and y + F = 2z + F = 2(z + F) as posets. Therefore all elements of $Z_1() = F$ are 2-divisible.

Let a 2 g(()). Since the hom on orphism h from $Z_1()=F$ is onto g(()), there is y 2 $Z_1()=F$ such that h(y) = a. Since y is 2-divisible, a is also 2-divisible: a = h(y) = h(2z) = 2h(z):

Theorem 3.5 Let G be an abelian group, without odd torsion, which has no in nitely 2-divisible elements other than 0. If some basis B of Z_1 (; Z_2) has a cyclic orientation \mathbb{B} that lies in Kerg, then (;g;G) is balanced.

Proof. If $Z_1()=h\mathbb{P}i^a$ does not have elements of in nite order, then, an application of Lemma 3.2 with $K = Z_1()$ implies that (;g;G) is balanced. If $Z_1()=h\mathbb{P}i^a$ has elements of in nite order, then by Lemma 3.4 g(()) is 2-divisible, which is only possible if g(()) = 0. Thus (;g;G) is balanced.

C orollary 3.6 Suppose is a nite graph and G is a free group. If all elements of a basis B of Z_1 (; Z_2) have cyclic orientations that lie in K erg, then (; g; G) is balanced.

Proof. g induces a hom om orphism \overline{g} from () into $G = G^0: G = G^0$ is a free abelian group and, therefore, does not have torsion or in nitely 2-divisible elements. By Theorem 3.5, Im $\overline{g} = 0$: But this can only happen if Im g = 1, because K erg is a free group whose abelianization is K erg.

C orollary 3.7 Let g be a group such that $G = G^0$ has no torsion or has only 2-torsion. Let (;g;G) be a gain graph whose gain group is G. If there is a basis B of the binary cycle space Z_1 (; Z_2) such that for each b2 B there is a cyclic orientation \mathfrak{B} for which g \mathfrak{E}) 2 G⁰, then every circle has gain in G⁰.

4 Counterexam ples

In discrete geom etry the case of an in nite gain graph with an abelian 2-divisible group of gains, such as Rⁿ or R is one of the most typical ones (see Ryshkov & Rybnikov (1997), Rybnikov (1999)). In such applications the cycle basis for which we can verify the balance property normally consists of circles. M ight the Circle Test, i.e., the B inary Cycle Test where all elem ents of the binary basis are known to be circles, work for in nite graphs with 2-divisible groups of gains? Unfortunately, not. We construct an in nite gain graph with a 2-divisible, torsion-free group of gains, unbalanced yet having a binary circle basis all of whose elem ents are balanced.




Figure 1: Counterexample to the Circle Test with in nitely 2-divisible elements.

Example 4.1 The graph is shown in Figure 1. We use the following notation for elements of $Z_1()$:

Then $fe_k; g_k; h_k g_{k-1}$ is an integral circle basis of . A susual, we denote an element of $Z_1(;Z_2)$ corresponding to x 2 $Z_1()$ by [x]. Let

and let B = f[b] jb 2 Bg. B is obviously a basis of Z_1 (; Z_2). Let H denote the subgroup of Z_1 () (hence of ZE) generated by B, and let :ZE ! ZE =H be the quotient m ap. Now, let us set the gain group to be ZE =H and the gain m ap g to be a, where a is the abelianization m apping from F_E to ZE. Then the essential gain group g(()) = $(Z_1()) = Z_1() =H$. By construction, B is a basis of the binary cycle space that consists of balanced circles. If $H \in Z_1()$, then the constructed gain graph is not balanced, because $Z_1()=H = h(e_k)$; (g_k) ; (h_k) jk li = g(()). But in fact, H $\in Z_1()$, because there is no nite linear combination of elements of H that is equal to e_1 .

Denote by $Z \left[\frac{1}{2}\right]$ the ring of dyadic rationals, i.e., the ring of rational numbers whose denom inators are powers of 2. Its additive group $Z \left[\frac{1}{2}\right]^{\dagger}$ is the unique sm allest group that contains an in nitely 2-divisible element of in nite order. One can show that $Z_1()=H = Z \left[\frac{1}{2}\right]^{\dagger}$ by mapping $e_i + H$ 7 d_i where $fd_ig_{i=1}^1$ generates $Z \left[\frac{1}{2}\right]^{\dagger}$ and satisfies $d_i = 2d_{i+1}$. Thus, the essential gain group g(()) is 2-divisible.

Notice that a circle $e_i + g_i + h_i$ has 5 edges.

C on jecture 4.1 Let G be a torsion-free abelian group, possibly 2-divisible, and suppose $Z_1()$ has a basis that consists of balanced circles with at most k edges. Then (;g;G) is balanced if k = 3, but it need not be balanced if k = 4.

There are also nite counterexam ples, but the gain group necessarily has an elem ent of odd order. Two such exam ples, based respectively on the wheeland on an even circle with all edges doubled, are in Rybnikov & Zaslavsky (20xx), Theorem 6.16.

5 A lgebra of gain graphs and their states

In applications of the kind in Section 6 gain graphs are norm ally used in the following setup. Let (;g;G) be a gain graph. Let Q be a set, which we call the set of qualities, and suppose G acts on Q; for q 2 Q and h 2 G we denote the result of the action by [q]h. For instance, it may be that Q = G and the action is by right multiplication (the right regular action). The combination (;g;G;Q) is a permutation gain graph. (The idea was introduced by G ross & Tucker (1977) under the name \permutation voltage graph".) A state of the graph is an assignment s of qualities to the vertices of . We want to nd a state such that for any two adjacent vertices v and w their qualities s(v) and s(w) are connected by s(w) = [s(v)]g(vw). Such a state is called satis ed with respect to g, or g-satis ed. The set of all g-satis ed states is denoted by Sat_g (;G;Q). The set of all states that are satis ed with respect to at least one element of G is denoted by Sat(;G;Q). If H is a subgroup of G^E, then Sat_H (;G;Q) is the set of all states always exists

if g is balanced, because in this case one can arbitrarily choose the state of one vertex in each connected component, then assign the states of other vertices according to the rule of satisfaction. The exact rule is that, if $s(v_0)$ is the arbitrary state and v is a vertex connected to v_0 by a walk W, then $s(v) = [s(v_0)]g(W)$.

The set G^E of all gain maps with values in G forms a group under componentwise multiplication, $gg^0(e) = g(e)g^0(e)$. If G is abelian the set Bal(;G) of all balanced gain maps is a subgroup of G^E . If, in addition, is connected, then $jBal(;G)j=jGj^{jvj1}$, and Bal(;G) = G^{jvj1} if G is abelian, because one can assign gains arbitrarily to the edges of a spanning tree and then other edge gains are uniquely determ ined by balance. In general, Bal(;G) $\in G^{jvj1}$ if G is nonabelian. From now on we assume that is connected.

If Q is a group, the set Q^{V} of states form s a group under componentwise multiplication, $ss^{0}(v) = s(v)s^{0}(v)$. From now on we assume that Q is a group. We do not assume, in general, that the action of G on Q is a group action.

If G does act on Q in the manner of a group action (i.e., through a hom om orphism G ! AutQ), then the set of all g-satis ed states, Sat_g (;G;Q), form s a subgroup of Q^V . If in addition is connected and g is balanced, then

$$\operatorname{Sat}_{q}(;G;Q) = Q$$

because the choice of s(v) at one vertex v determ ines s.

Another way G m ay act on Q is by a product action, that is, where

A ne action of R n on itself (by translations) is an example of a product action in geometry. A product action is very restricted.

Lem m a 5.1 An action of G on Q is a product action if and only if it has the form [q]f = (q)c(f), where : Q ! Q is an endomorphism of Q and c : G ! Q is a hom on orphism of G into the center of Q.

Proof. Any action of this form is clearly a product action. For the converse, compare the two sides of (5.1). First, with $q = q^0 = 1$; this establishes the existence of a hom on orphism c given by c(f) = [1]f. Next, with $q^0 = 1$, and f = 1; this establishes that $[q]f^0 = ([q]1) \quad c(f)$. Taking q = 1 and $f^0 = 1$ establishes that $[q]f = c(f)q^0$; combining this with the previous conclusion we get $[q]1 \quad c(f) = [q]f = c(f)$ [q]1 for all $q \ge Q$. So, c(f) is in the center of Q. Taking $f = f^0 = 1$ shows that :q = 7 [q]1 is a hom on orphism Q ! Q.

We call (g;s) 2 G^E Q^V a satis ed pair if s is a satis ed state with respect to the gain map g. W ith a product action of G on Q, the set of satis ed pairs form s a group SatPair(;G;Q) with respect to componentwise multiplication, (g;s) (g⁰;s⁰) = (gg⁰;ss⁰). If H G^E , then SatPair_H (;G;Q) stands for the set of all satis ed pairs (s;g) where g 2 H. If G is abelian and H happens to be a subgroup of Bal(;G), SatPair_H (;G;Q) form s a subgroup of SatPair(;G;Q).

We call an action of G on Q xed-point free if every element of G, other than the identity, acts without xed points. If is connected and the action of G is xed-point free, then Sat(;G;Q) = Bal(;G) Q, because, as shown in the following lemma, a gain mapping $g 2 G^E$ and the value g 2 Q at one vertex together determ ine a satis ed state if and only if g 2 Bal(;G). F from the de nitions we have:

Lem m a 5.2 Suppose the action of G on Q is xed-point free. Then a permutation gain graph (;g;G;Q) has a satist ed state if and only if (;g;G) is balanced, and then the state is determined by its value at any one vertex.

On the other hand, if the action if not xed-point free and is not a tree, then one can always de ne an unbalanced gain map that has a satistic ed state. The lemma implies, in particular, that if H is a subgroup of Bal(;G), then there is a natural bijection between Sat_{H} (;G;Q) and H Q.

Suppose G acts on Q in the manner of a group action. If Q is a module over a ring R and the group action is linear over R, then for any gain map g, Sat_g (;G;Q) is also an R-module. Furthermore, by Lemma 5.2

If G is also an R-m odule, then the group of gain mappings, G^E , is an R-m odule. If, m oreover, H is a submodule of Bal(;G), then the action of G on Q is indeed a product action, SatPair_H (;G;Q) is a subgroup of SatPair(;G;Q), and

In particular, SatPair(;G;Q) = Q $G^{\frac{y}{j}}$.

If the action of module G on module Q is also xed-point free, then by Lem m a 52,

A special case of permutation gain graphs has been studied by Joswig (2002) and Izm estiev & Joswig (2003) in connection with coloring of tilings of manifolds and problem s in the geometric topology of covering spaces. Let be the dual graph of a nite, pure, d-dimensional, strongly connected simplicial complex on n vertices, and let G, the gain group, be S_n , the symmetric group on the vertices of . The gain mapping g takes an edge connecting adjacent d-simplices whose symmetric dimense is a pair fi; jg to the transposition that exchanges i and j (Joswig calls this a `perspectivity"). Joswig calls the image g(()) of the group of closed edge-walks beginning and ending at a vertex v 2 the group of `projectivities" and writes it (;v). The main object of Izm estiev and Joswig's studies is the size and structure of this group for various combinatorial manifolds.

6 Gain graphs in geometry

G iven a tiling of \mathbb{R}^d by convex polyhedra, it is natural to ask whether this tiling can be thought of as the vertical projection of a convex PL-surface or, m ore generally, any PL-surface. A PL-function on \mathbb{R}^d is known as a \mathbb{C}_1^0 -spline in approximation theory. The problem of nding the dimension of the space of such splines on a given tiling has received signi cant attention from discrete geometers and spline enthusiasts (see, e.g., W hiteley (1996) or Billera (1989) for details). Voronoi (1908) showed that any simple tiling T, i.e., such that each vertex is incident to exactly d + 1 tiles, is indeed the projection of a convex surface, which he called a generatrix of T; furtherm ore, a surface that gives this tiling as a projection is uniquely determ ined by the choice of an a ne support function and a dihedral angle.

A tiling is an example of a more general concept, namely a PL-realization M in R^d of a d-dimensional manifold M. In this section, as an application of the B inary Cycle Test, we ask about possible PL-realizations of M in R^{d+1} that give M as a vertical projection.

If M is a PL-realization in \mathbb{R}^d of a cell-complex M (cell-complex de ned, e.g., in the sense of Seifert & Threlfall (1980); the PL-realization is what is called a geometric cell-complex), and L is another PL-realization of M, but in \mathbb{R}^{d+1} , such that for each cell C of M its realization in M is the vertical projection of its realization in L, then L is called a lifting of M. The notion of lifting naturally generalizes that of \mathbb{C}_1^0 -spline. The graph of a \mathbb{C}_1^0 -spline is a lifting of the tiling over which it is de ned, while a lifting of a PL-realization M in \mathbb{R}^d of a d-m anifold M is the graph of a \mathbb{C}_1^0 -spline if and only if M is an embedding. O briously, liftings can be added, just like \mathbb{C}_1^0 -splines. The space of liftings of M is denoted by Lift (M). A trivial kind of lifting is to a hyperplane in \mathbb{R}^{d+1} . The opposite kind is a sharp lifting: we call a PL-realization in \mathbb{R}^{d+1} of a d-com plex sharp if any two adjacent d-cells are realized on di erent a ne hyperplanes.

Of course, questions about projections of piecewise-linear surfaces belong to the realm of projective geometry. To make our presentation more visual and accessible we do all our geometry in the real a ne space R^d, although at the end of the section we give our result a proper projective interpretation.

A lthough som e of the constructions that we treat below were considered in R ybnikov (1999), the B inary C ycle Test is form ulated incorrectly there (in Lem m a 4.1). Roughly speaking, that form ulation does not have any restriction on gain groups, due to the fact that the author had in m ind only abelian groups. How ever, since the test was applied there for abelian, torsion-free groups only, all the geom etric results of R ybnikov (1999) about P L-realizations of (and splines over) a manifold M with H₁ (M; Z₂) = 0 hold true if one assumes that the manifold has nitely many cells; this last requirement was also om itted in R ybnikov (1999). (When M is simply connected the niteness restriction is not necessary, since in this case there is an alternative argument, which uses the fundamental group | see R yshkov & R ybnikov (1997) for proofs and examples.)

6.1 Technical Preparation

We use standard notions of PL-topology. (See, e.g., Munkres (1984) or Seifert & Threlfall (1980).) A regular CW -com plex K is a locally nite CW -com plex in which all gluing mappings are hom eom orphism s. A regular CW -com plex has a barycentric subdivision K[[], which is a sim plicial com plex. K also has a natural dual structure, called the dual cell-decom position; we will denote the dual CW -com plex by K . Note that K, K and K[[] have the same support and are hom eom orphic. The face lattices of K and K are dual. A cell is always assumed to be relatively open and the closure of a cellneed not be hom eom orphic to a ball. A k-cellC of K is the union of all sim plices of K [[] whose closures share the barycenter of a (d k)-cell C of K. The boundary of C is called the link of C. The dimension of K is the maximum dimension of any cell of K. Facets of K are cells of dimension dim K 1, and ridges of K are cells of dimension dim K 2. Two k-cells are adjacent if their closures share a (k 1)-cell. A pure d-dimensional CW -com plex is strongly connected if any two d-cells can be joined by a sequence of adjacent d-cells.

A hom obgy sphere is de ned inductively: a hom obgy 0-sphere is a standard 0-sphere, and a higher-dimensional hom obgy sphere is a strongly connected regular CW -com plex such that: (1) all its hom obgy groups are like those of a standard sphere and (2) the boundaries of all cells of the dual cell-decom position are hom obgy spheres. A hom obgy ball is a cone over a hom obgy sphere. A nite hom obgy d-m anifold (with boundary) is a strongly connected regular CW -com plex with nitely many cells, in which the link of each k-cell, for 0 k < d, is a hom obgy sphere (or ball, if the cell belongs to the boundary) of dimension d k 1. Seifert & Threlfall (1980) allow the cells of a hom obgy manifold to be hom obgy balls; then the regular CW -com plexes in our de nitions should be replaced by regular hom obgy CW -com plexes. All of our results hold for this more general interpretation.

If K is a regular CW -com plex and r is a continuous map from the barycentric subdivision K[[] to R^N such that (1) each abstract sim plex is mapped to an a ne sim plex, and (2) the sim plices of K[[] making up a k-cell of K are mapped to the same a ne k- at of R^N, then K = (K;r) is called a PL-realization of K. The realization is called non-degenerate if r, restricted to the closure of each cell of K, is a hom eom orphism.

6.2 Local Considerations

An oriented facet is an ordered pair of adjacent d-cells. The minimum possible number of d-cells that make contact at a k-cell of a convex tiling of \mathbb{R}^d , or of a (d+1)-polytope, is d k + 1. We call the star of a k-cell in a manifold simple (a.k.a. primitive in the theory of parallelohedra) if the cell is incident to only d k + 1 d-cells. A d-manifold is called k-simple if the star of each k-cell is simple. A manifold with boundary is k-simple if the stars of all its interior k-cells are simple. Notice that k-simplicity implies m-simplicity for m > k.

The dual graph (M) of a hom ology d-m anifold M (possibly with boundary) is the graph of adjacency of d-cells. It is the 1-skeleton of the dual cell-decom position M. The vertices are the d-cells of M and the edges are the pairs of d-cells that share a common facet. The edges of (M) can be thought of as the internal facets of M. In the dual graph of a k-simple manifold, the subgraphs corresponding to the stars of k-cells are complete subgraphs on d k + 1 vertices. Subgraphs of (M) that correspond to the stars of ridges are circles; we call them ridge circles and, in the case when the stars of ridges are simple, ridge triangles.

A reciprocal for a PL-realization M in R^d of a hom ology manifold M is a rectilinear realization R in R^d of the dualgraph (M) such that the edges of R are perpendicular to the corresponding facets. If none of the edges of R collapse into a point, the reciprocal is called non-degenerate; a one-point reciprocal is called trivial. A reciprocal for the star of a cell C is called a local reciprocal of C. R eciprocals were originally considered by M axwell (1864) and C rem ona (1890) in connection with stresses in plane fram eworks. C rapo & W hiteley (1993) gave a m odern treatment of the M axwell{C rem on a theory of reciprocals, stresses, and liftings for 2-m anifolds. O bviously, reciprocals can be added and multiplied by real scalars. G eom etrically, multiplication corresponds to scaling. The addition is induced by vector addition of the vertices. Thus, for a given M the reciprocals form a linear space. This space, factored by all translations of R^d, is denoted Rec(M).

A PL-realization of a homology d-m anifold is called generic if no pair of adjacent facets lies in the same $(d \quad 1)$ -plane.

Lem m a 6.1 For each non-degenerate generic PL-realization in R^d of a simple star of a cell there is a non-degenerate reciprocal. It is unique up to translations, how other and central inversions.

Proof. The existence of a non-degenerate reciprocal for a simple star is a trivial exercise in linear algebra. Such a reciprocal is the 1-skeleton of a simplex whose edges are perpendicular to the corresponding facets. Since directions of edges and the angles between them are uniquely determined by the geometry of the star, the reciprocal is unique up to a ne transform ations preserving directions and angles.

Lem m a 6.2 If Star is a non-degenerate generic PL-realization of a simple star of a cell, then dim Lift(Star) = d + 2.

Proof. Any three d-cells of Star form a triangle in the dual graph. Choose two d-cells in Star. By xing two a ne functions that lift the union of these d-cells to R $^{d+1}$, so that these functions coincide on the common facet of the cells, we x the lifting for all of Star. Since a lifting of two adjacent d-cells is de ned by d + 2 parameters (e.g., the coe cients of an a ne function in d variables and a dihedralangle in (d+1)-space), dim Lift(Star) = d + 2.

6.3 From Localto G lobal

In the remainder of the section we show that, subject to the topological restriction that $H_1(M; Z_2) = 0$ and the combinatorial restriction of (d 3)-simplicity, liftings of (d 2)-simple manifolds behave in the same way as those of simple stars. (A lthough a tiling of \mathbb{R}^d may not be a CW -complex, all our theorem s hold for the case when M is a nite tiling.)

The following lemma is a hom obgical version of what some call Poincare's (d 2)face principle (1882) in discrete geometry, which, basically, says that for a group of isometries to tile a Euclidean space, sphere, or hyperbolic space with copies of a dpolyhedron T it is enough that for each (d 2)-face F of T there are group elements g_1 ;:::; g_k such that $T;g_1(T)$;:::; $g_k(T)$ If the space, face-to-face, around F without gaps or overlaps. See D objiin (2000) for an exact form ulation and recent generalization of this principle.

Lem m a 6.3 Let M be a nite homology d-manifold with d 2 and with H $_1$ (M;Z₂) = 0. Let ((M);g;G) be an abelian gain graph whose underlying graph is (M) and whose gain group has no odd torsion. Then the gain graph is balanced if and only if the ridge circles of (M) are balanced.

Proof. The \only if" part follows from the de nition of balanced graph.

Consider the dual cell-decomposition M of M. The 2-cells of this decomposition are in one-to-one correspondence with the ridges of M. Since $H_1(M; Z_2) = 0$ and the underlying spaces of M and M are the same, the boundaries of the 2-cells of M generate $Z_1(M; Z_2)$. These boundaries are circles and they are balanced by our assumption. According to the Binary Cycle Test for nite graphs, ((M); g; G) must be balanced.

For instance, Lemma 6.3 applies to hom ology spheres of dimension at least 2.

Theorem 6.4 Let M be a nite (d 3)-simple homology d-manifold without boundary, with d 3, and with $H_1(M; Z_2) = 0$. Let M be a non-degenerate generic PL-realization of M in \mathbb{R}^d . Then M has a non-degenerate reciprocal and dim $\operatorname{Rec}(M) = 1$.

P roof. The main ingredients of the proof are the dual cell-decom position M $\,$ of M, the notion of gain graph, and the B inary C ycle Test for balance.

Let = (V; E) be the dual graph of M . An oriented facet can be thought of as an oriented edge of .

From the algebraic standpoint a reciprocal for M is a linear operator r from the vector space $(\mathbb{R}^d)^V$ of 0-cochains on (V; E) with values in \mathbb{R}^d , which has the property that $r(C_i; C_j)$ is orthogonal to the common facet F_{ij} of C_i and C_j , where $:C^0(; \mathbb{R}^d) ! C^1(; \mathbb{R}^d)$ is the coboundary map, dened by $r(C_i; C_j) = r(C_j) r(C_i)$ for each oriented facet $(C_i; C_j)$. (Thus, the edges $f(r(C_i); r(C_j))g$ of a non-degenerate reciprocal have a natural interpretation as the linear parts of the equations densing the facets of M. These linear parts are often called the covectors of the facets of M.) It follows from the densition that

whenever C_1 , C_2 , C_3 share a common ridge. Equation 6.1 means that r is a gain m ap on with gain group R^d. The gain graph is balanced because r is a coboundary. Because is connected, r is completely determined by r and one point r(C); indeed, r is any satis ed state of (; r; R^d; R^d), where R^d acts on R^d by translation (that is, the right regular action). Thus,

We associate with each oriented facet $(C_1;C_2)$ a unit vector $n(C_1;C_2)$, norm alto the common facet of C_1 and C_2 , so that $n(C_1;C_2) = n(C_2;C_1)$. Henceforth, these norm als are xed.

Consider the facet graph , whose vertices are the (unoriented) facets of M and whose edges are the pairs of facets sharing ridges. O rient the edges of in an arbitrary way. Take a ridge R where d-cells C_1, C_2, C_3 m ake contact. D enote by F_{ij} the common facet of C_i and C_j . Up to scaling there is only one nontrivial linear combination of n ($C_1; C_2$), n ($C_2; C_3$), n ($C_3; C_1$) equal to zero. Let

be one such combination with nonzero coe cients; it exists because M is a nondegenerate PL-realization. For the oriented edge $F_{12}F_{23}$ in the facet graph, de ne

In this way we de ne the map g on all oriented edges of the facet graph. We call (;g;R) the facet gain graph.

Lem m a 6.5 (;g;R) is a balanced gain graph.

P roof. O byiously, g ($F_{12}F_{23}$) depends only on the geometric realization M of M and on the (xed) choice of norm als n (A; B) for oriented facets. It is clear that g ($F_{12}F_{23}$) = g ($F_{23}F_{12}$)¹ and

The dual cell-decomposition M of M can be rened in a useful way. Each 2-cell of M is a triangle. Let M^{y} be the cell-complex obtained from M by subdividing each edge in the middle and then joining the new vertices by three new edges within each 2-cell, thereby partitioning the 2-cell into four triangles.

Since M and M $^{\rm Y}$ are identical to M as topological spaces,

M oreover, is a subgraph of $Sk_1 (M^{y})$. Consequently, for any $c_2 Z_1 (; Z_2)$ there is a 2-chain $2 C_2 (M_P^{y}; Z_2)$ such that c = 0. The chain can be decomposed as $_1+_2$, the sum of $_1 = _{_{1j}}$, where each $_{_{1j}}$ is a triangle whose vertices are new vertices corresponding to facets of M making contact at a ridge, and $_2 = _{_{2i}}$, where each $_{_{2i}}$ has one vertex in $Sk_0 (M)$, corresponding to a cell of M, and two vertices that are

new vertices corresponding to facets of that cell. For each d-cell C of M, let $_{2C}$ be the sum of all the $_{\hat{P}^{i}}$ having as one vertex that vertex of M that corresponds to C. Then $c = [0]_{1j} + [0]_{2C}$ where each term in the rst sum is a ridge triangle of and each term in the second sum is a cycle on the boundary of a d-cell of M.

This show s that ridge triangles and cycles lying on the boundaries of d-cells generate $Z_1(;Z_2)$. We prove next that (;g;R) is balanced. Since M is (d 3)-simple, the boundary of each d-cell C is ((d 1) 2)-simple. _C, the subgraph of on the vertices that belong to C, is the dual graph (@C) of the boundary cell-complex of C. The corresponding gain subgraph is $(_C;g;R)$. By Equation (6.4) the ridge circles of $_C$ are balanced. Since dim @C 2, Lemma 6.3 applied to @C implies that ($_C;g;R$) is balanced and, therefore, all cyclic orientations of binary cycles of $_C$ have gain 1. We have seen that binary cycles of these two types generate $Z_1(;Z_2)$. By the B inary Cycle Test for nite graphs, (;g;R) is balanced.

Suppose the set of qualities Q is R and R acts on R by multiplication. Fix a non-zero satis ed state s of (;g;R;R). We denote by $s(C_i;C_j)$ the value of s on a vertex of corresponding to a facet between d-cells C_i and C_j . We will construct yet another gain graph, (; $h_s;R^d$), this time with the gain group R^d . A ssign to each oriented edge C_1C_2 of the vector $h_s(C_1C_2) = s(C_1;C_2)n(C_1;C_2)$.

Lem m a 6.6 $(;h_s;R^d)$ is a balanced gain graph.

Proof. Since $n(C_1;C_2) = n(C_1;C_2)$ and $s(C_1;C_2) = s(C_2;C_1)$, $h_s(C_2C_1) = h(C_1C_2)$. Since $H_1(M_1;Z_2) = H_1(M_1;Z_2) = 0$, by Lemma 6.3 balance of the ridge triangles of implies balance of the gain graph. To conclude that these triangles are balanced we have to show that

We de ne (s) = h_s . It is obvious that is an injection and a vector-space hom om orphism . Let H be the image of . Then H Bal(; \mathbb{R}^d) and dim H = 1.

C onsider now the permutation gain graph ($;h_s;R^d;R^d$), where the rst three components are as above and R^d acts on R^d by translation. This action is obviously xedpoint free. Since a reciprocal is completely de ned by the coordinates of its vertices, all reciprocals form a linear subspace of $(R^d)^V$. A satistic edited for ($;h_s;R^d;R^d$) is a reciprocal r whose edge lengths have been decided by the gain graph ($;h_s;R^d;R^d$). That is, since ($;h_s;R^d$) is balanced and connected, we can start from any point in R^d as a vertex of the reciprocal and construct all other vertices. Then h = r. By Lemma 5.2 this construction gives all of Sat_{h_s} ($;R^d;R^d$); varying s, it gives all of Sat_H ($;R^d;R^d$). Furthermore, it shows that H f r jr is a reciprocalg, the reciprocal coboundary space, which is RecM by Equation 6.3. The non-zero elements of H correspond (bijectively) to the non-degenerate reciprocals.

Conversely, the edges of a reciprocal r determ ine a balanced gain map r w ith values in the gain group R^d . By the orthogonality property of a reciprocal and Equation (6.2), r has the form (s) for some non-zero s 2 (;g;R;R). Therefore, H = f r jr is a reciprocal g = Rec(M).

We established earlier that $\dim_R H = 1$. It follows that $\dim_R R ec (M) = 1$.

Theorem 6.7 Let M and M be as in Theorem 6.4. Then M has a sharp lifting and $\dim_{R} L \, \text{ift}\, (M$) is d+2.

Proof. Since M is (d 2)-simple, in any lifting of M the position of a d-cell C from the star Star(R) of a ridge R is completely de ned by the positions of the other two d-cells of Star(R). Therefore, if the lifting of Star(R) can be extended to a lifting of M, the resulting lifting of M is completely de ned by the lifting of Star(R). By Lemma 62, dim Lift(M) d+2.

Let us now prove that dim Lift (M) = d+ 2. Let H be as in the above theorem, i.e., let H be the subspace of Bal(; R^{d} ; R^{d}) that consists of those realizations of the dual graph of M that are reciprocals of M. Consider gain graphs where the underlying graph is the dual graph and the gain group is the additive group A_d of all a ne functions on R^{d} (this is isom orphic to R^{d+1}). A_d acts on itself by addition and this action is xed-point free. Therefore, by Lemma 5.2, the liftings of M can be identified with all satisfied states of permutation gain graphs ($;h_1;R^{d+1};A_d$) where h_1 is taken from the subgroup H_1 of Bal($;R^{d+1}$) that consists of gain maps of the form $h_1(F) = e_F$ (x $_E$), where F is an oriented facet, e_F is the corresponding oriented edge in some reciprocal, c_F is any point on F, and x is the variable vector. This gain map can be written as $h_1(F) = h(F) + c(F)$, where $h(F) = e_F$ x is a gain map in H Bal($;R^d$). We know that H = R. Therefore, a state s of ($;h_1;R^{d+1};A_d$) corresponds to a lifting if and only if the gain map $c(F) = e_F$ x is balanced. It is easy to see that all cycles of corresponding to ridges of M are balanced with respect to this gain map. These cycles generate all of $H_1(M; Z_2) = H_1(M; Z_2)$. Therefore, by the B inary Cycle Test c is balanced. Thus, by Lemma 5.4, Lift (M) = A_d R = R^{d+2}.

C orollary 6.8 Let M be a nite simple homology d-manifold, where d 3, such that $H_1(M; Z_2) = 0$. Let M be a non-degenerate generic PL-realization in \mathbb{R}^d whose d-cells are convex. Then M is a projection of a convex polyhedron in \mathbb{R}^{d+1} .

Proof. Since M is (d 3)-simple, there is a sharp lifting L of M to \mathbb{R}^{d+1} . Since all cells of M are how eom orphic to convex polytopes, and there are d k + 1 d-cells making contact at each k-face, M is a topological manifold. The sharp lifting L is then a simple PL-surface in \mathbb{R}^{d+1} , realizing abstract manifold M. L must be an immersion, since each cell is embedded and the star of each vertex is embedded. So, we have a realization of a d-manifold in \mathbb{R}^{d+1} which has the following properties: (1) it is an immersion, (2) it is locally (non-strictly) convex at each point, and (3) it is strictly convex at each vertex. By Van Heigenoort's (1952) theorem L is the boundary of a convex body. Since M is nite and L is piecewise-linear, L is a convex polyhedron.

A lthough Theorem 6.7 is form ulated for vertical projections, it, indeed, holds for a central projection from \mathbb{R}^{d+1} to \mathbb{R}^{d} \mathbb{R}^{d+1} . It also holds for a central projection from the origin of d-m anifolds realized in \mathbb{R}^{d+1} to a d-sphere in \mathbb{R}^{d+1} (see Rybnikov, 1999), or projection from (0; :::; 0; 1) of d-m anifolds realized in \mathbb{R}^{d+1} to the M inkow ski hyperboloid in \mathbb{R}^{d+1} . O f course, the reason for such universality is that the theorem is a theorem of projective geom etry. The projective form ulation is Theorem 6.9. There, orthogonality between the edges of the reciprocal and facets of M is replaced by duality between lines and subspaces of codimension 1 in \mathbb{RP}^d . O ther term inology is essentially as in the a ne version.

Theorem 6.9 Let M be a nite (d 3)-simple homology d-manifold with H_1 (M; Z_2) = 0. Let M be a non-degenerate generic piecewise-linear realization in RP^d. Then M has a sharp piecewise-linear realization L in RP^{d+1} that is projectively equivalent to M. Such a realization is uniquely determined by choosing d+2 free real parameters.
