#### A bstract

We introduce the notion of a braid group param etrized by a ring, which is de ned by generators and relations and based on the geom etric idea of painted braids. We show that the param etrized braid group is isom orphic to the sem i-direct product of the Steinberg group (of the ring) with the classical braid group. The technical heart of the proof is the Pure Braid Lem m a 2.1.1, which asserts that certain elements of the param etrized braid group commute with the pure braid group.

M ore generally, we de ne, for any crystallographic root system, a braid group and a param etrized braid group with param eters in a commutative ring. The param etrized braid group is expected to be isom orphic to the sem i-direct product of the corresponding Steinberg group with the braid group. The rst part of the paper (described above) treats the case of the root system  $A_n$ ; in the second part, we handle the root system  $D_n$ . O ther cases will be treated in the sequel [L-S2].

## 0 Introduction

Suppose that the strands of a braid are painted and that the paint from a strand spills onto the strand beneath it, modifying the color of the lower strand as in the picture below.

This gives rise, for any ring A, to the parametrized braid group B  $r_n$  (A), which is generated by elements  $y_i^a$ , where i is an integer, 1 i n 1, and a is an element of A, subject to the relations

(A variation of this group rst appeared in [L]. The choice of names for these relations will be explained in x1.2 below. The derivation of these relations from the painted braid model can be seen in Figures 2 and 3 of x2 below.)

Observe that when A = f0g (the zero ring), one obtains the classical Artin braid group  $Br_n$ , whose presentation is by generators  $y_i$ , 1 i n 1, and relations

A question immediately comes to mind: does Figure 1 correctly reject the elements of the parametrized braid group? Up to equivalence, a picture would be completely determined by a braid and a linear transformation of the set of colors. This linear transformation lies in the subgroup  $E_n$  (A) of elementary matrices. Hence if the parametrized braid group corresponds exactly to the pictures, it should be the semi-direct product of  $E_n$  (A) and  $Br_n$ . We will show that this is almost the case: we need to replace  $E_n$  (A) by the Steinberg group  $St_n$  (A) (cf. [St] [Stb]).

Theorem . For any ring A there is an isom orphism

 $Br_n(A) = St_n(A) \circ Br_n$ ;

where the action of B  $r_n$  is via the symmetric group  $S_n$ .

The quotient of B  $r_n$  (A) by the relation  $y_i^0 y_i^0 = 1$  is the group studied by K assel and R eutenauer [K-R] (in this quotient group, our relation (A1) becomes  $y_i^a y_i^0 y_i^b = y_i^{a+b}$ , which is exactly the relation used by [K-R] in place of (A1)). They show that this quotient is naturally isom orphic to the sem i-direct product St<sub>n</sub> (A) o S<sub>n</sub> of the Steinberg group with the sym metric group. So our theorem is a lifting of theirs.

M ore generally, when A is commutative, a Steinberg group St(;A) exists for any crystallographic root system . We construct a parametrized braid group, Br(;A), using a parametrized version of the relations

with m (;) (see x1 for the de nition) generators on each side. Our aim is to prove in all generality the existence of an isom orphism

W henever such an isomorphism exists, it implies an analogue of the theorem of K assel and R eutenauer for  $\ .$ 

W hen =  $A_n$ , the only values of m(;) are 1;2 and 3, and the corresponding relations are (A1); (A1 A1) and (A2) respectively. The same is true for the case =  $D_n$  that we treat in x3.

M ore cases will be treated in the sequel [L-S2].

C ontent. In x1 we outline the proof for a general crystallographic root system . We de ne the parametrized braid group Br(;A) of type with parameters in a commutative ring A. For such data a Steinberg group St(;A) has been constructed in [Stb] and [St]. We explain how it is equipped with an action of the Weyl group W (), and (since W () is an epim orphic image of Br(), with an action of the braid group Br() = Br(;0). We de neamap Br(;A)! St(;A) o Br() which we conjecture is an isom orphism

for a general crystallographic root system , and we indicate a procedure for proving this conjecture, which depends on a crucial technical result called the Pure Braid Lemma (1.4.2). Our proof of the Pure Braid Lemma a requires a manageable family of generators for the pure braid group. Such a family is easily obtained for the cases  $= A_{n-1}$  and  $= D_n$  that we treat in this paper.

In x2 we treat the case  $= A_{n-1}$  (the param etrized braid group presented in the introduction). Though this case follows the general pattern outlined in the rst section, x2 can be read independently. Moreover, in this case we need not assume that A is either commutative or unital.

In x3 we treat the case  $= D_n$ , which is technically more di cult due to the complexity of the generators of the pure braid group.

# 1 The Braid group and Steinberg group associated to a root system

In discussing C oxeter groups and root system s, we will adopt the term inology of H um phreys [H, xx12; 22; 23; 2.9], in which all root system s are reduced | that is, the only root parallel to is | but are not necessarily crystallographic ([H, 2.9]). If the root system is crystallographic and irreducible (i.e. the root system of a simple Lie algebra over the complex numbers), we must have m (;) = 1;2;3;4; or 6 ([H, P roposition, p. 38]). In this case, there can be at most 2 root lengths, and W () acts transitively on roots of the same length.

1.1 The braid group of a root system

For (not necessarily crystallographic) as above, de ne Br(), the braid group of type , as the group with generators fy j 2 g and de ning relations

where there are m = m (;) factors on each side. The mapy 7 de ned on generators induces a surjective hom on orphism Br()! W () whose kernel, PBr(), is called the pure braid group of type . We will write b to denote the image in W () of an element b 2 Br(). Since W () is obtained from Br() by adding the relations y <sup>2</sup> = 1 for 2, it follows that PBr() is generated by all y<sup>2</sup>; 2, together with their conjugates by arbitrary elements of Br().

### 1.2 The param etrized braid group of a root system

Now assume that the root system is crystallographic (so that m (;) = 2;3;4; or 6 when  $\epsilon$ ), and let A be a ring, assumed commutative if  $\epsilon$  A<sub>n</sub>. The parametrized braid group of type with parameters in A, Br(;A), has generators y<sup>a</sup>; 2, a 2 A, and relations

for ; 2 ; (see below), and a;b;c;d;e;f 2 A. There is also a relation (G 2) when m(;) = 6 which has 6 terms on each side; that relation and its consequences will be discussed in [L-S2].

The conditions in relations (A 2) and (B 2) refer to an ordering which will be made explicit in those cases (cf. 2.0.5 and 3.1.1).

W hen  $= A_{n-1}$  this is precisely the group  $Br_n(A)$  de ned in the introduction. The relations have been named to reject the type of irreducible crystallographic root system in which they occur.

Of course the root system determ ines which of these relations occur; for instance for the simply-laced root system  $s = A_n; D_n; E_6; E_7; E_8$  only the relations (A1); (A1 A1) and (A2) occur. In the cases  $= B_n; C_n; F_4$  one needs to add relation (B2). The case  $= G_2$  uses relations (A1) and (G2).

This presentation depends on the choice of a simple subsystem , as do the presentations given in x1.1. However, it is easily checked that changing the simple subsystem results in a group isom orphic to the original group.

W hen A = 0, relation (A1) becomes a tautology and the presentations of Br(;0) and Br()(x1.1) coincide. The unique ring hom on orphism A ! flog induces a split epim orphism :Br(;A) ! Br(), and thus Br(;A) is isom orphic to the sem i-direct product

### 1.3 The Steinberg group of a root system

Let be an irreducible crystallographic root system, and let A be a commutative ring. The Steinberg group, St(;A), of type over A (cf. [Stb] [St]), is presented with generators fx (a) =  $x^a$  j 2; a 2 Ag (we will freely mix the notations x (a) and  $x^a$  depending on how complicated the coe cient a is) subject to the relations

for all ; 2 such that +  $\frac{6}{5}$  0, where the product is taken over all roots of the form i + j ; i; j 2 Z\_{>0} in some xed order, and the N ; ; i; j are certain integers depending only on the structure constants of the simple Lie algebra of type .

W e shall see that the W eyl group W () (and therefore, the braid group Br()) acts on St(;A). This action takes the form

where the (;) = 1 are signs to be determ ined. Thus we can form the sem i-direct product  $St(;A) \circ Br()$ . The explicit form of relations (R1) and (R2); and of the N;  $_{;i;j}$  ([Car, Theorem 522, p. 77; x42, p. 55]) play an important role in de ning the action of the W eyl group on St(;A).

In m any cases, the group St(;A) is the universal central extension of E(;A), the elementary subgroup of the points in A of a Chevalley-D em azure group scheme with (crystallographic) root system ([St]).

#### 1.4 The Main Theorem and How It Is Proved

In this paper and its sequel [L-S2], we shall prove the following theorem .

Theorem 1.4.1. For any crystallographic root system and any commutative ring A, the map

:Br(;A)! St(;A) o Br()

induced by  $y^a$  7 ( $x^a$ ; y) is an isomorphism of groups. This is true when  $= A_{n-1}$  even when A is neither commutative nor unital.

Because the details in the proof of Theorem 1.4.1 can become rather complicated, we summarize the steps rst for the reader's convenience.

Step (a). We show that there exists a well-de ned m ap :Br(;A)! St(;A) o Br() induced by  $y^a$  7 ( $x^a;y$ ) and we verify that it is a group hom on orphism.

Step (b). A crucial technical result needed to show that is invertible is

Lem m a 1.4.2 (Pure Braid Lem m a). For any 2 and any a 2 A, the element  $y^{a}(y^{0})^{-1} 2 Br(;A)$  commutes with every element of the pure braid group PBr() (viewed as a subgroup of Br(;A)).

The proof of this lemma requires a manageable set of generators of the pure braid group PBr(). Such a result is classical for  $= A_{n-1}$  (cf. [Bir]), but less well-known in the other cases. For the case  $D_n$  in this paper, we deduce a set of generators from the work of D igne and G om i D-G ].

Step (c). We want to construct a group hom on orphism :St(;A) o Br()! Br(;A) which is inverse to .We begin by dening a map which, for 2, sends y to  $y^0$  and  $x^a$  to  $y^a (y^0)^{-1}$ . But St(;A) has many more generators, namely all the elements  $x^a$  for 2 (and not just those in the simple subsystem ), so we need to extend the denition of ( $x^a$ ) to any 2. Now since the Weyl group acts transitively on the set of roots of each length, we can choose 2W() such that ()2. Choosing a lifting ~2Br() of , we de ne ( $x^a$ ) as ~ <sup>1</sup> ( $\hat{x}_{()}$ ). To prove that well-de ned { that is, independent of the choice of and of its lifting ~ { and is a group hom on orphism requires Step (b).

Since it is clear that and are identity maps, these three steps establish the main theorem.

In this paper we treat completely two cases for which m (; ) 3, those of  $= A_{n-1}$  (which does not require the hypothesis of commutativity on A) and  $= D_n$ .

Before beginning the case by case proof we state two results which will prove useful later on.

Lem m a 1.4.3. The following relations in Br(;A) are consequences of relation (A1) of x1.2.

Proof. Replacing b by 0 in (A1) shows that  $y^0 y^0$  commutes with  $y^a$ . From this follows

Proof. First let us show that there exists  $b^0 2 Br()$  such that  $b^0 y^a b^{0-1} = y^a_{b()}$ . The two roots and b() have the same length, hence they are connected, in the Dynkin diagram, by a nite sequence of edges with m = 3 ([Car, Lemma 3.6.3]). Therefore it is su cient to prove the existence of  $b^0$  when and b() are adjacent. In that case and b() generate

a subsystem of type  $A_2$ ; we may assume =  $_1$  and b() =  $_2 2 A_2$ ; and we can use the particular case of relation (A2), namely

Since we have assumed that the Pure Braid Lemma holds for , we can thus conclude that by  $a(y^0)$   $b^1 = y^a(y^0)$   $b^1$  as desired.

2 The parametrized braid group for  $= A_{n-1}$ 

Let A be a ring, in this section not necessarily unital or commutative. We consider the special case of the parametrized braid group Br(;A) for  $= A_{n-1}$ . In this case we will write  $y_i$  instead of  $y_i$ , and  $Br_n(A)$  for  $Br(A_{n-1};A)$ . Because  $A_{n-1}$  is a simply-laced root system, we have

The geom etric motivation for the dening relations of this group, and its connection with braids, can be seen in the following gures in which u;v;w (the colors) are elements of A, and a;b;c are the coe cients of spilling. Relation (A1) comes from Figure 2.

Relation (A1 A1) arises because the actions of  $y_i^a$  and of  $y_j^b$  on the strands of the braid are disjoint when ji jj 2, so that these two elements commute. Relation (A2) derives from Figure 3.

2.2 The Steinberg group for  $= A_{n-1}$  and an action of the W eyl group

W hen =  $A_{n-1}$ , the Steinberg group of x1 3 is well-known and custom arily denoted  $St_n(A)$ . In that case it is custom any to write  $x_{ii+1}^a = x_{ii+1}$  (a) for the element x (a); =  $i_{i+1} 2$ , and, more generally,  $x_{ij}^a$  when =  $i_{j-2} 2A_{n-1}$ .

We should make two observations about this de nition. First, it follows from (StO) that  $x_{ij}^0 = 1$ . [K-S] for the relationship with the Stashe polytope), and for the simpli cation it brings in computation.

3 The param etrized braid group for  $= D_n$ 

In this section we discuss the parametrized braid group  $Br(D_n;A)$  (for a commutative ring A) and prove Theorem 1.4.1 in this case:  $Br(D_n;A)$  is isomorphic to the semi-direct product of  $St(D_n;A)$  with  $Br(D_n;0)$ .

3.1 The braid group and the param etrized braid group for  $D_n$

Since the relations involved in the denitions of  $B r (D_n; A)$  and  $St (D_n; A)$  are the same as the relations in the case of  $A_{n-1}$ , the map is well-dened (cf. Theorem 2.3.1). Step (b). The proof of the Pure Braid Lemma in the  $D_n$  case will be given below in x3.3. Step (c). Let  $:Br(D_n; A) ! 3.3 The Pure Braid Lemma for D<sub>n</sub>

3.3.1 G enerators for the Pure B raid G roup of D  $_n$ 

In principle, the method of Reidem eister-Schreier [M-K-S] is available to deduce a presentation of PBr( $D_n$ ) from that of Br( $D_n$ ). The details have been worked out by D igne and G om i D-G], although not in the speci city we need here. From their work we can deduce that the group PBr( $D_n$ ) is generated by the elements  $y^2$ ; 2 , together with a very sm all set of their conjugates. For example, PBr( $D_4$ ) is generated by the 12 elements

where a pre xed exponent indicates conjugation:  ${}^{h}g = hgh^{1}$ . Here (and throughout) we use the simplified notations  $k^{a} = y^{a}_{k}$  and  $k = y^{0}_{k}$  similar to those of x2.1.

P roposition 3.3.1. For n = 4, PBr( $D_n$ ) is generated by the elements

Proof of (3.3.1). We work in the case where W (in the notation of [D-G]) = W  $(D_n)$  (in our notation; cf. (1.1)). In the proof of [D-G, Corollary 2.7], we see that  $P_W = U_n \circ P_{W_{I_n 1}}$ ; taking  $I_n = fs_1; s_2; s_2; s_1; s_{n-1}g; n = 4$ , as on [D-G, p. 10], we see that their  $P_W$  is equal to (our)  $PBr(D_n)$  and their  $P_{W_{I_n 1}}$  is equal to (our)  $PBr(D_{n-1})$ . It follows that a set of generators for  $PBr(D_n)$  can be obtained as the union of a set of generators for  $PBr(D_{n-1})$  with a set of generators for  $U_n$ . This sets the stage for an inductive argument, since  $D_3 = A_3$  (with  $f_2; 3; 2^{\circ}g = D_3$  identieed with  $f_1; 2; 3g = A_3$ ). Because W  $(D_n)$  is a nite W eyl group, it follows from [D-G, Proposition 3.6], that  $U_n$  is generated (not just norm ally generated) by the elements  $a_{b;s}$ , and a list of these generators in our case is given on [D-G, p.10].

The calculations necessary to prove the Pure Braid Lemma for  $D_n$  are simpler if we replace the D igne-G om i generators by the equivalent set in which conjugation is replaced

by re ection; that is, we replace a generator  ${}^{h}g = hgh^{-1}$  by  $hgh^{0}$ , where if  $h = y_{i_{1}} ::: y_{i_{k}}$ ,  $h^{0} = y_{i_{k}} ::: y_{i_{1}}$ . (We already used this trick in the case of  $A_{n-1}$ .) For  $D_{4}$ , this procedure yields as generators of PBr( $D_{4}$ ) the set

and, m ore generally, P B r (D  $_n$ ); n 4 is generated by the elements stated in the P roposition.
