

Crossed products by endomorphisms, vector bundles and group duality

Abstract

We construct the crossed product $\mathcal{A} \rtimes_{\rho}^{\mathcal{E}} \mathbb{N}$ of a $C(X)$ -algebra \mathcal{A} by an endomorphism ρ , in such a way that ρ becomes induced by the bimodule $\widehat{\mathcal{E}}$ of continuous sections of a vector bundle $\mathcal{E} \rightarrow X$. Some motivating examples for such a construction are given. Furthermore, we study the C^* -algebra of G -invariant elements of the Cuntz-Pimsner algebra $\mathcal{O}_{\mathcal{E}}$ associated with $\widehat{\mathcal{E}}$, where G is a (noncompact, in general) group acting on \mathcal{E} . In particular, the C^* -algebra of invariant elements w.r.t. the action of the group of special unitaries of \mathcal{E} is a crossed product in the above sense. We also study the analogous construction on certain Hilbert bimodules, called 'noncommutative pullbacks'.

1 Introduction.

Let $d \in \mathbb{N}$, $\mathbb{U}(d)$ the unitary group of $d \times d$ -matrices, \mathcal{O}_d the Cuntz algebra generated by a set $\{\psi_h\}_{h=1}^d$ of isometries with relations $\psi_h^* \psi_k = \delta_{hk} 1$, $\sum_k \psi_k \psi_k^* = 1$. It is well-known that for every closed group $G \subseteq \mathbb{U}(d)$ there is a G -action by automorphisms on \mathcal{O}_d , obtained in the following way: let $H \subset \mathcal{O}_d$ be the vector space spanned by $\{\psi_h\}$; then H , endowed with the scalar product

$\psi, \psi' \mapsto \psi^* \psi' \in \mathbb{C}1$, $\psi, \psi' \in H$, is isomorphic to the standard rank d Hilbert space \mathbb{C}^d , so that there is an action $G \times H \rightarrow H$ by unitary operators, corresponding to the defining representation of G over \mathbb{C}^d . By universality of the Cuntz algebra, such an action extends to an automorphic action

$$G \rightarrow \mathbf{aut} \mathcal{O}_d \quad , \quad G \ni g \mapsto \widehat{g} \in \mathbf{aut} \mathcal{O}_d \quad .$$

We denote by $\mathcal{O}_G \subseteq \mathcal{O}_d$ the fixed-point algebra. Important cases are the C^* -algebras $\mathcal{O}_{\mathbb{U}(d)}$ and $\mathcal{O}_{\mathbb{SU}(d)}$, where $\mathbb{SU}(d)$ is the special unitary group: in particular, it turns out that $\mathcal{O}_{\mathbb{SU}(d)}$ is the crossed product of $\mathcal{O}_{\mathbb{U}(d)}$ by a certain shift endomorphism ([12, Lemma 3.8]).

Now, \mathcal{O}_d is equipped with the *canonical endomorphism*

$$\sigma \in \mathbf{end} \mathcal{O}_d \quad : \quad \sigma(t) := \sum_k \psi_k t \psi_k^* \quad , \quad t \in \mathcal{O}_d \quad ; \quad (1.1)$$

since $\sigma \circ \widehat{g} = \widehat{g} \circ \sigma$, $g \in G$, we find that σ restricts to an endomorphism $\sigma_G \in \mathbf{end} \mathcal{O}_G$. The pair $(\mathcal{O}_G, \sigma_G)$ can be used to prove a version of the Tannaka duality; in order to expose this fact, we recall the following general construction.

Let \mathcal{A} be a C^* -algebra, $\mathbf{end} \mathcal{A}$ the set of endomorphisms of \mathcal{A} , $\rho \in \mathbf{end} \mathcal{A}$. It is possible to associate with ρ a tensor category, say $\widehat{\rho}$, with objects the endomorphisms ρ^r , $r \in \mathbb{N}$ (for $r = 0$, we define ρ^0 as the identity automorphism ι); the spaces of arrows and the tensor structure are given by

$$\begin{cases} (\rho^r, \rho^s) := \{t \in \mathcal{A} : t\rho^r(a) = \rho^s(a)t, a \in \mathcal{A}\} \quad , \\ \rho^r, \rho^s \mapsto \rho^r \times \rho^s := \rho^{r+s} \quad , \\ t, t' \mapsto t \times t' := t\rho^r(t') = \rho^s(t')t \in (\rho^{r+r'}, \rho^{s+s'}) \quad , \end{cases}$$

$t \in (\rho^r, \rho^s)$, $t' \in (\rho^{r'}, \rho^{s'})$. Note that $(\iota, \iota) = \mathcal{A} \cap \mathcal{A}'$.

We now return to the pair $(\mathcal{O}_G, \sigma_G)$. Let \widehat{G} denote the category of tensor powers of the defining representation of G . Then, it is proved that there is an isomorphism of tensor categories $\widehat{\sigma}_G \simeq \widehat{G}$ ([12, Thm.3.5]); moreover, G can be characterized as the stabilizer of \mathcal{O}_G in \mathcal{O}_d ([12, Cor.3.3]). Thus, we are able to reconstruct the group G and the category \widehat{G} by analyzing the algebraic properties of the C^* -dynamical system $(\mathcal{O}_G, \sigma_G)$, together with the inclusion $\mathcal{O}_G \subseteq \mathcal{O}_d$.

The above construction is an important step towards the Doplicher-Roberts duality for compact groups ([13]), characterizing certain abstract tensor categories as group duals. In the present work, we start the program of generalizing such a duality to the case in which the set of arrows of the identity object does not reduce to the complex numbers. As a first step, we generalize the above 'Tannaka duality' for closed subgroups of $\mathbb{U}(d)$ to the case of certain noncompact groups naturally acting on vector bundles. Instead of the Cuntz algebra, we will make use of the Cuntz-Pimsner algebra associated with the module of continuous sections of a vector bundle $\mathcal{E} \rightarrow X$. The tensor categories that

we consider are characterized by the property $(\iota, \iota) = C(X)$, where ι is the identity object. In a future paper, we will proceed with our program by constructing a crossed product of a C^* -algebra by an endomorphism satisfying a weaker version of permutation symmetry and special conjugate property w.r.t. the analogous notions due to Doplicher and Roberts ([14]). This will generalize [14, Thm.4.1] (recovered as the trivial-centre case), and [4, Thm.2.4] for the case of a tensor category generated by a single object (in our case, the generating "admissible" DR-category in the sense of the above-cited reference is replaced by a more general category with $(\iota, \iota) \neq \mathbb{C}$). The groups we recover are in general non-compact.

The present paper is organized as follows:

In Section 3 we construct the crossed product of a C^* -algebra \mathcal{A} by an endomorphism ρ , in the following way: we consider the centre $ZM(\mathcal{A})$ of the multiplier algebra, and the unital abelian C^* -algebra

$$C(X^\rho) := \{f \in ZM(\mathcal{A}) : \rho(fa) = f\rho(a), a \in \mathcal{A}\} \quad . \quad (1.2)$$

Then, we consider a vector bundle $\mathcal{E} \rightarrow X^\rho$, and construct a crossed product in such a way that ρ becomes induced (in the sense of Def.3.1) by the module of continuous sections of \mathcal{E} (Prop.3.4). Our construction, made in the context of $C(X)$ -algebras ([21, 6]), includes as particular cases (i.e. trivial vector bundles) the crossed products by Stacey [33], Cuntz [7] and Paschke [27]. Motivating examples arise in the context of continuous trace C^* -algebras (Ex.3.3), and Cuntz-Pimsner algebras associated with vector bundles (Ex.3.4).

In Section 4 we introduce the C^* -algebra \mathcal{O}_G associated with a closed group G of unitaries acting on a vector bundle $\mathcal{E} \rightarrow X$. We associate with G a bundle $\mathcal{G} \rightarrow X$, called the *spectral bundle* of G (Def.4.7): roughly speaking, G is characterized as a 'total subset' of continuous sections of \mathcal{G} . We introduce the notion of *dual* of G , as the analogue of the category of tensor powers of the defining representation of a compact Lie group (Def.4.3); then, we study the analogue of the above mentioned construction for $(\mathcal{O}_G, \sigma_G)$ (Cor.4.4, Prop.4.8). An interesting fact is that non-isomorphic groups may have isomorphic duals; there are two orders of reason for this phenomenon:

- at a first level, it is verified that different groups have the same dual if and only if the associated spectral bundles coincide (Lemma 4.10);
- at a deeper level, a dual may have several embeddings into the tensor category of vector bundles; different embeddings give rise to non-isomorphic groups (Cor.4.18, Ex.4.7).

In the important case in which G is the group of special unitaries of \mathcal{E} , then \mathcal{O}_G is a crossed product in the sense of the previous section (Prop.4.17): this generalizes the analogous result for the C^* -algebra $\mathcal{O}_{\mathbb{S}\mathbb{U}(d)}$.

In order for future applications, in Section 5 we introduce and describe a class of Hilbert bimodules corresponding to noncommutative pullbacks of vector bundles, in the sense of Def.5.4. The interest in such bimodules arises from the fact that the associated Cuntz-Pimsner algebras exhibit canonical endomorphisms with weaker properties w.r.t. the case of vector bundles (in particular, they do not have permutation symmetry in the sense of [14, §4]). Vector bundle deformations in the sense of [35], and vector \mathcal{A} -bundles in the sense of Mishchenko ([24]) supply examples of noncommutative pullbacks. We study group actions over noncommutative pullbacks and the associated Cuntz-Pimsner algebras (Prop.5.7, Cor.5.8), generalizing some results of the previous section.

2 Keywords.

The main references for *tensor C^* -categories* are [13, 23], to which we refer for the notion of *symmetry*. Tensor C^* -categories of C^* -algebra endomorphisms, and their relationship with the duality theory, are studied in [12] in the setting of the Cuntz algebra, and more in general in [14]. We refer to these papers for the notions of *permutation symmetry* and *special conjugate property*. If $G \subseteq \mathbb{U}(d)$, then $\sigma_G \in \mathbf{end}\mathcal{O}_G$ has permutation symmetry ([12, §4]), if $G \subseteq \mathbb{SU}(d)$, then σ_G satisfies also the special conjugate property ([12, Lemma 2.2]).

Let X be a locally compact Hausdorff space. A *continuous bundle* of C^* -algebras over X is a C^* -algebra \mathcal{A} , equipped with a faithful family of epimorphisms $\{\pi_x : \mathcal{A} \rightarrow \mathcal{A}_x\}_{x \in X}$ such that for every $a \in \mathcal{A}$ the norm function $\{x \mapsto \|\pi_x(a)\|\}$ belongs to $C_0(X)$, and \mathcal{A} is a nondegenerate $C_0(X)$ -bimodule w.r.t. pointwise multiplication $f, a \mapsto \{f(x) \cdot \pi_x(a)\}$, $f \in C_0(X)$. The term *C^* -algebra bundle* will be also used. Standard references for C^* -algebra bundles (and the related notion of *continuous field*) are [8, §10], [9, 22], to which we refer for the notions of *restriction* and *local triviality*. A $C_0(X)$ -*algebra* is a C^* -algebra \mathcal{A} , equipped with a nondegenerate morphism from $C_0(X)$ into the centre of the multiplier algebra $M(\mathcal{A})$; in the sequel, we will identify elements of $C_0(X)$ with their image in $M(\mathcal{A})$. $C_0(X)$ -algebra morphisms are by definition C^* -algebra morphisms which are equivariant w.r.t. the $C_0(X)$ -module actions. $C_0(X)$ -algebras were introduced by Kasparov in [21, Def.1.5], and characterized as ‘upper semicontinuous bundles’ over X in [6, 25]. As can be expected, continuous bundles of C^* -algebras are $C_0(X)$ -algebras. Every $C_0(X)$ -algebra \mathcal{A} can be faithfully represented over a suitable Hilbert $C_0(X)''$ -module, where $C_0(X)''$ denotes the enveloping algebra (see [21, §1.6]).

Let \mathcal{A} be a C^* -algebra, $M(\mathcal{A})$ the multiplier algebra. The Cuntz-Pimsner algebra (*CP-algebra*, in the sequel) associated with a Hilbert \mathcal{A} -bimodule \mathcal{M} has been introduced in [28]. In [11, §3], the CP-algebras are defined by using a universal construction, essentially the one exposed in [13, §4], [23, §5]. The construction is (briefly) the following: we consider the Banach \mathcal{A} -bimodules $(\mathcal{M}^r, \mathcal{M}^s)$ of right \mathcal{A} -module operators from the (internal) tensor power \mathcal{M}^r

into \mathcal{M}^s , $r, s \in \mathbb{N}$; in particular, we define $\mathcal{M}^0 := \mathcal{A}$, so that $(\mathcal{A}, \mathcal{A}) \simeq M(\mathcal{A})$. Note that $(\mathcal{M}, \mathcal{M})$ is the C^* -algebra of bounded right \mathcal{A} -module operators of \mathcal{M} . If $1 \in (\mathcal{M}, \mathcal{M})$ is the identity operator, we embed $(\mathcal{M}^r, \mathcal{M}^s)$ into $(\mathcal{M}^{r+1}, \mathcal{M}^{s+1})$ by tensoring on the right by 1. Then, we consider the inductive limit $\mathcal{O}_{\mathcal{M}}^k := \cdots (\mathcal{M}^r, \mathcal{M}^s) \hookrightarrow (\mathcal{M}^{r+1}, \mathcal{M}^{s+1}) \hookrightarrow \cdots$, where $k := s - r \in \mathbb{Z}$. If $t \in \mathcal{O}_{\mathcal{M}}^h$, $t' \in \mathcal{O}_{\mathcal{M}}^k$, we can define a product by assuming $t \in (\mathcal{M}^r, \mathcal{M}^{r+h})$, $t' \in (\mathcal{M}^{r+h}, \mathcal{M}^{r+h+k})$, and by composing $t' \cdot t$. In the same way, the operation of assigning the adjoint operator induces an involution $*$: $\mathcal{O}_{\mathcal{M}}^k \rightarrow \mathcal{O}_{\mathcal{M}}^{-k}$. We define ${}^0\mathcal{O}_{\mathcal{M}} := \sum_k^{\oplus} \mathcal{O}_{\mathcal{M}}^k$; the above considerations imply that ${}^0\mathcal{O}_{\mathcal{M}}$ is a $*$ -algebra. It can be proved that there exist a unique C^* -norm on ${}^0\mathcal{O}_{\mathcal{M}}$ such that the *circle action* $z, t \mapsto z^k t$, $z \in \mathbb{T}$, $t \in \mathcal{O}_{\mathcal{M}}^k$ extends to an isometric action. The closure w.r.t. such C^* -norm is a C^* -algebra $\mathcal{O}_{\mathcal{M}}$, coinciding with the CP-algebra if \mathcal{A} is unital and \mathcal{M} is finitely generated (see also [19, 20] for a detailed study about the structure of CP-algebras). If $\mathcal{A} = \mathbb{C}$ and \mathcal{M} has finite rank $d \in \mathbb{N}$, then $\mathcal{O}_{\mathcal{M}}$ is the Cuntz algebra \mathcal{O}_d .

Let X be a compact Hausdorff space, $\mathcal{E} \rightarrow X$ a vector bundle. We denote by $\widehat{\mathcal{E}}$ the finitely generated Hilbert $C(X)$ -bimodule of continuous sections of \mathcal{E} , endowed with coinciding left and right $C(X)$ -module actions, and by $\mathcal{O}_{\mathcal{E}}$ the corresponding CP-algebra. Basic properties of $\mathcal{O}_{\mathcal{E}}$ are established in [34, §4]; we briefly recall them for the reader's convenience. According to the above mentioned procedure, $\mathcal{O}_{\mathcal{E}}$ is generated by the Banach $C(X)$ -bimodules $(\widehat{\mathcal{E}}^r, \widehat{\mathcal{E}}^s)$, $r, s \in \mathbb{N}$, which are identified (by the Serre-Swan theorem) with the sets $(\mathcal{E}^r, \mathcal{E}^s)$ of vector bundle morphisms from the tensor power \mathcal{E}^r into \mathcal{E}^s . In particular, note that $(\mathcal{E}, \mathcal{E}) \simeq (\widehat{\mathcal{E}}, \widehat{\mathcal{E}})$ is the C^* -algebra of bounded $C(X)$ -module operators of $\widehat{\mathcal{E}}$, and that there is a natural identification $\widehat{\mathcal{E}} \simeq (\iota, \mathcal{E})$, where $\iota := \mathcal{E}^0 := X \times \mathbb{C}$. If $\{\psi_l\}_l$ is any finite set of generators for $\widehat{\mathcal{E}}$, then $\mathcal{O}_{\mathcal{E}}$ can be described in terms of generators and relations (as by [28, §3]):

$$f\psi_l = \psi_l f \quad , \quad \psi_l^* \psi_m = \langle \psi_l, \psi_m \rangle \quad , \quad \sum_l \psi_l \psi_l^* = 1 \quad ; \quad (2.1)$$

here $f \in C(X)$ and $\langle \cdot, \cdot \rangle$ denotes the $C(X)$ -valued scalar product on $\widehat{\mathcal{E}}$. By removing the third of (2.1), we get the Toeplitz algebra $\mathcal{T}_{\mathcal{E}}$ (in the sense of [28]). $\mathcal{O}_{\mathcal{E}}$ is a locally trivial continuous bundle of Cuntz algebras over X . This fact is proved in [34, §4], but it was previously discovered by Roberts ([32]). $\mathcal{O}_{\mathcal{E}}$ is endowed with a canonical shift endomorphism σ , coinciding with (1.1) in the case of the Cuntz algebra, in the following way: if $t \in (\mathcal{E}^r, \mathcal{E}^s) \subset \mathcal{O}_{\mathcal{E}}$, then

$$\sigma(t) := 1 \otimes t \in (\mathcal{E}^{r+1}, \mathcal{E}^{s+1}) \quad , \quad (2.2)$$

where 1 is the identity on \mathcal{E} . Note that σ is a $C(X)$ -module map (i.e., σ is the identity on $C(X) \subset \mathcal{O}_{\mathcal{E}}$). In the present paper, we will also adopt the notation $\psi_L := \psi_{l_1} \cdots \psi_{l_r} \in (\iota, \mathcal{E}^r)$, $L = (l_1, \dots, l_r)$, so that an element of $(\mathcal{E}^r, \mathcal{E}^s) \subset \mathcal{O}_{\mathcal{E}}$ is a linear combination with coefficients in $C(X)$ of terms of the type $\psi_M \psi_L^*$, $M := (m_1, \dots, m_s)$; note that $\{\psi_L\}$ is a set of generators for $\widehat{\mathcal{E}}^r \simeq (\iota, \mathcal{E}^r)$.

If $\psi, \psi' \in (\iota, \mathcal{E}^r)$, $r \in \mathbb{N}$, then the relation $\psi^* \psi' = \langle \psi, \psi' \rangle \in C(X)$ holds in the CP-algebra, where $\langle \cdot, \cdot \rangle$ is the $C(X)$ -valued scalar product defined on the module of continuous sections of \mathcal{E}^r .

3 Crossed Products by Endomorphisms and Vector Bundles.

We start the present section by exposing some elementary properties of Hilbert bimodules in C^* -algebras (see [11] for details). Let $\mathcal{B} \subseteq \mathcal{A}$ be an inclusion of C^* -algebras; a closed vector space $\mathcal{M} \subset \mathcal{A}$ is said *Hilbert \mathcal{B} -bimodule in \mathcal{A}* if it is stable for left and right multiplication by elements of \mathcal{B} , and if $\psi^* \psi' \in \mathcal{B}$, $\psi, \psi' \in \mathcal{M}$; in such a way, we have a map

$$\mathcal{M} \times \mathcal{M} \rightarrow \mathcal{B} \quad , \quad \psi, \psi' \mapsto \psi^* \psi'$$

defining a \mathcal{B} -valued scalar product on \mathcal{M} .

\mathcal{M} is *finitely generated* if there is a finite set $\{\psi_l\} \subset \mathcal{M}$ such that $\sum_l \psi_l \psi_l^* \psi = \psi$ for every $\psi \in \mathcal{M}$ (note that $\psi_l^* \psi \in \mathcal{B}$, thus ψ is a linear combination with coefficients in \mathcal{B} of the generators). It is trivial to verify that $P := \sum_l \psi_l \psi_l^*$ is a projection, and that it does not depend on the choice of the generators. We call P the *support* of \mathcal{M} . Note that for every $r \in \mathbb{N}$, there is a natural identification of $\mathcal{M}^r := \text{span}\{\psi_1 \cdots \psi_r, \psi_i \in \mathcal{M}, i = 1, \dots, r\}$ with the r -fold internal tensor power $\mathcal{M} \otimes_{\mathcal{B}} \cdots \otimes_{\mathcal{B}} \mathcal{M}$. With the same argument, we have an identification $(\mathcal{M}^r, \mathcal{M}^s) = \mathcal{M}^s (\mathcal{M}^*)^r := \text{span}\{\psi' \psi^*, \psi' \in \mathcal{M}^s, \psi \in \mathcal{M}^r\}$. If $\mathcal{B} \subseteq \mathcal{A} \cap \mathcal{A}'$, then an endomorphism $\sigma_{\mathcal{M}}$ is defined on \mathcal{A} :

$$\sigma_{\mathcal{M}}(a) := \sum_l \psi_l a \psi_l^* \quad , \quad a \in \mathcal{A} . \quad (3.1)$$

$\sigma_{\mathcal{M}}$ does not depend on the choice of the generators, thus we say that $\sigma_{\mathcal{M}}$ is the *inner endomorphism induced by \mathcal{M}* . If \mathcal{A} has identity 1, then $P = \sigma_{\mathcal{M}}(1)$. Note that if $\mathcal{B} = \mathcal{A} \cap \mathcal{A}'$, then

$$\mathcal{M} = (\iota, \sigma_{\mathcal{M}}) := \{\psi \in \mathcal{A} : \psi a = \sigma_{\mathcal{M}}(a) \psi, \quad a \in \mathcal{A}\} .$$

In fact, if $\psi \in \mathcal{M}$ then $\sigma_{\mathcal{M}}(a) \psi = \sum_l \psi_l a (\psi_l^* \psi) = P \psi a = \psi a$, so that $\mathcal{M} \subseteq (\iota, \sigma_{\mathcal{M}})$; viceversa, if $\psi' \in (\iota, \sigma_{\mathcal{M}})$ then $\psi^* \psi' \in (\iota, \iota) = \mathcal{B}$ for every $\psi \in \mathcal{M}$, thus $\psi' = \psi' \cdot 1 = \sigma_{\mathcal{M}}(1) \psi' = \sum_l \psi_l (\psi_l^* \psi') \in \mathcal{M}$.

Definition 3.1. Let \mathcal{A} be a C^* -algebra with centre \mathcal{Z} , ρ an endomorphism of \mathcal{A} . ρ is said **inner** if there is a finitely generated Hilbert \mathcal{Z} -bimodule $\mathcal{M} \subset \mathcal{A}$ such that $\rho = \sigma_{\mathcal{M}}$.

Example 3.1. Let \mathcal{A} be a C^* -algebra with identity 1 and centre \mathcal{Z} , $v \in \mathcal{A}$ a partial isometry with $v^* v = 1$, $v v^* = P$. Then, $\mathcal{M} := \mathcal{Z} \cdot v$ is a Hilbert \mathcal{Z} -bimodule in \mathcal{A} with support P , (finitely) generated by v . An inner endomorphism $\sigma_{\mathcal{M}} \in \mathbf{end} \mathcal{A}$, $\sigma_{\mathcal{M}}(a) := v a v^*$, $a \in \mathcal{A}$, is induced.

Example 3.2. Let $\mathcal{E} \rightarrow X$ be a vector bundle over a compact Hausdorff space; then, the module $\widehat{\mathcal{E}}$ of continuous sections of \mathcal{E} is finitely generated by a set $\{\psi_l\}$. We consider the canonical endomorphism σ defined on the CP-algebra $\mathcal{O}_{\mathcal{E}}$ (see §2). By [34, Prop.4.2] we find that σ is inner, with $(\iota, \sigma) = (\iota, \mathcal{E}) \simeq \widehat{\mathcal{E}}$; so that, $\sigma(t) = \sum_l \psi_l t \psi_l^*$, $t \in \mathcal{O}_{\mathcal{E}}$. This also implies $(\mathcal{E}^r, \mathcal{E}^s) = (\sigma^r, \sigma^s)$, $r, s \in \mathbb{N}$. In fact, $(\mathcal{E}^r, \mathcal{E}^s)$ is spanned as a vector space by the elementary tensors $\psi_L \psi_M^*$, that belong to (σ^r, σ^s) , so that $(\mathcal{E}^r, \mathcal{E}^s) \subseteq (\sigma^r, \sigma^s)$; viceversa, if $t \in (\sigma^r, \sigma^s)$ then $t_{LM} := \psi_L^* t \psi_M \in (\iota, \iota) = C(X)$, and $t = \sum_{LM} \psi_L t_{LM} \psi_M^* \in (\mathcal{E}^r, \mathcal{E}^s)$. In particular, we find that $(\iota, \sigma^s) \simeq (\iota, \mathcal{E}^s) \simeq \widehat{\mathcal{E}}^s$, so that σ^s is inner.

Let ρ be an endomorphism of a C^* -algebra \mathcal{A} . Then ρ induces a natural structure of $C(X)$ -algebra on \mathcal{A} . In fact, if $M(\mathcal{A})$ is the multiplier algebra with centre $ZM(\mathcal{A})$, we consider the unital, abelian C^* -algebra $C(X^\rho) \subseteq ZM(\mathcal{A})$ defined in (1.2); since the identity $1_{M(\mathcal{A})} \in M(\mathcal{A})$ belongs to $C(X^\rho)$, we conclude that \mathcal{A} is a $C(X^\rho)$ -algebra. Furthermore, by definition ρ is a $C(X^\rho)$ -endomorphism.

Let now X be a compact Hausdorff space, \mathcal{A} a $C(X)$ -algebra, ρ a $C(X)$ -endomorphism of \mathcal{A} . We consider $d \in \mathbb{N}$ and a rank d vector bundle $\mathcal{E} \rightarrow X$, so that $\widehat{\mathcal{E}}$ is finitely generated as a Hilbert $C(X)$ -module. We want to construct a crossed product of \mathcal{A} by ρ , in such a way that ρ becomes induced by $\widehat{\mathcal{E}}$ as by (3.1).

Definition 3.2. A covariant representation of (\mathcal{A}, ρ) with rank \mathcal{E} is a pair $(\pi, \widehat{\mathcal{E}}_\pi)$, where

- $\pi : M(\mathcal{A}) \rightarrow L(\mathcal{M}_\pi)$ is a unital $C(X)$ -representation of the multiplier algebra $M(\mathcal{A})$ over a Hilbert $C(X)''$ -module \mathcal{M}_π ;
- $\widehat{\mathcal{E}}_\pi$ is a Hilbert $C(X)$ -bimodule in $L(\mathcal{M}_\pi)$, isomorphic to $\widehat{\mathcal{E}}$;
- $\pi \circ \rho = \sigma_\pi \circ \pi$, where σ_π is the inner endomorphism induced by $\widehat{\mathcal{E}}_\pi$ on $L(\mathcal{M}_\pi)$ as by (3.1).

If \mathcal{E} is trivial (i.e. $\mathcal{E} = X \times \mathbb{C}^d$), we can find a set $\{\psi_h\}_{h=1}^d$ of orthonormal sections generating $\widehat{\mathcal{E}}$, i.e. $\langle \psi_h, \psi_k \rangle = \delta_{hk} 1$, where δ_{hk} is the Kronecker symbol. By the isomorphism $\widehat{\mathcal{E}}_\pi \simeq \widehat{\mathcal{E}}$, we obtain that $\widehat{\mathcal{E}}_\pi$ is generated by a set $\{\psi_{h,\pi}\}_{h=1}^d$ of orthogonal isometries such that $\psi_{h,\pi}^* \psi_{k,\pi} = \delta_{hk} 1$. Thus, by (3.1) we find that σ_π is induced by $\{\psi_{h,\pi}\}_{h=1}^d$, as for the notion of covariant representation considered by Stacey ([33, §2]). For example, if $\mathcal{E} \simeq X \times \mathbb{C}$, we find that $\sigma_\pi(\cdot) = v \cdot v^*$ for some partial isometry $v \in L(\mathcal{M}_\pi)$.

We now prove the existence of covariant representations. For this purpose, let us denote by $\mathcal{O}_{\mathcal{E}}$ the CP-algebra of $\widehat{\mathcal{E}}$, and by $\mathcal{T}_{\mathcal{E}}$ the corresponding Toeplitz

algebra. By universality of the Toeplitz-Pimsner algebra, every covariant representation $(\pi, \widehat{\mathcal{E}}_\pi)$ induces a morphism $\mathcal{T}_\mathcal{E} \rightarrow L(\mathcal{M}_\pi)$, with image the C^* -subalgebra of $L(\mathcal{M}_\pi)$ generated by $\widehat{\mathcal{E}}_\pi$. If $\widehat{\mathcal{E}}_\pi$ has support the identity, then we obtain a monomorphism $\mathcal{O}_\mathcal{E} \hookrightarrow L(\mathcal{M}_\pi)$ ([28, Thm.3.12]).

Let us now introduce the inductive limit $\mathcal{A}_\infty := \mathcal{A} \xrightarrow{\rho} \mathcal{A} \xrightarrow{\rho} \dots$.

Lemma 3.3. *Let $\mathcal{E} \rightarrow X$ be a vector bundle. There exist covariant representations $(\pi, \widehat{\mathcal{E}}_\pi)$ of (\mathcal{A}, ρ) with rank \mathcal{E} if and only if $\mathcal{A}_\infty \neq \{0\}$.*

Proof. We proceed as in [33, Prop.2.2]. Let $\mathcal{A}_\infty \neq \{0\}$. We consider the crossed product $\mathcal{A} \rtimes_\rho \mathbb{N}$ of \mathcal{A} by ρ , with the nondegenerate morphism $i_\mathcal{A} : \mathcal{A} \hookrightarrow \mathcal{A} \rtimes_\rho \mathbb{N}$. Recall that $i_\mathcal{A}$ extends to the multiplier algebras; furthermore, there is a partial isometry $v \in M(\mathcal{A} \rtimes_\rho \mathbb{N})$ with support $p := i_\mathcal{A}(1_{M(\mathcal{A})})$, and the relation $i_\mathcal{A} \circ \rho(a) = v i_\mathcal{A}(a) v^*$, $a \in \mathcal{A}$, holds. Note that every $f \in C(X)$ defines a multiplier on $\mathcal{A} \rtimes_\rho \mathbb{N}$, say $i_\mathcal{A}(f)$. Now, since $\rho(fa) = f\rho(a)$, we find $v i_\mathcal{A}(fa) = i_\mathcal{A}(f) v i_\mathcal{A}(a)$, so that $i_\mathcal{A}(f)$ commutes with $i_\mathcal{A}(a)$, v . Furthermore, since $C(X) \cdot \mathcal{A}$ is dense in \mathcal{A} , and $\mathcal{A}_\infty \neq \{0\}$, we find that $i_\mathcal{A}(C(X)) \cdot \mathcal{A} \rtimes_\rho \mathbb{N}$ is dense in $\mathcal{A} \rtimes_\rho \mathbb{N}$. Thus, $\mathcal{A} \rtimes_\rho \mathbb{N}$ is a $C(X)$ -algebra. By [21, §1.6], there exists a faithful $C(X)$ -module representation ν of $\mathcal{A} \rtimes_\rho \mathbb{N}$ over a Hilbert $C(X)''$ -module \mathcal{M} . For the same reason, there is a faithful $C(X)$ -module representation ν' of $\mathcal{O}_\mathcal{E}$ over a Hilbert $C(X)''$ -module \mathcal{M}' . We consider the bimodule tensor product $\mathcal{M} \otimes_{C(X)''} \mathcal{M}'$, and claim that the pair $(\pi, \widehat{\mathcal{E}}_\pi)$, $\pi := (\nu \circ i_\mathcal{A}) \otimes 1$, $\widehat{\mathcal{E}}_\pi := \nu(v) \otimes \nu'(\widehat{\mathcal{E}})$, is a covariant representation of \mathcal{A} over $\mathcal{M} \otimes_{C(X)''} \mathcal{M}'$. In fact, it is obvious that $\widehat{\mathcal{E}}_\pi$ is isomorphic to $\widehat{\mathcal{E}}$ as a Hilbert $C(X)$ -bimodule; furthermore, if $\{\psi_l\}$ is a finite set of generators for $\nu'(\widehat{\mathcal{E}})$, by definition we find that $\widehat{\mathcal{E}}_\pi$ has support

$$\sum_l (\nu(v) \otimes \psi_l) \cdot (\nu(v)^* \otimes \psi_l^*) = (\nu(v) \cdot \nu(v^*)) \otimes 1 = \nu(p) \otimes 1$$

If $a \in \mathcal{A}$, $\psi \in \nu'(\widehat{\mathcal{E}})$, then

$$\begin{aligned} (\nu \circ i_\mathcal{A}(\rho(a)) \otimes 1) \cdot (\nu(v) \otimes \psi) &= \nu(i_\mathcal{A}(\rho(a)) \cdot v) \otimes \psi = \\ &= \nu(v \cdot i_\mathcal{A}(a) \cdot v^* \cdot v) \otimes \psi = \\ &= (\nu(v) \otimes \psi) \cdot (\nu \circ i_\mathcal{A}(a) \otimes 1) \quad ; \end{aligned}$$

so that $\pi \circ \rho(a)\varphi = \varphi\pi(a)$, $\varphi \in \widehat{\mathcal{E}}_\pi$. Since by definition $\varphi\pi(a) = \sigma_\pi \circ \pi(a)\varphi$, where σ_π is the inner endomorphism induced by $\widehat{\mathcal{E}}_\pi$, we conclude that $\pi \circ \rho = \sigma_\pi \circ \pi$, and the first implication is proven. Viceversa, let $\mathcal{A}_\infty = \{0\}$, so that for every $a \in \mathcal{A}$ there is $k \in \mathbb{N}$ such that $\rho^k(a) = 0$. Then, if $(\pi, \widehat{\mathcal{E}}_\pi)$ is a covariant representation, we obtain $0 = \pi(\rho^k(a)) = \sum_{|L|=k} \psi_L \pi(a) \psi_L^*$, where $\{\psi_l\}$ is a set of generators of $\widehat{\mathcal{E}}_\pi$ and $\psi_L := \psi_{l_1} \cdots \psi_{l_k}$. Note that if d is the rank of \mathcal{E} , then $\sum_{L=|k|} \psi_L^* \psi_L = \sum_L \langle \psi_L, \psi_L \rangle = d^k$. Now, $\pi(a) = d^{-k} \sum_L \psi_L^* \pi(a) \psi_L = 0$, thus $\pi = 0$. This is a contradiction, so that the lemma is proven. \square

Proposition 3.4. *Let \mathcal{A} be a $C(X)$ -algebra, ρ a $C(X)$ -endomorphism of \mathcal{A} with $\mathcal{A}_\infty \neq \{0\}$. Then, for every vector bundle $\mathcal{E} \rightarrow X$ there exists up to isomorphism a unique $C(X)$ -algebra $\mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$ such that*

- *there is a non-degenerate $C(X)$ -morphism $i : \mathcal{A} \rightarrow \mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$;*
- *$\widehat{\mathcal{E}}$ is contained in $\mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$ as a finitely generated Hilbert $C(X)$ -bimodule; furthermore, $i \circ \rho = \sigma_\mathcal{E} \circ i$, where $\sigma_\mathcal{E}$ is the inner endomorphism induced by \mathcal{E} on $\mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$;*
- *$\mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$ is generated as a C^* -algebra by $i(\mathcal{A})$, $\widehat{\mathcal{E}}$;*
- *for every covariant representation $(\pi, \widehat{\mathcal{E}}_\pi)$ there is a unique non degenerate $C(X)$ -representation $\Pi : \mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N} \rightarrow L(\mathcal{M}_\pi)$ such that $\Pi \circ i = \pi$ and $\Pi(\widehat{\mathcal{E}}) = \widehat{\mathcal{E}}_\pi$.*

Proof. The unicity of the crossed product follows the universality property w.r.t. covariant representations. Let us now consider the $*$ -algebra \mathcal{B} generated by \mathcal{A} , $\widehat{\mathcal{E}}$ with relations

$$\begin{cases} \psi^* \psi' = \langle \psi, \psi' \rangle \\ f\psi = \psi f \\ (af) \cdot \psi = a \cdot (f\psi) \\ \psi \cdot a = \rho(a) \cdot \psi \end{cases} \quad (3.2)$$

where $a \in \mathcal{A}$, $\psi, \psi' \in \widehat{\mathcal{E}}$, $f \in C(X)$ and $\langle \cdot, \cdot \rangle$ is the $C(X)$ -valued scalar product on $\widehat{\mathcal{E}}$. Every covariant representation $(\pi, \widehat{\mathcal{E}}_\pi)$ induces a representation of \mathcal{B} over the Hilbert $C(X)''$ -module \mathcal{M}_π . We denote by $\mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$ the C^* -algebra obtained by endowing \mathcal{B} with the maximal seminorm w.r.t. such representations. It follows from the previous lemma that the natural $C(X)$ -morphism $i : \mathcal{A} \rightarrow \mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$ is nondegenerate, \mathcal{A}_∞ being $\neq \{0\}$. Moreover, $\widehat{\mathcal{E}}$ is contained in $\mathcal{A} \rtimes_\rho^\mathcal{E} \mathbb{N}$ as a finitely generated Hilbert $C(X)$ -bimodule. By the last of (3.2), the inner endomorphism induced by $\widehat{\mathcal{E}}$ extends ρ as desired. \square

The next proposition states the compatibility of our crossed product with those defined by Stacey, Paschke, Cuntz, by choosing trivial vector bundles.

Proposition 3.5. *Let \mathcal{A} be a $C(X)$ -algebra, ρ a $C(X)$ -endomorphism of \mathcal{A} , $\mathcal{E}_d := X \times \mathbb{C}^d$ the trivial rank d vector bundle over X . Then $\mathcal{A} \rtimes_\rho^{\mathcal{E}_d} \mathbb{N}$ is isomorphic to the crossed product $\mathcal{A} \rtimes_\rho^d \mathbb{N}$ (in the sense of [33]).*

Proof. The module of continuous sections of \mathcal{E}_d is isomorphic to the free rank d Hilbert $C(X)$ -module. Thus, we can pick d orthonormal generators ψ_1, \dots, ψ_d , that appear in $\mathcal{A} \rtimes_\rho^{\mathcal{E}_d} \mathbb{N}$ as isometries such that $\psi_i^* \psi_j = \delta_{ij} 1$, and inducing the inner endomorphism extending ρ . Of course both $\mathcal{A} \rtimes_\rho^{\mathcal{E}_d} \mathbb{N}$ and $\mathcal{A} \rtimes_\rho^d \mathbb{N}$ are generated by elements of the type $i(a)\psi_L \psi_M^*$; thus, we have to verify only that $\mathcal{A} \rtimes_\rho^d \mathbb{N}$ satisfies the universal property w.r.t. covariant representations

$(\pi, \widehat{\mathcal{E}}_{d,\pi})$ (note that $\mathcal{A} \rtimes_{\rho}^d \mathbb{N}$ is a $C(X)$ -algebra, so it makes sense to consider $C(X)$ -representations of $\mathcal{A} \rtimes_{\rho}^d \mathbb{N}$). Let now \mathcal{M}_{π} be the Hilbert $C(X)''$ -module carrying the covariant representation $(\pi, \widehat{\mathcal{E}}_{d,\pi})$; we denote by $\psi_{i,\pi}$, $i = 1, \dots, d$, the orthogonal isometries in $L(\mathcal{M}_{\pi})$ generating $\widehat{\mathcal{E}}_{d,\pi}$. We have to prove that there exists a $C(X)$ -module representation Π of $\mathcal{A} \rtimes_{\rho}^d \mathbb{N}$ as in Prop.3.4. We consider a faithful state λ on $C(X)''$, and the Hilbert space $\mathcal{M}_{\pi,\lambda}$ obtained by introducing on \mathcal{M}_{π} the \mathbb{C} -valued scalar product $(v, w)_{\lambda} := \lambda(v, w)$, $v, w \in \mathcal{M}_{\pi}$. Thus, there is a unital monomorphism $i_{\lambda} : L(\mathcal{M}_{\pi}) \hookrightarrow L(\mathcal{M}_{\pi,\lambda})$, and $(i_{\lambda} \circ \pi, \{i_{\lambda}(\psi_{i,\pi})\}_{i=1}^d)$ is a covariant representation in the sense of [33, §2]. By construction of $\mathcal{A} \rtimes_{\rho}^d \mathbb{N}$, there exists a representation Π_{λ} of $\mathcal{A} \rtimes_{\rho}^d \mathbb{N}$ such that $i_{\lambda} \circ \pi = \Pi_{\lambda} \circ i$ and $\Pi_{\lambda}(\psi_i) = i_{\lambda}(\psi_{i,\pi})$. Now, since i_{λ} is injective and $\Pi_{\lambda}(\mathcal{A} \rtimes_{\rho}^d \mathbb{N}) \subseteq i_{\lambda}(L(\mathcal{M}_{\pi}))$, we can define the C^* -algebra morphism $\Pi := i_{\lambda}^{-1}|_{i_{\lambda}(L(\mathcal{M}_{\pi}))} \circ \Pi_{\lambda}$. If $f \in C(X)$, $b \in \mathcal{A} \rtimes_{\rho}^d \mathbb{N}$, then $\Pi(i(f)b) = i_{\lambda}^{-1} \circ \Pi_{\lambda}(i(f)) \Pi(b) = \pi(f) \Pi(b)$; since π is a $C(X)$ -representation, we conclude that Π is a $C(X)$ -representation. It is now clear that Π satisfies by construction the required properties, thus the proposition is proven. \square

Remark 3.1. Let ρ be an automorphism of a C^* -algebra \mathcal{A} , $\mathcal{L} \rightarrow X^{\rho}$ a line bundle. Then, the inner endomorphism $\sigma_{\mathcal{L}}$ is a 'locally unitary' automorphism of $\mathcal{A} \rtimes_{\rho}^{\mathcal{L}} \mathbb{N}$, in analogy with the notion introduced in [31].

Example 3.3. Let \mathcal{A} be a stable continuous trace C^* -algebra with compact spectrum X . Then, for every $C(X)$ -endomorphism ρ of \mathcal{A} there exists a unique (up to isomorphism) finitely generated Hilbert $C(X)$ -bimodule $\widehat{\mathcal{E}}(\rho)$ contained in the multiplier algebra $M(\mathcal{A})$, inducing ρ on \mathcal{A} in the usual way (3.1) (see [16, §4]). $\widehat{\mathcal{E}}(\rho)$ is isomorphic to the module of continuous sections of a vector bundle $\mathcal{E}(\rho) \rightarrow X$. The C^* -subalgebra of $M(\mathcal{A})$ generated by \mathcal{A} and $\widehat{\mathcal{E}}(\rho)$ is isomorphic to the crossed product $\mathcal{A} \rtimes_{\rho}^{\mathcal{E}(\rho)} \mathbb{N}$, since it obviously satisfies the universal property w.r.t. covariant representations.

Example 3.4. Let $\mathcal{E} \rightarrow X$ be a vector bundle, and $\mathcal{O}_{\mathcal{E}}^0$ the fixed point C^* -algebra of $\mathcal{O}_{\mathcal{E}}$ w.r.t. the circle action $\widehat{z}(\psi) := z\psi$, $\psi \in \widehat{\mathcal{E}}$, $z \in \mathbb{T}$. By general facts (see for example [11, §3]), $\mathcal{O}_{\mathcal{E}}^0$ can be regarded as the inductive limit $\varinjlim_r (\mathcal{E}^r, \mathcal{E}^r)$, where $(\mathcal{E}^r, \mathcal{E}^r)$ is embedded in $(\mathcal{E}^{r+1}, \mathcal{E}^{r+1})$ by tensoring on the right by the identity of $(\mathcal{E}, \mathcal{E})$. If $p \in (\mathcal{E}, \mathcal{E})$ is a projection, we define the shift endomorphism $\widehat{p} := t \mapsto p \otimes t$, with $t \in (\mathcal{E}^r, \mathcal{E}^r) \subset \mathcal{O}_{\mathcal{E}}^0$. Let in particular p be a rank 1 projection, and $\rho := \widehat{p}$. We prove that

$$\mathcal{O}_{\mathcal{E}} \simeq \mathcal{O}_{\mathcal{E}}^0 \rtimes_{\rho}^{\mathcal{L}} \mathbb{N},$$

where $\mathcal{L} := p\mathcal{E} \subset \mathcal{E}$ is the line bundle projected by p . Since

$$\widehat{\mathcal{E}} = (\mathcal{E}, \mathcal{E}) \cdot \widehat{\mathcal{L}} := \text{span} \{ t\varphi, t \in (\mathcal{E}, \mathcal{E}), \varphi \in \widehat{\mathcal{L}} \}, \quad (3.3)$$

we find that $\mathcal{O}_{\mathcal{E}}$ is generated by $\mathcal{O}_{\mathcal{E}}^0$, $\widehat{\mathcal{L}}$. Furthermore, ρ becomes inner in $\mathcal{O}_{\mathcal{E}}$: in fact, the identity $(p \otimes t) \cdot (\varphi \otimes 1) = \varphi \otimes t$, $t \in (\mathcal{E}^r, \mathcal{E}^r)$, $\varphi \in p\widehat{\mathcal{E}} \simeq \widehat{\mathcal{L}}$,

is equivalent to $\rho(t)\varphi = \varphi t$ in the CP -algebra $\mathcal{O}_{\mathcal{E}}$. Finally, we have to prove that $\mathcal{O}_{\mathcal{E}}$ satisfies the universal property for covariant representations. Let $(\pi : \mathcal{O}_{\mathcal{E}}^0 \rightarrow L(\mathcal{M}_{\pi}), \widehat{\mathcal{L}}_{\pi})$ be a covariant representation. Since ρ is induced by $\widehat{\mathcal{L}}$ we find $(\iota, \rho) = (\iota, \mathcal{L})$, so that $(\rho, \rho) = (\mathcal{L}, \mathcal{L})$; since p has rank 1, we find $(\mathcal{L}, \mathcal{L}) = p \cdot (\mathcal{E}, \mathcal{E}) \cdot p = C(X) \cdot p$. If $t, t' \in (\mathcal{E}, \mathcal{E})$, $\varphi, \varphi' \in \widehat{\mathcal{L}}$, we find, with $fp := pt^*t'p \in C(X) \cdot p$,

$$\varphi^*t^*t'\varphi' = \varphi^*pt^*t'p\varphi' = f\varphi^*\varphi' \in C(X) ;$$

moreover, if $\varphi_{\pi}, \varphi'_{\pi} \in \widehat{\mathcal{L}}_{\pi}$ are the images of $\varphi, \varphi' \in \widehat{\mathcal{L}}$ w.r.t. the isomorphism $\widehat{\mathcal{L}} \simeq \widehat{\mathcal{L}}_{\pi}$,

$$\varphi_{\pi}^*\pi(t^*t')\varphi'_{\pi} = \varphi_{\pi}^*\pi(p)\pi(t^*t')\pi(p)\varphi'_{\pi} = f\varphi_{\pi}^*\varphi'_{\pi} = f\varphi^*\varphi' \in C(X) . \quad (3.4)$$

The previous equality implies that $\widehat{\mathcal{E}}_{\pi} := \pi(\mathcal{E}, \mathcal{E}) \cdot \widehat{\mathcal{L}}_{\pi}$ is a Hilbert $C(X)$ -bimodule in $L(\mathcal{M}_{\pi})$. Recall from (3.3) that if $\psi \in \widehat{\mathcal{E}}$, then $\psi = t\varphi$, $t \in (\mathcal{E}, \mathcal{E})$, $\varphi \in \widehat{\mathcal{L}}$ (up to linear combinations with coefficients in $C(X)$). We define the following morphism of Hilbert $C(X)$ -bimodules:

$$\phi : \widehat{\mathcal{E}} \rightarrow \widehat{\mathcal{E}}_{\pi} : t\varphi \mapsto \pi(t)\varphi_{\pi} .$$

(3.4) implies that ϕ preserves the $C(X)$ -valued scalar product, thus ϕ is an isomorphism. By universality of the CP -algebra, there exists a unique $C(X)$ -monomorphism $\Pi : \mathcal{O}_{\mathcal{E}} \hookrightarrow L(\mathcal{M}_{\pi})$ extending ϕ : by construction, Π is the desired representation extending π .

4 The C^* -algebra of a G -vector bundle.

We start the present section by fixing some notations: if $d \in \mathbb{N}$, then $H \simeq \mathbb{C}^d$ is the standard Hilbert space with rank d ; \mathbb{M}_d is the C^* -algebra of $d \times d$ matrices with coefficients in \mathbb{C} ; $\mathbb{M}_{d,d'}$, $d' \in \mathbb{N}$, is the Banach space of $d \times d'$ matrices with coefficients in \mathbb{C} . If $r \in \mathbb{N}$, we denote by H^r the r -fold tensor power of H ; if $r = 0$ we define $H^0 := \mathbb{C}$. We also make use of the notation (H^r, H^s) , $r, s \in \mathbb{N}$, to denote the Banach space of linear operators from H^r into H^s , so that $(H^r, H^s) \simeq \mathbb{M}_{d^r, d^s}$. Note that the Cuntz algebra \mathcal{O}_d is generated by the spaces (H^r, H^s) , $r, s \in \mathbb{N}$, according to the procedure described in §2.

For basic notions and terminology about vector bundles, we refer to [2, 18], while for generic fibre bundles we refer to [17].

Let X be a compact Hausdorff space, $\mathcal{E} \rightarrow X$ a rank d vector bundle; we denote by $\mathcal{E}_x \simeq H$ the fibre of \mathcal{E} over $x \in X$, and by $\widehat{\mathcal{E}}$ the Hilbert $C(X)$ -bimodule of continuous sections of \mathcal{E} . We denote the elements of $\widehat{\mathcal{E}}$ by

$$\psi : X \rightarrow \mathcal{E} : x \mapsto \psi_x \in \mathcal{E}_x \subseteq \mathcal{E} . \quad (4.1)$$

In the sequel, we will often make use of the following property: let $U \subseteq X$ be a closed set with nonempty interior, $\pi_U : \mathcal{E}|_U \rightarrow U \times H$ a local chart. Then,

by functoriality a local chart $\pi_i^r : \mathcal{E}^r|_U \rightarrow U \times H^r$ is induced for every $r \in \mathbb{N}$. Now, for every $r \in \mathbb{N}$ the bimodule of continuous sections of $U \times H^r$ is given by the free bimodule $C(U) \otimes H^r$, that we identify with the space of continuous maps from U into H^r . The local charts π_U^r define restriction morphisms

$$\pi_U^{0,r} : (\iota, \mathcal{E}^r) \rightarrow C(U) \otimes H^r \quad , \quad \pi_U^{0,r}(\psi) := \{x \mapsto \pi_U^r \circ \psi_x\} \quad ,$$

$\psi \in \widehat{\mathcal{E}^r} \simeq (\iota, \mathcal{E}^r)$, $x \in U$. More in general, by extending over elements of the type $\psi_L \psi_M^*$, $|L| = s$, $|M| = r$ (see §2), we obtain restriction morphisms

$$\pi_U^{r,s} : (\mathcal{E}^r, \mathcal{E}^s) \rightarrow C(U) \otimes (H^r, H^s) \quad , \quad (4.2)$$

Note that $\pi_U^{r,q}(t't) = \pi_U^{s,q}(t') \pi_U^{r,s}(t)$, $t \in (\mathcal{E}^r, \mathcal{E}^s)$, $t' \in (\mathcal{E}^s, \mathcal{E}^q)$. Thus, the following local chart is induced on $\mathcal{O}_{\mathcal{E}}$:

$$\alpha_U : \mathcal{O}_{\mathcal{E}}|_U \rightarrow C(U) \otimes \mathcal{O}_d \quad , \quad \alpha_U(t) := \pi_U^{r,s}(t) \quad , \quad (4.3)$$

$t \in (\mathcal{E}^r, \mathcal{E}^s) \subset \mathcal{O}_{\mathcal{E}}$.

4.1 Unitary operators on vector bundles.

Let $\mathbf{U}\mathcal{E}$ be the group of unitary endomorphisms of \mathcal{E} . It is well-known that $(\mathcal{E}, \mathcal{E})$ is a locally trivial continuous bundle with fibre \mathbb{M}_d , thus $\mathbf{U}\mathcal{E}$ can be naturally regarded as the group of continuous sections of a fibre bundle $\mathcal{U}\mathcal{E} \rightarrow X$, that we call *the unitary bundle of \mathcal{E}* . $\mathcal{U}\mathcal{E}$ can be constructed in the following way: let $\{u_{ij} : X_i \cap X_j \rightarrow \mathbb{U}(d)\} \in H^1(X, \mathbb{U}(d))$ be a set of *transition maps* associated with \mathcal{E} for an open trivializing cover $\{X_i\}$ (see [18, I.3.5] about such a terminology); then, $\mathcal{U}\mathcal{E}$ is constructed by clutching the bundles $X_i \times \mathbb{U}(d)$ via the maps $f_{ij}(x, u) := (x, u_{ij}(x) \cdot u \cdot u_{ij}^*(x))$, $(x, u) \in (X_i \cap X_j) \times \mathbb{U}(d)$. We denote by $\eta : \mathcal{U}\mathcal{E} \rightarrow X$ the surjective map associated with the bundle structure of $\mathcal{U}\mathcal{E}$. By construction, $\mathcal{U}\mathcal{E}$ has fibre $\mathcal{U}\mathcal{E}_x := \eta^{-1}(x) \simeq \mathbb{U}(d)$ and structure group $\mathbb{U}(d)/\mathbb{T}$, acting by adjoint action. By functoriality, if $\pi_U : \mathcal{E}|_U \rightarrow U \times H$ is a local chart for \mathcal{E} , then a local chart

$$\eta_U : \mathcal{U}\mathcal{E}|_U \rightarrow U \times \mathbb{U}(d) \quad (4.4)$$

is induced. The elements of $\mathbf{U}\mathcal{E}$ can be described by families of continuous maps $g_i : X_i \rightarrow \mathbb{U}(d)$, satisfying the cocycle relations $u_{ij}g_j = g_iu_{ij}$. If \mathcal{E} is trivial, then $\mathcal{U}\mathcal{E} \simeq X \times \mathbb{U}(d)$ and $\mathbf{U}\mathcal{E}$ is isomorphic to $C(X, \mathbb{U}(d))$, i.e. the group of continuous maps from X into $\mathbb{U}(d)$.

Remark 4.1. Let $U \subseteq X$ be a closed set with non empty interior trivializing \mathcal{E} , $\pi_U^{1,1} : (\mathcal{E}, \mathcal{E}) \rightarrow C(U) \otimes (H, H)$ be the restriction morphism (4.2). In particular, we obtain the restriction morphism

$$\pi_U^{1,1} : \mathbf{U}\mathcal{E} \rightarrow C(U, \mathbb{U}(d)) \quad .$$

Remark 4.2. We denote by

$$g_x \in \mathcal{UE}_x \simeq \mathbb{U}(d)$$

the evaluation of $g \in \mathbf{UE}$ over $x \in X$. It is well-known that \mathcal{UE} is **full**, i.e. for every $x \in X$, $u \in \mathcal{UE}_x$ there is $g \in \mathbf{UE}$ such that $u = g_x$. The argument for the proof is the following. Pick an open set $U \subseteq X$ with a local chart $\eta_U : \mathcal{UE}|_U \rightarrow U \times \mathbb{U}(d)$; if $(\omega, g_0) \in U \times \mathbb{U}(d)$, then there is a continuous map $u : [0, 1] \rightarrow \mathbb{U}(d)$ such that $u(1) = g_0$, $u(0) = 1$. We consider a cutoff $\lambda \in C(X)$, $0 \leq \lambda \leq 1$, with support contained in U , $\lambda(\omega) = 1$, and construct a continuous section $g \in \mathbf{UE}$,

$$g_x := \begin{cases} \eta_U^{-1}(x, u \circ \lambda(x)) & , \quad x \in U \\ 1 & , \quad x \in X - U \end{cases}$$

where $1 \in \mathbf{UE}$ is the identity. Note that $g_\omega = \eta_U^{-1}(\omega, g_0)$. Since g_0 is an arbitrary element of $\mathbb{U}(d) \simeq \mathcal{UE}_\omega$, the assertion is proved.

We consider the *determinant map* $\det : \mathbf{UE} \rightarrow C(X, \mathbb{T})$, $(\det(g))(x) := \det(g_x)$, and introduce the group of special unitaries $\mathbf{SUE} := \det^{-1}\{1\}$. It is well-known that \mathbf{SUE} is the group of continuous sections of a bundle $\mathcal{SUE} \rightarrow X$ with fibre $\mathbb{SU}(d)$.

Let G be a closed subgroup of \mathbf{UE} ; then G acts in a natural way over \mathcal{E} , which becomes a G -vector bundle (with trivial G -action over X) in the sense of [2, §1.6]. Note that in general G is not (locally) compact (for example, consider $\mathcal{E} := X \times H$, so that $\mathbf{UE} = C(X, \mathbb{U}(d))$). A technical consequence of this fact is that there is no immediate analogue of the Haar measure, for such a kind of groups.

Remark 4.3. Let G_0 be a locally compact group, $\mathcal{E} \rightarrow X$ a G_0 -vector bundle such that the G_0 -action is trivial on X . Then, every $g \in G_0$ defines a unitary map on \mathcal{E} , so that there is a morphism $U : G_0 \rightarrow \mathbf{UE}$ of topological groups. If U is injective, then $UG_0 \subset \mathbf{UE}$ is locally compact.

Let $G \subseteq \mathbf{UE}$ be a closed group; by the identification $(\mathcal{E}, \mathcal{E}) \simeq (\widehat{\mathcal{E}}, \widehat{\mathcal{E}})$, we obtain that G acts on $\widehat{\mathcal{E}}$ by unitary $C(X)$ -bimodule operators.

Let $\mathcal{O}_{\mathcal{E}}$ be the CP-algebra associated with $\widehat{\mathcal{E}}$. We introduce a canonical \mathbf{UE} -action on $\mathcal{O}_{\mathcal{E}}$: if $g \in \mathbf{UE}$, then $g^{\otimes^r} \in (\mathcal{E}^r, \mathcal{E}^r)$ for every $r \in \mathbb{N}$, and we define

$$\widehat{g}(t) := g^{\otimes^s} \cdot t \cdot g^{*\otimes^r} \in (\mathcal{E}^r, \mathcal{E}^s), \quad (4.5)$$

where $g \in \mathbf{UE}$, $t \in (\mathcal{E}^r, \mathcal{E}^s)$. The map $\{g \mapsto \widehat{g}\}$ defines an \mathbf{UE} -action by $C(X)$ -automorphisms on $\mathcal{O}_{\mathcal{E}}$ (this fact is a consequence of the universality of the CP-algebra, see [11, §3]). We also consider the fixed-point Banach $C(X)$ -bimodules

$$(\mathcal{E}^r, \mathcal{E}^s)_G := \{y \in (\mathcal{E}^r, \mathcal{E}^s) : \widehat{g}(y) = y, g \in G\}, \quad r, s \in \mathbb{N}. \quad (4.6)$$

If X reduces to a single point, then we recover the canonical $\mathbb{U}(d)$ -action over the Cuntz algebra \mathcal{O}_d studied in [12, §1]; if $G_0 \subseteq \mathbb{U}(d)$ is a closed group we denote by $(H^r, H^s)_{G_0}$, $r, s \in \mathbb{N}$, the corresponding fixed-point Banach spaces, and by $\mathcal{O}_{G_0} \subseteq \mathcal{O}_d$ the associated C^* -algebra.

Let $\{t_x \in \mathcal{O}_d\}_{x \in X}$ be the vector field associated with $t \in \mathcal{O}_\mathcal{E}$. Then, it is clear that the vector field associated with $\widehat{g}(t)$ is given by $\{\widehat{g}_x(t_x) \in \mathcal{O}_d\}_{x \in X}$.

As we will see in the sequel, the Banach $C(X)$ -bimodules $(\mathcal{E}^r, \mathcal{E}^s)_G$ are not necessarily finitely generated, thus they do not correspond to modules of continuous sections of vector bundles in the usual sense. They define more in general (non-locally trivial) *Banach bundles* in the sense of [15], also called *quasi vector bundles* in [18, I.1]. In the special case in which G_0 is a locally compact group and \mathcal{E} is a G_0 -vector bundle (with trivial G_0 -action over X , see Rem.4.3), then the bimodules $(\mathcal{E}^r, \mathcal{E}^s)_{G_0}$ correspond to vector bundles (as can be proven with the argument used in [2, Prop.1.6.2]).

4.2 Algebraic properties of \mathcal{O}_G .

We consider the $*$ -subalgebra ${}^0\mathcal{O}_G$ of $\mathcal{O}_\mathcal{E}$ generated by the Banach $C(X)$ -bimodules $(\mathcal{E}^r, \mathcal{E}^s)_G$, $r, s \in \mathbb{N}$, and denote by \mathcal{O}_G the closure of ${}^0\mathcal{O}_G$ in $\mathcal{O}_\mathcal{E}$. \mathcal{O}_G naturally inherits from $\mathcal{O}_\mathcal{E}$ the structure of continuous bundle of C^* -algebras, with fibre

$$(\mathcal{O}_G)_x \subseteq \mathcal{O}_d \quad .$$

If $y \in \mathcal{O}_G$, we denote by $y_x \in \mathcal{O}_d$ the evaluation of y over $x \in X$ as a vector field. As by (2.2), we denote by σ the canonical endomorphism of $\mathcal{O}_\mathcal{E}$. If g is any element of $\mathbf{U}\mathcal{E}$, then for $t \in (\mathcal{E}^r, \mathcal{E}^s)$ we find $\widehat{g} \circ \sigma(t) = \widehat{g}(1 \otimes t) = 1 \otimes \widehat{g}(t)$, so that $\widehat{g} \circ \sigma = \sigma \circ \widehat{g}$. Thus, for every $G \subseteq \mathbf{U}\mathcal{E}$, the restriction $\sigma_G \in \mathbf{end}\mathcal{O}_G$ of the canonical endomorphism is well defined. For intertwiners, as usual we use the notation

$$(\sigma_G^r, \sigma_G^s) := \{y \in \mathcal{O}_G : y\sigma_G^r(y') = \sigma_G^s(y')y, y' \in \mathcal{O}_G\} .$$

We now discuss structural properties of \mathcal{O}_G and the canonical endomorphism σ_G . Let us denote by $\lambda\mathcal{E} \subseteq \mathcal{E}^d$ the exterior tensor product with order the rank of \mathcal{E} . $\lambda\mathcal{E} \rightarrow X$ is a line bundle, and $\lambda(\mathcal{E} \oplus \mathcal{E}') = \lambda\mathcal{E} \otimes \lambda\mathcal{E}'$ (see for example [18, §9.12 (b)] about the above identity); by identifying $H^2(X, \mathbb{Z})$ with the group of isomorphism classes of line bundles over X (endowed with the tensor product as group operation), we obtain an epimorphism $\lambda : K(X) \rightarrow H^2(X, \mathbb{Z})$, i.e. the first Chern class. We now give a local description of $\lambda\mathcal{E}$. We consider a trivialization $\pi_i : \mathcal{E}|_{X_i} \rightarrow X_i \times H$, such that \mathcal{E} admits a family of transition maps $\{u_{ij} := \pi_i \circ \pi_j^{-1} : X_i \cap X_j \rightarrow \mathbb{U}(d)\}$; note that for every $r \in \mathbb{N}$, a local chart $\pi_i^r : \mathcal{E}^r|_{X_i} \rightarrow X_i \times H^r$ is induced. We pick a partition of unity $\{\lambda_i\}$ subordinate to the open cover $\{X_i\}$ and consider, for each index i , the continuous sections

$$R_i := \lambda_i \cdot (\pi_i^d)^{-1} \circ R \in (\iota, \mathcal{E}^d) , \quad (4.7)$$

where

$$R := \sum_{p \in \mathbb{P}_d} \text{sign}(p) e_{p(1)} \otimes \cdots \otimes e_{p(d)} \in (\iota, H^d) \quad (4.8)$$

is regarded as a constant section of $X_i \times H^d$ (\mathbb{P}_d denotes the permutation group, and $\{e_h\}$ is the standard orthonormal basis of H). The R_i 's satisfy the relations

$$R_i^* R_j = \langle R_i, R_j \rangle = \lambda_i \lambda_j \left\langle R, u_{ij}^{\otimes d} R \right\rangle = \lambda_i \lambda_j \det(u_{ij}) \in C(X), \quad (4.9)$$

$$\lambda_i R_j = \lambda_j \det(u_{ij}) R_i, \quad (4.10)$$

$$\sum_i R_i^* R_i = \sum_i \langle R_i, R_i \rangle = 1, \quad (4.11)$$

and generate $(\iota, \lambda\mathcal{E}) \subset (\iota, \mathcal{E}^d)$ as a right Hilbert $C(X)$ -module. Since $\widehat{g}(R_i) = \det(g) R_i = R_i$, $g \in \mathbf{SU}\mathcal{E}$, the $\mathbf{SU}\mathcal{E}$ -action on $(\iota, \lambda\mathcal{E})$ is trivial. Now, the support of $(\iota, \lambda\mathcal{E})$ in $\mathcal{O}_{\mathcal{E}}$ is the projection

$$P := \sum_i R_i R_i^*; \quad (4.12)$$

so that, by using (4.12), we find $\widehat{g}(P) = \det(g) P \det(g^*) = P$ for $g \in \mathbf{U}\mathcal{E}$. The previous considerations imply that $(\iota, \lambda\mathcal{E}) \subset \mathcal{O}_{\mathbf{SU}\mathcal{E}}$ and $P \in \mathcal{O}_{\mathbf{U}\mathcal{E}}$.

An element of $(\mathcal{E}^2, \mathcal{E}^2)$ that will play a special role in the sequel is the symmetry $\theta \in (\mathcal{E}^2, \mathcal{E}^2)$,

$$\theta(\psi \otimes \psi') := \psi' \otimes \psi, \quad (4.13)$$

where $\psi, \psi' \in (\iota, \mathcal{E})$. It is clear that $\theta = \theta^* = \theta^{-1}$. As an element of $\mathcal{O}_{\mathcal{E}}$, θ can be expressed as

$$\theta = \sum_{l,m} \psi_m \psi_l \psi_m^* \psi_l^*, \quad (4.14)$$

where $\{\psi_l\}$ is a set of generators of (ι, \mathcal{E}) . Since the right $C(X)$ -action coincides with the left one on (ι, \mathcal{E}) , we obtain that θ is actually well defined (i.e., it does not depend on the choice of generators), bypassing the problems mentioned in [3, Rem.6.4]. Thus, for $g \in \mathbf{U}\mathcal{E}$ we find

$$\widehat{g}(\theta) = \sum_{l,m} (g\psi_m)(g\psi_l)(g\psi_m)^*(g\psi_l)^* = \theta,$$

so that $\theta \in \mathcal{O}_{\mathbf{U}\mathcal{E}}$.

Let \mathbb{P}_{∞} denote the group of finite permutations of \mathbb{N} , $\mathbb{S} \in \mathbf{end}\mathbb{P}_{\infty}$ the shift endomorphism $(\mathbb{S}p)(1) := 1$, $(\mathbb{S}p)(n) := 1 + p(n-1)$, $p \in \mathbb{P}_{\infty}$. By using the canonical endomorphism and the symmetry we get, with the same methods used in [12, §2], the following representation of \mathbb{P}_{∞} in $\mathcal{O}_{\mathcal{E}}$:

$$\mathbb{P}_r \ni p \mapsto \theta(p) \in (\mathcal{E}^r, \mathcal{E}^r): \quad \theta(p) \cdot \otimes_i^r \psi_i := \otimes_i^r \psi_{p(i)}, \quad \psi_i \in (\iota, \mathcal{E}). \quad (4.15)$$

Note that $\theta \circ \mathbb{S}(p) = \sigma \circ \theta(p)$, and that each $\theta(p)$ is a word in $\theta, \sigma(\theta), \dots, \sigma^s(\theta)$ for some $s \in \mathbb{N}$. Since the canonical endomorphism commutes with the $\mathbf{U}\mathcal{E}$ -action, $\theta(p)$ belongs to $\mathcal{O}_{\mathbf{U}\mathcal{E}}$ for each p . In particular, we will make use of the unitary operators $\theta(r, s) \in (\mathcal{E}^{r+s}, \mathcal{E}^{r+s})$, permuting the first r factors of the tensor product \mathcal{E}^{r+s} with the remaining s . Elementary properties of these operators, which are the same for vector bundles as well as for Hilbert spaces, are given in [12, §2]. We will make use of the obvious identity

$$\theta(s, 1) \cdot (t \otimes 1) = (1 \otimes t) \cdot \theta(r, 1) \quad ,$$

$t \in (\mathcal{E}^r, \mathcal{E}^s)$, which regarded in $\mathcal{O}_{\mathcal{E}}$ becomes

$$\theta(s, 1) \cdot t = \sigma(t) \cdot \theta(r, 1) \quad . \quad (4.16)$$

Note that in particular $\theta\psi = \sigma(\psi)$, $\psi \in (\iota, \mathcal{E})$.

Remark 4.4. Let $R \in (\iota, H^d)$ be the isometry defined in (4.8). Then, the identity $RR^* = \frac{1}{d!} \sum_{p \in \mathbb{P}_d} \text{sign}(p) \theta(p)$ holds (see remarks after [12, Lemma 3.7]); by applying (4.12), we find

$$P = \sum_i R_i R_i^* = \frac{1}{d!} \sum_{p \in \mathbb{P}_d} \text{sign}(p) \theta(p) \quad , \quad (4.17)$$

so that P belongs to the σ -stable algebra generated by θ .

Proposition 4.1.

- $\sigma(t) = \lim_{r \rightarrow \infty} \theta(r + k, 1) \cdot t \cdot \theta(r, 1)^*$, for every $t \in \mathcal{O}_{\mathcal{E}}^k$;
- if $t \in \mathcal{O}_{\mathcal{E}}$ and $[t, \theta(p)] = 0$ for $p \in \mathbb{P}_{\infty}$, then $\sigma(t) = t$ and $t \in C(X)$;
- if G is any subgroup of $\mathbf{U}\mathcal{E}$, then $\mathcal{O}'_G \cap \mathcal{O}_{\mathcal{E}} = C(X)$;
- the amenability property holds, i.e. $(\mathcal{E}^r, \mathcal{E}^s)_G = (\sigma_G^r, \sigma_G^s)$ for $r, s \in \mathbb{N}$.

Proof.

- It follows immediately by (4.16), and by considering the inductive limit.
- If t commutes with $\theta(p)$ for every $p \in \mathbb{P}_{\infty}$, then $t_x \theta_x(p) = \theta_x(p) t_x$ for each fibre $t_x \in \mathcal{O}_d$ and the corresponding permutation operator $\theta_x(p) \in \mathcal{O}_d$, as x varies in X . Thus, by [12, Lemma 3.2] we find $t_x \in \mathbb{C}$, and $t \in C(X)$.
- Since $\theta \in \mathcal{O}_{\mathbf{U}\mathcal{E}} \subset \mathcal{O}_G$ and \mathcal{O}_G is σ_G -stable, we find that $t \in \mathcal{O}'_G \cap \mathcal{O}_{\mathcal{E}}$ commutes with $\theta(p)$ for every $p \in \mathbb{P}_{\infty}$, so that $t \in C(X)$.
- If $t \in (\sigma_G^r, \sigma_G^s)$, then $t_{LM} := \psi_L^* t \psi_M \in \mathcal{O}'_G \cap \mathcal{O}_{\mathcal{E}} = C(X)$ for $\psi_M \in (\iota, \mathcal{E}^r)$, $\psi_L \in (\iota, \mathcal{E}^s)$. Thus, $t = \sum_{LM} t_{LM} \psi_L \psi_M^* \in (\mathcal{E}^r, \mathcal{E}^s)$, and it is by definition G -invariant. Viceversa, if $t \in (\mathcal{E}^r, \mathcal{E}^s)_G$, then $t \in (\mathcal{E}^r, \mathcal{E}^s) = (\sigma_G^r, \sigma_G^s)$ (see Ex.3.2); since by hypothesis $t \in \mathcal{O}_G$, in particular t belongs to (σ_G^r, σ_G^s) .

□

Remark 4.5. By (4.16) and the amenability property, we conclude that

$$\theta(s, 1) \cdot t = \sigma(t) \cdot \theta(r, 1) \quad , \quad t \in (\sigma^r, \sigma^s) ;$$

thus σ has permutation symmetry in the sense of [14, §4], as for the case in which X reduces to a point studied in [12]. The same is true for every restriction σ_G , $G \subseteq \mathbf{UE}$.

Lemma 4.2. *Let $\mathcal{E} \rightarrow X$ be a rank d vector bundle. Then, for every $R, R' \in (\iota, \lambda\mathcal{E})$ the following equality holds:*

$$R^* \sigma(R') = (-1)^{d-1} d^{-1} R^* R' . \quad (4.18)$$

If $G \subseteq \mathbf{SU}\mathcal{E}$, then $\sigma_G \in \mathbf{end}\mathcal{O}_G$ satisfies the special conjugate property in the sense of [14, §4] if and only if the first Chern class of \mathcal{E} vanishes, i.e. $\lambda\mathcal{E} \simeq X \times \mathbb{C}$.

Proof. By [12, Lemma 2.2], we have

$$R^* \sigma(R) = (-1)^{d-1} d^{-1} 1 , \quad (4.19)$$

where R is defined by (4.8). Let $\{R_i\}$ be the set of generators of $(\iota, \lambda\mathcal{E})$ introduced in (4.7); then $R_i^* \sigma(R_i) = (-1)^{d-1} d^{-1} \lambda_i^2$, so that, by using (4.9, 4.10) we find $\lambda_i \lambda_j R_i^* \sigma(R_j) = (-1)^{d-1} d^{-1} \lambda_i \lambda_j R_i^* R_j$. Since R_i (resp. R_j) has the same support of λ_i (resp. λ_j), we can divide the previous equality by $\lambda_i \lambda_j$, and obtain

$$R_i^* \sigma(R_j) = (-1)^{d-1} d^{-1} R_i^* R_j ;$$

since $\{R_i\}$ generates $(\iota, \lambda\mathcal{E})$, we obtain (4.18).

About the second assertion, note that $G \subseteq \mathbf{SU}\mathcal{E}$ implies $(\iota, \lambda\mathcal{E}) \subseteq (\iota, \mathcal{E}^d)_G$; thus, by amenability $(\iota, \lambda\mathcal{E}) \subseteq (\iota, \sigma_G^d)$. Recall that by definition σ_G satisfies the special conjugate property if and only if there is $S \in (\iota, \sigma_G^d)$ generating $(\iota, \lambda\mathcal{E})$ as a Hilbert $C(X)$ -module, i.e., $S^* S = 1$, $S S^* = P$ (by (4.18), this implies that S satisfies also (4.19)). This happens if and only if $\lambda\mathcal{E}$ is trivial. □

The previously exposed properties (in particular the amenability) allow to give the following

Definition 4.3. *Let $\mathcal{E} \rightarrow X$ be a vector bundle, $G \subseteq \mathbf{UE}$ a closed group. We denote by \widehat{G} the symmetric tensor C^* -category with objects the tensor powers \mathcal{E}^r , $r \in \mathbb{N}$, and arrows the invariant $C(X)$ -bimodules $(\mathcal{E}^r, \mathcal{E}^s)_G$. \widehat{G} is called the **dual of G** .*

Note that when X reduces to a single point, then \widehat{G} is the category of tensor powers of the defining representation of G .

Corollary 4.4. *Let $G \subseteq \mathbf{UE}$ be a closed group. Then, there is an isomorphism of tensor C^* -categories $\widehat{\sigma}_G \simeq \widehat{G}$.*

Proof. The amenability property proved in Prop.4.1 implies that $\widehat{\sigma}_G$ and \widehat{G} are isomorphic as C^* -categories. Let now $1_r \in (\mathcal{E}^r, \mathcal{E}^r)$ be the identity map (note that 1_r coincides with the identity in the Pimsner algebra $\mathcal{O}_{\mathcal{E}}$). Then, the identity

$$t \otimes t' = (t \otimes 1_{s'}) \cdot (1_r \otimes t) = t\sigma^r(t') \quad , \quad t \in (\mathcal{E}^r, \mathcal{E}^s) \quad , \quad t' \in (\mathcal{E}^{r'}, \mathcal{E}^{s'})$$

implies that $\widehat{\sigma}_G$ and \widehat{G} are isomorphic as tensor C^* -categories. \square

4.3 \mathcal{O}_G as a continuous bundle.

It is expectable that if $G \subseteq \mathbf{UE}$ is a closed group, then a natural notion of 'fibre' of G over $x \in X$ may be given. We now define two natural candidates for this role. As first, for every $x \in X$ we introduce the closed group

$$G_x := \{g_x : g \in G\} \subseteq \mathbb{U}(d) \quad . \quad (4.20)$$

Now, for every $x \in X$ there is an inclusion $(\mathcal{O}_G)_x \subseteq \mathcal{O}_d$. We consider the group

$$\mathbf{aut}_{(\mathcal{O}_G)_x} \mathcal{O}_d := \{\alpha \in \mathbf{aut} \mathcal{O}_d : \alpha(y) = y, y \in (\mathcal{O}_G)_x\} \quad .$$

It is clear from the definition of the canonical action (4.5) that there is an immersion $G_x \hookrightarrow \mathbf{aut}_{(\mathcal{O}_G)_x} : g_x \mapsto \widehat{g}_x$, $x \in X$. In general such an immersion is not surjective, as evident from the following example.

Example 4.1. *Let $X := [0, 1]$, $\mathcal{E} := X \times H$, $0 < \omega < 1$, and*

$$G := \{g \in C(X, \mathbb{U}(d)) : g_\omega = 1\} \quad .$$

Then $G_x = \mathbb{U}(d)$ for every $x \neq \omega$, and $G_\omega = \{1\}$. It is clear that $(\mathcal{E}^r, \mathcal{E}^s) = C(X) \otimes (H^r, H^s)$. Let now $t \in (\mathcal{E}^r, \mathcal{E}^s)$ be G -invariant. Then, for every neighbourhood U of ω , we find that $t|_{X-U}$ is a norm-continuous map taking values into $(H^r, H^s)_{\mathbb{U}(d)}$. Let $x \in X - U$; by [12, Lemma 3.6], for $r \neq s$ we find $t_x = 0$, and for $r = s$ we find $t_x \in (H^r, H^r)_{\mathbb{U}(d)}$. By continuity, $t_\omega = 0$ if $r \neq s$, and $t_\omega \in (H^r, H^r)_{\mathbb{U}(d)}$ for $r = s$. Thus, $(\mathcal{E}^r, \mathcal{E}^s)_G = C(X) \otimes (H^r, H^s)_{\mathbb{U}(d)}$, and $(\mathcal{O}_G)_x = \mathcal{O}_{\mathbb{U}(d)}$ for every $x \in X$. By applying [12, Cor.3.3], we conclude that $\mathbf{aut}_{\mathcal{O}_{\mathbb{U}(d)}} \mathcal{O}_d \simeq \mathbb{U}(d)$ for every $x \in X$.

Remark 4.6. *We consider the Cuntz algebra \mathcal{O}_d , with the fixed-point C^* -algebra $\mathcal{O}_{\mathbb{SU}(d)} \subset \mathcal{O}_d$ w.r.t. the $\mathbb{SU}(d)$ -action (4.5). Let \mathcal{A} be a σ -stable, unital C^* -algebra with inclusions $\mathcal{O}_{\mathbb{SU}(d)} \subseteq \mathcal{A} \subseteq \mathcal{O}_d$ (this implies $\mathcal{A}' \cap \mathcal{A} \subseteq \mathcal{A}' \cap \mathcal{O}_d = \mathbb{C}1$, see [12, Lemma 3.2]). We define $\rho := \sigma|_{\mathcal{A}}$, and note that ρ satisfies permutation symmetry and special conjugate property in the sense of [14, §4]. Suppose that \mathcal{A} is generated by the intertwiners spaces (ρ^r, ρ^s) , $r, s \in \mathbb{N}$. Let $G := \mathbf{aut}_{\mathcal{A}} \mathcal{O}_d$ denote the stabilizer of \mathcal{A} in \mathcal{O}_d . Then, by [14, Thm.4.1, Lemma 4.6], we obtain that G can be regarded as a closed subgroup of $\mathbb{SU}(d)$ acting on \mathcal{O}_d by the action (4.5), with $\mathcal{A} = \mathcal{O}_G$, $\rho = \sigma_G$, $(\rho^r, \rho^s) = (\sigma_G^r, \sigma_G^s)$, $r, s \in \mathbb{N}$.*

Let $\mathcal{E} \rightarrow X$ be a rank d vector bundle, $\mathcal{F} \subseteq \mathcal{O}_{\mathcal{E}}$ a σ -stable continuous bundle of C^* -algebras. We denote by $\mathcal{F}_x \subseteq \mathcal{O}_d$, $x \in X$, the fibre of \mathcal{F} over x , and $\rho := \sigma|_{\mathcal{F}} \in \mathbf{end}\mathcal{F}$.

Lemma 4.5. *With the above notation, suppose $\mathcal{O}_{\mathbf{U}\mathcal{E}} \subseteq \mathcal{F}$. Then, for every $x \in X$ the action (4.5) defines a group isomorphism*

$$\mathbf{aut}_{\mathcal{F}_x}\mathcal{O}_d \simeq K^x := \{g \in \mathbb{U}(d) : \widehat{g}(t) = t, t \in \mathcal{F}_x\}.$$

Moreover, suppose $\mathcal{O}_{\mathbf{S}\mathbf{U}\mathcal{E}} \subseteq \mathcal{F}$ and that \mathcal{F} is generated by the intertwiners spaces (ρ^r, ρ^s) , $r, s \in \mathbb{N}$. Then, $K^x \subseteq \mathbb{S}\mathbb{U}(d)$ and $\mathcal{F}_x \simeq \mathcal{O}_{K^x}$ for every $x \in X$.

Proof. Since $\mathcal{O}_{\mathbf{U}\mathcal{E}} \subseteq \mathcal{F}$ we find $\mathcal{F}' \cap \mathcal{O}_{\mathcal{E}} \subseteq \mathcal{O}'_{\mathbf{U}\mathcal{E}} \cap \mathcal{O}_{\mathcal{E}} = C(X)$, thus $\mathcal{F}'_x \cap \mathcal{O}_d = \mathbb{C}1$. Let now $\alpha \in \mathbf{aut}_{\mathcal{F}_x}\mathcal{O}_d$, $\psi, \psi' \in (\iota, H) \subseteq \mathcal{O}_d$, $t \in \mathcal{F}_x$. Then $\psi^*\alpha(\psi')t = \psi^*\alpha(\rho_x(t)\psi) = t\psi^*\alpha(\psi)$, and we conclude $\psi^*\alpha(\psi') \in \mathbb{C}1$. Thus α acts on (ι, H) as a unitary operator: $\alpha(\psi) = g\psi$, $\psi \in (\iota, H)$, $g \in \mathbb{U}(d)$, and this proves that $\alpha = \widehat{g}$. We conclude that every element of $\mathbf{aut}_{\mathcal{F}_x}\mathcal{O}_d$ is the image of an element of K^x w.r.t. the map (4.5).

Let $\rho_x \in \mathbf{end}\mathcal{F}_x$ be the canonical endomorphism $\rho_x(t_x) := 1 \otimes t_x$, $t_x \in (\rho^r, \rho^s)_x \subset \mathcal{F}_x$. Since $\mathcal{O}_{\mathbf{S}\mathbf{U}\mathcal{E}} \subseteq \mathcal{F} \subseteq \mathcal{O}_{\mathcal{E}}$, we have C^* -algebra inclusions $\mathcal{O}_{\mathbb{S}\mathbb{U}(d)} \subseteq \mathcal{F}_x \subseteq \mathcal{O}_d$; with the argument of Rem.4.6, we conclude that \mathcal{F}_x is the fixed-point algebra of \mathcal{O}_d w.r.t. the action of the stabilizer K^x of \mathcal{F}_x in \mathcal{O}_d . Rem.4.6 also implies that K^x can be identified as a closed subgroup of $\mathbb{S}\mathbb{U}(d)$, acting on \mathcal{O}_d by the action (4.5), so that there is an isomorphism $\mathcal{F}_x \simeq \mathcal{O}_{K^x}$. \square

Corollary 4.6. *Let $\mathcal{E} \rightarrow X$ be a rank d vector bundle, $G \subseteq \mathbf{U}\mathcal{E}$ a closed group. Then, for every $x \in X$ the action (4.5) induces an isomorphism*

$$\mathbf{aut}_{(\mathcal{O}_G)_x} \simeq G^x := \{g \in \mathbb{U}(d) : \widehat{g}(t) = t, t \in (\mathcal{O}_G)_x\}$$

Moreover, if $G \subseteq \mathbf{S}\mathbf{U}\mathcal{E}$ then $(\mathcal{O}_G)_x = \mathcal{O}_{G^x}$ for every $x \in X$.

Remark 4.7. Let $G \subseteq \mathbf{S}\mathbf{U}\mathcal{E}$. By the previous corollary, \mathcal{O}_G is a continuous bundle with fibres nuclear ([10]), simple ([12, Thm.3.1]) C^* -algebras.

The groups G^x are said the **spectral fibres** of G .

Now, recall that for every $u \in \mathcal{U}\mathcal{E}$ there is $g \in \mathbf{U}\mathcal{E}$ such that $u = g_x$, $x := \eta(u)$ (see Rem.4.2). Thus, for every $x \in X$, $\mathbf{U}\mathcal{E}_x \simeq \mathbb{U}(d)$ acts by automorphisms on $(\mathcal{O}_{\mathcal{E}})_x \simeq \mathcal{O}_d$, by defining $\widehat{u}(t) := \widehat{g}_x(t)$, $t \in (\mathcal{O}_{\mathcal{E}})_x$.

Definition 4.7. *Let $\mathcal{E} \rightarrow X$ be a rank d vector bundle, $G \subseteq \mathbf{U}\mathcal{E}$ a closed group. The **spectral bundle** associated with G is the topological subspace of $\mathcal{U}\mathcal{E}$*

$$\mathcal{G} := \{u \in \mathcal{U}\mathcal{E} : \widehat{u}(y) = y, y \in (\mathcal{O}_G)_x, x \in X\} \subseteq \mathcal{U}\mathcal{E},$$

endowed with the projection $\pi_G : \mathcal{G} \rightarrow X$, $\pi_G(u) := \eta(u)$.

By recalling the definition of spectral fibre, we obtain an isomorphism $\pi_G^{-1}(x) \simeq G^x$ for every $x \in X$. We denote by

$$SG := \{g \in \mathbf{U}\mathcal{E} : g_x \in G \forall x \in X\} \quad (4.21)$$

the closed group of elements of $\mathbf{U}\mathcal{E}$ which are continuous sections of \mathcal{G} . Since $G_x \subseteq G^x$, $x \in X$, it is clear that

$$G \subseteq SG.$$

Note that there is a simple criterion to determine whether some $g \in \mathbf{U}\mathcal{E}$ is an element of SG : it suffices in fact to verify that $g_x \in G^x$ for every $x \in X$.

Example 4.2. We consider a closed group $G_0 \subseteq \mathbb{U}(d)$, acting on the trivial bundle $\mathcal{E} := X \times H$ by the natural action $v \mapsto gv$, $g \in G_0$, $v \in \mathcal{E}_x \simeq H$. Note that $(\mathcal{E}^r, \mathcal{E}^s) = C(X) \otimes (H^r, H^s)$, $r, s \in \mathbb{N}$, and $\mathcal{O}_{\mathcal{E}} = C(X) \otimes \mathcal{O}_d$. Let $G \subset \mathbf{U}\mathcal{E} = C(X, \mathbb{U}(d))$ be the group of G_0 -valued, constant maps, and $C(X, G_0)$ the group of continuous maps from X into G_0 . It is clear that $C(X, G_0)$ is a closed group of $\mathbf{U}\mathcal{E}$, and it is easily verified that

$$(\mathcal{E}^r, \mathcal{E}^s)_G = (\mathcal{E}^r, \mathcal{E}^s)_{C(X, G_0)} = C(X) \otimes (H^r, H^s)_{G_0}.$$

Thus $\mathcal{O}_G \simeq C(X) \otimes \mathcal{O}_{G_0}$; the spectral bundle associated with G is $\mathcal{G} = X \times G_0$, with $SG = C(X, G_0)$.

In analogy with [12, Cor.3.3], the following result allows the reconstruction of the spectral bundle of G from the triple $(\mathcal{O}_G, \sigma_G, \mathcal{E})$ and thus, because of the amenability, from the dual \widehat{G} . We denote by $\mathbf{aut}_{\mathcal{O}_G} \mathcal{O}_{\mathcal{E}}$ the group of automorphisms of $\mathcal{O}_{\mathcal{E}}$ coinciding with the identity on \mathcal{O}_G , i.e. the stabilizer of \mathcal{O}_G in $\mathcal{O}_{\mathcal{E}}$.

Proposition 4.8. For every closed group $G \subseteq \mathbf{U}\mathcal{E}$ there is a natural isomorphism $SG \simeq \mathbf{aut}_{\mathcal{O}_G} \mathcal{O}_{\mathcal{E}}$, where SG is the group of continuous sections of the spectral bundle $\mathcal{G} \rightarrow X$. The duality map $\{\mathcal{G} \mapsto \widehat{G}\}$ is injective.

Proof. By definition it is clear that there is an immersion $SG \hookrightarrow \mathbf{aut}_{\mathcal{O}_G} \mathcal{O}_{\mathcal{E}}$, $g \mapsto \widehat{g}$. Viceversa, let $\alpha \in \mathbf{aut}_{\mathcal{O}_G} \mathcal{O}_{\mathcal{E}}$. Then for $\psi, \psi' \in \widehat{\mathcal{E}}$ we find $\psi^* \alpha(\psi)y = \psi^* \alpha(\psi y) = \psi^* \sigma(y) \alpha(\psi) = y \psi^* \alpha(\psi)$ for every $y \in \mathcal{O}_G$, so that by Prop.4.1 $\psi^* \alpha(\psi)$ belongs to $C(X)$ and $\alpha = \widehat{g}$ for some $g \in \mathbf{U}\mathcal{E}$. In order to prove that $g \in SG$ it suffices to verify, for every $x \in X$, that g_x belongs to the spectral fibre G^x : $\widehat{g}(y) = y \Rightarrow (\widehat{g}(y))_x = \widehat{g}_x(y_x) = y_x$, $y \in \mathcal{O}_G$. Since $(\mathcal{O}_G)_x = \mathcal{O}_{G^x}$, we find $g_x \in G^x$. Finally, let G, G' such that $\widehat{G} = \widehat{G'}$. Then $\mathcal{O}_G = \mathcal{O}_{G'}$, and $G^x = G'^x \simeq \mathbf{aut}_{(\mathcal{O}_G)_x} \mathcal{O}_d$, for every $x \in X$. Thus $\mathcal{G} = \mathcal{G'}$. \square

The fact we recover SG instead of G in Prop.4.8 is an example of the absence of the Galois property remarked in [3, §7]. A crucial point to get the injectivity of the duality map $\{\mathcal{G} \mapsto \widehat{G}\}$ is that the vector bundle \mathcal{E} has to be fixed; counterexamples will be given in the sequel (Cor.4.18).

Corollary 4.9. Let $G, G' \subseteq \mathbf{U}\mathcal{E}$ with $G = SG$, $G' = SG'$. Suppose there exists an automorphism α of $\mathcal{O}_{\mathcal{E}}$ with $\alpha(\sigma^r, \sigma^s) = (\sigma^r, \sigma^s)$ for $r, s \in \mathbb{N}$, and such that $\alpha(\mathcal{O}_G) = \mathcal{O}_{G'}$. Then G and G' are conjugate, i.e. there exists $u \in \mathbf{U}\mathcal{E}$ such that $G' = uGu^*$.

Proof. Since $\alpha(\sigma^r, \sigma^s) = (\sigma^r, \sigma^s)$, by amenability we find $\alpha(\iota, \mathcal{E}) = (\iota, \mathcal{E})$, thus $\alpha = \widehat{u}$, $u \in \mathbf{UE}$. Let now $\widehat{g} \in \mathbf{aut}_{\mathcal{O}_G} \mathcal{O}_{\mathcal{E}} \simeq G$, $\psi \in (\iota, \mathcal{E})_{G'}$. Since $\alpha^{-1}(\psi) = u^*\psi \in (\iota, \mathcal{E})_G$, we find $ugu^*\psi = \psi$; by the same argument, $(ugu^*)^\sim$ is the identity on $(\mathcal{E}^r, \mathcal{E}^s)_{G'}$. Thus, $(ugu^*)^\sim \in \mathbf{aut}_{\mathcal{O}_{G'}} \mathcal{O}_{\mathcal{E}} \simeq G'$. By exchanging the role of G, G' we obtain the desired equality $G' = uGu^*$. \square

Lemma 4.10. *Let $G \subseteq \mathbf{UE}$ be a closed group. Then $\widehat{G} = \widehat{G'}$ for every closed group $G' \subseteq \mathbf{UE}$ such that $\mathcal{G} = \mathcal{G'}$. In particular, $\widehat{G} = \widehat{SG}$ and $\mathcal{O}_G = \mathcal{O}_{SG}$.*

Proof. If $y \in (\mathcal{E}^r, \mathcal{E}^s)_G$, then $y_x \in (\mathcal{O}_G)_x$ for every $x \in X$, thus by Cor.4.6 y_x is G^x -invariant. Let now $g \in SG$; since $g_x \in G^x$ for every $x \in X$ we find $(\widehat{g}(y))_x = \widehat{g}_x(y_x) = y_x$, and $\widehat{g}(y) = y$. Now, if G' has the same spectral bundle as G then $g'_x \in G^x$ for every $g' \in G'$, thus $\widehat{g'}(y) = y$. So that, we proved that $(\mathcal{E}^r, \mathcal{E}^s)_G \subseteq (\mathcal{E}^r, \mathcal{E}^s)_{G'}$. By exchanging the role of G, G' we obtain $(\mathcal{E}^r, \mathcal{E}^s)_G = (\mathcal{E}^r, \mathcal{E}^s)_{G'}$. \square

Example 4.3. *Referring to Example 4.1, it is clear that $G \neq C(X, \mathbb{U}(d))$; anyway, the spectral bundle of G is $X \times \mathbb{U}(d)$, and $\widehat{G} = C(X, \mathbb{U}(d))^\sim$.*

We now study some topological properties of spectral bundles, and investigate how the structure of the algebras \mathcal{O}_G reflects such properties. According to (4.4), if $\pi_U : \mathcal{E}|_U \rightarrow U \times H$ is a local chart for \mathcal{E} , we use the notation $\eta_U : \mathcal{UE}|_U \rightarrow U \times \mathbb{U}(d)$ for the corresponding local chart induced on the unitary bundle.

Definition 4.11. *Let $G \subseteq \mathbf{UE}$ be a closed group. A **local chart for the spectral bundle** \mathcal{G} is given by a local chart $\pi_U : \mathcal{E}|_U \rightarrow U \times H$ such that $\eta_U(\mathcal{G}|_U) = U \times G_0$, where $G_0 \subseteq \mathbb{U}(d)$ is a closed group.*

Given a local chart π_U for \mathcal{G} , it is clear that the restriction map $\pi_U^{1,1} : \mathbf{UE} \rightarrow C(U, \mathbb{U}(d))$ restricts to a map $\pi_U^{1,1} : SG \rightarrow C(U, G_0)$.

We say that the spectral bundle $\mathcal{G} \rightarrow X$ is *locally trivial* if for every $x \in X$ there is a neighborhood $U \ni x$ defining a local chart for \mathcal{G} . If we can pick $U = X$, then we say that \mathcal{G} is *trivial*. A subgroup G of \mathbf{UE} does not define locally trivial spectral bundles in general (see Ex.4.5 below). *In order for a more concise terminology, in the sequel we will say that G is locally trivial if and only if the spectral bundle $\mathcal{G} \rightarrow X$ is locally trivial.* If X is connected, the local triviality implies that the isomorphism class of the spectral fibres is constant, so that there is $G_0 \subseteq \mathbb{U}(d)$ and an open trivializing cover $\{U_i\}$ such that $\mathcal{G}|_{U_i} \simeq U_i \times G_0$. Thus, the elements of SG can be described in terms of continuous maps $g_i : U_i \rightarrow G_0$ satisfying the cocycle relations $u_{ij}g_j = g_iu_{ij}$, where $u_{ij} : U_i \cap U_j \rightarrow \mathbb{U}(d)$ are transition maps for \mathcal{E} . If \mathcal{G} is trivial, then there is an isomorphism $SG \simeq C(X, G_0)$.

Locally trivial group bundles of the type above have been studied in the setting of a generalized equivariant K -theory in [26].

Example 4.4. Let $\mathcal{E} \rightarrow X$ be a vector bundle. Then the spectral bundle associated with $\mathbf{U}\mathcal{E}$ is the unitary bundle $\mathcal{U}\mathcal{E}$. In the same way, the spectral bundle associated with $\mathbf{SU}\mathcal{E}$ is the special unitary bundle $\mathcal{SU}\mathcal{E}$. These bundles are locally trivial, and are trivial if and only if \mathcal{E} is the tensor product of a trivial bundle with a line bundle.

Example 4.5. Let $X := [0, 2]$, $\mathcal{E} := X \times H$, $G_0 \subset \mathbb{SU}(d)$ be a closed group. We fix $\omega \in (0, 1)$ and consider the group

$$G = \{g \in C(X, \mathbb{SU}(d)) : g_x \in G_0, x \in [0, \omega]\} \subset \mathbf{SU}\mathcal{E}.$$

Since \mathcal{E} is trivial, we find $\mathcal{O}_{\mathcal{E}} \simeq C(X) \otimes \mathcal{O}_d$. If $t \in \mathcal{O}_G \subset \mathcal{O}_{\mathcal{E}}$, we find that $t_x \in \mathcal{O}_d$ is $\mathbb{SU}(d)$ -invariant for every $x \in (\omega, 2]$, i.e. $t_x \in \mathcal{O}_{\mathbb{SU}(d)}$. The map $\{X \ni x \mapsto t_x \in \mathcal{O}_d\}$ being continuous, we obtain that t_ω is norm limit of elements of $\mathcal{O}_{\mathbb{SU}(d)}$, thus $t_\omega \in \mathcal{O}_{\mathbb{SU}(d)}$. This fact implies that $(\mathcal{O}_G)_\omega = \mathcal{O}_{\mathbb{SU}(d)}$, so that $G^\omega = \mathbb{SU}(d)$. Thus,

$$\mathcal{G} = ([0, \omega] \times G_0) \sqcup ([\omega, 2] \times \mathbb{SU}(d))$$

is not locally trivial. This also implies that $(\mathcal{E}^r, \mathcal{E}^s)_G$, $r, s \in \mathbb{N}$, is not the bimodule of continuous sections of a vector bundle: in fact, the Banach bundle associated with $(\mathcal{E}^r, \mathcal{E}^s)_G$ has fibre $(H^r, H^s)_{G_0}$ for $x < \omega$, while for $x \geq \omega$ the fibre is $(H^r, H^s)_{\mathbb{SU}(d)}$. Note that $G_\omega = G_0$ is strictly contained in $G^\omega = \mathbb{SU}(d)$. If $g \in SG$ then $g_x \in G_0$ for every $x \in [0, \omega]$; thus, G_0 being closed, by continuity we obtain $g_\omega \in G_0$. We conclude that $g \in G$, so that $G = SG$.

Example 4.6. Let S^1 denote the circle, and $X := S^1 \times S^1$. Note that there is a standard closed cover $X = C_1 \cup C_2$, where C_1, C_2 are homeomorphic to the cylinder $[0, 1] \times S^1$, and $Y := C_1 \cap C_2$ is the disjoint union $S^1 \sqcup S^1$. Let $\mathcal{E} \rightarrow X$ be a rank d vector bundle, $d > 1$. Since C_i , $i = 1, 2$, is homotopic to S^1 , we find that $\mathcal{E}|_{C_i}$ is trivial, so that \mathcal{E} is described by a transition map $u : Y \rightarrow \mathbb{U}(d)$. An element $g \in \mathbf{SU}\mathcal{E}$ is described by a pair of continuous maps $g_i : C_i \rightarrow \mathbb{SU}(d)$, $i = 1, 2$, satisfying the cocycle relation $g_2 = \text{adu}(g_1) := ug_1u^*$. Let $G_0 \subseteq \mathbb{SU}(d)$ be a closed subgroup, $G := \{g \in \mathbf{SU}\mathcal{E} : g_2(x) \in G_0, x \in C_2\}$; then the spectral bundle \mathcal{G} is obtained by clutching the trivial bundles $C_1 \times \mathbb{SU}(d)$, $C_2 \times G_0$ via the transition map $\text{adu} : Y \rightarrow \mathbb{U}(d)/\mathbb{T}$. It is clear that \mathcal{G} is not locally trivial.

Lemma 4.12. If the spectral bundle $\mathcal{G} \rightarrow X$ is trivial, then there is a compact Lie group $G_0 \subseteq \mathbb{U}(d)$ acting on \mathcal{E} , in a such way that $(\mathcal{E}^r, \mathcal{E}^s)_G = (\mathcal{E}^r, \mathcal{E}^s)_{G_0}$, $r, s \in \mathbb{N}$. If G is locally trivial with spectral fibre G_0 , then for every $x \in X$ there is a neighborhood $U \ni x$ such that $(\mathcal{E}^r, \mathcal{E}^s)_{G|U} = (\mathcal{E}^r|_U, \mathcal{E}^s|_U)_{G_0}$, $r, s \in \mathbb{N}$.

Proof. Let G_0 be the spectral fibre of \mathcal{G} . Then $\mathcal{G} \simeq X \times G_0$, and there is an isomorphism $SG \simeq C(X, G_0)$. Thus \mathcal{G} can be associated with the group of constant G_0 -valued sections (see Ex.4.2). The second assertion follows trivially from the first one, by considering local charts $\mathcal{G}|_U \simeq U \times G_0$, $U \subseteq X$. \square

Definition 4.13. Let $G \subseteq \mathbf{UE}$ be a closed group, $U \subseteq X$ a closed set with nonempty interior. A **local chart for the pair** $(\mathcal{O}_\mathcal{E}, \mathcal{O}_G)$ is given by

- a local chart $\alpha_U : \mathcal{O}_\mathcal{E}|_U \rightarrow C(U) \otimes \mathcal{O}_d$, such that

$$\alpha_U(\mathcal{E}^r, \mathcal{E}^s)|_U = C(U) \otimes (H^r, H^s), \quad r, s \in \mathbb{N};$$

- a closed group $G_0 \subseteq \mathbb{U}(d)$, such that $\alpha_U(\mathcal{O}_G|_U) = C(U) \otimes \mathcal{O}_{G_0}$.

Note that if α_U is a local chart for $(\mathcal{O}_\mathcal{E}, \mathcal{O}_G)$, then $\alpha_U(\mathcal{E}^r, \mathcal{E}^s)_G|_U = C(U) \otimes (H^r, H^s)_{G_0}$, $r, s \in \mathbb{N}$. Thus α_U 'trivializes' the Banach bimodules $(\mathcal{E}^r, \mathcal{E}^s)_G$, i.e. the spaces of arrows of \widehat{G} . The pair $(\mathcal{O}_\mathcal{E}, \mathcal{O}_G)$ is said *locally trivial* if for every $x \in X$ there is a closed $U \ni x$ with nonempty interior carrying a local chart for $(\mathcal{O}_\mathcal{E}, \mathcal{O}_G)$.

Proposition 4.14. Let X be connected, $G \subseteq \mathbf{UE}$ a closed group. Then, the pair $(\mathcal{O}_\mathcal{E}, \mathcal{O}_G)$ is locally trivial if and only if G is locally trivial. In such a case, there is a closed group $G_0 \subseteq \mathbb{U}(d)$ such that, for every $x \in X$,

$$(\mathcal{O}_G)_x \simeq \mathcal{O}_{G_0}, \quad G^x \simeq G_0. \quad (4.22)$$

Proof. Let $\pi_U : \mathcal{E}|_U \rightarrow U \times H$ be a local chart for \mathcal{G} , with the induced restriction morphism $\pi_U^{1,1} : SG \rightarrow C(U, G_0)$. We now construct a local chart for $(\mathcal{O}_\mathcal{E}, \mathcal{O}_G)$. Let

$$\alpha_U : \mathcal{O}_\mathcal{E}|_U \rightarrow C(U) \otimes \mathcal{O}_d,$$

be the local chart defined by (4.3); we now verify that α_U restricts to a local chart for \mathcal{O}_G . Let $g_0 \in G_0$; with an abuse of notation, we denote by g_0 the constant map $\{U \ni x \mapsto g_0\}$. It is clear that g_0 is a continuous (constant) section of $U \times G_0$. Since there is a bundle isomorphism $U \times G_0 \simeq \mathcal{G}|_U$, there is a continuous section $g_U : U \rightarrow \mathcal{G}|_U$ such that

$$\pi_U^{1,1}(g_U) = g_0.$$

Since $(g_U)_x \in G^x$, $x \in U$, we find that $\widehat{g}_U(y_U) = y_U$ for every $y_U \in \mathcal{O}_G|_U$. Moreover, since $\alpha_U(g_U) = \pi_U^{1,1}(g_U) = g_0$, it is clear that

$$\alpha_U \circ \widehat{g}_U = \widehat{g}_0 \circ \alpha_U. \quad (4.23)$$

The previous equality implies that $\alpha_U(\mathcal{O}_G|_U)$ is the fixed-point algebra of $C(U) \otimes \mathcal{O}_d$ w.r.t. the action by automorphisms of the type \widehat{g}_0 , $g_0 \in G_0$, thus $\alpha_U(\mathcal{O}_G|_U) = C(U) \otimes \mathcal{O}_{G_0}$ (see Ex.4.2).

Let now α_U be a local chart for $(\mathcal{O}_\mathcal{E}, \mathcal{O}_G)$; we denote by $\alpha_x \in \mathbf{aut} \mathcal{O}_d$, $x \in X$ the automorphism induced by the evaluation of α_U over each fibre $x \in U$, so that there is a commutative diagram

$$\begin{array}{ccc} \mathcal{O}_\mathcal{E}|_U & \xrightarrow{\alpha_U} & C(U) \otimes \mathcal{O}_d \\ \downarrow & & \downarrow \\ \mathcal{O}_d & \xrightarrow{\alpha_x} & \mathcal{O}_d \end{array}$$

where the vertical arrows are the evaluation epimorphisms over the fibres. Since $\alpha_U(\iota, \mathcal{E})|_U = C(U) \otimes H$, the Serre-Swan equivalence implies that there is a local chart $\pi_U : \mathcal{E}|_U \rightarrow U \times H$. Now, the local chart π_U induces a local chart $\eta_U : \mathcal{UE}|_U \rightarrow U \times \mathbb{U}(d)$; in order to prove the proposition, we verify that η_U restricts to a map from \mathcal{G} onto $U \times G_0$. Let $g \in \mathbf{UE}$ with $g_x \in G^x \subseteq \mathcal{UE}$, $(x, g'_x) := \eta_U(g_x) \in U \times \mathbb{U}(d)$. We verify that $g'_x \in G_0$. For this purpose, note that if $t \in (\mathcal{E}^r, \mathcal{E}^s)$ then, with the same argument as (4.23) and by recalling (4.5),

$$(\alpha_U \circ \widehat{g}(t))_x = \alpha_x \circ \widehat{g}_x(t_x) = \widehat{g}'_x \circ \alpha_x(t_x) \quad .$$

From the previous equalities, it follows that $t_x \in (\mathcal{O}_G)_x$ (i.e., $\alpha_x(t_x) \in \mathcal{O}_{G_0}$) if and only if $\widehat{g}'_x \in G_0$. Thus, the proposition is proved. \square

4.4 The cases $G = \mathbf{UE}$, $G = \mathbf{SUE}$.

Proposition 4.15. *$\mathcal{O}_{\mathbf{UE}}$ is the σ -stable C^* -subalgebra of $\mathcal{O}_{\mathcal{E}}$ generated by θ and $C(X)$, and is isomorphic to $C(X) \otimes \mathcal{O}_{\mathbb{U}(d)}$.*

Proof. Let $\theta_d \in \mathcal{O}_{\mathbb{U}(d)}$ denote the exchange operator on $H \otimes H$, σ_d the canonical endomorphism on $\mathcal{O}_{\mathbb{U}(d)}$. By [12, Lemma 3.6] it follows that $C(X) \otimes \mathcal{O}_{\mathbb{U}(d)}$ is generated as a C^* -algebra by $C(X)$, $1 \otimes \theta_d$, and by closing w.r.t. the action of $\iota \otimes \sigma_d$ (here ι denotes the identity automorphism on $C(X)$). Let $\{U_i\}$ be a closed trivializing cover for \mathcal{E} , with local charts $\pi_{U_i} : \mathcal{E}|_{U_i} \rightarrow U_i \times H$; we denote by $\{u_{ij} := \pi_i \circ \pi_j^{-1} : X_i \cap X_j \rightarrow \mathbb{U}(d)\}$ the associated set of transition maps. By (4.3), local charts

$$\alpha_{U_i} : \mathcal{O}_{\mathcal{E}}|_{U_i} \rightarrow C(U_i) \otimes \mathcal{O}_d \quad (4.24)$$

are induced, in such a way that the cocycle associated with $\mathcal{O}_{\mathcal{E}}$ as a C^* -algebra bundle is given by $\{\widehat{u}_{ij} : X_i \cap X_j \rightarrow \mathbf{aut} \mathcal{O}_d\}$ (see [34, §4]). Since a local chart for \mathcal{UE} is induced by every π_{U_i} , it follows from Prop.4.14 that (4.24) restricts to a local chart $\beta_{U_i} : \mathcal{O}_{\mathbf{UE}}|_{U_i} \rightarrow C(U_i) \otimes \mathcal{O}_{\mathbb{U}(d)}$. Thus, the lemma will be proved if every transition map

$$\beta_{ij} := \beta_{U_i} \circ \beta_{U_j}^{-1} \in \mathbf{aut}(C(U_i \cap U_j) \otimes \mathcal{O}_{\mathbb{U}(d)})$$

reduces to the identity. Now, it is clear that β_{ij} is the restriction of \widehat{u}_{ij} to $C(U_i \cap U_j) \otimes \mathcal{O}_{\mathbb{U}(d)}$; since θ_d is $\mathbb{U}(d)$ -invariant, we find $\beta_{ij}(1 \otimes \theta_d) = \widehat{u}_{ij}(1 \otimes \theta_d) = 1 \otimes \theta_d$; furthermore, $\beta_{ij} \circ (\iota \otimes \sigma_d) = \widehat{u}_{ij} \circ (\iota \otimes \sigma_d) = (\iota \otimes \sigma_d) \circ \widehat{u}_{ij} = (\iota \otimes \sigma_d) \circ \beta_{ij}$. Thus, by evaluating β_{ij} over products of elements of the type $(\iota \otimes \sigma_d^r)(1 \otimes \theta_d)$, $r \in \mathbb{N}$, we conclude that β_{ij} is the identity automorphism, and the lemma is proved. In particular, for every $r \in \mathbb{N}$ there is an isomorphism $(\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{UE}} \simeq (H^r, H^r)_{\mathbb{U}(d)} \otimes C(X)$, while for $r \neq s$ we find $(\mathcal{E}^r, \mathcal{E}^s)_{\mathbf{UE}} = \{0\}$ (see [12, Lemma 3.6]). \square

Corollary 4.16. *Let $\mathcal{E}, \mathcal{E}' \rightarrow X$ be rank d vector bundles. Then*

$$(\mathcal{E}^r, \mathcal{E}^s)_{\mathbf{UE}} \simeq \delta_{r,s} \cdot [(H^r, H^s)_{\mathbb{U}(d)} \otimes C(X)] \quad ,$$

where $\delta_{r,s}$ is the Kroneker symbol. There is an isomorphism of tensor C^* -categories $\widehat{\mathbf{U}\mathcal{E}} \simeq \widehat{\mathbf{U}\mathcal{E}'}$ if and only if $\mathcal{E}, \mathcal{E}'$ have the same rank.

The previous lemma implies that the C^* -algebra $\mathcal{O}_{\mathbf{U}\mathcal{E}}$ does not maintain geometrical informations about \mathcal{E} , except for the rank. By restricting the group we can recover some geometrical data, as for example the first Chern class in the case of $\mathbf{SU}\mathcal{E}$. We are going to prove this fact. Let us consider the following endomorphism on $\mathcal{O}_{\mathbf{U}\mathcal{E}}$, defined by the shift

$$\rho(y) := P \otimes y, \quad (4.25)$$

where P is the totally antisymmetric projection (4.12, 4.17) and $y \in (\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{U}\mathcal{E}}$. Note that the relation $\rho(y) = P \cdot \sigma_{\mathbf{U}\mathcal{E}}^d(y)$ holds for $y \in \mathcal{O}_{\mathbf{U}\mathcal{E}}$.

Let $k \in \mathbb{N}$; we denote by $\lambda\mathcal{E}^k$ the tensor power of $\lambda\mathcal{E}$ iterated k times. For $k < 0$ we define $\lambda\mathcal{E}^k := [(\lambda\mathcal{E})^*]^{-k}$, where $(\lambda\mathcal{E})^*$ is the dual bundle of $\lambda\mathcal{E}$. Note that $(\iota, \lambda\mathcal{E}^k) = (\lambda\mathcal{E}^{-k}, \iota)$ for every $k \in \mathbb{Z}$. We denote by \otimes_X the internal tensor product of Hilbert $C(X)$ -bimodules.

Proposition 4.17. $\mathcal{O}_{\mathbf{SU}\mathcal{E}}$ is the σ -stable C^* -subalgebra of $\mathcal{O}_{\mathcal{E}}$ generated by θ and $(\iota, \lambda\mathcal{E})$, and is isomorphic to the crossed product $\mathcal{O}_{\mathbf{U}\mathcal{E}} \rtimes_{\rho}^{\lambda\mathcal{E}} \mathbb{N}$.

Proof. By [12, Lemma 3.7] we find

$$(H^r, H^s)_{\mathbf{SU}(d)} = \delta_{r-s, dk} \cdot (H^r, H^r)_{\mathbf{U}(d)} \cdot R^k$$

where $\delta_{i,j}$ is the Kroneker symbol, $R \in (\iota, H^d)$ is the totally antisymmetric isometry (4.8), and k is a positive integer (since $(\mathcal{E}^r, \mathcal{E}^s) = (\mathcal{E}^s, \mathcal{E}^r)^*$, it suffices to consider the case $k \geq 0$). Thus, by local triviality we conclude that $(\mathcal{E}^r, \mathcal{E}^s)_{\mathbf{SU}\mathcal{E}} \neq \{0\}$ if and only if $r - s = kd$, $k \in \mathbb{Z}$. In particular, $(\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{SU}\mathcal{E}} = (\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{U}\mathcal{E}}$, $r \in \mathbb{N}$. Let now $\{R_i\}$ be the set of generators of $\lambda\mathcal{E}$; then $\sum_i R_i^* R_i = 1$, so that $\sum_I R_I^* R_I = 1$, where $R_I := R_{i_1} \cdots R_{i_k} \in (\iota, \mathcal{E}^{dk})$, $k \in \mathbb{N}$. Let $y \in (\mathcal{E}^r, \mathcal{E}^{r+kd})_{\mathbf{SU}\mathcal{E}}$, $k > 0$; then $y = \sum_I (y R_I^*) R_I$, with $(y R_I^*) \in (\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{SU}\mathcal{E}} = (\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{U}\mathcal{E}}$. The previous argument implies that

$$(\mathcal{E}^r, \mathcal{E}^{r+kd})_{\mathbf{SU}\mathcal{E}} = (\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{SU}\mathcal{E}} \cdot (\iota, \lambda\mathcal{E}^k), \quad k \in \mathbb{Z}.$$

Thus, we have proved that $\mathcal{O}_{\mathbf{SU}\mathcal{E}}$ is generated as a C^* -algebra by $\mathcal{O}_{\mathbf{U}\mathcal{E}}$ and $(\iota, \lambda\mathcal{E})$. Furthermore, we have $Ry = P \otimes y \cdot R \otimes 1 = \rho(y)R$, $R \in (\iota, \lambda\mathcal{E})$, $y \in (\mathcal{E}^r, \mathcal{E}^s)_{\mathbf{SU}\mathcal{E}}$, so that ρ is inner in $\mathcal{O}_{\mathbf{SU}\mathcal{E}}$, induced by $(\iota, \lambda\mathcal{E})$. In order to prove the lemma, we have to verify the universal property w.r.t. covariant representations $(\pi : \mathcal{O}_{\mathbf{U}\mathcal{E}} \rightarrow L(\mathcal{M}_\pi), \widehat{\lambda\mathcal{E}}_\pi)$. Let $\{\psi \mapsto \psi_\pi\}$, $\psi \in (\iota, \lambda\mathcal{E})$, $\psi_\pi \in \widehat{\lambda\mathcal{E}}_\pi$ denote the isomorphism between $(\iota, \lambda\mathcal{E}) \subset \mathcal{O}_{\mathbf{SU}\mathcal{E}}$ and $\widehat{\lambda\mathcal{E}}_\pi \subset L(\mathcal{M}_\pi)$. Since

$$(\lambda\mathcal{E}, \lambda\mathcal{E}) = P \cdot (\mathcal{E}^d, \mathcal{E}^d)_{\mathbf{U}\mathcal{E}} \cdot P = C(X) \cdot P,$$

for every $\psi, \psi' \in \lambda\mathcal{E}$ there is $f_{\psi, \psi'} \in C(X)$ such that $\psi' \psi^* = f_{\psi, \psi'} P$. Furthermore, $\langle \psi, \psi' \rangle = \psi^* \psi' = \psi_\pi^* \psi'_\pi \in C(X)$. Now, $\psi' \psi^* \in \mathcal{O}_{\mathbf{U}\mathcal{E}}$, so that if

$\varphi \in (\iota, \lambda\mathcal{E})$ then

$$\begin{aligned}\pi(\psi'\psi^*)\varphi_\pi &= f_{\psi,\psi'}\pi(P)\varphi_\pi \\ &= f_{\psi,\psi'}\varphi_\pi = (f_{\psi,\psi'}\varphi)_\pi = \\ &= \psi'_\pi(\psi^*\varphi) = \psi'_\pi(\psi^*\varphi_\pi) .\end{aligned}\tag{4.26}$$

Let $\{R_{i,\pi}\} \subset \widehat{\lambda\mathcal{E}}_\pi$, $\sum_i R_{i,\pi}R_{i,\pi}^* = \pi(P)$, be a set of generators for $\widehat{\lambda\mathcal{E}}_\pi$. Then (4.26) implies

$$\pi(\psi'\psi^*) = \pi(\psi'\psi^*)\pi(P) = \sum_i \pi(\psi'\psi^*)R_{i,\pi}R_{i,\pi}^* = \sum_i \psi'_\pi\psi_\pi^*R_{i,\pi}R_{i,\pi}^* ,$$

so that $\pi(\psi'\psi^*) = \psi'_\pi\psi_\pi^*$. Thus, we define the $C(X)$ -morphism

$$\Pi : \mathcal{O}_{\mathbf{SU}\mathcal{E}} \rightarrow L(\mathcal{M}_\pi) , \quad \Pi(t\varphi) := \pi(t)\varphi_\pi ,$$

$t \in \mathcal{O}_{\mathbf{U}\mathcal{E}}$, $\varphi \in (\iota, \lambda\mathcal{E})$. The previous remarks imply that Π extends π as desired. \square

Corollary 4.18. *Let $\mathcal{E}, \mathcal{E}' \rightarrow X$ be rank d vector bundles. Then*

$$(\mathcal{E}^r, \mathcal{E}^s)_{\mathbf{SU}\mathcal{E}} \simeq \delta_{r-s, dk} \cdot [(\mathcal{E}^r, \mathcal{E}^r)_{\mathbf{U}\mathcal{E}} \otimes_X (\iota, \lambda\mathcal{E}^k)] ,$$

where $k \in \mathbb{Z}$ and $\delta_{i,j}$ is the Kronecker symbol. So that there is an isomorphism of tensor C^* -categories $\widehat{\mathbf{SU}\mathcal{E}} \simeq \widehat{\mathbf{SU}\mathcal{E}'}$ if and only if $\mathcal{E}, \mathcal{E}'$ have the same rank and first Chern class.

Example 4.7. Let X be a compact Hausdorff space with $H^2(X, \mathbb{Z}) = \mathbb{Z}$, $\mathcal{E} := \mathcal{L} \oplus \mathcal{L}^* \rightarrow X$ a vector bundle, where \mathcal{L}^* denotes the dual of a nontrivial line bundle $\mathcal{L} \rightarrow X$. By construction $(\mathcal{E}, \mathcal{E})$ is nontrivial as a continuous bundle of matrix algebras, in fact \mathcal{E} is not the tensor product of a trivial bundle by a line bundle. So that, $\mathbf{SU}\mathcal{E} \neq C(X, \mathbf{SU}(2))$, in fact $(\mathcal{E}, \mathcal{E})$ is generated as a $C(X)$ -algebra by $\mathbf{SU}\mathcal{E}$. Despite that, by the previous corollary there is an isomorphism of tensor C^* -categories $\widehat{\mathbf{SU}\mathcal{E}} \simeq C(X, \mathbf{SU}(2))^\wedge$: in fact, $\lambda\mathcal{E} = \mathcal{L} \otimes \mathcal{L}^* \simeq X \times \mathbb{C}$, so that the first Chern class of \mathcal{E} vanishes and $(\iota, \lambda\mathcal{E}) \simeq C(X) \cdot R$, where R is defined by (4.8). Thus, $\mathcal{O}_{\mathbf{SU}\mathcal{E}} \simeq C(X) \otimes \mathcal{O}_{\mathbf{SU}(2)}$.

The previous example shows that the injectivity of the duality map (Prop.4.8) is verified only if the embedding into the category of vector bundles is fixed. In fact, here $\widehat{\mathbf{SU}\mathcal{E}}$ is exhibited as a dual of non-isomorphic groups, i.e. $\mathbf{SU}\mathcal{E} \simeq \mathbf{aut}_{\mathcal{O}_{\mathbf{SU}\mathcal{E}}} \mathcal{O}_{\mathcal{E}}$ and $C(X, \mathbf{SU}(2)) \simeq \mathbf{aut}_{\mathcal{O}_{\mathbf{SU}\mathcal{E}}} (C(X) \otimes \mathcal{O}_2)$. The fact we recover different groups depends on the choice of embedding $\widehat{\mathbf{SU}\mathcal{E}}$ into the category of tensor powers of $\mathcal{E} := \mathcal{L} \oplus \mathcal{L}^*$ (corresponding to the inclusion $\mathcal{O}_{\mathbf{SU}\mathcal{E}} \hookrightarrow \mathcal{O}_{\mathcal{E}}$), or $X \times \mathbb{C}^2$ (corresponding to $\mathcal{O}_{\mathbf{SU}\mathcal{E}} \hookrightarrow C(X) \otimes \mathcal{O}_2$).

Anyway, in general the spectral fibres $\{G^x\}_{x \in X}$ of a closed group $G \subseteq \mathbf{U}\mathcal{E}$ do not depend on the choice of the vector bundle \mathcal{E}' realizing the embedding $\mathcal{O}_G \hookrightarrow \mathcal{O}_{\mathcal{E}'}$. Thus, different embeddings of \widehat{G} into the category of vector bundles correspond to different topologies over $\bigcup_x G^x$, and define not necessarily isomorphic spectral bundles.

5 Noncommutative Pullbacks.

5.1 Some general properties of Hilbert bimodules.

Let \mathcal{A} be a C^* -algebra, \mathcal{M} a Hilbert \mathcal{A} -bimodule. We consider the Banach \mathcal{A} -bimodules $(\mathcal{M}^r, \mathcal{M}^s)$, $r, s \in \mathbb{N}$, introduced in Sec.2. If \mathcal{A} is unital then $(\mathcal{A}, \mathcal{A}) \simeq \mathcal{A}$, and there is a natural isomorphism $(\mathcal{A}, \mathcal{M}) \simeq \mathcal{M}$. The category \mathcal{M}^\otimes with objects the tensor powers of \mathcal{M} and arrows $(\mathcal{M}^r, \mathcal{M}^s)$ is a semitensor C^* -category in the sense of [11, §2]; roughly speaking, a tensor product is defined on the objects, while on the arrows just the operation of tensoring on the right by the identity arrow is admitted. This structure reflects the well-known fact that in general it is not possible to define in a consistent way the tensor product of right \mathcal{A} -module operators ([5, §13.5]). Anyway, it is also possible to associate with \mathcal{M} a *tensor* C^* -category, having objects the tensor powers of \mathcal{M} , and arrows the sets of \mathcal{A} -bimodule operators *commuting with the left \mathcal{A} -action* :

$$\mathcal{B}(\mathcal{M}^r, \mathcal{M}^s) := \{t \in (\mathcal{M}^r, \mathcal{M}^s) : at = ta, a \in \mathcal{A}\}$$

(see [11, §2] for details: the operation of tensor product makes sense for elements of $\mathcal{B}(\mathcal{M}^r, \mathcal{M}^s)$). Let $\mathcal{O}_{\mathcal{M}}$ denote the C^* -algebra associated with \mathcal{M} (recall that if \mathcal{A} is unital and \mathcal{M} is finitely generated, then $\mathcal{O}_{\mathcal{M}}$ is the CP-algebra of \mathcal{M}). Following [11, §3], we construct the C^* -subalgebra $\mathcal{B}_{\mathcal{M}}$ of $\mathcal{O}_{\mathcal{M}}$ generated by the Banach bimodules $\mathcal{B}(\mathcal{M}^r, \mathcal{M}^s)$. Note that the relations $\mathcal{B}(\mathcal{M}^r, \mathcal{M}^s) = (\mathcal{M}^r, \mathcal{M}^s) \cap \mathcal{A}'$ hold in $\mathcal{O}_{\mathcal{M}}$; in particular, $\mathcal{B}(\mathcal{A}, \mathcal{A}) \simeq M(\mathcal{A}) \cap \mathcal{A}' = ZM(\mathcal{A})$ (the last equality is a classical remark due to Busby). Thus, $\mathcal{B}_{\mathcal{M}} \subseteq \mathcal{A}' \cap \mathcal{O}_{\mathcal{M}}$. The C^* -algebra $\mathcal{B}_{\mathcal{M}}$ is naturally endowed with the canonical endomorphism

$$\tau \in \text{end} \mathcal{B}_{\mathcal{M}} : \tau(t) := 1 \otimes t \in \mathcal{B}(\mathcal{M}^{r+1}, \mathcal{M}^{s+1}) , \quad (5.1)$$

where $t \in \mathcal{B}(\mathcal{M}^r, \mathcal{M}^s)$ and 1 is the identity on \mathcal{M} . Note that in general τ cannot be extended to an endomorphism of $\mathcal{O}_{\mathcal{M}}$, and τ is not the identity on elements of $\mathcal{B}(\mathcal{A}, \mathcal{A})$.

The next lemma allows to compute the relative commutant of \mathcal{A} and $\mathcal{B}_{\mathcal{M}}$ in relevant particular cases. We recall that by construction $\mathcal{O}_{\mathcal{M}}$ ($\mathcal{B}_{\mathcal{M}}$) is endowed with a \mathbb{Z} -grading, arising from the canonical circle action. We say that a C^* -algebra $\mathcal{B} \subseteq \mathcal{O}_{\mathcal{M}}$ is \mathbb{Z} -graded if $\cup_{k \in \mathbb{Z}} (\mathcal{B} \cap \mathcal{O}_{\mathcal{M}}^k)$ is dense in \mathcal{B} .

Lemma 5.1. *Let \mathcal{A} be a unital C^* -algebra, \mathcal{M} a Hilbert \mathcal{A} -bimodule, $\mathcal{B} \subseteq \mathcal{B}_{\mathcal{M}}$ a τ -stable, \mathbb{Z} -graded C^* -algebra. Suppose there is an isometry $R \in \mathcal{B}(\mathcal{A}, \mathcal{M}^d) \cap \mathcal{B}$, $d \in \mathbb{N}$, $d > 1$. Then, $\mathcal{B}_{\mathcal{M}} = \mathcal{A}' \cap \mathcal{O}_{\mathcal{M}}$. Furthermore, if there is $\lambda \in (-1, 0) \cup (0, 1)$ such that the equality $R^* \tau(R) = \lambda 1$ holds, then $\mathcal{A} = \mathcal{B}' \cap \mathcal{O}_{\mathcal{M}}$ (and \mathcal{A} is normal in $\mathcal{O}_{\mathcal{M}}$ in the sense of [11, §1]).*

Proof. The first assertion is proven in [11, Prop.3.4]. The second assertion follows from [11, Prop.3.5], by defining the sequence $R_k := \tau^{k-1}(R) \cdots \tau(R)R$. \square

Remark 5.1. Let $\mathcal{A} := C(X)$ be abelian, \mathcal{M} a finitely generated, projective Hilbert $C(X)$ -bimodule. Then, $C(X)$ is a unital C^* -subalgebra of the centre of $\mathcal{B}_{\mathcal{M}}$; moreover, by projectivity there is $n \in \mathbb{N}$ with inclusions of Banach $C(X)$ -bimodules $\mathcal{B}(\mathcal{M}^r, \mathcal{M}^s) \hookrightarrow C(X) \otimes \mathbb{M}_{n^r, n^s}$, $r, s \in \mathbb{N}$. This implies that $\mathcal{B}_{\mathcal{M}}$ is a continuous bundle of C^* -algebras over X . Let $\mathcal{E} \rightarrow X$ be the vector bundle having module of continuous sections isomorphic to \mathcal{M} as a right Hilbert $C(X)$ -module (\mathcal{E} is the so-called **symmetrization** of \mathcal{M} as in [1, Def.1.5]); we denote by σ the canonical endomorphism of $\mathcal{O}_{\mathcal{E}}$. Now, there is an inclusion of C^* -algebra bundles $i : \mathcal{B}_{\mathcal{M}} \hookrightarrow \mathcal{O}_{\mathcal{E}}$; note that in general it is false that $\sigma \circ i = i \circ \tau$: the obstruction is given by the eventuality that $\tau(f) \neq f$ for some $f \in C(X)$.

We now pass to consider group actions over a Hilbert bimodule \mathcal{M} , and the associated C^* -algebra. Let

$$\mathbf{UM} := \{u \in \mathcal{B}(\mathcal{M}, \mathcal{M}) : uu^* = u^*u = 1\} ;$$

then, \mathbf{UM} acts by automorphisms on $\mathcal{O}_{\mathcal{M}}$, by extending the map

$$\psi \mapsto \widehat{u}(\psi) := u\psi \quad , \quad \psi \in \mathcal{M} \quad , \quad u \in \mathbf{UM} \quad (5.2)$$

or, equivalently, by the analogue of (4.5) for elements of $(\mathcal{M}^r, \mathcal{M}^s)$. Note that $\mathcal{B}_{\mathcal{M}}$ is stable w.r.t. the action (5.2). By the same argument used for the action (4.5), the canonical endomorphism τ commutes with \widehat{u} , $u \in \mathbf{UM}$. Since $\mathbf{UM} \subset \mathcal{B}(\mathcal{M}, \mathcal{M})$, we find $\widehat{u}(a) = uau^* = a$, $u \in \mathbf{UM}$, $a \in \mathcal{A}$; thus \mathbf{UM} acts on $\mathcal{O}_{\mathcal{M}}$, $\mathcal{B}_{\mathcal{M}}$ by \mathcal{A} -bimodule automorphisms.

Definition 5.2. Let \mathcal{M} be a Hilbert \mathcal{A} -bimodule, $G \subseteq \mathbf{UM}$ a closed group. We denote by $\widehat{G}_{\mathcal{M}}$ the semitensor C^* -category with objects the tensor powers of \mathcal{M} and arrows the invariant \mathcal{A} -bimodules

$$(\mathcal{M}^r, \mathcal{M}^s)_G := \left\{ t \in (\mathcal{M}^r, \mathcal{M}^s) : t = \widehat{g}(t) := g^{\otimes^s} \cdot t \cdot g^* \otimes^r, g \in G \right\} . \quad (5.3)$$

We denote by $\mathcal{O}_{\mathcal{M}}^G$ the C^* -subalgebra of $\mathcal{O}_{\mathcal{M}}$ generated by the invariant spaces $(\mathcal{M}^r, \mathcal{M}^s)_G$. The following definition encodes a particular class of group actions over Hilbert bimodules.

Definition 5.3. Let \mathcal{A} be a C^* -algebra, \mathcal{M} a Hilbert \mathcal{A} -bimodule. A **tensor G -action** over \mathcal{M} is given by a closed group $G \subseteq \mathbf{UM}$ such that $(\mathcal{M}^r, \mathcal{M}^s)_G \subseteq \mathcal{B}(\mathcal{M}^r, \mathcal{M}^s)$, $r, s \in \mathbb{N}$.

Let $G \subseteq \mathbf{UM}$ be a closed group acting on \mathcal{M} by a tensor action. Then, the following elementary properties hold:

1. the condition $\mathcal{A} \subseteq (\mathcal{A}, \mathcal{A})_G \subseteq \mathcal{B}(\mathcal{A}, \mathcal{A}) = ZM(\mathcal{A})$ forces \mathcal{A} to be an abelian C^* -algebra;
2. since $(\mathcal{M}^r, \mathcal{M}^s)_G \subseteq \mathcal{B}(\mathcal{M}^r, \mathcal{M}^s)$, $r, s \in \mathbb{N}$, we obtain that $\widehat{G}_{\mathcal{M}}$ is a *tensor C^* -category*, and $\mathcal{O}_{\mathcal{M}}^G \subseteq \mathcal{B}_{\mathcal{M}}$;
3. $\mathcal{O}_{\mathcal{M}}^G$ is τ -stable (in fact, $\tau \circ \widehat{u} = \widehat{u} \circ \tau$, $u \in \mathbf{UM}$). We denote by $\tau_G \in \mathbf{end} \mathcal{O}_{\mathcal{M}}^G$ the corresponding restriction.

5.2 Basic properties of noncommutative pullbacks.

As remarked in [3, Rem.6.4], in general a well-defined symmetry in the sense of Doplicher and Roberts fails to exist in \mathcal{M}^\otimes : the exchange operators $\theta(r, s)$ introduced in §4 are well defined as elements of $(\mathcal{M}^{r+s}, \mathcal{M}^{r+s})$ if and only if the left and right \mathcal{A} -module actions coincide, i.e. $a\varphi = \varphi a$, $a \in \mathcal{A}$, $\varphi \in \mathcal{M}$. In fact

$$\theta(r, s)((\psi \otimes \psi')a) = \theta(r, s)(\psi \otimes (\psi'a)) = (\psi'a) \otimes \psi = \psi' \otimes (a\psi) ,$$

while

$$(\theta(r, s)(\psi \otimes \psi'))a = (\psi' \otimes \psi)a = \psi' \otimes (\psi a) ,$$

$\psi \in \mathcal{M}^r$, $\psi' \in \mathcal{M}^s$. We now introduce a class of Hilbert bimodules such that the corresponding semitensor C^* -categories of tensor powers admit a 'maximal' symmetric tensor C^* -subcategory. We start with two preliminary remarks.

Remark 5.2. Let \mathcal{A} be a C^ -algebra, \mathcal{M} a Hilbert \mathcal{A} -bimodule. We introduce the following unital, abelian C^* -algebra:*

$$C(X_{\mathcal{M}}) := \{f \in ZM(\mathcal{A}) : fa\psi a' = a\psi fa', \psi \in \mathcal{M}, a, a' \in \mathcal{A}\} . \quad (5.4)$$

Since the identity of $M(\mathcal{A})$ belongs to $C(X_{\mathcal{M}})$, it is clear that \mathcal{A} is a $C(X_{\mathcal{M}})$ -algebra. In the case in which \mathcal{A} is unital, we find $f \in C(X_{\mathcal{M}}) \Leftrightarrow f\psi = \psi f$, $\psi \in \mathcal{M}$.

Remark 5.3. Let \mathcal{A} be a $C_0(X)$ -algebra, \mathcal{N} a Hilbert $C_0(X)$ -bimodule. Then, the algebraic tensor product $\mathcal{N} \odot_{C_0(X)} \mathcal{A}$ with coefficients in $C_0(X)$ is endowed with a natural \mathcal{A} -valued scalar product $\langle \psi \otimes a, \psi' \otimes a' \rangle := \langle \psi, \psi' \rangle \cdot a^ a'$, $\psi, \psi' \in \mathcal{N}$, $a, a' \in \mathcal{A}$. We denote by $\mathcal{N} \otimes_X \mathcal{A}$ the corresponding completion. $\mathcal{N} \otimes_X \mathcal{A}$ is a right Hilbert \mathcal{A} -module in the natural way.*

Definition 5.4. *Let \mathcal{A} be a $C_0(X)$ -algebra, \mathcal{M} a Hilbert \mathcal{A} -bimodule such that $C_0(X) \subseteq C(X_{\mathcal{M}})$. \mathcal{M} is called a **noncommutative pullback (nc-pullback, in the sequel)** if there is a vector bundle $\mathcal{E} \rightarrow X$ with an isomorphism of right Hilbert \mathcal{A} -modules $\mathcal{M} \simeq \widehat{\mathcal{E}} \otimes_X \mathcal{A}$. \mathcal{M} is said **full** if X is compact and $C(X) = C(X_{\mathcal{M}})$.*

Every nc-pullback is generated as a right Hilbert \mathcal{A} -module by elements of $\widehat{\mathcal{E}}$. By using the formalism of amplimorphisms (in the sense of [13, §1]), nc-pullbacks correspond in the unital case to C^* -algebra morphisms of the type $\phi : \mathcal{A} \rightarrow \mathcal{A} \otimes \mathbb{M}_d$ such that $\phi(1) \in C(X) \otimes \mathbb{M}_d$ and $\phi(f) = \phi(1)f$, $f \in C(X)$. The corresponding module is recovered as $\mathcal{M} := \{\psi \in \mathbb{C}^d \otimes \mathcal{A} : \phi(1)\psi = \psi\}$, with right \mathcal{A} -action given by the scalar multiplication and left \mathcal{A} -action $a, \psi \mapsto \phi(a)\psi$.

Remark 5.4. Let \mathcal{A} be a $C(X)$ -algebra (with $C(X)$ unital), $\mathcal{M} \simeq \widehat{\mathcal{E}} \otimes_X \mathcal{A}$ a nc-pullback. Then, $C(X)$ is a unital C^ -subalgebra of $C(X_{\mathcal{M}})$, so that there is a surjective map $p : X_{\mathcal{M}} \rightarrow X$. We consider the pullback bundle $\mathcal{E}_{\mathcal{M}} := \mathcal{E} \times_X X_{\mathcal{M}} \rightarrow X_{\mathcal{M}}$ (in the sense of [18, I.1.16]), so that $\widehat{\mathcal{E}}_{\mathcal{M}} \simeq \widehat{\mathcal{E}} \otimes_X C(X_{\mathcal{M}})$.*

Now, a natural isomorphism $(\widehat{\mathcal{E}} \otimes_X C(X_{\mathcal{M}})) \otimes_{X_{\mathcal{M}}} \mathcal{A} \simeq \widehat{\mathcal{E}} \otimes_X \mathcal{A}$ of right Hilbert \mathcal{A} -modules is induced by the map $(\psi \otimes f) \otimes a \mapsto \psi \otimes (fa)$, $\psi \in \widehat{\mathcal{E}}$, $f \in C(X_{\mathcal{M}})$, $a \in \mathcal{A}$. Thus, in the case in which $C(X)$ is unital and \mathcal{A} is a $C(X)$ -algebra, every nc-pullback is a full nc-pullback.

Remark 5.5. When X is compact and \mathcal{A} is unital and separable, a nc-pullback \mathcal{M} naturally defines a class $(\mathcal{M}, 0)$ in the KK -theory group $\mathcal{R}KK(X; \mathcal{A}, \mathcal{A})$ (see [21] about the previous notation); thus \mathcal{M} is a central \mathcal{A} -bimodule in the sense of [29]. Let us now denote by $\mathcal{R}KK_f(X; \mathcal{A}, \mathcal{A})$ the group of Kasparov bimodules which are finitely generated as right Hilbert \mathcal{A} -modules. Then, there is a forgetful morphism $\pi : \mathcal{R}KK_f(X; \mathcal{A}, \mathcal{A}) \rightarrow K_0(\mathcal{A})$, defined by assigning to each Kasparov bimodule the corresponding right Hilbert \mathcal{A} -module. If $\mathcal{A} = C(Y)$ is commutative there is a surjective map $p : Y \rightarrow X$, and every vector bundle $\mathcal{E}' \rightarrow Y$ defines a Kasparov bimodule $(\widehat{\mathcal{E}'}, 0) \in \mathcal{R}KK(X; C(Y), C(Y))$. Thus $\pi : \mathcal{R}KK_f(X; C(Y), C(Y)) \rightarrow K^0(Y)$ is an epimorphism. If $\mathcal{E} \rightarrow X$ is a vector bundle, every nc-pullback of the type $\mathcal{M} \simeq \widehat{\mathcal{E}} \otimes_X C(Y)$ defines a class $(\mathcal{M}, 0)$ in $\pi^{-1}[p_*\mathcal{E}]$, where $p_*\mathcal{E} \rightarrow Y$ is the pullback bundle. Thus $\pi^{-1}[p_*\mathcal{E}] \subseteq \mathcal{R}KK_f(X; C(Y), C(Y))$ classifies the nc-pullbacks of \mathcal{E} over $C(Y)$.

Example 5.1. Let \mathcal{M} be a Hilbert \mathcal{A} -bimodule isomorphic as a right Hilbert \mathcal{A} -module to the free module $\mathbb{C}^d \otimes \mathcal{A}$. Then, \mathcal{M} is a nc-pullback of the trivial rank d vector bundle over $X_{\mathcal{M}}$. Bimodules of this type appear in the framework of so-called 'Hilbert C^* -systems' as in [3, 4], and are called algebraic Hilbert spaces. Other examples, given by Hilbert bimodules arising from contractions in compact metric spaces, can be found in [30, §4].

Example 5.2. Let X be a compact Hausdorff space, \mathcal{Z} a unital, abelian $C(X)$ -algebra, $\mathcal{E} \rightarrow X$ a vector bundle, $\rho \in \mathbf{end}_X \mathcal{Z}$ a $C(X)$ -endomorphism. Then, we can define a nc-pullback $\mathcal{M} := \widehat{\mathcal{E}} \otimes_X \mathcal{Z}$, with left \mathcal{Z} -action $z\psi := \psi\rho(z)$, $\psi \in \mathcal{M}$, $z \in \mathcal{Z}$. The case in which ρ is the identity corresponds to the usual notion of pullback of a vector bundle.

Example 5.3. Let \mathcal{A} be a C^* -algebra with identity $1_{\mathcal{A}}$, $E \in C(X) \otimes \mathbb{M}_d$ a projection defining a vector bundle $\mathcal{E} \rightarrow X$. Let \mathcal{B} be the corner $(E \otimes 1_{\mathcal{A}}) \cdot (C(X) \otimes \mathbb{M}_d \otimes \mathcal{A}) \cdot (E \otimes 1_{\mathcal{A}})$. Then, every unital $C(X)$ -morphism $\phi : C(X) \otimes \mathcal{A} \rightarrow \mathcal{B}$ corresponds with a nc-pullback of \mathcal{E} , isomorphic to the external tensor product $\widehat{\mathcal{E}} \otimes \mathcal{A}$ as a right Hilbert $(C(X) \otimes \mathcal{A})$ -module, and defining a natural structure of vector \mathcal{A} -bundle in the sense of [24].

Let X be a compact Hausdorff space, \mathcal{A} a unital $C(X)$ -algebra with identity 1, $\mathcal{M} \simeq \widehat{\mathcal{E}} \otimes_X \mathcal{A}$ a nc-pullback. According to Rem.5.4, we assume that \mathcal{M} is full, so that we identify X with $X_{\mathcal{M}}$. The following elementary properties hold:

1. There is a map $j : \widehat{\mathcal{E}} \rightarrow \mathcal{M}$, $j(\psi) := \psi \otimes 1$. It is clear that $j(\widehat{\mathcal{E}})$ is contained in $\mathcal{M} \equiv (\mathcal{A}, \mathcal{M})$. Thus, $j(\widehat{\mathcal{E}})$ is a finitely generated Hilbert $C(X)$ -bimodule in $\mathcal{O}_{\mathcal{M}}$ with support 1, and is isomorphic to $\widehat{\mathcal{E}}$.

2. By universality of the CP-algebra, j extends to a $C(X)$ -monomorphism $j : \mathcal{O}_{\mathcal{E}} \hookrightarrow \mathcal{O}_{\mathcal{M}}$.
3. The relation $j(\mathcal{E}^r, \mathcal{E}^s) \subset (\mathcal{M}^r, \mathcal{M}^s)$ holds, for every $r, s \in \mathbb{N}$ (in particular, $j(\widehat{\mathcal{E}}) = j(\iota, \mathcal{E}) \subset (\mathcal{A}, \mathcal{M})$). So that, j defines an injective functor $j : \mathcal{E}^{\otimes} \hookrightarrow \mathcal{M}^{\otimes}$ of semitensor C^* -categories. It is clear that j restricts to an isomorphism $j : \mathcal{E}^{\otimes} \rightarrow j(\widehat{\mathcal{E}})^{\otimes}$.
4. By amenability we have $\widehat{\sigma} \simeq \mathcal{E}^{\otimes}$, where $\sigma \in \mathbf{end}\mathcal{O}_{\mathcal{E}}$ is the canonical endomorphism (Prop.4.1); so that, there is an injective functor $j' : \widehat{\sigma} \hookrightarrow \mathcal{M}^{\otimes}$ of semitensor C^* -categories.

Lemma 5.5. *With the above notation, suppose that $\mathcal{B}'_{\mathcal{M}} \cap \mathcal{O}_{\mathcal{M}} = \mathcal{A}$. Then:*

1. $\mathcal{O}_{\mathcal{M}} \cap \mathcal{O}'_{\mathcal{M}} = C(X) \simeq C(X_{\mathcal{M}})$;
2. an inner endomorphism $\sigma_{\mathcal{E}} \in \mathbf{end}\mathcal{O}_{\mathcal{M}}$ is induced by $j(\widehat{\mathcal{E}})$;
3. $\sigma_{\mathcal{E}}(t) = \tau(t)$, $t \in \mathcal{B}_{\mathcal{M}}$;
4. $(\sigma_{\mathcal{E}}^r, \sigma_{\mathcal{E}}^s) = j(\mathcal{E}^r, \mathcal{E}^s) \subset (\mathcal{M}^r, \mathcal{M}^s)$, $r, s \in \mathbb{N}$;
5. there is an isomorphism $\widehat{\sigma} \simeq \widehat{\sigma}_{\mathcal{E}}$ of tensor C^* -categories, and $\sigma_{\mathcal{E}}$ has permutation symmetry.
6. For every $r, s \in \mathbb{N}$, the equality

$$(\mathcal{M}^r, \mathcal{M}^s) = \sigma_{\mathcal{E}}^s(\mathcal{A}) \cdot j(\mathcal{E}^r, \mathcal{E}^s) = j(\mathcal{E}^r, \mathcal{E}^s) \cdot \sigma_{\mathcal{E}}^r(\mathcal{A})$$

holds; i.e., $\{\sigma_{\mathcal{E}}^s(z)t = t\sigma_{\mathcal{E}}^r(a), z \in \mathcal{Z}, t \in j(\mathcal{E}^r, \mathcal{E}^s)\}$ is total in $(\mathcal{M}^r, \mathcal{M}^s)$.

Proof.

1. The elements of $C(X)$ commute with \mathcal{A} and $\mathcal{M} \equiv (\mathcal{A}, \mathcal{M})$ in $\mathcal{O}_{\mathcal{M}}$, thus $C(X) \subseteq \mathcal{O}_{\mathcal{M}} \cap \mathcal{O}'_{\mathcal{M}}$. Viceversa, $\mathcal{O}'_{\mathcal{M}} \cap \mathcal{O}_{\mathcal{M}} \subseteq \mathcal{B}'_{\mathcal{M}} \cap \mathcal{O}_{\mathcal{M}} = \mathcal{A}$, thus $\mathcal{O}'_{\mathcal{M}} \cap \mathcal{O}_{\mathcal{M}} \subseteq \mathcal{A} \cap \mathcal{A}'$; so that, if $f \in \mathcal{O}'_{\mathcal{M}} \cap \mathcal{O}_{\mathcal{M}}$ then $f\psi = \psi f$, $\psi \in \mathcal{M}$, and $f \in C(X)$.
2. $j(\widehat{\mathcal{E}})$ is a finitely generated Hilbert $C(X)$ -bimodule in $\mathcal{O}_{\mathcal{M}}$ with support 1; thus, the inner endomorphism $\sigma_{\mathcal{E}} \in \mathbf{end}\mathcal{O}_{\mathcal{M}}$ induced by $j(\widehat{\mathcal{E}})$ is defined, and the point is proved. Note that $j(\widehat{\mathcal{E}}) = (\iota, \sigma_{\mathcal{E}})$, $j(\widehat{\mathcal{E}})^r := \text{span}\{\psi_1 \cdots \psi_r, \psi_i \in j(\widehat{\mathcal{E}}), i = 1, \dots, r\} = (\iota, \sigma_{\mathcal{E}}^r)$, $r \in \mathbb{N}$.
3. Let $t \in \mathcal{B}(\mathcal{M}^r, \mathcal{M}^s)$, $\psi \in j(\widehat{\mathcal{E}}) \subseteq (\mathcal{A}, \mathcal{M})$. Then, $(\psi \otimes 1_s) \cdot t = \psi \otimes t = (1 \otimes t) \cdot (\psi \otimes 1_r)$, where 1_r is the identity of $(\mathcal{M}^r, \mathcal{M}^r)$. Thus, the relation $\psi t = \tau(t)\psi$ holds; on the other hand, by definition $\psi t = \sigma_{\mathcal{E}}(t)\psi$.

4. By definition, $j(\mathcal{E}^r, \mathcal{E}^s) \subseteq (\mathcal{M}^r, \mathcal{M}^s)$ and $j(\iota, \mathcal{E}^r) = j(\widehat{\mathcal{E}})^r$. Now, $j(\mathcal{E}^r, \mathcal{E}^s)$ is generated as a Banach $C(X)$ -bimodule by elements of the type $\psi_L \psi_M^*$, $\psi_L := \psi_{l_1} \cdots \psi_{l_s} \in j(\widehat{\mathcal{E}})^s$, $\psi_M \in j(\widehat{\mathcal{E}})^r$ (see §2). Since $j(\widehat{\mathcal{E}})^r = (\iota, \sigma_{\mathcal{E}}^r)$, we find $j(\mathcal{E}^r, \mathcal{E}^s) \subseteq (\sigma_{\mathcal{E}}^r, \sigma_{\mathcal{E}}^s)$. Viceversa, if $t \in (\sigma_{\mathcal{E}}^r, \sigma_{\mathcal{E}}^s)$ then $t = \sum_{LM} \psi_L t_{LM} \psi_M^*$, where $t_{LM} := \psi_L^* t \psi_M \in (\sigma^s, \iota) \cdot (\sigma_{\mathcal{E}}^r, \sigma_{\mathcal{E}}^s) \cdot (\iota, \sigma_{\mathcal{E}}^r) \subseteq (\iota, \iota) = C(X)$ ($\iota \in \text{end}\mathcal{O}_{\mathcal{M}}$ denotes the identity automorphism). Thus, $t \in j(\mathcal{E}^r, \mathcal{E}^s)$.
5. By the previous point, we find $j(\widehat{\mathcal{E}})^{\otimes} \simeq \widehat{\sigma}_{\mathcal{E}}$. Moreover, by amenability we obtain $\mathcal{E}^{\otimes} \simeq \widehat{\sigma}$. Since $\mathcal{E}^{\otimes} \simeq j(\widehat{\mathcal{E}})^{\otimes}$, we conclude $\widehat{\sigma} \simeq \widehat{\sigma}_{\mathcal{E}}$. Since σ has permutation symmetry (Rem.4.5), we obtain that $\sigma_{\mathcal{E}}$ has permutation symmetry.
6. Since $\sigma_{\mathcal{E}}^r(a) = \sum_M \psi_M a \psi_M^* \in (\mathcal{M}^r, \mathcal{M}^r)$, $a \in \mathcal{A}$, the inclusion $j(\mathcal{E}^r, \mathcal{E}^s) \cdot \sigma_{\mathcal{E}}^r(\mathcal{A}) \subseteq (\mathcal{M}^r, \mathcal{M}^s)$ is proved. Viceversa, if $t \in (\mathcal{M}^r, \mathcal{M}^s)$ then $t = \sum_{LM} \psi_L t_{LM} \psi_M^*$, where $\psi_L \in j(\widehat{\mathcal{E}})^s$, $\psi_M \in j(\widehat{\mathcal{E}})^r$, $t_{LM} := \psi_L^* t \psi_M \in (\mathcal{M}^s, \mathcal{A}) \cdot (\mathcal{M}^r, \mathcal{M}^s) \cdot (\mathcal{A}, \mathcal{M}^r) \subseteq \mathcal{A}$. Note that $\psi_L t_{LM} = \sigma_{\mathcal{E}}^s(t_{LM}) \psi_L$, $t_{LM} \psi_M^* = \psi_M^* \sigma_{\mathcal{E}}^r(t_{LM})$.

□

The next lemma (generalizing the second statement of Lemma 5.1) will be used in the sequel, and allows to compute the relative commutant of certain τ -stable \mathbb{Z} -graded subalgebras of $\mathcal{B}_{\mathcal{M}}$.

Lemma 5.6. *With the above notation, let $\mathcal{B} \subseteq \mathcal{B}_{\mathcal{M}}$ be a τ -stable, \mathbb{Z} -graded C^* -algebra. Suppose there is a finitely generated Hilbert $C(X)$ -bimodule $\mathcal{R} \subseteq j(\iota, \mathcal{E}^d) \cap \mathcal{B}$, $d > 1$, with support $P_{\mathcal{R}}$, such that*

$$\mathcal{R}\mathcal{R}^* := \text{span}\{R'R^* \mid R, R' \in \mathcal{R}\} = C(X) \cdot P_{\mathcal{R}}.$$

Moreover, suppose that for some $\lambda \in (-1, 0) \cup (0, 1)$ the equality $R^ \tau(R') = \lambda R^* R'$ holds for every $R, R' \in \mathcal{R}$. Then $\mathcal{A} = \mathcal{B}' \cap \mathcal{O}_{\mathcal{M}}$.*

Proof. The equality $\mathcal{R}\mathcal{R}^* = C(X) \cdot P_{\mathcal{R}}$ and the Serre-Swan Theorem imply that \mathcal{R} is the module of continuous sections of a line bundle $\mathcal{L} \rightarrow X$, $\mathcal{L} \subset \mathcal{E}^d$. Let us consider a closed cover $\{X_i\}$ of X , trivializing \mathcal{E}, \mathcal{L} . Now, $C(X)$ is a unital C^* -subalgebra of the centre of $\mathcal{O}_{\mathcal{M}}$; thus $\mathcal{O}_{\mathcal{M}}$ is a $C(X)$ -algebra, that we regard as an upper semicontinuous bundle over X .

Let \mathcal{A}_i denote the restriction of \mathcal{A} over X_i as an upper semicontinuous bundle. The restriction $\mathcal{O}_{\mathcal{M}}|_{X_i}$ of $\mathcal{O}_{\mathcal{M}}$ over X_i is generated as a C^* -algebra by $\mathcal{M}_i := \mathcal{M} \otimes_{\mathcal{A}} \mathcal{A}_i$, so that $\mathcal{O}_{\mathcal{M}}|_{X_i} \simeq \mathcal{O}_{\mathcal{M}_i}$; we denote by $\alpha_i : \mathcal{O}_{\mathcal{M}} \rightarrow \mathcal{O}_{\mathcal{M}_i}$ the associated epimorphism, so that $\alpha_i(\mathcal{A}, \mathcal{M}) = (\mathcal{A}_i, \mathcal{M}_i)$. Since $\mathcal{E}|_{X_i} \simeq X_i \times \mathbb{C}^d$ is trivial, we find that \mathcal{M}_i is isomorphic as a right Hilbert \mathcal{A}_i -module to the free module $\mathbb{C}^d \otimes \mathcal{A}_i$. In particular, $\mathcal{R}_i := \alpha_i(\mathcal{R})$ is generated as a Hilbert $C(X_i)$ -bimodule in $\mathcal{O}_{\mathcal{M}_i}$ by an isometry $R_i \in (\mathcal{A}_i, \mathcal{M}_i^d)$, corresponding to the generator of the free module of continuous sections of $\mathcal{L}|_{X_i} \simeq X_i \times \mathbb{C}$. Note

that $R_i^* \tau(R_i) = \lambda \alpha_i(1)$, where $\alpha_i(1)$ is the identity of $\mathcal{O}_{\mathcal{M}_i}$. By using R_i as in Lemma 5.1, we construct a sequence $\{R_{i,k}\}$.

Let now $t \in \mathcal{B}' \cap \mathcal{O}_{\mathcal{M}}$; then, every $t_i := \alpha_i(t)$ commutes with elements of $\{R_{i,k}\}$, so that $t_i \in \mathcal{A}_i$. We now consider a partition of unity $\{\lambda_i\} \subset C(X)$ subordinate to $\{X_i\}$; then, $\lambda_i t_i = \lambda_i t \in \mathcal{A}$, and we conclude that $t = \sum_i \lambda_i t_i \in \mathcal{A}$. \square

Let now \mathcal{Z} be an abelian, unital $C(X)$ -algebra, $\mathcal{M} \simeq \widehat{\mathcal{E}} \otimes_X \mathcal{Z}$ a full nc-pullback. We consider a closed group $G \subseteq \mathbf{SU}\mathcal{E}$ such that

$$G = SG,$$

where SG is defined by (4.21). Recall that there is a monomorphism $j : \mathcal{O}_{\mathcal{E}} \hookrightarrow \mathcal{O}_{\mathcal{M}}$ such that $j(\mathcal{E}^r, \mathcal{E}^s) \subset (\mathcal{M}^r, \mathcal{M}^s)$; in particular, $j(\mathbf{U}\mathcal{E}) \subset (\mathcal{M}, \mathcal{M})$. Let us now suppose that $j(G)$ acts on \mathcal{M} by a tensor action (recall Def.5.3 and subsequent remarks). In order for more concise notations, we identify G with $j(G)$ and define

$$\mathcal{B} := \mathcal{O}_{\mathcal{M}}^G \subseteq \mathcal{B}_{\mathcal{M}}, \quad \rho := \tau_G \in \mathbf{end}\mathcal{B};$$

we also consider the group

$$\mathbf{aut}_{\mathcal{B}}(\mathcal{O}_{\mathcal{M}}, \sigma_{\mathcal{E}}) := \{\alpha \in \mathbf{aut}\mathcal{O}_{\mathcal{M}} : \alpha|_{\mathcal{B}} = \iota, \alpha \circ \sigma_{\mathcal{E}} = \sigma_{\mathcal{E}} \circ \alpha\}.$$

Our purpose is to study the C^* -dynamical systems (\mathcal{B}, ρ) , $(\mathcal{O}_{\mathcal{M}}, G)$. In the particular case in which $\mathcal{Z} = C(X)$ (i.e. $\mathcal{M} = \widehat{\mathcal{E}}$), the C^* -dynamical system (\mathcal{B}, ρ) is of the type $(\mathcal{O}_G, \sigma_G)$ studied in the previous section.

Proposition 5.7. *With the above notation, the following properties hold:*

1. $\mathcal{B}' \cap \mathcal{B} = \mathcal{B}' \cap \mathcal{O}_{\mathcal{M}} = \mathcal{Z}$ (thus, $\mathcal{B}'_{\mathcal{M}} \cap \mathcal{O}_{\mathcal{M}} = \mathcal{Z}$, $\mathcal{O}_{\mathcal{M}} \cap \mathcal{O}'_{\mathcal{M}} = C(X)$).
2. The map $\{G \ni g \mapsto \widehat{g}\}$ defines an isomorphism $G \simeq \mathbf{aut}_{\mathcal{B}}(\mathcal{O}_{\mathcal{M}}, \sigma_{\mathcal{E}})$.

Proof.

1. There are obvious inclusions $\mathcal{Z} \subseteq \mathcal{B}' \cap \mathcal{B} \subseteq \mathcal{B}' \cap \mathcal{O}_{\mathcal{M}}$. Moreover, we recall Lemma 4.2 and apply Lemma 5.6 with $\mathcal{R} := (\iota, \lambda\mathcal{E}) \subset (\iota, \mathcal{E}^d)_G \subset \mathcal{B} \subseteq \mathcal{B}_{\mathcal{M}}$, $\lambda := (-1)^{d-1}d^{-1}$. Thus $\mathcal{B}' \cap \mathcal{O}_{\mathcal{M}} = \mathcal{Z}$, and the others equalities immediately follow.
2. Let $g \in G$. Since G acts on \mathcal{M} by a tensor action, $\widehat{g} \in \mathbf{aut}\mathcal{O}_{\mathcal{M}}$ restricts to the identity on \mathcal{B} ; moreover, $(\iota, \sigma_{\mathcal{E}}) = j(\widehat{\mathcal{E}})$ is G -stable, thus $\widehat{g} \circ \sigma_{\mathcal{E}} = \sigma_{\mathcal{E}} \circ \widehat{g}$ and $\widehat{g} \in \mathbf{aut}_{\mathcal{B}}(\mathcal{O}_{\mathcal{M}}, \sigma_{\mathcal{E}})$. Viceversa, let $\alpha \in \mathbf{aut}_{\mathcal{B}}(\mathcal{O}_{\mathcal{M}}, \sigma_{\mathcal{E}})$. If $\psi, \psi' \in (\iota, \sigma_{\mathcal{E}}) = j(\widehat{\mathcal{E}})$ we find $\psi^* \alpha(\psi') \in \mathcal{B}' \cap \mathcal{O}_{\mathcal{M}}$. By the previous point, $\psi^* \alpha(\psi') \in \mathcal{Z}$. Let now $\theta \in (\mathcal{E}^2, \mathcal{E}^2)_G$ be the operator defined by (4.14). Since $\alpha \circ \sigma_{\mathcal{E}} = \sigma_{\mathcal{E}} \circ \alpha$, we find $\rho(\psi^* \alpha(\psi')) = \psi^* j(\theta) \cdot \sigma_{\mathcal{E}} \circ \alpha(\psi') = \psi^* j(\theta) \alpha(j(\theta) \psi') = \psi^* \alpha(\psi')$. Thus $\psi^* \alpha(\psi)$ is ρ -invariant; since $\rho = \sigma_{\mathcal{E}}|_{\mathcal{B}}$, we conclude that $\psi^* \alpha(\psi)$ commutes with elements of $(\iota, \sigma_{\mathcal{E}})$.

Since $\mathcal{O}_{\mathcal{M}}$ is generated as a C^* -algebra by \mathcal{Z} , $(\iota, \sigma_{\mathcal{E}})$, we find $\psi^* \alpha(\psi') \in \mathcal{O}_{\mathcal{M}} \cap \mathcal{O}'_{\mathcal{M}} = C(X)$. Thus $(\iota, \sigma_{\mathcal{E}}) \simeq \widehat{\mathcal{E}}$ is α -stable, and $\alpha = \widehat{g}$ for some $g \in \mathbf{U}\mathcal{E}$. Now, we can regard \widehat{g} as an automorphism of $\mathcal{O}_{\mathcal{E}}$ leaving $\mathcal{O}_G \subseteq \mathcal{O}_{\mathcal{M}}^G$ pointwise invariant; thus, we apply Prop.4.8 and conclude that $g \in G = SG$.

□

Remark 5.6. Let $z \in \mathcal{Z}$. It follows from the point 1 of the previous proposition that $\rho(z) = \sigma_{\mathcal{E}}(z) = z \Leftrightarrow [z, (\iota, \sigma_{\mathcal{E}})] = 0 \Leftrightarrow z \in C(X) = \mathcal{O}_{\mathcal{M}} \cap \mathcal{O}'_{\mathcal{M}}$.

Corollary 5.8. Let G be locally trivial. Then, for every $r, s \in \mathbb{N}$,

$$(\mathcal{M}^r, \mathcal{M}^s)_G = \rho^s(\mathcal{Z}) \cdot j(\mathcal{E}^r, \mathcal{E}^s)_G = j(\mathcal{E}^r, \mathcal{E}^s)_G \cdot \rho^r(\mathcal{Z}) \quad (5.5)$$

(i.e., the set $\{\rho^s(z)t = t\rho^r(z) \mid z \in \mathcal{Z}, t \in (\mathcal{E}^r, \mathcal{E}^s)_G\}$ is total in $(\mathcal{M}^r, \mathcal{M}^s)_G$). Moreover,

$$(\mathcal{M}^r, \mathcal{M}^s)_G = (\rho^r, \rho^s), \quad (5.6)$$

so that there is an isomorphism of tensor C^* -categories $\widehat{\rho} \simeq \widehat{G}_{\mathcal{M}}$.

Proof.

1. The inclusion $\rho^s(\mathcal{Z}) \cdot j(\mathcal{E}^r, \mathcal{E}^s)_G \subseteq (\mathcal{M}^r, \mathcal{M}^s)_G$ is trivial. Viceversa, let $\{\psi_l\}$ be a finite set of generators of $j(\widehat{\mathcal{E}})$. The elements of $(\mathcal{M}^r, \mathcal{M}^s)_G$ are of the type $t := \sum_{LM} \rho^s(t_{LM}) \psi_L \psi_M^*$, where $\psi_L := \psi_{l_1} \cdots \psi_{l_s} \in j(\iota, \mathcal{E}^s)$, $\psi_M \in j(\iota, \mathcal{E}^r)$, $t_{LM} := \psi_L^* t \psi_M \in \mathcal{B}' \cap \mathcal{O}_{\mathcal{M}} = \mathcal{Z}$. Note that $\psi_L \psi_M^* \in j(\mathcal{E}^r, \mathcal{E}^s)$, thus $t \in \rho^s(\mathcal{Z}) \cdot j(\mathcal{E}^r, \mathcal{E}^s)$. Let G_0 be the spectral fibre of G , and $U \subseteq X$ a local chart for \mathcal{G} . Then, G_0 acts on $\mathcal{O}_{\mathcal{M}}|_U$ by automorphisms; if t_U is the restriction of t over U , by averaging w.r.t. the Haar measure of G_0 we obtain

$$t_U = \int_{G_0} \widehat{g}_0(t) dg_0|_U = \sum_{LM} \rho^s(t_{LM}) \int_{G_0} \widehat{g}_0(\psi_L \psi_M^*) dg_0|_U ;$$

by Lemma 4.12, we find

$$\int_{G_0} \widehat{g}_0(\psi_L \psi_M^*) dg_0|_U \in (j(\mathcal{E}^r, \mathcal{E}^s)|_U)_{G_0} = j(\mathcal{E}^r, \mathcal{E}^s)_G|_U ,$$

thus $t_U \in \rho^s(\mathcal{Z}) \cdot (\mathcal{E}^r, \mathcal{E}^s)_G|_U$. By considering an open cover $\{U_i\}$ trivializing \mathcal{G} , and a subordinate partition of unity $\{\lambda_i\}$, we conclude that $t = \sum_i \lambda_i t_{U_i} \in \rho^s(\mathcal{Z}) \cdot (\mathcal{E}^r, \mathcal{E}^s)_G$.

2. Let $t \in (\mathcal{M}^r, \mathcal{M}^s)_G$. Then, by the previous point $t \in \rho^s(\mathcal{Z})(\sigma_{\mathcal{E}}^r, \sigma_{\mathcal{E}}^s) \cap \mathcal{B} \subseteq (\rho^r, \rho^s)$. Viceversa, if $t \in (\rho^r, \rho^s)$, then t_{LM} defined as above belongs to \mathcal{Z} , thus $t \in (\mathcal{M}^r, \mathcal{M}^s)$; in particular, since t is G -invariant, we conclude $t \in (\mathcal{M}^r, \mathcal{M}^s)_G$. The proof of the isomorphism $\widehat{\rho} \simeq \widehat{G}_{\mathcal{M}}$ goes through the same line of Cor.4.4.

□

Remark 5.7. Let \mathcal{E} be a G_0 -vector bundle, where G_0 is a locally compact group acting trivially on X . We denote by $G \subseteq \mathbf{U}\mathcal{E}$ the associated closed group in the sense of Rem.4.3. Suppose that \mathcal{M} is a nc-pullback of \mathcal{E} carrying a tensor action by $G \subset \mathbf{SU}\mathcal{E} \subset \mathbf{UM}$. Then, (5.5,5.6) hold. In fact, we can use the Haar measure of G_0 and apply the invariant mean argument used in the proof of (5.5).
