# Con gurations in abelian categories. I. Basic properties

#### A bstract

This is the rst in a series of papers on con gurations in an abelian category A. G iven a nite partially ordered set (poset) (I; ), an (I; )-con guration (;;) is a nite collection of objects (J) and morphism s (J;K) or (J;K): (J)! (K) in A satisfying some axiom s, where J;K are subsets of I. Con gurations are a tool for describing how an object X in A decomposes into subobjects, and are especially useful for studying stability conditions on A.

This paper is prim arily elementary algebra and category theory. We de ne and motivate the idea of con gurations, and explain some natural operations upon them  $\mid$  subcon gurations, quotient con gurations, re nements and improvements. The next paper studies moduli spaces of (I; )-con gurations in A, using the theory of Artin stacks. We prove well-behaved moduli stacks exist when A is an abelian or exact category of coherent sheaves or vector bundles on a projective K-scheme P, and if A is an abelian category of representations of a quiver Q.

Subsequent papers will apply these results to construct and study in nite-dim ensional algebras associated to a quiver Q, and to de ne system s of invariants of a projective K-scheme P that 'count' (sem i) stable coherent sheaves and satisfy interesting identities.

## 1 Introduction

This is the rst of a series of papers [4,5,6,7,8,9] developing the concept of con guration in an abelian category. Given an abelian category A and a nite partially ordered set (poset) (I; ), we de ne an (I; )-con guration (;;) in A to be a collection of objects (J) and morphisms (J;K) or (J;K): (J)! (K) in A satisfying certain axioms, where J;K are subsets of I.

C on gurations are a tool for describing how an object X in A decomposes into subobjects. They are especially useful for studying stability conditions on A. G iven a stability condition ( ;T;6) on A (such as a slope function), objects X in A are called -stable, -sem istable or -unstable according to whether subobjects S X with S  $\in$  0;X have ([S]) < ([X]), ([S]) 6 ([X]), or ([S]) > ([X]).

For som e large classes of interesting abelian categories A , such as the abelian category m od-K Q of representations of a quiver Q over K , or  $\infty$ h (P ) of  $\infty$ herent

sheaves on a projective K-schemeP, for K an algebraically closed eld, one can de nemoduli spacesObj $_{ss}$ () of -sem istable objects in a xed class 2 K (A), which in good cases are quasiprojective K-schemes.

We shall regard 0 b  $j_{ss}$  () as the subset of —sem istable geometric points in the algebraic stack 0 b  $j_{s}$  of all objects in class . One goal of the series is to understand the relationship between 0 b  $j_{ss}$  () and 0 b  $j_{ss}$  (~) for two dierent stability conditions (; T;6); (~ F;6). Our key idea is that this is best understood by introducing moduli stacks M (I; ), of (I; )-con gurations in A.

W rite M  $_{ss}$  (I; ; ; ) for the subset of points [(;;)] in M (I; ) with [ (fig)] = (i) in K (A) and (fig) -sem is table for all i 2 I. When I = fig is one point M  $_{ss}$  (I; ; ; ) coincides with Obj $_{ss}$  (i) (). We shall express M  $_{ss}$  (I; ; ;  $\sim$ ) in terms of projections of M  $_{ss}$  (K; E; ; ), for nite posets (K; E) m one complicated than (I; ).

The next paper [4] deals with the technicalities of constructing A rtin stacks of con gurations M (I; ) . The third paper [5] de nes and studies in nite-dim ensional algebras of constructible functions on M (I; ), motivated by the idea of R ingel(H all algebras. Under some assumptions on A; (;T;6), in 6, 7, 8, 9] we de ne systems of invariants of A; (;T;6) by taking weighted Euler characteristics of M  $_{\rm SS}$  (I; ;; ), and determ ine identities the invariants satisfy, and their transform ation laws as (;T;6) changes.

This is the start of a broader program me. In later papers [10] the author intends to extend the notion of con gurations, and the corresponding moduli stacks and invariants, to triangulated categories. Then by applying them to derived categories of coherent sheaves on Calabi{Yau manifolds, we shall form ulate some results and conjectures on Homological Mirror Symmetry, branes in String Theory, and stability.

This paper introduces con gurations in an abelian category A, and studies their basic properties. We begin in x2 with an introduction to abelian categories, focussing on the notion of subobject S  $\,$  X of an object X 2 A, and the Jordan { Holder Theorem for A of nite length, which splits each X 2 A into simple factors  $S_1; \ldots; S_n$ .

Section 3 re nes the Jordan {Holder Theorem in the case when the simple factors  $S_1; \ldots; S_n$  of X 2 A are nonisom orphic. We not that the set of all subobjects of X may be classifed using a partial order on  $I = f1; \ldots; ng$ , the indexing set for the simple factors of X. We also classify quotient objects, factors and composition series for X using (I; ).

M otivated by this, x4 de nes the notion of (I; )-con guration (;;) in A, and proves that it captures the properties of the set of all subobjects of X  $^2$  A when X has nonisom orphic simple factors  $fS^i:i2$  Ig.

Section 5 de nes some elementary operations on con gurations. Given an (I; )-con guration we can make sub-and quotient (K; E)-con gurations, where (K; E) comes from (I; ) with K I or using a surjective : I! K. We also construct new con gurations by substituting one con guration into another.

Let E; be partial orders on a nite I, with E stronger than . Then each (I; )-con guration (;; ) has a quotient (I;E)-con guration ( $\sim$ ; $\sim$ ; $\sim$ ).

We call (;;) an (I;)—improvement of ( $\sim$ ; $\sim$ ; $\sim$ ). We call ( $\sim$ ; $\sim$ ; $\sim$ ) best if it has no strict in provements. Section 6 shows that in provements can be divided into a sequence of steps, classi es one step in provements, and gives a criterion for best congurations in terms of whether short exact sequences split.

Finally, x7 discusses ve short topics: the classes of the objects (J) in the G rothendieck group K  $_0$  (A); con gurations in exact categories; interpretations of (I; )-con gurations in terms of asque sheaves on I, and as functors F: C $_{(I;\ )}$ ! A for a category C $_{(I;\ )}$  constructed from (I; ); and we show that (I; )-con gurations in A form an exact category.

## 2 Introduction to abelian categories

We now review material on abelian categories we shall need later. Some useful references are Popescu [11] and Gelfand and Manin [2, xII.5[xII.6].

#### 2.1 Abelian categories

Here is the de nition of abelian category, taken from [2, xII.5].

De nition 2.1. Let A be a category. As a shorthand, write X 2 A or X 2 Obj(A) when X is an object of A, and f 2 M or (A) when f is a morphism of A. When X; Y 2 A write Hom (X; Y) for the set of morphisms f: X ! Y in A. Write  $id_X$  2 Hom (X; X) for the identity map  $id_X: X ! X$ .

We call A an additive category if it has the properties:

- (i) Hom (X;Y) is an abelian group for all X;Y 2 A, and composition of morphisms is biadditive.
- (ii) There exists a zero object 0.2 A such that Hom (0;0) = 0.
- (iii) For any X;Y 2 A there exists Z 2 A and morphisms  $_X$ :X ! Z,  $_Y$ :Y ! Z,  $_X$ :Z ! X,  $_Y$ :Z ! Y with  $_X$   $_X$  =  $id_X$ ,  $_Y$   $_Y$  =  $id_Y$ ,  $_X$   $_X$  +  $_Y$   $_Y$  =  $id_Z$  and  $_X$   $_Y$  =  $_Y$   $_X$  = 0.We write Z = X Y, the direct sum of X and Y. Any two such direct sums are canonically isomorphic.

Let A be an additive category, and f:X!Y a morphism in A.We call k:K!X a kernel of f:K=0 and for any  $k:K^0!X$  with f:k=0 there exists a unique  $h:K^0!K$  with  $k^0=k$  h. Similarly we call c:Y!C a cokemel of f:C=0 and for any  $b:Y!C^0$  with  $c^0=f=0$  there exists a unique  $h:C!C^0$  with  $c^0=h$  c.

If a kernelor cokemelexists it is unique up to canonical isom orphism . O frem we refer to K; C as the kernelor cokemel of f, taking k; C to be in plicitly given. De ne a morphism f: X ! Y to be injective if it has kernel O, and surjective if it has cokemel O.

We call A an abelian category of it satis es (i) { (iii) above and:

(iv) For any morphism f: X ! Y there is a sequence  $K !^k X !^i I!^j Y !^c C$  in A such that j = f, and K is the kemeloff, and C the cokemeloff, and C is both the cokemelofk and the kemelofc.

An abelian category A is called K-linear over a eld K if Hom (X;Y) is a vector space over K for all X;Y 2 A, and composition maps are bilinear.

W e will often use the following properties of abelian categories:

If i = i g and i is in jective, then f = g (i is left cancellable).

If f = g and is surjective, then f = g (is right cancellable).

If f:X! Y is in jective and surjective, then it is an isom orphism.

In an abelian category we can de ne exact sequences [2, xII.6].

De nition 2.2. Let A be an abelian category, and X  $^f$  Y  $^g$  Z a sequence in A with g f = 0. Let k: K! Y be the kernel of g and c: Y! C the cokemel of f. Then there exist unique morphisms a: X! K and b: C! Z with f = k a and g = b c. We say that  $\overset{f}{X}$  Y  $^g$  Z is exact at Y if a is surjective, or equivalently if b is injective.

A complex in A is called exact if it is exact at every term . A short exact sequence 0 ! X  $\stackrel{f}{\cdot}$  Y  $\stackrel{g}{\cdot}$  Z ! 0 in A is called split if there exists an isom orphism h : X Z ! Y such that the following diagram commutes:

The G rothendieck group K  $_0$  (A) is the abelian group generated by 0 b j (A), with a relation [Y] = [X] + [Z] for each short exact sequence 0! X ! Y ! Z ! 0.

#### 2.2 Subob jects, quotient ob jects and factors

Subobjects of objects in A are analogous to subgroups of an abelian group.

De nition 2.3. Let A be an abelian category. Two injective morphism si:S!X,  $i^0:S^0!X$  in A are equivalent if there exists an isomorphism  $h:S!S^0$  with  $i=i^0$  h. Then h is unique. A subobject of X:2 A is an equivalence class of injective morphism si:S!X. U sually we refer to S as the subobject, taking both i and the equivalence class to be in plicitly given, and write S

to mean S is a subobject of X . We write 0; X for the subobjects of X which are equivalence classes of 0! X and  $id_X$  : X ! X .

Sim ilarly, surjective morphisms  $:X ! Q, ^0 :X ! Q^0$  in A are equivalent if there is an isomorphism  $h : Q ! Q^0$  with  $^0 = h$ . A quotient object of X 2 A is an equivalence class of surjective :X ! Q . U sually we just refer to Q as the quotient object.

We de ne operations  $\ ;+\$  on subobjects, following Popescu [11,  $\times 2.6$ ]. The notation comes from the intersection and sum of subgroups of abelian groups.

De nition 2.4. Let A be an abelian category, let X 2 A, and suppose injective maps i:S! X, j:T! X de ne subobjects S;T of X. Apply part (iv) of De nition 2.1 to f = i  $_S$  + j  $_T$ :S T! X. This yields U;V 2 A and morphism sk:U! S T,1:S T! V and e:V! X such that i  $_S$  + j  $_T$  = e l, and k is the kemel of i  $_S$  + j  $_T$ , and l is the cokemel of k, and e is the image (the kemel of the cokemel) of i  $_S$  + j  $_T$ .

De ne a: U ! S by a = k  $_{S}$ , and b: U ! T by b = k  $_{T}$  and c: S! V by c = f  $_{S}$ , and d: T! V by d = f  $_{T}$ . Then  $k = _{S}$  a  $_{T}$  b, l = c  $_{S} + d$   $_{T}$ , i = e c and j = e d. Now 0! U! S T U! V ! 0 is exact. So i a = j b, and

$$0 \longrightarrow U \xrightarrow{s \ a \ T} b S \qquad T \xrightarrow{c \ s + d \ T} V \longrightarrow 0 \quad \text{is exact.} \quad (2)$$

As i; a are injective i a = j b:U! X is injective, and de nes a subobject of X. De ne S \ T to be this subobject. Similarly, e:V! X is injective, and so de nes a subobject of X. De ne S + T to be this subobject. As U; V; a; :::; e are unique up to canonical isom orphism, S \ T and S + T depend only on the subobjects S; T of X. The morphism sa; b; c; d give inclusions of subobjects

$$S \setminus T$$
  $S$   $S + T$   $X$  and  $S \setminus T$   $T$   $S + T$   $X$ : (3)

By Popescu [11, Prop. 2.6.4, p. 39] there are canonical isom orphisms

$$S=(S \setminus T) = (S + T)=T$$
 and  $T=(S \setminus T) = (S + T)=S$ : (4)

These operations \; + are commutative and associative. We can therefore form multiple sums and intersections. We shall write  $_{\rm j2J}$  T $_{\rm j}$  for the multiple sum + of a nite set of subobjects T $_{\rm j}$  X, in the obvious way.

#### 2.3 The Jordan {Holder Theorem

The Jordan  $\{H \text{ older Theorem in group theory decomposes a (nite) group into simple factors, using chains of normal subgroups. We shall explain the analogue of this in an abelian category.$ 

De nition 2.5. Let A be an abelian category. We call A artinian if for all X 2 A, all descending chains of subobjects  $_2$  AA $_1$  X stabilize, that is,  $A_{n+1} = A_n$  for all n 0. We call A noetherian if for all X 2 A, all ascending chains of subobjects  $A_1$  A $_2$  X stabilize, that  $A_n$  is,  $A_{n+1}$  for all n 0. We call A of nite length if it is both artinian and noetherian.

A nonzero object X in an abelian category A is called simple if it has no nontrivial proper subobjects. That is,  $X \in O$ , and if i:S ! X is injective then either S = O or i is an isom orphism .

Let X 2 A and consider Itrations of subobjects

$$0 = A_0 A_1 n = X (5)$$

in A. Such a ltration is called without repetitions if none of the inclusions  $i_k:A_k!$   $A_{k+1}$  is an isom orphism . A renement of (5) is any ltration obtained by inserting further term s. We allow (5) as a renement of itself, i.e. by inserting no further term s. We call (5) a composition series for X if the factors  $S_k = A_k = A_{k+1}$  are simple objects in A.

Here is the Jordan (Holder Theorem in an abelian category, [13, Th. 2.1].

Theorem 2.6. Let A be an abelian category of nite length. Then every length of tration 0 = A $_0$  A $_1$   $_n$  = AX without repetitions can be rened to a composition series for X . Suppose 0 = A $_0$  A $_1$   $_m$  =AX and 0 = B $_0$  B $_1$   $_n$  = BX are two composition series for X 2 A, with simple factors  $S_k$  = A $_k$ =A $_k$   $_1$  and  $T_k$  = B $_k$ =B $_k$   $_1$  . Then m = n, and for some permutation of 1;:::;n we have  $S_k$  = T  $_{(k)}$  for k = 1;:::;n.

#### 2.4 Exact categories

F in ally we de ne a class of subcategories of abelian categories called exact categories, that we will need in x7.2. They were introduced by Quillen [12, x2], and are discussed by Gelfand and Manin [2, Ex. IV 3.3, p. 275].

De nition 2.7. Let A be an abelian category, and B be a full additive subcategory of A in the sense of De nition 2.1, which is closed under extensions. That is, if  $0 \,!\, X \,!\, Y \,!\, Z \,!\, 0$  is a short exact sequence in A with X; Z 2 B then Y 2 B. Let E be the class of exact sequences  $0 \,!\, X \,!\, Y \,!\, Z \,!\, 0$  in A with X; Y; Z 2 B. Then the pair (B; E) is called an exact category.

Quillen [12, x2] gives necessary and su cient conditions on B;E for B to be embedded in an abelian category A in this way, and we take this to be the de nition of an exact category. An exact functor F:(B;E)!  $(B^0;E^0)$  of abelian categories is a functor F:B!  $B^0$  taking exact sequences E in B to exact sequences  $E^0$  in  $B^0$ . Note that F need not come from an exact functor A!  $A^0$  of the enveloping abelian categories.

## 3 Re ning the Jordan {Holder Theorem

W e shall study the follow ing situation.

De nition 3.1. Let A be an abelian category of nite length, and X 2 A. Then X adm its a composition series  $0 = A_0$   $A_1$  n = X by Theorem 2.6, and the simple factors  $S_k = A_k = A_{k-1}$  for  $k = 1; \ldots; n$  of X are independent of choices, up to isomorphism and permutation of  $1; \ldots; n$ . Suppose  $S_k \notin S_1$  for  $1 \in k < 1 \in n$ . Then we say that X has nonisom orphic simple factors.

Let X have nonisom orphic simple factors, and let I be an indexing set for  $fS_1; \ldots; S_n g$ , so that jIj = n, and write  $fS_1; \ldots; S_n g = fS^i : i 2$  Ig. Then Theorem 2.6 implies that for every composition series  $0 = B_0 = B_1$   $B_n = X$  for X with simple factors  $T_k = B_k = B_{k-1}$ , there exists a unique bijection : I!  $f1; \ldots; ng$  such that  $S^i = T_{(i)}$  for all  $i \ge I$ .

De ne a partial order on I by i j for i; j 2 I if and only if (i) 6 (j) for all bijections : I! f1;:::; ng constructed from a composition series  $0=B_0$   $B_1$   $n=\mathbb{K}$  for X as above. Then (I; ) is a partially ordered set, or poset for short.

The point of this de nition is to treat all the Jordan {Holder composition series  $0=B_0$   $B_1$   $n=\mathbb{R}$  for X on an equal footing. Now writing the simple factors of X as  $S_k$  for  $k=1;\ldots;n$  gives them a preferred order  $S_1;S_2;\ldots;S_n$ , and so favours one composition series over the rest. So instead we write the simple factors as  $S^1$  for i 2 I, some arbitrary indexing set.

To make our notation easier to follow we shall generally use superscripts  $S^i$  when i 2 I and subscripts  $T_k$  when k=1;:::;n, and write elements of I as i;j, and elements of f1;:::;ng as k;l. Here is some more notation.

De nition 3.2. Let (I; ) be a nite poset. De ne J I to be

- (i) an s-set if i2 I, j2 J and i j im plies i2 J,
- (ii) a q-set if i2 I, j2 J and j i im plies i2 J, and
- (iii) an f-set if i2 I and h; j2 J and h i j im plies i2 J.

The m otivation for this is that below s-sets will correspond to subobjects S  $\,$  X , q-sets to quotient objects X = S , and f-sets to factors T = S for S  $\,$  T  $\,$  X  $\,$ .

Here are some properties of s-sets, q-sets and f-sets.

Proposition 3.3. Let (I; ) be a nite poset. Then

- (a) I and ; are s-sets. If J; K are s-sets then  $J \setminus K$  and J [ K are s-sets.
- (b) J is an s-set if and only if In J is a q-set.
- (c) If J is an s-set and K a q-set, then J  $\setminus$  K is an f-set. Every f-set is of this form .
- (d) If J K are s-sets then K n J is an f-set. Every f-set is of this form .
- (e) If J; K are f-sets then  $J \setminus K$  is an f-set, but  $J \in K$  may not be an f-set.

The proof is elem entary, and left as an exercise. For the last part of (c), if F I is an f-set, de ne J = fi2 I :i j for som e j 2 F g and K = fi2 I :j i for som e j 2 F g. It easily follows that J is an s-set, K a q-set, and F = J \ K . Sim ilarly, for the last part of (d), if F I is an f-set, de ne K = fi2 I :i j for som e j 2 F g and J = K nF. It easily follows that J K are s-sets with F = K nJ.

Note that (a) and (b) in ply that the collections of s-sets and q-sets are both topologies on I, but (e) shows that the f-sets may not be a topology on I. Also can be reconstructed from the set of s-sets on I, as i j if and only if i 2 J for every s-set J I with j 2 J. In the following series of results we establish 1-1 correspondences between subobjects, quotient objects and factors of X , and s-sets, q-sets and f-sets of I.

Lem m a 3.4. In the situation of De nition 3.1, suppose S  $\,$  X is a subobject. Then there exists a unique s-set J  $\,$  I such that the simple factors in any composition series for S are isomorphic to S<sup>i</sup> for i 2 J.

Proof. Let  $0=B_0$   $_1=\mathbf{B}$  be a composition series for S, with simple factors  $T_k=B_k=B_{k-1}$  for  $k=1;\ldots;l$ . Then  $0=B_0$   $_1$  BX is a litration of X without repetitions, and can be rened to a composition series by Theorem 2.6. As  $T_k$  is simple, no extra terms are inserted between  $B_{k-1}$  and  $B_k$ . Thus X has a composition series  $0=B_0$   $_1$  B  $_n=\mathbf{K}$ , with simple factors  $T_k=B_k=B_{k-1}$  for  $k=1;\ldots;n$ .

Uniqueness of J is now clear, as a dierent J would give dierent simple factors for S. Suppose j 2 J and i 2 I n J. Then 1 6 (j) 6 l and l + 1 6 (i) 6 n, so (j) < (i), which implies that i j by De nition 3.1. Hence if j 2 J and i 2 I with i j then i 2 J, and J is an s-set.  $\square$ 

Lem m a 3.5. Suppose S;T X correspond to s-sets J;K I, as in Lem m a 3.4. Then S \ T corresponds to J \ K , and S + T corresponds to J [ K .

Proof. Let  $S \setminus T$  correspond to the s-set L I, and S + T to the s-set M. We must show  $L = J \setminus K$  and  $M = J \mid K$ . By Theorem 2.6 we may re ne the litration  $0 \cdot S \setminus T$ . S to a composition series for S containing one for  $S \setminus T$ . Thus the simple factors of S contain those of  $S \setminus T$ , and L J. Similarly L K, so L J\K, and J[K M as S; T S\T.

Now the simple factors of  $S=(S\setminus T)$  are  $S^i$  for i 2 J n L, and the simple factors of (S+T)=T are  $S^i$  for i 2 M n K . As  $S=(S\setminus T)=(S+T)=T$  by (4) we see that J n L = M n K . Together w ith L =  $J\setminus K$  and J [ K = M this implies that L =  $J\setminus K$  and M = J [ K .

Lem m a 3.6. Suppose S; T  $\times$  Correspond to s-sets J; K  $\times$  I. Then J  $\times$  if and only if S  $\times$  T  $\times$  A, and J = K if and only if S = T.

Proof. If S T X we can re ne 0 S T X to a composition series  $0=B_0$   $B_1$   $n=B\!X$  with  $S=B_k$  and  $T=B_1$  for 0.6 k 6.16 n. Let  $T_m=B_m=B_{m-1}$ . Then the simple factors of S are  $T_1; \ldots; T_k$  and of T are  $T_1; \ldots; T_1$ . Hence J K, as k 6.1. This proves the rst if.

Now suppose S; T X and J K. Then J\K = J, so S\T corresponds to the s-set J. But S\T S, so S=(S\T) has no simple factors, and S = S\T. Thus S T, proving the rst only if. The second part is immediate.  $\Box$ 

Lem m a 3.7. Let j 2 I and de ne  $J^j$  = fi 2 I : i jg. Then  $J^j$  is an s-set, and there exists a subobject D  $^j$  X corresponding to  $J^j$ .

Proof. Clearly  $J^j$  is an s-set. By De nition 3.1 each composition series  $0=B_0$   $B_1$   $n=\mathbb{K}$  for X gives a bijection :I! f1;:::; ng. Let \_1;:::; \_r be the distinct bijections :I! f1;:::; ng realized by composition series for X . For each k=1;:::; r choose a composition series  $0=B_0$   $B_1$   $n=\mathbb{K}$  with bijection \_k, and de ne C\_k to be the subobject B\_\_k(j) X .

This de nes subobjects  $C_1$ ;:::; $C_r$  X, where  $C_k$  corresponds to the s-set  $_k^1$  (f1;:::;  $_k$  (j)g) I. De ne  $D^j = C_1 \setminus C_2 \setminus _r \setminus \text{Then S} \times X$ , and Lem m a 3.5 shows that  $D^j$  corresponds to the s-set

by de nition of .

We can now classify subobjects of X in terms of s-sets.

Proposition 3.8. In the situation of De nitions 3.1 and 3.2, for each s-set J I there exists a unique subobject S X such that the simple factors in any composition series for S are isomorphic to  $S^i$  for  $i2\ J$ . This denies a 1-1 correspondence between subobjects S X and S-sets J I.

Proof. For each j 2 J de ne  $J^j$  and D  $^j$  as in Lem m a 3.7. Then j 2  $J^j$  J, so  $J = {}_{j2J}J^j$ . Set  $S = {}_{j2J}D^j$ . Then S = X corresponds to the s-set  ${}_{j2J}J^j = J$  by Lem m a 3.5. Uniqueness follows from Lem m a 3.6.

In the same way we classify quotient objects of X in terms of q-sets.

Proposition 3.9. In the situation of De nitions 3.1 and 3.2, for each q-set K I there exists a unique quotient object Q = X = S of X such that the simple factors in any composition series for Q are isomorphic to  $S^i$  for  $i \in X$ . This de nes a 1-1 correspondence between quotient objects and q-sets.

Proof. Let S X correspond to an s-set J I, and let Q = X = S be the quotient object. If the simple factors of S are  $S^i$  for  $i \ 2 \ J$ , then the simple factors of Q are  $S^i$  for  $i \ 2 \ K = I n J$ . But K = I n J is a q-set if and only if J I is an s-set. The result then follows from Proposition 3.8.

W e can also classify composition series for X .

Proposition 3.10. In the situation of De nition 3.1, for each bijection :I! f1;:::;ng there exists a unique composition series  $0 = B_0$   $n = \mathbb{K}$  with  $S^i = B_{(i)} = B_{(i)}$  for all i2 I if and only if i j implies (i) 6 (j).

Proof. The only if part follows from Denition 31. For the 'if' part, let: I! f1;:::;ng be a bijection for which i j implies that (i) 6 (j). Then 'f1;:::;kg) is an s-set for each k=0;1;:::;n. Let  $B_k$  X be the unique subobject corresponding to 'f1;:::;kg), which exists by Proposition 3.8. It easily follows that  $0=B_0$   $B_1$  n=BX is the unique composition series with  $B_k=B_{k-1}=S^{-1}(k)$  for k=1;:::;n, and the result follows.

This implies that composition series for X up to isomorphism are in 1-1 correspondence with total orders on I compatible with the partial order . In De nition 3.1 we de ned the partial order on I to be the intersection of all the total orders on I coming from composition series for X . We now see that every total order on I compatible with comes from a composition series.

Recall that a factor of X is a quotient T=S for S T X . We classify the factors of X in term S of G-sets.

Proposition 3.11. In the situation of De nitions 3.1 and 3.2, for each f-set L I there exists U 2 A, unique up to canonical isomorphism, such that

- (a) the simple factors in any composition series for U are isomorphic to S  $^{\rm i}$  for i 2 L , and
- (b) if J K are s-sets in I with K nJ = L, and S T are the corresponding subobjects of X , then there is a canonical isomorphism U = T = S.

Proof. Let L I be an freet, and de ne K  $^0$  = fi2 I : i j for som e j 2 Lg and J  $^0$  = K  $^0$  n L . Then J  $^0$ ; K  $^0$  are s-sets with J  $^0$  K  $^0$  and L = K  $^0$  n J  $^0$ , as in part (d) of Proposition 3.3. Let S  $^0$ ; T  $^0$  X be the unique subobjects corresponding to the s-sets J  $^0$ ; K  $^0$ , which exist by Proposition 3.8. Then S  $^0$  T  $^0$  by Lem m a 3.6. De ne U to be the quotient T  $^0$ =S  $^0$ , considered as an object of A . This is well-de ned up to canonical isom orphism in A .

By Theorem 2.6 we may re ne 0  $S^0$   $T^0$  X to a composition series 0 =  $B_0$   $B_1$   $_n$  =  $\mathbb{K}$  with  $S^0$  =  $B_k$  and  $T^0$  =  $B_1$  for som e 0 6 k 6 16 n. Let  $T_m$  =  $B_m$  =  $B_m$   $_1$  . Then the sim ple factors of  $S^0$  are  $T_1$ ;:::; $T_k$  and of  $T^0$  are  $T_1$ ;:::; $T_1$ . A lso 0 = ( $B_k$ = $S^0$ )  $_1$ = $S^0$ (B= U is a composition series for U. Thus the sim ple factors of U are  $T_{k+1}$ ;:::; $T_1$ , that is, the sim ple factors in  $T^0$  not appearing in  $S^0$ . Hence the sim ple factors of U are  $S^1$  for i 2 K  $^0$ n J  $^0$  = L, and part (a) follows from Theorem 2.6.

Now let J K be s-sets in I w ith K nJ = L, and S T be the corresponding subobjects of X. Then it is easy to see that  $J^0$  J and  $K^0$  K, and  $J \setminus K^0 = J^0$ , and J [ K  $^0$  = K . As S \ T  $^0$  corresponds to the s-set J \ K  $^0$  by Lem m a 3.5, J \ K  $^0$  = J  $^0$  gives S \ T  $^0$  = S  $^0$  by Lem m a 3.6. Since S + T  $^0$  corresponds to the s-set J [ K  $^0$  by Lem m a 3.5, J [ K  $^0$  = K gives S + T  $^0$  = T by Lem m a 3.6.

But (4) gives a canonical isom orphism  $T^0=(S\setminus T^0)=(S+T^0)=S$ , so that  $U=T^0=S^0=T=S$ , proving part (b). Note also that any U satisfying (a) and (b) must be canonically isom orphic to  $T^0=S^0$  by part (b), so U is unique up to canonical isom orphism.

## 4 Posets (I; ) and (I; )-con gurations in A

Although a subobject of X is an equivalence class of injective i:S:X, in x3 we for simplicity suppressed the morphism si, and just wrote S:X:W e shall now change our point of view, and investigate the natural morphism s between the factors T=S of X. Therefore we adopt some new notation, which stresses morphism s between objects. The following denition encodes the properties we expect of the factors of X, and their natural morphism s.

Denition 4.1. Let (I; ) be a nite poset, and use the notation of Denition 3.2. Dene F  $_{(I; )}$  to be the set of f-sets of I. Dene G  $_{(I; )}$  to be the subset of (J;K) 2 F  $_{(I; )}$  F  $_{(I; )}$  such that J K, and if j 2 J and k 2 K with k j, then k 2 J. Dene H  $_{(I; )}$  to be the subset of (J;K) 2 F  $_{(I; )}$  F  $_{(I; )}$  such that K J, and if j 2 J and k 2 K with k j, then j 2 K. It is easy to show that G  $_{(I; )}$  and H  $_{(I; )}$  have the following properties:

- (a) (J; K) lies in G(I; ) if and only if (K; K nJ) lies in H(I; ).
- (b) If (J;K) 2 G $_{(I;\ )}$  and (K;L) 2 G $_{(I;\ )}$  then (J;L) 2 G $_{(I;\ )}$  .
- (c) If (J;K) 2 H  $_{(I;)}$  and (K;L) 2 H  $_{(I;)}$  then (J;L) 2 H  $_{(I;)}$ .
- (d) If  $(J;K) 2G_{(I;)}$ ,  $(K;L) 2H_{(I;)}$  then  $(J;J \setminus L) 2H_{(I;)}$ ,  $(J \setminus L;L) 2G_{(I;)}$ .

De ne an (I; )-con guration ( ; ; ) in an abelian category A to be maps :F  $_{(I,\ )}$  ! Obj(A), :G $_{I,\ )}$  ! Mor(A), and :H  $_{(I,\ )}$  ! Mor(A), where

- (i) (J) is an object in A for  $J 2 F_{(I;)}$ , with (;) = 0.
- (ii) (J;K): (J)! (K) is injective for (J;K)2  $G_{I;J}$ , and (J;J) = id (J).
- (iii) (J;K): (J)! (K) is surjective for (J;K)2  $H_{(I;)}$ , and (J;J) = id (J).

These should satisfy the conditions:

(A) Let (J;K) 2  $G_{(I;)}$  and set  $L = K \, n \, J$ . Then the following is exact in A:

$$0 \longrightarrow (J) \xrightarrow{(J;K)} (K) \xrightarrow{(K;L)} (L) \longrightarrow 0:$$
 (6)

- (B) If  $(J;K) 2 G_{(I;)}$  and  $(K;L) 2 G_{(I;)}$  then (J;L) = (K;L) (J;K).
- (C) If (J;K) 2 H  $_{(I;)}$  and (K;L) 2 H  $_{(I;)}$  then (J;L) = (K;L) (J;K).
- (D) If (J;K) 2  $G_{(I;)}$  and (K;L) 2  $H_{(I;)}$  then

$$(K;L) \qquad (J;K) = (J \setminus L;L) \qquad (J;J \setminus L): \qquad (7)$$

Note that (A) { (D) make sense because of properties (a) { (d), respectively.

A morphism : (;;) ! ( $^0$ ;  $^0$ ;  $^0$ ) of (I; )-con gurations in A is a collection of morphism s (J): (J)!  $^0$ (J) for each J 2 F  $_{(I,)}$  satisfying

(K) 
$$(J;K) = {}^{0}(J;K)$$
 (J) for all  $(J;K) 2 G_{I;J}$ , and  
(K)  $(J;K) = {}^{0}(J;K)$  (J) for all  $(J;K) 2 H_{I;J}$ . (8)

It is an isomorphism if (J) is an isomorphism for all  $J \ge F_{(I;)}$ . Morphisms compose in the obvious way.

We now show that De nition 4.1 captures the properties of the families of subob tects S J X considered in x3.

Theorem 4.2. Let (I; ) be a nite poset, A an abelian category, and X 2 A. Suppose that for each s-set J I we are given a subobject  $S^J$  X, such that

;  $S^{I} = X$ ;  $S^{A} \setminus S^{B} = S^{A \setminus B}$  and  $S^{A} + S^{B} = S^{A \mid B}$  (9)

for all s-sets A; B I. Then there exists an (I; )-con guration (;; ) in A with (I) = X such that (J;I) : (J) ! X represents  $S^{J}$ I. This (;;) is unique up to canonical isomorphism in A.

Proof. Throughout (i) { (iii) and (A) { (D) will refer to De nition 4.1. We divide the proof into the following seven steps:

Step 1. De ne and on s-sets, and prove (B) for s-sets.

Step 2. For J; K s-sets with  $J \setminus K = J$ , show (J [K) = J)(K).

Step 3. De ne on f-sets and (J;L) for s-sets J.

Step 4. Complete the de nitions of ; , and prove (A).

Step 5. Prove partial versions of (C), (D), m ixing s-sets and f-sets.

Step 6. Prove (B), (C), and  $(J;J) = id_{(J)}$  in (ii) and (iii).

Step 7. Prove (D).

I, choose (J) 2 A and an injective morphism Step 1. For each s-set J  $(J;I): (J)! X representing S^{J} X . Then (J) and (J;I) are unique up to$ canonical isomorphism. In particular, choose (;) = 0 as in (i), (I) = X, and  $(I;I) = id_k$ . Suppose J K are s-sets. Then  $\theta$ ) implies that  $S^J = S^K$ Hence there exists a unique, in jective (J;K): (J)! Step 3. Let L I be an f-set which is not an s-set or a q-set, and de ne  $J^0 = \text{fi2} \, \text{InL} : 1$  i for all 12 Lg and K  $^0 = J^0 \, [$  L. Then  $J^0 - K^0$  are s-sets with L = K  $^0$  n  $J^0$ . Choose (L) 2 A and a surjective (K  $^0$ ;L): (K  $^0$ )! (L) which is a cokernel for ( $J^0$ ;K  $^0$ ): ( $J^0$ )! (K  $^0$ ). Then (L), (K  $^0$ ;L) are unique up to canonical isom orphism.

If L is an s-set then  $J^0$ ; L are s-sets with  $J^0 \setminus L =$ ;, and Step 2 shows that  $(K^0) = (J^0)$  (L), and we take  $(K^0;L)$  to be the natural projection with  $(K^0;L)$  (L; $\hat{K}$ ) = id (L).

Now let J K be s-sets in I with K nJ = L. Then J  $\theta$  and K K<sup>0</sup>, as J<sup>0</sup>; K <sup>0</sup> are defined to be as large as possible, and J<sup>0</sup>\ K = J, J<sup>0</sup> [ K <sup>0</sup> = K <sup>0</sup>. Let c: (K)! C be a cokernel for (J; K), and consider the commutative diagram with rows short exact sequences

De ne  $(K;L) = (K^0;L)$  (K;R), so that (K;L) = h cas 1(3) is commutative. As h is an isomorphism and c is a cokemel for (J;K), we see that (K;L) : (K) ! (L) is a cokemel for (J;K) : (J) ! (K). Hence (K;L) is surjective, and (6) is exact when J K are s-sets.



Consider the commutative diagram with exact rows and columns:



Here solid arrows! 'have already been de ned, and dashed arrows '99K' rem ain to be constructed. The left hand square commutes by (11).

Now  $(C^0; K nJ)$   $(A; C^0) = (C^0; K nJ)$   $(B; C^0)$   $(A; B^0) = 0$  as the middle column is exact. Since  $(C^0; K)$  is the cokemel of  $(A^0; C^0)$ , there exists a unique (K; K nJ): (K)! (K; NJ) with (K; K nJ) (C; K) =  $(C^0; K nJ)$ .

As  $(C^0;K nJ)$  is surjective, (K;K nJ) is surjective, as in (iii). Thus in (15) the lower dashed arrow exists, and the lower square commutes.

Suppose  $f:D: (B^0)$  is a morphism with  $(C^0;K)$  ( $E;C^0$ ) f=0. Then there exists a unique  $h:D: (A^0)$  with  $(A^0;C^0)$   $h=(E;C^0)$  f, as  $(E;C^0)$  is the kernel of  $(C^0;K)$ . But then  $(B^0;C^0)$  ( $A;B^0$ )  $h=(E;C^0)$  f, so  $(A^0;B^0)$  h=f as  $(E;C^0)$  is injective. This implies that  $(A^0;B^0)$  is the kernel of  $(C^0;K)$  ( $E;C^0$ ):  $(B^0)$ ! (K).

Suppose f: (K)! D is a morphism with f: (C;K) (C;K) = 0. Then there exists a unique h: (K nJ)! D with h: (C;K nJ) = f: (C;K), as  $(C^0;K nJ)$  is the cokemel of  $(B^0;C^0)$ . But then h: (K;K nJ) ((K;K)) = f: (C;K), so h: (K;K nJ) = f as (C;K) is surjective. This implies that (K;K nJ) is the cokemel of  $(C^0;K)$  ((C;K)): (C;K):

Now apply part (iv) of Denition 2.1 to the morphism ( $C^0;K$ ) ( $E^0$ ): (B<sup>0</sup>)! (K). As this morphism has kernel ( $A^0;B^0$ ) and cokernel (K;K nJ), and (B<sup>0</sup>;J) is the cokernel of ( $A^0;B^0$ ), this gives existence of a unique (J;K): (J)! We should also check that if J;K are s-sets, the de nition above gives the same answer for (J;K) as Step 1, and for (K;K nJ) as Step 3. If J;K are s-sets then  $A^0$ ; J;K are s-sets with  $A^0 \setminus J = A^0 \setminus K = ;$ , so Step 2 gives ( $B^0$ ) = ( $A^0$ ) (J) and ( $C^0$ ) = ( $A^0$ ) (K). Substituting these into 15), we nd the de nitions are consistent.

Step 5. Let C be an s-set and D ; E f-sets with (C;D); (C;E); (D;E) 2 H  $_{(I;)}$ , so that C D E. Apply Step 4 with J = D nE and K = D. This gives  $C^0$  which is the largest s-set with (C $^0$ ;D) 2 H  $_{(I;)}$ , so C  $C^0$ . Therefore

As in Step 4 with J;K replaced by J\L;L, de ne A<sup>0</sup> = fi2 InL:l i for all 12 Lg, B<sup>0</sup> = A<sup>0</sup>[ (J\L) and C<sup>0</sup> = A<sup>0</sup>[ L. Then J B<sup>0</sup> and K C<sup>0</sup>. Therefore

using (14) at the rst and fith steps, commutativity of the upper right square in (15) at the second, and (11) at the third and fourth. This proves

Hence (;;) is an (I; )-con guration, in the sense of De nition 4.1. It remains only to show that (;;) is unique up to canonical isom orphism in A. At each stage in the construction the objects and morphisms were determined either uniquely up to canonical isom orphism, or uniquely. Thus, if (;;), ( $^0$ ;  $^0$ ;  $^0$ ) both satisfy the conditions of the theorem, one can go through the steps above and construct a canonical isom orphism between them.

Applying the theorem to the situation of x3 gives:

Corollary 4.3. Let A;X;I and be as in Denition 3.1. Then there exists an (I; )-con guration (;; ) in A with (I) = X and (fig $\Rightarrow$  S<sup>i</sup> for i2 I, such that (J;I): (J)! Then the s-sets of (I;6) are f1;2:::;jg for j = 0;1;:::;n. De ne S $^{f1;:::;jg}$  = A $_j$  X for j = 0;:::;n. These S $^{f1;:::;jg}$  satisfy (9), and Theorem 4.2 gives:

Corollary 4.4. Let  $0=A_0$   $A_1$  n=X be a limition in an abelian category A. Set  $I=f1;\ldots;ng$ , with the usual total order 6. Then there is an (I;6)-con guration  $(\ ;\ ;\ )$  in A, unique up to canonical isom orphism, such that  $(f1;\ldots;jg;I):(f1;\ldots;jg)!$  X represents  $A_i$  X for  $j=0;\ldots;n$ .

This shows that we can regard (I; )-con gurations as generalized litrations. Here is the converse to Theorem 4.2.

Theorem 4.5. Let (I; ) be a nite poset, A an abelian category, and (;;) an (I; )-con guration in A. De ne X = (I), and let  $S^J$  X be represented by (J;I): (J)! X for each s-set J I. Then the  $S^J$  satisfy (9).

## 5 New (I; )-con gurations from old

Let (I; ) be a nite poset, and (;; ) an (I; )-con guration in an abelian category A. Then we can derive (K; E)-con gurations ( $\sim$ ;  $\sim$ ;  $\sim$ ) in A from (;; ) for other, simpler nite posets (K; E), by forgetting some of the objects and morphisms in (;; ). The next two de nitions give two ways to do this.

Denition 5.1. Let (I; ) be a nite poset, and use the notation of  $\Re$  and  $\Re$  and  $\Re$  suppose J is an f-set in I, so that J 2 F (I; ). Then (J; ) is also a nite poset, and K J is an f-set in (J; ) if and only if it is an f-set in (I; ). Hence F (J; ) F (I; ). One can also show that G (J; ) = G (I; ) \ (F (J; ) F (J; )) and H (J; ) = H (I; ) \ (F (J; ) F (J; )), so that G (J; ) G (I; ) and H (J; ) H (I; ). Let (;; ) be an (I; )-con guration in an abelian category A, and dene  $^{0}: F_{(J; )}: Obj(A), ^{0}: G_{(J; )}: Mor(A) and ^{0}: H_{(J; )}: Mor(A) by ^{0}= \frac{1}{2} (J; ), ^{0}= \frac{1}{2} (J; ) and ^{0}= \frac{1}{2} (J; ). Then (A) (D) of Denition 4.1 for (;; ) in ply (A) (D) for (0; 0; 0), so (0; 0; 0) is a (J; )-con guration in A. We call (0; 0; 0) a subcon guration of (;; ).$ 

De nition 5.2. Let (I; ) and (K;E) be nite posets, and : I! K a surjective map with (i) E (j) when i; j 2 I with i j. Use the notation of x3 and x4. If J K is an f-set in K then  $^1$  (J) I is an f-set in I. Hence (F<sub>(K,E)</sub>) F<sub>(I; )</sub>, where pulls back subsets of K to subsets of I in the obvious way. Similarly, if (A;B) 2 G<sub>(K,E)</sub> then  $^1$  (A);  $^1$  (B) 2 G<sub>(I; )</sub>, and if (A;B) 2 H<sub>(K,E)</sub> then  $^1$  (A);  $^1$  (B) 2 H<sub>(I; )</sub>.

Let ( ; ; ) be an (I; )-con guration in an abelian category A , and de ne  $\sim$  :F  $_{(K,E)}$  ! Obj(A),  $\sim$  :G $_{(K,E)}$  ! Mor(A) and  $\sim$  :H  $_{(K,E)}$  ! Mor(A) by  $\sim$  (A) =  $^1$  (A) ,  $\sim$  (A;B) =  $^1$  (A);  $^1$  (B) , and  $\sim$  (A;B) =  $^1$  (A);  $^1$  (B) . Then ( $\sim$ ; $\sim$ ; $\sim$ ) is a (K;E)-con guration in A. We call ( $\sim$ ; $\sim$ ; $\sim$ ) a quotient con guration of (;;). We also call (;;) a renement of ( $\sim$ ; $\sim$ ; $\sim$ ), generalizing the notion of renement of ltrations in x2.3.

Compositions of these constructions all behave in the obvious ways. Next we explain a method to glue two con gurations ( $^{0}$ ;  $^{0}$ ;  $^{0}$ ), ( $^{\sim}$ ;  $^{\sim}$ ) together, to get (;;) containing ( $^{0}$ ;  $^{0}$ ) as a subcon guration, and ( $^{\sim}$ ;  $^{\sim}$ ) as a quotient con guration. Consider the following situation.

De nition 5.3. Let (J; .) and (K; E) be nite posets and L K an f-set, with  $J \setminus (K \cap L) = ;$ . Suppose :J ! L is a surjective map with (i) E (j) when i; j 2 J with i. j. Set I = J [  $(K \cap L)$ , and de ne a binary relation on I by

An (I; )-con guration gives the same (L; E)-con guration in two ways.

Our third construction is a kind of converse to Lemma 5.4.

Theorem 5.5. In the situation of De nition 5.3, let A be an abelian category,  $(\ ^{0};\ ^{0};\ ^{0})$  a  $(J;\ )$ -con guration in A, and  $(\sim;\sim;\sim)$  a (K;E)-con guration in A. De ne  $(^{\circ};^{\circ};^{\circ})$  to be the quotient (L;E)-con guration from  $(^{0};\ ^{0};\ ^{0})$  and , and  $(\;;\;;\;)$  to be the (L;E)-subcon guration from  $(\sim;\sim;\sim)$ .

Composing with  $(B^0)$  gives  $(B;B^0) = a \text{ m.Asa} = (B;B) \text{ handa}$ ; (B;B) are injective, we see that m and hare inverse, so h is an isom orphism.

Step 5. Theorem 4.2 now constructs an (I; )-con guration (;;), unique up to canonical isom orphism, from the  $S^B$ . It follows from the construction of the  $S^B$  that the (J;.)-subcon guration of (;;) is canonically isom orphic to (°;°;), and the quotient (K;E)-con guration from is canonically isom orphic to (~;~;~). It is not dicult to see that we can choose (;;) so that these sub-and quotient con gurations are equal to (°;°;°) and (~;~;~). This completes the proof of Theorem 5.5.

The case when L = flg is one point will be particularly useful.

De nition 5.7. Let (J; .) and (K; E) be nonempty nite posets with  $J \setminus K = i$ , and 12 K . Set I = J [ (K n flg), and de ne a partial order on I by

and a surjective map : I : K by (i) = lifi2 J, and (i) = i ifi2 K nflg. Let A be an abelian category,  $( \ ^0; \ ^0; \ ^0)$  a (J; .)-con guration in A, and  $( \ ^*; \ ^*; \ ^*)$  a (K; E)-con guration in A with  $\ ^0(J) = \ ^*(flg)$ . Then by Theorem 5.5 there exists an  $(I; \ )$ -con guration  $( \ ; \ ; \ )$  in A, unique up to canonical isom orphism, such that  $( \ ^0; \ ^0; \ ^0)$  is its (J; .)-subcon guration, and  $( \ ^*; \ ^*; \ ^*)$  its quotient (K; E)-con guration from . We call  $( \ ; \ ; \ )$  the substitution of  $( \ ^0; \ ^0; \ ^0)$  into  $( \ ^*; \ ^*; \ ^*)$ .

## 6 Improvements and best conqurations

We now study quotient con gurations from (I; ), (K; E) when :I ! K is a bijection. So we identify I; K and regard :E as two partial orders on I.

De nition 6.1. Let I be a nite set and ; E partial orders on I such that if i j then iE j for i; j 2 I. Then we say that E dominates , and E strictly dominates if ; E are distinct. Let s be the number of pairs (i; j) 2 I I with iE j but i j. Then we say that E dominates by s steps. Clearly, E strictly dominates if and only if s > 0. Also

We shall see below that for distinct ;E the second two inclusions are strict.

For each (I; )-con guration (;;) in an abelian category A we have a quotient (I;E)-con guration ( $\sim$ ; $\sim$ ; $\sim$ ), as in De nition 52 with = id:I! I. We call (;;) an improvement or an (I;)-improvement of ( $\sim$ ; $\sim$ ; $\sim$ ), and a strict improvement if; E are distinct. If E dominates by s steps we also call (;;) and step improvement of ( $\sim$ ; $\sim$ ; $\sim$ ).

We call an (I;E)-con guration ( $\sim$ ; $\sim$ ; $\sim$ ) best if there exists no strict in provement (;;) of ( $\sim$ ; $\sim$ ; $\sim$ ). Note that in provements are a special kind of renement, in the sense of De nition 52.

Our rst result is simple. An (I;E)-con guration (;;) cannot have an in nite sequence of strict improvements, as I has nitely many partial orders. Thus, after nitely many steps we must reach an (I;)-con guration with no strict improvements, that is, a best con guration. This gives:

Lem m a 6.2. Let (I;E) be a nite poset, and (;;) an (I;E)-con guration in an abelian category A. Then (;;) can be improved to a best (I;)-con guration ( $^{0}$ ;  $^{0}$ ), for some partial order on I dominated by E.

A fler som e prelim inary results on partial orders in x6.1, section 6.2 proves a criterion for best con gurations in terms of split short exact sequences.

#### 6.1 Partial orders E; where E dominates

We study partial orders E; on I where E strictly dominates

Lem m a 6.3. Let E; be partial orders on a nite set I, where E strictly dominates . Then there exist  $i, j \ge I$  with  $i \ge j$  and  $i \ne j$ , such that there exists no  $k \ge I$  with  $i \ne k \ne j$  and  $i \ge k \ge j$ . Also

Proof. As E strictly dominates there exist i; j 2 I with i E j and i j. Suppose there exists k 2 I with i  $\in$  k  $\in$  j and i E k E j. Then as i j either (a) i k, or (b) k j. In case (a) we replace j by k, and in case (b) we replace i by k. Then the new i; j satisfy the original conditions, but are bloser together than the old i; j. As I is nite, repeating this process nitely many times we reach i; j for which there exists no such k. Equation (29) easily follows.  $\square$ 

This implies that if E strictly dominates then  $G_{(I,E)}$   $G_{(I,E)}$  and  $H_{(I,E)}$   $H_{(I,E)}$  in (28) are strict inclusions. But  $F_{(I,E)}$   $F_{(I,E)}$  need not be strict. For example, if I=f1;2g with 1 E 2 the only nontrivial relation, then  $F_{(I,E)}=F_{(I,E)}$  are both the set of all subsets of I.

The following elementary lemma characterizes E; diering by one step.

Lem m a 6.4. Let (I;E) be a nite poset, and suppose if j2 I with iE j but there exists no k2 I with if k f j and iE kE j. De ne on I by a b if and only if a E b and a f i, b f j. Then is a partial order and E dom inates by one step. Conversely, if is a partial order and E dom inates by one step then arises as above for some unique i; j2 I.

If E dominates by s steps, we can interpolate a chain of s+1 partial orders diering by one step.

Proposition 6.5. Let I be a nite set and ;E partial orders on I, where E dom in ates by s steps. Then there exist partial orders  $E = \cdot_0; \cdot_1; \dots; \cdot_s =$  on I such that  $\cdot_{r,1}$  dom in ates  $\cdot_r$  by one step, for  $r = 1; \dots; s$ .

Proof. De ne.  $_0$  = E. Suppose by induction that  $_0$ ;:::;  $_m$  have been chosen for 0 6 m < s such that  $_{r-1}$  dom inates  $_r$  by one step and  $_r$  dom inates by s  $_r$  steps for  $_r$  = 1;::; $_m$ . Then  $_m$  strictly dom inates  $_m$  as s  $_m$  > 0, so by Lem m a 6.3 there exist i; j 2 I with i.  $_m$  j but i j, and such that there exist no i  $_m$  k  $_m$  j.

De ne  $\cdot$  m + 1 by a  $\cdot$  m + 1 b if a  $\cdot$  m b and a  $\bullet$  i, b  $\bullet$  j. Then  $\cdot$  m + 1 is a partial order on I and  $\cdot$  m dom inates  $\cdot$  m + 1 by one step by Lemma 6.4, and  $\cdot$  m + 1 dom inates by s m 1 steps. Therefore by induction 0;:::; s exist, and as  $\cdot$  s dom inates by 0 steps we have  $\cdot$  =  $\cdot$ 

#### 6.2 Best (I; )-con gurations and split sequences

We now prove a criterion for best (I; E)-con gurations. First we decompose certain objects (J [ K ) as direct sums (J) (K).

Proposition 6.6. Suppose (I; ) is a nite poset, A an abelian category, and (;;) an (I; )-con guration in A. Let J; K  $2 F_{(I;)}$ , with j k and k j for all j 2 J and k 2 K. Then J [ K  $2 F_{(I;)}$  is an f-set and there is a canonical isomorphism (J) (K)= (J [ K ) identifying (J); (K); (J); (K) with (J; J [ K); (K; J [ K); (J [ K; J); (J [ K; K) ) respectively. Hence

$$(J;J[K)$$

Proof. The conditions on J;K imply that  $J \setminus K =$ ; and  $J \in K \setminus F_{(I, )}$  with  $(J;J \in K)$ ;  $(K;J \in K) \setminus E_{(I, )}$  and  $(J \in K;J)$ ;  $(J \in K;K) \setminus E_{(I, )}$ . De nition 4.1 (A) applied to  $(J;J \in K)$  shows that  $(J \in K;K) \setminus E_{(I;J)} \setminus E_{(I;J)$ 


Recall from De nition 22 that a short exact sequence  $0 \,!\, X \,!\, Y \,!\, Z \,!\, 0$  in A is called split if there is a compatible isomorphism  $Y = X \, Z$ .

Proposition 6.7. Suppose (I;E) is a nite poset, A an abelian category, and (;;) an (I;E)-con guration in A which is not best. Then there exist  $i \notin j2$  I with iE j but there exists no k2 I with  $i \notin k \notin j$  and iE kE j, such that the following short exact sequence is split:

$$0 \longrightarrow \text{fig} \xrightarrow{\text{(fig;fi;jg)}} \text{fi;jg} \xrightarrow{\text{(fi;jg;fig)}} \text{fjg} \longrightarrow 0: \quad (31)$$

Proof. As (;;) is not best it has a strict (I; )-improvement (0; 0; 0), for some dominated by E. Let i; j be as in Lemma 6.3. Then i  $\oplus$  j as i j, and there exists no k 2 I with i  $\oplus$  k  $\oplus$  j and i E k E j. As i j, j i

Proposition 6.6 shows that  ${}^{0}$ (fi; jg) =  ${}^{0}$ (fig)  ${}^{0}$ (fjg). But  ${}^{0}$ (fig) = (fig),  ${}^{0}$ (fi; jg) = (fig), so (fi; jg) = (fig) (fjg). Proposition 6.6 and equalities between;  ${}^{0}$  and;  ${}^{0}$  show that the diagram



com m utes, where h = (fig; fi; jg) = (fig) + (fig) + (fig) fi; jg) is an isomorphism. Therefore by (1), the short exact sequence (6) is split.

We classify im provements for a two point indexing set K = fi; jg.

Lem m a 6.8. De ne partial orders E;. on K = fi;jg by iE i, iE j, jE j, i. i and j. j. Let (;;) be a (K;E)-con guration in an abelian category A. Then there exists a (K;.)-im provement ( $^{0}$ ;  $^{0}$ ;  $^{0}$ ) of (;;) if and only if the short exact sequence (31) is split, and then such (K;.)-im provements ( $^{0}$ ;  $^{0}$ ;  $^{0}$ ) are in 1-1 correspondence with Hom (fjg); (fig).

Proof. If there exists a (K; .)-in provement of (; ; ) then (1) is split by Proposition 6.7, which proves the only if part. For the if part, suppose (31) is split. Then we can choose morphisms (6) (

Finally,  $\mathbf{x} \stackrel{0}{_{0}} (\mathrm{fjg;K}); \stackrel{0}{_{0}} (\mathrm{K};\mathrm{fig})$  satisfying (32). We can easily prove that every (K;.)-improvement ( $^{0}; ^{0}; ^{0}$ ) of (;;) is dened uniquely by  $^{0}=$ ,  $^{0}\dot{\mathbf{j}}_{\mathrm{K},\mathrm{K};\mathrm{E}}$ ) = and

for som e unique f 2 H om ( (fjg); (fig)), and every f 2 H om ( (fjg); (fig)) gives a (K;.)-im provement. This establishes a 1-1 correspondence between (K;.)-im provements ( $^{0}$ ;  $^{0}$ ) and f 2 H om (fjg); (fig).

Here is the converse to Proposition 6.7.

Proposition 6.9. Suppose (I;E) is a nite poset, A an abelian category, and (;;) an (I;E)-con guration in A. Let  $i \in j \setminus I$  with  $i \in j$  but there exists no k 2 I with  $i \in k \in j$  and  $i \in k \in j$ , such that the short exact sequence (31) is split. De ne a partial order on I by a b if a E b and a  $\in i$ , b  $\in j$ , so that E dom inates by one step. Then there exists an (I;)-im provement ( $\sim$ ; $\sim$ ; $\sim$ ) of (;;). Such improvements up to canonical isom orphism are in 1-1 correspondence with Hom (fig); (fig).

Proof. Set K = fi; jg, and let (;;) be the (K;E)-subcon guration of (;;). As (31) is split, Lem m a 6.8 shows that there exists a (K;.)-improvement ( $^{0}$ ;  $^{0}$ ) of (;;). Then (;;) and  $^{0}$ ;  $^{0}$ ) satisfy the conditions of Theorem 5.5 with = id, I in place of K, and K in place of both J and L. Therefore Theorem 5.5 gives the (I;)-improvement (~;~;~) that we want.

For the last part, note that every (I; )-im provem ent ( $\sim$ ; $\sim$ ; $\sim$ ) of (;;) may be constructed this way, taking ( $^{0}$ ; $^{0}$ ; $^{0}$ ) to be the (K; )-subcon guration of ( $\sim$ ; $\sim$ ; $\sim$ ). Thus, uniqueness up to canonical isomorphism in Theorem 5.5 shows that such improvements ( $\sim$ ; $\sim$ ; $\sim$ ) up to canonical isomorphism are in 1-1 correspondence with (K;.)-improvements ( $^{0}$ ; $^{0}$ ; $^{0}$ ) of (;;). But Lemma 6.8 shows that these are in 1-1 correspondence with Hom (fig); (fig).

Propositions 6.7 and 6.9 imply a criterion for best con gurations:

Theorem 6.10. Let (;;) be an (I;)-con guration in an abelian category A. Then (;;) is best if and only if for all  $i \in j2$  I with  $i \in k \in j$  and  $i \in k$ , the short exact sequence 31) is split.

If this criterion holds, it also holds for any subcon guration of (;;), giving:

Corollary 6.11. Suppose (;;) is a best (I;)-con guration in an abelian category A. Then all subcon gurations of (;;) are also best.

## 7 Further topics

We nish with short discussions of ve other subjects. Section 7.1 studies the classes of the objects (J) in the G rothendieck group K  $_0$  (A), and x7.2 congurations in exact categories. Interpretations of (I; )-congurations in terms of asque sheaves on I are given in x7.3, and as functors  $F:C_{(I; )}$ ! A for a category  $C_{(I; )}$  constructed from (I; ) in  $\mathbb{Z}.4\{x7.5$ . Finally, x7.6 $\{x7.7\}$  show that (I; )-congurations in an abelian or exact category A form an exact category C on f(I; ;A).

#### 7.1 Con gurations and $K_0(A)$

Let A be an abelian category and K  $_0$  (A) its G rothendieck group, as in D e nition 2.2. Let (;;) be an (I;)—con guration in A. Then each object (J) for J 2 F  $_{(I;)}$  has a class [ (J)] in K  $_0$  (A). The following proposition shows how these classes are related.

Proposition 7.1. Suppose (I; ) is a nite poset, A an abelian category, and (;; ) an (I; )-con guzation in A. Then there exists a unique map : I!  $K_0(A)$  such that  $[(J)] = {}_{j2J}$  (j) in  $K_0(A)$  for all f-sets J I.

Proof. Combining De nitions 22 and 3.1 (A) shows that

$$(K) = (J) + (K n J)$$
 for all  $(J; K) 2 G_{(I;)}$ . (33)

De ne : I!  $K_0(A)$  by (i) = [(fig)]. As fig 2  $F_{(I;)}$  for all i 2 I this is well-de ned, and also any satisfying [(J)] =  $_{j2J}$  (j) for J 2  $F_{(I;)}$  has (i) = [(fig)], so is unique.

Suppose K 2 F  $_{(I; )}$  with K j> 1. Let j 2 K be m inimal. Then (fjg;K) 2  $F_{(I; )}$ , so (33) gives [ (K)] = (j) + [ (K nfjg)]. We then easily prove [ (J)] =  $_{j2J}$  (j) for all J 2 F  $_{(I; )}$  by induction on jJ j completing the proof.

## 7.2 Con gurations in exact categories

Let (B;E) be an exact category, as in x2.4. Then De nition 4.1 makes sense in (B;E): we take (J) 2 Obj(B), (J;K); (J;K) 2 Mor(B), and use E to say what it means for (6) to be exact. Thus we have a concept of a (I; )-con guration in an exact category (B;E). If B is embedded in an abelian category A, then an (I; )-con guration (;; ) in (B;E) is just an (I; )-con guration in A with (J) 2 Obj(B) for all J 2 F $_{(I; )}$ .

Here is an interesting example we will study in [4]. Let P be a projective K-scheme over an algebraically closed eld K. Then the abelian category  $\cosh(P)$  of coherent sheaves on P contains as a subcategory the exact category vect (P) of vector bundles on P (that is, locally free sheaves on P of nite rank). Thus we can form (I; )-con gurations of vector bundles on P, which will be useful tools for studying stability of vector bundles on P.

All the material of  $x3\{x6$  extends simply to exact categories (B;E). In particular, subcong urations and quotient congurations in x5 are well-de ned in (B;E). Less trivial is the extension of Theorem 5.5 to exact categories:

Proposition 7.2. Theorem 5.5 holds in an exact category (B;E). That is, if B is embedded in an abelian category A, and ( $^{0}$ ;  $^{0}$ ), ( $^{\sim}$ ; $^{\sim}$ ) in Theorem 5.5 are con gurations in (B;E), and so in A, then the (I; )-con guration (;;) in A constructed in Theorem 5.5 is a con guration in (B;E).

Proof. Theorem 5.5 applies in the abelian category A, and yields an (I; )—con guration (;; ) in A.W emust show that (J) 2 0 b j(B) for all J 2  $F_{(I; )}$ , so that (;; ) is a con guration in (B;E). The theorem then holds in (B;E), independently of the the choice of enveloping abelian category A.

As ( $^{0}$ ;  $^{0}$ ;  $^{0}$ ) is the (J;.)—subcon guration of (;;) we have (fig) =  $^{0}$ (fig) 2 Obj(B) for i 2 J. And as ( $\sim$ ;  $\sim$ ;  $\sim$ ) is the quotient (K;E)—con guration of (;;) from we have (fig) =  $\sim$  (fig) 2 Obj(B) for i 2 InJ = K nL. Hence (fig) 2 Obj(B) for all i 2 I. Also (;) = 0 2 Obj(B). Hence (A) 2 Obj(B) for all A 2 F (I, ) with A j6 1.

Suppose by induction that (A) 2 Obj(B) for all A 2 F  $_{(I; )}$  with  $_{A}$  j6 k, for 1 6 k < jIj. Let B 2 F  $_{(I; )}$  with  $_{B}$  j= k + 1, let i be  $_{A}$  m aximal in B, and set A = B n fig. Then (A;B) 2 G  $_{(I; )}$ , so (6) gives a short exact sequence 0 ! (A) ! (B) ! (fig) ! 0. Now (A) 2 Obj(B) by induction, and (fig) 2 Obj(B) from above, and B is closed under extensions as it is an exact category. Therefore (B) 2 Obj(B). So by induction (A) 2 Obj(B) for all A 2 F  $_{(I; )}$ , and (;;) is an (I;)—con guration in (B;E).

#### 7.3 Con gurations and asque sheaves

We briefy describe an alternative point of view on congurations, explained to meby Tom Bridgeland. Let (I; ) be a nite poset, and (; ; ) an (I; )-conguration in an abelian category A. Then as in x3 the q-sets in I are the open sets of a topology on I.

It can be shown that the data (J) and (J;K): (J)! (K) for all q-sets I J K comprises a asque sheaf S on I with the q-set topology, with values in A. The rest of the data (;;) can be reconstructed, up to canonical isom orphism, from the (J) and (J;K) for q-sets J;K | this is essentially Theorem s 4.2 and 4.5 with s-sets replaced by q-sets.

The f-sets J  $\,$  I are the locally closed sets in the q-set topology. In fact, a topology on a nite set I comes from a (unique) partial order  $\,$  if and only if every point is locally closed. For f-sets J we interpret  $\,$  (J) as the sections of S near J locally supported on J.

A liternatively, we can take the s-sets to be the open sets of a topology on I, which is more compatible with x3 and x4. Then (;;) is equivalent to a asque cosheaf with values in A, or equivalently, a asque sheaf with values in the opposite category A.

Probably one could use this to reduce parts of our theory to known facts on sheaves, and so shorten the proofs. In particular, Theorem s 42 and 5.5 look like instances of general sheaf results. But I have been unable to nd appropriate references. Note however that Baclawski [1, x1] studies sheaves on posets with the q-set topology. He calls q-sets increasing subsets, or order liters.

## 7.4 Compositions of morphisms (;); (;)

In x7.5 we shall show that an (I; )-con guration (;;) in A is equivalent to an exact functor  $F:C_{(I,\cdot)}!$  A for  $C_{(I,\cdot)}$  a category constructed using (I; ). As a preparation for this, we must rst study the collection of m orphisms f:(A)! (B) obtained by compositions of m orphisms f:(A)! (B) obtained by compositions of m orphisms f:(A) in the sequels [A, 5, 6, 7, 8, 9], so to save space we leave all proofs as an exercise for the reader.

Proposition 7.3. Suppose (I; ) is a nite poset, A an abelian category, and (;;) an (I; )-con guration in A, with (K)  $\in$  (L) for K  $\in$  L. Then every morphism f: (A)! (B) which is a composition of nitely many (;); (;) may be written (J;B) (A;J) for some J A\B with (A;J)2 H (I;) and (J;B) 2 G (I;).

Here we assume  $(K) \in (L)$  to avoid compositions like (L;M) (J;K).

De nition 7.4. Let (I; ) be a nite poset, and A;B 2 F (I; ). De ne an equivalence relation  $_{A,B}$  on A \ B by i  $_{A,B}$  j for i; j 2 A \ B if there exist  $i=i_0;i_1;\dots;i_n=j$  with either  $i_{m-1}$   $i_{m}$  or  $i_{m}$   $i_{m-1}$  for  $m=1;\dots;n$ . De ne P (A;B) to be the set of  $_{A,B}$  equivalence classes J A \ B satisfying

(a) there do not exist i 2 A n B and j 2 J with j i, and

(b) there do not exist i 2 B n A and j 2 J with i j.

Then P (A; B) is a nite set of disjoint subsets of A  $\setminus$  B.

We use P(A;B) to classify J 2 F( $\alpha$ , ) with (A;J) 2 H( $\alpha$ , ), (J;B) 2 G( $\alpha$ , ), and the compositions (J;B) (A;J).

Proposition 7.5. Let (I; ) be a nite poset, A; B 2,  $F_{(I; )}$ , and J I. Then (A; J) 2  $G_{(I; )}$  and (J; B) 2  $H_{(I; )}$  if and only if  $J = {}_{K \ 2R} K$  for some unique R P (A; B). In this case, let (;; ) be an (I; )-con guration in A. Then

$$(J;B)$$
  $(A;J) = P$   $(K;B)$   $(A;K)$ :

Propositions 7.3 and 7.5 show that all morphisms f:(A)!(B) constructed from (;);(;) are linear combinations of (K;B) (A;K) for (K,B). The next denition shows how to compose such morphisms.

De nition 7.6. Let (I; ) be a nite poset. For A;B;C 2 F(I; ), de ne T (A;B;C) to be the set of triples (J;K;L) with J 2 P (A;B), K 2 P (B;C), L 2 P (A;C), and L  $J \setminus K$ .

Let J 2 P (A;B) and K 2 P (B;C). Then (J;B) 2  $G_{(I;)}$  and (B;K) 2 H  $_{(I;)}$ , so (J;J\K) 2 H  $_{(I;)}$  and (J\K;K) 2  $G_{(I;)}$  by De nition 4.1 (d). A lso (A;J) 2 H  $_{(I;)}$  and (K;C) 2  $G_{(I;)}$ , so (A;J\K) 2 H  $_{(I;)}$  and (J\K;C) 2  $G_{(I;)}$  by De nition 4.1 (b),(c). Thus J\K is a disjoint union of L 2 P (A;C) by P roposition 7.5. #### 7.5 C on gurations as functors

We shall now show that an (I; )-con guration (;; ) in A is equivalent to an exact functor  $F:C_{(I, \cdot)}$ ! A for a certain category  $C_{(I; \cdot)}$ .

De nition 7.7. Let (I; ) be a nite poset, and K be a eld. De ne a category  $C_{(I;\ )}$  to have objects O bj( $C_{(I;\ )}$ ) = F  $_{(I;\ )}$ , the set of f-sets of (I; ), and morphism s M or( $C_{(I;\ )}$ ) given by H om  $_{C_{(I;\ )}}$  (A;B) = f:P (A;B)! K, the set of functions from P (A;B) to K, for A;B 2 F  $_{(I;\ )}$ . Then H om  $_{C_{(I;\ )}}$  (A;B) is a vector space over K.

Let A;B;C 2 F  $_{(I;)}$  and f 2 Hom  $_{c(I;)}$  (A;B), g 2 Hom  $_{c(I;)}$  (B;C), so f;g m ap P (A;B);P (B;C)! K. De ne the composition g f 2 Hom  $_{c(I;)}$  (A;C) by

Then composition of morphisms is bilinear over K. De ne the identity morphism  $id_A$  for A 2 F  $_{(I;)}$  by  $id_A$  (J) = 1 for all J 2 P (A;A). For (A;B) 2 G  $_{(I;)}$ , de ne (A;B) 2 Hom  $_{(C,I;)}$  (A;B) by (A;B) (J) = 1 for all J 2 P (A;B). For (A;B) 2 Hom  $_{(C,I;)}$  (A;B) by (A;B) (J) = 1 for all J 2 P (A;B).

Theorem 7.8. In the situation of De nition 7.7, the composition of m orphisms (35) is associative, and f  $id = id_B$  f = f for f 2 H om  $_{(I; )}$  (A;B), so  $C_{(I; )}$  is a category. Also; 2 Obj( $C_{(I; )}$ ) = F  $_{(I; )}$  is a zero object in  $C_{(I; )}$ .

Fix f 2 H om  $_{\text{C}(I; )}$  (A;B), let D be the union of all J 2 P (A;B) with f (J)  $\in$  0, and set C = A n D and E = B n D. Then (C;A); (D;B) 2 G(I;) and (A;D); (D;E) 2 H (I;). Consider the sequence

in  $C_{(I;\ )}$ , where P (D;B) is the subset of J 2 P (A;B) with f(J)  $\stackrel{\leftarrow}{\bullet}$  0, and g 2 H om  $_{C(I;\ )}$  (D;B) is the restriction of f to P (D;B) P (A;B).

Then g (A;D) = f, and (C) is a kernel for f and (A;D), and (B;E) is a cokernel for f and g, and (A;D) is a cokernel for (C;A), and g is a kernel for (B;E). That is,  $C_{(I;\ )}$  satisfies Denition 2.1(iv). Hence kernels and cokernels exist, and exact sequences make sense, in  $C_{(I;\ )}$ .

The following analogues of De nition 4.1 (A) { (D) hold in  $C_{\scriptscriptstyle (I;\ )}$  .

(A) Let (J; K) 2 G(I; ) and set L = K nJ. Then the following is exact in  $C_{(I;\ )}$ :

- (B) If  $(J;K) 2 G_{(I;)}$  and  $(K;L) 2 G_{(I;)}$  then (J;L) = (K;L) (J;K).
- (C) If (J;K) 2 H (I;) and (K;L) 2 H (I;) then (J;L) = (K;L) (J;K).
- (D) If (J;K) 2 G  $_{\mbox{\scriptsize (I;\ )}}$  and (K;L) 2 H  $_{\mbox{\scriptsize (I;\ )}}$  then

  $(J;K) = (J \setminus L;L)$   $(J;J \setminus L)$ :

The theorem shows that  $C_{(\mathfrak{I};\ )}$  satis esparts (i), (ii) and (iv) of De nition 2.1, but it does not satisfy part (iii) if  $I\in \ ;$ , as  $C_{(\mathfrak{I};\ )}$  is not closed under direct sum s. Therefore  $C_{(\mathfrak{I};\ )}$  is not an abelian category. One can de ne a natural abelian category containing  $C_{(\mathfrak{I};\ )}$  by a kind of tensor product of  $C_{(\mathfrak{I};\ )}$  with the category of nite-dimensional vector spaces over K, but we will not do this.

The assumption in De nition 7.7 that K is a eld is needed to prove the statements on kernels and cokernels in the theorem . In particular, they do not hold for K = Z.Now we do not he functor F:  $C_{(\text{I};\ )}$ ! A associated to (;;)).

De nition 7.9. Let (I; ), K and  $C_{(I;)}$  be as in De nition 7.7. Suppose that A is a K-linear abelian category, and (;;) an (I;)—con guration in A. De ne F:  $C_{(I;)}$ ! A by F(A) = (A) for A 2 Obj $(C_{(I;)}$ ) = F(I;), and for f 2 Hom  $_{C(I;)}$  (A;B) de ne F(f) 2 Hom  $_{A}$  (A); (B) by

$$F (f) = \begin{cases} X \\ f(J) & (J;B) \end{cases} (A;J):$$
 (36)

Theorem 7.10. In De nition 7.9, F is a K-linear functor which takes exact sequences to exact sequences, and satisfies F (A;B) = (A;B) for (A;B) 2  $G_{(I;)}$  and F (A;B) = (A;B) for (A;B) 2  $H_{(I;)}$ .

Conversely, if  $F:C_{(I; )}$ ! A is a K-linear exact functor then setting (A)= F(A) for  $A \supseteq F_{(I; )}$  and (A;B)= F(A;B) for (A;B)2  $G_{(I; )}$  and (A;B)= F(A;B) for (A;B)2  $G_{(I; )}$  denes an (I; )-con guration (;;) in A.

The theorem provides the motivation for De nitions 7.7 and 7.9. In particular, the composition rule (35) for morphisms in  $C_{(1,1)}$  follows from (34) and (36).

To study (I; )-con gurations in an abelian category A which is not K-linear over some eld K, we can de ne C  $_{(I;\ )}$  using K = Z in De nition 7.7. Then C  $_{(I;\ )}$  is still a category, and F : C  $_{(I;\ )}$ ! A is well-de ned in De nition 7.9. However, as kernels and cokernels do not exist for all morphisms in C  $_{(I;\ )}$ , we need to be more careful about what we mean by F being an exact functor.

The constructions of x5 can be explained in this functorial notation. If (;;) is an (I;)-con guration and ( $^0$ ;  $^0$ ;  $^0$ ) its (J;)-subcon guration for J 2 F  $_{(I;)}$ , and F;F  $^0$  are the associated functors, then F  $^0$  = F S(I;;J) for a natural functor S(I;;J): C $_{(J;)}$ ! C $_{(I;)}$ . Similarly, if ( $^{\sim}$ ; $^{\sim}$ ; $^{\sim}$ ) is the quotient (K;E)-con guration of (;;) from with functor Then F = F Q(I;;K;E;) for a natural functor Q(I;;K;E;): C $_{(I;)}$ !

Theorem 5.5 has a more complicated explanation, as follows. The functors

This is an equivalence of categories, and so a functor from the left hand side to A induced by (~;~;~),  $(^0;~)$ , extends to a functor from the right hand side, uniquely up to canonical isom orphism .

## 7.6 The exact category of exact sequences in A

Let A be an abelian category, which may be K-linear over a eld K. In x7.7 we will show that the category Conf(I; ;A) of (I; )-con gurations in A is an

exact category. As a warm -up exercise, we rst show that the category Exact (A) of short exact sequences in A is an exact category. De nethecategory Comp (A) of complexes  $X_1$  !  $X_2$  !  $X_3$  in A as follows.

Objects in C om p (A) are  $X = (X_1; X_2; X_3; _1; _2)$  with  $X_1; X_2; X_3 \ge 0$  bj(A) and  $_1 : X_1 ! X_2, _2 : X_2 ! X_3$  in M or (A) with  $_2 = _1 = 0$ . M or phisms in C om p (A) are  $f = (f_1; f_2; f_3) : (X_1; X_2; X_3; _1; _2) ! (Y_1; Y_2; Y_3; _1; _2)$ , where  $f_a : X_a ! X_a$  lie in M or (A) for a = 1; 2; 3 with  $_1 = _1 f_2 = _1, _2 = _1 f_3 = _2$ . M or phisms som pose by  $(f_1; f_2; f_3) = (g_1; g_2; g_3) = (f_1 = _1 g_1; f_2 = _1 g_2; f_3 = _1 g_3)$ .


Proposition 7.11. This Comp(A) is an abelian category. If A is K-linear then Comp(A) is K-linear.

If A is K-linear then Hom (X;Y) is a K-vector space and composition is bilinear, which will prove C om p (A) is K-linear once we have veri ed (ii) { (iv). For (ii), the zero object is (0;0;0;0;0). For (iii), direct sums are given by

$$X Y = (X_1 Y_1; X_2 Y_2; X_3 Y_3; X_2 1 X_1 + Y_2 1 Y_1; X_3 2 X_3 2 X_2 + Y_3 2 Y_2);$$

with  $_{X}$  : X ! X Y equal to  $(_{X_{1}};_{X_{2}};_{X_{3}})$ , and so on.

For (iv), let f: X ! Y be as above. Applying Denition 2.1(iv) to  $f_a: X_a ! Y_a$  in the abelian category A for a=1;2;3 gives a sequence  $K_a \overset{!}{!}{}^a X_a \overset{!}{!}{}^a I_a \overset{!}{!}{}^a Y_a \overset{!}{!}{}^a C_a$  in A such that  $j_a = i = f_a$ , and  $K_a$  is the kernel of  $f_a$ , and  $C_a$  the cokernel of  $f_a$ , and  $I_a$  is both the cokernel of  $k_a$  and the kernel of  $k_a$ . We shall show these tinto a commutative diagram



where the morphisms 99K' have yet to be constructed.

Since  $_1$   $f=f_2$   $_1$  we have  $f_2$   $(_1$   $_k)=$   $_1$  f  $_k=0$ , as  $k_1=K\operatorname{er} f_1$ . But  $k_2=K\operatorname{er} f_2$ , so there is a unique  $_1:K_1!$   $K_2$  with  $k_2$   $_1=$   $_1$   $_k$ , making the top left square commute. We construct 2 in the same way. Then

By a dual proof, using cokernels instead of kernels, we construct  $_1; _2$  so the bottom squares commute and  $_2$   $_1$  = 0, so that C =  $(C_1; C_2; C_3; _1; _2)$  lies in Obj(C om p (A)).

Now  $i_2$  1  $k = i_2$  k 1 = 0, as  $i_2 = C$  oker $k_2$ . But  $i_1 = C$  oker $k_1$ , so there is a unique 1:  $I_1$ !  $I_2$  with 1  $i_1 = i_2$  1, making one of the diam onds in (37) commute. Then

But  $i_1$  is surjective as it is a cokernel, so  $j_2$   $_1 = _1$   $_1j$ , and another diam ond commutes. In the same way we construct  $_2:I_2:I_3$  with  $_2$   $_2i=i_3$   $_2$  and  $_3$   $_2=_2$   $_2j$ , so the whole of (37) commutes. And


so  $_2$   $_1$  = 0 as  $i_1$  is surjective, and  $I = (I_1; I_2; I_3; _1; _2)$  lies in Obj(C om p (A)). It is now easy to show that the sequence K  $_1^k$  X  $_2^i$  I!  $_2^j$  Y  $_2^j$  C in C om p (A) fulls De nition 2.1 (iv).

Now de ne the category Exact (A) of exact sequences in A to be the full subcategory of C om p (A) with objects  $X = (X_1; X_2; X_3; _1; _2)$  such that  $0 ! X_1 ^1 ! X_2 ^2 ! X_3 ! 0$  is a short exact sequence in A. De ne short exact sequences in Exact (A) to be short exact sequences in C om p (A) with objects in Exact (A). Then we have:

Proposition 7.12. This Exact (A) is an exact category. If A is K-linear then Exact (A) is K-linear.

Proof. Clearly Exact(A) is a full subcategory of Comp(A) which contains zero and is closed under direct sums, so it is an additive subcategory. By Denition 2.7, it remains to verify it is closed under extensions. Suppose  $0! X \stackrel{f}{}! Y \stackrel{g}{}! Z ! 0$  is a short exact sequence in Comp(A) with X; Z 2 Exact(A). We must show that Y 2 Exact(A).

That is, we have a com mutative diagram



in A, with K and arrows 99K' yet to be constructed, and with the columns and rst and last rows exact. We must show the middle row is exact.

Suppose : A !  $Y_1$  lies in Mor(A) with  $_1$  = 0. Then  $_1$  g =  $g_2$   $_1$  = 0, so g = 0 as  $_1$  is injective. But  $f_1$  = K erg $_1$ , so there is a unique : A !  $X_1$  with =  $f_1$  . Thus  $f_1$   $_1$  =  $_1$   $_1$   $_1$  =  $_1$  = 0. Now  $f_2$ ;  $_1$  are injective, so  $f_2$   $_1$  is injective, giving = 0, so that =  $f_1$  = 0. Therefore  $_1$  = 0 implies = 0, and  $_1$  is injective. A dual proof shows that  $_2$  is surjective.

Let  $k: K \ ! \ Y_2$  be a kernel for  $\ _2$ . As  $\ _2$   $\ _1 = 0$  there exists a unique i:  $Y_1 \ ! \ K$  with k i=  $\ _1$ . As  $\ _2$  g k=g  $\ _2$  k=0 and  $\ _1 = ker$   $\ _2$  there exists a unique j: K !  $\ Z_1$  with  $\ g_2$  k=g j. Also  $\ _1$  j i= $\ _2$  g k i=  $\ g_2$   $\ _1 = \ _1$  g, so j i= g as  $\ _1$  is injective. This shows (38) commutes. We shall show i is an isomorphism .

As j i = 1 and 1 is injective, we see that i is injective. Since j i = g and  $g_1$  is surjective, j is surjective. We claim i f is a kernel for j. Suppose :A! K with j = 0. Then g k  $g_1$  j = 0, so as g for K erg2 there is a unique :A! g with g = k. Then

as k = K er  $_2$ . But  $f_3$  is injective, so  $_2 = 0$ . Hence there exists : A! X with  $= _1$  , as  $_1 = K$  er  $_2$ . Therefore

$$k = f = f _1 = f = k i_1 f :$$

So = i f since k is injective, as it is a kernel. Thus every : A ! K with j = 0 factors via i  $_1f$  and i f = K erj. As j is surjective, we have j = C oker(i f).

Suppose : K ! D with i = 0. Then  $i_1 = f0$ , so there exists :  $Z_1$ ! D with = j, as j = C oker( $i_1$ ) fThus j = j i = i = 0, which implies = 0 as q is surjective, and so = 0. Hence i = 0 implies = 0, and i is surjective, so it is an isomorphism. Since k is a kernel for j = 0, this implies j = 0 is a kernel for j = 0. As j = 0 is surjective, the middle row of (38) is exact, and the proof is complete.

Note that Exact (A) is never an abelian category if A is nonzero. For if X 2 A with X  $\in$  0 then (0; id<sub>X</sub>;0): (0; X;X;0; id<sub>X</sub>)! (X;X;0; id<sub>X</sub>;0) is a morphism in Exact (A), whose kernel (0;0;X;0;0) and cokernel (X;0;0;0;0) lie in C om p (A) but not in Exact (A), so Exact (A) is not closed under kernels or cokernels.

#### 7.7 The exact category of (I; )-con gurations in A

Let A be an abelian category, and (I; ) a nite poset. We now generalize the proofs of x7.7 to show that the (I; )-con gurations in A form an exact category C on f(I; ;A). First we need an abelian category to embed C on f(I; ;A) in, analogous to the category C om p(A) of complexes in A.


De ne an (I; )-precon guration (;;) in A as in De nition 4.1, except that in (ii), (iii) we do not require (J;K) to be injective or (J;K) surjective, and instead of supposing (6) exact we require only that (K;L) (J;K) = 0. De ne morphisms of (I; )-precon gurations as in De nition 4.1. Write PC on f(I;;A) for the category of (I; )-precon gurations. Here is the analogue of Proposition 7.11.

Proposition 7.13. This PC onf(I; ;A) is an abelian category. If A is K-linear then PC onf(I; ;A) is K-linear.

Proof. We verify De nition 2.1 (i) { (iv). Parts (i) { (iii) and K-linearity are an easy generalization of Proposition 7.11. For (iv), suppose : ( $_2$ ;  $_2$ )! ( $_4$ ;  $_4$ ) lies in Mor(PConf(I; ;A)). For each J 2 F<sub>(I; )</sub>, apply De nition 2.1 (iv) to (J):  $_2$ (J)!  $_4$ (J) in A. This gives a sequence

$$_{1}\left( J\right) \overset{\left( J\right) }{\longrightarrow} _{2}\left( J\right) \overset{\left( J\right) }{\longrightarrow} _{3}\left( J\right) \overset{\left( J\right) }{\longrightarrow} _{4}\left( J\right) \overset{\left( J\right) }{\longrightarrow} _{5}\left( J\right)$$

in A with (J) (J) = (J), such that  $_1$  (J) is the kernel and  $_5$  (J) the cokemel of (J), and  $_3$  (J) is both the cokemel of (J) and the kernel of (J). For (J;K) 2 G $_{(I;)}$  and L = K nJ, the proof of Proposition 7.11 yields unique morphisms  $_a$  (J;K);  $_a$  (K;L) for a = 1;3;5 with  $_a$  (K;L)  $_a$  (J;K) = 0 tting into a commutative diagram



We must show ( $_a$ ;  $_a$ ;  $_a$ ) is an (I; )-precon guration for i=1;3;5. That is, we must prove that  $_a$  (J;J) =  $_a$  (J;J) =  $_a$  (J;J) =  $_a$  (J;J) for J 2 F  $_{(I;)}$ , and De nition 4.1(B)((D)) hold.

Putting J = K and L = ; in (39) and using  $_2(J) = id_{_2(J)}$  and  $_4(J) = id_{_4(J)}$ , uniqueness in (39) in plies that  $_a(J;J) = id_{_a(J)}$  for a = 1;3;5. A similar proof gives  $_a(J;J) = id_{_a(J)}$ . For (B), if (J;K); (K;L)  $2G_{(I,)}$  then

as (2;2;2)20bj(PConf(I; ;A)) and the top left square in (3)) commutes. But (L) is injective, so (3;1)1 (J;K) = (3;1)2, giving (B) for (3;1;1)2.

Sim ilar proofs using injectivity of (L) and surjectivity of (J); (J) prove (B)((D) for ( $_a$ ;  $_a$ ;  $_a$ ) for a = 1;3;5. Therefore

is a sequence in PC on f(I; ;A), which is easily seen to full De nition 2.1 (iv). So PC on f(I; ;A) is an abelian category.


Write C on f(I; ;A) for the category of (I; )-con gurations in A, a full subcategory of P C on f(I; ;A). Following P roposition 7.12 we prove:

Theorem 7.14. The category  $C \circ nf(I; ; A) \circ f(I; )$ -con gurations in A is an exact category. If A is K-linear then  $C \circ nf(I; ; A)$  is K-linear.

Proof. Clearly Conf(I; A) is a full subcategory of PConf(I; ; A) which contains zero and is closed under direct sum s, so it is an additive subcategory. We show it is closed under extensions. Suppose

is a short exact sequence in PConf(I; ;A) with (1;1;1), (3;3;3) in Obj(Conf(I;;A)). We must show that (2;2;2) 2 Conf(I;;A).

Let (J;K) 2  $G_{(I;)}$  and set  $L = K \, nJ$ . Then we have a com m utative diagram



in A, with the columns and rst and last rows exact. The proof of Proposition 7.12 now shows that the middle row is exact. As this holds for all (J;K) 2  $G_{(I;\ )}$ , ( $_{2}$ ;  $_{2}$ ) is an ( $_{1}$ ; )-con guration, and C on f( $_{1}$ ; A) is closed under extensions. This completes the proof.

U sing the ideas of x7.2, it is easy to generalize this to show that if (B;E) is an exact category then the category C on f(I; ;B) of (I; )-con gurations in B is also an exact category.

Let (J;.) be another nite poset. Then we can study (J;.)-con gurations in the exact category C on f(I; ;A), that is, (J;.)-con gurations of (I; )-con gurations in A. The category C on f(I; ;A) of such bon gurations of con gurations' is an exact category from above, so we can iterate this process inde nitely.

De ne K = I J, and a partial order E on K by (i;j) E  $(f;j^0)$  if i f and j.  $j^0$ . Then it can be shown that (J;.)-con gurations of (I;)-con gurations in A are essentially the same thing as (K;E)-con gurations in A. To be more precise, there is a natural forgetful functor

which is an equivalence of categories, since each (K;E)-con guration induces a unique (J;.)-con guration of (I;.)-con gurations, and conversely each (J;.)-con guration of (I;.)-con gurations comes from a (K;E)-con guration which is unique up to canonical isom orphism .

One moral of this is that (I; )-con gurations are a useful, universal idea, since operations on con gurations such as those of x5, or these con gurations of con gurations', tend to produce (K; E)-con gurations for another nite poset (K; E), rather than some more general object. We will seem ore examples of this in [6, 7], where we show that the transform ations of moduli spaces of stable (I; )-con gurations under change of stability condition can be fully described in terms of moduli spaces of (K; E)-con gurations, making con gurations a good tool for understanding stability.
