INTERSECTION HOMOLOGY AND ALEXANDER MODULES OF HYPERSURFACE COMPLEMENTS

Abstract. Let V be a degree d, reduced, projective hypersurface in ${\sf CP}^{n+1}$, n 1, and let H be a generic hyperplane. D enote by U the (a ne) hypersurface complement, ${\sf CP}^{n+1}$ V [H, and let U° be the in nite cyclic covering of U corresponding to the kernel of the linking number hom omorphism. U sing intersection homology theory, we give a new construction of the homological A lexander modules ${\sf H}_1({\sf U}^c;Q)$ of the hypersurface complement and show that, if i n, these global A lexander modules are torsion over the ring of Laurent polynomials with rational coecients. We also provide obstructions on the prime divisors of the associated global polynomials: their zeros are roots of unity of order d; moreover, the prime divisors of the global A lexander polynomials are restricted to those of the local A lexander polynomials of the link knots around the singular strata of a stratication of the pair (${\sf CP}^{n+1}; {\sf V}$). As an application, we obtain obstructions on the eigenvalues of monodrom y operators acting on the homology of the Milnor bre of a projective hypersurface arrangement.

1. Introduction

Intersection hom ology is the correct theory to extend results from $\,$ m anifolds to singular varieties: e.g., $\,$ M orse theory, Lefschetz (weak and hard) theorem s, $\,$ H odge

decom positions, but especially Poincare duality (which motivates the theory). It is therefore natural to use it in order to describe topological invariants associated with algebraic varieties.

Let V be a degree d, reduced, projective hypersurface in CP^{n+1} , n 1; let H be a xed hyperplane which we call the hyperplane at in nity; set $U = CP^{n+1}$ V [H. (A lternatively, let X C^{n+1} be a reduced a ne hypersurface and $U = C^{n+1}$ X.) Then $H_1(U) = Z^s$, where s is the number of components of V, and one proceeds, as in classical knot theory, to de ne A lexander-type invariants of the hypersurface V. M ore precisely, the rational homology groups of any in nite cyclic cover of U become, under the action of the group of covering transformations, modules over the ring of Laurent polynomials with rational coecients. The modules $H_1(U^c;Q)$ associated to the in nite cyclic cover U^c de ned by the kernel of the total linking number homomorphism, are called the A lexander modules of the hypersurface complement. Note that, since U has the homotopy type of a nite CW complex of dimension CW complex of CW complex of

It is known (see [26], [27], [28]) that, if V has only isolated singularities (including at in nity), then $H_1(U^c;Z) = 0$ for i < n, and $H_n(U^c;Q)$ is a torsion -module. If $_n(t)$ is the polynom ial associated to the torsion module $H_n(U^c;Q)$, then $_n(t)$ divides (up to a power of t -1) the product of the local A lexander polynom ials of the algebraic knots around the isolated singular points. Moreover, if we choose H to be a generic hyperplane, then the zeros of $_n(t)$ are roots of unity of order d. The case n=1 is discussed in [27], [28]. The higher dimensional analogue is treated in [26].

The aim of this paper is to provide generalizations of these results to the case of hypersurfaces with non-isolated singularities. We will assume that H is generic, i.e., transversal to all strata of a Whitney stratication of V. Using intersection hom ology theory, we will provide a new description of the Alexanderm odules of the hypersurface complement: these will be realized as intersection hom ology groups of CP^{n+1} , with a certain local coecient system with stalk $= Q[t;t^{-1}]$, dened on U. The latter will be called the intersection Alexanderm odules of the hypersurface V. Therefore, we will have at our disposal the apparatus of intersection hom ology and derived categories to study the Alexanderm odules of the complement.

The structure of the paper is as follows:

In Section 2, we recall the de nitions and main properties of the Alexander modules of the hypersurface complement, $H_{i}(U^{c};Q)$. We also show that, if V is in general position at in nity, has no codimension 1 singularities, and if V and $V \setminus H$ are rational homology manifolds, then for i n, the modules $H_{i}(U^{c};Q)$ are torsion and their associated polynomials do not contain factors of i (see Proposition 2.1).

In Section 3, we realize the A lexander m odules of complements to hypersurfaces in general position at in nity as intersection homology modules. In Section 3.1, we rst construct the intersection A lexander modules of the hypersurface V. More precisely, by choosing a Whitney stratication S of V and a generic hyperplane, H, we obtain a stratication of the pair (CP^{n+1} ; V [H). We do not a local system L_H on U, with stalk = Q [t; t⁻¹] and action by an element 2 1 (U) determined

by multiplication by $t^{lk\ (V\ [}$ dH;). Then, for any (super-)perversity p, the intersection homology complex $IC_p\ (CP^{n+1};L_H)$ is defined (as an object in the derived category ofbounded, constructible sheaves on CP^{n+1}) by using Deligne's axiom atic construction ([2], [15]). The intersection Alexander modules of the hypersurface V are then defined as hypercohomology groups of the middle-perversity intersection homology complex: $IH_i^m\ (CP^{n+1};L_H) := H^i\ (CP^{n+1};IC_m\ (CP^{n+1};L_H))$.

In Section 32, we set prove the key technical lem ma, which asserts that the restriction to V [H of the intersection homology complex IC $_{\rm m}$ (CP $^{\rm n+1}$; LH) is quasi-isom orphic to the zero complex (see Lem ma 3.1). As a corollary, it follows that the intersection A lexander modules of V coincide with the A lexander modules of the hypersurface complement, i.e. there is an isomorphism of -modules: IH $^{\rm m}$ (CP $^{\rm n+1}$; LH) = H (U°;Q). From now on, we will study the intersection A lexander modules in order to obtain results on the A lexander modules of the complement. U sing the superduality isomorphism for the local nite type codimension two embedding V [H CP $^{\rm n+1}$, and the peripheral complex associated with the embedding (see [4]), we show that the -modules IH $_{\rm i}^{\rm m}$ (CP $^{\rm n+1}$; LH) are torsion if i n (see Corollary 3.8). Therefore the classical A lexander modules of the hypersurface complement are torsion in the range i n. We denote their associated polynomials by $_{\rm i}$ (t) and call them the global A lexander polynomials of the hypersurface.

Section 4 contains the main theorems of the paper, which provide obstructions on the prime divisors of the polynomials $_{\rm i}$ (t). Our results should be interpreted as extensions to the case of hypersurfaces with general singularities of the results proven by A. Libgober for hypersurfaces with isolated singularities ([26], [27], [28]). The rst theorem gives a characterization of the zeros of the global polynomials. We prove the following:

Theorem 1.1. (see Theorem 4.1)

If V is an n-dim ensional reduced projective hypersurface of degree d, transversal to the hyperplane at in nity, then any root of the global A lexander polynomials $_{\rm i}$ (t), i n, is a root of unity of order d.

In the case of hypersurfaces with only isolated singularities, this specializes to Corollary 4:8 of [26].

The underlying idea of this paper is to use local topological inform ation associated with a singularity to describe some global topological invariants of algebraic varieties. Therefore, we provide a general divisibility result which restricts the prime factors of the global Alexander polynomial $_{\rm i}$ (t) to those of the local Alexander polynomials of the link knots around the singular strata. More precisely, we prove the following:

Theorem 1.2. (see Theorem 4.2)

Let V be a reduced hypersurface in CPⁿ⁺¹, which is transversal to the hyperplane at in nity, H , and x an arbitrary irreducible component, say Y. Let S be a W hitney stratication of the pair (CFⁿ⁺¹; V). Then for any inn, a prime 2 divides the order $_i$ (t) of the torsion -module H $_i$ (U°;Q) only if divides one of the local A lexander polynom ials $_1^{\rm S}$ (t) = order H $_1$ (S $^{\rm 2n}$ $^{\rm 2s+1}$ K $^{\rm 2n}$ $^{\rm 2s}$ $^{\rm 1}$;) associated to link pairs (S $^{\rm 2n}$ $^{\rm 2s+1}$; K $^{\rm 2n}$ $^{\rm 2s}$ $^{\rm 1}$) of s-dimensional strata S 2 S with S V1, for land s satisfying the following conditions:

if i < n, then for any s such that $1 \le n$, l satis es: $0 \le n \le n$ s and $0 \le 1 \le 2s$;

if i = n, then for any s such that 0 s n, l satis es: n 2s l n s.

For hypersurfaces with isolated singularities, the proof of the above theorem can be strengthened to obtain a result similar to Theorem 4.3 of [26] (in the absence of singular points at in nity):

Theorem 1.3. (see Theorem 4.5)

Let V be a reduced hypersurface in CP^{n+1} (n 1), which is transversal to the hyperplane at in nity, H, and has only isolated singularities. Fix an irreducible component of V, say V_1 . Then $_n$ (t) divides (up to a power of (t 1)) the product $_{p2\,V_1\setminus S\, ing\, (V)}$ $_p$ (t) of the local A lexander polynom ials of links of the singular points p of V which are contained in V_1 .

We end the section by relating the intersection A lexander modules of V to the modules 'at in nity'. We prove the following:

Theorem 1.4. (see Theorem 4.8)

Let V be a reduced hypersurface of degree d in CP^{n+1} , which is transversal to the hyperplane at in nity, H . Let S be a sphere of su ciently large radius in $C^{n+1}=CP^{n+1}$ H . Then for all i< n,

$$\text{IH}_{i}^{m} (CP^{n+1}; L_{H}) = H^{i} (S_{1}; IC_{m}) = H_{i}(U_{1}^{c}; Q)$$

and IH $_{n}^{m}$ (CP $^{n+1}$;LH) is a quotient of H $^{n-1}$ (S1;IC $_{m}$) = H $_{n}$ (U $_{1}^{c}$;Q), where U $_{1}^{c}$ is the in nite cyclic cover of S (V \ S1) corresponding to the linking number with V \ S1 (cf. [26]).

In the particular case of hypersurfaces with only isolated singularities, this is a version of Theorem 4:5 of [26].

In Section 5, we apply the preceding results to the case of a hypersurface $V = \mathbb{CP}^{n+1}$, which is a projective cone over a reduced hypersurface $Y = \mathbb{CP}^n$. We rst note that Theorem 4.2 specializes to divisibility results for the characteristic polynom ials of the monodrom y operators acting on the M ilnor ber F of the projective arrangement dened by Y in \mathbb{CP}^n . We prove the following:

Proposition 1.5. (see Proposition 5.1)

Let $Y=(Y_i)_{i=1;s}$ be a hypersurface arrangement in CP^n , and x an arbitrary component, say Y_1 . Let F be the M ilhor—bre of the arrangement. F ix a W hitney stratication of the pair $(CP^n;Y)$ and denote by Y the set of (open) singular strata. Then for q in 1, a prime 2 divides the characteristic polynomial P_q (t) of the monodrom Y operator P_q only if divides one of the polynomials P_q (t) associated to the local Alexander modules P_q (Since P_q in P_q and P_q in P_q in P

As a consequence, we provide obstructions on the eigenvalues of the ${\tt m}$ onodrom y operators:

For the special case of an arrangement with only normal crossing singularities, we obtain the following result from [5]:

Corollary 1.7. Let $A=(Y_i)_{i=1;s}$ be a hypersurface arrangement in CP^n , and x one irreducible component, say Y_1 . Assume that $\sum_{i=1;s} Y_i$ is a normal crossing divisor at any point $x \ 2 \ Y_1$. Then the monodrom y action on $H_q(F;Q)$ is trivial for $q \ n \ 1$.

Section 6 deals with examples. We show, by explicit calculations, how to apply the above theorems in obtaining information on the global Alexander polynomials of a hypersurface in general position at in nity.

The paper ends with an appendix in which we recall the basic results on the topology of hypersurface complements, and the Deligne construction of intersection hom ology complexes.

Note. Our overall approach in proving the above results makes use of sheaftheory and the language of derived categories ([2], [4], [15]) and we rely heavily on the basic material in these references. We will always use the indexing conventions of [15].

2. A lexander modules of hypersurface complements

In this section we recall the de nition and main results on the A lexanderm odules and polynomials of hypersurface complements. we also treat the special case of hypersurfaces which are rational homology manifolds.

2.1. De nitions. Let X be a connected CW complex, and let $_{\rm X}$: $_{\rm 1}$ (X)! Z be an epim orphism . We denote by X $^{\rm c}$ the Z-cyclic covering associated to the kernel of the morphism $_{\rm X}$. The group of covering transform ations of X $^{\rm c}$ is in nite cyclic and acts on X $^{\rm c}$ by a covering hom eom orphism h. Thus, all the groups H (X $^{\rm c}$;A), H (X $^{\rm c}$;A) and $_{\rm j}$ (X $^{\rm c}$) A for j > 1 become in the usual way $_{\rm A}$ -m odules, where $_{\rm A}$ = A [t;t $^{\rm 1}$], for any ring A. These are called the A lexander m odules of the pair (X; x).

If A is a eld, then the ring $_A$ is a P ID . Hence any nite type $_A$ -m odule M has a decomposition: M = ($_A$)^k ($_p M_p$), where k is the rank of M and the second sum is over all prime elements in $_A$. M $_p$ denotes the p-torsion part of M . M oreover, for each prime p w ith M $_p$ 6 0 we have a unique decomposition: M $_p$ = $_{i=1}^{m_p}$ $_A$ = $_p^{k_i}$ w ith m $_p$ > 0 and k_1 k_2 $_{m_p} k$ 1. The Alexander polynom ial of the $_A$ -m odule M is dened as the polynom ial (M) = $_p^{m_p} p_{i=1}^{k_i} p_i^{k_i}$. W ith the notations, we have the following simple fact: let f:M! N be

W ith these notations, we have the following simple fact: let f:M! N be an epim orphism of R-m odules, where R is a PID and M is torsion of nite type. Then N is torsion of nite type and (N) divides (M).

To x notations for the rest of the paper, let V be a reduced hypersurface in CP^{n+1} , de ned by a degree d hom ogeneous equation: $f = f_1$ s = f0, where f_i are the irreducible factors of f and $V_i = ff_i = 0g$ the irreducible components of V . W e w ill assume that V is in general position at in nity, i.e. we choose a generic hyperplane H (transversalto all singular strata in a strati cation of V) which we call the hyperplane at in nity. Let U be the (a ne) hypersurface complement: $U = CP^{n+1}$ (V [H). Then $H_1(U) = Z^s$ ([6], (41.3), (41.4)), generated by the meridian loops i about the non-singular part of each irreducible component V_i , i = 1; ;s. If denotes the m_eridian about the hyperplane at in nity, then in H $_1$ (U) there is a relation: $d_{i} = 0$, where $d_{i} = deg(V_{i})$. We consider the in nite cyclic cover U^{c} of Ude ned by the kernel of the total linking number hom om orphism $lk: _1(U) ! Z$, which maps all the meridian generators to 1, and thus any loop to lk(; V [dH). Note that lk coincides with the homomorphism $_1(U)$! $_1(C)$ induced by the polynom ialm ap de ning the a ne hypersurface $V_{aff} = V V \setminus H$ ([6], p. 76-77). The hom ological Alexander modules of the hypersurface complement are dened as $H_{i}(U^{c};Q)$.

Since U has the hom otopy type of a nite CW complex of dimension n+1 ([6] (1.6.7), (1.6.8)), it follows that all the associated A lexander modules are of nite type over $_A$, but in general not over $_A$. It also follows that the A lexander modules $_A$ ($_B$) are trivial for $_A$) and $_B$ $_A$ 1 and $_B$ 1 $_A$ 2 $_B$ 3 is free over $_B$ 3 ([8]).

Note that if V has no codimension 1 singularities (e.g., if V is normal), then the fundamental group of U is in nite cyclic ([26], Lemma 1.5) and U° is the universal cover of U. In particular, this condition if satished if n 2 and V has only isolated singularities (see also Appendix A): if this is the case, Libgober shows ([26]) that $\mathrm{H}'_i(\mathrm{U}^c;\mathrm{Z})=0$ for i< n, and $\mathrm{H}_n(\mathrm{U}^c;\mathrm{Q})$ is a torsion $_{\mathbb{Q}}$ -module. Also, one has the isomorphisms of the Alexander $_{\mathbb{Z}}$ -modules: $_n(\mathrm{U})=_n(\mathrm{U}^c)=\mathrm{H}_n(\mathrm{U}^c;\mathrm{Z})$; if we denote by $_n(\mathrm{U})$ the polynomial associated to the torsion module $\mathrm{H}_n(\mathrm{U}^c;\mathrm{Q})$, then Theorem 4.3 of [26] asserts that $_n(\mathrm{U})$ divides the product $_{i=1}^S$ i(t) (t 1) of the Alexander polynomials of links of the singular points of V. Moreover, the zeros of $_n(\mathrm{U})$ are roots of unity of order d = deg (V) ([26], Corollary 4.9).

Note. Libgober's divisibility theorem ([26], Theorem 4.3) holds for hypersurfaces with isolated singularities, including at in nity (and n 1). However, for nongeneric H and for hypersurfaces with more general singularities, the Alexander modules $\mathrm{H}_{\,\mathrm{i}}(\mathrm{U}^{\,\mathrm{c}};\mathrm{Q})$ (i n) are not torsion in general. Their __Q rank is calculated in [8], Theorem 2.10 (v). We will show that if V is a reduced hypersurface, in general position at in nity, then the modules $\mathrm{H}_{\,\mathrm{i}}(\mathrm{U}^{\,\mathrm{c}};\mathrm{Q})$ with i n, are torsion.

2.3. R ational hom ology m anifolds. Recall that a n-dimensional complex variety V is called a rational homology manifold, or is said to be rationally smooth, if for all points x 2 V we have:

$$H_{i}(V;V \quad x;Q) = \begin{cases} Q; & i = 2n \\ 0; & i \notin 2n \end{cases}$$

A rationalhom ology manifold of dimension n has pure dimension n as a complex variety. Rationalhom ology manifolds may be thought of as 'nonsingular for the purposes of rationalhom ology'. For example, Poincare and Lefschetz duality hold

for them in rational homology. The Lefschetz hyperplane section theorem also holds.

Exam ples of rational hom ology manifolds include complex varieties having rational hom ology spheres as links of singular strata. To see this, let cbe the codim ension of the stratum (in a W hitney strati cation) of V containing x, and let L_x be its link in V. Then we have:

$$H_{i}(V;V = x;Q) = \begin{pmatrix} & & & & & & & \\ & H_{i}(2n+2c + 1)(L_{x};Q); & i > 2n & 2c \\ & 0; & & i & 2n & 2c \end{pmatrix}$$

Indeed, since a neighborhood of x in V is hom eom orphic to C^n c (L_x) (where c (L_x)) is the open cone on L_x),

$$\begin{split} \text{H}_{\text{i}}(V; V & \text{x;Q}) = \text{H}_{\text{i}}(\text{C}^{\text{n-c}} & \text{c} (\text{L}_{\text{x}}); \text{C}^{\text{n-c}} & \text{c} (\text{L}_{\text{x}}) & \text{f}(0; \text{x}) \text{g;Q}) \\ & \text{(excision and local norm altriviality)} \\ & = \text{H}_{\text{i}}_{2n+2c}(\text{c} (\text{L}_{\text{x}}); \text{c} (\text{L}_{\text{x}}) & \text{x;Q}) & \text{(K unneth form ula)} \\ & = \text{H}_{\text{i}}_{2n+2c-1}(\text{c} (\text{L}_{\text{x}}) & \text{x;Q}) & \text{(long exact sequence of pair)} \\ & = \text{H}_{\text{i}}_{2n+2c-1}(\text{L}_{\text{x}}; \text{Q}) & \text{(deform ation retract);} \end{split}$$

which can be non-zero only if i> 2n 2c. Therefore, the assumption that the links of singular strata are rational homology spheres gives the desired result.

Note that, if V is a projective hypersurface having rational homology spheres as links of singular strata and H is a generic hyperplane, then V \ H is a rational homology manifold: indeed, by the transversality assumption, the link in V \ H of a stratum S \ H (for S a stratum of V) is the same as the link in V of S.

As a set example when the A lexander m odules H $_{\rm i}$ (U $^{\rm c}$;Q), i n, are torsion, we mention the following (compare [26], Lem m a 1.7, 1.12):

Proposition 2.1. Let V be a degree d projective hypersurface in CP^{n+1} , and let H be a generic hyperplane. A ssume that V has no codimension 1 singularities and that V and V \ H are rational homology manifolds. Then for i n, H_i(U^c;Q) is a torsion $_{\mathbb{Q}}$ -m odule and $_{\mathbb{I}}(1)$ $\stackrel{\leftarrow}{\bullet}$ 0, where $_{\mathbb{I}}(t)$ is the associated A lexander polynomial.

Note. We regard the trivial module (0) as a torsion module whose associated polynomial is (t) = 1.

Proof. Recall that, under our assumptions, U^c is the in nite cyclic and universal cover of $U = CP^{n+1}$ (V [H). We will use M ilnor's exact sequence ([26], [8]):

where the rst morphism is multiplication by t 1. We claim that H $_1$ (U;Q) = 0 for 2 i n, hence the multiplication by t 1 in H $_1$ (U°;Q) is surjective (2 i n). Therefore its cyclic decomposition has neither free sum m ands nor sum m ands of the form $_Q = (t \ 1)^r _Q$, with r 2 N. On the other hand, H $_1$ (U°;Q) = $_1$ (U°) $_2 = 0$.

Suppose that k is the dimension of the singular locus of V. Then, by our assumptions, n k 2. Let $L = CP^{n-k}$ be a generic linear subspace. Then, by transversality, $L \setminus V$ is a non-singular hypersurface in L, transversal to the hyperplane at in nity, $L \setminus H$. Therefore, by Corollary 1.2 of [26], $L \setminus U$ is hom otopy

equivalent to S¹_S^{n k}_ " \$\text{ . Thus, by Lefschetz hyperplane section theorem (applied k + 1-times) we obtain: $H_i(U;Q) = H_i(L \setminus U;Q) = 0; 2 i n$ For n k i n we have: $H_i(U;Q) = H_{i+1}(CP^{n+1}) + CP^{n+1}$ H);Q), as follows from the exact sequence of the pair (CP^{n+1} H; CP^{n+1} H)). Using duality, one can identify this with H $^{2n+1}$ i (V [H;H;Q). And by excision, this group is isomorphic to H $^{2n+1}$ i (V; V \ H;Q). Let u and v denote the inclusion of $V \setminus H$ and respectively $V \setminus H$ into V. Then the distinguished triangle u;u'Q ! Q ! v v Q ! (where we regard Q as a constant sheaf on V), upon applying the hypercohom ology with compact support functor, yields the isom orphism: H^{2n+1} i(V; V \ H;Q) = H_c^{2n+1} i(V \ V \ H;Q) (see [7], Remark 2.4.5.(iii)). By Poincare duality over Q , the latter is isomorphic to H $_{\rm i}$ $_{\rm 1}$ (V $_{\rm V}$ \ H;Q). The Lefschetz theorem on generic hyperplane complements in hypersurfaces ([9], p. 476) im plies that V V \ H is hom otopy equivalent to a wedge of spheres S^n . Therefore, $H_{i,1}$ (V V \ H;Q) = 0 for 0 < i 1 < n, i.e. for 2 n k i n. This nishes the proof of the proposition.

(Note that the assertion also follows by an argument similar to the one used in Lemma 1.7 of [26]: indeed, from the long exact sequence of the pair (V;V \ H), it su ces to show that the restriction map H j (V;Q)! H j (V \ H;Q) is onto if j = n, bijective if j = n + 1;::;n + k, and injective if j = n + k + 1 (note that under our assumptions, n + k + 1 < 2n); next note that from Poincare duality over Q and the Lefschetz hyperplane theorem , the hom ology groups dual to the cohom ology groups involved are isomorphic to either Q or 0 depending on the parity of n).

R em ark 2.2. There is a diesent construction of Alexander-type modules associated with a projective hypersurface (see [6]): if f is the degree d polynom ial dening V and F = ff = 1g is the global M ilhor ber of the (non-isolated) hypersurface singularity at the origin in C^{n+2} , A.D im cade nest he Alexander modules of V as being the -modules H $_i$ (F;Q), with module structure induced by the monodrom y action; the corresponding Alexander polynomials of the hypersurface are dened as being the characteristic polynomials P_i (t) of the monodrom y operators. He also shows that if V is a hypersurface with isolated singularities, then P_n (t) divides the product of the reduced local Alexander polynomials of the singularities (V;p), p 2 Sing(V). The relation with the divisibility theorem of Libgober is provided by the following observation ([26], Corollary 4.9): if V has only isolated singularities and is transversal to the hyperplane at in nity, there is an isomorphism of -modules

A nother interesting exam ple when the A lexander m odules H $_{\rm i}$ (U $^{\rm c}$;Q), i n, are torsion is the following: let Y = ff = 0g be a degree d reduced hypersurface in C P $^{\rm n}$, and let X be the a ne cone on Y, i.e. X is the a ne hypersurface in C $^{\rm n+1}$ de ned by the hom ogeneous polynom ial f. W e let V be the projective closure of X in C P $^{\rm n+1}$, i.e. V is the projective cone on Y. It's clear that V is transversal to the hyperplane at in nity. M oreover, the in nite cyclic cover U $^{\rm c}$ of the complement U = C $^{\rm n+1}$ X (corresponding to the evaluation of the linking number with X) is hom otopy equivalent to the M ilnor bre F of the global M ilnor bration of the hom ogeneous polynom ial f, F ,! C $^{\rm n+1}$ X ! $^{\rm f}$ C , therefore it has the hom otopy type of a nite dimensional CW complex. Hence the A lexander modules of

the complement of X , H $_1$ (U $^\circ$;Q), are nite dimensional over the eld of rational numbers, thus torsion $_{}$ -m odules. Their orders are identified with the characteristic polynomials of the m onodrom y operators of the M ilnor bration. Note that these coincide with the A lexander-type invariants of the hypersurface Y $_{}$ CP $^{\rm n}$, as considered by D in ca (see the previous remark). They also appear in the literature under the name of characteristic polynomials of the monodrom y operators acting on the homology of the M ilnor ber F of the projective hypersurface arrangement dened by f in CP $^{\rm n}$ (see also x5).

3. Intersection Homology and Alexander modules

U sing intersection hom ology theory, we will give a new construction of the A lexander modules of complements of hypersurfaces in general position at in nity. The advantage of the new approach is the use of the powerful language of sheaf theory and derived categories ([15], [2]) in the study of the A lexander invariants associated with singular hypersurfaces. This will be done in the next section. In particular, we will provide generalizations to classical results known only in the case of hypersurfaces with isolated singularities ([26]). For a quick introduction to derived categories, the reader is advised to consult [31], x1. When dealing with intersection homology, we will always use the indexing conventions of [15].

3.1. Intersection A lexander M odules. (1) A knot is a sub-pseudom anifold K $^{\rm n}$ S $^{\rm n+2}$ of a sphere; it is said to be of nite (hom obgical) type if the hom ology groups H $_{\rm i}$ (S $^{\rm n+2}$ K;) with local coe cients in = Q [t;t $^{\rm 1}$] are nite dimensional over Q . Here denotes the local system on S $^{\rm n+2}$ K , with stalk , and it corresponds to the representation ~ T $t^{\rm lk\,(K;\;)}$, ~ 2 $_{\rm 1}$ (S $^{\rm n+2}$ K), where lk (K;) is the linking number (see [4]).

A sub-pseudom anifold X of a manifold Y is said to be of nite local type if the link of each component of any stratication of the pair (Y; X) is of nite type. Note that a sub-pseudom anifold is of nite local type if and only if it has one stratication with links of nite type. It is also not hard to see that the link pairs of components of strata of a sub-pseudom anifold of nite local type also have nite local type ([4]). A lgebraic knots are of nite type and of nite local type ([4]).

(2) Let V be a reduced projective hypersurface of degree d in CP^{n+1} (n Choose a W hitney strati cation S of V. Recall that there is such a strati cation where strata are pure dimensional locally closed algebraic subsets with a nite number of irreducible nonsingular components. Together with the hypersurface com plem ent, CP^{n+1} V, this gives a stratication of the pair $(CP^{n+1}; V)$, in which S is the set of singular strata. A ll links of strata of the pair (\mathbb{CP}^{n+1} ; \mathbb{V}) are algebraic, CP^{n+1} is of nite local type (see [4], hence of nite (hom ological) type, so V Proposition 22). We choose a generic hyperplane H in CP^{n+1} , i.e., transversal to all the strata of V, and consider the induced stratic cation on the pair (CP^{n+1} ; V [H). We call H 'the hyperplane at in nity' and say that 'V is transversal to the hyperplane at in nity'. Following [4], we de ne a local system L_H on CP^{n+1} (V [H), with stalk = 0 = Q [t; t¹] and action by an element 2 1 ($\mathbb{C}P^{n+1}$ V [H) determ ined by multiplication by $t^{lk\ (V\ [}$ dH;). Here $lk\ (V\ [$ dH;) is the linking number of with the divisor V [dH of CP^{n+1} . (Note that V dH is a boundary in the hom ology of the projective space, as [V] = d[H] for generic hyperplane H.) Then,

(using a triangulation of the projective space) V = H is a (PL) sub-pseudom anifold of CP^{n+1} and the intersection complex $IC_p := IC_p (CP^{n+1}; L_H)$ is defined for any (super-)perversity p. The modules

will be called the intersection A lexander m odules of the hypersurface V . Note that these modules are of nite type over , since IC $_{\rm p}$ is cohomologically constructible ([2], V 3.12) and CP $^{\rm n+1}$ is compact (see [2], V 3.4.(a), V 10.13).

It will be useful to describe the links of the pair (CPⁿ⁺¹;V [H) in term sof those of (CPⁿ⁺¹;V). Because of the transversality assumption, there are stratications fZ_{ig} of (CPⁿ⁺¹;V) and fY_{ig} of (CPⁿ⁺¹;V [H) with Y_i = Z_i [(Z_{i+2}\ H) (here the indices indicate the real dimensions). The link pair of a point y 2 (Y_i Y_i 1)\ H = (Z_{i+2} Z_{i+1})\ H in (CPⁿ⁺¹;V [H) is (G;F) = (S¹ G₁;(S¹ F₁) [G₁), where (G₁;F₁) is the link pair of y 2 Z_{i+2} Z_{i+1} in (CPⁿ⁺¹;V). Points in V V \ H have the same link pairs in (CPⁿ⁺¹;V) and (CPⁿ⁺¹;V [H). Finally, the link pair at any point in H V \ H is (S¹;;). (For details, see [4]).

By Lem m a 2.3.1 of [4], V [H CP^{n+1} is of nite local type. H ence, by T heorem 3.3 of [4], we have the following isom orphism (the superduality isom orphism):

(here A op is the $^{-m}$ odule obtained from the $^{-m}$ odule A by composing all module structures with the involution t! t 1 .) Recall that the middle and logarithmic perversities are defined as: m(s) = [(s 1)=2] and 1(s) = [(s + 1)=2]. Note m(s) + 1(s) = s 1, i.e. m and lare superdual perversities.

(3) With the notations from x2, we have an isom orphism of -modules:

where L_H is the local coe cient system on $U=CP^{n+1}$ (V [H) de ned by the representation : 1(U)! Aut() = , () = $t^{lk}(;V)^{(n-1)}$.

Indeed, U° is the covering associated to the kernel of the linking number hom om orphism lk: $_1$ (U)! Z, 7 k(;V [dH), and note that factors through lk, i.e. is the composition $_1$ (U)! lk Z!, with the second hom om orphism mapping 1 to t. Thus Ker(lk) Ker(). By de nition, H (U;LH) is the hom ology of the chain complex C (U;LH) de ned by the equivariant tensor product: C (U;LH) = C (U°) $_{\rm Z}$, where Z stands for the group of covering transform ations of U° (see [7], page 50). Since = Q [Z], the chain complex C (U°) $_{\rm Z}$ is clearly isom orphic to the complex C (U°) Q, and the claim ed isom orphism follows. For a similar argument, see also [20], Example 3H 2.

(4) This is also a convenient place to point out the following fact: because m (2) = 0, the allowable zero—and one-chains ([14]) are those which lie in ${\rm CP}^{n+1}$ (V [H). Therefore,

32. Relation with the Alexander modules of the hypersurface complement. Let V be a degree d, reduced, projective hypersurface, and let H be a generic hyperplane, i.e. transversal to all the strata of a W hitney stratication of V. If S denotes the set of components of (open) singular strata in a stratication of (CP $^{n+1}$; V), then V [H is of nite local type in CP $^{n+1}$, and it has an induced stratication with (open) strata of the form S S\H,S\H and H V\H, for S2S.

W e are aim ing to show that, in our setting, the intersection A lexander m odules of a hypersurface coincide with the classical A lexander m odules of the hypersurface complement. The key fact will be the following characterization of the support of the intersection hom ology complex IC_m :

Lem m a 3.1. There is a quasi-isom orphism:

Proof. It su ces to show the vanishing of stalks of the complex IC $_{\rm m}$ at points in strata of V [H . W e will do this in two steps: Step 1.

The link pair of H $V \setminus H$ is $(S^1;;)$ and this maps to t d under L_H , therefore the stalk of IC_m (CPⁿ⁺¹;L_H) at a point in this stratum is zero. Indeed (cf. [2], V 3.15), for x 2 H $V \setminus H$:

The stalk at x 2 S \ H of the intersection hom ology com plex IC_m (CP^{n+1} ;L_H) is given by the local calculation formula ([2], (3.15)):

Thus, by induction on dimension we obtain:

Let $x \mid S \mid S \mid H$ be a point in an ane stratum of complex dimension S. The stalk cohomology calculation yields:

Note. The same property holds for link pairs of strata S 2 S of a stratic cation of the pair $(CP^{n+1}; V)$ since all of these are algebraic knots and have associated M ilnor brations.

Proof of km m a. We will prove the above claim by induction down on the dimension of singular strata of the pair (C^{n+1} ; V_{aff}). To start the induction, note that the link pair of a component of the dense open subspace of V_{aff} (i.e., for s=n) is a circle (S^1 ;;), that maps to tunder L_H . Moreover, the (intersection) homology groups IH $_{i}^{m}$ (S^1 ;) = H $_{i}$ (S^1 ;) are zero, except for i=0, hence the claim is trivially satis ed in this case.

Let S be an s-dimensional stratum of V_{aff} and let x be a point in S. Its link pair $(S_x^{2n-2s+1};K_x)$ in $(C^{n+1};V_{aff})$ is a singular algebraic knot, with a topological stratication induced by that of $(C^{n+1};V_{aff})$. The link pairs of strata of $(S_x^{2n-2s+1};K_x)$ are also link pairs of higher dimensional strata of $(C^{n+1};V_{aff})$ (see for example [10]). Therefore, by the induction hypothesis, the claim holds for such link pairs.

Let $IC = IC_m$ ($S_x^{2n-2s+1}$;) be the m iddle-perversity intersection cohomology complex associated to the link pair of S at x. In order to prove the claim, it su ces to show that its restriction to K is quasi-isom orphic to the zero complex, i.e. $IC_K = 0$. Then the lem mawill follow from the long exact sequence of compactly supported hypercohomology and from the fact that the ber F_x of the Milnor bration associated with the algebraic knot ($S_x^{2n-2s+1}$; K_x) has the homotopy type of an (n s)-dimensional complex ([32], Theorem 5.1) and is homotopy equivalent to the in nite cyclic covering $S_x^{2n-2s+1}$ K_x of the knot complement, which is dened by the linking number homomomorphism. More precisely, we obtain the isomorphisms:

Note that the above formulas, as well as the claim of the rst step of the previous lem m a, can also be obtained from the formula for the intersection homology of a join ([17], Proposition 3), applied to $G = G_1$ S^1 .

From the above considerations, the zeros of the polynom ials I $_{i}^{m}$ (G) and I $_{i}^{1}$ (G) (in the non-trivial range) are all roots of unity of order d.

C orollary 3.4. Let V be an n-dimensional reduced projective hypersurface, transversal to the hyperplane at in nity, H. Then the intersection A lexander modules of V are isomorphic to the classical A lexander modules of the hypersurface complement, i.e.,

upon applying the hypercohom ology functor, yields the isom orphism:

where H $^{\rm B\,M}$ denotes the Borel-M core hom ology. By Artin's vanishing theorem ([37], Example 6.0.6), the latter module is 0 for i < n + 1, since CP $^{\rm n+1}$ V [H is a Stein space of dimension n + 1.

Recall that the peripheral complex R , associated to the nite local type codimension two embedding V [H CP^{n+1} , is dened by the distinguished triangle ([4]):

M oreover, R is a perverse (for an introduction to the theory of perverse sheaves, see [31]), self-dual (i.e., R = DR $^{\rm op}$ [2n + 3]), torsion sheaf on CP $^{\rm n+1}$ (i.e., the stalks of its cohomology sheaves are torsion modules). All these properties are preserved by restriction to open sets.

By applying the hypercohom ology functor to the triangle de ning the peripheral complex R , and using the vanishing of the previous lem m a, we obtain the following:

Proposition 3.7. The natural maps:

Now, since R is a torsion sheaf (having nite dimensional rational vector spaces as stalks), the spectral sequence for hypercohomology implies that the groups $H^q(\mathbb{CP}^{n+1};\mathbb{R})$, q 2 Z, are also nite dimensional rational vector spaces, thus torsion -m odules. Therefore, the above proposition yields the following important feature of the (intersection) A lexander m odules associated with reduced hypersurfaces in general position at in nity:

Corollary 3.8. Let V CP^{n+1} be a reduced, n-dimensional projective hypersurface, transversal to the hyperplane at in nity. Then for any i n, the module IH_i^m (CP^{n+1} ; L_H) = H_i (U^c ; Q) is a nitely generated torsion -module.

Note. For i n, H $_{i}$ (U c ;Q) is actually a nite dimensional rational vector space, thus its order coincides with the characteristic polynomial of the Q-linear map induced by a generator of the group of covering transform ations (see [33]).

De nition 3.9. For i n, we denote by $_i$ (t) the polynom ial associated to the torsion module H $_i$ (U c ;Q), and call it the i-th global A lexander polynom ial of the hypersurface V . These polynom ials will be well-de ned up to multiplication by ct, c 2 Q .

As a consequence of the previous corollary, we obtain the following relation between the Euler characteristic of the (a ne) complement $U=CP^{n+1}$ V [H and the -rank of H $_{n+1}$ (U^{c} ;Q):

C orollary 3.10. Let $V = CP^{n+1}$ be a reduced, n-dim ensional projective hypersurface, in general position at in nity. Then the -rank of H_{n+1} (U^c ;Q) is expressed in terms of the Euler characteristic (U) of the complement by the formula:

Proof. The equality follows from the above corollary, from the fact that for q > n+1 the Alexander modules H $_q$ (U c ;Q) vanish, and from the form ula 2.10 (v) of [8]:

4. The Main Theorems

We will now state and prove the main theorems of this paper. These results are generalizations of the ones obtained by A. Libgober ([26], [27], [28]) in the case of hypersurfaces with isolated singularities, and will lead to results on the monodrom y of the Milnor ber of a projective hypersurface arrangement, similar to those obtained by Libgober ([29]), D im ca ([7], [5]) etc (see x5).

The rst theorem provides a characterization of the zeros of global A lexander polynom ials. For hypersurfaces with only isolated singularities, it specializes to C orollary 4.8 of [26]. It also gives a rst obstruction on the prime divisors of the global A lexander polynom ials of hypersurfaces:

Theorem 4.1. If V is an n-dimensional reduced projective hypersurface of degree d, transversal to the hyperplane at in nity, then for in n, any root of the global Alexander polynomial $_{\rm i}$ (t) is a root of unity of order d.

Proof. Let k and l be the inclusions of C $^{n+1}$ and respectively H into C P $^{n+1}$. For a xed perversity p, we will denote the intersection complexes IC $_p$ (C P $^{n+1}$; L $_H$) by IC $_p$. We will also drop the letter R when using derived functors. The distinguished

triangle: $l \ l' \ !$ id $! \ k \ k \ !^{[1]}$, upon applying the hypercohom ology functor, yields the following exact sequence:

Note that the complex k IC $_m$ [n 1] is perverse w ith respect to the m iddle perversity (since k is the open inclusion and the functor k is t-exact; [1]). Therefore, by Artin's vanishing theorem for perverse sheaves ([37], Corollary 6.0.4), we obtain:

Then, in order to nish the proof of the theorem, it su ces to study the order of the module H $^{\rm i}$ $^{\rm 2n}$ $^{\rm 1}$ (H;1 R $^{\rm op}$), for i n, and to show that the zeros of its associated polynomial are roots of unity of order d. This follows by using the hypercohom ology spectral sequence, since the stalks of R $^{\rm op}$ at points of H are torsion modules whose associated polynomials have the desired property: their zeros are roots of unity of order d (see Remark 3.3 concerning the local intersection A lexander polynomials associated to link pairs of strata of V \ H).

Note. The above theorem is also a generalization of the following special case. If V is a projective cone on a degree d reduced hypersurface Y = ff = 0g $\,$ CP n , then as observed in x2, H $_i$ (U c ;Q) = H $_i$ (F;Q), where F is the ber of the global M ilnor bration C $^{n+1}$ f 1 (0) ! C of the hom ogeneous polynom ialf. Therefore the zeros of the global A lexander polynom ials of V coincide with the eigenvalues of the m onodrom y operators acting on the hom ology of F. Since the m onodrom y has nite order d, all these eigenvalues are roots of unity of order d.

Next we prove a divisibility theorem relating the prime divisors of the polynom ials $_{i}$ (t) to the local (intersection) A lexander polynom ials of the link knots around the strata of V in a strati cation of the pair (CPⁿ⁺¹;V). This should be interpreted as an extension to the case of general singularities of a result due to A.Libgober ([26], Theorem 4.3; [28], Theorem 4.1 a), which gives a similar fact for the hypersurfaces with isolated singularities.

Theorem 4.2. Let V be a reduced projective hypersurface in CP^{n+1} , which is transversal to the hyperplane at in nity, H, and x an arbitrary irreducible component, say V_1 . Let S be a W hitney stratication of the pair $(CP^{n+1};V)$. Then for any xed positive integer in, a prime element 2 divides the order $_i$ (t) of the torsion -m odule IH $_i^m$ $(CP^{n+1};L_H) = H_i(U^c;Q)$ only if divides one of the polynom ials $_1^s$ associated to the local (intersection) A lexander modules IH $_1^m$ $(S^{2n-2s+1};L) = H_1(S^{2n-2s+1} + K^{2n-2s-1}; Of link pairs (S^{2n-2s+1};K^{2n-2s-1})$ of components of strata S 2 S of complex dimensions with S V_1 , for land s satisfying the following conditions:

if i < n, then for any s such that $1 \le n$, l satis es: $0 \le l \le n$ s and $0 \le l \le 1$; if i = n, then for any s such that $0 \le n$, l satis es: $n \le 2 \le l \le n$ s.

Note. (1) If k is the complex dimension of the singular locus of V and if n k 2, then $_{i}$ (t) 1 for 1 i < n k. This is a consequence of [26], Lemma 15. (2) The polynomials associated to the algebraic knots around the components of the zero stratum of V (if any), may only contribute to the global A lexander polynomial $_{n}$ (t).

Proof. Since V_1 is an irreducible component of V, it acquires the induced stratication from that of V. By the transversality assumption, the stratication S of the pair $(CP^{n+1};V)$ induces a stratication of the pair $(CP^{n+1};V)$ [H).

Let j and i be the inclusions of CP^{n+1} V_1 and respectively V_1 into CP^{n+1} . For a xed perversity p we will denote the intersection complexes IC_p (CP^{n+1} ; L_H) by

By the com pactly supported hypercohom ology long exact sequence and induction on the strata of V_1 , the polynom ial associated to H i 2n i $(V_1; i R ^{op})$ will divide the product of the polynom ials associated with all the modules H i_c 2n i $(V_1; i R ^{op})$, where V runs over the strata of V_1 in the strati cation of the pair $(CP^{n+1}; V [H])$, i.e. V is of the form $S \setminus H$ or $S \subseteq S \setminus H$, for $S \subseteq S$ and $S \cap V_1$. Moreover, if $i \in I$ is a restrict only to strata of the form $S \setminus H$ contained in $V_1 \setminus H$, for $S \subseteq S$. The zero-dimensional strata of V_1 only contribute to the module IH_1^m $(CP^{n+1}; L_H)$. (This observation will play a key role in the proof of Proposition 5.1 of the next section.) Indeed, by replacing V_1 by V in the arguments from the beginning of the proof, we obtain in a similar way that, for $i \in I$, the module IH_1^m $(CP^{n+1}; L_H)$ is a quotient of IH_1^m $(V_1; R^{-op})$. Next, consider the long exact sequence of compactly supported hypercohom ology groups associated to the disjoint union $V = V_{aff} t \in V \setminus H$):

where the rst isom orphism follows from the fact that the support on the peripheral complex is contained in V [H , and the vanishing follows from the Artin's theorem ([37], Corollary 6.0.4), applied to the perverse sheaf (in the sense of [1]) R $^{\rm op}$ [n 1] on the a ne space. Therefore, from the long exact sequence we have that, for i < n, H $^{\rm i}$ $^{\rm 2n}$ $^{\rm 1}$ (V; R $^{\rm op}$ j,) is a submodule of the torsion module H $_{\rm c}^{\rm i}$ $^{\rm 2n}$ $^{\rm 1}$ (V \ H; R $^{\rm op}$), and thus its associated polynomial is entirely determined by the polynomials associated to modules H $_{\rm c}^{\rm i}$ $^{\rm 2n}$ $^{\rm 1}$ (V; R $^{\rm op}$ j,), where V runs over the strata of V \ H in the stratication of the pair (C P $^{\rm n+1}$; V [H), i.e. V is of the form S \ H for S 2 S . Therefore, our claim follows.

Next, we will need the following:

Lem m a 4.3. Let V be a j-dim ensional stratum of V_1 in the stratic cation of the pair (CPⁿ⁺¹; V [H). Then the prime factors of the polynom ial of H_c^{i} $^{2n-1}$ (V; R op J_y) must divide one of the polynom ials I_1^{j} (t) = orderfIH I_1^{m} (S^{2n-2j+1}; L)g, in the range 0 l n j and 0 i l 2j, where (S^{2n-2j+1}; K^{2n-2j-1}) is the link pair of V in (CPⁿ⁺¹; V [H).

Once the lemma is proved, the rest of the theorem follows from Remark 3.3 which describes the polynomials of link pairs of strata $S \setminus H$ of $V \setminus H$ in $(CP^{n+1}; V \mid H)$ in terms of the polynomials of link pairs of strata $S \setminus S$ of V in $(CP^{n+1}; V)$, and Lemma 3.2 which relates the local intersection A lexander polynomials of links of strata $S \setminus S$ to the classical local A lexander polynomials.

Proof of Lem m a. For simplicity, we let r = i 2n 1. The module $H_c^r(V; R^{op}_j)$ is the abuttem ent of a spectral sequence with E_2 term given by:

Since R op is a constructible complex, H q (R op j_y) is a local coe cient system on V. Therefore, by the orientability of V and the Poincare duality isom orphism ([3], V .9.3), E $_2^{p,q}$ is isom orphic to the module H $_{2j}$ p (V; H q (R op j_y)). As in Lemma 9.2 of [10], we can show that the latter is a nitely generated module. More precisely, by deform ation retracting V to a closed, hence nite, subcomplex of V₁ (or CP $^{n+1}$), we can use simplicial homology with local coe cients to calculate the above E $_2$ terms.

We will keep the cohom ological indexing in the study of the above spectral sequence (see, for example, [10]). By the above considerations, we may assume that V is a nite simplicial complex.

 $E_2^{p,q}$ is the p-th hom ology of a cochain complex C_c (V;H q (R op \mathbf{j}_y)) whose p-th cochain group is a subgroup of C^p (V;H q (R op \mathbf{j}_y)), which in turn is the direct sum of modules of the form H q (R op) $_{\mathbf{x}()}$, where $\mathbf{x}()$ is the barycenter of a p-sim plex of V V_1 . By the stalk calculation ([2], V 3.15) and using IC_m $\mathbf{j}_y = 0$,

(where $L_{x()} = S^{2n-2j+1}$ is the link of V in (CPⁿ⁺¹; V [H)). Given that $E_2^{p,q}$ is a quotient of C_c^p (V; H^q (R^{op}j_y)), we see that $E_2^{p,q}$ is a torsion module, and a prime

element 2 divides the order of $E_2^{p,q}$ only if it divides the order of one of the torsion modules IH $^m_{2n+1+q}(L_{x(\cdot)};L)$. Denote by $^j_{2n+1+q}(t)$ the order of the latter module, where j stands for the dimension of the stratum.

Each $E_r^{p,q}$ is a quotient of a subm odule of $E_{r-1}^{p,q}$, so by induction on r, each of them is a torsion -m odule whose associated polynom ialhas the same property as that of E_2 . Since the spectral sequence converges in nitely many steps, the same property is satis ed by E_1 .

By spectral sequence theory,

Now set $A = H_c(V; R^{op})$ as a graded module which is litered by F^pA and set $E_0^p(A) = F^pA = F^{p+1}A$. Then, for some N, we have:

Let us see what happens at the rth grade of these graded modules. For clarity, we will indicate the grade with a superscript following the argument. For any p,

We know that each of the prime factors of the polynomial of this module must be a prime factor of some j (t). Further, by dimension considerations and stalk calculation, we know that $E_1^{p,r}$ can be non-trivial only if 0 p 2j and 2n 1 r p n j 1. Hence, as p varies, the only prime factors under consideration are those of j (t) in this range, i.e they are the only possible prime factors of the E_0^p (A) j, collectively in p (but within the grade r).

By induction down the above list of short exact sequences, we conclude that $F^NA^r=E_0^N(A)^r$, and subsequently $F^{N-1}A^r$, $F^{N-2}A^r$,:::, F^0A^r , and A^r , have the property of being torsion modules whose polynomials are products of polynomials whose prime factors are all factors of one of the $\frac{j}{2n+1+a}$ (t), where a must be chosen in the range 0 r a 2j and 2n 1 a n j 1. Since

 $H_c^r(V;R^{op}j_v)$ is the submodule of A corresponding to the rth grade, it too has this property. Using the fact that r=i 2n 1 and reindexing, we conclude that the prime factors of the polynomial of H_c^{i} ²ⁿ ¹(V;R ^{op}j_v) must divide one of the polynomials j(t) = orderfIH $_1^m$ (S²ⁿ ^{2j+1};L)g, in the range 0 1 n j and 0 i 1 2j, where S²ⁿ ^{2j+1} is the link of (a component of) V.

Remark 4.4. Isolated singularities

In the case of hypersurfaces with only isolated singularities, the previous theorem can be strengthen as follows.

A ssum e that V is an n-dimensional reduced projective hypersurface, transversal to the hyperplane at in nity, and having only isolated singularities. If n=2 this assumption implies that V is irreducible. If n=1, we x an irreducible component, say V₁. The only interesting global (intersection) A lexander module is IH $_n^m$ (CP $^{n+1}$; LH $_{\rm H}$) = H $_n$ (U $^{\rm c}$;Q). As in the proof of the previous theorem, the latter is a quotient of the torsion module H $^{\rm n-1}$ (V₁;R $^{\rm op}$). Let $_0$ = Sing(V) \ V₁ be the set of isolated singular points of V which are contained in V₁. Note that V₁ has an induced stratic cation:

(1) follows from the superduality isom orphism for intersection A lexander polynom ials of link knots ([4], C orollary 3.4; [10], T heorem 5.1).

By Remark 3.3, Lemma 4.3 and the long exact sequences of compactly supported hypercohomology, it can be shown that the modules ${\rm H_c}^{n-1}$ (${\rm V_1}_{\rm 0}$; ${\rm R}^{\rm op}$) and ${\rm H_c}^{\rm n}$ (${\rm V_1}_{\rm 0}$; ${\rm R}^{\rm op}$) are annihilated by powers of t 1.

Thus we obtain the following divisibility theorem (compare [26], Theorem 4.3; [28], Theorem 4.1(1); [7], Corollary 6.4.16):

Theorem 4.5. Let V be a projective hypersurface in CP^{n+1} (n 1), which is transversal to the hyperplane at in nity, H, and has only isolated singularities. Fix an irreducible component of V, say V_1 , and let $_0 = V_1 \setminus Sing(V)$. Then IH $_n^m$ (CP^{n+1} ; L_H) = H $_n$ (Q^c ; Q) is a torsion -m odule, whose associated polynomial $_n$ (t) divides the product $_{p2}$ $_0$ $_p$ (t) (t 1) of the local A lexander polynomials of links of the singular points of V which are contained in V_1 .

M oreover, the assum ption that the links of singular points are rational hom ology spheres, in combination with Proposition 2.1, yields the fact that the global A lexander polynom ial in discussion is not divisible by t 1. W ithout this assumption, powers of t 1 m ay appear in the A lexander polynom ial.

An imm ediate consequence of the previous theorem s is the vanishing of the global polynomials $_{i}$ (t), 1 in, if none of the roots of the local Alexander polynomials along some irreducible component of V is a root of unity of order d:

Exam ple 4.6. (com pare [25])

Suppose that V is a rational hom ology manifold having only isolated singularities. A ssum $e\ V$ is transversal to the hyperplane at in nity and all the singularities p of V locally look like Brieskom-type singularities:

(i.e. near p a coordinate system can be selected so that V is given by this equation) and gxxl:(p_i;d) = 1 for any i, where d = deg(V). If dim V = 1, it su ces to make this assumption at all singular points along some irreducible component of V. Then _n(t) = 1. Indeed, the characteristic polynomial of a Brieskom singularity is (t _ j_i ::: j_{n+1}), where _ j_i runs through all roots of unity of degree p_i di erent from 1 (see [32], theorem 9.1). Therefore, by the above divisibility theorem (4.5), none of the roots of _n(t) is a root of unity of degree d and, using Theorem 4.1 and Proposition 2.1, we conclude that _n must be 1.

R em ark 4.7. This example can be generalized to hypersurfaces with non-isolated singularities, by requiring that the local monodrom ies of link pairs of strata contained in some irreducible component of V have orders which are relatively prime to d. Then Theorem 4.1 and Theorem 4.2 yield that all the global (intersection) A lexander polynomials associated to (the complement of) V are powers of t 1.

We will end this section by relating the global (intersection) A lexander modules of the hypersurface V to the 'modules at in nity'. In the particular case of a hypersurface with only isolated singularities, our theorem is a version of Theorem 4.5 of [26] or, in the case n = 1, of Theorem 4.1 (2) of [28]. We will need Lemma 8.4.7 of [21] and Artin's vanishing theorem for perverse sheaves on Stein spaces ([37], Corollary 6.0.4).

Theorem 4.8. Let V be a reduced projective hypersurface of degree d in CP^{n+1} , which is transversal to the hyperplane at in nity, H . Let S be a sphere of sufciently large radius in $C^{n+1} = CP^{n+1}$ H (or equivalently, the boundary of a su ciently small tubular neighborhood of H in CP^{n+1}). Then for all i < n,

and IH $_n^m$ (CP $^{n+1}$;LH) is a quotient of H $^{n-1}$ (S1;IC $_m$) = H $_n$ (U $_1^c$;Q), where U $_1^c$ is the in nite cyclic cover of S $_1$ (V \ S1) corresponding to the linking number with V \ S1 (cf. [26]).

Note. If V is an irreducible curve of degree d in CP^2 , in general position at in nity, then the associated 'polynom ial at in nity', i.e. the order of H $_1$ (U $_1^c$;Q), is (t 1)(t d 1) d 2. This fact is used to show that the zeros of the global A lexander polynom ial of the curve are roots of unity of order d (see [27], [28]).

Proof. Choose coordinates $(z_0 : n; z)$ in the projective space such that $H = fz_{n+1} = 0g$ and O = (0 : 0:1) is the origin in C^{n+1} $H \cdot D \cdot D \cdot D \cdot D$

5. On the M ilnor fiber of a projective arrangement of hypersurfaces

In this section, we apply the preceding results to the case of a hypersurface V CP^{n+1} , which is a projective cone over a reduced hypersurface Y CP^n . As an application to Theorem 4.2, we obtain restrictions on the eigenvalues of the monodrom y operators acting on the homology of the M ilnor ber of the projective arrangement dened by Y in CP^n .

Let $f:C^{n+1}$! C be a hom ogeneous polynom ial of degree d>1, and let Y=ff=0g be the projective hypersurface in CP^n de ned by f. A ssume that the polynom ial f is square-free and let $f=f_1$ $_s$ life the decomposition of f as a product of irreducible factors. Then $Y_i=ff_i=0$ g are precisely the irreducible components of the hypersurface Y, and we refer to this situation by saying that we have a hypersurface arrangement $A=(Y_i)_{i=1:s}$ in CP^n .

The M ilhor ber of the arrangement A is defined as the ber $F=f^1(1)$ of the global M ilhor bration f:U:C of the (homogeneous) polynomial f; here $U:C^{n+1}=f^1(0)$ is the complement of the central arrangement $A=f^1(0)$ in C^{n+1} , the cone on A. F has as characteristic homeomorphism h:F:F the mapping given by h(x)=x with $=\exp(2i=d)$. This formula shows that $h^d=id$ and hence the induced morphism $sh_q:H_q(F):H_q(F)$ at the homology level are all diagonalizable over C, with eigenvalues among the d-th roots of unity. Denote by $P_q(t)$ the characteristic polynomial of the monodrom y operator h_q .

Note that the Milnor ber F is hom otopy equivalent to the in nite cyclic cover U° of U, corresponding to the hom om orphism $Z^s = H_1(U)$! Z sending a meridian generator about a component of A to the positive generator of Z. With this identication, the monodrom y hom eom orphism homogeneous precisely to a generator of the group of covering transform ations (see [6], p. 106–107).

It's easy to see that V CP^{n+1} , the projective cone on Y, is in general position at in nity, where we identify the hyperplane at in nity, H, with the projective space on which Y is defined as a hypersurface. Denote the irreducible components of V by V_i , i=1; ;s, each of which is the projective cone over the corresponding component of Y. Theorem 42 applied to F ' U^c and to the hypersurface V, provides obstructions on the eigenvalues of the monodromy operators acting on the homology of the M ilnor ber F. M ore precisely, we obtain the following result

concerning the prime divisors of the polynomials P_q (t), for q = 1 (compare [29], Theorem 3.1):

Proposition 5.1. Let Y = $(Y_i)_{i=1;s}$ be a hypersurface arrangement in CP^n , and x an arbitrary component, say Y. Let F be the M ilnor bre of the arrangement. Fix a W hitney stratication of the pair $(CP^n;Y)$ and denote by Y the set of (open) singular strata. Then for q n 1, a prime 2 divides the characteristic polynom ialPq(t) of the monodrom y operator hq only if divides one of the polynom ials s_1 (t) associated to the local Alexander modules $H_1(S^{2n-2s-1}-K^{2n-2s-3};)$ orresponding to link pairs $(S^{2n-2s-1};K^{2n-2s-3})$ of components of strata V 2 Y of complex dimension s (0-s-n-1) with V Y_1 , for 1 satisfying the following conditions: 0-1-n-s-1 and 0-q-1-2s+1.

Proof. There is an identi cation P_q (t) q (t), where q (t) is the global Alexander polynom ial of the hypersurface V, i.e. the order of the torsion module H_q (U^c ;Q) = IH $_q^m$ (CP^{n+1} ; L_H). We consider a topological stratication S on V induced by that of Y. From the proof of Theorem 42, we recall that, for q n 1, only polynom ials associated to local Alexander modules of link pairs of strata $S \setminus H$ of $V_1 \setminus H = Y_1$ in (CP^{n+1} ; V [H) can contribute to the prime factors of the global polynom ial q (t). By Remark 3.3, these local polynom ials can be expressed in terms of the local Alexander polynom ials of link pairs of strata S of V_1 in (CP^{n+1} ; V), or equivalently, in terms of the link pairs of strata of V_1 in (P^{n+1} ; V). By Lemma 4.3 we obtain the desired conclusion.

Note. The polynom ials $P_i(t)$, i=0; ;n, are related by the following form ula (see [6], (4.1.21) or [7], (6.1.10)):

where (F) is the Euler characteristic of the M ilnor ber. If, in addition, we assume that Y has only isolated singularities in ${\tt CP}^n$, say at the points ${\tt p}_1$; _____ ; pthen the Euler characteristic of F can be calculated by the formula ([6], (5.4.5)):

where (pi) is the Milnor number of the isolated singularity germ (Y;pi).

If Y CP^n has only isolated singularities, the proof of the previous proposition can be strengthened to obtain the following result, similar to [7], Corollary 6.4.16 (see also [6], (6.3.9)):

Proposition 5.2. With the above notations, if Y has only isolated singularities, then the polynomial P_{n-1} divides (up to a power of t=1) the product of the local A lexander polynomials associated to the singular points of Y contained in Y_1 .

A direct consequence of Proposition 5.1 is the following:

C orollary 5.3. If \uppi 1 is a d-th root of unity such that is not an eigenvalue of any of the local monodrom ies corresponding to link pairs of singular strata of Y_1 in a stratication of the pair (CP ;Y), then is not an eigenvalue of the monodrom y operators acting on H $_q$ (F) for q n 1.

U sing the fact that norm all crossing divisor germs have trivial monodrom y operators ([6], (5.2.21.ii); [7], (6.1.8.i)), we also obtain the following (compare [5], Corollary 16):

Corollary 5.4. Let A = $(Y_i)_{i=1;s}$ be a hypersurface arrangement in CP^n , and x one irreducible component, say Y_1 . Assume that $\sum_{i=1;s} Y_i$ is a normal crossing divisor at any point $x \ 2 \ Y_1$. Then the monodrom y action on H_q (F;Q) is trivial for q on 1.

6. Examples

We will now show, by explicit calculations on examples, how to combine Theorem s 4:1 and 4:2 in order to obtain information on the Alexander modules of a hypersurface. Our theorem sprovide obstructions on the prime factors of the global invariants: for examples, all such prime divisors of the global Alexander polynomials of a degree d hypersurface, must be also divisors of t^d .

We start with few remarks on the local Alexander polynomials of link pairs of strata of ($CP^{n+1};V$). Let s be the complex dimension of a (component of a) stratum V 2 S, and consider ($S^{2n-2s+1};K$) $\stackrel{\text{not}}{=}$ (S;K), the link pair in ($CP^{n+1};V$) of a point x 2 V. This is in general a singular algebraic link, obtained by intersecting ($CP^{n+1};V$) with a small sphere centered at x, in a submanifold of CP^{n+1} of dimension n s + 1, which meets the s-dimensional stratum transversally at x. We dene, as usual, a local system on the link complement, S K, with stalk and action of the fundamental group given by 7 $t^{lk(\cdot;K)}$. The classical Alexander modules of the link pair are dened as H (S K;) = H (\hat{S} K;Q), where \hat{S} K is the in nite cyclic covering of the link complement dened geometrically by the total linking number with K, i.e. the covering associated to the kernel of the epim orphism $_1$ (S K) $_1^{lk}$ Z, which maps the meridian generator loops around components of K to 1. The -module structure on H (\hat{S} K;Q) is induced by the action of the covering transformations. Note that H (S K;) is torsion -module since algebraic knots are of nite type ([4], Proposition 2.2).

For every algebraic link (S;K) as above, there is an associated M ilnor bration ([32]): sF , S K! sF , where sF is the M ilnor ber. Whenever we refer to objects associated to an s-dimensional stratum, we will use the superscript 's'. It is known that sF has the homotopy type of a (n s)-dimensional CW complex ([32], Theorem 5.1). We regard H (sF ;Q) as a -m odule, with the multiplication dened by the rule: t $a = {}^sh$ (a), where ${}^sh: {}^sF$! sF is the monodromy homeomorphism of the M ilnor bration. Note that the inclusion sF , S K is, up to homotopy equivalence, the in nite cyclic covering sF K of the link complement dened by the total linking number with K (more precisely, sF K is homeomorphic to sF R; note that sF is connected since we work with reduced singularities). With this identication, the monodromy homeomorphism of sF corresponds precisely to a generator of the group of covering transformations. It follows that the classical A lexander polynomials of the link pair can be identiced with the characteristic polynomials sF (t) = det(tI sh) of the monodromy operators sh .

Note that, in general, the Milnor bre associated to an algebraic knot has a certain degree of connectivity. For example, in the case of an isolated singularity,

the M ilnor bre is hom otopy equivalent to a join of spheres of its m iddle dim ension ([32]). Results on the hom otopy type of the M ilnor bre of a non-isolated hypersurface singularity and hom ology calculations can be found, for example, in [34] and [36].

Exam ple 6.1: One-dim ensional singular locus

Let V be the trifold in $CP^4 = f(x:y:z:t:v)g$, de ned by the polynom ial: $y^2z+x^3+tx^2+v^3=0$. The singular locus of V is the projective line Sing (V) = f(0:0:z:t:0); z;t:2 Cg. We let ft=0g be the hyperplane H at in nity. Then $V \setminus H$ is the surface in $CP^3 = f(x:y:z:v)g$ de ned by the equation $y^2z+x^3+v^3=0$, having the point (0:0:1:0) as its singular set. Thus, $Sing(V \setminus H) = Sing(V) \setminus H$. Let X be the a nepart of V, i.e., de ned by the polynom ialy $z^2z+x^3+x^2+v^3=0$. It's clear that V is transversal to the hyperplane at in nity.

In our example (n = 3, k = 1) we are interested in describing the prime factors of the global A lexander polynom ials $_2$ (t) and $_3$ (t) (note that $_1$ (t) 1, as n k 2; cf. [26], see also Appendix A). In order to describe the local A lexander polynom ials of link pairs of singular strata of V, we will use the results of [34] and [36]. We will not mention the trivial polynom ials, produced by the (high) connectivity of the corresponding M ilhor bers (cf [26]).

The link pair of the top stratum of V is $(S^1;;)$, and the only prime factor that may contribute to the global Alexander polynomials is tall, the order of H $_0$ $(S^1;)$. Next, the link of the stratum Sing (V) of (0:0:0:1:0) g is the algebraic knot in a 5-sphere S^5 of given by the intersection of the anevariety for $y^2 + x^3 + y^3 = 0$ g in $C^3 = f(x;y;v)$ g (where t = 0, z = 1) with a small sphere about the origin (0;0;0). (To see this, choose the hyperplane V (t) = f(x:y:z:0:v) g which is transversal to the singular set V (x;y;v), and consider an aneneighborhood of their intersection (0:0:1:0) in V (t) = CP^3 .) The polynomial $y^2 + x^3 + v^3$ is weighted hom ogeneous of Brieskom type, hence ([32], [34]) the associated M ilnor bre is simply-connected, hom otopy equivalent to f2 pointsg f3 pointsg f3 pointsg, and the characteristic polynomial of the monodrom y operator acting on H $_2$ (F;Q) is $(t+1)^2$ (t^2 t+1).

Finally, the link pair of the zero-dimensional stratum, f(0:0:0:0:1:0)g, (the origin in the ane space ft=1g), is the algebraic knot in a 7-sphere, obtained by intersecting the ane variety $y^2z+x^3+x^2+v^3=0$ in $C^4=f(x;y;z;v)g$ with a small sphere about the origin. Since we work in a neighborhood of the origin, by an analytic change of coordinates, this is the same as the link pair of the origin in the variety $y^2z+x^2+v^3=0$. Therefore the M ilnor ber of the associated M ilnor bration is the join of $fx^2=1g$, $fy^2z=1g$ and $fv^3=1g$, i.e., it is hom otopy equivalent to $S^2=f3$ pointsg, i.e., $S^3_S^3=f3$ ([32], [34]). Note that the above links, K 3 S 5 and K 5 S 7 , are rational homology spheres since none of the characteristic polynomials of their associated M ilnor bers has the trivial eigenvalue 1 (see [36], P roposition 3.6). Therefore V, and hence V \ H, are rational homology manifolds (see the discussion preceding P roposition 2.1). Then, by P roposition 2.1, t 1 cannot be a prime factor of the global A lexander polynomials of V. A lso note that the local A lexander polynomials of links of the singular strata of V have prime divisors none of which divides t^3 1, thus, by Theorem 4.1, they cannot appear among the prime divisors of $_2$ (t) and $_3$ (t).

A ltogether, we conclude that $_0$ (t) t 1, $_1$ (t) 1, $_2$ (t) 1 and $_3$ (t) 1.

Note. The above example can be easily generalized to provide hypersurfaces of any dimension, with a one-dimensional singular locus and trivial global Alexander polynomials. This can be done by adding cubes of new variables to the polynomial $y^2z + x^3 + tx^2 + v^3$.

Exam ple 6.2: An isolated singularity

Let V be the surface in CP^3 , de ned by the polynom ial: $x^3 + y^3 + z^3 + tz^2 = 0$. The singular locus of V is a point Sing (V) = f(0:0:0:1)q. We let ft = 0q be the hyperplane H at in nity and note that V \ H is a nonsingular hypersurface in H (de ned by the zeros of polynom $ial x^3 + y^3 + z^3$). Hence H is transversalon V (in the strati ed sense). The only nontrivial global A lexander polynom ial (besides $_{0}$ (t) t 1) may be $_{2}$ (t), and its prime divisors are either t 1 or prime divisors of the local A lexander polynomial of the link pair of the isolated singular point of V. The link pair of f(0:0:0:1)q in (CP3; V) is the algebraic knot in a 5-sphere, obtained by intersecting the a nevariety $x^3 + y^3 + z^3 + z^2 = 0$ in C^3 with a small sphere about the origin. Since we work in a neighborhood of the origin, by an analytic change of coordinates, this is the same as the link pair of the origin in the variety $x^3 + y^3 + z^2 = 0$. The polynom ial $x^3 + y^3 + z^2$ is weighted hom ogeneous of Brieskom type, hence ([32], [34]) the characteristic polynom ial of the monodrom y hom eom orphism of the associated M ilnor bration is $(t + 1)^2 (t^2 + 1)$. Note that none of the roots of the latter polynom ial is a root of unity of order 3, hence none of its prime factors may appear as a prime factor of $_2$ (t) (by Theorem 4.1). M oreover, the link of the isolated singular point is a rational hom ology sphere, as the monodrom y operator of the associated Milnor bration has no trivial eigenvalue ([6], Theorem 3.4.10 (A)). Therefore, by Proposition 2.1, t 1 is not a prime factor of $_2$ (t). A ltogether, we conclude that $_2$ (t) 1 and the A lexanderm odule is trivial. Note that the same answer is obtained by using Corollary 4.9 of [26]. Indeed,

Indeed, we have an isomorphism of -modules: H $_2$ (CP 3 V [H;) = H $_2$ (M $_f$;Q), where M $_f$ is the M ilnor ber at the origin, as a non-isolated hypersurface singularity in C 4 , of the polynomial $f:C^4$! C, $f(x;y;z;t)=x^3+y^3+z^3+tz^2$. The module structure on H $_2$ (M $_f$;Q) is given by the action on the monodrom y operator. By a linear change of coordinates, we can work instead with the polynomial $x^3+y^3+tz^2$. Note that the M ilnor ber of the latter is f3 pointsg f3 pointsg † . Hence the formula of the homology of a join ([6], (3.3.20)) shows that the module H $_2$ (M $_f$;Q) is trivial.

In the above examples, our theorems are used to show the triviality of the global A lexander modules. But these global objects are not always trivial.

Example 6.3: Manifold singularity Consider the hypersurface V in CPⁿ⁺¹ dened by the zeros of the polynomial: $f(z_0; n)z = (z_0)^2 + (z_1)^2 + \dots +_n (g)^2$. Assume that n k 2 is even. The singular set $= V(z_0; n; g) = CP^k$ is non-singular. Choose a generic hyperplane, H, for example $H = fz_n = 0g$. The link of is the algebraic knot in a (2n 2k + 1)-sphere $S^{2n-2k+1}$ given by the intersection of the ane variety $(z_0)^2 + (z_1)^2 + \dots +_n (g)^2 = 0$ in C^{n-k+1} with a small sphere about the origin. As n k is even, the link of the singularity (in the sense of [32]) is a rational homology sphere and the associate A lexander polynomial of the knot complement is $t (1)^n k+1 = t+1$. Hence the prime factors of the intersection A lexander polynomials of the hypersurface are either t+1 or t=1. However, since the links of singular strata are rational homology spheres, we conclude (by using Proposition 2.1 and [26], Corollary 4.9) that n k (t) t+1 and all the j(t); n k < j n, are multiples of t+1. Also note that in this case, j(t) 1 for 1 j n k 1.

Som etim es it is possible to calculate explicitly the global A lexander polynomials, as we will see in the next example:

Exam ple 6.4: Let V be the surface in CP³, de ned by the hom ogeneous polynomial of degree d: $f(x;y;z;t) = x^{d-1}z + xt^{d-1} + y^d + xyt^{d-2}$, d 3. The singular bous of V is a point: Sing (V) = f(0:0:1:0)g. We x a generic hyperplane, H. Then the (intersection) A lexander modules of V are de ned and the only 'nontrivial' A lexander polynomial of the hypersurface is $_2$ (t). Note that, by C orollary 4.9 of [26], there is an isom orphism of -m odules: H_2 (CP³ V [H;) = H_2 (M $_f$;Q), where M $_f$ is the M ilnor ber at the origin, as a non-isolated hypersurface singularity in C⁴, of the polynomial $f: C^4$! C, $f(x;y;z;t) = x^{d-1}z + xt^{d-1} + y^d + xyt^{d-2}$, and where the module structure on H_2 (M $_f$;Q) is given by the action on the monodrom y operator. Moreover, by [6], Example 4.1.26, the characteristic polynomial of the latter is $t^{d-1} + t^{d-2} + t^{d-2} + t^{d-1} + t^{d-2} + t^{d-1}$

7. APPENDICES

Appendix A. Topology of complements to hypersurfaces

In this section, we recall some basic facts on the topology of complements of hypersurfaces. The reference is [26], Section 1. See also [27], [28] for the case of projective curves in the projective plane.

Let n 1 be an integer, and let P $(z_1; :::; z_{n+1})$ be a reduced (square-free) polynom ial of degree d. Let X C^{n+1} be the hypersurface de ned by the zeros of P and \overline{X} its projective closure. Denote by H = fz_{n+1} = 0g the hyperplane at in nity. We will assume that \overline{X} is transversal to H and say that \overline{X} is transversal to the hyperplane at in nity.

A Itematively, we may consider a hypersurface V of degree d in CP^{n+1} , with $k=\dim_{\mathbb{C}}Sing(V)$. We shall x a generic hyperplane H (i.e. transversal to the strata of the singular locus of V).

Lem m a A .1. (see [26], Lem m a 1.1)

Let X be a nonsingular hypersurface in C^{n+1} , n 1, with \overline{X} nonsingular and transversal to the hyperplane at in nity (resp. a nonsingular hypersurface V in CP^{n+1}). Then:

De nition A.2. Let V be a hypersurface in CP^{n+1} , and let H be a hyperplane. A point of V is called 'a singular point at in nity' if it is a singular point of V \ H. The subvariety of singular points at in nity will be denoted as Sing (V).

A Itematively, if X is a hypersurface in C^{n+1} , the singularities at in nity of X will be de ned as:

$$Sing_1 (X) = Sing(\overline{X} \setminus H)$$

where H CP^{n+1} is the hyperplane at in nity and \overline{X} CP^{n+1} is the projective closure of X .

Remark A.3.

If the hyperplane at in nity is transversal to \overline{X} , then

On the other hand, tangency to the hyperplane at in nity yields singularities at in nity even if the projective closure is nonsingular.

Lem m a A 4. (see [26], Lem m a 1.5)

In this section, we recall Deligne's construction of the intersection hom ology complex and the de nition of the intersection hom ology groups. The main references are [2], [14] and [15].

This is an inductive de nition. A choice of such a topological stratication makes X into an n-dimensional topological straticed pseudomanifold. $X_{n-2}=$ is called the singular locus of the straticed pseudomanifold X . $S_{n-k}=X_{n-k}-X_{n-k-1}$, k 2, are called the singular strata of X .

A litered Hausdor space X is an n-dimensional PL strati ed pseudom anifold if X is a PL space, each X_{n-k} is a PL space, and, in the preceding de nition, we replace topological manifolds with PL manifolds and homeomorphisms by PL homeomorphisms.

One can similarly de nethe notion of a (PL) stratied pair (see [4]).

We are mainly interested in the study of singular spaces which arise as algebraic varieties. We list here a few theorems which make possible the use of either of the two denitions of the intersection homology groups, which we will present below.

Theorem B.2. (a) (Whitney) Any quasi-projective variety X of pure dimension n has a Whitney stratication.

(b) ([2]) Any W hitney stratic cation of a complex quasi-projective variety X of pure dimension n m akes X into a topological pseudomanifold of dimension 2n with strata

of even dim ension.

(c) (Lojasiewicz) If S is a W hitney strati cation of a complex quasi-projective variety X of pure dimension n, then there is a triangulation of X compatible with the stratic cation.

De nition B.3. ([14]) A perversity is a sequence of integers $p = (p_0; n)p$ satisfying:

$$p_0 = p_1 = p_2 = 0$$
 and $p_k p_{k+1} p_k + 1$; k 2

In [14, 15] perversities always satisfy $p_2=0$. Here we will also need to allow perversities with $p_2=1$ (and $p_{k+1}=p_k$ or p_k+1), which are called superperversities ([10], [4]). In both cases, we may take as the denition of the intersection homology complex IC_p , the Deligne construction:

The intersection hom ology complex becomes an object in the derived category of bounded, constructible sheaves on X, and it is uniquely characterized in the derived category by the following set of axioms:

De nition B.4. Let S be a dierential graded sheaf on X. The set of axiom s (A X) consists of the following conditions:

(A X 0) Normalization: $S_{k} = L[n]$

(A X 1) Lower bound: $H^{i}(S) = 0$, for i < n

(A X 2) Stalk vanishing condition: $H^{i}(S_{j_{k+1}}) = 0$, for $i > p_k$ n, k 2

(AX 3) Costalk vanishing condition: $H^{i}(j_{x}^{!}S) = 0$, for $i p_{k} k+1$, $x \ge X_{n-k} X_{n-k-1}$, where $j_{x}:fxg$, X is the inclusion of a point.

De nition B.5. If S satis es the set of axiom s (AX), we let

$$IH_{i}^{p}(X;L) = H^{i}(X;S)$$

and call them the intersection homology groups of X , with \cos cients in $\,L\,$ and supports in $\,$.

A Itematively, if X is a n-dimensional PL strati ed pseudomanifold and p is a classical perversity (i.e., p(2) = 0), the intersection homology groups can be defined as the total homology of a subcomplex IC p of the ordinary locally in ite PL chains C (X). More precisely, IC $_1^p$ (X) is the set of PL i-chains c that intersect each X $_n$ k (k > 0) in a set of dimension at most i k + pk, and whose boundary @c intersects each X $_n$ k (k > 0) in a set of dimension at most i k 1+ pk. We call such chains 'allowable' (their intersection with the strata of X is not 'too big', being controlled by the perversity p). Since these conditions are local, the IC $_p$ (U), for U open in X, form a sheaf of chain complexes, denoted IC $_p$ (X). We renumber IC $_p$ if IC $_p$ (X).

For any strati cation of an i-dim ensional chain c which satis es the allowability conditions, each i-dim ensional stratum of c and each (i 1)-dim ensional stratum of c are contained in X . Thus we may speak of chains c with coe cients in L, whenever L is a local system of coe cients on X . We form, as above, the

com plex $IC_p^i(L) := IC_i^p(X;L)$. It turns out that this com plex satisfies the set of axiom s (AX), therefore it is quasi-isom orphic to the D eligne's com plex.

Note. The constructions in the last paragraph require the use of classical perversities. For a more general approach, including the case of superperversities, see [11].

Recall the form ula for the stalk calculation of the intersection hom ology com plex ([2], (3.15)): if x 2 X $_{\rm n-k}$ $\,$ X $_{\rm n-k-1}$:

$$H^{q}(IC_{p})_{x} = \begin{cases} IH^{p}_{q (n k+1)}(L_{x}; L_{x};); & q p_{k} n \\ 0; & q > p_{k} n \end{cases}$$

where L_x is the link of the component of $X_{n-k} - X_{n-k-1}$ containing x.

We end this section by recalling Artin's vanishing results for the intersection homology groups of an a nealgebraic variety.

Proposition B.6. ([37], Example 6.0.6) Let X be a complex a nevariety (Stein space) of pure dimension n. Fix a W hitney stratic cation of X and a local system L de ned on the top stratum. We may also assume that the base ring is a PID. Then:

 (X;L) = 0 for k > n
IH $_k^m$ (X;L) = 0 for k < n:

If the stalks of L are torsion free, then ${}^{c}IH_{k}^{m}$ (X;L) is also torsion free.

Remark B.7.

- 1) The above result is also true for the logarithm ic perversity 1 (see [37]).
- 2) In contrast, if the stalks of the local system L are torsion modules, and X is a nealgebraic of complex dimension n, then IH $_{n}^{m}$ (X;L) is also a torsion module ([37], Corollary 6.0.3 and Corollary 6.0.4).
