IN VARIANT DIFFERENTIAL OPERATORS AND FCR FACTORS OF ENVELOPING ALGEBRAS

A bstract. If g is a sem isim ple Lie algebra, we describe the prime factors of U (g) that have enough nite dimensional modules, and also determine, which nite dimensional U (g)-modules are modules over a given prime factor. As an application we study nite dimensional modules over some rings of invariant diemential operators arising from Howe duality. We also provide a counterexample to a conjecture of Soergel.

1. Introduction

Let F denote an algebraically closed eld of characteristic zero. G iven an F-algebra A, we say that A has enough nite dimensional representations if the intersection of the annihilators of the nite dimensional A-m odules is zero. If in addition all nite dimensional representations are completely reducible A is an FCR algebra (see [KS94]).

Let g be a sem isim ple Lie algebra with enveloping algebra U = U(g). In this paper, we describe the prime factors of U that are FCR algebras, and also determine, in terms of highest weights, which nite dimensional U-modules are actually modules over a given prime factor. If A is a prime factor of U; then any nite dimensional A-module is a g-module, and hence completely reducible. So the issue is whether or not A has enough nite dimensional modules. However we use the appellation "FCR" for brevity.

We apply our work to study nite dimensional modules over some rings of invariant dierential operators. When g is spwe give a counterexample to conjecture 1 in [Soe90] concerning inclusions of ideals in U. We remark that the conjecture is related to one of two methods introduced by Soergel to study Spec U, and that the second method shows more promise, see [BJ01]) for recent progress.

We begin with some basic notation used to state the main theorem. Fix a Cartan subalgebra hofg. To any prime ideal of S (h), we can associate a prime ideal of U, and a "tautological highest weight"

ideal of U has the form I for a suitable prime ideal in S (h). Set U = U=I.

Let R denote the root system corresponding to h with W eyl group W . Choose a set of positive roots, R^+ , such that $R = R^+$ [R^+ , and let $B = f_1$; $_2$; $_n$ g denote the simple roots in R^+ . Denote the dom inant integral weights by P^+ .

We say that a prime ideal is dominant if $V() \setminus P^+$ is Zariski dense in V(), where V() denotes the zero set of in h.

The dot action of W on h induces an action on S (h). Let (;) denote the K illing form on g: For 2 h, let h be the element of h determined by (h;h) = (h) for all h 2 h. Main Theorem.

- (1) If U is FCR then for some w 2 W , w: is dominant.
- (2) Let be a dominant ideal in S (h), and w 2 W.

The following conditions are equivalent:

- (a) U_w : is FCR
- (b) $I_w := I$
- (c) w 2 W where =

This paper is organized as follows. In Section 2 we prove some results about root systems and the Weyl group which may be of independent interest. Then in Section 3 we collect some results about prime and primitive ideals in enveloping algebras. The main theorem is proved in Section 4, and the examples related to Howe duality are presented in Section 5.

2. W eyl group combinatorics

Proof. (1) Since W $_1$ is generated by re ections, s with $_2$ B $_1$ and ts t $_1$ = s_{t()} for t 2 T; it follows that T normalizes W $_1$. From the implication (1) =) (3) in Lemma 2.3 and [Hu90] Proposition 1.10 (c) we see that T is a transversal to W $_1$ in W $_0$. It follows easily that W $_0$ = W $_1$ T is the sem idirect product of W $_1$ by T.

3. FCR factors of Enveloping algebras.

We begin by recalling Soergel's work on prime ideals in the enveloping algebra $U=U\left(g\right)$ where g is a sem isimple Lie algebra. Let Z denote the center of U.


Let L () be the simple highest weight module for g_F with highest weight . If I is the annihilator of L () in U (g) we de ne () = I. 4. Proof of the main result.

In general, it is unknown when a prime ideal I is contained in a given primitive ideal I. However for $2P^+$ the answer is easy.

5. Invariant differential operators

An interesting class of exam ples arises from dualpairs (GW 98] Section 4.5, [How 89], [LS89]). The application of our method is fairly routine, so we give only the most interesting examples rather than conduct an exhaustive study.

Let M $_{\rm p,k}$ denote the set of p $\,$ k m atrices over F , and consider cases A ,B ,C as follows.

In case A we set n=p+q. If p=0 (resp. q=0) we set $V=M_{k,q}$ (resp. $V=M_{p,k}$). In all cases the algebra of invariant dierential operators D $(V)^K$ is generated (as an associative algebra) by a Lie algebra isom orphic to g. Hence there is a surjective hom om orphism

The image of gunder is described explicitly on pages 69{70 of [LS89]. Let T be a maximal torus of K. In [MR], it is shown that if zero is not a T-weight of V then D $(V)^K$ is FCR. This hypothesis is the situation in cases A and C of the above table and in case B for even k. In the case of odd k, the algebra D $(V)^K$ has no nite dimensional modules. This fact is an easy consequence of Theorem 4.1.

There is a multiplicity free decomposition of O(V) as a F [K] U (g)-module ([GW 98] Theorem 4.5.14). Furthermore, as a U (g) {module, O(V) is a direct sum of simple highest weight modules. Let

Our next aim is to describe the irreducible constituents of O (V) as a K-m odule and as a U (g)-m odule. W ith this goal in m ind we set up some standard notation.

By a partition we will mean a nite sequence of weakly decreasing non-negative integers. We will denote partitions by lower case G reek letters. The length of a partition is denoted '() = maxfij_i > 0g. The conjugate of a partition is a partition 0 whose i^{th} part is given by $jfjj_{i}$ igj. Note that that '() = 0 .
