COMPLETE M IN IM AL HYPERSURFACES IN THE HYPERBOLIC SPACE H⁴ W ITH VAN ISH IN G GAUSS-KRONECKER CURVATURE

Abstract. We investigate 3-dimensional complete minimal hypersurfaces in the hyperbolic space H 4 with Gauss-Kronecker curvature identically zero. More precisely, we give a classication of complete minimal hypersurfaces with Gauss-Kronecker curvature identically zero, nowhere vanishing second fundamental form and scalar curvature bounded from below.

1. Introduction

In order to study the rigidity of m in in al hypersurfaces, D a jzzer and G rom oll [6] invented the so called G auss param etrization. A sa by-product of this approach they were able to describe locally the m in in al hypersurfaces in the (n+1)-dimensional space form whenever the rank of the nullity distribution is constant. A limetida and B rito [2] initiated the study of compact m in in al hypersurfaces in the unit sphere S^4 with vanishing G auss-K ronecker curvature. In fact they proved that such compact hypersurfaces are boundaries of tubes of m in in al2-spheres in S^4 , provided that the second fundamental form never vanishes. R am anathan [10] extended this result and allowed points where the second fundamental form is zero. In [7], [8] the authors extended the above results to complete m in in al hypersurfaces in the Euclidean space R^4 or in the unit sphere S^4 .

The aim of this paper is to study complete minimal hypersurfaces in the 4-dimensional hyperbolic space H 4 with identically zero G auss-K ronecker curvature. We remind that the G auss-K ronecker curvature is the product of the principal curvatures. In fact, we deal with minimal hypersurfaces whose second fundamental form is nowhere zero, which is equivalent to the fact that the nullity distribution is one dimensional.

It turns out that such hypersurfaces are closely related to stationary spacelike surfaces in the de Sitter space S_1^4 , which is the Lorentzian unit sphere in the at Lorentzian space R_1^5 . M ore precisely, D a jzzer and G rom oll [6] noticed that the unit norm albundle of a stationary spacelike surface in S_1^4 gives rise to a m inim alhypersurface in H 4 with vanishing G auss-K ronecker curvature and now here zero second fundam ental form (for details see Section 2) and, conversely, any such hypersurface is obtained, at least locally, in this way.

W e are interested in the classic cation of complete minimal hypersurfaces in ${\rm H}^4$ with Gauss-K ronecker curvature identically zero. At a rst we show that there exists

an abundance of such hypersurfaces. To this purpose we focus on a class of stationary spacelike surfaces in S_1^4 , namely those with vanishing normal curvature. We establish a correspondence between stationary spacelike surfaces in S_1^4 with identically zero normal curvature and minimal surfaces in umbilical hypersurfaces in the hyperbolic space H 4 .

Our examples of complete m in in all hypersurfaces in H 4 with vanishing Gauss-K ronecker curvature arise as suspensions of complete m in in all surfaces in horospheres or equidistant hypersurfaces of H 4 . Then the question whether these are the only examples comes naturally.

W e prove that these suspensions are in fact the only complete m in in all hypersurfaces in H 4 with identically zero G auss-K ronecker curvature under the assum ptions that the second fundam ental form is nowhere zero and the scalar curvature is bounded from below.

The paper is organized as follows: In Section 2 we study stationary spacelike surfaces in the de Sitter space S_1^4 , we de ne the polar map and show that it induces m in in all hypersurfaces in H 4 with vanishing G auss-K ronecker curvature. In particular, we prove some auxiliary results about stationary spacelike surfaces in S_1^4 with identically zero normal curvature. Moreover, we furnish a method to produce complete minimal hypersurfaces in H 4 with identically zero G auss-K ronecker curvature. Section 3 is devoted to the local theory of minimal hypersurfaces in H 4 with vanishing G auss-K ronecker curvature. Furthermore, we give some auxiliary results. Finally, in Section 4 we state and prove the main result of this paper.

2. The polar map of stationary surfaces in the de Sitter space

At rst we set up our notation. Denote by R_1^5 the real vector space R^5 endowed with the Lorentzian metric tensor h; i given by

where $x = (x_0; x_1; x_2; x_3; x_4)$, $y = (y_0; y_1; y_2; y_3; y_4)$ 2 R⁵. We shall use the M inkow skim odel for the simply connected hyperbolic space of constant sectional curvature 1, which is the hyperquadric

M oreover, the hyperquadric

is the standard model for the $\sin p \ln p$ connected Lorentzian space form of constant curvature 1, and is called the de Sitter space.

Consider a 2-dim ensional manifold M 2 . An imm ension g:M 2 ! S_1^4 is called spacelike if the induced metric on M 2 via g is Riem annian, which as usual will be denoted again by h; i. Let i: S_1^4 ! R_1^5 be the inclusion map. Denote by

A point x 2 M 2 is called totally geodesic point of g if and only if $II_x=0$. If each point of M 2 is a totally geodesic point of g, then g is called totally geodesic im m ersion. Since S_1^4 is a Lorentz m anifold of constant sectional curvature, one can derive the equations of C odazzi and R icci, w hich are respectively

A ssum e now that M 2 is an oriented, 2-dim ensional R iem annian manifold and g:M 2 ! S_1^4 is a stationary isometric immersion. It is well known (cf. [1]) that there exists a holomorphic quadric dierential on M 2 , the so called H opf dierential. A point x 2 M 2 is a zero of the H opf dierential if and only if K (x) = 1 and K 2 (x) = 0. Such a point is called a superminimal point of g. The immersion g is called superminimal if each point of M 2 is a superminimal point of g. From the holomorphicity of the H opf dierential, it follows that either g is superminimal or the superminimal points are isolated.

Consider the unit normal bundle N 1 (g) of g, de ned by

Denote by : N 1 (g) ! M 2 the projection to the : rst factor and by $_g:$ N 1 (g) ! H 4 the projection to the second factor. The map $_g:$ is called the polar map associated with g.

Throughout the paper we follow the above mentioned notation and assume that all manifolds under consideration are connected, unless otherwise stated.

The following proposition was essentially proved by Dajczer and G rom oll in [6]. In order to make the paper self-contained we shall give here a proof that ts our exposition. This proposition furnishes a method for producing minimal hypersurfaces in H 4 with Gauss-K ronecker curvature identically zero and establishes the close relation between them and stationary surfaces in S_1^4 .

P roposition 2.1. Let M 2 be a 2-dim ensional R iem annian m anifold and g : M 2 ! ${\rm S_1^4}$ a stationary isometric im m ersion. Then

- (i) The polar map $\,_g$ associated with g is regular at (y;w) 2 N 1 (g) if and only if the second fundamental form of g is non-singular in the direction w .
- (ii) On the open set of its regular points, $_{\rm g}$ is a minimal immersion in H 4 with G auss-K ronecker curvature identically zero and nowhere vanishing second fundamental form .
- (iii) If x is a point on M 2 where the nomal curvature of g is not zero, then g is regular on the ber of N 1 (g) over x. Furthermore, if x is not a totally geodesic point of g and K (x) g 1, then g is regular on the ber of N 1 (g) over x.

Proof. Choose an adapted orthonormal frame eld $fe_2;e_2;e_3;e_4g$, along g de ned on an open set U M^2 , where e_4 is timelike. We parametrize e_4 (U) by e_4 via the map

Consequently, the Gauss-Kronecker curvature of $_{\rm g}$ is identically zero. Moreover using (2.2), we get

Rem ark 2.2. We shall see in Section 3 that every minimal hypersurface in the hyperbolic space H 4 with Gauss-Kronecker curvature identically zero and nowhere vanishing second fundamental form can be obtained, at least locally, as in Proposition 2.1 (ii).

We focus now on the class of stationary spacelike m in im all surfaces in S_1^4 with identically zero normal curvature. This class will play a crucial role in the classi—cation of complete m in imal hypersurfaces in the hyperbolic space with zero G auss-K ronecker curvature. We remind here that the totally geodesic submanifolds of S_1^4 arise as intersections of S_1^4 with linear subspaces of R_1^5 . The following result is due to A lias and Palmer [1]. For the sake of completeness we give another short proof.

P roposition 2.3. Let M 2 be a 2-dim ensional Riem annian manifold and g: M 2 ! S_1^4 be a stationary isometric immersion. Then K 2 0 if and only if g M 2 is contained in a totally geodesic hypersurface L 3 of S_1^4 , i.e., there exists a vector w such that hg (x); wi = 0, for each x 2 M 2 . Moreover,

- (i) w is spacelike if and only if K 1 and K 6 1,
- (ii) w is timelike if and only if K 1 and K 6 1,
- (iii) w may be chosen to be null if and only if K 1.

Proof. Denote by M $_1$ the set of superm in imal points of g. We distinguish two cases. Case 1. Assume that M $_1$ consists of isolated points only. Consider a non superm in imal point x of g and let fe $_1$; e $_2$; e $_3$; e $_4$ g be an adapted orthonormal frame eld dened on an open set V M $_1$ around x, e $_4$ being timelike. We may suppose that the shape operators associated with e $_3$ and e $_4$ are

where T_{34} stands for the connection form on the norm albundle of g with respect to the frame $f\overline{e}_3$; \overline{e}_4 g. Thus $T_{34}=0$, and so the vector eld $w=\overline{e}_3$ is constant along g and hg; wi=0 on U_x . This means that $g(U_x)$ is contained in a totally geodesic hypersurface L^3 of S_1^4 . Note that the normal vector eld we satisfies

Suppose now that $U_y = M^2 = M_1$ is an open set around another point $y \ge M^2 = M_1$, such that $U_x \setminus U_y \in \mathcal{F}$; and $g(U_y) = \overline{L}^3$, where \overline{L}^3 is a totally geodesic hypersurface of S_1^4 , with normal vector \overline{w} . We claim that $\overline{L}^3 = L^3$. To this purpose, it is enough to prove that w and \overline{w} are linearly dependent. Suppose in the contrary that these are linearly independent. Then g is totally geodesic on $U_x \setminus U_y$, a contradiction since $K \in 1$ on $U_x \setminus U_y$. So we deduce that $g \in M^2$ is contained in a totally geodesic hypersurface L^3 of S_1^4 , whose normal vector satis es

are holom orphic and their zeroes are precisely the totally geodesic points of g. Hence the set M $_0$ of totally geodesic points of g either coincides with M 2 or consists of isolated points. In the case where M $_0$ = M 2 , g M 2 is contained in a appropriate totally geodesic hypersurface of S_1^4 whose normal vector is null. Suppose now that M $_0$ consists of isolated points. Then the set M 2 M $_0$ is open and connected. C onsider a non totally geodesic point x 2 M 2 and let fe $_1$; e $_2$; e $_3$; e $_4$ g be an adapted orthonormal frame eld de ned on a simply connected neighborhood U M 2 M $_0$ of x, e $_4$ being timelike. We may suppose that A $_3$ = A $_4$. Since K 2 0, from (2:1) it follows that d! $_{34}$ = 0. Thus there exists a smooth function on U such that ! $_{34}$ = d . De ne the vector eld

Therefore w is constant and hg; w i = 0. Thus, g (U) is contained in a totally geodesic hypersurface L^3 of S_1^4 whose normal vector w satis eshw; w i = 0. A rguing as in C ase 1 we can prove that g M 2 L^3 . This completes the proof.

The following proposition provides a way to produce all spacelike stationary surfaces in S_1^4 with normal curvature identically zero. For the sake of convenience, we introduce the following notation. Let $h:M^2:Q^3$ be an isometric immersion, where M^2 is a 2-dimensional, oriented Riemannian manifold and Q^3 an umbilical hypersurface of H^4 . The orientation N of h gives rise in a natural way to a map $A : N : M^2 : S_1^4$ which is called the associate of h.

W e recall here that the umbilical hypersurfaces of H 4 arise as intersections of H 4 with a nehyperplanes of R $_1^5$. M oreover, an umbilical hypersurface Q 3 of H 4 has positive, negative or zero sectional curvature if Q 3 is a geodesic sphere, an equidistant hypersurface or a horosphere, respectively.

Proposition 2.4. Let M² be a 2-dim ensional, oriented Riem annian manifold.

- (i) If $h:M^2:Q^3$ is a minimal isometric immersion without totally geodesic points, where Q^3 is an umbilical hypersurface of H^4 , then its associate $H:M^2:S_1^4$ is a spacelike stationary immersion with normal curvature identically zero without totally geodesic points.
- (ii) Conversely, assume that $g:M^2:S_1^4$ is a stationary isometric immersion with normal curvature identically zero without totally geodesic points. Then there exist a vector w and a totally geodesic point free m inimal immersion $h:M^2:Q^3$, where Q^3 is an umbilical hypersurface of H^4 , with sectional

curvature K $_{Q^3}$ = hw; wi such that hg (x); wi = 0, for each x 2 M 2 and $q = \frac{1}{2}$.

Proof. (i) Let be a unit norm alvector of Q 3 in H 4 and A the corresponding shape operator. Obviously, A = I, for som e 2 R. We denote by N the orientation of h and by A $_N$ the corresponding shape operator. For each tangent vector X of M 2 , we have

Moreover, the vector elds R: h; R: hg constitute a frame eld in the normal bundle of R. Denote by R, R, R4 the shape operators of R0 with respect to directions R3 and R4. U sing the Weingarten formula and (2:3), we get

(ii) Suppose now that $g:M^2:S_1^4$ is a stationary isometric immersion with normal curvature identically zero without totally geodesic points. A coording to Proposition 2.3, $g:M^2$ is contained in a totally geodesic hypersurface of S_1^4 with normal vector w. Without loss of generality, we may assume that hw; will 1. We distinguish two cases.

C ase 1. A ssum e that w is not null. We set a = $\frac{p}{1}$ hw; wi. B ecause M² is oriented, we may choose a global vector eld normal along g such that, h; wi = 0 and h; i = $\frac{a^2}{1}$ 1. Consider the vector elds

Let M 2 be an oriented, 2-dim ensional R iem annian manifold and h : M 2 ! Q 3 an isom etric im m ersion, where Q 3 is an umbilical hypersurface of H 4 . D enote by a unit normal vector eld of Q 3 in H 4 . Consider the map F $_h$: M 2 R ! H 4 , given by

In the following proposition we show that there is an abundance of complete m in im allypersurfaces in H 4 w ith G auss-K ronecker curvature identically zero.

P roposition 2.5. Let $h: M^2 ! Q^3$ be a minimal isometric immersion of a 2-dimensional, oriented Riemannian manifold M^2 into an umbilical hypersurface Q^3 of H^4 . Then,

- (i) On the open subset of the regular points, the suspension F_h of h is a m in im al im m ersion in H 4 w ith G auss-K ronecker curvature identically zero.
- (ii) The m etric induced on M 2 R by F_h is complete if and only if M 2 is complete and Q 3 is a horosphere or an equidistant hypersurface in H 4 .

Proof. (i) Denote by N a unit normal vector eld along h in Q^3 and by A_N the corresponding shape operator of h. Let A = I, Q^3 and he corresponding shape operator of Q^3 in H 4 w ith respect to the unit normal vector eld . Then

Furthermore, the metric h; i_{F_h} induced on M $\frac{2}{9}$ R by F_h , is the warped product

Rem ark 2.6. The polar map associated with a non complete stationary surface in S_1^4 may gives rise to a complete minimal hypersurface in H 4 with G auss-K ronecker curvature identically zero and nowhere vanishing second fundamental form. In fact, consider a 2-dimensional, oriented, complete R iem annian manifold M 2 and suppose that h: M 2 ! Q 3 is a minimal isometric immersion without totally geodesic points, where Q 3 is a horosphere or an equidistant hypersurface of H 4 . The metric h, $i_{\rm R}$ induced by $^{1}{\rm R}$ is not complete. Indeed, if h, $i_{\rm R}$ where complete, then by M yers' Theorem and the fact that its G aussian curvature K $_{\rm R}$ satis es

M 2 would be compact. A contradiction, since there are no compact m inimal surfaces in simply connected space forms of non positive sectional curvature. M oreover according to Proposition 2.5, the metric induced on N 1 (A) by $_{\rm b}$ is complete.

Rem ark 2.7. There are num erous examples of complete m in in all hypersurfaces in H 4 with Gauss-K ronecker curvature identically zero and unbounded scalar curvature. Indeed, suppose that Q 3 is a horosphere and h: M 2 ! Q 3 is a complete minimal immersion. Then the suspension of h is a complete hypersurface in H 4 . A coording to (2:9) its principal curvatures are

There are also plenty of complete m inimal hypersurfaces in H 4 with G auss-K ronecker curvature zero and bounded scalar curvature. Indeed, there exist complete m inimal surfaces in H 3 with G aussian curvature bounded from below (see [5]). The suspension of such surfaces are minimal hypersurfaces in H 4 with G auss-K ronecker curvature identically zero and bounded scalar curvature.

3. Local theory of minimal hypersurfaces in H 4 w ith zero G auss-K ronecker curvature

Let M 3 be a 3-dim ensional, oriented R iem annian manifold and f: M 3 ! H 4 an isometric minimal immersion. Denote by a unit normal vector eld along f with corresponding shape operator A and principal curvatures k_1 k_2 k_3 . H 4 a minimal isometric immersion with unit normal vector eld , G auss-K ronecker curvature identically zero and nowhere vanishing second fundamental form . Each point x_0 2 M 3 has a neighborhood U such that the quotient space V of leaves of the nullity distribution on U is a 2-dimensional dierentiable manifold with quotient projection :U! V and

(i) there exists a spacelike stationary imm ersion $g:V:S_1^4$ and an isometry $T:U:N^1$ (g) such that g= and $f=_q$ T on U,

(ii) the Gaussian curvature K of the metric induced by g on V and the normal curvature K $^{?}$ satisfy

Part (ii) follows im mediately from (3:4).

4. Complete minimal hypersurfaces in ${\rm H}^4$ with vanishing Gauss-Kronecker curvature

The purpose of this section is to classify complete minimal hypersurfaces in H 4 with G auss-K ronecker curvature identically zero and nowhere zero second fundam ental form, under the assumption that the scalar curvature is bounded from below. M ore precisely, we shall prove the following

Theorem . Let M 3 be a 3-dim ensional, oriented, complete Riemannian manifold whose scalar curvature is bounded from below and $f:M^3!$ H 4 a minimal isometric immersion with Gauss-Kronecker curvature identically zero and nowhere zero second fundamental form. Then there exist a minimal isometric immersion h:M $^2!$ Q 3 , without totally geodesic points, of a complete 2-dimensional oriented Riemannian manifold M 2 into an equidistant hypersurface Q 3 of H 4 and a local isometry T:M $^3!$ N 1 (A) such that $f=\frac{1}{16}$ T.

The proof of our result relies heavily on the well known Generalized Maximum Principle due to 0 mori and Yau ([9],[11]):

G eneralized M axim um Principle. Let M be a complete Riemannian manifold whose Ricci curvature is bounded from below. If ' is a C^2 -function on M bounded from above, then there exists a sequence $fx_n g$ of points of M such that

Lem m a 4.1. Let M be a complete Riemannian manifold whose Ricci curvature is bounded from below, and $^\prime$ a C 2 -solution of the di erential inequality

Then ' is bounded from above and $\sup' = 0$.

Proof. We suppose in the contrary that \sup '=1. Then there exists a point x_0 2 M such that ' (x_0) 2. Consider a C 2 -positive increasing function F:R! R which fort 2 is given by F (t)=2 1 $t^{1=2}$. The function =F ' is bounded from above, since 2. Appealing to the Generalized Maximum Principle, we deduce that there exists a sequence fx_n g such that

C ase 1. We assume that there exists a global unit section e_2 of . Then the function $v=e_2$ (log) is globally de ned and smooth. A round each point x 2 M 3 we may choose a neighborhood U_x of x, vector elds e, e_3 such that the orthonormal frame eld fe; e_2 ; e_3 g gives the right orientation of M 3 and A $e_1=e_1$, A $e_3=e_3$ on U_x . If for another point \overline{x} 2 M 3 with corresponding neighborhood $U_{\overline{x}}$ and orthonormal frame eld fe; e_2 ; \overline{e}_3 g chosen as before, we have $U_x \setminus U_{\overline{x}}$ for then either $\overline{e}_1=e_1$ and $\overline{e}_3=e_3$ or $\overline{e}_1=e_1$ and $\overline{e}_3=e_3$ on $U_x \setminus U_{\overline{x}}$. Thus hr e_3 e_1 ; e_2 i = hr \overline{e}_3 \overline{e}_1 ; e_2 i on $U_x \setminus U_{\overline{x}}$ and so the local function unintroduced in Section 3 can be extended to a smooth global one.

Our assumptions imply that the Ricci curvature of M 3 is bounded from below. Making use of (3.2) and the harmonicity of u and v (Lemma 3.1), we obtain

Then Lemma 32 yields a (x_0) = b (x_0) = 0 or b (x_0) = d (x_0) = 0, respectively, and thus 2 (t), t2 R, is unbounded, where is the integral curve of e_2 emanating from the point x_0 . This contradicts our assumption on the scalar curvature. So $v^2 < 1$. It is obvious from Lemma 32, that on each integral curve of e_2 , the function v changes sign only once.

Consider, now, the set v^1 (0). From (32) we have e_2 (v) = v^2 u^2 1 < 0. Hence 0 is a regular value of v and thus v^1 (0) is an oriented and connected 2-dimensional submanifold of M 3 . Since u, v are bounded harm onic functions and M 3 has R icci curvature bounded from below, by a result due to Yau ([11], Theorem 3^{00}), it follows that the functions jr u_1^2 and jr v_2^2 are also bounded. Hence, from (4:9) and (4:10) we deduce that the sequence 1 (x_n) is bounded. Estimating at x_n and passing to the limit, from (4:8) we get $u_0=0$. So $\sup G=0$, because of $v_0=_0=0$. Thus G=0 and consequently u=0, which completes the proof of our claim.

It can be easily seen that the quotient space M 2 of leaves of the nullity distribution can be identified with the manifold v^1 (0) via the difference of a 2-dimensional manifold that makes the quotient projection : M 3 ! M 2 a submersion. Thus appealing to Proposition 3.3, there exists a spacelike stationary immersion g: M 2 ! S 4_1 and an isometry T : M 3 ! N 1 (g), defined by T (x) = ((x); f(x)), x 2 M 3 , such that g= and g= T. From the second part of Proposition 3.3 it follows that the normal curvature of g is identically zero and the G aussian curvature K of the metric induced by g satisfies E K > 1. So g has not totally geodesic points. Consequently, by virtue of Propositions 2.3 and 2.4, we deduce that g is the associate of a minimal immersion h: M 2 ! Q 3 , where Q 3 is an equidistant hypersurface of H 4 .

From Case 1, we know that the map $\mathbf{g}: \mathbb{A}^2 ! S_1^4$, which is induced by \mathbb{C} , is a spacelike stationary im mersion without totally geodesic points. Furthermore, there exists a minimal immersion $\mathbb{R}: \mathbb{A}^2 ! \mathbb{Q}^3$, where \mathbb{Q}^3 is an equidistant hypersurface of \mathbb{R}^4 , such that \mathbf{g} coincides with the associate of \mathbb{R}^4 and $\mathbb{C}^2 = \mathbb{Q}^4$, where \mathbb{C}^4 is the isometry given by \mathbb{C}^4 (Re) = (e (Re); \mathbb{C}^4 (Re)), Re 2 \mathbb{C}^4 3. Bearing in mind Propositions 2.3, 2.4 and taking into account (3.4) we easily see that

Rem ark 4.2. It should be interesting to know whether a similar classic cation result can be obtained without the assumption that the scalar curvature is bounded from below.
