ON NORMAL SUBGROUPS OF PRODUCT OF GROUPS

Abstract. The object of this paper is to $\$ nd a necessary and su cient condition for a pair of groups G_1 and G_2 so that every normal subgroup of G_1 G_2 is of the type N_1 N_2 where $N_i \to G_i$, i=1;2

1. Introduction

Let G be a nite group. Then G has a composition series given by feg = H_0 C H_1 C H_n = G: The set-with-multiplicities of composition factors associated to this composition series is given by C (G) = $fH_i=H_{i-1}: i=1;2;:::;ng;$ noting that any two composition series of G give rise to the same set-with-multiplicities of composition factors, upto isomorphism of factors (see [2], Jordan-Holder Theorem). It is a standard fact (see [1]) that 8 K C G the set C (G) is the disjoint union (i.e. union counting multiplicities) of the sets C (G=K) and C (K). By convention C (feg) = ;

In [3], Leinster has proved that if G_1 and G_2 are any two nite groups such that the sets $C(G_1)$ and $C(G_2)$ have no member in common then every normal subgroup of G_1 G_2 is of the type N_1 N_2 where N_i $E(G_i)$, i=1;2. However, considering $G_1=G_2=$ the alternating group A_5 , one can see that the converse is not true.

In this paper we derive a condition which is necessary as well as su cient for any pair of groups G_1 and G_2 (nite or in nite, abelian or non-abelian) so that all normal subgroups of G_1 G_2 are of the above mentioned type. This condition seems to provide more options for nding examples of non-abelian perfect groups; a perfect group being one in which the sum of the orders of all normal subgroups equals twice the order of the group (see [3]).

2. The NS-condition

We begin this section with a few de nitions.

De nition 2.1. Let G_1 and G_2 be any two groups. A normal subgroup N of G_1 G_2 is said to be of standard type if N = N₁ N₂ where N_iE G_1 , i= 1;2:

De nition 2.2. Two groups G_1 and G_2 are said to have a subgroup in comm on if there exist non-trivial subgroups H_i of G_i ; i=1;2; such that $H_1=H_2$.

De nition 2.3. Two groups G_1 and G_2 are said to satisfy NS-condition if 8 H $_i$ E G_i , i = 1;2; the centres Z (G_1 =H $_1$) and Z (G_2 =H $_2$) of the quotient groups G_1 =H $_1$ and G_2 =H $_2$ have no subgroup in com m on.

Remark 2.4. If H E G then the subgroups of Z (G=H) are of the type K=H where H E K G and gkg 1k 1 2 H, 8g 2 G and 8k 2 K. In particular K E G:

The following proposition shows that NS-condition is strictly weaker than Leinster's hypothesis (see Proposition 3.1 of β).

P roposition 2.5. If G_1 and G_2 are two nite groups such that the sets $C(G_1)$ and $C(G_2)$ have no member in common then G_1 and G_2 satisfy NS-condition, but not conversely.

Proof. Suppose H_i E G_i , i = 1;2; are such that the centres Z (G_1 = H_1) and Z (G_2 = H_2) have a subgroup in common. So, there are non-trivial subgroups K_i = H_i of Z (G_i = H_i), i = 1;2; such that K_1 = H_1 = K_2 = H_2 . Then C (K_1 = H_1) = C (K_2 = H_2). Since H_i C K_i E G_i ; we have C (K_i = H_i) C (K_i) C (G_i), i = 1;2. Thus, C (G_1) and C (G_2) have a member in common.

That the converse is not true can be easily seen by considering $G_1 = G_2 = a$ nite simple non-abelian group or a product of such groups.

P roposition 2.6. Two nite groups G_1 and G_2 satisfy NS-condition if and only if $gcd(n_1; n_2) = 1$ where

$$n_i = Q_{H_i \to G_i} \not Z (G_i = H_i) \dot r i = 1;2:$$

Proof. If each n_i is divisible by a prime p, then p divides Z ($G_i=H_i$) j for some H_i E G_i , i=1;2. So, each of Z ($G_i=H_i$), i=1;2, has a subgroup of order p (see [1]) . Obviously such a subgroup is isom orphic to Z_p .

Conversely, if gcd $(n_1;n_2) = 1$ then 8 H $_i$ E G $_i$, i=1;2, the centres Z $(G_1=H_1)$ and Z $(G_2=H_2)$ have coprime orders and so they can not have any subgroup in common.

The following corollary is im mediate.

Corollary 2.7. If two nite groups G_1 and G_2 have coprime orders then they satisfy NS-condion. Converse also holds if G_1 and G_2 are nite abelian.

3. Main Theorem

In this section we show that the NS-condition is indeed necessary as well as su cient.

Theorem 3.1. Let G_1 and G_2 be any two groups (nite or in nite, abelian or non-abelian). Then all normal subgroups of G_1 G_2 are of standard type if and only if G_1 and G_2 satisfy NS-condition.

Proof. Suppose G_1 and G_2 satisfy NS-condition. Let N E G_1 G_2 . Set $H_1 = {}_1$ (G_1 fe_2g) \ N) and $H_2 = {}_2$ ((fe $_1g$ G_2) \ N) where e_i are identities of G_i and ${}_i$: G_1 G_2 ! G_i are projections, i = 1; 2. Then H_1 fe_2g ; fe_1g H_2 N ${}_1$ (N) ${}_2$ (N) and so

It may be noted here that $H_i \to G_i$ and $H_i \to G_i$ (N), i = 1;2: Now, suppose $a_1 \to G_i$ (N). Then $(a_1;a_2) \to G_i$ for some $a_2 \to G_i$ in fact $a_2 \to G_i$ (N). Therefore, $g_1 \to G_i$ we have

Finally, if $b \ge 2 (N)$ then $(a;b) \ge 2 (N)$ for some $a \ge 2 (N)$ and so $f(aH_1)=bH_2$, which implies that f is surjective. Thus f is an isom orphism. Thus $(g_1;g_2)(a_1;a_2)(g_1;g_2)^{-1} \ 2\ N$, and so $N \ E \ G_1 \ G_2$. On the other hand, suppose N is of standard form $N_1 \ N_2$ where $N_i \ E \ G_i$, i=1;2. Then, $_i(N)=N_i$, i=1;2. But since F is bijective, we have $_i(N)=K_i$, i=1;2. Therefore, $N=K_1 \ K_2$. Since $K_1=H_1$ is non-trivial, there is some $a_1 \ 2\ K_1$ such that $a_1H_1 \ f \ H_1$. But $(a_1;e_2) \ 2\ K_1 \ K_2 = N$. So, $F(a_1H_1)=e_2H_2=H_2$, the zero element of $K_2=H_2$. Therefore, since F is injective, we have $a_1H_1=H_1$, the zero element of $K_1=H_1$. This contradiction shows that N is not of standard type.

As an imm ediate consequence, using induction and the fact that the centre of a product of groups equals the product of the centres of the constituent groups, we have

Corollary 3.3. Let $G = \bigcap_{i=1}^{Q} G_i$ where allor all-but-one of the groups G_i are simple non-abelian. Then every norm alsubgroup of G is of the standard type $\bigcap_{i=1}^{n} N_i$ where $N_i \to G_i$, i=1,2.
