The moduli space of curves is rigid

1 Introduction

Kapranov has proposed the following informal statement [Kapranov97]. Given a smooth variety X = X(0), consider the moduli space X(1) of varieties obtained as deformations of X(0), the moduli space X(2) of deformations of X(1), and so on. Then this process should stop after $n = \dim X$ steps, i.e., X(n) should be rigid (no infinitesimal deformations). Roughly speaking, one thinks of X(1) as H^1 of a sheaf of non-abelian groups on X(0). Indeed, at least the tangent space to X(1) at [X] is identified with $H^1(T_X)$, where T_X is the tangent sheaf, the sheaf of first order infinitesimal automorphisms of X. Then one regards X(m) as a kind of non-Abelian H^m , and the analogy with the usual definition of Abelian H^m suggests the statement above.

In particular, the moduli space of curves should be rigid. In this paper, we verify this in the following precise form: the moduli stack of stable curves of genus g with n marked points is rigid for each g and n.

On the other hand, moduli spaces of surfaces should have non-trivial deformations in general. I do not know any examples at present, but hope to address this question in the future. It seems plausible that there should be a non-trivial deformation of a moduli space of surfaces whose fibres parametrise "generalised surfaces" in some sense, for example non-commutative surfaces. From this point of view the result of this paper says that the concept of a curve cannot be deformed.

Let us also note that our result can be thought of as a version of Mostow rigidity for the mapping class group. Recall that the moduli space M_g of smooth complex curves of genus g is the quotient of the Teichmüller space T_g by the mapping class group Γ_g . The space T_g is a bounded domain in \mathbb{C}^{3g-3} , which is homeomorphic to a ball, and Γ_g acts discontinuously on T_g with finite stabilisers. We thus obtain M_g as a complex orbifold with orbifold fundamental group Γ_g . The space T_g admits a natural metric, the Weil– Petersson metric, which has negative holomorphic sectional curvatures. So, roughly speaking, M_g looks like a quotient of a complex ball by a discrete group Γ of isometries, with finite volume. Mostow rigidity predicts that such a quotient is uniquely determined by the group Γ up to complex conjugation. (This is certainly true if Γ acts freely with compact quotient, see [Siu80]). In particular, it should have no infinitesimal deformations. Unfortunately I do not know a proof along these lines.

2 Statements

We work over an algebraically closed field k of characteristic zero. Let g and n be non-negative integers such that 2g - 2 + n > 0. Let $\overline{\mathcal{M}}_{g,n}$ denote the moduli stack of stable curves of genus g with n marked points. The stack $\overline{\mathcal{M}}_{g,n}$ is a smooth proper Deligne–Mumford stack of dimension 3g - 3 + n.

Theorem 2.1. The stack $\overline{\mathcal{M}}_{g,n}$ is rigid, that is, has no infinitesimal deformations.

Let $\partial \overline{\mathcal{M}}_{g,n} \subset \overline{\mathcal{M}}_{g,n}$ denote the boundary of the moduli stack, that is, the complement of the locus of smooth curves (with its reduced structure). The locus $\partial \overline{\mathcal{M}}_{g,n}$ is a normal crossing divisor in $\overline{\mathcal{M}}_{g,n}$.

Theorem 2.2. The pair $(\overline{\mathcal{M}}_{g,n}, \partial \overline{\mathcal{M}}_{g,n})$ has no locally trivial deformations.

Let $\overline{M}_{g,n}$ denote the coarse moduli space of the stack $\overline{\mathcal{M}}_{g,n}$. The space $\overline{M}_{g,n}$ is a projective variety with quotient singularities.

Theorem 2.3. The variety $\overline{M}_{g,n}$ has no locally trivial deformations if $(g, n) \neq (1, 2), (2, 0), (2, 1), (3, 0)$.

Remark 2.4. In the exceptional cases, the projection $\overline{\mathcal{M}}_{g,n} \to \overline{\mathcal{M}}_{g,n}$ is ramified in codimension one over the interior of $\overline{\mathcal{M}}_{g,n}$, and an additional calculation is needed to relate the deformations of the stack and the deformations of the coarse moduli space (cf. Prop. 5.2). Presumably the result still holds.

3 Proof of Theorem 2.2

Let $\Omega_{\overline{\mathcal{M}}_{g,n}}(\log)$ denote the sheaf of 1-forms on $\overline{\mathcal{M}}_{g,n}$ with logarithmic poles along the boundary, and $T_{\overline{\mathcal{M}}_{g,n}}(\log)$ the dual of $\Omega_{\overline{\mathcal{M}}_{g,n}}(\log)$. The sheaf $T_{\overline{\mathcal{M}}_{g,n}}(\log)$ is the subsheaf of the tangent sheaf $T_{\overline{\mathcal{M}}_{g,n}}$ consisting of vector fields on $\overline{\mathcal{M}}_{g,n}$ which are tangent to the boundary. In other words, it is the sheaf of first order infinitesimal automorphisms of the pair $(\overline{\mathcal{M}}_{g,n}, \partial \overline{\mathcal{M}}_{g,n})$. Hence the first order locally trivial deformations of the pair $(\overline{\mathcal{M}}_{g,n}, \partial \overline{\mathcal{M}}_{g,n})$ are identified with the space $H^1(T_{\overline{\mathcal{M}}_{g,n}}(\log))$. To prove Thm. 2.2, we show $H^1(T_{\overline{\mathcal{M}}_{g,n}}(\log)) = 0$.

Let $\pi : \mathcal{U}_{g,n} \to \overline{\mathcal{M}}_{g,n}$ denote the universal family over $\overline{\mathcal{M}}_{g,n}$. That is, $\mathcal{U}_{g,n}$ is the stack of *n*-pointed stable curves of genus *g* together with an extra section (with no smoothness condition). There is an isomorphism of stacks

$$c: \overline{\mathcal{M}}_{g,n+1} \stackrel{\sim}{\longrightarrow} \mathcal{U}_{g,n}$$

which identifies the morphism $p_{n+1} : \overline{\mathcal{M}}_{g,n+1} \to \overline{\mathcal{M}}_{g,n}$ given by forgetting the last point with the projection $\pi : \mathcal{U}_{g,n} \to \overline{\mathcal{M}}_{g,n}$ [Knudsen83a, Sec. 1–2]. We define the boundary $\partial \mathcal{U}_{g,n} \subset \mathcal{U}_{g,n}$ as the image of $\partial \overline{\mathcal{M}}_{g,n+1} \subset \overline{\mathcal{M}}_{g,n+1}$ under the isomorphism c. Equivalently, $\partial \mathcal{U}_{g,n}$ is the union of $\pi^* \partial \overline{\mathcal{M}}_{g,n}$ and the n tautological sections of π .

We assume the reader is familiar with log structures at the level of [KatoK89]. If \mathcal{X} is a Deligne–Mumford stack, we can consider the étale site of \mathcal{X} , and define log structures on \mathcal{X} as in the case of schemes. If $(X, \mathcal{M}) \rightarrow (Y, \mathcal{N})$ is a morphism of log schemes (or stacks), we write $\Omega_{X/Y}(\log)$ for the sheaf of logarithmic 1-forms, and $T_{X/Y}(\log)$ for the dual sheaf.

The normal crossing divisors $\partial \overline{\mathcal{M}}_{g,n} \subset \overline{\mathcal{M}}_{g,n}$ and $\partial \mathcal{U}_{g,n} \subset \mathcal{U}_{g,n}$ define smooth log structures $\mathcal{M}_{\overline{\mathcal{M}}_{g,n}}$ and $\mathcal{M}_{\mathcal{U}_{g,n}}$. The morphism $\pi \colon \mathcal{U}_{g,n} \to \overline{\mathcal{M}}_{g,n}$ extends naturally to a log smooth morphism of log stacks $\pi \colon (\mathcal{U}_{g,n}, \mathcal{M}_{\mathcal{U}_{g,n}}) \to (\overline{\mathcal{M}}_{g,n}, \mathcal{M}_{\overline{\mathcal{M}}_{g,n}})$. There is an exact sequence

$$0 \to \pi^* \Omega_{\overline{\mathcal{M}}_{g,n}}(\log) \to \Omega_{\mathcal{U}_{g,n}}(\log) \to \Omega_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log) \to 0.$$
(1)

Here $\Omega_{\overline{\mathcal{M}}_{g,n}}(\log)$ and $\Omega_{\mathcal{U}_{g,n}}(\log)$ are the sheaves of 1-forms with logarithmic poles along the boundary. Let ω_{π} denote the relative dualising sheaf of the morphism $\pi : \mathcal{U}_{g,n} \to \overline{\mathcal{M}}_{g,n}$ and Σ the union of the *n* tautological sections of π . The sheaf $\Omega_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log)$ is identified with the line bundle $\omega_{\pi}(\Sigma)$. Indeed, the exact sequence above induces an isomorphism

$$\Omega_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log) \cong \det \Omega_{\mathcal{U}_{g,n}}(\log) \otimes \pi^* \det \Omega_{\overline{\mathcal{M}}_{g,n}}(\log)^{\vee} \\ = \omega_{\mathcal{U}_{g,n}}(\partial \mathcal{U}_{g,n}) \otimes \pi^* \omega_{\overline{\mathcal{M}}_{g,n}}(\partial \overline{\mathcal{M}}_{g,n})^{\vee}.$$

Now $\omega_{\mathcal{U}_{g,n}} \otimes \pi^* \omega_{\overline{\mathcal{M}}_{g,n}}^{\vee} \cong \omega_{\pi}$ since π is a Gorenstein morphism [Hartshorne66, p. 142–4] and $\partial \mathcal{U}_{g,n} - \pi^* \partial \overline{\mathcal{M}}_{g,n} = \Sigma$, so $\Omega_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log) \cong \omega_{\pi}(\Sigma)$ as claimed.

Dualising the exact sequence (1) we obtain an exact sequence

$$0 \to T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log) \to T_{\mathcal{U}_{g,n}}(\log) \to \pi^* T_{\overline{\mathcal{M}}_{g,n}}(\log) \to 0.$$

Applying π_* , we obtain a long exact sequence of sheaves on $\overline{\mathcal{M}}_{g,n}$ with connecting homomorphism

$$\delta: T_{\overline{\mathcal{M}}_{g,n}}(\log) \to R^1 \pi_* T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log).$$

We claim that the map δ is an isomorphism. The idea is the following: The map δ is the Kodaira–Spencer map for the log smooth family $(\mathcal{U}_{g,n}, \mathcal{M}_{\mathcal{U}_{g,n}}) \to (\overline{\mathcal{M}}_{g,n}, \mathcal{M}_{\overline{\mathcal{M}}_{g,n}})$ (we make this precise below). The family $(\mathcal{U}_{g,n}, \mathcal{M}_{\mathcal{U}_{g,n}}) \to (\overline{\mathcal{M}}_{g,n}, \mathcal{M}_{\overline{\mathcal{M}}_{g,n}})$ is the universal log stable curve of type (g, n) (see [KatoF00] for the precise statement). Hence δ is an isomorphism.

Let us now be more explicit. Let $U \to \overline{\mathcal{M}}_{q,n}$ be étale and $p \in U$ a point. Then the restriction of the universal family of pointed stable curves to the germ $(p \in U)$ is the universal deformation of the fibre (C, x_1, \ldots, x_n) over p. Let \mathcal{M}_U denote the log structure on U. Write k = k(p), and let \mathcal{M}_k denote the log structure on Spec k pulled back from U. Let $A = k[t]/(t^2)$, and let \mathcal{M}_A denote the log structure on Spec A pulled back from Spec k via the retraction $\operatorname{Spec} A \to \operatorname{Spec} k$. Then $T_{\overline{\mathcal{M}}_{q,n}}(\log) \otimes k$ is identified with the set of liftings of $(\operatorname{Spec} k, \mathcal{M}_k) \to (U, \mathcal{M}_U)$ to a morphism $(\operatorname{Spec} A, \mathcal{M}_A) \to$ (U, \mathcal{M}_U) , by [KatoK89, Prop. 3.9, p. 203]. Let \mathcal{M}_C denote the log structure on C pulled back from the log structure on $\mathcal{U}_{g,n}$. The fibre $H^1(T_{C/k}(\log))$ of $R^1 \pi_* T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log)$ at p is identified with the set of log smooth deformations of $(C, \mathcal{M}_C)/(\operatorname{Spec} k, \mathcal{M}_k)$ over $(\operatorname{Spec} A, \mathcal{M}_A)$, i.e., log smooth morphisms $(C', \mathcal{M}_{C'})/(\operatorname{Spec} A, \mathcal{M}_A)$ extending $(C, \mathcal{M}_C)/(\operatorname{Spec} k, \mathcal{M}_k)$, by [KatoK89, Prop. 3.14(3), p. 205]. The map $\delta \otimes k : T_{\overline{\mathcal{M}}_{q,n}}(\log) \otimes k \to H^1(T_{C/k}(\log))$ sends a morphism (Spec A, \mathcal{M}_A) $\rightarrow (U, \mathcal{M}_U)$ to the log smooth deformation $(C', \mathcal{M}_{C'})/(\operatorname{Spec} A, \mathcal{M}_A)$ obtained by pullback from the family over U. This is verified exactly as in the case of a smooth family of schemes (cf., e.g., [Voisin02, 9.1.2, p. 223–5]).

It remains to check that $\delta \otimes k$ is an isomorphism. The sheaf $T_{C/k}(\log)$ is the dual of $\omega_C(x_1 + \cdots + x_n)$, where ω_C is the dualising sheaf, hence $\dim H^1(T_{C/k}(\log)) = 3g - 3 + n = \dim T_{\overline{\mathcal{M}}_{g,n}}(\log) \otimes k$ by Riemann Roch. So it is enough to show that $\delta \otimes k$ is injective. Suppose that a lifting $(\operatorname{Spec} A, \mathcal{M}_A) \to (U, \mathcal{M}_U)$ induces the trivial log smooth deformation of $(C, \mathcal{M}_C)/(\operatorname{Spec} k, \mathcal{M}_k)$. Then, since $(p \in U)$ is the universal deformation space of (C, x_1, \ldots, x_n) , it follows that the underlying morphism of schemes Spec $A \to U$ is the "constant" morphism $f : \operatorname{Spec} A \to \operatorname{Spec} k \to U$. The morphism (Spec A, \mathcal{M}_A) \to (Spec U, \mathcal{M}_U) is then given by an automorphism $\sigma : f^* \mathcal{M}_U = \mathcal{M}_A \to \mathcal{M}_A$. So, the induced log deformation $(C', \mathcal{M}_{C'}) \to$ (Spec A, \mathcal{M}_A) is isomorphic to the deformation given by

$$(C, \mathcal{M}_C) \times_{(\operatorname{Spec} k, \mathcal{M}_k)} (\operatorname{Spec} A, \mathcal{M}_A) \to (\operatorname{Spec} A, \mathcal{M}_A) \xrightarrow{g} (\operatorname{Spec} A, \mathcal{M}_A),$$

where g is the automorphism given by the identity map on Spec A and the automorphism σ^{-1} of \mathcal{M}_A . By [KatoF00, Prop. 2.1, p. 228] (or explicit calculation, cf. [Olsson01, Lem. 5.3.2, p. 112]), the log smooth deformation $(C', \mathcal{M}_{C'})/(\operatorname{Spec} A, \mathcal{M}_A)$ is isomorphic to the trivial deformation only if σ equals the identity. Thus $\delta \otimes k$ is injective, as required.

We have $H^0(T_{C/k}(\log)) = 0$ for each fibre C/k of $\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}$. Hence $\pi_*T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log) = 0$. Also $R^i\pi_*T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log) = 0$ for i > 1 by dimensions. So $H^{i+1}(T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}) = H^i(R^1\pi_*T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}})$ by the Leray spectral sequence. Hence the isomorphism δ induces an isomorphism

$$H^{i}(T_{\overline{\mathcal{M}}_{g,n}}(\log)) \xrightarrow{\sim} H^{i+1}(T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}(\log))$$
 (2)

for each i.

Recall that the sheaf $T_{\mathcal{U}_{g,n}/\mathcal{M}_{g,n}}(\log)$ is the dual of the line bundle $\omega_{\pi}(\Sigma)$. Let $U_{g,n}$ denote the coarse moduli space of the stack $\mathcal{U}_{g,n}$ and $p: \mathcal{U}_{g,n} \to U_{g,n}$ the projection. The line bundle $\omega_{\pi}(\Sigma)$ on the stack $\mathcal{U}_{g,n}$ defines a \mathbb{Q} -line bundle $p_*^{\mathbb{Q}}\omega_{\pi}(\Sigma)$ on the coarse moduli space $U_{g,n}$ (see Sec. 5). We use the following important result, which can be viewed as a generalisation of a result of Arakelov [Arakelov71, Prop. 3.2, p. 1297], and depends on subsequent work by Fujita, Keel, Kollár, Viehweg and others.

Theorem 3.1. [Keel99, Thm 0.4, p. 255] The \mathbb{Q} -line bundle $p^{\mathbb{Q}}_*\omega_{\pi}(\Sigma)$ is big and nef on $U_{g,n}$.

It follows by Kodaira vanishing (see Thm 6.1) that $H^i(T_{\mathcal{U}_{g,n}/\overline{\mathcal{M}}_{g,n}}) = H^i(\omega_{\pi}(\Sigma)^{\vee}) = 0$ for $i < \dim \mathcal{U}_{g,n}$. Combining with (2), we deduce

Proposition 3.2. $H^i(T_{\overline{\mathcal{M}}_{g,n}}(\log)) = 0$ for $i < \dim \overline{\mathcal{M}}_{g,n}$.

In particular, $H^1(T_{\overline{\mathcal{M}}_{g,n}}(\log)) = 0$ if dim $\overline{\mathcal{M}}_{g,n} > 1$. The remaining cases are easy to check. This completes the proof of Theorem 2.2.

4 Proof of Theorem 2.1

We now prove Theorem 2.1. Since $\overline{\mathcal{M}}_{g,n}$ is a smooth Deligne–Mumford stack, its first order infinitesimal deformations are identified with the space $H^1(T_{\overline{\mathcal{M}}_{g,n}})$, and we must show that $H^1(T_{\overline{\mathcal{M}}_{g,n}}) = 0$. Let \mathcal{B} denote the boundary $\partial \overline{\mathcal{M}}_{g,n}$, and let $\nu \colon \mathcal{B}^{\nu} \to \mathcal{B}$ denote its normalisation. We have an exact sequence

$$0 \to \Omega_{\overline{\mathcal{M}}_{g,n}} \to \Omega_{\overline{\mathcal{M}}_{g,n}}(\log) \to \nu_{\star}\mathcal{O}_{\mathcal{B}^{\nu}} \to 0$$

where the last map is the Poincaré residue map. Dualising, we obtain an exact sequence

$$0 \to T_{\overline{\mathcal{M}}_{q,n}}(\log) \to T_{\overline{\mathcal{M}}_{q,n}} \to \nu_* \mathcal{N} \to 0$$

where \mathcal{N} is a line bundle on B^{ν} . Roughly speaking, the line bundle \mathcal{N} is the normal bundle of the map $\mathcal{B}^{\nu} \to \overline{\mathcal{M}}_{g,n}$. More precisely, étale locally at a point p of \mathcal{B}^{ν} , the line bundle \mathcal{N} is identified with the pullback of the normal bundle of the corresponding branch of the boundary $\mathcal{B} \subset \overline{\mathcal{M}}_{g,n}$ at $\nu(p)$. Consider the associated long exact sequence of cohomology

$$\cdots \to H^i(T_{\overline{\mathcal{M}}_{g,n}}(\log)) \to H^i(T_{\overline{\mathcal{M}}_{g,n}}) \to H^i(\mathcal{N}) \to \cdots$$

We prove below that $H^i(\mathcal{N}) = 0$ for $i < \dim \mathcal{B}$. Now, since $H^i(T_{\overline{\mathcal{M}}_{g,n}}(\log)) = 0$ for $i < \dim \overline{\mathcal{M}}_{g,n}$ by Prop. 3.2, we deduce

Proposition 4.1. $H^i(T_{\overline{\mathcal{M}}_{g,n}}) = 0$ for $i < \dim \overline{\mathcal{M}}_{g,n} - 1$.

In particular, $H^1(T_{\overline{\mathcal{M}}_{g,n}}) = 0$ if dim $\overline{\mathcal{M}}_{g,n} > 2$. In the remaining cases it is easy to check that $H^1(\mathcal{N}) = 0$, so again $H^1(T_{\overline{\mathcal{M}}_{g,n}}) = 0$.

The irreducible components of the normalisation \mathcal{B}^{ν} of the boundary $\mathcal{B} \subset \overline{\mathcal{M}}_{g,n}$ are finite images of the following stacks [Knudsen83a, Def. 3.8, Cor. 3.9]:

- (1) $\overline{\mathcal{M}}_{g_1,S_1\cup\{n+1\}}\times\overline{\mathcal{M}}_{g_2,S_2\cup\{n+2\}}$ where $g_1+g_2=g$ and S_1, S_2 is a partition of $\{1,\ldots,n\}$.
- (2) $\overline{\mathcal{M}}_{g-1,n+2}$

Here $\overline{\mathcal{M}}_{h,S}$ denotes the moduli stack of stable curves of genus h with marked points labelled by a finite set S. In each case the map to \mathcal{B}^{ν} is given by identifying the points labelled by n+1 and n+2. The map is an isomorphism onto the component of \mathcal{B}^{ν} except in case (1) for $g_1 = g_2$ and n = 0 and case (2), when it is étale of degree 2.

For $\overline{\mathcal{M}}_{h,S}$ a moduli stack of pointed stable curves as above, let $\pi: \mathcal{U}_{h,S} \to \overline{\mathcal{M}}_{h,S}$ denote the universal family, and $x_i: \overline{\mathcal{M}}_{h,S} \to \mathcal{U}_{h,S}, i \in S$, the tautological sections of π . Define $\psi_i = x_i^* \omega_{\pi}$, the pullback of the relative dualising sheaf of π along the section x_i .

Lemma 4.2. The pullback of \mathcal{N}^{\vee} to $\overline{\mathcal{M}}_{g_1,S_1\cup\{n+1\}} \times \overline{\mathcal{M}}_{g_2,S_2\cup\{n+2\}}$ is identified with $\operatorname{pr}_1^*\psi_{n+1} \otimes \operatorname{pr}_2^*\psi_{n+2}$. Similarly, the pullback of \mathcal{N}^{\vee} to $\overline{\mathcal{M}}_{g-1,n+2}$ is identified with $\psi_{n+1} \otimes \psi_{n+2}$.

Proof. Let $U \to \overline{\mathcal{M}}_{g,n}$ be étale and $p \in U$ a point. Let (C, x_1, \ldots, x_n) be the fibre of the universal family of pointed stable curves over p. The tangent space at $p \in U$ is identified with the space of first order deformations of (C, x_1, \ldots, x_n) , which equals $\operatorname{Ext}^1(\Omega_C(\sum x_i), \mathcal{O}_C)$, cf. [DM69, p. 79–82]. The components of the boundary at $p \in U$ are labelled by the nodes of C — the component B_q labelled by a node q is the locus where the induced deformation of the germ $(q \in C)$ is trivial. The fibre of the normal bundle $\mathcal{N}_{B_q/U}$ at p is thus identified with the 1-dimensional k-vector space $\operatorname{Ext}^1(\Omega_{\hat{\mathcal{O}}_{C,q}}, \hat{\mathcal{O}}_{C,q})$. Let $C^{\nu} \to C$ denote the normalisation of C and q_1, q_2 the pre-images of q. The space $\operatorname{Ext}^1(\Omega_{\hat{\mathcal{O}}_{C,q}}, \hat{\mathcal{O}}_{C,q})$ is canonically isomorphic to $\mathcal{O}_{C^{\nu}}(q_1)|_{q_1} \otimes \mathcal{O}_{C^{\nu}}(q_2)|_{q_2}$ [Friedman83, Prop. 2.3, p. 85], and there are isomorphisms $\omega_{C^{\nu}} \otimes \mathcal{O}_{C^{\nu}}(q_i)|_{q_i} \cong \mathcal{O}_{q_i}$ given by the residue map. Combining, we obtain a canonical isomorphism $\mathcal{N}_{B_q/U}^{\vee} \otimes k(p) \cong \omega_{C^{\nu}}|_{q_1} \otimes \omega_{C^{\nu}}|_{q_2}$. This gives the desired identifications.

Lemma 4.3. [Knudsen83b, Thm. 4.1(d), p. 202] The line bundle ψ_{n+1} on $\overline{\mathcal{M}}_{g,n+1}$ is identified with the pullback of the line bundle $\omega_{\pi}(\Sigma)$ under the isomorphism $\phi: \overline{\mathcal{M}}_{g,n+1} \to \mathcal{U}_{g,n}$.

Corollary 4.4. The \mathbb{Q} -line bundle on the coarse moduli space of \mathcal{B}^{ν} defined by \mathcal{N}^{\vee} is big and nef on each component

Proof. This follows immediately from Lem. 4.2, Lem. 4.3, and Thm. 3.1. \Box

We deduce that $H^i(\mathcal{N}) = 0$ for $i < \dim \mathcal{B}$ by Thm 6.1. This completes the proof of Theorem 2.1.

5 Proof of Theorem 2.3

We first prove a basic lemma which relates the deformations of a smooth Deligne–Mumford stack and its coarse moduli space.

Let \mathcal{X} be a smooth proper Deligne–Mumford stack, X the coarse moduli space of \mathcal{X} , and $p: \mathcal{X} \to X$ the projection. Let $T_{\mathcal{X}}$ denote the tangent sheaf of \mathcal{X} . Let $D \subset X$ be the union of the codimension one components of the branch locus of $p: \mathcal{X} \to X$ (with its reduced structure). Let $T_X(\log D)$ denote the subsheaf of the tangent sheaf T_X consisting of derivations which preserve the ideal sheaf of D. It is the sheaf of first order infinitesimal automorphisms of the pair (X, D).

Lemma 5.1. $p_*T_{\mathcal{X}} = T_X(\log D)$

Proof. The sheaves $p_*T_{\mathcal{X}}$ and $T_X(\log D)$ satisfy Serre's S_2 condition, and are identified over the locus where p is étale. So it suffices to work in codimension 1. We reduce to the case $\mathcal{X} = [\mathbb{A}^1_x/\mu_e]$, where $\mu_e \ni \zeta : x \mapsto \zeta x$. Then $X = \mathbb{A}^1_x/\mu_e = \mathbb{A}^1_y$, where $y = x^e$, and $D = (y = 0) \subset X$. Let $\pi : \mathbb{A}^1_x \to \mathbb{A}^1_x/\mu_e$ be the quotient map. We compute

$$p_*T_{\mathcal{X}} = \left(\pi_*\mathcal{O}_{\mathbb{A}^1_x} \cdot \frac{\partial}{\partial x}\right)^{\mu_e} = \mathcal{O}_{\mathbb{A}^1_y} \cdot x \frac{\partial}{\partial x} = \mathcal{O}_{\mathbb{A}^1_y} \cdot y \frac{\partial}{\partial y} = T_X(\log D),$$

as required.

Proposition 5.2. The first order deformations of the stack \mathcal{X} are identified with the first order locally trivial deformations of the pair (X, D).

Proof. By the Lemma,
$$H^1(T_{\mathcal{X}}) = H^1(p_*T_{\mathcal{X}}) = H^1(T_X(\log D)).$$

We now apply this result to relate deformations of the stack $\overline{\mathcal{M}}_{g,n}$ and its coarse moduli space $\overline{\mathcal{M}}_{g,n}$.

A stable *n*-pointed curve of genus 0 has no non-trivial automorphisms. Hence the stack $\overline{\mathcal{M}}_{0,n}$ is equal to its coarse moduli space $\overline{\mathcal{M}}_{0,n}$, and $\overline{\mathcal{M}}_{0,n}$ is rigid by Thm. 2.1. Also, recall that $\overline{\mathcal{M}}_{1,1}$ is isomorphic to \mathbb{P}^1 and therefore rigid. So, in the following, we assume that $g \neq 0$ and $(g, n) \neq (1, 1)$.

Let $\mathcal{D} \subset \mathcal{M}_{g,n}$ be the component of the boundary whose general point is a curve with two components of genus 1 and g-1 meeting in a node, with each of the *n* marked points on the component of genus g-1. Note that each point of \mathcal{D} has a non-trivial automorphism given by the involution of the component of genus 1 fixing the node. Let $p: \overline{\mathcal{M}}_{g,n} \to \overline{\mathcal{M}}_{g,n}$ be the projection, and $D \subset \overline{\mathcal{M}}_{g,n}$ the coarse moduli space of \mathcal{D} .

Proposition 5.3. If $g + n \ge 4$ then the automorphism group of a general point of $\overline{\mathcal{M}}_{g,n}$ is trivial, and the divisor $D \subset \overline{\mathcal{M}}_{g,n}$ is the unique codimension 1 component of the branch locus of p.

Proof. This is a straightforward dimension count. One shows that the locus of *smooth* curves in $\overline{\mathcal{M}}_{g,n}$ with a non-trivial automorphism has codimension at least (g-2) + n. Together with the description of the components of the boundary this implies the result.

Assume $g + n \geq 4$. Let $\nu : \mathcal{D}^{\nu} \to \mathcal{D}$ denote the normalisation, then $\mathcal{D}^{\nu} \cong \overline{\mathcal{M}}_{1,1} \times \overline{\mathcal{M}}_{g-1,n+1}$. Let \mathcal{N} denote the normal bundle of the map $\mathcal{D}^{\nu} \to \overline{\mathcal{M}}_{g,n}$, cf. Sec. 4.

Lemma 5.4. There is an exact sequence

$$0 \to T_{\overline{M}_{g,n}}(\log D) \to T_{\overline{M}_{g,n}} \to p_*\nu_*\mathcal{N}^{\otimes 2} \to 0.$$

Proof. We identify the cokernel of the map $T_{\overline{M}_{g,n}}(\log D) \to T_{\overline{M}_{g,n}}$. Étale locally over the coarse moduli space, the projection p is of the form $[U/G] \to U/G$, where U is a smooth affine variety and G a finite group acting on U. We reduce to the case $U = \mathbb{A}^N$ with G acting linearly. Let V = U/Gand $\pi: U \to V$ the quotient map. Let $H \subset G$ be the (normal) subgroup generated by pseudo-reflections. Write U' = U/H and let $\alpha: U \to U'$ and $\beta: U' \to V$ be the quotient maps. Then U' is smooth and β is étale in codimension 1. Let $B \subset U$ be the union of the reflecting hyperplanes, B'its image in U', and D its image in V. In our case B is a normal crossing divisor — it is the pullback of the divisor $\mathcal{D} \subset \overline{\mathcal{M}}_{g,n}$ by Prop 5.3. Hence we may assume $H = \mu_{m_1} \times \cdots \times \mu_{m_r}$, and H acts on $U = \mathbb{A}_{x_1,\ldots,x_N}^N$ via

$$H \ni h = (\zeta_1, \dots, \zeta_r) : x_i \mapsto \begin{cases} \zeta_i x_i & \text{if } i \le r \\ x_i & \text{if } i > r \end{cases}$$

Then $B = B_1 \cup \cdots \cup B_r$ where $B_i = (x_i = 0)$. Also $U' = \mathbb{A}_{y_1,\dots,y_N}^N$, where $y_i = x_i^{m_i}$ if $i \leq r$ and $y_i = x_i$ if i > r, and $B' = B'_1 \cup \cdots \cup B'_r$ where $B'_i = (y_i = 0)$. There is an exact sequence

$$0 \to T_{U'}(\log B') \to T_{U'} \to \oplus \mathcal{N}_{B'_i/U'} \to 0.$$

Moreover, there is a canonical isomorphism $\mathcal{N}_{B'_i/U'} \cong (\alpha_* \mathcal{N}_{B_i/U}^{\otimes m_i})^H$. Applying $(\beta_*(\cdot))^{G/H}$ we obtain an exact sequence

$$0 \to T_V(\log D) \to T_V \to \pi_*(\oplus \mathcal{N}_{B_i/U}^{\otimes m_i})^G \to 0.$$

In our case $m_i = 2$ for each i, since a general point of $\mathcal{D} \subset \overline{\mathcal{M}}_{g,n}$ has automorphism group $\mathbb{Z}/2\mathbb{Z}$. Hence the cokernel of $T_{\overline{\mathcal{M}}_{g,n}}(\log D) \to T_{\overline{\mathcal{M}}_{g,n}}$ is identified with $p_*\nu_*\mathcal{N}^{\otimes 2}$ as claimed. We have $H^1(T_{\overline{M}_{g,n}}(\log D)) = H^1(T_{\overline{M}_{g,n}}) = 0$ by Prop. 5.2 and Sec. 4. Also $H^1(\mathcal{N}^{\otimes 2}) = 0$ by Thm. 6.1 because the Q-line bundle defined by \mathcal{N}^{\vee} on the coarse moduli space of \mathcal{D}^{ν} is big and nef by Cor. 4.4. So $H^1(T_{\overline{M}_{g,n}}) = 0$, that is, $\overline{M}_{g,n}$ has no locally trivial deformations. This concludes the proof of Thm. 2.3.

6 Appendix: Kodaira vanishing for stacks

Let \mathcal{X} be a smooth proper Deligne–Mumford stack, X the coarse moduli space of \mathcal{X} , and $p: \mathcal{X} \to X$ the projection. Étale locally on $X, p: \mathcal{X} \to X$ is of the form $p: [U/G] \to U/G$, where U is a smooth affine variety and G is a finite group acting on U [AV02, Lemma 2.2.3, p. 32]. A sheaf \mathcal{F} on [U/G]corresponds to a G-equivariant sheaf \mathcal{F}_U on U, and $p_*\mathcal{F} = (\pi_*\mathcal{F}_U)^G$, where $\pi: U \to U/G$ is the quotient map.

Let \mathcal{L} be a line bundle on \mathcal{X} . Then, for $N \in \mathbb{N}$ sufficiently divisible, the pushforward $p_*(\mathcal{L}^{\otimes N})$ is a line bundle on X. We define $p_*^{\mathbb{Q}}\mathcal{L} = \frac{1}{N}p_*(\mathcal{L}^{\otimes N}) \in \operatorname{Pic}(X) \otimes \mathbb{Q}$, and call $p_*^{\mathbb{Q}}\mathcal{L}$ the \mathbb{Q} -line bundle on X defined by \mathcal{L} .

Theorem 6.1. Assume that the coarse moduli space X is an algebraic variety. If the \mathbb{Q} -line bundle $p^{\mathbb{Q}}_*\mathcal{L}$ on X is big and nef then $H^i(\mathcal{L}^{\vee}) = 0$ for $i < \dim \mathcal{X}$.

Theorem 6.1 is proved by reducing to the following generalisation of the Kodaira vanishing theorem.

Theorem 6.2. [KM98, Thm. 2.70, p. 73] Let X be a proper normal variety and Δ a \mathbb{Q} -divisor on X such that the pair (X, Δ) is Kawamata log terminal (klt). Let N be a \mathbb{Q} -Cartier Weil divisor on X such that $N \equiv M + \Delta$, where M is a big and nef \mathbb{Q} -Cartier \mathbb{Q} -divisor. Then $H^i(X, \mathcal{O}_X(-N)) = 0$ for $i < \dim X$.

Proof of Thm. 6.1. Observe first that X is a normal variety with quotient singularities. Consider the sheaf $p_*(\mathcal{L}^{\vee})$ on X. If the automorphism group of a general point of \mathcal{X} acts nontrivially on \mathcal{L} , then $p_*\mathcal{L}^{\vee} = 0$, and so $H^i(\mathcal{L}^{\vee}) = H^i(p_*\mathcal{L}^{\vee}) = 0$ for each *i*. Suppose now that the automorphism group of a general point acts trivially on \mathcal{L} . Then $p_*\mathcal{L}^{\vee}$ is a rank 1 reflexive sheaf on X. Write $p_*\mathcal{L}^{\vee} = \mathcal{O}_X(-N)$, where N is a Weil divisor on X. Let $n \in \mathbb{N}$ be such that $p_*(\mathcal{L}^{\otimes n})$ is a line bundle on X. Let M be a Q-divisor corresponding to the Q-line bundle $p_*^{\mathbb{Q}}\mathcal{L} = \frac{1}{n}p_*(\mathcal{L}^{\otimes n})$. There is a natural map $(p_*\mathcal{L}^{\vee})^{\otimes n} \to p_*(\mathcal{L}^{\vee \otimes n})$, i.e., a map $\mathcal{O}_X(-nN) \to \mathcal{O}_X(-nM)$,

which is an isomorphism over the locus where p is étale. So $N \equiv M + \Delta$, where Δ is an effective \mathbb{Q} -divisor supported on the branch locus of p. Let D_1, \ldots, D_r be the codimension 1 components of the branch locus. Let e_i be the ramification index at D_i , and a_i the age of the line bundle \mathcal{L}^{\vee} along D_i . That is, over a general point of D_i , and after removing the automorphism group of a general point of \mathcal{X} , the stack \mathcal{X} is of the form $[\mathbb{A}_x^1/\mu_{e_i}]$, where $\mu_{e_i} \ni \zeta : x \mapsto \zeta \cdot x$, and μ_{e_i} acts on the fibre of \mathcal{L}^{\vee} by the character $\zeta \mapsto \zeta^{-a_i}$, where $0 \le a_i \le e_i - 1$. We compute that $\Delta = \sum \frac{a_i}{e_i} D_i$. We claim that (X, Δ) is klt. Let $\Delta' = \sum \frac{e_i - 1}{e_i} D_i$, then $K_{\mathcal{X}} = p^*(K_X +$

We claim that (X, Δ) is klt. Let $\Delta' = \sum \frac{e_i - 1}{e_i} D_i$, then $K_{\mathcal{X}} = p^*(K_X + \Delta')$, and \mathcal{X} is smooth, so (X, Δ') is klt by [KM98, Prop. 5.20(4), p. 160]. Now $\Delta \leq \Delta'$ and X is Q-factorial, so (X, Δ) is also klt. We deduce that $H^i(\mathcal{L}^{\vee}) = H^i(p_*\mathcal{L}^{\vee}) = H^i(\mathcal{O}_X(-N)) = 0$ for $i < \dim \mathcal{X}$ by Thm. 6.2.
