Large deviations for the zero set of an analytic function with diffusing coefficients

Abstract

The *hole probability* that the zero set of the time dependent planar Gaussian analytic function

$$f_{\mathcal{C}}(z,t) = \sum_{n=0}^{\infty} a_n(t) \frac{z^n}{\sqrt{n!}},\tag{1}$$

where $a_n(t)$ are *i.i.d.* complex valued Ornstein-Uhlenbeck processes, does not intersect a disk of radius R for all $t \in [0, T]$ decays like $\exp(-Te^{cR^2})$. This result sharply differentiates the zero set of $f_{\mathcal{C}}$ from a number of canonical evolving planar point processes. For example, the hole probability of the perturbed lattice model $\{\sqrt{\pi}(m, n) + c\zeta_{m,n} : m, n \in \mathbb{Z}\}$ where $\zeta_{m,n}$ are i.i.d. Ornstein-Uhlenbeck processes decays like $\exp(-cTR^4)$. This stark contrast is also present in the *overcrowding probability* that a disk of radius R contains at least N zeros for all $t \in [0, T]$.

1 Introduction

In this paper we study large deviations for the zero set $Z_{fc}(t)$ of the time dependent planar Gaussian analytic function (GAF)

$$f_{\mathcal{C}}(z,t) = \sum_{n=0}^{\infty} a_n(t) \frac{z^n}{\sqrt{n!}},\tag{2}$$

where $a_n(t)$ are *i.i.d.* complex valued Ornstein-Uhlenbeck processes. Specifically, $a_n(t) = e^{-t/2}B_n(e^t)$ where $B_n(t) = \frac{1}{\sqrt{2}}(B_{n,1}(t) + iB_{n,2}(t))$ is a Brownian motion in \mathbb{C} . With probability one, this process defines an analytic function in the entire plane, and at any fixed time t the distribution of $Z_{f_c}(t)$ is translation invariant (see Sodin and Tsirelson [6] for references).

Figure 1: The zero set of $f_{\mathcal{C}}(\cdot, t)$ (left) and a poisson point process with the same intensity.

Sodin and Tsirelson [7] study the large deviation behavior of Z_{fc} at a fixed time, and show that the hole probability decays exponentially in the square of the area of the disk. The overcrowding behavior of Z_{fc} at a fixed time has been studied by Krishnapur [2] who shows that the probability a fixed disk contains N zeros is asymptotic to $e^{-N^2 \log N}$. The study of Gaussian analytic functions as dynamic processes was initiated by Peres and Virág [4], who considered the closely related time dependent hyperbolic GAF

$$f_U(z,t) = \sum_{n=0}^{\infty} a_n(t) z^n,$$
(3)

where $a_n(t)$ are defined as above. Peres and Virág showed that $|f_U(\cdot, t)|$ can be reconstructed from its zeros, and hence the zero process determined by $f_U(\cdot, t)$ is a time homogenous Markov process. Their proof may be easily adapted to show that $|f_{\mathcal{C}}(\cdot, t)|$ can be reconstructed from its zero set, and hence $Z_{f_c}(t)$ is a time homogenous Markov process as well.

For fixed t, the zero set $Z_{fc}(t)$ exhibits strong repulsive forces between nearby zeros, as one can see visually in figure 2. To appreciate the effect of this repulsion, Sodin and Tsirelson compare $Z_{fc}(0)$ to three toy models. The first model is a Poisson process with the same intensity, $\pi^{-1}dm$. The second model is a *perturbed lattice model* consisting of the points $\{\sqrt{\pi}(k+i\ell) + c\zeta_{k,\ell} : k, \ell \in \mathbb{Z}\}$ where $\zeta_{k,\ell}$ are independent standard $\mathbb{C}N(0,1)$ random variables. The third model is a *triangular cluster model* consisting of the points

$$\left\{\sqrt{3\pi}(k+i\ell) + ce^{2\pi i m/3}\zeta_{k,\ell} : k, \ell \in \mathbb{Z}, m = 0, 1, 2\right\},\$$

where $\zeta_{k,\ell}$ are as before. They prove that the fixed time hole probability that $Z_{f_c}(0)$ contains no zeros in the disk of radius r decays as $\exp(-cr^4)$. This decay rate differentiates $Z_{f_c}(t)$ from the Poisson process for which the hole probability decays as $\exp(-cr^2)$, but not from the perturbed lattice and triangular cluster models. By studying the asymptotic behavior of linear statistics, Sodin and Tsirelson are able to differentiate $Z_{f_c}(t)$ from the perturbed lattice model, but not the triangular cluster model.



Figure 2: The zero set of $f_{\mathcal{C}}(\cdot, t)$ (left) and the second toy model (right), conditioned to have a hole of radius five.

Each of the toy models has a natural extension to a time dependent process which preserves its distribution. The Poisson process can be made into a time dependent process by allowing the points to evolve as independent planar Brownian motions. The perturbed lattice and triangular cluster models may be extended to time dependent processes by replacing the coefficients $\zeta_{k,\ell}$ with independent Ornstein-Uhlenbeck processes. We show that certain large deviation probabilities starkly contrast $Z_{f_c}(\cdot)$ from the other three models. Specifically, let $H_{f_c}(T, R)$ denote the hole probability that $D_R = \{z \in \mathbb{C} : |z| \leq R\}$ contains no zeros of $f_c(\cdot, t)$ for all $t \in [0, T]$. We prove that

Theorem 1.

$$\limsup_{T \to \infty} \frac{1}{T} \log \left(\mathbb{P}(H_{f_{\mathcal{C}}}(T, R)) \right) \le -e^{\left(\frac{1}{3} - o(1)\right)R^2} \tag{4}$$

and

$$\liminf_{T \to \infty} \frac{1}{T} \log \left(\mathbb{P}(H_{f_{\mathcal{C}}}(T, R)) \right) \ge -e^{(\frac{1}{2} + o(1))R^2}.$$
(5)

Denote by $H_k(T, R)$, where k equals pp for Poisson process, pl for perturbed lattice or tc for triangular cluster, the event that the time dependent k^{th} model has no points in D_R for all $t \in [0, T]$. We have the following results:

Proposition 2. For the Poisson process

$$\lim_{T \to \infty} \frac{1}{T} \log \mathbb{P}(H_{pp}(T, R)) = 0.$$
(6)

For the perturbed lattice model and the triangular cluster model (k = pl or tc), any $R > R_* > 16$ and $T > T_*$, there exist positive constants c_1 and c_2 depending only on T_* and R_* so that

$$\limsup_{T \to \infty} \frac{1}{T} \log(\mathbb{P}(H_k(T, R))) \le -c_1 R^4$$
(7)

and

$$\liminf_{T \to \infty} \frac{1}{T} \log(\mathbb{P}(H_k(T, R))) \ge -c_2 R^4.$$
(8)

We also obtain estimates for the *overcrowding probability*, the event that D_R contains at least N zeros of $f_U(\cdot, t)$ for all $t \in [0, T]$. Denote this event by $C_{fc}(T, R, N)$.

Theorem 3. For fixed R, we have

$$\limsup_{T \to \infty} \frac{1}{T} \log \left(\mathbb{P}(C_{f_{\mathcal{C}}}(T, R, N)) \right) \le -e^{\left(\frac{1}{6} - o(1)\right)N \log N}$$
(9)

and

$$\liminf_{T \to \infty} \frac{1}{T} \log \left(\mathbb{P}(C_{f_{\mathcal{C}}}(T, R, N)) \right) \ge -e^{(\frac{1}{2} + o(1))N \log N}.$$
(10)

For the three toy models, denote by $C_k(T, R, N)$ the event that the time dependent k^{th} model (k equals pp, pl or tc) has at least N points in D_R for all $t \in [0, T]$. We have the following results:

Proposition 4. For the Poisson process

$$\liminf_{T \to \infty} \frac{1}{T} \log \mathbb{P}(C_{pp}(T, R, N)) \ge -\frac{CN}{R^2}.$$
(11)

For the perturbed lattice model and the triangular cluster model (k = pl or tc):

$$\liminf_{T \to \infty} \frac{1}{T} \log \mathbb{P}(C_k(T, R, N)) \ge -C(R)N^2.$$
(12)

This paper is organized as follows. In section 2, we state some well known large and small deviation estimates for Ornstein-Uhlenbeck processes, and prove the large deviation estimates for the toy models. In section 3, we prove that $|f_{\mathcal{C}}(z,t)|$ can be reconstructed from its zero set, and deduce that $Z_{f_{\mathcal{C}}}(t)$ is a time homogenous Markov process. In section 4, we prove Theorem 1, and in section 5 we prove Theorem 3. In section 6, we prove the large deviation estimates for Ornstein-Uhlenbeck processes.

2 Large deviations for toy models

2.1 Estimates for Ornstein-Uhlenbeck processes

We begin by stating some well known large and small deviation estimates for Ornstein-Uhlenbeck processes that will be used throughout the paper. For completeness, full proofs of these estimates are given in section 6. These are the only estimates on the coefficients $\zeta_{k,\ell}$ necessary to derive Propositions 2 and 4. However, further properties of Ornstein-Uhlenbeck properties are used (at least superficially) to derive Theorems 1 and 3.

Lemma 5. Let $W(t) = e^{-t/2}B(e^t)$ where B(t) is a \mathbb{C} -valued Brownian motion started from 0. For all $R < R_*$ and $T > T_*$, there exist constants C_1 and C_2 depending only on R_* and T_* so that

$$e^{-C_1 T/R^2} < \mathbb{P}(|W(t)| < R \ \forall t \in [0,T]) < e^{-C_2 T/R^2}.$$
 (13)

Lemma 6. Let $W(t) = e^{-t/2}B(e^t)$ where B(t) is a \mathbb{C} -valued Brownian motion started from 0. For all $R > R_* \ge 1$ and $T > T_*$, there exist constants C_1 and C_2 depending only on R_* and T_* so that

$$e^{-C_1 T R^2} < \mathbb{P}(|W(t)| > R \ \forall t \in [0,T]) < e^{-C_2 T R^2}.$$
 (14)

Lemma 7. Let $D_{\rho}(x)$ denote the ball of radius ρ centered at x. Then for fixed ρ and all $R > R_*(\rho)$ and $T > T_*(\rho)$ there exist constants c_1 and c_2 so that

$$e^{-c_1 R^2 T} \le \mathbb{P}(W(t) \in D_{\rho}(R) \ \forall t \in [0, T]) \le e^{-c_2 R^2 T}.$$
 (15)

Lemma 8. Let $W(t) = W_x(t) + iW_y(t) = e^{-t/2}B(e^t)$ where B(t) is a \mathbb{C} -valued Brownian motion. For all $R > R_*$ and $T > T_*$ there exists a constant C depending only on R_* and T_* so that

$$\mathbb{P}(W_x(t) < R \ \forall t \in [0,T]) \ge \exp\left[-Te^{-CR^2}\right].$$
(16)

2.2 Proof of Proposition 2

We start with the Poisson process. Let $\rho(\alpha, R, T)$ denote the conditional probability that no points in the Poisson process with intensity α intersect D_R during the time interval [0, T], given that no points lie in D_R at time 0. Brownian scaling and the fact that the union of two independent Poisson processes is another Poisson process gives the following:

$$\rho(1, R, T) = \rho(R^2, 1, T/R^2)
= \rho(1, 1, T/R^2)^{R^2}.$$
(17)

Moreover, $\rho(1,1,T) = \rho(T,1/\sqrt{T},1) = \rho(1,1/\sqrt{T},1)^T$. So it suffices to bound $\rho(1,1/\sqrt{T},1)$.

For a complex valued Brownian motion $B(t) = \frac{1}{\sqrt{2}}(B_1(t) + iB_2(t))$, let us denote by $\zeta(r)$ the hitting time of ∂D_r . Recall that for $r_1 < r_2 < r_3$

$$\mathbb{P}(\zeta(r_3) < \zeta(r_1) | |B(0)| = r_2) = \frac{\log(r_2) - \log(r_1)}{\log(r_3) - \log(r_1)}.$$
(18)

It follows that

$$\mathbb{P}(\zeta(\log T) < \zeta(1/\sqrt{T}) | |B_0| = 1) = \frac{-\log(1/\sqrt{T})}{\log_2 T - \log(1/\sqrt{T})} \ge 1 - \frac{2\log_2(T)}{\log(T)}$$
(19)

where we write \log_2 to denote two iterations of the log function. Now compute

$$\mathbb{P}\left(\max_{0\le t\le 1}|B(t)|\ge a\right)\le 2\mathbb{P}\left(\max_{0\le t\le 1}|B_1|\ge a\right)\le 8\mathbb{P}(B_1(1)\ge a)\le \frac{4\sqrt{2}}{a\sqrt{\pi}}e^{-a^2/2}$$
(20)

where we have used the reflection principle and Lemma 1.3 in [3]. It follows that for large T we have the estimate $\mathbb{P}(\zeta(\log t) < 1 | |B(0)| = 1) \le e^{-\frac{1}{2}(\log T)^2}$. Combining this fact with equation (19) we find

$$\mathbb{P}(\zeta(1/\sqrt{T}) > 1 | |B(0)| = 1) \ge 1 - \frac{3\log_2(T)}{\log T}.$$
(21)

For B(t) starting at radius r < 1 we can compute the probability that B(t) avoids $D_{1/\sqrt{T}}$ for all $t \in [0, 1]$ by considering the probability that the Brownian motion hits D_1 prior to $D_{1/\sqrt{T}}$ and then use (21). This consideration yields

$$\mathbb{P}(\zeta(1/\sqrt{r} > 1) | B(0)| = r < 1) \ge \left(1 - \frac{2\log 1/r}{\log T}\right) \left(1 - \frac{3\log_2 T}{\log T}\right).$$
(22)

Similar reasoning for r > 1 yields the bound

$$\mathbb{P}(\zeta(1/\sqrt{T} > 1) | B(0)| = r > 1) \ge 1 - \left(\frac{4\sqrt{2}}{(r-1)\sqrt{\pi}}e^{-(r-1)^2/2}\right) \left(\frac{3\log_2 T}{\log T}\right).$$
(23)

Now fix N, and let $A_k = D_{(k+1)/N} \cap D_{k/N}^c$ for $1 \le k \le N$, and $\tilde{A}_k = D_{k+1} \cap D_k^c$ for $1 \le k \le \infty$. Write $\#A_k(0)$ to denote the number of points in A_k at time 0, and similarly $\#\tilde{A}_k(0)$ and $(\#D_r)(0)$. We compute, using equations (22) and (23)

$$\begin{split} \rho(1, 1/\sqrt{T}, 1) &\geq \mathbb{P}((\#D_{1/N})(0) = 0) \mathbf{E} \left(\prod_{k=1}^{N} \left[\left(1 - \frac{2\log\frac{N}{k}}{\log T} \right) \left(1 - \frac{3\log_2(T)}{\log T} \right) \right]^{\#A_k} \right) \\ &\mathbf{E} \left(\prod_{k=1}^{\infty} \left[1 - 4(k-1)e^{-(k-1)^2/2} \left(\frac{3\log_2 T}{\log T} \right) \right]^{\#\tilde{A}_k} \right). \end{split}$$

Now, if M is a Poisson random variable with mean μ , then $\mathbf{E}c^M = e^{(c-1)\mu}$. Therefore

$$\begin{split} \rho(1, 1/\sqrt{T}, 1) &\geq e^{-1/N^2} \prod_{k=1}^{N} \left[\exp\left((-\frac{2\log\frac{N}{k}}{\log T} - \frac{3\log_2 T}{\log T})(\frac{1}{N})(\frac{2\pi(k+1)}{N}) \right) \right] \\ &\prod_{k=1}^{\infty} \left[\exp\left((-\frac{12(k-1)e^{-(k-1)^2/2}\log_2 T}{\log T})(2\pi k) \right) \right] \\ &\geq e^{-1/N^2} \exp\left[\sum_{k=1}^{N} \left((-\frac{2\log\frac{N}{k}}{\log T} - \frac{3\log_2 T}{\log T})(\frac{1}{N})(\frac{2\pi(k+1)}{N}) \right) \right] \\ &\exp\left[\sum_{k=1}^{\infty} (-\frac{12(k-1)e^{-(k-1)^2/2}\log_2 T}{\log T})(2\pi k) \right] \\ &\geq e^{-1/N^2} \exp\left[-\frac{C_1\log_2 T}{\log T} \right]. \end{split}$$

Taking $N = \log T$, we have $\rho(1, 1/\sqrt{T}, 1) \ge e^{-\frac{C_2 \log_2 T}{\log T}}$. Combining this result with (17) it follows that as $T \to \infty$

$$\frac{1}{T}\log\rho(1,R,T) \ge \frac{-C_2}{R^2} \frac{\log_2(T/R^2)}{\log(T/R^2)} \to 0,$$
(24)

which proves the claim.

We now consider the perturbed lattice model. To bound $\mathbb{P}(H_{pl}(T, R))$ from above, note that if $H_{pl}(T, R)$ occurs then for each point m + in with $\max |m|, |n| \leq \lfloor R/4 \rfloor + 1$ we have $|\xi_{m,n}(t) - (m, n)| \geq R/2$ for all $t \in [0, T]$. Applying lemma 6, we see that

$$\mathbb{P}(H_2(T,R) \le \left(e^{-CTR^2}\right)^{R^2/4}$$
(25)

and (7) follows. For the lower bound, observe that $H_2(T, R)$ will occur if the following two conditions are satisfied for all lattice points (m, n):

- i. If $\max\{|m|, |n|\} \le 2R$ we have $|\xi_{m,n}(t) (m+in)| \ge 4R$ for all $t \in [0, T]$.
- ii. If max $\{|m|, |n|\} > 2R$ then for all $t \in [0, T]$ the process $(m + in) + \xi_{m,n}(t)$ lies in the half plane H which is a distance R from the origin, is parallel to one of the coordinate axis and maximizes $d((m, n), H^c)$.

From lemma 6 we see that

$$\mathbb{P}(i) \ge \left(e^{-CTR^2}\right)^{4R^2}.$$
(26)

From lemma 8 we estimate:

$$\mathbb{P}(ii) \ge \prod_{k=\lfloor 2R \rfloor+1}^{\infty} \exp\left[-Te^{-C(k-R)^2}\right]^{8k} = e^{-\tilde{C}T}.$$
(27)

Since the events (i) and (ii) are independent we obtain (8) for k = pl.

The proof of the upper bound for the triangular cluster model is completely analogous. The proof of the lower bound is also very similar. Note that $H_{tc}(T, R)$ will occur if the following two conditions are satisfied:

- i'. If $|\sqrt{3}(m,n)| \le 10R$ then $|\xi_{m,n}(t) (m,n)| \ge 20R$ for all $t \in [0,T]$.
- ii'. If $d = |\sqrt{3}(m,n)| > 10R$, then $\sqrt{3}(m,n) + c\xi_{m,n}(t)$ lies in the quarter plane Q such that Q^c is a distance $s = d\sin(15) R$ from $\sqrt{3}(m,n)$ and the vertex of Q lies on the segment connecting $\sqrt{3}(m,n)$ to the origin. See figure 3.

Lemma 8 implies that

$$\mathbb{P}(i') \ge \left(e^{-CTR^2}\right)^{CR^2}.$$
(28)

Moreover, since $W_x(t)$ and $W_y(t)$ are independent and the distribution of W is radially symmetric we can apply lemma 8 to compute:

$$\mathbb{P}(ii') \ge \prod_{k=\lfloor 10R \rfloor}^{\infty} \exp\left[-2Te^{-C_1(k\sin(15)-R)^2}\right]^{C_2k} = e^{-C_3T}.$$
(29)



Figure 3: Construction used for bounding the hole probability for the triangular cluster model. By restricting one of the points in a triad to an appropriate quarter plane, we can ensure that none of the three points enters D_R .

2.3 Proof of Proposition 4

We now prove lower bounds for the over-crowding probabilities of the toy models.

Proof of Proposition 4. We begin with the Poisson process. Observe that:

$$\mathbb{P}(B_t \in D_R \ \forall t \in [\tau, \tau + R^2] \text{ and } B(\tau + R^2) \in D_{R/2} | B(\tau) \in \partial D_{R/2})$$

is a constant independent of R, and gives a lower bound for the conditional probability

$$\mathbb{P}(B_t \in D_R \ \forall t \in [\tau, \tau + R^2] \text{ and } B(\tau + R^2) \in D_{R/2} | B(\tau) \in D_{R/2})$$

It follows that

$$\mathbb{P}(C_1(N, R, T)) \ge c_1 e^{-c_2 N \lfloor T/R^2 \rfloor}$$

from which the result follows. For the perturbed lattice model, the result follows by using lemma 7 to compute the probability that the points corresponding to the N closest lattice points lie in D_R for all $t \in [0, T]$. The computation is analogous for the triangular cluster model, in this case we compute the probability that one point corresponding to each of the Nclosest centers lies in D_R .

3 Reconstructing $|f_{\mathcal{C}}(\cdot, t)|$ from its zero set

This discussion closely parallels the proof given in [4] that the modulus of a hyperbolic Gaussian analytic function (3) can be reconstructed from its zero set. The key lemma is the following

Lemma 9. Fix t. Then with probability one we have

$$\lim_{n \to \infty} e^{(n^6 - \gamma)/2} \prod_{\substack{z \in Z_{f_{\mathcal{C}}}(t) \\ |z| < n^3}} \frac{|z|}{n^3} = |f_{\mathcal{C}}(0, t)|,$$
(30)

where $\gamma = -\int_0^\infty e^{-x} \log x \, dx$ is Euler's constant.

Proof. Assume $f_{\mathcal{C}}(\cdot, t)$ has no zeros on ∂D_r , then by Jensen's formula (see [1], p. 208) we have

$$\log|f_{\mathcal{C}}(0,t)| = \frac{1}{2\pi} \int_{0}^{2\pi} \log|f_{\mathcal{C}}(re^{i\alpha})| \, d\alpha + \sum_{\substack{z \in Z_{f_{\mathcal{C}}}(t) \\ |z| < r}} \log\frac{|z|}{r}.$$
(31)

Write $|f_{\mathcal{C}}(re^{i\alpha},t)|^2 \stackrel{d}{=} \sigma_r^2 Y$ where $Y \sim \exp(1)$ and $\sigma_r^2 = \operatorname{Var} f_{\mathcal{C}}(re^{i\alpha},t) = e^{r^2}$. Then

$$\mathbf{E}\log|f(re^{i\alpha},t)| = \frac{1}{2}(\log(\sigma_r^2) + \mathbf{E}\log(Y)) = \frac{1}{2}(r^2 - \gamma).$$

Define $g_{r,t}(\alpha) = \log |f_{\mathcal{C}}(re^{i\alpha}, t)| + \frac{1}{2}(\gamma - r^2)$, so that the distribution of $g_{r,t}(\alpha)$ is independent of r, t and α , and $\mathbf{E}g_{r,t}(\alpha) = 0$. Set

$$L_{r,t} = \frac{1}{2\pi} \int_0^{2\pi} g_{r,t}(\alpha) \, d\alpha,$$
(32)

we prove that with probability one $L_{n^3,t} \to 0$ as $n \to \infty$. The proof is a straightforward application of Chebyshev's inequality and the Borel-Cantelli lemma. Compute:

$$\operatorname{Var} L_{r,t} = \mathbf{E} \left(\frac{1}{(2\pi)^2} \int_0^{2\pi} \int_0^{2\pi} g_{r,t}(\alpha) g_{r,t}(\beta) \, d\alpha d\beta \right)$$
$$= \frac{1}{2\pi} \int_0^{2\pi} \mathbf{E} (g_{r,t}(\alpha) g_{r,t}(0)) \, d\alpha$$

where we have used rotational invariance and absolute integrability to obtain the last expression. By lemma 17 in [4] we have the estimate

$$\mathbf{E}(g_{r,t}(\alpha)g_{r,t}(0)) \le c \frac{|\mathbf{E}f_{\mathcal{C}}(re^{i\alpha},t)\overline{f_{\mathcal{C}}(r,t)}|}{\operatorname{Var}(f_{\mathcal{C}}(r,t))} = ce^{r^{2}(\cos\alpha-1)}.$$

It follows that

$$\operatorname{Var} L_{r} \leq \frac{1}{\pi} \int_{0}^{\pi} c e^{r^{2}(\cos \alpha - 1)} d\alpha$$

$$\leq c \left[\cos^{-1}(1 - 1/r) + e^{-r} \right].$$

For small x we have the estimate $\cos(x) \le 1 - \frac{x^2}{2} + \frac{x^4}{24} \le 1 - \frac{11}{24}x^2$. It follows that for y close to 1, $\cos^{-1}(y) \le \sqrt{\frac{24}{11}(1-y)}$. Thus for large r we obtain the bound

$$\operatorname{Var}L_r \le c \left[\sqrt{\frac{24}{11r}} + e^{-r} \right].$$
(33)

Applying Chebyshev's inequality to (33), it follows from the Borel Cantelli lemma that $L_{n^3} \to 0$ a.s. Thus by equation (31):

$$\sum_{\substack{z \in Z_{f_{\mathcal{C}}}(t) \\ |z| < n^3}} \log \frac{|z|}{n^3} + \frac{n^6 - \gamma}{2} \to \log |f_{\mathcal{C}}(0)| \text{ a.s.}$$
(34)

Exponentiating (34), we obtain (30).

To see that $|f_{\mathcal{C}}(\cdot, t)|$ may be reconstructed from its zero set, note that if $T(z) = z + \xi$, then by computing covariances we see that

$$\tilde{f}_{\mathcal{C}}(\cdot,t) \stackrel{def}{=} e^{-\overline{\xi}z - \frac{1}{2}\xi\overline{\xi}} f_{\mathcal{C}}(T(\cdot),t) \stackrel{d}{=} f_{\mathcal{C}}(\cdot,t).$$

So, applying lemma 9 to \tilde{f} , we can recover $|f_{\mathcal{C}}(\xi, t)|$ with probability one. Iterating this procedure, we can recover $|f_{\mathcal{C}}(\cdot, t)|$ from $Z_{\mathbf{f}_{\mathcal{C}}}(t)$ on a dense countable subset, and hence recover $|F_{\mathcal{C}}(\cdot, t)|$ everywhere by continuity.

4 Hole probability for $f_{\mathcal{C}}$

In this section, we compute the probability of the event $H_{fc}(T, R)$ that D_R contains no zeros of $f_{\mathcal{C}}(\cdot, t)$ for all $t \in [0, T]$.

4.1 Proof of lower bound in Theorem 1

We claim that a hole of radius R will exist for all $t \in [0, T]$ if the following three conditions are satisfied for all such t:

i. $|a_0(t)| \ge 1 + e^{(R^2 + \log 48R^2)/4}$

ii.
$$|a_k(t)| \le e^{-(R^2 + \log 48R^2)/4}$$
 for $1 \le k \le 48R^2$

iii.
$$|a_k(t)| \le 2^k$$
 for $k > 48R^2$.

A similar computation is given in [7]. Write $f_{\mathcal{C}}(z,t) = a_0(t) + \psi(z,t)$ and compute

$$\sum_{k=1}^{48R^2} \frac{R^k |a_k|}{\sqrt{k!}} \le \sqrt{48R^2} \sqrt{\sum_{k=1}^{48R^2} \frac{R^{2k} |a_k|^2}{k!}} \le \sqrt{48R^2} \max_{1 \le k \le 48R^2} |a_k| e^{R^2/2} \le e^{(R^2 + \log 48R^2)/4}.$$
 (35)

Since we also have

$$\sum_{k>48R^2} \frac{R^k}{\sqrt{k!}} 2^k \le \sum_{k>48R^2} \frac{2^k}{\sqrt{k!}} \left(\frac{k}{48}\right)^{k/2} < \sum_{k>48R^2} \left(\frac{k}{12} \cdot \frac{e}{k}\right)^{k/2} < \sum_{k\ge 1} 2^{-k} = \frac{1}{2}$$
(36)

(we used the inequality $k! < \left(\frac{k}{e}\right)^k$ which follows from Sterling's formula), it follows that if (i), (*ii*) and (*iii*) hold then $\sup_{z \in D_R} |\psi(z, t)| \le 1/2 + e^{(R^2 + \log 48R^2)/2}$ and hence $f_{\mathcal{C}}(z, t)$ contains no zeros in D_R for $t \in [0, T]$. Using lemmas 5 and 6 we have:

$$\mathbb{P}(i) \geq \exp\left[-Te^{(\frac{1}{2}+o(1))R^{2}}\right] \\
\mathbb{P}(ii) \geq \exp\left[-Te^{(\frac{1}{2}+o(1))R^{2}}\right]^{48R^{2}} = \exp\left[-Te^{(\frac{1}{2}+o(1))R^{2}}\right] \\
\mathbb{P}(iii) \geq \prod_{k>48R^{2}} e^{c_{1}T/4^{k}} = e^{-c_{2}T}.$$
(37)

Events (i), (ii) and (iii) are independent, therefore

$$\mathbb{P}\left(H_{f_{\mathcal{C}}}(T,R)\right) \ge \mathbb{P}(i)\mathbb{P}(ii)\mathbb{P}(iii) \ge \exp\left[-Te^{\left(\frac{1}{2}+o(1)\right)R^{2}}\right]$$
(38)

as desired.

4.2 Proof of upper bound in Theorem 1

If a hole of radius R exists at time t, Jensen's formula gives

$$\log|a_0(t)| = \int_{\partial D_R} \log|f_{\mathcal{C}}(z,t)|d\mu(z), \tag{39}$$

where μ is the uniform probability measure on ∂D_R . So for fixed c < 1/2 and $\tilde{c} > 1/2$ one of the following three events must occur:

- A) $\int_{\partial D_R} \log |f_{\mathcal{C}}(z,t)| d\mu(z) < cR^2$ and $\max_{z \in D_R} |f_{\mathcal{C}}(z,t)| < e^{\tilde{c}R^2}$ $B^1) |a_0(t)| \ge e^{cR^2}$
- B^2) max_{$z \in D_R$} $|f_{\mathcal{C}}(z,t)| \ge e^{\tilde{c}R^2}$.

Write A(t) to denote the event that A occurs at time t, and $B_{\ell}^{1}(t)$ to denote the event that $|a_{0}(t)| \geq e^{(c+\ell)R^{2}}$ and $B_{\ell}^{2}(t)$ to denote the event that $\max_{z \in D_{R}} |f_{\mathcal{C}}(z,t)| \geq e^{(\tilde{c}+\ell)R^{2}}$. Let $B_{\ell}(t)$ denote the event that either $B_{\ell}^{1}(t)$ or $B_{\ell}^{2}(t)$ occurs. Also, define $b(t) = \max\{\ell : B_{\ell}(t) \text{ is true}\}$ and $\mathcal{F}_{t} = \sigma\{a_{k}(s) \forall k \geq 0 \text{ and } 0 \leq s \leq t\}$. The method of proof is similar to the proof of the upper bound given for lemma 6. We observe the function $f_{\mathcal{C}}(\cdot, t)$ at a sequence of times $0 = t_{0} < t_{1} < \cdots < t_{N}$ and bound the probability that either condition A or condition B is satisfied at all $t_{k} \leq T$. Specifically, define $t_{k+1} = t_{k} + \Delta t_{k}$, where Δt_{k} is defined as follows:

1. if $A(t_k)$ is true and $B_0(t_k)$ fails, $\Delta t_k = \Delta t_A(\epsilon) \stackrel{def}{=} e^{-(1-2c-\epsilon)R^2}$

2. if
$$b(t_k) = \ell \ge 0$$
, then $\Delta t_k = \Delta t_B(\ell) \stackrel{def}{=} \begin{cases} 6R^2 & 0 \le \ell \le 2\\ 2(\ell+1)R^2 & \ell > 2 \end{cases}$

If both $A(t_k)$ and $B_0(t_k)$ fail then we set N = k, i.e. the observation process is halted. The proof relies on the following

Claim 10. For any c > 1/3 and $0 < \epsilon < 1$ satisfying $\Delta t_A(\epsilon) < 1$ we may choose \tilde{c} and R_* sufficiently large so that there exist p_A and p_B such that:

$$\mathbb{P}(A(t_{k+1}) \mid \mathcal{F}_{t_k}) < p_A \tag{40}$$

$$\mathbb{P}(B_{\ell}(t_{k+1}) \mid \mathcal{F}_{t_k}) < p_B^{\overline{\Delta t_A(\epsilon)} + 1}.$$
(41)

and $p_A + p_B + p_B(1 - p_B) < 1/2$ for all $R \ge R_*$.

The proof of this claim is somewhat technical, so we shall first check that it implies the upper bound stated in Theorem 1.

Let p_A and p_B be chosen as in Claim 10, and consider the process $\tilde{t}_n = \sum_{k=0}^{n-1} \Delta \tilde{t}_k$, where $\Delta \tilde{t}_k$ are i.i.d. and have distribution:

$$\mathbb{P}(\Delta \tilde{t}_k = 0) = 1 - p_A - p_B$$
$$\mathbb{P}(\Delta \tilde{t}_k = \Delta t_A(\epsilon)) = p_A + p_B(1 - p_B)$$
$$\mathbb{P}(\Delta \tilde{t}_k = n\Delta t_A(\epsilon)) = p_B^n(1 - p_B) \quad \text{(for } n > 1\text{)}.$$

Set $\tilde{N} = \min \{k : \Delta t_k = 0\}$. Equations (40) and (41) imply that $\Delta \tilde{t}_k$ stochastically dominates Δt_k , so $\mathbb{P}(\tilde{t}_{\tilde{N}} \ge T) \ge \mathbb{P}(t_N \ge T)$. Using the following lemma

Lemma 11. $\mathbb{P}(\tilde{t}_{\tilde{N}} \ge (k+1)\Delta t_A(\epsilon) \mid \tilde{t}_{\tilde{N}} \ge k\Delta t_A(\epsilon)) \le p_A + p_B + p_B(1-p_B).$

it follows that

$$\mathbb{P}(t_N \ge T) \le \mathbb{P}(\tilde{t}_{\tilde{N}} \ge \lfloor \frac{T}{\Delta t_A(\epsilon)} \rfloor \Delta t_A(\epsilon)) \\
\le (p_A + p_B + p_B(1 - p_B))^{\lfloor \frac{T}{\Delta t_A(\epsilon)} \rfloor} \\
\le \exp\left[-Te^{(1 - 2c - \epsilon + o(1))R^2}\right],$$

so the upper bound in Theorem 1 follows by letting $c \downarrow 1/3$ and ϵ decrease to zero.

To prove lemma 11, we compute

$$\begin{split} \mathbb{P}(\tilde{t}_{\tilde{N}} \ge (k+1)\Delta t_A(\epsilon) \mid \tilde{t}_{\tilde{N}} \ge k\Delta t_A(\epsilon)) &\leq \max_{s \ge 1} \mathbb{P}(\Delta \tilde{t}_n = s\Delta t_A(\epsilon) \text{ and } \Delta \tilde{t}_{n+1} > 0 \mid \Delta \tilde{t}_n \ge s\Delta t_A(\epsilon)) \\ &+ \max_{s \ge 1} \mathbb{P}(\Delta \tilde{t}_n \ge (s+1)\Delta t_A(\epsilon) \mid \Delta \tilde{t}_n \ge s\Delta t_A(\epsilon)) \\ &\leq \frac{p_A + p_B - p_B^2}{p_A + p_B} (p_A + p_B) + p_B \\ &= p_A + p_B + p_B (1 - p_B). \end{split}$$

4.3 Proof of Claim 10

The following lemmas allow us to bound the conditional probabilities $\mathbb{P}(A(t_{k+1})|\mathcal{F}_{t_k})$ and $\mathbb{P}(B_{\ell}(t_{k+1})|\mathcal{F}_{t_k})$.

Lemma 12. For $0 < \delta < 1/6$, and $\tilde{z} \in \mathbb{C}$ with $R/2 \leq |\tilde{z}| \leq R$ and $R \geq 1$ we have:

$$\mathbb{P}\left(\max_{z\in\tilde{z}+\delta D_R}|f_{\mathcal{C}}(z,t+\Delta t)| \le \sqrt{1-e^{-\Delta t}}e^{(1/2-3\delta)|\tilde{z}|^2}|\mathcal{F}_t\right) \le e^{-C_2(\delta)R^4}.$$
(42)

Proof. Define $\|\psi\| = \sup_{z \in \tilde{z} + \delta D_R} |\psi(z)|$. Observe that for fixed t and Δt we may write

$$f_{\mathcal{C}}(\cdot, t + \Delta t) = e^{-\Delta t/2} f_{\mathcal{C}}(\cdot, t) + \sqrt{1 - e^{-\Delta t}} q(\cdot)$$
(43)

where $q(z) = \sum_{k=0}^{\infty} \frac{\alpha_k z^k}{\sqrt{k!}}$ and α_k are i.i.d. $\mathbb{C}N(0,1)$ random variables independent of \mathcal{F}_t . Now,

$$\|e^{-\Delta t/2}f_{\mathcal{C}}(\cdot,t) + \sqrt{1 - e^{-\Delta t}}q(\cdot)\| + \|e^{-\Delta t/2}f_{\mathcal{C}}(\cdot,t) - \sqrt{1 - e^{-\Delta t}}q(\cdot)\| \ge 2\sqrt{1 - e^{-\Delta t}}\|q(\cdot)\|, \quad (44)$$

 \mathbf{SO}

$$\mathbb{P}(\|e^{-\Delta t/2} f_{\mathcal{C}}(\cdot, t) + \sqrt{1 - e^{-\Delta t}} q(\cdot)\| \le k |\mathcal{F}_t)^2 \le \mathbb{P}(2\sqrt{1 - e^{-\Delta t}} \|q(\cdot)\| < 2k) \\
= \mathbb{P}(\sqrt{1 - e^{-\Delta t}} \|q(\cdot)\| < k).$$
(45)

Quoting [7, Claim 1], this probability is bounded above by $e^{-2C_2(\delta)R^4}$ provided that $\frac{k}{\sqrt{1-e^{-\Delta t}}} \leq e^{(1/2-3\delta)|\tilde{z}|^2}$. Choosing the maximum allowable value for k, we obtain

$$\mathbb{P}\left(\max_{z\in\tilde{z}+\delta D_{R}}\left|f_{\mathcal{C}}(z,t+\Delta t)\right| \leq \sqrt{1-e^{-\Delta t}}e^{(1/2-3\delta)|\tilde{z}|^{2}} \mid \mathcal{F}_{t}\right) \leq e^{-C_{2}(\delta)R^{4}}.$$
(46)

Lemma 13. If $\Delta t \geq e^{-(1-2c-\epsilon)R^2}$ with $\epsilon > 0$ then

$$\mathbb{P}(A(t+\Delta t)|\mathcal{F}_t) \le e^{-\tilde{C}(\epsilon)R^4}.$$
(47)

Proof. The proof uses several estimates from [7], and we use similar notation. Take $N = \lfloor 2\pi\delta^{-1} \rfloor$ and $z_j = \kappa Re^{2\pi i j/N}$ where $\kappa = 1 - \delta^{1/4}$ and $0 < \delta < 1$. By lemma 12 we see that if $R > R_*(\delta)$ then with probability at least $1 - e^{-C_3(\delta)R^4}$ we can choose N points ξ_1, \ldots, ξ_N with $\xi_j \in z_j + \delta D_R$ such that

$$|f_{\mathcal{C}}(\xi_j, t + \Delta t)| \ge \sqrt{1 - e^{-\Delta t}} e^{(1/2 - 3\delta)|z_j|^2}$$
(48)

Let $P(z,\xi)$ be the Poisson kernel for the disk D_R with |z| = R and $|\xi| < R$. Define $P_j(z) = P(z,\xi_j)$. Then if μ is the uniform probability measure on ∂D_R we have

$$(1/2 - C_5 \delta^{1/4}) R^2 + \log \sqrt{1 - e^{-\Delta t}} \leq \frac{1}{N} \sum_{j=1}^N \log |f_{\mathcal{C}}(\xi_j, t + \Delta t)|$$

$$\leq \int_{\partial D_R} \left(\frac{1}{N} \sum_{j=1}^N P_j(z) \right) \log |f_{\mathcal{C}}(z, t + \Delta t)| d\mu(z)$$

$$= \int_{\partial D_R} \left(\frac{1}{N} \sum_{j=1}^N P_j(z) - 1 \right) \log |f_{\mathcal{C}}(z, t + \Delta t)| d\mu(z)$$

$$+ \int_{\partial D_R} \log |f_{\mathcal{C}}(z, t + \Delta t)| d\mu(z)$$
(49)

For the remainder of the proof we condition on the event that $\max_{z \in D_R} |f_{\mathcal{C}}(z, t + \Delta t)| \leq e^{\tilde{c}R^2}$, since otherwise $A(t + \Delta t)$ must fail. So,

$$\int_{\partial D_R} \log_+ |f_{\mathcal{C}}(z, t + \Delta t)| d\mu(z) \le \tilde{c}R^2.$$
(50)

Also, by applying lemma 12 with R replaced by R/2 and $|\tilde{z}| = R/4$, we know that except on an exceptional set of measure less than $e^{-C_6(\delta)R^4}$ we have $\tilde{\xi} \in \partial D_{R/2}$ so that $|f_{\mathcal{C}}(\tilde{\xi}, t + \Delta t)| \geq \sqrt{1 - e^{-\Delta t}} \exp[(1/2 - 3\delta)R^2/16]$. Then

$$\int_{\partial D_R} \log |f_{\mathcal{C}}(z,t+\Delta t)| P(z,\tilde{\xi}) d\mu(z) \ge \log \sqrt{1-e^{-\Delta t}} + (1/2-3\delta)R^2/16.$$
(51)

An easy computation shows that $1/3 \le P(z,\xi) \le 3$ for |z| = R and $|\xi| = R/2$, hence

$$3\int_{\partial D_R} \log_+ |f_{\mathcal{C}}(z,t+\Delta t)| d\mu(z) - \frac{1}{3}\int_{\partial D_R} \log_- |f_{\mathcal{C}}(z,t+\Delta t)| d\mu(z)$$
$$\geq \int_{\partial D_R} \log |f_{\mathcal{C}}(z,t+\Delta t)| P(z,\tilde{\xi}) d\mu(z)$$
$$\geq \log \sqrt{1 - e^{-\Delta t}} + (1/2 - 3\delta) R^2 / 16 \tag{52}$$

Combining (50) and (52) we obtain

$$\int_{\partial D_R} \log_{-} |f_{\mathcal{C}}(z,t+\Delta t)| d\mu(z) \leq 9 \int_{\partial D_R} \log_{+} |f_{\mathcal{C}}(z,t+\Delta t)| d\mu(z)
-3 \log \sqrt{1-e^{-\Delta t}} - 3(1/2-3\delta)R^2/16
\leq 9\tilde{c}R^2 - 3\log \sqrt{1-e^{-\Delta t}}
\int_{\partial D_R} |\log |f_{\mathcal{C}}(z,t+\Delta t)| |d\mu(z) \leq 10\tilde{c}R^2 - 3\log \sqrt{1-e^{-\Delta t}}$$
(53)

Now from [7, claim 2] we know that

$$\max_{z \in \partial D_R} \left| \frac{1}{N} \sum_{j=1}^N P_j(z) - 1 \right| < C_3 \delta^{1/2}$$
(54)

Combining (49), (53) and (54) gives that, except on an exceptional set of probability bounded by $e^{-C_2(\delta)R^4}$:

$$\begin{split} \int_{\partial D_R} \log |f_{\mathcal{C}}(z,t+\Delta t)| \, d\mu(z) &\geq (1/2 - C_5 \delta^{1/4}) R^2 + \log \sqrt{1 - e^{-\Delta t}} \\ &- C_3 \delta^{1/2} \left[10 \tilde{c} R^2 - 3 \log \sqrt{1 - e^{-\Delta t}} \right] \\ &\geq (1/2 - C_6 \delta^{1/4}) R^2 + (1 + C_7 \delta^{1/2}) \log \sqrt{1 - e^{-\Delta t}}. \quad (*) \end{split}$$

All we must show is that (*) exceeds cR^2 for sufficiently small $\delta > 0$ which may be chosen uniformly in R. Observe that (*) is increasing in Δt , so it suffices to restrict to $\Delta t = e^{-(1-2c-\epsilon)R^2} < 1/2$. Using the inequalities $1-e^{-x} > x-x^2$ and $\log(1-x) > -C_8x$ for $0 \le x \le 1/2$, we compute:

$$(*) \geq (1/2 - C_6 \delta^{1/4}) R^2 + \frac{1}{2} (1 + C_7 \delta^{1/2}) (\log \Delta t + \log(1 - \Delta t))$$

$$\geq (1/2 - C_6 \delta^{1/4}) R^2 + \frac{1}{2} (1 + C_7 \delta^{1/2}) (\log \Delta t - C_8 \Delta t)$$

$$\geq (c + \frac{\epsilon}{2}) R^2 + \delta^{1/4} R^2 \left[-C_6 + \frac{1}{2} C_7 (2c + \epsilon - 1) \right] - \frac{C_8}{2} (1 + C_7 \delta^{1/2}) e^{-(1 - 2c - \epsilon)R^2}.$$
(55)

It is clear that for fixed $\epsilon \in (0, 1 - 2c)$ and $R > R_*(\epsilon)$ we may choose $\delta > 0$ small enough (uniformly in R) so that (55) exceeds cR^2 .

Lemma 14. Fix $0 < \epsilon < 1$ small enough so that $\Delta t_A(\epsilon) < 1$. Then for R > 1

$$\mathbb{P}(B^1_{\ell}(t_{k+1})|B_0(t_k) \ fails) \le \exp\left[-e^{(6c+2\epsilon-2+o(1))R^2}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\epsilon)}+1}.$$
(56)

Proof. Assuming $B_0(t_k)$ fails, write:

$$|a_0(t_{k+1})| \le e^{-\Delta t/2} |a_0(t_k)| + \sqrt{1 - e^{-\Delta t}} |X|$$
(57)

where $X \sim \mathbb{C}N(0,1)$ is independent of \mathcal{F}_{t_k} and $\Delta t = \Delta t_A(\epsilon) < 1$. Using the inequalities $1 - x \leq e^{-x} \leq 1 - x + x^2/2$ it follows that if $B^1(t_{k+1})$ is satisfied, then

$$\left(1 - \frac{\Delta t}{2} + \frac{(\Delta t)^2}{8}\right)e^{cR^2} + \sqrt{\Delta t}|X| \ge e^{(c+\ell)R^2}$$
(58)

and therefore, since $(\Delta t)^2 < \Delta t$:

$$|X| \geq \frac{1}{\sqrt{\Delta t}} \left(e^{\ell R^2} - 1 \right) e^{cR^2} + \frac{3\sqrt{\Delta t}}{8} e^{cR^2}$$

$$\geq \left(e^{\ell R^2} - 1 \right) e^{(1/2 - \epsilon/2)R^2} + \frac{3}{8} e^{(2c + \epsilon/2 - 1/2)R^2} \stackrel{def}{=} Q_1(\ell).$$
(59)

Now, $\mathbb{P}(|X| \ge Q_1(\ell)) = e^{-Q_1(\ell)^2}$, so

$$\mathbb{P}(B^{1}_{\ell}(t_{k+1})|B_{0}(t_{k}) \text{ fails}) \leq \left[\exp\left(\frac{-Q_{1}(\ell)^{2}\Delta t_{A}(\epsilon)}{\Delta t_{B}(\ell) + \Delta t_{A}(\epsilon)}\right)\right]^{\frac{\Delta t_{B}(\ell)}{\Delta t_{A}(\epsilon)} + 1}$$
(60)

The quantity $\exp\left(\frac{-Q_1(\ell)^2 \Delta t_A(\epsilon)}{\Delta t_B(\ell) + \Delta t_A(\epsilon)}\right)$ is decreasing for $\ell \ge 0$, it follows that

$$\mathbb{P}(B^{1}_{\ell}(t_{k+1})|B_{0}(t_{k}) \text{ fails}) \leq \left[\exp\left(-e^{(6c+2\epsilon-2)R^{2}-\log(64R^{2})}\right)\right]^{\frac{\Delta t_{B}(\ell)}{\Delta t_{A}(\epsilon)}+1} \\ = \left[\exp\left(-e^{(6c+2\epsilon-2+o(1))R^{2}}\right)\right]^{\frac{\Delta t_{B}(\ell)}{\Delta t_{A}(\epsilon)}+1}$$
(61)

as desired.

Lemma 15. Fix $0 < \epsilon < 1$ so that $\Delta t_A(\epsilon) < 1$. Then for R > 1 we have

$$\mathbb{P}(B^1_{\ell}(t_{k+1}) \mid B_0(t_k)) \le \exp\left[-e^{(4c+\epsilon-1+o(1))R^2}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\epsilon)}+1}.$$

Proof. As before, write

$$|a_0(t_{k+1})| \le |a_0(t_k)| e^{-\Delta t_k/2} + \sqrt{1 - e^{-\Delta t_k}} |X|$$
(62)

where $X \sim \mathbb{C}N(0,1)$ is independent of \mathcal{F}_{t_k} . Assuming $B_\ell(t_{k+1})$ occurs, we deduce:

$$e^{(c+\ell)R^2} \le e^{(c-1)R^2} + |X| \tag{63}$$

so $|X| \ge e^{(c+\ell)R^2} - e^{(c-1)R^2} \ge e^{(c+\ell)R^2 - 1}$. Now,

$$\mathbb{P}\left(|X| \ge e^{(c+\ell)R^2 - 1}\right)^{\frac{\Delta t_A(\epsilon)}{\Delta t_B(\ell) + \Delta t_A(\epsilon)}} \le \mathbb{P}\left(|X| \ge e^{(c+\ell)R^2 - 1}\right)^{\frac{\Delta t_A(\epsilon)}{2\Delta t_B(\ell)}} = \exp\left[-e^{(4c+2\ell+\epsilon-1)R^2 - 2 - \log(2\Delta t_B(\ell))}\right]$$

is decreasing in ℓ for all $\ell \ge 0$, so we obtain:

$$\mathbb{P}(B^1_{\ell}(t_{k+1}) \mid B_0(t_k)) \le \exp\left[-e^{(4c+\epsilon-1+o(1))R^2}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\epsilon)}+1}.$$
(64)

Lemma 16. Fix $0 < \epsilon < 1$ so that $\Delta t_A(\epsilon) < 1$, then if $\tilde{c} > 2$ there exists a constant $R_* > 0$ so that for all $R > R_*$:

$$\mathbb{P}(B_{\ell}^2(t_{k+1}) \mid B_0(t_k) \text{ fails}) \le \exp\left[-e^{(\tilde{c}+3c+3\epsilon/2-2+o(1))R^2}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\epsilon)}+1}$$
(65)

Proof. Write $f_{\mathcal{C}}(\cdot, t_{k+1}) = e^{-\Delta t_k/2} f_{\mathcal{C}}(\cdot, t_k) + \sqrt{1 - e^{-\Delta t_k}} q(\cdot)$ where $q(z) = \sum_{n=0}^{\infty} \frac{\alpha_k z^k}{\sqrt{k!}}$ with $\alpha_k \sim \mathbb{C}N(0, 1)$ i.i.d. and independent of \mathcal{F}_{t_k} . Also, define $\|\psi\| = \max_{z \in D_R} |\psi(z)|$ and observe that:

$$\|f_{\mathcal{C}}(\cdot, t_{k+1})\| \le e^{-\Delta t_k/2} \|f_U(\cdot, t_k)\| + \sqrt{1 - e^{-\Delta t_k}} \|q(\cdot)\|.$$
(66)

If $B_{\ell}^2(t_{k+1})$ is satisfied and $B_0(t_k)$ fails then $\Delta t_k = \Delta t_A(\epsilon) < 1$, and we have (using the inequalities $e^{-\Delta t_k/2} < 1 - \frac{3\Delta t_k}{8}$ and $1 - e^{-\Delta t_k} < \Delta t_k$):

$$e^{(\tilde{c}+\ell)R^{2}} \leq e^{-\Delta t_{k}/2}e^{\tilde{c}R^{2}} + \sqrt{1-e^{-\Delta t_{k}}}\|q(\cdot)\|$$

$$\leq \left(1-\frac{3\Delta t_{k}}{8}\right)e^{\tilde{c}R^{2}} + \sqrt{\Delta t_{k}}\|q(\cdot)\|$$

$$\|q(\cdot)\| \geq \frac{1}{\sqrt{\Delta t}}\left(e^{\ell R^{2}}-1\right)e^{\tilde{c}R^{2}} + \frac{3\sqrt{\Delta t_{k}}}{8}e^{\tilde{c}R^{2}}$$
(67)

$$\begin{aligned} q(\cdot) \| &\geq \frac{1}{\sqrt{\Delta t_k}} \left(e^{cR} - 1 \right) e^{cR} + \frac{1}{8} e^{cR} \end{aligned} \tag{67} \\ &\geq \left(e^{\ell R^2} - 1 \right) e^{(\tilde{c} + 1/2 - c - \epsilon/2)R^2} + \frac{3}{8} e^{(\tilde{c} + c + \epsilon/2 - 1/2)R^2} \stackrel{def}{=} Q_2(\ell). \end{aligned} \tag{68}$$

From [7, p. 4] we have the estimate:

$$\mathbb{P}(\|q(\cdot)\| > e^{(1/2 + \alpha)R^2}) < \exp\left(-e^{\alpha R^2}\right)$$
(69)

provided that $R \ge R_0(\alpha)$, where $R_0(\alpha)$ is decreasing in α . Since we resticted to $\tilde{c} \ge 2$ we can fix $R_* > 1$ so that (69) may be used to estimate the probability of (68) for all $R \ge R_*$. For such constants, we have:

$$\mathbb{P}\left(\|q(\cdot)\| \ge Q_{2}(\ell)\right)^{\frac{\Delta t_{A}(\epsilon)}{\Delta t_{B}(\ell) + \Delta t_{A}(\epsilon)}} \le \exp\left[-e^{\log Q_{2}(\ell) - R^{2}/2}\right]^{\frac{\Delta t_{A}(\epsilon)}{2\Delta t_{B}(\ell)}} \\
= \exp\left[-\frac{3}{8}e^{(\tilde{c} + c + \epsilon/2 - 1)R^{2}} + (e^{\ell R^{2}} - 1)e^{(\tilde{c} - c - \epsilon/2)R^{2}}\right]^{\frac{\Delta t_{A}(\epsilon)}{2\Delta t_{B}(\ell)}} \\
= \exp\left[\frac{-\frac{3}{8}e^{(\tilde{c} + 3c + 3\epsilon/2 - 2)R^{2}} + (e^{\ell R^{2}} - 1)e^{(\tilde{c} + c + \epsilon/2 - 1)R^{2}}}{2\Delta t_{B}(\ell)}\right]. (70)$$

It is clear that if R is sufficiently large, (70) is decreasing in ℓ for $\ell \ge 0$, so evaluating (70) at $\ell = 0$ we obtain

$$\mathbb{P}(\|q(\cdot)\| \ge Q_2(\ell)) \le \exp\left[-e^{(\tilde{c}+3c+3\epsilon/2-2+o(1))R^2}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\epsilon)}+1}.$$
(71)

Lemma 17. For $\tilde{c} \geq 2$ and $0 < \epsilon < 1$ such that $\Delta t_A(\epsilon) < 1$ then there exists a constant R_* so that for all $R > R_*$:

$$\mathbb{P}(B_{\ell}^{2}(t_{k+1}) \mid B_{0}(t_{k})) \leq \left(\exp\left[-e^{(\tilde{c}+2c+\epsilon-3/2+o(1))R^{2}}\right]\right)^{\frac{\Delta t_{B}(\ell)}{\Delta t_{A}(\epsilon)}+1}.$$
(72)

Proof. Equation (66) holds as before, but now we assume that $B_0(t_k)$ is satisfied so $\Delta t_k = \Delta t_B(b(t_k))$. If $B_\ell^2(t_{k+1})$ holds, then

$$e^{(\tilde{c}+\ell)R^2} \le e^{(\tilde{c}-1)R^2} + \|q(\cdot)\|.$$
(73)

By requiring $R_* > 1$ we deduce $||q(\cdot)|| \ge \frac{1}{2}e^{(\tilde{c}+\ell)R^2}$. Since we have fixed $\tilde{c} \ge 2$ we can fix a constant R_* so that for all $R > R_*$ equation (69) may be used to write

$$\mathbb{P}\left(\|q(\cdot)\| \ge \frac{1}{2}e^{(\tilde{c}+\ell)R^2}\right)^{\frac{\Delta t_A(\epsilon)}{\Delta t_B(\ell)+\Delta t_A(\epsilon)}} \le \left(\exp\left[-\frac{1}{2}e^{(\tilde{c}+\ell-1/2)R^2}\right]\right)^{\frac{\Delta t_A(\epsilon)}{2\Delta t_B(\ell)}} \\
= \exp\left[-\frac{1}{4\Delta t_B(\ell)}e^{(\tilde{c}+\ell+2c+\epsilon-3/2)R^2}\right].$$
(74)

It is easy to check that (74) is decreasing in ℓ for all $\ell \ge 0$, so

$$\mathbb{P}(B_{\ell}^2(t_{k+1}) \mid B_0(t_k)) \le \left(\exp\left[-e^{(\tilde{c}+2c+\epsilon-3/2+o(1))R^2} \right] \right)^{\frac{\Delta t_B(\ell)}{\Delta t_A(\epsilon)}+1}.$$
(75)

Claim 10 now follows from lemmas 13 - 17.

5 Over-crowding probability for f_U

In this section we compute the probability of the event $C_{f_{\mathcal{C}}}(T, R, N)$ that D_R contains at least N zeros of $f_U(\cdot, t)$ for all $t \in [0, T]$.

5.1 Proof of lower bound in Theorem 3

We claim that for sufficiently large N, the disk D_R will contain at least N zeros for all $t \in [0, T]$ if the following three conditions are satisfied for all such t:

(i)
$$|a_k| < \frac{R^N}{(e^{R^2}N \cdot N!)^{1/4}}$$
 for all $k < N$

(ii)
$$|a_N| \ge 2(e^{R^2}N \cdot N!)^{1/4}$$

(iii) $|a_k| < 2^{k-N}$ for all k > N.

To see that this is the case, observe that condition (i) implies that for $t \in [0, T]$:

$$\sum_{k=0}^{N-1} \frac{|a_k(t)|R^k}{\sqrt{k!}} < \left(\sum_{k=0}^{N-1} |a_k|^2\right)^{1/2} \left(\sum_{k=0}^{N-1} \frac{R^{2k}}{k!}\right)^{1/2} < \frac{R^N e^{R^2/2} N^{1/4}}{N!^{1/4}}.$$
(76)

While (*iii*) implies that for large N and $t \in [0, T]$:

$$\sum_{k>N} \frac{|a_k(t)|R^k}{\sqrt{k!}} \leq \frac{2R^{N+1}}{\sqrt{(N+1)!}} \sum_{k=0}^{\infty} \left(\frac{2R}{\sqrt{(N+1)}}\right)^k \\ = \frac{2R^{N+1}}{\sqrt{(N+1)!}} \left(\frac{1}{1-\frac{2R}{\sqrt{N+1}}}\right) \\ \leq \frac{4R^{N+1}}{\sqrt{(N+1)!}}.$$
(77)

Thus, the claim follows by comparing the functions $\frac{a_N(t)z^N}{\sqrt{N!}}$ and $f_U(z,t)$ on ∂D_R and applying Rouché's theorem. From lemmas 5, 6 and 8 we compute:

$$\mathbb{P}(i)\mathbb{P}(ii)\mathbb{P}(iii) \ge \left(e^{-C_R T \sqrt{N^3 N!}}\right) \left(e^{-CT}\right) = \exp\left(-T e^{\left(\frac{1}{2} + o(1)\right)N \log N}\right).$$
(78)

Since events (i), (ii) and (iii) are independent, this computation yields the lower bound in Theorem 3.

5.2 Proof of upper bound in Theorem 3

The style of proof is identical to that given for the upperbound of Theorem 1. Jensen's formula states that

$$\log|a_0(t)| = -\sum_{\substack{|z_k| < \rho \\ f_U(z_k, t) = 0}} \log\left(\frac{\rho}{|z_k|}\right) + \int_{\partial D_{\rho}} \log|f_U(z, t)| d\mu(z),$$
(79)

where μ is the uniform probability measure on ∂D_{ρ} . Evaluating (79) at $\rho = \sqrt{N}$, we see that if $f_U(\cdot, t)$ has at least N zeros in D_R and $\sqrt{N} > R$ then:

$$\log|a_0(t)| \le -N\left(\frac{1}{2}\log N - \log R\right) + \int_{\partial D_{\sqrt{N}}} \log|f_U(z,t)| d\mu(z).$$
(80)

Thus, if $C_{f_{\mathcal{C}}}(T, R, N)$ holds, $\gamma \in (0, 1/2)$ and $N > N_*(\gamma)$ it follows that at each $t \in [0, T]$ one of the following conditions must be satisfied:

- A) $\log |a_0(t)| \le -\frac{\gamma}{2}N \log N$
- B) $\max_{z \in \partial D_{\sqrt{N}}} \log |f_U(z,t)| \ge \frac{\gamma}{2} N \log N.$

Write A(t) to denote the event that condition A is satisfied at time t, and $B_{\ell}(t)$ to denote the event that $\max_{z \in \partial D_{\sqrt{N}}} \log |f_U(z,t)| \ge (\frac{\gamma}{2} + \ell) N \log N$. Also, define $b(t) = \max \{\ell : B_{\ell}(t) \text{ is true}\}$. We shall observe the function $f_U(\cdot, t)$ at a sequence of times $0 = t_0 < t_1 < \cdots < t_N$, and bound the probability that either condition A or condition B is satisfied at all $t_k < T$. Define $t_{k+1} = t_k + \Delta t_k$, where Δt_k is defined as follows:

1. if
$$A(t_k)$$
 is true and $B_0(t_k)$ fails then $\Delta t_k = \Delta t_A(\alpha) \stackrel{def}{=} e^{-(\gamma - \alpha)N \log N}$

2. if
$$B_0(t_k)$$
 is true and $b(t_k) = \ell$, then $\Delta t_k = \Delta t_B(\ell) \stackrel{def}{=} \begin{cases} 6N \log N & 0 \le \ell \le 2\\ 2(\ell+1)N \log N & \ell > 2 \end{cases}$

If both $A(t_k)$ and $B_0(t_k)$ fail, then we set N = k, i.e. the observation process is halted. We assert the following

Claim 18. For any $\alpha \in (\frac{2\gamma}{3}, \gamma)$ we may choose $N_*(\gamma)$ sufficiently large so that there exists p_A and p_B such that:

$$\mathbb{P}(A(t_{k+1}) \mid \mathcal{F}_{t_k}) < p_A \tag{81}$$

$$\mathbb{P}(B_{\ell}(t_{k+1}) \mid \mathcal{F}_{t_k}) < p_B^{\frac{\Delta t_B(\ell)}{\Delta t_A(\alpha)} + 1}$$
(82)

and $p_A + p_B + p_B(1 - p_B) < 1/2$ for all $N > N_*$.

It then follows exactly as before that

$$\mathbb{P}(t_N \ge T) \le (p_A + p_B + p_B(1 - p_B))^{\lfloor \frac{T}{\Delta t_A(\alpha)} \rfloor} \le \exp\left[-Te^{(\gamma - \alpha + o(1))N\log N}\right].$$
(83)

The upper bound in Theorem 3 now follows by letting $\gamma \uparrow 1/2$ and $\alpha \uparrow 1/3$.

Claim 18 follows from the following three lemmas:

Lemma 19. For $\gamma > \alpha$ we have $\mathbb{P}(A(t_{k+1})|\mathcal{F}_{t_k}) \leq 2e^{-\alpha N \log N}$

Proof. Write $a_0(t_{k+1}) = e^{-\Delta t_k} a_0(t_k) + \sqrt{1 - e^{-\Delta t_k}} X$ where $X \sim \mathbb{C}N(0, 1)$. The probability that $A(t_{k+1})$ holds is maximized when $a_0(t_k) = 0$, so we have

$$\mathbb{P}(A(t_{k+1})|\mathcal{F}_{t_k}) \le \mathbb{P}\left(|X| < \frac{e^{-\frac{\gamma}{2}N\log N}}{\sqrt{1 - e^{-\Delta t_k}}}\right).$$
(84)

Since $\Delta t_k \geq \Delta t_A(\alpha)$ it follows that $e^{-\Delta t_k} < 1 - \frac{\Delta t_A(\alpha)}{2}$. Hence:

$$\mathbb{P}(A(t_{k+1})|\mathcal{F}_{t_k}) \leq \mathbb{P}\left(|X| < \sqrt{2}e^{-\frac{\alpha}{2}N\log N}\right)$$

= $1 - \exp\left[-2e^{-\alpha N\log N}\right] < 2e^{-\alpha N\log N}.$ (85)

Lemma 20. If $\gamma > \alpha$ there exists a constant N_* so that for all $N \ge N_*$:

$$\mathbb{P}(B_{\ell}(t_{k+1})|B_0(t_k) \ fails) \le \exp\left[-e^{(\frac{3}{2}\alpha - \gamma + o(1))N\log N}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\alpha)} + 1}$$
(86)

Proof. Define $\|\psi\| = \max_{z \in D_{\sqrt{N}}} |\psi(z)|$. Following the proof of lemma 16, we write

$$\|f_U(\cdot, t_{k+1})\| \le e^{-\Delta t_k/2} \|f_U(\cdot, t_k)\| + \sqrt{1 - e^{-\Delta t_k}} \|q(\cdot)\|$$
(87)

and deduce that if $B_{\ell}(t_{k+1})$ is satisfied but $B_0(t_k)$ fails then

$$\begin{aligned} \|q(\cdot)\| &\geq \frac{1}{\sqrt{\Delta t_k}} \left(e^{\ell N \log N} - 1 \right) e^{\frac{\gamma}{2} N \log N} + \frac{3\sqrt{\Delta t_k}}{8} e^{\frac{\gamma}{2} N \log N} \\ &\geq \left(e^{\ell N \log N} - 1 \right) e^{(\gamma - \alpha/2) N \log N} + \frac{3}{8} e^{\frac{\alpha}{2} N \log N} \stackrel{def}{=} Q_2(\ell) \end{aligned}$$
(88)

Now, using (69) we obtain:

$$\begin{aligned} \mathbb{P}(\|q(\cdot)\| \ge Q_2(\ell))^{\frac{\Delta t_A(\alpha)}{\Delta t_B(\ell) + \Delta t_A(\alpha)}} &\le \exp\left[-e^{\log Q_2(\ell) - N/2}\right]^{\frac{\Delta t_A(\alpha)}{2\Delta t_B(\ell)}} \\ &= \exp\left[\frac{-(e^{\ell N \log N} - 1)e^{\frac{\alpha}{2}N \log N - N/2} - \frac{3}{8}e^{(\frac{3\alpha}{2} - \gamma)N \log N - N/2}}{2\Delta t_B(\ell)}\right] \end{aligned}$$

It is clear that for sufficiently large N, the above expression is decreasing in ℓ for $\ell \ge 0$, so evaluating at $\ell = 0$ we obtain:

$$\mathbb{P}(\|q(\cdot)\| \ge Q_2(\ell)) \le \exp\left[-e^{(3\alpha/2 - \gamma + o(1))N\log N}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\alpha)} + 1}.$$
(89)

Lemma 21. For $N \geq 2$ we have

$$\mathbb{P}(B_{\ell}(t_{k+1})|B_0(t_k)) \le \exp\left[-e^{(\alpha-\gamma/2+o(1))N\log N}\right]^{\frac{\Delta t_B(\ell)}{\Delta t_A(\alpha)}+1}.$$
(90)

Proof. Equation (87) holds as before, but now we assume both $B_0(t_k)$ and $B_\ell(t_{k+1})$ are satisfied so

$$e^{(\frac{\gamma}{2}+\ell)N\log N} \le e^{(\frac{\gamma}{2}-1)N\log N} + \|q(\cdot)\|.$$
(91)

So for $N \ge 2$ we have $||q(\cdot)|| \ge \frac{1}{2}e^{(\frac{\gamma}{2}+\ell)N\log N}$. Thus,

$$\mathbb{P}(\|q(\cdot)\| \ge \frac{1}{2}e^{(\frac{\gamma}{2}+\ell)N\log N})^{\frac{\Delta t_A(\alpha)}{\Delta t_B(\ell)+\Delta t_A(\alpha)}} \le \left(\exp\left[-\frac{1}{2}e^{(\frac{\gamma}{2}+\ell)N\log N-N/2}\right]\right)^{\frac{\Delta t_A(\alpha)}{2\Delta t_B(\ell)}} \\
\le \exp\left[-\frac{1}{4\Delta t_B(\ell)}e^{(\alpha-\frac{\gamma}{2}+\ell)N\log N-N/2}\right] \\
\le \exp\left[-e^{(\alpha-\frac{\gamma}{2}+o(1))N\log N}\right].$$
(92)

6 Proofs of Large deviations for O.U. processes

In this section we give proofs of the large deviation estimates for Ornstein-Uhlenbeck processes. *Proof of lemma 5.* Take $\Delta t = R^2$, and observe that:

$$\mathbb{P}(|W(t+\Delta t)| < R \mid |W(t)| < R) \le \mathbb{P}(|W(t+\Delta t)| < R \mid W(t) = 0).$$
(93)

Also, for fixed t we may write $W(t + \Delta t) = e^{-\Delta t/2}W(t) + \sqrt{1 - e^{-\Delta t}}X$, where $X \sim \mathbb{C}N(0, 1)$ is independent of W(t). Thus,

$$\mathbb{P}(|W(t+\Delta t)| < R \mid W(t) = 0) \leq \mathbb{P}\left(|X| < \frac{R}{\sqrt{1-e^{-\Delta t}}}\right)$$
(94)

$$\leq \mathbb{P}\left(|X| < \frac{R_*}{\sqrt{1 - e^{-R_*^2}}}\right) = C_* \tag{95}$$

since $\frac{R}{\sqrt{1-e^{-R^2}}}$ is increasing in R. Thus,

$$\mathbb{P}\left(|W(t)| < R \text{ for } t \in [0,T]\right) \le C_*^{\lfloor T/\Delta t \rfloor} = e^{-C_2 T/R^2}$$
(96)

For the other bound, take $\Delta t = \log(1 + R^2)$ and define

$$\begin{array}{lll} Q(t) & = & \text{Event that } |W(s)| < R \text{ for } s \in [t,t+\Delta t] \text{ and } |W(t+\Delta t)| < R/2 \\ \tilde{Q} & = & \text{Event that } |B(s)| < R \text{ for } s \in [1,1+R^2] \text{ and } |B(1+R^2)| < R/2. \end{array}$$

Observe that

$$\mathbb{P}(Q(t) \mid |W(t)| < R/2) \ge \mathbb{P}(\tilde{Q} \mid |B(1)| = R/2) = \tilde{C}$$

$$\tag{97}$$

where \tilde{C} is independent of R by Brownian scaling. Hence,

$$\mathbb{P}(|W(t)| < R \text{ for } t \in [0,T]) \ge \mathbb{P}(|W(0)| < R/2)\tilde{C}^{\lceil T/\log(1+R^2) \rceil} \ge e^{-C_1 T/R^2}.$$
(98)

Proof of lemma 6: For the upper bound, take $\Delta t = \log(1 + 1/R^2)$ and define

$$\begin{array}{lll} Q(t) &=& \text{Event that } |W(s)| > R \text{ for } s \in [t,t+\Delta t] \text{ and } |W(t+\Delta t)| > 2R \\ \tilde{Q} &=& \text{Event that } |B(s)| > R\sqrt{1+1/R^2} \text{ for } s \in [1,1+1/R^2] \text{ and } |B(1+1/R^2)| > 2R\sqrt{1+1/R^2} \\ \tilde{Q}' &=& \text{Event that } |B(s)| > R^2 + 1/2 \text{ for } s \in [1,2] \text{ and } |B(2)| > 2R^2 + 1. \end{array}$$

Now observe that:

$$\mathbb{P}(Q(t) \mid |W(t)| > 2R) \geq \mathbb{P}(Q \mid |B(1)| > 2R)$$
$$\geq \mathbb{P}(\tilde{Q}' \mid |B(1)| = 2R^2) \geq C_*$$

where C_* is a positive constant and the last inequality follows from Brownian scaling and the inequality $\sqrt{1+x} \leq 1+x/2$. It follows that

$$\mathbb{P}(|W(t)| > R \ \forall t \in [0,T]) \ge \mathbb{P}(|B(1)| > 2R)C_*^{\lceil T/\Delta t \rceil} \ge e^{-C_1 R^2 T}$$
(99)

For the lower bound, we observe W(t) at times $0 = t_0 < t_1 < \cdots < t_N$ and then bound the probability that $|W(t_k)| \ge R$ for all $t_k \le T$. Specifically, if we observe W(t) at time t_k and $|W(t_k)| = R_k \ge R$, then we set $t_{k+1} = t_k + \Delta t_k$ where $\Delta t_k = 2 + \lfloor 2\log(R_k/R) + 1 \rfloor$. If $|W(t_k)| < R$ then we halt the observation process and define N = k. We are interested in bounding $\mathbb{P}(t_N > T)$ from above. Observe that if k < N then we may write:

$$|W(t_{k+1})| \le e^{-\Delta t_k/2} |W(t_k)| + \sqrt{1 - e^{-\Delta t_k}} |X_k|$$
(100)

where $X_k \sim \mathbb{C}N(0,1)$ is independent of $\sigma \{W(t)|t < t_k\}$. Thus, $|W(t_{k+1})| \leq R/e + |X_k|$ and we see that if $r \geq R$ then

$$\mathbb{P}(|W(t_{k+1})| \ge r|W(t_i) \ \forall i \le k) \le \mathbb{P}(|X| \ge r - R/e) \le \mathbb{P}(|X| \ge r(1 - 1/e)) = e^{-r^2(1 - 1/e)^2}$$
(101)

Let

$$C_* = \sup_{r \ge R} \exp\left(-\frac{r^2(1-1/e)^2}{3+\lfloor 2\log(r/R)+1 \rfloor}\right)$$

$$\leq \sup_{r \ge R} \exp\left(-\frac{r^2(1-1/e)^2}{4+2\log(r/R)}\right)$$

$$= \exp\left(-R^2(1-1/e)^2/4\right)$$
(102)

so that for $n \ge 1$ we have $\mathbb{P}(\Delta t_{k+1} \ge n) \le C_*^{n+1}$ by (101) and (102). Now let $\Delta \tilde{t}_k$ be i.i.d. geometric random variables satisfying $\mathbb{P}(\Delta \tilde{t}_k = n) = C_*^n(1 - C_*)$ for $n = 0, 1, 2, \ldots$ Define $\tilde{t}_n = \sum_{k=0}^{n-1} \Delta \tilde{t}_k$ and set $\tilde{N} = \min \{k : \Delta \tilde{t}_k = 0\}$. It follows that $\Delta \tilde{t}_k$ stochastically dominates the conditional distribution of Δt_k given Δt_i for all i < k, so $\mathbb{P}(\Delta \tilde{t}_{\tilde{N}} > T) \ge \mathbb{P}(t_N > T)$. Using the following lemma Lemma 22. $\mathbb{P}(\Delta \tilde{t}_{\tilde{N}} > k + 1 | \Delta \tilde{t}_{\tilde{N}} > k) = C_* + C_*(1 - C_*)$

it follows that

$$\mathbb{P}(t_N > T) \le \mathbb{P}(\Delta \tilde{t}_{\tilde{N}} > \lfloor T \rfloor) = (2C_* - C_*^2)^{\lfloor T \rfloor} \le e^{-C_2 T R^2}.$$
(103)

It remains only to prove Lemma 22. Let ϕ_k be i.i.d. Bernoulli random variables satisfying $\mathbb{P}(\phi_k = 1) = C_*$. Define $\tau_0 = 0$ and $\tau_n = \min\{k > \tau_{n-1} : \phi_k = 0\}$. Observe that we may construct the ϕ_k 's so that $\Delta \tilde{t}_k = \tau_{k+1} - \tau_k - 1$. Then the event $\Delta \tilde{t}_N > n$ corresponds to the event that the ϕ_k process yields more than n 1's before 2 consecutive 0's, and the lemma follows easily.

Proof of lemma 7: The upper bound follows from lemma 6. We now prove the lower bound. Set $\Delta t = \log(1 + 1/R^2)$ and let

- 1. A(t) denote the event that $W(t + \Delta t) \in D_{\rho/2}(R)$ and $W(s) \in D_{\rho}(R)$ for all $s \in [t, t + \Delta t]$.
- 2. \tilde{A} denote the event that $B(1+1/R^2) \in D_{\frac{\rho}{2}\sqrt{1+1/R^2}}(R\sqrt{1+1/R^2})$ and $B(s) \in D_{\rho\sqrt{s}}(R\sqrt{s})$ for all $s \in [1, 1+1/R^2]$.

Then we compute:

$$\mathbb{P}(A(t)|W(t) \in D_{\rho/2}(R)) \geq \mathbb{P}(A(0)|W(0) = R - \rho/2)$$

$$\geq \mathbb{P}(\tilde{A}|B(1) = R - \rho/2).$$

As $R \to \infty$ we have

$$\mathbb{P}(B(s) \in D_{\rho\sqrt{s}}(R\sqrt{s}) \; \forall s \in [1, 1 + 1/R^2] | B(1) = R - \rho/2) \to 1$$
(104)

so for sufficiently large R we obtain

$$\begin{split} \mathbb{P}(A(t)|W(t) \in D_{\rho/2}(R)) &\geq \frac{1}{2} \mathbb{P}(B(1+1/R^2) \in D_{\frac{\rho}{2}\sqrt{1+1/R^2}}(R\sqrt{1+1/R^2})|B(1) = R - \rho/2) \\ &= \frac{1}{2} \mathbb{P}((R-\rho/2) + \frac{1}{R}X \in D_{\frac{\rho}{2}\sqrt{1+1/R^2}}(R\sqrt{1+1/R^2}) \end{split}$$

where $X \sim \mathbb{C}N(0,1)$. Using the approximation $\sqrt{1+1/R^2} < 1+1/(2R^2)$ we have

$$\begin{split} \mathbb{P}(A(t)|W(t) \in D_{\rho/2}(R)) &\geq \quad \frac{1}{2}\mathbb{P}(X \in D_{\frac{R\rho}{2}\sqrt{1+1/R^2}}(\frac{R\rho+1}{2}) \\ &\rightarrow \quad \frac{1}{2}\mathbb{P}(\operatorname{Re}(X) > \frac{1}{2}). \end{split}$$

Thus, $\mathbb{P}(A(t)|W(t) \in D_{\rho/2}(R))$ is bounded away from zero by a positive constant. It follows that

$$\mathbb{P}(W(t) \in D_{\rho}(R) \ \forall t \in [0,T]) \ge e^{-c\lfloor \frac{T}{\log(1+1/R^2)} \rfloor} \ge e^{-c_1 R^2 T}.$$

Proof of lemma 8: Observe that

$$\mathbb{P}\left(\max_{s\in[0,1]} W_x(s) < R \text{ and } W_x(1) < R/2 | W_x(0) = R/2\right) \geq \mathbb{P}\left(\sup_{s\in[0,e-1]} B_x(s) \le \left(\sqrt{e} - 1\right) \frac{R}{2}\right) \\
= 1 - 2\mathbb{P}\left(B_x(e-1) \ge \left(\sqrt{e} - 1\right) \frac{R}{2}\right) \\
\ge 1 - e^{-c_1 R^2} \ge \exp\left[-e^{-c_2 R^2}\right]$$

It follows that

$$\mathbb{P}\left(\max_{s\in[0,T]} W_x(s) < R\right) \geq \mathbb{P}(W_x(0) < R/2) \exp\left[-e^{-c_2R^2}\right]^{\lfloor T \rfloor} \\
\geq \exp\left[-Te^{-CR^2}\right].$$
