A bstract

Inspired by the theory of trace identities of matrices, we introduce a very simple approach to the algebra of multisymmetric functions, yielding both generators and relations in an explicit form under the assumption that the order of the symmetric group is invertible in the base eld. The method works on the multilinear level regardless of the characteristic. As an application, a consequence is drawn on the dening equations of the commuting variety.

1 Introduction

Let K be an arbitrary eld. The symmetric group S_n acts on $V = K^n$ by permuting coordinates. Write V^m for the m-fold direct sum of this representation, and write $K[V^m]$ for the coordinate ring of V^m (an mn-variable polynom ialalgebra). The algebra of multisymmetric polynom ials is the ring of invariants $K[V^m]^{S_n}$. It is an old result proved by Schla i [29], Noether [23], MacM ahon [22], Weyl [32], that when K has characteristic zero, this algebra is generated by the polarizations of the elementary symmetric polynom ials. Extensions and counterexamples for base elds of positive characteristic were given by Richman [28], Stepanov [30], Fleischmann [9], Briand [2]. The relations among the generators had been studied classically

by Junker [16] [17], [18], and recently by Dalbec [4], Bukhshtaber and Rees [3], and Vaccarino [31]. In characteristic two, a nite presentation of the ring of multisymmetric functions was given by Feshbach [8].

We introduce here a very simple approach to the presentation of the algebra of multisym metric functions, inspired by the theory of trace identities of matrices. The key step in our work is Theorem 2.1, giving a new basis in the algebra of multisym metric functions. This yields quickly and simultaneously both the generators (rst fundamental theorem) and the relations (second fundamental theorem) in an explicit form, under the assumption that the order of the symmetric group is invertible in K, see Theorem 2.6. In particular, applying recent results of Derksen [5] we derive Theorem 4.1, a nite presentation for the algebra of multisymmetric functions. We note also that our methods work on the multilinear level regardless of the characteristic of K. To illustrate the results we work out concrete examples in Section 5.

Furtherm ore, we point out a connection to the work of Processi [26] on the scheme of n-dimensional representations of an algebra, and derive a consequence on the dening equations of the commuting variety: our Theorem 3.3 says that the scheme of semisimple representations of the m-variable polynomial algebra is reduced (when m = 2 this was proved earlier by G an and G inzburg [12]).

The main new results in the paper are Theorem 2.1, the case char(K) > n of Theorem 2.6 (ii), Theorem s 2.8, 3.2, 3.3, and 4.1.

2 Trace identities of diagonal matrices

Identify V m with the space of m -tuples of diagonal m atrices. W rite

for the generic diagonal matrices, where $x(i)_j$ is the jth coordinate function on the ith sum mand of V^m . The algebra K $[V^m]^{S_n}$ contains the traces Tr(w) of non-trivial monomials $w=x(1)^{-1}$ x(m) in the generic diagonal matrices; these invariants in other words are the polarized power sums. There is a natural N_0^m -grading on K $[V^m]$: the multidegree of the entries of x(i) is the ith standard basis vector in N_0^m . The multidegree of Tr(w) (for was above) is . We say that an element of K $[V^m]$ is multilinear if it is multihom ogeneous of multidegree $(1; \ldots; 1)$.

Theorem 2.1 Assume that char(K) > n or char(K) = 0. Then the products Tr(u)Tr(v) Tr(w) of at most n traces of monomials form a basis in $K[V^m]^{S_n}$.

Proof. We are dealing with a permutation action, so the orbit sums of m onom ials form a vector space basis in the algebra of invariants. An arbitrary monomial win the mn variables x(i); uniquely factors as w [n], where w [j] is a (possibly empty) monomial depending only on the m variables $x(i)_{i}$, i = 1; ...; m with xed lower index j. Call the height of w the num ber of non-em pty subm onom ials w [i]. D enote by we [j] the monomial in the variables x(1); x(m) obtained by deleting the lower index j from the variables $x(i)_j$. Clearly, two monomials $w; u \in \mathbb{K}$ [V m] belong to the same S_n -orbit if and only if the multisets five [1];:::; we [n]g and fe[1];:::;e[n]g coincide. Therefore the dimension of the multihom ogeneous component of K V^m S^n with multidegree equals the number of $multisets fw_1; :::; w_rg of m onom ials in x(1); :::; x (m) such that r n and$ r ₩ x (1) 1 x (m). On the other hand, this is also the number of products of at most n traces having multidegree. Therefore it is su cient to prove that the products of at most n traces are linearly independent.

Assume on the contrary that a non-trivial linear combination of products of at most n traces is zero. Choose a term $Tr(w_1)$ Tr)(wwith non-zero coe cient such that r n is maximal. G iven j 2 f1;:::; ng and a m onom ial z in the m variables x(1);:::;x(m), de ne zhji 2 K $[V^m]$ as the monom ial in the variables x (i) $_{j}$ obtained from z by putting the lower index j to all the variables x (i) in z. 0 ne can easily see that the expansion of $Tr(w_1)$ in the variables $x(i)_i$ contains the monomial w_1 hli rhowi with coe cient d!, where there are distinct monomials in the multiset fw1;:::; wrg, and the ith occurs with multiplicity r_i . Since r_1 + d ⇒rr n, this coe cient is non-zero. M oreover, a product of at most r 1 traces contains only monomials with height < r, and the only product of r traces containing the above m onom ial is $Tr(w_1)$ Tr/w Hence expanding our non-trivial linear combination of products of at most n traces in the m n variables $x(i)_i$ contains the monomial w_1 hli rhwiw ith a non-zero coe cient. This is a contradiction.

Example. Take n = m = 2, write x = x(1) and y = x(2), then the multihom ogeneous component of K $[V^2]^{S_2}$ of multidegree (3;2) has the following basis (provided that char(K) \in 2):

Remark 2.2 It is stated in [14] that one gets the multigraded Hilbert series of K [V m] S_n by substituting $z_1^{\ 1} \quad \ _m^{\ m} z$, 2 N $_0^m$, into the nth complete symmetric function in in nitely many variables. This can be seen by counting the S_n -orbits of monomials. Theorem 2.1 gives a basis dierent from the orbit sums of monomials that corresponds naturally this formula for the Hilbert series.

Next we introduce a fundamental (n + 1)-linear relation among the traces of monomials. Set

where the sum m ation ranges over all factorizations of x(1) x(n + 1) into the product of non-empty submonomials.

Proposition 2.3 We have the identity

in K $[V^{n+1}]^{S_n}$.

Proof. This follows by specializing the fundam ental trace identity of n m atrices to diagonal matrices. Indeed, let Y (1);:::;Y (n + 1) be generic n n matrices (so their entries generate an $(n+1)n^2$ -variable commutative polynom ial ring). For a permutation $2 S_{n+1}$ with cycle decomposition

called the fundamental trace identity of n n matrices. This can be obtained by multilinearizing the Cayley-Hamilton identity to get an identity multilinear in the n matrix variables Y (1);:::;Y (n), and then multiplying by Y (n + 1) and taking the trace; see [11] for details. The substitution Y (i) (i = 1):::;(n + 1) in (3) yields (2).

R em ark 2.4 An alternative way to deduce (2) is to express the (n + 1)th elem entary sym m etric function in n + 1 variables in term s of the power sum s using the N ew ton form ulae, then polarize, and specialize the last coordinates to zero.

A monom ial w=x(1) 1 x (m) can be thought of as an S_n -equivariant polynom ial map V^m ! V. A k-tuple $\underline{w}=(w_1;:::;w_k)$ of such monom ials gives an S_n -equivariant polynom ial map V^m ! V^k , inducing a K-algebra hom on orphism

So P roposition 2.3 im m ediately in plies the following class of relations among the traces contained in K [V m] S_n .

C orollary 2.5 Let $w_1; :::; w_{n+1}$ be arbitrary non-empty monomials in the variables x(1); :::; x(m). Then we have the relation

Theorem 2.1 and C orollary 2.5 essentially contain both the rst fundam ental theorem (generators) and the second fundam ental theorem (relations) for K [V $^{\rm m}$] $^{\rm S_n}$ (when n! is invertible in K). To state the second fundam ental theorem in a form alway we need some more notation. Denote by M $^{\rm (m)}$ the set of non-trivial monomials in the (commuting) variables x (1);:::;x (m). To each w 2 M $^{\rm (m)}$ associate an indeterminate $t_{\rm w}$, and take the polynomial ring

in in nitely many commuting variables. One may think of the elements of F $^{(m)}$ as formal trace expressions, into which one can substitute arbitrary m pairw ise commuting n $^{(m)}$ n matrices over some commutative K-algebra. In particular, we have the K-algebra homomorphism

induced by t_w 7 Tr(w). Its im age is contained in the ring ofmultisym metric functions. Note that F $^{(m)}$ is naturally multigraded, the multidegree of t_w being the multidegree of w, and that ' $^{(m)}$ is multihom ogeneous. Later we shall speak about the multilinear component of F $^{(m)}$, which is the multihom ogeneous component with multidegree (1;:::;1). In the case m=n+1, F $^{(m)}$ contains the multilinear element

where the sum ranges over all factorizations of the monomials (1) x(n+1) as a product of non-empty submonomials (compare with (1)). Proposition 2.3 says that $_{n+1}$ belongs to the kernel of $'^{(n+1)}$. Given a k-tuple $\underline{w} = (w_1; :::; w_k)$, $w_i \ge M^{(m)}$ and a k-variable monomial $i \ge M^{(k)}$ denote by $i \le M$ the monomial in $i \le M^{(m)}$ obtained by substituting in $i \le M$ the variable $i \le M$. The K-algebra homomorphism (4) lifts to

In particular, \underline{w} maps $\ker('^{(k)})$ into $\ker('^{(m)})$, and we say that the relation $(f \underline{w})(x(1); :::; x(m)) = 0$ (where $f 2 \ker('^{(k)})$) is a consequence of the relation f(x(1); :::; x(k)) = 0.

Theorem 2.6 Assume that char(K) > n or char(K) = 0.

- (i) The algebra K $[V^m]^{S_n}$ of multisymmetric functions is minimally generated by the traces of monomials of degree n in x(1); ...; x(m).
- (ii) All relations among the traces of monom ials are consequences of the fundamental relation (2). Formally speaking, the kernel of the surjection $^{(m)}:F^{(m)}:$ K V^m J^{S_n} is generated as an ideal by the elements of the form $_{n+1}$ \underline{w} , where \underline{w} is an (n+1)-tuple of monom ials in $M^{(m)}$.

Proof. Theorem 2.1 shows in particular that the algebra of multisym metric polynomials is generated by the traces of monomials (with no bound on

the degree). Given a monom ial of degree n+1, write it as a product $w_1 = {n+M}$ of n+1 non-empty monom ials. The relation (5) tells us that $n \operatorname{Tr}(w_1 = {n+M})$ can be expressed in terms of traces of monom ials of strictly smaller degree. This obviously implies that the traces of degree n generate the algebra of multisym metric functions.

Regardless of the characteristic of the base eld, (5) shows that an arbitrary product $Tr(w_1)$ $T_{r}(w_1)$ of n+1 traces of m onom ials can be expressed as a linear combination of products of at most n traces (of m onom ials obtained by multiplying together some of the $w_1; \ldots; w_{n+1}$). Therefore the relations (5) in Corollary 2.5 are clearly su cient to reduce an arbitrary product of traces into a normal form (i.e. as a linear combination of the elements of the basis provided by Theorem 2.1), hence this is a complete system of dening relations.

M oreover, since there is no relation of degree $\,$ n am ong the traces of m onom ials, the traces of degree $\,$ n form a m in im algenerating set of K $[V^m]^{S_n}$.

Remark 2.7 One can replace the polarized power sums of degree the polarized elem entary symmetric functions to get an equivalent generating system . Theorem 2.6 (i) in characteristic zero is the well known classical result of Schla i [29], Noether [23], MacMahon [22], Weyl [32], which was generalized to the case char(K) > n by Richman [28] (see also [30], [2], [10] for other proofs). In the case char(K) = 0, Theorem 2.6 (ii) appears in a recent paper by Bukhshtaber and Rees [3] (using a dierent language and motivation), and can be derived also from statements of Dalbec [4] (partly reform ulating results of Junker [17]) and Vaccarino [31]. The case char(K) > n of Theorem 2.6 (ii) is new. In our point of view, (ii) is a close relative of the result of Razmyslov [27] and Procesi [25] saying that all trace identities of n n matrices are consequences of the fundamental trace identity. The original approach in [27] and [25] is based on Schur-Weyl duality. Kem er in [19] gave an elem entary combinatorial proof valid on the multilinear level in all characteristic. Our Proposition 2.10 below is inspired by an analogous statem ent of K em er.

Our method works on the multilinear level in arbitrary characteristic.

Theorem 2.8 Let K be an arbitrary base eld.

- (i) The multilinear products Tr(u)Tr(v) Tr(w) of at most n traces of monom ials form a basis in the multilinear component of K $[V^m]^{S_n}$.
- (ii) All multilinear relations among the traces of monomials are consequences of the fundamental identity (2). Formally speaking, any multilinear element in the kernel of ''m': F'm'! K [V'm'] Sn' is contained in the ideal generated by the elements of the form m+1 w, where w is an (n+1)-tuple of monomials such that the multidegree of w_1 $m+w_1$ belongs to $f0;1g^m$.

Proof. (i) Note that the only point in the proof of Theorem 2.1 where the assumption on char(K) was used is that $(r_i!)$ is non-zero. Now in the multilinear case, all the r_i are equal to 1.

(ii) G iven the statement (i), the proof of (ii) is the same as the proof of Theorem 2.6 (ii) above.

R em ark 2.9 As a consequence, standard arguments show that Theorem 2.8 holds also on the integral level, i.e. when K is replaced by the ring Z of integers. Moreover, (ii) gives a new proof of the known fact that if 0 < char(K) n, then the invariant $\text{Tr}(x(1) \times (m)) \ge K^m \mathbb{S}^{n}$ is indecomposable (can not be expressed by lower degree invariants); see [7] for the relevance of this latter fact for matrix invariants.

Proposition 2.10 The multilinear element $_{\text{w2P}_{\text{m}}}^{\text{P}}$ awt (where aw 2 K) belongs to the kernel of $_{\text{P}}^{\prime}$ (m) if and only if for all $u=fu_1;:::;u_rg\ 2\ P_m$ with r n we have that $_{u=w}^{\text{p}}$ aw = 0.

Proof. One may think of a relation P_{w2P_m} $a_w_i Tr(w_i) = 0$ as a trace identity for diagonal matrices. Thanks to multilinearity it holds if and only

3 Sem isim ple com mutative representations

The results of Section 2 can be reinterpreted in terms of representation varieties.

First denote by M or $_{S_n}$ (V m ; V) the algebra of S_n -equivariant polynom ial maps V m ! V. The algebra structure comes from the algebra structure of the space V of diagonal matrices. As we pointed out earlier, the monom ials in the generic matrices x (i) can be viewed as elements of M or $_{S_n}$ (V m ; V). Similarly, the algebra diag (K [V m]) of diagonal matrices over the coordinate ring of V m is identified with the algebra of polynomial maps V m ! V.

Proposition 3.1 Assume that char(K) > n or char(K) = 0. The algebra Mor $_{S_n}$ (V m ; V) of S_n -equivariant polynomial maps from V m to V coincides with the Tr-stable K-subalgebra of diag(K [V m]) generated by the generic diagonal matrices x (1);:::;x (m).

Proof. The argument is a straightforward modi cation of the corresponding reasoning for the case of the algebra of matrix concomitants (cf. [25]): the linear map Mor_{Sn} (V ^m; V)! K [V ^{m+1}] ^{Sn} given by f 7 Tr(f x (m + 1)) is obviously injective, and the image is contained in the component of K [V ^{m+1}] ^{Sn} having degree 1 in x (m + 1). This component is spanned by elements of the form Tr(u) Tr(v)Tr(w x (m + 1)), where u;:::;v;w 2 M ^(m). The preimage of this element is Tr(u) Tr(v)w.

Theorem 2.6 on the relations among the polarized power sums can be paraphrased as follows: the free m-generated commutative algebra with trace satisfying the nth C ayley-H am ilton identity is isom orphic to M or $_{S_n}$ (V m ; V). To make this statement precise we need to recall some term inology from [26]. A K-algebra (where we still assume that n! is invertible in K) R with a trace is equipped with a K-linear map tr: R ! R satisfying for all a; b 2 R that (i) tr(a)b = btr(a); (ii) tr(ab) = tr(ba); (iii) tr(tr(a)b) = tr(a)tr(b). For example, Mor $_{S_n}$ (V^m ; V) or diag (K [V^m]) endowed with the usual Trare examples of algebras with trace (we identify scalars with scalar matrices, so K [V^m] is identified with a subalgebra of diag (K [V^m]) and K [V^m] S_n is identi ed with a subalgebra of M or_{S_n} (V m ; V)). W orking in the category of algebras with trace we consider only trace preserving morphisms. Given a K-algebra with trace one can de ne for a 2 R and i = 0;1;:::;n the element $_{i}$ (a) as f (tr(a); tr(a^{2}); :::; tr(a^{n})) where f is the unique n-variable polynom ial over K for which the ith coe cient of the characteristic polynom ial of a general n n matrix y is f (Tr(y); Tr(y²):::; Tr(y²)). The form alnth characteristic polynom ialofa 2 R is $_{a}^{(n)}$ (t) = $_{i=0}^{p}$ $_{i}$ (a)tⁿ $_{i}$. We say that R satisfies the nth Cayley-Ham ilton identity if tr(1) = n and $a^{(n)}(a) = 0$ for all a 2 R. Consider the polynomial algebra A (m) in m commuting indeterm in ates x(1); ...; x(m) over the ring $F^{(m)}$. Endow this algebra with the form altrace

given by $\text{tr}(w) = t_w$ (for $w \ 2 \ M^{-(m)}$) and $\text{tr}(1) = n \cdot C$ learly, $A^{-(m)}$ is the free object generated by m elements in the category of commutative algebras w ith a trace satisfying tr(1) = n.

Theorem 3.2 Assume that char(K) > n or char(K) = 0. Then the kernel of the natural trace preserving surjection

is the tr-stable ideal generated by $_a^{(n)}$ (a), where a ranges over A $^{(m)}$. In other words, M or_{Sn} (V m ; V) is the free object with m generators in the category of commutative algebras with a trace satisfying the nth C ayley-H am iltonidentity.

Proof. Again the proof is a straightforward modication of the proof of the corresponding result on matrix concomitants in [27] and [25], so we give

only a sketch. One can think of an element of $\ker(\m^m)$ as an identity with trace for diagonal n n matrices. Just like in the proof of Proposition 3.1, multiplying by an extra matrix variable x (m + 1) and taking trace we get an equivalent pure trace identity. Now we can apply Theorem 2.6 (ii) to conclude that the latter is a consequence of the fundamental trace identity. Since the identity (3) (and hence (2)) arises that way from the multilinearization of the Cayley-Ham ilton identity (see for example [20] for the polarization process of classical invariant theory, or see [11] for the same principle in the context of polynomial identities) when we translate back the pure trace identity in m + 1 variables to an identity with trace in m variables we see that the latter follows from the Cayley-Ham ilton identity.

For the rest of this section we assume that K = C, the eld of complex numbers. Write $M_{n,m}$ for the space of m-tuples of n n matrices with com plex entries. A point of M nm determ ines an n-dim ensional representation of the free associative algebra $Chx_1; ...; x_m$ i. M oreover, $M_{n,m}$ is an a ne GL (n; C)-variety under the simultaneous conjugation action. The algebraic quotient M $_{n,m}$ =G L (n;C) param eterizes the isom orphism classes of sem isim ple n-dim ensional representations of the free algebra, see [1]. Now Let $C_{n,m}$ be the subvariety of $M_{n,m}$ consisting of those m-tuples of matrices whose components pairwise commute. This is the so-called commuting variety. It is a closed GL(n;C)-subvariety, and the quotient $C_{n,m} = GL(n;C)$ $M_{n,m} = GL(n;C)$ can be thought of as the variety of isom orphism classes of sem isim ple representations of the m -variable com m utative polynom ialalgebra. The space V^m of m -tuples of diagonal matrices is a subvariety of C_{nm} , and it is easy to see that the natural surjection $C[C_{n,m}]! C[V^m]$ between the coordinate rings restricts to an isom orphism

(this isom orphism is explained in Proposition 621 of [13]).

The coordinate ring C M $_{n,m}$] is the m n^2 -variable com m utative polynom ial algebra generated by the entries of the generic n n m atrices Y (1);:::;Y (m). D enote by J the ideal in C M $_{n,m}$] generated by the entries of the com m utators Y (i)Y (j) Y (j)Y (i), 1 i < j m. W rite $R_{n,m}$ for the quotient C M $_{n,m}$]=J. The ideal J is stable with respect to the simultaneous conjugation action of G L (n;C) on C M $_{n,m}$], so there is an induced action of G L (n;C) on $R_{n,m}$. By de nition the algebra $R_{n,m}$ is the coordinate ring of the scheme of n-dimensional representations of the m-variable commutative polynomial algebra. It is a long standing open problem in commutative

algebra whether this scheme is reduced or not, see for example [15]. It is obvious that the common zero locus of J is the commuting variety $C_{n,m}$, hence $R_{n,m}$ =rad ($R_{n,m}$) = C [$C_{n,m}$].

There is a unique hom om orphism from the m-variable commutative polynomial algebra C [x (1);:::;x (m)] to the algebra M (n;R_{n,m}) of n n matrices over R_{n,m}, given by x (i) 7 Y (i) (we keep the same notation for the images of the generic matrices Y (i) in the quotient modulo J). This is the universal map of [26]; that is, in a categorical sense this map is universal among the hom om orphisms from C [x (1);:::;x (m)] into an n n matrix algebra over a commutative ring. The universal map extends uniquely to a trace preserving hom om orphism ! :A $^{(m)}$! M (n;R_{n,m}), where M (n;R_{n,m}) is endowed with the usual trace function. C learly, ! is a universal map in the category of algebras with trace. Being an algebra of matrices over a commutative ring, M (n;R_{n,m}) satis es the nth C ayley-H am ilton identity. Therefore! factors through

(where (S)_{tr} stands for the trace stable ideal generated by S). Theorem 2.6 of [26] (see also [21] for a reformulation) can be applied in this situation to conclude that ! maps A $^{(m)}=({a\atop a}^{(n)}(a)$ ja 2 A $^{(m)})_{tr}$ isom orphically onto M $(n;R_{n,m})^{\text{GL}(n;C)}$, the algebra of GL (n;C)-equivariant polynom ial maps from Spec(R $_{n,m}$) to M (n;C). Moreover, the subalgebra tr(A $^{(m)}=({a\atop a}^{(n)}(a)$ ja 2 A $^{(m)})_{tr}$) is mapped onto R $_{n,m}^{\text{GL}(n;C)}$. So we have the chain of homomorphism s

$$\operatorname{tr}(A^{(m)}) = (\binom{(n)}{a} (a) ja 2 A^{(m)})_{\operatorname{tr}}) \stackrel{!}{:} R_{n \pi n}^{\operatorname{GL}(n, \mathbb{C})} \stackrel{!}{:} C [\mathbb{C}_{n \pi n}]^{\operatorname{GL}(n, \mathbb{C})}$$

Both the rst and the third algebras can be identied with the algebra of multisymmetric functions by Theorem 32 and (8), respectively, implying that the composition ! of the above two hom om orphisms is the identity map on C V^m J^{S_n} . So we have proved the following result supporting the conjecture that $R_{n,m}$ is reduced:

Theorem 3.3 The natural surjection : $R_{n,m}$! $C [C_{n,m}]$ from the coordinate ring of the scheme of n-dimensional representations of the m-variable polynomial algebra to the coordinate ring of the commuting variety restricts to an isomorphism $R_{n,m}^{GL(n;C)}$! $C [C_{n,m}]^{GL(n;C)}$ between the subalgebras of GL(n;C)-invariants. In other words, rad $(R_{n,m})$ contains no non-zero GL(n;C)-invariants.

Remark 3.4 In the special case m=2 the above result is due to G an and G inzburg, see Theorem 1.2.1 in [12]. One may paraphrase it by saying that "the scheme of n-dimensional sem is imple representations of the commutative m-variable polynomial algebra is reduced". The above argument shows in the reverse direction that if the scheme of n-dimensional representations of the m-variable polynomial algebra is reduced, then at least in characteristic zero, Theorem 2.6 (ii) on the multisymmetric syzygies can be considered as a consequence of Theorem 2.6 in [26].

4 A nite presentation

Throughout this section we assume that n! is invertible in K, so the group algebra K S_n is sem isimple. Combining Theorem 2.6 (ii) with a general result of Derksen [5] we derive a nite presentation of the algebra of multisymmetric functions in terms of generators and relations. Namely, to each m-variable monomial of degree n^2 n+2 we associate a generator (the Tr of the corresponding monomial in the generic diagonal matrices x(1);::;x(m)), and to each factorization of a monomial of degree n^2 n+2 into the product of n+1 non-empty submonomials we associate a relation (namely, we substitute the n+1 factors into the identity (2)) expressing the trace of the long monomial as a linear combination of products of n+1 shorter traces.

 \mathbb{W} e need som e m ore notation to state the result. For a natural number d, set

$$F_d^{(m)} = K [t_w jw 2 M^{(m)}; deg(w) d]$$

(an $_{\ m}^{\ m+d}$ -variable polynom ial subalgebra of F $^{(m)}$), and consider the restriction

of the surjection $'^{(m)}:F^{(m)}!$ $K[V^m]^{S_n}$.

Theorem 4.1 Assume that dar(K) > n or dar(K) = 0. Then the kernel of the surjection

is generated as an ideal by

Proof. We have the chain of polynomial algebras

The Tr(w) with deg(w) n is a minimal set of homogeneous generators of K [V^m] S_n by Theorem 2.6 (i). Apply Theorem 2 in [5] in this special case to conclude that the ideal ker ($\binom{m}{n}$) of relations among these generators is 2 $_{S_{n}}$ (V m), where for a G ^{+}m odule W , the number generated in degree G (W) is de ned as the minimal natural number d such that all hom ogeneous polynomials of degreed are contained in the ideal of K W] generated by the hom ogenous invariants of positive degree (the Hilbert ideal). It was shown by N .W allach that S_n (V^m) = $\frac{n}{2}$ + 1, see C orollary 3.2.2 in [13] (the result is stated there for m = 2 and in characteristic zero, but the argum ent attributed to A.M.Garsia obviously works for an arbitrary m and also for char(K) > n). Consequently, $\ker({n \choose n})$ is generated in degree n^2 n+2. By Theorem 2.6, these generators are contained in the ideal of F (m) generated by S . Note that S is contained in F $_{n^2-n+\,2}^{\mbox{ (m)}}$, and denote by L the ideal of $F_{n^2-n+2}^{(m)}$ generated by S. Clearly, L \ $F_n^{(m)} = \ker(m^n)$, and L contains for each w 2 M $^{(m)}$ with n < deg (w) n^2 n + 2 a hom ogeneous element of the form t_w f_w , where f_w 2 F_n (i.e. a relation expressing Tr(w) in terms of traces of degree n), again by Theorem 2.6. Therefore the natural surjection F $_{n^2-n+2}^{\text{ (fin)}}$! F $_{n^2-n+2}^{\text{ (fin)}}$ =L restricts to a surjection F $_n^{\text{ (fin)}}$! F $_{n^2-n+2}^{\text{ (fin)}}$ =L with kernel $L \setminus F_n^{(m)} = \ker('_n^{(m)})$, in plying $F_{n^2}^{(m)} = L = K [V^m]^{S_n}$.

5 Calculations

Throughout this section we assume that n! is invertible in K, so K V^m J^{S_n} is C ohen-M acaulay (see for example [6] as a general reference for the invariant theory of nite groups). For illustrative purposes we do calculations in concrete examples. To simplify notation, write $k^i y^j$ k^j to denote the trace $Tr(x^i y^j)$ of a monomial in generic diagonal matrices. An obvious homogeneous system of parameters (primary generators) in K V^m V^m V^m is

W rite hP i for the ideal of K $[V^m]^{S_n}$ generated by P , and write K [P] for the polynom ial subalgebra of K $[V^m]^{S_n}$ generated by P . Note that to nd secondary generators we need to get a vector space basis modulo hP i in K $[V^m]^{S_n}$.

Lem m a 5.1 Assume that n! is invertible in K. Let w be a monom ialhaving degree $\,$ n in one of the variables x(1); :::; x (m), and having total degree $\,$ n + 1. Then $\,$ Tr(w) belongs to $\,$ hP i.

Proof. A ssum e for example that w has degree n in x(1). Then w can be written as a product of n+1 factors as x(1)x(1) x(1)u for som e nonempty monomial u. The relation $_{n+1}(x(1);x(1);:::;x(1);u)=0$ shows the claim, since each nontrivial partition of the multiset fx(1);:::;x(1);ug contains a part consisting solely of x(1)s.

Remark 5.2 From Lemma 5.1 and Theorem 2.1 we immediately get the upperbound n (n 1)m for the degrees of the secondary generators. However, the general method of Broer (see Theorem 3.9.8 in [6]) yields the better bound $\frac{1}{2}$ n (n 1)m.

5.1 The case n = 2

In this subsection we assume char(K) \in 2. The fundamental multilinear trace identity for diagonal 2 \times 2 m atrices is

(com pare with (4.17) in [24]). The specialization z = w in (12) leads to

The N $_0^m$ -graded H ilbert series of K [V m] S_2 can be written as a rational function by M olien's form ula:

$$\text{H (K [V^m]^{S_2}; t_1; ...; t_m)} = \frac{P_{\substack{[\frac{m}{2}] \\ i=0}} e_{2i}(t_1; ...; t_m)}{Q_{\substack{m \\ j=1}} (1 t_j) (1 t_j^2)};$$

where e_i (t_1 ;:::; t_m) is the ith elementary symmetric function in t_1 ;:::; t_m . It is easy to describe the H ironaka decomposition of K [V m] S_2 . The secondary generators are

The substitution x 7 x (i), y 7 x (j), z 7 x (k) in (13) gives a relation showing that $[k](i) \times (k)] [k](j) \times (k)]$ is contained in hP i for all i; j; k. Substitutions $fx; y; z; wg ! fx (j_1); \ldots; x (j_{2k}) g$ in the relation (12) show that a product $[k](j_1) \times (j_2)]$ $[k](j_1) \times (j_{2k})]$ is congruent m odulo hP i to $[k](j_1) \times (j_2)]$ $[k](j_1) \times (j_2)]$ for an arbitrary permutation . These relations in ply that the algebra of multisym metric functions is generated by S as a module over the polynom ialring K [P]. The H ilbert series show s that it is a free module. These considerations show also that the specializations $fx; y; z; wg ! fx (1); \ldots; x (m) g$ in (12) generate the ideal of relations among the generators $[k](i); k \times (1)$, and that a minimal system of relations consists of relations of degree 4.

5.2 The case n = 3, m = 2

In this subsection we assume char(K) \in 2;3. The fundamental identity $_4(x;y;z;w) = 0$ takes the form

Consider the following consequences:

Let us use the notation f g to indicate that f; g 2 K [V^2] S^3 are congruent modulo hP i. The above 17 relations in the order of listing imply the following:

Recall that K $\[N^2\]^{S_3}$ is m in in ally generated as an algebra by P [f[xy]; [xy^2]g. The above congruences obviously show that as a module over K $\[P\]$, the algebra K $\[N^2\]^{S_3}$ is spanned by

U sing M olien's form ula one can easily com pute

and this implies that K $[V^2]^{S_3}$ is a free K [P]-m odule generated by S. The above considerations imply that the ideal of relations among the 21 generators

is generated by the 17 relations (14) and (15). The relations (14) can be used to elim inate the super uous generators of degree 4 in the relations (15). This way we get 5 de ning relations for the m inim algenerating system $f[x^iy^j]ji+j$ 3g. The bidegrees of these relations are (3;2), (2;3), (4;2), (2;4), (3;3). It is easy to see that these 5 relations m in in ally generate the ideal of relations.
