### AN ABSTRACT PACKAGE FOR HOMOLOGICAL ALGEBRA

#### MOHAMED BARAKAT & DANIEL ROBERTZ

A bstract. Hom ological algebra is a natural extension of the theory of modules over rings. The category of modules and their hom om orphisms is replaced by the category of chain complexes and their chain maps. A module is represented by any of its resolutions. The module is then recovered as the only non-trivial homology of the resolution. All resolutions of a module are equivalent in a well-de ned sense. The role of kernels and cokernels resp. exact sequences in the abelian category of modules is played by cones resp. distinguished triangles in the appropriate category of complexes. The notions of derived functors and their homologies, connecting homomorphism and the resulting long exact homology sequences play a central role in homological algebra [H S97].

The M aple package homal provides a way to deal with these powerful notions. The package is abstract in the sense that it is independent of any speci c ring arithmetic. If one speci es a ring in which one can solve the ideal membership problem and compute syzygies, the above homological algebra constructions over that ring become accessible using homalg.

### 1. Introduction

Our dream was, in the setup of nitely presented module categories, to realize the notion of a functor in a computer algebra system. Functors map objects of a source category to objects of a target category and, in a compatible way, morphisms between two objects in the source category to morphisms between their images in the target category. So when one implements a functor one has not only to take care of how it acts on objects, but also of how it acts on morphisms between these objects. This meant, that for each functor we wanted to implement we wrote two procedures: its object part and its morphism part. The next step was to construct more complex functors out of given ones via iterated compositions and derivations. Faced with the increasing complexity of implementing these two procedures for these recursively define to mean and its morphism part.

- (1) The morphism part of the functor must be directly extractable in a uni ed manner from its object part, where \uni ed means that it does not depend on the particular functor under consideration.
- (2) De ning the object part of the derivation of a functor, given by its two parts, must be done in a uni ed way, regardless of the functor one wants to derive. The object part of the derived functor must ful 11 (1).
- (3) De ning the object part of the composition of two functors must be done in a uni ed way, regardless of the functors one wants to compose. The object part of the composed functor, again, must ful 11(1).

Ful lling these three conditions was the most dicult task in designing the package. We will try in what follows to isolate the mathematical ideas that helped us to realize this dream.

Not a single algorithm to compute in any sort of rings is implemented in homalg. Rather it is a package built up of hom ological algebraic denitions and constructions. On the highest levels one and the construction of connecting hom om orphisms and long exact sequences, the processes of composition and derivation of functors and denitions of various special controls. On lower levels homal goes all the way down till it reaches three procedures, which are basically the only ones required from another package implementing the ring special carithmetics for the ring R:

- (1) BasisOfModule: Com pute a basis of an R-subm odule of the free module  $R^n$ , the submodule being given by nitely many generators.
- (2) Reduce: Reduce, or better, nd a normal form of a given element of R<sup>n</sup> with respect to an R-submodule given by a basis computed using BasisOfModule.
- (3) SyzygiesGenerators: For two R-subm odules N  $\,$  M  $\,$  R  $^{\rm n}$  compute a generating set of relations between the elements of a basis of M  $\,$  m odulo N  $\,$ .

In practice one uses (1) to realize (2) and (3): One computes a basis to be able to nd normal forms of elements modulo this basis, but also to compute syzygies. Instead of computing normal forms, what we in fact need is to exclively decide, whether an element of R<sup>n</sup> belongs to a given R-submodule or not. By \e ectively" we mean: In case the element does belong to the submodule, one then gets it back expressed in the basis of the submodule. So it would actually sure to have an algorithm exclively deciding the submodule membership, which is a slight generalization of exclively deciding the ideal membership. Summing up we can say that all what homal gneeds from a ring are two procedures: One to exclively solve the ideal membership problem and one to compute a generating set of syzygies. We will call such rings computable.

The following ring-speci c packages have successfully been used with homalg: Involutive and Janet BCG+03], JanetOre Rob06] and OreModules [CQR07]. PIR Bar06] is one more tiny package, or rather a pseudo-package, that makes Maple's built-in facilities for dealing with integers and some other principal ideal rings available to homalg.

homalg is also able to make use of various normal form algorithms for modules resp. special type modules over various rings, which are used to provide a standard form for a presentation of these modules:

PIR uses the Sm ith normal form for (Maple-built-in) principal ideal rings.

Janet optionally uses the Jacobson normal form for univariate dierential rings, i.e. rings of the form K [0], where K is a dierential eld with (a derivation of K. Involutive optionally uses the extension package QuillenSuslin written by Anna Fabianska [Fab06, FQ 07] in plementing the Quillen-Suslin theorem to compute

a free basis of a projective module over a polynomial ring (which is then free by the theorem). A similar extension package is planned for 0 reModules.

It goes without saying that we will suppress some technical issues of the package for the sake of mathematical clarity. The best technical guide to the package remains the code itself, which in nearly all parts can be read as a mathematical text.

#### 2. Presentations

The functor coker that maps

In what follows we want to confuse the two categories and therefore we simply denote both by  ${\tt C}$  .

A susual a presentation is given by generators and relations. A presentation of a module in the current M aple in plem entation of homalg is a list<sup>3</sup> containing as rst entry the list of generators and as second entry the list of relations. The third entry is a string delim iter to optically indicate the end of the presentation. This string, unless changed by the user, defaults to "Presentation". The remaining entries provide extrainformation about the presented module, e.g. its Hilbert series in case the ring is the polynomial ring. This extra information can only be provided by the ring-specie c package.

3.1.1. RightDivide. This procedure, is the ring-theoretic generalization of solving a linear in-hom ogeneous system of equations. Hence, it is not astonishing that in a lot of computations it plays the nal and decisive role.

For three R  $\rightarrow$ m atrices A; B and L w ith the same number of columns, one wants to compute an X w ith

After computing (X; Y) one often simply throws away Y.

W log.we forget about L, ie. consider the system B = XA. To nd X one computes a basis G for A (ie.a matrix G with rows being a basis for the rows of A) together with a matrix  $C_A$ , such that  $G = C_AA$ . Then reduces B m odulo G, ie. compute a normal form matrix N, with rows being those of B reduced modulo G. We compute N together with a matrix  $C_B$ , such that  $N = B + C_BG$ . If N is not the zero matrix, then the system is not solvable. O therwise  $X = C_BC_A$  is a solution. Thinking of X as  $X = BA^{-1}$  justimes the name of the procedure.

3.1.2. Complete ImSq. As explained in Section 5, this is the most prominent application of Right Divide in homalg. We call an incomplete square of the form

32. Procedures additionally based on Syzygies Generators. For a matrix M2 R 1/2 1/2 a m atrix of generating syzygies or a syzygy m atrix is a m atrix S 2 R  $^{\frac{1}{2}}$  such that SM = 0 and  $R^{1} > S = \ker(R^{1} > R^{1} > R^{1} > R^{1})$ .

A slight generalization of this is when one requires that SM = 0 m od N, where N has the sam e num ber  $l_0$  of colum ns as M. O ne calls S the syzygy m atrix of M m odulo N.

- 321. ResolutionOfModule. By iterating the process of taking syzygies one obtains a whole free resolution of the module M = coker(M). What homely additionally does is the following: W henever it computes the ith syzygy matrix it uses its rows to locate the obsolete rows of the (i 1)st syzygy matrix. The ith syzygy matrix is recomputed, its rows are again used to locate more obsolete rows of the (i 1)st syzygy matrix. This process stabilizes, since the number of rows of the latter is bounded. Then one proceeds with the (i+1)st syzygy matrix. Etc.
- 322. SubfactorModule. Given two matrices  $M_1$  and  $M_2$  with the same number of columns. First one computes a basis B of  $M_2$ . Then one reduces  $M_1$  m odulo B and gets N. The syzygy m atrix S of M m odulo N is a presentation of the subfactor m odule (im  $(M_1)$  + im  $(M_2)$ ) = im  $(M_2)$ .

By D  $^k$  (C) we denote the category of chain complexes  $^4$  C :  $C_1$  !  $C_2$  ! !  $_k$  6fC of nite length k and their chain maps.

5. The morphism part of a functor

A functor is by de nition a map between two categories that maps objects to objects and, in a compatible way, morphisms to morphisms. To be allowed to speak about functors in this package we need to be able to not only de ne the functor on objects, but also on morphisms between objects.

It m ight be puzzling for the reader that we start with a section devoted to the morphism part rather than the object part of functors. The reason for that will become clear towards the end of this section.

Here we write everything for covariant functors. A dapting things for contravariant functors is done in the obvious way.

For a m orphism S ! T and a functor F we want to compute F ( $^{\prime}$ ). There are three cases homalg distinguishes:

- (1) The functor F is a composed functor:  $F = F_1$   $F_2$ . Since F (') =  $F_1$  ( $F_2$  (')) we are able to reduce computing F (') to computing  $F_2$  (') and then  $F_1$  ( $F_2$  (')).
- (2) The functor F is an  $i^{th}$  (left) derived functor:  $F = L_i G$ . In Section 9, where we will deal with the derivation of functors, we will show how to reduce the computation of F (') to essentially computing G (').
- (3) The functor F is neither composed nor derived. In what follows such functors are called basic functors.

For basic functors the idea then is to reduce the computation of F(') to completing an image square (cf. 3.1.2). To this end one embeds F(S) resp. F(T) in a module Hull F(S)

resp. Hull (T) with an induced morphism Hull (') determined by ':

Expressed categorically,  $\operatorname{Hul}_F$  is a functor, which we call a hull functor of F, and  $_F$  is a natural transform ation, which we call the corresponding natural embedding. For this idea to work the morphism  $\operatorname{Hul}_F$  (') must be much simpler to compute than F (').

W e will dem on strate this idea in Section 6 by giving concrete realizations of  $\text{Hull}_F$  for various basic functors F .

The procedure in homalg that precisely accomplishes the above mentioned distinction is called FunctorMap. The several pieces of code of the Maple implementation reproduced below will demonstrate how FunctorMap unites the d


# 6. The object part of a functor

All functors we consider are of the form  $F:D_i^k(C)$ ! C. We simply distinguish two types of functors, depending on whether F(C) is a subfactor module of  $Obj_i^k(C)$ , for all objects  $C:D_i^k(C)$ , or not. In what follows a functor of the previous kind is called a functor producing subfactor modules.

Following the name convention used in the Maple implementation of homalg: If the procedure implementing the object part of a functor is called F, then the procedure implementing the morphism part is called FMap (cf. the comment 1133 at the end of Section 11).

## 6.1. Functors producing subfactor modules.

6.1.1. The functor Cokernel. On the level of objects the covariant cokernel functor associates to a morphism between two modules its cokernel. Cokernel:  $D_2^2$  (C)! C, i.e.

The Cokernel functor is the most basic functor in our setting, in the sense that com puting its morphism part Cokernel (') is trivial: If we take the generators of A resp.

B to be the generators of Cokernel () resp. Cokernel (), then the matrix representing Cokernel (') coincides with that of '. In other words the hull functor  $\operatorname{Hull}_{\operatorname{Cokernel}} = \operatorname{Cokernel}$  and the natural embedding  $\operatorname{Cokernel}$  is the identity transform ation 6.

6.1.2. The functor Kernel. On the level of objects the covariant kernel functor associates to a morphism between two modules its kernel. Kernel:  $D_1^2(C)$ !  $C_1$  i.e.

The procedure Kernel is based on SubfactorModule introduced in 322. To compute the above embedding one needs to compute the syzygies of the morphism relative to its target module.



62.1. The functor Hom.R. Let R be a (not necessarily commutative) ring with a xed involution Recall that Hom R (;R) is a contravariant functor from the category of left R-m odules to the category of right R-m odules. We use the involution to transform the resulting right R-m odule into a left R-m odule. The idea is to reduce the computation of the hom om orphism module to computing a kernel. Since Hom R (;R) is left exact one obtains:

We compute  $\operatorname{Hom}_R(M;R)$  as the kernel of the right most morphism. Following the row convention we identify  $\operatorname{Hom}_R(R^{1-j};R)$  with  $R^{j-1}$ , which justimes the notation (M) for the right most morphism. Further, identifying  $R^{j-1}$  with  $R^{1-j}$  in the obvious way nally yields



For the most general denition of tensor product of modules one starts with a not necessarily commutative ring R, a right R-module M<sub>R</sub>, and a left R-module <sub>R</sub>N. If the R-module structure of M resp. N comes from a (Q;R)-bimodule resp. an (R;S)-bimodule structure, then their tensor product over R is in a natural way a (Q;S)-bimodule  $_{Q}M_{R}$   $_{R}N_{S}$ . Q and S, again, are not necessarily commutative rings. A nalogously, let M and N be two left modules over a not necessarily commutative ring R and denote by Hom<sub>R</sub>  $(_{R}M;_{R}N)$  the abelian group

of R-hom om orphisms. If the R-m odule structure of M resp. N comes from an (R;Q)-bim odule resp. an (R;S)-bim odule structure, then  $H \circ m_R (_R M;_R N)$  is again in a natural way a (Q;S)-bim odule.

Note that in both cases the resulting module might not be nitely generated as a (Q;S)-bim odule, even if M and N are nitely generated as R-modules.

In the special case where either M or N is an (R;R)-bim odule, then M  $_R$  N resp. Hom  $_R$  (M;N) is again an R-m odule  $^{12}$ . This is always the case when the ring is commutative, since then every R-m odule is an (R;R)-bim odule in the obvious way.

The Maple implementation of homal gdoes neither support changing the ring, nor bim odule structures. These are issues we want to address in future implementations. But even though, the above mentioned problem of non-nite generation will remain the major obstacle.

# 7. Encapsulating functors

A functor is fully de ned when both parts are de ned, i.e. its object part and its morphism part. If the functor is a multi-functor, then several morphism parts have to be de ned. homalg accesses all these parts of a functor via a so called encapsulation. It incorporates both parts and also takes care of the possible multi-functoriality. In future implementations the concept of encapsulations will be taken care of by the data structure for functors (cf. 1133). We will demonstrate the encapsulation of functors by the following examples:

7.1. The functor Hom\_R. This is the simplest form of encapsulation:


## 9. Derivation of functors

The philosophy of derived categories is, roughly speaking, to replace a module by one of its resolutions, and then to look at the resolution as a very special type of complexes, with hom ology concentrated at degree 0. A fter inverting quasi-isom orphisms, one obtains the derived category, where the objects are quasi-isom orphism types of complexes. Especially, all resolutions of a module become isom orphic objects in the derived category.

Using the cylinder-cone-translation construction [GM 03, III3] one constructs out of every short exact sequence of complexes, a so called distinguished triangle. By passing to hom ology we again obtain distinguished triangles in the category of graded objects (which one can view as cyclic complexes, i.e. complexes with zero boundary maps [GM 03, III23]). A popular way to start, is to take a distinguished triangle coming from a short exact sequence of complexes that are simultaneously resolving a short exact sequence of modules. Then one applies a functor, that turns such distinguished triangles again into distinguished triangles, and at last one takes the hom ology.

The classical way of writing such a distinguished triangle of hom ologies is as a long exact hom ology sequence.

9.1. ResolveModule: Resolve a module. By resolving a module M, which we view as a complex concentrated in degree 0, we obtain a complex of free (resp. projective) modules and a quasi-isomorphism



A fter inverting quasi-isom orphisms all resolutions become isom orphic. The derivation procedure of modules in homalg is called ResolveModule. It is based on the low-level ResolutionOfModule introduced in 32.1.

92. A pplying functors to complexes. As mentioned in Section 9, functors should be applied to complexes of modules, rather than to single modules. Thereby homalg again makes use of the encapsulation of functors. In this implementation, there are two procedures depending on whether one is dealing with a covariant or a contravariant functor. They are called FunctorOnSeqs and CofunctorOnSeqs. For future development cf. 1133.



9.3. Derived functors. 



9.4. ResolveShortExactSeq: Resolving a short exact sequence of modules. To resolve a short exact sequence of modules 0 ! M $^{0}$ ! M $^{0}$ ! O, one starts with a resolution of M $^{0}$ :




Then one completes the middle line by taking iterated pullbacks. Finally one lls the upper line by taking kernels to obtain:



with exact lines and rows. This method is implemented in the procedure ResolveShort-ExactSeq. There are several other methods to resolve a short exact sequence simultaneously, cf. [HS97, Proof of Theorem IV .6.1].


9.5. Connecting hom om orphism and long exact sequences. Applying an additive covariant functor F to the diagram P



results in a diagram  $\overline{P} = F$  (P) where the columns are still exact, but where the rows are in general no longer exact. Connecting the homologies of the rows one obtains the long exact homology sequence

#### 10. Natural transformations

com m utes.

The attempt to formalize the notion of a natural mapping, like the natural monomorphisms, epimorphisms and isomorphisms one encounters in linear algebra for example, was one of the biggest motors behind inventing category theory and resulted in the formal notion of natural transformations.

The natural embeddings of Section 5 are all examples of natural transform ations. The following three natural transform ations are the most important ones in homalg:

- 10.1. NatTrTargetToCokernel= CokernelEpi. In the setup of 6.1.1, associating to each the epim orphism onto the cokernel of is a natural transform ation from the functor Target =  $Obj_2^2$  to the functor Cokernel.
- 10.2. NatTrKernelToSource= KernelEmb. In the setup of 6.1.2, associating to each the embedding of the kernel of into the source of is a natural transform ation from the functor Kernel to the functor Source =  $Obj_1^2$ . Computing KernelEmb relies on computing syzygies.
- 10.3. NatTrIdToHomHom\_R. Let M be a module and M its double dual. The classical evaluation map  $ev_M$ : M! M de nesa natural transformation from the identity functor Id to the double dual functor HomHom\_R.

### 11. Future implementations of homalq

11.1. W hy Maple? Choosing Maple for implementing homaly was dictated by the pre-existence of several ring packages developed in our workgroup written in Maple, that were (and to some extent are still) not available in other free computer algebra systems. The main reason for choosing Maple to develop these ring packages was that Maple allows one to work relatively easy with the ring K  $\left[\frac{\theta}{\theta x_1}; :::; \frac{\theta}{\theta x_n}\right]$ , where K is a di-erential eld and  $\frac{\theta}{\theta x_1}; :::; \frac{\theta}{\theta x_n}$  are commuting derivations of K. The Maple package Janet [BCG + 03] provides the Janet division algorithm for these rings.

112. Why not Maple? Maple is commercial, even for the purely scientic academic use. In fact homal gdoesn't rely on anything specic in Maple which is not available in an open system such as GAP4 [GAP06] for example. On the contrary, we believe that a system like GAP4 provides with its structures, method selection schemes and lazy evaluation a way to reduce the data overhead and hence the overall performance of homal gdrastically.

11.3. D ream ing further. Beside choosing a computer algebra system with method selection capabilities, we want to make future implementations more exible. For example, we want to still be able to use our dierential ring packages written in Maple, without being forced to rewrite them elsewhere, simply because they are still best placed in Maple. We also want to use the Singular [GPS05] engine to compute Grobner basis, which is now available for the wide class of G-algebras [LS03]. In short, we want to interact with as much systems as possible. To remedy the drawback of moving huge data from one system to the other, the computed data will be kept on the computing system side and homalg will solely receive a pointer to the result. This will minimize the data transfer to an extreme and should even, to some extent, enable us to parallelize the computations.

In general, interm ediate results tend to be much larger than end results. Besides, lots of computations in homological algebra need a fair amount of intermediate steps. Hence restricting the data transfer to the end result would be an enormous gain. And often enough one is even only interested in a true/false answer, saying for example if a module vanishes or if a sequence is exact or not, making real data transfer completely obsolete.

This will also mean that the operations in homal g that directly get in touch with data, such as taking the union of two lists of relations or transposing a matrix, must then be transferred to the package where the computations reside. This must be done for each such package. This is an unavoidable, but more or less the only drawback of this philosophy.

- 11.3.1. Derived categories. The future in plementations of homaly will become more serious about derived categorical concepts. For example connecting homomorphisms and long exact sequences will be systematically computed using the idea of mapping cones. The spectral sequence formalism will be easier to realize, once object oriented data structures are introduced to homalg.
- 11.3.2. Topology. For the sake of dem on stration we wrote a tiny package called alexander [BR 06a], which relies on homalg and computes simplicial homology and cohomology. Future implementations of homalg are planned to enable more serious applications to topology.
- 11.3.3. One more word to functors. In future implementations of homalg the two procedures implementing the object and morphism part of a functor will be united in one. The united procedure will be able to recognize if it has been applied to an object, to a morphism or even to complexes. This will be an easy task, once we strictly use structures throughout homalg.

## 12. Examples

For further examples we refer to [BR06c, BR06d] and the hom epage of the package [BR06b]. A nice application is the tiny homalg-based package conley that computes C-connection matrices of graded module octahedra/braids of Morse decompositions in dynamical system theory [BR].
