ON NONCOMMUTATIVE WEIGHTED LOCAL ERGODIC THEOREMS

Abstract. In the present paper we consider a von Neum ann algebra M with a faithful norm alsem i- nite trace , and f $_{\rm t} g$ a strongly continuous extension to L^p (M ;) of a sem igroup of absolute contractions on L^1 (M ;). By m eans of a non-commutative Banach Principle we prove for a Besicovitch function b and x 2 L^p (M ;), the averages

$$\frac{1}{T}\int_0^T b(t) t(x) dt$$

converge bilateral alm ost uniform in $L^p(M;)$ as T ! 0.

1. Introduction

It is known (see for example [12]) that in the classical ergodic theory one of the powerful tools in dealing with the almost everywhere convergence of ergodic avarages is the well-known Banach Principle, which can be formulated as follows:

Theorem 1.1. Let (S;F;m) be a measurable space with a - nite measure and let X be a Banach space. Let $fa_n\,g$ be a sequence of continuous linear maps of X into the space of measurable functions on S. Assume that $\sup_n f_{ia_n}(x)(s)_{ij} < 1$ for each x 2 X and almost all s 2 S. If the sequence a_n (x) converges almost everywhere for x in a dense subset of X, then this sequence converges for each x 2 X.

This principle is often applied in proofs concerning the almost everywhere convergence of weighted averages, moving averages, etc.

In a non-com mutative setting the alm ost everywhere convergence of sequences of operators were applied to study of the individual ergodic theorem s in von Neumann algebras by many authors [6],[7],[13],[17],[22] (see [10] for review). But in these investigations those ergodic theorem s were obtained without using an analog of the Banach Principle. In [8] rstly a non-commutative analog of such principle was proved for quasi-uniform convergence. Using that result in [14] a uniform sequence weighted ergodic theorem was proved in the space of integrable operators a liated with a von Neumann algebra. Recently, in [3] for the Banach Principle for bilateral uniform convergence has been adopted, and by means of it the Besicovitch weighted ergodic theorem has been proved.

In the present paper we are going to prove non-commutative local and weighted local ergodic theorems by means of the Banach principle. Note that such kind of

theorem s in commutative settings were studied by many authors (see for example [1], [9], [12]). In a non-com mutative setting we mention works [2], [4], [10], [11], [23].

Let us end this section with description of the organization of the paper. In Section 2, we recall some prelim in any results and formulate the Banach Principle. There, to prove local ergodic theorem, we adopt the principle in a more convenient formulation. In the next Section 3 we prove the local ergodic theorem for sem igroups of absolute contractions of Lp-spaces. Note that this section reviews the results of [2],[11]. Using the result of Sec. 3, in the last Section 4, we establish a weighted local ergodic theorem by means of the Banach principle.

2. Preliminaries

Let M be a sem i nite von Neum ann algebra acting on a Hilbert space H, let be a faithful norm alseminite trace on M, let P(M) be the complete lattice of all projections in M . A densely-de ned closed operator x in H is said to be a liated with M if y^0x xy^0 for every y^0 2 M 0 , where M 0 is the commutant of the algebra M . An operator x, a liated with M , is said to be -m easurable if for each " > 0 there exists e 2 P (M) with (e^2) " such that eH D_x, where $e^2 = II$ e, II is the unit of M , D $_{\rm x}$ is the domain of de nition of x. Let S (M) be the set of all m easurable operators a liated with M . Let k k stand for the uniform norm in ${\tt M}$. The m easure topology in S (M) is given by the system

Theorem 2.1. [15] Equipped with the measure topology, S (M) is a complete topological *-algebra.

Here, \dot{x} j is the absolute value of x, i.e. the square root of x x. By L_{+}^{p} (resp. L_{sa}^{p}) we denote the set of positive (resp. self-adjoint) elements of Lp. We refer a reader to [18] for more information about noncommutative integration and to [19, 21] for general term inology of von Neum man algebras.

There are several dierent types of convergences in S (M) each of which, in the com m utative case with nite m easure, reduces to the alm ost everywhere convergence (see for example [16]). In the paper we deal with so called the bilateral almost uniform (bau.) convergence in S (M) for which x_n ! x m eans that for every " > 0 there exists e 2 P (M) with $\mbox{ (e}^{?}$) $\mbox{ " such that ke}(x_{n}$ It is clear that bau. in plies convergence in measure. Now recall well known fact concerning bau. convergence (see [15], [20]).

Lem m a 2.2. Let M be as above. If two sequences x_n and y_n converge ball, then $x_n + y_n$ converges ball.

In [3] the following results has been proved.

Theorem 2.3. Algebra S (M) is complete with respect to the bau. convergence.

R em ark. A coording to Theorem 2.3 that the fundam entals equences in Theorem 2.5 indeed have their lim its belonging to S (M).

As it has been pointed out that the Banach Principle is one of the basic tools to prove ergodic theorem s. But the above form ulated Principle is too complicated to apply, since it requires m inorantly density of X_0 , which makes discult to check the condition (ii). Basically, to obtain some ergodic theorems we really need the following theorem, which is an analog of the Banach Principle.

Theorem 2.6. Let X be a Banach space and let $a_n:X$! S(M) be a sequence of linear m aps satisfying the conditions

This proves the assertion.

R em ark. We should note that in the proved Theorem a Banach space X need not be ordered. Hence a condition of m inorantly density of X_0 and positivity of a_n are extra restrictions, which were important in Theorem 2.5. But the condition (i) in Theorem 2.6 is strong than one in Theorem 2.5. For example, it implies that each mapping a_m (m 2 N) is continuous with respect to ball convergence, which can be seen from (2.1).

Recall a positive linear map $:L^1(M;)!L^1(M;)$ will be called an absolute contraction if (x) II and ((x)) (x) for every $x \ge M \setminus L^1$ with 0 x II. If is a positive contraction in L^1 , then, as it is shown in [22], k (x)k_p kxk_p holds for each $x = x \ge M \setminus L^p$ and all 1 p = 1. Besides, there exist unique continuous extensions $:L^p!L^p$ for all 1 p < 1 and a unique ultra-weakly continuous extension :M!M (see [11],[22]). 3. Local ergodic theorem

In this section we are going to prove a local ergodic theorem by means of the Banach Principle. Namely, we are going to prove the following

Theorem 3.1. Let f $_tg_t$ 0 be a strongly continuous extension to L^p (M ;) of a sem igroup of absolute contractions on $L^1 M$;). Then for every x 2 $L^p M$;) the averages $_{T}$ (x) converge b.a.u. in L^{p} (M;) as T! 0.

Proof. Take $X=L^p$ in Theorem 2.6. Then due to Theorem 2.7 the condition (i) of Theorem 2.6 is satis ed. Now take an arbitrary sequence of positive numbers fag such that $a_n ! 0$. Then according to Lemma 3.5 one sees that $a_n (x)$ converges ball. for every $x 2 X_0$. From Lemma 3.3 we already knew that X_0 is dense in L^p . Hence, all the conditions of Theorem 2.6 are satis ed, which implies the assertion of the theorem .

R em ark. Note that similar results were proved in [2] and [11], respectively in ${\tt L}^1$ and ${\tt L}^p$ spaces. But our approach uses the Banach principle.

4. A weighted local ergodic theorem

In this section by m eans of T heorem 3.1 and the B anach principle w e are going to prove a w eight local ergodic theorem .

Since $^{(R)}_T: X = L_+^p ! S (M)$ is a positive linear continuous maps, and the set $X_0 := L_+^p \setminus M$ is dense in $X = L_+^p$, by Theorem 2.6 we obtain the bau. convergence of $^{(R)}_T(x)$ for all $x \ge L_+^p$. R em ark. In the proof we could use Theorem 2.5 instead of Theorem 2.6, since in that case we may take $X = L_{sa}^p X_0 = L_+^p \setminus M$. Indeed, X is an ordered Banach space with closed cone $X_+ = L_+^p$, and X_0 is a minorantly dense subset of L_+^p (see β).
