MODULAR CLASSES OF POISSON-NIJENHUIS LIE ALGEBROIDS

Abstract. The modular vector eld of a Poisson-Nijenhuis Lie algebroid A is de ned and we prove that, in case of non-degeneracy, this vector eld de nes a hierarchy of bi-Hamiltonian A-vector elds. This hierarchy covers an integrable hierarchy on the base manifold, which may not have a Poisson-Nijenhuis structure.

1. Introduction

The relative modular class of a Lie algebroid morphism was rst discussed by G rabowski, M arm o and M ichor in [11]. K osm ann-Schwarzbach and W einstein in [16] showed that this relative class could be seen as a generalization of the notion of modular class introduced by W einstein in [17]. In [8], D am ianou and Fernandes introduced the modular vector eld of a Poisson-N ijehuis manifold and showed that it is intimately related with integrable hierarchies (see, also, the alternative approach o ered by K osm ann-Schwarzbach and M agri in [14]). In this paper, we generalize this construction and consider the modular vector eld of a Poisson-N ijehuis Lie algebroid.

Recall (see, e.g., [15]) that a N ijenhuis operator N : A ! A on a Lie algebroid (A;[;];) allows us to de ne a deformed Lie algebroid structure $A_N = (A;[;]_N; N)$ such that $N:A_N! A$ is a Lie algebroid morphism. Our rst result states that the modular class of this morphism has a canonical representative:

Proposition 1. The relative modular class N : A $_{\rm N}$! A is represented by d $_{\rm A}$ TrN .

Let us assume now that A is equipped with a Poisson structure compatible with N . Then we can de netwo Lie algebroid structures on A , namely (A ;[;];]; obtained by dualization from , and $A_{\rm N}=(A;[;]_{\rm N};{\rm N}^{\rm I})$) obtained from the rst one by deformation along N . Again, N : $A_{\rm N}$! A is a Lie algebroid morphism and, by the proposition above, its relative modular class has the canonical representative X $_{\rm N}$;) = d (TrN), which we will call the modular vector eld of the Poisson-Nijenhuis Lie algebroid (A;;N). When A = TM we recover the construction of D am ianou and Fernandes [8] up to a factor of 1=2 (for the same reason that the modular class associated with a Poisson manifold diers from the modular class of its cotangent Lie algebroid by a factor of 1=2).

The modular vector eld X $_{(N\ ;\)}$ of the Poisson-N ijenhuis Lie algebroid (A;; N) is always a d_N -cocycle. If N is non-degenerated it is also a d_N -coboundary. In this case we have the following generalization of a result of D am ianou and Fernandes for a Poisson-N ijenhuis manifold:

Theorem 2. Let (A; N) be a Poisson-Nijenhuis Lie algebroid with N a non-degenerated Nijenhuis operator. Then there exists a hierarchy of A-vector elds

The hierarchy of ows on A, given by this theorem, covers a hierarchy of (ordinary) multi-H am iltonian ows on the base manifold M. A lthough the hierarchy on A is generated by a N ijenhuis operator, it may happen that the base hierarchy is not generated by one. We will see that this is precisely the case for the $A_{\rm n}$ -Toda lattice. This gives a new explanation for the existence of a hierarchy of Poisson structures and ows associated with a bi-H am iltonian system which may not have a N ijenhuis operator.

This paper is organized as follows. In Section 2, we present the necessary background on Poisson-Nijenhuis Lie algebroids. In Section 3, we introduce the modular vector eld of a Poisson-Nijenhuis Lie algebroid, state its basic properties, and prove Theorem 2. Section 4 is concerned with integrable hierarchies and discusses the example of the A_n -Toda lattice. In the last section, we discuss our results in the context of three basic classes of Lie algebroids: The rst class is the extreme case where the base manifold is a point, i.e., a Lie algebra. The second class, is the case of the tangent bundle of a manifold where we recover the results of [8], and the last class is the Lie algebroid associated with the dynamical Yang-Baxter equation of Etingof and Varchenko ([4]) and discovered by Xu in [18].

2. Poisson-Nijenhuis Lie Algebroids

In this section we will recall some basic facts about Nijenhuis operators and Poisson structures on Lie algebroids which we will need later. A general reference for Lie algebroids is the book by Cannas da Silva and Weinstein [3]. Nijenhuis operators are discussed in detail in the article by Kosmann-Schwarzbach and Magri [15], while PN-structures on Lie algebroids are discussed by Kosmann-Schwarzbach in [13] and by Grabowski and Urbanski in [12].

2.1. C artan calculus on Lie algebroids. Let us recall that a Lie algebroid is a kind of generalized tangent bundle, which carries a generalized C artan calculus.

First, for any Lie algebroid (A;[;];) we have a complex of A-di erential form s k (A) = (k A) with the di erential given by:

A morphism : A! B (over the identity) of Lie algebroids over M induces by transposition a chain map of the complexes of dierential forms:

Hence, we also have a well de ned m ap at the level of cohom ology, which we will denote by the same letter :H (B)! H (A).

22. N ijenhu is operators. Let (A;[;];) be a Lie algebroid over a manifold M . Recall that a N ijenhu is operator is a bundle map N : A ! A (over the identity) such that the induced map on the sections (denoted by the same symbol N) has vanishing torsion:

Let us set $_N$: N . For a N ijenhuis operator N , one checks easily that the triple A_N = $(A; [;]_N;_N)$ is a new Lie algebroid, and then $N:A_N$! A is a Lie algebroid morphism .

Since N is a Lie algebroid morphism, its transpose gives a chain map of the complexes of differential form s N : (k (A); dA)! (k (A); dA)! Hence we also have a map at the level of algebroid cohomology N : H (A)! H (A).

2.3. Poisson structures on Lie algebroids. Let $2 \times X^2$ (A) be a bivector on the Lie algebroid (A;[;];) and denote by 1 the usual bundle map

2.4. Poisson-Nijenhuis Lie algebroids. The basic notion to be used in this paper is the following:

De nition 3. A Poisson-Nijenhuis Lie algebroid (in short, a PN-algebroid) is a Lie algebroid (A; $[;]_A$;) equipped with a Poisson structure and a Nijenhuis operator N which are compatible.


The compatibility condition between N and means that:

where $[;]_N$ is the Lie bracket de ned by the bivector eld N 2 X 2 (A), and $[;]_N$ is the Lie bracket obtained from the Lie bracket [;] by deform ation along the N ijenhuis tensor N .

As a consequence, N de nes a new Poisson structure on A, compatible with:

and one has a commutative diagram of morphisms of Lie algebroids:



In fact, we have a whole hierarchy N $^{\rm k}$ (k 2 N) of pairw ise compatible Poisson structures on A .

3. Modular class of a Poisson-Nijenhuis Lie algebroid

In this section we will state and prove our main results.

31. M odular class of a Lie algebroid. Let (A;[;];) be a Lie algebroid over the manifold M . For simplicity we will assume that both M and A are orientable, so that there exist non-vanishing sections $2 \times X^{top}(A)$ and $2 \times X^{top}(A)$.

so that the cohom ology class [A] 2 H 1 (A) is independent of the choice of and . This cohom ology class is called the modular class of A and we will denoted it by mod A = [A].

Proposition 4. Let N be a N ijenhuis operator on a Lie algebroid A and x non-vanishing sections and as above. The modular form $_{A_{\, N}}$ of the Lie algebroid $A_{\, N}$ and the modular form $_{A_{\, N}}$ of A are related by:

Therefore we have the following im mediate corollary of Proposition 4:

C orollary 6. The relative modular class of the algebroid morphism N : A : A is a ${\tt A}_{\tt N}$ -cohom ology class with canonical representative the ${\tt A}_{\tt N}$ -form ${\tt d}_{\tt A}$ TrN .

Note that the class $[d_A \ TrN \] \ 2 \ H^1 (A_N)$ maybe non-trivial: in general, the di erentials d_A and d_{A_N} will be distinct.

32. Modular class of a Poisson-Nijenhuis Lie algebroid. Now we consider a Poisson-Nijenhuis Lie algebroid (A; N;). Then N is a Nijenhuis operator of the dual Lie algebroid (A;[;];) and, by Corollary 6, its relative modular class has the canonical representative d (TrN), so that:

In case N is non-degenerated, we obtain the PN-algebroid generalization of a result in [8] (which corresponds to the case A = TM; see examples below):

Theorem 9. Let (A; ;N) be a Poisson-Nijenhuis Lie algebroid with N a non-degenerated Nijenhuis operator. Then the modular vector eld X $_{(N;)}$ is a d $_{N}$ -coboundary and determines a hierarchy of vector elds

The expressions for the hierarchy now follow from identity (9) and Proposition 8 applied to N and to N 1 .

- 4. Integrable hierarchies and PN-Algebroids
- 4.1. Flows of A -vector elds. A vector eld X 2 X (A) on a Lie algebroid has a ow, generalizing the usual picture which corresponds to the case A = TM .

Given a vector eld X on M , we denote by $\overset{t}{X}$ its ow:

We can generalize this to any Lie algebroid A: to any vector eld X 2 X (A) (i.e., a section of A) one associates a 1-param eter group ${\mathsf t}^{\mathsf t}$ of autom orphism s of A. For this we can use the following general construction of (in nitesimal) ows. Let us assum e that E is a vector bundle over M . A derivation on E is a pair (D ;X) where D: (E)! We can apply the previous construction to a vector eld X 2 X (A) where we consider the derivation $(D_X; (X))$ with $D_X = [X;]$. The resulting ow, called the ow ofX,

An alternative description can be obtained using the berwise linear Poisson structure f ; $g_{A}\,$ on the dual bundle A : denote by X $_{f_{X}}\,$ the H am iltonian vector eld associated with the function f_X : A ! R. It is easy to check (see [7]) that:

42. Ham iltonian ows on Lie algebroids. Let us assume now that $2 \times X^2$ (A) is a Poisson structure on the Lie algebroid A. This bivector eld determines a bundle map 1 : A , and for the Lie algebroid structure on A , we have that 1 is a Lie algebroid morphism.

Proposition 11. For any f 2 C 1 (M) the H am iltonian vector eld X $_{\rm f}$ on A covers the (ordinary) H am iltonian vector eld on M associated with f. The H am iltonian ow $_{\rm X}^{\rm t}$ on A is dual to the ow of the section $d_{\rm A}$ f of A .

Proof. By de nition, the ow of X $_{\rm f}$ covers the ow of (X $_{\rm f}$). This vector eld is the H am iltonian vector eld on M associated with f

43. Integrable H ierarchies on Lie algebroids.

De nition 12. Let X be a vector eld on A. A rst integral of X is a function f:A! R which is constant along each integral curve of X:

Note that a rst integral of X is just a rst integral of X $^{\rm A}$, the canonical lift of (X) to A .

Observe that, on one hand, given 2 (A), f is a rst integral of X if and only if D $_{\rm X}$ () = L $_{\rm X}$ = 0.0 n the other hand, since the ow of X covers the ow of (X), pull-backs of rst integrals of (X) are rst integrals of X.

De nition 13. Given a Poisson structure on A, we say that two functions g;f 2 C 1 (A) -com m ute ifff;gg $_A$ = 0. A vector eld X is said to be integrable if X A , the canonical lift of (X) to A, is Liouville integrable.

Two rst integrals of the vector eld (X) may not $_{\rm M}$ -commute but their pullbacks always -commute, because basic functions always commute with respect to the linear Poisson bracket de ned on the dual of a Lie algebroid. In particular, we have:

are the functions which —com m ute with $f_{d_A\,f}$. In particular, evaluations of sections of A which com m ute with $d_A\,f$ and pull-backs of functions which M —com m ute with f are rst integrals of X $_f$.

Let N be a N ijenhuis operator on A compatible with . The sequence of Poisson structures $_k$ = N k covers a sequence of Poisson structure on M:

$$M_{M}^{k} = N^{k}$$
 ;

but, as an example below shows, these Poisson tensors may not be related by a Nijenhuis operator on M . We also have a sequence of linear Poisson brackets on A:

$$f ; g_{\lambda}^{k}$$

and, given a section on A , a sequence of H am iltonian vector elds

$$X_f^k = ff ; g_A^k :$$

A bi-Hamiltonian vector eld

$$X = {}^{1}_{0} (d_A h_1) = {}^{1}_{1} (d_A h_0)$$

de nes a hierarchy of multi-Hamiltonian vector elds on A:

$$X_{k+i} = \int_{k}^{1} (d_{A} h_{i}) = \int_{i}^{1} (d_{A} h_{k})$$
:

This hierarchy, on one hand, covers a hierarchy of Hamiltonian vector elds on M

$$(X_{i+k}) = {k \choose M}^{i-1} dh_i = {i \choose M}^{i-1} dh_k$$

and, on the other hand, is associated with the hierarchy of canonical lifts

$$(X_{i+k})^{A} = X_{f_{d_{A}h_{i+k}}}^{0} = X_{f_{d_{A}h_{k}}}^{i} = X_{f_{d_{A}h_{k}}}^{k}$$

4.4. C overing Integrable H ierarchies. We can try to apply our main result (Theorem 9) to obtain an integrable hierarchy on a Lie algebroid. However, one observes that in Theorem 9 the Ham iltonian functions, which are rst integrals of the vector elds in the hierarchy, are all basic functions, i.e., are pull-backs of functions on the base. Hence, in general, they will not provide a complete set of rst integrals. However, there is yet another connection with (classical) integrable systems, due to the following theorem:

Theorem 15. Let (A; ;N) be a Poisson-Nijenhuis Lie algebroid with N a non-degenerated Nijenhuis operator. Then the the modular vector eld X $_{\rm N}$; overs a bi-H am iltonian vector eld on M, and the associated hierarchy (7) of A-vector elds covers a (classical) hierarchy of ows on M. This hierarchy is given by:

(11)
$$X_{i+j} = \int_{i}^{1} dh_{j} = \int_{j}^{1} dh_{i} \quad (i; j 2 Z)$$

where $_{\rm i}$ are Poisson structures on M and ${\rm h_i}$ are the functions given by (8).

Although we have a hierarchy of modular vector elds X $_{(N^k;\)}$ generated by the N ijenhuis operator N , generally the covered hierarchy of bi-H am iltonian vector elds on M is not generated by any N ijenhuis operator. This is illustrated by the next example.

- $4.5.\ The\ classical\ Toda\ lattice$. The classical Toda lattice was already considered in [1], using speci c properties of this system . We use our general approach to show how one can recover those results and explain some of those form ulas.
- 4.5.1. Toda lattice in physical coordinates. The H am iltonian de ning the Toda lattice is given in canonical coordinates $(p_i;q_i)$ of \mathbb{R}^{2n} by

(12)
$$h_{2}(q_{1}; :::; q_{n}; p_{1}; :::; p_{n}) = \sum_{i=1}^{X^{n}} \frac{1}{2} p_{i}^{2} + \sum_{i=1}^{X^{n}} e^{q_{i} q_{i+1}}:$$

For the integrability of the system we refer to the classical paper of Flaschka [10]. Let us recall the bi-H am iltonian structure given in [6]. The $\,$ rst Poisson tensor in the hierarchy is the standard canonical sym plectic tensor, which we denote by e_0 , so that

$$fq_i;p_jg_0 = ij;$$

while the second Poisson tensor e_1 is determined by the relations

Then setting $h_1 = p_1 + p_2 + f$, pw e obtain the biH am iltonian form ulation:

$$e_0^1 dh_2 = e_1^1 dh_1$$
:

If we set, as usual,

$$N = e_1^{j} (e_0^{j})^{-1};$$

then a small computation gives the following multi-Hamiltonian formulation:

Proposition 16. The Toda hierarchy adm its the multi-Ham iltonian formulation:

$$e_{i}^{1}dh_{2} = e_{i+2}^{1}dh_{0};$$

where $h_0 = \frac{1}{2} \log (\det N)$ and h_2 is the original H am iltonian (12).

4.5.2. Toda lattice in Flaschka coordinates. Let us recall the Flaschka coordinates $(a_1; ...; a_{n-1}; b_1; ...; b_n)$ where:

$$\begin{array}{lll} b_i = \; p_i \text{;} & (i = \; 1 \text{;:::;} n) \\ \\ a_i = \; e^{q_i \quad q_{i+\; 1}} \; \text{;} & (i = \; 1 \text{;::::;} n \quad \; 1) \end{array}$$

In these new coordinates there is no recursion operator anym ore (this is a singular change of coordinates, where we loose one degree of freedom). Nevertheless, the multi-Ham iltonian structure does reduce ([6]). One can then compute the modular vector elds of the reduced Poisson tensors $\bar{}_j$ relative to the standard volume form:

It turns out that the modular vector $\,$ elds X $^{\rm j}$ are H am iltonian vector $\,$ elds w ith H am iltonian function

$$h = log(a_1 n q) + jlog(det(L));$$

where L is the Lax matrix. This is observed in [1], where one also nds the multi-Ham iltonian formulation:

with $h_j = \frac{1}{3} \operatorname{TrL}^j$ for $j \in 0$ and $h_0 = \ln (\det(L))$.

We would like to give now an intrinsic explanation for these form ulas, similar to the one given above for the Toda chain in physical coordinates.

4.5.3. Toda lattice in extended Flaschka coordinates. Let us extend the Flaschka coordinates by considering a variable a_n de ned by:

$$a_n := q_n$$

Then the transform ation $(q_i; p_i)$ 7 $(a_i; b_i)$ is a honest change of coordinates. In these extended F laschka coordinates, the rst Poisson tensor e_0 is determined by:

$$fa_i;b_ig_0 = a_i;$$
 (i = 1;:::;n 1)
 $fa_i;b_{i+1}g_0 = a_i;$ (i = 1;:::;n 1)
 $fa_n;b_ng_0 = 1:$

while the second Poisson e₁ structure is given by:

$$fa_{i}; a_{i+1}g_{1} = a_{i}a_{i+1}; (i = 1; :::; n 1)$$

$$fa_{i}; b_{i}g_{1} = a_{i}b_{i}; (i = 1; :::; n 1)$$

$$fa_{n}; b_{n}g_{1} = b_{n}$$

$$fa_{i}; b_{i+1}g_{1} = a_{i}b_{i+1}; (i = 1; :::; n 1)$$

$$fb_{i}; b_{i+1}g_{1} = a_{i}; (i = 1; :::; n 1)$$

In these coordinates, we still have the N ijenhuis tensor, relating the various Poisson tensors in the hierarchy.

The submanifold R $^{2n-1}-R^{2n}$ de ned by $a_n=0$ is a Poisson submanifold for all Poisson tensors in the hierarchy, so that the biH am iltonian structure reduces to this submanifold, and yields the biH am iltonian formulation for the Toda lattice in Flaschka coordinates. However, the tangent space to this submanifold is not left invariant by the Nijenhuis operator N, and on R $^{2n-1}$ we do not have an induced PN-structure.

A nother way of expressing these facts is to observe that the involutive diecomorphism $:R^{2n} ! R^{2n}$ de ned by:

$$(a_1; ...; a_n; b_1; ...; b_n) = (a_1; ...; a_n; b_1; ...; b_n);$$

is a Poisson di eom orphism for all Poisson structures. Hence, the group $Z_2=fI;\ g$ acts by Poisson di eom orphisms on R 2n , for all Poisson structures. It follows that its x point set, which is just R $^{2n-1}$, has induced Poisson brackets (see the Poisson Involution Theorem in [9, 19]), and these form the hierarchy in Flaschka coordinates.

4.5.4. Toda lattice on a Lie algebroid. We now consider the following biH am iltonian formulation on a Lie algebroid.

We let $A=R^{2n-1}$ R^{2n-1} R^{2n-1} be the trivial vector bundle with ber R^{2n} . We denote by $fe_1; \ldots; f_n; f_1; \ldots; f_n; g$ a basis of global sections and we let $(a_1; \ldots; a_{n-1}; b_1; \ldots; b_n)$ be global coordinates on the base. Now we de ne a Lie algebroid structure by declaring that the bracket satis es:

$$[e_i;e_j]_A = [f_i;f_j]_A = [e_i;f_j]_A = 0;$$

and that the anchor is given by:

$$A_{A}(e_{i}) = \frac{e}{e_{a_{i}}}$$
 (i = 1;:::;n 1) $A_{A}(e_{n}) = 0$
 $A_{A}(f_{i}) = \frac{e}{e_{a_{i}}}$ (i = 1;:::;n):

Notice that $(A;[;]_A;_A)$ is just the trivial extension of Lie algebroids:

$$0 \longrightarrow L_R \longrightarrow A \longrightarrow TR^{2n-1} \longrightarrow 0$$

where L_R denotes the trivial line bundle over R^{2n-1} .

Now on A we can de ne the following Poisson tensors:

$$\begin{array}{l} & \mathbb{X} & ^{1} \\ & = & a_{i}e_{i} \wedge (f_{i} - f_{i+1}) + e_{n} \wedge f_{n} \\ & \stackrel{i=1}{=} & \mathbb{X} & ^{2} \\ & = & a_{i}a_{i+1}e_{i} \wedge e_{i+1} - a_{n-1}e_{n-1} \wedge e_{n} + \sum_{i=1}^{N} & a_{i}e_{i} \wedge (b_{i}f_{i} - b_{i+1}f_{i+1}) \\ & \stackrel{i=1}{=} & \mathbb{X} & ^{1} \\ & + & b_{n}e_{n} \wedge f_{n} - a_{i}f_{i} \wedge f_{i+1} ; \end{array}$$

These Poisson structures on A cover ordinary Poisson structures on the base R^{2n-1} , which are just the Poisson structures $\bar{}_0$ and $\bar{}_1$ of the Toda lattice, in Flaschka coordinates.

Since $_{0}$ is symplectic, the Poisson tensors on A are associated with a PN-algebroid structure. By our main theorem , they give rise to an integrable hierarchy on A

 $j = -\frac{1}{j} dh_3$ j : k 2 Z

In this hierarchy the H am iltonians di erby a factor of 2 relative to the H am iltonians in the multi-H am iltonian formulation of the Toda lattice given by P roposition 16. A lthough the hierarchy in the Lie algebroid is generated by a N ijenhuis operator, it is well known that this is not the case with the Toda lattice in the base m anifold.

5. Examples

In this section, we consider 3 examples that illustrates the results above. The rst two examples are the two extreme cases of (i) a Lie algebra over a point A=g and (ii) the tangent bundle of a manifold A=TM. The third example, is the Lie algebroid connected with dynamical R-m atrices, which is a product of a tangent Lie algebroid and a Lie algebra, therefore combining aspects of both.

5.1. Lie algebras. Let g be a nite dimensional Lie algebra, considered as a Lie algebroid over a one point space, and let N be a Nijenhuis operator compatible with a Poisson tensor $2 \times X^2$ (g).

The modular class of g is given by the adjoint character (see, e.g., [17]):

$$_{g}(X) = Tr(ad_{X}); X 2 g:$$

where ad denotes the adjoint representation of g.

Now we consider a Nijenhuis tensor N: g! g, i.e., a linear map such that:

(13)
$$N N X; Y + N X; N Y N Y N Y N X; N Y = 0; 8X; Y 2 g:$$

This allows us to deform the Lie bracket on g to the new Lie bracket:

$$[X;Y]_N := [NX;Y] + [X;NY] \quad N[X;Y]; \quad X;Y 2 g$$
:

The new Lie algebra $g_N = (g; [;]_N)$ (again viewed as Lie algebroid over a point) has modular class:

$$q_N$$
 (X) = Tr(ad_x^N); X 2 g:

where ad^N denotes the adjoint representation of g_N . Since the base manifold is a single point, Proposition 4 says $sin\ p\,ly$ that:

$$g_N = N g$$
;

which of course maybe checked directly. Sim ilarly, by iteration, we have:

$$g_{Nk} = N^k g$$
:

Let us denote by r:g! g the skew-symmetric linear transformation determined by the bivector $2 \times X^2$ (g). The condition that is Poisson is just the condition that r is a solution of the Classical Yang-Baxter Equation:

$$[\mathbf{r};\mathbf{r}] = 0$$

For this reason, in this example we suppress any mention to the Poisson structure, and we use instead the notation r, a solution of (14). We have also a Lie bialgebra structure (q; q), and the bracket on q is given by:

$$[;] = [;]_r = ad(r())$$
 ad(r());; 2 g:

where ad denotes the coadjoint representation of g. The m odular class of g is given by

$$_{g}$$
 () = Tr(ad^r); 2 g;

where ad^r is the adjoint representation of $(g; [;]_r)$.

Let us assume now that we have a triple (g;r;N). Under the compatibility assumptions,

(15) N
$$r = r$$
 N and $[ad_r; N]() = ad_r; N$ (); ; 2 g;

where [;] denotes the usual commutator of operators, we obtain a PN-algebroid (g;r;N), with zero anchor (since the base manifold is a single point). Then N de nes a sequence of modular form s on g, which are associated with the higher brackets on g, and are just related by:

$$g_{N^k} = N^k g_N$$
:

This is just an algebraic relation which must be satisfied by any pair of linear maps N and rwhich satisfy the algebraic equations (13), (14) and (15).

O byiously, in this case Theorem 9 says nothing, since every function is constant.

5.2. Tangent bundles. Let us consider now the case of A = TM , the tangent bundle of som e m anifold M . Since the anchor on A is the identity m ap, P roposition 4 yields the following result of [8]:

P roposition 17. The modular class of (TM ;[; $_{
m N}$; $_{
m N}$) is the cohomology class represented by the 1-form d (TrN).

Now a Poisson-Nijenhuis structure on A is just an ordinary Poisson-Nijenhuis manifold (M; N). Note, however, that the modular vector eld associated with a Poisson manifold, as originally de ned by Weinstein in [17], diers from TM; by a factor of 1=2. For this reason, the modular class of a Poisson-Nijenhuis manifold was de ned in [8] as

$$X_{(N;)} = \frac{1}{2}_{TM_N} \frac{1}{2}N_{TM} = \frac{1}{2}d$$
 (TrN):

Then Theorem 9 im m ediately yields the main result of [8]:

Theorem 18. Let (M; ;N) be a Poisson-Nijenhuis manifold and assume that N is non-degenerate. Then the modular vector eld X_N is bi-Hamiltonian and hence determines a hierarchy of ows which are given by:

$$X_{i+j} = \int_{i}^{1} dh_{j} = \int_{i}^{1} dh_{i}$$
 (i; j 2 Z)

where

$$h_0 = \frac{1}{2} \log(\det N); \quad h_i = \frac{1}{2i} TrN^i \quad (i \in 0):$$

In [8] the authors show that m any known hierarchies of integrable systems can be obtained in this manner, therefore providing a new approach to the integrability of those systems.

5.3. D ynam ical Lie A lgebroid. Let us start by describing the Lie bialgebroids that arise in connection with the dynam ical Yang-Baxter equation.

Let g be a Lie algebra and h g an abelian Lie subalgebra of dimension l. We let A = Th g be the direct product of Lie algebroids, where Th is the tangent algebroid of the manifold h and g is viewed as a Lie algebroid over a point. More explicitly, the anchor: Th g! Th is the projection on the rst factor, while the bracket between two sections of A is given by:

$$[(v;f); (w;g)]_A = ([v;w];v(g) w(f) + [f;g]_g);$$

where v; w 2 X (h) are vector elds in h and f; g:h! g are smooth g-valued functions on h

Let fh_1 ;::: h_1g be a basis of h and $(q_1$;::: $;q_1$) the dual system of linear coordinates on h . Then we have a constant bivector eld $_0$ 2 X^2 (A) de ned by:

$$_{0}=\sum_{i=1}^{X^{1}}h_{i}^{2} \frac{\theta}{\theta q_{i}}$$
:

Since h is an abelian subalgebra of g, it follows that $_0$ is in fact a Poisson structure on A . Now we recall (see [4]):

De nition 19. A triangular dynamical r-matrix on g is an h-equivariant function r:h ! g g satisfying the classical dynamical Yang-Baxter equation

Its well known (see [2, 18]) that any triangular dynam ical r-m atrix on g, de nes a new Poisson bivector on the Lie algebroid A by:

$$_{r}(q) = \sum_{i=1}^{X^{1}} h_{i} \wedge \frac{e}{eq_{i}} + r(q)$$
:

Thus r determ ines a Lie bialgebroid structure on (A;A). The Lie bracket on the sections of A is given by

$$\begin{array}{lll} h_{q} ; h_{q}^{0} & = & 0 \\ [\textbf{"}_{q} ; h_{q}] & = & ad_{h_{q}} \textbf{"}_{q} \\ & \textbf{"}_{q} ; \textbf{"}_{q}^{0} & = & ad_{\textbf{r}_{q}} \textbf{"}_{q}^{0} + ad_{\textbf{r}_{q}^{0}} \textbf{"}_{q} + d\textbf{r}(\textbf{"}_{q}; \textbf{"}_{q}^{0}); \end{array}$$

for h_q ; h_q^0 2 h and $\textbf{"}_q$; $\textbf{"}_q^0$ 2 g , where ad $\,$ is the co-adjoint representation of g

$$had_x$$
 "; Y i = h"; [X ; Y]i; X ; Y 2 q; " 2 q :

The modular class of the Lie algebroid A is represented by

where r(q) is the 1-cocycle on g de ned by the anti-sym m etric bivector r(q).

Now, if N is a Nijenhuis operator on A compatible with $_{\rm r}$, then the modular vector eld of this Poisson-Nijenhuis Lie algebroid is

$$d_{r}(TrN) = d_{0}(TrN) = X^{1} \frac{\theta TrN}{\theta q_{i}} \frac{\theta}{\theta q_{i}}$$
