# OPERATOR ALGEBRAS FOR MULTIVARIABLE DYNAM ICS

#### KENNETH R.DAVIDSON AND ELIAS G.KATSOULIS

Abstract. Let X be a locally compact Hausdor space with n proper continuous self maps  $_i:X:X:X$  for 1 in. To this we associate various topological conjugacy algebras; and two emerge as the natural candidates for the universal algebra of the system, the tensor algebra A (X;) and the semicrossed product  $C_0(X)$   $F_n^+$ . The C\*-envelope of A (X;) is the Cuntz-P im sner algebra C (X;) as defined by Katsura.

We introduce a new concept of conjugacy for multidimensional systems, which we coin piecewise conjugacy. We prove that the piecewise conjugacy class of the system can be recovered from either the algebraic structure of A (X;) or C $_0$ (X)  $F_n^+$ . Various classication results follow as a consequence. For example, for n=2;3, the tensor algebras are (algebraically or even completely isometrically) isomorphic if and only if the systems are piecewise topologically conjugate.

We de neageneralized notion of wandering sets and recurrence. Using this, it is shown that A (X; ) or C  $_0$  (X)  $F_n^+$  is sem isimple if and only if there are no generalized wandering sets. In the metrizable case, this is equivalent to each  $\ _i$  being surjective and v-recurrent points being dense for each v 2  $F_n^+$ .

#### 1. Introduction

Let X be a locally compact Hausdor space; and suppose we are given n proper continuous selfmaps  $_i:X$ ! X for 1 i n, i.e., a multivariable dynamical system. This paper is the rst attempt to develop a theory of conjugacy algebras for such multivariable dynamical systems, with one of the goals being the association of the dynamics of the multivariable systems to fundamental areas of study within operator algebra theory. One of the main outcomes of this work is that the classication and representation theory of conjugacy algebras is intimately connected to piecewise conjugacy and generalized recurrence for multivariable systems. These concepts appear to be new in multivariable dynamical system theory and are rst studied in this paper.

We discover a variety of new operator algebras. For the system of a single map , there is a single prototypical example, the sem icrossed product of the system, rst introduced by Arveson [1] but form ally studied by Peters [37]. As we shall see, the case n>1 o ers a far greater diversity of examples and it seems that there are various non-isom orphic algebras that can serve as a prototype for the conjugacy algebra of the system. The algebras will contain an isometric copy of  $C_0\left(X\right)$ . Plus they need to contain generators  $s_i$  which encode the covariance relations of the maps  $_i$ . In addition, it is necessary to impose norm conditions to be able to talk about a universal operator algebra for the system. The choice of these conditions creates more than one natural universal operator algebra. Ideally, the properties of the algebra should reject properties of the system. Based on that, we isolate two natural choices for the appropriate universal operator algebra for the system.

The two choice that we focus on are the case in which the generators are either isometric, producing the sem icrossed product, or row isometric, producing the tensor algebra. We develop an appropriate dilation theory for each. This is both more straightforward and more satisfying in the case of the tensor algebra, where it turns out to be a C\*-correspondence in the sense of Muhly and Solel [30]. This enables us to exploit their work, and work of K atsura [22] and K atsoulis (K ribs [21], in order to describe the C\*-envelope of the tensor algebra.

In the sem icrossed product situation, one needs to work harder to achieve what we call a full dilation. This turns out to be both orthogonally injective and projective, and by another result of Muhly and Solel [29], these representations turn out to be boundary representations in the sense of Arveson [2] except that they need not be

irreducible. This allows us to show that generally these algebras are not C\*-correspondences.

In [17], H adw in and H oover considered a rather general class of conjugacy algebras associated to a single dynamical system. In [8], we re ned these axioms for the B anach algebra category. By viewing conjugacy algebras as equivalent if they arise from conjugate systems, we were able to show that the conjugacy class of the system forms a complete invariant for algebraic isomorphisms between equivalence classes of conjugacy algebras. In this paper, we are taking a more restrictive view in order to focus on the most natural candidates. Nevertheless, the ideas of [8] will play a crucial role in the analysis of our algebras.

It is also natural to ask that there be an expectation of these operator algebras onto the diagonal  $C_0$  (X ). In both cases which we consider, such an expectation is available. This leads, among other things, to the notion of a Fourier series for elements of these algebras. This is a useful tool for establishing automatic continuity of algebraic isomorphisms among this class of algebras.

In Section 7, following the techniques of H adw in {H oover [17] and our techniques in [8] for the one variable case, we describe the characters and the nest representations into the algebra  $T_2$  of 2 2 upper triangular m atrices. In Section 8 we introduce a new concept in dynam ical system theory, piecewise conjugacy, and we study its elementary properties. The results in both these sections are mostly preparatory for the results of the subsequent section.

In Section 9, we prove the classi cation theorem s. Working in the multivariable setting, one often comes up against issues in multivariable algebra or analysis. Here we not that we need to exploit properties of analytic varieties. Theorem 9.2 allows us to recover the dynamical system up to piecewise conjugacy. Essentially one can determine the system locally, that is, on some neighbourhood of each point of X; but the pairing between the two systems can change from one open set to the next. This works on both the tensor algebra and the semi-crossed product. In order to establish the converse in certain cases, we not that we need topological information about the unitary group which limits the dimension of systems where we are able to obtain a complete invariant. However for n = 2 or 3, or when X is 0 or 1 dimensional, we show that piecewise conjugacy is a complete invariant up to either algebraic or completely isometric isomorphism. We state a conjecture regarding the general situation.

In the case of a single map, the radical of the sem icrossed product has been studied [27, 37] and nally was completely characterized by

Donsig, Katavolos and Manoussos [9] using a generalized notion of recurrence. In Section 10, we introduce a generalized notion of wandering set for a dynamical system which is appropriate for a non-commutative multivariable setting such as ours. This is related to a generalized notion of recurrence, and are equivalent in the metrizable setting.

These topological notions are exploited in the last section to characterize when the tensor algebra and the sem icrossed product are sem isim – ple in terms of the dynamics. The more general issue of describing the radical remains an interesting open problem.

Finally we mention that the ideas of this paper may be applied to dynamical systems with relations among the continuous maps. This issue will be explored in another paper.

## 2. Universal Operator Algebras

We now discuss the choice of an appropriate covariance algebra for themultivariable dynamical system (X;). An operator algebra encoding (X;) should contain  $C_0(X)$  as a  $C^*$ -subalgebra, and there should be n elements  $s_i$  satisfying the covariance relations

$$fs_i = s_i(f_i)$$
 for  $f 2 C_0(X)$  and  $1 i n s$ 

This relation shows that  $s_{i_k} \, f_k \, s_{i_{k-1}} \, f_{k-1} ::: s_{i_1} \, f_1 = s_w \, g$  where we write  $s_w = s_{i_k} \, s_{i_{k-1}} ::: s_{i_k}$  and g is a certain product of the  $f_j$ 's composed with functions built from the  $_i$ 's. Thus the set of polynomials in  $s_1$ ;:::; $s_n$  with coe cients in C  $_0$  (X ) forms an algebra which we call the covariance algebra A  $_0$  (X ; ). The universal algebra should be the (norm-closed non-selfad joint) operator algebra obtained by completing the covariance algebra in an appropriate operator algebra norm.

O beerve that in the case of compact X,  $A_0$  (X; ) is unital, and will contain the elements  $s_i$  as generators. When X is not compact, it is generated by  $C_0$  (X) and elements of the form  $s_i$ f for f 2  $C_0$  (X).

By an operator algebra, we shall mean an algebra which is completely isometrically isomorphic to a subalgebra of B (H) for some Hilbert space H. By the Blecher (Ruan (Sinclair Theorem [6], there is an abstract characterization of such algebras. See [5, 36] for a thorough treatment of these issues. Our algebras are suciently concrete that we will not need to call upon these abstract results. Nevertheless, it seems more elegant to us to de ne universal operator algebras abstractly rather than in terms of specic representations.

An operator algebra claim ing to be the operator algebra of the system must be universal in some way. This requires a choice of an appropriate norm condition on the generators. A few natural choices are:

- (1) Contractive: ksik 1 for 1 i n.
- (2) Isom etric:  $s_i s_i = I$  for 1 i n.
- (3) Row Contractive:  $s_1 s_2 ::: s_n 1$ .
- (4) Row Isometric:  $s_1 \ s_2 \ \dots \ s_n$  is an isometry; i.e.  $s_i \ s_j = ij$  for  $1 \ ij \ n$ .

One could add variants such as unitary, co-isom etric, column contractive, etc.

In the one variable case, all of these choices are equivalent. Indeed, the SzN agy isometric dilation of a contraction is compatible with extending the representation of  $C_0(X)$ . This leads to the semi-crossed product introduced by Peters [37]. Various non-selfadjoint algebras associated to a dynamical system (with one map) have been studied [1, 4, 25, 17, 40, 27, 9].

But once one goes to several variables, these notions are distinct, even in the case of commutative systems. For example, with three or more commuting variables, examples of Varopoulos [42] and Parrott [35] show that three commuting contractions need not dilate to three commuting isometries. However a dilation theorem of Drury [12] does show that a strict row contraction of norm uting operators dilates to (a multiple of) Arveson's d-shift [3]. While this is not an isometry, it is the appropriate universal commuting row contraction.

For non-commuting variables, where there is no constraint such as commutativity, one could dilate the nontractions to isometries separately. We shall see that this can be done while extending the representation of  $C_0$  (X) to maintain the covariance relations. Also for the row contraction situation, there is the dilation theorem of Frahzo (Bunce (Popescu [13, 7, 39] which allows dilation of any row contraction to a row isometry. Again we shall show that this can be done while extending the representation of  $C_0$  (X) to preserve the covariance relations.

De nition 2.1. A locally compact Hausdor space X together with n proper continuous maps  $_{\rm i}$  of X into itself for 1  $_{\rm i}$  n will be denoted by (X; ). We shall refer to this as a multivariable dynamical system . It will be called metrizable if X is metrizable.

We now do not the two universal operator algebras which we will associate to (X; ). We justify the nomenclature below.

De nition 2.2. Given a multivariable dynamical system (X;), dene the tensor algebra to be the universal operator algebra A (X;) generated by  $C_0$  (X) and generators  $s_1; \ldots; s_n$  satisfying the covariance relations

$$fs_i = s_i (f_i)$$

and satisfying the row contractive condition  $s_1 \ s_2 \ ::: \ s_n \ 1:$  Sim ilarly, we de ne the sem icrossed product to be the universal operator algebra  $C_0$  (X )  $F_n^+$  generated by  $C_0$  (X ) and generators  $s_1$ ; :::;  $s_n$  satisfying the covariance relations and satisfying the contractive condition  $ks_ik$  1 for 1 in.

We will not belabour the set theoretic issues in de ning a universal object like this, as these issues are familiar. Su ce to say that one can x a single Hilbert space of su ciently large dimension, say  $@_0 \not X \not j$  on which we consider representations of  $C_0 (X)$  and the covariance relations. Then one puts the abstract operator algebra structure on  $A_0 (X; )$  obtained by taking the supremum over all (row) contractive representations. A lternatively, one forms the concrete operator algebra by taking a direct sum over all such representations on this xed space.

A case can be made for preferring the row contraction condition, based on the fact that this algebra is related to other algebras which have been extensively studied in recent years. If X is a countable discrete set, then the row contractive condition yields the graph algebra of the underlying directed graph that forgets which map i is responsible for a given edge from x to i(x). In the general case, this turns out to be a C\*-correspondence algebra, or tensor algebra, as de ned by M uhly and Solel [30]. It is for this reason that we call this algebra the tensor algebra of the dynam ical system. As such, it sits inside a related C untz{P in sner C\*-algebra [38], appropriately de ned and studied by K atsura [22] building on an important body of work by M uhly and Solel beginning with [30, 31]. This C untz-P in sner algebra turns out to be the C\*-envelope [2, 16] of the tensor algebra [30, 15, 19]. The C\*-envelope of the tensor algebra is therefore always nuclear.

We may consider the dynamical system (X; ) as an action of the free sem igroup  $F_n^+$ . The free sem igroup  $F_n^+$  consists of all words in the alphabet f1;2;:::;ng with the empty word? as a unit. For each  $w=i_ki_{k-1}:::i_1$  in  $F_n^+$ , let  $_w$  denote the map  $_{i_k}$   $_{i_{k-1}}$   $_{i_1}$ . This sem igroup of endom orphisms of X induces a family of endom orphisms of  $C_0(X)$  by  $_w(f)=f_w$ . The map taking  $w\in F_n^+$  to  $_w$  is an antihom om orphism of  $F_n^+$  into End( $C_0(X)$ ); i.e.  $_{v=w}=_{wv}$  for  $v_i^*w\in F_n^+$ .

This leads us to consider the contractive condition, which is the same as considering contractive covariant representations of the free sem igroup. Hence we call the universal algebra the sem i-crossed product C  $_0$  (X )  $F_n^+$  of the dynamical system . It also has good properties. However we do not not this algebra as tractable as the tensor algebra.

Indeed, several problems that are resolved in the tensor algebra case remain open for the semicrossed product. In particular, it offen occurs (see Proposition 6.10) that the C\*-envelope of the semicrossed product is not nuclear.

In both cases, the (row) contractive condition turns out to be equivalent to the (row) isometric condition. This is the result of dilation theorem s to extend (row) contractive representations to (row) isometric ones. These are analogues of a variety of well-known dilation theorem s. The tensor algebra case is easier than the sem icrossed product, and in addition, there is a nice class of basic representations in this case that determ ine the universal norm. In the case of the crossed product, one needs to introduce the notion of a full isometric dilation; and these turn out to yield the (not necessarily irreducible) boundary representations of the C\*-envelope.

# 3. Dilation for the Tensor Algebra

We rst consider a useful family of representations for the tensor algebra analogous to those used by Peters [37] to de ne the semicrossed product of a one variable system.

By Fock space, we mean the Hilbert space  $^{\circ}$  ( $F_n^+$ ) with orthonormal basis  $f_w$ : w 2  $F_n^+$ g. This has the standard left regular representation of the free sem igroup  $F_n^+$  de ned by

Consider the following Fock space representations of (X; ). Fix x in X. De nea -representation  $_{x}$  of C  $_{0}$  (X) on F  $_{x}$  =  $^{12}$  (F  $_{n}^{+}$ ) by  $_{x}$  (f) = diag(f( $_{w}$ (x))), i.e.

Send the generators  $s_i$  to  $L_i$ , and let  $L_x = L_1$  :::  $L_n$  . Then (  $_x$ ;  $L_x$ ) is easily seen to be a covariant representation.

De ne the fullFock representation to be the (generally non-separable) representation (;L) where =  $_{x2X}$  x and L =  $_{x2X}$  L<sub>x</sub> on F<sub>X</sub> =  $_{x2X}$  F<sub>x</sub>. We will show that the norm closed algebra generated by (C<sub>0</sub>(X)) and (C<sub>0</sub>(X))L<sub>i</sub> for 1 i n is completely isometric to the tensor algebra A(X;). When X is separable, a direct sum over a countable dense subset of X will yield a completely isometric copy on a separable space.

Now we turn to the dilation theorem, which is straight-forward given our current know ledge of dilation theory. When the dynam ical system is surjective, this is closely related to [30, Theorem 3.3].

Theorem 3.1. Let (X; ) denote a multivariable dynamical system. Let be a -representation of  $C_0$  (X) on a Hilbert space H, and let  $A=A_1$ ::  $A_n$  be a row contraction satisfying the covariance relations

Then there is a Hilbert space K containing H, a -representation of  $C_0(X)$  on K and a row isometry  $S_1$  :::  $S_n$  such that

- (i)  $(f)S_i = S_i$   $(f_i)$  for  $f 2 C_0 (X)$  and 1 i n.
- (ii) H reduces and  $(f)_{ij} = (f)$  for  $f 2 C_0(X)$ .
- (iii) H? is invariant for each  $S_{i}$ , and  $P_{H} S_{i} j_{H} = A_{i}$  for 1 i n.

Proof. The dilation of A to a row isometry S is achieved by the Frahzo {Bunce{Popescu dilation [13, 7, 39]. Consider the Hilbert space K = H  $^{\circ 2}$  (F<sub>n</sub> ) where we identify H with H C  $_2$ . Following Bunce, consider A as an operator in B (H  $^{(n)}$ ; H ). Using the Schae er form of the isometric dilation, we can write D = (I<sub>H</sub> I<sub>n</sub> A A)<sup>1=2</sup> in B (H  $^{(n)}$ ) and I<sub>H</sub> L = I<sub>H</sub> L<sub>1</sub> ::: I<sub>H</sub> L<sub>n</sub>. We make the usual observation that (C  $_2$ ) is identified with  $^{\circ 2}$  (F<sub>n</sub> ) in such a way that L<sub>i</sub>j<sub>C  $_2$ </sub>)? 'L<sub>i</sub> for 1 i n.

Combining these two identities yields the desired covariance relation for (;S).

The other properties of the dilation are standard.

R em ark 3.2. If one wishes to obtain the m inim aldilation, one restricts to the sm allest subspace containing H which reduces and each  $S_i$ . The usual argum ent establishes uniqueness.

C orollary 3.3. Every row contractive representation of the covariance algebra dilates to a row isometric representation.

We now relate this to the special Fock space representations. It was an observation of Bunce [7] that the dilation S of A is pure if  $kA\,k=\,r<\,1$ , where pure means that S is a multiple of the left regular representation L. In this case, the range N  $_0$  of the projection P  $_0$  = I  $_{i=\,1}^n S_i S_i$  is a cyclic subspace for S .

The spectral theorem shows that  $_0$  is, up to multiplicity, a direct integral of point evaluations. Thus it follows that the representation (;S) is, in a natural sense, the direct integral of the special Fock space representations. Thus its norm is dominated by the norm of the full Fock representation.

As a consequence, we obtain:

Corollary 3.4. The full Fock representation is a faithful completely isometric representation of the tensor algebra A (X; ).

Proof. By de nition, if  $T = {P \choose w \, 2F_n^+} s_w \, f_w$  belongs to  $A_0 \, (\!X \, ; \, )$  (i.e.  $f_w = 0$  except nitely often), its norm in  $A_0 \, (\!X \, ; \, )$  is determined as

$$kT k := \sup_{w \ge F_n^+} X$$

over the set of all row contractive representations (;A). Clearly, we can instead sup over the set (;rA) for 0 < r < 1; so we may assume that kAk = r < 1. Then arguing as above, we see that (;A) dilates to a row isometric representation (;S) which is a direct integral of Fock representations. Consequently the norm

Thus the full Fock representation is completely isometric, and in particular is faithful.

R em ark 3.5. Indeed, the same argument shows that a faithful completely isometric representation is obtained whenever  $_0$  is a faithful representation of  $C_0$  (X). Conversely a representation  $_0$  on H induces a Fock representation on K = H  $^{\varrho}$  ( $F_n^+$ ) by (f) = diag( $_0$  (f  $_w$ )). Then sending each  $s_i$  to  $I_H$   $L_i$  yields a covariant representation which is faithful if  $_0$  is.

So now we can make some preliminary comments on the C\*-envelope C (X; ) of A (X; ). We denote the generators which are the images of  $s_i$  by  $s_i$ , and we consider  $C_0$  (X) as a subalgebra. This is a quotient of the full Fock representation. Consequently, the generators determine an isometry  $s=s_1$ :::  $s_n$ . Thus the isometries  $s_i$  have pairwise orthogonal range. So they satisfy  $s_j s_i = i_j$ . It is routine to verify now that the elements which are nite sums of the form  $v_{v,w} \, 2F_n^+ \, s_v \, f_{v,w} \, s_w$  form a dense —subalgebra of C (X; ).

## 4. Fourier Series and Automatic Continuity

Since the tensor algebra has a universal property, it is evident that whenever (;S) satis es the covariance relations and the row contractivity  $S_1$ :::  $S_n$  1, then so does (; S) for = (i) 2  $T^n$ , where  $S = {}_1S_1$ :::  ${}_nS_n$ . Therefore the map which sends the generators  $s_i$  of A (X; ) to  ${}_is_i$  and xes C  ${}_0$ (X) extends to a -autom orphism of C (X; ) which xes A (X; ). In particular, if  ${}_i = z$  2 T for 1 i n, we obtain the gauge autom orphism s  ${}_z$  that are a key tool in many related studies.

One im mediate application is standard:

Proposition 4.1. The map E (a) =  $_{z}$  (a) dz is a completely contractive expectation of A (X; ) onto  $C_{0}$  (X).

Proof. It is routine to check that the map taking z to  $_z$  (a) is norm continuous. Check this on  $A_0$  (X; ) rst and then approximate. So E (a) makes sense as a Riemann integral. Now computing E on the monomials  $s_w$  f shows that E (f) = f and E ( $s_w$  f) = 0 for w f ? . As this map is the average of completely isometric maps, it is completely contractive.

O bserve that in the Fock representation, one can see the expectation as the compression to the diagonal. The map E as defined above makes sense for any element of C (X; ). However the range is then not  $C_0(X)$ , but rather the span of all words of the form  $s_v f s_w$  for jvj=jwj. We will make use of this extension below. It is also clear from this representation that one can read of the Fourier coeficients of elements of A (X; ). This is computed within the universal C\*-algebra as follows:

These Fourier coe cients do not seem to be obtainable from an integral using invariants of A (X; ) without passing to the C\*-algebra. This means that they are less accessible than in the singly generated case. A partial recovery is the following. For k 0, de ne

An improtant feature of the Fourier series expansion is that if all the Fourier coe cients of a 2 A (X; ) are zero, then a = 0. This is a key property in establishing automatic continuity for isomorphisms between tensor algebras.

# 5. C \*-correspondences and the C \*-envelope

In this section, we identify the tensor algebra with the tensor algebra of a C\*-correspondence in the sense of P in sner [38], M uhly {Solel [30] and K atsura [22]. This will enable us to consider A (X; ) as a subalgebra of a natural C\*-algebra which is the C\*-envelope of A (X; ).

De ne E=X n to the the union of n disjoint copies of the space X. We will view  $E=C_0(E)$  as a C\*-correspondence over  $C_0(X)$ . To this end, we need to de ne left and right actions of  $C_0(X)$  and de ne a  $C_0(X)$ -valued inner product. Let =(x;j) and denote elements of E, and E actions are given by

We will show that  $T_+$  (E) is completely isometrically isomorphic to A (X; ). In addition, we shall show that the enveloping C\*-algebra of A (X; ) in the full Fock representation is —isomorphic to T (E). Moreover, we will identify the quotient of T (E) which is the C\*-envelope of A (X; ). This will be an application of K atsura [22] and K atsoulis and K ribs [21]. To describe this quotient, we need some further description of the work of K atsura.

As usual, the set K (E) of compact multipliers is the ideal of elements of L (E) generated by the rank one elements ; for ; 2 E given by ; = h; i. In our case, ' ( $\mathbb{C}(X)$ ) is contained in K (E). To see this, given f 2 C<sub>0</sub>(X), factor f  $_{i} = g_{i}h_{i}$ . Then for  $_{i} = \binom{n}{j+1} k_{j} 2$  E,

Katsura's ideal for a C\*-correspondence E over a C\*-algebra A is de ned as

The space F (E) $J_E$  becomes a Hilbert C\*-module over  $J_E$ . Moreover K (F (E) $J_E$ ) is spanned by terms of the form  $_f$ ; where ; 2 F (E) and f 2  $J_E$ . He shows that this is an ideal in T (E). The quotient O (E) = T (E)=K (F (E) $J_E$ ) is the Cuntz{P im sner algebra of E. (Note that in Muhly{Solel [30], this is called the relative Cuntz-P im sner algebra O ( $J_E$ ;E). However the crucial role of this particular ideal  $J_E$  is due to K atsura.)

A representation of a C\*-correspondence E consists of a linear map to fE into B (H) and a -representation of  $C_0$  (X) on H such that

There is a universal C\*-algebra  $T_E$  generated by such representations, and K atsura [22, P rop.6.5] shows that the universal C\*-algebra is isomorphic to T (E).

There is again a universal  $C^*$ -algebra  $O_E$  for reduced representations of E. This algebra is shown to be —isom orphic to O(E) 22, Prop. 6.5].

One says that C (;t) adm its a gauge action if there is a map of the circle T into Aut(C (;t)) such that  $_z$  ((f)) = (f) and  $_z$  (t()) = zt() for f 2 C<sub>0</sub> (X) and 2 E. The universal algebras have this property autom atically.

Every operator algebra is contained completely isometrically in a canonical minimal C\*-algebra known as its C\*-envelope. Muhly and Solel [30, Theorem 6.4] show that, when ' is injective, that the C\*-envelope of  $T_+$  (E) is O (E). This was further analyzed in [15]. In the non-injective case, this is done by K atsoulis-K ribs [19].

Theorem 5.1. Let (X; ) be a multivariable dynamical system, and let E be the associated C\*-correspondence. Then A (X; ) is completely isometrically isomorphic to the tensor algebra  $T_+$  (E). Consequently, the C\*-envelope of A (X; ) is —isom orphic to O (E).

P roof. The point is to observe that the Fock representations give rise to representations of E which are su cient to yield a faithful representation of  $T_E$ . Fix x 2 X . De ne a representation of E on  $F_x = \sqrt[2]{F_n^+}$  by

In particular, the quotient of T (E) by K (F (E)) is not injective on  $C_0$  (X).

## 6. Dilation and the Semi-crossed Product

In this section, we consider the contractive case. Again a routine modi cation of the classical theory yields a dilation to the isometric case. This will allow us to determ inecertain faithful representations of C  $_0$  (X )  $F_n^+$ .

P roposition 6.1. Let (X; ) denote a multivariable dynamical system. Let be a -representation of  $C_0(X)$  on a Hilbert space H, and let  $A_1; \ldots; A_n$  be contractions satisfying the covariance relations

The following result is a dilation in the spirit of unitary dilations, rather than isometric dilations, in that the new space contains H as a sem i-invariant subspace (rather than a coinvariant subspace).

This result requires the existence of a Borel cross section for the inverse of a continuous map, and that appears to require a separability condition. We were not able to not any counterexamples for huge spaces, but the case of most interest is, in any case, the metrizable one. Recall that a locally compact Hausdor space is metrizable if and only if it is second countable. In this case, it is also separable.

Theorem 6.5. Let (X; ) be a metrizable multivariable dynamical system. Every isometric covariant representation (;S) of (X; ) has a dilation to a full isometric representation in the sense that there is a Hilbert space K containing H, a —representation of G (X) and isometries  $T_1; \ldots T_n$  such that

So this is a contractive covariant representation of (X ; ). Hence it has an isometric dilation ( $_1$ ;T $^{(1)}$ ) on a Hilbert space K $_1$ . Moreover, by construction, the range of T $_i$  contains E ( $_i$ (X))H.

Repeat this procedure with the representation (  $_1$ ;T  $^{(1)}$ ) to obtain an isometric representation (  $_2$ ;T  $^{(2)}$ ) such that the range of  $T_i^{(2)}$  contains E  $_1$  (  $_i$ (X ))K  $_1$ . By induction, one obtains a sequence of dilations (  $_k$ ;T  $^{(k)}$ ) on an increasing sequence of H ilbert spaces K  $_k$  so that, at every stage, the range of  $T_i^{(k+1)}$  contains E  $_k$  (  $_i$ (X ))K  $_k$ .

Let K be the H ilbert space completion of the union of the K<sub>i</sub>. De ne a -representation of G (X) on K by  $\frac{1}{2}k_k = k_k$ , and set  $T_i \frac{1}{2}k_k = T_i^{(k)}$ . This is a full isometric dilation by construction.

Douglas and Paulsen [10] promoted the view that the Hilbert space H on which a representation (;S) is defined should be considered as a Hilbert module over  $C_0(X) = F_n^+$ . Muhly and Solel [28] have adopted this view. We are concerned with two notions where we use their more suggestive nomenclature. A Hilbert module K over an operator algebra A is orthogonally injective if every contractive short exact sequence

has a contractive splitting. Likew ise a Hilbert module Q is orthogonally projective if every such contractive short exact sequence has a contractive splitting. These notions explain the signicance of full dilations.

Proposition 6.6. Let (;A) be a contractive representation of the sem icrossed product  $C_0(X)$   $F_n^+$  on a Hilbert space H, considered as a Hilbert  $C_0(X)$   $F_n^+$  module.

- (1) H is orthogonally injective if and only if (; A) is a full isometric representation.
- (2) H is orthogonally projective if and only if (;A) is an isometric representation.

Proof. Suppose that H is an orthogonally injective Hilbert module. Let (;S) be a full dilation of (;A) on a Hilbert space M. The complement Q = H? together with the restriction  $\sim$  of and the compressions  $T_i = P_Q S_i j_Q$  is the quotient Hilbert module. So

is a contractive short exact sequence of H ilbert m odules. This splits, which implies that Q is invariant for each  $S_i$ . Fullness means that  $S_iS_i=E$  (  $_i(X)$ ), which means that

From this it follows that each  ${\tt A}_{\, {\scriptsize i}}$  is an isometry satisfying the fullness condition.

Conversely, suppose that (;A) is a full isom etric representation on H . Let  $0 \, ! \, H \, ! \, M \, ! \, Q \, ! \, 0$  be a contractive short exact sequence of H ilbert m odules. Let (;S) be the representation associated to M .

W rite  $S_i = \begin{pmatrix} A_i & B_i \\ 0 & D_i \end{pmatrix}$  with respect to M = H Q (as Hilbert spaces). Then

The fullness of (;S) asserts that E ( $_{i}(X)$ ) =  $A_{i}A_{i}$ . Hence  $B_{i}B_{i}$  = 0. Thus Q is invariant for S and so the natural injection of Q into M is a contractive module map. That is, H is orthogonally injective.

The second part is sim ilar. If (;A) is not isometric, then an isometric dilation does not split. Conversely, if (;A) is isometric and 0! K! M! H! 0 is a contractive short exact sequence, then again we write  $S_i = \begin{pmatrix} A_i & 0 \\ C_i & D_i \end{pmatrix}$  with respect to M = H K (as Hilbert spaces). The fact that  $A_i$  are isometries and  $S_i$  is a contraction ensures that  $C_i = 0$  and thus the sequence splits.

Muhly and Solel [29] relate this notion to Arveson's approach to dilation theory [2]. Any contractive representation of an algebra A dilates to a -representation of the C \*-envelope C (A) by Arveson's and Stinespring's Theorem s. It is easy to see that a representation which is orthogonally injective is, in fact, the restriction of a -representation. The converse is not true in general.

A rveson called an irreducible representation of the C\*-envelope a boundary representation if the restriction to A has a unique completely positive extension to C (A), namely the representation itself. Muhly and Solel proved that an irreducible representation of A is a boundary representation of A if and only if it is both orthogonally injective and orthogonally projective. Recently, Dritschel and McCullough [11]

completed a method of Arveson to show that the direct sum of all boundary representations yields a faithful representation of C (A).

Thus the set of irreducible full isom etric representations are su cient to determ ine the C \*-envelope of C  $_0$  (X )  $F_n^+$ . W e sum m arize this discussion as a corollary.

C orollary 6.7. The C\*-envelope of  $C_0(X)$   $F_n^+$  can be obtained as  $C(A_0(X;))$  where is the direct sum of all full isometric representations of  $A_0(X;)$  on a xed Hilbert space of dimension f(X) is separable and metrizable, then a separable Hilbert space will suce.

Exam ple 6.8. It is not clear to us how to write down a complete family of full isometric representations for the semicrossed product. But the theorem above suggests that one consider the full atomic representations as a natural candidate. For each x 2 X , let H  $_{\rm x}$  denote a non-zero H ilbert space such that

Interesting separable representations can be found by taking a dense countable subset Y such that  $_{i}(Y)$  Y and for every y 2 Y \  $_{i}(X)$ , Y \  $_{i}^{1}(x)$  is non-empty. Then build isom etries as above.

Unfortunately, the general structure of such representations appears to be very complicated. This makes it discult to describe the algebraic structure in the C \*-envelope.

There is an expectation E from the sem icrossed product onto  $C_0$  (X ). This is established exactly as in Proposition 4.1. The isometries in  $C_0$  (X )  $F_n^+$  do not have nice relations, so one cannot de ne the Fourier coe cients as easily as in the tensor algebra case. One can, though, de ne the projections  $_k$  onto the span of all words of length k in  $T_1$ ;:::; $T_n$ . This is a nite dimensional subspace spanned by these words, which form a basis. So in principle, there is a Fourier series

that can be determ ined in this way. Certainly the Cesaro means exist as nice integrals just as before. These are completely contractive maps into A $_0$ (X; ) which converge in norm for every element of C $_0$ (X)  $F_n^+$ . There is no analogue of Proposition 4.3. In particular, exactly the same proof as for Corollary 4.6 yields automatic continuity of isom orphisms:

C orollary 6.9. Let (X; ) and (Y; ) be multivariable dynamical systems. Then any isomorphism of  $C_0$  (X)  $F_n^+$  onto  $C_0$  (Y)  $F_n^+$  is automatically continuous.

Finally, we show that in general the algebra  $C_0(X)$   $F_n^+$  does not arise as the tensor algebra of som e C—correspondence. This implies in particular that the computations of Section 5 have no analogues in the context of sem icrossed products, when n>1.

P roposition 6.10. Let (X; ), = ( $_1$ ;  $_2$ ;:::;  $_n$ ), n > 1, be a multivariable dynam ical system . A ssum e that the maps  $_i$  have a common xed point. Let E be an arbitrary C -correspondence, over a C -algebra A, and let  $T_+$  (E) be the associated tensor algebra. Then, the semicrossed product  $C_0$  (X)  $F_n^+$  and the tensor algebra  $T_+$  (E) are not completely isometrically isomorphic.

Proof. Let  $x_0$  be a common xed of the  $_i$  for 1 in. Consider the representation of  $C_0$  (X)  $F_n^+$  which sends f 2  $C_0$  (X) to f ( $x_0$ ) and sends  $s_i$  to the generators  $U_i$  of  $C_r$  ( $F_n$ ), the reduced C\*-algebra of the free group  $F_n$ . This representation is full since each  $U_i$  is unitary. Therefore by Proposition 6.6, is orthogonally injective and orthogonally projective. So by [29], has a unique completely positive extension to the C ( $C_0$  (X)  $F_n^+$ ) and it is a representation. Thus  $C_r$  ( $F_n$ ) is a quotient of C ( $C_0$  (X)  $F_n^+$ ). In particular, the C\*-envelope is not nuclear.

On the other hand, suppose that  $C_0$  (X)  $F_n^+$  and  $T_+$  (E) were completely isometrically isomorphic. The diagonal of  $T_+$  (E), and hence the diagonal of  $C_0$  (X)  $F_n^+$ , contains an isomorphic copy of A. Therefore A is commutative. Consequently the associated Cuntz-P immsner algebra  $O_E$  is nuclear [22, Corollary 7.5]. By a result of K at soulis and K ribs [20], O (E) is the C—envelope of  $T_+$  (E).

Thus as the C \*-envelope of C  $_0$  (X )  $F_n^+$  is not nuclear, it is not a tensor algebra.

For speci c correspondences E, one can draw stronger conclusions than that of the above P roposition. For instance we will see in C orollary 7.5 that under weaker hypotheses than P roposition 6.10, the sem increased product C  $_0$  (X )  $\quad F_n^+$  and the tensor algebra A (X ; ) are not isomorphic as algebras.

#### 7. Characters and Nest Representations.

In this section, we extend methods from [8] to the multivariable setting. This will be applied in the Section 9 to recover much of the dynamical system from the tensor or crossed product algebra. Following Hadwin-Hoover [17], we set look at characters. At xed points, there will be some analytic structure which will be important. Then we study nest representations into the 2 2 upper triangular matrices  $T_2$ .

In this section, many results will hold for both the tensor algebra A (X; ) and the sem icrossed product  $C_0$  (X)  $F_n^+$ . We will use A to denote either algebra, and will specify when the results diverge.

C haracters. Let M  $_{\rm A}$  denote the space of characters of A endowed with the weak—topology. Since A contains  $C_0$  (X) as a subalgebra, the restriction of any character to  $C_0$  (X) will be a point evaluation  $_{\rm X}$  at some point x 2 X. Let M  $_{\rm A}$  , x denote the set of all characters extending  $_{\rm X}$ . Observe that since there is an expectation E of A onto  $C_0$  (X), there is always a distinguished character  $_{\rm X}$ ,0 =  $_{\rm X}$ E in M  $_{\rm A}$ , x. Since characters are always continuous, a character 2 M  $_{\rm A}$ , x is determined by z = (( $s_1$ );:::; ( $s_n$ )). We will write  $_{\rm X}$ , for this character when it is defined.

In particular, M  $_{A,x} = f_{x,0}g$  if x is not a xed point for any  $_{i}$ .

Proof. Let  $2 M_{A,x}$ . Characters always have norm 1; and indeed, they are completely contractive. So for A (X;), we must have

Hence this extends to a contractive representation of A (X; ), yielding the desired character  $_{x,z}$ . Sim ilarly if z 2  $\overline{D}$  ( $\overline{I_x}$ ), then this determ ines a contractive covariant representation. So it extends to a character of  $C_0$ (X)  $F_n^+$ .

Now consider analyticity. If a 2 A  $_0$  (X; ), then  $_a$  (z) is a polynom ial in fz $_i$ : i 2 I $_x$ g; and hence is analytic. Since k  $_a$ k $_1$  kak, it now follows for arbitrary a by approximation that  $_a$  is the uniform limit of polynomials on B (I $_x$ ) (respectively D (I $_x$ )). Hence it is analytic on the interior of the ball (respectively polydisc) and continuous on the closure.

Denition 7.2. An open subset M of M  $_{\rm A}$  is called analytic if there is a domain in C  $^{\rm d}$  and a continuous bijection of onto M so that the function (z) (a) is analytic on for every a 2 A . It is a maximal analytic subset if it is maximal among analytic subsets of M  $_{\rm A}$ .

In particular, consider x 2 X for which  $I_x$  is non-empty. The open ball B  $(I_x)$  = fz 2  $\overline{B}(I_x)$ : kzk<sub>2</sub> < 1g considered as an open subset of C  $^{I_x j}$  is a complex domain that is mapped in the obvious way onto B<sub>x</sub> = f<sub>x;z</sub>: z 2 B  $(I_x)$ g. This is an analytic set in M<sub>A(X;)</sub>. Similarly the polydisc D  $(I_x)$  = fz 2  $\overline{D}(I_x)$ : kzk<sub>1</sub> < 1g m aps onto the analytic set D<sub>x</sub> = f<sub>x;z</sub>: z 2 D  $(I_x)$ g in M<sub>C(X)</sub>  $F_n^+$ .

Lem m a 7.3. The maximal analytic sets in M  $_{A(X;)}$  are precisely the balls  $B_x$  for those points x 2 X  $\,$  xed by at least one  $_i$ . Similarly the maximal analytic sets in M  $_{C_0(X)}$   $_{F_n^+}$  are precisely the polydiscs D  $_x$  for those points x 2 X  $\,$  xed by at least one  $_i$ .

Proof. It su ces to show that analytic sets must sit inside one of the bres M  $_{A,x}$ . Let map a domain into M  $_{A}$ . For every f 2 C  $_{0}$  (X), the function (z) (f) and the function (z) (f) = (z) (f) are analytic, and hence constant. Since continuous functions on X separate points, this implies that maps into a single bre.

Now observe that M  $_{A,x}$  is hom eom orphic to a closed ball (respectively polydisc). Hence the maximal analytic subset would be the \interior" B $_x$  (respectively D $_x$ ). So we have identied all of the maximal analytic sets.

C orollary 7.4. The characters of A determ ine X up to homeomorphism, and identify which points are x=0 by some x=0, and determ ine exactly how many of the maps x=0 the point.

Proof. The lemma shows that M  $_{\rm A}$  consists of a space which is bred over X , and the bres are determined canonically as the closures of maximal analytic sets and the remaining singletons. Thus there is a canonical quotient map of M  $_{\rm A}$  onto X ; and this determines X . Next, the points which are xed by some  $_{\rm i}$  are exactly the points with a non-trivial bre of characters. The corresponding maximal analytic set is homeomorphic to a ball (respectively polydisc) in C  $^{\rm d}$  where d =  $J_{\rm x}$  j. The invariance of domain theorem shows that the dimension d is determined by the topology.

Proof. An algebra isom orphism will yield a homeomorphism of the character spaces, and will be a biholomorphic map of each maximal analytic set of the tensor algebra to the corresponding maximal analytic set in the semicrossed product. The existence of a point  $\mathbf{x}_0$  xed by k 2 of the maps  $_i$  means that the tensor algebra contains the ball  $\mathbf{B}_k$  as a maximal analytic set, while the semicrossed product has a polydisc  $\mathbf{D}_k$ . However no polydisk of dimension at least 2 is biholomorphic to any ball, and vice versa. Therefore the algebras are not isomorphic.

N est representations. In [8], we considered representations onto the 2 upper triangular m atrices  $T_2$ . Here we actually need to consider a m ore general notion.

De nition 7.6. Let  $N_2$  denote the maximal nest  $fOg; Ce_1; C^2$  in  $C^2$ . If A is an operator algebra, let  $rep_{N_2}$  denote the collection of all continuous representations of A on  $C^2$  such that Lat (A) =  $N_2$ .

These representations are called nest representations. There are two unital subalgebras of the 2  $\,$  2 m atrices M  $_2$  with this lattice of invariant subspaces, T  $_2$  and the abelian algebra A (E  $_{12}$ ) = spanfI; E  $_{12}$ g. Both have non-trivial radical. The other unital subalgebras of T  $_2$  are sem isim ple, and except for C I, they are all similar to the diagonal algebra D  $_2$ . Their lattice of invariant subspaces is the Boolean algebra with two generators. So representations with sem isim ple range are not nest representations.

Observe that for any representation of A into  $T_2$ , the compression to a diagonal entry is a homomorphism. Thus determines two characters which we denote by  $_{:1}$  and  $_{:2}$ . The map taking a to the

It is convenient to consider representations which restrict to —representations on  $C_0(X)$ . For (completely) contractive representations of  $C_0(X)$ , this is automatic. It is also the case that representations of  $C_0(X)$  into  $M_2$  are automatically continuous, and thus are diagonalizable. Here we need a stronger version of this fact. Let  $\operatorname{rep}^d A$  and  $\operatorname{rep}^d_{yx} A$  denote the nest representations which are diagonal on  $C_0(X)$ .

Lem m a 7.7. Let X be a locally compact space; and let be a continuous map of X into itself. Let K X, and let be a domain in C  $^d$ . Suppose that is a map from K into rep A so that

## 8. Piecew ise conjugate multisystems

In this section we introduce the concept of piecew ise conjugacy for multivariable dynamical systems. This concept is central for the classication of their algebras and apparently new in the theory of dynamical systems. We therefore study some of its basic properties and present a few illuminating examples.

Recall that two multivariable dynamical systems (X; ) and (Y; ) are said to be conjugate if there exists a homeomorphism of X onto Y and a permutation  $2 S_n$  so that  $\frac{1}{i} = \frac{1}{(i)}$  for 1 i n.

De nition 8.1. Say that two multivariable dynamical systems (X; ) and (Y; ) are piecewise conjugate if there is a homeomorphism of X onto Y and an open cover Y of Y so that for each Y of Y of Y of Y and Y of Y

We could have expressed this som ewhat dierently, saying that Y has an open cover so that on each open set, there is some permutation so that locally intertwines each  $_{\rm i}$  with  $_{\rm (i)}$ . But this is readily seen to be equivalent.

The di erence in the two concepts of conjugacy lies on the fact that the permutations depend on the particular open set. As we shall see, a single permutation generally will not suce.

For a point  $x \ 2 \ X$ , we say that two continuous functions f;g m apping X into another topological space Z are equivalent if they agree on an open neighbourhood of x. The equivalence class  $[f]_x$  is called the germ of f at x.

Proposition 8.2. Let (X; ) and (Y; ) be piecewise conjugate multivariable dynamical systems. Assume that X is connected and that E := fx 2 X : j (x) j = ng is dense in X. Then (X; ) and (Y; ) are conjugate.

Proof. Let be the homeomorphism implementing the piecew ise conjugacy. Observe that by continuity, E is open; and by hypothesis, it is dense. For each  $2 S_n$ , de ne an open set

From the piecew ise conjugacy, this is an open cover of X. If  $x \ge E$ , the permutation must be unique since (x) consists of n distinct points. This must persist to the closure, for if E is non-empty, then being open, it would intersect E, contrary to the previous conclusion. Hence the sets E must be clopen. From the connectedness of X, we conclude that there is a single permutation so that X = E. This yields the desired conjugacy.

Let Z (X; ) = fx 2 X : j (x)j < ng. Then Z (X; ) is the closed set E  $^c$ . Thus the previous proposition could be stated as saying that Z (X; ) is nowhere dense.

If Z (X; ) has non-empty interior, then the situation may change dram atically. We illustrate this in the simplest possible case.

Example 8.3. Let X = [0;1] and  $= (_1;_2)$ . We describe the piecew ise conjugacy class of ([0;1]; ). We may as well assume that Y = X and = id.

Pick points  $a_k$ ;  $b_k$ , k 2 K, so that the interior of Z (X; ) can be expressed as a disjoint union

Conversely, any system ([0;1]; ) which is piecew ise conjugate to ([0;1]; ) arises that way. The main point is that the functions must coincide on an interval in order to make the switchover. On the other hand, there cannot be countably many switches, because the switching points would then have a cluster point, and the two systems could not coincide on any neighbourhood of that point. We omit the details.

In particular, suppose that  $_1$  is non-increasing,  $_2$  is non-decreasing and that Z ([0;1]; ) = [a;b], with 0 < a < b < 1. The switching across (a;b) yields a piecew ise conjugate system (X; ) which is not monotonic. As any homeomorphism of [0;1] is monotone, these two systems are denitely not conjugate.

For n = 2, we can be more de nitive in Proposition 82.

Proposition 8.4. Let X be connected and let =  $(_1;_2)$ ; and let E = fx 2 X : j (x)j= 2g. Then piecewise conjugacy coincides with conjugacy if and only if  $\overline{E}$  is connected.

Proof. If E is empty, then  $_1 = _2$  and there is nothing to prove. As in the proof of Proposition 82, the sets E are open and

A rguing as before using the connectedness of  $\overline{E}$ , it follows that there is some so that E contains  $\overline{E}$ . But clearly both  $E_{id}$  and  $E_{(12)}$  contain  $\overline{E}^c = Z$  (X; ). Thus E = X and so X and Y are conjugate.

At the other end of the spectrum, total disconnectedness makes piecew ise conjugacy very tractable.

By hypothesis, this is an open cover of X . Hence there is a partition of unity ff g of positive functions in C(X) such that f = 1 and  $f^{1}(0;1)$  U for  $2 S_n$ . Then  $K = f^{1}[1=n!;1]$  is a compact subset of U and K = X.

Each point x 2 K is contained in U , and thus there is a clopen neighbourhood  $\mathbf{V}_{\mathbf{x}}$  of  $\mathbf{x}$  contained in  $\mathbf{U}$  . Select a  $% \mathbf{x}$  nite subcover of  $\mathbf{K}$  . The union of this nite cover is a clopen set V containing K contained in U .

To obtain the desired partition, order the permutations, and replace V by its intersection with the complement of the V 's which precede it in the list.

#### 9. Classification

The purpose of this section is to establish the connection between isom orphism of the tensor or sem icrossed product algebras and piecewise conjugacy.

Before embarking on the proof, we need to recall some basic facts from the theory of several complex variables [14]. Let G dom ain and let A G be an analytic variety of G.One says that A is regular at z 2 A of dim ension q if there is a neighborhood Uz and holomorphic functions  $f_i:U_z$ ! C for 1 i k q so that

(i) the Jacobian of  $(f_1; f_2; \dots; f_k = 1)$  at z has rank k q, and, (ii)  $A \setminus U_z = N$   $(f_1; f_2; \dots; f_k = 1)$  = 1

By the Theorem of local param eterization at regular points [14, Theorem I.8.3], the dimension is well de ned. The set  $A_{req}$  of all regular points of A forms an open subset of A, and the dimension is constant on each connected component of  $A_{\text{reg}}$ . The closure of each such component is itself an analytic variety of G which is irreducible, i.e., the regular points are connected. The maximum dimension of the irreducible subvarieties of A is called the dimension of A.

We need a rather modest conclusion from this theory. However we know of no elementary proof of this fact.

Proposition 9.1. Let  $G C^k$  be a domain and let

Proof. Assume that N ( $_1$ ;  $_2$ ;:::;  $_1$ ) is non-empty. If l=1, then the techniques of [14, Proposition I.8.4] imply that the dimension of that variety is k 1. Consequently, [14, Exercise III.6.1] implies that for an arbitrary k, the dimension of N ( $_1$ ;  $_2$ ;:::;  $_1$ ) is at least k 1 and hence is positive. In particular, some irreducible component of N ( $_1$ ;  $_2$ ;:::;  $_1$ ) is regular of positive dimension at some point z. The conclusion follows now from the Implicit Function Theorem .

If there were an isolated point of the zero set, simply reduce G to a small neighbourhood of that point to obtain a contradiction.

We now have all the requisite tools to recover much of the dynam ical system from the tensor or crossed product algebra in the multivariable setting. Again we will work as much as possible with both the tensor algebra and the sem icrossed product.

Theorem 9.2. Let (X; ) and (Y; ) be two multivariable dynamical systems. We write A and B to mean either A (X; ) and A (Y; ) or  $C_0(X)$   $F_n^+$  and  $C_0(Y)$   $F_n^+$ . If A and B are isomorphic as algebras, then the dynamical systems (X; ) and (Y; ) are piecew ise conjugate.

Proof. Let be an isom orphism of A onto B. This induces a bijection  $_{\rm c}$  from the character space M  $_{\rm A}$  onto M  $_{\rm B}$  by  $_{\rm c}$ () =  $^{1}$ . Similarly it induces a map  $_{\rm r}$  from rep  $_{\rm N}$ , (A) onto rep  $_{\rm N}$ , (B).

Since M  $_{\rm A}$  is endowed with the weak- topology, it is easy to see that  $_{\rm c}$  is continuous. Indeed, if  $\,$  is a net in M  $_{\rm A}$  converging to  $\,$  and b 2 B , then

The same holds for  $_{\rm c}$   $^{1}$ . So  $_{\rm c}$  is a homeomorphism .

O beerve that  $_{\rm C}$  carries analytic sets to analytic sets. Indeed, if  $\,$  is an analytic function of a dom ain  $\,$  into M  $_{\rm A}$  , then

is analytic for every b 2 B; and thus  $_{\rm c}$  is analytic. Since the same holds for  $^{\rm 1}$ , it follows that  $_{\rm c}$  takes maximal analytic sets to maximal analytic sets. Thus it carries their closures, M  $_{\rm A,x}$ , onto sets M  $_{\rm B,y}$ . The same also holds when these sets are singletons.

By Corollary 7.4, X is the quotient of M  $_{\rm A}$  obtained by squashing each M  $_{\rm A,x}$  to a point. It follows that  $_{\rm C}$  induces a set m ap  $_{\rm S}$  of X onto Y which is a homeomorphism since both X and Y inherit the quotient topology.

The hard part of the proof is to show that k=1. Assume that this has been veried. Then one can partition the functions  $_i$  into families with a common germ at  $x_0$ , and they will be paired with a corresponding partition of the  $_j$  's of equal size. This provides the desired permutation in some neighbourhood of each  $x_0$ .

It rem ains to show that k = 1. By way of contradiction, assume that  $k \in 1$ . By exchanging the roles of X and Y if necessary, we may assume that k > 1. We do not exclude the possibility that l = 0.

In light of Proposition 82 we obtain the following classication for both the tensor algebra and the semicrossed product. Recall that Z(X; ) = fx : j(x)j < ng.

Corollary 9.3. Let (X;) and (Y;) be multivariable dynamical systems and assume that X is connected and Z (X;) has empty interior. Then A and B are isomorphic if and only if the systems (X;) and (Y;) are conjugate.

Corollary 9.3 is the strongest result we can o er for both the tensor algebra and the sem i-crossed product. In order to obtain more de nitive results, we focus in the tensor algebra case. In the totally disconnected case, the situation is straightforward. The reader should compare this with [18].

Corollary 9.4. Assume that X is totally disconnected. Then the tensor algebras A (X; ) and A (Y; ) are isomorphic if and only if (X; ) and (Y; ) are piecew ise topologically conjugate. In this case, the algebras are completely isometrically isomorphic.

Proof. One direction is provided by Theorem 92. For the converse, assume that (X; ) and (Y; ) are piecew ise topologically conjugate. By Proposition 8.5, there is a partition of X into clopen sets fV:  $2 S_n g$  so that for each  $2 S_n$ ,

When n = 2, we have a complete answer.

Theorem 9.6. Let n = 2 and suppose that  $(X;_1;_2)$  and  $(Y;_1;_2)$  are two dynamical systems. The following are equivalent:

- (1) (X; ) and (Y; ) are piecew ise topologically conjugate.
- (2) A (X; ) and A (Y; ) are isomorphic.
- (3) A (X; ) and A (Y; ) are completely isometrically isomorphic.
- (4) There is a homeomorphism of X onto Y so that
  - (a)  $f_1(x)$ ;  $f_2(x)$  (x)  $f_1(x)$ ;  $f_2(x)$  (x)  $f_2(x)$  for each  $f_2(x)$  and
  - (b)  $X_i = fx 2 X : _1(x) \in _i (x)g$ , i = 1;2, have disjoint closures.

Proof. Clearly (3) implies (2); and (2) implies (1) by Theorem 92. Suppose that (1) holds for a homeomorphism and an open cover  $fU_{ii}; U_{(12)}g$ . That is,  $_i$   $j_{id} = _i j_{id}$  and  $_i$   $j_{(12)} = _i ^0 j_{(12)}$  for i = 1; 2 and  $fi; i^0g = f1; 2g$ . In particular, (4a) holds for every x 2 X . Moreover,  $\overline{X}_1$   $U_{id}^c$  and  $\overline{X}_2$   $U_{(12)}^c$ . Consequently,

$$\overline{X_1} \setminus \overline{X_2}$$
  $U_{id} [U_{(12)}]^c = ?$ :

This establishes (4b).

So we now assume that (4) holds. To simplify the notation, we may assume that Y = X and = id. Let  $(;S_1;S_2)$  be a faithful representation of the covariance relations for (X;). Since  $\overline{X_1}$  and  $\overline{X_2}$  are disjoint, there is a continuous function h 2  $C_b(X)$  such that  $h_{\overline{X_1}} = 0$ ,  $h_{\overline{X_2}} = \frac{1}{2}$  and h takes real values in  $[0;\frac{1}{2}]$  everywhere. Let

denote the extension of  $\,\,$  to the bounded Borel functions on X  $\,$  . De  $\,$  ne  $\,$ 

$$T_1 = S_1^- (\sinh h) + S_2^- (\cosh h)$$
 and  $T_2 = S_1^- (\cosh h) \cdot S_2^- (\sinh h)$ :

First observe that  $T_i$  are isom etries with orthogonal range. For example,

Next observe that A (X ; ) is generated by  $C_0$  (X ) and  $T_iC_0$  (X ) for i=1;2. This is because

I ultiplying on the right by (f) for any f 2 C<sub>0</sub> (X) yields the corre

Multiplying on the right by (f) for any  $f 2 C_0(X)$  yields the corresponding fact for A (X; ).

Now exactly the same procedure works in a faithful representation of A (X; ). Let  $\mathfrak{t}_1$  and  $\mathfrak{t}_2$  denote the generators of A (X; ). Since A (X; ) contains a representation of the covariance relations for (X; ), there is a hom om orphism of A (X; ) onto A (X; ) that takes f to (f) and  $\mathfrak{t}_i$  f to  $T_i$ f. It is then clear that  $a_1 := \mathfrak{t}_1^-(\sinh) + \mathfrak{t}_2^-(\cosh)$  is sent to  $S_1$  and  $a_2 := \mathfrak{t}_1^-(\cosh) + \mathfrak{t}_2^-(\sinh)$  is sent to  $S_2$ . Likew ise there is an algebra hom om orphism in the reverse direction which is evidently the inverse m ap on the generators. Therefore these algebras are isom orphic. M oreover the m aps in both directions are complete contractions, and thus are completely isom etric.

The evidence strongly suggests the following:

C on jecture 9.7. The tensor algebras A (X;) and A (Y;) are isom orphic if and only if the system s (X;) and (Y;) are piecew ise topologically conjugate; and in this case, they are completely isometrically isomorphic.

The analysis leads to a technical conjecture which we can verify in low dimensions that would suce to solve our conjecture.

C on jecture 9.8. Let  $_n$  be the n!-simplex with vertices indexed by  $S_n$ . Is there a continuous function u of  $_n$  into U (n) so that:

- (1) each vertex is taken to the corresponding permutation matrix,
- (2) for every pair of partitions (A; B) of the form

$$f1;:::;ng = A_1 [ ::: [A_m = B_1 [ ::: [B_m ;$$

where  $\beta_s j = \beta_s j \cdot 1$  s m, let

$$P(A;B) = f(2S_n:(A_s) = B_s;1 s mg:$$

If  $x=\frac{P}{2P(A_{jB})}x$ , then the non-zero matrix coe cients of  $u_{ij}(x)$  are supported on  $\sum_{s=1}^m B_s$   $A_s$ . We call this the block decomposition condition.

P roposition 9.9. Conjecture 9.8 is valid for n=2; 3. M oreover there is a function on the 1-skeleton of  $_n$  satisfying the conditions of this conjecture for every n.

Proof. For each permutation  $2 \, S_n$ , one can choose a Herm itian matrix A so that  $U = \exp(iA)$  as follows: Decompose into cycles, and select a logarithm for each cycle with arguments in [ ; ]. The eigenvalues come in conjugate pairs except for 1. Make the choice between for the eigenvalue 1 alternately; so that kA k and TrA 2 f0; g. Choosing A in this way ensures that it respects the block diagonal structure of U coming from the cycle decomposition.

To describe such a function on the 1-skeleton of  $_{\rm n}$ , just order the elements of  $S_{\rm n}$ . For future use, we insist that the even permutations precede the odd permutations in this order. Then if < in this order, de ne

$$u((1 t) + t) = U \exp(itA_1)$$
:

This works because if ; 2 P (A;B), then  $^1$  2 P (A;A). Hence A  $_1$  respects the block structure A, so that exp (itA  $_1$ ) does also. Consequently U exp (itA  $_1$ ) respects the A;B block decomposition. This 1-skeleton argument contains the n =  $2_p$ case.

Observe that for any n, the function  $u(t) = \exp(it)$  that is maps n into U(n) and u() = U . n general, it does not satisfy the block decomposition condition.

Now consider n = 3. Any non-trivial block decomposition of 3 is given by a vertex (i; j); namely

$$fA_1 = fig; A_2 = A_1^c; B_1 = fjg; B_2 = B_1^cg$$
:

There are two permutations respecting this block decomposition, say  $_{ij}$  and  $_{ij}$  where  $_{ij}$  is even and  $_{ij}$  is odd. To not the function usatisfying Conjecture 9.8, we start with the function constructed in the

previous paragraph and modify it on the nine edges to obtain the block decomposition condition.

Take the 6-sim plex  $_3$  and glue a half-disk D  $_{ij}$  to each of the nine edges[ $_{ij}$ ;  $_{ij}$ ]. On the sem icircular edge  $_{ij}$ [D;1] between  $_{ij}$  and  $_{ij}$ , de ne u as in the second paragraph:

Recall that on the straight edge [ij; ij], u is de ne as

The determ inant along these two paths is respectively

The issue is now to extend the denition of u to each half-disk D  $_{ij}$  in a continuous way. The key fact is that SU (3) is simply connected [26, Theorem II.4.12]. (Indeed SU (n) is simply connected for all n 1.) The determinant is an obstruction to U (n) being simply connected. But by ensuring that our functions have domain in the set of unitaries with determinant in the upper half plane means that we remain in a simply connected set. Hence there is a homotopy between the edge u([ $_{ij}$ ;  $_{ij}$ ]) and u( $_{ij}$ ) which enables the extension of the denition of u. Finally observe that there is a continuous function h of  $_3$  onto  $_3$   $_{i,j=1}^3$  D  $_{ij}$  which takes the edges [ $_{ij}$ ;  $_{ij}$ ] onto  $_{ij}$ . The composition v = u h is the desired function.

We can now show how to modify the proof of Theorem 9.6 to work for any n for which we have Conjecture 9.8. Recall that the covering dimension of a topological space X is the smallest integer k so that every open cover can be rended so that each point is covered by at most k+1 points.

Theorem 9.10. If Conjecture 9.8 is correct for some value of n, then for two paracompact dynamical systems (X;) and (Y;) where =  $f_1; \ldots; f_n g$  and =  $f_1; \ldots; f_n g$ , the following are equivalent:

- (1) (X; ) and (Y; ) are piecewise topologically conjugate.
- (2) A (X; ) and A (Y; ) are isomorphic.
- (3) A (X; ) and A (Y; ) are completely isometrically isomorphic.

If C on jecture 9.8 is valid on the k-skeleton of  $_{\rm n}$ , then the theorem still holds if the covering dim ension of X is at most k.

Proof. Clearly (3) implies (2); and (2) implies (1) by Theorem 92. Suppose that (1) holds for a homeomorphism and an open cover  $fU:2S_ng$ . To simplify notation, we may identify Y with X via , so that we have Y=X and = id. If the covering dimension of X is k, then the cover  $fU:2S_ng$  can be rened so that each point of X is contained in at most k+1 open sets. Let  $fg:2S_ng$  be a partition of unity relative to this cover. This induces a map g of X into the simplex g given by g(x)=g(x) g in the case of covering dimension g. In the case of covering dimension g in the image lies in the g-skeleton.

Our hypothesis is that there is a continuous function u from  $_{\rm n}$  or its k-skeleton into the unitary group U (n) satisfying the block decomposition condition. Let v=u-g map X into U (n). Now if x 2 X , there is a m inim alpartition

The permutations for which g (x)  $\in$  0 respect this block structure. Hence so does the map v. This will ensure that in our construction below, we will always intertwine functions that agree on a neighbourhood of each point.

Let  $v_{ip}$  be the matrix coecients of v. De ne operators in A (X; ) by  $T_i = \bigcap_{j=1}^n s_j v_{ij}$ . Then since the  $s_j$ 's have pairw ise orthogonal range,

$$T_k T_i = \sum_{j=1}^{X^n} \overline{v_{kj}} v_{ij} = k_i I$$
:

Hence the  $T_i$ 's are isom etries with pairw ise orthogonal ranges. To check the covariance relations, observe that if  $v_{ij}(x) \in 0$ , then i and j agree on a neighbourhood of x. That is,  $v_{ij}(f) = v_{ij}(f)$  is for all i; j. Therefore

$$fT_{i} = f \begin{cases} X^{n} \\ s_{j}v_{ij} = X^{n} \\ j = 1 \end{cases} s_{j}v_{ij} (f j)$$

$$= X^{n} \\ = S_{j}v_{ij} (f j) = T_{i} (f j);$$

$$= T_{i} (f j)$$

Next observe that A (X ; ) is generated by  $C_0$  (X ) and  $T_iC_0$  (X ) for 1 i n. This is because for 1 k n,

Therefore there is a completely contractive hom om orphism of A (Y; ) onto A (X; ) sending  $t_i$  to  $T_i$  for 1 i n which is the identity on  $C_0(Y) = C_0(X)$ . Likew ise there is a completely contractive hom om orphism of A (X; ) onto A (Y; ) which is the inverse on the generators g. Consequently these m aps are completely isometric isomorphisms.

C orollary 9.11. Suppose that n = 3. Then for two dynam ical systems (X;) and (Y;), the following are equivalent:

- (1) (X; ) and (Y; ) are piecewise topologically conjugate.
- (2) A (X; ) and A (Y; ) are isom orphic.
- (3) A (X; ) and A (Y; ) are completely isometrically isomorphic.

The dimension 0 case corresponds to totally disconnected spaces. So this result subsumes Corollary 9.4. Since compact subsets of R have covering dimension 1, we obtain:

Corollary 9.12. Suppose that X has covering dimension 0 or 1. In particular, this holds when X is a compact subset of R. Then for two dynamical systems (X;) and (Y;), the following are equivalent:

- (1) (X; ) and (Y; ) are piecew ise topologically conjugate.
- (2) A (X; ) and A (Y; ) are isom orphic.
- (3) A (X; ) and A (Y; ) are completely isometrically isomorphic.

## 10. W andering sets and Recursion

In this section, we exam ine some topological issues which are needed in the next section on sem isimplicity.

De nition 10.1. Let (X; ) be a multivariable dynamical system . An open set U = X is said to be (u; v)-wandering if

$$_{uwv}^{1}(U) \setminus U = ?$$
 for all  $w \ 2 F_{n}^{+}$ :

If U is a (u;v)-wandering set for some u;v in  $F_n^+$ , we say that U is a generalized wandering set. We may write v-wandering instead of (?;v)-wandering.

Observe that if som e  $_{i}$  is not surjective, then the set U = X n  $_{i}$ (X) is (i;?)-wandering. If one is interested in when there are no wandering sets, one should restrict to the case in which each  $_{i}$  is surjective. In this case, whenever U is (u;v)-wandering, the set  $_{u}$  (U) is (?;vu)-wandering. This open set is non-empty because every  $_{u}$  is surjective. In general, the additional generality seems to be needed.

De nition 10.2. Let (X; ) be a multivariable dynamical system. Given  $u; v \in F_n^+$ , we say that a point  $x \in X$  is (u; v)-recurrent if

for every neighbourhood U 3 x, there is a w 2  $F_n^+$  so that  $_{uw\,v}$  (x) 2 U . W e will write v-recurrent instead of (?;v)-recurrent.

Again, if each  $_{i}$  is surjective, we see that when x is (u;v)-recurrent, then any point y in the non-empty set  $_{i}^{1}(x)$  is (?;vu)-recurrent.

The following proposition explains the relationship between recursion and wandering sets in metric spaces.

Proposition 10.3. Let (X; ) be a metrizable multivariable dynamical system. There is no (u;v)-wandering set U X if and only if the set of (u;v)-recurrent points is dense in X.

Proof. If the (u;v)-recurrent points are dense in X, then any open set U X contains such a point, say  $x_0$ . Thus there is a word w 2  $F_n^+$  so that  $u_{WV}(x_0)$  2 U. Therefore  $u_{WV}^{-1}(U) \setminus U \in \mathbb{R}$ . So there are no (u;v)-wandering sets.

Conversely, suppose that there are no (u;v)-wandering sets. Let be the metric on X . For each  $x \ge X$  , de ne

$$(x) = \underset{u,v}{\text{u,v}}(x) := \inf_{w \ge F_n^+} (x; _{uwv}(x)):$$

Observe that is upper sem icontinuous, i.e. fx 2 X : (x) < rg is open for all r 2 R. Indeed, if  $(x_0)$  < r and  $(x_0; uw v()(x_0)) = r$  ", the continuity of our system means that for some  $0 < < "=2, (x; x_0) < implies that <math>(uwv(x); uwv(x_0)) < "=2$ . So by the triangle inequality, (x; uwv(x)) < r; whence (x) < r.

Suppose that U is a non-empty open set containing no (u;v)-recurrent points. Then (x) > 0 for every  $x \ge U$ . So

$$U = \int_{n}^{1} fx \ 2 \ U : (x) \frac{1}{n} g:$$

This is a union of closed sets. By the Baire Category Theorem , there is an integer  $n_0$  so that fx 2 U : (x)  $\frac{1}{n_0}g$  has non-empty interior, say V .

Select a ball  $U_0$  contained in V of diam eter less than  $1=n_0$ . We claim that  $U_0$  is (u;v)-wandering. Indeed, for any  $x \ 2 \ U_0$  and any  $w \ 2 \ F_n^+$ ,  $(x; u_{wv}(x)) = 1=n_0$  and thus  $u_wv(x)$  lies outside of  $U_0$ . That is,  $U_0 \setminus \frac{1}{u_{wv}}(U_0) = ?$ .

C orollary 10.4. In a m etrizable multivariable dynamical system (X; ), the following are equivalent:

- (1) there is no non-empty generalized wandering set in X
- (2) the set of (u;v)-recurrent points are dense for every  $u;v \ge F_n^+$
- (3) each  $_{i}$  is surjective and the set of v-recurrent points is dense in X for every v 2  $F_{n}^{+}$ . for every v 2  $F_{n}^{+}$ .

Proof. The equivalence of (1) and (2) is immediate from the Theorem . It was observed that (1) implies that each  $_{\rm i}$  is surjective; and clearly (2) implies as a special case that the set of v-recurrent points is dense in X for every v 2  $F_{\rm n}^+$ .

Conversely, suppose that (3) holds, and x (u;v) and a point  $x_0$  2 X . By surjectivity, there is a point  $y_0$  2 X so that  $_u$  ( $y_0$ ) =  $x_0$ . Given a neighbourhood  $U_0$  3  $x_0$ , let  $V_0 = _u^{-1}(U_0)$ . Select a vu-recurrent point y 2  $V_0$ ; and let  $x = _u$  (y). If U 3 x is any open set, let  $V = _u^{-1}(U)$ . There is a word w so that  $_{wvu}$  (y) 2 V . Therefore  $_{uwv}$  (x) 2 U . Thus x is (u;v)-recurrent, and the set of such points is dense in X . So (2) holds.

## 11. Sem is implicity

We now turn to an analysis of the tensor algebra and the sem icrossed product to decide when they are sem is imple. In spite of their dierences, the answer is again the sem e. We now apply the results of the previous section to characterize the sem is implicitly in our setting.

Theorem 11.1. Let (X; ) be a multivariable dynamical system. The following are equivalent:

- (1) A (X; ) is sem is im ple.
- (2)  $C_0(X)$   $F_n^+$  is sem isimple.
- (3) There are no non-empty generalized wandering sets.

When X is metrizable, these are also equivalent to

(4) Each  $_{i}$  is surjective and the v-recurrent points are dense in X for every v 2  $F_{n}^{+}$ .

Proof. Assume rst that there exists a nonempty open set U X and u; v 2  $F_n^+$  so that

$$_{uwv}^{1}(U) \setminus U = ?$$
 for all  $w \circ 2F_{n}^{+}$ :

Let  $h \in 0$  be continuous function with support contained in U . Then  $(h \cup_{u \in V})h = 0$ .

We will show that A (X; ) is not sem isimple. Indeed, the (non-zero) operator N =  $s_v h s_u$  generates a nilpotent ideal. To see this, let w 2  $F_n^+$  and f 2 C  $_0$  (X). Compute

$$N (s_w f)N = s_v h s_{uw} f s_v h s_u$$
$$= s_{vuwv} (h uwv)h (f v) s_u = 0:$$

Therefore NAN = 0 for all A 2 A (X; ). Hence the 2-sided ideal hN i generated by N is nilpotent of order 2; and thus A(X; ) is not

sem isimple. The same calculation holds in the sem icrossed product. So both (2) and (3) imply (1).

Conversely, assume that there are no non-empty wandering sets. We will show that both (2) and (3) hold. As before, we will write A to denote either the tensor algebra or the sem icrossed product. The Jacobson radical of any Banach algebra is invariant under automorphisms. In particular, both of our algebras have the automorphisms

which send the generators  $s_i$  to  $\ _is_i$  for each  $\ 2\ T^n$  . Integration yields the expectations

$$_{k}(a) = (a)^{-k} d$$

for each a 2 N  $_0^{\rm n}$  onto the polynom ials spanned by  $s_w$  f, where w ( ) =  $^k$  . Consequently, these expectations m ap the radical into itself.

By way of contradiction, assume that  $\operatorname{rad} A$  contains non-trivial elements. By the previous paragraph,  $\operatorname{rad} A$  will contain a non-zero element of the form

$$Y = {}_{a}(Y) = {}^{X} {}_{s_{w}} h_{w} = {}^{X^{p}} {}_{s_{w_{j}}} h_{j}$$

for som e a 2  $N_0^n$ . Since Y  $\in$  0, we may suppose that  $h_1 \in$  0. By multiplying Y on the right by a function, we may suppose that  $h_1 = 0$  and  $kh_1k > 1$ .

Wewill look for an element of the form

$$Q = I + X \\ k 1 2 k s_{v_k} Y = X \\ k 0 j = 1$$

where  $w_{k,j} = v_k w_j$ . The goal will be to show that Q is not quasinilpotent, so contradicting the fact that Y is in the radical.

When n=1, Y has only one term and the coe cients in Q and all of its powers are non-negative functions. Here there is no cancellation of term s, so the size of a single term in the product  $Q^m$  yields a useful lower bound for the norm .

However when n 2, this is not the case. Instead, we can arrange to choose the words  $v_k$  so that the distinct terms in a product  $Q^m$  will be distinct words in  $F_n^+$ . This will be accomplished if the word  $v_k$  begins with the sequence  $t_k = 21^k 2$ , the sequence consisting of k 1s separating two 2s. For such  $v_k$ , consider the terms in a product  $Q^m$ . They will have the form  $s_u g_u$  where u is a product of m words  $u = w_{k_1;j_1} ::: w_{k_m;j_m}$ . The rst few letters of u will be  $t_{k_1}$ , uniquely identifying  $k_1$  and  $w_{k_1;j_1}$  will be the rst  $jv_{k_1}j_1+j_2j$  terms of u. Peel that term o and repeat. Since the product determ ines the term s, in

order, it follows that distinct products yield distinct words. So again, there is no cancellation of terms. Therefore the size of a single term in the product will yield a lower bound for the norm of  $\mathbb{Q}$ .

The plan of attack is to show that

$$Q^{2^{k}-1} = 2^{n_k} s_{u_k} g_k + \text{other term } s$$

where  $kg_k k > 1$  and  $n_k = 2^k - k - 1$ . In computing the next power, we see that

$$\begin{array}{l} Q^{2^{k+1}-1} = Q^{2^k-1}QQ^{2^k-1} \\ &= (2^{-n_k}s_{u_k}g_k)(2^{-k}s_{w_{k;1}}h_1)(2^{-n_k}s_{u_k}g_k) + \text{other term s} \\ &= 2^{-2n_k-k}s_{u_kw_ku_k}(g_k-w_ku_k)(h_1-u_k)g_k + \text{other term s} \\ &= 2^{-n_{k+1}}s_{u_{k+1}}g_{k+1} + \text{other term s:} \end{array}$$

Provided that  $kg_k k > 1$  for all k = 1, we obtain that

$$\text{spr}(Q) = \lim_{k! = 1} kQ^{2^k - 1} k^{1 = (2^k - 1)} \qquad \lim_{k! = 1} 2^{\frac{2^k - k - 1}{2^k - 1}} = \frac{1}{2} > 0:$$

The preceding calculation indicates where we should look. One has formulae

and  $v_k$  begins with  $t_k$  for k 1. We choose  $u_0 = ?$  so that  $u_1 = w_1$  to start the induction. We also have functions  $g_1 = h_1$  and

$$g_{k+1} = (g_k \quad w_{k+1} u_k) (h_1 \quad u_k) g_k$$
 for  $k = 1$ :

We need to ensure that  $kg_k k > 1$  for all k > 1.

To this end, let  $V_1=fx\ 2\ X\ : h_1(x)>1$  g. Our task will be accomplished if we can not non-empty open sets  $V_{k+1}$   $V_k$  for k 1 so that

$$u_k u_k (V_{k+1})$$
  $V_k$  and  $u_k (V_k)$   $V_1$  for all  $k-1$ 

Indeed, if we have these inclusions, we can show by induction that  $g_k > 1$  on  $V_k$ . Clearly this is the case for k = 1. Assuming the properties outlined in the previous paragraph,

$$u_{\nu} (V_{k+1}) \qquad u_{\nu} (V_{k}) \qquad V_{1};$$

and thus  $h_1$   $u_k > 1$  on  $V_{k+1}$ . Sim ilarly,  $w_k u_k$   $(V_{k+1})$   $V_k$ , and so  $g_k$   $w_k u_k > 1$  on  $V_{k+1}$ . Finally  $g_k > 1$  on  $V_k$   $V_{k+1}$ . Therefore the product yields  $g_{k+1} > 1$  on  $V_{k+1}$ .

To construct  $V_{k+1}$ , observe that there are no  $(t_{k+1};w_1u_k)$ -wandering sets. In particular, there is a  $v_k^0$  2  $F_n^+$  so that

$$V_{k+1} = {1 \atop t_k v_k^0 w u_k} (V_k) \setminus V_k \in ?$$

W ith this choice (and recalling that  $w_{k,1} = t_k v_k^0 w_1$ ), we have that

$$u_{k+1}(V_{k+1}) = u_k w_{k;1}u_k(V_{k+1}) u_k(V_k) V_1$$

This completes the induction. We see that the radical must be f0g, and so A is sem is imple.

The equivalence of (1) and (4) in the metric case is given by Corollary 10.4.
