

OBSERVABLE CONCENTRATION OF MM-SPACES INTO NEGATIVELY PINCHED MANIFOLDS

Abstract. The measure concentration property of an mm-space X is roughly described as that any 1-Lipschitz map on X to a metric space Y is almost close to a constant map. The target space Y is called the screen. The case of $Y = \mathbb{R}$ is widely studied in many literature. (see [8], [11], [17], [18], [22], [25], [26] and their references). M. Gromov developed the theory of measure concentration in the case where the screen Y is not necessarily \mathbb{R} (cf. [6], [7], [8]). In this paper, we consider the case where the screen Y is a simply connected negatively pinched manifold. We also show that if the screen Y is so big, then the mm-space X does not concentrate.

1. Introduction

Let ν_n be the volume measure on the n -dimensional unit sphere S^n in \mathbb{R}^{n+1} normalized as $\nu_n(S^n) = 1$. In 1919, P. Levy proved that for any 1-Lipschitz function $f : S^n \rightarrow \mathbb{R}$ and any $\epsilon > 0$, the inequality

$$(1.1) \quad \nu_n(fx) \geq \nu_n(f(x)) - m_f \epsilon^{\frac{n}{2}} \geq 2e^{-\frac{(n-1)\epsilon^2}{2}}$$

holds, where m_f is some constant determined by f . For any fixed $\epsilon > 0$ the right-hand side of the above inequality converges to zero as $n \rightarrow \infty$. This means that any 1-Lipschitz function on S^n is almost close to a constant function for sufficiently large $n \in \mathbb{N}$. This high dimensional concentration phenomenon of functions was first extensively used and emphasized by V. D. Milman in his investigation of asymptotic geometric analysis. He used Levy's inequality (1.1) for a short proof of Dvoretzky's theorem on Euclidean section of convex bodies (cf. [15]). The same year later he extended Levy's result to some nonspherical spaces and then pushed forward the idea of concentration of functions as a general unifying principle (cf. [14], [16]). Nowadays, the concentration theory of functions is widely studied in many literature and blend with various areas of mathematics (see [8], [11], [17], [18], [22], [25], [26] and references therein for further information).

In 1999, M. Gromov promoted a theory of concentration of maps into general metric spaces by introducing the notion of the observable diameter in [8]. He settled the following definition.

Definition 1.1. Let Y be a metric space and μ a Borel measure on Y such that $m := \mu(Y) < +\infty$. We define for any $\epsilon > 0$

$\text{diam}(\mu; m_\epsilon) = \inf \{\text{diam}(Y_0) : Y_0 \subset Y \text{ is a Borel subset such that } \mu(Y_0) \geq m - \epsilon\}$

and call it the partial diameter of μ .

An m -space is a triple $(X; d; \mu)$, where d is a complete separable metric on a set X and μ a finite Borel measure on $(X; d)$.

Definition 1.2 (Observable diameter). Let $(X; d; \mu)$ be an m -space and Y a metric space. For any $\epsilon > 0$ we define the observable diameter of X by

$\text{diam}(X \xrightarrow{\text{Lip}_1} Y; m_\epsilon) = \sup \{\text{diam}(f(X); m_\epsilon) : f : X \rightarrow Y \text{ is a } 1\text{-Lipschitz map}\};$

where $f(\cdot)$ stands for the push-forward measure of μ by f .

The target metric space Y is called the screen. The idea of the observable diameter came from the quantum and statistical mechanics, that is, we think of Y as a state on a configuration space X and f is interpreted as an observable. We define a sequence $fX_n g_{n=1}^1$ of m -spaces is a Levy family if $\text{diam}(X_n \xrightarrow{\text{Lip}_1} R; m_n) \leq 0$ as $n \rightarrow 1$ for any $\epsilon > 0$, where m_n is the total measure of the m -space X_n . This is equivalent to that for any $\epsilon > 0$ and any sequence $f f_n : X_n \rightarrow R g_{n=1}^1$ of 1-Lipschitz functions, we have

$$\lim_{n \rightarrow 1} (f f_n)_* \mu_n \geq \mu \quad \text{as } n \rightarrow 1;$$

where μ_{f_n} is some constant determined by f_n . The Levy families are first introduced and analysed from a geometric point of view by Gromov and Milman in [9]. The inequality (1.1) shows that the sequence $fS^n g_{n=1}^1$ is a Levy family. Gromov proved in [8] that $\text{diam}(X_n \xrightarrow{\text{Lip}_1} Y; m_n) \leq 0$ as $n \rightarrow 1$ for any $\epsilon > 0$ and for a Levy family $fX_n g_{n=1}^1$ if the screen Y is a compact metric space or a Euclidean space. He also discussed the case where the screens are Euclidean spaces whose dimensions go to infinity by considering the barycenters of the push-forward measures (see Theorem 4.13). His barycenter method also goes well if the screens are negatively curved metric spaces, that is to say, CAT(0)-spaces (see Section 4). In [7], he considers and analyzes the questions of isoperimetry of waists and concentration forms from a unit sphere to a Euclidean space. In the recent work [12], M. Ledoux and K. Oleszkiewicz estimated the observable diameter $\text{diam}(X \xrightarrow{\text{Lip}_1} R^k; m_\epsilon)$ provided that the m -space X has a Gaussian concentration. In our previous paper [5], the author studied the case where the screen Y is a metric space with a doubling measure. In [6], Gromov introduced the notion of L^p -concentration of maps from m -spaces into metric spaces. The property of L^p -concentration is closely related to that of the concentration (see Lemma 4.18 and 4.20), and in [6], he got several L^2 -concentration inequalities of maps (see for example, Theorem 4.25 and Proposition 4.28).

In this paper, motivated by Gromov's study, we study concentration phenomenon of maps into CAT(0)-spaces. In particular, we consider the case where dimensions of screens

go to infinity. Given $\epsilon_1, \epsilon_2 > 0$ with $\epsilon_1 + \epsilon_2 < 0$ and $n \geq N$, we denote by $NM(n; \epsilon_1, \epsilon_2)$ the set of all n -dimensional complete simply connected Riemannian manifolds with sectional curvature bounded from below by ϵ_1 and from above by ϵ_2 . One of our main theorems in this paper is the following:

Theorem 1.3. Let $f(X_n; d_n; m_n)g_{n=1}^1$ be a sequence of mm-spaces of finite diameter and $p = 1=2$. We assume that a sequence $a(n)g_{n=1}^1$ of natural numbers and sequences $f_{1n}g_{n=1}^1, f_{2n}g_{n=1}^1$ of negative numbers satisfy that $\lim_{n \rightarrow \infty} f_{2n}, \sup_{n \geq N} f_{2n} < 0$, and

$$(1.2) \quad \frac{P - \frac{1}{2n} \operatorname{diam} X_n^{Lip_1} R^{a(n)}; m_n}{(\epsilon_{1n})^{1=4} (\operatorname{diam} X_n)^p} \xrightarrow{n \rightarrow \infty} 0 \text{ as } n \rightarrow \infty$$

for any $\epsilon > 0$. Then we have

$$\sup_n \frac{\operatorname{diam} X_n^{Lip_1} N; m_n}{(\epsilon_{1n})^{1=4} (\operatorname{diam} X_n)^p} \xrightarrow{n \rightarrow \infty} 0$$

as $n \rightarrow \infty$ for any $\epsilon > 0$.

Note that the assumption of the theorem directly implies that $fX_n g_{n=1}^1$ is a Levy family.

In the proof of Theorem 1.3, we find a point in a screen N which is a kind of barycenter of the push-forward measure on N , and prove that the measure concentrates to the point by the delicate discussions comparing N with a real hyperbolic space.

For $\epsilon_0 < 0$ and $n \geq N$, we indicate by $NM(n; \epsilon_0)$ the set of all n -dimensional complete simply connected Riemannian manifolds with negative sectional curvature bounded from below by ϵ_0 . A similar argument in the proof of Theorem 1.3 implies the following theorem.

Theorem 1.4. Let $f(X_n; d_n; m_n)g_{n=1}^1$ be a sequence of mm-spaces of finite diameter and $p = 1=2$. We assume that a sequence $a(n)g_{n=1}^1$ of natural numbers satisfies that

$$(1.3) \quad \frac{\operatorname{diam} X_n^{Lip_1} R^{a(n)}; m_n}{(\operatorname{diam} X_n)^p} \xrightarrow{n \rightarrow \infty} 0 \text{ as } n \rightarrow \infty$$

for any $\epsilon > 0$. Then for any $\epsilon > 0$ and $\epsilon_0 < 0$, we have

$$\sup_n \frac{\operatorname{diam} X_n^{Lip_1} N; m_n}{(\operatorname{diam} X_n)^p} \xrightarrow{n \rightarrow \infty} jN \geq N \text{ as } n \rightarrow \infty :$$

As corollaries of Theorem 1.3 and 1.4, we obtain L^p -concentration results of maps into N for $p = 1=2$ (see Corollary 4.22 and 4.23).

The next theorem says that if the screen Y is so big that the mm-space X which satisfies some homogeneity condition, can isometrically be embedded into Y , then its observable diameter $\operatorname{diam}(X^{Lip_1} Y; m_n)$ is not close to zero.

Theorem 1.5. Let $f(X_n; d_n; m_n)g_{n=1}^1$ be a Levy family with $\inf_{n \geq N} m_n > 0$ and $fY_n g_{n=1}^1$ a sequence of metric spaces satisfying the following conditions (1) – (3).

(1) $X_n = \operatorname{Supp}_{m_n}$ is connected.

- (2) For any $r > 0$ and $n \in \mathbb{N}$, all measures of closed balls in X_n with radius r are mutually equal.
(3) For each $n \in \mathbb{N}$, there exists an isometric embedding from X_n to Y_n .

Then, for any ϵ with $0 < \epsilon < \inf_{n \in \mathbb{N}} m_n$, we have

$$\liminf_{n=1}^{\infty} \text{infldiam}(X_n \xrightarrow{\text{Lip}_1} Y_n; m_n) \geq \frac{1}{2} \liminf_{n=1}^{\infty} \text{infldiam}(X_n);$$

From Theorem 1.5, we obtain the following corollary:

Corollary 1.6. For any ϵ with $0 < \epsilon < 1$, we have

$$\liminf_{n=1}^{\infty} \text{infldiam}(S^n \xrightarrow{\text{Lip}_1} R^{n+1}; 1) > 0;$$

Note that the dimension $n+1$ of the screen can be replaced by any natural number greater than n .

As an appendix, we discuss the case where the screen Y is a (combinatorial) tree and give some answer to Exercise of Section 3 $\frac{1}{2}$ -32 in [8]. Precisely, we prove the following proposition:

Proposition 1.7. Assume that a sequence $f(X_n; d_n; m_n) g_{n=1}^{\infty}$ of mm-spaces is a Levy family. Then, we have

$$\sup_{n \in \mathbb{N}} \text{supfdiam}(X_n \xrightarrow{\text{Lip}_1} T; m_n) \leq T \text{ is a tree} \Leftrightarrow 0 \text{ as } n \rightarrow \infty$$

for any $\epsilon > 0$.

2. Preliminaries

Let $(X; d)$ be a metric space. For $x \in X$, $r > 0$, and $A, B \subseteq X$, we put

$$B_x(x; r) = \{y \in X \mid d(x, y) \leq r\}; d(A, B) = \inf \{d(a, b) \mid a \in A, b \in B\};$$

$$d(x; A) = d(x, A) = \inf \{d(x, a) \mid a \in A\}; A_r = \{y \in X \mid d(x, y) \leq r\}.$$

We denote by m and m_n the total measure of mm-spaces X and X_n respectively, and by $\text{Supp } m$ the support of a Borel measure.

2.1. Observable diameter and Levy radius. In this subsection, we prove several results in [8] because we find no proof anywhere. Let $(X; d; m)$ be an mm-space and $f : X \rightarrow \mathbb{R}$ a Borel measurable function. A number $a_0 \in \mathbb{R}$ is called a pre-Levy mean of f if $f^{-1}([a_0, a_0 + 1]) = m = 2$ and $f^{-1}([a_0, a_0 + 1]) \neq m = 2$. We remark that a_0 does exist, but it is not unique for f in general. Let $A_f \subseteq \mathbb{R}$ be the set of all pre-Levy means of f . The proof of the following lemma is easy and we omit the proof.

Lemma 2.1 (cf. [8, Section 3 $\frac{1}{2}$ -19]). A_f is a closed bounded interval.

The Levy mean m_f of f is defined by $m_f = (a_f + b_f)/2$, where $a_f = \inf A_f$ and $b_f = \sup A_f$. For $\epsilon > 0$, we define the Levy radius, $\text{LeRad}(X; f)$, as the minimum of $\epsilon > 0$ such that every 1-Lipschitz function $f : X \rightarrow \mathbb{R}$ satisfies $|f(x) - f(y)| \leq \epsilon$ for all $x, y \in X$.

Lem m a 2.2 (cf. [8, Section 3 $\frac{1}{2}$:32]). For any $\epsilon > 0$, we have

$$\text{diam}(X \xrightarrow{\text{Lip}_1} R; m) \leq 2\text{LeR ad}(X; \epsilon).$$

P r o o f. Put $a = \text{LeR ad}(X; \epsilon)$. It follows from the definition of the Levy radius that $(fx 2 X \xrightarrow{\text{Lip}_1} f(x) - m_f g) \leq a$ for any 1-Lipschitz function $f : X \rightarrow R$. So we obtain $f(\cdot)(m_f; m_f + a) \leq m$, which implies $\text{diam}(f(\cdot); m) \leq \text{diam}(m_f; m_f + a) = 2a$. This completes the proof.

Lem m a 2.3 (cf. [8, Section 3 $\frac{1}{2}$:32]). For any ϵ with $0 < \epsilon < m/2$ we have

$$\text{LeR ad}(X; \epsilon) \geq \text{diam}(X \xrightarrow{\text{Lip}_1} R; m).$$

P r o o f. Put $a = \text{diam}(X \xrightarrow{\text{Lip}_1} R; m)$. For any $\epsilon' > 0$, there exists a closed interval $X_0 \subset R$ such that $f(\cdot)(X_0) \leq m$ and $\text{diam}(X_0) \geq a + \epsilon'$. We shall show that $m_f \geq X_0$. If $X_0 \subset (1; m_f)$, we have

$$\frac{m}{2} < m \quad f(\cdot)(X_0) \leq f(\cdot)(1; m_f) \leq \frac{m}{2},$$

which is a contradiction. In the same way, we have $X_0 \subset (m_f; +1)$. Hence, we get $m_f \geq X_0$, which yields $X_0 \subset [m_f - (a + \epsilon'); m_f + (a + \epsilon')]$ since $\text{diam}(X_0) \geq a + \epsilon'$. Therefore, we obtain

$$(fx 2 X \xrightarrow{\text{Lip}_1} f(x) - m_f g) = f(\cdot)(m_f - (a + \epsilon'); m_f + (a + \epsilon'))$$

$$f(\cdot)(X_0) \leq m \quad :$$

As a result, we have $\text{LeR ad}(X; \epsilon) \geq a + \epsilon'$, which completes the proof of the lemma.

Combining Lemmas 2.2 and 2.3, we obtain the following corollary.

C orollary 2.4 (cf. [8, Section 3 $\frac{1}{2}$:32]). A sequence $fx_n g_{n=1}^1$ of mm-spaces is a Levy family if and only if $\text{LeR ad}(X_n; \epsilon) \neq 0$ as $n \rightarrow \infty$ for any $\epsilon > 0$.

2.2. Levy radius and concentration function. Given an mm-space $(X; d)$, we define the function $x : (0; +1) \rightarrow R$ by

$$x(r) = \sup_{A \in \mathcal{B}} (X \setminus A) \setminus A \text{ is a Borel subset of } X \text{ such that } |A| = 2r;$$

and call it the concentration function of X . Although the following lemmas and corollary are somewhat standard, we prove them for the completeness of this paper.

Lem m a 2.5 (cf. [11, Section 1.3]). For any $r > 0$ we have

$$\text{LeR ad}(X; 2x(r)) = r;$$

P r o o f. Let $f : X \rightarrow R$ be a 1-Lipschitz function. We put $A = fx 2 X \xrightarrow{\text{Lip}_1} f(x) - m_f g$ and $A^0 = fx 2 X \xrightarrow{\text{Lip}_1} f(x)g$. Then,

$$fx 2 X \xrightarrow{\text{Lip}_1} f(x) - m_f + rg = X \setminus fx 2 X \xrightarrow{\text{Lip}_1} f(x) < m_f + rg = X \setminus A^0;$$

In the same way,

$$f(x) \geq X - jm_f - f(x) + rg - X n A_{+r}^0;$$

Since (A) $m=2$ and (A^0) $m=2$, we have

$$\begin{aligned} (f(x) - j\bar{f}(x) - m_f j - rg) &= (f(x) - j\bar{f}(x) - m_f + rg) + (f(x) - jm_f - f(x) + rg) \\ &\quad (X n A_{+r}) + (X n A_{+r}^0) \\ &= 2_{+r}(x); \end{aligned}$$

This completes the proof.

Lemma 2.6 (cf. [11, Section 1.3]). For any ϵ with $0 < \epsilon < m = 2$, we have

$$x \in 2\text{LeRad}(X; \epsilon);$$

Proof. Let A be a Borel subset of X such that (A) $m=2$. We define a function $f : X \rightarrow \mathbb{R}$ by $f(x) = d(x; A)$. Putting $\epsilon = \text{LeRad}(X; \epsilon)$, by the definition of the Levy radius, we have $f(x) - j\bar{f}(x) - m_f j < \epsilon$. Then we get

$$\begin{aligned} f(x) - j\bar{f}(x) - m_f j &< \epsilon \\ (m - \epsilon) + m &= 2 - m = m = 2 > 0; \end{aligned}$$

Hence, there exists a point $x_0 \in f(x) - j\bar{f}(x) - m_f j < \epsilon \setminus A$ and we have $m_f = \bar{f}(x_0) - m_f j < \epsilon$. Consequently, we obtain

$$(X n A_{+2}) = f(x) - 2g \subset f(x) - j\bar{f}(x) - m_f j - g;$$

which completes the proof of the lemma.

Corollary 2.7. A sequence $fX_n g_{n=1}^1$ of m_m -spaces is a Levy family if and only if $x_n(r) \neq 0$ as $n \neq 1$ for any $r > 0$.

Proof. Let $fX_n g_{n=1}^1$ be a Levy family. Fix $r > 0$ and take any $\epsilon > 0$. For an $n \in \mathbb{N}$ with $m_n = 2 - \epsilon$, we have $x_n(r) = \epsilon$. Hence, we only consider the case of $m_n = 2 > \epsilon$. From the assumption, we have $2\text{LeRad}(X_n; \epsilon) \geq r$ for any sufficiently large $n \in \mathbb{N}$. Therefore, by virtue of Lemma 2.6, we have

$$x_n(r) \in X_n \cap 2\text{LeRad}(X_n; \epsilon);$$

which shows $x_n(r) \neq 0$ as $n \neq 1$.

Conversely, assume that $x_n(r) \neq 0$ as $n \neq 1$ for any $r > 0$. Fix $\epsilon > 0$ and take any $\epsilon' > 0$. From the assumption, we have $2_{+r}(\epsilon') \geq r$ for any sufficiently large $n \in \mathbb{N}$. Therefore, applying Lemma 2.5 to X_n , we obtain

$$\text{LeRad}(X_n; \epsilon) \geq \text{LeRad}(X_n; 2_{+r}(\epsilon')) = \epsilon';$$

This completes the proof.

2.3. Concentration function and separation distance. Let $(X; d; \mu)$ be an mm-space. For any $0; 1; \dots; N \in \mathbb{N}$, we define

$$\begin{aligned} \text{Sep}(X; 0; \dots; N) &= \text{Sep}(X; 0; \dots; N) \\ &= \sup_{\substack{\text{Borel subsets } X_i, X_j \\ i \neq j}} d(X_i, X_j); \quad \text{if } X_i, X_j \text{ are Borel subsets of } X \\ &\quad \text{which satisfy } |X_i| = \frac{1}{N} \text{ for any } i; \end{aligned}$$

and call it the separation distance of X . In this subsection, we investigate the relationships between the concentration function and the separation distance. The proof of the following lemma is easy, and we omit it the proof.

Lemma 2.8 (cf. [8, Section 3.2]). Let $(X; d_X; \mu_X)$ and $(Y; d_Y; \mu_Y)$ be two mm-spaces. Assume that a 1-Lipschitz map $f : X \rightarrow Y$ satisfies $f(\mu_X) = \mu_Y$. Then we have

$$\text{Sep}(Y; 0; \dots; N) = \text{Sep}(X; 0; \dots; N);$$

Let us recall that the Hausdorff distance between two bounded closed subsets A and B in a metric space X is defined by

$$d_H(A; B) = \inf \{r > 0 \mid A \subset B_r; B \subset A_r\};$$

It is easy to check that d_H is the metric on the set C_X of all bounded closed subsets of X .

Lemma 2.9 (Blaschke, cf. [1, Theorem 4.4.15]). If X is a compact metric space, then $(C_X; d_H)$ is also compact.

Lemma 2.10. Let $(X; d; \mu)$ be an mm-space and assume that $\text{Supp } \mu$ is connected. Then, for any $r > 0$ with $\mu_X(r) > 0$ we have

$$\text{Sep}(X; \frac{m}{2}; \mu_X(r)) = r;$$

Proof. The proof is by contradiction. We may assume that $X = \text{Supp } \mu$. Suppose that $\text{Sep}(X; m=2; \mu_X(r)) > r$, there exist $r_0 > 0$ with $r_0 > r$ and Borel subsets $X_1, X_2 \subset X$ such that $|X_1| = m=2, |X_2| = \mu_X(r)$, and $d(X_1, X_2) > r_0$. Let us show that $(X_1)_r + (X_1)_{r_0} = X$. If $(X_1)_r = (X_1)_{r_0}$, we have $X = (X_1)_r \cup X \setminus (X_1)_{r_0}$. Since X is connected, we get either $X_1 = \emptyset$ or $X \setminus (X_1)_{r_0} = \emptyset$. It follows from $|X_1| = m=2 > 0$ that $(X_1)_r \neq \emptyset$. By $d(X_1, X_2) > r_0$, we obtain $X_2 \subset X \setminus (X_1)_{r_0}$, which implies that $X \setminus (X_1)_{r_0} \subset (X_2) \subset \mu_X(r) > 0$. Therefore, we have $X \setminus (X_1)_{r_0} \neq \emptyset$, which is a contradiction. Thus, there exists a point $x_0 \in X \setminus (X_1)_r \cap X \setminus (X_1)_{r_0}$. Taking a sufficient small ball B centered at x_0 such that $B \subset X \setminus (X_1)_r$ and $B \setminus X \setminus (X_1)_{r_0} = \emptyset$, we have

$$\begin{aligned} (X_2) \subset \mu_X(r) &\subset X \setminus (X_1)_r \\ B \setminus (X \setminus (X_1)_{r_0}) &= (B) + (X \setminus (X_1)_{r_0}) \\ &> X \setminus (X_1)_{r_0} = (X_2); \end{aligned}$$

which is a contradiction. Therefore, we have finished the proof.

Remark 2.11. If $\text{Supp } f$ is disconnected, the above lemma does not hold in general. For example, consider the space $X = \{x_1, x_2\}$ with a metric d given by $d(x_1, x_2) = 1$ and with a Borel probability measure given by $(fx_1) = (fx_2) = \frac{1}{2}$. In this case, we have $x(1=2) = 1=2$ and $\text{Sep}(; 1=2; 1=2) = 1$.

Lemma 2.12. For any $r > 0$ there exists a Borel subset $X_0 \subset X$ such that

$$X \cap (X_0)_{+r} = x(r) \text{ and } (X_0) \cap \frac{m}{2} :$$

Proof. From the definition of the concentration function, for any $n \geq N$, there exist a closed subset $A_n \subset X$ such that

$$(A_n) \cap \frac{m}{2} \text{ and } X \cap (A_n)_{+r} + \frac{1}{n} = x(r) :$$

Take an increasing sequence $K_1 \subset K_2 \subset \dots$ of compact subsets of X such that $\lim_{n \rightarrow \infty} K_n = X$. By using Lemma 2.9 and the diagonal argument, we have that $f(A_n \setminus K_i g_{n=1}^1)$ Hausdorff converges to a closed subset $B_i \subset K_i$ and $f(X \cap (A_n)_{+r} \setminus K_i g_{n=1}^1)$ Hausdorff converges to a closed subset $C_i \subset K_i$ for each $i \geq N$. Put $K = \bigcup_{i=1}^{\infty} A_i$; $R = \bigcup_{i=1}^{\infty} C_i$, $X_0 = \overline{K}$, and $Y_0 = \overline{R}$. It is easy to check that $B_1 \subset B_2 \subset \dots$ and $C_1 \subset C_2 \subset \dots$. We will show that $d(K; R) \geq r$ by contradiction. If $d(K; R) < r$, there exists $r_0 > 0$ such that $d(K; R) < r_0 < r$. Hence there exist $x \in K$ and $y \in R$ such that $d(x; y) < r_0$. There exists $i \geq N$ such that $x \in B_i$ and $y \in C_i$, because both $f(B_n g_{n=1}^1)$ and $f(C_n g_{n=1}^1)$ are increasing sequences. Since both $f(A_n \setminus K_i g_{n=1}^1)$ and $f(X \cap (A_n)_{+r} \setminus K_i g_{n=1}^1)$ Hausdorff converge to B_i and C_i respectively, there exist two sequences $fx_n g_{n=1}^1, fy_n g_{n=1}^1 \in X$ such that $d(x_n; x) = d(y_n; y) = 0$ as $n \geq 1$, and $x_n \in A_n$; $d(y_n; A_n) \geq r$ for any $n \geq N$. Therefore, for any sufficiently large $n \geq N$ we have

$$d(x_n; y_n) = d(x_n; x) + d(x; y) + d(y_n; y) < r_0 + d(x_n; x) + d(y_n; y) < r;$$

which is a contradiction, because $x_n \in A_n$ and $d(y_n; A_n) \geq r$. Thus, we obtain $d(K; R) \geq r$ which yields that $d(X_0; Y_0) \geq r$ and therefore $Y_0 \subset X \cap (X_0)_{+r}$. Let us show that $(X_0) \cap m=2 = \emptyset$ and $(Y_0) \cap x(r) = \emptyset$. For any $\epsilon > 0$ there exists $n_0 \geq N$ such that $(K_{n_0}) + \epsilon \subset m$. Take any $\epsilon > 0$. Then, for any sufficiently large m we have $A_m \setminus K_{n_0} \subset (B_{n_0})$. Therefore,

$$(X_0) \cap (B_{n_0}) \cap (A_m \setminus K_{n_0}) = (A_m) + (K_{n_0}) \cap m \cap \frac{m}{2} - \epsilon :$$

By taking $\epsilon \rightarrow 0$, we obtain $(X_0) \cap m=2 = \emptyset$, which shows $(X_0) \cap m=2 = \emptyset$. In the same way, we have $(Y_0) \cap x(r) = \emptyset$. This completes the proof.

Lemma 2.12 directly implies

Lemma 2.13. For an m -space X and $r > 0$, we have

$$\text{Sep}(X; \frac{m}{2}; x(r)) \geq r:$$

Corollary 2.14. If a sequence $fx_n g_{n=1}^1$ of m -spaces satisfies that $\text{Sep}(X_n; ;) \geq 0$ as $n \geq 1$ for any $\epsilon > 0$, we then have $x_n(r) \geq 0$ as $n \geq 1$ for any $r > 0$.

Proof. Suppose that there exists $c > 0$ such that $x_n(r) \geq c$ for infinitely many $n \in \mathbb{N}$. Applying Lemma 2.13 to X_n , we have

$$r \leq \text{Sep}(X_n; \frac{m_n}{2}; x_n(r)) \leq \text{Sep}(X_n; x_n(r); x_n(r)) = \text{Sep}(X_n; c; c);$$

This is a contradiction, since the right-hand side of the above inequality converges to 0 as $n \rightarrow \infty$. This completes the proof.

Lemma 2.15 (cf. [11, Lemma 1.1]). Let $(X; d; \mu)$ be an mm-space. Assume that a Borel subset $A \subset X$ and $r_0 > 0$ satisfy (A) and $x(X; r_0) < \infty$. Then, for any $r > 0$ we have

$$x_n(A_{(r_0+r)}) \leq x_n(r);$$

Corollary 2.16. Assume that a sequence $f(X_n; d_n; \mu_n)_{n=1}^\infty$ of mm-spaces satisfy $x_n(r) \geq 0$ as $n \in \mathbb{N}$ for any $r > 0$. Then, we have $\text{Sep}(X_n; \mu_n) \geq 0$ as $n \in \mathbb{N}$ for any $r > 0$.

Proof. Since $\text{Sep}(X_n; \mu_n) = 0$ for $n \in \mathbb{N}$ with $m_n < \infty$, we assume that $m_n = \infty$ for any $n \in \mathbb{N}$. For any $\epsilon > 0$, we have $x_n(\epsilon) < \infty$ for any sufficiently large $n \in \mathbb{N}$ from the assumption. Thus, it follows from Lemma 2.15 that $x_n(X_n \cap (A_n)_{+2\epsilon}) \leq x_n(\epsilon) < \infty$ for any Borel sets $A_n; B_n \subset X_n$ with $A_n \cup B_n = X_n$. In the same way, we get $x_n(X_n \cap (B_n)_{+2\epsilon}) < \infty$. Therefore, we obtain

$$\begin{aligned} x_n(X_n \cap (A_n)_{+2\epsilon}) \setminus (B_n)_{+2\epsilon} &\leq x_n(X_n \cap (A_n)_{+2\epsilon}) + x_n(X_n \cap (B_n)_{+2\epsilon}) \\ &< m_n; \end{aligned}$$

which implies $x_n((A_n)_{+2\epsilon}) \setminus (B_n)_{+2\epsilon} > 0$, and thereby $((A_n)_{+2\epsilon}) \setminus (B_n)_{+2\epsilon} \neq \emptyset$. As a consequence, we have $\text{diam}(A_n; B_n) \geq 4\epsilon$, which shows $\text{Sep}(X_n; \mu_n) \geq 4\epsilon$. This completes the proof.

Combining Corollaries 2.14 and 2.16, we obtain the following corollary.

Corollary 2.17 (cf. [8, Section 3.2.33]). A sequence $f(X_n)_{n=1}^\infty$ of mm-spaces is a Levy family if and only if $\text{Sep}(X_n; \mu_n) \geq 0$ as $n \in \mathbb{N}$ for any $r > 0$.

3. Proof of the Main theorem

Let M be a complete Riemannian manifold and μ a Borel measure on M such that $\text{Supp } \mu$ is compact and $\mu(M) < +1$. We consider the function $d : M \times M \rightarrow \mathbb{R}$ defined by

$$d(x) = \inf_{y \in M} \frac{d_M(x, y)}{\mu(y)},$$

where d_M is the Riemannian distance on M . The proof of the following lemma is easy and we omit the proof.

Lemma 3.1. There exists a point $x \in M$ such that d attains its minimum and

$$d_M(x; \text{Supp } \mu) = 2\text{diam}(\text{Supp } \mu);$$

Remark 3.2. The above x is not unique in general. For example, consider a $M = \mathbb{R}$ and a Borel probability measure on \mathbb{R} given by $f_0g = f_1g = 1/2$. In this case, the points 0 and 1 imply the minimum of the function d .

From now on, we consider the m -dimensional hyperbolic space H^m as a Poincaré disk model $D_m = \{x \in \mathbb{R}^m \mid \|x\| < 1\}$. For $\kappa < 0$, we denote by $H^m(\kappa)$ a complete simply connected Riemannian manifold of constant curvature κ . We consider $(H^m(\kappa); d_{H^m(\kappa)})$ as $(D_m; (1 - \frac{\|x\|^2}{1 - \kappa})^{-1} d_{H^m})$.

Lemma 3.3 (cf. [20, Theorem 4.6.1]). For any $x, y \in H^m$ we have

$$d_{H^m}(x, y) = 2 \log \frac{\sqrt{1 - \|x\|^2} \sqrt{1 - \|y\|^2}}{\sqrt{1 - \|x\|^2} \sqrt{1 - \|y\|^2} + \sqrt{(1 - \|x\|^2)(1 - \|y\|^2)}} + 1 :$$

Proof of Theorem 1.3. The claim obviously holds in the case of $\lim_{n \rightarrow \infty} \text{diam } X_n = 0$, so we assume that $\inf_{n \in \mathbb{N}} \text{diam } X_n > 0$. Under this assumption, since $\lim_{n \rightarrow \infty} m_n = 0$ implies the claim, we also assume that $\inf_{n \in \mathbb{N}} m_n > 0$. Note that there is a sequence $f_n g_{n=1}^1$ of positive numbers such that $f_n \rightarrow 0$ as $n \rightarrow \infty$ and for any $p > 0$

$$\frac{p}{2n} \text{diam } X_n \stackrel{\text{Lip}_1}{\rightarrow} R^{a(n)}; m_n \rightarrow \frac{n}{(1_{1n})^{1-p} (\text{diam } X_n)^p} \rightarrow 0 \text{ as } n \rightarrow \infty :$$

Hence we only consider the case that $1_{1n} = 2n + 1$ as $n \rightarrow \infty$.

Let $f N_n g_{n=1}^1$ be any sequence such that $N_n \subset N M(a(n); 1_{1n}; 2n)$ for each $n \in \mathbb{N}$ and $f f_n : X_n \rightarrow N_n g_{n=1}^1$ be any sequence of 1-Lipschitz maps. Let $p_n \in N_n$ be the minimum of the function $d_{(f_n)(n)} : N_n \rightarrow \mathbb{R}$. We shall show that

$$(f_n)(n) N_n \cap B_{N_n}(p_n; r) \rightarrow \frac{1}{(1_{1n})^{1-p} (\text{diam } X_n)^p}$$

for any $r > 0$ with $\inf_{1 \leq n \leq N} (1_{1n})^{1-p} (\text{diam } X_n)^p = (2 \inf_{1 \leq n \leq N} 1_{1n})^p$ and sufficiently large $n \in \mathbb{N}$.

Since N_n is simply connected and has nonpositive sectional curvature, N_n has no cut locus at any point. Let e_n be a linear isometry from the tangent space of N_n at p_n to the tangent space of $H^{a(n)}(2n)$ at 0 and put $\phi_n = \exp_{p_n}^{-1} e_n \exp_{p_n}^1 : N_n \rightarrow H^{a(n)}(2n)$. By virtue of the hinge theorem (cf. [21, Chapter IV, Remark 2.6]), we have

$$\frac{1}{2n} d_{H^{a(n)}}(\phi_n(x), \phi_n(x^0)) \rightarrow d_{N_n}(x, x^0)$$

for any $x, x^0 \in N_n$. Since ϕ_n is the $\frac{p}{2n}$ -Lipschitz map from X_n to the Euclidean space $(D_{a(n)}; d_{R^{a(n)}})$, from the assumption there exists a Borel subset $A_n \subset D_{a(n)}$ such that $A_n \subset \text{Supp}(\phi_n)(n)$, $\phi_n(A_n) \geq m_n = (1_{1n})^{1-p} (\text{diam } X_n)^p$, and $\text{diam}(A_n; d_{R^{a(n)}}) \neq 0$ as $n \rightarrow \infty$.

Let us show that $d_{H^{a(n)}}(A_n; 0) \neq 0$ as $n \rightarrow \infty$. Suppose that $d_{H^{a(n)}}(A_n; 0) = 0$ for any $n \in \mathbb{N}$ and some $r > 0$. For any $x \in D_{a(n)}$, we take $y \in D_{a(n)}$ such that $y = x$ as a vector

in $R^{a(n)}$ for some $\epsilon > 0$ and

$$\frac{1}{\inf_{1n} d_{H^{a(n)}}(0; y)} = \frac{1}{\inf_{2n} d_{H^{a(n)}}(0; x)}.$$

We define $\pi_n : D_{a(n)} \setminus D_{a(n)}$ by $\pi_n(x) = y$. Since $1_n = 2_n + 1$ as $n \rightarrow 1$ and $d_{H^{a(n)}}(A_n; 0) \rightarrow 0$ for any $n \geq N$, we get $\text{diam } (\pi_n(A_n); d_{R^{a(n)}})$, $d_{R^{a(n)}}(\pi_n(A_n); S^{a(n)-1}) \rightarrow 0$ as $n \rightarrow 1$. Since $\text{diam } (A_n; d_{R^{a(n)}})$, $d_{R^{a(n)}}(A_n; S^{a(n)-1}) \rightarrow 0$ as $n \rightarrow 1$, there are points $q_n \in D_{a(n)}$ having the following properties (1), (2):

- (1) $|q_n| \leq 1$ as $n \rightarrow 1$.
- (2) $|q_n - x| \leq 1$ and $|q_n - y| \leq 1$ for any $x \in \pi_n(A_n)$.

Claim 3.4. For any $n \geq N$ and $x \in \pi_n^{-1}(A_n) \setminus f_n(X_n)$, we have

$$p \frac{1}{d_{N_n}(p_n; x)} = q \frac{1}{d_{N_n}(\pi_n^{-1}(q_n); x)} + p \frac{c_n}{\text{diam } X_n},$$

where c_n are positive numbers satisfying $\lim_{n \rightarrow 1} c_n = d_{N_n}(p_n; \pi_n^{-1}(q_n)) = 1 = (2^{\frac{p}{2}} - 1)$.

Proof. According to the hinge theorem (cf. [21, Chapter IV, Theorem 4.2 (2)]), we have $d_{N_n}(\pi_n^{-1}(q_n); x) = (1 - \frac{p}{1_n}) d_{H^{a(n)}}(q_n; \pi_n^{-1}(q_n)(x))$. Note that also $d_{N_n}(p_n; x) = (1 - \frac{p}{1_n}) d_{H^{a(n)}}(0; \pi_n^{-1}(q_n)(x))$. Therefore, from Lemma 3.3 and (2), we have

$$\begin{aligned} & p \frac{1}{d_{N_n}(p_n; x)} = p \frac{1}{d_{N_n}(\pi_n^{-1}(q_n); x)} \\ & d_{H^{a(n)}}(0; \pi_n^{-1}(q_n)(x)) = d_{H^{a(n)}}(q_n; \pi_n^{-1}(q_n)(x)) \\ & = \log \frac{1}{\frac{1}{|q_n - \pi_n^{-1}(q_n)(x)|} + p \frac{1}{|q_n - \pi_n^{-1}(q_n)(x)|} (1 + |q_n - \pi_n^{-1}(q_n)(x)|)} \\ & = \log \frac{1}{\frac{1}{1 - \frac{p}{1_n}} + p \frac{1}{(1 - \frac{p}{1_n})^2} (1 + |q_n - \pi_n^{-1}(q_n)(x)|)} \\ & = \log \frac{1}{2} \frac{(1 + \frac{p}{1_n})(1 + |q_n - \pi_n^{-1}(q_n)(x)|)}{\frac{1}{1 - \frac{p}{1_n}} + p \frac{(1 + \frac{p}{1_n})(1 + |q_n - \pi_n^{-1}(q_n)(x)|)}{(1 - \frac{p}{1_n})^2}} \\ & = \log \frac{1}{2} \frac{(1 + \frac{p}{1_n})(1 + |q_n - \pi_n^{-1}(q_n)(x)|)}{\frac{1}{1 - \frac{p}{1_n}} + p \frac{(1 + \frac{p}{1_n})(1 + |q_n - \pi_n^{-1}(q_n)(x)|)}{(1 - \frac{p}{1_n})^2}} \\ & \log \frac{1}{2} \frac{(1 + \frac{p}{1_n})^2}{\frac{1}{1 - \frac{p}{1_n}} + p \frac{(1 + \frac{p}{1_n})^2}{(1 - \frac{p}{1_n})^2}} = : \frac{p}{1_n} b_n: \end{aligned}$$

Thus, we get

$$\begin{aligned}
 & \frac{p}{d_{N_n}(p_n; x)} - \frac{q}{d_{N_n}((n - n')^{-1}(q_n); x)} \\
 & \leq \frac{q}{d_{N_n}((n - n')^{-1}(q_n); x) + b_n} - \frac{q}{d_{N_n}((n - n')^{-1}(q_n); x)} \\
 & \leq \frac{b_n}{d_{N_n}((n - n')^{-1}(q_n); x) + b_n + d_{N_n}((n - n')^{-1}(q_n); x)} \\
 & = \frac{b_n}{p \frac{d_{N_n}(p_n; x)}{d_{N_n}(p_n; x)} + q \frac{b_n}{d_{N_n}((n - n')^{-1}(q_n); x)}} \\
 & = \frac{b_n}{\frac{p}{2} \frac{d_{N_n}(p_n; x)}{d_{N_n}(p_n; x)} + \frac{p}{2} \frac{b_n}{diam X_n}}:
 \end{aligned}$$

Applying Lemma 3.1, we have $d_{N_n}(p_n; x) \geq 2 \text{diam } X_n$. Therefore we obtain

$$\frac{p}{d_{N_n}(p_n; x)} - \frac{q}{d_{N_n}((n - n')^{-1}(q_n); x)} \geq \frac{p}{2} \frac{b_n}{2 \text{diam } X_n}:$$

Since $\lim_{n \rightarrow \infty} b_n = d_{N_n}(p_n; (n - n')^{-1}(q_n)) = 1$, putting $c_n = b_n/(2 \frac{p}{2})$, this completes the proof of the claim.

Assume first that $(n - n')^{-1}(H^{a(n)} n A_n) = 0$ for infinitely many $n \geq N$. Then, by using Claim 3.4, we get

$$d_{(f_n)(n)}((n - n')^{-1}(q_n)) \leq d_{(f_n)(n)}(p_n) - p \frac{m_n c_n}{\text{diam } X_n} < d_{(f_n)(n)}(p_n):$$

This is a contradiction since $p_n \geq N_n$ is the supremum of the function $d_{(f_n)(n)}$.

We consider the other case that $(\ell_n - f_n)(\pi_n(H^{a(n)} n A_n)) > 0$ for any sufficiently large $n \in \mathbb{N}$. Put $B_n := X_n \setminus (\ell_n - f_n)^{-1}(A_n)$. By virtue of Claim 3.4, we have

$$\begin{aligned}
 & \frac{d_{(f_n)(\pi_n)}(\pi_n(\ell_n)^{-1}(q_n))}{Z} \\
 = & \frac{d_{N_n}(\pi_n(\ell_n)^{-1}(q_n); f_n(x_n))}{(\ell_n - f_n)^{-1}(A_n)} d_n(x_n) \\
 & + \frac{Z}{B_n} \frac{d_{N_n}(\pi_n(\ell_n)^{-1}(q_n); f_n(x_n))}{d_n(x_n)} \\
 Z & \frac{d_{N_n}(p_n; f_n(x_n))}{d_n(x_n)} + \frac{p \frac{C_n}{\text{diam } X_n} (\ell_n - f_n)(\pi_n(A_n))}{d_{N_n}(\pi_n(\ell_n)^{-1}(q_n); f_n(x_n))} \\
 & + \frac{d_{(f_n)(\pi_n)}(p_n) - p \frac{C_n}{\text{diam } X_n} \inf_{1 \leq i \leq n} \frac{1}{(\ell_{1n})^{1=4} (\text{diam } X_n)^p}}{d_{N_n}(\pi_n(\ell_n)^{-1}(q_n); f_n(x_n))} \\
 & + \frac{\epsilon_1 \frac{d_{N_n}(\pi_n(\ell_n)^{-1}(q_n); f_n(x_n))}{d_{N_n}(\pi_n(\ell_n)^{-1}(q_n); f_n(x_n))} + \frac{d_{N_n}(p_n; f_n(x_n))}{d_{N_n}(p_n; f_n(x_n))}}{d_n(x_n)}.
 \end{aligned}$$

Since

$$\begin{aligned}
 & \frac{n^q}{(\ell_{1n})^{1=4}} \frac{d_{N_n}(\pi_n(\ell_n)^{-1}(q_n); f_n(x_n))}{d_{N_n}(p_n; f_n(x_n))} + \frac{d_{N_n}(p_n; f_n(x_n))}{d_{N_n}(p_n; f_n(x_n))} \rightarrow 0 \\
 & \frac{q}{p} \frac{d_{N_n}(p_n; f_n(x_n))}{d_{N_n}(p_n; f_n(x_n))} = 2 \\
 & = \frac{p}{d_{H^{a(n)}}(0; q_n)} = 2 ! + 1 \quad \text{as } n \rightarrow 1 ;
 \end{aligned}$$

$\inf_{\mathbb{Z}^N} (\text{diam } X_n)^p = (2 \inf_{\mathbb{Z}^N} 1)$, and $\lim_{n \rightarrow 1} c_n = d_{N_n}(p_n; (x_n, x'_n)^{-1}(q_n)) = 1 = (2^{\frac{p}{2}})$, we get

$$\begin{aligned} & \frac{c_n}{p \overline{\text{diam } X_n}} \inf_{\mathbb{Z}^N} 1 - \frac{(\text{diam } X_n)^p}{(2 \inf_{\mathbb{Z}^N} 1)^{1=4} (\text{diam } X_n)^p} \\ & + \frac{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)}{B_n} \frac{d_{N_n}(p_n; f_n(x_n))}{q} d_n(x_n) \\ & \frac{c_n \inf_{\mathbb{Z}^N} 1}{2^p \overline{\text{diam } X_n}} + \frac{Z}{B_n} \frac{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)}{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)} \frac{d_{N_n}(p_n; f_n(x_n))}{q} d_n(x_n) \\ & Z \frac{n}{B_n} \frac{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)}{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)} \frac{d_{N_n}(p_n; f_n(x_n))}{q} \\ & \frac{c_n (2 \inf_{\mathbb{Z}^N} 1)^{1=4} \inf_{\mathbb{Z}^N} (\text{diam } X_1)^p}{2} \frac{1=2}{\inf_{\mathbb{Z}^N} 1} \frac{d_n(x_n)}{d_n(x_n)} \\ & Z \frac{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)}{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)} \frac{d_{N_n}(p_n; f_n(x_n))}{q} \frac{2 d_{N_n}(p_n; (x_n, x'_n)^{-1}(q_n))}{d_n(x_n)} d_n(x_n) \\ & Z \frac{d_{N_n}(p_n; (x_n, x'_n)^{-1}(q_n))}{d_{N_n}(x_n, x'_n)^{-1}(q_n); f_n(x_n)} \frac{d_n(x_n)}{d_n(x_n)} < 0 \end{aligned}$$

for any sufficiently large $n \geq N$. Therefore we obtain $d_{(f_n)(x_n)}(x_n, x'_n)^{-1}(q_n) < d_{(f_n)(x_n)}(p_n)$ for any sufficiently large $n \geq N$. Consequently we have a contradiction since $p_n \geq M_n$ is the maximum of the function $d_{(f_n)(x_n)}$.

Since $d_{H^a(n)}(A_n; 0) \neq 0$ as $n \geq 1$, we get

$$A_n = B_{H^a(n)}(0; r \inf_{\mathbb{Z}^N} \frac{p}{2}) = B_{H^a(n)}(0; r \frac{p}{2}) = B_{N_n}(p_n; r)$$

for any $r > 0$ and sufficiently large $n \geq N$. Therefore we obtain

$$(f_n)(x_n) \in B_{N_n}(p_n; r) \quad (f_n)(x_n) \in B_{N_n}(p_n; r) \subset \overline{(x_n, x'_n)^{-1}(A_n)} \subset \overline{(\text{diam } X_n)^p}$$

for any sufficiently large $n \geq N$. This completes the proof of the theorem.

Proof of Theorem 1.4. As in the proof of Theorem 1.3, we assume that $\inf_{n \geq N} p_n > 0$ and $\inf_{n \geq N} \text{diam } X_n > 0$. Let $f N_n g_{n=1}^1$ be any sequence such that $N_n \geq N M(a(n); r_0)$ for each $n \geq N$ and $f f_n : X_n \rightarrow N_n g_{n=1}^1$ be any sequence of 1-Lipschitz maps. We shall show that

$$(f_n)(x_n) \in B_{N_n}(p_n; r) \subset \overline{(\text{diam } X_n)^p}$$

for any $r > 0$ such that $\inf_{\mathbb{D}^N} (\text{diam } X_1)^p = (2 \inf_{\mathbb{D}^N} m_1)$ and $r < 1$. Let $p_n \in N_n$ be the minimum of the function $d_{(f_n)}(\cdot, p_n) : N_n \rightarrow \mathbb{R}$. Take $r_n > 0$ with $\overline{B_{N_n}(p_n; r_n)} \subset B_{N_n}(p_n; r_n)$ and let ϵ_n be negative numbers such that the sectional curvature on $B_{N_n}(p_n; r_n)$ is bounded from above by ϵ_n and $\epsilon_n \rightarrow 0$ as $n \rightarrow 1$. Let ϵ_n be a linear isometry from the tangent space of N_n at p_n to the tangent space of $H^{a(n)}(N_n)$ at 0 and put $\gamma_n = \exp_0^{-1} \circ \exp_{p_n}^1 : B_{N_n}(p_n; r_n) \rightarrow B_{H^{a(n)}(N_n)}(0; r_n)$. By virtue of the hinge theorem, we have

$$\frac{1}{p} \leq \frac{d_{H^{a(n)}}(\gamma_n(x), \gamma_n(x^0))}{d_{N_n}(x, x^0)}$$

for any $x, x^0 \in B_{N_n}(p_n; r_n)$. Since γ_n is the $\frac{p}{n}$ -Lipschitz map from X_n to the Euclidean space $(D_{a(n)}, d_{R^{a(n)}})$, from the assumption there exists a Borel subset $A_n \subset D_{a(n)}$ and $m_n > 0$ such that $m_n \rightarrow 0$ as $n \rightarrow 1$, $A_n \subset \text{Supp}(\gamma_n)_n \subset B_{H^{a(n)}(N_n)}(0; r_n)$, $(\gamma_n)_n(A_n) > m_n = (\text{diam } X_n)^p$, and $\text{diam}(A_n; d_{R^{a(n)}}) \geq \frac{p}{n}$.

Let us show that $d_{H^{a(n)}}(A_n; 0) = \frac{p}{n} \rightarrow 0$ as $n \rightarrow 1$. Suppose that there is a constant $C > 0$ such that $d_{H^{a(n)}}(A_n; 0) \geq C \frac{p}{n}$ for any $n \in \mathbb{N}$. For any $x \in D_{a(n)}$, we take $y \in D_{a(n)}$ such that $y = x$ as a vector in $R^{a(n)}$ for some $e = 0$ and

$$\frac{1}{p} \leq \frac{d_{H^{a(n)}}(0; y)}{d_{N_n}(0; x)} = \frac{1}{p} \leq \frac{d_{H^{a(n)}}(0; x)}{d_{N_n}(x, y)}$$

We denote $\gamma_n : D_{a(n)} \rightarrow D_{a(n)}$ by $\gamma_n(x) = y$. Since $\text{diam}(A_n; d_{R^{a(n)}}) \geq \frac{p}{n}$, $d_{H^{a(n)}}(A_n; 0) \geq C \frac{p}{n}$, and $m_n \rightarrow 0$ as $n \rightarrow 1$, we obtain

$$\text{diam}((\gamma_n)_n(A_n); d_{R^{a(n)}}) \geq \text{diam}((\gamma_n)_n(A_n); S^{a(n)-1}) \rightarrow 0 \text{ as } n \rightarrow 1 :$$

Thus, as in the proof of Theorem 1.3, we have a contradiction.

From $d_{H^{a(n)}}(A_n; 0) = \frac{p}{n} \rightarrow 0$ as $n \rightarrow 1$ and $\text{diam}(A_n; d_{R^{a(n)}}) \geq \frac{p}{n}$, we get

$$A_n \subset B_{H^{a(n)}}(0; r_n) = (\gamma_n)_n B_{N_n}(p_n; r_n)$$

for any $r > 0$ with $r < 1$ and sufficiently large $n \in \mathbb{N}$. Therefore we obtain

$$(f_n)_n N_n \cap B_{N_n}(p_n; r) \subset (f_n)_n N_n \cap (\gamma_n)_n A_n \subset \overline{(diam X_n)^p}$$

for any sufficiently large $n \in \mathbb{N}$. This completes the proof of the theorem.

Proof of Theorem 1.5. By (2) and $m_n < +1$, X_n is compact. Hence, there exist $x_n, y_n \in X_n$ such that $\text{diam } X_n = d_n(x_n; y_n)$. We define a function $f_n : X_n \rightarrow \mathbb{R}$ by $f_n(x_n) = d_n(x_n; x)$. Let a_n be a pre-Levy mean of f_n . Then we have

Claim 3.5. $\text{diam } X_n = 2a_n$.

Proof. If $a_n < \text{diam } X_n = 2$, we get $B_{X_n}(x_n; a_n) \setminus B_{X_n}(y_n; a_n) = \emptyset$. Since $B_{X_n}(x_n; a_n) = \{x\} \times f_n(x) - a_n$ and by (2), we obtain

$$\begin{aligned} m_n - 2a_n B_{X_n}(x_n; a_n) &= m_n B_{X_n}(x_n; a_n) + m_n B_{X_n}(y_n; a_n) \\ &= m_n B_{X_n}(x_n; a_n) [B_{X_n}(y_n; a_n) - 1] \end{aligned}$$

which implies that $X_n = \text{Supp}_n B_{X_n}(x_n; a_n) \cap B_{X_n}(y_n; a_n)$. This is a contradiction because X_n is connected. This completes the proof of the claim.

Given $y \in X_n$, we define a function $f_y : X_n \rightarrow \mathbb{R}$ by $f_y(x) = d_n(x; y)$. Then we have

Claim 3.6. a_n is a pre-Levy mean of f_y .

Proof. Since

$$\begin{aligned} \int_{X_n} f_y(x) d\mu_n(x) - a_n g &= \int_{X_n} B_{X_n}(y; a_n) d\mu_n(x) \\ &= \int_{X_n} B_{X_n}(x_n; a_n) = \int_{X_n} f_y(x) d\mu_n(x) - a_n g; \end{aligned}$$

we obtain $\int_{X_n} f_y(x) d\mu_n(x) - a_n g = m_n/2$. On the other hand, we get

$$\begin{aligned} \int_{X_n} f_y(x) d\mu_n(x) - a_n g &= \lim_{n' \rightarrow 0} \int_{X_n} f_y(x) d\mu_{n'}(x) \\ &= \lim_{n' \rightarrow 0} \int_{X_n} f_y(x) d\mu_{n'}(x_n; a_n) \\ &= \int_{X_n} f_y(x) d\mu_n(x) - a_n g - \frac{m_n}{2}; \end{aligned}$$

This completes the proof.

Take any $\epsilon > 0$ and put $B_{n,\epsilon} := f(x; y) \in X_n \setminus j d_n(x; y) - a_n < \epsilon$. Then, it follows from Fubini's theorem together with Claim 3.5 and 3.6 that

Z

$$(f_y \otimes \mu_n)(B_{n,\epsilon}) = \int_{X_n} \int_{X_n} f_y(x) d\mu_n(y) d\mu_n(x) - m_n(m_n/2) \geq \epsilon;$$

Let $\pi_n : X_n \rightarrow Y_n$ be an isometric embedding and $A_n \subset Y_n$ any Borel subset with $(\pi_n)_*(A_n) = m_n$. Then we have

$$\begin{aligned} (f_y \otimes \mu_n)(\pi_n^{-1}(A_n)) &\leq (\pi_n)_*(A_n) \setminus B_{n,\epsilon} \\ &= (\pi_n)_*(A_n) - (\pi_n)_*(A_n \setminus A_n) + (\pi_n)_*(B_{n,\epsilon}) \leq m_n^2 - (m_n - \epsilon)^2 \leq 2m_n(m_n - \epsilon); \end{aligned}$$

Since $m_n(\epsilon) \neq 0$ as $n \geq 1$, the right-hand side of the above inequality is positive for any sufficiently large $n \geq N$. So, we get $B_{n,\epsilon} \setminus \pi_n^{-1}(A_n) \neq \emptyset$, which leads to that there exist $x_n^0, y_n^0 \in \pi_n^{-1}(A_n)$ with $j d_n(x_n^0; y_n^0) - a_n < \epsilon$. Hence, we obtain

$$\text{diam}(X_n \setminus \pi_n^{-1}(Y_n; m_n)) \leq \text{diam}((\pi_n)_*(A_n); m_n) - a_n \leq \frac{\text{diam} X_n}{2} - \epsilon;$$

and this completes the proof of the theorem.

4. Applications and some related topics about the main theorems

In this section, we investigate concentration phenomenon of maps into CAT(0)-spaces.

4.1. Barycenter of a measure and observable central radius.

4.1.1. Basics of the barycenter of a measure. First, we shall review some standard terminology in metric geometry. A metric space $(X; d_X)$ is said to be geodesic if every two points $x, y \in X$ can be joined by a rectifiable curve whose length coincides with $d_X(x; y)$. A rectifiable curve $\gamma : [0; 1] \rightarrow X$ is called a minimal geodesic if it is globally minimizing and has a constant speed, i.e., parameterized proportionally to the arclength. A geodesic metric space X is called a CAT(0)-space if we have

$$d_X(x; \gamma(1/2))^2 \leq \frac{1}{2} d_X(x; y)^2 + \frac{1}{2} d_X(x; z)^2 - \frac{1}{4} d_X(y; z)^2$$

for any $x, y, z \in X$ and any minimizing geodesic $\gamma : [0; 1] \rightarrow X$ from y to z . If the reverse inequality

$$d_X(x; \gamma(1/2))^2 \geq \frac{1}{2} d_X(x; y)^2 + \frac{1}{2} d_X(x; z)^2 - \frac{1}{4} d_X(y; z)^2$$

holds for any x, y, z and γ , then we say that $(X; d_X)$ is an Alexandrov space of nonnegative curvature.

Example 4.1. (1) A complete simply connected Riemannian manifold is a CAT(0)-space if and only if its sectional curvature is nonpositive everywhere. Similarly, a complete Riemannian manifold is an Alexandrov space of nonnegative curvature if and only if its sectional curvature is nonnegative.

(2) A Hilbert space is both CAT(0)-space and an Alexandrov space of nonnegative curvature.

(3) For a compact convex domain $\Omega \subset \mathbb{R}^n$, let ℓ equip the length metric d induced from the standard metric of \mathbb{R}^n . Then $(\Omega; d)$ is an Alexandrov space of nonnegative curvature.

(4) A tree is a CAT(0)-space.

Let $(X; d_X)$ be a metric space. We denote by $B(X)$ the set of all finite Borel measures on X with separable supports. Given $1_R < p < +1$, we indicate by $B^p(X)$ the set of all Borel measures $\mu \in B(X)$ such that $\int_X d_X(x; y)^p d\mu(y) < +1$ for some (hence all) $x \in X$. Obviously, $B^p(X) \subset B^q(X) \subset B(\mathbb{N})$ for any $p > q$.

The following two characterizations of CAT(0)-spaces and Alexandrov spaces of nonnegative curvatures are due to K-T. Sturm.

Theorem 4.2 (cf. [24, Theorem 4.9]). A complete metric space X is a CAT(0)-space if and only if, for any $\mu \in B(X)$ with $m = \int_X d_X(x; y)^2 d\mu(y) = \int_Z d_Z(x; z)^2 d\mu(z)$, we have

$$\inf_{x \in X} \int_X d_X(x; y)^2 d\mu(y) \leq \frac{1}{2m} \int_Z \int_Z d_Z(x; z)^2 d\mu(x) d\mu(z):$$

Theorem 4.3 (cf. [23, Theorem 1.4]). A geodesic metric space X is an Alexandrov space of nonnegative curvature if and only if, for $\mu \in B(X)$ with $m = \int_X d_X(x; y)^2 d\mu(y) = \int_Z d_Z(x; z)^2 d\mu(z)$, we have

$$\inf_{x \in X} \int_X d_X(x; y)^2 d\mu(y) \geq \frac{1}{2m} \int_Z \int_Z d_Z(x; z)^2 d\mu(x) d\mu(z):$$

See [2], [3], [4], [8], [10] and references therein for further information about CAT(0) spaces and Alexandrov spaces.

For any $z \in B^1(X)$ and $x \in X$, we consider the function $h_z : X \rightarrow \mathbb{R}$ defined by

$$h_z(x) := \inf_{y \in X} d_X(x; y)^2 - d_X(z; y)^2 g_d(y);$$

Note that

$$\inf_{x \in X} d_X(x; y)^2 - d_X(z; y)^2 g_d(y) = d_X(x; z) - d_X(x; y) + d_X(z; y) g_d(y) < +1;$$

that is, the function h_z is well-defined.

Definition 4.4. The point $z_0 \in X$ is called the barycenter of $B^1(X)$ if for any $z \in X$, z_0 is the unique minimizing point of the function h_z . We denote the point z_0 by $b(\cdot)$. A metric space X is said to be barycentric if every $B^1(X)$ has the barycenter.

Proposition 4.5 (cf. [24, Proposition 4.3]). A CAT(0)-space N is barycentric. Moreover, for any $B^2(N)$, we have

$$d_N(b(\cdot); y)^2 g_d(y) = \inf_{x \in N} d_N(x; y)^2 g_d(y);$$

S. Ohta pointed out in [19, Lemma 5.5] that Proposition 4.5 holds for more general metric spaces, such as 2-uniformly convex metric spaces.

A simple variational argument yields the following two lemmas.

Lemma 4.6 (cf. [24, Proposition 5.4]). Let H be a Hilbert space. Then for each $x \in B^1(H)$ with $m = (X)$, we have

$$b(\cdot) = \frac{1}{m} \sum_{y \in H} y g_d(y);$$

For any $n \in \mathbb{N}$, we denote by NM^n the set of all n -dimensional complete simply connected Riemannian manifolds with nonpositive sectional curvatures.

Lemma 4.7 (cf. [24, Proposition 5.10]). Let $N \in NM^n$ and $x \in B^1(N)$. Then $x = b(\cdot)$ if and only if

$$\int_N \exp_x^{-1}(y) g_d(y) = 0;$$

In particular, $b(\exp_{b(\cdot)}^{-1}(x)) = 0$:

Let $(\Omega; \mathcal{A}; P)$ be a probability space and X a barycentric metric space. For X -valued random variable $W : \Omega \rightarrow X$ satisfying $W \sim P \in B^1(X)$, we define its expectation by the barycenter of $W \sim P$.

4.1.2. Observable central radius. Let Y be a metric space and assume that $2B^1(Y)$ has the barycenter. For any $\epsilon > 0$, putting $m = \text{CRad}(Y)$, we define the central radius $\text{CRad}(\cdot; m)$ of \cdot as the infimum of $\epsilon > 0$ such that $B_Y(b(\cdot); \epsilon) \subset B^1(Y)$.

Let $(X; d_X; x)$ be an mm-space with $x \in 2B^1(X)$ and Y a barycentric metric space. For any $\epsilon > 0$, we define

$$\text{ObsCRad}_Y(X; \epsilon) := \sup f \text{CRad}(f(x); m) \quad \text{if } f : X \rightarrow Y \text{ is a 1-Lipschitz map};$$

and call it the observable central radius of X .

The proof of the following lemma is easy, so we omit the proof.

Lemma 4.8 (cf. [8, Section 3 $\frac{1}{2}$:31]). For any $\epsilon > 0$, we have

$$\text{diam}(X \stackrel{\text{Lip}_1}{\rightarrow} Y; m) \geq 2\text{ObsCRad}_Y(X; \epsilon).$$

We prove the following lemma by contradiction, since we find no proof anywhere in [8].

Lemma 4.9 (cf. [8, Section 3 $\frac{1}{2}$:31]). Let X be an mm-space with a finite diameter and $(Y; k)$ a Hilbert space. Then for any $\epsilon > 0$ we have

$$(4.1) \quad \text{ObsCRad}_Y(X; \epsilon) \leq \text{diam}(X \stackrel{\text{Lip}_1}{\rightarrow} Y; m) + \frac{1}{m} \text{diam } X :$$

Proof. Given a 1-Lipschitz map $f : X \rightarrow Y$, let $Y_0 \subset Y$ be a Borel subset such that $f(x)(Y_0) = m$. From Lemma 4.6, we get

$$\begin{aligned} \text{kb } f(x) - zk &= \frac{1}{m} \sum_{y \in Y} (y - z) df(x)(y) \\ &= \frac{1}{m} \sum_{y \in Y} (ky - zk) df(x)(y) \\ &= \frac{1}{m} \sum_{y \in Y_0} (ky - zk) df(x)(y) + \frac{1}{m} \sum_{y \in Y \setminus Y_0} (ky - zk) df(x)(y) \\ &\leq \text{diam } Y_0 + \frac{1}{m} \text{diam } X : \end{aligned}$$

Hence we obtain

$$f(x) \in B_Y(bf(x); \text{diam } Y_0 + \frac{1}{m} \text{diam } X) \quad f(x)(Y_0) = m \quad ;$$

which implies that $\text{CRad}(f(x); m) \leq \text{diam } Y_0 + \frac{1}{m} \text{diam } X$. This completes the proof.

Remark 4.10. In [8], Lemma 4.9 is stated as

$$(4.2) \quad \text{ObsCRad}_Y(X; \epsilon) \leq \text{diam}(X \stackrel{\text{Lip}_1}{\rightarrow} Y; m) + \frac{1}{m} \text{diam } X :$$

The inequality (4.1) gives slightly better estimate than that (4.2) gives.

Lemma 4.11. For any $N \geq N M^n$ and $\epsilon > 0$, we have

$$\text{ObsCRad}_N(X; \cdot) = \text{ObsCRad}_{R^n}(X; \cdot):$$

In particular, if a sequence $f X_n g_{n=1}^1$ of $m m$ -spaces and a sequence $f a(n) g_{n=1}^1$ of natural numbers satisfy that

$$\text{ObsCRad}_{R^{a(n)}}(X_n; \cdot) \rightarrow 0 \text{ as } n \rightarrow 1$$

for any $\epsilon > 0$, then for any $\epsilon > 0$ we have

$$\sup f \text{ObsCRad}_N(X_n; \cdot) \leq N \geq N M^{a(n)} g ! 0 \text{ as } n \rightarrow 1 :$$

Proof. Let $f : X \rightarrow N$ be an arbitrary 1-Lipschitz map. We identify the tangent space of N at $z = b f(x)$ with R^n and consider a map $f_0 = \exp_z^{-1} f : X \rightarrow R^n$. According to the hinge theorem, f_0 is a 1-Lipschitz map. By using Lemma 4.7, we have $f_0^{-1} B_{R^n} \subset f_0(X); \epsilon = f_0^{-1} B_{R^n}(0; \epsilon) = f^{-1} B_N(z; \epsilon)$ for any $\epsilon > 0$. Hence, we obtain

$$\text{CRad}(f(x); m) = \text{CRad}(f_0(x); m) = \text{ObsCRad}_{R^n}(X; \cdot)$$

for any $\epsilon > 0$ and this completes the proof.

Proposition 4.12. Let $f X_n g_{n=1}^1$ be a sequence of $m m$ -spaces of finite diameters and $p \geq 1$. We assume that a sequence of natural numbers $f a(n) g_{n=1}^1$ satisfies that

$$(4.3) \quad \frac{\text{diam } X_n}{\text{diam } X_n^{\text{Lip}}(R^{a(n)}; m_n)} = \frac{1}{(\text{diam } X_n)^p} \rightarrow 0 \text{ as } n \rightarrow 1$$

for any $\epsilon > 0$. Then, for any $\epsilon > 0$ we have

$$\sup_n \text{ObsCRad}_N(X_n; \cdot) = \frac{1}{(\text{diam } X_n)^p} \leq N \geq N M^{a(n)} \rightarrow 0 \text{ as } n \rightarrow 1 :$$

Proof. The proof follows from Lemma 4.9 and Lemma 4.11.

Note that in Proposition 4.12, we need not pinch the sectional curvature of the screen N . The assumption (4.3) is stronger than both (1.2) and (1.3) for $p < 1$ in general.

Let M be a compact connected Riemannian manifold and μ_M the normalized volume measure on M . We denote by $\lambda_1(M)$ the first non-zero eigenvalue of the Laplacian on M . We shall consider M as an $m m$ -space $(M; d_M; \mu_M)$.

Theorem 4.13 (Gromov, cf. [8, Section 3.2]). Let M be a compact connected Riemannian manifold and $N \geq N M^n$. Then, for any $\epsilon > 0$ we have

$$\text{ObsCRad}_N(M; \cdot) = \frac{1}{\lambda_1(M)} \frac{r^n}{n} :$$

Proof. In [8, Section 3.2], Gromov proved the case of $N = R^n$. This and Lemma 4.11 gives the proof of the proposition.

We indicate by $S^n(r)$ the n -dimensional sphere in R^{n+1} with radius $r > 0$.

Corollary 4.14. Let s be a number with $0 < s < 1/2$ and $f_a(n)g_{n=1}^1$ a sequence of natural numbers such that $a(n)=n^{1-2s} \neq 0$ as $n \geq 1$. Then for any $\epsilon > 0$, we have

$$\sup_{\Omega} \text{ObsCRad}_N(S^n(n^s); \cdot) j N 2 N M^{a(n)} g \neq 0 \text{ as } n \geq 1 :$$

Proof. Combining $\dim S^n(n^s) = n^{1-2s}$ and Theorem 4.13, we have the corollary.

Remark 4.15. Let us consider the case of $s = 1/2$. Denote by f_n the projection from $S^n(\frac{1}{n})$ into R . It is known by H. Poincaré that the sequence $(f_n)_{S^n(\frac{1}{n})}_{n=1}^1$ of probability measures on R converges weakly to the canonical Gaussian measure on R (cf. [13, Section 1.1]). Therefore, for any $\epsilon > 0$ we have

$$\liminf_{n \geq 1} \text{diam}(S^n(\frac{1}{n}))^{Lip_1(R; 1)} > 0 :$$

Corollary 4.16. Assume that a sequence $f_a(n)g_{n=1}^1$ of natural numbers satisfies that $a(n)=n \neq 0$ as $n \geq 1$. Then for any $\epsilon > 0$, we have

$$\sup_{\Omega} \text{ObsCRad}_N(SO(n); \cdot) j N 2 N M^{a(n)} g \neq 0 \text{ as } n \geq 1 :$$

Proof. Since

$$\text{Ric}_{SO(n)} = \frac{n-1}{4} - \frac{n(n-1)}{2} = 1 - \frac{1}{2n},$$

we have $\text{Ric}_{SO(n)}(n-1)=4$ by Lichnerowicz's theorem. Therefore, by combining this and Theorem 4.13, the proof is completed.

4.2. L^p -concentration of m-spaces. Let $(X; d_X; x)$ be an m-space and $(Y; d_Y)$ a metric space. Given a Borel measurable map $f : X \rightarrow Y$ and $p \in (0; +\infty]$, we put

$$V_p(f) := \inf_{x \in X} \int_Y d_Y(f(x); f(x^0))^{p-1} d_X(x) d_X(x^0);$$

$$V_1(f) := \inf_{r > 0} \int_X \int_X (f(x); f(x^0))^{2/X} \int_Y d_Y(f(x); f(x^0))^{-rg} = 0$$

Let $f_{X,n}g_{n=1}^1$ be a sequence of m-spaces and $f_{Y,n}g_{n=1}^1$ a sequence of metric spaces. For any $p \in (0; +\infty]$, we say that a sequence $f_{f,n} : X_n \rightarrow Y_n g_{n=1}^1$ of Borel measurable maps L^p -concentrates if $V_p(f_n) \neq 0$ as $n \geq 1$. Given an m-space X and a metric space Y we define

$$\text{ObsL}^p\text{-Var}_Y(X) := \sup_{f \in F} V_p(f) \text{ if } f : X \rightarrow Y \text{ is a 1-Lipschitz map};$$

and call it the observable L^p -variation of X .

The standard argument yields the following basic fact.

Lemma 4.17. For $0 < p < q$, L^q -concentration of m-spaces implies L^p -concentration of m-spaces under the assumption $\sup_{n \in \mathbb{N}} \mu_n < +\infty$.

We shall investigate relationships between concentration and L^p -concentration.

Lem m a 4.18. Let X be an m -space and Y a metric space. For any $\epsilon > 0, p \geq 0; +1],$ and a Borel measurable map $f : X \rightarrow Y,$ we have

$$\text{diam } f(x);m \leq \frac{2}{(m)^{1-p}} V_p(f);$$

Proof. The case of $p = 1$ is easy, so we consider the case of $p < +1$ only. Assume that $\int_X d_Y(f(x); f(x^0))^p d_X(x) d_X(x^0) > m^p$ for any $x, x^0 \in X$ and $m = V_p(f) = (m)^{1-p}.$ By the Chebyshev's inequality, we get

$$V_p(f)^p = \int_X \int_Z d_Y(f(x); f(x^0))^p d_X(x) d_X(x^0) > m^p d_X(x^0) = m^p m = V_p(f)^p;$$

Hence, there is a point $x^0 \in X$ such that $\int_X d_Y(f(x); f(x^0))^p d_X(x) > m^p.$ This completes the proof.

Corollary 4.19. For any $p \geq 0; +1], L^p\text{-concentration of maps implies concentration of maps.}$

Lem m a 4.20. Let X be an m -space with a finite diameter and Y a metric space. Then, for any $\epsilon > 0, p \geq 0; +1],$ and 1-Lipschitz map $f : X \rightarrow Y,$ we have

$$V_p(f)^p \leq m^2 \text{diam } f(x);m \leq \frac{p}{(\text{diam } X)^p} + 2m \leq \frac{2m}{(\text{diam } X)^p};$$

Proof. For any $\eta > 0$ with $\text{diam } f(x);m = (\text{diam } X)^p < \eta,$ there exists a Borel subset $A \subset Y$ such that $\text{diam } A < \eta$ and $f(x);A = (\text{diam } X)^p.$ By $\text{diam } A < \eta,$ we get

$$(4.4) \quad \int_{f^{-1}(A)} \int_Z d_Y(f(x); f(x^0))^p d_X(x) d_X(x^0) \leq m^2 \eta^p;$$

Since

$$\begin{aligned} \int_X \int_X d_Y(f(x); f(x^0))^p d_X(x) d_X(x^0) &\leq m^2 \frac{2}{(\text{diam } X)^p} \\ &= 2m \frac{2}{(\text{diam } X)^p} \frac{2}{(\text{diam } X)^p}, \end{aligned}$$

we also have

$$(4.5) \quad \int_X \int_{f^{-1}(A)} d_Y(f(x); f(x^0))^p d_X(x) d_X(x^0) \leq 2m \frac{2}{(\text{diam } X)^p};$$

Combining (4.4) and (4.5), we obtain

$$V_p(f)^p \leq m^2 \eta^p + 2m \frac{2}{(\text{diam } X)^p};$$

This completes the proof.

Corollary 4.21. Let $fX_n g_{n=1}^1$ be a sequence of mm-spaces with finite diameters and $fY_n g_{n=1}^1$ a sequence of metric spaces. Assume that $\sup_{n \geq N} m_n < +1$ and

$$\text{diam } X_n \stackrel{\text{Lip}_1}{\rightarrow} Y_n ; m_n \xrightarrow{(\text{diam } X_n)^p} 0 \text{ as } n \rightarrow 1$$

for any $\epsilon > 0$ and some $p \geq 0$. Then we have $\text{ObsL}^p\text{-Var}_{Y_n}(X_n) \rightarrow 0$ as $n \rightarrow 1$.

Combining Theorem 1.3, 1.4, and Corollary 4.21, we get the following L^p -concentration results.

Corollary 4.22. Let $fX_n g_{n=1}^1$, p , $fa(n)g_{n=1}^1$, $f_{1n} g_{n=1}^1$, and $f_{2n} g_{n=1}^1$ be as in Theorem 1.3 and assume that $\sup_{n \geq N} m_n < +1$. Then we have

$$\sup f\text{ObsL}^p\text{-Var}_N(X_n) \leq 2N M(a(n); f_{1n}; f_{2n}) g \rightarrow 0 \text{ as } n \rightarrow 1 :$$

Corollary 4.23. Let $fX_n g_{n=1}^1$, p , and $fa(n)g_{n=1}^1$ be as in Theorem 1.4 and assume that $\sup_{n \geq N} m_n < +1$. Then for any $\epsilon_0 < 0$, we have

$$\sup f\text{ObsL}^p\text{-Var}_N(X_n) \leq N M(a(n); \epsilon_0) g \rightarrow 0 \text{ as } n \rightarrow 1 :$$

As in the above corollaries, combining Lemma 4.8, Proposition 4.12, and Corollary 4.21, we obtain the following corollary.

Corollary 4.24. Let $fX_n g_{n=1}^1$, p , and $fa(n)g_{n=1}^1$ be as in Proposition 4.12 and assume that $\sup_{n \geq N} m_n < +1$. Then we have

$$\sup f\text{ObsL}^p\text{-Var}_N(X_n) \leq 2N M^{a(n)} g \rightarrow 0 \text{ as } n \rightarrow 1 :$$

Theorem 4.25 (Gromov, cf. [6, Section 8]). Let M be an m -dimensional compact symmetric space of rank 1 and N be an n -dimensional Riemannian manifold. Then, for any 1-Lipschitz map $f : M \rightarrow N$, we have

$$V_2(f)^2 \leq \frac{n}{m} \int_M \int_M d_M(x; x')^2 d_M(x) d_M(x') :$$

We indicate by M^n the set of all n -dimensional Riemannian manifolds.

Corollary 4.26. Assume that $0 < s < 1/2$ and a sequence $fa(n)g_{n=1}^1$ of natural numbers satisfies $a(n) = n^{1/2s} \rightarrow 0$ as $n \rightarrow 1$. Then we have

$$\sup f\text{ObsL}^2\text{-Var}_M(S^n(n^s)) \leq 2M^{a(n)} g \rightarrow 0 \text{ as } n \rightarrow 1 :$$

In particular, for any $\epsilon > 0$ we have

$$\sup f\text{diam}(S^n(n^s)) \stackrel{\text{Lip}_1}{\rightarrow} M ; m_n \rightarrow 0 \text{ as } n \rightarrow 1 :$$

Remark 4.27. Since compact symmetric spaces $SO(n)$ are not rank 1 for $n \geq 4$, we cannot apply Theorem 4.25 for $SO(n)$.

Let X be an $m m$ -space and $N \in N M^n$. For any Borel measurable map $f : X \rightarrow N$ with $f(x) \in B^1(N)$, we put $f_0 = \exp_{b(f(x))}^{-1} f : X \rightarrow R^n$.

Proposition 4.28 [cf. [8, Section 13]]. The map $f_0 : X \xrightarrow{p} R^n$ satisfies that $f_0(x) \in d_N f(x); f(x^0) \text{ for any } x; x^0 \in X \text{ and } V_2(f) = 2V_2(f_0)$.

Corollary 4.29. Let X be an $m m$ -space and $N \in N M^n$. Then we have

$$\text{ObsL}^2\text{-Var}_N(X) \xrightarrow{p} \text{ObsL}^2\text{-Var}_{R^n}(X);$$

In particular, if a sequence $f X_n g_{n=1}^\infty$ of $m m$ -spaces and a sequence of natural numbers satisfy that

$$\text{ObsL}^2\text{-Var}_{R^{a(n)}}(X_n) \rightarrow 0 \text{ as } n \rightarrow 1;$$

then we have

$$\sup f \text{ObsL}^2\text{-Var}_N(X_n) \in N \in N M^{a(n)} g \rightarrow 0 \text{ as } n \rightarrow 1;$$

Proof. Assume that there exists a 1-Lipschitz map $f : X \rightarrow N$ satisfies that $f(x) \notin B^1(X)$. From Theorem 4.2, we have $V_2(f) = +1$. Take a point $x_0 \in X$. For each $k \in N$, we put $f_k = f|_{B_X(x_0; k)}$. Since $f_k \in B^1(B_X(x_0; k))$, from Proposition 4.28, there exists a 1-Lipschitz map $\tilde{f}_k : B_X(x_0; k) \rightarrow R^n$ such that $V_2(\tilde{f}_k) = 2V_2(f_k)$. From [1, Theorem 3.1.2], there exists a $\frac{p}{n}$ -Lipschitz extension of \tilde{f}_k , say $g_k : X \rightarrow R^n$. Since $(1=\frac{p}{n})g_k : X \rightarrow R^n$ is a 1-Lipschitz map and

$$V_2 \left(\frac{1}{n} g_k \right) = \frac{1}{n} V_2(\tilde{f}_k) = \frac{1}{n} V_2(f_k) \rightarrow V_2(f) = +1 \text{ as } k \rightarrow 1;$$

we obtain $\text{ObsL}^2\text{-Var}_{R^n}(X) = +1$. From this and Proposition 4.28, we have completed the proof.

Lemma 4.30. Let N be a CAT(0)-space and X an $m m$ -space. Then for any Borel measurable map $f : X \rightarrow N$ with $f(x) \in B^1(N)$ and $\epsilon > 0$, we have

$$\text{CRad}(f(x); m) \leq \frac{V_2(f)}{2m};$$

Proof. Assume that $f(x) \in N \setminus B_N(b(f(x)); \epsilon)$ holds for $\epsilon = V_2(f) = \frac{p}{2m}$. Combining Theorem 4.2 and the Chebyshev's inequality, we get

$$\frac{V_2(f)^2}{2m} = \int_0^Z d_N(b(f(x)); q)^2 dF(x)(q) \geq \frac{V_2(f)^2}{2m},$$

which is a contradiction. Hence, we obtain $f(x) \in B_N(b(f(x)); \epsilon) \subset m$. This completes the proof.

Corollary 4.31. L^2 -concentration of maps into CAT(0)-space implies concentration of maps to their expectations.

Combining Theorem 4.25 and Lemma 4.30, we also get the same result obtained in Corollary 4.14.

From Theorem 4.3, we obtain the following corollary.

Corollary 4.32. Let $fX_n g_{n=1}^1$ be a sequence of $m m$ -spaces with $\sup_{n \in \mathbb{N}} m_n < +\infty$ and $fY_n g_{n=1}^1$ a sequence of Alexandrov spaces of nonnegative curvatures. Assume that a sequence $ff_n : X_n \rightarrow Y_n g_{n=1}^1$ of Borel measurable maps satisfies that

$$\inf_{y \in Y_n} d_{Y_n}(y; f_n(x))^2 \leq d_n(x) \quad \text{for all } x \in X_n.$$

Then we have $V_2(f_n) \leq 0$ for all $n \geq 1$.

The proof of the following lemma is easy.

Lemma 4.33 (cf. [8, Section 3.2]). For an $m m$ -space X , $n \in \mathbb{N}$, and $p > 0$, we have

$$\text{diam}(X \stackrel{\text{Lip}_1}{\rightarrow} R^n; m_n)^p \leq \text{diam}(X \stackrel{\text{Lip}_1}{\rightarrow} R; m) :$$

Lemma 4.34. Let M be an m -dimensional compact connected Riemannian manifold such that $Ric_M - e_1 > 0$. Then, for any $p > 0$ we have

$$\text{diam}(M \stackrel{\text{Lip}_1}{\rightarrow} R^n; 1)^p \leq \frac{2n \log \frac{2n}{e_1}}{e_1} :$$

Proof. From the Levy-Gromov isoperimetric inequality, we have $\text{vol}_M(r) \sim e^{-r^2/2}$ (cf. [9, Section 1.2, Remark 2]). Thus, combining Lemmas 2.2, 2.5, and 4.33 leads to the lemma.

Remark 4.35. For fixed $p > 0$, the inequality in Lemma 4.34 is weaker than that in Theorem 4.13 for a Riemannian manifold M with a positive lower Ricci curvature bound for the same screen R^n . However, in the case where $p = 0$, the inequality in Lemma 4.34 gives a better estimate for the observable diameter of M than that in Theorem 4.13.

Corollary 4.36. Let M be an m -dimensional compact connected Riemannian manifold such that $Ric_M - e_1 > 0$. Then, for any $p > 0$ we have

$$\text{diam}(M \stackrel{\text{Lip}_1}{\rightarrow} R^n; 1)^p \leq \frac{2n \log \frac{2n}{e_1} \frac{m}{m-1}}{(e_1)^p} :$$

Proof. This follows from Lemma 4.34 together with the Myers's diameter theorem.

Corollary 4.37. Let s be a number with $0 < s < 1/2$ and $f_a(n) g_{n=1}^1$ a sequence of natural numbers such that $(f_a(n) \log n) = n^{1/2s} \leq 0$ for all $n \geq 1$. Then for any $p > 0$, we have

$$\sup_{n \in \mathbb{N}} \text{ObsL}^p \text{-Var}_N(S^n(n^s)) \leq 2N M^{a(n)} g ! \leq 0 \text{ for all } n \geq 1 :$$

Proof. Since $Ric_{S^n(n^s)} = (n-1)n^{-2s}$, combining this and Corollary 4.36, we obtain

$$\text{diam } S^n(n^s) \stackrel{\text{Lip}_1}{\rightarrow} R^{a(n)}; 1 \frac{V}{(2)^{\frac{V}{(\text{diam } S^n(n^s))^p}}} \frac{u}{2} \frac{u}{t} \frac{2a(n) \log \frac{2a(n)n^{sp}}{p}}{(n-1)n^{-2s}}$$

for any $\epsilon > 0$. Therefore, combining Corollary 4.17 and 4.24, this completes the proof.

Note that the assumption of $a(n)g_{n=1}^1$ in Corollary 4.37 is stronger than that in Corollary 4.26. Hence, Corollary 4.26 implies better result than Corollary 4.37 for $p=2$.

Corollary 4.38. Assume that a sequence $a(n)g_{n=1}^1$ of natural numbers satisfies that $(a(n)\log n)=n!0$ as $n \rightarrow 1$. Then, for any $p > 0$ we have

$$\sup_{f \in \text{BSL}^p} \text{Var}_N(SO(n)) \leq 2N M^{a(n)} g ! 0 \text{ as } n \rightarrow 1 :$$

Proof. Since $Ric_{SO(n)}(n-1)=4$ and by using Corollary 4.36, we have

$$\text{diam } SO(n) \stackrel{\text{Lip}_1}{\rightarrow} R^{a(n)}; 1 \frac{V}{(2)^{\frac{V}{(\text{diam } SO(n))^p}}} \frac{u}{2} \frac{u}{t} \frac{8a(n) \log \frac{2a(n)(2n)^{p-2}}{p}}{n-1}$$

for any $\epsilon > 0$. Therefore, applying Corollary 4.17 and 4.24, this completes the proof.

5. Tree screens

We define a tree T as a (possibly infinite) connected combinatorial graph having no loops. We identify the individual edges of a tree as bounded closed intervals of the real lines, and then define the distance between two points of the tree to be the infimum of the lengths of paths joining them.

Definition 5.1. Let $(X; d_X; \mu)$ be an m -space and $f : X \rightarrow T$ be a Borel measurable map. A pre-Levy mean of f is a point $p \in T$ such that there exist two trees $T^0; T^\infty \subset T$ such that

$$T = T^0 \cup T^\infty; T^0 \setminus T^\infty = fpg; f(x)(T^0) = \frac{m}{3}; \text{ and } f(x)(T^\infty) = \frac{m}{3};$$

Proposition 5.2. There exists a pre-Levy mean.

Proof. Take an edge e of T and x an inner point $q \in e$. There exist two trees $T^0; T^\infty \subset T$ such that $T^0 \setminus T^\infty = f(q)$ and $T = T^0 \cup T^\infty$. If $f(x)(T^0); f(x)(T^\infty) = m = 3$, we have finished the proof. Hence we consider the case of $f(x)(T^\infty) < m = 3$.

Let V^0 be the vertex set of T^0 . For any $v \in V^0$, we indicate by C_v the set of all connected components of $T \setminus fvg$ and put $C_v^0 := \{F \in \text{fgv} \mid F \subset C_v\}$. Suppose that a point $v \in V^0$ satisfies $f(x)(F) < m = 3$ for any $F \in C_v^0$, then it is easy to check that v is a pre-Levy mean of f . So, we assume that for any $v \in V^0$ there exists $T_v \in C_v^0$ such that $f(x)(T_v) = m = 3$. If for some $v \in V^0$ there exists $T_v^0 \in C_v^0 \setminus fT_vg$ such that $f(x)(T_v^0) = m = 3$, then this v is a pre-Levy mean of f . Therefore, we also assume that $f(x)(T_v^0) < m = 3$ for any $v \in V^0$ and $T_v^0 \in C_v^0 \setminus fT_vg$.




Figure 1. Tree

We denote by \mathcal{L} the set of all unit speed geodesics $: [0; L(\cdot)] \rightarrow T^0$ from q such that $L(\cdot) \geq V^0$ and $[t; L(\cdot)] \subset T_{(t)}$ for each $t \in V^0 \cap L(\cdot) \setminus [0; L(\cdot)]$. It is easy to verify that $L(\cdot) = V^0$ for any $\cdot \in V^0$ with $L(\cdot) = L(V^0)$. Put $\mathcal{L}^0 = \text{supf}L(\cdot) \cap \mathcal{L}$. Let us show that there exists $e \in \mathcal{L}$ with $L(e) = V^0$. If $L(\cdot) < V^0$ for any $\cdot \in V^0$, there exists a sequence $f_n g_{n=1}^1 \in \mathcal{L}^0$ such that $L(g_1) < L(g_2) < \dots$! as $n \rightarrow \infty$. Then we have

$$f(x)(T) = \lim_{n \rightarrow \infty} \sup f_n(x) \circ C_{n(L(g_n))}^0 n T_{n(L(g_n))} \circ \frac{2m}{3},$$

which is a contradiction. Suppose that there exists a sequence $f_{t_n} g_{n=1}^1 \in [0; L(e)]$ such that $t_1 < t_2 < \dots$! $L(e)$ as $n \rightarrow \infty$ and $f_{t_n} g_{n=1}^1 \in V^0$ for each $n \in \mathbb{N}$. Since $T^0 = T_{\sim(L(e))}$ and

$$f(x) \circ C_{\sim(L(e))}^0 n T_{\sim(L(e))} \circ e \in L(e) = \lim_{n \rightarrow \infty} f(x)(T_{\sim(t_n)}) \circ \frac{m}{3},$$

$e \in L(e)$ is a pre-Levy mean of f . We will consider the other case, that is, there exist $t_0 \in [0; L(e)]$ and edge e_0 of T^0 such that $e(t_0) \in V^0$ and e_0 connects $e(t_0)$ and $e \in L(e)$. If $f(x) \circ C_{\sim(t_0)}^0 n T_{\sim(t_0)} \circ fe(t_0)g \circ m = 3$, then $e(t_0)$ is a pre-Levy mean of f . If $f(x) \circ C_{\sim(t_0)}^0 n T_{\sim(t_0)} \circ fe(t_0)g \circ m < 3$, there exists a pre-Levy mean of f on e_0 since $e_0 \subset T_{\sim(L(e))}$. This completes the proof.

Lemma 5.3. For any $\epsilon > 0$, we have

$$\text{diam}(X \stackrel{\text{Lip}^1}{\rightarrow} T; m) \geq 2 \text{Sep}(x; \frac{m}{3}; \frac{m}{2})$$

Proof. Let $f : X \rightarrow T$ be an arbitrary 1-Lipschitz map. Take a pre-Levy mean $p \in T$ of f and let $T^0; T^{(0)} \rightarrow T$ be its associated trees. Let $\delta > 0$ satisfies $\delta > \text{Sep}(x; m=3; \delta) = 2$. Suppose that $f(x) \in T^0 \cap B_T(p; \delta)$. Then, applying Lemma 2.8, we have

$$\text{d}_T(T^0; T^0 \cap B_T(p; \delta)) \geq \text{Sep}(f(x); \frac{m}{3}; \frac{m}{2}) \geq \text{Sep}(x; \frac{m}{3}; \frac{m}{2});$$

which is a contradiction. In the same way, we have $f(x) \in T^0 \cap B_T(p; \delta) \subset B_T(p; 2)$. As a consequence, we obtain $f(x) \in T \cap B_T(p; 2) \subset B_T(p; 2)$. This completes the proof.

Proof of Proposition 1.7. The claim obviously follows from Lemma 5.3.
