ON THE SHARPNESS OF FEW NOM IAL BOUND AND THE NUMBER OF COMPONENTS OF A FEW NOM IAL HYPERSURFACE

Abstract. We show the existence of systems of n polynomial equations in n variables, with a total of n+k+1 distinct monomial terms, possessing $\frac{n+k}{k}^k$ nondegenerate positive solutions. This shows that the recent upper bound of $\frac{e^2+3}{4} 2^{\binom{k}{0}} n^k$ for the number of nondegenerate positive solutions is asymptotically sharp for xed k and large n. We also adapt a method of Perrucci to show that there are fewer than $\frac{e^2+3}{4} 2^{\binom{k}{0}} 2^n n^k$ connected components in a smooth hypersurface in the positive orthant of R^n dened by a polynomial with n+k+1 monomials. Our results hold for polynomials with real exponents.

K hovanskii [5] showed there are at most $2^{\binom{n+k}{2}}$ (n + 1)^{n+k} nondegenerate positive solutions to a system of n polynom ialequations in n variables having a total of n+k+1 distinct monom ials. This few nomial bound is also a bound for polynomials with real exponents, which are linear combinations of monomials with real-number exponents. The equivalence is discussed in [8] and the arguments of [3] require that we allow real exponents.

While this few nom ial bound was not believed to be sharp, only recently have smaller bounds been found. The rst breakthrough was due to Li, Rojas, and Wang [] who showed that a system of two trinom ials in two variables has at most 5 positive solutions, which is signicantly less than K hovanskii's bound of 5184. B ihan 2] showed that a system of n polynom ials in n variables with n+2 monom ials has at most n+1 nondegenerate positive solutions and proved the existence of such a system with n+1 positive solutions. This gave the sharp bound of n+1 for the case k=1. B ihan and Sottile [3] generalized this to all k, giving the upper bound of $\frac{e^2+3}{4}$ 2 $\binom{k}{6}$ n^k for the number of nondegenerate positive solutions, which was signicantly smaller than K hovanskii's bound. We show that this upper bound is near-optimal for xed k and large k.

Theorem 1. For any positive integers n;k with n > k, there exists a system of n polynom ials in n variables involving n+k+1 distinct monom ials and and having $\frac{n+k}{k}$ nondegenerate positive solutions.

We believe that there is room for improvement in the dependence on k, both in the upper bound of [3] and in the lower bound of Theorem 1.

Proof. We will construct such a system when n=km, a multiple of k, from which we may deduce the general case as follows. Suppose that n=km+j with 1-j < k and we have a system of mk equations in mk variables involving mk+k+1 monomials with $(m+1)^k$ nondegenerate positive solutions. We add j new variables $x_1; :::; x_j$ and j new equations $x_1 = 1; :::; x_j = 1$. Since the polynomials in the original system may be assumed to have

constant terms, this gives a system with n polynomials in n variables having n+k+1 m onomials and $(m+1)^k = \frac{n+k}{k}$ nondegenerate positive solutions.

Fix positive integers k;m and set n=km. Bihan [2] showed there exists a system of m polynomials in m variables

$$f_1(y_1; ...; y_m) = f_2(y_1; ...; y_m) = =_m (f_1; ...; y_m) = 0$$

having m+1 solutions, and where each of polynom ial has the same m+2 m onom ials, one of which we may take to be a constant.

For each j=1;:::;k, let $y_{j;1};:::;y_{j;m}$ be m new variables and consider the system

$$f_1(y_{j;1}; ...; y_{j,m}) = \underset{m}{=} (f_{j;1}; ...; y_{j,m}) = 0;$$

which has m+1 positive solutions in $(y_{j;1};:::;y_{j,m})$. As the sets of variables are disjoint, the combined system consisting of all km polynomials in all km variables has $(m+1)^k$ positive solutions. Each subsystem has m+2 m onomials, one of which is a constant. Thus the combined system has m+1 km m+1 = m+1 m onomials.

Remark 2. This proof of Theorem 1 is based on Bihan's non-constructive proof of the existence of a system of m polynomials in m variables having m+2 monomials and m+1 nondegenerate positive solutions. While inding explicit such systems is challenging in general, we give systems for n=2 and n=3.

The system of n = 2 equations with 2 variables

$$x^2y$$
 $(1 + 4x^2) = xy$ $(4 + x^2) = 0;$

has 4 = 2 + 1 + 1 m onom ials and exactly 3 complex solutions, each of which are nondegenerate and lie in the positive quadrant. We give numerical approximations, computed with the computer algebra system SINGULAR [4, 10].

The system of n = 3 equations with 3 variables

yz
$$(1=8+2x^2) = xy$$
 $(1=220+x^2) = z$ $(1+x^2) = 0$;

has 5 = 3 + 1 + 1 m onom ials and exactly 4 complex solutions, each of which are nondegenerate and lie in the positive octant.

K hovanskii also considered smooth hypersurfaces in the positive orthant $R^n_>$ de ned by polynom ials with n+k+1 m onom ials. He showed that the total Betti number of such a few nom ial hypersurface is at most $(2n^2-n+1)^{n+k}$ $(2n)^{n-1}2^{\binom{n+k}2}$ [6, x3.14, Cor. 4]. Li, Rojas, and W ang [7] bounded the number of connected components of such a hypersurfaces by $n(n+1)^{n+k+1}2^{n-1}2^{\binom{n+k+1}2}$. Perrucci [9] lowered this bound to $(n+1)^{n+k}2^{1+\binom{n+k}2}$. H is method was to bound the number of compact components and then use an argument based on the faces of the n-dimensional cube to bound the number of all components. We improve Perrucci's method, using the n-simplex and the bounds of Bihan and Sottile [3] to obtain a new, lower bound. This also extends an earlier bound of Benedetti, Loeser, and Risler to the context of sparse polynomial systems [1].

Theorem 3. A smooth hypersurface in $R^n_>$ de ned by a polynom ial with n+k+1 m onomials having a ne span R^n has fewer than $\frac{e^2+3}{4}$ $(2^n)^k$ connected components.

Remark 4. If a hypersurface f=0 is singular, we may bound its number of connected components by the number of connected components of the two hypersurfaces f=, for small. (This is Lemma 13 in [7].) Since we can assume that f has a constant term, this gives the bound of $2 \frac{e^2+3}{4} 2^n p^k$ for the number of connected components of an arbitrary (possibly singular) hypersurface in $R^n_>$ defined by a polynomial with n+k+1 monomials.

Let (n;k) be the maximum number of compact connected components of a smooth hypersurface in $\mathbb{R}^n_>$ de ned by a polynom ial having at most n+k+1 monom ials and let (n;k) be the maximal number of connected components of such a hypersurface.

ProofofTheorem 3. Bihan and Sottile [3] proved that (n;k) $\frac{e^2+3}{8}2^{\binom{k}{2}}n^k$. Substituting this into Lemma 5 bounds (n;k) by

Proof of Lem m a 5. Let f be a polynom ial in the variables $x_1; :::; x_n$ which has n+k+1 distinct m onom ials and suppose that f(x)=0 de nes a smooth hypersurface X in $R^n_>$. We may apply a monom ial change of coordinates to $R^n_>$ and assume that $1; x_1; x_2; :::; x_n$ are among the monom ials appearing in f. Perturbing the exponents of f if necessary, we may assume that f also has a monom ial $x^a := x_1^{a_1} x_2^{a_2} = x_1^{a_n} x_1^{a_n} x_1^{a_n} = x_1^{a_n} x_1^{a_n} x_1^{a_n} = x_1^{a_n}$

The transform ation $Log: R_>^n$! R^n de ned on each coordinate by x_i \mathcal{T} $log(x_i)$ sends the hypersurfaces $H_0; H_1; \ldots; H_n$ to hyperplanes in general position. That is, if $S_i = 0$, $H_i = 0$, H

If we restrict f to some H $_{\rm S}$, we will obtain a new polynomial f $_{\rm S}$ in n $_{\rm S}$ j variables with at most 1+ n $_{\rm S}$ j+ k m onomials. (While this is obvious when 0 2 S, if 0 2 S, then we pick an index j 2 S and use x^a $_0$ = 1 to eliminate x_j .) For almost all , the polynomial f $_{\rm S}$ denes a smooth hypersurface $X_{\rm S}$ of H $_{\rm S}$.

We may choose small enough so that every compact connected component of X lies in the bounded region of the complement of the hypersurfaces H_{i} , and every noncompact connected component of X meets some hypersurface H_{i} . Shrinking if necessary, we can insure that every bounded component of X_{S} lies in the bounded region of the complement of $H_{i} \setminus H_{S}$ for j S, and every unbounded component meets some $H_{i} \setminus H_{S}$ for j S.

Given a connected component C of X, the subsets S f0;1;:::;ng such that C meets H_S form a simplicial complex. If S represents a maximal simplex in this complex, then $C \setminus H_S$ is a union of compact components of X_S , and $\mathfrak{F} j < n$ as H_S is not a point. Thus the number of connected components of X is bounded by the sum of the numbers of compact components of X_S for all S f0;1;:::;ng with $n > \mathfrak{F} j$. Since each f_S has at most 1+n $\mathfrak{F} j+k$ monomials, this sum is bounded by the sum in the statement of the lemma.
