# SOM E OBSERVATIONS ON LOCAL AND PROJECTIVE HYPERSURFACES

#### HALLONG DAO

Abstract. Let R be a hypersurface in an equicharacteristic or unram i ed regular local ring. For a pair of m odules (M; N) over R we study applications of rigidity of  $Tor^R$  (M; N), based on ideas by H uneke, Wiegand and Jorgensen. We then focus on the hypersurfaces with isolated singularity and even dimension, and show that modules over such rings behave very much like those over regular local rings. Connections and applications to projective hypersurfaces such as intersection dimension of subvarieties and cohomological criterion for splitting of vector bundles are discussed.

### 1. Introduction

The purpose of this note is to continue our investigation of the rigidity and decent intersection of modules over a local hypersurface R done in [Da1]. There we showed that the vanishing of  $^{\rm R}$  (M; N), a function introduced by Hochster in [Ho1], in plies the rigidity of Tor for (M; N). We will apply this to give various new results on modules over hypersurfaces. We also give supporting evidences for the following C on jecture made in [Da1]:

C on jecture 1.1. Let R be an hypersurface with isolated singularity. Assume that dim R is even. Then  $^{\rm R}$  (M ;N ) always vanishes.

In Section 2 we review the basic notations and prelim inary results. In Section 3 we use the procedure invented by Huneke and W isgand in [HW 2] to show that  $\operatorname{Hom}_R$  (M; M) rarely has good depth. The use of  $^R$  (M; N) allows us to simplify and strengthen some results in [HW 2] (see 32 and 33, also 44 and 45).

Section 4 is concerned with two consequences of Conjecture 1.1:

C on jecture 1.2. Let R be an adm issible hypersurface (meaning  $\hat{R}$  is a quotient of an unram i ed or equicharacteristic regular local ring by a nonzero element) with isolated singularity. Assume that dim R is even. Let M; N be R-modules such that  $Tor_i^R$  (M; N) = 0 for some i, then  $Tor_i^R$  (M; N) = 0 for all j i.

C on jecture 1.3. Let R be an adm issible hypersurface with isolated singularity. A ssum e that dim R is even. Let M ;N be R-m odules such that l(M  $_{\rm R}$  N ) < 1 . Then dim M + dim N  $_{\rm C}$  dim R .

We will prove 1.1 when M is free on the punctured spectrum of R and N = M (see 4.1). We also prove 1.3 when R is a standard graded local complete intersection and M; N are graded modules (see 4.11). Many applications follow, such as generalizations of results on Hom R (M; M) over regular local rings by Auslander and Auslander-Goldman (Corollary 4.8 and 4.9). In this section, the connection with geometry of projective hypersurfaces (which goes both ways) will be exploited.

For example, 4.11 will be proved using 1-adic cohomology, and from 4.1 we obtain the following (see 4.7):

Corollary 1.4. Let k be a eld and n an even integer 4. Let X  $P_k^n$  be a sm ooth hypersurface. Let E be a vector bundle on X . If  $H^1$  (X ; (E  $\,$  E  $\,$ ) (l)) = 0 for all 12 Z , then E is a direct sum of line bundles of the form O  $_X$  (i).

In Section 5, we gives some further applications of rigidity. The rst is a simple characterization of maximal Cohen-Macaulay modules. The second is a connection between vanishing of Ext\_R^n (M; M) with pd\_R M, following a recent result by Jorgensen ([Jo]).

## 2. Notation and preliminary results

Unless otherw ise specied, all rings are N oetherian, commutative and local, and all modules are nitely generated. A local ring (R; m; k) is a hypersurface if its completion  $\hat{R}$  has the form T=(f), where T is a regular local ring and f is in the maximal ideal of T. We say that R is admissible (as a hypersurface) if T is a power series ring over a eld or a discrete valuation ring.

For a ring R and a non-negative integer i, we set X  $^i(R) := fp\ 2$  Spec(R)jdim (R $_p$ ) ig. We denote by Y (R) the set X  $^{dim\ (R)}$  , the punctured spectrum of R. We say that R satisfy the condition (R $_i$ ) if R $_p$  is regular for any p 2 X  $^i(R)$ . We denote by G (R) the G rothendieck group of nitely generated modules over R and by G (R) = G (R)=R], the reduced G rothendieck group. Also, we let Sing (R) = fp 2 Spec(R)R $_p$  is not regular be the singular locus of R. For an abelian group G, we let G $_Q$  = G  $_Z$  Q.

Let M  $\Rightarrow$  Hom (M;R) be the dual of M . The module M is called re exive provided the natural map M! M is an isomorphism. The module M is called maximal Cohen-Macaulay (MCM) if depth<sub>R</sub> M = dim R.

For a non-negative integer n, M is said to satis es (Sn) if:

(The depth of the 0 m odule is set to be 1 .).

A pair of R-m odules (M; N) is called rigid if for any integer i = 0,  $To_1^R$  (M; N) = 0 in plies  $Tor_j^R$  (M; N) = 0 for all j = i. M oreover, M is rigid if for all N, the pair (M; N) is rigid.

One de nes the nite length index of the pair (M; N) as:

$$f_R (M; N) := m \inf_{i \in I} (Tor_i^T (M; N)) < 1 \text{ for } j \in I$$

The function  $^{R}$  (M ; N )

Let R = T=(f) be an adm issible local hypersurface. The function  $^R$  (M ;N ) was introduced by Hochster ([Hol]) for any pair of nitely generated modules M ;N such that  $f_R$  (M ;N ) < 1 as:

where e is any integer (d+2)=2. It is well-known (see £i]) that  $Tor^R (M;N)$  is periodic of period 2 after d+1 spots, so this function is well-de ned. The theta function satis es the following properties. First, if M = R N has nite length, then:

Secondly,  $^{\rm R}$  (M ;N ) is biadditive on short exact sequence, assuming it is de ned. Specifically, for any short exact sequence:

and any module M such that  $f_R$  (M;  $N_i$ ) < 1 for all i=1;2;3, we have  $i^R$  (M;  $N_2$ ) =  $i^R$  (M;  $N_1$ ) +  $i^R$  (M;  $N_3$ ). Similarly, (M;  $N_3$ ) is additive on the rst variable.

In [Da1], we show that when [M] (M) can be defined and vanishes, then (M); N) is rigid:

Proposition 2.1. Let R be an admissible hypersurface and M ; N be R-modules such that  $f_R$  (M ; N ) < 1 (so that  $^R$  (M ; N ) can be de ned). Assume  $^R$  (M ; N ) = 0. Then (M ; N ) is rigid.

The Pushforward

Let R be a G orenstein ring and M a torsion-free (equivalent to  $(S_1)$ ) R-m odule. Then there is an exact sequence:

Here = (M). This exact sequence is called the pushforward of M. The following proposition is taken from [H] JW ]. As m entioned in section 2, only a tiny m odication is needed for the proof to work w ith our denition of  $(S_k)$ .

Proposition 2.2. ( $\mathbb{H} JW$  ], 1.6) Let R; M; M<sub>1</sub> as above. Then for any p 2 Spec(R):

- (1) M  $_{p}$  is free if and only if  $(M_{1})_{p}$  is free.
- (2) If M  $_{\rm p}$  is a m axim alCohen-M acaulay R  $_{\rm p}\text{-m}$  odule, then so is (M  $_1)_{\rm p}$  .
- (3)  $\operatorname{depth}_{R_p} (M_1)_p = \operatorname{depth}_{R_p} M_p = 1.$
- (4) If M satis es  $(S_k)$ , then M  $_1$  satis es  $(S_{k-1})$ .

The depth formula

A result by Huneke and W legand showed that when all the high Torm odules vanish, the depths of the modules satisfy a remarkable equation:

Proposition 2.3. ([HW 1], 2.5) Let R be a complete intersection. Let M; N be non-zero nitely generated modules over R such that  $Tor_i^R$  (M; N) = 0 for all i 1. Then:

$$depth (M) + depth (N) = depth (R) + depth (M) R N$$

We will call a module M such that M is locally free over the punctured spectrum of R a vector bundle over Y (R) (or just vector bundle). We observe that for a vector bundle M and any R-module N, R(M; N) is always dened. In this section we will show that for certain modules over admissible hypersurfaces, Hom (M; M) and M marely have good depth. We will follow the same procedure as in [HW2], but with two essential additions: we focus on vector bundles from the beginning

(even if the results do not involve them) and we will exploit the function  $^{R}$  (M; N) rather heavily. These will allow us to simplify and strengthen some results in [HW2].

Proposition 3.1. Let R be an admissible hypersurface. Let M be a vector bundle over Y (R) such that depth (M) 1. Let N be an R-m odule such that  $^R$  (M; N) = 0 and depth (M) N) 1. Then  $To_r^R$  (M; N) = 0 for all i > 0.

Proof. The assumptions ensure that M  $\,$  is  $S_1$  . Hence we have the pushforward of M  $\,\cdot\,$ 

We can tensor with N to get:

$$0 ! Tor_{1}^{R} (M_{1}; N) ! M_{R} N ! N ! M_{1}_{R} N ! 0$$

By 2.2, M  $_1$  is also a vector bundle. So l(Tor  $_1^R$  (M  $_1;\!N$  )) < 1 . Since it em beds into a m odule ofpositive depth, Tor  $_1^R$  (M  $_1;\!N$  ) m ust be 0. C learly  $^R$  (M  $_1;\!N$  ) is de ned and equal to:

So by 2.1,  $Tor_i^R (M_1; N) = 0$  for all i > 0. Since  $M = syz_1^R (M_1)$ , we are done.

The next result is an analogue of Theorem 2.4 in [HW 2]

Theorem 3.2. Let (R;m) be an adm issible hypersurface of dimension d. Let r be an integer such that 0 r < d. Let M be a vector bundle over Y (R) such that depth (M) r. Let N be an R-module such that: N satisfy (Sr), R (M;N) = 0, and  $H_m^r$  (M) RN) = 0. Then depth (M) r + 1 and if r > 0, we have  $Tor_i^R$  (M;N) = 0 for all i > 0.

Proof. We will use induction on r. If r=0 the conclusion is trivial. Now we assume r>0. Then N satisfy  $(S_1)$  and we have the pushforward:

Tensoring with M we get:

which we breaks into two short exact sequence:

Since M is a vector bundle,  $T=Tor_1^R\ (N_1;M)$  ) has nite length. In particular  $H_m^{r+1}(T)=0$ . By applying  $H_m^0$  ( ) to the rst exact sequence we get  $H_m^r\ (C)=0$ . Now applying  $H_m^0$  ( ) to the second exact sequence and using  $H_m^{r-1}\ (M)=0$  (because depth (M)) r) and  $H_m^r\ (M_R\ N)=0$  we get  $H_m^{r-1}\ (N_1_R\ M)=0$ . We need to check the other inductive assum ptions for  $N_1$ . C learly,  $N_1$  is  $(S_{r-1})$  by 2.2. A lso, R (M;  $N_1$ ) is de ned and equal to:

So by induction we have depth (M  $_R$  N $_1$ ) r. Then by 3.1 Tor $_i^R$  (N $_1$ ;M ) = 0 for all i > 0, so we have the rst assertion and :

which implies depth (M R N) r+1.

Corollary 3.3. Let R be an admissible hypersurface satisfying condition ( $R_2$ ). Let M be a re-exive R-module such that M = 0 in  $\overline{G}$  (R)<sub>Q</sub>. If H om (M; M) satisfy ( $S_3$ ) then M is free.

Proof. We use induction on d = dim R. If d 2 then R is regular, and M , being re exive, must be free. Assumed 3 and (by induction hypothesis, since all the conditions localize) that M is free on the punctured spectrum. In other words, M is a vector bundle. Consider the natural map : M  $_{\rm R}$  M ! Hom (M;M). Since M is a vector bundle, the kernel and cokernel of both have nite length. By considering the long exact sequence of local cohomology from the two short exact sequences:

and using  $H_m^i$  (Hom (M; M)) = 0 for i < 3 (because Hom (M; M) is (S<sub>3</sub>) and d 3) we can deduce that  $H_m^2$  (M  $_R$  M) = 0. Now M is also a re exive vector bundle, hence  $^R$  (M; M) = 0. So Theorem 3.2 applies to give  $Tor_i^R$  (M; M) = 0 for all i > 0. By depth formula we get:

$$depth(M) + depth(M) d + 3$$

so by ([Va], 3.3.16) we must have depth (M ) = depth (M ) = d. On the other hand, the vanishing of all Tor  $_i^R$  (M ; M ) forces one of this modules to have nite projective dimension (see ([HW 2], 1.9). Either way, M must be free (since M is MCM).

Exam ple 3.4. This will be our main example throughout this note. Let R =  $k \, [[x;y;u;v]] = (xu \quad yv) \, with \, m = (x;y;u;v) \, and \, M = (x;y) \, .$  Then M = (x;v) and M \_ R M = (x^2;xy;xv;yv) = (x^2;xy;xv;xu) = m . Using the long exact sequence of local cohom ology for the sequence 0 ! m ! R ! k ! 0 we get  $H_m^1 \, (M \quad _R M \quad ) = H_m^1 \, (m) = k \, and \, H_m^2 \, (M \quad _R M \quad ) = H_m^2 \, (m) = 0 \, . \, C \, learly \, depth \, (M \quad _R M \quad ) = 1 \, .$ 

Note that both M and M are MCM modules over R. Since R has isolated singularity, they are also vector bundles over Y (R). It can be easily computed that  $Tor_{1}^{R}$  (M; M) = 0,  $Tor_{2}^{R}$  (M; M) = k and R (M; M) = 1.

Consider Proposition 3.1 and Theorem 3.2. Let N = M . Then the example shows that the condition  $^{\rm R}$  (M ;N ) = 0 can not be dropped.

Consider Corollary 3.3. Since  $\overline{G}$  (R)<sub>Q</sub> = Q M ], the condition M = 0 in  $\overline{G}$  (R)<sub>Q</sub> can not be dropped either.

## 4. Isolated hypersurface singularities of even dimensions

In this section we will show some supporting evidences for Conjecture 1.1. They indicate that modules over isolated hypersurface singularities of even dimensions behave very similar to those over regular local rings. We extra prove:

Theorem 4.1. Let R be a hypersurface with isolated singularity. Assume that  $\dim R$  is even. Then for any vector bundle M on Y(R), R(M; M) = 0.

We need to review the concept of stable (co)hom ology (form ore details, see [Bu] or [AB]). Let R be a Noetherian ring, a complete resolution of an R-m odule M is a complex T such that  $H_n(T) = H^n(T) = 0$  for all  $n \in T$  and  $T_r = P_r$  for some projective resolution of M and some integer r. It is known that the modules

 $\mbox{H}^{\,1}\mbox{ (H om }_{\mbox{R}}\mbox{ (T ;N ))}$  and  $\mbox{H}_{\,1}\mbox{ (T }_{\mbox{R}}\mbox{ N )}$  are independent of the resolution, and one calls them  $\mathbf{E}\mathbf{x}_{R}^{i}$  (M;N) and  $\mathbf{For}_{i}^{R}$  (M;N), respectively.

We will need the standard and easy results below, reproved for the reader's convenience (some of these could be found in [AB], but we could not nd a full reference):

Lem m a 4.2. Let R be a local hypersurface. Let M ; N be R-m odules such that M is maximalCohen-Macaulay (MCM). Then we have the following isomorphism:

- (1)  $\operatorname{Tor}_{i}^{R}(M;N) = \operatorname{Por}_{i}^{R}(M;N)$  for all i > 0.
- (2)  $\operatorname{Ext}_{R}^{i}(M;N) = \operatorname{Ext}_{R}^{i}(M;N)$  for all i > 0.

- (3)  $\text{Por}_{i}^{R}$  (M ;N ) =  $\text{Por}_{i+2}^{R}$  (M ;N ) for all i. (4)  $\text{Ext}_{R}^{R}$  (M ;N ) =  $\text{Ext}_{R}^{I}$  (M ;N ) for all i. (5)  $\text{Por}_{i}^{R}$  (M ;N ) =  $\text{Ext}_{R}^{I}$  (M ;N ) for all i. (6)  $\text{Tor}_{i}^{R}$  (M ;N ) =  $\text{Ext}_{R}^{I}$  (M ;N ) for all i.

Proof. Let  $F: ::: ! F_1 ! F_0 ! M ! 0$  be a free resolution of M . Since M is = M and  $Ext^n$  (M; R) = 0 for all n 1. So dualizing F we get: M CM we have M

$$F : 0! M ! F_0 ! F_1 ! :::$$

W e can splice the two complexes together to get:

$$T : ::: ! F_1 ! F_0 ! F_0 ! F_1 ! :::$$

It is obvious that T is a complete resolution of M. That proves (1) and (2). Also, since M is MCM and R is a hypersurface, F (and therefore T) is periodic of period 2. Hence (3) and (4) follows. From the construction, T [ 1] is a complete resolution of M  $\,$  , and the canonical isom orphism  $\,$  H om  $_{R}$  (T  $\,$  ; N  $\,$ ) = (T  $_{R}$  N  $\,$ ) gives (5). Finally, (6) follows from combining (1), (5) and (4).

We will also need the following result by Buchweitz:

Proposition 4.3. (Bul,10.3.3) Let R be a local hypersurface with isolated singularity such that dim R is even. Then for any two MCM R-modules M; N, even integer i and odd integer j:

$$1(2xt_{R}^{i}(M;N)) = 1(2xt_{R}^{j}(N;M))$$

Now we can prove 4.1:

Proof. (of Theorem 4.1) First, we will prove the theorem for the case when M is MCM. In this situation, for any integer i> 0 we have:

$$Tor_{i}^{R} (M;M) = \cancel{E}^{l}xt_{R}^{i+1} (M;M)$$

by (6) of 4.2. Hence 4.3 shows that  $^{R}$  (M; M) = 0.

Now, assumeM is a vector bundle. Let  $K = syz_1^R (M)$ . We claim that  $R (M;M) = Syz_1^R (M)$  $^{R}$  (K; K). Dualizing the short exact sequence: 0 ! K ! F ! M ! 0 we get:

$$0! M ! F ! K ! Ext_{R}^{1} (M;R)! 0$$

So M = K +  $\operatorname{Ext}_{R}^{1}$  (M ; R) in  $\overline{G}$  (R). But  $\operatorname{Ext}_{R}^{1}$  (M ; R) has nite length because M is free on the punctured spectrum of R, so it is equal to 0 in  $\overline{G}$  (R)<sub>Q</sub>. So  $^{R}$  (M ; ) =  $^{R}$  (K ; ). Together with  $^{R}$  (M ; ) =  $^{R}$  (K ; ), the claim follows.

Repeating the claim we get  $^R$  (M ; M ) =  $^R$  (K ; K ) when K =  $syz_n^R$  (M ) for any n > 0. But for n > 0 K is an MCM R-module, so  $^R$  (K ; K ) = 0.

C orollary 4.4. Let R be an adm issible hypersurface such that R has isolated singularity and dim R > 2 and is even. Let M be a re exive R-module. If H om (M;M) satisfy  $(S_3)$  then M is free.

Proof. Exam ining the proof of 3.3 we can see that the only thing we need is  $^R$  (M ;M ) = 0. Since by induction we can assume M is a vector bundle, the Corollary follows from Theorem 4.1.

C orollary 4.5. Let R be an admissible hypersurface such that R has isolated singularity and dim R 2 and is even. Let M be a vector bundle over Y (R).

- (1) If  $H_m^1$  (M  $_R$  M ) = 0 then M = F T, where T is free and T has nite length. (2) If  $H_m^2$  (M  $_R$  M ) = 0 and dim R > 2 then M is free.
- Proof. (1) By (3.3) of [HW 2] we may assume that M is torsion free. By 32 we have  $Tor_i^R$  (M; M) = 0 for all i > 0. An identical argument to the last part of 3.3 shows that M is free.
- (2) By (3.3) of [HW 2] we have  $H_m^2$  (M R M ) = 0. A gain, using 3.2 we have M is free.

Example 4.6. Let R; M as in Example 3.4. Then  $H_m^2$  (M  $_R$  M ) = 0 but M is not free. Note that dim R = 3.

Corollary 4.7. Let k be a eld and n an even integer 4. Let X  $E_k^n$  be a sm ooth hypersurface. Let E be a vector bundle on X . If  $H^1\left(X\;;\;(E\ E\ )\;(l)\right)=0$  for all  $12\ Z$ , then E is a direct sum of line bundles of the form  $O_X$  (i).

Proof. This is a straightforward consequence of standard connections between a projective variety and its a necone (see section 5 in [HW 2]).

It is worth noting that two obvious consequences of Corollary 4.4 which are generalizations of well-known results by Auslander and Goldman (AG), Theorem 4.4) and Auslander (Au], Theorem 1.3) for modules over regular local rings:

Corollary 4.8. Let R be an admissible hypersurface such that R has isolated singularity and dim R > 2 and is even. Let M be a re exive R-module. If Hom  $(M;M) = R^n$  for somen then M is free.

C orollary 4.9. Let R be an adm issible hypersurface such that R has isolated singularity and dim R > 2 and is even. Let M be an R-m odule satisfying  $(S_3)$ . If H om  $(M ; M) = M^n$  for some n then M is free.

We now show that Conjecture 13 is true in the standard graded case:

Theorem 4.10. Let k be an algebraically closed eld. Let X  $P_k^N$  be a smooth complete intersection such that dim X = n is odd. Let U; V be subvarieties of X such that U \ V = ; . Then dim U + dim V < dim X .

Proof. We are going to use 1-adic cohom ology (for basic properties and notations, we refer to  $[M\ i]$ ). Let 1 be a prime number such that  $1 \in \text{char}(k)$ . There is a class map:

$$cl:CH^{r}(X)!H^{2r}(X;O_{1}(r))$$

This map gives a graded ring hom eom orphism CH (X)!  $H^{2r}(X;Q_1(r))$  (with the intersection product on the left hand side and the cup product on the right hand side, see Mil, chapter 23). Let  $a=\dim U$  and  $b=\dim V$ , and we may assume a b. Suppose  $a+b=\dim X=n$  (if a+b>n, we can always choose some subvariety of smaller dimension in U or V such that equality occurs). Then 2a=n, but n is odd, so 2a>n. Let  $h \in CH^1(X)$  represents the hyperplane section. By Weak Lefschetz Theorem and the fact that 2(n=a)< n, we have

$$H^{2(n a)}(X;Q_1(n a)) = H^{2(n a)}(P_k^N;Q_1(n a))$$

the latter is generated by power of the class of the hyperplane section. Thus cl(U ) = cl(h)^n a in H  $^{2(n-a)}$  (X ;Q  $_1$ (n a)). We then have :

$$\operatorname{cl}(U \ \ \ \ ) = \operatorname{cl}(U) [\operatorname{cl}(V) = \operatorname{cl}(h)^n \ \ \ \ \ [\operatorname{cl}(V) = \operatorname{cl}(h^n \ \ \ \ \ \ \ ))$$

The last term is equal to the degree of  $h^n$   $^a$   $\mathbb{V}$  2 CH $^n$  (X), so it is nonzero. But the rst term has to be 0 by assumption. This contradiction proves the Theorem.

Theorem 4.11. Let k be a eld. Let  $A=k \, [\![k_0]\!]; :::;;x_N \not\models (I)$  be a homogenous complete intersection. Let  $(R\ ;\![m\ ;\![k]\!])$  be the local ring at the origin of A. Suppose that R has isolated singularity and dim R is even. Let M ; N be graded R-modules such that  $l(M)_R N$ ) < 1. Then dim M + dim N dim R.

Proof. W ithout a ecting them atters we may assume k is algebraically closed. Since the minimal primes over a graded modules are graded, we may replace M and N with R=P and R=Q, where P; Q are homogenous primes in R. Now let X = P roj(A), U = P roj(A=P), V = P roj(A=Q) and applying the previous Theorem.

## 5. Some other applications

We note a simple characterization of maximal Cohen-Macaulay modules, due to the fact that over an admissible hypersurface, a module of nite length is rigid (see 4.10 in [0.1]):

P roposition 5.1. Let R be a adm issible hypersurface and M an R-module. The following are equivalent:

- (1) There is a nite length module N such that  $Tor_1^R (M; N) = 0$ .
- (2) There is a nite length module N such that  $Ext_R^1$  (M; N) = 0.
- (3) M is a maximal Cohen-Macaulay R-module.

Proof. For equivalence of (1) and (2): we may assume R is complete. Then by Matlis duality  $Tor_1^R$  (M; N) - Ext\_R^1 (M; N-), so (1) and (2) are equivalent.

Assume (1). Then since N is rigid, we have  $Tor_i^R (M;N) = 0$  for all i 1. The depth formula shows:

$$depth(M) + depth(N) = depth(R) + depth(M)$$

hence depth (M) = depth(R) and (3) follows.

Finally, assum e (3). Let  $n=\dim R$ , we can choose a regular sequence  $x_1$ ; :::;  $x_n$  on both M and R (by induction on n). Now, just take  $N=R=(x_1; :::; x_n)$ . Then N is nite length and  $Tor_1^R$  (M; N) = 0.

It would be very interesting to know whether the previous P roposition is true for all local complete intersections. It is not hard to see that this question has intimate connection to the rigidity of modules of nite length over such rings:

Lem m a 5.2. Let C be the category of all local complete intersections. Considering the following properties:

- (1) For any R 2 C, an R-module of nite length is rigid.
- (2) For any R 2 C and any R-m odule M , if there is a  $% 10^{12}$  nite length R-m odule N such that Tor\_1 M ;N ) = 0 then M  $% 10^{12}$  is m axim alCohen-M acaulay.
- (3) For any R 2 C such that dim R > 0 and any R-m odule M , if there is a nite length R-m odule N such that  $Tor_1^R$  (M ;N ) = 0 then depth (M ) > 0.
- (4) For any R  $^2$  C, an R  $^4$ m odule of nite length and nite projective dimension is rigid.

W = have (1) ) (2) , (3) ) (4).

Proof. (1)) (2) is the proof of 5.1.

- (2), (3). (2) clearly implies (3). Suppose (3) holds. Then since depth (M); depth (R) > 0 we can nd x 2 Ann\_RN such that x is regular on both R and M. Then  $Tor_1^{R=(x)} \text{ (M =xM; N)} = Tor_1^R \text{ (M; N)} = 0. \text{ So we can replace R; M by R=(x); M =xM}$  and repeat the process until dim R = 1, at which point M is MCM by (3).
- (2)) (4). Suppose M ;N are nonzero R -m odules such that l(N) < 1 , pd<sub>R</sub> N < 1 and Tor\_i^R (M ;N ) = 0 for some i > 0. Then let M  $^0$  =  $syz_{i-1}^R$  M and we get Tor\_1^R (M  $^0$ ;N ) = 0. By (2) M  $^0$  is M CM . Let q be the largest integer such that Tor\_R (M  $^0$ ;N )  $\in$  0. Then by Lem m a 22 in [HW 2] we have:

$$\label{eq:continuous} \mbox{depth}(M^0) + \mbox{depth}(N) = \mbox{depth}(R) + \mbox{depth}(Tor_q^R M^0;N)) \quad \mbox{ q} \\ \mbox{Since depth}(M^0) = \mbox{depth}(R) \mbox{ and depth}(N) = \mbox{depth}(Tor_q^R M^0;N)) = 0 \mbox{ we must have } q = 0.$$

Remark. In [JS] a module M is constructed over a 0-dimensional Gorenstein ring such that M is not rigid. So property (1) fails for Gorenstein rings.

Finally, we want to use our approach to rigidity to prove a connection between vanishing of Ext and projective dimension, following a recent result by Jorgensen. In [Jo], the following was proved:

Theorem 5.3. ([Jo], Theorem 1.1) Let R be a local ring and M an R-module such that M is rigid. Then  $\operatorname{Ext}^n_R(M;M)=0$  if and only if  $\operatorname{pd}_R(M)< n$ .

W e will modify Jorgensen's proof to show:

Proposition 5.4. Let R be an admissible hypersurface and M be an R-module such that M = 0 in  $\overline{G}$  (R) $_{Q}$ . Then Ext\_{R}^{n} (M ;M ) = 0 if and only if pd\_R (M ) < n.

Rem ark. Over a hypersurfaces, the classes of rigid modules and of modules which are 0 in  $\overline{G}$  (R)<sub>0</sub> are incomparable (see [Da1]).

Proof. We ret need to review some notation in [Jo]. Let N be an R-m odule and let

$$F = ::: ! F_2 ! F_1 ! F_0 ! N ! 0$$

be a m in im al free resolution of N . Then one can de ne for i 0:

$$D^{i}(N) = coker(F_{i} ! F_{i+1})$$

Exam ining the proof of Lem m a 2.2 and Theorem 1.1 in [Jo] shows that to prove Ext^n\_R (M ; M ) = 0 in plies pd\_R (M ) < n one only needs that the pair (D ^n (syz^R\_{n-1} M ); M ) is rigid. Let L = D ^n (syz^R\_{n-1} M ). We will show that ^R (L; M ) = 0 using induction

on dim R. Ifdim R = 0 then  $\frac{R}{G}$  (; ) is always de ned and equals 0, since all modules have nite length and  $\frac{R}{G}$  (R)<sub>Q</sub> = 0. Take any prime p 2 Y (R). By induction (syz<sub>n-1</sub> M)<sub>p</sub> is free, so L<sub>p</sub> is a free R<sub>p</sub> module. Thus  $\frac{R}{G}$  (L; ) is always de ned and since M = 0 in  $\frac{R}{G}$  (R)<sub>Q</sub> we must have  $\frac{R}{G}$  (L; M) = 0. So (L; M) is rigid and we are done.

Exam ple 5.5. Let R = k[x;y]=(xy) and M = R=(x). Then  $Ext^{2i+1}(M;M) = 0$  for all i > 0 but  $pd_R M = 1$ . Note that  $\overline{G}(R) = Z[M]$ .
