# Control Theory for Sem igroups over Local Fields

#### Abstract

Let G be a 1-connected, alm ost-sim ple Lie group over a local eld and S a subsem igroup of G with non-empty interior. The action of the regular hyperbolic elements in the interior of S on the ag manifold G =P and on the associated Euclidean building allows us to prove that the invariant control set exists and is unique. We also provide a characterization of the set of transitivity of the control sets: its elements are the xed points of type w for a regular hyperbolic isom etry, where w is an element of the W eyl group of G. Thus, for each w in W there is a control set D<sub>w</sub> and W (S) the subgroup of the W eyl group such that the control set D<sub>w</sub> coincides with the invariant control set D<sub>1</sub> is a W eyl subgroup of W. We conclude by showing that the control sets are param eterized by the lateral classes W (S)nW:

## 1 Sem igroups and Control Sets

Our purpose in this text is to study a particular example of sem igroup: namely, the sem igroup of a Lie group over a local eld. This task will be tackled in an essentially geometrical way, by means of a detailed study of the action of the sem igroup in a suitable space. This approach leads to a rich theory that relates the sem igroup to the control sets. We begin with some basic de nitions:

Let X be a topological space and C (X ) the group of hom eom orphism s of X , a sem igroup (of hom eom orphism ) is a set S C(X) closed under composition.

Let S be a sem igroup of hom eom orphism of X and x a point in X: The set Sx = fgx 2 X : g 2 Sg is called the orbit of x by the action of S: W e will refer to the closure cl(Sx) of Sx in X as the approxim at orbit. A subset of X is S-invariant if SD D:

We say that the action of S on a set A X is approximately transitive if A cl(Sx) for all  $x \ge A$ .

De nition 1 A control set for S in X is a subset D X which fulls the following conditions :

1. D cl(Sx) for all x 2 D

2. D is maximal with the rst property

3. intD € ;

The rst two item softhe previous de nition of controlset says that these sets are maximal sets where the action of S is approximately transitive.

W e introduce the following partial ordering between control sets:  $D_1$  is smaller than  $D_2$  if there exist x 2  $D_1$  and s 2 S such that sx 2  $D_2$ . A maximal control set with respect to this ordering is called an invariant control set , which is clearly S-invariant.

W e de ne the set of transitivity as

 $D_0 = fx 2 D : x 2 int(S^1x)$ 

P roposition 2 Let S be a sem igroup of hom eom orphism s with non-empty interior, D a control set for S in X and D $_0$  the set of transitivity of D. Then the following hold:

1.  $D_0 = int(Sx)$  for all x 2  $D_0$ 

2.  $cl(D_0) = D$ 

3. For any x; y 2 D<sub>0</sub>, 9s 2 S with sx = y

The last item above elucidate why D  $_{\rm 0}$  is called the set of transitivity of D .

W hen the topological space X is compact, an application of Zom's Lemma yields the existence of an invariant control set D .

In the very special case in which S G, with G a sem i-simple Lie group, San M artin has developed a powerful theory relating the sem igroups and the control sets in the ag manifold G = P. Am ong others results San M artin proved that if  $int(S) \in i$ ; then there is a unique control set in G = P, and that for each element of the W eylgroup w 2 W there exist a control set D<sub>w</sub> on maximal ag G = P, whose elements of the set of transitivity are xed points of type w, for some regular h. For more information and another results see [?] and [?].

W e generalize these results for algebraic groups over a local eld.

## 2 Buildings

## 2.1 Coxeter G roups and C om plexes

Let I be a nite set of indexes. A C oxeter matrix  $M = (m_{ij})$  is a square matrix with values in N [fl g such that  $m_{ij} = 1$  if and only if i = j and  $m_{ij} = m_{ji}$ :

To simplify the notation we denote  ${\tt W}$  (M) by  ${\tt W}$  wherever it is clear which C oxeter M atrix is been referred.

We can see identify the set of indexes I with the the set  $fr_i : i 2$  Ig of order two generators of W and call the pair (W;I) a C oxeter system .

A special subgroup of a Coxeter group W with generators J is a subgroup W (J) generated by a subset J I. A special coset is a coset wW (J), determined by a special subgroup W (J).

Now we will describe the cham ber complex, the Coxeter complex, associated to a Coxeter system, that will be crucial in this work. Let V be a poset with the usual inclusion order. Let be a family of nite subsets of V containing every singleton fvg V and satisfying the condition that, if A 2 and B A then B 2 . Such a pair (V; ) is called a sim plicial complex and a fam ily of sim plices. Given sim plices B A 2 we say that B is a face of A.

The cardinality r of a simplex A is said rank of A and r 1 is said dim ension of A. Two simplices A; B in a simplicial complex are adjacent if they have a codim ension 1 face. A gallery is a sequence of m axim al simplices in which any two consecutive ones are adjacent.

We will say that is a cham ber complex if all maximal simplices have the same dimension and any two can be connected by a gallery. The maximal simplices will then be called chambers. A chamber complex is said labelled by a set I; if there is a surjective function :V ! I such that the restriction to each chamber is a bijection.

Given a Coxeter G roup W (I), we consider the set of all special cosets = (W;I). We de ne on a partial order inverse to the inclusion: W (J) W (L) if L J. W ith this order we nd the posets (; ) and (P (I); ) are isom on orphic and thus a simplicial structure can be induced on , thus called the C oxeter com plex of (W;I). Them axim alekements in

(W; I), are called chambers. They are the minimal special cosets, i.e., the sets with one element w with w 2 W: The adjacency relation is determined as follows:  $w_1 = i w_2 i w_1 = r_i w_2$  with  $r_i 2 I$ ; We remark that every C oxeter complex can be labelled by I, the set of generators of W: W hen considering the usual action of W in the set of its cosets by left product, we have the follow ing:

Proposition 3 [Hu]

- 1. The group W acts on (W; I) by type-preserving autom orphism s.
- 2. The action of the group W is transitive on the collection of sim plices of a given type.

### 2.2 Tits Building

A building is a simplicial complex ; togheter with a family A subcom – plexes (called the set of apartments) satisfying the following axiom s:

- 1. Each apartment is a Coxeter com plex.
- 2. For any two simplices A ; B 2  $\,$  , there is an apartment  $\,$  containing both of them .

- 3. If and <sup>0</sup> are two apartments containing A and B, then there is an isom orphism ! <sup>0</sup> xing A and B pointwise.
- 4. Every codim ension 1 simplex is a face of at least three chambers (thickness axiom).

It is clear, by A xiom B 2, that every two apartments are isomorphic. It also implies that two maximal simplices A and B have the same dimension can be connected by a gallery in the apartment containing both of them, and so is a chamber complex. Furthermore is a labelled chamber complex labeled by I, the set of generators of the Coxeter group of any given apartment. The isomorphism of apartments ! <sup>0</sup> postulated in A xiom B 2 can, a posteriori, be taken as label preserving isomorphism.

Any collection A of apartments satisfying the former axioms will be called a system of apartments for .

P roposition 4 The apartments are convex, i.e., given two chambers of , then every minimal gallery of  $\$  connecting these chambers is contained in

## 2.3 Autom orphism G roups and BN -pairs

Let be a building, A a system of apartments for and a group G acting on as simplicial automorphism that preserves labels and that leaves A invariant, i.e., if 2 A then g 2 A.

We say that the action of G is strongly transitive if G acts transitively in the pairs (;C); with C 2 , in other words, if G is transitive in the apartments and the stabilizer of an apartment is transitive on the chambers of .

Henceforward we will assume that G acts strongly transitive in and chose  $_0$  2 A and C $_0$  2  $_0$ , called the fundam ental apartm ent and fundam ental cham ber, respectively.

Given J I we de ne  $P_J$  G as the subgroup of G generated by < B;W(J) >, where W(J) is the special subgroup with generators indexed by J. A face of type J is a simplex of with vertices labeled by J.

P roposition 5 G iven  $J^0$  J and a face A of type J  $J^0$ , then the stabilizer  $P_{J^0}$  of A satisfies:

In particular, we have the B ruhat D ecom position of G:

As a consequence of the Bruhat D ecom position and the A xiom of T hickness, we have that B w B B j B B w B [B w j B and j B j B for every j 2 J. All those properties are stated as postulates in the de nition of B N -pairs.

The relation between buildings and B N -pairs are stated in the next two Theorem s N ow we can state the T it's Theorem s that relates the structure of building with the structure of B N -pairs

Theorem 7 ([B ro] pg. 100-115) G iven a building with G a group acting strongly transitive. Dening B;C and N as in 1 we the pair (B;N) is a T its system. Reciprocally, every system of T its (B;N) in a group G denes a building in which the chamber are the cosets of B and the equivalence relation is given by gB<sup>j</sup> g<sup>0</sup>B ()  $gP_j = g^0P_j$  and nally, the action of G is strongly transitive and N stabilizes an apartment.

## 3 Geometrical Representation of Buildings

W hen the Coxeter group is an isometry group of a space we can give a geometrical meaning to the Coxeter Complex and to the building.

## 3.1 Spherical Buildings

Let V be a nite-dimensional real vector space with an inner product, H V be a hyperplane and an unit normal vector to H. The rejection with respect to H is the linear transformation dened as  $s_H(v) = v$  hv; i.

A nite re ection group is a nite group W of linear transform ations of V generated by re ections  $s_H$ , where H ranges over a set H of hyperplanes. In other words, W is a discrete subgroup of the orthogonal group O (V), that is generated by re ections.

We say that a nite relection group W is essential relative to V if W acts on V with no nonzero xed points. Given a nite relection group W and V<sub>0</sub> its space of xed points, It's clear that any subgroup W stabilizes  $V_0$  and its orthogonal complement  $V_0^2$  and W is essential relative to  $V_0^2$ .

A nite relection group (W ;V) is called reducible if V decomposes as  $V^0 = V^0 w$  ith  $V^0$  and V " non-trivial and W invariant, i.e., W  $V^0 = V^0$  and W  $V^0 = V^0$ .

Let  $F = fa_H = h$ ; i:H 2 H g the set of all linear functional associated with H 2 H. G iven a function :F ! f+1; 1g, we associate the set:

$$C = fx 2 V : (x)f(x) > 0;8f 2 Fg$$

The cham bers are the non empty C . The chambers form a partition of V into disjoint convex cones.

A set B is called a face of A if its the intersection of C with a subspace  $S_T = fx 2 X : f(x) = 0$ ; 8f 2 T Hg. In this case we write B A. A wall is a maxim alproper face.

A Coxeter complex is called spherical if it is isomorphic to the complex associated to a nite relection group. It can be demonstrated that is spherical i has nite diameter. A building  $_{\rm S}$  is called spherical if its apartments are spherical. The diameter of a spherical building  $_{\rm S}$  is nite and equal to the diameter of any apartment.

Two chambers  $C; C^0$  in a spherical building s are said to be opposite if  $d(C; C^0) = diam(A)$ .

### 3.2 Euclidean Buildings

Let V be a nite-dimensional real vector space with an inner product. The isometry group of V is the sem idirect product O (V) n V. A a nere ection group W is a discrete subgroup of O (V) n V, that is generated by re ections in a ne hyperplanes.

We de ne H = fH :s<sub>H</sub> 2 W g and F = fa<sub>H</sub> :H 2 H g. We can de ne the chambers for the a ne relection group in a similar way as we de ne for the nite groups. In the a ne case the chambers are bounded and they are the open D irichlet domains for the action of W in R<sup>n</sup>.

Henceforth, let  $C_0$  be a xed chamber, that we denom in the fundam ental chamber, and let J be the rejections in the walls of  $C_0$ .

Proposition 8 1.

2. The action of W is simply transitive in the chambers.

- 3. W is generated by J.
- 4. W ; J is a Coxeter Com plex.
- 5. Exists x 2 V such that the stabilizer W  $_{\rm x}$  is isomorphic to a nite C oxeter group  $\overline{\rm W}$  .
- 6. W '  $Z^n n \overline{W}$ , with n being the dimension of V.

A point x 2 V such that  $W_x$  is isomorphic to  $\overline{W}$  is called special point. A (n abstract) C oxeter complex is said Euclidean if it is isomorphic to the complex j jassociated to an a nere ection group. The complex j jis called the geometric realization of the complex . We can choose a norm in the vector space V such that the chambers has diameter 1, this norm are called the canonical norm and with it every simplicial isomorphism : !

<sup>0</sup> induces a isom etry on the geom etrical realization, j j: j j<sup>0</sup>.

Let j jbe the geom etric realization of a Euclidean C oxeter com plex, and let H be the associated set of hyperplanes in V. Fix x 2 V and let  $\overline{H}$  be the set of hyperplanes through x and parallel to som e element of H. The set  $\overline{H}$  is nite. Let  $F = a_H = h$ ; i:H 2  $\overline{H}$  the set of all linear functional associated with H 2  $\overline{H}$ . Given a function :F ! f+1; 1g, we associate the set:

$$A = fy 2 V : (x) f(y x) > 0;8f 2 Fg$$

The sectors are the non empty A . The sectors form a partition of V into disjoint convex cones. Given A and B sectors, A is called a subsector of B if A  $\,$  B .

A set B is called a face of A if its the intersection of C with a subspace  $S_T = fy 2 X : f(y = 0, 8f 2 T = Hg$ . In this case we write B A. A wall is a maximal proper face. These cells will simply be referred to as conical cells based at x. C learly if A is a sector based at x, the set A = x + y is a sector based at y. A building  $_{\rm E}$  is called Euclidean if its apartments are Euclidean. A geometrical realization j  $_{\rm E}$  jof a Euclidean Building is is a building such that each apartment is a a ne Coxeter complex.

## 3.3 The Geometry of Euclidean Buildings

Euclidean Buildings are very nice geom etrical spaces. They are the n dimensional generalization of trees and some kind of discrete symmetric spaces of non-positive curvature .

We start de ning a very special metric in the geometrical realization  $j_E j o f_E G$  iven two points x; y 2  $j_E j$ , the axiom (B1) of buildings says that exists a apartment containing x and y. This apartment can be endowed with a metric such that the chambers have diameter 1. Let d (x; y) be the distance of x and y in this metric. We de ne the canonical metric as:

$$d(x;y) = d(x;y)$$

Proposition 9 ([Ga] pg. 194) Given f: E ! C = 0 a morphism of Euclidean building. Then jfj:j E j! j E c is a isometry of the geometrical realization.

The geom etrical realization  $j_E$  jwith the canonical metric is a CAT (0) space. This means that the curvature of such spaces is smaller or equal to zero, in the sense that the triangles in such spaces are thinner than in  $\mathbb{R}^2$ .

G iven x;y;z three points in a metric space X, a comparison triangle 4 in  $\mathbb{R}^2$  is a triangle with vertices  $\overline{x};\overline{y};\overline{z}$  such that

$$d(x;y) = d(\overline{x};\overline{y}); d(y;z) = d(\overline{y};\overline{z}) \text{ and } d(x;z) = d(\overline{x};\overline{z})$$

A metric space X is called a CAT (0) space if for any geodesical triangle 4 in X and  $\overline{4}$  a comparison triangle in R<sup>2</sup>. We have that  $d(x;y) = \overline{d}(\overline{x};\overline{y})$  for any x; y 2 4.

A complete CAT (0) space is called H adam and space. Its easy to see that the geometrical realization  $j_E j of_E$  is a H adam and space. (For a proof and a more general result see [Ga]pg. 197). From now on, a CAT (0) space m eans a complete one.

The CAT (0) inequality in plies the following properties of the building j  $_{\rm E}$  j

 that given two points x; y there is a unique geodesic segm ent joining these points, and that this geodesic segm ent varies continuously with it endpoints

- 2. That the balls are convex and contractible, in particular it is simply connected and all of its higher hom otopy groups are trivial.
- 3. A at F is a set that is isometric to some  $R^n$ . Every maximal at is a apartment and vice versa. So we have a geometrical description of the apartments in the geometrical realization j<sub>E</sub> j.
- The apartments are convex and every geodesic is contained in an apartment. A geodesic is called regular if it's contained in just one apartment.

## 3.3.1 The Building at the In nite

Given X a locally compact CAT (0) space, two geodesic rays (t) and (t) are called asymptotic if exists a constant K such that d((t); (t)) K for all t 0.

We denote the set of points in the boundary of X, (X, as the equivalence class of asymptotic rays. The union X [ <math>(X, w) ill denoted by  $\overline{X}$ . Given x 2 X and 2 (X, exists a geodesic ray starting at x and such that (1) = This ray will be denoted by <math>x:

We introduce a topology at  $\overline{X} = X$  [@X using as base to this topology the open sets of X and the following opens sets:

 $U(x; ;R;") \coloneqq fz \ 2 \ \overline{X} : z \ B(x;R) \text{ and } d(x;z(R); x;(R)) < "g$ 

with x 2 X , 2 @X and R, " real num bers. This topology does not depend of the choice of the base point, and with this topology  $\overline{X}$  is a compact space.

A fundamental fact of this topology is that given a isometry of a complete CAT (0) space, the natural extension of to  $\overline{X}$  is a homeomorphism.

The compactication of the geometrical realization of  $_{\rm E}$ ,  $(j_{\rm E})$ , can be provided with a spherical building structure.

The face in the in nity  $c_1$  of a conical cell c in  $j_E j w$  ith vertex  $x_0$  is dened as the set of points 2  $(j_j)$  such that the open geodesic ray (x; ) is contained in c. An Ideal simplex or simplex in the in nity is a subset of  $(j_E j)$  for which exists a conical cell c such that  $= c_1$ .

Given c; d two conical cells with vertex at  $x_0$ , we say that the ideal simplex  $d_1$  is a face of the ideal simplex  $c_1$  if d is a face of c. In that case we write  $d_1$   $c_1$ .

Theorem 10 ([G a] pag. 279) The ideal simplex partition  $(j_E)$ . The face relation is well de ned and the poset of ideal simplices of  $(j_E)$  is the

geom etrical realization of the spherical building associated with  $j_E j$  i.e.,  $((j_E) = j_S)$ . Moreover, the apartments of  $((j_E) = j_S)$  are in bijection with the maximal system of apartments of  $j_E j$ .

## 4 A lgebraic G roups over Local Fields

#### 4.1 Local elds

In what follows, k will denote a eld with char(k) = 0. An ultram etric norm in a eld k is a function  $jj k ! Z_+$ , that satisfy

- 1. jx j = 0, x = 0
- 2. jxyj= jxjjyjand jlj= 1
- 3. jx + yj maxfjxj;jyjg

The last inequality is called ultram etric inequality or strong triangular inequality.

Another way to de ne an ultram etric norm is through a valuation. A valuation v of k is a hom on orphism of the multiplicative group k of k into the additive group of Z that satis es v(x + y) m in fv(x); v(y)g for all x; y 2 k with  $x + y \in 0$ . By convention we de ne v(0) = 1 and thus the last inequality can be interpreted for all x; y 2 k.

A valuation induces an ultrametric norm in k: if we de ne  $j_x j_y = e^{v(x)}$ and conversely a norm induces a valuation  $v_{jj}(x) = \log(j_x j)$ , thus we will use these concepts without distinction.

A eld with a norm that satis es the strong triangular inequality is said ultram etric eld or Archim edean eld. A eld is said to be com plete if it's com plete in the topology induced by the norm.

A local eld is a complete and locally compact ultrametric eld.

Example 11 The p-adic eld.

Given p a prime number, we can construct in Q the p-adic norm. For alla 2 Q we decompose  $a = p^{r} \frac{m}{n}$  with r; m; n integers and m and n coprime with p. So we de ne the norm  $j_{\frac{1}{p}}$  in Q by  $j_{\frac{1}{p}} = 0$  and by  $j_{\frac{1}{p}} = p^{r}$  if  $a \neq 0$ .

The p-adic eld  $Q_p$  is the completion of Q with respect to the norm jj.

We can construct a valuation in Q setting  $v(a) = v(p^{r}\frac{m}{n}) = r$ . The norm that come from this valuation is equivalent to the p-adic one, in other words, these two norms generate the same topology.

Proposition 12 Let k be a local eld. Then:

- 1. A = fx 2 k : v(x) Og is a sub-ring of k called valuation ring.
- 2. The group of units A of A is the kernel of v, i.e.,  $A = v^{1}(0)$ .
- 3. Let 2 k with v () = 1 Every element x 2 k can be expressed in a unique way as  $x = {}^{n}u$  with n 2 N and u 2 A .
- 4. k is the eld of fractions of A.
- 5. The quotient ring  $\hat{k} = A = A$  is a nite eld.

Every element of a local eld k is a accumulations point with respect to the ultrametric norm. So we can de ne the derivative of a function f:U! k, with U a open set of k, at the point a by the usual way. The well-known rules for di erentiation of sum s, products, quotients and composition carry over without any problem. Likewise we can de ne the di erential of a multivariable function, m anifolds and Lie groups over Local elds. For a complete description of the results about Lie group over local elds see [Se].

## 4.2 Basic De nitions

Given a local eld k with algebraic closure k, the a ne space A<sup>n</sup> =  $(a_1; :::; a_n)$  over k. and A =  $k[x_1; ::: x_n]$  the algebra of the polynom ials over k. We de ne the set of the zeros of f 2 A as Z (f) = fP 2 A<sup>n</sup> : f(P) = 0;8f 2 Tg. A subset Y of A<sup>n</sup> is algebraic if exists T A such that Y = Z (T).

The topology of Zariski in  $A^n$  is the topology in which the open sets are complements of the algebraic sets.

A non-empty set Y of a topological space X is said irreducible if it cannot be expressed as union of two closed proper disjunct subsets.

De nition 13 An a ne algebraic variety X is a closed set irreducible of  $A^n$ . An algebraic variety is de ned over k if X is the set of zeros of a nite number of polynomials with coe cients in k. If X is an algebraic variety over k, will denote by X (k) = X \ k, the set of the k-rationals points.

 $D \mbox{ e nition 14 A}$  linear algebraic group G over k is a (Zariski) closed subgroup of GL (k).

It is possible to demonstrate that exists a unique irreducible component that contains the identity of G. This component will be denoted by G<sup>0</sup> and it is called the component of identity of G:A group G is said connected if  $G = G^0$ .

An algebraic group T overk is a torus of rank n, if T becomes isomorphic to  $(GL_1)^n$  after the extension of the base eld to the algebraic closure k. A torus is split if it is isomorphic overk to  $(GL_1)^n$ .

A element of g of a algebraic group is unipotent if g 1 is a nilpotent element. An a ne algebraic group is called unipotent if all its elements are unipotent. Any unipotent algebraic group is isom orphic to a closed subgroup of the group of upper triangular matrices with diagonal entries 1.

An algebraic group G over k is said reducible if it does not contain a non-trivial connected norm alunipotent subgroup.

Finally, an algebraic group G (k) is said sem is imple if G (k) does not contains a non-trivial connected soluble norm all subgroup .

4.3 The spherical building of a algebraic group

If G is sem is in ple then G(k) has a BN -pair to which we can associate a spherical building. We will describe brie y this construction (for more details see [Hu]).

A subgroup H G is said parabolic when G = H is a complete variety. A Borel subgroup P is a minimal parabolic. We choose a Borel subgroup P such that it contains a maximal split torus T (k).

Let N  $_{\rm sph}$  the norm alizer of T in G (k).

Proposition 17 ([G a] pags. 111) If  $gP^{I_1}g^{-1} = P^{I_2}$  then  $I_1 = I_2 = I$  and  $g \ge P^{I}$ .

A decomposition of a algebraic group as a sem idirect product Z N , with Z reductive and N unipotent is called a Levi decomposition and we call Z the Levi factor

P roposition 18 (Levi decomposition) Let N unipotent radical of P and Z the centralizer of the torus T . Then

P = Z N

# 4.4 The Euclidean building of a algebraic group over a Local eld

The spherical building stated in the previous section depends only of the algebraic structure of G. W hen the base eld is a local one, is possible to associate to G other BN -pair, that results in a Euclidean building for G.

Theorem 19 (Tits Theorem [TB]) Let G be a simple and simply connected group, over a local eld. Then we can associate to G, by a BN-pair, a Euclidean building  $_{\rm E}$ .

U sing the B ruhat-T its theorem we can give the following description of the Euclidean building:

Theorem 20 (Bro], pag 163) The building  $_E$  associated to a group G with a Euclidean BN -pair is isomorphic to the ag complex of the incidence geometry consisting of the maximal bounded subgroups of G, where two distinct such subgroups P;Q are incident if and only if  $P \setminus Q$  is a maximal subgroup of P

The subgroups  $P_{J^0} = \begin{bmatrix} B & w & B \end{bmatrix}$  of G will be called paraholics. They  $w^2 & W^0$ 

are open and compact (in the non-Archim edian topology of G).

The spherical Building at the in nity associated with this Euclidean building coincides with the previous one.

W e denote by N  $_{\rm trans}$  the subgroup of N  $\,$  that acts on the apartm ent by translations.

Lem m a 22 ([G a] pags. 200) The Levi factor  $Z = N \setminus P$  of the m inimal parabolic P with respect to the apartment  $A_1$  is:  $Z = N_{trans}$ .

#### 4.5.2 Cartan-Iw asaw a D ecom position

Let K be the stabilizer in G of the special vertex s of the chamber C, we have that  $K = B W_0 B$  and that K is a maxim alcompact subgroup.

Let A be a sector in the apartment with vertex s. This sector determines a chamber  $A^1$  in the spherical building  $j_s j = 0$  ( $j_E j$ ).

Let Z the subgroup of N that acts on the apartment by translations and let  $Z_A = Z$  the subset of translations that sends s to a vertex in A. At least, let N be the unipotent subgroup of G that stabilizes the chamber  $A^1$  of  $(j_E)$ . Then we have the following decompositions, that are analogous to the Lie case.

## 4.5.3 Bruhat Cellular Decom position

Let G be a simple and simply connected group, over a local eld. W e rem ark that the quotient group can be provided with a structure of m anifold over the local eld, so in particular the agm anifolds are m anifolds over the local eld ([Se] LG 4.10 and LG 4.11).

Let J the generators of the spherical W eyl group W<sub>0</sub>. Given I J a subset of generators of W<sub>0</sub> we de ne the two special groups W<sub>I</sub> = hj<sub>i</sub> :i2 Ii and W<sup>I</sup> = hj<sub>k</sub> :k  $\geq$  I:i, to whose we can associate the following parabolics P<sub>I</sub> = PW<sub>I</sub>P and P<sup>I</sup> = PW<sup>I</sup>P. We have that G = P<sup>I</sup>; P<sub>I</sub> and that P<sup>I</sup> \ P<sub>I</sub> = P.

Now consider the agmanifold  $G = P^{I}$ . For each g 2 G the image of g by the application G !  $G = P^{I}$  will be denoted by  $g = gP^{I}$ .

Let N<sub>I</sub> be the maximal unipotent subgroup of P<sup>I</sup> and let  $\overline{N}_{I}$  be the maximal unipotent subgroup of P<sub>I</sub>. The element N<sup>1</sup> =  $\overline{N}$ 

The manifold  $\overline{N}_{I}$  <u>e</u> is called the open cell of  $G = \mathbb{P}$ . This cell can be identied with  $\overline{N}_{I}$  because  $n_{2}n_{1}^{-1} 2 \mathbb{P}^{I}$  i  $n_{1} = n_{2}$ . We will demonstrate that the open cell  $\overline{N}_{I}$  <u>e</u> is open and dense in the non-Archim edean topology of  $G = \mathbb{P}^{I}$ .

Using the application  $gP \ ! \ gP^{I}$  we can reduce the demonstration to the case G = P.

Theorem 24 (Bruhat cellular decomposition) Given w 2 W we dene  $\overline{N}^{W} = \overline{N} \setminus w \overline{N} w^{-1}$ . Then the mapping  $! w \text{ of } \overline{N}$  in G=P is injective and G=P is the disjunct union of the cells  $\overline{N}^{W} w$ , w 2 W.

P roof. Using the Bruhat D ecom position and the Levi decom position, respectively, we have:

Since the previous union is disjoint, it may be used, as follow, to construct a decomposition of G=P into cells. Since the stabilizer of wP in G is wPw<sup>1</sup>, the stabilizer of w\_= wP 2 G=P in N is  $\overline{N} \setminus wPw^{1} = \overline{N} \setminus wNw^{1}$ . Therefore we can identify  $\overline{N} wP$  with  $\overline{N} = (\overline{N} \setminus wNw^{1})$ .

Since  $\overline{N} = (\overline{N} \setminus w \overline{N} w^{-1}) (\overline{N} \setminus w N w^{-1})$ , it follows that  $\overline{N} w P = \overline{N}^{w} w P$  can be identied with  $\overline{N}^{w}$  w. Thus the agmanifold G = P is disjunct union of the cells  $\overline{N}^{w} w$ .

The cell  $\overline{N}$  <u>e</u> has the same dimension that G = P, while the cells  $\overline{N}$  <u>w</u> has codimension at least one, so the cell  $\overline{N}$  <u>e</u> is open and dense G = P.

Corollary 25 The open cell  $\overline{N}$  <u>e</u> is open and dense in G = P.

Let  $_{\rm E}$  be the euclidean building associated with G and j  $_{\rm E}$  j be its geometrical realization. We can associate to every simplex S an parabolic group P<sup>I</sup> and a parabolic type I, so we can de ne an application:

Now we consider the induced topology of  $(j_E)$  in  $(E_E)$ , i.e., a sequence of simplexes in  $(E_E)$  converges if and only if this sequence converges in  $(j_E)$ . The sets  $(E_E)$  are compact for every I.

Lem m a 26 The topological spaces  $0^{i}$  (  $_{E}$ ) with the topology above and G = P with the ultrametric topology are homeomorphic.

P roof. The group G acts continuously and transitively in  $0^{i}$  ( $_{E}$ ) with P stabilizing a chamber, so we have a continuous bijection  $:G = P ! 0^{i} (_{E})$ , but, as  $0^{i} (_{E})$  is compact, we have that is a homeomorphism.

A direct consequence of the previous lemma is the compactness of the agmanifold G = P (compare with [Ma, pag 55]).

At long last, we can conclude that

Lem m a 27 G iven a chamber C in  $0^{i}$  ( $_{\rm E}$ ), and let N be the maximal unipotent group xing C and let  $\overline{\rm N}$  be the maximal unipotent group xing the opposite chamber C. The orbit  $\overline{\rm N}$  C is open and dense in  $0^{i}$  ( $_{\rm E}$ ).

A hyperbolic isom etry h is said regular if all the axes of h are contained in a apartm ent

For a non regular hyperbolic isom etry, we have, by de nition, that exists at least an axis contained in more that one apartm ent.

If we consider the action of W  $_0$ , The spherical W eyl group of G, in an apartment , we can give another characterization of the regularity of h. To that we introduce the notation: given P a hyperplane in the apartment , we denote by  $s_P$  the inversion in this hyperplane. A fter xing a origin, we can associate to W  $_0$  a fam ily of hyperplanes H = fP :  $s_P$  2 W g. A hyperbolic isometry h is regular if its axes are not contained in any hyperplane P 2 H. A non regular hyperbolic isometry is de ned by negation

of the previous statement. In a more speci c way a hyperbolic isometry h is said of type if h has an axis contained in the hyperplane P H , with H = fP :  $s_P 2 W$  g with W the maximal W eyl subgroup with this property.

Lem m a 30 Let f <sup>i</sup>g a fam ily of apartments that contains a axis c of h. Then  $U = {}^{i}$  and  $I = {}^{i}$  are both invariants by h. In particular, if h is a regular hyperbolic isometry, i.e., every axes of h are contained in just one apartment, then this apartment are invariant by h.

Proof. Let i be a apartment containing the axis c. Then h i is a at containing c since h leaves c invariant.

The fam ily f<sup>i</sup>g is nite (in the local case) and since h is a bijection, we have that h acts as permutations of the fam ily f<sup>i</sup>g. Consequently we have

Proof. Let  $\hat{F}$  be a maximal at containing F. The at  $\hat{F}$  is isometric to  $\mathbb{R}^n$ , with n the rank of the building, so we have that F is isometric to a subspace of  $\mathbb{R}^n$ . Is well known, that in  $\mathbb{R}^n$  a isometry h of a subspace can be extended in a unique way to a isometry of  $\mathbb{R}^n$ , and so we have a unique extension of h to  $\hat{h}$  in  $\hat{F}$ . Now to extend  $\hat{h}$  to  $j_E j$  consider C a chamber in  $\hat{F}$  and  $\hat{h}(C)$  its image. The axiom s of buildings assure the existence of a isometry  $\tilde{h}$  of  $j_E j$  such that  $\tilde{h}(C) = \hat{h}(C)$  and  $h(\hat{F}) = \hat{F}$ . This isometry satis es  $\tilde{h}_{j} = h$ .

By de nition, we have that  $\tilde{h}_1 (\tilde{h}_2)^{-1} j_F$  is the identity, i.e.,  $\tilde{h}_1 (\tilde{h}_2)^{-1} 2 W_F$ , and so we have the uniqueness if F is a maximal at.

Not all the geodesics of j  $_{\rm E}$  j can be a axis for an hyperbolic isom etry of G. For instance, if our building is not thick, in other words, if j  $_{\rm E}$  j is isom etric to a C oxeter C om plex. The local niteness of the group of C oxeter tells us that nor all the straight line can be axes of an isom etry com ing from the group W. The previous theorem tells us that the geodesics that are axes for an isom etry com ing from the axiom the action of W in a at are also axes for an isom etry of j  $_{\rm E}$  j.

In a analogous way to the real case we have that the hyperbolic isom etries that x an apartm ent are in bijection with the elements of the torus Z;(22) and a isom etry is regular if and only if it is contained in just one torus Z. The non-regular isom etries have codimension in the regular ones, that is, the regular ones are dense.

Given a  $\mbox{ at } F$  and  $x_0$  a base point in F , we associate to each hyperbolic isom etry h a vector :

#### 4.6.2 The action of the hyperbolic Isom etries

Let h be a regular hyperbolic isom etry, F the apartm ent invariant by h and  $F = F_1$  the apartm ent in the spherical building  $(j_E)$  that is the boundary of the apartm ent F. W e rem ark that we will kept this notation: when we are referring to a simplex of the spherical building  $(j_E)$  associated to a simplex of the Euclidean building  $j_E$  we will denote both by the same symbol, using bold for the simplex in  $(j_E)$ .

The main attractor of a hyperbolic isometry h is the point 2 @ (j) such that  $h^n (x) !$  for all x 2 X. The chamber in the in nite containing will be denoted by C (). The main attractor of h<sup>1</sup> is called the principal repulsor of h will be denoted by . We have that C () is the opposite chamber to C () in F, with F the invariant apartment of h

The main objective of that section is to understand the behavior of the orbit of 2 (j) by the action of regular hyperbolic isometry h.

Our rst observation is that when is in the apartment invariants by h, i.e.,  $2 F = \emptyset (F)$ , the action of h in is trivial and is xed. So we can restrict ourselves to the case 2 F. Now we consider a apartment  $F^0$  containing and . In such a case, we have:

Given a sector S F, such that 2 @(S) with the principal repulsor of h, we will demonstrate that  $h^k S$  is a family of increasing nested sectors, i.e.,  $h^k(S) = h^{k+1}(S)$ .

Lem m a 33 Let h be a regular hyperbolic isom etry, and the m ain attractor and repulsor, respectively. Let F be the invariant apartment by h and S F a sector such that 2 @ (S). Then  $h^k$ S is a family of increasing nested sectors. Given any point x in the interior of S and a geodesic starting in x and no entirely contained in S, then the length L ( $j_{k^k}(s)$ ) of the segment of contained in  $h^k$  (S) grows linearly.

Proof. Since F is invariant by h and F is isometric to  $\mathbb{R}^n$ , we reduced the problem to a euclidean situation in the which we can consider h as a translation of  $\mathbb{R}^n$ . So we have L  $(j_{k} (s_1)) = kd(x_0;h(x_0))$  for all  $x_0 2$  F.

G iven a point  $x_0$  in the interior of S , we de ne the geodesic segment  $^k$  (t) as being the segment that starts at  $x_0$  and such that  $\ ^k$  (1 ) =  $h^k$  ( ).

Let be the geodesic ray entirely contained in F that starts at  $x_0$  and that is parallel to the segment  ${}^0j_{\mathbf{j}}$ . An initial segment of coincides with an initial segment of  ${}^0$  and in some point they fork as in a tree, with being prolonged in F and  ${}^0$  being prolonged in F<sup>0</sup>. The same happens with and  ${}^k$ , with the dimension that  ${}^k$  is prolonged in h<sup>k</sup> (F<sup>0</sup>). The lemma below describes the growth of this intersection

To demonstrate this, consider the geodesic segment h $\,^0$ . This segment passes by h(x\_0) and h(), and is contained in h(F $^0$ ). Also, h $\,^0\,{}_{\rm F}$  is parallel to .

Now let lbe the geodesic contained in h (F<sup>0</sup>) that is parallel to h<sup>0</sup> and that passes in  $x_0$ . The segment  $l_{j_1}$  is parallel to , i.e.,  $1 = j_{h(S)}$ . 

## 5 Sem igroups and Control Theory

In this section, G denotes a simple simply connected algebraic group over a local eld. W e remark that the group G is also a Lie group over a local eld with the ultram etric topology (G;  $_{\rm U}$ ). Our principal object of study is the sem igroups S G with non-empty interior in the ultram etric topology.

Let  $2 \ Q_1 \ (E)$  be a regular point in the spherical building and C () be the unique chamber that contains . By the lemma 26, we can identify the chambers in  $Q_1 \ (E)$  with the points in the maximal ag B and so, by abuse of notation, we write that C () 2 B, or that 2 B.

Given 2 B, we denote by B () the open Bruhat cell containing (??).

D i erently of the real case, we have sem igroups of non-empty interior that doesn't contains hyperbolic isom etry.

P roposition 36 G iven S  $\,$  G a sem igroup with non-empty interior. If S contains a hyperbolic isometry of  $\,_{\rm E}$ , then S contains a regular hyperbolic isometry in its interior.

P roof. Let g 2 int(S), as the sim plicial structure of  $_{\rm E}$  is discrete g cannot be parabolic, so we can assume that g is elliptic. Let x be a xed point by g and K<sub>x</sub> the maximal compact subgroup xing x. The subgroup S<sub>x</sub> = fs 2 S : sx = xg is a non-empty subgroup of K<sub>x</sub> because g 2 int(S) \ K<sub>x</sub>  $\Leftrightarrow$ ;, so we have that S<sub>x</sub> is a open subgroup of G. Now, given a hyperbolic isometry h 2 S we have that ghg <sup>1</sup> is a hyperbolic isometry in the interior of S A existência de um a isometria hiperbolica regular em int(S) deve se a argumentos de dimensaot picos

P roposition 37 G iven S G a sem ignoup with non-empty interior. If S contains only elliptic isometries, then S is a open subgroup of G.

P roof. Let g 2 int(S) be an elliptic isom etry, the previous argument in plies that  $g^{-1} 2 S$ . So we have that the interior of S, int(S), is a open subgroup of G. If s 2 S, and g 2 int(S), then g s 2 int(S) but  $g^{-1} 2$  int(S) and therefore s 2 int(S).

We assume henceforth that S G sem igroups of non-empty interior that contains a hyperbolic isom etry.

Let h 2 int (S) be a regular hyperbolic isom etry and its main attractor.

Lem m a 38 For all 2 B exists a g 2 S such that g 2 B ().

Proof. The proof is a immediate consequence from the fact that B () is open and dense on B. Let 2 B and A int(S) be a open set. Then, A is open and intercepts the Bruhat cellB () that is dense in B, i.e., 9g2 int(S) such that g 2 B ().

The agmanifold B is a compact space (Ma, pag. 55) and so we have, by the theorem ??, the existence of a invariant control set in B for the action of S. The following result assures the uniqueness of such control set in B

Theorem 39 Let S G be a sem igroup with int(S)  $\notin$ ; and that contains a hyperbolic isometry. Then exists a unique invariant control set in B for the action of S.

Proof. We will prove that exists such that  $2 \operatorname{cl}(S)$  for all  $2 \operatorname{B}$ , i.e.,  $2 \operatorname{cl}(S)$ . Let be a main attractor for a regular hyperbolic isometry  $2\operatorname{B}$ h 2 int(S). By the previous lem mawe can assume that 2 B(). So we have that  $\lim_{k \to \infty} h^{k}() =$ , for all 2 B() and 2 cl(S) for all . Clearly

this implies the uniqueness of the invariant control set.

W e denote by D the unique invariant control set in B and by D  $_{\rm 0}$  its set of transitivity.

Now we will characterize the others control sets in B. We de ne

= fh 2 int(S) : h is a regular hyperbolic isom etryg

Given a regular hyperbolic isom etry h, we have a single apartm ent that contains the axis of this isom etry and an decom position of Iwasawa associated  $G = K \ AN$ . The set of chambers in the spherical building xed by h is in bijection with W, so we can associate to each one of these cameras a w-type. We observed that the w-type depends on the choice of h. We will denote for b(h;w) the xed point for h of the w-type.

Proposition 40 Let  $(D_1)_0 = fb(h;1) : h 2 g$ . Then  $(D_1)_0 = D_0$ .

P roof. As  $(D_1)_0$  is the set of main attractors we have that  $(D_1)_0$   $D_0$ . To demonstrate the other inclusion, we consider  $= b(h;1) \ 2 \ D_0$  with h 2 int(S) a regular hyperbolic isometry. Given  $2 \ D_0$  exists  $s_1;s_2 \ 2$  int(S) such that  $s_1 =$  and  $s_2 =$ , because  $D_0$  is the set of transitivity of D. Now we consider  $h_2 = s_1 h^n s_2$ . The following lemma proves that  $s_1 h^n s_2$  is a regular hyperbolic isometry for n su ciently large.

P roposition 41 G iven h a regular hyperbolic isom etry with m ain attractor and  $s_1$ ;  $s_2$  such that  $s_2s_1 \ge P$  (); P () the parabolic subgroup that stabilizes , then for n su ciently large,  $s_1h^ns_2$  is a regular hyperbolic isom etry.

Proof. Let  $g = s_2 s_1$ , then  $s_1 h^n s_2 = s_1 h^n g s_1^{-1}$ . So it is enough prove that  $h^n g$  is hyperbolic when g is a isometry xing , the main attractor of h.

Now, let F be the invariant at by h and F<sup>0</sup> = gF, S be a sector in  $F \setminus F^{0}$  and  $S_{2} = g^{-1}S \setminus S$ , so we have  $gS_{2} = S$ .

Since  $S_2$  and  $gS_2$  are sectors in F containing , we have that, for n large enough,  $h^n gS_2 = S_2$ , i.e.,  $h^n g$  is a regular hyperbolic isom etry.

Theorem 42 For every w 2 W exists a control set  $D_w$  in B, which set of transitivity is

 $(D_w)_0 = fb(h;w):h2$  g

and these are all the control sets in B.

Proof. The theorem will be proved in three steps.

In the rst step we will prove that for any control set  $D^{0}$  exists a xed point of w-type b(h;w) in  $D^{0}$ , for some regular hyperbolic isometry h.

In the second step we will prove that given two points with the same w-type =  $b(h_1;w)$  and =  $b(h_2;w)$ , with w 2 W and  $h_1;h_2$  2, then 2 cl(S) and 2 cl(S). And therefore, by Proposition ??,  $(D_w)_0$  is contained in the transitivity set of a control set  $D_w$ .

At last, we will prove that  $(D_w)_0 := fb(h;w) : h 2 g is the set of transitivity of D_w.$

has non-empty interior in M, since M normalizes AN. The fact that M is compact implies that is a subgroup of M. So int(S) AN + 6; and hence exists a regular hyperbolic isometry g 2 int(S) such that g = . In particular, is is a xed point of w-type for g.

(2) Given =  $b(h_1;w)$  and =  $b(h_2;w)$ , if  $b(h_1;1) = b(h_2;1)$  then  $b(h_1;w)$  is in the same B ruhat cell that  $b(h_2;w)$ , and so by P roposition ??,  $\lim_{n! 1} (h_2)^n b(h_1;w) = b(h_2;w)$ . If  $b(h_1;1) \in b(h_2;1)$ , the P roposition ?? assure that exists  $s_1 \ 2 \ s$ , such that  $s_1b(h_1;1) = b(h_2;1)$  since  $(D_1)_0$  is a transitivity set, and thereby we reduce to the previous case.

(3) Now we will prove that for any control set D<sup>0</sup> its set of transitivity is  $(D_w)_0$  for some w. Let =  $b(q;w) \ge D^0$  be the attractor of w-type in D<sup>0</sup> which existence was proved in (1).

Given  $2 D_0^0$ , then we have  $s_1; s_2 2$  int(S) such that  $s_1 =$  and  $s_2 =$ . Then  $h_2 = s_1 g^n s_2$  is a regular hyperbolic isometry and  $= b(s_1 h^n s_2; w_1)$ . Hence,  $D_w$  is the set of transitivity of  $D^0$ .

### 5.1 Subgroup W (S)

In the previous section, we demonstrate that any control set for S in B is one D  $_{\rm W}$  for some w 2 W  $\,$  .

Now we will describe when the control sets  $D_{\,\,w}\,$  coincides. We start with the de nition

$$W (S) = fw 2 W : D_w = D_1 g$$

The de nition of the group W (S) depends of the choice of a chamber  $C^+$  in the apartment F  $Q_1$  (X). But, by abuse of notation we will write W (S) instead of W (S;  $C^+$ ). If we chose another chamber  $C_1^+ = gC^+$ , then the conjugate of w by g acts in  $C_1^+$ , i.e.,

$$w 2 W (S;C^+)$$
,  $gwg^{\perp} 2 W (S;gC^+)$ :

So the conjugation by g de nes a isom orphism between W (S;C<sup>+</sup>) and W (S;gC<sup>+</sup>). This isom orphism does not depends on the choice of the element g that takes C<sup>+</sup> to gC<sup>+</sup>, because di erent elements di erby an element that xes the pointwise the cham ber C<sup>+</sup>.

Henceforth,  $b_0 \ 2 \ B$  is the image of the chamber C<sup>+</sup>, used to de ne W (S) = W (S;C<sup>+</sup>).

Lem m a 43 Given  $b_0 2$  (D<sub>1</sub>)<sub>0</sub> Then are equivalent:

- 1.w2W(S);
- 2. wb\_0 2 (D  $_1)_0$  , with w being a representative of w in M  $\,$  , and W = M = M .

P roof. Let  $b_0 2 (D_1)_0$ , w 2 W (S) and w a representative of w in M. Then, by the characterization of  $(D_w)$ , wb<sub>0</sub> 2  $(D_w)_0$ , i.e., wb<sub>0</sub> 2  $(D_w)_0 = (D_1)_0$ . Now we prove the reciprocal, let w 2 W (S), the hypothesis that  $D_w = D_1$ , in plies that  $(D_w)_0 = (D_1)_0$ , but  $(D_w)_0 = fb(h;w)$ : h 2 g and do wb<sub>0</sub> 2  $(D_w)_0$ . ■

Proposition 44 W (S) is a subgroup of W .

Proof. Let b2  $(D_1)_0$ ,  $w_1$  and  $w_2 2 W$  (S) and  $w_1$  and  $w_2$  they representatives in M . By the Lemma 43  $w_1$ b2  $(D_1)_0$ . Now using the Lemma 43 again for  $w_1$ bwe conclude that  $(w_1w_2(w_1)^{-1})w_1$ b2  $D_0$  and therefore  $w_1w_2$ b2  $D_0$ ) W (S) is a sem igroup of W, but since W is nite W (S) is a subgroup.

W (S) is not only a subgroup of W , but a W eyl subgroup of W , i.e., W (S) = W for some subset of simple roots.

Theorem 45 W (S) = W , for some

Proof. Let H = fh 2 int(S) : W (S)h = hg.

Suppose that  $H \notin ;$  and let  $\Re 2 H$  be an isometry of maximum regularity in H, and be its type. We will prove W (S) = W proving that W (S) acts transitively in  $C_h$  = f the chambers that has  $\Re$  as wally.

Since  $\Re$  2 int(S) we have a h<sub>c</sub> 2 int(S) such that h<sub>c</sub> is a regular hyperbolic isometry that has the chamber C 2 C<sub>h</sub> as main attractor.

So every chamber C 2  $C_h$  belongs to the set of transitivity of the invariant control set in B and so S acts transitively in  $C_h$  .

If H = ; we will prove that W = W (S). Let C be a chamber in the set of transitivity  $D_0$  of the invariant control set in B and let h a regular hyperbolic isometry that has C as the main attractor.

W e denote  $h_w$  = w  $h^n$  and we have that all  $h_w$  are regular hyperbolic isom etries for n su ciently large. Let K  $\,$  be the cone and K  $_N$  be the lattice de ned as follow :

$$K = f \qquad a_w v_{h_w} : a_w 2 R^+ g$$
$$K_N = f \qquad a_w v_v h_w : a_w 2 N g$$
$$w^{2W} \qquad w^{2W}$$

The rst observation is that K is a vector space, because the absence of xed points in plies that  $v_{h^1}+\ldots+v_{h^w}=0$ . And as the action of W is irreducible and W (S) W acts without xed points we have that K it is the whole apartment F.

Since  $K_N$  int(S) is a lattice in K we have that for any chamber C 2  $@_1$  (F) exists hyperbolic isometry  $h^0 2 K_N$  int(S), such that  $h^0$  has C as the attractor chamber, and therefore W (S) acts transitively in the chambers of  $@_1$  (F). But, as W acts simply transitive in the chambers of  $@_1$  (F), we conclude that W (S) = W .

The map w !  $D_w$  de ned in the theorem of characterization of  $(D_w)_0$  it is not necessarily bijective. The following theorem says that we can parametrize the control sets by the lateral classes W (S)nW.

Theorem 46  $D_{w_1} = D_{w_2}$  if and only if,  $w_1 w_2^{-1} 2 W$  (S). Hence the control sets of S in B are in bijection with W (S)nW.

Proof. We will just demonstrate that  $(D_{w_1})_0 = (D_{w_2})_0$  if and only if,  $w_1 w_2^{-1} \ge W$  (S).

() ) Let  $b_0 \ 2 \ D_0 = (D_1)_0$ . By the characterization of the control sets, we have that  $w_1b_0 \ 2 \ (D_1)_0$ , and by hypothesis we have  $(D_{w_1})_0 = (D_{w_2})_0$ , and

since  $w_1b 2 (D_{w_2})$  we have by the denition of  $(D_{w_2})_0$  and by conjugation, that  $(w_1w_2 (w_1)^{-1})^{-1}w_1b 2 D_0$ , and so  $(w_2)^{-1}w_1 2 W$  (S).

(() Let  $b^0 = w_1 b_0 2 (D_1)_0$ . Then  $(w_2) {}^1b^0 2 D_0$ , since  $w_2 {}^1w_1 2 W$  (S). And  $(w_1 w_2 (w_1) {}^1) {}^1w_1 b_0 2 D_0$  and consequently  $b^0 2 (D_{w_2})_0$ , by the denition of  $(D_{w_2})_0$ .
