COM PACTNESS FOR EM BEDDED PSEUDOHOLOM ORPHIC CURVES IN 3-M AN IFOLDS

CHRISW ENDL

A bstract. We prove a compactness theorem for holom orphic curves in 4-dimensional symplectizations that have embedded projections to the underlying 3-manifold. It strengthens the cylindrical case of the SFT compactness theorem $[B E H^+ 03]$ by using intersection theory to show that degenerations of such sequences never give rise to multiple covers or nodes, so transversality is easily achieved. This has application to the theory of stable nite energy foliations introduced in [HW Z03], and also suggests a new approach to de ning SFT-type invariants for 3-manifolds with stable H am iltonian structures.

1. Introduction

C om pactness argum ents play a fundam ental role in applications of pseudoholom orphic curves to sym plectic and contact geom etry: in the closed case we have G rom ov's com pactness theorem, and m ore generally the compactness theorem s of Sym plectic Field Theory $[BEH^+ 03]$ for punctured holom orphic curves in noncompact sym plectic cobordisms. As a rule, the singularities of the compacti ed m oduli space have positive virtual codim ension, which translates into algebraic invariants if transversality is achieved. In general how ever, even if the m oduli space of sm ooth curves is regular, multiple covers can appear in the compacti cation and make

transversality in possible without abstract perturbations, thus presenting a large technical complication.

The motivating idea of this paper is that by restricting to a certain geom etrically natural class of holom orphic curves in general low dimensional settings, one can use topological constraints to prevent the aforem entioned analytical di culties from arising in fact the compacti ed moduli space tums out to have a m iraculously nice structure. Examples of this phenom enon have been seen previously in the com pactness argum ents of [HW Z03] and [W enb], both of which deal with stable nite energy foliations on contact 3-m anifolds. A long sim ilar lines, M . Hutchings [Hut02] has proved a strong version of SFT-type compactness for a class of embedded index 1 and 2 curves in 4-dim ensional sym plectizations, a result which form s the analytical basis of Periodic Floer Homology and Embedded Contact Homology. The result proved here is dierent in several respects. The condition on our set of curves is seem ingly stricter than that of Hutchings (though neither implies the other), and the result is correspondingly stronger: where Hutchings' limits allow certain types of multiple covers (over trivial cylinders), ours do not. In a di erent sense, the setup for our main result is more general because it uses no genericity assumptions and is valid for arbitrary (also negative) Fredholm indices. The restriction on multiple covers in the lim it arises from topological considerations, independent of analysis; in particular we make crucial use of the recently developed intersection theory for punctured holom orphic curves, due to R. Siefring Sieb].

In the positive index case, it is shown in [W ena] that our moduli spaces are precisely those which have the local properties necessary to form stable J-holom orphic foliations, thus the theory of such foliations is one of the main applications we have in m ind. M ore generally, it may be possible to de ne speci cally low-dimensional symplectic or contact invariants (as in G rom ov-W itten or Symplectic Field Theory [EGH00]) by counting this restricted class of holom orphic curves. If such a theory exists, it has an immediate technical advantage over general SFT, in that it seem ingly can be de ned without any need for restrictive topological assumptions (e.g. sem ipositivity) or abstract perturbations.

The present work is part of a larger program involving com pactness for a special class of embedded holom orphic curves in 4-dimensional symplectic cobordisms. We focus here on the special case where the target space is the R-invariant symplectization of a 3-manifold M. The relevant class of holom orphic curves is then distinguished by the property of being not only embedded in R M but also having embedded projections to M. We'll give the required de nitions and state simple versions of the main theorem s in x1.1; these are implied by som e slightly more technical results which we state and prove in x7, after developing the necessary machinery. We will also give som e more details in x1.2 on the general program into

which this work ts, and state som e partial results for nontrivial sym plectic cobordism s.

1.1. Setup and m ain results. The following structure was introduced in $[BEH^+ 03]$ as a general setting in which one has compactness results for punctured holom orphic curves. Let M be a closed, oriented 3-m anifold. A stable Ham iltonian structure on M is a tuple H = (;X;!;J) where

It follows from these de nitions that the ow of X also preserves the sym – plectic structure de ned by ! on , and the special 1-form associated to and X by the conditions

We shall denote periodic orbits of X by = (x;T), where T > 0 and x : R ! M satisfies $\underline{x} = X$ (x) and x(T) = x(0). If $x;x^0 : R ! M$ differ only by $x(t) = x^0(t+c)$ for some $c \ge R$, we regard these as the same orbit $= (x;T) = (x^0;T)$. We say that has covering number $k \ge N$ if T = k, where > 0 is the minimal period, i.e. the smallest number > 0 such that x() = x(0). An orbit with covering number 1 is called simply covered. The k-fold cover of = (x;T) will be denoted by

We shall occasionally abuse notation and regard as a subset of M ; it should always be remembered that the orbit itself is specified by both this subset and the period.

The open 4-m anifold R M is called the sym plectization of M, and it has a natural R-invariant alm ost com plex structure J associated to any stable H am iltonian structure H = (;X;!;J). This is de ned by $JQ_a = X$ and Jv = Jv for v2, where a denotes the coordinate on the R-factor and Q_a is the unit vector in the R-direction. We then consider pseudoholom orphic

(or J-holom orphic) curves

It is convenient to think of (; j) as a R iem ann surface with cylindrical ends, and we will sometimes refer to neighborhoods of the punctures as ends of -.

The energy of a punctured pseudoholom orphic curve w = (a;u) : (-;j) !(R M;J) is defined by

with $T = f' 2 C^1 (R; [0;1]) j'^0$ Og. An easy computation shows that both integrands are nonnegative whenever u is J-holom orphic, and such a curve is constant if and only if E(u) = 0. When u is proper, connected, Jholom orphic and satis es E(u) < 1, we call it a nite energy surface. As shown in [Hof, HW Z96], nite energy surfaces have asymptotically cylindrical behavior at the punctures: this means the map u : -! R M approaches f 1 g _z at each puncture z 2 , where _z is a (perhaps multiply covered) periodic orbit of X. (See Prop. 3.1 for a precise statement.) The sign in this expression partitions into positive and negative punctures = + [

De nition 1.1. The trivial cylinder over a periodic orbit = (x;T) of X is the nite energy surface with one positive and one negative puncture given by

Recall that a periodic orbit = (x;T) of X is called nondegenerate if the linearized time-T return map d' $_{X}^{T}(x(0))j_{x(0)}$ does not have 1 in its spectrum. Choosing a unitary trivialization of along x, one can associate to any nondegenerate orbit its Conley-Zehnder index _{CZ}() 2 Z. The odd/even parity of _{CZ}() is independent of the choice, and we call the orbit odd or even accordingly. Dynam ically, even orbits are always hyperbolic, and most odd orbits are elliptic, though there can also be odd hyperbolic orbits, whose double covers are then even. The follow ing piece of term inology is borrowed from Sym plectic Field Theory [EGH00], where




Figure 1. A sequence of nite energy surfaces of genus 2 converging to a stable holom orphic building with three levels and arithmetic genus 2. The middle level has a node.

the orbits in question are precisely those which must be excluded in order to de ne coherent orientations.

De nition 1.2. A bad orbit of X is an even periodic orbit which is a double cover of an odd hyperbolic orbit.

A stable Ham iltonian structure H = (;X;!;J) will be called nondegenerate if all periodic orbits of X are nondegenerate, and we will say that a sequence $H_k = (_k;X_k;!_k;J_k)$ converges to H = (;X;!;J) if each piece of the data converges in the C¹ -topology on M. We shall be concerned mainly with the following special class of holom orphic curves.

De nition 1.3. A nite energy surface $\alpha = (a;u) : -!$ R M will be called nicely embedded if the map u : -! M is embedded.

By a compactness result in $[B E H^+ 03]$, sequences of nite energy surfaces with uniform ly bounded genus and energy have subsequences convergent to stable holom orphic buildings (see Figure 1). We will give precise de – nitions in x2; for now, let us simply recall that a holom orphic building w consists of nitely many levels, each of which is a (possibly disconnected) nodal J-holom orphic curve with nite energy, and neighboring levels can be attached to each other along matching connecting orbits. Every holom orphic building w de ness a graph G_w whose vertices correspond to the sm ooth connected components of w, with edges representing each node and connecting orbit. We say that the building w is connected if the graph G_w is connected.

De nition 1.4. For a holom orphic building α , a connecting orbit will be called trivial if deletion of the corresponding edge from G_{α} divides the

graph into two components, one of which only has vertices corresponding to trivial cylinders. Connecting orbits that do not have this property will be called nontrivial.

- De nition 1.5. We say that a holom orphic building is nicely embedded if
 - (1) It has no nodes.
 - (2) Each connected component is either a trivial cylinder or is nicely embedded.
 - (3) If $v_1 = (b_1; v_1)$ and $v_2 = (b_2; v_2)$ are any two distinct connected components, then the maps v_1 and v_2 either are identical or have no intersections.
 - (4) Every nontrivial connecting orbit is even, and either simply covered or both doubly covered and bad.

Theorem 1. Assume $H_k = (_k; X_k; !_k; J_k)$ is a sequence of stable H am iltonian structures converging to a nondegenerate stable H am iltonian structure H = (; X; !; J), and $v_k = (a_k; u_k) : -! R$ M are J_k -holom orphic

nite energy surfaces which are nicely embedded and converge in the sense of $[B E H^+ 03]$ to a stable J-holom orphic building α . Then α is nicely embedded.

Note that this statem ent assumes nothing about the index of the curves \mathfrak{v}_k . We will therefore obtain a stronger statem ent by restricting attention to generic data and curves of positive index. Suppose $\mathfrak{v} : -!$ R M is a nite energy surface with nondegenerate asymptotic orbits $_z$ at the punctures z 2, and denotes a choice of unitary trivialization for along each $_z$. Then the Conley-Zehnder index of \mathfrak{v} with respect to is denote to be the sum

where c_1 (u) denotes the relative rst C hern number of the bundle u! -with respect to , de ned by counting zeros of a generic section that is constant with respect to near the ends. As shown in [HW Z 99], ind (a) is indeed the index of the linearized C auchy-R iem ann operator, and gives the virtual dimension of the moduli space of nite energy surfaces in a neighborhood of a.

For the following de nition, it is useful to observe from (1.3) that ind (α) + 0 is always even. De nition 1.6. The normal rst Chern number $g_{\rm N}$ (a) 2 Z of a nite energy surface a of genus g is de ned by the relation

The meaning of $q_{\rm N}$ (α) is most easily seen by considering an immersed, closed curve $\alpha = (a;u)$: ! M ore generally, for in m ersed curves with punctures, $q_{\rm N}$ (α) should be interpreted as the relative rst Chern number of N_{r} ! -with respect to special trivializations at the asymptotic orbits; this notion will be m ade precise in x6. The \nicely em bedded" condition is relevant to the normal rst Chern number for the following reason: u is in jective if and only if a is embedded and there is never any intersection between a and its R-translations $u^c := (a + c; u)$ for c 2 R. In this case, u belongs to a 1-parameter family of non-intersecting nite energy surfaces, which can be described via zero free sections of N_{μ} , in plying, at least in principle, that $q_N(\alpha) = 0$. A more precise statem ent is that for generic J (or generic parametrized families J), the condition $q_{\rm N}$ (α) = 0 is necessary so that a and all other nite energy surfaces nearby have embedded projections into M. A more detailed discussion of this may be found in [W ena]. Note also that a linearized version of positivity of intersections (see the discussion of wind (w) in x4) implies $q_{\rm v}$ (w) 0 for any nicely embedded curve thus G_N (α) = 0 is a m in in a lity condition.

A coording to D e nition 1.6, the condition $q_N(\alpha) = 0$ allows exactly two cases where α can have positive index. We will say that a nicely embedded curve α is stable if either

w has index 2, genus 0 and no even punctures, or w has index 1, genus 0 and exactly one even puncture.

Theorem 2. In addition to the assumptions of Theorem 1, suppose the choice of J in H is generic and the curves α_k are stable. Then

- If ind (a) = 1, a is a stable nicely embedded nite energy surface, hence the moduli space of such curves up to R-translation is com pact.
- (2) If ind (a) = 2, then either a is a nicely embedded nite energy surface, or it is a building with exactly two nicely embedded connected components, both stable with index 1, with projections that do not intersect each other in M, and connected to each other along a unique nontrivial connecting orbit.




Figure 2. A sequence of stable nicely embedded nite energy surfaces degenerating in accordance with Theorem 2. The numbers indicate the Fredholm indices of the components and parities of the orbits. Note that each of the index 0 curves in the limit is a trivial cylinder, and the odd connecting orbits are thus trivial. The limit has exactly two nontrivial components (of index 1) and one nontrivial connecting orbit (even); the latter is also the unique even orbit for each of the index 1 components.

Figure 2 shows a possible lim it of stable index 2 curves. Stranger things can happen if the genericity assumption is weakened: for example if J is not generic but belongs to a generic 1-parameter fam ily fJ g $_{2R}$, then α can contain index 0 components (arbitrarily many, in principle) with




Figure 3. Convergence of stable nicely embedded index 2 curves in the absence of genericity: the limit can now have more than two nontrivial components, because nontrivial index 0 curves may appear. If the two odd orbits on the left are identical, it can also occur that the two components of the top level in the limit are identical curves, an outcom e that is forbidden in the generic case.

 $\#_0 = 2$, and there may be distinct nicely embedded components with identical images (Figure 3).

12. D iscussion. The class of stable nicely embedded nite energy surfaces that we've de ned above is of great interest in the theory of stable nite energy foliations introduced by Hofer, W ysocki and Zehnder in [HW Z03]. As shown in [W ena], these are precisely the curves whose m oduli spaces form local foliations in both R M and M. Thus Theorem 1, together with a corresponding gluing result, can be seen as a tool for proving stability of holom orphic foliations under R-invariant hom otopies.

Likewise, Theorem 2 guarantees a particularly nice structure for the moduli space of leaves in a xed foliation. This provides the rst half of the proof of an inform alconjecture suggested in [W en05], that to every stable nite energy foliation F one can associate various SFT-type algebraic structures, in particular a C ontact H om ology algebra HC (F). In fact the result suggests m ore than this, since it does not assume the existence of any foliation: one m ight hope to encode this com pactication of the space of nicely embedded index 2 curves algebraically as in SFT, thus de ning new invariants that count nicely embedded index 1 curves. In this case the transversality problem is already solved for generic J, so one would not need any abstract perturbations or restrictive assumptions on the target space.

To carry these ideas further, one needs a corresponding compactness theorem for punctured holom orphic curves u : -! W in nontrivial sym – plectic cobordisms (W;!) with compatible J. In this case the \nicely embedded" condition makes no sense, but one can form ulate an appropriate generalization using the intersection theory of punctured holom orphic curves [Sieb]. In this theory, the standard adjunction form ula for closed holom orphic curves has a generalization of the form

i(u;u) = 2 $(u) + G_1(u) + cov_1(u)$:

Here i(u;u) and (u) are generalizations of the hom obgical self intersection number and singularity number respectively: they are hom otopy invariant integers that count actual intersections and singularities in addition to some nonnegative \asymptotic term s" (which vanish under generic perturbations). The normal rst Chern number c_N (u) is again the integer given by D e nition 1.6, and cov_1 (u) is a nonnegative integer that depends only on the asymptotic orbits of u: it is zero if and only if all the relevant extrem al eigenfunctions are simply covered (cf.x3). One can now characterize nicely embedded curves in symplectizations by the condition i(u;w) = 0, and this is a sensible condition to apply to certain curves in symplectic cobordism s as well. Of particular interest is the space of som ewhere in jective index 2 curves u: -! W with i(u;u) = 0: these are autom atically embedded and satisfy c_N (u) = cov_1 (u) = 0. By a result in [W ena] in fact, such a curve is always regular and com es in a sm ooth 2-dimensional fam ily of nonintersecting curves, which foliate a neighborhood of u(-) in W. We can now state two partial results that we conjecture to be special cases of a more general theorem. A ssum e for both that (W;J) is an asym p-totically cylindrical alm ost com plex manifold as in $[BEH^+ 03]$.

P roposition. Suppose W is closed and $u_k : ! W$ is a sequence of closed, som ewhere injective J-holom orphic curves with ind $(u_k) = 2$ and $i(u_k; u_k) = 0$, converging to a nodal curve u. Then u is either a smooth embedded curve or a nodal curve consisting of two embedded index 0 components that intersect each other once transversely. These t together with all smooth curves close to u as a singular foliation of som e neighborhood of the im age of u, with the nodal point as an isolated singularity.

Rem ark. This can easily be generalized to apply to any 2-dimensionalm oduli space of curves with marked points $z_1; \ldots; z_N$ satisfying xed point constraints $u(z_j) = p_j 2 W$; one must then assume that i(u;u) has the smallest value allowed by the constraints. The local structure of such moduli spaces is studied in [W ena], showing that locally they form singular foliations in W. In this way one can also accommodate immersed curves if the images of the self intersections are xed.

P roposition. Suppose $u_k : -!$ W is a sequence of proper, somewhere injective, punctured nite energy J-holom orphic curves with $ind(u_k) = 2$ and $i(u_k; u_k) = 0$, and they converge to a smooth multiple cover u = v '. Then v is an embedded index 0 curve with i(v; v) = 1 and u is immersed. Moreover, the moduli space of curves close to u is a smooth orbifold with an isolated singularity at u; all other curves close to u are embedded, and they t together with v as a foliation on some neighborhood of the image of v.

In both cases, as with Theorem s 1 and 2, the upshot is that the degeneration in the limit is nice enough so that transversality can still be achieved this is true even in the second case, despite the appearance of a multiple cover in the limit. (The latter can happen only in symplectic cobordisms s that are both noncompact and nontrivial). The reason one obtains sm oothness in this case has to do with the transversality results of H ofer, Lizan and Sikorav [HLS97]: speci cally in dimension 4, one can sometime suse topological constraints to prove transversality for all J (not just generic choices). This does not depend on u being somewhere injective, though it is important that u is immersed. In fact, the proof that u is immersed is also based on such transversality arguments, which one can use to show that if u has a critical point, then the moduli space of curves near u consists only of other multiple covers u = v ', thus contradicting the assumption that the u_k are somewhere injective. Details of this argument will appear in a future paper.

2. Holomorphic buildings in symplectizations

In this and the next few sections, we assemble some de nitions and known results on punctured holom orphic curves and holom orphic build-ings, xing term inology and notation that will be used throughout.

Let D denote the open unit disk in C, and write D = D n f 0 g. We de ne the circle compactic cation of D as follows. Using the biholom orphic map

For each z 2, choose coordinates to identify a neighborhood of z biholom orphically with D, identify the punctured neighborhood as above with a half-cylinder and then add a circle at in nity $_z = f1 g$ S¹ by replacing the half-cylinder with (0;1] S¹. W e say that the nodal surface S is connected if \overline{S} is connected, and de ne its arithmetic genus to be the genus of \overline{S} . Neither of these de nitions depends on the choice of decoration.

Let M be a closed 3-m anifold with stable H am iltonian structure H = (;X;!;J) and associated alm ost complex structureJ. If S = (S;j;;) is a closed nodalR iem ann surface with m arked points, a nodalJ-holom orphic curve

The nodal curves u_m are called levels of u. For each m = 1; :::; n = 1 and $\underline{z} \ge 2_{m}^{+}$, there is a unique $\overline{z} \ge 2_{m+1}$ such that $i_m(\underline{z}) = -\overline{z}$. We then call the pair $f\overline{z}; \underline{z}g$ a connecting pair, and denote by $(\underline{z}; \underline{z})$ the connecting orbit parametrized by $u_m j_{\underline{z}} = u_{m+1}j_{\overline{z}}$. Let c denote the set of connecting pairs.

De ne the partially decorated nodal R iem ann surface S = (S; j; ; ;'), where (S; j) is the disjoint union of $(S_1; j_1); \ldots; (S_n; j_n), = + [= n^n [_ 1,] , is the union of the connecting pairs in _ c with the nodal pairs in _ N = _ 1 [::: [_ n, and ' is the collection of decorations at the connecting pairs <math>f\overline{z}; \underline{z}g$ de ned by ' $_m : \underline{\theta}_+ \overline{S}_m ! \underline{\theta}_{m+1}$. We will call S the dom ain of w, and indicate this via the shorthand notation

Choosing arbitrary decorations $_m$ for each S_m , these together with ' de ne a decoration for S, and S is now the surface obtained from S_1 [::: [S_n by gluing boundaries together via '. There is then a continuous map

u:<u>S</u>! M

such that $u_{\overline{k}_m} = u_m$. The orbits _z parametrized by u_j for z 2 are called asymptotic orbits of α .

Remark 2.1. Technically, what we've de ned should be called holom orphic buildings with zero marked points, since all the marked points of S are being viewed as punctures of π . O ne can also de ne holom orphic buildings with marked points, though we will not need them here; see [BEH⁺ 03] for details.

The relationship of a building w with its dom ain S gives rise to a slightly more general notion which we will nd useful.

Denition 2.2. Suppose S = (S; j; ;;) is a nodal Riemann surface with partitioned into two sets of pairs $_{C} [$ $_{N}$, called connecting pairs and nodal pairs respectively, and denotes a choice of decoration at each of the connecting pairs. A generalized J-holom orphic building u:S! R Mis then a proper nite energy J-holom orphicm ap $u = (a; u):Sn([_{C})! R M$ such that

- (1) For each nodal pair $f\overline{z}; \underline{z}g = \mathfrak{v}(\underline{z})$.
- (2) Completing to a decoration of S by choosing arbitrary decorations at the nodal pairs, u : S n ([) extends to a continuous map $u:\overline{S} \ ! M$.

Considering orientations, we see that each connecting pair $f\overline{z}; \underline{z}g$ c includes one positive and one negative puncture of r.

Just as with nodal R iem ann surfaces, we say that the generalized building α : S ! R M is connected if S is connected, and its arithmetic genus

is defined as the genus of \overline{S} . A connected component of \mathfrak{r} is the nite energy surface obtained by restricting the map $\mathfrak{r}:Sn([_c)! R M$ to any connected component of its domain. The sets S are the positive and negative punctures of \mathfrak{r} . In general, each connected component may have some punctures that do not belong to but are included among the connecting pairs $_c: \mathfrak{w}$ call these connecting punctures.

Denition 2.3. A generalized building w: S ! R M is stable if each connected component $S_1 S n ([) on which w is constant satisfies <math>(S_1) < 0$.

N otation. For any generalized holom orphic building ${\tt w}$ and puncture z 2 , we will always denote by

z ≒ u(z)

the asymptotic orbit at z, and for connecting pairs $f\overline{z}; \underline{z}g$ c denote the connecting orbit $u(-\overline{z}) = u(z)$ by

Unless stated otherwise, the domain S will be assumed to consist of the data (S; j; ; ;') as de ned above. When multiple domains are under discussion, we'll often use S⁰ to denote a second domain (S⁰; j⁰; ⁰; ⁰; '⁰), or similarly S^t = (S^t; j^t; ^t; ^t; 't) and so forth.

Every holom orphic building is also a generalized holom orphic building in an obvious way. The main di erence is that the components of generalized buildings cannot in general be assigned levels, and every component may have positive and negative punctures which are not connecting punctures; holom orphic buildings have these only at the top and bottom levels.

Denition 2.4. Given a generalized holom orphic building $\mathfrak{r}: S ! R M$, an augmentation of \mathfrak{r} at a puncture z 2 is the generalized building $\mathfrak{r}^0: S^0! R M$, dened as follows:

- (1) $(S^{0}; j^{0})$ is the disjoint union of (S; j) with a sphere $(S_{T}; j_{T}) := (S^{2}; i)$. Denote by p ;p₊ 2 S⁰ the points 0 and 1 respectively in S_{T} .
- (2) $^{0} = ([fp g)nfzg.$
- (3) $_{C}^{0}$ is $_{C}$ with the addition of one extra pair fz; p g.
- (4) $\tilde{0}_{N} = N$.
- (5) $\mathfrak{w}_{\mathfrak{f}_n([c])}^{0} = \mathfrak{w}$ and $\mathfrak{w}_{\mathfrak{f}_n nfp_+,p}^{0}$ is a trivial cylinder over z. A decoration is then chosen at ${}_{C}^{0}$ n $_{C}$ so that \mathfrak{w}^{0} is a generalized holom orphic building.

An augmentation at a connecting pair $f\overline{z};\underline{z}g$ _c is dened in the same manner with the following changes:

- (1) $^{0} = .$
- (2) $_{\rm C}^{\rm 0}$ is $_{\rm C}$ with two additional pairs, fz;p g and fp₊;zg.

(3) $\mathfrak{a}^{0}\mathfrak{z}_{\mathrm{T}\,\mathrm{nfp}_{+},p}$ is a trivial cylinder over $(\overline{z},\underline{z})$.

In general, an augmentation of w is any generalized building obtained from w by a nite sequence of these two operations.

A ugm entation is essentially the operation of shifting levels of v by inserting trivial cylinders. One should think of v^0 as being hom otopic to v, generalizing the fact that a nite energy surface v = (b;v) is hom otopic to any of its R-translations $v^c = (b + c; v)$ for c 2 R; an augm entation is in some sense a sequence of in nite R-translations.

Just as one can insert trivial cylinders in a generalized building, one can also \collapse " them .

Denition 2.5. Suppose α : S! R M is a generalized holomorphic building such that at least one connected component is not a trivial cylinder. The core of α is then the unique generalized building α^{K} : S^K! R M such that α is an augmentation of α^{K} and no connected component of α^{K} is a trivial cylinder.

De nition 2.6. Given a generalized building $\pi : S ! R M$, a subbuilding $\pi^0 : S^0 ! R M$ of π is a generalized building such that

- (1) S^0 is an open and closed subset of S, on which $j^0 = j$.
- (2) ⁰ is the union of $\ S^0$ with all z 2 S^0 for which fz; z^0 g is a connecting pair in $_{\rm C}$ with z^0 \mathbb{Z} S^0 .
- (3) ${}^{0}_{C}$ is the set of all connecting pairs $f\overline{z};\underline{z}g$ in ${}_{C}$ for which both \overline{z} and \underline{z} are in S⁰, and 0 is the restriction of .
- (4) $_{\rm N}^{0}$ is the set of all nodal pairs $f\overline{z}; \underline{z}g$ in $_{\rm N}$ for which both \overline{z} and \underline{z} are in S⁰.
- (5) $\overline{\mathbf{w}}^0 = \mathbf{w} \mathbf{j}_{\mathbf{s}^0 n} \left(\begin{array}{c} 0 \\ 0 \end{array} \right)$

W e refer to $[BEH^+ 03]$ for the detailed de nition of what it means for a sequence of nite energy surfaces to converge to a holom orphic building. W e will only need to use the following fact, immediate from the de nition:

Proposition 2.7. If $\alpha_k = (a_k; u_k) : (-_k; j_k) ! (\mathbb{R} \quad M; J_k)$ is a sequence of

nite energy surfaces converging to aJ-holom orphic building $\alpha : S ! R$ M, then for su ciently large k there exist hom eom orphism s'_k: $\overline{S} ! k$, identifying the blown up punctures of S with those of -k and restricting to sm ooth m aps \overline{S} n (\overline{QS} [)! -k, such that

(1) u_k $'_k$! u in C^1_{loc} (S n (@S [);M), (2) u_k $'_k$! u in C^0 (S;M).

The proof of Theorem 1 will rely heavily on our ability to control the norm all rst Chern number for components of a holom orphic building. Positivity of intersections guarantees that this number is nonnegative for any nite energy surface that is not preserved by the R-action. The hardest part of the proof therefore involves the so-called trivial curves, for which this number can be negative. De nition 2.8. A nite energy surface $\alpha : -!$ R M will be called a trivial curve if $E_{!}(\alpha) = 0$, and nontrivial if $E_{!}(\alpha) > 0$.

Exam ining the integrand in (1.1), one nds that a nite energy surface $\alpha = (a; u) : -! R M$ is trivial if and only if the image of du(z) is everywhere tangent to X, which means u(-) is contained in a single periodic orbit . If α is not constant, then this implies one can always write $\alpha = \forall$ ' where ':-! R S¹ is a holom orphic branched cover and \forall is the trivial cylinder over .

D e nition 2.9. A holom orphic building or generalized holom orphic building will be called trivial if it is connected, has no nodes, and all its connected components are trivial curves. A dditionally, such a building will be called cylindrical if it has arithm etic genus zero and exactly two punctures.

Observe that every nonconstant trivial curve has at least one positive and one negative puncture, and the same statement therefore holds for trivial (generalized) buildings. It follows that in general, a trivial building $\alpha:S ! R M$ has $(\overline{S}) = 0$, with equality if and only if α is cylindrical.

P roposition 2.10. A nonconstant trivial building is cylindrical if and only if it is an augmentation of a trivial cylinder.

Proof. Observe rst that the statem ent is true for any building w with only one level (i.e. a nite energy surface), for then w covers a trivial cylinder wby a holom orphic m ap ': R S¹ ! R S¹ of degree k 2 N, and every such m ap is of the form '(s;t) = (ks;kt) up to constant shifts in s and t.

For a more general trivial building w: S ! R M with two punctures and $(\overline{S}) = 0$, we only need observe that under these assumptions, no connected component of w can have nontrivial genus or more than two punctures.

3. A symptotic eigenfunctions

Let = (x;T) be a periodic orbit of X, and writing $S^1 := R = Z$, de ne the parametrization

We can then view the norm albundle to as the induced bundle $x \, ! \, S^1$. Choosing any symmetric connection r on M, we de ne the asymptotic operator

A : (x)! (x): v 7 J($r_t v T r_v X$):

O ne can check that this expression doesn't depend on the choice r and gives a well de ned section of x . Morally, A is the Hessian of a certain action functional on C^1 (S¹;M), whose critical points are the closed characteristics of X. As an unbounded operator on L^2 (x) with domain H¹(x), A is selfadjoint, with spectrum (A) consisting of isolated real eigenvalues of multiplicity at most two. We shall sometimes refer to the

eigenfunctions of A as asymptotic eigenfunctions. Recall that the orbit is degenerate if and only if 0.2 (A).

Operators of this form are fundamental in the asymptotic analysis of punctured holomorphic curves, as demonstrated by the following result proved in [HW Z96, M orO3, Siea]. Denote

and assign to Z the standard complex structure $i\frac{\theta}{\theta s} = \frac{\theta}{\theta t}$ in terms of the coordinates (s;t) 2 Z . We will use the term asymptotically constant reparametrization to mean a smooth embedding ':Z ! Z for which there are constants s_0 2 R and t_0 2 S¹ such that '(s s_0 ;t t_0) (s;t) ! 0 with all derivatives as s ! 1.

P roposition 3.1. Suppose w = (a;u): Z ! R M is a proper nite energy half-cylinder asymptotic to a nondegenerate orbit = (x;T). Then there is an asymptotically constant reparam etrization ': Z ! Z such that for jsj su ciently large, w ': Z ! R M is either (T s;x (T t)) or satis es the following asymptotic form ula: there exists an eigenfunction e 2 (x) of A with negative/positive eigenvalue such that

 '(s;t) = exp_{T s:x(Tt)} e^s (e(t) + r(s;t));

where exp is de ned with respect to any R-invariant connection on R M and $r(s;t) = 2 x_{(T,t)} satistic esc r(s;t) = 0$ with all derivatives as s = 1.

Since nontrivial eigenfunctions e 2 (x) are never zero, this implies in particular that u (s;t) is either contained in or never intersects for su ciently large jsj. Sim ilar form ulas are proved in [Siea] for the relative asym ptotic behavior of distinct holom orphic half-cylinders approaching the same orbit; this is fundamental to the intersection theoretic results that we will review in x4.

Prop.3.1 obviously applies to nite energy surfaces ${\tt w}:-!$ R $\,$ M by identifying a punctured disk-like neighborhood of each puncture z 2 biholom orphically with Z $\,$.

Denition 3.2. For \mathfrak{w} : Z ! R M as in Prop. 3.1, if \mathfrak{w} satisfies the asymptotic formula with a nontrivial eigenfunction e and eigenvalue, we call j j > 0 the transversal convergence rate of \mathfrak{w} and say that e controls the asymptotic approach of \mathfrak{w} to . Otherwise, if \mathfrak{w} is simply a reparametrization of (T s;x(T t)) near in nity, we dene the transversal convergence rate to be +1. Sim ilar wording will be used also for more general punctured holomorphic curves \mathfrak{w} : -! R M approaching orbits $_z$ at z 2.

It will be important to understand the eigenfunctions of A in greater detail. For k 2 N, de ne a parametrization of k by

By a result in [HW Z95], the winding number of a nontrivial eigenfunction e of A depends only on its eigenvalue, thus we can sensibly write wind (e) = wind (). In fact, the result in question proves:

Proposition 3.3. wind : (A) ! Z is a monotone increasing function, and for each $k \ge Z$, there are precisely two eigenvalues 2 (A) counted with multiplicity such that wind () = k.

Assuming to be nondegenerate, we now de ne the integers

noting that the parity p() 2 f0; 1g doesn't depend on . A nother result in [HW Z95] then gives the following form ula for the C on ley-Zehnder index:

De nition 3.4. We will say that a nontrivial eigenfunction e of A is a positive/negative extrem al eigenfunction of if wind (e) = ().

If e 2 (x) satis es A e = e, we de ne the k-fold cover $e^k 2$ (x_k) by e^k (t) = e(kt) and nd A $_k e^k = k e^k$. In general, an eigenfunction f of A is called a k-fold cover if there is an orbit and eigenfunction e of A such that $^k =$ and $e^k = f$. We say that f is simply covered if it is not a k-fold cover for any k > 1.

Lem m a 3.5. A nontrivial eigenfunction f of A $_{k}$ is a k-fold cover if and only if wind (f) 2 kZ.

Proof. C learly if $f = e^k$ then wind (f) = k w ind (e) 2 kZ. To see the converse, note that by Prop. 3.3 there is a two-dimensional space of eigen-functions e of A having any given integer value of wind (e). This gives rise to a two-dimensional space of k-fold covers e^k with winding k wind (e). Since this attains all winding numbers in kZ, every eigenfunction of A k that is not a k-fold cover has winding in Z n kZ.

P roposition 3.6. Let be a simply covered periodic orbit, a unitary trivialization of along and $k \ge N$. Then a nontrivial eigenfunction e of A k is simply covered if and only if k and wind (e) are relatively prime.

Proof. From the lemma, we see that e is an n-fold cover if and only if n divides both k and wind (e). So e is simply covered if and only if this is not true for any n 2 f2;:::;kg.

4. Intersection theory

If w = (a; u) : -! R M is a nite energy surface and :TM ! is the berw is a linear projection along X, then the composition Tu : T-! de nes a section

It is shown in [HW Z 95] that Tu satis as the similarity principle, thus it is either trivial or has only isolated positive zeros; the latter is the case unless $E_{\perp}(\alpha) = 0$. A sum ing $E_{\perp}(\alpha) > 0$ and α also has nondegenerate asymptotic orbits, the asymptotic formula of Prop. 3.1 in plies that Tu has no zeros outside some compact subset, and its winding near in nity is controlled by eigenfunctions of asymptotic operators. We can thus de ne the integer

as the algebraic count of zeros of Tu. It follows from the nonlinear Cauchy-Riem ann equation that wind $(\alpha) = 0$ if and only if u : -! M is immersed and transverse to X.

Recalling the form ula for q_N (a) from De nition 1.6, a result in [HW 295] shows that all nite energy surfaces a with E_1 (a) > 0 satisfy wind (a) q_N (b). A ctually one can state this in a slightly stronger form as an equality. For z 2 , let e_z be an asymptotic eigenfunction that controls the approach of a to $_z$, choose a unitary trivialization of along $_z$ and de ne the asymptotic defect of a t z to be the nonnegative integer

This is zero if and only if the asymptotic approach to $_z$ is controlled by an extrem al eigenfunction. The total asymptotic defect of α is then de ned as $_X$

Now the argument in [HW Z95] im plies:

Proposition 4.1. For any nite energy surface α with E_1 (α) > 0 and nondegenerate asymptotic orbits,

and both terms on the left hand side are nonnegative.

Next we collect some important results from the intersection theory of nite energy surfaces, due to R. Siefring. In the following, we assume all periodic orbits of X are nondegenerate and write punctured holom orphic disks as half-cylinders Z ! R M. These statements, proved in [Sieb], are all based on the construction of hom otopy invariant \asymptotic intersection numbers", which are well de ned due to the relative asymptotic form ulas proved in [Siea].

Proposition 4.2. Suppose w = (a;u) : Z ! R M is a proper – nite energy half-cylinder such that u : Z ! M is embedded. Then any asymptotic eigenfunction controlling w at in nity is simply covered.

P roposition 4.3. Suppose w = (a;u) : Z ! R M and v = (b;v) : Z ! R M are proper nite energy half-cylinders asymptotic to ^m and ⁿ respectively for some simply covered orbit and m; n 2 N. A sum e also that u and v are both embedded and do not intersect each other. Then m = n, and the asymptotic eigenfunctions controlling w and v at in nity have the sam e winding number.

Proposition 4.4. Suppose \mathfrak{a}_+ : $(\mathfrak{a}_+;\mathfrak{u}_+)$: \mathbb{Z}_+ ! \mathbb{R}_+ M and \mathfrak{a} : (a;u): \mathbb{Z} ! \mathbb{R} M are proper nite energy half-cylinders asymptotic to $^{k_+}$ and k respectively for some simply covered periodic orbit and k 2 N. Assume also \mathfrak{u}_+ and \mathfrak{u} are both embedded and do not

intersect each other. Then both have asymptotic defect zero, and either

(1) is even and $k_{+} = k = 1$, or

(2) is odd hyperbolic and $k_{+} = k = 2$, hence $k_{+} = k$ is bad.

5. Constraints at the asymptotic orbits

Given a periodic orbit , a positive/negative asymptotic constraint for is a real number c 0 such that c 2 (A). We will say that a proper nite energy half-cylinder u: Z ! R M asymptotic to is compatible with this constraint if its transversal convergence rate (recall De nition 3.2) is strictly greater than c. Sim ilarly, for a generalized holom orphic building u: S ! R M with punctures = + [, denote by $c = fc_z g_{z2}$ an association of a positive/negative asymptotic constraint c_z to each asymptotic orbit $_z$ for z 2, and say that u is compatible with c if for every z 2, the corresponding end has transversal convergence rate strictly greater than c_z . Observe that the space of holom orphic buildings compatible with a given set of asymptotic constraints is a closed subset of the space of all holom orphic buildings.

Let be a nondegenerate orbit and x a unitary trivialization of along . Then if c is a positive asymptotic constraint for , de ne the positive constrained C on ley-Zehnder index by

As shown in [W ena] (based on arguments in [HW Z99]), if w is a nite energy surface, ind (w;c) is the virtual dimension of the moduli space of nite energy surfaces near w that are compatible with c.

The relation between C on ky-Zehnder indices and winding numbers has a straightforward generalization to the constrained case. G iven an orbit and c 2 R with c 2 (A), de ne

This sum is nonnegative, and is zero if and only if a is controlled by extrem al eigenfunctions with respect to the constraints at every puncture.

If \mathfrak{w} is a generalized building compatible with constraints c, then every subbuilding \mathfrak{w}_0 is compatible with a natural set of induced constraints \hat{c} de ned as follows. For each puncture z of \mathfrak{w}_0 that is also a puncture of \mathfrak{w} , set $\hat{c}_z = c_z$, and for all other punctures of \mathfrak{w}_0 (i.e. those which are only connecting punctures of \mathfrak{w}), set $\hat{c}_z = 0$. The following relation is easily veri ed using (5.3).

Suppose now that α^0 is an augmentation of α : there is then a canonical bijection between the sets of punctures for each, so a set of asymptotic constraints c on either induces one on the other, which we'll also denote by c. However if α^0 is compatible with c, it is not necessarily true that α is as well. Indeed, it may happen that for a given puncture z 2 , the component of α^0 containing z is a trivial cylinder, and is therefore compatible with arbitrarily strict asymptotic constraints, which is not necessarily true for α . On the other hand, if α^0 arises as the limit of a sequence α_k of nite energy surfaces compatible with c, then in a neighborhood of z 2 , convergence to α^0 and convergence to α are equivalent notions. It follows that both α and α^0 are in this case compatible with c: this is true in particular if α is the core of α^0 .

6. The normal first Chern number

Suppose x : S ! R M is a generalized holom orphic building compatible with asymptotic constraints $c = fc_z g_{z2}$, and the asymptotic orbits $_z$ are all nondegenerate. Fix a unitary trivialization for along each $_z$.

De nition 6.1. De ne the constrained normal rst Chern number of w ith respect to c as the integer

 $c_{N} (\alpha; c) = c_{1} (u) (S) + (z; c_{z}) + (z; c_{z});$

O ne can easily check that this doesn't depend on $\,$, and a simple com – putation using (5.5) and (5.3) shows that

where g is the arithmetic genus of w. The new formula is therefore consistent with D e nition 1.6.

The following result is immediate from the de nition.

P roposition 6.2. If α^0 is an augmentation of α then q_N (α^0 ; c) = q_N (α ; c).

W e also have an imm ediate generalization of Prop. 4.1:

Proposition 6.3. If α is a nite energy surface compatible with c and $E_{1}(\alpha) > 0$, then

$$(\alpha) + def_1 (\alpha; c) = c_N (\alpha; c);$$

and both terms on the left hand side are nonnegative.

P roposition 6.4. Suppose $\mathfrak{r}: S \ ! \ R \ M$ is a generalized holomorphic building compatible with asymptotic constraints c, and $\mathfrak{r}_i: S_t \ ! \ R \ M$ are the connected components of \mathfrak{r} , with induced constraints c_i for i = 1; :::; N. Then

$$\mathbf{G}_{N} (\boldsymbol{\alpha}; \mathbf{C}) = \begin{array}{c} X^{N} & X \\ \mathbf{G}_{N} (\boldsymbol{\alpha}_{i}; \mathbf{C}_{i}) + & \mathbf{p}(\boldsymbol{\alpha}_{i;\underline{Z}}) + \\ \mathbf{i} = 1 & \mathbf{f} \overline{\mathbf{z}}; \underline{\mathbf{z}} \mathbf{g} \\ \mathbf{z} \end{array}$$

Proof. W e must check that q_N behaves appropriately under certain natural operations on generalized holom orphic buildings. The simplest such operation is the disjoint union of two buildings $\alpha : S ! R M$ and $\alpha^0 : S^0 ! R M$ with constraints c and c⁰ respectively: this de nes a building $\alpha t \alpha^0 : S t S^0 ! R M$, compatible with the obvious union of constraints ct c⁰. C learly then,

Next, if $\mathfrak{r}: S ! R \in \mathfrak{m}$ is a building with two points $z; z^0 2 S n ([))$ such that $\mathfrak{r}(z) = \mathfrak{r}(z^0)$, we can add a node to \mathfrak{r} and de ne $(z; z^0)\mathfrak{r}$:

Similarly, if there are punctures $\underline{z} \ 2^+$ and $\overline{z} \ 2^-$ for which $\underline{z} = \overline{z}$ and $\underline{c}_{\underline{z}} = \underline{c}_{\overline{z}} = 0$, then we can change \underline{v} by \gluing" these punctures, which means adding $f\overline{z};\underline{z}g$ to the set of connecting pairs and choosing an appropriate decoration so that the result is a generalized holom orphic building $(\overline{z};\underline{z})\underline{v}: (\overline{z};\underline{z})S \ R \ M \ By bring two unconstrained punctures,$ $this operation subtracts <math>(\underline{z}) + (\overline{z}) = p((\overline{z};\underline{z}))$ from $q_N(\underline{v};c)$, hence

C om posing these operations as often as necessary gives the stated result.

7. Proofs of the main results

W e will now state and prove stronger, more technical versions of Theorem s 1 and 2. A ssum e H_k = $(_k; X_k; !_k; J_k)$ is a sequence of stable H am iltonian structures converging to H = (; X; !; J), where the latter is nondegenerate, and u: S ! R M is a J-holom orphic building com patible with asymptotic constraints c = fc_zg_{z2} . Since the orbits $_z$ are nondegenerate, for su ciently large k there are unique periodic orbits $_{zik}$ of X_k such that

in the sense that these orbits have param etrizations S^1 ! M that converge in the C^1 -topology. We may also assume that for each z 2 , c_z Ø (A $_{z,k}$).

Theorem 3. Assume \mathfrak{v}_k are nicely embedded J'_k -holom orphic nite energy surfaces converging to the J-holom orphic building \mathfrak{v} , such that the \mathfrak{v}_k are also compatible with c and $q_N(\mathfrak{v}_k;c) = 0$. Then \mathfrak{v} is nicely embedded, its core \mathfrak{v}^K is compatible with c, and for every connected component \mathfrak{v}_i of \mathfrak{v}^K with induced constraints c_i , $q_N(\mathfrak{v}_i;c_i) = 0$.

Remark 7.1. If \mathfrak{w}_k ! \mathfrak{w} under the assumptions of Theorem 1, then one can assume after taking a subsequence that all the \mathfrak{w}_k are compatible with some choice of asymptotic constraints c such that q_N (\mathfrak{w}_k ; c) = wind (\mathfrak{w}_k) + def₁ (\mathfrak{w}_k ; c) = 0. This is why Theorem 3 implies Theorem 1. Similarly, Theorem 2 is a special case of the next statement.

Theorem 4. In addition to the assumptions of Theorem 3, suppose J is generic. Then ind (w;c) is either 1 or 2. If it is 1, then w is a nite energy surface, hence the moduli space of such curves with constraint c is compact. If ind (w;c) = 2 and w is not a nite energy surface, then it has exactly two nontrivial connected components $v_i = (b_i; v_i)$, both with ind $(v_i;c_i) = 1$, such that v_1 and v_2 have no intersections in M and they are connected to each other by a unique nontrivial connecting orbit.

We begin now with some preparations for the proof of Theorem 3. By Prop.2.7, we can assume without loss of generality that the curves w_k have a xed dom ain -= n with varying complex structures j_k , and there is a xed hom eom orphism

:S !

such that u_k ! u in C^1_{loc} (S n (@S [);M) and u_k ! u in C^0 (S;M). The punctures of w_k and w are also identied via , so we shall use the same notation for both: the asymptotic orbit of w_k at z 2 is then $_{z,k}$ for su ciently large k.

Lem m a 7.2. The building α has at least one nontrivial component.

Proof. If $\mathfrak{a} : S ! R$ M is a trivial building, then $u : \overline{S} ! M$ represents the trivial hom ology class $[u] = 0 2 H_2 (M)$. Perturbing \mathfrak{a} to \mathfrak{a}_k with asymptotic orbits $_{z,k}$ for su ciently large k, we also have $[u_k] = 0 2$ $H_2 (M)$, thus $E_{!_k} (\mathfrak{a}_k) = _u_k !_k = h[!_k]$; $[u_k]i = 0$. This is a contradiction, since \mathfrak{a}_k is assumed to be nicely embedded, and thus nontrivial.

Lem m a 7.3. For each k, u_k (-) M is disjoint from each of the orbits $z_{;k}$ M for z 2 .

Proof. Since u_k is embedded, it follows from the nonlinear C auchy-R iem ann equation that it is also transverse to X_k , thus any intersection with $_{z,k}$ is transverse and implies transverse intersections of u_k with its image in a neighborhood of z.

Lem m a 7.4. For every z 2 , the extrem al negative/positive eigenfunctions of $_z$ with respect to c_z are simply covered. Moreover if z and are

25

distinct punctures with the same sign and $_z$ and $_z$ over the same simply covered orbit, then $_z$ = .

Proof. Since def₁ (\mathfrak{a}_k ;c) \mathfrak{c}_N (\mathfrak{a}_k ;c) = 0, \mathfrak{a}_k is controlled by extrem al eigenfunctions with respect to c at each puncture, and these must then be simply covered by Prop. 4.2. Sim ilarly Prop. 4.3 in plies that distinct positive/negative ends of \mathfrak{a}_k approaching covers of the same orbit must approach with the same covering number. Both statements hold also in the limit due to the nondegeneracy of the orbits \mathfrak{a}_k .

Lemma 7.5. Suppose $z_+ 2^+$ and $z 2^-$, such that z_+ and z^- cover the same simply covered orbit. Then $z_+ = z^-$ and it is either a simply covered even orbit or a doubly covered bad orbit with simply covered extrem al eigenfunctions. Moreover, we can reset $c_{z_+} = c_z^- = 0$ without changing ind (α ; c) or q_N (α ; c).

Proof. For z_{jk} , the rst part of the statement follows from Prop. 4.4 since u_k is embedded, and the second part results from the fact that z_{jk} is therefore even and w_k is controlled by extremal eigenfunctions (in the unconstrained sense) at both of these punctures, so A $_z$ can have no eigenvalues between c_z and 0. The same result is true for $_z$ due to nondegeneracy.

Lem m a 7.6. For every connected component $\mathbf{v}_i = (\mathbf{b}_i; \mathbf{v}_i) : \mathbf{S}_1 ! \mathbf{R}$ M of \mathbf{v}_i either \mathbf{v}_i is a trivial curve or $\mathbf{v}_i : \mathbf{S}_1 ! \mathbf{M}$ is injective. Moreover for any two such components \mathbf{v}_1 and \mathbf{v}_2 that are not trivial, \mathbf{v}_1 (\mathbf{S}_1) and \mathbf{v}_2 (\mathbf{S}_2) are either disjoint or identical, the latter if and only if \mathbf{v}_1 can be obtained from \mathbf{v}_2 by R-translation (up to param etrization).

Proof. Suppose $v_i = (b_i; v_i) : S_i ! R M$ is a nontrivial connected com – ponent of v_i , so $E_i : (v_i) > 0$ and consequently the section

has only nitely many zeros, all positive. We claim rst that \mathbf{v}_i is somewhere injective. If not, then there exists a somewhere injective nite energy surface $\mathbf{w}_i = (_i; \mathbf{w}_i) : \mathbf{S}_1^0 ! \mathbf{R}$ M and a holom orphic branched cover $'_i : \mathbf{S}_1 ! \mathbf{S}_1^0$ of degree k 2 such that $\mathbf{v}_i = \mathbf{w}_i$ $'_i$. We can therefore nd an embedded loop $^0: \mathbf{S}^1 ! \mathbf{S}_1^0$ which does not lift to \mathbf{S}_i , and by sm all perturbations of 0 , we may assume it misses all punctures and zeros of $T\mathbf{w}_i$. Now choose an embedded loop $: \mathbf{S}^1 ! \mathbf{S}_1 u$ which projects to an n-fold cover of 0 for some n 2, and denote $\mathbf{C} = (\mathbf{S}^1) \mathbf{S}_1, \mathbf{C}^0 = ^0(\mathbf{S}^1) \mathbf{S}_1^0$. Choose also an open neighborhood U^0 of \mathbf{C}^0 and a corresponding neighborhood U of C such that $'_i(\mathbf{U}) = U^0$. The restriction $'_ij_i : \mathbf{U} ! U^0$ is an n-fold covering map, and we may assume without loss of generality that $\mathbf{v}_i j_i : \mathbf{U} ! \mathbf{M}$ and $\mathbf{w}_i j_0 : \mathbf{U}^0 ! \mathbf{M}$ are both transverse to X. From this we can derive a contradiction. Indeed, any map $\mathbf{v}^0: \mathbf{U} ! \mathbf{M}$ that's \mathbf{C}^1 -close to $v_i j_j$ can be written on some neighborhood of C as

$$v^{0}(z) = {\prime}_{X}^{f(z)}(v_{i}(z))$$

where ${}'_{x}^{t}$ denotes the ow of X and f is a smooth real valued function de ned on some neighborhood of C. Choosing any nontrivial deck transform ation g:U ! U for the covering m ap ${}'_{ij}$, there is necessarily a point z 2 C at which f(z) = f g(z), and thus $\vartheta(z) = v^{0}(g(z))$. By Prop. 2.7, this is true in particular for a suitable restriction of u_{k} for k su ciently large, contradicting the assumption that u_{k} is embedded. We conclude that v_{i} is somewhere injective.

Now denote R-translations of nite energy surfaces u = (a;u) by $u^c := (a + c;u)$ for $c \ge R$. Suppose that v_1 and v_2 are two nontrivial components and $v_1(z_1) = v_2(z_2)$. This gives an intersection $v_1(z_1) = v_2^c(z_2)$ for some $c \ge R$. If the intersection is isolated then it is positive, and yields an isolated intersection of u_k and $u_k^{c^0}$ for som $e c^0 \ge R$, again contradicting the fact that u_k is embedded. The alternative, since v_1 and v_2 are both som ewhere injective, is that v_1 and v_2^c are identical up to parametrization. The same e argum ent applies to intersections of v_1 with itself: since v_1 is somewhere injective, the intersection of v_1 with v_1^c is then necessarily isolated, otherwise v_1 and v_1^c are identical up to parametrization; this is impossible in light of the asymptotic behavior described in Prop. 3.1.

We shall call a nonconstant trivial subbuilding of α maximal if every component attached to it by a connecting orbit is nontrivial. Given such a subbuilding $\alpha^t : S^t ! R M$, we introduce the following notation: write the punctures of α^t as

$$b = b_{c} [b_{F};$$

where $b_E := b \setminus and b_C$ consists of all punctures of a^t that arise from connecting punctures of a. A sum $e \# b_C^+ = p, \# b_C^- = q, \# b_E^+ = r$ and $\# b_E^- = s$; we have necessarily $\# b^+ = p + r > 0, \# b^- = q + s > 0$ and since a is connected and has nontrivial components, $\# b_C^- = p + q > 0$. Every asymptotic orbit of a^t covers the same simply covered orbit , so denote the orbit at z 2 b by

$$z = m_z$$

for some multiplicity m_z 2 N. Each z 2 b_c belongs to a connecting pair fz;2g c of w, and the component $v_z = (b_z; v_z)$ of w containing 2 is necessarily nontrivial, and negatively/positively asymptotic to m_z at 2. W e know now from Lemma 7.6 that each of the maps v_z is injective (thus embedded near the punctures), and any two of them are either disjoint or identical. Then by the intersection theoretic results of x4, all the m_z for z 2 b_c equal a xed number m_c 2 N, and the asymptotic approach of each v_z to m_c is controlled by eigenfunctions e_z with the same winding wind (e_z) $= w_c$ 2 Z. Likewise for z 2 b_c Lemmas 7.4 and 7.5 in ply that all m_z equals xed multiplicity $m_E 2 N$, and there is a xed extrem all winding number $w_E := ({}^{m_E};c_z)$. Note that if both ${}^{b_E}_E$ and ${}^{b_E}_E$ are nonempty, then ${}_{+}({}^{m_E};c_z) = {}_{+}({}^{m_E}) = ({}^{m_E}) = ({}^{m_E};c_z)$; this follows from Lemma 7.5.

Lem m a 7.7. For the maximal trivial subbuilding α^t described above, $m_c = m_E$ and $w_c = w_E$.

Proof. There's nothing to prove if $b_E = ;$, so assume r + s > 0. De ne the compact subset $t = (S^t)$ and recall that for su ciently large k, $u_k \xrightarrow{j_k}$ is C^0 -close to u^t . Let k be the unique simply covered orbit of X for su ciently large k such that k !. Then some cover of k is an asymptotic orbit of w_k , thus by Lemma 7.3, we can assume $u_k(t)$ lies in a xed tubular neighborhood N of but without intersecting k. We can also arrange that u_k have the following behavior at each component of e^{t} :

for $z 2 \frac{b}{c}$, wind $(u_k((z))) = w_c$, for $z 2 \frac{b}{c}$, wind $(u_k((z))) = w_E$.

The crucial observation is now that $u_k(\overline{})$ realizes a homology in $H_2(\mathbb{N} \cap H_2(\mathbb{T}^2))$. From this we obtain the relations

$$pm_{C} + rm_{E} = qm_{C} + sm_{E};$$

$$pw_{C} + rw_{E} = qw_{C} + sw_{E};$$

and consequently

$$\begin{array}{cccc} m_{\rm C} & m_{\rm E} & p & q \\ w_{\rm C} & w_{\rm E} & r & s \end{array} = \begin{array}{c} 0 \\ 0 \end{array} :$$

If p = q and r = s, then both of these are nonzero and Prop. 4.4 in plies that either is even and $m_C = m_E = 1$ or is odd hyperbolic and $m_C = m_E = 2$, with $w_C = w_E = \frac{m_C}{m_C} = \binom{m_C}{m_C}$ in either case. O therw ise the determ inant of the matrix above must vanish, so $m_C w_E = m_E w_C$. However, by Prop. 4.2, w_C and w_E are winding numbers of sim ply covered eigenfunctions for m_C and m_E respectively, thus Prop. 3.6 in plies that m_C and w_C are relatively prime, as are m_E and w_E . This im plies $m_C = m_E$ and $w_C = w_E$

C orollary 7.8. If $\alpha^t : S^t ! R M$ is the maximal trivial subbuilding above with induced asymptotic constraints $\hat{c} = f \hat{c}_z g_{z^2}$, then

$$\mathbf{q}_{\mathrm{N}} (\mathbf{a}^{\mathrm{t}}; \mathbf{\hat{c}}) + \sum_{z2_{\mathrm{c}}}^{\mathrm{X}} \mathbf{p}(z) + \mathrm{def}_{1}^{\mathbf{\hat{z}}} (\mathbf{w}_{z}) = (\overline{\mathrm{S}}^{\mathrm{t}}):$$

In particular this sum is nonnegative, and is zero if and only if α^t is cylin-drical.

Proof. By the lemma we have $\# b^+ = \# b$ and can write $m = m_E = m_C$ and $w = w_E = w_C = (m; c_z)$ for each $z \ 2 \ b_E$. Then, noting that $c_1(u^t) = 0$,

$$\begin{aligned} q_{N} (a^{t}; \hat{c}) + & p(z) + def_{1}^{\hat{z}} (w_{z}) \\ &= & (S^{t}) + & (m; \hat{c}_{z}) & + (m; \hat{c}_{z}) \\ &+ & (m; \hat{c}_{z}) & + (m; \hat{c}_{z}) \\ &+ & (m; \hat{c}_{z}) & + (m; \hat{c}_{z}) \\ &+ & (m; \hat{c}_{z}) & \\ &+ & (m; \hat{c}_{z}) & \\ &+ & (m; \hat{c}_{z}) & \\ &+ & (m; \hat{c}_{z}) \\ &+ & (m; \hat{c}) \\$$

We shall handle constant components of \mathfrak{r} similarly. Call a connected subbuilding $\mathfrak{r}^\circ: S^\circ ! R \quad M$ of \mathfrak{r} a constant subbuilding if every connected component of \mathfrak{r}° is constant. Further, call it a maximal constant subbuilding if every constant component of \mathfrak{r} that is attached by a node to some component of \mathfrak{r}° is also in \mathfrak{r}° . Note that constant subbuildings cannot have punctures, thus \overline{S}° is closed. Denote by $b_N \quad S^\circ$ the set of points z 2 S° that belong to nodal pairs fz; $z^0g \quad_N$ of S such that \mathfrak{r} is not constant near z^0 ; this set is necessarily nonem pty since \mathfrak{r} is connected. Then the stability condition on \mathfrak{r} implies

$$(\underline{S}^{c} n b_{N}) < 0$$

Thus $c_N (a^c) + 2\# b_N = (\overline{S}^c) + \# b_N + \# b_N = (\overline{S}^c n b_N) + \# b_N > \# b_N > 0. W e've proved:$

Lem m a 7.9. For any maxim alconstant subbuilding α^{c} of α with nodes b_{N} connecting it to nonconstant components of α_{r} ,

All the ingredients are now in place.

Proof of Theorem 3. By the above results, a consists of the following pieces:

- (1) M axim al constant subbuildings α^{c} such that q_{N} (α^{c}) + 2# b_{N} > 0.
- (2) M axim altrivial subbuildings $\mathfrak{a}^{t} w$ ith induced asymptotic constraints c^{t} , for which the sum of $q_{N} (\mathfrak{a}^{t}; c^{t}) + \sum_{z2^{c}} p(z) w$ ith the asymptotic defects of all neighboring nontrivial ends is nonnegative, and zero if and only if \mathfrak{a}^{t} is cylindrical.
- (3) Nontrivial connected components v = (b; v) with v injective.

Note that each nontrivial component \forall is compatible with induced asymptotic constraints \hat{c} and satisfies $c_N(\forall; \hat{c}) = w$ ind $(\forall) = 0$.

Since $q_N(\alpha;c) = 0$, we conclude from Prop. 6.4 that α contains no constant subbuildings or nodes, every trivial subbuilding is cylindrical and every nontrivial component ν has wind $(\nu) = 0$. Such components ν are therefore nicely embedded. A slightly stronger statement results from the observation that the core α^K is also compatible with c and only contains nicely embedded components. Thus each of these components ν satisfies $c_N(\nu; \hat{c}) = 0$, where \hat{c} are now the constraints induced on ν as a subbuilding of α^K .

Proof of Theorem 4. For a given set of asymptotic constraints c, the Rinvariance of J togetherw ith a standard transversality argument (cf. [W ena]) in ply that for generic choices of J 2 (End()) compatible with !, all nontrivial somewhere injective nite energy surfaces w compatible with c satisfy ind (w;c) 1. Then each connected component of w^{K} has constrained index at least 1, and by Prop. 5.1, these add up to ind (w;c). W e conclude there is exactly one component if ind (w;c) = 1, and at most two if ind (w;c) = 2. In the latter case, both nontrivial components w_i have ind (w_i ; c₁) = 1, so by (6.1), each has a unique puncture whose constrained parity is even: this is therefore the unique connecting puncture. Since the ends of w_1 and w_2 approaching this connecting orbit have opposite signs, w_1 and w_2 cannot be the same up to R-translation, thus their projections to M are disjoint.
