Stabilized plethysms for the classical Lie groups

A bstract

The plethysms of the Weyl characters associated to a classical Lie group by the symmetric functions stabilize in large rank. In the case of a power sum plethysm, we prove that the coe—cients of the decomposition of this stabilized form on the basis of Weyl characters are branching coe—cients which can be determined by a simple algorithm. This generalizes in particular some classical results on the power sum plethysms of Schur functions. The stabilization of power sum plethysms also implies that the specializations at q equal to 1 in certain parabolic Kazhdan-Lusztig polynomials do not depend on the rank of the root system considered. We also establish explicit formulas for the outer multiplicities appearing in the decomposition of the tensor square of any irreducible—nite dimensional module into its symmetric and antisymmetric parts. These multiplicities can notably be expressed in terms of the Littlewood-Richardson coe—cients.

1 Introduction

This paper is concerned with the plethysm softhe W eyl characters associated to classical Lie groups by the sym metric functions. Let g be a classical Lie group with rank n; and a partition. Recall that the W eyl character s^g is the character of the irreducible g-module V^g () of highest weight: Consider f a sym metric function of degree d and suppose n djj: We prove that the plethysm f s^g of the W eyl character s^g by f decomposes on the basis s^g j 2 s^g with coe cients which do not depend on n (Proposition 3.3.2). When s^g is the power sum of degree '; we establish that the coe cients so obtained are branching coe cients corresponding to the restriction to certain Levi subgroups (Theorem 5.1.1). For $g=gl_n$; it is well known that the coe cients a gl_n ; are, up to a sign, Littlewood-Richardson coe cients. They are then obtained from the 'quotient of the partition : We give a similar algorithm for computing the coe cients a gl_n ; when $g=so_{2n+1}$; sp_{2n} or so_{2n} : This algorithm was originally introduced in [10] to decompose the plethysm sp_n so_{2n+1} on the basis of Weyl characters for any integers gl_n 2 and '1 (that is, with no restrictive conditions on the rank gl_n). Although similar procedures also exist for $g=sp_{2n}$ or so_{2n} when 'is odd, our method failed for the even power sum plethysms on the Weyl characters of type gl_n or gl_n . it su ces to consider the coe cients a $\frac{SO_{2n+1}}{i}$ for which there exists an algorithm in both cases 'even and 'odd.

We give two applications of the stabilization property of plethysms. By results conjectured by Lusztig [12] and proved by K ashiwara-Tanisaki [5], the power sum plethysm $p ilde{s}$ can be interpreted as the character of the indecomposable U (g)-module L (') where 2 C is a primitive 2'-root of unity. The coe cients of the expansion of char(L (')) on the basis of W eyl characters are up to a sign, parabolic Kazhdan-Lusztig polynom ials specialized at q = 1: These polynom ials, introduced by Deodhar [2], are analogues of the Kazhdan-Lusztig polynomials obtained by replacing the a ne Hecke algebra P by one of its parabolic module P (being a weight of the a ne root system considered). In Proposition 524, we establish that the previous specializations of K-L parabolic polynomials are branching one cients and do not depend on the rank n considered 'j j:W e conjecture that the parabolic K-L polynom ials appearing in the expansion of char(L (')) are also independent of n when this hypothesis is veri ed. In Proposition 621, we use our expression of the coe cients a $\frac{g^2}{i}$ as branching coe cients, to derive explicit form ulas giving the decompositions of the symmetric and antisymmetric parts of V^g () 2 in their irreducible components when n 2 j j: The corresponding multiplicatives can then be expressed in terms of the Littlew ood-Richardson coe cients. Note that we have not found a combinatorial interpretation of this result sim ilar to that given in [1] from the combinatorics of dom ino tableaux.

The paper is organized as follows. In Section 2; we recall some basics on the representation theory of the classical Lie groups. Section 3 is concerned with plethysms $f = g^g$ and their stabilization in large rank. In Section 4, we describe the algorithm of [10] which perm its to compute the plethysms $g = g^{SO_{2n+1}}$ for any positive integer ': We state Theorem 5.1.1 and Proposition 5.2.4 in Section 5: Finally, in Section 6; we express the multiplicities $g^{g/2}$ in terms of the Littlewood-Richardson coe cients.

2 Background on classical Lie groups

2.1 Root systems and Weylgroups

As suggested by the above decompositions, the manipulation of the Weyl characters is simplied by working with in nitely many variables. In [7], Koike and Terada have introduced a universal character ring for the classical Lie groups. This ring can be regarded as the ring = $Z[x_1; ...; x_n; ...]^{sym}$ of symmetric functions in countably many variables. It is equipped with three natural Z-bases indexed by partitions, namely

3 Plethysms and stabilized plethysms

In particular, the coecients of the decomposition of p. $s^{\text{SO}_{2n}}$ and p. $s^{\text{SO}_{2n}}$ on the basis of W eyl characters are not branching coecients in general when 'is even. As we are going to see, this is nevertheless the case for the stabilized forms of these plethysms.
