# Remarks on the American Put Option for Jump Diffusions 9

#### A bstract

We prove that the perpetual American put option price of an exponential Levy process whose jumps come from a compound Poisson process is the classical solution of its associated quasi-variational inequality, that it is  $C^2$  except at the stopping boundary and that it is  $C^1$  everywhere (i.e. the smooth pasting condition always holds). We prove this fact by constructing a sequence of functions, each of which is a value function of an optimal stopping problem for a diffusion. The sequence is constructed sequentially using a functional operator that maps a certain class of convex functions to smooth functions satisfying some quasi-variational inequalities. This sequence converges to the value function of the American put option uniform by and exponentially fast, therefore it provides a good approximation scheme. In fact, the value of the American put option is the functional operator we use.

## 1 Introduction

Let (;F;P) be a complete probability space hosting a W iener process  $W = fW_t$ ; to 0g and a Poisson random measure on  $R_+$  R with mean measure (dx)dt (in which is a probability measure on  $R_+$ ) independent of the W iener process. We will consider a M arkov process  $X = fX_t$ ; to 0g of the form

In the context of the Am erican option pricing problem, we will take = r, in which  $= {}_{R} xv(dx) < 1$  (a standing assumption) so that X is the price of a security and the dynamics in (1.1) are stated under a risk neutral measure.

The value function of the perpetual American put option pricing problem is

in which  $h(x) = (K x)^+$ .

We will show that V is the classical solution of the associated quasi-variational inequality, and that the hitting time of the interval  $(0;l_1)$  is optimal for some  $l_1$  2 (0;K). Moreover, the value function is in  $C^1((0;1)) \setminus C^2((0;1))$  flyg) (the smooth pasting condition holds at  $l_1$ ). We will prove these results by observing that V in fact is the limit of a sequence of value functions of optimal stopping problems corresponding to the geometric Brownian motion. Since this sequence converges to V exponentially fast, and the optimal stopping problems for geometric Brownian motion are easier to solve, this will provide an algorithm whose accuracy versus speed characteristics can be controlled. We will in fact prove that V is the xed point of a functional operator that maps a certain class of convex functions to a class of smooth functions that are classical solutions of quasi-variational inequalities.

Recently, Mordecki (2002) developed a representation result for the price of the perpetual put American option on exponential Levy processes in terms of the in mum of the Levy process at an independent exponential time using the uctuation theory for Levy Processes. This was generalized to other reward functions by Mordecki and Salm inen (2006) using a representation they developed for the value function of the optimal stopping problem for a Hunt process in terms of an integral of its G reen function with respect to a Radon measure, see their Theorem 3.1. This theorem is a very general veri cation lemma: if one can not function satisfying the weak assumptions of this theorem, then that function is the value function of the optimal stopping problem. This theorem was then used to study smooth pasting principle (whether the value function is  ${\bf C}^1$  at the stopping boundary) in Example 5.3. It was proved that the value function of the optimal stopping problem of an exponential Levy process with exponential jumps is smooth everywhere except the stopping boundary when the reward function is maxf0; x g. The approach in Example 5.3 relies on being able to determ ine the G reen function of the underlying process explicitly, which is in turn used to determ ine the Radon measure in the integral representation. This task may be dicult when the jumps come from other distributions.

A lili and Kyprianou (2005), on the other hand, analyzed when smooth pasting principle is satis ed for the Am erican put option pricing problem for exponential Levy processes using the result of Mordecki (2002). Our proof can be considered as an alternative proof to theirs because we do not rely on the uctuation theory of Levy processes and simply use results from classical di usion theory by transforming the original problem for an exponential Levy process into a sequence optimal stopping problems for a di usion using a suitable functional operator. Also, we prove that the value function is the classical solution of the corresponding quasi-variational inequality, which is not carried out in Aliliand Kyprianou (2005) or in Mordecki (2002). The presentation in the paper assum es that the jum ps com e from a com pound Poisson process, which is a little bit restrictive. But after going through the details one might note that it is possible to consider Markov processes other than Levy processes using our approach (e.g., we can take (x) = ax + b and (x) = cx + d). An inspection of our proof reveals that our main result (the fact that the value function is the classical solution of the corresponding quasi-variational inequalities, see Thm 2.1) for the perpetual put option holds even for the nite horizon case. M oreover, the approximating sequence of functions we construct converges to the value function exponentially fast, which lends itself to an accurate num erical implementation.

We will tackle the optimal stopping problem by dening a sequence of functions (each of which corresponds to an optimal stopping time) iteratively using a certain functional operator and show that this sequence converges to the value function (or that the value function is the xed point of this operator) and that the functional operator maps a certain class of convex

functions to a certain class of smooth functions with the right properties. Since it may not be clear to the reader how one would conceive this particular sequence or the functional operator, here, we would like to give an intuitive explanation: A very natural sequence that comes to m ind is the optim al stopping problem swith time horizons equal to the jump times of the Levy process. For e.g., the rst function in this sequence is the value function of the optim alstopping problem when the decision horizon is the rst jump time of the Levy process, whereas the second function corresponds to the value function of an optimal stopping problem whose investment horizon is the second jump time. Strong Markov property suggest that one can write the second function in terms of the rst one (a Dynamic Program ming Principle). When one does so she can come up with the functional operator that we use for the iteration. This sequential approxim ation technique that we use to prove our result was also one of the main tools in solving optim al stopping problem s associated with quickest detection problems in Bayraktar et al. (2006), Bayraktar and Sezer (2006) and Dayanik and Sezer (2006). The optimal stopping problems in Bayraktar et al. (2006), Bayraktar and Sezer (2006) were for a multi-dim ensional piece-wise determ inistic M arkov process driven by the sam e point process and the one in D ayanik and Sezer (2006) was for a particular jump di usion process. This technique treats the piece-wise determ in istic processes and jump diusion processes in the same way. Therefore, using the sequential approximation technique one ndout whether by adding an independent Brownian motion to the state process, which is initially a piece-wise deterministic Markov process, one can smooth out the value function at the boundary between the optim al stopping and continuation regions (and see when the folklore holds).

Surprisingly, the value function of the American put option price for an exponential Levy process was never represented as a limit of a sequence of optimal stopping problems for a discipling to be taking the horizon of the problem to be the times of jumps of the Levy process), which is a natural representation. The purpose of this note is to illustrate how this natural technique that was recently used in solving quickest detection problems can be used to solve a well-know problem in Mathematical Finance. Other, somewhat similar, approximation techniques were used to solve optimal stopping problems for discipling to fine jump discipling, see e.g. A livarez (2004b) for perpetual optimal stopping problems with non-smooth pay-ofunctions, and Carr (1998) and Bouchard et al. (2005) for nite time horizon American put option pricing problems.

The next section prepares the proof of our main result Theorem 2.1. Here is the outline of our presentation: First, we will introduce a functional operator J, and de ne a sequence of convex functions ( $v_n$  ( ), 0 successively using J. Second, we will analyze the properties of this sequence of functions and its limit  $v_1$  ( ). This turns out to be a xed point of J. Then we will introduce a family of functional operators ( $R_1$ )<sub>12R</sub>, study the properties of such operators, and obtain explicit representations for them. The explicit representation of  $R_1$  in plies that  $R_1$ f satisfies a quasivariational inequality for any positive function f. Next, we will show that  $R_1$ f ( ) = Jf ( ), for a unique l = l[f], when f is in certain class of convex functions (which includes  $v_n$  ( ), 0 n 1 ). Our main result will follow from observing that  $v_1$  ( ) = Jy =  $R_1$ [ $v_1$ ]  $v_1$ .

## 2 A Sequence of Optimal Stopping Problems for a Diusion

Proof: The fact that J preserves order is evident from (2.3). Note that if f () is convex, so is Sf(). Because of drift and volatility are linear functions,  $X^0$  is linear in its initial condition. This implies that Sf( $X^0$ ) is convex a convex function of the initial value x for all t 0. Therefore, the integral in (2.3) is also convex in x. Since h(X) is also convex in x and the upper envelope (supremum) of convex functions is convex the second statement in the lemma follows.

As a corollary of Lem m a 22 we can state the following corollary, whose proof can be carried out by induction.

C orollary 2.2 The sequence of functions de ned in (2.10) is an increasing of convex functions.

The function  $v_1$  ( ) is well de ned as a result of 2.11) and C orollary 2.2. In fact, it is convex because it is the upper envelope of convex functions and it is bounded by the right-hand-side of (2.1).

We will study the functions  $(v_n(\cdot))$  and  $y(\cdot)$  m ore closely, since their properties will be useful in proving our main result.

C orollary 2.3 For each n,  $v_n$  ( ) is a decreasing function on [0;1 ). The same property holds for  $v_1$  ( ).

Remark 2.6 The sequence  $(l_n)_{n\geq N}$  is a decreasing sequence.
