A Proof of the Smoothness of the Finite Time Horizon American Put Option for Jump Diffusions

A bstract

We give a new proof of the fact that the value function of the nite time horizon American put option for a jum p di usion, when the jum ps are from a compound Poisson process, is the classical solution of a quasi-variational inequality and it is C 1 across the optimal stopping boundary. Our proof only uses the classical theory of parabolic partial di erential equations of Friedman (1964, 2006) and does not use the theory of vicosity solutions, since our proof relies on constructing a sequence of functions, each of which is a value function of an optimal stopping time for a di usion. The sequence is constructed by iterating a functional operator that maps a certain class of convex functions to smooth functions satisfying variational inequalities (or to value functions of optimal stopping problems involving only a di usion). The approximating sequence converges to the value function exponentially fast, therefore it constitutes a good approximation scheme, since the optimal stopping problems for diusions can be readily solved. Our technique also lets one see why the jump-di usion control problems m ay be smoother than the control problem swith piece-wise deterministic Markov processes: In the form er case the sequence of functions that converge to the value function is a sequence of value function of control problems for di usions, and in the latter case the converging sequence is a sequence of the value functions of determ inistic optim alcontrol problem s. The rst of these sequences is known to be smoother than the second one.

1 Introduction

Let (F;P) be a complete probability space hosting a W iener process $W = fW_t;t$ 0g and a Poisson random measure on R_+ R_+ with mean measure (dx)dt (in which is a probability measure on R_+) independent of the W iener process. We will consider a Markov process $S = fS_t;t$ 0g of the form

(a standing assumption). Here, S is the price of a security/stock and the dynamics in (1.1) are stated under a risk neutral measure. The constant r 0 is the interest rate, and the constant > 0 is the volatility.

The value function of the American put option pricing problem is

in which $S_{0;T}$ is the set of stopping times (of the Itration generated by W and N) taking values in [0;T].

We will show that V is the classical solution of a quasi-variational inequality and that it satis es smooth to principle across the optimal stopping boundary, i.e., V(;) is continuously dierentiable with respect to its rst variable at the optimal stopping boundary. We argue this by showing that V(;) is the xed point of an operator, which we will denote by J, that maps functions to the value functions of optimal stopping problems for divisions. As soon as a given function, f(;) has some regularity properties, we show that Jf(;) is the unique (classical) solution of a quasi-variational inequality and satis es the smooth to principle (it is C^{-1} across the optimal stopping boundary). We show that V has these regularity properties by making use a sequence (iterating J starting at the pay-of function of the put option) that converges to V uniformly and exponentially fast. This incidentally gives a numerical procedure, whose accuracy versus speed characteristics can be controlled, since the optimal stopping problems for divisions can be solved readily using the several numerical procedures that are available (e.g. Monte-Carlo methods of Longsta and Schwartz (2001), Glassermann and Yu (2004) or Finite Dierence Methods in Wilmott et al. (1995) or Kusner and Dupuis (2003)).

Pham (1997) provided a proof that the value function V is the classical solution of a quasivariational inequality using a combination of Friedman (2006) and the theory of viscosity solutions. See Proposition 3.1 in Pham (1997) which carries out its proof (details are not provided but hinted) using sim ilar line of arguments to the proof of Proposition 5.3 in Pham (1998), which uses the uniqueness results for viscosity solutions, see e.g. Ishii (1989). Our proof does not make use the theory of viscosity solutions and relies on constructing a sequence of functions, each of which is a value function of an optimal stopping time for a di usion. This technique provides an intuitive explanation as to why the jump-di usion optimal stopping problems may be smoother than the control problems with piece-wise deterministic Markov processes. The failure of the smooth t principle was observed for example in optimal stopping problem for multidim ensional piece-wise deterministic processes in Bayraktar et al. (2006). In the case of optim al stopping problem s for jum p di usions the sequence of functions that converge to the value function is a sequence of value function of control problem s for di usions, and in the case of optimal stopping problems for piece-wise deterministic processes the converging sequence is a sequence of the value functions of determ in istic optim alcontrol problem s. The rst of these two sequences is known to be smoother. Also, as we mentioned before, our proof procedure gives an accurate num erical procedure as an added bene t.

The in nite horizon American put option for jump di usions were analyzed in Bayraktar (2007) by similar means. The main diculty in this paper stems from the fact that we are

dealing with two dimensional parabolic variational inequalities. For example, we make use of Friedman (2006), Karatzas and Shreve (1998) (Chapter 2) (also see Peskir and Shiryaev (2006) (Chapter 7)) to study the properties of the operator J, and we show that the approximating sequence of functions are bounded with respect to the Holder seminorm (see Friedman (1964), page 61) to argue that the limit of the approximating sequence (which is a xed point of J) solves a partial differential equation in a bounded parabolic domain, etc. A liliand Kyprianou (2005) and Mordecki and Salminen (2006) considered the smooth tiprinciple (the fact that the value function is C^1 across the optimal stopping boundary) for one-dimensional exponential Levy processes using a uctuation theory. See Bayraktar (2007) for a detailed discussion.

We represent the value function of the American put option for an jump di usion process as a limit of a sequence of optimal stopping problems for a di usion (by taking the horizon of the problem to be the times of jumps of the compound Poisson process). Somewhat similar, approximation techniques were used to solve optimal stopping problems for di usions (not jump di usions), see e.g. A lyarez (2004) for perpetual optimal stopping problems with non-smooth pay-o functions, and Carr (1998) and Bouchard et al. (2005) for nite time horizon American put option pricing problems.

The next two sections prepare the proof our main result Theorem 3.1 in a sequences of Lemmata and Corollaries. Our contribution is not the result itself but our proof of it. In the next section, we introduce the functional operator J, that maps a function to the value function of an optimal stopping time for a di usion, and analyze its properties: for e.g. it preserves convexity with respect to the rst variable, the increase in the Holder seminorm of the function can be controlled, it maps certain class of functions to the classical solutions of quasi-variational inequalities. In Section 3, we construct a sequence of functions that converge to the value function uniform ly and exponentially to the smallest xed point of the operator J that is greater than the pay-o of the put option. We show that the sequence has bounded in the Holder norm, convex with respect to the rst variable, etc using results of Section 2. We eventually arrive at the fact that the xed point of the operator we consider is the value function itself and is the classical solution of the quasi-variational inequalities and satis es smooth t principle.

2 A Functional Operator and Its Properties

Let us de ne an operator J through its action on a test function $f:R_+^2$! R_+ , as the value function of the following optim al stopping problem

The next two lemm as are very crucial for our proof of the sm oothness of the Am erican option price for jump di usions, shows that the increase in the Holder sem i-norm that the operator J causes can be controlled.

3 A Sequence of Value Functions of Optim al Stopping Problems for S⁰ Approximating V

As a corollary of Lemmas 2.2 and 2.9 we can state the following corollary, whose proof can be carried out by induction.

This function is well de ned as a result of (3.2) and Corollary 3.2. In fact, it is convex because it is the upper envelope of convex functions and it is bounded by the right-hand-side of (3.2).

C orollary 3.3 For each n 0 and t2 R_+ , x ! v_n (x;T), is a decreasing function on [0;1). The same holds for x ! v_1 (x;T), x 0, for all T 2 R_+ .

Proof: The statement is a corollary of Corollary 32 and Remark 3.1 since any convex function that is bounded from above is decreasing.

Now, we can sharpen the upper bound in Corollary 3.1, and this has some implications about the continuity of x! $(v_n(x;T))_{n=1}$ and x! $v_1(x;T)$ at x=0.

Remark 3.2 The upper bound in (3.1) can be sharpened using Corollary 3.3 and Remark 2.2. Indeed, we have
