### DEFORM ATIONS OF BATALIN {VILKOVISKY ALGEBRAS

#### OLGA KRAVCHENKO

### A bstract

We show that a graded commutative algebra A with any square zero odd dierential operator is a natural generalization of the Batalin (Vilkovisky algebra. While such an operator of order 2 de ness a Lie algebra structure on A, an operator of an order higher than 2 (Koszul (Akm an de nition) leads to the structure of a strongly homotopy Lie algebra (L1 {algebra) on A. This allows us to give a de nition of a Batalin (Vilkovisky algebra up-to homotopy. We also make an important conjecture generalizing Kontsevich formality theorem to the Batalin (Vilkovisky algebra level.

## 1. Introduction.

Batalin {Vilkovisky algebras are graded commutative algebras with an extra structure given by a second order dierential operator of square 0.

The simplest example is the algebra of polyvector elds on a vector space  $\mathbb{R}^n$ : There is a second order square zero dierential operator on this algebra. This operator comes from the de Rham dierential on the algebra of dierential forms by pairing forms to polyvector elds  $\mathbb{W}$  ].

In this article, we consider the following generalization of the Batalin {V ilkovisky structure: we do not require that the operator is of the second order. However, the condition that this operator is a dierential (of square 0) leads to the structure of  $L_1$  algebra [HS, GK, LS] (also sometimes called a Lie algebra up-to homotopy or strong homotopy Lie algebras).

The notion of an algebra up-to hom otopy is a very useful tool in proving certain deep theorem s (like form ality theorem of K ontsevich [K]).

The most important property of algebraic structures up-to hom otopy is that all the higher hom otopies die on hom ology groups of algebras up-to hom otopy. Namely, let A be a P up-to hom otopy algebra, with a dierential d; then H (A; d) is a P algebra (where P here means an adjective: Lie, or associative, or commutative, or Poisson, or G erstenhaber etc.).

We propose a de nition of a commutative strong homotopy Batalin (Vilkovisky algebra.

Its noncommutative version leads to a generalized formality conjecture.

# 2. Batalin (V ilkovisky algebras (BV (algebras).

We work in the category of Z {graded algebras:  $A = A_i$ ; with dim  $(A_i) < 1$  for all i: We denote the degree of a hom ogeneous element a by jaj (if a 2  $A_1$ , then jaj = 1.)

Let :A A! A be a graded commutative product on A. Following Akman, for any such map D:A! A we can inductively de ne the following multi-linear expressions (multi-braces)  $F_D^k:A^k!$  A:

De nition 3. A Batalin {Vilkovisky algebra (BV {algebra for short) is a the data (A; ): a Z {graded associative commutative algebra A, and a second order operator of degree 1 and of square 0.

De nition 4. A Gerstenhaber algebra is a graded space A with a graded associative commutative product (a b) = a bofdegree 1 and a graded Lie bracket (a b) = [a;b] of degree 0, such that

that is the Lie adjoint action is an odd derivation with respect to the product.

Fact 5. Any BV (algebra (A; ) is a G erstenhaber algebra with the Lie bracket given by F  $^2$  :

A Gerstenhaber algebra which is also a BV algebra is called \exact" [KS], since the bracket is given by a coboundary.

Remark 1. In the language of operads one can give another de nition of a Gerstenhaber algebra. A Gerstenhaber algebra is an algebra over the braid operad [G]. Then BV (algebras are algebras over a cyclic braid operad [GK]. In other words a Gerstenhaber algebra structure comes from a BV operator if the corresponding operad is cyclic.

The multi-braces (brackets) given by the recursive formulas (1) have interesting relations. To describe them we need the notion of an  $L_1$  {algebra. Here we follow an exposition by Penkava P]. We view  $L_1$  {algebra as the structure of a codi erential on the exterior coalgebra of a vector space. Incidentally, this is a generalization of the point of view on graded Lie algebras taken in R].

De nition 6. An  $L_1$  {algebra structure on a graded vector space V is a codi evential Q on V, that is a map Q: V! V such that

Q is a coderivation:

Q is a homological vector eld: Q = 0:

The notion of a hom ological vector eld appears in [V], where the Gerstenhaber structure on the exterior algebra of an algebroid is described. A S Schwarz calls algebras with a hom ological vector eld Q  $\{m \text{ anifolds ([Schw])}\}$ .

A coderivation  $Q_k$  is said to be of order k if it is de ned by its action  $Q_k$ :  ${}^kV$ ! V: Then the coderivation property provides the action of  $Q_k$  on  ${}^nV$  for any n:

4. Deformations of Batalin (Vilkovisky algebras.

The multi-braces (1) are skew symmetric if the product is graded commutative. Hence they can be restricted to the exterior powers of A:

Then we make another step and consider the multi-braces (1) extended to be coderivations. We are going to show that their sum is a homological vector eld.

W e need just another notion related to the degree:

De nition $_{p}$ 7. A map D on a graded space A =  $_{p}^{p}$  A  $_{i}$ ; D : A ! A; is called odd if D : A  $_{i}$ !  $_{k}$  A  $_{i+2k+1}$ ; k 2 Z for each i.

Lem m a 1.  $^1$  Consider an odd operator D on a graded copp m utative algebra (A; ). Then D  $^2$  = 0 if and only if the sum of multi(braces  $Q_D$  =  $F_D^n$  is an  $L_1$  {algebra.

Proof. The statement means that  $F_{k+l=n+1}F_{D}^{k}$   $F_{D}^{1}=0$  for each n 1:

The "if" direction is obvious | it is the series of equations above: n = k = l = 1: The proof of the "only if" part is a tedious calculation.

For a graded commutative algebra Akman's denition of the braces (1) coincides with the denition of Koszul [Ko], which we are going reformulate in the following terms. Dene the following product on the exterior algebra : A ^ A ! A; by the same formula as on A A:  $(a_1 ^a a_2) = a_1$  a, also we can extend it to any exterior power  $(a_1 ^a ::: ^a a_n) = a_1$  :::  $_n a$ Then we can dene a {coproduct as a map A! A A: = ( ) :

The Koszulde nition of multi-braces is the following:

Carefully looking at this equation we see that we have sum m ands with D $^2$  and any other sum m and is present twice with the opposite signs thanks to the fact that the operator D is odd.

Notice that the brackets  $F_D^n$  from the Lie algebra structure up-to hom otopy with respect to the operator D (not D<sub>1</sub>). That is the bracket  $F_D^2$  gives a Lie algebra structure on the cohom ology of A with respect to the operator D:

Remark 2. Dierential BV {algebra. If the operator Disoforder nwe see that the highest homotopy is given by the n-th brace.

In particular, the second bracket

gives a classical BV {bracket for the case when  $D_n = 0$  for n = 3. Then the operator D is of order 2, that is  $D = D_1 + D_2$ : Such a D describes the case of a dierential BV {algebra which was the starting point of Barannikov {Kontsevich [BK], see also M].

On the other hand, starting from a dierential algebra (A;;d) with additional second order dierential operator one can de ne a generalized BV algebra by adding to d+ operators of higher order, requiring that their sum

is of square 0; where  $D_1 = d$ ;  $D_2 = c$ :

Com paring with the dierential BV {algebra we see, that there are still two dierentials on the deformed algebra  $\mid$  D and D<sub>1</sub> (the fact that D<sub>1</sub><sup>2</sup> = 0 of course follows from D<sup>2</sup> = 0)

Rem ark 3.0 rder and degree. There is a litration on the algebra of di erential operators de ned by the operator's order. For the operator D however we would like to obtain an unambiguous splitting  $D = {}_{n} {}_{1}D_{n}$ ; where  $D_{n}$  are operators of n-th order. All we know is that the rst  $D_{1}$  is killed by all  $F_{D}^{n}$  for n > 1. Then once  $D_{1}$  is killed,  $D_{2}$  is killed by  $F^{n}$ ; n > 2; but not  $F^{2}$  and so on. G rading comes from the degree.

D acts on a graded algebra, so D is a sum of operators of di erent degrees. It turns out that degree and order are in correspondence. It is natural to ask that the classical BV structure is a particular case of the generalized structure. Hence, we may start with the requirement that D<sub>1</sub> is of order 1 and of degree + 1, and D<sub>2</sub> is of order 2 and degree 1. This defines the grading: the operator D is unambiguously represented as a sum of operators of hom ogeneous order.

Lem m a 2. Consider an operator D : A ! A; such that D  $^2$  = 0 and given by a sum of an operator of order 1 and of degree + 1; D  $_1$  : A ! A  $_{+\,1}$  with higher order operators. Then D can be represented as a sum

$$D = D_n$$

where each  $D_n$  is an operator of order n and degree 3 2n; that is  $D_n$ : A ! A  $_{+3}$   $_{2n}$ :

This follows from the condition D $^2$  = 0:0 fcourse we also can weight each operator of a certain degree by som e $\sim$  in the corresponding degree.

The following lemma should prove to be useful in generalizing the paper [BK].

Lem m a 3. An operator D =  $^{\rm P}$  D  $_{\rm n}$ , such that D  $^{\rm 2}$  = 0 on the algebra (A; ) is a derivation of the bracket [a;b] =  $F_{\rm D}^{\rm 2}$  (a;b), but not of the product ; while D  $_{\rm 1}$  is a derivation of the product but not of the bracket.

The second bracket  $F_D^2 = [D;]$  gives a derivation of the product up-to the third bracket  $F_D^3$  (by de nition), so it gives Leibniz identity up-to an extra bracket.

Rem ark 4. Generalization to Leibniz algebras ([L]). If we start with a non-commutative associative algebra structure, the multi{braces  $F_D^n$  (1) still make sense for a di erential operator D . However there is no antisymmetry condition anymore, so the hom otopy structure we get from  $D^2=0$  is not  $L_1$ . Instead, one gets "Leibniz1" { algebra, hom otopy version of a Leibniz algebra (see [Li]). This is probably a reasonable generalization of the structure for which the vertex operator algebras would be an example.

## 5. Commutative BV $_1$ algebra.

We are proposing now a denition of a strong hom otopy Batalin  $\{V \text{ ilkovisky algebra.}\}$  Here we will restrict ourselves to the case of commutative algebras (the most general denition will be given elsewhere).

De nition 8. A triple (A;d;D) is a commutative strong hom otopy Batalin (Vilkovisky algebra when

A is a graded com mutative algebra,

d:A! A is a degree 1 di erential of the algebra A;

D: A! A is an odd square zero di erential operator, such that the degree of D d is negative.

There are various ways to de ne a strong hom otopy BV (algebra (BV $_1$  (algebra). In our de nition the commutative structure is preserved. One can imagine deforming the commutative structure as well (we mentioned one of the generalizations, the one letting the Loday $_1$  algebras.) However, all de nitions should lead to the following property  $\mid$  a BV (algebra up-to hom otopy should have a BV (algebra structure on its cohom ology. Indeed in our case:

Theorem 4. The cohomology H (A;d) of the algebra (A;d;D) is a BV (algebra.

Proof. Consider the condition D  $^2$  = 0: Since the degree of D d is negative, it m eans that D is a sum of d; the derivation of degree + 1; and negative degree operators: D  $_2$  + D  $_3$  + (Lem m a 2). From the fact that  $\not$  0 follows that dD  $_2$  + D  $_2$ d = 0; that is D  $_2$  acts on the cohom ology H (A;d): M oreover, D  $_2$  = dD  $_3$  + D  $_3$ d; which m eans that on the cohom ology H (A;d) D  $_2$  = 0: Since D  $_2$  is a second order operator, it de nes a structure of a BV algebra on the cohom ology H (A;d):

# 6. Possible applications.

My original aim in considering deform at ions of BV (algebras was extending Kontsevich form ality theorem [K] to the quasi-isom orphism of BV (algebras up-to hom otopy.

K ontsevich form ality theorem says that two dierential graded Lie algebras de ned on any manifold M: algebra of local Hochschild cochains D and algebra of polyvector elds T are quasi-isom orphic as  $L_{\parallel}$  {algebras.

Denote A the algebra of functions on M (say, sm ooth A = C  $^1$  (M )), with a point-wise commutative product. D can be thought of also as an algebra of local polydifferential operators on M :D = D  $^k$ ; D  $^k$  = H om  $_{loc}(A^{k+1};A)$ ; and T is an algebra of polyvector elds on M :T =  $T^k$ ;  $T^k$  = ( $^{k+1}TM$ ), both with the degree shifted by 1:

Then there are the following corresponding structures on these two algebras:

One can check that T is in fact a Gerstenhaber algebra (De nition 4) while D is a Gerstenhaber algebra up-to hom otopy in the following sense. The [-product on D is commutative only up-to hom otopy (the Lie adjoint action is still an odd derivation with respect to the product).

Recently D im a Tam arkin [I] lifted K ontsevich's theorem of form ality to the level of G erstenhaber algebras. Namely, algebra of polydi erential operators is G (form al:

the algebra of polydi erential operators and the algebra of polyvector elds are quasi-isom or phic as  $G_1$  {algebras (Gerstenhaber algebras up-to hom otopy).

However we want even more. It would be nice to see how one can lift the form ality of  $L_1$  {algebras to the form ality of  $BV_1$  {algebras.

If the rst C hem class of a manifold M is 0, then the algebra of polyvector elds on M is a BV {algebra. There is a one-to-one correspondence between BV {structures on a manifold M and at connections on the determinant bundle (bundle of polyvector elds in the top degree:  $^{\text{top}}\text{TM}$ ). Such a structure on real manifolds was studied in many papers: [Ko, Xu, H, W], on Calabi{Yau manifolds one can refer to ([Sch, BK]). We conjecture that in these cases there should be some BV  $_1$  structure leading to the G erstenhaber bracket on polydierential operators.

C on jecture 1. There is a structure of a  $BV_1$  {algebra on the space of local polydifferential operators on a manifold with a zero rst Chem class.

C on jecture 2. The BV $_1$  {algebra of local polydi erential operators on a manifold is form al: it is quasi-isom orphic as a BV $_1$  {algebra to its cohom ology, the BV {algebra of polyvector elds.

For this conjecture we will need a more general denition than denition 8, since the cup product on the algebra of polydierential operators is commutative only up-to hom otopy. This generalization should not pose a problem (compare with [A]).

From the conjecture would follow the Maurer(Cartan equations (MC (equations) for the BV operator on both of the algebras. Moreover, the quasi-isomorphism of BV (algebras maps solutions of MC (equation on one algebra to solutions of MC (equation on the other algebra.

Then we know from <code>BK</code>] that form alm oduli space of solutions to the M C {equation m odulo gauge invariance on polyvector elds on a Calabi{Yau m anifold carry a natural structure of the Frobenius m anifold. If this quasi-isom orphism of BV {structures up-to hom otopy exists it would de ne the Frobenius m anifold structure on the solutions of M C {equation on polydi erential operators.

A nother interesting example where we could expect to nd the generalised BV { structures is vertex operator algebras. There is a structure of the Batalin {Vilkovisky algebra on the cohomology of vertex operator algebras (Lian and Zuckerman [LZ], and Penkava and Schwarz [PS]). Natural question to ask what is the initial structure on the vertex operator algebras. This shows the need of a suitable de nition of a BV1 {structure. Besides it should tinto the general picture outlined by Stashe [S].
