Gerbes of chiraldi erential operators

Vassily Gorbounov, Fyodor Malikov, Vadim Schechtman

1. In this note we compute the cohomological obstruction to the existence of certain sheaves of vertex algebras on smooth varieties. These sheaves have been introduced and studied in the previous work by Vaintrob and two of the authors, cf. M SV] and M S1]. Hopefully our result claries to some extent the constructions of op. cit.

Recall that in [M] SV] one discussed two kinds of sheaves on smooth complex algebraic (or analytic) varieties X. First, one defined the sheaf of conformal vertex superalgebras $_{X}^{ch}$, called chiral defined a Rham algebra. These sheaves are canonically defined for an arbitrary X. Second, for some varieties X one can define a purely even counterpart of $_{X}^{ch}$, a sheaf of graded vertex algebras 0_{X}^{ch} , called a chiral structure sheaf, cf. op. cit., x5. For example, one can define 0_{X}^{ch} for curves, and for agraces G=B. For an arbitrary X, there arises certain cohomological obstruction to the existence of 0_{X}^{ch} . The in nitesimal incarnation of this obstruction is calculated in op. cit., x5, A.

In the present note we compute explicitly this obstruction, which turns out to adm it a very simple expression in terms of characteristic classes of X, cf. Theorem 3 below. From a dierent view point, this theorem may be regarded as a geometric interpretation of the second component of Chem character. In the last no. we discuss some generalizations.

First, a remark about term inology and notation. As was noted in M SV], (cf. the last paragraf of x5), the sheaf O_X^{ch} may be regarded as a chiral counterpart of the sheaf D_X of dierential operators on X. By that reason we prefer in this note to change its notation to D_X^{ch} and call it a sheaf of chiral dierential operators on X. From this point of view, the sheaf $_X^{ch}$ is a chiral counterpart of the sheaf $_X^{ch}$ of dierential operators on the de Rham algebra $_X$ of dierential form s, so it would probably deserve the notation D_{X}^{ch} , cf. M S2].

For a graded vertex algebra V , $V_{\rm i}$ will denote the component of conformalweight i.

In this note we will live in the analytical category.

2. Fix an integer N 1. Let $O = C [b^1; :::; b^N]$ be the polynom ial algebra. Following [M SV], de ne the vertex algebra D as the free bosonic vertex algebra

(i = 1; :::; N), with the OPE

the other products being trivial. The algebra D is called the algebra of (algebraic) chiral di erential operators on $\mathbb{C}^{\mathbb{N}}$.

The conform alweight zero component D₀ is equal to C $[b_0^1; ::: ; b_0^N]$, and will be identified with 0. The component D₁ is a free 0-m odule with the base $b_1^i; a_1^i$. The submodule \Rightarrow 0 b_1^i V₁ will be identified with the 0-m odule of 1-differentials $b_0^1 = b_0^1$ od b_0^1 by identifying b_0^1 with b_0^1 . The submodule T b_0^1 will be identified with the 0-m odule of vector elds 0 b_0^1 where $b_0^1 = b_0^1$ by identifying b_0^1 with b_0^1 .

Let X be an N-dimensional smooth complex analytic variety. Let U X be an open subset given together with a coordinate system, i.e. an open embedding $b = (b^1; \ldots; b^N)$: U ! C^N . Let O (U) denote the algebra of holomorphic functions on U. The map b induces an algebra homomorphism O ! O (U). We set D (U;b) = O (U) $_{\odot}$ D. A coording to M SV], 6.9, D (U;b) admits a canonical structure of a conformal vertex algebra. It is called the algebra of (holomorphic) chiral differential operators on U, associated with the coordinate system b.

If V U is an open subset, the map b induces a coordinate system on V, and we get an algebra D (V;b). When V varies, we get a sheaf of conformal vertex algebras D $_{(U;b)}$ on U | the sheaf of holomorphic chiral dierential operators on U, associated with the coordinate system b.

The component D $_{(U\ ;b)0}$ is identied with the sheaf of holomorphic functions O $_U$, and the component D $_{(U\ ;b)1}$ is identied with the direct sum of the sheaf $_U^1$ of holomorphic 1-dierentials and the sheaf $_U^1$ of holomorphic vector elds.

does not depend on the choice of a coordinate system b, cf. M SV], 6.2.

Let us de ne a groupoid D $^{\rm ch}$ (U) as follows. The objects of D $^{\rm ch}$ (U) are coordinate systems b on U . Given two coordinate systems b; 0b , the set of morphisms H om D $^{\rm ch}$ (U) (b; 0b) consists of isom orphisms of sheaves of graded vertex algebras D $_{\rm (U\,;b)}$! D $_{\rm U\,;^0b)}$ which induce the identity on the conformal weight zero components, and on the associated graded (with respect to the litration (2.2)) of the conformal weight one components. (Note that any morphism of graded vertex algebras as above necessarily respects the litration (2.2)). This groupoid will be called the groupoid of (holomorphic) chiral dierential operators on U . When U varies, we get a stack (champ) of groupoids, i.e. a gerbe D $_{\rm X}^{\rm ch}$ on X , called the gerbe of (holomorphic) chiral dierential operators on X .

Concerning the JG iraud's language of gerbes, see for example Section 5 of \mathbb{D}].

3. Theorem . The lien of the gerbe D $_{\rm X}^{\rm ch}$ is canonically isomorphic to the sheaf of closed holomorphic 2-di erentials $_{\rm X}^{\rm 2;cl}$.

The equivalence class $c(D_X^{ch}) 2 H^2(X; \frac{2;cl}{X})$ is equal to

Here T_X denotes the tangent bundle; for a vector bundle E we set

$$ch_2 (E) = \frac{1}{2}c_1^2 (E) \quad c_2 (E)$$

where $c_i(E)$ 2 H $^i(X; _X^{i;cl})$ are the Hodge Chem classes. Recall that the set of equivalence classes of gerbes on X bounded by a given abelian sheaff is identified with the group H $^2(X; F)$; this is explained in [D], 5.3.

This theorem means that a "sheaf of chiral dierential operators" is not a uniquely de ned object associated with X , but an object of a canonically de ned groupoid (X;D $_{\rm X}^{\rm ch}$). This groupoid is empty if the class (3.1) is non-trivial.

If (3.1) is trivial then this groupoid is equivalent to the groupoid of $_{\rm X}^{2;{\rm cl}}$ -torseurs on X . Thus, in this case the set of isom orphism classes of (X;D $_{\rm X}^{\rm ch}$) is isom orphic to H 1 (X; $_{\rm X}^{2;{\rm cl}}$), and the autom orphism group of an object is isom orphic to H 0 (X; $_{\rm X}^{2;{\rm cl}}$).

From this one sees im m ediately that for curves the obstruction vanishes, and the above groupoid is trivial: one can de ne canonically "the" sheaf of chiraldi erential operators D $_{\rm X}^{\rm ch}$. For the explicit construction, see (6.2) below .

The same is true for the ag spaces G=B. This explains the constructions of M SV]. As a negative example, note that for the projective spaces of dimension greater than 1, the class (3.1) is non-zero.

4. Let us explain a local statem ent which implies Theorem 3. Let Θ 0 be the algebra of the Taylor power series in variables b^i convergent in some neighbourhood of the origin. Let G be the group whose elements are N-tuples $g = (g^1(b); \ldots; g^N(b))$ where $g^i \in \Theta$ and the Jacobian matrix $@g := (@_i g^j)$ is non-degenerate. The composition is defined by

We will denote by $\frac{1}{\phi}$ (resp., T_{ϕ}) the module of germs of holomorphic 1-dierentials (resp., holomorphic vector elds). It is a free $\frac{1}{\phi}$ -module with the base fdb (resp.,

Let us call an autom orphism of \cancel{b} natural if it induces an autom orphism g 2 G on \cancel{b}_0 , and the induced by g autom orphism on $gr_{i}^{:} \cancel{b}_1$.

We want to describe the group G of all natural autom orphisms of $\dot{\mathbb{P}}$. In coordinates, a natural autom orphism is given by a pair (g;h) where g 2 G and h 2 M $_{\rm N}$ ($\dot{\mathbb{P}}$) is an N N-matrix over $\dot{\mathbb{P}}$. By denition, such a pair acts on the generating elds as follows

(this will be the right action). Here the matrix (g) = (ij)(g) is dened by

The straightforward computation of OPE shows that a pair (g;h) de nes an automorphism of the vertex algebra $\overset{1}{P}$ if and only if the matrix h satis es the equations

The computation similar to that in the proof of Theorem 3.8 from [M SV], shows that the composition on G is given by the formula

where $(g_1; g_2) = (ij (g_1; g_2))$ is given by

This describes the group G. The unit is (1;0). Let us introduce a bigger group G^0 consisting of all pairs (g;h) as above, with the multiplication (4.8), but with h not necessarily satisfying the conditions (4.6 a, b). One has to check the associativity of multiplication, which is straightforward. Obviously, G G^0 .

It is convenient to introduce in G 0 the new coordinates by setting

We have an obvious epim orphism G^0 ! G, (g;h) 7 g, and the formula (4.12) shows that its kernel, as a G-module, may be identified with the G-module of quadratic differentials $\begin{pmatrix} 1 & 2 \\ 0 \end{pmatrix} = \begin{pmatrix} 1 & 1 \\ 0 & 0 \end{pmatrix}$, i.e. we have the group extension

Equation (4.10) means that if we chose a section of the epim orphism G^0 ! G as g 7 (g;0) then the extension (4.13) corresponds to the 2-cocycle $(g_1;g_2)$ 2 $Z^2(G;\frac{2}{b})$. The equation of a cocycle (equivalent to the associativity of multiplication in G^0) reads as

5. Now let us take care of the subgroup G^{00} G^{0} given inside G^{0} by the equation (4.6a). Since the matrix (g) is symmetric, and the matrix h is arbitrary, the above equation has N (N 1)=2-dimensional (over Θ) space of solutions.

For example, for N = 1, (4.6) has a unique solution, and G $^{\circ\circ}$ = G , namely

Now let us treat the case of an arbitrary N . First of all, (1) = 0 and (1) = 1, and the equation (4.6) means simply that the matrix h is skew symmetric. This means that G $^{\odot}$ is included in a group extension

Comparing the expression (5.6) with the formula (4.5) from [TT] we see that the cocycle is nothing but the universal cocycle of G representing the characteristic class corresponding to the invariant polynomial tr(AB) (on pairs of N N m atirces), i.e. it represents the component of the Chern character c_1^2 $2c_2$.

Thus, we arrive at

6. Finally, group G is given inside $G^{(0)}$ by the equation (4.6b). For g=1 this equation $\sin p \log m$ eans that the form $h^{ij}db^i \wedge db^j$ is closed (we are grateful to A Beilinson for this remark).

Therefore, the kernel of the obvious map G $\,$! G is isomorphic to the G-module $^{2;{\rm cl}}_{,\varphi}$ of closed 2-form s.

6.1. Theorem. The group G of all natural automorphisms of the vertex algebra P is included in the group extension

The cohom ology class of this extension is equal to $2ch_2 = c_1^2 - 2c_2 + 2 (G;^{2;cl})$ where $c_i + 2 + 4 (G;^{2;cl})$ are the universal Chem classes.

Note that the standard cocycles representing the universal Chem classes in H i (G; $^i_{\phi}$) in fact take values in $^{i;cl}_{\phi}$.

We need only to prove that the map G ! G is surjective. To this end, note that in M SV], x5 one has lifted an arbitrary element of the Lie algebra W $_{\rm N}$: Lie (G) to a derivation () of \widehat{D} . Since every g 2 G is the exponent of some vector

This, together with Proposition 5.1, proves the theorem.

Consider the case N = 1. In this case $G = G^{0} = G$. Thus, every automorphism $g \ge G$ lifts uniquely to a natural automorphism of B given by

cf. (5.1). This corresponds to the fact that for curves the sheaf D_X^{ch} is uniquely de ned. Note that the formula [M SV], (5.23b) is a particular case of (6.2) (for $q(b) = b^{-1}$).

Our main Theorem 3 is an immediate consequence of Theorem 61.

7. Let E be a vector bundle over X , E its exterior algebra. Proceeding in a completely similar way as above, we can produce a gerbe D $_{\rm E}^{\rm ch}$ of chiral dierential operators on E, also bounded by the lien $_{\rm X}^{\rm 2;cl}$. Here E is odd in the corresponding vertex superalgebra. It seems that its characteristic class is equal to

The m inus sign com es out due to the ferm ionic nature of E , cf. M SV].

A ssum ing that (7.1) is true, we see that for $E = \frac{1}{X}$ we arrive at the neutral gerbe, and the chiral de Rham algebra is its global section. Note that we could take $E = T_X^{-1}$ as well, and also get the neutral gerbe. Its global sections would be certain "m irror partners" of the chiral de Rham algebra.
