A relation among the effective nucleon mass, the incompressibility and the effective σ -meson mass in nuclear matter

A relation among the effective nucleon mass M^* , the incompressibility Kand the effective σ -meson mass m_s^* in nuclear matter is studied by using the relativistic nuclear model. We found that there is a strong correlation between M^* and m_s^* , while there is only a weak correlation between K and m_s^* . At the normal density, m_s^* is smaller than the one at zero density, if M^* is smaller than 0.8 times of the nucleon mass at zero density. It is also found that the off-shell effective mass μ_s^* is related directly to K and M^* at the normal density.

1 Introduction

Recently, the π - π scattering phase shift is reanalyzed and the existence of the light iso-singlet scalar σ -meson is strongly suggested. [1] The similar results are also obtained by reanalyzing the $\pi^0\pi^0$ mass spectra and angular distributions around $K\bar{K}$ -threshold and at 1.5GeV in $p\bar{p}(\text{at rest}) \rightarrow 3\pi^0$. [2]

Although the existence of the σ -meson is not still established, this meson play an important role for the nuclear matter properties in the quantum hadrodynamics(QHD). For example, the nuclear saturation properties are realized by a balance of attractive effects of the σ -meson and repulsive effects of the ω -meson. [3]

The effective self-interactions (or potentials) of σ -meson play an important role in determining the effective nucleon mass and the incompressibility of the nuclear matter. [4] Inversely, in QHD, the properties of the effective potentials in the symmetric nuclear matter are almost determined if the values of the effective nucleon mass M_0^* at the normal density and the incompressibility K are given as input parameters. The effective σ -meson mass is also determined if the values of these two quantities are given, since it can be defined as a second derivative of the effective potential with respect to the σ -meson field. In this paper, we study the relation among the effective nucleon mass, the incompressibility and the effective σ -meson mass within the framework of QHD.

2 Formalism

We use the relativistic Hartree approximation (RHA) [5] based on the σ - ω model. [3] The Lagrangian density is composed of three fields, the nucleon ψ , the scalar σ -meson ϕ and the vector ω -meson V^{μ} , and is given by

$$L = \bar{\psi}(i\gamma_{\mu}\partial^{\mu} - M + g_{s}\phi - g_{v}\gamma_{\mu}V^{\mu})\psi + \frac{1}{2}\partial_{\mu}\phi\partial^{\mu}\phi - \frac{1}{2}\mu_{s}^{2}\phi^{2} - \frac{1}{4}F_{\mu\nu}F^{\mu\nu} + \frac{1}{2}\mu_{v}^{2}V_{\mu}V^{\mu} + \sum_{n=0}^{4}C_{n}\phi^{4}; \qquad F_{\mu\nu} = \partial_{\mu}V_{\nu} - \partial_{\nu}V_{\mu}$$

where M, μ_s , μ_v , g_s , g_v and C_n are constant parameters. The last term in (1) is a counter term and C_n is determined by the phenomenological renormalization conditions at zero baryon density, namely,

$$C_n = \frac{1}{n!} \frac{\partial^n}{\partial <\phi >^n} U_{1-\text{loop}}^{\text{V}}(<\phi >) \qquad (n = 0, 1, 2, 3, 4),$$

where $U_{1-\text{loop}}^{\text{V}}$ is the unrenormalized 1-loop effective potential induced by the vacuum fluctuations and $<\phi>$ is the ground state expectation value of the σ -meson field.

Replacing the meson fields by their ground state expectation values $\langle \phi \rangle$ and $\langle V^0 \rangle$, we obtain the equation of motions for $\langle \phi \rangle$ and for $\langle V^0 \rangle$, namely,

$$\rho_{\rm s} = \frac{1}{C_{\rm s}^2} g_{\rm s} < \phi >= \frac{1}{C_{\rm s}^2} (M - M^*) \tag{3}$$

and

$$\rho = \frac{1}{C_{\rm v}^2} g_{\rm v} < V^0 >, \tag{4}$$

where $M^* (\equiv M - g_s < \phi >)$, ρ_s and ρ are the effective nucleon mass, the scalar density and the baryon density, respectively, and $C_s = g_s/\mu_s$ and $C_v = g_v/\mu_v$. The scalar density $\rho_s = \langle \bar{\psi}\psi \rangle$ and the baryon density $\rho = \langle \bar{\psi}\gamma_0\psi \rangle$ are given by

$$\rho_{\rm s}(k_F, <\phi>) = \frac{\lambda}{2\pi^2} M^* \left[k_F E_F^* - M^{*2} \ln\left(\frac{k_F + E_F^*}{M^*}\right) \right] \\ - \frac{1}{g_{\rm s}} \frac{dU_{\rm 1-loop}^{\rm V,R}}{d<\phi>} \equiv \rho_{\rm s}^{\rm D}(k_F, <\phi>) + \rho_{\rm s}^{\rm V}(<\phi>)$$
(5)

and

$$\rho(k_F) = \frac{\lambda}{3\pi^2} k_F^3,\tag{6}$$

where λ is the number of degree of freedom of nucleons, k_F is the Fermi momentum, $E_F^* = \sqrt{k_F^2 + M^{*2}}$, respectively. The ρ_s^D and ρ_s^V are the density part and vacuum fluctuation part of the scalar density, respectively. The $U_{1-\text{loop}}^{\text{V,R}}$ is the renormalized effective potential induced by the 1-loop vacuum fluctuation effects and is given by [5]

$$U_{1-\text{loop}}^{\text{V,R}}(\langle \phi \rangle) = - \frac{\lambda}{8\pi^2} [M^{*4} \ln (M^*/M) + M^3(M - M^*) - \frac{7}{2}M^2(M - M^*)^2 + \frac{13}{3}M(M - M^*)^3 - \frac{25}{12}(M - M^*)^4].$$
(7)

The energy density of the nuclear matter is also given by

$$\varepsilon(k_F, <\phi>,) = \varepsilon_{\rm N}(k_F, M^*) + \varepsilon_{\rm v}(< V^0>) + \frac{1}{2}\mu_{\rm s}^2 <\phi>^2 + U_{\rm 1-loop}^{\rm V,R}(<\phi>),$$
(8)

where

$$\varepsilon_{\rm N}(k_F, <\phi>) = \frac{\lambda}{12\pi^2} \left[3k_F^3 E_F^* + \frac{3}{2}M^{*2}k_F E_F^* - \frac{3}{2}\ln\left(\frac{k_F + E_F^*}{M^*}\right) \right] \tag{9}$$

and

$$\varepsilon_{\rm v}(k_F, V_0) = g_{\rm v} < V^0 > \rho - \frac{\mu_{\rm v}^2}{2} < V^0 >^2 = \frac{\mu_{\rm v}^2}{2} < V^0 >^2$$
. (10)

It is easy to show that

$$\rho_{\rm s}^{\rm D} = -\frac{1}{g_{\rm s}} \frac{\partial \varepsilon_{\rm N}}{\partial < \phi >} \tag{11}$$

Using the thermodynamical identity, we obtain

$$\frac{\varepsilon + P}{\rho} = \mu = E_F^* + C_v^2 \rho, \qquad (12)$$

where P and μ are the pressure and the baryonic chemical potential of the nuclear matter, respectively. At the normal density ρ_0 , the pressure P vanishes. Then, Eq. (12) yields [4]

$$C_{\rm v}^2 = (-a_1 + M - \sqrt{k_{F0}^2 + M_0^{*2}})/\rho_0, \qquad (13)$$

where the quantity with zero subscript shows the one at the normal density and a_1 is the value of the binding energy. Equation (13) and the condition $C_v^2 > 0$ gives a condition $M_0^*/M < 0.944$. The incompressibility K of the nuclear matter is given by

$$K = 9\rho_0^2 \left. \frac{\partial^2(\epsilon/\rho)}{\partial\rho^2} \right|_{\rho=\rho_0} = 9 \left. \frac{\partial P}{\partial\rho} \right|_{\rho=\rho_0} = 9\rho_0 \left. \frac{\partial \mu}{\partial\rho} \right|_{\rho=\rho_0} \tag{14}$$

Putting $\mu = E_F^* + C_v^2 \rho$ into (14), we obtain

$$K = 9\rho_0 \left(\frac{k_F^3}{3\rho E_F^*} + \frac{g_v^2}{\mu_v^2} + \frac{M^*}{E_F^*} \frac{dM^*}{d\rho} \right) \Big|_{\rho = \rho_0}$$
(15)

Next we calculate the self-energy Π_s of the σ -meson by using the random phase approximation (RPA). [6] Using the same renormalization conditions as (2) for the effective potential and the usual renormalization conditions for the σ -meson wave function, we obtain

$$\Pi_{\rm s}(q; <\phi>, k_F) = \Pi_{\rm s}^V(q^2; <\phi>) + \Pi_{\rm s}^D(q; <\phi>, k_F).$$
(16)

The particle-antiparticle excitation part $\Pi^V_{\rm s}$ does not depend explicitly on k_F and is given by

$$\Pi_{\rm s}^{V}(q^2; <\phi>) = \frac{3g_{\rm s}^2}{4\pi^2} \int_{0}^{1} \mathrm{d}x \left[3M^{*2} + M^2 - 4MM^* - q^2x(1-x) - A^{*2}\ln\frac{A^{*2}}{M^2} \right],\tag{17}$$

where $A^{*2} = M^{*2} - q^2 x(1-x)$. The Π_s^D which includes the particle-hole excitations and the Pauli-blocking effects depends explicitly on k_F and is given by

$$\Pi_{\rm s}^D(q; <\phi>, k_F) = - ig_{\rm s}^2 \int \frac{\mathrm{d}^4 k}{(2\pi)^4} \mathrm{Tr}[G_D(k)G_F(k+q) + G_F(k)G_D(k+q) + G_D(k)G_D(k+q)]$$
(18)

where G_D and G_F are the density part and the Feynman part of the nucleon propagator in RHA.

Now we define two kinds of effective σ -meson mass. First, we define an "off-shell" effective mass μ_s^* by

$$\mu_{\rm s}^{*2} \equiv \mu_{\rm s}^2 + \lim_{q_0 \to 0} \lim_{|\mathbf{q}| \to 0} \Pi_{\rm s}(q).$$

The μ_s^* can be regarded as a range of the nuclear force which is mediated by the σ -meson in the nuclear matter. The μ_s^* can be related to the effective potential of the nuclear matter. In fact, it is easy to show that

$$\mu_{\rm s}^{*2} = \frac{\partial^2 \varepsilon}{\partial \langle \phi \rangle^2}.\tag{20}$$

Differentiating the equation of motion (3) for the σ -meson field with respect to the baryon density and using Eqs. (11) and (20), we obtain

$$\frac{dM^*}{d\rho} = -\frac{g_{\rm s}^2 M^*}{E_F^* \frac{\partial^2 \epsilon}{\partial \langle \phi \rangle^2}} = -\frac{g_{\rm s}^2}{\mu_{\rm s}^{*2}} \frac{M^*}{E_F^*} \tag{21}$$

Putting (21) into (15), we obtain

$$K = 9\rho_0 \left(\frac{k_F^3}{3\rho E_F^*} + \frac{g_v^2}{\mu_v^2} - \frac{g_s^2}{\mu_s^{*2}} \frac{M^{*2}}{E_F^{*2}} \right) \Big|_{\rho=\rho_0}.$$
 (22)

The $\mu_{\rm s}^*$ is not an "on-shell" mass which is defined by the pole of the propagator

$$\Delta(q) = \frac{1}{q^2 - (\mu_{\rm s}^2 + \Pi_{\rm s}(q))}.$$
(23)

We define the "on shell" effective mass $m_{\rm s}^*$ by the equation

$$m_{\rm s}^{*2} \equiv \mu_{\rm s}^2 + \Pi_{\rm s}(q)|_{\mathbf{q}^2 = 0}_{q_0^2 = m_{\rm s}^{*2}}.$$
(24)

In particular, at $\rho = 0$, we define

$$m_{\rm s}^2 \equiv \mu_{\rm s}^2 + \Pi_{\rm s}(q)|_{\mathbf{q}^2 = 0}_{q_0^2 = m_{\rm s}^2}, \qquad (25)$$

where $m_{\rm s}$ is the physical mass of σ -meson.

In the ordinary RHA K = 473 MeV, which is much larger than the empirical value 150~350 MeV. [7, 8] Therefore, we add an additional potential of the σ -meson self-interaction

$$U^{\rm H}(<\phi>) = \sum_{n=5}^{\infty} D_n (g_{\rm s} <\phi>)^n = \sum_{n=5}^{\infty} D_n (M - M^*)^n$$
(26)

to the Lagrangian (1). We regard $U^{\rm H}(<\phi>)$ as the effective potential induced by the higher-order quantum corrections beyond 1-loop approximation. We remark that, in Eq. (26), the terms of $<\phi>^0 <<\phi>^4$ have been canceled by the counter term to the higher-order quantum corrections just as Eq. (2). By this modification, Eqs (8) and (16) are modified as

$$\varepsilon(k_F, <\phi>,) = \epsilon_N(k_F, M^*) + \epsilon_v(< V^0>) + \frac{1}{2}\mu_s^2 <\phi>^2 + U_{1-\text{loop}}^{V,R}(<\phi>) + U^{H}(<\phi>)$$
(27)

and

$$\Pi_{\rm s}(q; <\phi>, k_F) = \Pi_{\rm s}^V(q^2; <\phi>) + \Pi_{\rm s}^D(q; <\phi>, k_F) + g_{\rm s}^2 \frac{d^2}{dM^{*2}} U^H(<\phi>).$$
(28)

We remark that Eqs. (20) and (22) are still valid, after this expansion was carried out.

3 Numerical calculation




Figure 1: The ratio μ_{s0}^*/g_s as a function of M_0^* . The solid, the dashed and dashed-dotted curves show results for K = 200 MeV, 300MeV and 400MeV, respectively. The cross show the result for the original RHA.

Equation (22) gives the relation among the effective nucleon mass, the incompressibility and the effective σ -meson mass μ_s^* at the normal density. If the values of M_0^* and K is given, $C_v = g_v/\mu_v$ is determined by Eq. (13) and we can calculate the ratio μ_s^*/g_s at the normal density. In Fig. 1, we display the ratio μ_s^*/g_s as a function of M_0^* with several values of K. In the numerical calculations, we set $a_1 = 15.75 \text{MeV}$, $\rho_0 = 0.15 \text{fm}^{-3}$ and M = 939 MeV. The ratio μ_s^*/g_s increases as M_0^* increases, while the ratio depends on K only slightly.

Since U^H does not appear explicitly in (22), the result in Fig. 1 is established regardless of the details of the potential form. However, to calculate μ_s^* itself, we must determine g_s . For this purpose, we assume that [9]

$$U^{\rm H}(<\phi>) = D_5(M-M^*)^5 + D_6(M-M^*)^6.$$
⁽²⁹⁾

In this approximation, we have four parameters for RHA calculation, namely, $C_{\rm s}$, $C_{\rm v}$, D_5 and D_6 . As is seen in Eq. (13), $C_{\rm v}$ is determined if the value of M_0^* is given. We have two conditions for the saturations at $\rho = \rho_0$.

$$\varepsilon(\rho_0) = (M - a_1)\rho_0 \quad \text{and} \quad P(\rho_0) = 0 \tag{30}$$

Therefore, if the value of K is given, the remaining three parameters $C_{\rm s}$, D_5 and D_6 are determined.

Using the same potential as (29), we obtain

$$\Pi_{\rm s}(q; <\phi>, k_F) = \Pi_{\rm s}^V(q^2; <\phi>) + \Pi_{\rm s}^D(q; <\phi>, k_F) + 20g_{\rm s}^2 D_5 (M-M^*)^3 + 30D_6 g_{\rm s}^2 (M-M^*)^4, \quad (31)$$

From Eqs. (25) and (31), at zero density, we obtain

$$1 + C_{\rm s}^2 \left. \frac{\Pi_{\rm s}^V(q)}{g_{\rm s}^2} \right|_{\substack{\mathbf{q}_{\rm s}^2 = 0\\ q_0^2 = m_{\rm s}^2}} = \frac{m_{\rm s}^2}{\mu_{\rm s}^2}.$$
 (32)




Figure 2: The μ_s as a function of M_0^* . The various curves and the cross have the same notation as in Fig. 1.




Figure 3: The $g_{\rm s}$ as a function of $M_0^*.$ The various curves and the cross have the same notation as in Fig. 1

Since Π_s^V/g_s^2 does not depend on g_s , we can calculate μ_s by putting the value of C_s and $m_s = 550$ MeV into Eq. (32). After determining μ_s , we can also determine the value of g_s . In Figs. 2 and 3, we display μ_s and g_s as a function of M_0^* . As

 M_0^* increases, g_s is suppressed more strongly than μ_s . Since, as is seen in (13), C_v^2 approches zero as $M_0^* \to 0.944M$, g_s becomes small more quickly than μ_s to keep the saturation conditions. Both of μ_s and g_s depend on K only slightly.




Figure 4: The ratio μ_{s0}^*/μ_s as a function of M_0^* . The various curves and the cross have the same notation as in Fig. 1.




Figure 5: The ratio m_{s0}^*/m_s as a function of M_0^* . The various curves and the cross have the same notation as in Fig. 1.

After determining $\mu_{\rm s}$ and $g_{\rm s}$, we can calculate $\mu_{\rm s}^*$ and $m_{\rm s}^*$. In Figs. 4 and 5, we display $\mu_{\rm s}^*/\mu_{\rm s}$ and $m_{\rm s}^*/m_{\rm s}$ at the normal density as a function of M_0^* . As M_0^* increase, the ratios $\mu_{\rm s}^*/\mu_{\rm s}$ and $m_{\rm s}^*/m_{\rm s}$ increase. The ratio $\mu_{\rm s}^*/\mu_{\rm s}$ is smaller than 1 for $M_0^* < 0.560(0.542, 0.526)M$, when K = 200(300, 400)MeV. Similarly, the ratio $m_{\rm s}^*/m_{\rm s}$ is smaller than 1 for $M_0^* < 0.815(0.802, 0.793)M$, when K = 200(300, 400)MeV. Both of two ratios depend on K only slightly.




Figure 6: The ratio $\mu_{\rm s}^*/\mu_{\rm s}$ as a function of the baryon density. The solid, the dashed and dashed-dotted curves show results for $M_0^* = 0.65M$, 0.75M and 0.85M, respectively. The dotted curve shows the result for the original RHA.




Figure 7: The ratio $m_{\rm s}^*/m_{\rm s}$ as a function of the baryon density. The various curves have the same notation as in Fig. 6.

In Figs. 6 and 7, we display $\mu_{\rm s}^*/\mu_{\rm s}$ and $m_{\rm s}^*/m_{\rm s}$ as a function of baryon density with several values of M_0^* . Since two ratios depend on K only slightly, we have fixed the value of K at 300MeV. The density dependence of the two ratios also changes, when M_0^* changes. The ratio $\mu_{\rm s}^*/\mu_{\rm s} \gtrsim 1$ in the region of $\rho \lesssim 1.3 \rho_0$, while the ratios $m_{\rm s}^*/m_{\rm s} < 1$ except for the case with $M_0^* = 0.85M$.

4 Summary

In summary, we have studied the relation among the effective nucleon mass M^* , the incompressibility K and the effective σ -meson mass m_s^* in nuclear matter by using the relativistic nuclear model. We found that there is a strong correlation between M^* and m_s^* , while there is only a weak correlation between K and m_s^* . At the normal density, m_s^* is smaller than the one at zero density for $M_0^* \leq 0.8M$, while μ_s^* hardly decreases. We remark that it is interesting that the off-shell mass μ_s^* at the normal density is related directly to M_0^* and K which can be determined phenomenologically.
