On the magnitude of the energy ow inherent in zero-point radiation

The spectrum of zero-point radiation is relativistically invariant and its spectral density function is therefore inversely proportional to the cubes of its wavelengths. For its energy to be nite, there must exist a minimum wavelength, q. The measurements of the apparent attraction between two uncharged conductor plates, placed in a vacuum at a temperature close to absolute zero, made by Sparmaay in 1958 allow us to deduce that the energy ow of the zero-point radiation which comes of or into an area  $(q)^2$ , corresponds with the emission of one photon of wavelength q per q (q=q=c), plus one photon of wavelength 2q per  $2^3q$ , etc., up to one photon of wavelength q per q or q is energy ow is enormous, but Sparmaay's experiments in plied only photons whose wavelengths were greater than q and zero-point radiation may include only photons with wavelengths greater than q being q an integer, perhaps very great.

## I. IN TRODUCTION

Sparnaay's 1958 [1] experim ents exposed the existence of zero-point radiation, which Nemst had considered as a possibility in 1916. However, this was not Spamaay's intention, as he was only trying to check Casim ir's hypothesis about the mutual attraction of two uncharged conductor plates placed very close together in a vacuum [2]. This attraction must disappear when the temperature approaches absolute zero, but Spamaay found that at that tem perature there was still some attraction not accounted for by Casim ir's hypothesis, being independent of tem perature and obeying a very simple law, it is directly proportional to the surface area of the plates, and inversely proportional to the 4th power of the distance \d" between them. Spamaay observed this force when the plates were located in a near-perfect vacuum at nearzero absolute tem perature. For a distance of 5  $\,$  10  $^{5}$  cm between the plates, he was able to measure a force of 1.96 g cm  $s^2$ , and deduced the formula

In a near-perfect vacuum and at near absolute zero tem perature, which means the absence of any \photon gas", the phenomenon observed by Spamaay could only be produced by a radiation inherent in space. This could only be the case if its spectrum is relativistically invariant, which could only happen if its spectral density function is inversely proportional to the cubes of the wavelengths. In other words, if the number of photons of wavelength , which strike a given area within a given time is inversely proportional to 3.

A function of spectral density inversely proportional to the cubes of the wavelengths, in plies a distribution of energies which is inversely proportional to the  $4^{th}$  power of the wavelengths, because the photons energies are inversely proportional to their wavelengths. In 1969, T in othy H . B over [3] showed that the spectral density function

In the Spamaay e ect, the presence of a force which is inversely proportional to the  $4^{th}$  power of the distance  $\d$ " between the plates, while the photons distribution of energies is inversely proportional to the  $4^{th}$  power of the wavelengths, leads us to infer that the cause of the apparent attraction must lie in some factor which varies inversely with wavelength and which produces a dierent behaviour in photons of wavelength equal to or greater than  $\d$ ", since:

The factor in question turns out to be the proportion of photons which are rejected, not absorbed; that is the coefficient of rejection , while the dijected behaviour is caused by the obstacle which each plate of error to the rejection by the inner plate of the other one, of photons of wavelengths equal to orgreater than  $\d^{"}$ . As we know, the energy which in transferred by a rejected photon is double that transferred by one which is absorbed.

## II. INTERPRETATION OF THE EXPERIMENTAL RESULTS

We now come to the title of this paper, an attempt to not the magnitude of the energy ow which is inherent in zero-point radiation; two radiations with the same spectrum, i.e. with the same energy distribution by wavelength, can have very dierent energy ows.

The results of Spamaay's experiments provide a link with reality which is enough to show the intensity of the energy ow belonging to zero-point radiation. So, remembering the requirement that in zero-point radiation there must exist a threshold, q, for the wavelength of the photons, we will now test the hypothesis that the results agree with an energy ow which would produce the incidence in a hypothetical area  $(q)^2$  of:

O ne photon of wavelength q; per xq (q = q = c)
O ne photon of wavelength 2q; per x2<sup>3</sup>q :::
O ne photon of wavelength nq; per xn<sup>3</sup>q

This radiation implies an energy ow of:

From Spamaay's experiments and our earlier argument, this energy ow should cause the dierence between the owstransmitted to the outer faces, and those transmitted to their inner faces to be:

where n is the distance between the plates expressed in  ${\bf q}$  . Hence

To sim plify the next stages of reasoning we will use the system of measurement (e, m  $_{\rm c}$ , c), in which the basic magnitudes are the quantum of electric charge e, the electron mass m  $_{\rm e}$ , and the speed of light c. In this system the units of length and time are respectively:  $l_{\rm e} = e^2 = m_{\rm e} c^2$ ,

$$t_e = e^2 = m_e c^3$$
; producing  $h = \frac{2}{t_e} \frac{m_e l_e^2}{t_e}$ ;  $c = \frac{l_e}{t_e}$ .

C learly, if  $l_e=k\ q$ , we have  $t_e=l_e=c=k\ q=c=k$  q. On the other hand if n is the number representing the measurem ent of the distance between the plates in q, the number which represents it in  $l_e$  is D  $l_e$ , D  $l_e$ k being equal to n. It must be remembered that k is certainly a very large number; there have been detected cosmic rays photons with wavelengths up to  $10^{20}$  eV, which would imply k values of the order of 2;273  $10^{11}$ . The true value of k could be much greater than this.

If in (5) we substitute q by  $l_e=k$ ; q by  $t_e=k$ ; n by D  $l_e$ k, and h by  $\frac{2}{t_e}\frac{m_e l_e^2}{t_e}$ , and remember that the ow

per  $(l_e)^2$  is  $(k)^2$  times greater than the ow per  $(q)^2$ , we can write

In (6) we not that the factor k has disappeared. If this were not so, we would arrive at absurd results, since the value of would be provided by:

For a > 0 would be huge and for a < 0 would be tiny; it must be remembered that k must be greater than 2;273  $10^{11}$ . The values of must always be less that 1, and for a radiation where photons predom inate with wavelengths slightly greater than 5  $10^{5}$  cm, these values must be greater than 0,4.

Since we must consider the energy ows for both the plates, we not that they produce an apparent force of attraction which can be expressed by:


In order to express (7) in term sofg sper cm  $^2$ , we have to include the transform ation coe cients 1 cm =  $k_{l_e} l_e$ ; 1 s=  $k_{t_e} t_e$ ; 1 g=  $k_{m_e} m_e$ , rem em bering to multiply by  $(k_{l_e})^2$  in order to m ove to forces per cm  $^2$ , and that D  $_{l_e} = k_{l_e} d$  cm , from which we obtain the following force per cm  $^2$ :

Since  $k_{l_e}=3;548692$   $10^{12}$ ;  $k_{t_e}=1;063871$   $10^{23}$ ;  $k_{m_e}=1;097668$   $10^{27}$ ; d=5  $10^{-5}$ ; by inserting these values in (8), we reach

Zero-point radiation comes from all directions within the half of space which is faced by the outer side of each plate, and its normal component is given, for each direction, by F sen, where is the angle between the plane of the plate and the direction in question. If we in agine a sphere of radius F, it is not hard to see that the number with measures the sum of the normal components is the number which measures the volume of the hem isphere of radius F, where F is the number measuring F in the system of units employed.



However W , as shown in (5), is not the ow which arrives from each and every direction in the said half-space, but the sum of all the ows which arrive from all those directions. In order to make the necessary correction we have only to divide the number  $\frac{2}{3}$  (F )³ by 2 (F )², which represents the area of the hem isphere of radius F , this amounts to dividing the total sum between the total of the directions to be considered. The resulting value is

However, this relation, which makes it easier to visualize the problem, is not the correct one, because the radiation which strikes at an angle ' from the vertical has a trajectory between the plates which is given by  $d=\cos'$  (Fig. 1).

Therefore the value of W to be considered is:

This force is equal to  $F_{(e,m_e,c)}\cos^4$  and its component normal to the plane of the plates is  $F_{(e,m_e,c)}\cos^5$ . On g. 2 it can be seen that to each point P on the circum ference of radius F there corresponds a point P, whose coordinates are those of P multiplied by  $\cos^4$ . The points P, form a line within the circle, and the sum of the component normal to the plates is now given by the volume produced by the area enclosed within that line and by the axis of coordinates when it turns around the axis OY, instead of the volume produced by the quadrant of circle turning around that axis. The volume in



question is given by the product of the said area and the circle described by its center of gravity [4] (Fig. 2).

The parametric coordinates of the curve thus described are

U sing this with the results of Sparnaay's m easurem ents, we obtain

Since x must be a natural number, and must fall between 0 and 1 the only possible results are

The second of these pairs is unlikely for wavelengths close to 5  $\,$  10  $^5$  cm . W e can therefore deduce that the energy ow of zero-point radiation is the results of the incidence, in an area (q) $^2$ , of:

One photon of wavelength q per q

One photon of wavelength 2q; per  $2^3q$  :::

One photon of wavelength nq; per  $n^3q$ 

## III. CONCLUSIONS

Returning to (3);  $W = \frac{4}{90x} \frac{hc}{q}$  per (q)<sup>2</sup>, and expressing it through the (e; m<sub>e</sub>; c) system and as an energy ow by  $(l_e)^2$ , we obtain

W hence, where x = 1,

over an area  $(l_e)^2$ .

This force, expressed in the (c,g,s) system and over 1 cm  $^2$  is produced by

As before, the normal force per cm $^2$  of surface is given by the third part of this value (see (10))

G iven the importance of k, this force is huge and, at rst sight, im possible to imagine. However, the rigorous equality prevailing between the energy ows arriving from all directions of space implies that the results are system atically nil. The presence of this force can only be detected when its equality of arrival is disturbed, as a result of phenom ena such as the Sparmaay e ect, or through the interaction of the photons with free elemental particles. Obviously Spamaay's experiments implied only photons whose wavelengths were greater than 5  $\,$  10  $^{5}$ cm, and zero-point radiation may include only photons with wavelengths greater than xq, being x an integer perhaps very great. Nonetheless the fact that this force may be immensely great is a surprising datum in the reality of the Universe. A surprising datum from which surprising consequences may derive.
