## The generation of an entangled four-photon W-state by using linear optical elements

## A bstract

We present a scheme to produce an entangled four-photon W-state by using linear optical elements. The symmetrical setup of linear optical elements consists of four beam splitters, four polarisation beam splitters and four mirrors. A photon EPR-pair and two single-photon sources are required as the input modes. The projection on the W-state can be made by a four-photon coincidence measurement. Further on we show, that by means of a horizontally oriented polarizer in front of one detector the W-state of three photons can be generated.

The generation of entangled states plays a central role in quantum optics. An experim ental realization in this context can be achieved with trapped ions [1], cavity-QED [2] and Bose-Einstein condenses [3]. Many schemes were proposed for the generation of entangled states of atom s [4]. The GHZ-state was experimentally demonstrated with a system of four trapped ions and with a system of three atoms and a cavity [5] [2]. Experiments with entangled photons open a broad eld of research. Entangled photon states can be used to test Bell's inequality [6] or to implement quantum information protocols for quantum teleportation [7], quantum dense coding [8] and quantum cryptography [9]. An experim ental realization of GHZ-states by means of three or four photons was experimentally demonstrated [10]. E cient quantum computation with linear optics was put forward [13]. More recently, a feasible linear optical scheme [14] was proposed to produce entangled N -photon states of the form  $\frac{1}{p-2}$  (j); N i + jN; 0i) via linear optical elements. The incentive to produce entangled states of spin-s objects (S > 1=2) increased signi cantly in the context of quantum communication and quantum information processing [15, 16]. A scheme was proposed [17] to generate an entangled four-photon state  $\frac{1}{2}$  (½;0;2;0i jl;1;1;1i+ j);2;0;2i), which is equivalent to two maximally entangled spin-1 particles. Drum mond [18] demonstrated the violation of the Bell inequality by this kind of multi-photon states. It was shown that there exist two inequivalent classes of three-qubits entangled states, namely the GHZ-state  ${}^{\dagger}GHZi = \frac{1}{p-2}({}^{\dagger}J11i + {}^{\dagger}D00i)$  and the W-state  ${}^{\dagger}Wi = \frac{1}{p-2}({}^{\dagger}J00i + {}^{\dagger}D10i + {}^{\dagger}D01i)$ , which are assisted under local operation by classical com munication [19]. Recently a di erent set of Bell inequality is considered with the purpose of illustrating some dierence between the violation of local realism exhibited by the GHZ and W state [20]. A W -state generation scheme of systems of three or four qubits was proposed [21]. In that paper

the Heisenberg model was used to generate the W-state of three or four atoms. We propose a scheme to generate a W-state

of four photons by means of linear optical elements.

An EPR-source  $_{EPR}$  is used to generate two entangled branches of the symmetric experimental setup. These two branches are denoted by the mode 1 and the mode 2. Two single-photon sources are injected in order to generate an entangled four-photon state. A four-photon coincidence detection projects this state on the W-state.

In the following we present a detailed analysis of the proposed scheme. The experimental setup is shown in Figure 1. The EPR-source generates the input state  $_{EPR}=(\sharp i_1\sharp v_2+\sharp v_3\sharp i_1\sharp i_2)=\frac{1}{2}$ . In order to inject two further photons in this arrangement of linear optical devices we use two single-photon sources:  $_e=\sharp i_e$  and  $_f=\sharp i_f$ . The single-photon input modes e and f are horizontally polarized. The two-photon injector consists of four polarization beam splitters PBS $_i$ , two beam splitter BS $_j$  and four mirrors. Since polarization beam splitter transmit the horizontal polarization and rejector consists of four polarization beam splitters PBS $_1$  and PBS $_2$  transform the EPR-state  $_{EPR}$  into

Notice, that the modes b and d pass through the beam splitters  $BS_1$  and  $BS_2$ , and that these beam splitters are connected with the single-photon input modes e and f. The result of the two-photon injection at the beam splitters  $BS_1$  and  $BS_2$  is

The re-ectance  $\sin$  and the transmittance  $\cos$  of these beam splitters are the same, since the same angle—is chosen. This coe-cient will be determined later. This four-photon state interacts with the two polarization beam splitters PBS<sub>3</sub> and PBS<sub>4</sub>, which transmit the horizontal polarization and re-ect the vertical polarization state. This method of a two-photon injection on the EPR-modes 1 and 2 results in the four-photon state

This expression shows the generated four-photon state explicitly in terms of the input modes (1;2;e;f). In order to perform a projection on the W-state a four-photon

coincidence detection is needed. This can be done by splitting the branches 1 and 2 separately by the beam splitters  $BS_3$  and  $BS_4$ . Since we consider only those terms, which correspond to a 4-photon coincidence detection (one photon in each of the four beams), the state of the system is projected with probability  $\cos^2 \sin^4 = 2$  into the W-state

The probability attains it's maximal value 2=27, if the transmittance of the beam splitter is  $\cos = 1 = 3$ .

If a polarizer with horizontal orientation is used in front of detector 1 the four-photon coincidence detection projects into the three-photon state

In conclusion, a scheme is presented to produce entangled W-states of four photons based on linear optical devices and a four-photons coincidence detection. Further on we proposed a modi cation of this sym metric scheme by adding one horizontal oriented polarizer in front of detector D $_1$ . This brakes the sym metry of the scheme and makes the generation of a W-state of three photons possible. Such multi-photon states may play a crucial role in fundamental tests of quantum mechanics versus local realism and in many quantum information and quantum computation schemes.

This scheme requires two single-photon sources and one two-photon EPR-state source. If ideal detectors are assumed, the eciency of this W-state generation scheme is 2=27, but the problem of input signal generation (four photons) has to be taken into account. The two single-photon sources can for example consist of two modes generated by a nonlinear crystal, which have a low production probability [22]. O ther triggered single photon sources of very good perform ance operate by means of uorescence from a single molecule [23] or a single quantum dot [24] [25]. However, the synchronized arrival of the required number of photons on the input ports of our scheme is experimentally challenging.
